Maya Leaders reject **GOB's FPIC protocol**

This morning, the Government of Belize issued a Cabinet brief announcing the approval of a Free, Prior Informed Consent (FPIC) Protocol, which it said, will "guide consultations with Maya communities, whether by government or private entities, in keeping with government's commitment to the implementation of the 2015 Consent Order of the Caribbean Court of Justice". Cruise ship docks in Belize after Bahamas denies entry

The Celebrity Apex was turned away from the Bahamas in early January due to that nation's new entry requirements for cruise ships

BELIZE CITY, Mon. Jan. 24, 2022

On Friday, January 7, the *Celebrity Apex* was unable to make its scheduled port call in the Bahamas after being denied entry. This was due to the island nation's recent modification of its cruise ship entry requirements in the face of the COVID-19 Omicron variant, and as a result, passengers onboard the ship spent the day at sea rather than on the shores of Nassau. They then returned to their port of embarkation in Fort Lauderdale, Florida, on Saturday.

Two weeks later, the *Celebrity Apex*, according to recent reports, docked in Belize.

Previously, when a ship that had been turned away from other ports in the Caribbean and Latin America the *MSC Divina*—was allowed to dock in Belize, Ministry of Tourism & Diaspora Relations CEO Nicole Solano had commented that cruise ships were only allowed to call on Belize's port if the Ministry of Health & Wellness deemed them safe enough. And, apparently, this was the case with the *Celebrity Apex* as well. Capacity Development, said that earlier in January, the ship was redflagged by Bahamian health authorities after a significant number of COVID-19 cases were detected onboard. But he went on to note that by the time the vessel approached Belize's shores, there were "less than a handful" of cases that were detected onboard among crew members. He further said that Ministry of Health and Wellness officials had gone onboard the boat to carry out an inspection and had issued the clearance, as is standard protocol for cruise and cargo vessels.

A portion of the 1,200 passengers who arrived on the *Apex* were allowed to disembark and go on pre-booked tours, and later on that day, after requests were made by Belize's tourism industry reps, others onboard the ship were allowed by the ship's management to reach out to the independent tour operators. Reports are that Belize has been placed on a list of countries where only passengers who buy tours sold on the vessels would be allowed to disembark. incident. Reports indicate that just before 7:00 o'clock that evening, the armed men entered the store demanding money. The customers, one of whom was seemingly assaulted with a shopping cart, were reportedly ordered at gunpoint to lie on the ground. After taking the proceeds of the day's sales from the cash register of the establishment, the robbers demanded more money, and one of the robbers proceeded to hit the store manager, Carla Castillo, 40, in the face with a firearm.

It resulted in an íðån wîund in the m³ddlå îf her head, and the left side of her neck was swollen. She was not the only person in the store to be assaulted, however. Juan Sandoval, 37; Sulma Sho, 38, and Ernesto Paau, 23, were all in the store at the time of the incident. Sandoval was hit in the left side of his head, while Sho and Paau were hit in the right side of their heads.

Commissioner Williams told local reporters that he has reviewed surveillance footage of the incident and that he is disgusted by what occurred.

"Having looked at the video circulating, it is [a] cruel and heinous act perpetrated by those who are involved. I was even more disturbed by the fact that one of the gunmen had a gun pointed at one of the persons in the store and despite that, hit the person in the face. That is really terrible," said COMPOL Williams.

The Belize Police Department has additionally confirmed that one of the armed robbers was a former police officer who was dismissed just a little over a year ago.

"That individual had been dismissed by me, over a year ago, and he's no longer a police officer. So an ex-police officer," said Commissioner of Police, Chester Williams, when he addressed the media.

According to Williams, the San Ignacio police are making a diligent effort to locate and detain those who perpetrated this latest robbery.

"The police in San Ignacio are following that particular incident. We currently have a number of persons detained who we believe are involved and investigators are working to put the pieces together. We should be making significant progress towards making an arrest," he said.

The robbers took an undisclosed amount of cash from the store's register, as well as a number of other items, including ³/₄³õ làðtîð³/₄ and a cellphone belonging to a customer in the store.

UDP calls out GoB on high gas prices

BELIZE CITY, Thurs. Jan. 27, 2022 On Wednesday, January 26, it was announced that once again the price of fuel in the country would be rising. There was a 41-cent jump in the per-gallon price of regular gas, which increased from

\$11.69 to \$12.10, while the prices of kerosene and diesel rose by 59 cents and 67 cents per gallon respectively. The price of premium



press release went on to refer to steps taken by the Barrow administration during its term to mitigate high gas prices. These included a move by GoB at that time to absorb part of the price increase, as well as steps that were taken to cap the amount of tax revenue derived by government from the sale of gas at a reasonable level, and an alteration of the tax formula to provide relief at the pumps, the UDP release said. The UDP release also pointed out that the Briceño administration has not attempted to ease the fuel tax burden on Belizeans, even once passing on a one-cent increase to consumers. "We remind Briceno that fuel prices impact the acquisition costs on all goods. The now weekly increases in fuel prices have Belizeans struggling to meet basic needs as the prices of all goods continue to rise proportionally," the release states.

When interviewed by local reporters, Abil Castaneda, BTB's Director of Quality Management and

gasoline, however, remains at \$12.30.

Following the announcement of the most recent increase in fuel prices, the United Democratic Party (UDP) issued a press release that urges the Briceño administration to reduce the taxes imposed by the government on fuel by \$2 at the minimum and to commit to keeping fuel prices below \$10 per gallon.

"This is unsustainable. This is unacceptable, because the burden he is putting on the Belizean people is just way too much. We are at a breaking point, and the Prime Minister needs to act as soon as possible," the release states.

The Opposition continued by stating that the Belizean people are unable to cope with the high gas prices. Their

Garifuna Nation speaks on Mayor Palacio's plight

The Garifuna Nation Congress has issued an open letter to the Belizean public regarding the recent clash between five members of the Belmopan City Council and Mayor Sheran Palacio. That letter stated that the mayor had filed a complaint with the Congress regarding the issue. It also explained that whenever a citizen of the Garifuna Nation-a group made up of Garinagu from Belize as well as the greater diaspora-files a complaint, it is the duty of the Congress to investigate that complaint's validity and then carry out the necessary actions on that citizen's behalf. In the case of Mayor Palacio, the Congress is currently carrying out an investigation after having determined that "there is some legitimacy" to her complaint that the City of Belmopan councilors have made false allegations against her.

"As soon as we have gathered all the necessary information, we intend to write a letter to the Belmopan Area Representative Honourable Oscar Mira, the Minister of Local Government Honourable Oscar Requeña, and the Prime Minister of Belize Honourable John Briceño," said the letter.

In an interview with the media, several of the organization's leaders, namely, Egbert Shaka Higinio, president of the Garifuna Nation; 1st

Vice-President and Ambassador-At-Large in Belize, Ms. Cynthia Ellis-Topsey; and Garifuna Nation Speaker and Congress Minister of Lands, Joseph Guerrero, spoke about the dispute. During that interview, the leaders commented that the way the issue is being dealt with is improper. They also stated that the councilors who are at odds with Mayor Palacio acted unprofessionally both when they failed to ensure that the mayor was aware of their complaints before leaking the document to the media and when they signed the document without doing their due diligence and ensuring that its contents were truthful and accurate.

"If they truly respected the mayor, they would have approached the mayor. They would have made sure that the mayor received the letter," said Guerrero.

The Congress criticized the confrontational approaches that are often seen during conflicts in our country, with Cynthia Ellis-Topsey calling it a cycle of controversy that often occurs due to politicization of governance issues. She stressed the huge role that the media often plays in this and then stated that the Garifuna Nation believes instead in reconciliation and due process.

"We must not allow issues to be tried by the media," said Ellis-Topsey. And shortly after, she asserted that the fact that much of the dispute between the Mayor and the councilors took place on Facebook was "unacceptable".

The ongoing feud is reflective of a much greater issue that exists in our country—an issue that Egbert Higinio refers to as an "undermining culture". According to Higinio, that "undermining culture" is seen when conflicts between parties, especially political parties, often lead to them undermining each other, ultimately resulting in little to no real progress. We should instead aim to establish an ethic of care, he said.

"There is a better approach," stated Joseph Guerrero, noting that each of the points brought across by the Belmopan councilors could have been resolved by sitting down in a discussion with Mayor Palacio. And the Garifuna Nation has offered to facilitate that better approach.

Specifically, the leaders of the Garifuna Nation have offered to facilitate what they referred to as a professional conversation around the issue. They stated that they are not taking sides with anyone and would simply like to provide a space where both sides can have a mature discussion.

"We are a democratic nation and we want to maintain those principles. And therefore we the leadership of the Garifuna Nation are offering to provide a space for reconciliation, for listening, for mediating, and moving forward for this democratic nation that we are proud to be a part of," said Ellis-Topsey.

Firearms found in Belize City

Two Belize City men were arrested and charged for keeping unlicensed firearms and ammunition

At around 6:35 p.m., on Saturday, January 22, police were pursuing a male person on McKenzie Lane, when that male entered a fenced yard. While waiting for reinforcement, the officers saw another male person leaving the yard armed with what appeared to be a firearm. They then ordered that individual, later identified as Clifford Russell Anderson, 32, to place the firearm on the ground. The officers then inspected the weapon and discovered that the firearm was a .38 Smith and Wesson, which contained (6) live rounds of ammunition. Andersen was arrested and charged for keeping unlicensed firearms and ammunition.

Another gun was removed off the streets of Belize City over the weekend. Officers were conducting a mobile patrol at about 7:50 p.m., in the North Creek area when they saw Isaiah Jeremiah Willacey, 26, and decided to perform a search on him. The officers discovered that Willacey was carrying a .45 pistol with five live .45 rounds of ammunition.

Willacey, like Anderson, was arrested and charged.

PM visits Honduras for inauguration of its first female president

President-elect Xiomara Castro won elections with a record-breaking 1.7 million votes

BELMOPAN, Wed. Jan. 26, 2022 Prime Minister Hon. John Briceño left the country on Wednesday for Tegucigalpa, Honduras, to attend the inauguration of the Central American country's first female president. The official inauguration of the president of the Republic of Honduras is set to take place Thursday, January 27. Back in November, 2021, Xiomara Castro won Honduras' presidential elections with a landslide victory of 1.7 million votes (51% of all votes cast), which is the largest number of votes that any candidate has received in the country's history.

Castro, who is a democratic socialist and whose husband served as Honduras' president from 2006-2009, has promised to tackle corruption and poverty, and to attempt to remove or amend the country's abortion laws during her four-year term. "We are adamant on stop and search. Our officers will continue to do it, and hopefully our efforts will quibble the streets a little when it comes to these illegal firearms," mentioned ASP Yearwood, the Police Department's Communications Director, when he spoke to reporters at a recent police briefing.

"I am happy to say over the weekend, we had three separate instances where police's stop and search led to the detention and arrest of three separate individuals with loaded firearms. These are persons who we believed were going to carry out murders, but they were interrupted by the police ...," said Commissioner of Police Chester Williams on the firearms that were found over the weekend.

And the prices keep rising

SIB reports 4.9% inflation rate in December

The Statistical Institute of Belize has reported, via its Consumer Price Index Survey, an inflation rate of 4.9% in the country in December 2021, with increases being recorded in the prices of fuel, food, Liquefied Petroleum Gas (LPG), restaurant services, and household cleaning products.

The report indicated that, compared to December of 2020, prices in the "Transport" category rose by 18.6%, mainly due to a notable increase in the cost of motor vehicle fuels. The price of premium gasoline, for example, rose from \$9.28 in December 2020 to \$12.58 in December 2021—a \$3.30 increase. The cost of diesel rose by \$2.53, while regular gasoline prices rose by \$2.67. In the case of food, the SIB reported an increase in the prices of basic food items. The price of pigtails, for instance, went up by a remarkable 47%. Overall, there was an average increase of 3.4% in the prices of food and non-alcoholic beverages. Some fresh produce, such as tomatoes and red kidney beans, however, did decrease in price.

The SIB report also indicated a 3% inflation rate for "Housing, Water, Electricity, Gas & Other Fuel", a 2.2% inflation rate for "Furnishings, Household Equipment, and Routine Household Maintenance", and a 4.7% rate for "Restaurants and Accommodation Services".

Of all the municipalities, Orange Walk Town recorded the highest inflation rate for December 2021 (7.2%), while Benque Viejo Del Carmen showed the lowest rate (3.3%).

Unions seeking possible end of salary cuts

(BNTU) at the House of Culture in Belize City to discuss the country's current financial situation, PSU president Dean Flowers and national president of the BNTU, Elena Smith appeared to be hopeful about the prospects for the restoration of the full salaries of public workers at some point in the future, although they expressed a desire to get additional information from the government. The main focus of the meeting with highlevel representatives of GoB was whether the country is doing well enough fiscally at this point for GOB to rescind the 10% salary cut and increment freeze to which government workers have been subjected. According to the union leaders, however, they need to engage in further discussions before they can



confidently demand a restoration of their salaries.

BNTU national president, Elena Smith has stated that another meeting between the government and the unions is scheduled to take place on February 16. And until then, the unions will be reviewing the information that they have received from GoB to assess whether they are truly satisfied with the government's response or not.

"I think we want to look forward to further analysis and then reach a determination after the February 16 meeting," she stated.

Flowers commented that, while the government appears to be performing well fiscally at the moment, he shared Smith's sentiments that additional information is needed. According to Flowers, it is still too early to know if and when the full salaries of public workers will be restored.

"We still have to wait and see," he added. He also noted that despite their need to request more information from the government, the meeting was, overall, a fruitful one.

In a previous interview, the BNTU president told the media that, once all documents and numbers begin to show that the government is able to rescind the 10% salary cut, the BNTU will demand that they do so. And if GOB refuses, she said, they will fight back.

Senator Darrell Bradley is representing the National Trade Union Congress of Belize as an interested party and has made submissions in line with that of the claimant's, local reports say. Justice Sonya Young has reserved her decision until February 18, when she will hand down her ruling on whether or not a case with requisite merit was presented by Peyrefitte. If granted leave for this judicial review, the submitted arguments from the parties will be examined, and judgement will be handed down.

contract to Smart for the provision of Microsoft 365 licenses to various government departments. The claimant, Peyrefitte, is seeking leave for the court to conduct a judicial review of the award, and to hand down a decision to quash the contract due to its illegality and the alleged biases that led to the selection of Smart as the software provider.

The contract, previously held by our national telecom company, Belize Telemedia Limited, is worth 3.37 million dollars and is for the provision of Microsoft 365 licenses for government computers. The claimant, represented by former Prime Minister, Rt. Hon. Dean Barrow, is asserting that the bidding process that led to the awarding of this contract was flawed, since the bid was not vetted by the Contractor General, and that Smart entered the selective tendering at a late point in the bidding process.

Briceno, an "immense debt" for funding the PUP while they were in opposition for almost 13 years. It is widely known that the Briceño family are part-owners of Speednet's Smart, and the claimant's assertions are that Jaime Briceño, the brother of the PM, is at this time the chairman of the company. While the familial connection between Hon. Briceño, who heads the Ministry of Finance through which the contract was granted, and the owners/chairman of the company is not an automatic indication that favoritism influenced the process that led to the awarding of the contact, the claimant is insisting that the process was, in fact, tainted with bias.

The government's attorney, Trinidadian Queen's Counsel Douglas Mendez, has conceded that GOB did violate the Finance and Audit Reform Act in not sending the contract to the Contractor General for review and approval prior to the awarding of the contract to Smart. In an interview recently, PM Briceño acknowledged the violation of the Act, but indicated that it was the Financial Secretary, Joseph Waight, who was responsible for any slip-ups in the process. His legal counsel, in submissions to the court, pointed to the Financial Secretary as the final decision-maker and not the Prime Minister. There is an insistence on his part, though, that Smart offered the lowest bid and that it was on this basis that the company was granted the contract. "Our Government has admitted that they did not go to the Contractor General, so basically all that is going to be is that we're going to go to the Contractor General for him to take a look at ... but in

the report that the Contractor General gave he was very clear that all the process was followed, that it was open, that it was transparent and that Speednet did give the best offer to the government," PM Briceño said in his interview.

The PM said that Fin. Sec. Waight had a sense of urgency in his efforts to renew the contract, since the expiration date for the licenses was approaching. "So, I guess in his haste, and I have not sat down to ask him about it. I guess in his haste he said you know what, Speednet, you won it, please hurry make sure that they don't cut us off," Hon. Briceño said. (What is worth, noting, though, is that there were a number of months of service remaining in the contract with Belize Telemedia Limited—service which had reportedly already been paid for, resulting in a duplication of payment by the government when it entered a contract with Smart prior to the expiration of the previous contract

The claimant also highlighted another major point—an appearance of bias on the part of the Prime Minister, Hon. John Briceño, who has publicly said that he owes his brother, Jaime

with BTL, which had been extended.)

The claimant, Senator Michael Peyrefitte, stated in a media interview last Friday that putting all the blame on the Financial Secretary is intolerable.

"Well, that is unacceptable. The buck stops with the Ministry of Finance and the Minister of Finance, like he used to like to say when he was the Leader of the Opposition. And so, he is responsible for making sure that the contract reached the Contractor General. We are hoping that the judge will quash this contract and send a clear message that the government cannot break the law," stated Peyrefitte.

He went on to say, "Behind door number one, you have to admit that you broke the law, and you purposely did




Drifting toward being a banana republic

Vaughn Gill, the host of the morning show on the government's television station, said on Tuesday that the people involved in the industrial action at the Port of Belize Ltd. (PBL) are stuck in 2005. Later that same morning, Evan "Mose" Hyde, the president of the Christian Workers Union (CWU), which represents the workers of PBL, said similarly at a press conference — that what is happening today, the impasse at PBL, is rooted in the past.

The stevedores are presently on strike. The CWU president said the stevedores are out of options, they have acted with great restraint under the conditions, and the purpose of the press conference was to put on record before the Belizean people how they have been dealt with by PBL, and to call on the government to step up, to do more to resolve the situation.

The impact of the strike is already being felt. A couple ships with containers filled with goods for Belize, and some containers filled with products for export have been delayed, and the Belize Chamber of Commerce and Industry, the largest business group in the country, has expressed their dismay about a situation which they say will drive up the cost of doing business and cause the price of goods in the country to be inflated even further than they already are.

As both Hyde and Gill said, this story is rooted in a time when the port moved from public to private hands. PBL was publicly owned, up to 2002 when a PUP government on a privatization spree totally bypassed the workers at the port and sold it to a favored businessman, Mr. Luke Espat, and his group. The price at which the port was sold to Espat was reportedly \$74 million,



and the government sweetened the deal by dredging in front of the port, an operation that cost the Belizean people \$40 million.

In 2007 Espat and his group sued the government for failure to deliver on certain commitments it had made. Espat claimed, among other things, that the government did not honor certain tax and duty exemptions it promised, that it reneged on an agreement to confine the port at Big Creek to shipping business related to bananas, and that it had not delivered on promises to facilitate the development of a cruise port, hotel, and casino at the site.

The Luke Espat group had a number of projects that failed, and it became heavily indebted to the Belize Bank. The group could barely pay the interest on its debts, and a number of its assets were auctioned off, while PBL, its only viable entity, went into receivership in 2012. A 2012 News5 report said the company appropriating PBL was actually a "shell company, Private Investment Limited, registered at the bank's (Belize Bank) Market Square address." Later in the same newscast, Espat was reported as saying, "I have informed the Prime Minister

(Dean Barrow) this morning that he was helpful in allowing rogues to steal my business."

The "rogues" have been in charge of PBL since. A decade later, PBL remains in the control of the receiver, the financials of the company are top secret, the receivership and the workers are constantly in a standoff, and the facilities have fallen into disrepair.

Everyone "knows" that Lord Ashcroft is the lead player in the receivership, and he has stated baldly that the refurbishing/ upgrading of the port's facilities to make it more competitive is contingent on his group getting the green light to establish a cruise port at PBL and dredge in front of the port so it can handle the world's largest ships.

Busting the stevedores is prominent in the receivership's plans to capitalize on the asset; reducing the cost of labor is almost always a target for big business, but that wouldn't help them get the green light for the massive dredging they propose, and the cruise port. The fact is that very serious environmental concerns stand in the way of dredging, and Belizeans are cautious about increasing the number of cruise visitors to the country because of the potential to erode our product.

In his attempts to have his way, Ashcroft went on his television station, Channel Five, and effectively called the Prime Minister a wimp. One of his aides has gone as low as to charge that some of our senior public officers had indicated that support for the cruise port and dredging could be bought and, even lower, to hint at the UK-Belize Bilateral Investment Treaty.

The receivers showed little concern when the sugar company, ASR/BSI decided to bypass PBL and take its sugar by road to the port in Big Creek. The stated reason for that decision was that considerable savings would be realized; however, the receiver's CEO, Andy Lane, told Channel Five what everybody already knew: that on the whole, the economics for the move isn't there.

To calculate the loss to the receivers when ASR/BSI decided to bypass PBL, one has to factor in their big game plan. For the stevedores the loss was considerable, with some estimates indicating that as much as 40% of their yearly earnings was lost in the move. The stevedores are demanding compensation, BZ \$5million, from PBL for their lost earnings, and the CWU has cited the government's promise to compensate PBL if any of its business was lost to the Port of Big Creek, as one of the bases for its demands.

Vehicles such as offshore companies, shell companies, and fronts make it hard to track the transactions in the business world, for instance who bankrolls the big boys at Big Creek, but on paper the Port of Big Creek was (is) the property of the Banana Growers Association. Information coming from South Stann Creek some years ago was that the Belize Bank took over the largest banana farm, giving it control of 40% of the


That is the story of capitalism at its most rapacious. The standard game plan for big business is to break up the unions, and, as has been seen in the sugarcane industry up north, break up the associations, so they can deal with workers and farmers individually.

The television host who said the stevedores must wake up and realize "the ship has sailed" obviously doesn't understand the stakes here. The ship is still in port, but we are drifting from our mooring, heading toward becoming a banana republic. We have seen the caravans, impoverished people in neighboring republics trekking thousands of miles because life at home has become too miserable. We are headed there if we roll over, if we let big business prevail.

Reopening of land borders scheduled for Feb. 1

BELIZE CITY, Thurs. Jan. 27, 2022

When interviewed by local reporters yesterday, Prime Minister Hon. John Briceño announced that the government has set February 1, 2022, as the tentative date for the reopening of the country's land borders. Last year, GOB announced that those borders would be reopened in early January, but in late December it issued a press release notifying the public of the postponement of the reopening date to February. The government (following calls from medical officials in the Central Health Region to delay the opening in order to focus on school reopenings as well as study virus trends in neighboring countries) cited a need for the resumption of classroom learning and to monitor the Omicron Covid-19 wave as the reasons for its decision.

The majority of schools are currently engaged in hybrid learning (a mix of in-person classes and online instruction) despite some pushback from teachers and students, and the Omicron wave continues to result in a daily number of new cases that is in the triple digits. PM Briceño said, however, that their timeline to reopen at the start of February is still in place unless something "big happens".

While he said that he needed to verify what the regulations governing the reopening would be, he did hint that only vaccinated persons would be allowed to cross the border, and he further suggested that such a restriction may encourage more persons to get vaccinated.

"The numbers for vaccination has been down now to about 200 per day, and we need to do more. If we could get at least to 70%, then I think we would be way much better off," PM Briceno noted.

And while the reopening of the borders will likely breathe muchneeded life into our economy, domestic consumption of goods and services is expected to fall as the borders reopen and persons resort to shopping in Mexico and Guatemala. "I know a lot of businesses have benefitted greatly because the borders have been closed, but the reality is that it can't stay closed forever," the Prime Minister said. Last week, the PM pointed out during an interview that the closure of the border for almost two years has caused problems in the areas of travel, business, and trade. He said that some key sectors are needed to drive Belize's economic growth, and he stated that finding a way to reopen the border safely is what the government is working on.

Vaughn Gill, el presentador del programa matutino en la estación de televisión del gobierno, dijo el martes que las personas involucradas en la acción industrial en Port of Belize Ltd. (PBL) están atrapadas en 2005. Más tarde esa misma mañana, Evan "Mose" Hyde, el presidente del Sindicato de Trabajadores Cristianos (CWU por sus siglas en inglés), que representa a los trabajadores de PBL, dijo de manera similar en una conferencia de prensa que lo que está sucediendo hoy, el estancamiento en PBL, tiene sus raíces en el pasado.

Los estibadores están actualmente en huelga. El presidente del CWU dijo que los estibadores no tienen opciones, han actuado con gran moderación bajo las condiciones, y el propósito de la conferencia de prensa era dejar constancia ante el pueblo beliceño de cómo PBL los ha tratado, y hacer un llamado al gobierno a redoblar esfuerzos, a hacer más para resolver la situación.

El impacto de la huelga ya se está sintiendo. Un par de barcos con contenedores llenos de mercancías para Belize, y algunos contenedores llenos de productos para la exportación se han retrasado, y la Cámara de Comercio e Industria de Belize, el grupo empresarial más grande del país, ha expresado su consternación por una situación que dicen aumentará el costo de hacer negocios y hará que el precio de los bienes en el país se infle aún más de lo que ya está.

Como dijeron tanto Hyde como Gill, esta historia tiene sus raíces en una época en la que el puerto pasó de manos públicas a manos privadas. PBL era de propiedad pública hasta 2002, cuando un gobierno PUP en una ola de privatizaciones pasó totalmente por alto a los trabajadores del puerto y lo vendió a un empresario favorecido, el Sr. Luke Espat, y su grupo. Según los informes, el precio al que se vendió el puerto a Espat fue de \$ 74 millones, y el gobierno endulzó el trato dragando frente al puerto, una operación que le costó al pueblo beliceño \$ 40 millones.

En 2007, Espat y su grupo demandaron al gobierno por incumplimiento de ciertos compromisos que había asumido. Espat afirmó, entre otras cosas, que el gobierno no cumplió con ciertas exenciones de impuestos y aranceles que prometió, que incumplió un acuerdo para limitar el puerto de Big Creek a negocios de transporte marítimo relacionados con los bananos, y que no había cumplido promesas de facilitar el desarrollo de un puerto de cruceros, hotel y casino en el sitio.

El grupo Luke Espat tuvo una serie de proyectos que fracasaron y se endeudó fuertemente con el Banco Belize. El grupo apenas podía pagar los intereses de sus deudas y varios de sus activos fueron subastados, mientras que PBL, su única entidad viable, entró en receptoría en 2012.

Un informe de News5 de 2012 decía que la empresa que se

La información proveniente del Sur de Stann Creek hace algunos años fue que el Banco Belize se hizo cargo de la finca bananera más grande, dándole el control del 40% de la industria.

Los estibadores no son trabajadores temporales. Sus ganancias por hora son sustancialmente más altas que las de otros "obreros", porque están altamente calificados, trabajan duro y se mantuvieron juntos durante generaciones. Pero las grandes empresas lo quieren todo. En lugar de levantar, el objetivo aquí es derribar, poner la mano de obra en su lugar. Esa es la historia del capitalismo en su forma más rapaz. El plan de juego estándar para las grandes empresas es romper los sindicatos y, como se ha visto en la industria de la caña de azúcar en el norte, romper las asociaciones, para que puedan tratar con los trabajadores y agricultores individualmente. El presentador de televisión que dijo que los estibadores deben despertar y darse cuenta de que "el barco ha zarpado" obviamente no entiende lo que está en juego aquí. El barco todavía está en el puerto, pero estamos saliendo de nuestro amarre, yendo a la deriva hacia convertirnos en una república bananera. Hemos visto las caravanas, personas empobrecidas en las repúblicas vecinas que recorren miles de kilómetros porque la vida en casa se ha vuelto demasiado miserable. Nos dirigimos allí si nos entregamos atados, si dejamos que las grandes empresas prevalezcan.

apropiaba de PBL era en realidad una "empresa pantalla, Private Investment Limited, registrada en la dirección de Market Square del banco (Belize Bank)". Over the past week, mass media has been abuzz over the impasse at the Port of Belize Limited. The stevedores have initiated industrial action and are justly engaged in a standoff with the management of the Port to ensure that their fair due is met. Now, as a consequence of the stevedores standing up for their rights against this fiscal giant, the country is now in a predicament. The free trade and passage of goods have been impeded, and businesses are being impacted as a result. And amid this ongoing impasse, the stevedores are being unfairly criticized and idly blamed and judged for their actions, simply because it is causing some interruptions to the flow of businesses and services. Well, I pen this piece today to implore all of you to stand with the stevedores!

As I am engaged in writing, I note that Belize's delegation attending the inauguration of the Honduran president are being warmly welcomed. They were notably quiet when prices kept climbing and soaring and the populace's spending power was being weakened and threatened day in, day out. The stevedores are standing for their rights, and if anything, we should endeavor to stand with them.

Therefore, I find it extremely repugnant that we are (made) to believe that the stevedores are the problem. The mainstream media has allowed itself to be used in the politicization of a very serious issue, which has painted and tainted the stevedores as recalcitrant. They are not. And to imply that the stevedores are holding the country hostage and as a corollary will lead to higher inflation is an untrue statement and couldn't be further from the truth. Inflation has skyrocketed over the past few months prior to this impasse and has continued unabated. The stevedores are standing for their rights ... it's a bread and butter issue. The key there, Braa, is grin and bear it. Nothing better noh deh. In his exchanges with the Lady Speaker of the House I found that Mr. Faber was too familiar, that he didn't appreciate the great difference between the sexes. But enough of that so I can express a gripe with him for his handling of the ministries of education and culture.

No, not to pile it on, but some things have to be said. I told a friend that he passed through more than a billion dollars and he didn't buy one single book from me. Really, I don't think his ministry bought one book from any Belizean writer. Vladimir Putin's annual press conference — Part 5

Very interesting to see how Russia was able to solve its economic situation and Belize has also reported that they have been able to solve theirs. But how? Is it on the back of the poor? Was it by cutting spending on welfare programs? It would be very interesting to know the truth. Anyhow, our dear readers of this column, permit me to present to you Part V of Vladimir Putin's annual press conference:

Dmitry Peskov: Let us move on. I suggest that we turn to RIA, the third of Russia's major news agencies. Mic to the central sector, please.

Yelena Glushakova: Yelena Glushakova, RIA Novosti. Mr. President, just now you were talking about social support measures, but the business side of the question is of no less importance. In your opinion, how can we balance anti-COVID restrictions with the need to keep the economy going? Not only major corporations suffer from restrictions, but small businesses too: retailers, small restaurants, cafés, small shops, the cinema industry, and the entertainment sector. If you allow me, I have a second question in this connection. How well did the governors perform? They received a lot of authority during the pandemic but used it in different ways, introducing various restrictions. In your opinion, how well did they perform? What grade would you give them for their efforts? Thank you.

Vladimir Putin: Let me start with the question on businesses and how we have been supporting them. You said that major corporations are not the only ones to suffer, and that small enterprises suffer as well. In fact, it is primarily small businesses that suffer, even if major corporations also felt some negative consequences. We devised support measures for these sectors, in fact, for all major sectors of the economy, if you remember, for all major corporations. I specifically asked the government last year, at the very beginning of the year, and the Government complied. Our key industries and major corporations have clearly benefited from a number of measures. After all, they operated without any or virtually no interruptions, and in some cases even increased their output. This is the case for the defence industry, which reported higher production volumes. As for small and medium-size enterprises – catering, gyms, cinemas, and even theatres, museums, etc., all the enterprises in the service sector – of course, they were the first to suffer. However, they were also the first to receive our support.

There was a whole range of measures. I do not know whether I need to list them all. This included subsidised loans, direct support to save jobs and wages, reduced interest rates, loan payments in installments, lease subsidies, etc. By the way, some of these measures are still in place, and you know this. We have allocated and continue to allocate large sums of money from the federal budget to this effect. The government is doing this intentionally and understands what is going on. That said, it may well be that some things should have been done in a more sophisticated and responsive manner. Still, I would like to praise my colleagues' work. After all, this is all happening in direct contact with the business community. As you know,



I recently attended events held by the Russian Union of Entrepreneurs and Industrialists and had meetings with the heads of other business associations, including those working with SMEs. Overall, these people have expressed their understanding and overall were quite positive about the government's efforts to support businesses. Incidentally, the result was not bad at all. As I have said, we overcame the crisis faster than many other world economies. Our fall was not as bad, and we came out of the crisis quicker. This is a result after all. Now, as regards... what is the second part of the question?

January 20, 2022, On elsalvador.com reported its first case of "Flurona", which is the combination of influenza and Covid-19, in a five-year-old boy. It was identified for the first time worldwide in Israel at the beginning of 2022 and thereafter spread to other countries. Now, there is no doubt that the president of Mexico, Andres Manuel Lopez Obrador, is a good statesman, since he is giving to the United States in terms of helping the refugees by giving them asylum, while at the same time buying the refinery "Deer Park" in Houston, Texas, for the good of Mexico and Mexicans. So, it seems that they want to put brothers against brothers, cousins against cousins, wives against husbands, husbands against wives, etc. What's wrong with them? In what diabolical mind is there so much evil? The vision of the great leader, the Right Hon. George Cadle Price who supposedly fought for independence from Great Britain for all Belizeans who were here in 1981 and for those also who were in foreign countries, seems to not have worked out. 





COMPOL asks businesses to place surveillance cameras on streets

Commissioner of Police Chester Williams is pleading with establishment owners to take the extra step and put surveillance cameras on the streets on which their establishments are located.

BELIZE CITY, Wed. Jan. 26, 2022

As a result of the increased presence of surveillance cameras across the country, in both businesses and domestic residences, police have had greater access to much-needed surveillance footage that has been used by the department to apprehend and convict criminals. Commissioner of Police, Chester Williams, during an interview this week, applauded those establishments that have installed cameras in their place of business, but are asking them to take it a bit further.

"We do appreciate the fact that a number of business establishments have mounted surveillance cameras inside their stores and to an extent outside. I would like to make an appeal to the business place: while yes, what you have done is good, it will be better if you can put surveillance cameras at the street in front of your establishment as well. That will identify the people when entering. You find that the perpetrators of these robberies [are], for the most part, they wouldn't walk the street with their face covered up and will cover their face when they get to the store, so if you have the camera in front, it might help pick up the person before they cover their face." said Commissioner Williams. COMPOL Williams is further asking the public to video any crime that they see happening, since such video footage can assist police in identifying the perpetrators of those crimes. "These surveillance footage have helped our investigators significantly in the terms of identifying perpetrators. We know we live in an era where witnesses and victims of crimes are afraid to come out to identify perpetrators, and so these cameras do help us to do the job that the victims or witnesses are afraid to do. We do encourage it," he said.



Government signs Medical Waste Regulations

Belize's medical waste disposal system is largely unregulated, which can prove hazardous if not remedied

According to a recent GoB press release, on November 29 of last year, the Government of Belize, through the Ministry of Sustainable Development, Climate Change and Disaster Risk Management's Department of Environment, signed the Medical Waste Regulations. These regulations are meant to ensure proper storage, transportation, treatment, and disposal of medical waste throughout the country.

In recent years, there has been growing concern across the world over the increased production of infectious medical waste as a result of the COVID-19 pandemic. And as several studies have shown, the improper management of healthcare waste can contribute to the spread of the virus. Now more than ever, proper management and disposal are needed to ensure the safety of not only patients, sanitation workers, and medical staff, but also the general public. Improper incineration or open burning of medical waste can have dire effects, both on human health and on the environment. One such effect is the production of Persistent Organic Pollutants, or POPs, which are toxic chemicals that can survive in the environment for long periods and can be harmful to humans, animals, and the environment.

According to the GoB release, the government recognizes that Belize's stakeholders were directly engaged in all major municipalities targeting all health care providers in the human health and animal health sectors. The regulations came into effect on November 29, 2021," stated the release.

As a result of the passing of these regulations, improper disposal of medical waste is now illegal, and anyone found guilty of such an offense could be fined. Additionally, those entities which generate medical waste must now keep "records of the dates, types, and amounts of medical waste generated, and the date and locations where such waste are shipped for disposal."

The release also said that the regulations take into consideration the installation of a medical waste autoclave system at the Mile 3

Transfer Station in Belize City. An autoclave system uses high-pressure steam at specific temperatures to kill off pathogens such as bacteria and viruses, and disinfects medical waste before its disposal.



Belize supports Taiwan's bid for participation in World Health Assembly

The country has been barred from attending the annual assembly since 2016 due to what it claims is Chinese interference

Taiwan's fight to secure a seat as an observer at the 75th World Health Assembly is being backed by the

Government of Belize, which, along with the Ministry of Health & Wellness, has openly expressed its support.

"Taiwan has demonstrated its ability to effectively manage the COVID-19 pandemic. The country is seen as a

model in combating the pandemic due to their highly effective early response measures, and continues to be applauded internationally, which is why Belize's support for their inclusion comes at this critical time," said the government's press release.

For the past 7 years, the Republic of China (Taiwan) has been barred from attending the annual meeting as an observer due to China's ongoing claim that the country is a part of its territory. After Taiwan's successful management of the COVID-19 crisis for a year and a half, however, calls for the country's inclusion at the WHA have increased, with several countries, including the G-7 (Britain, Canada, France, Germany, Italy, Japan and the United States), openly voicing their support for the first time last year—a move which the Chinese government referred to as "gross interference".

In May of 2021, the Taiwanese government openly criticized the World Health Organization-the agency that convenes the meeting, for "submitting to China" after it did not receive an invite. The country's foreign minister, Jau-Shieh Joseph Wu, and Health & Welfare Minister Chen Shih-Chung asserted that there should be no gap in the global public health and disease prevention system and that Taiwan's participation in the WHA would serve to benefit the global community.

In its press release, the Government of Belize noted that Taiwan has assisted many countries, including our own, in their COVID-19 response efforts through the donation of medical supplies, ventilators, PPE, and more.

"Taiwan's expertise and input will benefit all member states in the global health fight against COVID-19," it added.

Taiwan was expelled from the WHO and the WHA in 1972-a year after Beijing formally joined the United Nations. It was then allowed to attend the WHA as an observer from 2009 to 2016 but was barred from attending once President Tsai Ing-Wen was elected.

"We had the opportunity to chat with the highest level of government to understand priorities and how CABEI can actually come and assist the government in their tasks at hand," said Dr. Mossi.

"We chatted about how to expand electricity, roads, bridges, telecom, and also how to provide better services, particularly health services during this pandemic," he added.

Dr. Dante Mossi also stated that CABEI is prepared to offer loans, grants, and technical assistance to both the government and the private sector. At one of the meetings, the CEO of the Ministry of Economic Development, Dr.Osmond Martinez, remarked that the main objective of the government's partnership with CABEI is to enable a friendly environment for investment in Belize, for the expansion of existing businesses, and also for the creation of new businesses opportunities. CABEI's main priorities during their mission were seeing firsthand the areas in which the government needs assistance, establishing how to increase economic activity in the country, and advancing science and technology within the country's productive sector. According to Martinez, CABEI is also planning to provide a total of 225 scholarships for secondary education.



Celebrating Belizean patriot Beatrice Kingston 1929 - 2022

Beatrice Kingston, BK, was the firstborn of Henry Kingston and Irene Guild Kingston. Raised by her Aunt Blanch after her mother's death when she was just about 11 years old, BK and sister Olivia grew up with their maternal cousins. Her cousin Sonia Menzies fondly remembers growing up with BK and Olivia into their young adult years. Barbara Kingston, Babsy, is BK's third sister from her father's second marriage. BK was married to Joe Durant Smith until his death in 1995. Having no children of her own, BK was godmother to several men and women, including Elaine.

Cousin Sonia recalls BK's exceptional leadership and academic prowess. BK started her education at Ms. Annett Maheia's private school. She went on to St. Hilda's



College and graduated with honors. After graduation she became a teacher right at her alma mater. Her dream career took off. After teaching for some time in the high school, BK took her first journey outside of Belize to Bethlehem Training College in Jamaica to improve her qualifications. Never one to rest on her laurels, she was soon off once more to Canada, where she earned a Master's degree. BK's desire for excellence would drive her to travel two more times to England and to Barbados, all the time advancing and improving her qualifications. She spent many years as a lecturer at the Belize Teachers College. In her postretirement years, BK, the teacher, education innovator, author, and all around selfless Belizean patriot, spent many years at the Education Ministry's Quality Assurance Department (QADS) tabulating national examination test scores.

BK was a foundational woman of the Belize chapter of the Young Women's Christian Association. She served in many capacities, including president of the YWCA, over a fortyyear period. BK was a founding member, along with the late Dr. Ruby Perriot Marrith, of the Creole Association for Retrieval Retention and Promotion (CARP). CARP was one of three groups that amalgamated to form the National Kriol Council. Beatrice Kingston dedicated social service to the elders in the Crooked Tree community with on-the-ground support from Ava Tillett. Young inmates at the YEA, where she taught numeracy and literacy, benefited from BK's diligence and resources BK's stellar visionary support continued into the last decade of her life, during which she pledged and provided resources to train young adults in urban and rural gardening as one part of the Garvey Satuye Economic Initiative for sustainable development through the Beatrice Kingston Smith University Without Walls (BKSU). We will continue to honor the memory and legacy of this Belizean patriot. Beatrice Kingston, you are gone but will not be forgotten. May God be pleased with your works and bless you as you journey on.



BSI: metal, sticks, and rocks in sugar cane

extraneous material being found in the sugarcane that is being delivered to the mill. According to Communication Officer at BSI, William Neal, larger-than-usual rocks, sticks, and metals are being found during the initial phases of milling.

"It has been one month since the crop has started, and what is concerning to us at BSI is that we have seen extraneous materials, which means anything from metals to sticks, to rocks showing up more frequently in the cane that is being delivered to the mill. Because of the process for how the mill works, as the cane is being prepared, it has to go through the hammers, knives, etc., which as the name suggests for the knives, seeks to cut it in smaller portions so that it can go through the mill easier. So, obviously, when you have metal coming in, it cannot cut at the knives. Then, the hammers, which flattens the cane into something similar to what bagasse looks like as a part of the preparation for it to go through the mill itself. You have the problem that it cannot crush that at the level that it needs to be done for the preparation, and it damages the mill itself." Neal explained.

These materials can cause significant damage to the hammers and knives used to prepare the cane at the start of the process, and if they somehow slip past that point, could cause "**catastrophic**" damage to the mill and harm to the sugar crop as a whole.

"Because of the frequency and the sizes, we are seeing, in terms of metals and rocks, that BSI has felt it necessary to write the cane farmer community, but at the same time also do something publicly to register that we are extremely concerned about the extraneous matter that we see coming to the mill and the damage it could do to the mill itself," Neal stated in an interview.

This letter to the sugar cane farmers urges them to pay keener attention in the loading process to ensure that the potentially damaging material is not included in their loads of sugar cane delivered. One loading method that BSI is lobbying to ban is the use of push-pilers to load sugar cane in trucks after the cane is cut in the field. Neal explained that the use of this method results in potentially damaging material being indiscriminately picked up along with the cane.

"There has been talk of a ban for quite some years to push pilers. When the cane cutters have finished

cutting the cane, the push pilers come behind, and as the name suggests, it actually pushes and piles so that it can be loaded in the truck. Sometimes you will have rocks, etc. being picked up, but that is one of the reaping practices that actually we have been pushing to eradicate and ban completely, because when you have a weather situation, that means it increases the mud that is also being collected. It also increases the chances of rocks or metals being piled in with the cane in the first place," he said.

Currently, however, the amount of mud in the cane that is being delivered does not exceed what has typically been seen.

The sugar crop was delayed this year amid a stand-off between the Belize Sugarcane Farmers Association (BSCFA) and BSI over the terms of a new commercial agreement governing the revenueand-cost-sharing arrangement between the mill and sugar cane farmers. After days of heated protest, the government brokered the signing of an interim agreement to allow for the sugar crop, which had been scheduled to start on December 20, to commence in the first week of January. Readers would recall that BSI found a sizable rock in the sugarcane shortly after the opening of the mill. These actions, however, are not currently being classified as sabotage by BSI/ASR.

"We're not saying that they are acts of sabotage, and we are hopeful that they are not, but we are just saying that they are extremely worrisome, especially this early in the crop, because of what it could do to the overall crop itself," Neal explained.

He added that BSI was asking the Sugar Cane Production Committee to reinforce the proposal to ban push pilers and rein in those sugar cane farmers who are known, repeat offenders.

"In the interim, what we are asking also because the cane is delivered by group, we can detect which group the extraneous materials are tied to and so we are also asking the SCPC at this point to look at those frequent offenders and either figure out a way to enforce some kind of greater due diligence on their part to make sure that that is not the situation that we face at the mill because it can be catastrophic for everyone within the industry," Neal said.

CWU to GOB: Step Up!

Saturday afternoon by members of the Christian Workers Union (CWU), to which the stevedores belong. It is a standstill in operations that, according to the CWU, the stevedores had been trying to avoid, but that became a last resort after the stevedores found themselves at an apparent dead-end with the PBL enterprise in their efforts to get their concerns addressed. Ultimately, the trigger which led last Thursday to a protest by the gangs who were scheduled to unload the cargo ships was PBL's rejection of key recommendations from the stevedores' general foremenrecommendations aimed at ensuring the safety of the stevedores, many of whom find themselves working at heights of 50 or 60 feet in varying weather conditions, with dangerous equipment. That has resulted in a standoff in the industry that could affect the supply chain of a number of local retailers. But at a Christian Workers Union (CWU) press conference that was streamed online yesterday, the union's president, Evan "Mose" Hyde, said that it didn't have to come to this.

And in contrast to what was suggested in an apparent media blitz featuring Chamber of Commerce representatives—a series of statements and video bytes that seemed to create an impression in the public's mind that the high prices being seen in stores for over a year are somehow the fault of the stevedores—Hyde pointed to a number of players that have contributed to the

current situation: the PBL, a private entity whose affiliates have spent more money (reportedly \$10 million) preparing a plan for a cruise terminal at the port, that has so far not been approved, than it is willing to spend to compensate stevedores due to the loss of their earnings (\$5 million); and a government that has willingly overlooked a memorandum signed years ago that possibly made the transfer of sugar-loading to Big Creek illegal, and which has not seemed willing to step in to broker a truce for the stevedores as it has readily done in the sugar industry. The purpose of the press conference was to show the public that the stevedores were willing to negotiate and consider offers that are serious, in contrast to recent proposals by PBL that seemed aimed at mocking and insulting them. He, in fact, pleaded, on behalf of the stevedores, for the government to get involved in mediating the negotiationssomething that is in fact its duty.

Hyde stated at the press conference that since the stand-off on Thursday, a number of meetings were held between the CWU, PBL, the Belize Port Authority, and even the new Minister responsible for Public Utilities and Logistics, Hon. Michel Chebat, to resolve the issue. According to Hyde, all those meetings were fruitless. "Unfortunately, proposals about reducing the number of gangs, and comments made in the media by the receivership's management concerning issues surrounding the loss of sugar earnings, exacerbated open wounds and has now placed the unresolved gridlock negotiations of finding a financial

settlement in the aftermath of the sugar lost, in the front and center of everything," he said.

According to Hyde, what the Port of Belize Ltd. has been suggesting is that the stevedores consent to the reduction of the number of workers in each gang from 8 to 6, so that those stevedores who are not terminated can work longer hours and thus make more money. In other words, the PBL said that some stevedores could make more money if they accepted what many would see as an act of treachery—consenting to the exclusion of 28 stevedores (since each gang includes 14 persons) so that the others who remain can earn more. Hyde compared what was being suggested to abandoning some of one's brothersleaving them to perish in the desert—so that a few could be guaranteed more water. The unions have made their stance on this suggested act of disloyalty clear, stating that this suggestion is not only unacceptable but also preposterous. They also rejected a proposal that they be compensated with their own retirement earnings-in other words, being paid with what is already theirs.

Hyde went on to state that the union believes that looking back is important to understand the current scenario-where a private entity is wielding power over an essential utility that is for the public good, and is making decisions designed to maximize its profits rather than ensure public welfare. He pointed to the privatization of the PBL almost 20 years ago, and the subsequent placement of the port, a little over a decade ago, under a receivership-when, according to knowledgeable sources, the Ashcroftowned Belize Bank became a receiver in control of the port, which is an arrangement that was not to have lasted for such a long time. That privatization of the port was what he called the original sin. In his remarks, Hyde said, "We believe the way forward is to look backward and to let history guide our judgment and our consciences. To understand now, where we are right now, you must understand the privatization of the port. We put this matter squarely in the hands of the Briceño administration. Our membership has borne the worst of the anguish caused by that original sin."

In February 2019, the Government of Belize sanctioned a loan to BSI of US \$15 million dollars delivered from IDB Invest, an institution that is a private arm of the IDB Group. According to the release issued by the IDB, the loan was earmarked to "increase its production and exports of higher value-added sugars, diversifying its export markets and strengthening its value chain." Hyde said that the investment funded BSI/ASR's move to Big Creek. This loan was backed by the government to help the sugar cane industry mitigate transportation costs. "CWU cannot argue that the wellbeing of our brothers and sisters in the cane industry is not of national importance. What we are arguing today, is that the plight of our brothers and their families who now sit in the sewer tanks of your privatization adventures are of national importance as well," he stated. Hyde, in tracing the timeline that led to the current situation, went on to note that the union, after becoming aware of rumors of a relocation of sugar-loading to Big Creek, wrote to Prime Minister John Briceño in May 2021 to outline the problems brewing on their end. He said a month passed before the PM responded—after stevedores brought unloading/loading of the sugar boats to a halt. The CWU then wrote to the Department of Labor in July 2021, issuing a notice of industrial action, after which, on the 21st of that same month following a meeting with the various parties, they agreed to negotiate on the matter in the presence of the Ministry of Labor.

The Ministry then decided to pull out of those negotiations and announced that the Essential Services Arbitration Tribunal would take over the issue, and the union rejected this apparent withdrawal of the government from the process and requested that its sister union, the NTUCB, withdraw its representative from the tribunal in support of the CWU. The Labor Ministry eventually returned to chair the tribunal, but in the words of the CWU president, the negotiations "failed miserably."

"To be refused compensation in a negotiation is not unique, but to have as the final offer given to us a proposal that featured the issue of a percentage of our members' earned retirement entitlements conditional on the reduction of stevedore gangs. An absolutely grotesquely timed suggestion, the equivalent of which is to meet a group of brothers struggling with thirst in the desert and to inform them that there would be a little bit of water available on the condition that they would leave some of those brothers behind," Hyde stated in reference to those proposals, which were seen by the union members as an insult. He went on to note that this proposal was the proverbial straw that broke the camel's back, and as a result, the membership voted for industrial action on November 24, 2021. It has been noted, however, by longtime stevedore Guy Neal that there was unwillingness on the part of the stevedores to engage in industrial action immediately, since such a move would have been disruptive to the heightened commerce (as well as the customary receipt by Belizeans of items from abroad) during the Christmas season.

Hyde said that at that point, the members, although they had already voted for industrial action, requested yet another meeting with the Prime Minister in an effort to seek his intervention.

"We met with the Prime Minister and we informed him of the vote for industrial action. We informed him about the proposal that was made to us, and that the proposal included a condition that we should reduce the number of gangs; we asked him to intervene. The PM met with the receivership's management, and then met with us a week later and informed us that their position remained the same," Hyde said. The CWU is not accepting the proposal from the PBL or the fact that they are unwilling to agree to a sugar compensation package. For the stevedores, receiving this compensation for the earnings lost as a result of the relocation of the sugar-loading operations to the Big Creek port, despite the presence of a memorandum that should have prevented this, is a primary issue and one that cannot be swept under the rug. "What we would hope for is that there comes a point where they accept that you

can't just simply say 'get away with unu desire fi have some remedy fi the fact that sugar gone down south'. We have to move from there, so we di put the ball pan the court and we di say to the state, do the work," Hyde said.

He said that this option to shut down the port, contrary to what is being portrayed in some quarters, is not an easy one for the stevedores, who are suffering loss of earnings as a result, and putting their livelihood at risk in order to get key decision-makers to seriously respond to their calls for fairness. In fact, he said that those workers are more focused on, and desirous of, continued generation of income.

"All we want is for the people out there to understand that we never run down this. We never run this down. We run down the big people inna the country, we run down trying to find solutions, we run down meetings, we run down negotiations—we show up da every single one, we nuh run down shutdown," Hyde stated, in an effort to make it clear that the stevedores are not seeking to cause financial harm to the public.

On Monday, the Belize Chamber of Commerce and Industry (BCCI) released a statement urging the parties to resolve the issue using the Essential Services Arbitration Tribunal, and highlighted a number of negative impacts that could result from the standoff at the port. President of BCCI, Marissa Longsworth, said that at least 700 containers full of supplies will not be cleared this week if the issue continues. This, she said, will include "essential supplies, medical supplies, pharmaceuticals, inputs for those businesses here that create goods for the local market, and the export market." The BCCI further noted that some exporters have also been reporting that containers with their items are stuck at the port amid the stand-off. This could prevent them from meeting their delivery obligations, and ultimately affect our foreign exchange earnings, said BCCI.

The comments made by the BCCI have led to a portrayal of the stevedores, following a standoff of just a few days, as the cause of high prices that have been plaguing the Belizean public for over a year. Hyde noted that this was a primary reason for their decision to directly address Belizeans.

He remarked, "Now da we wahn blame fi inflation! Stevedores wahn responsible for inflation? Da stevedores [responsible] fi the price of gas? Da stevedores responsible for how the tax structure deh pahn gas? Da stevedores responsible fi that fact that they can't find truckers, they can't find containers globally? But quickly, oh, da stevedores responsible for the gouging weh di go on inna shops."

He then called out the BCCI, which so readily sounded alarm about a standoff that has so far lasted just a few days, for being noticeably silent about alleged "price-gouging" that has been taking place in stores for almost two years—with prices of some items at times almost doubling over the course of a week. At best, it could be seen as inconsistency on the BCCI's part. Hyde went on to ask what the BCCI, which has been so vocal and visible over the past week, had done to condemn such gouging. "But quickly, oh da stevedores responsible for the gouging weh di go on inna shops. BCCI had anything fi say about the gouging? BCCI say [anything] about the gouging? BCCI come pan the radio and fight down that fact that when unu go da wahn store, overnight ih gone from 2 dollars to 4 dollars? BCCI nuh say a damn thing about that! But now, stevedores fi blame ... we come fight against that, people ..., "Hyde exclaimed.

He explained, "We come yah fi say we inna wahn forced marriage from 2003, 2004—weh part yo da say da wahn shotgun marriage. Weh part it's built on no love, and every two years da this, da nuh because stevedores bad privatization fail! This thing lock up inna wahn receivership right now. Fi nearly 12 years, this da weh fi we members di deal; and every time we have to stand, they make it seem like, bwuay, stevedores di manufacture wahn issue, di manufacture problem, di manufacture shutdown."

He added, "We are here to face anybody right now and answer them as best we can, so that you, you out there di listen, know that we nuh wahn hurry come up, fi come shut down no port. We nuh run down conflict; our member run down money, our members run down the hustle. They run down work, our member run down container ship."

"Man deh out deh di dog see if somebody nuh show up so they could get a chance," he pointed out.

"Dat da weh they into. They nuh into shutdown, they nuh into have to face BDF di look fi move containers. They nuh into man di tell them right now, 'bwuay, all unu ship gweyn da Big Creek'. Just imagine that. You best believe all our members have been told that, so the stance weh they di tek right now, just imagine what it takes for them to take that," he said.

The CWU's call is for the Government of Belize to do its part to resolve this situation. "We are at an extremely bad spot; our membership feels cornered. We are being told all manner of things. We believe that its duty, we believe that it's a responsibility, not just because of the Constitution, but because this is not just your everyday company having problems with its workers. This is a company under a receivership that exists because, it only exists as a private company because of a decision made by the Government of Belize; and whether it happen 50 years ago, 30 years ago, in this case, it happen 20 years ago, does not unhitch you from the responsibility of that action," Hyde said.

Today, Hyde informed the media that the union was presented a verbal proposal re the sugar redundancy package, and that they met with the Essential Services Tribunal who handed down a synopsis of their rulings following the rebuttal submission from the parties. Hyde outlined that the tribunal made a ruling on the matter of primary substitutes, and they were to be confirmed to their respective gangs. Hyde said the tribunal ruled that the parties should negotiate the redundancy package based on their prior agreement, but the union can't act because they have nothing in writing, and they "don't know what the position of the employer is on these rulings."

A meeting was held this afternoon between the members of the CWU, Minister Chebat, and PBL. We will continue to follow.

Maya Leaders reject GOB's FPIC protocol

protocol and that the document, since sent to the Caribbean Court of Justice (CCJ), does not have the consent of the Mayan people.

"The protocol was sent out to the Caribbean Court of Justice by way of a surprise to us. We have not seen this protocol; it has not been consulted with us, and it certainly does not carry our consent as the appellants to the CCJ consent order." Coc said.

Coc went on to state that they have not had a chance to thoroughly look at revisions that have been put in this version of the FPIC protocol but are basically unilaterally made it a protocol that for the most part is sympathetic to the desirous initiative of the Government and not the Maya people," Coc said.

When pressed on whether or not any consultations were carried out in furtherance of the finalization of this FPIC, Coc reiterated that the government failed to carry out the necessary discussions.

"No, no consultation has been had. This is a clear ambush on the Maya people, no consultation has happened. We are seeing for the first time, just like you, that an FPIC protocol has been approved by the Cabinet, and it is only until today, that the Commissioner, Greg Ch'oc, has sent to us this version of the FPIC protocol," Coc said. Greg Ch'oc is the Commissioner of Indigenous People's Affairs, the liaison between the Mayan communities and the Government of Belize. She claimed that the TAA, the appellants to the order, have been subject to direct attacks from institutions put in place to oversee the implementation of the FPIC protocol. "It's very disheartening to learn that, despite all the effort that the Maya people made, despite our patience, we have been waiting for almost 7 years to see the implementation of this consent order and it has been painstakingly slow. We had a lot of hope with the new administration in place; unfortunately, we continue to see an immediate dismissal and undermining of the implementation process and a particular attack on the Toledo Alcaldes Association, the appellants to this order, by the institutions that have been put in place to oversee the implementation, particularly by the Commissioner of Indigenous People's Affairs. So what does this mean for our struggle moving forward? It certainly means that this latest move certainly is damaging to an already strained relationship that the Maya people have had with this government," Coc remarked.

She informed AMANDALA that their next step is to hear from the leaders of the various Maya communities in order to determine their collective position so that they can plan the way forward.

She went on to express the view that

under a collective traditional governance institution. He is very aware of the Toledo Alcaldes Association and the importance of preserving our governance system here in the Maya communities of southern Belize," Coc asserted.

In the 2005 Standard Setting document on Legal Commentary of the concept of Free, Prior, and Informed Consent published by the Commission on Human Rights, they cited the Belize Maya Land Rights Case and outlined the following.

"Most recently, in the Maya Indigenous Communities case, dealing with Maya land rights in their traditional territories in the south of Belize, within which the government had granted oil exploration and logging concession, the Commission found that granting such concessions 'without effective consultations with and the informed consent of the Maya people' constituted a violation of human rights guarantees. The Commission reaffirmed that international law upholds indigenous peoples' land and resource rights, independent of domestic law, and held that one of the central elements to the protection of indigenous property rights is the requirement that states undertake effective and fully informed consultations with indigenous communities ... [these rights] specially oblige a member state to ensure ... a process of fully informed consent on the part of the indigenous community as a whole."

already seeing glaring red flags.

"Just on the surface, we immediately flag that the Government is calling it a consultation protocol, and even in the body and language of the protocol, it continues to use this ambiguous term of consultation rather than consent, which is what is ultimately the safeguard," she pointed out. She added that the protocol does not meet the requirements of the CCJ's 2015 order, since the court at the last compliance hearing made it clear to the government that meaningful and timely consultations were to be carried out with the appellants, the MLA and TAA.

"They've made it very clear that the signatories to this consent protocol would be the appellants, the parties to the CCJ consent order, and until these parties have signed on to this protocol, it comes into effect. The government has this decision made by the government to submit what she considers a unilateral FPIC protocol to the CCJ is clearly an attempt to remove the traditional governance of the Maya people.

"I just want to make it very clear that despite the appearance, or what the perception out there might be, it is very clear that this government is attempting to remove and erase the traditional governance institution of the Maya people, which is very dangerous and damaging to the process of implementation. It is very clear to us that the government wants to move ahead unilaterally without the appellant in this matter, and that continues to be a grave concern for us, especially knowing that the Commissioner of Indigenous People's Affairs, Mr. Ch'oc, is fully knowledgeable and aware of the way in which Maya people organize themselves
