# Borders reopen on Feb 7, ONLY for fully vaxxed

BELIZE CITY, Thurs. Feb. 3, 2022

After several postponements of the reopening of the country's land borders, which was first set to take place in the first week of January, before being postponed to February 1, the Government has now set February 7, next Monday, as the tentative date for the reopening. Today, the Minister of Health and Wellness, Hon. Kevin Bernard, gave the media details on the reopening and announced that only fully vaccinated persons will be allowed to cross the land borders into Mexico and Guatemala.

"Certain things are being added to the SI: one, that the border will open from 6:00 a.m. to 10:00 p.m. daily. Belizeans exiting the border must be

fully vaccinated. It will be open for only fully vaccinated persons at this point in time. Upon re-entry to Belize, once you are less than 24 hours, there will be no need for you to test, but there will be information provided to those persons by the health personnel in case there are any

### CCJ sends back BLDC v AG case

The CCJ says the Belmopan Land Development Corporation v the Attorney General of Belize case has been sent back due to lack of evidence

BELIZE CITY, Wed. Feb. 2, 2022

The Caribbean Court of Justice (CCJ), in a judgment issued at a virtual hearing on January 31, 2022, ruled that the Belmopan Land Development Corporation (BLDC) v the Attorney General case is to be remitted to the Supreme Court of Belize, where further evidence must be made available. The ruling mirrors the conclusions of Belize's Appeal Court, which had heard the government's appeal on July 21 of a Supreme Court order to pay BLDC a total of 16 million dollars, and had indicated, after reviewing the evidence of both parties, that more evidence was needed. At the heart of the case is an effort by the company, which owns 2,647 acres of land near Belmopan (in the vicinity of Cotton Tree village) to seek a higher peracre payment from government for 1394 acres of that land which government had expropriated and, to some extent, distributed.

The company had not objected to this move by the then Barrow administrations, which had been distributing parcels of that land since 2013, but had insisted on receiving payment that reflected fair market values. The core issue on which the ultimate outcome of the case will hinge is whether what GoB has paid to BLDC for the expropriated land is fair or whether the company should receive the additional 11 million dollars that it is seeking.

That amount is based on an assessment by BLDC's expert witness who, when the case was taken to the Supreme Court, assigned a value of \$11,000-per-acre to the land, which the judge presiding over the case, current Acting Chief Justice Michelle Arana, had accepted as the for calculating basis compensation that GoB was ordered to pay. The government (which had found its own land valuation expert, who provided much lower estimates of the value of the land) later appealed the ruling in the Court of Appeal, and finally the case was taken to the CCJ, which upheld the Appeal Court order that further evidence from the government's expert witness be taken back to the Supreme Court.

The legal dispute can be traced back to a breakdown in negotiations Belmopan between Land Development Corporation (BLDC) and the government during their efforts to reach an agreement on the fair market value of the 1,394 acres of private property that had been acquired by GoB for distribution. BLDC then filed a constitutional action claiming damages.

The huge gap between what the GoB considered to be fair value and the much larger amount being demanded by the company can be attributed to the difference in the way the two parties have classified the property. BLDC's land appraiser valued the property as 'city



expansion' land that is sold at a much higher price than plots of land designated as being rural or well outside city limits. He thus estimated that a fair price for the land would be \$11,549 per acre, which would require a total payment of \$16,099,306.00 BZD to the company. The trial judge presiding over the matter in the Supreme Court, Justice Michelle Arana, had accepted the expert opinion. However, GoB, in the face of that \$16 million price tag, had appealed the ruling. The Court of Appeal, and later the CCJ, would both reach the conclusion that the methodology and assumptions used by the BLDC's valuer to estimate the price of the land was flawed and the case should be remitted to the Supreme Court for further evidence to be put forward.

President Saunders and Justices Wit and Jamadar all asserted in their judgment that the BLDC valuer's evidence was tainted because the value that he assigned to the lands was premised on his belief that the land was acquired by GoB for the purpose of "city expansion" —an assumption that they considered unjustified. He thus assigned prices to the expropriated land that were equivalent to what was being paid for the purchase of commercial land in the City of Belmopan, and the justices objected to this system of valuation.

It is to be noted that although the majority of the CCJ judges were of the view that the evidence was tainted, the Court's minority (Justices Anderson and Burgess) concluded that there was no basis for rejecting the expert evidence that had been accepted by the Supreme Court judge, since the expert had not relied on unacceptable hearsay evidence.

As previously mentioned, the Court remitted the case to the Supreme Court for further review. The Court has ordered GoB to pay an interim payment to BLDC in the sum of \$6 million BZD with interest on that sum at 6% per annum from 1 January 2014, less any payments that GoB has already made to the company. It was also ruled that the government should

make all efforts, at its own expense, to survey and delineate the land it acquired from BLDC within a reasonable time so that the land can be transferred by the company to GoB. Costs were awarded to BLDC.

The Court was presided over by the Hon. Justice Saunders (CCJ president) and the Hon. Justices Wit, Anderson, Burgess, and Jamadar. BLDC was represented by Naima Barrow of Barrow and Co. LLP and the government by Assistant Solicitor General Samantha Matute-Tucker and attorney Briana Williams.

Interestingly, the property in question was seen by grassroots activist Nigel Petillo as ideal for distribution to landless Belizeans. Petillo, who played a key role years ago in the establishment of Harmonyville, had organized a number of gatherings of Belizeans in need of land at the height of the COVID-19 pandemic, and at those meetings he had insisted that the property was idle land formerly owned by an Asian national who had presumably left the country. After a huge number of persons converged on the land, a representative of the BLDC, Glen Ysaguirre, former Governor of the Central Bank, took to the media and stated, "Belmopan Land Development Corporation and its shareholders from mid to early 90s. So it's been with that company for over twenty-five years or more and it's titled property. They actually held titles for about two thousand, six hundred acres ... My objective and intent was to establish publicly, for all those concerned and seem to have their eyes on that property, that that's a property with active ownership and that we will protect and defend our ownership and rights in that property".

### Minister Espat: Full salary for public workers a priority

BELIZE CITY, Thurs. Feb. 3, 2022

When questioned by a local reporter about the upcoming national budget for the year 2022, Minister of Infrastructural Development and Housing, Hon. Julius Espat stated that the first thing he would clamor for is a reinstatement of the 10% portion of the salaries of public servants that was deducted as part of a GoB cost-reduction effort.

"The first thing I would clamor for is that the salaries are given back to the people from whom the ten percent was taken. So, you're asking me, I would strongly, strongly ask for that to be returned before we do anything else. So if we have to do any kind of negotiation for that to happen, that's a priority in my point of view. I work with public servants that are working extremely hard, over time, not collecting the overtime, and working with ten percent less, and they have given the Ministry of Infrastructure Development their all in 2021, and so it is our responsibility to fight for them to at least get back to the norm

and then fight for them to get more. To me, that's the priority." Espat said.

Espat has long been an advocate for the proper funding of the oversight bodies across the government spectrum, and has been particularly vocal about the need for proper funding of the Integrity Commission, Public Accounts Committee, and the Office of the Auditor General and Contractor General. He told local reporters that the Attorney General is currently carrying out a review of draft legislation from the former Auditor General, which includes suggestions to make the office of the Auditor General independent.

"The Auditor General made an incredible report to us about two Cabinet [meetings] ago. She came and gave a detailed analysis of what she found when she was there, and she gave us a draft proposed legislation on how to make sure that the Office of the Auditor General is independent. Cabinet received it extremely well, and we have forwarded it to the Attorney General, so she will go

through the legal parameters to see if what they are proposing are in line with the Constitution," he explained.

"... at that meeting and in public I have been quite vocal that I believe that the Judiciary, which we know should be independent, but also the oversight bodies. That is why I fought for PAC (Public Accounts Commission) to be able to—you see to be independent you do it in various ways. One is financial independence, which is what I believe the Auditor General needs so that she can be able to not have to go beg a minister to do

something, and also have the ability to hire her own staff. That, I believe, is critical. That is part of the proposed legislation, and I support that. Then you have the PAC, another issue to deal with oversight. That one was not a financial aspect initially, but it will become also, so have managed to have PAC reconstituted where it's a bi-cameral (assembly). It is also to hold the hearings in public and then the next step will be to give PAC similar to what the Auditor General is requesting," Espat further commented.

Magali Marin Young, has said this law is being introduced to increase the culpability of rogue social media pages and fringe media operations, the new law will directly affect the work of professional media houses across the country. Of note, as highlighted by the news director of 7News, Jules Vasquez, no consultation was done with the media on this new law.

When asked yesterday by 7News about the lack of consultation, Hon. Espat acknowledged that those consultations with the media should have taken place, but he expects those talks to occur following the first reading, which is supposedly scheduled for this Friday.

"Definitely you should be consulted. That's why it's only the first

reading in the House, so that has to go to committee and if you all have any objections, if you all have any issues with it, this is the time. But I believe you should have been consulted before, and if it wasn't done, then let's make sure that it's done, but it's not a legislation that we passed through in 3 readings. There is ample time. Let's look at which committee it goes to. I could give you that information if you don't have it, and then you all have to do your part. I remember when we were in PAC, the media was asking all kinds of questions as to why they couldn't come into the meetings and stuff like that, so let's be proactive on both sides." Espat said.

Cabinet has stated that the purpose of the new legislation is to modernize the libel and slander tort law and strike a balance between freedom of speech and the protection, through possible prosecution, of those who might be subject to unjustified injury to their reputation.

### "Elderly man" assaulted in video is 47 years old

Almost everyone who saw a video that surfaced last weekend of a frail man being assaulted with a bat in Belmopan, had believed that the victim of the attack was a senior citizen, and the perceived assault of an elderly person had stirred widespread public outrage. The Police Department had even sought public assistance in their efforts to locate the injured man. However, police have revealed that they located the victim in question but have discovered that he is, in fact, not elderly. According to police reports, the man—who has refused to make a formal report—is 47years-old.

In the video footage, seen by a number of Belizeans, the man is seen being hit in the head and body with a

metal bat until he lost consciousness. It drew so much attention that Commissioner of Police, Chester Williams, spoke out against it, calling the act disgusting. The National Council on Ageing also responded to the video, issuing a press release condemning all acts of violence against the elderly and urging the public to take a stand against it. Shortly after, the police urged the public to report any information they might have had regarding the victim or the perpetrators.

Even though the victim was not in fact a senior citizen, however, what has not changed is the fact that a heinous act of violence was committed. Earlier in the week, Crime Stoppers Belize reached out to the public, asking for any information regarding the assailant in the video. The police continue to investigate.

### **Belmopan busito drivers angry** about random checkpoint

On Tuesday morning, February 1, busitos (minibuses that are a mode of transportation for many who commute to Belmopan) were brought to a half-an-hour halt by an unannounced checkpoint at the entrance to Belmopan near the Agriculture and Trade Show Grounds—causing a disruption in the schedules of a number of commuters. Drivers of the minibuses were caught off guard, and have since noted that they usually receive a notification from the Transport Department about any scheduled checkpoints.

Selvin Romero, Secretary of the Western Mini Bus Cooperative, told local reporters that he believes that the checkpoint was put in place at an inappropriate time, when commuters were trying to get to work. "It was a very unfortunate event in which we were not informed of this checkpoint where each unit from the Western

Mini Bus would have been inspected. I believe it's unfortunate due to the fact that of the time and the place. It's the time where commuters are in urgency of reaching work, they have their bosses and that the precise moment, you unload them and they would take about twenty to thirty minutes to inspect the vehicle. Some commuters were very upset. They even asked our warden, 'What's happening with the busitos?" he said.

He further commented, "It wasn't our fault; we were just pulled over. We were just inspected with prior notification. Nobody was prepared, nobody was informed, any member, any driver. So indeed it was a very unfortunate event for us as [the] Western Mini Bus Cooperative.".

According to Romero, this is the first time he has encountered a checkpoint that has been randomly set up at a time of day that is a critical point in the schedule of commuters. In the past, such inspections which were done at the checkpoint would have been carried out while buses are stationary, he said. "The last time they did [the check-up], but they did here in the parking [lot]. The vehicles were not moving, and it's not like they're going to check brakes light; they just checked the interior, the seats, fire extinguishers and that's about it," he pointed out.

Romero said they're scheduling a meeting with the Department of Transport in an effort to resolve the issue prior to any future checks.

We reached out for a comment from the Ministry of Transport, but have so far we have not received any response.

### **Worker at Trial Farm** bakery shot in the head

An employee of an Orange Walk bakery is currently in the hospital with a bullet lodged in his head after a gunman outside the bakery aimed several shots at him as he worked inside. On the night of Monday, January 31, twenty-one-year-old Hernan Arturo Godoy was packing bread at Cal's bakery in Trial Farm when a lone gunman opened fire. The barrage of bullets penetrated the windows of the bakery, and one of them hit Godoy in the head.

Godoy's employer, who was nearby at the time, said that she heard five shots but initially thought that they were "palomitas" or firecrackers. Upon investigating, however, she found Godoy covered in blood. He was taken to the Northern Regional Hospital by the police and a CT scan revealed that the bullet was still lodged in the right side of his forehead.

According to his employer, Godoy had been working at the bakery for about two years. He is not known to be a confrontational person, she said, and he had no known enemies.

### **BAS: PM Briceño not maintaining** investor confidence

Farms Limited was set ablaze in early January of this year.

The first cause for concern mentioned by the BAS Group was that events over the past two months have shown that the government has not been enforcing the law when criminal acts are committed against investors and their investments. As a result, a mounting lack of confidence in law enforcement and judicial processes on the part of investors has led some of them to the decision to "fend for themselves".

"It is recommended that government become more proactive in the application of the law in defense of these investments and denounce any criminal act perpetrated against investors," stated the letter.

It then went on to detail the group's second issue, regarding "Antiquated Regulation that Hinder Industry Grown and Modernization." According to the BAS Group, current regulations in the agricultural processing fields are burdensome and are restricting growth of most of Belize's traditional agricultural industries. The group recommended that the government implement full or partial deregulation of several Acts after consultation with stakeholders and producers. Those Acts include the Citrus (Processing and Production) Act, the Sugar Cane Industry (Control) Act, the Banana Industry Act, the Pesticides Control Act, and the Grain Act.

Lastly, the letter brought up the issue of "Clear and Consistent Application of Tax Laws and Incentivized Tax

Systems for Exports", noting the inconsistencies in the application of tax laws across the agro-productive sector. The letter cited General Sales Tax (GST) refunds as an example, pointing out that the investors represented by the letter are owed several million dollars in tax refunds.

"The current investment climate has had the effect of slowing or stopping future investment in Belize. The slowdown and/or halt in investment will have significant effects on the local economy and employment. We respectfully ask that the GoB considers quick action to protect our investments and rebuild the trust and confidence that first brought these investments to Belize," said the letter.

The BAS Group also expressed its willingness to work with GoB and to advise the government how to resolve all the issues raised.

When asked about the letter during an interview last week, Deputy Prime Minister Hon. Cordel Hyde said that he was surprised, in light of the fact that the government has constantly been engaged with investors and agroproducers.

"As a government, we have been in communication constantly with the business community, with the agroproducers. We have not thrown them by the wayside. We have been very committed to trying to make the environment as conducive to their investment as possible," said Hyde. The Deputy PM also said that he is certain the government will be very responsive to whatever concerns the group has been voicing.

### Too many roads lead to Big Creek

Panama Disease devastated Belize's banana industry in the 1920s, and it was not until the 1970s, with the introduction of Grand Nain, a variety of banana that has resistance to the disease, that farmers, with tremendous support from the Government of Belize, got the courage to start planting bananas commercially again. This was the age of Belize's Green Revolution, a period when much of our government's investments were going into agriculture, a period when farmers' cooperatives were on the rise.

A United Nations Food and Agriculture Organization report says the Banana Growers' Association was set up in 1971, and "in 1972 a plan was put forward to rehabilitate existing banana farms to ship to the U.K." The Banana Control Board received a loan from the Caribbean Development Bank in 1973, and "farm units of 30-60 acres were given to tenant farmers making a total of 1,326 acres by 1974."

The fledgling banana industry had its share of teething pains, and it didn't help that it was hit by a couple hurricanes. In the early 1980s the industry was struggling, and when a UDP government came to power in 1984, it found the industry several millions of dollars in debt. The UDP's solution was to sell it. Thus, under a UDP government in 1985, the entire banana industry fell into the control of a few large farmers.

In explaining the UDP government's decision, the big farmers said they had greater vision than the smaller ones. But the fact is that the UDP 1984-89 did not favor collectivism. The UDP's big sponsor was USAID; the UDP put much emphasis on sales of passports to rich Chinese citizens who were

supposed to come to Belize and make major investments; and the UDP increased private ownership of the nation's only telecommunications company, BTL, to 49%. By the time the UDP was booted from office in 1989, farmers' cooperatives were on life support. The PUP government which took over came not to revive collectivism, but to finish it off.

Since taking full control of the banana industry, the large farmers have had great success. Banana plantations owned by the big boys now cover 6,500 acres in South Stann Creek and North Toledo, and they have a share of, or full control of, all associated businesses, including the port at Big Creek.

Initially, the port in Big Creek was limited to handling exports of bananas, and supplies of fertilizers and pesticides from Guatemala and Honduras for the plantations, but ever since a minister (or ministers) in a PUP government during the Musa administrations gave them the green light to get involved in other businesses, growth at the port has been rapid. Massive investments have flowed in to deepen the channel, expand storage capacity, and purchase modern equipment to increase efficiency.

Presently, at the Port of Big Creek – Toledo Enterprises Ltd. (PBCTEL) in South Stann Creek/North Toledo, are the old tanks that were used to store fuel from Venezuela that came in under the Petro Caribe Program; tanks that store crude oil for BNE; tanks that store butane, after a government gave monopoly control of imports of that product to an associated group; warehouses that store sugar and molasses produced by Santander, a new sugar company in the Cayo District; and facilities for the storage of sugar coming all the way from ASR/BSI in Orange Walk, after the sugar producers in the north made the incredible decision to truck their products across country all the way down south, instead of by sea to the port in Belize City, Port of Belize Ltd. (PBL), which it had been doing for many decades.

Business might be slow in other parts of Belize, but it is booming in Big Creek. The listed major shareholders of PBCTEL are Belizeans, so its success should be a plus all around for the country. Unfortunately, not all of its businesses make sense for Belize. In regard to its role as the nation's number one handler of crude petroleum exports and butane imports, the port in Big Creek is perfectly suited, being set in a lagoon. If there should be a spill, the impact would be far less than it would be if the port was set by the sea. In regard to the handling of sugar, however, there are concerns.

This year PBCTEL will handle an estimated 75,000 tons of sugar and 30,000 tons of molasses produced by Santander. PBCTEL will also handle most of the sugar and molasses produced by ASR/BSI. In 2017, ASR/BSI produced over 140,000 tons of sugar and 40,000 tons of molasses.

The wear and tear on Belize's highways that will be caused by transporting over 200,000 tons of sugar and molasses can't be ignored, because it costs Belize almost \$2 million to rehabilitate a mile on the George Price Highway, and it is costing almost \$4 million to deliver a mile on the Manuel Esquivel Coastal Road. Sugar and molasses from Santander are being transported over 100 miles, to the port in Big Creek, when the distance to PBL in Belize City is about 45 miles. Sugar and molasses from ASR/BSI, which used to be transported by barge, will be transported over 150 miles, to the port in Big Creek, when the route by road to PBL in Belize City is about a third of that distance.

Why are sugar and molasses from Santander and ASR/BSI pounding holes on Belize's highways and roads? This is a story as disturbing as the BTL saga, which saw Belize sell its most prized asset for a song, and buy it back for the entire orchestra. What is the reason for bypassing PBL? Is it because the receiver at PBL must have a cruise port in Belize City, even if our environmentalists say dredging to berth giant cruise ships is unsound and our tourism experts say the increased visitors brought in by a new cruise port will damage our product? Is it to deal a final blow to end unionized labor in Belize?

If sugar producers insist on bypassing PBL, there is a port in Commerce Bight, Stann Creek, which is almost 50 miles closer for their products than the port in Big Creek. At this time, Commerce Bight, our country's only natural deep water port, languishes; its pier, which handled shipments of citrus products up to the turn of the last century, in a state of disrepair, and its ownership in confusion. Our country would realize considerable savings if this port was refurbished and sugar and molasses were shipped through it.

Belize is dependent on agricultural exports, but there are many other contributors to our economy. There is crushing poverty in our country, and we are wasting millions transporting sugar and molasses by road, all the way to Big Creek.



# Demasiados caminos conducen a Big Creek

El Mal de Panamá devastó la industria bananera de Belize en la década de 1920, y no fue sino hasta la década de 1970, con la introducción de Grand Nain, una variedad de banano resistente a la enfermedad, que los agricultores, con el tremendo apoyo del Gobierno de Belize, tuvieron el coraje de empezar a plantar bananos comercialmente de nuevo. Esta fue la era de la Revolución Verde de Belize, un período en el que gran parte de las inversiones de nuestro gobierno se destinaron a la agricultura, un período en el que las cooperativas de agricultores estaban en auge.

Un informe de la Organización de las Naciones Unidas para la Agricultura y la Alimentación dice que la Asociación de Cultivadores de Banano se estableció en 1971, y "en 1972 se presentó un plan para rehabilitar las existentes fincas de banano para enviarlas al Reino Unido". La Junta de Control del Banano recibió un préstamo del Banco de Desarrollo del Caribe en 1973, y "se entregaron unidades agrícolas de 30 a 60 acres a agricultores arrendatarios, lo que hizo un total de 1,326 acres en 1974".

La incipiente industria bananera tuvo su parte de dolores de dentición, y no ayudó que fuera golpeada por un par de huracanes. A principios de la década de 1980, la industria estaba en dificultades, y cuando un gobierno UDP llegó al poder en 1984, encontró que la industria tenía una deuda de varios millones de dólares. La solución del UDP fue venderla. Así, bajo un gobierno UDP en 1985, toda la industria bananera cayó bajo el control de unos pocos grandes agricultores.

Al explicar la decisión del gobierno UDP, los grandes agricultores dijeron que tenían una mayor visión que los pequeños. Pero el hecho es que el UDP de 1984-89 no favoreció el colectivismo. El gran patrocinador del UDP fue USAID; el UDP puso mucho énfasis en la venta de pasaportes a ricos ciudadanos chinos que se suponía iban a venir a Belize y hacer grandes inversiones; y el UDP aumentó la propiedad privada de la única empresa de telecomunicaciones del país, BTL, al 49 %. Cuando el UDP fue expulsado de su cargo en 1989, las cooperativas de agricultores estaban en soporte vital. El gobierno PUP que asumió el poder no vino a revivir el colectivismo, sino a acabar con él.

Desde que tomaron el control total de la industria bananera, los grandes agricultores han tenido un gran éxito. Las plantaciones de banano propiedad de los grandes empresarios ahora cubren 6,500 acres en el sur de Stann Creek y el norte de Toledo, y tienen una parte o control total de todos los negocios asociados, incluido el puerto de Big Creek.

Inicialmente, el puerto en Big Creek se limitaba a manejar exportaciones de banano y suministros de fertilizantes y pesticidas de Guatemala y Honduras para las plantaciones, pero desde que un ministro (o ministros) en un gobierno PUP durante las administraciones de Musa les dio el visto bueno para involucrarse en otros negocios, el crecimiento en el puerto ha sido rápido. Se han realizado inversiones masivas para profundizar el canal, ampliar la capacidad de almacenamiento y comprar equipos modernos para aumentar la eficiencia.

Actualmente, en el puerto de Big Creek – Toledo Enterprises Ltd. (PBCTEL) en el sur de Stann Creek/norte de Toledo, se encuentran los viejos tanques que se usaban para almacenar combustible de Venezuela que entraba bajo el Programa Petro Caribe; tanques que almacenan crudo para BNE; tanques que almacenan butano, luego de que un gobierno le diera el control monopólico de las importaciones de ese producto a un grupo asociado; bodegas que almacenan azúcar y melaza producida por Santander, una nueva empresa

azucarera en el Distrito de Cayo; e instalaciones para el almacenamiento de azúcar procedente de ASR/BSI en Orange Walk, después de que los productores de azúcar del norte tomaran la increíble decisión de transportar sus productos en camiones a través del país hasta el sur, en lugar de hacerlo por mar hasta el puerto de la Ciudad de Belize, Port of Belize Ltd. (PBL), cosa que había estado haciendo durante muchas décadas.

Los negocios pueden estar lentos en otras partes de Belize, pero están en auge en Big Creek. Los principales declarados accionistas de PBCTEL son beliceños, por lo que su éxito debería ser una ventaja para el país. Desafortunadamente, no todos sus negocios tienen sentido para Belize. Con respecto a su papel como el principal operador de exportaciones de petróleo crudo e importaciones de butano del país, el puerto de Big Creek se adapta perfectamente, ya que se encuentra en una laguna. Si hubiera un derrame, el impacto sería mucho menor que si el puerto estuviera ubicado por el mar. Sin embargo, en cuanto al manejo del azúcar, existen preocupaciones.

Este año PBCTEL manejará un estimado de 75.000 toneladas de azúcar y 30.000 toneladas de melaza producidas por Santander. PBCTEL también manejará la mayor parte del azúcar y la melaza producidos por ASR/BSI. En 2017, ASR/BSI produjo más de 140 000 toneladas de azúcar y 40 000 toneladas de melaza.

No se puede ignorar el desgaste de las carreteras de Belize que provocará el transporte de más de 200 000 toneladas de azúcar y melaza, porque a Belize le cuesta casi \$2 millones rehabilitar una milla en la carretera George Price, y está costando casi \$4 millones para entregar una milla en la Carretera Costera Manuel Esquivel. El azúcar y la melaza de Santander se transportan a través de más de 100 millas, hasta el puerto de Big Creek, cuando la distancia a PBL en la Ciudad de Belize es de unas 45 millas. El azúcar y la melaza de ASR/BSI, que solía transportarse en barcazas, se transportarán más de 150 millas hasta el puerto de Big Creek, cuando la ruta por carretera hasta PBL en la Ciudad de Belize es aproximadamente un tercio de esa distancia.

¿Por qué el azúcar y la melaza de Santander y ASR/BSI están haciendo agujeros en las carreteras y caminos de Belize? Esta es una historia tan inquietante como la saga BTL, en la que Belize vendió su activo más preciado por una canción y lo volvió a comprar por toda la orquesta. ¿Cuál es la razón para pasar por alto a PBL? ¿Es porque la receptoría en PBL debe tener un puerto de cruceros en la Ciudad de Belize, incluso si nuestros ambientalistas dicen que el dragado para atracar cruceros gigantes no es sólido y nuestros expertos en turismo dicen que el aumento de visitantes traído por un nuevo puerto de cruceros dañará nuestro producto? ¿Es para asestar un golpe final a la mano de obra sindicalizada en Belize?

Si los productores de azúcar insisten en pasar por alto a PBL, hay un puerto en Commerce Bight, Stann Creek, que está casi 50 millas más cerca para sus productos que el puerto en Big Creek. En este momento, Commerce Bight, el único puerto natural de aguas profundas de nuestro país, languidece; su muelle, que manejaba envíos de productos cítricos hasta principios del siglo pasado, está en mal estado y su propiedad en confusión. Nuestro país obtendría ahorros considerables si se remodelara este puerto y se transportara azúcar y melaza a través de él.

Belize depende de las exportaciones agrícolas, pero hay muchos otros contribuyentes a nuestra economía. Hay una aplastante pobreza en nuestro país, y estamos desperdiciando millones transportando azúcar y melaza por carretera, hasta Big Creek.

the throne. Unconfirmed reports are that they will be in Belize for a four-day visit sometime in March as a part of their tour in this part of the world, with reports that they just may visit Ambergris Caye and also go to mainland Belize.

Reports are that there will be a focus during the royals' tour on ecological issues facing the world. The couple's last royal tours were in March 2020 before the COVID-19 pandemic, when they visited Ireland, and in December of that same year, when they took a three-day royal train tour across the UK. In May 2021, they spent a week engaged in conversation across Scotland.

In a few days, on February 10, Prince William will visit Dubai for his first official visit to the UAE. February 3, 2022, the pump price of premium gasoline will increase from \$12.30 to \$12.73 per gallon—an increase of 43 cents. Regular gasoline is set to increase by 18 cents, going from \$12.10 to \$12.28 per gallon. The prices of kerosene and diesel, however, remain unchanged at \$8.79 and \$11.56

per gallon, respectively.

The announcement comes just one week after a previous price increase and less than a week after the United Democratic Party (UDP) called out the Briceño administration on the steadily rising fuel prices, urging the government to commit to keeping gas prices below \$10 and to reduce the taxes imposed on fuel.

According to the Government's press release, they plan to work with the fuel industry to stabilize the pump prices paid by Belizean consumers. The release stated that the increase in gas prices is a reflection of the current demand and supply conditions in the crude oil sector within the international petroleum market as well as fluctuation in acquisition prices in countries from which Belize obtains its fuel supplies.

### Some Mayan leaders a little too American

When the leaders of Mayan Belizeans in Toledo first brought their case for communal ownership rights to the land they lived on, I supported, with gusto. For years our Mayan brothers and sisters had seen developments that threatened their traditional way of life, and the final straw was when a GOB decided to issue logging rights over thousands of acres in the district. For a time villagers watched helplessly as the loggers destroyed the forest, and then they decided to go to court.

I cheered the ruling by Chief Justice Conteh back in 2007 (2008?), that Santa Cruz and Conejo had established customary land tenure. A couple years later, the decision was extended to most of the other villages where the Maya were the dominant tribe.

In one of my columns, I wrote that had the Maya of Toledo been pastoral, they wouldn't have needed to go to court. The easiest way to control the land is to fall the bush, put barbed wire around it, and put in livestock. In the old Maya system, they fell the forest, burned it, planted a crop, and then they let the land rest for some years before repeating the cycle. It is not the best way to farm, and our brothers and sisters are gradually shifting to more progressive systems, such as utilizing cover crops, alley cropping, and terracing to conserve the soil and make it yield more sustainably.

We have to wonder if any Chief Justice other than Dr. Abdulai Conteh would have forced the government to come to the table. The UDP had installed a new Chief Justice, Mr. Manuel Sosa, just before the 1998

general elections, and when the PUP won, one of their first acts was to get our country a new Chief Justice. To get their man, they went all the way to Sierra Leone.

A Wikipedia page states that Dr. Conteh was once vice president of Sierra Leone, and he was ousted following a military junta in 1992. He was our Chief Justice from 2000 to 2010, when the UDP did not rehire him. It took an extraordinary man to hand down that judgment. No one has asked Justice Sosa, at least not publicly, what his thoughts were about the ruling.

We know how the red and the blue felt. Said Musa had said about the communal land rights claim that he wouldn't preside over the Balkanization of Belize. And when the UDP came to power, their lawyers questioned the authenticity of the Maya of Toledo, if they were really from the area, and they had to get a message from the CCJ to get them to respect the ruling. The UDP lost every big case at the CCJ, against the rich man, Ashcroft, and against the cash-poor people of Toledo.

There has been some trouble in implementing the ruling, and to my mind that is because some Mayan leaders are going too far over in favor of an American solution. The Inter-American Commission on Human Rights was big in the case brought by the Mayan leaders, and I have a sense that some of the lead activists from that group were from the USA. Whether yes or no to that, my sense is that the stumbling block in the process has been the leaders who like the idea of near total autonomy, akin to what's the rule on reservations in the US. On the rez,

all is good to go as long as they respect the basic civil rights and liberties established in the US.

We are so, so different from the US. In that country north of us, the Europeans came like conquistadores and massacred the Native Americans, slaughtered their main food source, the buffalo, took all their best lands, and confined them to land that couldn't sustain crops. The power structure in the US remains European; all their presidents have been/are Europeans, save for one who is a fifty percenter.

I won't get into kwaaril here with a few Mestizos/Maya in the north side of our country who try to daub Belize with the same brush. I've learned well enough that some people in Belize like to take bullet points and run, so keeping on course, I just want to point out here that the lands in Toledo are some of the most fertile in our country, and beginning with our first native leader, George Price, it has been a parade of Mayan lineage in the big seat in the National Assembly. Looking at our present leader, he could assimilate in Crique Sarco and San Pedro Columbia, no problem.

I know that the person who could make the implementation of the Conteh ruling a completely smooth process doesn't exist. That's the way it is with negotiations. I will say to the parties that are not in agreement with the present FPIC that has been settled on that they not forget to keep Belize at heart. In all your deliberations, remember to ask yourselves: Is it good for Belize? We might no longer be the tranquil haven of democracy, thanks to our group of lawyers who don't prize justice, but we have a rich history,

and across the country our love is still strong.

We have a special thing here. I do not like for Belizeans to flat out say that the Conteh ruling was a bad decision. No matter what your views are on the world, you should be able to find some good in turning back the krayzinis of 1492.

I also don't congratulate Belizeans who throw the baby out with the bath water when they think of the colonizers. There were bad things, for sure, but we cannot completely turn back the time. We have to approach the implementation of the FPIC with an abrazo, not a cold stare. Yes, in negotiations we have to be tough, so we aren't driven too far off from our position, but if we always keep in mind the greater good for Belize, we will do the right thing. We are not the USA.

#### A criminal leak

Last week a distraught woman went to the police station and made a statement that her spouse had abused her. Some police officer or officers, or some person who works at the Police Department released the statement the lady made so all the world could see. I haven't read the statement, and I don't want to. I don't want to, because the statement made by the distraught lady wasn't intended for me.

I'm not questioning either of the parties that were affected by the leak, but there's a reason why we say there are three sides to a story. It's not that one side isn't the flatout truth. I won't go on here, because we could go down many roads. I just say, give it a thought, and be sincere.

Leaking information has become common in the government, because government after government has violated the rights of Belizeans to know how their money is being spent. There are times leaders have to be careful or strategic with the release of information. There are sensitive matters. But when it comes to our money and other assets, we should know.

What happened at the Police Department was no common leak. It's possible the person(s) who leaked that document doesn't know that they committed a serious violation, if not a criminal act. In releasing a private statement, they were savage, and if there is any excuse for them, it is that in this case the one offended, Patrick, well, he has messed up many times already.

Belize is slipping down, and it is important that we do something about it. I wouldn't ask for whoever released that statement to be nailed to the stake, because they might be ignorant, but at the least it should be made clear that if it happens again, somebody is going to jail.



# **Vladimir Putin's annual press conference** — **Part 6**

The working class is the backbone of the economy and the development of a country. Without the workers, the companies could not exist. For this reason, there must be a good relationship between the two entities, since it is necessary for the company to obtain a good economic profit and the working class a good salary to be able to pay for the necessary services for a decent life and not walk like beggars because they cannot afford a good, balanced diet. What we do not see in Russia and other countries with leftist governments, is their people being beggars in order to buy medicine and put bread on the table. Anyhow, allow me, our dear readers of this column, to present to you the sixth part of Vladimir Putin's annual conference:

Yelena Glushakova: About regional governors

Vladimir Putin: Assessment of the heads of the regions. You know, I have said many times, and I would like to reiterate – I think you will agree with me: many countries have followed our path. Indeed, we were the first to say that ours is a large country and the situation in various regions is different and is developing in different ways. So, with overall guidance from the federal centre, and a government commission was set up for this purpose, we must still give the regions the opportunity to regulate the situation locally, considering the subtle nuances. Is it possible to compare, say, Chukotka and Moscow? They are completely different, and the epidemiological situation has been different from region to region because of our vast territory. Let me repeat, like any complex issue, some things could probably have been done better and with more urgency, but in general, the heads of the regions showed the utmost responsibility and were not afraid to make difficult decisions. In turn, the government and the federal centre has always supported the regions that made the required decisions and needed assistance, say, from the federal centre. Assistance for the regions has been increased many times over. Cooperation between the federal centre and the regions has produced positive results, the results we needed.

Dmitry Peskov: Alright, let us go on. Let someone from the regions speak. There is a girl in a yellow blouse there. It says: "A City for Life." Go ahead, please.


Lyudmila Danilkina: Good afternoon, Veliky Novgorod, Lyudmila Danilkina. Our city that you, Mr. President, have visited more than once, is not big but it is very beautiful and has an ancient history. I am talking about the city for a reason, because my question is part personal and part business, about the urban environment. Which city would you personally choose to live in, except St. Petersburg and Moscow? This is the first, personal part of my question. The second part is about Novgorod Region. Our region is very fortunately placed between the two capitals, which is, of course, a plus for our territory. But we would develop much faster if there were a high speed railway not far from Novgorod. There is a lot of talk about it now at both the federal and regional levels. I would like to know the prospects for the development or, to be more precise, implementation of this project on our territory. Thank you.

**Vladimir Putin:** As for my place of residence, you said "other than Moscow and St Petersburg." Why did you exclude Moscow and St. Petersburg? These cities are part of the Russian Federation as well, and I was born in one of them. It is my hometown, so when you asked this question, my first thought was about St. Petersburg. Our cities, large and small alike, are developing at a fairly fast pace, although we should focus primarily on developing small cities. We have been discussing this lately and are making efforts to expand infrastructure, primarily, to ensure transport connectivity both by rail and road, as well as by air, sea and river transport.

I have already spoken about this, it is one of the growth drivers in which we plan to invest enormous resources. Much depends on connectivity, because one can and should be able to live in a favourable environment – I am not talking about myself – and to commute to work or change where you work. Increasing mobility of the population is one of our goals. So, it is possible, and I would, of course, think of St. Petersburg first and foremost as my hometown. Krasnodar in the south of Russia is developing quite well. Look at how the coastal area and Crimea are developing. Now, speaking of infrastructure, we are talking about developing the Eastern Operating Domain, but not only. Let us say, Moscow-Kazan, and we plan to extend it further to Tvumen and then make it a loop. All of that makes the people feel they live in a favourable environment with easy commutes from their places of work to their homes, where they can meet with their friends and go to places catering to other aspects of life, such cultural centres internationally recognised museums, and so on.

I think we have many beautiful and worthwhile places where people can and should feel comfortable. High-speed rail is a separate topic that is still in the works. First, if there is to be a high-

speed railway, I think Veliky Novgorod should feel its presence, because even though it is high-speed rail, the train must stop somewhere. Veliky Novgorod is one such place where the train can make a stop. Moscow–St. Petersburg air service will clearly cease to exist, because it will take just three hours to get from central Moscow to central St. Petersburg, whereas now it can take up to 90 minutes to get to the airport in Moscow. So, air service on this route will no longer make sense. We need to weigh everything, think it over and have a look at high-speed rail in other countries. For example, the People's Republic of China has many such railway systems. Until recently, they were all operating at a loss, even in China with its



provide a solution for traveling certain distances. Air travel is a better solution in some places. These things are still being studied at the expert level. Thank you.

### **Derivation of the word Crecie and Mulatto**

The British settled and developed their first town at what is known today as St. George's Caye. Thereafter, they brought an enslaved people from Africa who were thrown in a swampy place near which there was once a Maya village by the name Holzuz. With time, different names were used to refer to this place. Eventually, it was called Belize Town. While the British masters' business was taking place, they created two new classes of people which were the Royal mulattos colonial apologists, and the Creoles from the enslaved African people born in the Americas. With that being said, our dear readers of this column, permit me to present to you the official meaning of the word "Creole/Mulatto" published by <a href="http:/">http:/</a> /etimologias.dechile.net/?criollo and is as follows:

#### Creole

Some say that the word "creole" derives from "crio", which is what the Spaniards called their children born in the Indies. Of course, other sources say that it comes from the Portuguese "crioulo", as was used to refer to the slaves born in America, distinguishing them from those brought directly from Africa. Corominas and most philologists agree that it is a derivation of the verb "to raise". It is the same root as the word "servant," which was used to refer to servants and slaves. "Criar" comes from the Latin "creare", which means "to engender". It is the same Indo-European root (\*ker-) of other words such as create, cereal, and grow.

The word Creole is used to refer to the children of European or

African parents born in America. It is used to highlight indigenous qualities and devotion to an American country. It is not used to refer to people of mixed race. The children of Spaniards with natives were called "mestizos" from the Latin, mixticius (mixed). The children of Spaniards with blacks were called "mulatos" from "mule". In linguistics, the word creole is also used to refer to a "mixed language, created on the basis of a specific language and with the contribution of numerous elements from another or others, which frequently arises in former colonial territories and which, unlike pidgins, is transmitted from parents to children, thus becoming the language of a community", (DLE). Gimeno makes it synonymous with amalgamation.

The Creole word also has a linguistic meaning, so that some speak (improperly) of Creole languages. There are no creole languages, but creole dialects of certain languages (such as Spanish, English, French or Portuguese), especially frequent in America and other places. They do not affect the language (the linguistic system) but the speech. The so-called Creolespeaking variants were born because a community of people, either transplanted by slavery, or from different autochthonous territorial origins and from various autochthonous languages, are forced to live together and communicate.

1. Some say that they come from a pidgin or lingua franca in which the first speakers took the structure of the language of their dominators,

The Government of Belize (GOBZ) has received financing from the Caribbean Development Bank (CDB) and the United Kingdom Caribbean Infrastructure Partnership Fund (UKCIF) towards the cost of the Philip Goldson Highway and Remate Bypass Project and intends to apply a portion of the proceeds of this financing to eligible payments under a contract for which this invitation is issued. Payments by CDB will be made only at the request of GOBZ and upon approval by CDB, and will be subject in all respects to the terms and conditions of the Financing Agreement. The Financing Agreement prohibits withdrawals from the Financing Account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOBZ shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

The Ministry of Infrastructure Development and Housing (MIDH) through its Project Execution Unit (PEU), the Executing Agency, now wishes to procure consultancy services for the Development and Implementation of a Livelihoods Enhancement Strategy and Action Plan for Small Businesses and Communities along the Philip Goldson Highway and Remate Bypass.

The objective of the consultancy is to explore the potential economic development opportunities available for Project-impacted communities especially small businesses and entrepreneurs, including vendors, to take advantage of the wider economic opportunities that the upgrading of the road is intended to bring. The consultancy team is expected to provide the consultancy services in two phases: Phase One (Assessment and Planning) in 30 days, over a four-month period; and Phase Two (Implementation) in 45 days, over an eight-month period.



inserting words from the other language in contact into that structure. By inheriting that pidgin, simple and restricted in origin, its children, and inheriting it as the only spoken language, it enriches and develops out of necessity, complicating its primitive structure and becoming a creole speech (based on x, according to the original language).

2. Others do not contemplate the existence of a pidgin phase and simply explain it by the progressive evolution of a language, which by mere contact is influenced by other languages, from which terms are borrowed that are inserted into its structure.

Creole languages are, for example, Nicaraguan or Belizean Creole (English dialect), French Guiana Creole (French dialect), Santo Tome Forro Creole (Portuguese dialect), or Chabacano Philippine Creole (considered dialect of Spanish). In reality, the classifications are not exact or very scientific, since some focus primarily on the lexicon to classify the language, others on the grammatical structure. Some of the Creole languages have the structure and system of the language of English, French, Portuguese or Spanish, and therefore are a dialect of these languages. Others, on the other hand, have the structure of native African, American or Asian languages, and as such must be considered dialects of one of these languages, having instead the lexicon of French, English, Spanish, etc. Generally, the linguistic structures only in exceptional cases show some case of fusion of forms or innovation, in very isolated and concrete cases; generally the general structures are not mixed.

### Feud over land leads to family's lockdown

COROZAL TOWN, Wed. Feb. 2, 2022

A family of six, including two persons with disabilities and a seriously ill woman, found themselves unable to leave their yard to get food, water, or medical care after the gate at the entrance of the yard was padlocked by relatives of the family who reportedly carried out that hostile act due to a land dispute. Erlinda Miller, 76, a Corozal resident, had to resort to using a Facebook post over the weekend to send out a social media SOS, in which she pleaded for assistance to free herself and her family. In the post Miller claimed that she had been locked inside the yard by her in-laws. Miller believes that it was her sisterin-law who locked the gate.

Police eventually went to the house, where they had to break the lock on the gate in order to free the family. According to Miller, the incident was the result of a feud between her and her husband's siblings which had been developing over a number of years over land that belonged to her husband's nowdeceased mother. The land is, according to legal documents, the property of her sister-in-law, but according to Miller, a contract exists that stipulates that her husband, who was diagnosed with dementia four years ago, is to live on the land until his death. However, Miller, whose husband is still alive, says that her husband's sisters are trying to force her off the land.

When speaking to local reporters, Miller stated that she received two eviction notices, and tried to settle the dispute in court. However, they were told that they had to go to the Supreme Court.

She stated in her interview, "I got a letter from their attorney, OJ Ellington, saying that I am

trespassing, that I should get off the land and that the contract that was made was revoked and that I am not part of that contract. I said, 'I will not get off, because yes, I am a part of that contract' because the contract states that unless the gentleman Mr. Miller dies or refuses to live on the premises, then, whenever he [is] dead, his family should be evacuated immediately, and he is still living. So since he is still living, I still have a right to be there, because I am his wife for 50 years."

Miller said that her husband's sister visited him at their home two weeks ago and told him that she would lock the gates, and she said that when the gate was indeed padlocked, she had reported what occurred to the police, but they had not done anything about it.

"We started to pack, but while we were packing, 2:30 the Sunday, the other sister, she came and put a padlock. She brought her husband with her and she came out of the vehicle and put a padlock on the gate, so then we couldn't get out [any] at all. Then I called the police. I called them for about three hours, on and off, on and off. They said they are changing shifts and that they would come. When they came, they said that they will talk to her to open the padlock so we could come out," Miller further explained to local reporters.

Miller went on to state, "I have my husband with mental [sickness]. I have a disabled child, 38 years, who doesn't walk, just crawl around, and I have a daughter on dialysis. She need to leave early morning to go to Orange Walk for dialysis, and the gate is locked. They went and told her [when the matter was reported to the police] and said, 'Miss, sorry, we cannot do [anything] about this because the lady said she is not going to remove the lock and the land is hers and that she could do what she wants,' so just stayed there."

She then recounted what subsequently took place: "Our neighbours brought us food and some water, because the little that we have over the weekend was finished. I went to sleep and got up at three o'clock and decided something has to be done, so I got on Facebook and post this and said what was happening to us. The morning, between 7:00 to 7:30, the police officer, Mister Sanchez, came, and he cut the lock from the door outside and let us out."

# Tourism Ministry to finance food hub and music studios

BELIZE CITY, Wed. Feb. 2, 2022

During the launch of BTB's matching grant program early this week, members of the media asked Minister of Tourism, Hon. Anthony Mahler, to indicate some ways that the funds would be used. He went on to state that a portion of the 3 million Belize dollars acquired from the Inter-American Development Bank has been earmarked to finance a "gastronomy corridor", or food hub,



on the Mahogany Street stretch where a number of restaurants are located. Also, two recording studios will be developed: one in Belize City and another in Dangriga. "Three million dollars in total. A portion of it, maybe four hundred thousand, goes to the gastronomic corridor and another two hundred and fifty thousand to the music studios. Then, the rest goes to the matching grants," he said.

Hon. Mahler went on to explain, "A portion will go for a food hub, but fancy word, 'gastronomy corridor', on Mahogany Street. That strip where all the restaurants are, we are going to redo that. We want to do two major music studios across the country, one in Belize City and one in Dangriga. We will help some other smaller music studios."

This is all in an effort to propel the

revitalization of the tourism industry and ensure that Belize has its cultural and infrastructural capacity prepared for the projected rebound to come, Minister Mahler said.

"Food is a part of tourism, culture is, and so we want to take that to the next level—food, music, our local wines, even all the pepper and sauces that we do here in the country, herbs in terms of being a part of the product. I think that is crucial. We want to invest in that area as well. We have a lot of talented musicians. They just don't have the opportunity to express themselves the way they can," Hon. Mahler further said.

In the past, Minister Mahler has highlighted the importance of supporting local artists and even creating a tourism product around our local music.



While not yet a multilateral agreement, it is being hailed as a win for keeping the WTO relevant and for addressing behindthe-border barriers which may service providers. Notwithstanding the fact that the countries involved collectively account for over 90% of global services trade, those countries were mainly developed countries and no Caribbean Community (CARICOM) was among the participants. Therefore, this first SRC Trading

Thoughts for 2022 discusses this new agreement and examines some of the pros and cons CARICOM Member States may have to weigh should they decide to sign on.

#### What is the SDRA?

The outcome is contained in a document called the Reference Paper on Services Domestic Regulation dated November 26, 2021. The disciplines apply to measures relating to licensing and qualifications requirements and procedures and technical standards affecting trade in services. The disciplines do not prohibit countries from maintaining these requirements or procedures, nor do they detract from countries' ability to regulate in the public interest. Rather, the

signatory countries commit to ensuring their measures are transparent and ensure legal certainty and predictability and regulatory quality and facilitation.

For example, in order to promote transparency, they agree to establish appropriate mechanisms for responding to enquiries from service providers. Similarly, to promote regulatory quality and facilitation, parties undertake to, for example, limit applicants to having to approach only one competent authority to obtain authorization, to ensure fees are reasonable and transparent, and to accept electronic applications and authenticated copies of documents. These measures help to reduce waiting times and costs, resulting in ease of doing business, especially for small and medium-sized enterprises (SMEs) which would be more disproportionately affected by regulatory barriers.

### Pros and cons of joining for CARICOM countries

Although only those WTO Members which have signed on to the agreement are bound by its disciplines, they have agreed to multilateralise the benefits. This means that non-participating countries like those in CARICOM do not necessarily have to sign on to the agreement for their service exporters to benefit from the easier regulatory conditions in those countries. A joint OECD/WTO (2021) study found that implementing the outcome would do four things: improve the business climate, lower trade costs to about US \$150 billion annually, facilitate services trade and generate gains to all WTO members, including participating countries. However, it is worth highlighting some pros and cons joining the agreement might entail for CARICOM Members.

First, the economic devastation COVID-19 inflicted on tourismdependent Caribbean economies, in particular, has further reiterated the perennial need to place our economies on a more diversified and competitive footing. Increasing the export of high value-added services is one of the line items in most CARICOM countries' post-COVID-19 economic recovery and diversification strategies. However, the development of these sectors requires supportive business environments. Despite some notable improvements, and accelerated by the COVID-19 situation, CARICOM countries generally lag on global ease of doing business indices. Moreover, governments' unilateral reforms could be more easily rolled back than reform commitments made at the multilateral level. One value-added of signing on to the agreement could be to lock in existing reforms and accelerate the pace of reforms which would benefit both domestic and

foreign service providers. However, commitments such as the opportunity for comment and information before entry into force might be onerous for smaller governments to honour.

Second, those WTO members which have signed on to the agreement will incorporate the agreed "additional disciplines as commitments" under Article XVIII of the GATS under their GATS schedules. One concern which CARICOM countries may have is signing on to additional WTO commitments at a time when they are still grappling with implementing commitments under the WTO Trade Facilitation Agreement, for example. Granted, however, the agreement allows developing country members transitional periods of up to seven years following the disciplines' entry into force, while also allowing those in need of an extended transitional period to make a request in accordance with the relevant procedures. It also encourages developed countries and developing country Members in a position to do so to encourage specific technical assistance and capacity building to developing countries, particularly least-developed countries. These can be done on the latter's request or on mutually agreed terms and conditions. Therefore, in theory, this agreement provides another avenue by which CARICOM countries could obtain technical assistance for their business environment reform programmes.

Third, there is the possible signaling effect that signing this agreement could have to investors of the country's commitment to encouraging a business-friendly environment. A country's receptiveness to encouraging business activity and the ease of its business climate rank among important factors in investors' business decisions.

#### **Concluding thoughts**

The conclusion, albeit on a plurilateral basis, of uniform principles on services domestic regulation is a positive development for the WTO at a time when there is increased skepticism about the organisation's relevance. Joining the agreement, however, brings both pros and cons. CARICOM countries considering joining after the fact would have to weigh whether doing so advances their regulatory reforms further than unilateral reforms would and whether the benefits of adopting multilateral commitments outweigh burdens the possible implementation.





slippery slope that charts a


### **Hon. Tracy Panton: The (Only) Formidable Way!**

### **Dolphin carcass** found in Corozal

SARTENEJA, Corozal District, Sat. Jan. 29, 2022

The carcass of a bottlenose dolphin washed ashore this past weekend in the Corozal Bay Wildlife Sanctuary, located in Sarteneja Village. This is believed to be the first instance of a mammal turning up dead onshore in the area for the year 2022. Upon receiving reports of the discovery, Honorio Santos, Research Assistant at the Sarteneja Alliance for Conservation and Development (SACD), along with one of the sanctuary's rangers, went to investigate. They then conducted an external examination on the mammal and identified it as a calf, measuring 130 centimeters (about 4 feet 3 inches) in length. The examination did not vield much insight into the cause of the calf's death, as there was no sign of injury on its body that could indicate human interference or a watercraft collision.

While photos of the dolphin show what look like several wounds, Santos pointed out that those were most likely due to the carcass colliding with rocks and other objects before washing up onshore. He then told the media that upon performing necropsy, they found that the dolphin's digestive system was empty—something

which Santos called unusual. According to Santos, this is what led them to conclude that the calf had unfortunately starved as a result of separation from its mother.

"We assume that the calf could have separated from its mother, and so it couldn't feed by itself, since it's really small. We assume that might be the cause of death," he stated.

Santos told local media that while instances of mammals washing up onshore are common, manatees are the animals most often seen, usually as a result of boating incidents. Currently, SACD is researching the areas where aquatic mammals are most often observed with the aim of carrying out education campaigns to prevent the death of these mammals, especially as a result of the impact of speeding

According to Santos, the dolphin is the first dead mammal reported in the Corozal Bay Wildlife Sanctuary for 2022.



· In 1878, legendary soprano Marie Selika Williams became the first Black musician to sing at the White House after she performed for President Rutherford Hayes and First Lady Lucy Webb Hayes in the Green Room.

· Born a slave, George Washington Johnson went on to became the first African American to make a commercial record after he was discovered as a street performer in 1890.

- · Ethel Waters became the first Black performer to appear on TV after her one-night variety special, *The Ethel Waters Show*, was aired on NBC in 1939.
- · For her role as Mammy in Gone with the Wind, Hattie McDaniel won the Academy Award for Best Supporting Actress in 1940,

becoming the first African American to win an Oscar.

Science



· Though he was born enslaved during the Civil War, George Washington Carver later studied botany as the first Black student at Iowa State University and was responsible for creating over 300 products using the peanut, including dyes, plastics, and gasoline.

· After becoming the very first African American and the first woman to graduate with a master's degree from the University of Hawaii, Alice Ball went on to invent the first successful treatment for Hansen's disease (otherwise known as leprosy) in 1916. It wasn't until years after her tragic death at the young age of 24 that Ball even got proper credit for her work.


· In 1956, Gladys West was hired as a mathematician by the U.S. Naval Proving Ground, and it was there that she invented an accurate model of the

Earth, which was then used as the foundation for the creation of the Global Positioning System (GPS).





· When Jackie Robinson made his debut with the Brooklyn Dodgers in 1947, it marked the first African American to play Major League Baseball since Moses Fleetwood Walker in 1884, marking the end of racial segregation in professional baseball.

· In 1950, Althea Gibson became the first Black tennis player to compete at the U.S. National Championships, and just six years later, she made history again as the first Black athlete to win a tennis grand slam tournament after winning the 1956 French Open.

• Though he only ended up playing 45 games during his career, Willie O'Ree will always be remembered as the National Hockey League's first Black player, and he continues to fight for more diversity in the sport.

· African Americans held their first large-scale convention in Philadelphia in 1830, and the gathering (which marked the start of the National Negro Conventions Movement) led to the formation of the American Society of Free Persons of Color. Bishop Richard Allen, who founded the African Methodist Episcopal Church, was made president of the society, and he worked to coordinate civil rights efforts locally.

• The final convention movement in 1864—presided over by Black abolitionist Frederick Douglass—led to the founding of the National Equal Rights League, an organization that pushed for full political rights for Black



· In 1870, the Mississippi state legislature sent Hiram Revels to fill a vacancy in the U.S. Senate during Reconstruction, making him the first African American senator. Though Revels's term in the Senate only lasted a year, he became an outspoken opponent of racial segregation and broke new ground for African Americans in Congress.

· After working several years as a civil rights lawyer, Thurgood Marshall became the first African American to serve in the U.S. Supreme Court. He was officially nominated by President Lyndon B. Johnson in 1967, and he served as a justice until 1991.

· In 1968, Shirley Chisholm became the first African American woman to win a seat in Congress. Four years later, she became the first Black candidate for a major-party nomination for President of the United States.

Arts and Literature



· Back in 1859, Harriet Wilson published the autobiographical novel *Our Nig: Sketches from the Life of a Free Black*, making her the first African American author to publish a novel. The novel was later lost for over 100 years until it was reprinted with a critical essay by Henry Louis Gates, Jr., in 1983.

· Known as the first African American professional photographer, Gordon Parks was hired by *Life* magazine as their first Black staff photographer in 1948 after publishing a photo essay on the life of a Harlem gang leader. He remained at the magazine for two decades, where he took photos of everyone from Muhammad Ali to Malcolm X.

· Gwendolyn Brooks became the first Black person to win a Pulitzer Prize in 1950 for her book *Annie Allen*, which chronicles the evolution of a young Black girl into womanhood through poetry.

In addition to designing one of the most famous wedding dresses in history (the gown worn by Jacqueline Bouvier when she married John F. Kennedy in 1953), Ann Lowe created a number of designs for high-society women, earning a reputation as the first renowned African American fashion designer. Today her work is exhibited at the Metropolitan Museum of Art.

### **Belize and Mexico discuss trade agreement**

BELIZE CITY, Thurs. Feb. 3, 2022

At a virtual meeting between government representatives of Belize and Mexico on Wednesday, February 2, the two countries discussed the potential signing of a high-level trade agreement. The Belize delegation was led by Hon. Eamon Courtenay, Minister of Foreign Affairs, Foreign Trade, and Immigration, while the Mexican delegation was led by Señora Tatiana Clouthier Carrillo, Mexico's Secretary of the Economy.

A press release from the Government of Belize Press Office stated that formal trade with Mexico is a high priority, and that a trade agreement would substantially boost the economic development of Belize, particularly through

increased exports to Mexico.

After the discussion, the meeting concluded with both countries reaffirming their commitment to agreements made by Prime Minister Hon. John Briceño and Mexican president Andrés Manuel López Obrador during their meeting in Mexico. Those agreements were centered on the improvement of economic cooperation between Belize and Mexico; technical exchanges on legal and technical hurdles that the parties can resolve through cooperation; the completion and signing of a possible MOU on trade and investment cooperation; and a commitment by Mexico to explore possibilities for facilitating the exportation of Belizean goods.

Minister Courtenay was accompanied by Ambassador Amalia Mai, CEO of the Ministry

A Memorandum of Understanding (MOU) was signed Wednesday, February 2, between the Belize Tourism Board (BTB) and the Association of Protected Areas Management Organization (APAMO) as part of a coordinated effort to strengthen cooperation in the sustainable development of the country's protected

areas. The MOU has created a new partnership between environmental NGOs and the tourism sector that will further this effort.

APAMO is an association consisting of several nongovernmental protected areas management organizations that advocate for and contribute to the sustainability and proper management of Belize's protected

The MOU was signed at BTB's Belize City headquarters on Regent Street. As part of the agreement, the BTB has committed to providing APAMO with \$75,000 of funding, which will be used to support the association's marketing, destination planning, training and certification, and data sharing activities. Also, the BTB will develop a pilot project alongside APAMO to further develop areas for sustainability certification/accreditation and growth.

"It's a celebration, because this is historic. This is unprecedented. Our natural resources [are] the bloodline of the tourism product, and we'll see it over and over. Sometimes you take someone from outside, they come and remind us that is what we have." said Jose Perez, Executive Director of APAMO. "We can no longer be those tree huggers, we have to embrace the industry but exploit our natural resources in a sustainable manner," he further said.

"The partnership, I think, is viable; it's happening quicker than I thought, which is excellent, so we're excited, we're encouraged. I see this as a first step," Perez continued.

Minister of Tourism and Diaspora Relations, Hon. Anthony Mahler, remarked, "When we got into the Minister of Tourism and Diaspora Relations under the BTB we said, 'we need to engage the NGO community; we need to have sustainability for our resources as we move forward in developing a vital tourism product', and so we reached out and today is a combination of the road that we want to go hand-in-hand down."

Chairman of the BTB's board of directors, Evan Tillett, commented at the signing that development and growth of the industry are the end goals.

"The vision of fostering [the] growth of the dynamic Belize tourism product for everyone to enjoy, the BTB is actively engaging its partners and stakeholders via execution of innovative strategies, partnerships to market, develop and enhance the tourism sector. There is a need to incorporate eco-tourism for economic well-being with our many communities by supporting the growth of our environmental NGOs," noted Tillett.

### BSI/ASR installs air emission system

The company has invested an estimated 6 million dollars in a new air emission system

Belize Sugar Industries Limited

(ASR/BSI) has installed a new air emission control system in an effort to mitigate the environmental impact of the company's sugar factory particularly the amount of ash emitted

during its operations, which have affected nearby communities. As a result of the installation of this new system, plumes of white smoke can now be seen leaving one of the factory's chimneys, an indication that the air coming out of it is clean. Since the project is only 50% completed, however, the smoke being emitted from the other chimney is still dark

According to ASR/BSI Director of Finance Shawn Chavarria, 6 million dollars (out of a total of \$11 million) was invested to install the new system. Chavarria also stated that the implementation was a team effort between ASR/BSI and the Department of Environment (DOE).

"It took years of planning to get to this day, and also the support of the Department of Environment—they were very instrumental in reviewing with us and coming back quickly in terms of feedback and in terms of design and engineering," he said.

The Director of Finance also told local media that he looks forward to phase two of the project, which will be done during the upcoming off-crop season and will involve the replacement of the second chimney's air emission system.

Seidy Lienez, the E.H.S. Regional Manager at ASR/BSI, told local media that the project is a part of the company's effort to work towards sustainability. According to Lienez, sustainability is currently one of their major areas of focus. She said that the company is dedicated to reusing as much waste material as possible and reducing its overall environmental impact. Studies have found that sugar production is a significant contributor to greenhouse gas production, and the combustion of bagasse, specifically, produces particle and air emissions that enter

the environment and can affect air quality.

In terms of how much this new system has improved the emissions coming from the chimney, Lienez says that will be determined in their annual stalk test, which is set for later this year. BSI/ASR has also been monitoring the air quality in the immediate area and nearby communities like Tower Hill and Chan Pine Ridge.

The company's new focus on sustainability comes after several instances in which residents of the nearby communities have voiced complaints that BSI has been polluting the surrounding environment. In June of 2019, residents of Chan Pine Ridge took to local media to complain that the company's factory had been polluting the air with ash and smoke. Since then, the villagers have constantly urged both BSI/ASR and the Department of Environment to take action. Also in 2019, BSI/ASR was accused of polluting the New River. The company, however, denied those claims, stating that it treated all its effluent discharge before sending it into the river.

When asked whether BSI will have to work hard to change the public's perception of the company after facing several controversies, Director Shawn Chavarria said that he is hopeful.

"We are hopeful that the community will see this as a positive step in the right direction, and that when we do the second phase really, that it's a culmination of commitment we made to the community, including the Chan Pine Ridge Committee, who we've invited here before. We committed to them that by this year we will get it done, and so we're living up to that commitment," he stated.

h) Present the first and final drafts of the Strategic Plan and Work Plan to the NCA Board



### **Destiny Wagner stands up against racism and hair discrimination**

"My hair symbolizes strength, spirituality, and resilience, just like my ancestors," said Miss Earth 2021, Destiny Wagner

BELIZE CITY, Thurs. Feb. 3, 2022 Despite a slew accomplishments, including being the first-ever Belizean to hold the prestigious title of Miss Earth, Destiny Wagner—like countless other black women—has often faced discrimination and racism. Most notably, on January 28, 2022, Wagner took to her social media platforms to speak out against a pageantry fan page that had attempted to ridicule her by comparing her locked hair to cow

In response to the attack, Wagner wrote, "As the first queen with locs

to EVER win an international crown, I knew I would be subject to ridicule and criticism. People are often intimidated by things they do not understand. Many do not associate natural hair (dreadlocks/locs) with the word 'beautiful'."

Hair discrimination is one of the many ways that a history of colonization and racism still impacts communities, and it is, unsurprisingly, still a common occurence. Two years ago, a group of Belizean police officers turned to the Supreme Court after facing disciplinary charges for refusing to remove their dreadlocks. And while the Court ruled in favor of the officers, there have been many other

instances, both in Belize and across other Afro-Caribbean nations, where schools, workplaces, hair salons, and other establishments have discriminated against the natural texture of Afrodescendants' hair. Just recently, in January of 2021, the Belmopan City Council was accused of discrimination after a receptionist was told by her superiors to "do something" about her hair.

There are many other unreported instances, however, of black women (and men) being subject to

### CCJ rules on Belize v T&T brown sugar case

Initially, Belize was seeking damages, based on the local sugar industry's loss of opportunities to generate revenue through the sale of sugar, as a result of Trinidad and Tobago's decision, but at the trial hearing, the country's legal representative, E. Andrew Marshalleck SC, indicated Belize's willingness to accept a mere judicial statement on the importance of implementing the CET on extraregional brown sugar.

In the CCJ ruling, it was noted that "At the hearing, Belize indicated its willingness to accept in substitution of the relief claimed appropriately worded judicial statements of the importance of implementation and maintaining of the CET on extraregional brown sugar."

Such a statement was indeed provided by the court. The president of the CCJ, Justice Adrian Saunders, stated the following in the court's judgment: "The court emphasizes the importance of maintaining the CET, especially in respect to the importation of an extra-regional production such as brown sugar which is of demonstrable importance to a member state such as Belize that manufactures it. The court found that the CET does not guarantee regional brown sugar producers an assured market but that those producers are entitled to the production of the

market that the CET is intended to provide".

Belize had claimed that Trinidad and Tobago's importation of sugar from our Latin American neighbors resulted in a decline in the prices, and sales, of brown sugar produced by Belize Sugar Industry Limited (BSI). The case was brought by Belize on behalf of BSI, which was the first entity to claim damages. They claimed that from November 2018 to June 2020, extra-regional brown sugar was imported to T&T without the CET being imposed. In the court's ruling, however, it noted that Belize failed to provide the court with sufficient evidence of its claims.

"The court found that there were severe shortcomings in the evidence offered by Belize in respect of the alleged failure of Trinidad and Tobago to apply the CET and that these failures were not cured by reference to circumstantial evidence," Justice Saunders stated.

In its defense, Trinidad and Tobago had denied that it permitted the importation of brown sugar in a manner inconsistent with the RTC, specifically denying that they imported extra-regional sugar without imposing the 40% CET.

Trinidad and Tobago also claimed that the country could not bring a claim on behalf of BSI, since that company is not a state-owned entity in Belize, and that Belize could not present a claim for the benefit of BSI

nor claim damages on behalf of BSI.

In the CCJ ruling, however, Saunders stated, "The court commented on the fact Belize presenting this claim for its benefit and for the benefit of BSI, the court found that there was no doubt that under the RTC Belize was entitled to espouse its claim on behalf of BSI."

According to counsel representing Belize, E. Andrew Marshalleck S.C, the case puts positive pressure on countries which are members of the CSME to meet the treaty obligations, which would ensure that BSI does not face any unfair competition in the export of its product to the CSME countries. He said that Belize would have five years to appeal the ruling in the event that new evidence emerges which shows that the relief originally sought should be granted.

Each country was ordered to bear its own costs.

In her post regarding the recent attack, Wagner commented, "to many, 'hair is just hair', but to many others, including myself, hair is identity! My hair symbolizes strength, spirituality, and resilience, just like my ancestors."

She then shared several photos depicting other Belizean women sporting—and embracing—their natural hair, and representing what she called "Black Girl Magic".

### **BIL nears its end**

Minister of Infrastructural Development, Hon. Julius Espat shared in an interview that the private company is currently in maintenance mode, and the former BIL general manager, Christy Mastry, has been "terminated amicably"

During an interview yesterday, the Minister of Infrastructural Development and Housing, Hon. Julius Espat, was asked to provide an update on the status of Belize Infrastructural Limited (BIL), the private company incorporated under the Barrow administration to carry out infrastructural development projects on behalf of the government. In early 2021, Espat alleged that BIL was created as a vehicle to carry out the "misappropriation of public monies without public scrutiny."

At the time he famously expressed his intention to "Kill BIL", and now, the company is but a shell of what it was, and is carrying out only maintenance duties, under the headship of the Ministry's CEO, Mr. Victor Espat.

Minister Espat explained, "The director is no longer with us. What

we did, her contract was terminated amicably; we transferred the management to the CEO as to the ministry. The role of BIL has changed since we got over it. BIL will no longer build buildings. What BIL is doing presently is just maintaining 2 structures [that] were left under its mandate, which is the finishing of the Finance building, which is, I think DFC moved in last week,

National Bank will move in next week, the Ministry of Finance probably by the end of February. We are in the final negotiations with the government of Belize if BIL will continue maintaining those buildings. It is that building and the Civic. That's the only responsibility that BIL is doing."

He explained that at this time, BIL has just a small number of persons on what he referred to as a skeletal staff. That small group of employees includes a building manager, and a maintenance crew, which is carrying out the upkeep of the newly constructed Finance building and the Civic Center. He went on to note that by the time the PUP became the new government of the country, the APEX contract for maintenance of the Civic Center had already expired.

Hon. Espat said that the government is still analyzing the contracts given to that company and

that his Ministry has committed to ensuring that projects be carried out as public service works.

"We have been analyzing their past contracts. That's an ongoing process; that takes quite a bit, and so when we have more information on that, we will be able to follow up with you. BIL will no longer be functioning as before. We made it a point that all the projects that will be done under the Ministry of Infrastructure Development will be done as regular public service type work, meaning we will go to the Contractor General; we will go to the Ministry of Finance, we will follow all the oversight regulatory bodies. We believe that's the best way. It takes a little bit longer, but I think that's the way to be accountable to how you spend the people's money," the Infrastructural Development Minister said.

He also mentioned that the government is in the process of hiring an on-call maintenance crew for the new Finance building.

"The CEO of the Ministry now takes over the little that BIL is doing, but we have managers, so there will be a manager for the Finance building that will be strictly responsible for the day-to-day maintenance. We have a crew there that does the security; we have hired the Police Department to assist us with security, because we believe that they are a part of the public service and they should be given that opportunity. We have cleaners, we have gardeners, we are contracting,

it's like on a consultant basis, one of the engineers that came off the building who has very good knowledge of how the building operates," he said.

As for the recently constructed Civic Center, he called it a "poster boy for white elephants."

The remark was made during an exchange between Espat and a local reporter. Espat had stated, "With the Civic we have, similar, it's mostly gardening. It's a sad situation that we have to be mopping and cleaning empty seats and putting on air condition for nobody to use, that's a ...".

At that point the reporter said, "An effect of the pandemic ...," to which Espat replied, "No, that's your poster boy for a white elephant project."

When asked by the reporter why he had made such a statement about the Civic Center, Espat went on to say, "Because [it] was designed for not facing the reality of our needs in this country. You have a building that is designed to be only used if it's fully air-conditioned, and so any time you put on that AC you di run a \$10,000 bill and we are not at that level. So buildings in developing countries have to be designed with a green architectural approach, where you can enjoy the cross ventilations that we have free of cost, where you can position your building in such a way that the sun does not create too much heat, but no, we go to the opposite extreme: we're designing buildings as if we're in Europe and now facing the consequences of that."

### MIDH gives residents of Belize City, Belmopan new homes

Under its Modular House Pilot Program, the Ministry of Infrastructure Development & Housing has given a number of homes to families in need

A Belize City woman and two Belmopan families became new homeowners this week after the Ministry of Infrastructure Development & Housing presented them with the keys to new concrete houses as part of the Ministry's Modular House Pilot Program. At a handing-over ceremony, held on

Wednesday, Belize City resident Margaret McDougall received one of the homes. At the ceremony, which took place in Ms. McDougall's yard in Belisle Alley, president of the Senate and member of the Belize Association of Planners, Carolyn Trench-Sandiford, gave a welcome address.

Back in August 2021, sixty-oneyear-old McDougall and her family of five reached out to the public for assistance after their home, then made of plycem and wood, had collapsed. According to Minister Espat, who also delivered remarks at the ceremony, upon visiting the home, they found it to be structurally unsound and realized that they would have to consolidate the soil—an extensive undertaking—before they could start rebuilding. Six months later, the family was able to enter their new home on that plot of land.

"What we're doing, ladies and gentlemen, is changing lives one at a time. That is what is special about this project—changing of individual lives," Hon. Espat said. He added that as long as the budget is approved, the ministry will continue building homes. Miss McDougall gave the vote of thanks, though the emotional homeowner kept her speech short, stating that the donation had touched her heart.

On Thursday, February 3, two more houses were handed over in Salvapan. There, Minister Espat spoke a bit on the occasional criticism that the Ministry has received regarding the housing program. According to Espat, the people who have been criticizing the program, particularly the size of the homes, are those who are already fortunate enough to have all their needs met—those who might not appreciate just how important it is to have a roof over one's head.

"I have been listening quite keenly to people saying that 'the house tu small' or 'yuh shudda mi build wa four-bedroom, wa three-bedroom,' but those people that are criticizing don't understand or refuse to understand what poverty is, what struggle is, and how important it is to somebody to have a reinforced structure of this type," he said.

One of the new homeowners expressed deep gratitude to the Ministry, stating, "My little family has been struggling in our old house for some years now, so this is a true blessing to us. God has answered our prayers. It can rain now while we sleep, warm."

Also present at the handing-over ceremony was Belmopan area representative, Hon. Oscar Mira, who stated at the ceremony that so far they have given homes to five families in need in Belmopan.

In addition to Mayor Bernard Wagner, speakers present at the ceremony included Councillor Edmund Kwan, who holds responsibility for local e c o n o m i c development, small businesses and new businesses; Youth Shadow Mayor, Steve Good; Director and Chief Financial Officer of Axiory Global Limited, Ms. Sheree Holland; and

Training Development Officer of BELTRAIDE, Ms. Monique Usher. In her short address, Ms. Gillett shared with the newer members that her small business, "For U By Me" has shown significant growth following

Mayor Wagner and the Belize City Council plan to continue the Belize City Accelerator Program in order to nurture more small business ideas and establish more businesses in Belize City.

### Ahmadiyya 7th basketball season is set to start on Sunday

The Ahmadiyya Basketball League returns for its 7th season after a two-year hiatus due to COVID-19

The longing to play competitive sports in the country has now ended, for Belizean basketball fanatics at least, as the Ahmadiyya Basketball League is set to return for its 7th season on Sunday, February 6. Back in 2020, the last time the season was operational, games were abruptly put on pause due to the COVID-19 pandemic, and the season was never completed.

The Ahmadiyya Basket League is a tournament conducted annually under the umbrella of the Ahmadiyya Muslim Jama'at Belize, an organization that spreads humanitarian services throughout the

community.

For the inaugural season, in 2014, the league started with eight teams, and now, eight years later, the league is seeing its highest registration to date, with forty-seven teams. "We were struggling with eight teams, and then it got a little bit better in the third year when we moved to a new venue, and in the fourth year we moved to SJC which accommodates three games different simultaneously. This is

the first time we will be having all of our games at the new facility at Mexico Center, and with the grace of God, we have forty-seven teams registered, the biggest we've ever had...this is something huge," Naveed Mangla, National President of Ahmadiyya Muslim Jama'at Belize shared in an exclusive interview with *Amandala*.

Two years since the cancelation of the 2020 season, we're still in the midst of the pandemic, however, the organization has adjusted to the new norm, and now they are opening areas previously closed due to the pandemic. For the upcoming season, mandatory precautions have been put in place to prevent the spread of the virus during the tournament.

"We will be extra careful; the last thing you want is a clutter here at our league and this becomes a spot where everybody catches it from. Keeping that in consideration, we're just allowing the teams alone, 12 members, and they're allowed to bring 8 extra people in the gym. There'll be two teams playing and two waiting, so only four teams in the gym. The capacity the government allows is much more but we are doing it this way so everybody is safe, to safeguard the youth from this COVID. As soon as two teams are done playing they exit, and we allow two more to come in the gym...so that kids are not gathering there. We're also trying to get a live stream going this year so that youth that are interested in watching don't have to be in the gym to watch; they can do so at home, access it on Facebook," Mangla explained.

Mangla said the rule is that all the teams, everybody playing has to be fully vaccinated. "One exception that was given to us by the Ministry of Sports is that a person who recently had COVID, they're allowed to play, but they have to show a letter from the government when they had the COVID the last time. And also, they have to at least have had one vaccination; people with zero vaccinations are not allowed and the same rule applies for the extra people that they're bringing. We will have people that will be checking

their vaccination card, and we'll also have the temperature guns to check for people who might have a fever. We will not jeopardize their health...or the health of the other people that are in the gym by allowing them [people who might be sick] in," Mangla explained.

Earlier this year, 15-year-old Joshua Flores, a student of Dangriga Town who was an avid basketball player, was gunned down while walking on Isla Road in the Sabal Community of Dangriga Town by someone who is believed to have been a friend of his. According to Naveed, this would have been his first time participating in the season. "It was the U15 that this individual would be playing in. He has never played for us before; he was just preparing to come this year. I never met him, he has never played. We haven't thought about doing any remembrance for him but if the team feels that something needs to be done, we're all for it and definitely, we will do something about it."

At the end of the season, awards such as Most Valuable Player (MVP) and the Sportsmanship Award will be given out to individuals with the most outstanding performance for the season. Also, the winner for each division will get a trophy.

The first games start at 9 a.m., with Falcons vs Young Ballers and Conquerors vs Los Lagos Defenders in the U15 division.

sworn in as the Leader of the Opposition (LOO), one day after the January 31 date on which the erstwhile Opposition leader, Hon. Patrick Faber, was scheduled to resign. It is a bit of déjà vu, and marks the third time since June that there has been a change in the Opposition leadership as a result of a submission by UDP parliamentarians of a letter to the Governor General in which the majority of the UDP members of the House requested that the person occupying that seat in Parliament be replaced. It was a parliamentary maneuver that enabled Shyne to first claim the Opposition leadership seat in June of last year in the midst of calls for Hon. Faber to be recalled as UDP leader, and was used by Faber three months later to reclaim his seat in September. And now, less than five months later, Hon. Barrow is once again Leader of the Opposition, and he is seeking to also be selected as the leader of the UDP at a party convention on March 27. Delegates at that convention will determine whether he secures that party leadeship, or the other contender for the post, area representative for the Albert division, Tracy Taegar-Panton, ascends to the top spot in the UDP. At this time, there has still been no indication that Hon. Patrick Faber has submitted an official letter of resignation, but according to Barrow, the UDP party chairman, Michael Peyrefitte is currently acting as interim party leader.

In an interview following hia swearing-in yesterday, Hon. Barrow said that he believes that he will be the next leader of the UDP.

"Thave the majority of support in the House of Representatives on the Opposition benches. I have the majority of support within the 31 constituencies as we've [seen] with the massive endorsement from the Caucus for Change, and we had 53% of delegates that voted to recall in July of 2021," Barrow asserted.

He claimed that he had led the charge for the recall of Patrick Faber. Those who remember that recall effort that started in June 2021 might note, however, that the sequence of events which led to a recall convention at which Faber secured enough votes to hold on to his leadership was a bit more than a one-man effort. It was somewhat complex — full of intrigue and a number of key players. The recall petition which triggered the recall convention in July was, in fact, submitted by Tony Herrera, a former PUP supporter, and Philip Willoughby, UDP standard bearer for the Port Loyola division, on behalf of the UDP faction, Caucus for Change, who, Herrera had indicated, was led by former UDP Minister of National Security, John Saldivar (former Belmopan area rep), who himself had been Faber's rival in a previous quest for UDP leadership in 2020.

The quest for leadership by Panton and Barrow in fact appears to be a sequel to a power struggle which started in June of 2021 after the circulation online of a video that seemed to show Faber behaving aggressively toward the mother of his 2-year-old daughter. That triggered the UDP Caucus for Change's recall petituon as well as calls by Hon. Shyne Barrow for Faber to be replaced. What ensued thenceforth, however, was a series of moves on the public stage that showed a distinct contrast between the approaches being taken by Panton and Barrow toward the crisis in leadership — a contrast that will likely continue to be displayed in the two leaders' efforts to secure the UDP leader post.

The Amandala had reported last year that on June 9, 2021, Hon. Moses "Shyne" Barrow "publicly stated in a Facebook post that the UDP leader [had]lost the confidence of the majority of the members of the Opposition in the House of Representatives... and then proceeded to suggest that the role of leader be assumed by Hon. Tracy Taegar Panton, whom he deem[ed] to be the most influential member of the Opposition."

The newspaper went on to note, however, that "Hon. Panton... appeared to shy away from the apparent endorsement. She responded to Barrow's Facebook post by issuing a public statement in which she asserted that the Mesopotamia area representative... was 'selective in which of [their] private conversations and messages he had chosen to place in the public domain." According to that AMANDALA article, Panton had further remarked that she remained "firm that any changes in the party's structure must be properly ventilated, and she further stated that she had formally requested that an urgent meeting be held to address the ongoing

Hon. Shyne Barrow, however, would later claim for himself the Opposition leader seat in the House of Representatives through the submission of a letter to the Governor General on June 20 that bore the signatures of Hon. Hugo Patt and Hon. Denise Barrow and indicated loss of confidence in Faber's leadership, After Faber survived a recall petition within the UDP in July, and had secured the support of Hon. Patt to regain his position as Opposition leader

in September, however, Panton reportedly hesitated prior to offering her signature in support of Faber's return to his Opposition Leader role and called for the holding of a National Party Council before she pledged her support for Faber.

Now that Barrow is claiming that he has the support of the majority of the representatives within the UDP, however, Panton is focused on garnering the support of the majority of the party's 570 delegates, who in fact will select the new leader of the party on March 27.

In a recent Facebook post, Panton stated," As I begin my campaign to become the next Party Leader of the United Democratic Party, I look forward to meeting with you, talking to you, listening to you, and giving you the opportunity to get to know me better.

candidacy My represents the change our great United Democratic Party needs at this time. It is absolutely important that we choose a leader that will help us re-establish our credibility as a mass political party; regain the trust and confidence of the Belizean People, and

inspire independent voters to give us an opportunity to govern Belize."

On the matter of domestic violence and allegations of domestic abuse made against Barrow by his wife, Panton said, "We must hold our leaders to the highest standards of behavior and as leaders, our character must be beyond reproach. We can not have different standards for those who aspire for the highest office in the land. Domestic violence is a critical issue of national importance. Two persons have been publicly accused of domestic violence. One has been forced to resign. "

In response to this, Barrow remarked, "History will record, that when she had the opportunity to stand up for all GBV victims, when she had the opportunity to stand up for women, when she had the opportunity to stand up for the United Democratic Party, when she had the opportunity to stand up for the country of Belize, who desperately needs a viable opposition, she refused. She stood up for the accused, she made a deal with the accused who, unlike me, that was not the first instance, that was the third instance that we knew of, and she chose to be an apologist, she chose to be a sympathizer, rather than stand up, so she should be the last one to talk about those issues, and it is really shameful to use such a serious issue as a political tool."

It is to be noted that at the time, after the video of Faber's domestic incident had surfaced, Hon. Panton had, in fact, issued a statement condemning all forms of gender-based violence, but had opposed the manner in which Hon. Barrow and two other UDP area reps had attempted to oust him — citing instead the need to comply with the protocols outlined in the party's constitution. She had said that it was important to ascertain the will of the majority of the party's delegates.

"We did not seek to hear the consensus of the people of the party. the delegates and those decisionmakers of the party, and therefore I was unprepared to sign a letter unilaterally that did not reflect what the party's decision-makers thought was the best way forward. I wrote to the Chairman requesting a National Party Council, which is the highest decision-making body of the party, and I wasn't told that we needed to agitate for a National Party Council and I also my colleagues at the time, up to them agitate for the National Party Council, and I was told the time for talking was done," Panton later explained to local reporters.

A national convention is tentatively

set for March 27 of this year. Both candidates are seeking the support of the majority of the 570 national delegates who make up the base of the party. Barrow is already confident that he has the majority of these key votes on his side. Panton, for her part, has said that she is putting her faith in them to make the right decision.

"The ultimate authority of the United Democratic Party is the national convention, which are the delegates that vote and the National Party Council. The central executive acts as a recommender; they can suggest, as some people would say they could "halla Rome and Jerome," but ultimately the National Party Council makes the decision, and with the endorsement of 20 of the constituencies, certainly I have the majority support in the National Party Council, so we have already decided that I will be the Leader of the Opposition. We have already decided that we are ready for a convention to allow the people, the delegates, to make the ultimate decision," she said.

When interviewed yesterday about a meeting with representatives of the UDP Caucus of Change which supposedly led to the decision of the majority of the UDP representatives of the country's 31 constituencies to support Hon. Barrow's leadership bid, Panton said that there were not as many people in attendance at that meeting she attended as is being reported by Barrow. She also said that some "representatives" of constituencies within the UDP Caucus for Change were new within the group and were not, in fact, official standard bearers. She counted 11 caretakers in attendance, while Shyne indicated the support of 20 of these purportedly key

"Maybe I should clarify that endorsement that comes from colleagues. I attended that meeting as well on Saturday. Most candidates were invited to meet with colleagues to share their views on the way forward for the party. At the meeting I attended, there were 11 persons present, 7 of whom were caretakers of the party, 4 coming from other constituencies but not as caretakers. So their claim that there were 19 participants attending that meeting, is really not consistent with the meeting I attended. I don't know if there were 19 people at a meeting my colleague was at but certainly not at the meeting that I attended with this group of colleagues." Panton has said.

### Low carbon public transport system launched

This European Union funded project is being administered by the United Nations Development Programme (UNDP) Belize Country Office. The project supports Belize's commitment to the Nationally Determined Contributions to the United Nations Framework Convention on Climate Change (UNFCCC) and Low Emission Development Strategy (LEDS). This project promotes electric mobility with a view to support Belize's transition away from contemporary carbon alternatives currently utilized by Belize's transportation sector.

Among those present at the project launch were UNDP Programme Analyst, Ms. Diane Wade; Minister for Public Utilities, Energy and Logistics, Hon. Michel Chebat; Minister of State for the Ministry of Public Utilities, Energy and Logistics, Hon. Gilroy Usher; His Worship Mayor Bernard Wagner; Head of Cooperation for the Delegation of the European Union to Belize, His Excellency Aniceto Rodriquez-Ruiz; and the UNDP Deputy Resident Representative, Ian King.

Ms. Diane Wade gave an overview of the e-mobility initiative by outlining its three outcomes: (1) e-mobility institutionalization-creating an ecosystem for e-mobility, (2) demonstration of e-mobility application in the public transport sector and (3) enabling investments in e-mobility and the upscaling of the system

Hon. Gilroy Usher spoke on the transition from gas vehicles to

electric vehicles and the benefits it will bring to Belize.

Mayor Bernard Wagner, who represented the Belize City Council as a project partner, brought attention to the very real dangers of climate change and the impacts it can have on Belize City if steps are not taken to reduce emissions and implement best practices. As a stakeholder in this project, the Belize City Council is currently awaiting the arrival of the first electric buses in Belize City that will be integrated in the public transport system.

Mayor Wagner said, "For us, it fits into our local mandate to transform Belize City into a smart and healthy city; one that embraces green technology, social development and innovative solutions to our transportation, health and economic concerns."

Project partners include the Government of Belize, United Nations Development Programme (UNDP), European Union, Belize City Council, United Nations Capital Development Fund (UNCDF), Caribbean Community Climate Change Centre (CCCCC), UN Environment's Electric Mobility Programme, Belize Electricity Limited (BEL) and South-South and Triangular Cooperation (SSTrC).

The total budget for the project is 4.5 million euros and it is expected to be completed in 39 months.

She said that she did not attend a first meeting held by the caucus, at which there may well have been 19 representatives in attendance and reiterated that only 11 reps were at the meeting she attended.

The United Democratic Party has seemingly been in a state of flux since the ascension of Patrick Faber to leadership. The reputed leader of the UDP Caucus for change, John Saldivar, had initially secured that leadership spot at a UDP convention in 2020 prior to the retirement of Rt. Hon. Dean Barrow, but a short time later, after testimony in a Utah court indicated a financial link between him and convicted US fraudster Lev Dermen, another convention was held at which Patrick seized the top spot.

The UDP, following two domestic violence incidents in which Hon. Faber was allegedly involved over the last few months, is once again scrambling to reorganize itself following the stability that existed within the party during the 20 years that Rt. Hon. Dean Barrow was at the helm — particularly during the 13-year-period that spanned three consecutive administrations during which he was.the country's prime minister. The new Leader of the Opposition, Hon. Moses "Shyne" Barrow, the eldest son of Rt. Hon. Dean Barrow, when pressed on whether his father's departure is the reason for the UDP's current woes, said that the writing was on the wall for some time.

"If you recall in 2019- 2020 for the first convention, again, an overwhelming majority of standard-bearers....there were members of Cabinet that said they would resign if the former leader of the party were to become leader. All of them supported Mr. Saldivar to be leader; the former leader of the party lost handily. Whatever happened to Mr. Saldivar happened, and there were members of Cabinet that said 'if anyone ah unu put in unu name we wah resign from the Cabinet'. The point is, regardless of

what happened to Mr. Saldivar, nobody wanted Mr. Faber to lead the party," Barrow said.

In regard to his earlier endorsement of Panton as the right person to lead the UDP a few months ago and his own vision for the party, Hon. Shyne Barrow stated during a recent interview, "I begged the Hon. Panton to be the Leader of the Opposition. We begged her to take up the position so that we can show the country this is who the UDP is and let us move on and start that rebuilding process around her. I would have been her party whip, all of us would have come around her, but she chose Patrick over principle. So, there is no hunger, there is no greed on my part, but there is a necessity." Barrow said.

In response to those comments, Panton told local media, "I certainly felt that we should have followed the guidelines outlined in the constitution properly, and I was not prepared, outside of that, at that time given the environment, given all the agendas that were at play, I really did not feel that it was the right time for me, because I was not prepared to abandon the constitution of the party."

While Hon. Barrow said that his aim is to unite the party and ensure that the UDP is "the opposition that the country of Belize needs," Panton, in outlining her leadership vision, stated in a Facebook post," We are at a critical crossroads in our organization's political history. There is an urgent need for us to re-establish the party's credibility as a mass political party. There is an urgent need for us to regain the trust and confidence of the Belizean people if we are to remain a viable alternative to govern. We need to inspire hope among those who look to us for leadership. My bid to lead the United Democratic Party will achieve these objectives: credibility, trust, confidence."

As mentioned, no official letter of resignation from Patrick Faber has been made public, but a national UDP leadership convention is tentatively set for March 27.

of an unpainted cement bungalow house where they discovered the motionless body of Fermin Rivera, 67, the caretaker of the farm. Police observed the body with multiple apparent chop wounds. Rivera, a naturalized Belizean, is a resident of Xaibe Village.

Initial investigations reveal that earlier that same morning, at around 5 a.m., Rivera was attacked, tied up, and chopped multiple times. This evening a news team from CTV3 visited the area and police, who were still on the scene, asked them to leave as canvassing and investigations were still being done

The last murder that occurred in the Orange Walk District was on Christmas Day when Steve Gilbert Patten, 57, was ambushed and stabbed multiple times by an unknown assailant.

### Borders reopen on Feb 7, ONLY for fully vaxxed

symptoms. Thereafter they will then be required to go and do their test. But once you are overnight, or more than 24 hours, then you must be required to test at the border points," Minister Bernard outlined.

The cost of each test will be \$100, and these will be administered by the private entities in place at the border crossing. The high price of the Antigen Rapid tests, however, may rub Belizean travelers the wrong way. When asked about the possibility of public disapproval of this requirement, Minister Bernard said that the reopening of the borders will require that these restrictions be put in place.

"We are saying to you, if you want to go travel over to Mexico or Guatemala or whereever you choose to go, that's your choice, your personal choice. This issue, though, when you come back, you have to pay that fee. I think that's far from the point, the point is that we are opening our border but we have to have certain restrictions," Minister Bernard said,

The Ministry is hoping for a smooth transition, and Minister Bernard does not think the number of locals who will cross the northern border will be as high as was seen on past occasions prior to the pandemic. Notably, all regulations, COVID-19 and otherwise, remain in place at the customs and immigration section of the border crossing.

At this time, various self-testing solutions are available worldwide. In Belize, a way has not yet been found to properly implement self-testing as a part of our monitoring of the spread of the disease while ensuring surveillance is not affected. Minister Bernard said that they will continue to have that conversation next week, but for now, those going across the border will have to use the testing facilities available at the border crossings.

In contrast, persons entering the country through the Philip Goldson International Airport are allowed to bring a recent COVID-19 test from their home country for clearance. In the case of the land borders, all persons, Belizean and tourists, will have to be administered the test on the Belize side of the border, and pay the \$100 fee.

"We want to ensure the safety of our citizens, people that are coming are free from COVID-19 and if you are a tourist and you tested positive then you need to return to the country where you came from," explained Bernard.

Dr. Melissa Diaz-Musa, the Deputy Manager of the Central Health Region, explained the reasoning for testing after the 24-hour window:

"If you are obviously ill, we would like you to say to us that I have a fever, I feel unwell, because the whole entire purpose is for us to detect early and isolate persons early and get treatment early if you are unwell. With regards to the 24 hours, remember that in Health we do surveillance, so the incubation period of this virus is anywhere from 1 to 14 days, right, so you can be exposed and on day 13 you start with symptoms, most commonly it is before 5 days. And the reason we've done the 24 hours is it's a true surveillance, trying to pick up cases. We are not saying that you got it from Mexico. We are not saying,' ohh its what you did over there', but we want to pick it up, isolate you early so that we can contain the spread in the country," Dr. Diaz-Musa said.

Belizean nationals who test positive at the border and are not in private transportation will have to hire a gold standard vehicle to take them home, where they will need to isolate for up to 10 days.

During an interview, this week Tourism Minister Anthony Mahler outlined the importance of the reopening of the land borders to the tourism sector.

"The land borders, or traffic through the borders, is important for us. It represents almost 20% of the overnight arrivals, and so it is long-awaited. We have opened like kinda-kinda, we say we're partially opened for tourists, but even though we're opened, the borders are closed on 12 o'clock on the weekends, when a lot of people travel, so it is important that we open up. We have to continue to work with the Ministry of Health to ensure that we do so with the necessary protocols so that our people can be safe," Minister Mahler said.

Today, in an exclusive interview with AMANDALA, Belize's Ambassador to Mexico, H.E. Oscar Arnold, noted that Mexico has been one of the countries with very limited restrictions as it relates to presenting proof of vaccination and negative COVID-19 tests. He informed us, however, that a strong emphasis is being placed on prevention measures.

"Mexico was one of the countries that did not close down its port of entry, and so their land borders, as well as their airports, remained open throughout the pandemic, so they don't have any restrictions. For example, you can fly to Mexico, you can cross the border and you don't need to present any PCR or rapid test. They do, however, observe social distancing, wearing of masks, sanitizing, as well as taking an individual's temperature before they enter any building or business establishment, so those basically are what Belizeans will see or will have to look out for," Ambassador Arnold said.

He outlined that a four-color monitoring system is in place in Mexico, with each tier determining the level of activity that is allowed. At this time, he said that the state of Quintana Roo is currently in the yellow stage, which means activities have resumed under strict precautions.

"They have a color system. Depending on the color system that they are under, for example, red is high contagious, then there is orange, and then there is yellow, and then there is green. Depending on the color that the state or the municipality might be under at that time, that will tell you the percentage of people that will be allowed to be inside businesses at any given time, for example a restaurant. So you may have 30%, then 50%, then 60%, and that sort of thing. I believe Quintana Roo right now should be yellow," he said.

He shared that the COVID-19 numbers in the various states are monitored weekly and changes are made to their classification under the color system if needs be. He also noted that typically persons are not required to present proof of vaccination or a negative PCR test in order to enter public buildings, but there have been some instances where he was asked to be swabbed when entering specific buildings on specific occasions.

"I've been to some meetings here in Mexico City in certain private buildings, and for certain meetings, you would take a rapid test while entering or while going into the meeting and just wait for your result. But that is not something that is widespread, that was more in individual cases depending on the type of meeting that I was going to so, no mandates, no requirement to present your vaccination card ... However, we will be monitoring on the ground the traffic through the

border points or the border entries, and we believe if there are any changes, they will advise us, and we will then advise the authorities back home," he further explained..

It's been almost two years since the closure of the land borders, with a partial reopening for tourists occurring last year. Businesses and individuals on both sides have experienced severe economic impacts as a result of the closure, with some businesses on the Mexican side closing their doors, due to the lack of business from Belizean patrons. Ambassador Arnold said Quintana Roo has been waiting and is ready for the reopening.

"Especially the border towns, like Quintana Roo, they are ready. They've been wanting this for some time, because obviously, the economic activity has severely impacted with the border closure. I think prior to COVID in 2019, some statistics showed that we have about 30,000 Belizeans who cross the border to go into Mexico for either leisure, for vacation, for medical treatment for school, all sorts of stuff, and that stop. I believe in the bordering cities in Quintana Roo, some business had actually shuttered their windows and their doors because they just

could not simply keep up. And so the economic activity that they are expecting will be well received, obviously back home depending on whom you speak to, they will say 'you know what, it's bad, because we will be losing business that will take flight and go across the border, but it goes both ways, because there are some Mexicans and some tourists who would want to come and experience and see what we have here to offer," Ambassador Arnold further said.

While much interest is being placed on the northern crossing, the western land border that is shared with Guatemala will also be reopened for those of the general public who are vaccinated.

"At the end of the day, especially, for now, I tell Belizeans, I tell my family and friends, it's a personal choice. Not because the borders are opened means that you want to come and see what's going on over on the other side. But you have to put your own personal health and family health and decide what you want to do. I would advise anyone to wear their mask, to sanitize to do social distancing and try to limit the amount of contact that they have if they do want to cross the border," Ambassador Arnold said.

# Travel insurance push back

letter, they called the travel insurance another tax for the government and said it was untenable, given the struggling tourism industry.

Those protesting the insurance said it would create more hassle for travellers who plan to come to Belize, and it will lead them to go to competing destinations. The letter states, "It places our industry at a disadvantage with our international competitors and may present a drop in reservations. This may also lead to a further reduction in jobs and indeed GoB foreign currency and tax dollar income from our viable export product."

These major hotels, 15 in total reported by local media, are clamoring for the government to revisit its position. "In short," their letter states, "we would like GOB to retract this proposal and allow incoming guests to choose their insurance vendors as they have been doing successfully up to now, with local insurance options. Backed up by data, we know that hospitalization has decreased dramatically for the vaccinated, which means they ought to have the option of visiting Belize without an insurance policy."

In an interview this week with Tourism Minister, Anthony Mahler, he outlined that the policy seeks to protect travellers, and the smaller hotels which make up the majority of the accommodations landscape in Belize.

"We have looked at this thing for some time; we were in a position where Omicron was raging all over the place, there were a lot of cancellations, and so we are trying to help to protect the industry. We have almost 900 hotels throughout this country and most of them are under 10 rooms. Most of them, after two years of being devastated by COVID are on the brink, and so we have to ensure that not only the big players survive, but also the small players. We are in constant communication with the Ministry of Health. There are many countries across

the world that require insurance; that is the reality. I've spoken to ministers abroad who have that requirement as a part of the protocols for entering their country," Minister Mahler said.

Travel insurance has been imposed in various Caribbean islands since the beginning of the COVID-19 pandemic. In Aruba, all travellers are required to purchase COVID-19 travel insurance from the Government. The Bahamas also has included in the cost of their travel health visa, the cost to cover mandatory insurance from that country; and Jamaica has implemented the "Jamaica Cares" mandatory travel vaccine for all visitors entering the country.

The Belize Tourism Industry Association has come out in support of the travel insurance which is set to be implemented by February 15. Minister Mahler shared that the portal to purchase travel insurance will be up as early as next week, and reports of cancellations due to lack of accessibility would be looked into and addressed.

Recently, COVID-19 clusters were identified in cruise ships allowed to dock in Belize, and the group of concerned business persons in the tourism industry questioned why the travel insurance is not being imposed on them.

"We know that the previous three hospitalizations of covid patients came from cruise ships and yet when we posed the question to BTB and the Ministry, we were told that cruise tourism was not included in the immediate scheme and would be phased in later.

Why?" the letter from those protesting the mandatory travel insurance asked Minister Mahler.

Minister Mahler told media that the entities namely, The Lodge at Chaa Creek, Tropic Air, Victoria, House Resort, Blancaneaux Lodge, Turtle Inn, Hidden Valley Inn, El Pescador, Copal Tree, Chabil Mar Villas, San Ignacio Hotel, Blu Zen, Alaia Belize, Hamanasi resort and, Ramon's village resort have already been responded to by his Ministry.
