The country of Belize is mourning the loss of its second prime minister, Rt. Hon. Dr. Sir Manuel Esquivel, who passed away around 4:30 this evening at a local hospital. The twotime prime minister had been battling a health issue for some time before finally passing away today. He served his first term as the country's leader from 1984-1989, after winning the newly formed Caribbean Shores seat, and again from 1993-1998. He was appointed to the Privy Council by Queen Elizabeth II and holds an Honorary Doctorate degree from Loyola University.





Feb. 10, 2022 During Wednesday's sitting of the Senate, the senator who represents the country's non-governmental organizations, Osmany Salas, announced that he would be resigning from his post in the National Assembly, to take up a high-level position at the World Wildlife Fund. His resignation takes effect at the end of this month.

Redistricting case goes to court on Feb. 24

On February 24, the case brought by the BPM to address the disproportionality in the number of voters across constituencies goes to trial; GOB submits motion to strike out



BELIZE CITY, Wed. Feb. 9, 2022 Earlier this week, the representative of the claimants in the Belize Peace Movement (BPM) redistricting case, Hubert Enriquez, told AMANDALA that the case is about to be heard on February 24 in the Supreme Court, where the application, on behalf of the government, to strike out the proceedings will be dealt with. The Chairman of the Elections and Boundaries Commission, Oscar Sabido, had made a submission to cancel the legal action earlier this year on the grounds that the claimant failed to file its submissions on time and the new administration had already begun the process of preparing for the redistricting exercise. Enriquez said, however, that a declaration from the court on the matter is being sought by the Belize Peace Movement.

"Now that government has already started the exercise, why is it necessary to continue with the case? But you know, we have heard these things before already. A promise is a comfort to a fool. We want to see it take place, because there is no guarantee, even if they say they will do it now, once the case is withdrawn, they will continue with doing it, and so we need to have this case settled in court. Because we also want a determination from the court itself, what is their view on the Constitution, and not only that, but for future reference, we will be able to say that in fact this matter was settled by a court and the court made certain precedents." Enriquez explained.

The core matter that the claimants are seeking to address through the courts is the disproportionality in the number of voters registered in the various constituencies of the country in order to ensure fair representation for the citizens in those specific divisions, and across the country. The BPM has argued that voters in larger constituencies are accessing a lower level of representation.

Enriquez also mentioned that the court had instructed the parties to meet and engage in a form of dispute resolution, but the government side had rejected that option, according to him.

"We had made efforts to settle this matter without having to go to court. We had made proposals to the Election and Boundaries Commission and, in fact, on the instruction of the judge, that we should meet and settle the matter amicably. These proposals were rejected by the government's side, because by now that matter would have been settled already and everything would have just proceeded the way it normally does, and so we don't know what the government insisted on going to court, because in our opinion there can only be one determination, which is that in fact that the question of the constitutionality of the voter's role is what is going to be determined, and it is clear in the Constitution, in our view, that it ought to be done in such a way that it ought to be approximately equal, and they are not. It is very, very clear to us," he said.


In regard to the benefits that would accrue to citizens of the country if voters are more equally distributed across the various constituencies, Enriquez said, "The more representation you have, the better your interest is going to be represented. What we see now, for instance, let us say in the Lake I constituency, on the day Mr. Cordel Hyde makes, has his clinic, there will be many persons out there waiting to see the Minister. Now, if his constituency was properly proportioned, there will be less persons to see the ministry and your chance of getting to see the Minister will be much greater than it is right now, since you have so many people to deal with, so representation is very important."

The case, if the high court rules in favor of the claimants, could result in the redistribution of voters and thus alter the size of certain constituencies to allow for equal representation in divisions across the country. It could also lead to an increased number of divisions across the country and an expanded House of Representatives.

Father of 2 faces extradition for RTA 23 years ago

A resident of Belmopan who is facing possible extradition is currently on remand at the Belize Central Prison after being denied bail in the Belize City Magistrate's Court on Tuesday of this week. Osmar Eliaser Correa, 46, was informed by Chief Magistrate Sharon Fraser of the reason for his arrest—an order issued by the Ministry of Foreign Affairs for his extradition to the US so that he can answer to charges for a fatal road traffic accident that reportedly occurred in that country 23 years ago.

Reports are that the extradition request was handed down by the US Embassy in Belmopan on January 14 of this year. Correa had reportedly absconded from the US more than 20 years ago following the incident. Now a husband, father of two, and successful businessman, he will possibly have to face charges for his past actions that may very well land him in prison for an extended period.

According to his attorney, David Morales, who argued fervently for bail to be granted to his client, Correa is claiming that the circumstances surrounding the incident, which occurred in 1998, are different from the scenario being described by the US authorities. Morales, who has lived in Belize for almost 23 years, has been reportedly traversing the western and northern borders with his passport without encountering any difficulty. Yet, he was denied bail on the grounds that he is a flight risk. He was informed, however, that he does have the option of applying to the Supreme Court for bail.

Morales is asserting that the US's delayed legal response to this matter is now affecting his client's life and livelihood. Correa will remain remanded until March 8, when the extradition hearing is set to continue.

Additionally, travellers will be reimbursed for emergency assistance services such as air evacuation and emergency expenses related to preexisting conditions. The insurance policy will also cover trip cancellations and other expenses incurred by COVID-19-positive travellers who require extended stays at hotels.

The BTB has informed the public, "Verification of travellers will take place at the Philip Goldson International Airport in Belize by the Immigration Department of Belize, and not airlines. The purchase of the insurance can be made before entering the country via the Philip Goldson International Airport (PGIA) or land borders. Also, the following are exempted from purchasing the insurance: QRPs, Belizeans & permanent residents, foreign homeowners, long-stay nonnationals, Peace Corps, military personnel, airline crew, and persons in Belize for less than 24 hours are exempt."

By the looks of it, the Insurance Corporation of Belize will be the provider of this insurance policy, despite pushback from various entities, including a number of large hotels. The new portal highlights the company prominently on its main page and lists that company along with BTB and BTIA in the website's footer.

Senate approves \$70 mil appropriation

BELIZE CITY, Thurs. Feb. 10, 2022

An almost 6-hour-long Senate meeting held yesterday ended with the Government of Belize's 70-milliondollar supplementary appropriation being read a third time and passed in the upper house. As reported, this is the third supplementary budget brought by this PUP administration since entering government, with the first additional allocation of funds being sought in October 2021. In December, the government returned to parliament to once more access additional funding, and now it is doing so again in early February, just a little less than two months before the new budget for the coming fiscal year is read.

Prior to outlining to the Senate how the additional funds are to be allocated, Lead Government Senator, Hon. Eamon Courtenay, very aware of the optics of a third request for extra funds by GoB, prefaced his explanation of the mainline items on the budget by stating, "In anticipation of the grandstanding, I want, Madam President, to explain for the benefit of those who intend to perpetrate mischief, the main items in the supplementary." He then went on to refer to the \$23 million (as reported in the Tuesday issue of the AMANDALA) that is being allocated to the Ministry of Health and Wellness as a part of this supplementary budget: "The first one, Madam President, under head 19:121 Medical Supplies, fifteen point five million, addresses the purchasing of drugs for the public service. It is stated right there, materials supplies, and

Faber can still run for leader, says Peyrefitte

On Monday, during a virtual interview, UDP chairman Michael Peyrefitte noted that despite the UDP's national party council's decision over the weekend to invoke the new Electronic Transactions Act 2021 in order to put into effect Patrick Faber's oral resignation, which was placed in a video message about two weeks ago, Hon. Faber is still eligible to vie for leadership of the party on nomination day, set for this Friday. Faber, however, has indicated that he does not intend to do so, said Peyrefitte.

"Technically yes, he can run again.

vote. This activated his resignation despite his subsequent decision to not submit a resignation letter – although Faber had insisted in an email to Peyrefitte that a vote by the National Party Council could not remove him from his leadership post.

Peyrefitte has referred to statements made by Faber subsequent to a video message in which he pledged to resign on January 31, as irrelevant, since the electronic publication made in late January amounted to his final decision on the matter.

"Any pronouncement that you make through any electronic form, and electronic form is defined right here in this very act, so I have to believe that when the Honorable Patrick Faber made that statement, he knew or ought to have known that pronouncement publicly through an electronic form would take effect as much as it would have taken effect had it been in writing," Peyrefitte said.

In regard to any possibility of a legal challenge being brought by Faber, Peyrefitte remarked, "The courts are wide open. We live in a democracy, people are free to go to court and whatever the court decided then that's what the court decided. I know I have read the act very clearly; come January 31, based on what that Hon. Patrick Faber had said to the world, come January 31, he had resigned, and so whatever he wrote or whatever he didn't write, subsequent to that he was writing it as no longer the leader of the UDP, so how can you say that it is not your intention to resign when you have already resigned," Peyrefitte said. Those seeking to be selected as the new leader of the UDP have been given until February 11 to submit their names so that they can participate in the March 27 UDP national convention. So far, only Hon. Moses "Shyne" Barrow and Hon. Tracy Panton have indicated that they will seek to become the new leader of the party.

pharmaceuticals, and consumables. And, before mischief-makers take to the floor, let me make it abundantly clear that there are a number of amounts stated under the subhead, 'contracts and consultancy'. No appropriation is being made for any consultancy. All of these under the Ministry of Health, we are told, are for contracts for the supply of services and goods, not consultancy. It is styled 'contracts and consultancies' simply because that is the heading that is given to that subhead," he said.

In reference to that amount being sought for medical supplies, however, Senator Darrell Bradley pointed out that the "devil is in the details," and he noted that for the preceding 11 months the government had budgeted just 10 million dollars for the purchase of pharmaceuticals and supplies in the Health Ministry, but is now, at this late juncture, asking for \$15 million more, just one month before the new budget is read.

"The devil is in the details. The government is coming to this house to ask for the approval of the house to allocate in one month an additional 15 million dollars for pharmaceuticals and supplies, in circumstances where the entire year's budget 11 months was only 10 million dollars. With the absence of any explanation, just the figure, so that, with respect, but to tout the idea that this is transparency, in my view, is not accurate," Senator Bradley said.

He further commented, "I will not respond to anything that he would say that the United Democratic Party has done [in reference to the PUP's insistence that the previous UDP administration had accessed large amounts of supplementary funding for the budget without formally getting the approval of parliament], but I will say that if we are debating this budget allocation and the government is asking for an additional 15 million dollars in the final month, in order for me to vote in favor of that, I need to have details, I need to know why." Senator Christopher Coye, during his address to the Senate, however, revealed that a portion of the funds will be used to cover unpaid expenses incurred by the past administration. "That 15.5 million in a sense is a bit of a catching up, because of payables [from] the past administration that had not been paid. 5 million were taken out of the approved estimates to pav those past payables, so this 15 million, a portion of that has to account for

what is accrued for this year," he said.

While the sizable allocation of funding to the Ministry of Health and Wellness was hotly debated, Senator Michael Peyrefitte focused on the other spending to be done with the supplementary funds, including the purchase of vehicles and the repairs being done to various sections of the office of the Prime Minister.

"Purchase of vehicles—\$750,000 they have spent already for the year budgeted for; they come back one month before a new budget is to be read after spending \$750,000 worth of vehicles. They are asking now for \$733,000 worth of vehicles now. Taking us to just under 1.5 million dollars for the year. So you can look at public servants, can't give them increments, telling them to wait, we are all punishing in this together, we are all taking this lick, but I as the prime minister get to sit on \$45,000 worth of furniture and get 1.5 million dollars worth of vehicles. You really think that's going to fly with the Belizean people? Some of the expenses make no sense, and some of them go to projects that you didn't allocate a penny for the entire year," Senator Peyrefitte said.


He also made reference to budgeted allocations to cover personal emoluments for the office of the Director of Public Prosecution (DPP).

"The numbers don't lie, and the intent of the government cannot be hidden. When you look, Madam President, general administration, personal emoluments for the D.P.P. office, a hundred and sixty-seven thousand dollars-for what? You didn't know that in December? And if they wah come with scratch records, Madam President, then the music has to scratch. Because, if you show no creativity and no new ways of growing the economy, like the current Prime Minister criticized the previous Prime Minster for not doing, then you are going to hear the same thing as well. You have personal emoluments, you can't give the people their ten percent back, you can't give people their pay, but you can hire more people," Hon. Peyrefitte commented. The Senator representing the country's unions, Elena Smith, also noted the additional hiring being done by GoB, despite the moratorium on hiring and 10% salary cuts endured by government-paid workers.

You would remember when the Honorable John Saldivar had resigned after becoming leader-elect, there was a subsequent election to choose just the leader because he resigned and then he ran again. So technically, he can run again, although from what he has said to us in the NPC, he said that for sure he will not run again. But of course, it's his option to run again if he so chooses," Peyrefitte said.

During the national party council's extended virtual session this weekend, members of the council voted on whether to accept Faber's resignation as final under the Electronic Transactions Act 2021. At the end of the day, the results were nearly split down the middle, with Faber losing by reportedly just one

"I, as of the end of this month, Madam President, and colleagues, I will be stepping down as Senator representing NGOs. I have tendered my resignation to the steering committee of the Belize Network of NGOs. The reason I have decided, after much contemplation and deliberation, is that, and the advice that I sought, is that I have applied for and have offered to work for the World Wildlife Fund in the position of Country Lead for the Project Finance for Permanence. That three-year undertaking will inevitably require negotiations, discussions and agreement with the government. So, I made that discussion because I do not want even the appearance of conflict of interest in the work that I will be charged of leading as of next month," stated Salas.

Senator Salas, who was selected in 2017 by Belize's NGOs to occupy the post of a 13th Senator in fulfillment of a manifesto promise made by the UDP administration, has served in the Senate for 5 years. In response to his announcement, his colleagues on both sides of the Senate wished Salas well and expressed appreciation for the role he has played in the upper house.

"We respect his decision and salute his service. Senator Salas, like the other members of the Senate and particularly those from the social sector, has distinguished himself in the mature, sober, and quite [a] comprehensive way in which he prepares and participates in the work of the Senate," stated Senator Eamon Courtenay, Lead Government Senator.

"I just want to echo the sentiments of the leader of government business in that indeed Senator Salas is to be respected for his level of preparation and participation in the Senate process. One thing was for sure, while you were here and continue to be here, is that you would not leave a stone unturned, you took this job seriously and you applied yourself continuously every time to every debate, and to every process of the Senate and for that I congratulate you and I thank you and I wish you well in your new endeavours with the World Wildlife Fund. Thank you for your service, Senator Salas," remarked Lead Opposition Senator Michael Peyrefitte.

Senator Salas' fellow senator representing the social partners, Senator Elena Smith, who represents the country's trade unions, also commended Salas for the contributions he made during his five years in the Senate. "I want to acknowledge the work of Senator Salas, as well to acknowledge the partnership that we, as social partner senators, have created, over the last few years. Senator Salas, know that you've done well and that we are proud of the work that you have done along with us and your commitment to ensuring we do better as social partner senators for our country, for our people," Senator Smith said.

According to Senator Chris Coye, who also wished Salas well, Salas' role at the World Wildlife Fund will involve heading a team that will develop the world's first fully Coastal and Marine Project Finance for Permanence.

for personal emoluments. I am being told that we are requesting more funds, and I understand that there are new persons being hired. Well, I came here today, and I saw a new person here, so I don't know if that is a new hire or if that is an old person that came back, I don't know. But, in any event, we heard about the Director of Public Prosecution, we are hearing about honorariums. Yet, Madam President, a year ago, the same people who are coming to say that these people need to get their honorariums came to me and said to my colleagues that we must sacrifice because all of us must share in the pain. So, how is it that all of us were to share in the pain but not all of us can share in the honorariums? It cannot be," Senator Smith stated. In the end, Senator Smith, along with the senators representing the Opposition, did not support the supplementary allocation, and she specifically cited a lack of information on the government's part as the reason

she was withholding her support.

"We don't come to the Senate to just go against or vote against what is presented. We do our very best to support what comes to us, but we can only support if we have enough information. When we are asking legitimate questions, we ought to be given the responses," she said. Senator Courtenay noted during the session, however, that the supplementary budget they were reviewing was an indication that the current administration is complying with the provisions in the Constitution by seeking the approval of the National Assembly before accessing extra funds. Return to pre-Omicron levels depends on us-Dr. Manzanero

New models from the Epidemiology Unit are projecting a return to pre-Omicron levels of COVID-19 within three weeks. Dr. Russell Manzanero says now is not the time to relax.

BELIZE CITY, Wed. Feb. 9, 2022 New models developed by the Ministry of Health & Wellness' Epidemiology Unit are predicting that the country might see pre-Omicron levels of COVID-19 cases within the next two to three weeks, but according to Medical Epidemiologist Dr. Russell Manzanero, it is still not time to let our guard down, as the behavior of the public can easily shift the trajectory that is currently being seen. According to Manzanero, the models are indicating what could likely be the scenario within a few weeks on the basis of current trends. But those trends depend on what people choose to do in the upcoming days and weeks, and could change.

"In regards to the model, it's pretty much saying that by mid-February or the ending of February you should start seeing a downward trend of cases in regards to where we're at. However, I must say that models change and, particularly, the nature of Omicron in itself is very fluid. We really can't develop a true model to tell you 'this is what is going to happen,' because Omicron is spreading so fast and the transmission rate is so high," said Dr. Manzanero to local media.

Even in the face of the highly transmissible Omicron variant, data from the Epidemiology Unit has revealed that the country's positivity and January, to near 20%—a sign that the peak of the fourth wave of COVID-19 might be nearing its end. Dr. Manzanero has warned, however, that all that could change the moment public health measures are no longer adhered to.

"If we're adhering to the social measures and the public health measures, all these are factors that can influence your model. So if we continue as is with our public health measures and vaccination coverage, we can see that there will be numbers decreasing. However, if we go back to being a little lax or we are not enforcing the use of the mask, or not getting our vaccines, all these numbers can change," he stated.

"We have to do our part or the numbers will go right back up. If we don't maintain our measures and if vaccination doesn't continue, we will see an increase in numbers again," he added.

The Omicron variant, which was first reported in South Africa, after which it surfaced in the United Kingdom, is highly transmissible, thus causing a rapid spread of the virus, but the symptoms exhibited by persons infected with this variant are notably less severe than other variants, such as Delta. Even so, said Dr. Manzanero, there have been ICU admissions and some deaths as well due to Omicron infections, including in Belize. And while the peak of the fourth wave seems to be nearing its end, there is no telling if and when the wave will come to a conclusive end.

"To say that you're over a wave basically is that you are reporting no cases. To say 'okay, we're finally over a wave,' you'd basically have to have zero cases for x amount of time. We are not at that. We were never at that. We've seen an increase of cases, a decrease of cases, and that is how this will be. Omicron will not be the last variant that we'll see. We'll see others, and this is the nature of the virus. It mutates, it adapts, and it's trying to establish itself within the

order to rebuild the government, public service and the wider economy of this country. The supplementary appropriation bill is before this Senate because we have committed to seeking the approval of the honorable House of Representatives and the Senate prior to expenditure whenever it is possible and required by law," Senator Courtenay said.

He also mentioned that the government is making efforts to organize a system through which the Senate can have meetings as a committee to discuss the details of these types of bills before they are presented in the upper house. The bill was passed at the end of the day's debate. population. So this is the way how it's going to go," he added.

"I'm not saying we're going back in three weeks. This is a model that has been done, and if we continue like this, then that is what might happen. I'm not saying it is," Manzanero emphasized.

Manzanero said that he is hoping the country can reach a positivity rate of less than 5% that can be maintained for over two or three weeks, after which it would finally be safe to say that the numbers are decreasing. And while it can be expected that numbers might rise with the reopening of land borders on February 7, Manzanero said that it is all still dependent on the public and how well they adhere to public health measures, including getting vaccinated.




Automation is not about displacing people

If the Port of Belize (PBL) had not been built by the government and people of Belize for the development of our country, the receiver might not have been crossing the line if it said to the GOB, 'if you don't give us the green light to dredge the channel, create a deep water berthing area to accommodate great ships, and build a cruise port, we will not invest in modern equipment to make the port more competitive to handle goods'. But because PBL is of tremendous national importance, when the receiver issued that ultimatum to GOB, it went out of bounds.

The fact is that even if PBL was a product of private enterprise that had received no development concessions/incentives from the GOB, and it had been built on a prime area of our country that was privately owned from colonial days, it would still have some debt to Belize. Indeed, no individual or business that enjoys all the protections provided for by our Constitution, and uses our assets, be they natural or paid for by the labor/taxes of the people of Belize, is free of responsibility to our country.

If the receiver at PBL was a good "citizen", the right investments would have been made to modernize the port, making it more competitive. If the necessary improvements had been made, ASR/BSI, the manufacturers of sugar at Tower Hill, Orange Walk, quite likely would still be shipping their product through PBL, not transporting it by road all the way to Big Creek, to the Port of Big Creek-Toledo Enterprises Ltd. (PBC-TEL).

The victory at PBC-TEL, getting ASR/BSI to send its sugar their way, is a big loss for PBL, especially its workers who had the job of receiving the bulk sugar and transferring it to the ships that take it to its destinations abroad. Whichever way



you look at it, though, in our "big business"-dominated economic system, it's not clear sailing for the stevedores. They lost the handling of sugar because PBL is antiquated, but if the company introduces modern equipment, it will need fewer workers.

PBC-TEL, the port in the south of the country, has invested millions of dollars over the last two decades to improve its facilities. The channel at PBC-TEL was deepened, its storage area was increased, and it was equipped with modern machines. With all that hightech equipment, PBC-TEL needs few workers, relative to PBL. It is without doubt that had PBL modernized, it too would have needed less man hours to get its job done. Claire Cain Miller, in the January 12, 2017 New York *Times* story, "A Darker Theme Obama's in Farewell: Automation Can Divide Us", said a darker theme underneath the nostalgia and hope in American president Barack Obama's farewell address to the American people (in 2016) was his discussion of "the struggle to help the people on the losing end of technological change." Miller said Obama's

successor, Donald Trump, "tended to blame trade, offshoring and immigration" for the loss of jobs in the US, but Obama said "the next wave of economic dislocations won't come from overseas, it will come from the relentless pace of automation that makes a lot of good, middle-class jobs obsolete."

Chris Weller, in a 2016 story in the *Business Insider* titled, "Obama just warned Congress about robots taking over jobs that pay less than \$20 an hour", said an Oxford University study done in 2013 "found 50% of jobs could get taken over within the next 10 to 20 years", and a story in *Tech Insider*, by Ian Pearson, an author and fellow at the World Academy for Arts and Science, said that only workers who were involved in complex human interaction that a machine can't replicate, such as teachers, police officers and managers, will have job security in the future.

It isn't just stevedores and other manual workers whose jobs are under threat from automation. In agriculture we have seen many farmers displaced from the banana, citrus, and grain industries as large farmers with high-capacity equipment have made the smaller ones less competitive. Santander, whose output is equivalent to more than 50% of the production of the over 5,000 sugarcane farmers in the Corozal and Orange Walk Districts, is a single-owner corporation with a mere handful of contributing farms.

One of the areas where small farmers have held their ground is in vegetable production, but they too are not immune from being thrown out into the world as job seekers. A single tomato farmer with modern equipment could supply our needs. Belize consumes an estimated 250,000 pounds of fresh tomatoes per month, and a single farmer with only ten acres in production each month, ten or twelve workers, and the right equipment could easily satisfy all our demands for that vegetable/fruit. Many of us are in the "firing" line; as Weller stated, more than 50% of jobs in the developed world could be replaced by automation in the next two decades.

It is good when business owners have a conscience in regard to labor, when business owners are not consumed by greed. It is also good when workers have strong unions. But the onus is on government to ensure that its citizens don't lose their livelihoods to machines.

In a dictatorship, the people don't have much say; but in a democracy, which is government of the people, by the people, for the people, leaders have to respond to who elect them. Machines should work for people, not displace them. In highly automated countries, workers aren't displaced, they just work less hours. Instarem, at the website instarem.com, said that in 2017 the average work week for the average Mexican was 43 hours, while the average German worked 26 hours per week. It's only in a regressive country that stevedores would lose if PBL stepped up and got the equipment the company needs to be competitive. In the case of the stevedores, especially considering the facts surrounding the port, the government would be duty-bound to insist that any worker whose job is made redundant by automation is given every opportunity to learn another job at the workplace, or is sufficiently equipped through training to find placement in a new work environment. The vision of the present government is to stimulate the private sector, grow the economy, and encourage efficiency. It is good to push private businesses, but our government can't wash its hands of workers. God forbid that our GOB is banking on "trickle down" from big businesses. That economic model fosters unemployment and underemployment, and ends in caravans on the road to the USA. Our workers need modern tools and equipment to make them more productive. Automation will result in increased profits for businesses, but it's not solely about them. The increase must be for all.

"The Government is working to better position Belize to emerge economically, reflecting a culture of environmental sensitivity and building on that brand," stated Minister Coye.

Dr. Leon, during the meeting, provided assurances of the CDB's commitment to assist borrowingmember countries in improving the lives of people and securing a sustainable future for the region's children. Some issues on the agenda included strengthening trade, innovative financing, advancing agriculture, and building economic and climate resilience. He stated that Belize's government and the bank have an aligned vision, and noted that "as we transition from the pandemic, we must seize the opportunity and create a future the rest of the region and our citizens deserve." This, he added, is urgent, and requires immediate, bold, and impactful steps.

These steps, he said, comprise a three-prong solution that involves (1) lifting nations out of the dire state many are in as a result of the economic fallout caused by the pandemic; (2) recovery post-rescue by rebuilding the region's economies' resilience to global pandemics and climate change, and finally (3) repositioning those countries' economies so that they can move on to the next phase to foster further economic development. He then pointed out that he hopes to steer Belize towards a path of meaningful recovery.

The discussion with Dr. Leon included updates on the state of Belize's economy and developments in the financial sector, as well as potential areas for CDB support, the need for collaboration between the public and private sectors to promote economic expansion, regional integration, and areas for strengthening the relationship between Belize and the CDB.

The CDB delegation is expected to announce four new trade initiatives in Belize on Thursday.

The CDB president was accompanied on this visit by Isaac Solomon, the vice president (Operations) of the bank; Shelton Nicholls, senior advisor; Daniel Best, the bank's director of projects; Andrea Power, Coordinator – Regional Integration; and Cassie-Ann James, communications officer.

The Central Bank was represented by Sidney Campbell, chairman of the board of the Central Bank, and Mr. Emory Ford, the manager of the Central Bank's Research Department. Minister Coye was joined by Joseph Waight, Financial Secretary; Osmond Martinez, CEO in the Ministry of Economic Development; and Karlene McSweaney, Economist in the Policy and Planning Unit at the Ministry of Economic Development.

The high-level visit of the CDB president is scheduled to last for one week.

Nationwide blackout caused by Mexican provider, says BEL

BELIZE CITY, Wed. Feb. 9, 2022

On Monday night, at about 6:30, a nationwide power outage plunged the country into darkness for a little over an hour. Belize Electricity Limited (BEL) has since reported that it was a disruption in the

operations of Comision Federal de Electricidad (CFE)— a Mexican company from which Belize purchases part of its power supply-that caused the outage reportedly across all districts. A release from BEL states, "An unexpected interruption in supply from Independent Power Producer (IPP), Mexico's Comision Federal de Electricidad (CFE) at Xulha, resulted in a power outage that affected all areas of the country." A power outage was also reported in Chetumal around the same time, according to our sources. By 7:58 p.m., power had been restored almost countrywide, according to the BEL release. The company's team reportedly discovered not long after the shutdown in power supply that the outage was



caused by a malfunction at the Mexican

provider and promptly moved to use local energy sources to commence a phased restoration—starting in the Stann Creek District, and then Cayo, before restoring power to the remainder of the country.

"Belize Electricity Limited utilized local and renewable energy sources to restore the national grid commencing within 20 minutes in the Stann Creek and Toledo Districts using BAPCOL, followed by hydro from BECOL to initiate restoration to the Cayo District. Power supply was restored to the remainder of the country by 8:10 with the support from CFE, which came back online during the gradual restoration that was necessary to ensure that safe and steady return of power supply to customers," the release from the company stated.



La automatización no se trata de desplazar personas

Si Port of Belize (PBL) no hubiera sido construido por el gobierno y el pueblo de Belize para el desarrollo de nuestro país, la receptoría podría no haber cruzado la línea si le hubiera dicho al Gobierno de Belize, 'si no nos da luz verde para dragar el canal, crear un área de atraque en aguas profundas para dar cabida a grandes barcos y construir un puerto de cruceros, no invertiremos en equipos modernos para que el puerto sea más competitivo en el manejo de mercancías'. Pero debido a que PBL es de tremenda importancia nacional, cuando la receptoría emitió ese ultimátum al Gobierno, se salió de los límites.

El hecho es que incluso si PBL fuera un producto de la empresa privada que no hubiera recibido concesiones/ incentivos de desarrollo del Gobierno de Belize, y se hubiera construido en un área privilegiada de nuestro país que era de propiedad privada desde la época colonial, todavía tendría algo de deuda a Belize. De hecho, ningún individuo o empresa que disfrute de todas las protecciones previstas por nuestra Constitución y utilice nuestros activos, ya sean naturales o pagados por el trabajo/impuestos del pueblo de Belize, está libre de responsabilidad ante nuestro país.

Si la receptoría de PBL fuera un buen "ciudadano", se habrían realizado las inversiones adecuadas para modernizar el puerto, haciéndolo más competitivo. Si se hubieran realizado las mejoras necesarias, ASR/BSI, los fabricantes de azúcar en Tower Hill, Orange Walk, muy probablemente aún estarían enviando su producto a través de PBL, no transportándolo por carretera hasta Big Creek, hasta el puerto de Big Creek-Toledo Enterprises Ltd. (PBC-TEL).

La victoria en PBC-TEL, logrando que ASR/BSI les envíe su azúcar, es una gran pérdida para PBL, especialmente para sus trabajadores que tenían el trabajo de recibir el azúcar a granel y trasladarlo a los barcos que lo llevan a sus destinos en el exterior. Sin embargo, se mire como se mire, en nuestro sistema económico dominado por las "grandes empresas", las cosas no están claras para los estibadores. Perdieron el manejo del azúcar porque PBL es anticuado, pero si la empresa introduce equipos modernos, necesitará menos trabajadores.

PBC-TEL, el puerto del sur del país, ha invertido millones de dólares en las últimas dos décadas para mejorar sus instalaciones. Se profundizó el canal de PBC-TEL, se amplió su área de almacenamiento y se equipó con modernas máquinas. Con todo ese equipo de alta tecnología, PBC-TEL necesita pocos trabajadores, en relación con PBL. Sin duda, si PBL se hubiera modernizado, también habría necesitado menos horas de trabajo para realizar su trabajo.

Claire Cain Miller, en la nota del New York Times del 12 de enero de 2017, "Un tema más oscuro en la despedida de Obama: la automatización puede dividirnos", dijo que un tema más oscuro debajo de la nostalgia y la esperanza en el discurso de despedida del presidente estadounidense Barack Obama al pueblo estadounidense (en 2016) fue su discusión sobre "la lucha para ayudar a las personas en el lado perdedor del cambio tecnológico". Miller dijo que el sucesor de Obama, Donald Trump, "tendía a culpar al comercio, la deslocalización y la inmigración" por la pérdida de empleos en EE. UU., pero Obama dijo que "la próxima ola de dislocaciones económicas no vendrá del extranjero, vendrá del ritmo implacable de la automatización que hace obsoletos muchos buenos trabajos de clase media". Chris Weller, en una nota de 2016 en Business Insider titulada: "Obama acaba de advertir al Congreso sobre los robots que se hacen cargo de trabajos que pagan menos de \$ 20 por hora", dijo que un estudio de la Universidad de Oxford realizado en 2013 "encontró que el 50% de los trabajos podrían ser tomados dentro de los próximos 10 a 20 años", y una nota en Tech Insider, de lan Pearson, autor y miembro de la Academia Mundial para las Artes y las Ciencias, dijo que solo los trabajadores que participaron en complejas interacciones humanas que una máquina no puede replicar, como maestros, policías y gerentes, tendrán seguridad laboral en el futuro.

No son solo los estibadores y otros trabajadores manuales cuyos trabajos están amenazados por la automatización. En la agricultura, hemos visto a muchos agricultores desplazados de las industrias del banano, los cítricos y los cereales, ya que los grandes agricultores con equipos de alta capacidad han hecho que los más pequeños sean menos competitivos. Santander, cuya producción equivale a más del 50% de la producción de los más de 5.000 productores de caña de azúcar en los distritos de Corozal y Orange Walk, es una corporación de un solo propietario con un puñado de fincas contribuyentes.

Una de las áreas en las que los pequeños agricultores se han mantenido firmes es en la producción de hortalizas, pero ellos tampoco son inmunes a ser arrojados al mundo como buscadores de empleo. Un solo agricultor de tomates con equipos modernos podría suplir nuestras necesidades. Belize consume aproximadamente 250,000 libras de tomates frescos por mes, y un solo agricultor con solo diez acres en producción cada mes, diez o doce trabajadores y el equipo adecuado podría satisfacer fácilmente todas nuestras demandas de esa verdura/fruta. Muchos de nosotros estamos en la línea de "fuego"; como dijo Weller, más del 50% de los trabajos en el mundo desarrollado podrían ser reemplazados por la automatización en las próximas dos décadas.

Es bueno cuando los dueños de negocios tienen conciencia en cuanto al trabajo, cuando los dueños de negocios no están consumidos por la codicia. También es bueno cuando los trabajadores tienen sindicatos fuertes. Pero la responsabilidad recae en el gobierno para garantizar que sus ciudadanos no pierdan su sustento a causa de las máquinas.

En una dictadura, la gente no tiene mucho que decir; pero en una democracia, que es gobierno del pueblo, por el pueblo, para el pueblo, los líderes tienen que responder a quienes los eligen. Las máquinas deberían trabajar para las personas, no desplazarlas. En países altamente automatizados, los trabajadores no son desplazados, solo trabajan menos horas. Instarem, en el sitio web instarem.com, dijo que en 2017 la semana laboral promedio para el mexicano promedio fue de 43 horas, mientras que el alemán promedio trabajó 26 horas por semana.

Es solo en un país regresivo que los estibadores perderían si PBL se esforzara y obtuviera el equipo que la empresa necesita para ser competitiva. En el caso de los estibadores, especialmente considerando los hechos que rodean al puerto, el gobierno estaría obligado a insistir en que cualquier trabajador cuyo trabajo sea despedido por la automatización tiene todas las oportunidades para aprender otro trabajo en el lugar de trabajo, o está lo suficientemente equipado a través de la capacitación para encontrar un lugar en un nuevo entorno laboral. La visión del gobierno actual es estimular el sector privado, hacer crecer la economía y fomentar la eficiencia. Es bueno impulsar a las empresas privadas, pero nuestro gobierno no puede lavarse las manos de los trabajadores. Dios no quiera que nuestro Gobierno de Belize esté apostando por el "goteo" de las grandes empresas. Ese modelo económico fomenta el desempleo y el subempleo, y termina en caravanas camino a los Estados Unidos. Nuestros trabajadores necesitan herramientas y equipos modernos para hacerlos más productivos. La automatización dará como resultado mayores ganancias para las empresas, pero no se trata solo de ellas. El aumento debe ser para todos.

HENB completes Digital Literacy Training Program

The woman-led NGO, dedicated to safeguarding Belize's culture and heritage, has been helping to highlight small creative and cultural enterprises.

Heritage Education Network Belize's Digital Literacy Training Program, which concluded on Friday, January 28, was aimed at equipping women's groups, cooperatives, and MSMEs (Micro, Small & Medium Enterprises) to make advancements in the culture and creative industries by providing them with two weeks of virtual training in social media marketing, graphics, financial literacy, and the integration of "culture" into business. In an exclusive interview with AMANDALA, Heritage Education Network Belize (HENB) co-directors Sylvia Batty and Dr. Rebecca Freidel Juan spoke about the project's impact on small cultural and creative enterprises from across the country and its role in the safeguarding of culture.

"In terms of the participants, we worked with people in the cultural and creative industries, and a lot of times people don't really know what that means, but it means anybody who leverages the expression of their culture to provide a source of income for themselves. What that looks like in Belize is people who have dance groups, drumming groups, women's cooperatives, small NGO's, artisans, people who have gift shops at archaeological sites, people who make embroidery or do weaving or make basketry or ceramics—which are all expressions of their culture," explained Batty, who also mentioned that the response to the news of the program was overwhelmingly positive. Out of a total of 35 applicants, 10

participants were selected for the program and 3 were awarded scholarships. The 10 participants, said Batty, represented artisans and traditional craft makers from across the country and from across different cultures and cultural expressions.

According to the co-directors, the main goal of the program was to provide participants with the tools needed to create a space for themselves on social media, which has rapidly become one of the main ways businesses and small enterprises achieve visibility.

"We live in a digital world, and if you're not on social media, really and truly you're not visible in Belize. And what tends to happen, especially in the cultural and creative industries, especially among people who are expressing traditional crafts, is that they don't have the platform and the tools necessary to tell their story," stated Batty. "Every person from every community should be able to tell their own story in their own words in the way that they want it said," she added.

The first few days of the Digital Literacy Training Program, led by co-directors Ella Békési and Dr. Rebecca Friedel Juan, focused on how participants can highlight their culture in ways that garner attention from audiences-and potential customers-on social media. A part of the training included lessons on how to use Facebook and Instagram, as the majority of the participants did not have a social media presence. They were also shown to use social media tools to transmit their culture and tell their own stories.

"We really wanted to give them the support that they needed and the information, the skills needed to stay afloat and to keep up with a really rapidly changing world," said Dr. Friedel Juan.

"We just really want to see them prosper. And I think quite a few of them told us as soon as they opened their page they started getting more interest and more orders for their products and their services," she added.

Heritage Education Network Belize, which was founded in 2020 during the height of the COVID-19 pandemic, was born out of an interest in Belizean culture and a desire to safeguard that culture. The organization's four co-directors, Sylvia Batty, Dr. Rebecca Friedel Juan, April Martinez, and Ella Békési are all archaeologists by training, and through their work, the four women were able to recognize the deep connection that exists between archaeology (and heritage) and people.

"What we cannot separate from



archaeology in Belize is the people—the human aspect or element of it," said Batty. "Because first and foremost this is everybody's history. So this is the history of all Belizeans that we excavate, that we report on, that we communicate our scientific findings to. But the second aspect of that is that there are a lot of people who engage with archaeology outside of research or outside of academia."

Those people are the artists, artisans, sculptors, traditional craft makers, and entrepreneurs who use their cultural expression as a source of income. This connection between heritage and people is what inspired HENB's first project, Heritage Highlight, which shines a spotlight on various Belizeans in culture and creative industries. Now, almost two years later, the NGO is once again aiming to assist those creative enterprises in promoting their work, only this time, as a result of the Digital Literacy Program, which was funded through the support of the Republic of China (Taiwan)'s Economic Empowerment Project, it will be on their own platforms.

While HENB started out by providing free resources to tourism professionals, cultural and heritage organizations, and artisans severely impacted by COVID-19, they have taken on several projects that focus on Belizean culture, heritage, and history since then, including their first annual KULCHA Symposium back in September 2021 and their Garifuna Cultural Project. Even after the conclusion of the Digital Literacy Training Program, the women behind the Heritage Education Network continue to engage with the program's participants and other workers in Belize's cultural and creative industries. For the past two years, the NGO has been operating solely through the support of its members, co-directors, and numerous volunteers.

U.S.'s first Black billionaire calls for reparations

This is my contribution to Black History Month 2022. My question is: where does the word "black" come from? It is derived from what term? America's first Black billionaire is calling for \$14 trillion in reparations to compensate for slavery, Jim Crow, and '200 years of systemic racism'

• Robert L. Johnson, America's first Black billionaire, is calling on the federal government to pay reparations.

• His suggested \$14 trillion would be roughly \$333,400 per Black person in the US.

• He also urged lawmakers to pass a decades-old bill that would set the stage for reparations.

Robert L. Johnson, America's first Black billionaire and founder of Black Entertainment Television (BET), is calling on the federal government to pay out \$14 trillion in reparations to Black Americans—and he wants a check too. Johnson made the charge in an interview with Vice News published Wednesday. "Reparations would require the entire country to ... admit that the result of slavery has been 200 years of systemic racism and for that reason Black folks have been denied \$13-15 trillion of wealth," Johnson told the outlet. "And therefore we as a country now must atone by paying Black people of all stripes—the rich ones, the poor ones, and the middle—out of our pocket." The figure could equate to roughly \$333,400 per person, based on 2019 data from the US Census Bureau that showed there are approximately 41.9 million African-

Americans in the US. The wealth gap between Black and white Americans exists for many reasons. The effects of redlining in the housing market, differences in education, homeownership, lower wages, unconscious and conscious biases, have all contributed. Johnson, now 75, told Vice News that a \$14 trillion payout would be enough money to close the wealth gap. However, he says he's "not exactly optimistic." There has been legislation introduced to support reparations for Black Americans. A bill to create the "Commission to Study and Develop Reparation Proposals for African-Americans Act," otherwise known as HR 40, would be a step towards the reparations conservation if it were to get passed. The bill was first introduced in 1989 by Congressman John Conyers. "HR 40, when it's passed, will not actually provide reparations for anyone, but what it will do is move us on the road to be more truthful and in direct conversation about what happened," Rashad



Robinson, president of Color of Change, a civil rights advocacy organization, told Vice News, "we're also seeing local communities have these conversations, seeing a reparations mindset to some advocacy work to repay Black people."

There have been local efforts, too, including in Evanston, Illinois which in March became the first town in the US to embark on a reparations plan. The Chicago suburb will spend \$10 million in total, starting with \$400,000 in mortgage relief for families. Johnson said that reparations should reach Black Americans of all walks of life, even those who have accumulated wealth. Johnson named successful Black people such as Oprah Winfrey, Lebron James, Michael Jordan, and even himself, of all being deserving of a check. "If you're a successful Black business, the idea is you've had enough," Johnson told Vice News, "but no one ever asks if [a whiteowned business] is too rich to benefit from investing in a football stadium, or receiving other benefits like preferential tax treatment or liquidity injections from the Federal Reserve."



AMANDALA will move in the direction of being a community newspaper rather than a political organ. How long we will survive is, of course, up to you, the people. I also want to do some writing otherwise. By and large, the years have been good ones. I will not answer the post-election rumours and accusations. Only time will be the judge, and you will know this was a brother that was sincere to you, the people."

Friday, November 8, 1974. (Reproduced on pg. 55 of FEELINGS, 1975)

As a young man, I considered myself a revolutionary personality, in the sense that I was challenging the most powerful institutions in this country. I knew there were certain leadership roles I could never play, because I suffered from a terrible airplane phobia, and it was clear to me that one could never be any really relevant leader of people unless one was prepared to fly to different parts of the region and the world.

Development (UBAD) was thrust upon me when the first leader of the organization, one Lionel Clarke, gave up the position after just a few weeks and went to New York City, where he has apparently resided ever since. I have never seen him or heard of him again from that time, early 1969. (UBAD was founded on February 9, 1969, split at the top in early 1973, and was formally dissolved in early November of 1974.)

After UBAD was dissolved, I apparently became attractive as a potential ally to the ruling People's United Party, which had come under serious pressure in the October 1974 general election and the December 1974 Belize City Council election from the relatively new United Democratic Party (UDP), which had been formed in early 1973 out of a coalition among the People's Development Movement (PDM), the National Independence Party (NIP), and a so-called, and leaderless, Liberal Party.

The reason I became attractive as a potential ally to the PUP, with whom I had been fighting from the time they charged me and the late Ismail Shabazz with seditious conspiracy in February of 1970, was because the 1974 general election suggested, based on my performance as the sole UBAD candidate, in the hotly contested Collet constituency, that there was a bloc of voters (about 4 per cent), whose loyalty was to those concepts for which UBAD and I had stood. (Before 1978, you had to be 21 years old in order to vote in Belize.)

After three or four private meetings between myself and PUP Deputy Premier, Hon. C. L. B. Rogers, I basically became a PUP ally. I ran the streets of Belize City with Hon. Rogers' no. 1 general, the late Ray Lightburn, and I regularly ate at Ray's mom's home, his mom being the late, legendary Lucille Eusey.

In mid-1977, the PUP decided.

1977. Remember, in December of 1974, the PUP had lost the City Council for the first time ever, to the UDP. This was a UDP victory which could be considered almost sensational.

I had a couple good friends in the PUP slate who urged me to accept a candidacy, even though I had publicly resigned from electoral politics in 1974. Against my better judgment, I finally relented and ran as a candidate for the PUP's socalled "Dynamic Nine." I was humiliated in that election. The UDP won all nine CitCo seats, and I ran last out of all the candidates.

So then, that is when I decided that the way I would contribute to my city and country was by job creation, with the newspaper being our only business at the time. We're talking about more than forty years ago. Incidentally, children were allowed to sell newspapers in those days when AMANDALA became Belize's leading newspaper in 1981.

The collating section of our newspaper then produced the core of the championship Kremandala Raiders basketball team, and it was that basketball team, I think, which enabled our second major business, KREM Radio, to survive some rough times after we began broadcasting in 1989. (In memory of James Wilfred Gordon. Peace and love.)

And so, all the preceding has been by way of introducing you to the fact that Kremandala suffered a tragedy this week when one of the newspaper collators who has been with us for almost three decades, Evan "Porque" Mitchell, was stabbed to death in Lord's Bank on Friday evening.

At the time, the chief of our collating section, Charles "Bigga" Myles, who has been with us from the middle 1980s, had himself been temporarily hospitalized at KHMH. When Porque was brought into KHMH emergency, Bigga was informed of the tragedy, and made contact with my second daughter, Jacinta, who runs the newspaper these days. Jacinta called me on Friday night. I was at home recovering from hernia surgery which had been performed on Tuesday at Belize Health Care Partners. There are Belizeans out there who have built Kremandala over the decades and to whom we must feel personal gratitude. Perhaps all you may have heard about is yours truly, but ours is not a one-man show. It never was.

No Mercy

Last week in Minneapolis, the home of George Floyd, another "n*gger" was killed by the police, another innocent "n*gger" was killed by the police. I use the word "n*gger", because that is how the police see black people, especially young black people. And by police, I mean black or white officers; they see black youth in particular, and black people in general, as criminals. Amir Locke, 17 years old, with no criminal record, and who owned a licensed handgun, was murdered by police, half asleep on a friend's couch. The police used a no-knock warrant to break down the door. A no-knock warrant means that a judge gave the police permission to surprise the person they were looking for. Amir was sleeping when they broke down the door, so one would imagine that your reflexes would immediately make you reach for your gun, in selfdefense. Well, he's gone-a young, promising life ended, by those who swore to serve and protect! He's gone, even though he wasn't the person they were looking for!

The first piece of irony in this case is that it happened in Minneapolis. The second piece is that the mayor had promised that the police would not employ that tactic anymore; police reform, he said, a year ago. Yet here we are, black people being murdered, without compunction, by the law! It happens much more than is reported; that is why responsible black parents have to give their children "the talk." The talk is instructions on how to act when stopped or confronted by the

the rate to 90-95 percent, while our figure is 59.4 percent, which explains the current situation.

Should we try to prosecute people? No, I don't think so. The point at issue is not political will. The fact is, everything has an equal and opposite reaction. We must respect people, whatever their position, and we must patiently explain the importance of taking specific measures. Take vaccination. You asked about the reason for COVID reinfection, etc. It is true that reinfection can and does happen. But do you know

police. Be polite, keep your hands on the steering wheel, no sudden movement, or else bang, bang, you're dead. What a horrible and inhuman, not inhumane, way to live!

Black people were brought to the Americas in chains, against their will. They were kept in chains during slavery, in a different kind of chain beginning during Reconstruction and through present day, nonstop. We live, every day, with that chain around our ankles and that knee on our necks, and yet we go on. Some thrive, some are left behind, and the racism is constant, throughout the four centuries since our arrival. It doesn't matter if our leaders or presidents are white or black; that

the reinfection rate among those who have recovered from the disease? People do get reinfected - your colleagues in this room, and our international media are writing about such cases. Dear Amandala,

We have been following the conflict between the Maya communities of Toledo and the Government of Belize for a long time. Because of our many years of work in the area, we have served as expert witnesses in cases brought before the Supreme Court of Belize concerning Maya lands.

We write to clarify a few points concerning the history of the case and the organizations that have been involved.

The central point of the CCJ Consent Order is that the Government and third parties must recognize the rights of Maya communities to make their own decisions regarding how they use their water, forests, wildlife, and other resources. As it states:

The [CCJ] accepts the undertaking of the Government to, in consultation with the Maya people or their representatives, develop the legislative, administrative and/or other measures necessary to create an effective mechanism to identify and protect the property and other rights arising from Maya customary land tenure, in accordance with Maya customary laws and land tenure practices.

So who are the 'representatives' of the Maya people?

Over the past twenty-two years, two organizations have pursued the legal case on behalf of the land rights of Toledo villages: the Maya Leaders Alliance (MLA) and the Toledo Alcaldes Association (TAA). The TAA, which coordinates the work of the alcaldes, is also a signatory to the April 2015 CCJ Consent Order.

Recently, the names of several other organizations have been mentioned in discussions surrounding land rights, but how have they been involved in this long legal process? The Toledo Maya Cultural Council (TMCC) was involved along with the TAA at the beginning of the cases in the 1990s. But the TMCC fell apart in around 2000 and has been inactive ever since (until it was recently revived, apparently to oppose the MLA and the TAA). The Kekchi Council of Belize was also active in the 1990s, but has not been heard from in a long time. SATIIM was for a time



Belize Zoo resumes night tours

BELIZE CITY, Tues. Feb. 8, 2022

For over fifteen years, The Belize Zoo has been offering night-time tours for tourists; however, following the onset of the COVID-19 pandemic and the drastic reduction in the number of tourists entering the country, the Belize Zoo has embarked on an effort to market its night-time tours to Belizeans. According to the Belize Zoo's Director, Celso Poot, the objective of the tour is to showcase the nocturnal animals living at the zoo to its visitors.

"What happened is that a lot of the animals in the tropics are very nocturnal, so they're active at night, and when you come to the zoo during the day, you tend to NOT see these animals, and if you see them, they appear to be sleeping or hiding from you, which is the natural setting for

the zoo, so you have to look for the animals. We've been doing night tours for some years now, fifteen/ twenty years, but mostly to the tourists and the guests staying at the zoo and the Tropical Educational Center, and when the pandemic hit us, we decided to reduce the rates and open it for Belizeans so that we can provide food for the animals. It was a hit with Belizeans, so people come to the zoo [to] spend the night for birthdays, people come to the zoo [to] spend the night for different activities. When you do the zoo at night, you don't see the animals that you would see during the day, because we focus only on the nocturnal critters," Poot explained.

Due to the ongoing COVID-19 pandemic, many precautionary measures are in place to prevent the spread of the virus at the zoo. The facility is Gold Standard Certified by

the Belize Tourism Board and does private tours for a maximum of ten persons.

"We are Gold Standard Certified, both the Zoo and the Tropical Education Center, so both facilities are Gold Standard Certified by the Belize Tourism Board, so we have all the protocols that the big hotels they have in place; we have all those protocols in place at our site as well. What we normally do is that we advise families to do private tours so you can bring your household; up to ten people can do one tour in a group. Families of four come and they just want to their family in the tour and we can do up to four tours for the night is the maximum we can do, and so we never had to turn anybody back because we plan it where there won't be a lot of interaction with people outside your group," noted Poot.

One of the plans that The Belize Zoo has in place is to transform the landscape of the current establishment so that the animals are in an environment similar to the natural habitat in which they would have otherwise lived and also to facilitate genetic diversity.

"The reason why corridors are so important is that they create space for movement so that we have genetic diversity. The animals need to move across the landscape so that they find partners so that their genes can flow. As Belize develops, you find what we call a lot of 'forest fragments', some little pocket of forest all over the place. You have animals living in these forest fragments. So what the zoo is doing, the zoo is protecting some of these lands along with other partners we have developed to what has called the 'Maya Forest Corridor", said Poot.

He further explained, "The Maya Forest Corridor is protecting lands to ensure that connectivity between the forest in the north part of the country and the forest in the southern part of the country, so we're connecting those big contiguous pieces of land through the Maya Forest Corridor, and the zoo is a big part of that. This land that we managed, we have animals like the Tapir, white-lipped peccary, we have jaguars, pumas, we have the endangered yellow-headed parrot and that is what we are doing. We are moving away from that zoo setting to a now more wildlife natural setting similar to a safari."

The animals at the Zoo are either donated; found injured, abandoned, or orphaned, and brought in for rehabilitation; or born at the Zoo. It is home to approximately 175 native animals and receives an average of 86,000 visitors annually.

On Putin's Fate

I carefully scrutinised Putin when Macron met him recently in Moscow on his doomed-to-failure visit. For the first time, I noted Putin's puffed and bloated face, the hitherto hidden strands of white hair. I came to the conclusion that his time to go is near. He may go to bed one night and never wake up again.

This assault on a fractured NATO, a divided and weak Europe, and his total ignoring of chaotic Britain, led by a fascist clown and a chancer, represents Putin's last hurrah, which is to leave as his legacy a kind of restoration of what the once powerful Soviet Union represented. And, his gateway to this is Ukraine.

But each time I think of Putin now, for some unnamed reason, this poem by Byron which harks back to my "A" Level years at Wesley College, when almost 60 years ago, Colville Young taught Literature in English to the combined "A" Level classes of Wesley, St. Michael's and St. Hilda's colleges, asserts itself in my mind's eye.

"The Destruction of Sennacherib" BY LORD BYRON (GEORGE GORDON)

The Assyrian came down like the wolf on the fold,

And his cohorts were gleaming in purple and gold;

And the sheen of their spears was like stars on the sea,

When the blue wave rolls nightly on deep Galilee.

Like the leaves of the forest when Summer is green,

That host with their banners at sunset were seen:

Like the leaves of the forest when Autumn hath blown,

That host on the morrow lay withered and strown.

For the Angel of Death spread his wings on the blast,

And breathed in the face of the foe as he passed;

And the eyes of the sleepers waxed deadly and chill,

And their hearts but once heaved, and for ever grew still!

And there lay the steed with his nostril all wide,

Belize to benefit from £500 million Blue Planet Fund

The UK's £500 million fund is helping developing nations tackle issues such as marine pollution, biodiversity, and sustainability through programs like the OCPP.

Belize is set to be the first Caribbean nation to benefit from the United Kingdom's £500 million Blue Planet Fund after an announcement that the first £16.2 million of the fund would go to five programs dedicated to tackling climate change, restoring ocean health, and reducing poverty. One of those five programs is the Ocean Country Partnership Programme (OCPP), through which the UK has been partnering with countries to deal with issues related to biodiversity, pollution, and sustainable seafood. In Belize, the UK will be partnering, through the OCPP, with entities such as the Fisheries Department, Coastal Zone Management Institute & Authority, and the Department of the Environment, as well as stakeholders in the public and private sectors, to exchange science, research, and development expertise.

The UK government began formal discussions with the Government of Belize on implementing the OCPP in the country in August 2021, and now the Deputy Director for International Marine Environment of the UK's Department for Environment, Food, and Rural Affairs (Defra), James Smith, is leading a delegation on a visit to Belize to launch the program. The delegation, visiting from February 6 to 11, includes members of the UK's Centre for Environment, Fisheries, and Aquacultures (Cefas) and the Joint Nature Conservation Committee (JNCC) and is being facilitated by the British High Commissioner, Her Excellency Claire Evans OBE.

"We recognise Belize's commitment to environmental management, marine conservation, biodiversity protection, and tackling climate change, and hope that UK's partnership through the OCPP will continue to support Belize's worldleading actions in these areas," stated the British High Commissioner in a press release.

According to the British High Commission in Belmopan, the UK delegation will be meeting with Prime Minister Hon. John Briceño and Governor-General HE Froyla Tzalam, as well as several Cabinet ministers, including Hon. Andre Perez, Minister of Blue Economy and Civil Aviation; Hon. Orlando Habet, Minister of




Sustainable Development, Climate Change, and Disaster Risk Management; and Hon. Jose Mai, Minister of Agriculture, Food Security, and Enterprise.

Hon. Andre Perez. Minister of the Blue Economy and Civil Aviation, expressed his gratitude to the UK government for the OCPP project initiative last year, stating "Belize's blue assets have been central to its development and quality of life of its people. The support of the UK government represents a strategic partnership contributing to our economic recovery through the effective management of our biodiversity, which underpins blue economic development."

The £500 million Blue Planet Fund (BPF) was launched in June 2021 and is managed by the UK's Department for Environment, Food & Rural Affairs (Defra) and the Foreign, Commonwealth, and Development Office (FCDO).

During an interview with Beverly Wade, Director of Blue Bond and Project Finance for Permanence Unit, she shared, "This program will build on activity and initiatives that were already happening in Belize, in particular, looking at marine pollutions, plastics, it will also look at effective managed of marine protected areas, strengthening science for protected areas but also for biodiversity management and also looking at aquaculture- how we now look at responsible aquaculture but also looking at the potential for aquaculture development in Belize."

Education: an essential tool for agriculture in the 21st century

Education is an essential public good. Without high quality, inclusive and equitable training, countries will not succeed in breaking the cycle of poverty that is leaving millions of children, youth and adults behind.

This reality acquires even greater importance, given the impact of the COVID-19 crisis. Countries will need to rehabilitate their economies and to overcome the severe consequences of the pandemic. Education is key to this process.

Agriculture, rural territories and their integration with urban centers stand to play a critical role in this agenda. Realizing the potential of rural areas will call for innovation and technology to trigger virtuous cycles of economic growth, job creation and the bridging of social divides.

In Latin America and the Caribbean, agriculture is a central activity and one of the few sectors that remained active after the outbreak of COVID-19. In the coming years, the sector will take another qualitative leap, incorporating the benefits of digitalization and other technological advancements.

This change will be inevitable and will necessitate the development of new capacities, because agricultural digitalization can assist in increasing the supply and quality of food, even while maintaining a harmonious relationship with the environment.

In tandem with these processes, the rural population and upcoming generations will need access to proper education, which will enable agroindustrial transformative processes to capitalize on the benefits of the Fourth Industrial Revolution.

Technology in and of itself will not drive these changes, but rather human talent and duly empowered organizations. Therefore, once rural activity implements the digitalization agenda, we must then take steps to ensure that education enables the rural population to assume a leading role. international organizations, such as the Inter-American Institute for Cooperation on Agriculture (IICA) and the Inter-American Development Bank (IDB), in collaboration with private sector allies, such as Microsoft, have issued a warning regarding the urgency of addressing the problems of rural connectivity and digital skills development.

In the Latin American and Caribbean region, there is a 34 percentage point gap between connectivity access in urban and rural areas. Digital skills development among rural dwellers is also limited, with only 17.1% of the population having acquired specific digital skills.


Furthermore, in Latin America, only 33% of schools have access to adequate broadband or internet speed. In rural areas, in eight of 10 countries, less than 15% of schools have sufficient broadband access or internet speed.

Education has been particularly hard hit by the pandemic, with the closure of schools and abandonment of schooling. According to UNESCO, 3.1 million youth and children in the region have fallen out of the education system. This scenario points to the challenges facing a rural education agenda.

It is therefore a matter of priority to align actions with future demands and to drive the development of agrotechnical education, by modernizing rural educational institutions to prepare qualified resources among rural youth, fostering rural retention, linkages with the production sector and the integrated and inclusive development of rural areas and their people.

We must prepare leaders to transform our agrifood systems. Thus, providing better opportunities through first-class education in agrotechnical schools should be prioritized.

This is the path to laying the foundation of a new rurality: better education, full connectivity and a population that is equipped to make intensive and intelligent use of new technology, thereby transforming rural areas into zones of opportunity and engines of economic development.





CCCCC wins Energy Globe Award for the third time

BELMOPAN, Tues. Feb. 8, 2022 The Caribbean Community Climate Change Centre (CCCCC) took home the Energy Globe Award for the third time ever this year for their project entitled "Water Sector Resilience Nexus for Sustainability in Barbados" (or WSRN S-Barbados), which aims to increase the supply, distribution, quality, availability, access, and utilization of water in Barbados by incorporating

energy renewable technology. The project, valued at US \$45.2 million, is being carried out in collaboration with the Barbados Water Authority and was funded by the Green Climate Fund (GCF). It was launched in January 2019 and is set to continue until March 2024. And according to the CCCCC, it serves to benefit not only Barbados but ultimately, the Caribbean region as well. Caribbean The

Community Climate Change Centre is an inter-governmental CARICOM institution that is located in Belmopan and provides support to the Caribbean region as it addresses the impact of climate change and climate variability.

"We are honoured to have won this award; it demonstrates the capacity and experience of the CCCCC to develop and implement, in partnership with CARICOM Member States, innovative and transformative projects that build the climate



The Energy Globe Award, established 20 years ago, has been hailed as one of the most important global energy awards for sustainability. It was created to honor some of the best and most innovative projects that address environmental challenges. The award has five categories—Earth, Fire, Water, Air, Youth, and a special category that varies from year to year. CCCCC received the award for the Water category.

According to a press release from

the organization, over 180,000 persons are set to directly benefit from the project's impact, while almost 285,000 will benefit indirectly. The project has included the installation of potable water tanks, including 1,500 personal tanks.

"In an effort to improve the water resilience of Barbados to the effects of climate change, the Government of Barbados and the CCCCC secured a grant of US\$27.6 million from the Green Climate Fund in 2015. Combined, with the co-financing from the BWA, the total project will invest over US\$45.2M to improve the water resilience of Barbados over 5 years," said the release.



Travel insurance mandate a "negative marketing strategy"

Dear Editor,

I have read with interest your article "Travel Insurance Pushback" in your edition dated Friday, February 4, 2022.

We appreciate your assessment of Tourism Minister Mahler's remarks that *it's not all about the big guys*. This was precisely why the letter of concern was written to the Ministry of Tourism in the first place.

While the larger hotels have more financial resources to leverage the cost of mandatory insurance, the midrange and small hotels, bed & breakfasts and hostels do not. These small-to-medium-sized properties, comprising the majority of our hotels, depend on the price-conscious traveler to fill their rooms.

Today's tourist does their own research and price comparisons as they review global and regional vacation destinations. A traditional booking for a family of four who already bear the responsibility of preliminary and post-holiday Covid tests now requires that such a family adds an additional \$72 US to their Belize entry cost. Interestingly, our main competitor, Costa Rica, has pulled all restrictions, aside from vaccination requirements, and Mexico is restriction-free. Belize will be the only mandated travel insurance country in Central America.

Although we hear that the travel insurance initiative has the backing of BTIA, we question this. Certainly the 15 members who signed the concerned citizens letter do not support it. To our knowledge, there have been no membership surveys sent out by BTIA to confirm this compliance status, and so we are left scratching our heads.





Senegal is handing out millions in money and land to its historic soccer champions



Sadio Mané and friends are richer by a few thousand dollars

The mood in Senegal after its men's soccer team won the Africa Cup of Nations (Afcon) for the first time on Feb. 6 has been close to ecstasy. It has spread beyond the capital city Dakar to communities in the US where Senegalese live, like Harlem in New York.

Following their victory over Egypt, Kalidou Koulibaly, Sadio Mané, and their teammates were treated to a grand welcome at home, helped by the declaration of a public holiday on the Monday after the final. But in addition to the goodwill of joyous crowds that cheered on the players as they paraded through streets on open-top buses, Senegal's president Macky Sall announced three rewards to the entire delegation of players and staff who helped achieve the historic feat in Cameroon.

Reward validates Aliou Cisse's long-term vision

Senegal will receive \$5 million as the official prize from the Confederation of African Football (CAF) for winning the 2021 Afcon.

But Sall said "the players and other members of the official delegation will each receive a special bonus of 50 million CFA francs (\$87,412) and a 200 square meter plot of land in Dakar," according to Reuters. They will also each be referred to as Grand Officers of the National Order of the Lion, Senegal's highest honor (the national team is known as the "Teranga Lions".)

Senegal's Afcon squad was staffed with some of the best players in the world in their positions, including Edouard Mendy whom the International Federation of Association Football (FIFA) recently crowned the best goalkeeper in the world. These players plying their trade at elite European clubs are well paid relative to Senegal's minimum wage of 36 cents an hour. Star man Mané, who became the country's joint-highest scorer of all time, earns £100,000 a week at Liverpool which is the equivalent of Sall's cash gift.

But not every member of the team earns as much as Mané, and the Senegalese president's gesture is not aimed at enriching the players anyway. Instead, it is more a recognition of perseverance shown by the team under the tutelage of Aliou Cisse, Senegal's 45-year-old head coach since 2015.

Cisse was Senegal's captain in 2002 and missed the last penalty kick in the country's first Afcon final against Cameroon. He was the leader as they reached the quarter-final stage in their first World Cup later that summer and, as coach, guided the team to second place in the 2019 Afcon. As one of the continent's notable local coaches, his story was a rallying point for neutrals who wanted Senegal to finally join Africa's group of soccer champions.

Sall wants soccer in Senegal's futuristic city

In addition to cash, land, and honors to the team, a 500 square meter plot of land will be set aside to memorialize the Afcon victory in Diamniadio. It is a township outside Dakar that is being remade into a \$2 billion modern city with a sprawling rail network and industrial park as part of Sall's Emerging

Senate supports Domestic Violence Motion

BELMOPAN, Wed. Feb. 9, 2022

There was unanimous support for the Domestic Violence Motion in the Senate this past Wednesday, just a few days after it received overwhelming support from both parties in the House of Representatives last week. The motion, which recognizes domestic violence as a widespread international public health and human rights issue, calls for the allocation of additional resources to effectively address the issue and for the undertaking of a legislative review aimed at filling gaps and putting in necessary reforms to bolster the country's response to domestic violence. It also calls for national leaders to take a zero-tolerance position on domestic violence.

During the Senate meeting, several

senators rose to express their support for the motion and condemned domestic abuse, including Lead **Opposition Senator**, Michael Peyrefitte.

"Madame President, this is a serious motion. And I don't think that anybody in this chamber could possibly oppose this motion. We on this side certainly wholeheartedly support it, because we believe, as has been immortalized in song, that there is nothing domestic about domestic violence, as it is termed," said Peyrefitte.

"I hope to see in the future, Madame President, the promotion of the reality that domestic violence is not a private matter. It irritates me every time I hear that such and such couple are dealing with it as a private matter, and somehow it should be left to them to sort out. Madame President,

violence, including the so-called domestic violence, is a crime against the state," he added.

UDP senator Jacklyn Burns also rose to support the motion, and during her remarks she addressed the many silent victims of domestic violence, and urged them to speak out. She cited the many horrendous instances of abuse that she witnessed while being responsible for Women's Affairs in the city of Belmopan.

Senator Darrell Bradley, during his comments, pointed to the need for more men to speak up about the issue of domestic violence, and he noted that more often than not, those who attend domestic violence prevention rallies and presentations are predominantly women. "And I think it must be said by more men in our society that this is not a women's issue. It is an issue that affects all of us. We may not be directly affected by domestic violence but, as was said in the Chamber, every member may have personal experiences, either being a victim of violence or witness violence or being a perpetrator of violence or knowing somebody who is a victim of violence," he said.

Labour senator Hon. Elena Smith spoke from the perspective of a teacher, and revealed that she had witnessed several instances of teachers being victims of abuse. She noted one particular instance in which a fellow teacher had been seriously beaten by her spouse and then left for dead. Not only did the victim suffer, said Smith, but so did her children who bore witness to the vicious act.

"Sometimes we don't realize or recognize how these actions affect our children. As teachers, we have to have these children with us on a daily basis. We hear their stories—especially the little ones who are so innocent. They come and tell you things that they would not understand their parents may not want them to be sharing, but innocently they share with us as teachers, and so we get all of what is happening in the homes. It affects the person who has been abused, it affects the children, but for those of us, as Senator Bennet said earlier, those of us who work with these persons are also affected," she said. Smith pointed out the need for there to be more focus on forms of abuse other than physical abuseincluding emotional, psychological, and sexual abuse. She also stressed the need to examine the systems that are in place to support and respond to domestic violence victimssystems that all too often fail to achieve their intended purpose. The meeting, which lasted just under 6 hours, also saw several other issues debated, none of which received the unanimous support that was given to the Domestic Violence Motion.

Earthshot Prize—1 million pounds for climate change

Caribbean Climate-Smart Accelerator is seeking nominations for the prestigious award of anyone with innovative solutions to environmental challenges.

BELIZE CITY, Wed. Feb. 9, 2022 In a search for world-changing solutions to climate change, the 2022 Earthshot Prize—an award of £1,000,000 each–will be given to five innovative entities. Caribbean Climate-Smart Accelerator (CCSA), an official nominator for the prize, is now seeking applications from Caribbean nationals, including individuals, businesses, communities, and organizations which could qualify for the prize.

Caribbean Climate-Smart Accelerator's CEO, Raquel Moses, spoke with AMANDALA on Wednesday about what CCSA is looking for in its applicants and also expressed her hopes that the Caribbean will win one or more of the Earthshot Prizes.

"Earthshot is looking for innovations that have the abilities to scale. It is meant for innovations that are already in existence, not for new ideas, so it has to be beyond the concept stage, whether it's a solution that can help mitigate, which is prevent, climate change or adapt to climate change. And it's a really exciting opportunity to bring some much-needed money to the region to address climate change," she stated. "We're looking for Caribbean applicants first and foremost because we are a nominator for the region. But we also want to see solutions that are in the pilot phase. So it doesn't have to be a massive implementation, but certainly something that is already proven that has the ability to scale. Now what we'd love to see is something that has the ability to scale across the region and can do so fairly quickly with this massive injection of cash," she added. Referred to as the most prestigious global environment prize in history, the Earthshot Prize was launched in 2020 by Prince William and The Royal Foundation and is designed to champion environmental change across the planet through the

innovation and ingenuity of its awardees. Any person or organization with a project that they believe can help solve climate change and enable progress towards achieving any of five "Earthshots" is welcomed to submit a nomination to CCSA. The five Earthshots are five simple goals that, if achieved by 2030, will improve life on the planet for all. Those five goals are (1) to protect and restore nature, (2) clean our air, (3) revive Our Oceans, (4) build a waste-free world, and fix our climate. The 2021 winners included Coral Vita, a company in the Bahamas reviving oceans by growing coral on land to later replant in the sea; the Republic of Costa Rica, which has been restoring nature by paying citizens to protect forests, plant trees, and restore ecosystems; and the city of Milan, Italy, which created Food Waste Hubs to recover food from supermarkets that would otherwise be thrown away and give it to NGOs which distribute it to those in need.

Moses also stated that the organization is hopeful they'll see great innovations coming from across the region. And even if an applicant's solution is not ideal for Earthshot, Caribbean Climate-Smart Accelerator will be able to potentially provide other sources of

Ma in Wendy's absence, Barrow spoke about his hopes for Belize, prison reform, and his rise from incarceration to being а parliamentarian. He also referred to himself as the Leader of the House of Representatives and stated that he plans to vie for the post of Prime Minister. Of important note, however, is the fact that "Opposition Leader in the House of Representatives" and "Leader of the House of Representatives" are very different terms-particularly because the latter term refers to a position that does not exist, and even if it did, that title would most likely be held by Ms. Valerie Woods, the current Speaker of the House of Representatives.

This is not the first time that the newly instated LOO has used parliamentary terms in a loose, or, at times, inaccurate manner. In August 2021, Hon. Barrow, after receiving his diplomatic visa, made his first trip to the U.S. since his deportation in 2009 and had indicated via a press release that he would be meeting with members of the U.S. Congress, state senators, and House members to "strengthen relationships and establish new relationships to further the development of Belize." In addition to meeting with those members of the U.S. government, Barrow had also made an appearance at the birthday party of fellow rapper Fat Joe in Manhattan, New York, and at that gathering he had stated, while expressing birthday wishes to the rapper, "I'd just like to wish my brother for over twenty years now a happy birthday. You know, I'm the leader of the House of Representatives and they call me 'Honourable', but you've been honourable for all the years that I've known you."

That misnomer used by Hon. Barrow had not been addressed or corrected publicly upon his return to Belize. This week, however, while on the *Wendy Williams Show*, he once again used the term "Leader of the House of Representatives" to refer to the post he currently holds. Belize," said Barrow. It was a statement that received a resounding standing ovation from the American audience. He then went on to speak about the need for change in the prison system.

Many Belizeans have objected to Barrow's leadership aspirations due to his past career as a hip hop artist and his subsequent conviction and incarceration in the U.S. two decades ago. The current Government of Belize even went as far as to introduce the 11th Amendment Bill, which was an attempt to bar persons who have served prison sentences from becoming members of the National Assembly. When asked by Remy Ma to comment on such views and actions, Barrow responded that he lets his actions and good deeds throughout Belize speak for him. One of those good deeds, according to Fat Joe, was giving land and housing to the citizens of Belize. Hon. Barrow also likened his journey to that of Malcom X and Nelson Mandela, the latter of whom was incarcerated because he opposed South Africa's apartheid laws.

Hon. Barrow also spoke on his dreams for Belize, including plans to demolish the "oligarchy" that exists in the country (an oligarchy which one might say that he himself is a part of and has benefitted from, with his father being former Prime Minister, Rt. Hon. Dean Barrow; his aunt being Hon. Denise Barrow, area representative for Queen's Square; and his uncle being Michael Finnegan, a former member of the House of Representatives and former area representative of the Mesopotamia division). "My dream is to transform Belize into a developed nation and to create equality. Right now our system is very imbalanced and people are not allowed the Belizean Dream. I want to create a Belize where you can go from a working-class laborer to a multi-millionaire," he said. "I don't want it to be the oligarchs in the upper echelons, they control everything and no one can have an opportunity to succeed based on their talent and success," he added.

During the 11-minute segment, Hon. Barrow himself mentioned that his family helped to form the United Democratic Party. Incidentally, today, when asked about Hon. Barrow's reference to himself as the "Leader of the House of Representatives," Prime Minister Hon. John Briceño said that he thinks Barrow misspoke. "By virtue of being the leader of the PUP and the Prime Minister, I am the leader of the House. I think he misspoke as usual ... always putting his foot in his mouth. I guess hopefully he will learn soon ...," PM Briceño said.

representing the Maya communities in the south.

"What caught my attention is that I've worked extensively since 2009 in the Maya villages in Toledo, and have seen first-hand the consultation that the TAA and the Maya Leaders Alliance; both the Toledo Alcaldes Associations and the Maya Leaders Alliance being intersecting organizations - I've seen how, in working and consulting in the villages in my role as an ethnographer, I've also been part of the organization of the alcaldes when they initially brought forward the case to the CCJ all the way through and how their representation occurred; and so my concern is that it seems to me that there is something that is happening right now that is not recognizing the 22-year longevity of the TAA and the MLA as representatives of the alcaldes," Dr. Baines said.

The TAA has traditionally acted as a body that collectively represents the alcaldes who govern the villages in southern communities. Many of these communities continue to lack the funding and technical expertise to properly carry out negotiations with entities such as the government on their own. The role of the TAA has traditionally been to act as a body through which these village leaders can acquire information relevant to decisions to be made by these communities, and by means of which resources can be mobilized, consultation on important matters can be carried out, and experiences and best practices can be shared between the communities.

Dr. Baines stated that any attempt to undermine or question the legitimacy and importance of that organization is not in the spirit of the 2015 Consent Order handed down by the government, and would prevent meaningful negotiations with the government across many villages.

"From what I've seen, the alcaldes have the authority, and they meet with their communities' members, but there is a structure; they don't all have the time or the expertise to interact with the government, while the TAA will come into villages if they have specific issues," Dr. Baines explained. She added, "The alcaldes make decisions with the communities, so they go back into the communities, they talk with the communities, they say 'okay, what do we want to do on this land, what do we want to allow', ... and then if they want to do something they are able to come into the MLA/TAA, they offer space, they offer food, transportation, they can talk to other alcaldes about how it works in their village and think about what kinds of regulations would allow them to continue the things that are important to their communities while still given the flexibility for the alcaldes to make

their own decisions. So, just because there are these organizations that allow the alcaldes to come together, just because there are these organizations that present a unified voice to government doesn't mean that there is no flexibility within the system for them to do what's best for their community."

Baines noted that, without this system in place, it would be difficult for them to coordinate the work of alcaldes within the various communities.

"There are systems of governance in the villages that, while they intersect with the government of Belize, they don't have the resources or the frameworks for putting what's best for their villages, their decisions into a formalized framework, so the TAA and the MLA have done and continue to provide them with the resources, the language, not the ideas, they build the ideas together, so part of my concern is that these organizations are being painted as sort of this topdown approach, like they are telling the alcaldes what to do, and I've just not ever seen it work that way," Dr. Baines pointed out.

She went on to note that while the government's position may be portrayed as a way to give the alcaldes more authority, it is not practical for those community leaders to launch campaigns as individual communities, without the support of a larger, unified body.

"It isn't practical for every single alcalde - yes, it is imperative for them to make their own decision, for their communities-but it's not practical for them to launch a campaign in the Belizean government. There needs to be representation, and that representation should be flexible enough to allow the alcalde system to work, for each alcalde to make decisions on their own, but to come together collectively to create a protocol that allows that process to happen," she said.

In regard to the language being used by the government in the FPIC protocol that GoB has submitted to the Caribbean Court of Justice (CCJ)—including the replacement of the word "consent" with consultation"-she said that such changes in the terminology go against the language of the 2015 CCJ Consent Order. "The decision about what happens with land in Maya communities is with the Maya communities, and they need to consent to anything that happens on their lands. From what I can see from the CCJ order, it seems like it's very easy to manipulate what consultation was to mean. Consent is something that's much more clear, and I think a blurring of the language is certainly purposeful. It undermines both the spirit and the letter of the original CCJ decision," she said. Dr. Baines further commented that the struggle will continue, despite the dissenting views and what appears to be an undermining of the representation of the Maya people.

"From my research, this is something that I know, that it's critical for health and livelihood of the Maya communities in Toledo for them to manage their land," she said.

Her research focused on how health is defined and maintained in those traditional communities, and she found a nexus between wholistically healthier persons and traditional living.

"I found that those families, those communities' members that defined themselves as most traditional in terms of their land use and in terms of their farming were those that were rated the healthiest. So, the way that Maya communities traditionally practice land use is critical to the maintenance of their health, of their bodies. Not just sought of the social health, although I look at all the layers of health, I don't separate the social from the psychological from the physical ... Traditional land use is fundamental to health and wellbeing and happiness," Baines shared.

Baines remarked that she feels the world is looking at Belize's actions as they seek an appropriate model for the resolving of similar issues in other locations, and the opportunity exists for the country to set a fitting example for governments and indigenous communities across the world to follow.

"I think the people are looking at the FPIC protocol as something that potentially that communities from all around the world can look at and think about, this is a way that we can come to the table and support our traditional practice and work with the government in this way. For me, it seems a shame for it not to play out in a way that seem to uphold the letter and the spirit of the original ruling," Dr. Baines said.

During an interview today, however, Prime Minister Hon. John



Briceño, when asked about the objections being raised by the representatives of the Mayan people to the approach being taken by government officials, said, "I think they will not be happy until we give them over the Toledo District, and that's never going to happen under a PUP government. What we have done is what the CCJ has asked of us, is for us to set the FPIC, the Free Prior. Informed Consent, which is basically a mechanism, where we go with them, anybody that wants to do any kind of projects in that area, that they could do and present it to them. But it is not a matter that they are going to have a monopoly as to what is going to take place in that area. Toledo is a part of this country, and as a government, we have a responsibility to the people of Toledo."

He added, "The consent, the way it has been structured or set by the CCJ is basically a process of where we go. It's not a process where they have any kind of monopoly as to say, if you wa put wa road they have to approve, that's not the case and will not happen under the PUP. We have a responsibility ... could we end it here, we have a responsibility to the people that live in the Toledo District, we have a responsibility to the Maya people to try to improve their lives. It's not only the MLA; the MLA is an association. We have a responsibility, and we are not going to abdicate our responsibility to the people of the Toledo District."
