

The 4th CARICOM-SICA Summit was held this Thursday, March 3, in San Pedro, Ambergris Caye, where

CARICOM and Central American Heads of State came together for the first time since 2011 to strengthen relationships and discuss ways to navigate the common challenges facing the two regions, including the climate crisis and the

pandemic. During the opening ceremony of the summit, CARICOM chairman Hon. John Briceño pointed out that this year's Summit is the first



Channel 7 claims unfair treatment. MOFA responds.

Public outcry following 7News' Cherisse Halsall's removal from the pool area of Grand Caribe Resort, which included calls for the dismissal of the Director of the Government Press Office, Mike Rudon, by the UDP, prompted a lengthy response from the Ministry of Foreign Affairs.

The Ministry of Foreign Affairs, Foreign Trade, and Immigration has issued a lengthy press release regarding the removal of 7News reporter Cherisse Halsall from a no-access zone during this week's Heads of Government Meeting and subsequent accusations that the Government has shown preferential treatment to one particular media house. The press release, possibly prompted by the public outcry

that followed the circulation of video footage in which Halsall is seen being handled in a rough manner by security personnel, asserts that Channel 7's claims that the Government was attempting to muzzle the media are false. It stated that before the CARICOM Meeting, the Government Press Office briefed the media on rules that would be applied throughout the event and stated that those rules were provided by the CARICOM Secretariat.

"All attending media houses were informed that, because of the nature of the Summit, and the fact that the region's

Herbert Panton passes

The lifelong supporter of the UDP and husband of Albert area rep, Hon. Tracy Panton, who is an aspirant for the post of UDP leader, passed suddenly on Wednesday after being admitted to a private hospital on Tuesday night.

Yesterday, news broke of the sudden death of United Democratic Party stalwart Herbert Panton. Reports are that he died suddenly sometime yesterday after being admitted to a private hospital on the previous night for an unknown ailment that is being classified by some members of the media as a "cardiac condition". Panton, an attorney by trade, served the UDP for most of his adult life and held a number of posts within that party, and the wider society.

In a Facebook post following Panton's death, his wife, Hon. Tracy Panton, who is an aspirant for the post of UDP leader, stated, "I lost my best friend yesterday, March 1st, 2022 on an Ash Wednesday. He was my ride or die. He was my one true love. He and I had BIG dreams together. We would fight for the things we believed in. We would stand up for the principles and values we shared. We would be the voice for the voiceless. He with his law practice, me through my bid for political leadership. '

The sudden loss came as a shock to Panton's political family as well. Michael Peyefitte, the chairman of the UDP, referred to him as a "five-star general" of the party.

"There's no bigger UDP than Herbert Panton, no bigger supporter of the UDP than Herbert Panton. It is a sad, sad day, and his passing is a serious blow to the United Democratic

Party, that's all I can say. I'm still in shock. I still can't believe it. I couldn't believe it when I first heard it, and it's going to be a huge, huge loss for us,' Peyefitte said.

Peyrefitte told local media that Panton always wanted to be a lawyer, and that he "moved mountains" to accomplish his goal, and always made to a point call out any wrong he saw within the party.

"He moved mountains to go to law school; he made all the necessary sacrifices. He was a magistrate even [and a] distinguished attorney, and so we have lost not just a colleague, but a UDP brother and also a friend. He was the editor of the newspaper at one point, assistant secretary-general of the party at one point. He has played so many different roles for the UDP and is always one of those people who would be the first to put us right. One of the first persons to tell us what we were doing well, what we were doing wrong, and he was a person whom you would listen to, a person whose opinion mattered," Peyrefitte remarked.

His wife, Hon. Tracy Panton, in her online reflection on her husband's qualities, said, "Family was everything for Herbert Panton. If you knew him well, you know he had a way with words. He loved the English language, and he had a command of words. He could be sharp with his tongue, but he could not hurt a single fly. It was just not in his DNA. Hands down, he was my biggest fan, my most ardent supporter. He had his flaws, and so did I, but we were perfect for each other. We made a lifelong commitment to walk beside each other and hold each other's hands through the thick and the thin, the highs and the lows, the good and the bad. One thing we knew for sure, we would not give up on each other, not now, not ever. I will always love him with every pore of my being."

We extend our deepest condolences to the family and friends of Herbert Panton. May he rest in peace.

leaders would be present, security would be heightened. ALL media houses were informed of areas at the conference site where they would have access, and areas where they would not be allowed access," read the press release—notwithstanding the fact that there was one local media house to which those rules did not seem to fully

According to the Ministry, Cherisse Halsall disregarded the no-access protocols when, on Tuesday, March 1, she arrived at an area near the Grand Caribe swimming pool where government officials were having bilateral meetings over breakfast. The press release claims that, in response to attempts to remove her, Halsall was "verbally abusive to security personnel," who were acting on the orders of Government Press Office Director, Mike Rudon.

"The video being aired by Channel 7 shows clearly that Ms. Halsall was at the pool area – a no-media area. Despite that incident, Channel 7's cameraman was allowed full access to the opening session of the Summit, as had been promised to all media houses," continued the press release, which also stated that all media houses, local and regional, were allowed the same access privileges.

But when she appeared on Channel 7's morning talk show, SunUp, Cherisse Halsall provided a different side of the story—noting that the animosity displayed towards her and the media house on Tuesday had been building for days prior. While the Foreign Affairs Ministry claims that all media houses were given equal access to the event, Halsall pointed out that Channel 5 had been given the tender to livestream the event, without a proper, publicized selection process through which other media houses could have applied for the privilege, while others were to be relegated to a media room across the street.

Halsall further pointed out that while local media was told that no media house—regional or local would be allowed at the Inter-Sessional Meeting, that is not what ultimately happened, as there was a Caribbean reporter at the event. She explained that that reporter was allowed to do a stand-up, at the very location from which Halsall would be later removed, without any incident, while she was not. In a video shared by Channel 7, Halsall can be seen telling security personnel that she would continue to do her stand-up while they attempted to remove her.

"We were trying to go live ... and two security guards kind of—they accosted me and James and one of them twisted my phone out of my hand. It got so severe that Mrs. Briceño [the wife of the Prime Minister] who was sitting there having breakfast stood up and screamed 'do not touch her'," said Halsall, as she detailed the events that led up to her removal.

"I think that the altercation that resulted came from the fact that when I saw that Caribbean reporter there, I decided that I no longer had to tiptoe around Government Press director Mike Rudon, who had been completely ridiculous this entire time. And the only reason I was removed was that his anger got a little bit too piqued," she added.

In response, the Ministry of Foreign Affairs has accused Channel 7 of playing the victim with "extreme sensationalism" while using freedom of the press as justification. Channel 7 director Jules Vazquez has made the point, however, that the incident was a result of the systematic exclusion of all media houses, apart from Channel 5, from having front-line access to the Heads of Government Meeting. And in its own recent press release, the United Democratic Party shared Vasquez' sentiments. The UDP also called for the dismissal of the Press Office Director.

"This is not the first or second national embarrassment caused by a Mike Rudon-run Government Press Office: the cutting of Commission of Inquiry live feed during the union representative's address; the distasteful Facebook comments to concerned Belizeans during the butchered Independence Day Ceremony broadcast are just two of many other embarrassing incidents. How many strikes will this individual get," stated the UDP's press release. It then went on to call for fair treatment of all media houses.

While the Ministry of Foreign Affairs condemned Channel 7's

Mask mandate partially lifted

The Minister of Health and Wellness, Hon. Kevin Bernard, said that masks must still be worn in public buildings, but are no longer required outdoors.

BELIZE CITY, Tues. Mar. 1, 2022

It was reported at the beginning of this week that the nightly curfew was no longer in place, and also that the mask mandate was being partially lifted. The new Statutory Instrument which outlines the adjustments in Covid-19-related regulations, however, indicates that it is still required that persons wear a face mask inside public buildings and at indoor gatherings, such as church services, weddings, funerals, wakes, and repasts, as well as at social club events, and receptions.

Earlier this week, the Minister of Health and Wellness, Hon. Kevin Bernard, tried to provide clarity to local media about the settings in which mask-wearing is no longer

required, and the settings in which the mask mandate will still be in place.

"Requirement for mask usage is if persons are attending an indoor event such as church service, wedding ceremony or reception, funeral service, a social club event. If Rotary Club is having a meeting or any of these fraternity clubs are having a meeting. If it's an annual general meeting of an association, even if it's under a tent, it's indoors, it's confined, it must be worn at all times," he said.

"If you have to access a government building, supermarket, major retail store, bank or any establishment that is indoors with more than one person gathered, you need to wear that mask. On public transportation, buses, if you're

traveling in a taxi, you have to wear your mask. The wearing of a mask captures all of these areas," Health Minister Bernard went on to explain.

.He then pointed to circumstances under which the wearing of a mask will no longer be required: "If you are simply walking on the street from home to the shop, you don't

necessarily have to wear the mask, if you are walking in an open space. If you are at an open area like a wide, huge park, where it's just you and your children, then [you don't] necessarily have to wear the mask," he outlined.

Minister Bernard told the media that the decision to remove some of the regulations was made after a review was done of the country's daily cases and hospitalization rate.

"Many factors were looked at. We are at the stage where our daily positivity rate, the hospitalization rate, has been very low. We've seen the evidence that Omicron has come, taken its peak, and it's now taking its steep dive all the way down to pre-Omicron levels, and so it's obvious that even around the world, restrictions are being lifted. But we're not doing this because the United States did it, or the Mexican government did, or the Bahamian government did it or anybody. We are doing this because, in Belize, we believe over the two-plus years we have had regulations put in place recommended by our Covid Medical Response Team, and, based on the numbers, we feel like it is time to ease some of the restrictions," the Health Minister said.

The latest SI also states that at churches and other places of worship, as well as other indoor venues where social events are held, only seventyfive percent of the number of persons that can fit in any such space should be present at any given time, and attendees must wear a mask.

Regular fuel prices jump by 56 cents

Again, there was no announcement by GoB prior to the most recent recent fuel price increase.

On Monday night, the price of regular fuel increased by 56 cents, taking the cost per gallon of regular fuel to \$12.84. At this point, the prices of all three major fuel products are above \$12 per gallon—a first in our history, by all indications. At this time, the per-gallon price of diesel stands at 12.06, and the price of premium gas is \$12.90. The Prime Minister, Hon. John Briceño, had indicated, when interviewed by local reporters last week, that the

government had absorbed a portion of the price increase for the most recent shipment of diesel, but the government shouldered only 50% of the cost—with the other half of that cost being added to the price paid by consumers at the pumps.

Gas prices have been constantly rising since late last year, and, following a historic hike in the price of kerosene in February—the Government Press Office apparently opted to discontinue its practice of issuing a press release announcing changes to pump prices. Again, this most recent price increase caught consumers by surprise. Unconfirmed reports are that the price increase is slightly higher in the districts.

actions at length in its release, it did not address the alleged disparity in the amount of access given to media houses. When speaking with local media, Channel 7 director Jules Vasquez called the Ministry's press release an ugly and pointless piece of communication, noting that Halsall was just trying to do her job. He also condemned what he referred to as an incestuous relationship between the Ministry of Foreign Affairs and Channel 5 due to the fact that the Ministry's CEO, Amalia Mai, is the former CEO of the media house.

"The fact that Channel 5 has preeminence—total preeminence, to the exclusion of all other media houses—at this event is worth noting." expressed Vasquez. It must be noted that Vasquez and a camera operator from 7News were seen with other local media personnel around the table at the closing press conference at the Inter-sessional meeting held yesterday evening.

CARICOM Heads of Government meet in San Pedro

SAN PEDRO, Ambergris Caye, Tues. Mar. 1, 2022

The 33rd Inter-Sessional Meeting of the CARICOM Heads of Government took place this week on March 1 and 2. On Tuesday, an opening ceremony was held, at which the leaders and other representatives of Member States of CARICOM were welcomed to the country, and to the island of Ambergris Caye. Those leaders included the prime minister of the Bahamas, Hon. Philip Davis; the prime minister of Barbados, Hon. Mia Amor Mottley; the deputy prime minister of Saint Vincent and the Grenadines, Hon. Montgomery Daniel; the prime minister of Dominica, Hon. Roosevelt Skerrit, as well as leaders and delegations from the British Virgin Islands, Grenada, Guyana, Haiti, Montserrat, Turks and Caicos, and Suriname.

The meeting, held under the chairmanship of Prime Minister Hon. John Briceño, featured many firsts. Dr. Carla Barnett, CARICOM Secretary-General, expressed gratitude that her first Heads of Government Meeting as the Secretary-General was taking place in her home country. She also extended a warm welcome to the newly elected prime minister of The Bahamas, Hon. Philip Davis, who was attending his first meeting as a member of the conference along with Prime Minister Philip J. Pierre of Saint Lucia.

The Secretary-General also thanked the outgoing CARICOM chairman, Prime Minister of



Antigua and Barbuda, Hon. Gaston Browne, for his stewardship during the last six months of 2021, during which the region faced many tests. Hon. Browne, who attended the meeting virtually, gave an outgoing speech, expressing his full support for the incoming chairman and noting the importance of unity and solidarity to CARICOM's strength and stability.

"All around us, very dangerous and volatile changes threaten to overwhelm the international order, as we have come to know it. As I speak, the guns of war are once again roaring in Europe in a military confrontation that could bring two nuclear-armed world powers into open conflict. Implications of this development for world peace and security are almost too frightening to contemplate," said Hon. Gaston Browne, who made note of the 2021 assassination of the president

of Haiti, Jovenel Moise—an event almost unheard of in the Caribbean but one that revealed that the region is not invulnerable to the forces of instability and criminality rising in the world.

The 33rd Inter-Sessional Meeting is also the first face-to-face meeting for the Heads of Government in almost two years due to the COVID-19 pandemic. Secretary-General Dr. Barnett noted that, while the pandemic is still with us, CARICOM continues to adapt to what can only be called the "new normal".

"Significant obstacles still lay in our path. Much too many of our citizens remain unvaccinated, too many of our children are still out of school, too many of our businesses are still floundering, with the resultant effect of unemployment. However, one thing we have learned over the 49 years of our existence is that we are a resilient community, bound together, particularly in times of adversity," she said.

The Secretary-General then went on to express her hopes for the Community in the coming years, mentioning CARICOM's goal of increasing intra-regional trade from 16-18% of its total trade to 25% by the year 2025. She highlighted the importance of the agricultural sector in achieving this goal, and then went on to call for a greater application of technology across the Caribbean as well as for greater advocacy for easier access to funds meant to assist developing nations.

Meanwhile, during his speech as Chairman, Prime Minister Hon. John Briceño spoke of the importance of demanding immediate reform of the international financial system, urgent climate action, and immediate access to vaccines.

"While it is imperative that we continue to press our case, which is fair and just, we know from experience that the wheels of international cooperation grind slowly. We cannot afford to lose further ground. We cannot afford to lose our future. Therefore we must be more strategic and coordinated in our advocacy," he said, noting just how imperative integration is in the recovery of the Caribbean region.

The year 2023, as the Prime

Minister pointed out during his speech, will mark the 50th anniversary of the founding of CARICOM and the conclusion of the Georgetown accords of 1973. Hon. Briceño proposed to his fellow Heads of Government that during 2022 they embark on a journey of regional consultation, "so that we can mark the anniversary of the accord with the adaptation of a repurposed, reimagined revitalized accord that irreversible presents prescription designed to achieve our region's just objectives." He that already Commonwealth Heads Government Meeting and the Summit of the Americas are set for June of this year in Rwanda and Los Angeles, respectively. COP27 is also scheduled for November of this year and will take place in Egypt.

As the Secretary-General Dr. Barnett had mentioned to local media during a press conference prior to the Meeting, the issue of integration and the implementation of the CARICOM Single Market and Economy (CSME) was a focal point of discussion during the conference. Prime Minister Briceño reiterated this, stating that integration of our small Caribbean states is, at this point, almost inevitable.

Along with economic integration, food security was an important discussion point during the 33rd Inter-Sessional Meeting. During the press conference held at the conclusion of the two-day conference, Prime Minister Hon. John Briceño highlighted Guyana's president Irfaan Ali's plan for the development of the agri-food sector—a plan which the Chairman says was embraced by all. The Guyanese president, in his venture to further develop the region's agriculture, did a comprehensive study of the region to see what agricultural products can be grown in what locations. This was done so that the Community can eventually grow more of what it eats rather than having to rely on imports, which are subject to various types of disruption.

The Heads of Government also came to an agreement that they would mount a regional campaign combatting disinformation regarding vaccines in an effort to increase vaccination rates. Additionally, they spoke at length with the Prime Minister of Haiti to decide how the Community could assist the country as it tries to deal with a number of difficulties.

The Chairman further went on to state that the Heads of Government have issued the Ambergris Caye Declaration in response to the ongoing climate crisis and plan to meet to consider the matter in depth.

Prime Minister Hon. John Briceño also revealed that the next Inter-Sessional Meeting will be hosted by the country of Suriname at the offer of its president, Chan Santokhi.

Man, 51, dies in RTA in Toledo

PG resident dies after his motorbike collided with a bicycle on the San Antonio Road in southern Belize.

A resident of Punta Gorda lost his life as a result of a road traffic accident that took place on Sunday, February 27. Enero Bol, 51, passed away while receiving treatment at the hospital after his motorbike collided with a bicycle being ridden by Antonio Cal, 23, on the San Antonio Road in the Toledo District.

On Sunday, at around 4:09 p.m., police arrived at a location near Caliz Farm, where the incident had reportedly occurred, and saw Bol lying on the side of the road, with severe head and body injuries. Nearby was a motorcycle, which is believed to have belonged to Bol, and which he was driving before the accident.

A second male person, identified as 23-year-old Antonio Cal, was also seen sitting on the other side of the road with injuries to his face.

According to the police's initial report, Antonio Cal was riding his bicycle a short distance ahead of Bol on the highway and made a sudden Uturn, and as a result the motorbike and the bicycle collided—causing both men to be thrown onto the road.

Both Bol and Cal were transported to the Punta Gorda Hospital, where Bol succumbed to his injuries while receiving treatment. His body remains at the PG morgue, where a postmortem exam will be conducted.



Minister Kareem, wheel and come again with that weed

Hon. Kareem Musa, the Minister of Home Affairs and New Growth Industries, has been working on legislation to make marijuana products an export earner, but thus far it has been smoke only. The House of Representatives gave the go-ahead to a marijuana bill, which was withdrawn after the social partner senators expressed strong reservations about it.

Lead Opposition Senator, Hon. Michael Peyrefitte, whose party decriminalized the possession of 10 grams of marijuana in 2017, has said that the new government's efforts to make an industry out of weed are futile at this time, because, it being illegal still in the US on the federal level, the banks won't touch it.

Hon. Kareem has reportedly tweaked his marijuana bill and will be taking it back to the House of Representatives at its next sitting. Maybe he is about getting laws in place for the time when the US acts soberly with marijuana, but right now almost everyone agrees with the UDP Senator, that as an export earner it's a no-go, because the banks won't go for it. For the second or third time, we will suggest to the minister that we make the best out of this bad situation, for the purpose of addressing what many consider the worst problem in our country, this horrible violence.

Forget foreign exchange at this time. Let the government grow the marijuana under strict controls. Under the strictest controls provide clean, unadulterated marijuana to the known small peddlers in the country. At the least that will serve to take the violence out of the marijuana part of the drug trade.

At its most productive, it will work out like a New Growth Industry. Violence is the worst enemy of the economy. Take out the violence, and our brothers and sisters in tough urban areas will have an environment where they can thrive.

No cruise, no cargo

When Lord Michael Ashcroft spoke about his vision for the Port of Belize Ltd. (PBL) on his television station. Channel Five, after the PUP came into office in November 2020, he spoke as if he was the owner of the company. Under a previous PUP government, PBL was sold to Belizean businessman Mr. Luke Espat, and it ended up in the hands of a "receiver" after Mr. Espat reportedly was unable to service debts he had with an entity connected to the Lord Ashcroft-controlled Belize Bank.

In the business world, for different purposes, some above board, and some below, the ownership of many companies cannot be pinned down. The investigative journalist can dig, at great expense, but how do they get around the "front", one of the most common tools of the rich and famous who are

intent on concealing what they own? When the journalist reaches the "front," they're still at the back door, because they then encounter the libel laws, which help to foil further sleuthing.

For all intents and purposes, we could say that Ashcroft is the owner of PBL, despite him saying in April 2020, on Channel Five that PBL was in receivership. On that same show, Mr. Ashcroft said, re: proposed port developments by Waterloo, that Belize, under UDP leadership at the time, was "messing around"; and in April 2021 he told his television station that Waterloo's investment in the port would amount to about US\$200 million, that if it got the go-ahead he believed it would be the biggest infrastructure project in Belize, and for those who mightn't like him, he said his ownership would not amount to more than "20 or 25 percent."

To date, Waterloo has not been able to get the green light for its proposed investment in PBL. Meanwhile, the "receiver" "owner" is in a hostile relationship with stevedores at PBL. In the face of the recent extraordinary, vicious move by the receiver/owner to block a payment of \$1.5 million the stevedores received from GOB, even Belizeans who are uncommitted to labor are staggered by the extent of the venom.

The receiver/owner of PBL has done little to improve the bulk cargo capacity of the company since taking it over in 2012. In 2021 the receiver/owner said on Channel Five: "Waterloo has made it clear, there isn't one (increased bulk cargo capacity) without the other (cruise port)." The mega project calls for massive dredging of the sea in front of the port so that giant ships can be accommodated, and indeed the potential of such a venture would be greatly enhanced if a cruise port is included.

There is no discussion of a scaled down project. It's all or nothing, mega-ships or none for the receiver/owner of PBL. Lord Ashcroft said on his television station that he's in it for "the challenge of doing something that I believe is right for the country." The decision to let the port's facilities rot to hell partly led to PBL losing the bulk of the contract to handle sugar exports from ASR/BSI at Tower Hill, a crushing blow to the workers at the company. But, who cares about workers, there's an aging man and his dream to do what he thinks is right for Belize, with an asset many believe he should never have gotten his hands on in the first place.

The receiver/owner of PBL says there isn't space for three cruise ports in Belize City. Presently, a cruise port is being built at Stake Bank, while the Waterloo proposal and one south of the Sibun, Port of Magical Belize, are on the table. All three present serious environmental concerns, but apparently Waterloo, with its intention to dredge 7.5 million cubic meters of material from the sea in front of PBL, is facing the stiffest winds.

In respect to the concern about the number of cruise ports Belize City can serve, the experts have a lot to consider. Two Oasis-type vessels (mega-ships) visiting the same day would bring over 10,000 more tourists. It's a short stay, not more than 8 hours for a cruise visitor, so they wouldn't be able to range much farther than the limits of the Belize District. If Waterloo got the green light for its project, Altun Ha, Jaguar Paw, and Goff's Cay quite likely would collapse under the pressure.

In the movie, *Mamma Mia!*, Abba sang "it's a rich man's world", and there's no refuting that; the evidence is all around us, from their yachts and mansions and boardroom deals, to their pulling the rug from under workers. In the latter category, the receiver/owner of PBL filed an injunction to stop stevedores from accessing funds from the GoB.

The "rich man" spoke as if PBL was his property. Speaking as if PBL was his property, he effectively said: no cruise, no cargo.





The climate crisis demands immediate action – IPCC report

Nations that have contributed the least to climate change are the most vulnerable to its effects. As the recent IPCC report has shown, failure to take action in addressing the growing climate crisis will prove detrimental—deadly, even—to the Global South.


BELIZE CITY, Wed. Mar. 2, 2022

The assessment issued by the Intragovernmental Panel on Climate Change (IPCC) on Sunday, titled "Climate Change 2022: Impacts, Adaptation, and Vulnerability," gives a dire warning of the havoc that climate change will wreak on the world in the coming two decades, particularly on nations of the Global South who have contributed the least to global warming, if immediate action is not taken. The 2022 report, which is the sixth assessment of its kind, contains over seven years' worth of peer-reviewed climate science and focuses on the damage that climate change has caused and is predicted to cause in the coming

years. It also provides world leaders with potential solutions for addressing the climate crisis.

According to the report, without immediate global action, the temperature of the earth is set to increase by 2-3 °C, which ultimately result in significantly worse effects than we have seen in recent years, such as the bleaching of coral reefs, deadly heatwaves, catastrophic storms, and raging

wildfires. The effects of climate change, particularly the extreme events caused by it, also have a



significant effect on physical and mental wellbeing. And small developing nations of the Global South, who have contributed the least to emissions and warming, remain the most vulnerable to those effects. Those nations—which include the Caribbean Community—have been calling, now more than ever, for increased action and increased support. Developed nations, however, have been slow to answer that call.

Caribbean Climate-Smart Accelerator (CCSA) issued a media release regarding the IPCC report, calling it an "eye-opening reality check for world leaders and every citizen of planet Earth."

"The Caribbean region must continue to come together and fast track partnerships and collaborations to accelerate climate action plans. Areas within the blue economy, climate-smart agriculture, and renewable energy, for example, all offer opportunities which the region can take right now to start moving towards economic prosperity, future resilience, and sustainability," said CCSA CEO Raquel Moses.

Kiesha Farnum, Director of Public Sector Projects at CCSA, issued a call for owners of climate-smart projects in the Caribbean to come forward and work with organizations like CCSA. "We have seen what recent hurricanes have done to our Caribbean neighbours in Antigua and Barbuda, Dominica, and Puerto Rico. The choice is simple; we must adapt now so that we do not pay the price with life and livelihoods later," she stated.

Addressing the climate crisis and preventing the heating of the world by 2-3 more degrees requires immediate action along with a complete departure from the status quo. Failure to achieve that, as pointed out by a *Nature* study titled "Global risk of deadly heat" will prove lethal for our most vulnerable

The IPCC report also outlines actions that world leaders and policymakers can take to slow the effects of climate change, including rapidly lowering greenhouse gas emissions before 2030 and pursuing the UN's Sustainable Development Goals. As Prime Minister Hon. John Briceño shared at the opening of this week's Heads of Government Meeting, COP26 is set to be held in Egypt this November. There, world leaders will continue to discuss the climate crisis and, hopefully, the IPCC Sixth Assessment will play a pivotal role in steering those discussions and resulting action.

Ministro Kareem, intente de nuevo con eso de la mota

El Honorable Kareem Musa, el Ministro del Interior y Nuevas Industrias de Crecimiento, ha estado trabajando en una legislación para hacer que los productos de marihuana sean una fuente de ingresos derivada de su exportación, pero hasta ahora solo ha sido humo. La Cámara de Representantes dio luz verde a un proyecto de ley sobre la marihuana, que fue retirado después de que los senadores de los interlocutores sociales expresaran fuertes reservas al respecto.

El senador líder de la oposición, el Honorable Michael Peyrefitte, cuyo partido despenalizó la posesión de 10 gramos de marihuana en 2017, ha dicho que los esfuerzos del nuevo gobierno para convertir la mota en una industria son inútiles en este momento porque, siendo ilegal en los EE. UU. a nivel federal, los bancos no lo tocarán.

El Honorable Kareem, según los informes, modificó su proyecto de ley sobre la marihuana y lo llevará de regreso a la Cámara de Representantes en su próxima sesión. Tal vez él se trata de promulgar leyes para el momento en que EE. UU. actúe sobriamente con la marihuana, pero en este momento casi todos están de acuerdo con el senador UDP en que, como fuente de ingresos por exportaciones, no se puede hacer, porque los bancos no aceptarán eso. Por segunda o tercera vez, le sugeriremos al ministro que saquemos lo mejor de esta mala situación, con el fin de atender lo que muchos consideran el peor problema de nuestro país, esta horrible violencia.

Olvídense de divisas en este momento. Que el gobierno cultive la marihuana bajo estrictos controles. Que bajo los más estrictos controles se proporcione marihuana limpia y sin adulterar a los pequeños vendedores ambulantes conocidos en el país. Al menos eso servirá para quitarle la violencia a la parte de la marihuana del tráfico de drogas. En su forma más productiva, funcionará como una nueva industria de crecimiento. La violencia es el peor enemigo de la economía. Si se elimina la violencia, nuestros hermanos y hermanas en áreas urbanas difíciles tendrán un entorno en el que puedan prosperar.

Sin puerto de cruceros, no hay carga

Cuando Lord Michael Ashcroft habló sobre su visión para Port of Belize Ltd. (PBL) en su estación de televisión, Channel Five, después de que el PUP asumiera el poder en noviembre de 2020, habló como si fuera el dueño de la empresa. Bajo un anterior gobierno PUP, se vendió PBL al empresario beliceño, el Sr. Luke Espat, y terminó en manos de una "receptoría" después de que el Sr. Espat supuestamente no pudo pagar las deudas que tenía con una entidad conectada con Lord Ashcroft - controlado por el Banco Belize.

En el mundo de los negocios, para diferentes propósitos, algunos sobre la mesa y otros por debajo, la propiedad de muchas empresas no se puede precisar. El periodista de investigación puede cavar, a un gran costo, pero ¿cómo sortear el "frente", una de las herramientas más comunes de los ricos y famosos que intentan ocultar lo que poseen? Cuando el periodista llega al "frente", todavía está en la puerta de atrás, porque luego se encuentra con las leyes contra la difamación, que ayudan a frustrar investigación adicional.

A todos los efectos, podríamos decir que Ashcroft es el propietario de PBL, a pesar de que dijo en abril de 2020, en Channel Five, que PBL estaba bajo administración judicial. En ese mismo programa, el Sr. Ashcroft dijo, en relación con los desarrollos portuarios propuestos por Waterloo, que Belize, bajo el liderazgo del UDP en ese momento, estaba "perdiendo el tiempo"; y en abril de 2021 le dijo a su canal de televisión que la inversión de Waterloo en el puerto

ascendería a unos US\$200 millones, que si obtenía el visto bueno creía que sería el proyecto de infraestructura más grande de Belize, y para aquellos a quien él no les caía bien, dijo que su propiedad no ascendería a más del "20 o 25 por ciento".

Hasta la fecha, Waterloo no ha podido obtener luz verde para su inversión propuesta en PBL. Mientras tanto, el "administrador judicial" "propietario" tiene una relación hostil con los estibadores de PBL. En vista de la reciente maniobra extraordinaria y viciosa de la receptoría/el propietario para bloquear un pago de \$1.5 millones que los estibadores recibieron del Gobierno de Belize, incluso los beliceños que no están comprometidos con la fuerza laboral están asombrados por la magnitud del veneno.

La sindicatura/el propietario de PBL ha hecho poco para mejorar la capacidad de carga a granel de la empresa desde que se hizo cargo de ella en 2012. En 2021, la sindicatura/el propietario dijo en Channel Five: "Waterloo lo ha dejado claro, no hay uno (mayor capacidad de carga a granel) sin el otro (puerto de cruceros)". El megaproyecto exige un dragado masivo del mar frente al puerto para que puedan acomodarse barcos gigantes y, de hecho, el potencial de tal emprendimiento aumentaría enormemente si se incluyera un puerto de cruceros.

No se habla de un proyecto reducido. Es todo o nada, mega-barcos o nada para la receptoría/el propietario de PBL. Lord Ashcroft dijo en su canal de televisión que está en esto por "el desafío de hacer algo que creo que es correcto para el país". La decisión de dejar que las instalaciones del puerto se pudriesen en parte llevó a que PBL perdiera la mayor parte del contrato para manejar las exportaciones de azúcar de ASR/BSI en Tower Hill, un duro golpe para los trabajadores de la empresa. Pero, a quién le importan los trabajadores, está un hombre envejecido y su sueño de hacer lo que cree que es correcto para Belize, con un activo que muchos creen que nunca debería haber accedido en primer lugar.

La receptoría/el propietario de PBL dice que no hay espacio para tres puertos de cruceros en la Ciudad de Belize. Actualmente, se está construyendo un puerto de cruceros en Stake Bank, mientras que la propuesta de Waterloo y un puerto al sur de Sibun, Port of Magical Belize, están sobre la mesa. Los tres presentan serias preocupaciones ambientales, pero aparentemente Waterloo, con su intención de dragar 7,5 millones de metros cúbicos de material del mar frente a PBL, se enfrenta a los vientos más fuertes.

Con respecto a la preocupación sobre la cantidad de puertos de cruceros que la Ciudad de Belize puede atender, los expertos tienen mucho que considerar. Dos embarcaciones tipo Oasis (mega-barcos) visitando el mismo día traerían más de 10,000 turistas más. Es una estadía corta, no más de 8 horas para un visitante de un crucero, por lo que no podrían ir mucho más allá de los límites del Distrito de Belize. Si Waterloo obtuviera luz verde para su proyecto, es muy probable que Altun Ha, Jaguar Paw y Goff's Cay colapsaran bajo la presión.

En la película ¡Mamma Mia!, Abba cantó "es un mundo de hombres ricos", y eso no se puede refutar; la evidencia está a nuestro alrededor, desde sus yates y mansiones y tratos en la sala de juntas, hasta cómo les jalan la alfombra debajo de los trabajadores. En la última categoría, la sindicatura/el propietario de PBL presentó una orden judicial para impedir que los estibadores accedan a los fondos del Gobierno.

El "hombre rico" habló como si PBL fuera de su propiedad. Hablando como si PBL fuera de su propiedad, efectivamente dijo: sin puerto de cruceros, no hay carga.

May 29 of this year will mark the fiftieth anniversary of a major incident (or series of incidents) in Belize City which has been ignored by the media and academics of Belize.

In fairness, one needs to point out that in 1972 there was only one radio station in Belize. (Today, there are maybe fifty or sixty radio stations in The Jewel.) The one 1972 radio station was a government monopoly called Radio Belize, and the ruling People's United Party (PUP), which had never lost a national election in

its 22-year history, used the station for political propaganda.

There was no television here in 1972, except in the northern part of Corozal, where Belizeans saw Mexican television stations. At least, that is my understanding. (I know that around November of 1970 the late Galento X Neal and I saw the Muhammad Ali vs Oscar Bonavena fight on television at a sidewalk cafe in Chetumal.)

There was no internet or social media in Belize in 1972. These things were not invented until the 1990s, to

the best of my knowledge.

In May of 1972, the only real newspaper in Belize was THE REPORTER. The late Hon. Philip Goldson had closed down his BELIZE BILLBOARD in early 1972 and gone to study law in London. AMANDALA was a tiny entity printed on a letter press. The editor in May 1972 was the UBAD Secretary-General, Norman Fairweather. When he was remanded to Her Majesty's Prison (along with 10 or 11 UBADers) for a week because of the May 1972 incidents, I

believe a UBAD officer who was a Spanish teacher at St. Michael's College, Elbert "Shaft" Franklin, edited an issue of the newspaper.

I imagine I will discuss the May 1972 uproar some more in the next couple months, but I opened with the May 1972 subject to give you a sense of how few sources a researcher who wanted to look at May 1972, would have available.

The topic I want to look at today is the Belize Black Summit of September 2003, a subject a researcher would have a lot more sources to explore than one would if one wanted to study the May 1972 uprising.

If one really wants to try to figure out what happened to Belize's black community between 1972 and 2022, if one really wants to identify the phenomena which have led to the civil war among black youth here, a shooting war which has been going on for more than three decades, then one needs to go over what happened during the three days of the Belize Black Summit, held at the Biltmore Hotel.

The media and academics in Belize have totally ignored the Belize Black Summit, and they have much less of an excuse to do so than they do when they ignore May 1972.

When I look at two major areas where I held strong opinions which have been proven wrong in a devastating way, these two areas being semi-pro basketball (1992-1996) and the Belize Black Summit (2003), I am tempted to think that there were operatives in the employ of the power structure of Belize who sought to undermine both processes. (So, who is or are the power structure here?)

In the case of the black summit idea, in late 1993 I had become so obsessed with it that I lashed out at two black community icons of my generation, the late Bert Tucker and Nuri Muhammad. Why did I lash out at them? I did so because I believed that the United Democratic Party (UDP), which had returned to power in June of 1993, would not allow me to organize a black summit, because it had always been a suggestion of the UDP that the party stood for black Belizeans. I speculated that if I began work on a 1994 black summit for the silver anniversary of UBAD (February 9, 1969), the UDP would use Tucker or Muhammad against me.

This was very unfair to these two gentlemen, a terrible mistake on my part, but it is evidence of how desperate I was. (These were the early years of the gang wars, which had begun here in the late 1980s.)

In Kriol we say *saafli saafli taiga kech monki*.

I hate having to write this. Jim Reeves sang, "are my fears coming true", and that's how it has been with me about customary land rights, that a party might want too much. There is always a "what next", and in this case I prayed it would be with the good of Belize always at the fore, so there wouldn't be much contention. I worry that we will lose the love. I understand in negotiation some will push, but braa, you have to tread lightly, for the love of nation.

We all understand the process of negotiation. The worst is when the

parties start far apart. My, we know where our Mayan brothers and sisters in that part of the country started from. They had no rights ataal. And now some leaders luk like dehn waahn tek dehn head.

Give some people an inch, they take a yard. Our leaders understand how the world works. Said Musa said, no Balkanization. Dean Barrow tried to overturn the ruling. That's my interpretation of what happened between 2008 and 2020. John Briceño says he is not giving away Toledo.

The ruling, ten to one Justice Sosa would have said no. I believe that. Justice Conteh said yes. This corner cheered his verdict. Justice Conteh never said a solid block. He said we'll have to work it out.

Someone mentioned the Mennonites. I understand they have three villages that have what we could call communal land. According to my source, the one at Spanish Lookout came about after the Mennonite group bought 18,500 acres from a lady named Ms. Olga Burns in the 1950s. There was a governor in Belize named Burns. Belize was a colony up to 1964. The Mennonites control many thousands of acres. But only those acres in the three communities have communal-type land status.

We understand the 41 Mayan villages are scattered over a million acres, 17% of Belize. These million acres are not like the Indian reservations in the US, which are mostly desert land. There are things we have to understand about development. Dr. Leroy Taegar liked saying that the land is the bank. All progressive governments steer the land into the hands of individuals who they believe will develop it. That's how wealth is created.

The US holds 2.3% of their land

in reserve for the Native Americans. I said these are not the kinds of land we find in Toledo. The reservations in the US are mostly arid places, the equivalent of the salt marshes/broken ridge you see between Mile 25 and Hattieville on the George Price Highway. Many Native Americans are poor. They can't produce much on those lands. Much of the lands in Toledo are what the Americans call bottom land. You can grow anything there.

2.3%. I thought that would be more or less the area that would have been labeled as falling under customary land rights. I think that was what Justice Conteh was thinking too. 2.3%. That doesn't mean that our Mayan brothers and sisters wouldn't get land outside of the rez. It means that all the land wouldn't be under communal ownership. Quite likely, most of the lands around the communal villages would be owned by Mayans. But they would be subject to the direction of national leadership.

I'll complain with Jules Vasquez for bringing up the "fact" that there are some little racial things in Belize and some might be looking at the Maya of Toledo winning customary land rights and objecting because of their bias. I expect those disappointing types exist, but on his show with a couple Mayan leaders, that shouldn't have been part of the discussion. That lapse opened the door for a story about leaders who are about the notorious divide and conquer. Braa, the only thing being divided here is Belize; an aggressive element in a group has expressed ambitions to divvy away 17% of her, and conquer.

If this claim should go through, as it APPEARS that it is being pushed by the JCS, MLA, and TAA, then the question arises, if they, like the Mennonites of Spanish Lookout, should stay away from voting in Belize's general elections. FPIC, with the FULL CONSENT, is a go on communal lands. But all of Belize isn't communal lands. And 17% of Belize can't be communal lands.

Bah, I really don't know what Godfrey Smith was doing at a blackboard. Was he the one who said the ship has sailed? I don't know what he was talking about. Does he understand that the real story here is the definition of communal land? If a man shoots a deer five miles from home, is that communal land? It could be, IF that's how we choose to define it. Is every piece of forest that has fallen to the axe and machete and chainsaw in the last 100 years communal land? It could be, IF that's how we choose to define it.

Customary land is land that you use ALL the time. The village proper and immediate surrounds are communal land. From there we start to reason. I still look forward to something absolutely beautiful coming out of the process. Let us treasure our love.



The clash of races

The following, our dear readers of this column, is a sensitive issue which to me is educational. The term "Creole" was introduced by the invaders and conquerors of this continent we call America, who were the masters of an enslaved people brought from Africa and also of the indigenous people of this land, which caused a "boil up", and out of that a new race was born. here in America, which means a mixture between Europeans and Indigenous people. In the case of Belize, it would be the Maya, since Belize is part of the Maya world. So, it would be the Maya mixed with Spanish or Spaniard; that's where the Mestizo came from; it's not a race, it's a mixture, it's two races. So, I do not know how it is that Belizean intellectuals, those who form the think tanks and make laws and constitutions and all those things, have not realized that there is a big mistake; it is a myth and it seems that this country, they love to live under myths, under lies, under made-up things. There's no such thing as a Creole race or a Mestizo race. These are mixtures of races on both sides.

When I look at myself, I had to start thinking, now which race am I, since I've been asked that question. I'm a mixture of African, Maya and European. Those genes flow through my veins. I'm a mixture of races, I am a product of the clash of races, and I was born here in America, here in Central America. I was not born in the Caribbean, no, in Central America. Of course, here the shore is part of the Caribbean Sea, but that does not make me a Caribbean, I'm

not part of the Caribbean. One thing

is the agreement and the formation of CARICOM countries that came together and formed themselves, but to say that I have a tie, or a family tie in any of those islands, no, and I think the majority of us don't have. Now, we are also part of the Central American Integration System (SICA), and it so happens that, taking that in mind, it reminds me of the first time I took out my passport. It was in English and French, and I wondered also, why French? There is no French country close by. We are surrounded by countries of Spanish- speaking people, and Spanish is also widely spoken in Belize, and many of us speak spanglish, which is a mixture of the English and Spanish languages. Going back to the topic of the passport, I remember writing an article about why such a document in Belize is written in French and English, since we are surrounded by Spanish-speaking countries.

Fortunately, afterwards, it was changed, and now it comes out in English and Spanish. The other thing that I observed arriving here, back in '93, '94 was that the justice system would always mention the term "Spanish"—that the Spanish had committed such crime, the Spanish did this or the other, and I also wrote another article, which was published in this same newspaper, in which I stated that were no Spaniards here in Belize. There were Maya and there were Mestizos. Lately, I have been trying to do a little research on the words Ladino, Latino, Hispanic, etc. They are all the same. It's a mixture of races, it is not a race. Now, ethnicity, we have to go on the word ethnic and its definition is as follows:

"A group of people who share a similar culture (beliefs, values, and behaviors), language, religion, ancestry, or other characteristic that is often handed down from one generation to the next. They may come from the same country or live together in the same area. Examples of ethnic groups include Hispanics and Han Chinese. Some diseases or genetic conditions may be more common in certain ethnic groups than in others." - (https:// www.cancer.gov/publications/ <u>dictionaries/cancer-terms/def/</u> ethnic-group).

Perhaps even more important was the fact that the summit concluded with an open mike session where, if I remember correctly, upwards of seventy Belizeans stepped forward to express their ideas or put forward their suggestions for positive change in the black community.

I think it would be good for us to listen today to what our people were saying almost two decades ago. I am, needless to say, biased, because Dr. Ted Aranda, Virginia Echols, and myself were the main organizers of the summit. But surely an airing of the black summit recordings would be more valuable than that constant refrain, with reference to the unending bloodshed, "This has to stop." It ain't stopping, Jack: it just keeps getting worse.

This Monday morning I decided to visit the KREM Television studio in order to give a little moral support to Ya Ya Marin Coleman, who had been forced to substitute for host Mose Hyde on KREM's WUB morning show. As president of the Christian Workers Union (CWU), Mose had major responsibilities this morning in the Supreme Court because of a dastardly challenge to the union by the Port of Belize, which is to say, by Vladimir Ashcroft. But yesterday morning, the practically indefatigable Ya Ya had missed her KREM Sunday Review show because of exhaustion. Hence, my "morale" visit.

I was stunned when I pushed the KREM TV door to see my contemporary Cliff Lewis, the television station's technical guru, cleaning up in the bathroom, a classic case of beyond the call of duty. Like myself, Cliff is in his mid-seventies, and past what we normally consider retirement age. A lot of things went through my head.

The centerpiece of my thoughts was an organization of young people that emerged in Belize City in the early 1960s after the devastating Hurricane Hattie of late October 1961. The organization was called "The Righteous Crowd," and gathered on weekends mostly at the North Front Street home of Kevurtis Andersen.

Some years ago, my son Mose and Norman Fairweather's daughter, Imani, who are friends, got Norman and me together to discuss various things, principally for our children's understanding and benefit.

A prominent and assertive leader of "The Righteous" was the late Cecil "Chubby" Reneau, but to me, as a sideline associate of The Righteous, the undoubted superstar was Norman Fairweather, who had been sent to school in Jamaica after Hattie and had become exposed to a more sophisticated level of socializing.

Let me bring in Cliff, whom I knew only by face back then in the early

1960s. Cliff was a modest and quiet guy. He and the late Ed "Junior" Yorke were dating two sisters, tall young ladies from the Myvett family, and both of these relationships were very stable.

Perhaps the only area where Tony Wright and I have a slight disagreement is this: Tony feels that we have lost things that we will never regain in the black community here. I agree, but I do not encourage myself in nostalgia, because I feel that all young generations will experience relationships and happenings that they will look back on with wonder when they age. This is because teenage hormones are so powerful, Jack, so powerful.

During my session with Norman as long as a decade ago, he said his children suggested he write a book. The Righteous was an unbelievable organization because it included Belizean teenagers across school, religion, and class barriers.

One of the reasons I was not a Righteous regular was because, as an SJC Sixth Form student, I rolled sometimes with parties that included young people like Sonny Meighan, Peter Young, Carlson Gough, Carlos Perdomo, Vance and Lennox Vernon, and so on. I think the hostesses of these parties were the Martinez sisters of Daly Street, and for sure Anne Longsworth from St. Hilda's College was one of the female stars.

A few weeks ago, Norman and I were corresponding by e-mail, and he told me that Percy Mutrie, Steve Tillett, and Dick Lewis had all moved to Florida. I missed Dennis "Jazz" Henry, my basketball teammate from SJC.

Kent Bladon and Evan Evans have passed.

Everybody moved to America except Junior Yorke (deceased), Cliff, and me. That's how it looks to

The Righteous Crowd — what an incredible sociological phenomenon. Nzinga Barkley-Waite was a part of that story. Cliff Lewis knows a lot of things. Talk to him sometime.

Bullet Tree men charged for

Hattieville home invasion

Two residents of Bullet Tree Falls village were arrested and charged in connection with a home invasion in Hattieville, during

which the family's Toyota Hilux was stolen.

detained by police for driving a vehicle that was reportedly stolen during a home invasion that occurred in Hattieville on Sunday morning, February 27. Those men were later charged in connection with the burglary of the home.

At around 12:30 a.m. on that day, Theodore Gabourel, a security guard, was at home with his common-law wife, Laura-Mae Mortis, and a child who is Mortis' granddaughter, when he was awakened by someone shouting "police" outside of his home. When he ventured outside to find out what was happening, he was held up at gunpoint by two men.

The robbers then proceeded to tie up the family and ransack their home. At some point, they also allegedly hit Gabourel in the back with a gun. They then stole approximately \$2,000 in different denominations, as well as jewelry worth several thousand dollars and Mortis' grey 2014 Toyota Hilux pickup truck, in which they escaped.

The accused men, since identified as Charlie Martinez, 34, and Angel Mayen, 23, residents of Bullet Tree Falls, in the Cayo District, were later detained by police at the Bullet Tree Falls checkpoint, near the country's western border, sometime after 4:30 a.m. that morning, after the pickup truck matching the description listed in Gabourel's report to police was spotted by officers. The officers later confirmed, by checking the VIN number of the vehicle, that it was indeed the stolen Hilux.

Communications Director of the Police Department, ASP Fitzroy Yearwood, had initially told local reporters that both men would be charged with "handling stolen goods" and possibly theft. He indicated, however, that police were engaged in efforts to gather evidence that would establish a connection between the men and the home invasion, after which more serious charges would be brought against Mayen and Martinez.

"I know that investigators are trying their very best to prove their involvement in the original home invasion. But, like I said, the investigation is still pretty young and we are not rushing, we're trying to cover all bases, and we will see whether or not we can prove them to

be perpetrators of that crime," Yearwood had said.

"Now that we know, this crime that took place a few hours later we recovered the vehicle. Our investigators know how to piece that together, and we're hoping that after connecting the dots we can charge all parties involved, hopefully, [depending] on what we gathered in this investigation," he had remarked.

It appears that they were able to establish that connection, because when Mayen and Martinez appeared in the Magistrate's Court on Wednesday, they were charged with wounding (for allegedly hitting Gabourel in the back with a gun) and aggravated burglary and were remanded to the Belize Central Prison. They pleaded not guilty to both charges. Their next court appearance is scheduled to take place on April 28. Although they were not offered bail in the Magistrate's Court, since a gun was used in the commission of the home invasion, they have the option of applying for bail in the Supreme Court.

In recent years, a number of Hilux pickup trucks have been stolen from Belize and taken for sale across the Guatemalan border, where these vehicles appear to be in high demand. ASP Yearwood believes that this was the plan of Mayen and Martinez, based on the location in which they were found.

"We believe so far of the nature and the place that we found the stolen vehicle, we believe that they were definitely targeted for that vehicle, because if you notice that being found in Santa Familia is no distance away from the Guatemalan border and we have seen a trend when these Hilux go missing that they try to get it as quickly as possible towards the border or across the border in some of these cases," Yearwood said.

He added, "We know that there is a high demand for that kind of vehicle in Guatemala, and whether or not he was unfortunate, whether the orchestrators of that crime are from Belize District itself, is what the investigators are trying to put together. We wouldn't want the general public into [a] high state of panic and at the same time, if you're the owner of these vehicles, we want you to be very alert. And the paramount importance is your safety. We're not telling you to go out there and to hurry sell your truck, because people buy things for their own convenience and these are people of humble earnings, and we are very happy that our officers' diligent work and their alertness on duty helped us to recover this pickup before it went into Guatemala, and we would have had a more difficult task to try to recover it," continued ASP Yearwood.

He further commented, "This isn't the first Toyota Hilux that went missing from the Belize District, and we have seen where some have [gone] missing in the Cayo District, indeed. Now, we are putting together the puzzle."

Where we stand

How could the colonizer look after his workers while periodically gunning down a crowd of colonized? How could the colonized deny himself so cruelly yet make such excessive demands? How could he hate the colonizers and yet admire them so passionately? (I too feel this admiration in spite of myself.)

--The Colonizer and the Colonized (Boston, 1967), p. x.

When I contemplate those master seafarers, pirates, and buccaneers of Scottish and English origin— who somehow maneuvered the torrential waters tucked safely behind what we now know as the Belize Barrier Reef – I get a sense of awe. Damn, think about the fight with those waves, and risks of running aground. Imagine

there really was a storm on that night, or day, they first arrived. If you've ever gone deepwater fishing outside the reef, you would be able to relate, but see, these same men, who in their own right, have garnered respect and admiration for their exploits, laid the foundation for the oppressive class that continues to dominate our country today. And so, we have the Baymen, and a band of black slaves who would shank the other at the first bad glance, but take countless cat-o'-nine-tail kisses from an unloving master and bid him the time of the day the next morning.

Where we stand here and now is not by a mistake, but is the result of an intricate design created to maintain the power and dominance of the oppressive class. This is why we see countless reports of Belize City youths killing each other time after time and none covering a

protest of the murderous fuel prices and cost of living. The enemy of my enemy is my friend? No, not in Belize. Because by design, by way of our failed educational system, we are taught to ingratiate ourselves to those in power, the natural enemy of the oppressed, and scorn those on the fringes of so-called societal rank, our natural kinsmen. Do the math: the oppressed in our societies across the world are the majority, yet in Belize, the majority is called untalented, not worth those positions of rank and respect reserved only for the very select. Sure.

We cannot become convinced that we are unfit, we cannot accept the narratives that we are lazy and incapable of learning, and we cannot and should never live up to the expectations of those in the dominant class, that we are good for nothing and troublemakers. Self-deprecation

is a tool used by the upper class and sadly internalized in Belizean society. I've oftentimes heard the stories of mothers and fathers putting up their houses for educational loans for their kids in colonial Belize, only to be denied on the grounds that "they could be a policeman or teacher, maybe a nurse – but doctor? lawyer? Oh no, can't approve a loan for that." Whether or not it's true, it is seen clearly that time and time again young Belizeans, specifically young black kids from the southside of Belize City, are oftentimes told that their dreams are ridiculous, impossible, and unattainable. And sadly, I've grown to see so many become convinced of that and settle or implode.

The design of our system, and many others across the world, turns those hopeless souls against each other, instead of against those who have subjugated and dehumanized them (and in turn, dehumanized themselves); in fact, they hold close to their hearts the oppressors, and are constantly sweetened by the fake love, suppression, in the guise of humanitarianism. So, we see when elections come around a host of reds and blues are out in numbers, and let's be real, my people on the ground are not entirely concerned with who wins or loses—they know not much will change for them—but are more interested in when that day-pay for their support hits their hands. In Belize, the politician embodies the idea of counterfeit paternalism, I'd dare to say all in emulation, but none reaching close to, the Father of the Nation. And yes, while his counterfeit was the best, the effects of that injustice – the handout culture it created -- coupled with the admiration afforded them by those who think themselves to be beneficiaries - has created the pacified society we live in, and has fueled the poverty and injustices we continue to live with. This is where we stand.

Al menos eso es lo que yo entiendo. (Sé que alrededor de noviembre de 1970, el finado Galento X Neal y yo vimos la pelea de Muhammad Ali vs Oscar Bonavena en la televisión en un café en la calle en Chetumal).

No había Internet ni redes sociales en Belize en 1972. Estas cosas no se inventaron hasta la década de 1990, que yo sepa.

En mayo de 1972, el único periódico real en Belize era THE REPORTER. El finado Honorable Philip Goldson había cerrado su BELIZE BILLBOARD a principios de 1972 y se había ido a estudiar derecho a Londres. AMANDALA era una pequeña entidad impresa en una prensa tipográfica. El editor en mayo de 1972 fue el secretario general de UBAD, Norman Fairweather. Cuando fue remitido a la prisión de Su Majestad (junto con 10 u 11 UBADers) durante una semana debido a los incidentes de mayo de 1972, creo que un oficial de UBAD que era profesor de español en el Colegio San Miguel, Elbert "Shaft" Franklin, editó un número del periódico.

Me imagino que discutiré un poco más el alboroto de mayo de 1972 en los próximos meses, pero comencé con el tema de mayo de 1972 para darles una idea de cuán pocas fuentes tendría disponibles un investigador que quisiera mirar mayo de 1972.

El tema que quiero abordar hoy es la Cumbre Negra de Belize de septiembre de 2003, un tema que un investigador tendría muchas más fuentes para explorar que si quisiera estudiar el levantamiento de mayo de

Si uno realmente quiere tratar de averiguar qué le sucedió a la comunidad negra de Belize entre 1972 y 2022, si realmente quiere identificar los fenómenos que han llevado a la guerra civil entre la juventud negra aquí, una guerra a tiros que ha durado más de tres décadas, entonces hay que repasar lo sucedido durante los tres días de la Cumbre Negra de Belize, celebrada en el Hotel Biltmore.

Los medios de comunicación y los académicos de Belize han ignorado por completo la Cumbre Negra de Belize, y tienen muchas menos excusas para hacerlo que cuando ignoran mayo de 1972.

Cuando observo dos áreas principales en las que sostuve opiniones firmes que se han demostrado erróneas de manera devastadora, estas dos áreas son el baloncesto semiprofesional (1992-1996) y la Cumbre Negra de Belize (2003), me siento tentado a pensar que hubo agentes al servicio de la estructura de poder de Belize que intentaron socavar ambos procesos. tanto con ella que arremetí contra dos íconos de la comunidad negra de mi generación, el finaso Bert Tucker y Nuri Muhammad. ¿Por qué les arremetí? Lo hice porque creía que el Partido Demócrata Unido (UDP por sus siglas en inglés), que había vuelto al poder en junio de 1993, no me permitiría organizar una cumbre negra, porque siempre había sido una sugerencia del UDP que el partido defendía a beliceños negros. Especulé que si comenzaba a trabajar en una cumbre negra de 1994 para las bodas de plata de UBAD (9 de febrero de 1969), el UDP usaría a Tucker o Muhammad en mi contra.

Esto fue muy injusto para estos dos señores, un terrible error de mi parte, pero es una prueba de lo desesperado que estaba. (Estos fueron los primeros años de las guerras de pandillas, que habían comenzado aquí a fines de la década de 1980).

Bueno, Kremandala tiene su propia estación de radio y su propia estación de televisión, y Kremandala tiene las grabaciones de la Cumbre Negra de Belize de 2003, pero nunca hemos sentido la necesidad de transmitir las grabaciones. ???

El orador destacado en esa cumbre de 2003 fue un profesor de la Universidad Temple de Filadelfia, Molefi Asante, quien era socio del legendario profesor de historia africana, el finado John Henrik Clarke.

Quizás aún más importante fue el hecho de que la cumbre concluyó con una sesión de micrófono abierto en la que, si no recuerdo mal, más de setenta beliceños dieron un paso al frente para expresar sus ideas o presentar sus sugerencias para un cambio positivo en la comunidad negra.

Centuries ago, nations declared wars against other nations to expand their territories, and killed many human beings, destroyed their cities and annexed invaded nations to expand their empires. Despite the loss of many human lives that included those of innocent women, children and

civilians, many of us have looked up to these invading nations of the past as Great Empires.

In many History curricula for colleges and universities, they are still teaching their students about these great empires, such as the Babylonian empire, Assyrian empire, Greek empire, Roman empire, Turkish empire, Egyptian empire, British empire, French empire, Spanish empire, Portuguese empire, Dutch empire, Indian empire and several others.

There is little discussion on the moral and legal justifications for these nations' invasion and colonization of other sovereign nations. Yet, the citizens of these nations and other students, would applaed these leaders and nations for



the unjustified genocidal acts that they committed against innocent fellow human beings like themselves. These actions continued into World War I in 1914, during which many nations of the world fought up until the ending of that war in 1918.

The total number of military and civilian casualties was about 40 million people. It is estimated that

there were about 20 million deaths and 21 million wounded. On January the 10th 1920 President Woodrow Wilson, the American president, was so angry over this war that he founded an organization by the name of the League of Nations to end future world wars.

Most nations became members of this international organization to participate in efforts to avoid future wars. The principal mission of this organization was to maintain world peace. After years of peace in the world, some nations that were not satisfied with the way they lost their territories in World War I, like Germany at the ending of the war, began to prepare for a new war. Germany began to build its military forces after the ending of that conflict. On September the 1st 1939 Germany invaded Poland and that started World War II. When Poland was invaded, the other countries appealed to Hitler to leave the Polish nation, but he refused to listen to their appeal. Great Britain and France then declared war against Germany three days after.

While Hitler was invading Poland, Japan was at war with China. From Poland, Hitler of Germany began invading other countries and was expanding his territories throughout most of Europe. Many nations on the European continent were afraid to engage Hitler's army. He continued his invasion of all the following countries in 1940: Denmark, Norway, Belgium, the Netherlands, Luxemberg, France, Yugoslavia and Greece in April of 1941. After Germany signed the Axis Alliance with Japan and Italy in 1940, Japan became emboldened and decided later to bomb the United States military bases in Pearl Harbor on December 7th 1941. The United States declared war against Japan and the Axis Alliance. As the war intensified, most colonial countries and their colonies were engaged in this war up until 1945.

When this war ended, it was estimated that between 70 and 80 million people perished. There were 15,000,000 battle deaths, 25,000,000 wounded, 45,000,000 civilian deaths, and 25,000,000 battle wounded. Like World War I, the effects of World War II were far more severe in terms of deaths of military personnel and innocent civilians. The nations of the world saw the need to build on the League of Nations and make the organization a more

PUTIN'S INVASION OF UKRAINE — A GRAVE MISTAKE THAT COULD SET A BAD PRECEDENT

engaged and proactive institution. On October the 24th 1945 the United Nations was established in San Francisco, California, with 51 countries becoming members.

The United Nations Charter was drafted to guide the member nations on its structure, qualifications for admissions, its purpose, principles, the functions of the United Nations and all issues and matters related to United Nations. administrative headquarters was later built in New York City. The two main branches of the United Nations are the Security Council with twelve members— seven regional and five countries that possess veto powers, which are Great Britain, China, Russia, The United States and

These nations also possess nuclear weapons and are trying to prevent other nations from gaining this technology. If any of these five members exercise their veto powers on a UN Resolution, it is difficult to get any action on it. The General Assembly is comprised of all the 193 independent countries in the world. The Security Council has more powers than the General Assembly and the countries that possess veto powers all have a seat on this body. China, Russia, Great Britain, France and the United States have been maximizing it to their full advantage over the years.

The US invasion of Grenada, Russian invasion of Ukraine, Georgia and other former USSR republics and China's invasion of some of its neighboring countries are examples of veto abuses by these countries. Some member states are calling on the United Nations to get rid of the veto power of these countries to make the United Nations more democratic. In 1945, when the United Nations was established, about 750 million people in the world lived in colonized countries. There was a resolution passed by the United Nations for all colonized countries to become independent. Since then, more than 80 countries in the world have gained their independence.

The right for citizens and their nations to be Self-Determined and to determine their own destiny, is a fundamental part of the United Nations Charter and International Law. Invading another country results in the taking away of this right from citizens and their nations. According to Article 2, paragraph 4, of the United Nations Charter, no country has the right to invade another country. This article reads that all members of the United Nations shall refrain from the threat or use of force against the territorial integrity or political independence of any state, or in any other manner inconsistent

with the Purposes of the United Nations. Nations who violate this act will be accused of committing an Act of Aggression under International

Nations that violate this Act get punished by other member states of the United Nations General Assembly. Sanctions, suspensions from favorable actions, reprisals, expulsion from the United Nations and other punishments can be used by this body. The member nations of the United Nations have been able to stop some countries from using military force against other countries, but there are many countries who have and continue to engage in unlawful aggression, against some nations of the world for no justifiable reason or reasons. Putin and Russia's invasion of Ukraine is in violation of this article.

The United Nations General Assembly and the UN Security Council must convene an emergency meeting to deal with this issue. Individual countries all have the right to impose other punishments against Russia to isolate and punish them for their violation of International Law. History has proven that no matter how large and powerful a nation is, the actions taken by the United Nations against countries who violate the UN Charter rules and International Law, can have a catastrophic effect on the countries who violate the United Nations Charter and International

In 2017 the United Nations went further to reactivate the Rome Statute for War Crimes; this is to bring criminal charges against countries and their leaders who unlawfully invade other countries and cause undue hardships to citizens and their nations. Many leaders of various countries have been placed on trial since then. In 2006 the United Nations passed a Resolution against Iran for its efforts in constructing nuclear missiles. Then, in 2017, they brought action against North Korea in an attempt to stop them from constructing additional nuclear missiles. Both nations failed to comply with the UN Resolutions and the UN imposed sanctions against them. Despite all the sanctions against North Korea, they continue to build and test new nuclear missiles. Many people and nations in the world, are frustrated with the way the United Nations functions due to their inability to enforce their rules against rogue nations. The developed nations, like Japan and Germany, who were punished and restricted from building their militaries after World War II, want all the restrictions lifted against

They are well off economically and can take care of themselves and do not want United States and NATO forces in their countries. Many nations in Europe still fear Japan and Germany and do not want the NATO countries to remove their troops from these two countries. Now, with Russia invading Ukraine, they will make a case for the restrictions

against them to be lifted.

Developing nations want the veto power given to the five countries, Russia, the United States, China, Great Britain and France, to be removed so that the institution can function under the one-nation, onevote principle as equal nations. They contend that these countries violate the United Nations Charter rules and nothing is being done to them because they possess veto powers and sit on the Security Council, which is the enforcement body of the United Nations.

Another issue is the financing of the United Nations, which is done mostly by these five countries, because many of the other countries are not financially capable of financing the United Nations. Japan and Germany have the finances to assist in the financial obligations of the United Nations, but they are both demanding that some concessions be made to them before they do it. Due to all these troubling issues, there is now pressure building in the United Nations to punish Putin and Russia for the invasion of Ukraine.

My guess is that there will be calls from many nations in the world to do so. Weak and vulnerable nations need reassurance that what Russia did to Ukraine will not happen to them. This is the greatest challenge that the United Nations is experiencing in this 21st Century. History has convinced us that the invasion of a country and people might be easy, but to occupy a nation for a prolonged period of time is a greater challenge. It takes the world back to the Colonialism era, when today most people and nations want to be free and independent.

The people and nations of the world must pass a United Nations Resolution to give Putin and Russia an ultimatum to withdraw their troops from Ukraine immediately. Failure to withdraw their troops, shall result in the nations of the United Nations expelling Russia from the United Nations using all their resources to remove the Russian troops out of Ukraine. The nations of the world cannot afford to allow this to happen, because that will run the risk of other nations doing the same thing to many other weaker countries on this planet earth.

When this war is all over, Putin and Russia will face many consequences that will have a negative impact on their country in the international arena. This conflict cannot last for a long period of time, because the people and the nations of the world will not let it last. It is the responsibility of every living human being and nation on this planet earth, to demand that Putin and Russia leave Ukraine in the interest of world peace. I am very confident that this will happen sooner rather than later. Let us extend our love and care to all the human beings on our planet earth. As a Garifuna person whose people experienced colonialism and continued genocide, I ask that all human beings be allowed to enjoy their freedoms.

No more testing at the land borders

Belizeans spending an overnight or more across the border are not required to be tested for COVID-19 upon their return.

BELIZE CITY, Thurs. Mar. 3, 2022

There will be no more mandatory testing of Belizeans crossing the border to re-enter the country after having spent more than 24 hours in another country, as had been mandated when the borders were initially reopened for local residents. After that initial reopening, Belizeans who spent more than 24 hours across the border had to pay a mandatory fee of \$100 for a COVID-19 test.

However, Minister of Health and Wellness, Hon. Kevin Bernard, has announced that there will be no more testing at the land borders for vaccinated Belizeans.

"With the requirement, now only vaccinated people can leave the country, and if you're vaccinated and coming back in, there's no need to test. Therefore, the Belizeans going to

Chetumal for five, six days, can, a week if you like, there's no need for you to test, so there's no fee you're paying for coming after an overnight stay or after a 72-hour stay. There's no longer the need for them to pay that fee. The only persons that are required to pay the fee are those who are coming in unvaccinated that are tourists, because Belizeans who leave the country must be vaccinated to leave," Minister Bernard said.

As for tourists, as long as they are fully vaccinated they won't be

required to take a test to enter the country.

"If you are a tourist coming in; coming by land, sea, or air, you can come into the country once you are fully vaccinated and can prove that you are immunized for COVID, then you don't need to test at the border or at the entry point. But if you are unvaccinated, you have to test at the airport, if you're coming by air or at the land border; or at the seaports once you're traveling through those means," said Hon. Bernard.

BELIZE CITY, Tues. Mar. 1, 2022

Chairman of the Baron Bliss Harbor Regatta Committee, Collet "Bunas" Maheia has informed *Amandala* that the committee is planning a regatta in honor of Baron Bliss, "but unfortunately because of the COVID restrictions, we had to reschedule for Sunday, 1st of May."

The traditional holiday on March 9 was once called "Baron Bliss Day" in honor of the country's greatest benefactor, the seafaring baron who requested the holding of annual boat races on that day. The

day now encompasses other Belizean heroes and benefactors, and has been officially named National Heroes and Benefactors Day since 2008.

Stevedores' payments temporarily blocked

injunction which froze the account for a period of 15 days, until March 16 at 5:00 p.m. The case is scheduled to be heard on that day, but this past Monday was the day the stevedores had a reasonable expectation to receive the payment. The principals of the union had been engaged in an intensive process over the past week and over the weekend to put everything in place to facilitate the payment on the date set out in the Memorandum of Association signed with the Government of Belize: February 28. The president of the CWU, Evan "Mose" Hyde, had even indicated in a press briefing two weeks ago, when he was responding to local reporters' questions about the agreement with GoB, that every effort was being made to put all the processes in place to ensure transparency and accountability in the disbursement process and to ensure that all documentation would be in place to indicate which persons had received those funds — in line

with a commitment they had made to GoB. During the hearing on Monday, however, attorneys for PBL posited to the court that the CWU's continuation of its efforts to issue payment to the stevedores was disrespectful — and the sitting Justice, Lisa Shoman, who, coincidenally, was closely affiliated with the PUP administration under which the privatization of PBL took place— appeared to concur.

However, what the attorney representing the CWU, Darrell Bradley, pointed out in a press briefing on Tuesday is that it is in fact the PBL's "urgent" injunction — filed several weeks after a well-publicized agreement with GoB was put into place and after a disbursement effort was set into motion — that was actually an act of disrespect.

"What I think is disrespectful is the fact that this was all done in public, so that the fact of the negotiations between the CWU, the government of Belize, and the Port Authority, that began in January of this year, if you look at the affidavits filed by the

claimant, it tracks the fact that they knew that these negotiations were happening from January." Bradley

The affidavit of Arturo Vasquez, in the original notice of the interim injunction, confirmed that they had knowledge of the negotiations between the government of Belize and the stevedores since January 26, and also of the MOU entered into by the CWU and Port Authority on February 3, granting them 1.5 million payment to be paid "on or before the 28th of February 2022."

In reference to what had been taking place since the signing of that MOU, Bradley stated, "Since then, the entities have been meeting, they have been working out the logistics and so forth, and on Friday, there would have been an urgent injunction in relation to stopping the payment. Now when you use the court processes for urgency, that's because something is happening when you had no opportunity to act. When you are saying that something is urgent, you are saying that people are trying to do something behind closed doors, but that is furthest from the truth. These things were public; these things were done with press conferences and in the plain view of every single member of the public..."

Bradley, in addition to pointing to what appeared to be a bad-faith move of an entity that knew for weeks of the payment process that had been set into motion but chose to file an "urgent" injunction at the "last minute" (as part of an effort which bears some semblance to a legal ambush), also

mentioned that the CWU and its attorneys did not receive notice of the document, which was needed for them to prepare for the hearing until Saturday. This, Bradley said, was an act of disrespect. He said that at that very late juncture, they proceeded to work on preparing the affidavits for the hearing, which was scheduled for Monday.

"The only reason that is the case is because we received the documents involving our clients and seeking this injunction on Saturday, so that we had to be struggling to put in place what would be our response and so forth for a hearing that would have been on Monday, for something which they the claimants are saying is urgent, for something that was in the public domain since January and for a memorandum and payment, knowledge of which they had, when the memorandum was signed on the 3 of February 2022. In my view that is disrespectful," Bradley said.

Bradley went on to state that PBL and its attorneys are attempting to give the impression that some misdeed is taking place in the dark between the CWU and the government of Belize, when, in fact, the agreement and all subsequent processes have taken place openly, with full transparency. PBL and its attorneys have been insisting, however, that the monies paid out to the CWU did not receive the required parliamentary approval. When interviewed by local reporters on Monday, PBL's attorney Hector Guerra, said that if the requisite



Dear Editor,

I want to clarify three important points in your editorial article.

I must reiterate that the BAA has always welcomed foreign athletes and coaches to assist in the development of the sport of athletics. We have sought many ways to better the performance of our athletes, but while we do that, we try to ensure that the athletes of the BAA will [not] be taken advantage of in the process. Many have tried to do such. We will always aim to make BAA one of the best sporting associations and ensure our athletes have the enabling environment to perform their best. This will always be our number one priority. I have contacted Mr. Meyers via email and have welcomed him to share his knowledge and sporting expertise with us at the BAA. He has agreed to work with us for future programs.

The executive of the BAA are aware that many people have knowledge that the BAA elections are in the pipeline, and therefore the level of mischief will be up, but I hope that before this paper listens to hearsay and tickle-ears falsities, they will get the facts on any important matter or issue. If one desires to see the sport develop and progress, don't be a person who tears down, but lend a hand and an idea to assist and build and make better and stronger.

Don't say it. Show it.

Reparations sub-committee drafts letter from CARICOM to European countries

During the press conference at the conclusion of the 33rd Inter-sessional Meeting of the Conference of CARICOM Heads of Government,

Prime Minister of Barbados, Hon. Mia Mottley announced that the Prime Ministerial Sub-Committee of Reparations, which she chairs, has drafted a letter to reengage European nations on the unresolved issue of reparations for the region. The countries in the Caribbean region were subjected to generations of resource-extraction and dehumanization of their people in order to fund the economic growth of European countries which colonized those nations. As PM Mottley stated, this is not the first such letter to be sent out to the European nations, but it seeks to rekindle a conversation that has been downplayed by those European countries.

"I chair the Prime Ministerial subcommittee on reparations. Last year we took a decision that we would write to the African Union before we wrote to the European nations who were responsible for colonizing our territories and for the enslavement of our forefathers. Today, we share a draft letter that will go to the heads of different European nations, and we will weigh the comments of our colleague heads with respect to that actual draft letter," said PM Mottley.

She noted that this is not the first letter sent from the region to the European nations, but said that this most recent letter is being sent at this juncture in an attempt to start a more mature engagement on the topic.

PM Mottley added, "I think a predecessor of mine sent a letter in 2016, and there was a response to it, and while it was noted that it was a dark period in the history of our countries and theirs, there was not an acknowledgment of the need for reparations. Since then, however, we've had the George Floyd and Black Lives Matter, we've had a recognition by the global population, especially

younger people, that there is a need for climate justice, and I think that we are dealing with a world that is generally intolerant of the kind of inequity, and poverty and discrimination that has come to characterize too much of the last three to four decades in particular of global activity and development."

She noted that while almost 47 million pounds was paid to former slave owners, no development compact was given to Caribbean nations when they received independence, and this has led to the systemic shortfalls we see commonly across CARICOM nations.

"We had no development compact given to us at the point of independence, but there was a compensatory package for those who were slave owners, and there was a further package for the apprenticeship system, I think that my officials and advisors count it at about 20 million pounds for the British planters who had slaves and another 27 million pounds as a result of the apprenticeship system, so that 47 million pounds was given in the middle of the 19th century. Fast forward now, 130 years to Jamaica becoming independent, Trinidad becoming independent, Guyana becoming independent, Barbados and we go down the line, none of us were given a development compact. We had to start providing for our people without the benefit of any sort of development funding; we had to deal with lack of housing, lack of educational opportunities, lack of healthcare facilities, and we had to do this in spite of the fact that substantial wealth were extracted from our countries, for centuries, in spite of the fact that substantial wealth was extracted not only by the governments but also by the private players who were the owners of the plantations of the owners of the enterprises doing business and trade in our part of the world, and whether we like it or not it is regrettable that the region to which we belong effectively was the modern crucible for racism in the Americas and in the Western world. "PM Mottley said.

The issue of reparatory justice ties into that of climate justice. It is widely known that the capital acquired from the extraction of resources in the Caribbean funded the Industrial Revolution in European countries; it is equally widely accepted that the period marks the start of the increase in global temperature, which began around 150 years ago at the height of the said Industrial Revolution. This creates a direct nexus between the profits gained from the enslavement of the ancestors of those currently living in the Caribbean and the impacts of uncontrollable emission of greenhouse gases that continues to fuel the climate crisis.

PM Mottley said it is no different from any conversation in respect to persons doing wrong: "In private law, you can do wrong through breach of contract, or tortious interference. In development there has been an act regrettably that has left us suffering, and we hope that we can engage with the European countries to ensure that there is an appropriate framework to fuel our development in this difficult time in history," she said.

in over a decade. At the last such Central American-Caribbean gathering, the heads of the two regions committed to increasing cooperation and engagement, but the efforts made since then, noted Hon. Briceño, have been less than satisfactory.

"Clearly, much has happened in the world since 2011. The global and regional landscape has changed significantly. Our partnership, therefore, must be strategic. It must deliver more for the peoples of our shared neighbourhood. As nations we are clawing our way back from a severe economic downturn, occasioned by a devastating COVID-19 pandemic," he stated. In addition to having similar challenges, expressed Hon. Briceño, the nations of the two sub-regions also share similar commitments—to achieving development, sustainable multilateralism, and to maintaining democratic governance.

The president of Costa Rica, Carlos Alvarado Quesada, also delivered opening remarks in which he noted Belize's unique position as a bridge between the two regions. Quesada proposed that the Heads of State work

together on a SICA-CARICOM action plan that focuses on increased connectivity between nations, particularly in the form of language and intra-regional transportation. He highlighted the fact that Central America and the Caribbean are two of the most vulnerable regions when it comes to the climate crisis and emphasized that achieving true progress requires a unified voice.

President of Panama and Pro-tempore President of SICA, H.E. Laurentino Cortizo was unable to attend the Summit due to COVID-19. In his stead, Erika Mouynes, Panama's Minister of Foreign Affairs, spoke on the significance of the collaboration between the two subregions.

"The fact that 22 countries are coming together cannot be lost on us, and the power, and the message that that sends is also extremely important. And so we need to embrace it and understand," Mouynes said.

H.E. Antonio Gutierrez, the Secretary-General of the United Nations, was in attendance at the Summit, albeit virtually, due to the ongoing invasion of Ukraine by Russian forces and the key role he is playing as the United Nations attempts to address this crisis as an international body. face of adversity.

"Challenges will be everywhere, but if you are determined in your soul that this is what you want to do, you should be willing to face the music, but keep focused on what you want to do," she said, also highlighting how important it is for women to come together and support one another. At the She4She Summit, Dr. Howard-Taylor will be speaking on why representation of women matters.

"I want to say to Belizean women, whether you are young or middle age or aging, there are still opportunities for women to come together, more so for the younger women, because they are the next generation, and those of us who are on the stage now must begin to prepare those who are coming after us so that this struggle for equality isn't lost," added the vice president. She cited Madame Ellen Johnson Sirleaf, who made history as the first elected female head of state in all of Africa, noting that thanks to her and women like her, the journey for other women is much easier.

The program for the three-day summit will include talks on Women's Participation in Public and Political Affairs, Facilitating Women Inclusion in Political Governance, Building and Enabling an Environment for Women's Participation in Public and Political Affairs, Women in Solidarity, and most notably "Her Story," which will see several speakers share stories about their own journeys to success. Speakers will include Belize's Special Envoy for the Development of Families and Children, H.E Mrs. Rosanna Briceño; Madam Mayor Nicole Jackson of Rice, Texas; and the Permanent Representative to the UN at the Government of Sierra Leone, Ambassador Victoria Sulimani.

According to Mayor Palacio, the She4She Summit is set to take place in the Republic of Liberia next year. Dr. Howard-Taylor also said that she hopes Belizeans, regardless of gender, will attend the event, learn, and then go on to mentor others using what they have learned.

Court strikes out Stake Bank v AG claim

leave for judicial review of GoB's approval of the Port of Magical Belize project. Today, however, Justice Lisa Shoman struck out the case, on the grounds that the attorneys for the claimant, Senior Counsel Glenn Godfrey and William Michael Lindo, Jr., failed to file the claim within the mandated 14-day period.

The parties made submissions yesterday, and an oral decision was reserved for this morning, when Justice Shoman ruled in favor of the Attorney General's Ministry, the first defendant in the matter. In her ruling, she outlined that the rules of the court do not grant the bench powers to extend the fixed 14-day period in a judicial review action not filed within the mandated time.

The attorney for Stake Bank, William Michael Lindo, did not deny the legal requirement that there must be strict compliance with the 14-day mandated period, but maintained that they filed the claim within the stipulated time period. He noted that they uploaded the file to the Apex Court system and received acknowledgment of receipt prior to the end of that period. This was ruled to be not sufficient by Justice Shoman, who asserted that until a party receives a stamped court document, whether hardcopy or electronic, a claim is not considered filed.

In an interview subsequent to the hearing, Hector Guerra, attorney for Waterloo Investments Holdings, which is an interested party in the case, said, "The court today ruled that a document is not filed, or at least it's deemed to be filed until a party received back a stamped copy of that electronic document, saying, look, it's been filed, and it has the date. '

The judicial review action brought by Stake Bank hinged on the geographical proximity of the two ports, which, it has

asserted, would reduce the financial viability of both projects, which would share a limited market. Those two locations, Port Coral and Port of Magical Belize, are located about 12 miles from each other, and somewhere in the middle of that would have been the proposed Waterloo port, which was denied environmental approval, but would have resulted in a three-way apportioning of market share, and further reduction in returns on investments.

Last year, Waterloo Investments joined the case after being denied environmental clearance by the Department of the Environment, following expressions of alarm, both by environmental groups and the country's Belize Water Services Limited, about the adverse potential environmental impact of the project. Those environmental concerns were not cited when the approval was denied, and the company seemed to ignore those concerns when it issued a scathing letter accusing unnamed members of the National Environmental Appraisal Committee of attempting to seek bribes - a claim that they failed to substantiate with any evidence or further details, according to the Minister of Sustainable Development, Climate Change and Disaster Risk Management, Hon. Orlando Habet.

Stake Bank Enterprise Limited may have an opportunity to appeal the decision, said Guerra.

"There is a possibility that it may be an appeal. Of course, any litigant has that at its disposal. Now, in terms of whether a fresh claim can be brought, we have our reservation about that. We do not believe that a fresh claim can be brought as a result of the way the law stands at the moment," Guerra said.

So for now, the battle of the ports continues, and Stake Bank's Port Coral continues its construction of facilities to accommodate cruise tourists on the island. We will continue to follow.

Two murders in less than an hour

after being shot in the northern part of the country.

The first fatal shooting that occurred on Wednesday night, took place shortly after 7:00 p.m. in the Japan area of Ladyville Village. At about 7:40 p.m., police went to a residence on Myrtle Wade Crescent, where that initial shooting occurred. The alleged shooter, who resides at the home, was, according to police, in a nervous state, and when he was questioned by police, he explained that someone came to his home and tried to kill him. After police searched the yard of the home and found the motionless body of 27-yearold Dijon Kenrick Foreman and a .40 caliber pistol, which is believed to be the murder weapon used to kill Foreman, in the yard, they arrested the resident of the home.

"Based on the information gathered so far by investigators, they're saying it was only the person who lives at the house and the victim which was there. The victim lives not too far from where he was killed, and we don't want to make any presumptions. We're just sticking to the facts. What I can tell you is that for investigators right now, this is looking pretty good, and we're hoping to gather more information from neighbors," said Communications Director of the Belize Police Department, ASP Fitzroy

Yearwood today at a press briefing.

No clear motive has yet been established for the shooting, but according to police, initial reports indicated that Foreman had gone to the home, where he was shot, for an unknown purpose.

The second murder of the night occurred at about 8:30 p.m. on Wilson Street in front of the WASA water tank in Belize City. When police arrived at the scene, they found the motionless body of 55-year-old Edward Reubin Saldano, Sr., also known as 'Scrubboad', a Belizean stevedore, lying on the ground with apparent gunshot injuries to his body. According to the police's initial report, at about 8:25 p.m., Saldano was riding his bicycle on Wilson Street, when a darkcolored Nissan Murano drew close to him and the occupants of the car exited the vehicle and fired a barrage of bullets in his direction, which caused his death. On February 9, the son of Edward Saldano, Sr., Edward Saldano, Jr, escaped from police custody while at the Belize Magistrate Court, and since that day police have been on the hunt for Saldano. ASP Yearwood speculated that Saldano, Sr., was an innocent target, and was killed unjustly possibly in retaliation for the unlawful actions of his son.

"I wouldn't want to say that, because he's on the run from the law, and I

don't believe any law enforcement officer may have had anything to do with what took place to Mr. Saladano last night. I just want to make it very clear, Edward Saldano, Sr., and Edward Saldano, Jr., are two different persons, and as much as I know about the father is that he is a hardworking person and have been that way from I can't remember how long, knowing him for so many years. What his son may have done in the street could be elements, but I still wouldn't want to lean towards that, and I honestly believe that someone took advantage of Edward Saldano, Sr., and took away his life unjustly," noted ASP Yearwood.

Police have no clear motive for the second murder, but ASP Yearwood mentioned that the gunmen might have been sending a message, based on the number of bullets fired. "So far, we haven't established motive, but what we can say is that with that excess amount of bullets fired at him, they wanted to make sure that he died," Yearwood noted. Police are in search of two individuals in connection with Saldano's murder and are pleading with the residents of the area to come forward with any information they might have on this recent murder.

"When it comes to murder, it is very difficult, because the way our laws are set, we don't want to identify anyone before that person is detained, because then could prejudice the case. So we only have our officers tasked with finding these persons, and hopefully through our investigative tactics we can come to a conclusive arrest when it comes to that. But it wouldn't hurt if members of the public know the identity of these persons without us having to tell them who these people are. If they could call 922, 911 [or] come in and visit your nearest police station. Any way you prefer to give us that information, it would be very helpful for us," said ASP Yearwood.

While Foreman and Saldano died due to gunshots, an eighteen-year-old teenager from Corozal is fighting for his life at the Corozal Community Hospital after being shot multiple times. According to initial reports, at around 10:30 p.m., Andre Sanker of Corozal Town was socializing on a veranda on F & D street along with two other persons, Ainsworth Matura, 18, and Leonardo Acosta, 19, when a gunman approached them from behind the house and fired a barrage of bullets, which wounded Sanker.

Police believe that Sanker was the intended target, based on the number of times he was hit, but no clear motive has yet been established.

So far, one person has been detained and is in police custody. Sanker is listed as being in a critical condition at the Corozal Community Hospital.

parliamentary approval is granted, they would have to "reconsider the matter," but that they have their own view as to "whether that would cure the misstep that has happened".

(It is worth noting that PBL, while attempting to portray itself as an advocate of compliance with law and proper procedures, had, up until last week, not complied with the rulings of the government-appointed Essential Services Arbitration Tribunal — even though the stevedores had ended an 8day strike with the hope that they would. The Belize Chamber of Commerce and Industry (BCCI), when expressing disapproval of the stevedores' industrial action in January, had pointed to this tribunal as the appropriate mechanism for resolving differences between the parties. However, it remains to be seen how this mechanism can effectively address these concerns, in light of what appears, at least at this point, to be PBL's disregard of that tribunal's orders.)

Prime Minister John Briceno had informed local media that the payment was made by special warrant and would be approved at the next budget presentation in the National Assembly, and Darrel Bradley also noted that section 114 of the Constitution provides for payments by means of a special warrant, with a period of 90 days without immediate parliamentary approval, which is one of the grounds of the claimant's case, or so it seems.

The preamble of the Memorandum of Understanding sets out overarching reasoning for the decision to issue payment to the stevedores.

"Whereas the Port of Belize Limited was privatized on or about 18 day of January 2002; And Whereas the Government of Belize recognizes that the Stevedores may have been prejudiced by the said privatization or the Port; And Whereas the Government of Belize, without accepting any liabilities for any prejudices that may have been suffered by the Stevedores, desires to provide the stevedores with an ex-gratia payment to offset any such prejudice that may have arisen," the MOU signed by the CWU and government states.

While the government itself assumes no liability for any harm to the stevedores that may have been caused by privatization, they do recognize that stevedores "may have been prejudiced by said privatization **or the Port**". This assertion seemingly transfers some level of implied culpability to the receivership which oversees the Port of Belize, a major service provider that has been operating with a transitional management team for 20 years, and which has been in a volatile relationship with its workers over the past two decades.

The effort of the CWU to provide some relief for their aggrieved members has been interrupted by their employer in a manner that seems to many Belizeans to be spiteful — and that, in some quarters, is viewed as an effort to cause economic pain to the stevedores, some of whom have been physically injured while on the job. The president of CWU, Evan "Mose" Hyde, told local media that the stevedores had a reasonable expectation that they would be receiving payment on the date designated by the

memorandum of understanding they signed with the government, since they fully complied with the requests within the MOU.

For now, since that process has been stalled, the union is unable to access its online account to check its account balance to determine what amount has been withdrawn, and many stevedores, unable to access funds from local banks — particularly the bank associated with the entity which controls PBL — have had to pay incredibly high fees to third party agencies to cash their checks. And it in fact appears that the union is in fact unable to access any of its funds — even those funds completely unrelated to GoB's disbursal and which are needed to pay the union's expenses.

"Our advice to our members today is that they need to remove their accounts from those institutions that are related to the employer forthwith. If they have any loan arrangement, of course, they have to keep with those, but you cannot do business with people who have acted this way to you. Because ultimately that is what we have, the situation that we are faced with is that unfortunately people who have deposited their checks to various financial institutions are now being told that they are unable to get any access to their funds, that's going on. But it's even broader than that; what happens at CWU, is we have independent financial institutions not honoring our check, which is not related to the account in question, not even the same bank." Hyde said..

He went on to state, "But it just shows the end product of a veryunkind, I'm trying to be pleasant... very unkind intentions from the employer to do its best to make things as messy, to make things as hard, to make things as unpleasant as they have become, and we have to put that on the record. "

Attorney Bradley said that the injunction, to which there might have been an excessive reaction by local banks, only legally restrains the CWU from paying the stevedores for a period of 15 days, but any monies paid out by check or otherwise are not frozen by the interim order.

"We just want to be very clear in relation to what the order speaks about. The order speaks about the payment of the fund and the order specifies the \$1.5 million, and what the order does is temporarily for a period of 15 days, what the order does is it restrains the CWU and its officers, president, general secretary from making the payment to the members, so if the payment has already been made previous to the granting of the injunction, that can't be caught by the order," Bradley said.

Concerning the difficulties being faced with the other domestic bank accounts, he said, "Just by way of the court order, the court order only deals with a particular sum of money which was paid into a particular account, so this doesn't deal with any other account or any other monies. It's a particular thing, and what it does is that there is no holding of that; what it does it prevents me, from your, those proceeds, but every other thing is not caught by the injunction." Bradley explained.
