# BNTU: touch one, touch all

BNTU to remove its accounts from Belize Bank in solidarity with CWU; calls on sister unions to do the same.

BELIZE CITY, Mon. Mar. 14, 2022

The Belize National Teachers Union (BNTU) has decided to close all its accounts at the Belize Bank and to get its banking done at other financial institutions to indicate its solidarity with its sister union, the Christian Workers Union (CWU), which is facing a lawsuit brought by the employer of the stevedores who belong to the union, the Port of Belize Ltd., which is suing several members of the union's negotiating team and also seeking to prevent a payout from

the government to the stevedores. The entity which reportedly controls the finances and decisionmaking at PBL is said to be the same entity which is the proprietor of Belize Bank, the domestic bank with the hugest share of the banking market here in Belize.

The case, which goes back before Justice Lisa Shoman on Wednesday of this week, is an attempt to block the government from paying out \$1.5 million dollars to over a hundred



## Churches oppose marijuana legalization

again, issued a press release
expressing its opposition to the
legalization of marijuana and the
recently revised cannabis regulations

Bill 2022) set to be presented in the House of Representatives this week.

In the release, the NEAB cites the potential for the involvement of drug cartels in the event that the proposed marijuana industry becomes a profitable business, stating,

"We are sounding the warning that this is opening a door to influences that, once they are in, will be near impossible to remove from Belize."

The NEAB also referenced the nearby Mexican Riviera Maya, where drug cartel conflicts have endangered the lives of locals and tourists alike.

The sudden and untimely death of Herbart Panton, UDP stalwart and husband of UDP Albert area representative, Hon. Tracy Panton, took the nation and the already fragile opposition party by surprise. Last week, the party faithful, along with Panton's loved ones, mourned his passing, and his remains were laid to rest by his family.

Subsequent to his burial, Hon. Panton stated in a post published on Facebook on Saturday, March 12, "I have made the decision to continue to pursue the leadership of the United Democratic Party at a Special Convention that will be convened on Sunday, March 27, 2022. The convention is set to be held exactly 13 days from today. According to reports, Roosevelt Blades, Hon. Panton's campaign manager, has confirmed that she will proceed without any delay for grieving. (Panton said that she is sure it is what her late husband would have wanted.)

She is now asking for the support of the delegates of the party who will make the final

decision on March 27.

Last week, the Prime Minister of Belize, Hon. John Briceño, visited the Republic of China, Taiwan, where he received the Order of Propitious Clouds with Special Grand Cordon from the Taiwanese government. After receiving that honor, on Friday, March 11, Prime Minister Briceño also received an honorary doctorate from Kun Shan University, located in Tainan

"Such an honor!" expressed Prime Minister Briceño via social media after the conferral of the honorary degree. "Tainan is a city with the longest history and earliest cultural roots in Taiwan, boasting a stunning natural landscape and well-known agricultural and fishery products and cuisine. Prime Minister Briceño traveled to Taiwan with a delegation that included Hon. Eamon Courtenay, Minister of Foreign Affairs, Foreign Trade and Immigration; Hon. Jose Mai, Minister of Agriculture, Food Security and Enterprise; Hon. Francis Fonseca, Minister of Education, Culture, Science and Technology; Ambassador Stuart Leslie, Cabinet Secretary; Mrs. Rossana Briceño, Special Envoy for the Development of Families and Children; and Belizean Trade and Investment Ambassador, Jaime Briceño. By all indications, he and the delegation returned to the country on Saturday, March 12.

### WHO discussing how and when to call an end to COVID-19 pandemic

Belize and many other countries have been slowly rolling back COVID-19 regulations in light of what currently appears to be a deceasing number of Covid-19 cases following the decline of the recent Omicron wave of the virus. The World Health Organization's (WHO) International Health Regulation Emergency Committee on COVID-19 is currently discussing the next steps forward to determine what conditions should signal an end to the public health emergency first declared in January 2020.

The committee, based in Geneva, Switzerland, is made up of public health experts who are currently in discussion on how and when the world can call an end to the pandemic, but it has made it clear that such a declaration is not yet being considered, despite the ever-lower number of cases worldwide.

Any new recommended steps emerging from those discussions would signify a meaningful move toward ending the pandemic and would trigger a rollback of more public health regulations that had been put in place to minimize the impact of the virus.

The pandemic, however, is still very much ongoing, with 10 million cases being reported in the last week, and 52,000 fatalities also recently recorded. Some Asian countries are seeing a surge of infections, with a

spike of deaths being recorded in Hong Kong, and 1,000 plus cases being recorded in China last week, for the first time in two years.

Experts say the disease is likely to continue to cause deaths in the thousands each year, even if cases reach lower levels – and the potential for new and dangerous variants is an unpredictable reality.



The level of population immunity—the percentage of a population that has antibodies to fight the disease, either as a result of infection or vaccination, or both—will be a key metric in the decision to lift the global emergency declaration. Ultimately, the decision will be made by WHO's Director-General, Tedros Adhanom Ghebreyesus after he consults with the experts on the committee.

The goal of herd immunity, seen as the saving grace at the start of the pandemic, is now being viewed as "extremely unlikely," since vaccinations for the virus do not in all cases prevent infection, and infection does not prevent repeated bouts of the virus, according to David Heymann, in an interview with *Bloomberg News*.

Heymann, a former epidemiologist for WHO and the US Centers for Disease Control and Prevention, says many countries are now relying on national and regional data to guide their decision making, but are not ignoring the WHO.

## Behave like a terrorist, get treated like one - COMPOL

According to Commissioner Chester Williams, the police will be responding aggressively to the raging gang warfare in the city, since mediations have, for the most part, failed.

The increase in gang-related shootings across the city has led Commissioner of Police Chester Williams to announce that the police will be forgoing the method of mediation for much more aggressive and direct methods of dealing with feuding gang members.

The Police Commissioner recently told local media that, since attempts at dialogue have been failing, police officers in Belize City will be carrying out daily operations targeted at gang members. One such operation has resulted in the arrest of a 20-year-old believed to be responsible for the January 21st murder of Burrell Boom businessman Leslie Gillett.

On Thursday, March 10, at around 5:30 p.m., police went to the St. Martin De Porres area in search of the accused murderer. What resulted, according to Commissioner Williams, was an attack on the police by an angry mob which led to the police firing

rubber bullets in response. The person wanted in connection with the Burrell Boom murder, Earl Dean Baptist, was subsequently arrested along with his brother, Hubert Baptist, who had reportedly attempted to throw away a .45 caliber pistol and 60 rounds of ammunition, which were eventually recovered.

Since then, however, residents of the area have claimed that the police displayed an unnecessary amount of force and that they also fired unwarranted shots at two vehicles. In response to those claims, and to the surveillance videos that the residents have shared which show the entire incident, the Commissioner of Police remarked via Facebook that it merely shows the "difficult circumstances under which the police must work."

"I call upon our citizens to be patient and supportive of our efforts as we try our best to ensure your safety. We cannot allow a hand full of criminals to hold us hostage in our community," he wrote. And those are the same sentiments that the Commissioner expressed to local media when he first spoke about the upcoming increase in special operations last week.

"We cannot continue to work with terrorists. Behave like terrorists, then you will be treated as one," said the COMPOL, who noted that even some of the men who make an effort to attend mediation meetings

held by police to ease tensions between gangs end up becoming gunmen at night.

According to Commissioner Williams, the string of shootings seen over the past few weeks are a direct result of an intense rivalry between George Street and Wagner's Lane gangs that has expanded to include the PIV and Mayflower areas as well. This includes last week's shooting near Logwood Street which proved fatal after four men from the PIV area were dropped off in the area to carry out an execution. The four were spotted by men from the area and this led to an exchange of gunfire which saw one of the would-be-executioners, 23-year-old Carrel Sanchez, shot



dead.

That failed ambush was an attempt at retaliation for the attempted murder of Patrick "Pato" Jones which occurred on Mopan Street last Monday night. Jones was shot at while driving, and his vehicle, which overturned during the attack, was extensive damaged.

According to some reports, Carrel Sanchez had just attended a mediation meeting last Tuesday—the same day that the Logwood Street shooting took place. And while the Commissioner expressed that he isn't certain how true that is, he stated that he won't stand for gang members thinking they can "take us [the police] for a ride."

"While yes we do have some of them who are productive and are engaged in the ongoing arrangement that we have through the Multi-Agency Task Force, we will try our utmost best to keep those who are engaged and trying to change their life to do so, but at the same time we must go hard on those who continue to hold the people of the city hostage," said Commissioner Williams.

"It seems as if some don't want for us to work with them and they want to be working against us or against the law-abiding people of this country. And so operations will be conducted in Belize City every day," he added, and further noted that he believes the people of the city have had enough.

The COMPOL says he was invited to a recent mediation meeting but declined. "I believe that I have spoken enough with these people. For me at this time it's no more talking," he said.

In addition to sparking an increase in special operations, the recent gang warfare has also prompted some changes in leadership. The police's Eastern Division will soon be seeing the transferral of its leader, Senior Superintendent Suzette Anderson, who is being replaced by the former head of the Western Region, Assistant Commissioner of Police Howell Gillett.

While the Commissioner has said that there is no magic fix for the crime situation, the department will continue to do what it can for the safety and security of the people.

"We have to from time to time restrategize, look at situations where we can put people where they can function at optimal...We believe it is best to have the senior ACP in the Eastern Division," explained Williams, citing the dynamics and the large size of the division.

### **BBA seeks judicial review of Floralia Bus permit**

The BBA has retained the services of Senior Counsel Rt. Hon. Dean Barrow and is seeking a stay on Floralia bus runs from Dangriga to Belize that are scheduled to start on Monday.

After just four months and some days in operation, the newly formed bus company, Floralia, could be facing a judicial review of its road service permit – after a letter of notice of application for permission for such a review was forwarded to the chairman of the Belize Transport Board, Byron Sanchez, and other government officials by senior counsel Rt. Hon. Dean Barrow, the attorney for the Belize Bus Association (BBA) and two major bus operators from the south, James Bus Line from Punta Gorda, and Griga Line from Dangriga. At this time, the bus operators are seeking a stay on an approved road service permit granted to Floralia to start doing runs from Dangriga to Belize City, a route that has traditionally

been the base of the two major operators. The new company, however, says that they met all requirements laid out by the Transport Board and were given approval after an arduous process.

Last week, the BBA threatened a national strike by all its members in response to the Ministry of Transport's alleged reluctance to allow an increase of bus fares to offset the high price of fuel that is currently eating away at the bottomline of the bus operators. The applicants for the judicial review are saying Floralia was given permission to operate on their traditional routes without any consultation with, or consideration of, the established bus operators.

In December 2020, the company officially started its runs from Punta Gorda to Belize City, in direct conflict with the run already assigned to James

Bus Line, one of the applicants, which is a major bus operator from the south. The claimant is asserting that the decision to grant the permits was illegal and made without the application being presented/reviewed at meetings of the Transport Board, on which the BBA says they have a representative. They even claim that interested parties were not given ample time to submit objections, since the usual steps to gazette the approval were not followed.

So, the bus operators which have applied for the judicial review are suggesting that the permits were issued to the new bus operator under the cover of darkness, and thus, in the view of the claimants, the permits are illegal and should be quashed. As mentioned, the permit for the PG to Belize City run is already in effect, but approval was given to Floralia for a run from Dangriga to Belize, which is to commence today, Monday, March 14 – but the BBA and two major operators from the south are seeking to have the court grant a stay on the second permit, and prevent that run from beginning until the case is completed.

The owner and director of Floralia, Marvin Vanzie, in a local media appearance said that, in his view, the bus operators are motivated by fear of both the competition which Floralia buses bring to the industry, and a deadline put in place by the government for traditional operators to upgrade their bus fleets sometime this year.



## Fire victim beaten by neighbors on Jasmine Street

A little after midnight on Friday, March 11, a 20-by-30-foot white cement bungalow home on Jasmine Street was damaged by fire, leaving reportedly five persons without a home.

Lincoln Vaughn, 67, was sleeping in his room when he was awakened by the flames that were inside of the home. Vaughn attempted to extinguish the flames, and during that attempt was burnt on various parts of his body, including his head, back, ears, and hands. He was able to exit the building, however, before receiving further

injuries.

Unconfirmed reports have indicated that five persons resided at the home: Vaughn, an elderly woman, and about two or three kids who were in the building at the time of the fire.

The Officer in Charge at the National Fire Service for the Belize District, Kenneth Mortis, has said that, although the cause of the fire is yet to be determined, he believes an electrical malfunction could have started the fire.

"We cannot directly say what caused the fire. The nature of this particular fire still [has] us a bit stumped, so to speak. We understand that the building did have electricity, contrary to the previous information received. We are of the opinion that fire could have started as a result of an electrical flaw; the room itself poses as a fire load, and then the fire spread from there," he noted.

Although the National Fire Service is still investigating the cause of the fire, arson hasn't been ruled out yet. Mortis pointed out, however, that it would be difficult to determine why an individual would want to commit a malicious act towards an elderly man.

"The perplexing part of this is, you know, you're looking at a 67-year-old; he should've been asleep, and we're trying to figure out if this fire was a malicious act, what would've been the motive in trying to destroy this building and almost take the life of Mr. Vaughn. We are thankful that he's up and on the way to recovery; however, that would be the final part of the puzzle that we need to put the pieces together in terms of who would want to start the fire and why," Mortis said.

After exiting from the burning structure, Vaughn was reportedly beaten by his neighbors, and suffered a broken nose as a result of that beating.

"We know that he sustained damage to the nose. I think he broke his nose, and he had swelling to his face. Again, it's a very complicated situation, because what harm or what threat could a sixty-seven-year-old individual hold to the community? I was made to understand he's well known by the neighbors in the Jasmine Street area. For whatever reason, these characters may have inflicted bodily harm on him. That is something we're trying to determine ... we spent almost a majority of Saturday morning trying to gather as much information as we possibly can. However, it's not something that anybody wants to come out and say, 'well, this is what we know'. These are the types of situation that leave us in a limbo, and we just have to try to put the pieces together and see what we can come up with. Because, at the end of the day, we still need to figure out the reason why and the motive behind the beating, so those are the two factors that are up in the air that we cannot answer," Mortis said.

Vaughn was transported to the Karl Heusner Memorial Hospital, where he was treated for his injuries and was released sometime on Sunday.

The estimated cost of the damages to the home in which he lived is yet to be determined.

# Budget presentation set for Tuesday

A special sitting of the House of Representatives, at which the 2022-2023 budget will be presented, is scheduled to take place on Tuesday, March 15, 2022. On Friday, the Office of the Clerk released a public notice announcing a reopening of one of the public galleries, with a limited seating capacity of 24 persons. Persons who desire to attend the sitting will have to ensure that they are vaccinated, have an ID card, and arrive very early, since persons will be seated on a first-come, first-served basis. Any item that is included on a list of prohibited items that has been a part of the protocol for House entry, will not be allowed inside the chambers. Any legal prohibited item will be held by officers upon inspection. And, of course, sanitization, wearing of face masks and physical distancing will all be required of those who sit inside the chambers of parliament.

Reports are that Alberto August, whom the chairman of the United Democratic Party has referred to as "UDP chairman for life", attempted, as a private citizen, to stage a protest at the steps of the National Assembly during Tuesday's House meeting, but his request for permission to do so, which was sent in a letter to Commissioner of Police Chester Williams, was reportedly rejected by the COMPOL, who reportedly cited COVID-19 regulations as the reason for his refusal to grant such a permit. Reports are that the UDP has not decided to organize any protests at this time, so his attempt was an independent effort.

Of note, it is expected that the Government of Belize will include a \$1.5 million payment to the stevedores of the Port of Belize in the budget and will thus seek to obtain parliamentary approval for the disbursement prior to the hearing of a lawsuit brought by the Port of Belize that is based on a claim that parliamentary approval was not given for the payment. That case is scheduled to go to court on Wednesday, March 16.

# Iguanas and hicatees being hunted illegally, says APAMO

The Association of Protected Areas Management Organizations (APAMO) urges Belizeans to abide by hunting regulations.

The illegal hunting of iguanas and hicatee turtles has caught the attention of the Association of Protected Areas Management Organizations (APAMO) after a video showing persons catching these animals was circulated online. APAMO highlighted the importance of these types of animals to the local ecosystem in a press release that was issued on Friday, March 11.

"The Association of Protected Areas Management Organizations (APAMO) recognizes the value of all species to the environment, and highlights that some species are endangered and critically endangered – animals that have become so rare they are in danger of becoming extinct. This includes the Iguana (Iguana iguana), who are important seed dispersers for many native plants, and the Hickatee (Dermatemys mawii), who plays a critical role in the food web, both their protection is vital to the health of the ecosystem," the press release noted.

The hunting of iguanas is traditionally done in March and April, since these are the months during which female iguanas carry their eggs. However, the season during which iguanas can be caught, has been closed since February 1, and will reopen on June 30.

The hicatee, a freshwater turtle, is another critically endangered specie that is protected under the Belize Fisheries Act, and the season for

hunting this animal—May 1 to May 31 – is also currently closed. Additional legislation prohibits possession of more than three turtles at any one time; as well as fishing for female turtles greater than 43cm (16 inches) or smaller than 38cm (14 inches) in length. It is also illegal to sell or purchase these turtles, and to transport more than five such turtles in any vehicle.

The release from APAMO concludes, "The overhunting and hunting of these species during the closed seasons will cause a drastic decline of wildlife populations. By not catching more than you are allowed and respecting closed seasons, we will help to ensure that these endangered species flourish and remain healthy for future generations. Let's do our part and report illegal activities to the Forest Department (822-1525) and the Fisheries Department (224-4552)."

our standard of living was much lower than today, in terms of living conveniences like running water inside our homes, electricity to most towns and villages, standing or ceiling fans in homes, and, especially since proliferation of pawn shops and credit stores, with most homes now having a refrigerator, a sofa set, and a butane-burning stove/oven in the kitchen. Older folks can often be heard lamenting that when we had to "back water" from the neighborhood stand pipes, or traffic our "night soil" to the canals on a daily basis, and it was all about sandpaper and varnish for the old furniture at Christmas time along with some new linoleum for the floor, we were a more peaceful and happier people. Life was hard back then, but there were very few murders; and folks could walk anywhere in town, whether day or night, without fear of being robbed or killed by an intended or stray bullet. The word "gang," when it was used in those days, only referred to groups of hardworking men at the waterfront

or in the woodcutting operations in the country, not to unemployed young men plying the illegal drug trade or engaging in violent crimes of robbery and murder. So, as a society we were poor back then, and there were problems; but crime and violence was not a major issue like it has become in the last three decades, since our annual murder rate has routinely jumped over a hundred. By international standards, we have been bordering civil war levels of murders in our once peaceful Jewel.

There has been a lot of analysis on how we got here. Right now, we have to focus on the fact that we are here, with an extremely high level of unemployment and underemployment that could in actuality be as high as 50%; and in a country where there is no provision for unemployment benefits, with the biggest part of our population being young people and growing, hungry children, it stands to reason that desperation will lead some to crime, and the "crab eena barrel" complex will instigate violence between rivals in the quest of the things that money can buy. With unemployment as high as it is, and the price of food climbing along with hikes in oil prices, things don't look too nice in the crime and violence department.

By now it is abundantly clear that our problem is bigger than the police can handle. It has been openly admitted by our local experts that the police cannot solve our crime and violence problem alone. They are indeed overwhelmed by the numbers, and have a difficult time ensuring convictions, because a traumatized citizenry are often reluctant to risk their life by giving evidence against accused individuals. And then there is the matter of corruption, high and low, that further complicates and obstructs the work of sincere law enforcement officers.

But all is not lost, Belize. While the police try to clean up their own ranks and improve on their investigation and interdiction efforts, and other agencies try to develop new areas of employment to reduce the numbers of desperate youth who are vulnerable to the lure of gangs and crime, there is something that individual citizens, especially those in the better-off financial bracket, can do. In fact, it may be a case of self-preservation for members of the more affluent section of society, those who would like to save the Jewel, rather than packing up and leaving for foreign shores. Burglar bars can only do so much, and with the continually widening gap between the masses of hungry/ desperate poor and the well-off in Belize — those comfortably cushioned bureaucrats, high-end technocrats and affluent business folks whose greatest dilemma is choosing between a new Lexus or a Prado — it is wise for those of us on the brighter side of the economy to seriously consider making some sacrifices to help the situation before it reaches a real breaking point of lawlessness in our streets, where criminal gangs brazenly rule sections of our town, as has happened in some other countries.

Gas gaan up! Diesel gaan up! Butane gaan up! Everything is going up. And the poor people bawl, "Laad, a kyan tek it no mo!"

If this Putin madness continues much longer, things may get really, really bad in our little Jewel, so that a few years from now we may be looking back with nostalgia at these "good old days."

But, Belizeans are a resilient people; and we say we are Godfearing - Christians, Muslims, Baha'i, whatever religious sect or denomination. The time is near when we may all have to join in the effort, those who have, to see that there is a means of livelihood for those who don't have. Some who have been entrusted with the authority and the competence to direct and guide the sharing of our economic pie, have focused on feathering their own nest, while the lot of the masses was left to flounder in distress and despair. Now we each have to lend a hand to bail this sinking ship, or we'll all go down with it. This is a time for sacrifice and reaching out to help our falling brethren/ sistren get back on their feet.

There is a saying, that when all else fails, "Love conquers all!" If we are to survive as a people, we Belizeans will need to begin living the true meaning of those words. When circumstances and failures have seen some of us hit rock bottom, encouraging words and prayers are fine, but just as important is the "backative". No money, no love.

## **GOB to appoint a People's Constitution Commission**



Hon. Henry Charles Usher – Minister of Political and Constitutional Reform

BELIZE CITY, Wed. Mar. 9, 2022

During a short interview last week, Minister of Public Service, Constitutional and Political Reform, Hon. Henry Charles Usher, said that the Briceño administration is in the initial stages of an effort to reform the country's current Constitution and replace outdated laws with modern and improved legislations. This is one aspect of a process started by GoB to elevate the standard of governance of the people, Minister Usher said, and he further noted that it is a long overdue exercise, since the people of Belize were never given a chance to draft their own Constitution.

"Many of the laws are antiquated. Constitution was one that we were given; it didn't out of come constitutional assembly where the people had a say in what should be in the Constitution; 40 plus years later, it is time to look at our Constitution and see how we can improve it, where we can modernize it maybe even rewrite it," Minister Usher said.

It has long been documented, that in the rush for independence, Belize modeled its Constitution off those of fellow

Commonwealth Caribbean countries, which resulted in a set of laws that was approved by the Queen of England in July 1981, despite the hostility resulting from the Heads of Agreement proposal signed in March of that year. In September 1981, our independence was granted and the Constitution approved.

Minister Usher said that they have decided to form a constitutional commission to spearhead the reformation of our current laws.

"It depends on what the constitutional commission talks about. Last week, the Ministers' strategic session, I gave a presentation to Cabinet as to the steps

going forward," Minister Usher said. He added, "When you are looking at constitutional reform, then it's looking at widespread consultation process, looking at legislation in our region, legislation throughout the world, where constitutions have been modernized or amended. Or you can take the approach just to say we just need to amend certain sections, or you can take the approach to say we need to rewrite the Constitution; we need to look at how we are governed, and I'm thinking that as the Prime Minister announced in his message after the strategic session that he is appointing a People's Constitution Commission. That commission will be looking at the very same question that we are asking today." Minister Usher said.

Improving our legal system and modernizing legislation to bring the country in line with global legal trends are some of the major tasks the commission will have to tackle.

"The commission will be looking at this very same question that we are asking today—how can we improve the system that we have, that we have inherited from the UK and how can we modernize our laws to better serve our people," Minister Usher said.

## Worst thing in that video was gang

The clip with the uncle or older brother giving the kid a drink and getting him to express allegiance to a gang caused dismay across the nation last week. I cast some blame for what happened there on unrealistic people who waste time and diffuse our energies in a way that makes it impossible for us to address our problems. It's hard to get the job done when otherwise intelligent people are vociferously promoting wild agendas, excuse me.

There were two things terribly wrong with the story: one, the child was way too young to be near strong drink, and two, the lesson from the elder, that "we da Gaza [gang]" or some like craziness, that was rank depressing.

There are some guys who hurry, hurry take their boys to the brothel to introduce them to sex. That's crazy. The boy will find it, and when he does, pray that he doesn't make it all there is to his life. Stop introducing kids and youth to adult things.

I believe the drink the elder gave the kid to sip had some alcoholic thing that tasted nice; some alcoholic drinks are as soft as fruit juice on the taste buds, and when we see the kid drinking a liquid from what looked like a rum bottle, that was probably water.

Parents shouldn't encourage children to drink rum. The elder deserves a severe reprimand for that. But let's not even think about jail for that sip from a cup. Get real. The old Woodward's Gripe Water had 3.6% alcohol. *BlackTailNYC*, in the story "Do Kids in Germany drink beer?", said a 14-year-old minor in Germany can drink wine or beer if they are with a "custodial person", and at the age of 16 they can drink wine and beer unaccompanied. That pic with the little fellow and his yohoho bottle of rum, haha, I saw myself with my younger brother, Ronald, and our cousin David, a rum bottle filled with a cocoa drink, our arms draped around each other's shoulders, staggering about as if we were in the Tenth Parade, and chanting, "we three da bum bali, we beat up anybody!" No adult set us up to play drunk. Look, if you wanted to block little kids from seeing inebriation you'd have to shut down the movies too. Oh, Ron doesn't drink, Dave takes a drink but he's no alcoholic.

No, no, no, don't encourage a kid to drink! What I thought was really disappointing was the gang lesson the elder was giving the kid. An adult has to be daft or chaansi to encourage a kid to see some virtue there. It's tricky turf just to ask kids to support the team you play for or ride with. But maybe we can't blame that irresponsible dude, because the responsible dudes are teaching little kids all kinds of things these days. Thanks to adults, there's no age of innocence anymore.

These folk and their obsession that alcohol is a terrible thing for grown people, they need to refocus. Tell the truth about alcohol; a little of it is good for most people. One solid bit of advice for young adults is that they make sure they are in the company of true friends when they're drinking, the kind of friend that will protect you soh yu doant imbibe too much, an du fool. Once I went out with some friends and when they got a little buzz they all wanted to pik fight. I didn't go out with them again. Don't drink with friends who get violent or overly stupid.

Protecting children must be our priority. We desperately need to work together. Marijuana is about to be freed up some more. We haven't reached there, and stories abound about adults giving children weed to smoke, weed in fudge and that kind



## "Sin dinero, no hay amor"; un tiempo para el sacrificio

"No podemos hacer el amor sin dinero. No podemos hacer el amor con el estómago hambriento. Johnny, serás el único con el que esté soñando; eres mi tórtola; pero, ¡sin dinero, no hay amor!" - The Mighty Sparrow

Belize, nuestro amado país, es una hermosa Joya, y nuestra Constitución se jacta de que somos una nación con un pueblo temeroso de Dios que fue bendecido con la bondad de Dios al heredar estas preciosas 8867 millas cuadradas de tierra y mar para llamar nuestro hogar. Pero estos no son los mejores tiempos en Belize; y todo apunta a que los tiempos se pondrán aún más difíciles. Acabábamos de comenzar a sentir que habíamos sobrevivido al estrangulamiento económico que nos provocó el Covid-19 en los últimos dos años; pero como alguien ahogándose que jadea por aire, mientras nuestras cabezas parecían estar saliendo del agua, hay nuevos obstáculos que buscan empujarnos hacia abajo nuevamente. El toque de queda inducido por Covid acababa de levantarse y el mandato de máscarillas faciales se redujo un poco, las fronteras se reabrieron y se permitió que más fanáticos regresaran a los estadios deportivos; la vida comenzaba a volver a la normalidad de manera continua, pero todas nuestras grandes esperanzas se desvanecieron cuando, al otro lado del océano, Rusia invadió Ucrania, y ahora es posible que el mundo entero esté cayendo bajo otro tipo de pandemia. Y, aunque solo podemos ver en la televisión la devastación, la destrucción y las bajas causadas por los misiles rusos que apuntan a ciudades y pueblos ucranianos, aquí en Belize, al igual que países de todo el mundo, ya estamos sintiendo los efectos del aumento de los precios del petróleo. Al igual que el petróleo, también aumentan los precios de la mayoría de los demás productos básicos, especialmente los artículos importados; y si los tiempos han sido difíciles para nuestros muchos ciudadanos desempleados, ahora será aún más difícil. De hecho, si esta guerra no termina rápidamente, como pueblo, es posible que debamos esforzarnos por aprender el verdadero significado del sacrificio que es el enfoque anual entre los cristianos en esta época del año.

Es un hecho indiscutible que el crimen y la violencia no estaban ni cerca del nivel actual en nuestro país en un momento en que nuestro nivel de vida era mucho más bajo que el actual, en términos de comodidades como agua corriente dentro de nuestros hogares, electricidad en la mayoría de los pueblos y aldeas, ventiladores de pie o de techo en los hogares y, especialmente desde la proliferación de casas de empeño y tiendas de crédito, la mayoría de los hogares ahora tienen un refrigerador, un juego de sofás y una estufa/horno de butano en la cocina. A menudo se puede escuchar a las personas mayores lamentándose de que cuando teníamos que cargar agua del chorro público del vecindario, o traficar nuestro "desecho nocturno" a los canales a diario, y todo se trataba de papel de lija y barniz para los muebles viejos en la epoca de Navidad junto con un poco de linóleo nuevo para el piso, éramos un pueblo más pacífico y feliz. La vida era dura en ese entonces, pero había muy pocos asesinatos; y la gente podía caminar por cualquier lugar de la ciudad, ya fuera de día o de noche, sin temor a que les robaran o los mataran con una bala perdida o intencionada. La palabra "pandilla", cuando se usaba en esos días, solo se refería a grupos de estibadores o aquellos en las operaciones de tala de árboles en el país, no a jóvenes desempleados que practicaban el tráfico ilegal de drogas o cometían delitos violentos de robo y asesinato. Por lo tanto, como sociedad, éramos pobres en ese entonces y había problemas; pero el crimen y la violencia no eran un problema tan importante como lo han sido en las últimas tres décadas, ya que nuestra tasa anual de homicidios ha saltado rutinariamente a más de cien. Según los estándares internacionales, hemos bordeado niveles de guerra civil en cuanto a asesinatos en nuestra Joya que alguna vez fue pacífica.

Ha habido mucho análisis sobre cómo llegamos aquí. En este momento, tenemos que centrarnos en el hecho de que estamos aquí, con un nivel extremadamente alto de desempleo y subempleo que en realidad podría acercarse más al 50%; y en un país donde no hay disposiciones para las prestaciones por desempleo, con la mayor parte de nuestra población formada por jóvenes y niños hambrientos y en crecimiento, es lógico que la desesperación lleve a algunos a la delincuencia, y el complejo del "cangrejos en barril" instigará la violencia entre rivales en la búsqueda de las cosas que el dinero puede comprar. Con el desempleo tan alto y el precio de los alimentos subiendo junto con los precios del petróleo, las cosas no se ven muy bien en el departamento de crimen y violencia.

A estas alturas, está muy claro que nuestro problema es más grande de lo que la policía puede manejar. Nuestros expertos locales han admitido abiertamente que la policía no puede resolver nuestro problema de delincuencia y violencia por sí sola. De hecho, están abrumados por los números y tienen dificultades para garantizar condenas, porque una ciudadanía traumatizada a menudo se muestra reacia a arriesgar su vida al prestar testimonio contra las personas acusadas. Y luego está el asunto de la corrupción, en lo alto y bajo, que complica y obstruye aún más el trabajo de los sinceros agentes de la ley.

Pero no todo está perdido, Belize. Mientras la policía trata de limpiar sus propias filas y mejorar sus esfuerzos de investigación e interdicción, y otras agencias intentan desarrollar nuevas áreas de empleo para reducir el número de jóvenes desesperados que son vulnerables a la tentación de las pandillas y el crimen, hay algo que pueden hacer los ciudadanos individuales, especialmente aquellos en el nivel financiero más acomodado. De hecho, puede ser un caso de autopreservación para los miembros de la sección más rica de la sociedad, aquellos a quienes les gustaría salvar la Joya, en lugar de hacer las maletas y marcharse a costas extranjeras. Las barras antirrobo solo pueden hacer tanto, y con la brecha cada vez mayor entre las masas de hambrientos/pobres desesperados y los acomodados en Belize, esos burócratas cómodamente protegidos, tecnócratas de alto nivel y empresarios ricos cuyo mayor dilema es elegir entre un nuevo Lexus o un Prado: es prudente que aquellos de nosotros que estamos en el lado más brillante de la economía consideremos seriamente hacer algunos sacrificios para ayudar a la situación antes de que llegue a un punto de verdadera ruptura de anarquía en nuestras calles, donde las bandas criminales gobiernan descaradamente sectores de nuestra ciudad, como ha sucedido en algunos otros países.

¡Subió la gasolina! ¡Subió el Diesel! ¡Subió el butano! Todo está subiendo. Y la pobre gente grita: "¡Dios, ya no lo soporto!" Si esta locura de Putin continúa por mucho más tiempo, las cosas pueden ponerse muy, muy mal en nuestra pequeña Joya, de modo que dentro de unos años podamos mirar hacia atrás

con nostalgia a estos "buenos viejos tiempos".

Pero, los beliceños son un pueblo resistente; y decimos que somos temerosos de Dios: cristianos, musulmanes, bahá'ís, de cualquier secta o denominación religiosa. Se acerca el momento en que quizás todos tengamos que unirnos al esfuerzo, los que tienen, para ver que haya un medio de vida para los que no tienen. Algunos a los que se les ha confiado la autoridad y la competencia para dirigir y guiar el reparto de nuestro pastel económico, se han centrado en llenar su propio nido, mientras que la suerte de las masas se ha dejado a merced de la angustia y la desesperación. Ahora cada uno de nosotros tiene que dar una mano para rescatar este barco que se hunde, o todos nos hundiremos con él. Este es un momento para el sacrificio y para ayudar a nuestros hermanos/hermanas hundiéndose a recuperarse.

Hay un dicho que dice que cuando todo lo demás falla, "¡El amor lo conquista todo!" Si queremos sobrevivir como pueblo, los beliceños necesitaremos comenzar a vivir el verdadero significado de esas palabras. Cuando las circunstancias y los fracasos han hecho que algunos de nosotros toquemos fondo, las palabras de aliento y las oraciones están bien, pero igual de importante es el "refuerzo". Sin dinero, no hay amor.

There are at least two generations of Belizeans, which is to say, the post-independence/television/phone generations, which would have almost no idea of what is really involved in the present war between the aggressor Russia and the underdog Ukraine.

Insofar as foreign policy is concerned, Belize is in a somewhat tricky spot, because geopolitical and other circumstances have dictated that we have no choice but to be in favor of the United States where foreign policy issues are concerned.

The tricky part of that is that the neighbor republic which is claiming our Belizean territory is a long-time and favorite ally of these same United States. Ergo, we may have to look elsewhere than Washington if and when there is conflict between Guatemala City and Belmopan. I'm just saying.

Belizeans are a pragmatic people, it does appear. We are not passionate, combative or heroic like the Cubans, who have withstood more than sixty years of terrible embargo pressure from these same United States.

Anyway, back to Russia and Ukraine. Please understand, I am not claiming to be any kind of expert here. But because I am a member of Belize's post-World War II generation, and because those of that generation who did tertiary work in education had to do a lot of reading, we have a more comprehensive sense of the Russia-Ukraine conflict than our younger people.

When the Russian Revolution occurred in 1917, a revolt of the working classes overthrew the czarist monarchy and the aristocratic classes. The new system was known as communism. It was officially atheistic, and favored the lower classes. Industrially, Russia, a feudal society for centuries, began to develop quite rapidly.

Russia after 1917 was known as the Soviet Union, or the Union of Soviet Socialist Republics (USSR). It included the Ukraine, Crimea, Belarus, and several other nations which became independent in 1991 after the Soviet Union collapsed, which is a long story in itself. The collapse of the communist Soviet Union was considered a great victory for the capitalist United States.

The core Russia, and the Ukraine which Vladimir Putin is now attempting to subjugate, are very wealthy areas of planet earth. They produce much of the world's wheat, oil, and natural gas. This war is about power. If Russia absorbs the Ukraine, Russia can look the United States and China in the eye. Perhaps the Russians already can, on the basis of their plethora of nuclear missiles, to which Putin is referring from time to time.

It appears to me that world power has recently been shifting from the West to the East. After World War II (1939-1945), the United States began emerging as a superpower, while the United Kingdom remained an imperial force, considered by most as the victors in the war. These are Western powers.

Adolf Hitler's Germany, the leader of the Axis powers (Japan and Italy) which fought against the British, the Americans, and the French, had been shattered and divided into two parts -- West Germany, controlled by the Americans, and East Germany, run by the Russians.

China and India, nation-entities, were nonentities at that time. But India, a British fiefdom for centuries, soon became independent and began growing rapidly. China was taken over by Mao's Communist Revolution in 1949, and began growing perhaps even more rapidly.

And my opinion is that it was Russia, sacrificing 26 or 27 million lives, which had really won World War II, even though it was the Americans who ended up defeating the Russians (1991) in the so-called Cold War which followed World War II.

The one thing about war is that the concept of "good guys, bad guys" does not stand up to scholarly analysis. War is about power and survival. War is hell. Human beings, at the end of the day, are just like animals.

The singular aspect of the present Russia-Ukraine conflict is that there is a reality which goes all the way back to when Hitler's fascist Germany invaded Stalin's communist Russia in 1941, a couple years after the two nations had signed a nonaggression pact. The local cable companies have closed down Russian television transmission here, but the fact of the matter is that there is a powerful element in the Ukraine which the Russians consider German and pro-Nazi in nature. Russia is alarmed by Ukraine's attempts to join the North Atlantic Treaty Organization (NATO), which would enable/force Western nations to come to Ukraine's military assistance if it is attacked. There are complications here.

There is clear pressure on Belizeans to look inwards for survival in the coming months and years. During World War II, our ancestors had to become more self-reliant, because our imports from Great Britain were being interrupted by German submarines. A similar situation is developing now, in that imports will become increasingly expensive when they are not downright unobtainable.

I would like to close with a brief look at the racial hierarchy across the Atlantic Ocean where people who look white are now fighting with other people who look white. We Belizeans are not used to that. Adolf Hitler, who started World War II, was driven by racial theories. He conceived of an ideal, superior, racial phenotype which would feature blonde hair and blue eyes. This appears to me to be the Scandinavian type, found in Sweden, Norway, Denmark, and so on. Such a type is mixed up with the Anglo-Saxon group, which dominates Great Britain, Germany, and the Netherlands. The Spaniards, Portuguese, and even the French, are considered too "Latinized" to rank along with the Scandinavians. Such is the world of racial purists.

The Russians, and other Eastern Europeans, are considered Slavic; they are considered inferior by the Germans and other NATO members. Other people who live in so-called Eastern Europe, like Poles and Hungarians, are also considered Slavic. It is all quite complicated, beloved.

The one thing we know for sure is that we people of color, so to speak, are at the bottom of the totem pole. We have been offered a peaceful Jesus as a palliative for many centuries, ever since we were brutally subjugated by Europe. But now these people who offered us Christ have built terrible weapons which can destroy the planet which Christ's Father created. How weird it all is! It isn't worth it to become so scared any more. Man has become God.

# FROM THE PUBLISHER, en Especial

Hay al menos dos generaciones de beliceños, es decir, las generaciones posteriores a la independencia/ televisión/teléfono, que casi no tendrían idea de lo que realmente está involucrado en la guerra actual entre el agresor Rusia y la Ucrania desvalida.

En lo que respecta a la política exterior, Belize se encuentra en una situación algo delicada, porque las circunstancias geopolíticas y de otro tipo han dictado que no tenemos más remedio que estar a favor de Estados Unidos en lo que respecta a cuestiones de política exterior.

La parte difícil de eso es que la república vecina que reclama nuestro territorio beliceño es un aliado favorito desde hace mucho tiempo de este mismo Estados Unidos. Ergo, es posible que tengamos que buscar en otro lugar que no sea Washington si hay un conflicto entre la Ciudad de Guatemala y Belmopán. Sólo digo.

Parece que los beliceños son un pueblo pragmático. No somos apasionados, combativos ni heroicos como los cubanos, que han soportado más de sesenta años de terribles presiones de embargo por parte de este mismo Estados Unidos.

De todos modos, volvamos a Rusia y Ucrania. Por favor, comprendan que no pretendo ser ningún tipo de experto aquí. Pero debido a que soy miembro de la generación de Belize posterior a la Segunda Guerra Mundial, y debido a que aquellos de esa generación que hicieron un trabajo terciario en educación tuvieron que leer mucho, tenemos un sentido más completo del conflicto Rusia-Ucrania que nuestra gente más joven.

Cuando se produjo la Revolución Rusa en 1917, una revuelta de las clases trabajadoras derrocó a la monarquía zarista y a las clases aristocráticas. El nuevo sistema se conoció como comunismo. Era oficialmente ateo y favorecía a las clases bajas. Industrialmente, Rusia, una sociedad feudal durante siglos, comenzó a desarrollarse con bastante rapidez.

Rusia después de 1917 se conocía como la Unión Soviética o la Unión de Repúblicas Socialistas Soviéticas (URSS). Incluía a Ucrania, Crimea, Bielorrusia y varias otras naciones que se independizaron en 1991 después del colapso de la Unión Soviética, lo cual es una larga historia en sí misma. El colapso de la Unión Soviética comunista fue considerado una gran victoria para Estados Unidos capitalista.

La Rusia misma y Ucrania, que Vladimir Putin ahora está tratando de subyugar, son áreas muy ricas del planeta tierra. Producen gran parte del trigo, el petróleo y el gas natural del mundo. Esta guerra se trata de poder. Si Rusia absorbe a Ucrania, Rusia puede mirar a Estados Unidos y China a los ojos. Tal vez los rusos ya puedan hacerlo, sobre la base de su plétora de misiles nucleares, a los que Putin se refiere de vez en cuando.

Me parece que el poder mundial se ha estado desplazando recientemente de Occidente a Oriente. Después de la Segunda Guerra Mundial (1939-1945), Estados Unidos comenzó a emerger como una superpotencia, mientras que el Reino Unido siguió siendo una fuerza imperial, considerada por la mayoría como vencedora de la guerra. Estas son las potencias occidentales.

La Alemania de Adolf Hitler, el líder de las potencias del Eje (Japón e Italia) que lucharon contra los británicos, los estadounidenses y los franceses, había sido destrozada y dividida en dos partes: Alemania Occidental, controlada por los estadounidenses, y Alemania Oriental, dirigida por los rusos.

China e India, entidades-nación, eran minucias en ese momento. Pero India, un feudo británico durante siglos, pronto se independizó y comenzó a crecer rápidamente. China fue absorbida por la Revolución Comunista de Mao en 1949 y comenzó a crecer quizás incluso más rápidamente.

Y mi opinión es que fue Rusia, sacrificando 26 o 27 millones de vidas, la que realmente ganó la Segunda Guerra Mundial, a pesar de que fueron los estadounidenses quienes terminaron venciendo a los rusos (1991) en la llamada Guerra Fría que siguió a la Segunda Guerra Mundial.

Lo único de la guerra es que el concepto de "chicos buenos, chicos malos" no resiste el análisis académico. La guerra se trata de poder y supervivencia. La guerra es el infierno. Los seres humanos, al final del día, son como animales.

El aspecto singular del actual conflicto Rusia-Ucrania es que existe una realidad que se remonta a cuando la Alemania fascista de Hitler invadió la Rusia comunista de Stalin en 1941, un par de años después de que las dos naciones firmaran un pacto de no agresión. Las compañías de cable

locales han cerrado la transmisión de televisión rusa aquí, pero el hecho es que hay un elemento poderoso en Ucrania que los rusos consideran de naturaleza alemana y pro-nazi. Rusia está alarmada por los intentos de Ucrania de unirse a la Organización del Tratado del Atlántico Norte (OTAN), lo que permitiría u obligaría a las naciones occidentales a acudir en ayuda militar de Ucrania si es atacada. Aquí hay complicaciones.

Existe una clara presión sobre los beliceños para que miren hacia adentro en busca de supervivencia en los próximos meses y años. Durante la Segunda Guerra Mundial, nuestros antepasados tuvieron que volverse más autosuficientes, porque los submarinos alemanes estaban interrumpiendo nuestras importaciones desde Gran Bretaña. Una situación similar se está desarrollando ahora, en el sentido de que las importaciones se volverán cada vez más caras cuando no sean del todo imposibles de obtener.

Me gustaría cerrar con una breve mirada a la jerarquía racial al otro lado del Océano Atlántico, donde las personas que se ven blancas ahora luchan con otras personas que se ven blancas. Los beliceños no estamos acostumbrados a eso. Adolf Hitler, quien inició la Segunda Guerra Mundial, fue impulsado por teorías raciales. Concibió un fenotipo racial ideal, superior, que presentaría cabello rubio y ojos azules. Me parece que es del tipo escandinavo, que se encuentra en Suecia, Noruega, Dinamarca, etc. Tal tipo se mezcla con el grupo anglosajón, que domina Gran Bretaña, Alemania y los Países Bajos. Los españoles, portugueses e incluso los franceses considerados demasiado "latinizados" para clasificarse junto con los escandinavos. Así es el mundo de los puristas raciales.

Los rusos y otros europeos del este se consideran eslavos; son considerados inferiores por los alemanes y otros miembros de la OTAN. Otras personas que viven en la llamada Europa del Este, como los polacos y los húngaros, también se consideran eslavos. Es todo bastante complicado, queridos.

Lo único que sabemos con certeza es que nosotros las personas de color, por así decirlo, estamos en la parte inferior del tótem. Se nos ha ofrecido un Jesús pacífico como paliativo durante muchos siglos, desde que fuimos brutalmente subyugados por Europa. ## Peru's 'catastrophe' oil spill slams small-scale fishermen

The large spill is having a devastating effect on 'poverty line' fishermen who depend on small daily catches to make a living

PERU, Mar. 14, 2022 (Aljazeera) A huge recent oil spill in Peru which the government called an ecological "catastrophe" has wreaked havoc on the lives and livelihoods of many fishermen who rely on the small amounts of fish they harvest close to the shore for their daily income.

Walter de la Cruz scrambled down a large sand dune in the fog to reach a rock overlooking the Pacific Ocean, where he has fished for 30 years. He cast a hook into the waters off Peru's coast several times, with no luck. One attempt yielded a piece of plastic stained with oil.

De la Cruz, 60, is one of more than 2,500 fishermen whose livelihoods have been cast into doubt as a result of the large crude-oil spill at the Spanish-owned Repsol oil refinery on January 15.

"We are desperate," he said, counting on his fingers the debts that overwhelm him, including a bank loan, bills for water, electricity, gas, and school supplies for his two grandchildren.

The spill has had a devastating effect on fishermen who are among the most economically vulnerable in Peru. They harvest small amounts of fish very close to the coast, sometimes from small boats and sometimes from the shore, said Juan Carlos Sueiro, an expert on the economics of fishing with the international conservation group Oceana.

"They are on the poverty line. Their income varies from day to day," he said.

Peru has characterised the spill of 11,900 barrels in front of a Repsol

refinery as its "worst ecological disaster." The spill happened when the Mare Doricum, an Italian-flagged tanker, was unloading oil at the La Pampilla refinery, just off Peru's coast north of the capital. The ship's captain told the South American country's Congress that oil spilled into the ocean for at least eight minutes.

A report by United Nations experts estimates it involved about 2,100 tonnes of crude, well above the 700 tonnes the International Tanker Owners Pollution Federation Limited considers the threshold for a large spill — and an unprecedented amount for the type of crude that leaked. The oil was extracted from Buzios, the world's largest deep-water oil field and the most productive in Brazil.

Peru — which has a vast informal economy — does not have exact data on the number of fishermen affected, or of the people on the docks and ports who depend on the fishing industry, including restaurants, food vendors, and those who rent sun umbrellas or boats.

De la Cruz said he knew immediately that the oil would halt for the first time the activity carried out for centuries on Peru's Pacific coast.

"I saw the fruits of my livelihood destroyed," he said. "It's like if you have a store and someone comes and sets it on fire."

# DFC workers reject proposed salary cut

This past Friday, office workers at Development Finance Corporation (DFC) branches across six districts of the country staged a protest during their lunch break in response to a proposed 10% pay cut. The workers, many of whom wore black, stood in front of their branch buildings and reportedly sang the union song, "Solidarity Forever".

While the Government of Belize recently announced the full reinstatement of public servants' salaries come July 1, the unionized workers of DFC have been facing off with DFC management for the past

eight months in an effort to avoid having their own salaries cut. Since June of 2021, the workers, represented by the Christian Workers Union, have been attempting to negotiate a collective bargaining agreement while seeking to avoid a 10% pay cut that has been proposed as one of the terms of that agreement.

This isn't the first time that DFC workers have stood up in protest. Back in 2006, the unionized workers staged a walk-off in response to the Government's decision to allow write-offs for holders of housing and student loans in the face of DFC management's decision to hold off on discussions regarding workers' wages and benefits.

BELIZE CITY, Mon. Mar. 14, 2022 A woman who resided in the Green

Hills area of Spanish Lookout in the Cayo District lost her life as a result of a road traffic accident that occurred on Saturday, March 12.

Maria Norma Cedillo, 38, a Belizean housewife, along with her 8-year-old child, was traveling on her motorbike toward Green Hills along a route from Spanish Lookout when the motorcycle collided with a 1997 4Runner, which was being driven by Jesson Geovanny Guevara Perez, 24, a Guatemalan laborer of Bullet Tree Falls, Cayo District, who was heading from Aguacate Falls towards Spanish Lookout Village.

According to initial police reports, Perez was driving his vehicle on the Aguacate Lagoon Road, 1st Avenue 70th Street, in Spanish Lookout, in a direction opposite to the one in which Cedillo was heading, when he allegedly miscalculated as he was swerving along a curve, which caused him to collide head-on into Cedillo's motorcycle. Cedillo was severely injured and died shortly after.

Her 8-year-old child, who was injured in the head and body, was transported to the Western Regional Hospital and is listed in a critical condition. Also, the lifeless

body of Maria Cedillo was transported to the San Ignacio Hospital, where she was pronounced dead on arrival.

"I know that Mister Perez was immediately detained. I cannot say whether he has been charged as yet, but I know police officers already issued him with a Notice of Intended Prosecution, and the necessary blood and urine samples were requested. Whether he complies or not, it will be sent to us today," said Communications Director of the Belize Police Department, ASP Fitzroy Yearwood at a weekly police press briefing. It has been reported that Perez's vehicle was damaged on the front driver's side.

So far, it is unclear whether Cedillo or her child was wearing a helmet at the time of the accident.

While conducting a search in the Back-A-Town area in Southside Belize City on Thursday, March 10, police discovered a MAC-10 fully automatic pistol.

"Our aggressive operation in the city geared at targeting gang members and their bases continues. Just moments ago, our team in the Back-A-Town area found this firearm. For those who don't know, this is a Mac-10 fully automatic weapon. It shoots 9mm rounds and is classified as one of the

deadliest short [arms]," stated Commissioner of Police, Chester Williams.

The police also seized another firearm from the BLC (Backa Lands Crips) gang that operates in the



vicinity of Police Street.

The police have been actively conducting such operations in response to a spate of shootings and murders that have recently occurred in Belize City.

Rodwell Ferguson, made some recommendations that the BBA views as promising, and they are now going back to their membership to discuss those recommendations and chart a path forward.

"It's all depending on when we go back to our membership -- but as a responsible association, if we are dialoguing and we are seeing where we are going, we are seeing our headway then, as the president, I would tell my operators to hold back and see, you know. Let diplomacy actually have its way," said Shaw.

The stance that is currently being taken is very different from the position of the BBA on Thursday last week, when the secretary of the BBA, Ewart Metzgen, said that Minister Rodwell Ferguson flatly denied the association's request for some form of relief for bus operators, who have been absorbing substantial increases in the price of fuel and in overhead expenses for years, without raising

bus fares.

Shaw said that they are acting in good faith—on the basis of government's assurance that it will not take more than two weeks to return to the BBA with a final decision, and while the details of the recommendations are still unknown, Shaw said that both the issue of fuel prices and the increase of the standard bus fare is to be discussed by Cabinet.

A meeting was held today for the parties to complete the discussion on all the details of the bus operators' demands and the recommendations from the Ministry.

"I'll be more satisfied when I see it materialize, but as I said, it's a step in the right direction, and actually, they are telling us basically what we want to hear, but we want to know that it'll materialize," Shaw said.

He said that they will get in contact with their members for their feedback on the advancements made in the recent meetings and says they will utilize their online chat group to do so, since getting all their members in one physical location is sometimes difficult.

The threat of a nationwide bus strike is, for all intents and purposes, off the table for now, following the sit-down between the BBA executive and the government of Belize. The feedback from the membership—bus operators on the road every day who are shouldering the brunt of the fuel price increases and rising cost of living—will determine whether the recommendations are accepted.

stevedores for the financial losses and hardships they experienced during the 20-plus years since the privatization of the port. At the last hearing, Justice Shoman granted an interim injunction to freeze the CWU's account to prevent the issuance of the funds paid by GoB to the stevedores, but the president of the union, Evan "Mose" Hyde, had indicated that they experiencing blockages of other bank accounts belonging to the union and its members that was amounting to a financial blackout as a result of the order.

The BNTU, after discussion with the CWU and its members, has stated that the case "amounts to no less than a bold attack on Trade Unionism, as a whole, in our country." The BNTU is thus asking all unions in the country to consider the implications that the case brought by the Port of Belize Ltd. (seen by many Belizeans as a vicious attempt by an employer to cause economic pain to workers) can have on unionism in Belize and to join them in boycotting the Belize Bank.

"After in-depth discussions were complete, our Council unanimously voted that we stand in full support and solidary with our sister Union, the CWU, and in doing so, our action, in the first instance, will be to withdraw all our Union's accounts, those of both national and local branches, from the Belize Bank Limited," a release from the BNTU states.

"Through this medium, we also wish to call on all other sister Unions, under the Trade Union Congress of Belize, to fully consider the dire implication that the court

case against the CWU can have on all of us, as Trade Unions. The trumpet call of unionism is, 'Touch One, Touch ALL," and therefore the time to come to the aid of our sister union is NOW!!!" the release, which was sent from the BNTU's Finance Department, states.

But the BNTU is going even further. It will be engaging in further discussions with its wider membership within the coming weeks, in an effort to lay the groundwork for what could be further action on the part of the union.

In its press release the union states, "The Trade Union movement is arguably one of the most important pillars in our democracy as a young nation, and we will not stand idly by and allow any individual, or entity to trample or try to destroy its existence"

When interviewed some weeks ago, Hector Guerra, one of the Port of Belize's attorneys, had pointed to the lack of parliamentary approval prior to the government's decision to enter the agreement with the CWU and disburse payment as the reason for the lawsuit. He said that if approval is granted, they would have to revisit the action. The Prime Minister, Hon. John Briceño, had earlier said that the government will seek the requisite parliamentary approval during the presentation of the budget for the new fiscal year at the next meeting of the House of Representatives, which is scheduled for tomorrow, Tuesday, March 15. The PBL case that seeks to block the \$1.5 million disbursement to the stevedores goes back to court on Wednesday, March 16. The interim injunction is set to expire at 5:00 p.m. on that day.

following the resignation of former senator Osmany Salas who has gone on to work with the World Wildlife Fund. Chanona, who has been the acting Vice President of Oceana Belize since January 2014 and is also a former journalist, received 21 votes out of a possible 31, while candidate Dr. Sharmayne Saunders, nominated by the Turneffe Atoll Sustainability Association and Haven House, received 10 votes. Chanona was nominated by the National Garifuna Council, the Belize Tourism Industry Association, and the Belize Audubon Society.

"I commit to honouring the vote of confidence that I've received today through hard work and inclusive representation...The contributions of the NGO community to national development via multiple sectors is tremendous, and their voices deserve to be amplified in the corridors of power in support of informed decision making and good governance," said the senator-elect at Friday's BNN meeting.

Upon being officially sworn in at the next sitting of the Senate, which will take place later this month, Janelle Chanona will become the fifth woman senator. Chanona has stated that while the idea of playing a role in increasing the female representation in the Senate is certainly uplifting, she plans to continue to ensure that such representation is not merely a form of tokenism and hopes that, by means of her new position, she will act as a voice that amplifies the needs of others.

"I certainly was heartened by the fact that regardless of how the pendulum swung today, that the Senate would have gained additional female representation. I don't see where that has ever hurt in terms of having a female voice and representation in any circle in any quarters, so I am proud to be part of that number," she stated.

Administration stepped forward to legalizing marijuana, here came the drug planes! As if Belize sent them a coded message!" the association added.

Of important note, however, is the fact that Belize has long been a transshipment point for the movement of drugs, particularly cocaine, from South America to the United States, and suspected drug planes have been landing in the country long before the decriminalization of marijuana, which occurred in November of 2017

The NEAB previously criticized Prime Minister Hon. John Briceño in October of 2018 when he was Leader of the Opposition after he called for the full legalization of marijuana. Back then, the organization attributed the rise in crime and violence, specifically the murders of young men in Belize City, to the recent decriminalization of cannabis. And in October 2020, Minister of Home

Affairs and New Growth Industries, Hon. Kareem Musa, received backlash from the association for his comments regarding fully embracing the marijuana industry in Belize.

The NEAB has also previously stated that the legalization of weed could potentially further threaten the standing of the country's banking sector, which already has experienced a destabilization of its linkages with international banks.

"If this bill passes, we can expect increasingly serious harm to come to our youth, business, tourism and international banking relationships. With all the human and natural resources God has given to Belize, we have great potential for recovery and prosperity without resorting to the inevitably demoralizing and corrupting marijuana business," stated the press release, which then went on to say that, since the country's economy is already on the rebound, the government should aim to take what the NEAB calls a "healthy and more beneficial course."

# Child Protective Services takes child seen drinking in video from mother

boy being coaxed into drinking what appears to be rum have resulted in the boy being taken away from his mother by Child Protective Services. When the videos surfaced online last week, both the Police Department and the Department of Human Services had asked for the public's assistance in locating the boy as well as his caretakers. In one of the videos, the boy can be seen sitting on a bicycle while the male person filming the video encourages him to take a shot from a "Badman" bottle which contained a clear liquid. A woman's voice can also be heard telling the boy, "yuh have to tek a shot". In another video, the man behind the camera gives the boy a cup of what appears to be liquor and tells him to take a shot after instructing him to shout expletives and to pledge support for a local gang. According to the boy's mother, who subsequently spoke with local media, the man who filmed the video is the boy's older cousin.

"He was at home with his father," she said, and she explained to local

reporters that at some point, some of the boy's cousins came by and took him to "hang out" with them. The mother, who was at work during the incident, only found out about the videos after they had already made their way onto social media. Shortly after that, personnel from Child Protective Services came by and took her son away.

"We done give up the persons' name already. We done suspect da who do it," said the mother, who also said that when she saw the video, she couldn't believe what they were doing to her child.

In response to the videos, Commissioner of Police Chester Williams issued a statement, calling the act an outright case of child abuse.

"This clearly shows that some of us have certainly lost their sense of humanity, caring, and nurturing of our children," wrote the Police Commissioner on Facebook. He went on to request that anyone who knows the child or his parents contact him directly. Since then, the boy's parents have turned over the names of the relatives whose voices were heard in the videos to the police.
