PM Briceño presents \$1.3 billion budget

The largest budget in Belize's history is saddled with a correspondingly large overall deficit of 97.6 million dollars; funding from Taiwan is to cover the gap. The House debates the 2022-2023 budget in just a few days.



In an almost two-hour-long presentation in the House of Representatives on Tuesday, Prime Minister Hon. John Briceno outlined specific aspects of the General Revenue Appropriation Bill (the budget) for 2022-2023 and reflected on the above-average performance of the economy over the past year—highlighting a marked economic rebound, but warning of dark clouds on the horizon.

"My report today will show that our first Budget exceeded all performance markers and that the new Budget, proposed at \$1.361 billion, will be the largest spending and investment Budget in the history of our country," Hon. Briceño noted in his presentation.

But the government must remain cautious from both a revenue and spending standpoint, said the Prime Minister. The total revenue and grants to be received by GoB is projected in the new budget to be \$1.26 billion, with a recurrent revenue of \$1.22

billion—about 7.5% more than what was projected in the 2021 budget, which saw a 19% increase in the amount of funds entering the country's coffers due to an additional \$50 million in grants and \$5.36 million in capital revenue—resulting in total revenue and grants of



PM Briceño: The Principality of Islandia is "schupid"

When news broke that investors bought an island in Belize to start their own country, it raised more than a few eyebrows. The issue of the Principality of Islandia, however, is as complex as it is controversial.

When the news broke that a group of investors had purchased Coffee Caye, located 15 minutes off the coast of Belize City, and were proclaiming it their own sovereign state called "The Principality of Islandia", it quickly garnered much attention and criticism—from Belizeans near and far, with the Prime Minister sharing some of his own thoughts on the issue this past Tuesday. After being asked by local reporters, following the budget presentation, how he felt about the Principality of Islandia, Prime Minister John Briceño said that, quite frankly, it is "schupid" and, at first, refused to comment further.

According to CNN, a group of travelers purchased the 1.2-acre mangrove-lined island known as

Coffee Caye through crowdfunding back in December 2019 at a price of US \$180,000 plus tax after Belizean real estate agent Oscar D. Romero found the property for them. Today the caye, which has since been dubbed "The Principality Islandia" by

owners, has its own national flag, an anthem, a passport, and a "government," and it has garnered a total of 89 investors. And just recently, in February, 13 of those new investors took a trip to the island for the first time, camping there overnight.

Their website, "Let's Buy an Island", states that the Principality of Islandia is a "micronation experiment" and that its owners plan to use the island to forward their own ideals of democracy, inclusion, and sustainability while "keeping with, and enhancing" the laws of their host nation.

Given a second chance at commenting on the issue, Prime Minister Briceño reiterated his sentiments, lambasting the new Coffee Caye owners for "false marketing".

"Would I allow anybody to have their own country within this

country? Man, that is a schupid thing," stated the Prime Minister.

"It has absolutely no support from the government. And certainly, I don't think, and if it is, we'll change it, that the Ministry, or BTB, or anybody in tourism could say 'ok as a marketing strategy you say buy an island and have your own country,' it's not going to happen," he added.

Let's Buy an Island co-founder Marshall Mayer has stated that their claims of the Principality of Islandia being its own country and an "experiment with democracy" is nothing more than a tongue-in-cheek marketing ploy.

"We are a tongue-in-cheek micronation falling squarely within the laws of Belize," Mayer told *Travel* + *Leisure* magazine.

For Stephen Rice, another one of the investors, the concept of Islandia is merely about fulfilling the dream of owning an island. But while those like Rice and Meyer see Islandia as a "fun and quirky" idea, there are some, such as the project CEO and cofounder, Gareth Johnson, who take the concept a bit more seriously, with Johnson telling CNN that the micronation is "as close to a nation as you can get."

While the new "citizens" of Islandia have expressed enthusiasm regarding their new venture, many persons, including some potential investors, have voiced concerns that the small island will not be able to withstand the mounting effects of the climate crisis, including stronger hurricanes and rising sea levels.

Robbers invade home in Cotton Tree

The home of a family of three in Cotton Tree Village in the Cayo District was burglarized in the wee hours of Wednesday, March

According to Indira Barrientos, she and the other two occupants of the home — her mother and daughter— were asleep when she heard a noise coming from the upstairs of their home about 2:00 a.m. that morning. She went to investigate the noise, and found herself in front of a pistol that was pointed at her face, and before she knew it, she was being held at gunpoint by two reportedly dark-complexioned men who demanded money and threatened to rape her.

She later explained to reporters, "I heard [a] noise in my home, upstairs. I got up, saw something, and I went closer to the window, then a guy pointed a gun at me. After that, I threw myself down, then I remembered about my daughter, so I hurried ran to the room. When I ran to the room, they broke the first door, so I got a phone, tried calling the police, and when I called the police [the men] came into the room where I was. At that time, they grabbed the phone from my hand [but] I hurried cut it off, so they made me lock it just to make sure the call was not made to the police. After that, they asked me for money, and one of them told me they were going to rape me, and he took me to the next room then the dogs [started to bark]. I think I got saved from that raping because of the dogs."

"Everything happened quickly. One of them was holding me from the back of my shirt; he is short and kind of thick, smelled of rum, and all covered up." Barrientos said.

While none of the residents of the home were physically harmed during the ordeal, Barrientos said that one of the men repeatedly threatened to rape her, but she told him that she was pregnant in order to avoid the attack.

"They didn't hurt any of us. The short guy told me that I will get raped. He insisted that I will get rapped. I even told him that I was pregnant, but I am not pregnant. I just invented that. When we were downstairs, also, in the room, he also tried to rape me again, and I told him that I was pregnant, so he stopped," she said.

Barrentios said that she prayed that her daughter did not wake up during the home invasion, as it would have made the situation more dire.

"I was in shock, and at that moment I just prayed to God that my daughter doesn't get up and scream, because maybe it could've gotten worse, because she would've made noise. This happened so fast, and I stayed in shock," she said.

The two robbers escaped with over \$300 dollars in cash, a laptop, 2 cell phones, a necklace with Indira's name on it, and some packs of cigarettes.

Police are investigating.

Police van bursts into flames

This morning, a thick plume of black smoke caused by a burning vehicle could be seen by those traveling toward Belize City from the Hattieville area. A van used by police to do daily runs to the Belize Central Prison inexplicably burst into flames sometime after 8 o'clock this morning while it was being used to transport 5 prisoners to the prison. The vehicle fire produced a large amount of smoke which prevented commuters from continuing on their route. One James Bus took a u-turn back towards Hattieville and utilized the Boom cutoff road to enter the Philip Goldson Highway and make its way to Belize City.

The front portion of the police vehicle was burnt to a near crisp, but the Police Communications Director, ASP Fitzroy Yearwood, said that the fire was extinguished and the 5 passengers in the vehicle were transferred to another police van that was on the road at the time, which safely transported them to the prison.

Police were on the scene, but no fire or first response personnel were present. The van was parked at the side of the road while the flames gutted the vehicle. Reports are that the driver of the van saw flames coming out the hood and immediately allowed everyone to exit. Police are currently investigating the cause of this seemingly spontaneous fire.

GOB working on providing relief at the pump

The Government has been assessing ways to mitigate the effects of rising gas prices that are being felt countrywide, PM Briceño told local reporters. That includes capping the price of diesel at \$13.41.

With fuel pump prices slowly inching towards \$15 a gallon after the most recent price increase on Saturday, March 12, took the prices of Diesel and Kerosene to \$13.41 and \$9.05 respectively, Prime Minister John Briceño has indicated that the Government plans to meet with the private sector and other stakeholders to discuss the rising prices and ways to mitigate the effects being felt by everyday citizens.

"We have fuel as it is right now—it is a crisis. The price of fuel without taxes, you know, it's already very high. And so what we are doing with the fuel issue—we have some ideas, but I won't want to disclose them at this time. I prefer to hear out from our social partners," he stated.

According to the Prime Minister, the government will soon be meeting with its social partners in both the private and the productive sectors to hold discussions. Among those partners is the Central Bank of Belize, which, along with the Ministry of Finance, will be presenting data and analysis

on the changes in prices of fuel throughout history and comparing past and present trends.

Many have questioned why the Government of Belize has not done more to absorb some of the fuel costs, thus preventing everyday citizens from feeling the brunt of the effect of rising prices. Prime Minister Briceño noted, however, that the Government has already been doing so.

"In the last shipment of Diesel, I think we have already taken a cut of about \$400,000 that we did not pass on to the pump," he commented.

A recent update from the Ministry of Finance revealed that on Friday, March 11, the Government of Belize lowered taxes on diesel by 35%, allowing its price to be capped at \$13.41. Had this not been done, said the release, the price of diesel would have already reached \$14.70.

Prime Minister Briceno previously stated that several factors have been and will continue to influence the steadily rising fuel prices—including potential hurricanes, inflation, COVID-19, and especially the current war in Ukraine. In this most recent release, the Ministry noted that while

small countries like Belize, with open and vulnerable economies, have no control over these factors, attempting to adjust nationally specific factors may have some kind of an impact. And according to the release, the Government will continue to do what it takes to provide relief at the pump.

"I can tell you that whatever we can control, and whatever it is that we can do, we are going to do our best," said the Prime Minister to local reporters.

Apart from diesel and kerosene, the prices of premium and regular gasoline, which last saw an increase on February 17, currently stand at \$12.90 and \$12.84. These changes, however, like the most recent ones, went mostly unannounced. In fact, within the past month, about four separate increases in fuel pump prices have occurred without any announcement from the Government of Belize Press Office. When local reporters asked the Prime Minister why this was the case and demanded the return of the press releases, he



denied that the Government has been witholding information about upcoming changes in gas prices.


"The truth of the matter is that we are not controlling the publication because you get it the minute it hits the pumps. The minute it hits the pump unu si the change, so it's not that we're hiding the publication," he said.

After being told that the press releases are public information which many depend on and which ensure transparency, the PM seemed to reconsider his stance, stating "It is something I can bring up with the Ministry of Finance."

He also noted that, with the rising gas prices, an increase in bus fares is highly likely.

Minister Ferguson: too many buses on the road

The divisive entry of the new bus line Floralia into the playing field has raised the bar for the standard of public transport, and Minister Rodwell Ferguson is not in opposition to that raising of the bar, as he soon hopes to give the entire industry a much-needed overhaul.

At the request of governmental authorities, up and coming bus line Floralia has delayed the commencement of its new Independence runs by one week—an announcement which comes just three days after Belize Bus Association (BBA) secretary Ewart Metzgen briefly lamented the difficulties faced by operators in the industry, especially with the entrance of a new bus line, and less than a week after it was revealed that the Association had filed an application to the Supreme Court for road permits granted to Floralia to be rescinded and declared illegal.

"In a spirit of cooperation and to allow for a smooth transition between

Operators, Floralia's Independence Run will now commence Monday, March 21," wrote the new bus company, which just recently began operations in December of 2021.

The Supreme Court application, filed by Barrow & Williams LLP, asserts that Floralia's permit to transport passengers from Belize City to Punta Gorda (as well as Belize City to Dangriga) conflicts with the already existing runs being made by other bus lines. In speaking with local reporters, Minister of Transport Hon. Rodwell Williams stated, however, that whichever bus operator was doing the Independence runs over the last few months was doing so illegally, since the person who held the permit for it, Calbert Williams, passed away late last year and the permit for the run expired on December 31, 2021. Minister Ferguson refrained from commenting any further, since the court has not yet made a decision on the

In recent months, many commuters have stated that while the quality of most buses on the road has been lacking, Floralia's emergence has raised the bar for public transport standards. Hon. Rodwell Ferguson has stated that he welcomes that elevation, noting that in taking over the Ministry his main priority has always been upgrading and completely transforming Belize's transport industry, something which he says he immediately communicated to all bus

operators and which he hopes to accomplish by December 2022. This new upgrade would be timely, as rising fuel prices have sparked discussions around whether there will soon be an increase in bus fares, and, according to the Minister, most commuters would not be willing to pay more money for substandard services.

"If you look at the threads on Facebook, the commuters are saying that they want better buses on the highway, and we don't mind paying the price if we get better transportation services across this country. So I believe that the commuter might erupt, and say 'you di increase the price for me and then the buses are still old and inadequate'. So we hope that we can balance the act as we go along and figure out how quickly we can resolve it," he said.

Previously, bus operators who belong to the Belize Bus Association were threatening to take industrial action after their requests for relief to counter the impact of steadily rising gas prices and other overhead expenses were reportedly ignored. After a successful meeting with the Government, the BBA called off their strike, and it was agreed that fuel prices and the potential increase in bus fares would be discussed in Cabinet this Monday. According to Minister Ferguson, during that meeting, he also spoke with the bus operators about the plan to upgrade the transport industry.

A part of that upgrade, he said, might involve reducing the number of buses on the roads as, currently, there are far too many.

"Right now we're doing an assessment—a whole transformation plan going on in the Ministry of Transportation...When we discussed with the bus operators a couple of days ago, I told them together we have to fix the industry and to be frank, too many buses are on the highway, and nobody's making any money. So we have to figure out what is the best way forward to streamline this industry that we can see an improvement and likewise operators making money. So if somebody will have to go at the end of the day some will have to go. But that will be between ourselves and the bus operators," he stated.

While he didn't go into much detail, Hon. Ferguson also said that he has been negotiating with banks for all bus operators to be able to get loans to improve their services and bring in new buses in an effort to level the playing field and elevate the standards of the industry. Currently, many operators are unable to do so due to many of their road permits being short-term, thus preventing them from being approved for loans. Hon. Rodwell Ferguson also added that he supports anyone who wishes to improve transport services, stating, "If you invest and you bring in and you want to upgrade, then I'm with you."

Revised Cannabis Bill tabled at National Assembly

After being sent back to Cabinet for approval last week, the revised Cannabis and Industrial Hemp Control and Licensing Bill was tabled at the sitting of the House of Representatives this past Tuesday. Over the past 8 months, the set of regulations, which is an attempt by GoB to establish proper legislation to govern the

cultivation, processing, distribution, and delivery of cannabis and industrial hemp products, has gone from being an amendment to the Misuse of Drugs Act to its current status as a specialized, standalone Act.

During the House sitting, the Minister of Home Affairs and New Growth Industries, Hon. Kareem Musa, stated that presenting the cannabis regulations in the form of a standalone act highlights the importance of directing specific focus and attention to the industry. He also noted that the revised bill underscores inclusiveness and responsiveness — having been the result of consultations, working groups, virtual town halls, and dialogue with stakeholders.

"Those interactions, Madame Speaker, have made this bill. It is a bill not shy of feedback from both proponents and opponents. Everyone together has played a part in making this bill better," said Minister Musa.

One of the improvements made to the newly revised bill is a change in the minimum legal age for cannabis use, which has been upped from 18 to 21 years, after government took into consideration calls to more forcefully protect young persons in the country. According to the Minister, regulations related to transparency and confidence will also be strengthened in an effort to "bring cannabis out of the shadows."

"It is our duty to bring the assurance of a tested and safer product while embracing the opportunity to educate Belizeans on the potential risks and benefits. What is before us, Madame Speaker, is an earnest attempt to legislatively, deliberately, thoughtfully repair and contain the damage caused by failed policies or rather a complete lack of policy altogether along with the racist enforcement schemes that exist. We continue to push towards a framework that is built on equity, responsibility, restitution, and peace," he said.

The bill, which has the support of the Cabinet, will be referred to the National Security and Immigration Committee for examination and consideration, after which it will have a second reading on March 24, 2022.

\$1.192 billion for that period.

Notably, however, although the 2021-2022 budget was presented as one of austerity, the government's spending surpassed the \$1.217 billion that had been budgeted for expenditure by \$14 million.

Prime Minister Briceño acknowledged this excess spending during his budget presentation, and remarked, "Now the excess spending in the instance of Goods and Services is the item of greatest concern to me: \$50m or some 29 percent higher than the Budget. While we concede that the cut for FY 2021/22 was significant, compared to previous years, there must be an acceptance that spending 20 cents of every dollar collected by Government on Goods & Services is intolerably high."

He added, "The Ministry of Finance will redouble efforts to suppress this expenditure line item but to do so requires an all-of-government approach. I appeal to Ministries and Financial Officers to exercise maximum restraint."

In the upcoming financial year, overall spending is expected to increase by \$144 million or 12%, to \$1.36 billion. This will include the 10% of public workers' and teachers' salaries that had been deducted from what they received over the past year as a cost-saving measure but will be paid once more to those workers following the reinstatement of their full salaries.

"The decision to restore, in dollar terms, translates into an additional \$40 million in the Personal Emoluments and \$15 million in the Subsidies and Transfer line, for a total of \$55 million," the Prime Minister said. He also noted that this year \$101 million will be allocated for pension

payments

"Taken all together, wages and pensions, including the wage-related subsidies categorized as Subsidies and Transfers, will total some \$704 million. Let me repeat, for necessary emphasis that stunning figure: Wages, wage-related subsidies, and pensions will cost Government \$704 million in the coming Budget year. 62 cents of every dollar Government collects in recurrent revenues will therefore be spent on wages and pensions," said Hon. Briceño.

The overall deficit of \$97.6 million will be bridged through grant funding from Taiwan, which is categorized as Capital 3 funding (loans from external sources), and the issuing of treasury bills, explained Hon. Briceño. In response to questions about the high overall deficit in this budget, he said, "The point is, we are bridging the deficit, and the way we are bridging the deficit is, one, by grants, which our good friends from Taiwan are helping us with some grants, and secondly from the Cap 3 funding when the US comes in, and then we will also be issuing some treasury notes and bills. Between those three factors, we will be able to close the deficit."

According to the International Monetary Fund, Belize's economy is estimated to expand by 6.5% this year — but despite the upswing of 2021, which saw global world input increase by 5.9% and a 12.5% economic expansion in Belize, the world (including Belize) is headed for tougher times, cautioned Hon. Briceño.

In outlining what economic prospects lie ahead for 2022, the Prime Minister stated, "The global growth momentum observed in 2021 is expected to recede in 2022. According to the IMF, global growth is expected to weaken by 1.5 percentage points to 4.4 percent in 2022."

Despite GoB's anticipation of a global economic downturn, however, no new major tax or revenue-collection measures were included in the new budget—notwithstanding the fact that the four major categories of taxes together constitute the primary portion of what GoB collects in recurrent revenue, with taxes on goods and services estimated at \$654,966,339 for this coming fiscal year (over half a billion dollars for the Belizean taxpayer).

The government is, however, providing funding to bolster the new Tax Recovery Unit.

"Cabinet committed to establishing a Tax Recovery Unit. This Unit began operations in October of last year. With help from CARTAC, the Unit reviewed the 18,830 accounts that carried nominal arrears of some \$645 million and relating to the Belize Tax Service Department (that is, the GST, Business Tax, and the PAYE levies). Of this \$645 million: only 6 percent or \$38 million were assessed within the last two years; less than 20 percent or \$111 million are less than 5 years in arrears; approximately \$419 million or 67 percent are noncollectable by law due to the statute of limitations, or because they related to the now obsolete Sales Tax," stated the PM during his presentation of the budget.

While the International Monetary Fund's (IMF) fiscal affairs department has deemed taxes that have been outstanding for more than three years to be uncollectable, however, the Leader of the Opposition, Hon. Moses "Shyne" Barrow, stated during his remarks in the House that a bill should be brought to the House to extend the statute of limitation on recovery of uncollected taxes.

"There are creative ways to make it where we can get the money, get people to pay what they owe the Belizean taxpayers ... we have come to this honorable House and presented legislation to remedy problems that did not exist, so with a problem such as this I believe the entire country would rally behind the government to bring legislation where we can get people to pay what they owe. The statute of limitation should not be used for absconders of tax dollars that are owed to the Belizean people," said Hon.

Increased collection of taxes could be of assistance to the country as it services its debt portfolio and inches toward reducing its 108% debt-to-GDP ratio. Last year, \$86.4 million of public debt was retired, separate from the write-off related to the Blue Bond payout of the Superbond.

"According to the IMF's most recent assessment, issued on 24th February 2022, Belize's public debt fell from 133 percent of GDP at the close of 2020 to 108 percent at the close of 2021, down by a massive 25 percent of GDP," the PM stated in his budget presentation.

During an interview following the House meeting, the PM Briceño told reporters that his administration is aiming to reduce the debt to GDP ratio to as low as 80% during their time in office

"In the first year, we manage to reduce it by 25%. That does not mean we are out of the woods; we are still in dangerous territory. So our objective and goal is for us to reduce debt to GDP to 80% by 2025 and by 2030 we hope that the next government ... will be able to reduce it to 70%," he said.

Key sectors driving the economic rebound recorded in 2021 remain our traditional mainstays: agriculture and tourism. This budget, the PM says, has been proposed "to allow time for the economic recovery to solidify and for wage relief to offset rising inflation."



Increasing bus fares isn't the best option

News that bus operators across the country were seriously considering strike action because they weren't making enough off their runs to cover costs came as no surprise to commuters. While no study has been done to find out how much the pandemic negatively affected the earnings of bus operators, most believe it has been considerable. A falloff in the number of commuters is only one of two hits bus operators have taken. They've also been hit hard by the rising cost of fuel at the pumps.

Recently, the price of crude oil spiked significantly after the world's most heavily nuclear-armed country, Russia, viciously invaded its neighbor, Ukraine. Today, the price of diesel, the fuel of industry, is well above \$13 per gallon, and bus operators, who in fact were being crushed at the pumps even before the change of government in November 2020, can't handle the pain anymore, hence their decision to cry out for relief.

The president of the Belize Bus Association, Mr. Thomas Shaw, said that in meetings with the Ministry of Transport (MoT) their discussions revolved around the government subsidizing fuel costs for bus operators, or giving them the go-ahead to increase the fare for commuters. Reports are that the MoT is leaning in the direction of higher bus fares.

Government's take from fuel taxes has never been so good, and with our country still heavily indebted after two years in the grip of the pandemic, GOB is probably tempted to milk the pumps a while longer. The taxes collected off fuel are

incredibly important for GOB, but there's just so much you can get from people who are struggling financially. If GOB supports having commuters reach deeper into their pockets to travel on public buses, it might be miscalculating the level of pain out here. It is both bus operators and commuters that are strained past the breaking point.

As PM Briceño pointed out in his budget speech on Tuesday, things were bad in Belize before his government took office. While all the numbers point to an economy on the rebound, we are not yet back to where we were prior to the pandemic. There was much suffering in our land pre-pandemic, and since then our deprivation has increased. An estimated 60 % of Belizeans are living in poverty at this time, and that means that six out of ten Belizeans are counting pennies, not dollars. These are very hard times.

It is very rough out here, and it could get a lot worse quickly if this war in the Baltics isn't over soon. The fallout from raising bus fares would be varied and plentiful, and the thousands who will feel their pockets pinched even further are mostly students, small

entrepreneurs, and government workers. Bus owners will be happy, but it mightn't be for long. Raising bus fares means there'll be more hitchhiking on the highways, more people camping at their work sites instead of going home, more people dropping out of the work force, increased cost of the produce of our small entrepreneurs. In these times of high gas prices, the bus fares should encourage folks to park their cars.

Presently, the MoT is on a mission to get bus operators to improve their fleets. Efficient, comfortable and affordable transportation of Belizeans to their work sites all across this country is critical to our development, but that goal won't be realized if the industry isn't profitable. GOB has a number of options to satisfy bus operators; increasing bus fares shouldn't be one of them.

With raising bus fares off the table, one option is for GOB to subsidize the bus operators. This is the quickest solution; it could be done with the stroke of a pen. The GOB would give up some tax, and it would have to have strict controls so that bus operators don't abuse the assistance.

The other option is to set up a small refinery. Highly regarded engineer/economist, Mr. Bill Lindo on his blog published on March 12, 2022 said that we could easily bring down the cost of diesel in Belize. Mr. Lindo says at this time we are still pumping 450 barrels of crude oil from the earth daily, so all we need to do is "stop exportation and set up a small refinery to take out the diesel and export the residue as it's not economical to refine gasoline and other products."

In 2011 the GOB busted a man who was producing diesel and kerosene from crude oil taken from two small "wells" on a property in Belmopan. The *Amandala*, in the story, "Secret oil refinery busted in Belmopan", said that a 56-year-old Cuban mechanic, Roberto Igarza Velasquez, who was in Belize illegally, had "been charged by Belmopan police for embarking on a project without applying to the Environmental Department, and also, for carelessly causing a disaster." A source told the *Amandala* that there was always "heavy vehicular traffic" at the site, and that police sources said "kerosene and diesel were found in industrial quantities."

The UDP, which formed governments in 2008, 2012, and 2015, made us many promises, and in the party's 2012 manifesto we were told that if the party had a victory at the polls the country would get an oil refinery. Then PM, Dean Barrow promised that the party would get on with this project as quickly as possible, and that we would be producing both diesel and gasoline from the crude oil produced by BNE. The UDP government of 2012 to 2015 didn't deliver on that promise. It easily could have if it had confined itself to producing diesel.

Belize has enough small oil wells, so it doesn't need BNE oil. There are many limitations being a small nation with only 400,000 people, but there are advantages too, one of which is that to satisfy our needs for diesel we don't need a big refinery. A refinery just to supply diesel to bus operators shouldn't cost a fortune.

Our elected representatives —our government, of, by, for the people —are at this time discussing/negotiating with bus operators to find the best way forward for this critical industry. Behind closed doors we don't know all that they are discussing. One option that shouldn't be on the table is raising bus fares.

If GOB can't sustain subsidizing the price of diesel to bring it down to where bus operators are making sufficient profits to cover their costs, including maintaining their buses so that commuters are transported safely and comfortably, maybe they have to talk to Mr. Lindo. Or do it like the Americans, who have sent an emissary to Venezuela. We should send to Cuba, for a man named Mr. Velasquez.

Music world mourns the loss of "Guayo"

His musical prowess made its mark in the world of Garifuna music with his guitar solo in "Watina" and continued to do so for 15 years. Now, the musical community is mourning the loss of talented Honduran guitarist Ramon "Guayo" Cedeño.

TEGUCIGALPA, Honduras, Wed. Mar. 16, 2022

The passing of renowned Honduran guitarist and producer Ramon Eduardo "Guayo" Cedeño, has left the Latin American and Garifuna music world, reeling. Guayo, as he was most affectionately known, was 48 years old and died from respiratory complications in a hospital in Tegucigalpa on Friday, March 11—just two days after the birth of his second child, Matias.

Over the years, Cedeño has worked with a number of Garifuna artists and has contributed vastly to the local music scene, having worked extensively with Stonetree Records, and playing the guitar on several acclaimed albums, including *Watina*, *Umalali*, *Laru Beya*, and *Landini*. In fact, since working with Stonetree for the first time in 2006, when

he collaborated in the production of Andy Palacio's *Watina*, Guayo and his guitar have been featured in every single Garifuna song made by the record label.

"Our music will never be the same without Guayo, but I thank him from the bottom of my heart for the many gifts he has left us," wrote Stonetree's founder, Ivan Duran. Duran has described being in the studio with the skilled guitarist as "an otherworldly musical experience".

Born on January 7, 1974, in the coastal city of La Ceiba, the Honduran native spent his early years watching his father play in the band Los Robbins. He would also eventually go on to encounter Garifuna music, which, according to Cedeño's website, is what ultimately led him to record and tour the world years later with some of the world's greatest Garifuna stars: Andy Palacio, The Garifuna Collective, Umalali, and Aurelio

Martinez. A recording can be found on YouTube of Cedeno performing a guitar solo at the 2013 Africa Festival in Germany as a part of the Aurelio Martinez World Tour. There, he gives an impassioned and enthusiastic performance, while Martinez, often referred to as his brother in music, dances in the background.

"Guayo Cedeño my heart is broken, nothing else remains for me to tell you, thank you for so much my little brother," wrote Nilo Espinal, lead vocalist of Diablos Negros, of which Cedeno was also a part, on Facebook.

Guayo leaves behind his wife, musician Gaby Flores; daughter Amelia, his newborn son, and a host of fans from Honduras, Belize, and across the globe. His first and only album, *Coco Bar*, was produced in 2015 and pays tribute not only to his father but to 1960s Honduran music. Currently, the Cedeno family is hosting a GoFundMe campaign to support his wife and children.

Aumentar las tarifas de los autobuses no es la mejor opción

La noticia de que los operadores de autobuses de todo el país estaban considerando seriamente una huelga porque no estaban ganando lo suficiente para cubrir sus costos no fue una sorpresa para los viajeros. Si bien no se ha realizado ningún estudio para averiguar cuánto afectó negativamente la pandemia las ganancias de los operadores de autobuses, la mayoría cree que ha sido considerable. Una caída en el número de pasajeros es solo uno de los dos golpes que han recibido los operadores de autobuses. También se han visto muy afectados por el aumento del costo del combustible en las bombas

Recientemente, el precio del petróleo crudo se disparó significativamente después de que el país con mayor armamento nuclear del mundo, Rusia, invadiera brutalmente a su vecino, Ucrania. Hoy, el precio del diesel, el combustible de la industria, está muy por encima de los \$13 por galón, y los operadores de autobuses, que de hecho estaban siendo aplastados en las bombas incluso antes del cambio de gobierno en noviembre de 2020, ya no pueden soportar el dolor, por lo tanto su decisión de clamar por alivio.

El presidente de la Asociación de Autobuses de Belize, el Sr. Thomas Shaw, dijo que en reuniones con el Ministerio de Transporte (MdT) sus discusiones giraron en torno a que el gobierno subsidie los costos de combustible para los operadores de autobuses, o les dé el visto bueno para aumentar la tarifa para viajeros. Los informes indican que el Ministerio de Transporte se está inclinando en la dirección de tarifas de autobús más altas.

La recaudación del gobierno de los impuestos al combustible nunca ha sido tan buena, y con nuestro país aún muy endeudado después de dos años bajo el control de la pandemia, el Gobierno de Belize probablemente se siente tentado a sacarle provecho a las bombas por un tiempo más. Los impuestos recaudados del combustible son increíblemente importantes para el Gobierno de Belize, pero solo hay tanto que se puede obtener de personas que tienen dificultades financieras. Si el Gobierno de Belize apoya que los viajeros saquen más de sus bolsillos para viajar en autobuses públicos, podría estar calculando mal el nivel de dolor aquí afuera. Tanto los operadores de autobuses como los viajeros están distendidos más allá del punto de ruptura.

Como señaló el primer ministro Briceño en su discurso sobre el presupuesto el martes, las cosas estaban mal en Belize antes de que su gobierno asumiera el cargo. Si bien todos los números apuntan a una economía en recuperación, aún no hemos vuelto a donde estábamos antes de la pandemia. Hubo mucho sufrimiento en nuestra tierra antes de la pandemia, y desde entonces nuestras carencias han aumentado. Se estima que el 60 % de los beliceños viven en la pobreza en este momento, y eso significa que seis de cada diez beliceños cuentan centavos, no dólares. Estos son tiempos muy difíciles.

Es muy difícil aquí, y podría empeorar mucho más rápido si esta guerra en el Báltico no termina pronto. Las consecuencias del aumento de las tarifas de los autobuses serían variadas y abundantes, y los miles de personas que sentirán que sus bolsillos se aprietan aún más son en su mayoría estudiantes, pequeños empresarios y trabajadores del gobierno. Los propietarios de autobuses estarán felices, pero puede que no sea por mucho tiempo. Aumentar las tarifas de los autobuses significa que habrá más gente pidiendo un aventón en las carreteras, más personas acampando en sus lugares de trabajo en lugar de irse a casa, más personas abandonando la fuerza laboral, mayor costo de los productos de nuestros pequeños empresarios. En estos tiempos de alta precios de la gasolina, las tarifas de los autobuses deberían animar a la gente a aparcar sus coches.

Actualmente, el Ministerio de Transporte tiene la misión de

hacer que los operadores de autobuses mejoren sus flotas. El transporte eficiente, cómodo y asequible para los beliceños a sus lugares de trabajo en todo el país es fundamental para nuestro desarrollo, pero ese objetivo no se logrará si la industria no es rentable. El Gobierno de Belize tiene una serie de opciones para satisfacer a los operadores de autobuses; aumentar las tarifas de los autobuses no debería ser uno de ellos.

Con el aumento de las tarifas de los autobuses fuera de la mesa, una opción es que el Gobierno subsidie a los operadores de autobuses. Esta es la solución más rápida; se podría hacer de un plumazo. El Gobierno renunciaría a algún impuesto, y tendría que tener controles estrictos para que los operadores de buses no abusen de la asistencia.

La otra opción es montar una pequeña refinería. El ingeniero/ economista de gran prestigio, el Sr. Bill Lindo, en su blog publicado el 12 de marzo de 2022, dijo que podríamos reducir fácilmente el costo del diésel en Belize. El Sr. Lindo dice que en este momento todavía estamos extrayendo 450 barriles de petróleo crudo de la tierra diariamente, por lo que todo lo que tenemos que hacer es "detener la exportación y establecer una pequeña refinería para sacar el diésel y exportar los residuos, ya que no es económico refinar gasolina y otros productos".

En 2011, el Gobierno de Belize arrestó a un hombre que estaba produciendo diesel y queroseno de petróleo crudo extraído de dos pequeños "pozos" en una propiedad en Belmopán. *Amandala*, en el reportaje "Refinería secreta de petróleo encontrada en Belmopán", dijo que un mecánico cubano de 56 años, Roberto Igarza Velásquez, que estaba ilegalmente en Belize, había "sido acusado por la policía de Belmopán por emprender un proyecto sin aplicar al Departamento de Medio Ambiente, y también, por causar un desastre por descuido". Una fuente dijo a *Amandala* que siempre había "pesado tráfico vehicular" en el sitio, y que fuentes policiales dijeron que "se encontró queroseno y diésel en cantidades industriales".

El UDP, que formó gobiernos en 2008, 2012 y 2015, nos hizo muchas promesas, y en el manifiesto del partido de 2012 nos dijeron que si el partido ganaba en las urnas, el país tendría una refinería de petróleo. Luego, el primer ministro, Dean Barrow, prometió que el partido continuaría con este proyecto lo más rápido posible y que estaríamos produciendo tanto diesel como gasolina del crudo producido por BNE. El gobierno UDP de 2012 a 2015 no cumplió esa promesa. Podría haberlo hecho fácilmente si se hubiera limitado a producir diesel.

Belize tiene suficientes pozos de petróleo pequeños, por lo que no necesita petróleo de BNE. Hay muchas limitaciones al ser una nación pequeña con solo 400,000 habitantes, pero también hay ventajas, una de las cuales es que para satisfacer nuestras necesidades de diesel no se necesita una gran refinería. Una refinería solo para suministrar diesel a los operadores de autobuses no debería costar una fortuna.

Nuestros representantes electos —nuestro gobierno, de, por, para el pueblo— están en este momento discutiendo/ negociando con los operadores de autobuses para encontrar el mejor camino a seguir para esta industria crítica. Detrás de puertas cerradas no sabemos todo lo que están discutiendo. Una opción que no debería estar sobre la mesa es aumentar las tarifas de los autobuses.

Si el Gobierno no puede seguir subsidiando el precio del diésel para reducirlo hasta el punto en que los operadores de autobuses obtengan suficientes ganancias para cubrir sus costos, incluido el mantenimiento de sus autobuses para que los pasajeros se transporten de manera segura y cómoda, tal vez tengan que hablar con el Sr. Lindo. O háganlo como los americanos, que han enviado un emisario a Venezuela. Deberíamos enviar a Cuba, por un hombre llamado Sr. Velásquez.



When the COVID-19 virus broke out in March of 2020, almost two years ago, I remember thinking to myself that the only way our roots people could survive this catastrophe was if there were some transfer of wealth from Belize's super rich to the poor. This did not occur. In fact, the super rich grabbed more.

As time went along, I asked my eldest son, Mose, how it was that our people were surviving. I knew that things had been rough even before the coronavirus, so the virus was a case of, as we say, from bad to worse. Mose said that it was the Belizean diaspora in the United States which had made survival in the home country possible. In the absence of any other explanation, I accepted his analysis.

When we watch our destitute and mentally challenged staggering along so pitifully along the streets of the old capital, those of us who know the history feel a dagger in our chest. These are our people, and there was a time, for centuries in fact, that our people, our enslaved people, were the backbone of this territory. Our enslaved people for centuries were the vast majority of the population in this British colony, which was called British Honduras by the colonial masters in London. Guatemalan children are taught in school that the land of Belize was stolen from Guatemala by the British, and that we Belizeans of color who live here were British chattel. That is a whole history in itself, and it will be culminating with a judgment by the International

Court of Justice (ICJ).

I have said to you before that we Belizeans were more fortunate than other British subjects in this Caribbean region, because we had a land bridge through Mexico to the United States of America, the richest economy in the world. British Honduras was the only British possession in Spanish-speaking Central America. So that, when American immigration officials at the border between the U.S. and Mexico heard black people speaking English, they assumed such individuals were black Americans, not "wetbacks."

It was World War II which opened the eyes of the working class in B.H. to the wealth and largesse of America, as compared to the suffering being imposed on us by the "geechy" British. During World War II (1939-1945), Belizean workers were hired to work in the Canal Zone in Panama, where the Americans ran things. Belizeans began to long to travel to the United States.

The wider context of this situation had to do with the Monroe Doctrine, a declaration by the United States government in 1823 that they would no longer tolerate interference in the Western Hemisphere by any European power, a designation which would include Great Britain, which was in possession of British Honduras in 1823. (The United States of America had declared independence from Great Britain in 1776.)

But there was a special relationship between the U.S. and the U.K. in the nineteenth century (white supremacy), so that in 1859

the United States "godfathered" a deal whereby Guatemala acceded to international boundaries to define The Jewel — 8,867 square miles — as British territory.

A few decades later, the ruling business/industrial and military classes in Guatemala began to complain about the 1859 Treaty, but in 1919 there was a massive uprising by the black people in Belize (the so-called "British blacks") which was essentially rejecting British colonial rule. Still, Guatemala, the hostile 1,000- pound gorilla, remained on Belize's western and southern borders, and it was the British who had to send a warship here in 1948 to protect Belizeans, the majority of whom were black.

By 1950, however, because the British devalued the Belizean dollar, Belizeans began to agitate for self-government and independence. This original Belizean thrust for self-rule was supported between 1951 and 1954 by a Guatemalan government led by Jacobo Arbenz.

But Arbenz was too nationalistic for the Americans, so Washington organized his overthrow and began installing CIA puppets like Carlos Castillo Armas and Miguel Ydigoras Fuentes to run Guatemala. The result was a terrible civil war in Guatemala, which began in 1960 and lasted until 1996.

During this period of bloody violence in the republic, Belize was completely peaceful, and achieved self-government in 1964. The British were now beginning to transfer British Honduras to the hegemony of the Americans who, following Hurricane Hattie in 1961, began to absorb Belize's black population into the Union.

Today, Belize's is a minority black population. The transfer from majority black to minority black was accomplished peacefully because we Belizeans wanted to go north.

So now, this is where Belize is today, where Washington decided for us to be. The only thing that really makes us different from the two Central American republics around us — Guatemala and Honduras — is that English is the official language in Belize. When that changes, this becomes a whole new ball game. Trust me.



The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). Through this project, the Belize Tax Service Department (BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS)) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

The BTSD Strategic Plan clearly addresses the relevance of taxpayer segmentation and the risk management approach. It indicates that:

"It has become good practice for Tax Administrators across the world to implement Taxpayer Segmentation in revenue management to effectively analyze taxpayer data and to efficaciously implement different and specific surveillance and control mechanisms," and that; "The deployment of a 'Risk management approach' is a modern and pertinent tactic that would aid in compliance. This approach gives a structured basis for strategic planning; focuses on the underlying drivers (not symptoms) of non-compliance; promotes diversity in the way major tax compliance risks are treated, rather than a 'one size fits all' approach; realizes better outcomes as it refers to efficiency and effectiveness of programs; coincides with international standards and is a strong basis for evidence-based evaluation.

Consequently, the BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. As an important aspect of the RMP, risk mitigating strategies will be proposed for application against potential and existing risks. The plan will highlight all areas of risks including risk-based assessments, risk-based audits, risk-based sector and taxpayer segmentation, compliance risks (registration, filing, reporting and payments) and international risks. Risk mitigation reduces the extent of exposure and ensures that the strategic objectives are achieved."

The consulting services ("the services") includes the contracting of a Consultancy Firm for a period of five (5) months to review and update the current Taxpayer Segmentation and develop a Risk-based compliance management model, including configuration of the model in the ITAS. The main activity of the consultancy includes:

Taxi driver charged for Medina's break-in

BELIZE CITY, Wed. Mar. 16, 2022
Between 5:00 p.m. on Saturday,
March 12, and 8:00 a.m. on Monday,
March 14, a taxi driver who has had
previous run-ins with the law,
allegedly burglarized Medina's

allegedly burglarized Medina's House of Jewelry located on Orange Street in Belize City. He has since been identified as Raymond Montes and was arrested and charged for the crime, but has since been granted bail.

Ethan Medina, 55, the owner of the jewelry store, told police that an assortment of items was stolen during the burglary— including a large number of gold earrings and other gold jewelry totaling approximately \$20,000.00 BZD in value, a Dell brand laptop valued at \$1,500.00, assorted silver jewelry, and 2 Apple iPhones.

According to Medina, the robbers gained entry into the establishment by breaking an existing wall on the west side of the building, where the office is located.

After a further police investigation, on Tuesday, March 15, police formally arrested and charged Raymond Anthony Montes, a 48-year-old taxi driver of Police Street in Belize City, for burglary. Montes is a well-known felon and a convicted burglar.

On Wednesday, March 16, Montes appeared before Senior Magistrate, Tricia Pitts-Anderson in court and was read charges for the criminal offense of burglary. Montes was represented by his attorney, Norman Rodriguez, and pleaded not guilty, and since there was no objection to bail, Senior Magistrate Pitts-Anderson granted him bail of \$5,000, which he met.

The project is aimed at assisting over 7,000 local Belizean farmers with weather data and technical information to help improve harvests for crops and livestock and facilitate better planning. Also, the project will be providing grants to over 3,700 small farmers, which will allow them

to adopt climate-smart practices to improve the sustainability of their farms.

The matching grant scheme, combined with technical support for farmers, is aimed at leveraging US\$18.2 million in private financing for climate-smart agricultural technology. Importantly, 30 percent of grants will be designated for women farmers in the project.

"I have seen first-hand how important farmers and agriculture are to Belize. Both the World Bank and Belize know the sector can be an engine of growth to support the wellbeing of families and communities and improve the economic prospects of the country," said Lilia Burunciuc, World Bank Country Director for the Caribbean. "We have witnessed the importance of food security to the region, something that has been particularly underscored throughout the COVID-19 pandemic, and this project will accelerate efforts to address that in a climate-smart way," she continued.

The COVID-19 pandemic has caused an increase in challenges within Belize's agriculture sector — disrupting the supply chains, reducing purchasing power, and weakening the demand for food products, including within Belize's tourism sector. In 2021, however the country saw a bounceback in agriculture, with notable increases in the production of banana and sugar cane.

One of the project's initiatives is focused on ensuring that farmers become more resilient and produce food in an environmentally sustainable manner that meets the needs of local and international markets.

These farmers under the project will be receiving training in improving practices and will also be given greater access to data, improved infrastructure for the sector, and technical advice.

The Belize Climate Resilient and Sustainable Agriculture Project will also fund capacity-building for key institutions that support the farmers, including the Ministry of Agriculture, Food Security, and Enterprise, to better support the development of a more resilient, productive, and climate-smart agricultural sector.

Social Security Board Announces Implementation of the Contribution and Benefit Increase

Social Security Board (SSB) introduces the final phase of the Contribution Reform. The final contribution and benefit increase, which falls under the 3-year phased approach, aims to improve and provide greater value to beneficiaries during time away from work if they become incapacitated or ill.

This is essential for the strengthening of the SSB program in order to provide sickness, maternity, disablement, invalidity, injury, death benefit and pensions to contributors, their families and survivors.

Under the final phase, employers and employees will see an increase of 1% in the Contribution Rate from 9% to 10% and \$480 to \$520 in the Wage Ceiling effective Monday, April 4, 2022. This translates to an increase in the maximum cash benefit of \$416 weekly for short term benefits and \$312 weekly or \$16,224 yearly for pensions.



Mother seeks justice for slain daughter

body was found burnt beyond recognition with a slit throat and multiple

stab wounds to her back and abdomen at the Belmopan Dump Site on the outskirts of Belmopan on the Hummingbird Highway.

On March 11, 2017, Ara was allegedly killed in a home in Belmopan City, and it is alleged that her body was taken to the dumpsite by 27-year-old Jaime Patnett and 25-year-old Shaylon Santos, both of whom were residents of Teakettle Village. The two men were subsequently arrested and charged with the crime of murder. But earlier this year, on February 23, the duo were able to exit the Belmopan Supreme Court as free men after a not guilty verdict was delivered by Justice Francis Cumberbatch.

Shirley Mai, the mother of Keona Ara, has lamented to reporters that, although she was assured by police that the case against the men was a strong one, she had begun to feel unsettled as key pieces of evidence began to go missing.

"From the beginning, I was in that courtroom from the start to the end, and I knew the case was going somewhere where only God can bring it back, because the file they start to go missing. I went back to the police station. I spoke

to the high-ranking officer, and I told him 'this is what going on, this is what's happening, this is what taking place'... But I was in the courtroom and I heard my statement went missing, my daughter's statement went missing, like everything is going missing. So I knew from the beginning this case is not going to sit right," said Mai.

She further stated, "Every time the case is being called, I heard something is going missing. I went back and told the high-ranking officer, who I trust, who I believe, and I take their word for it. On the following day, before the case went to where it is [a] 'not guilty verdict,' I went back there again, and I told the same officer again, 'officer, please tell me where is the recording, because you assured me there was a recording', because normally I know you turn some evidence in Belize, the ...witness normally turn up dead or something go wrong and he said, 'Miss Mai, we have a recording; we will use this in court even if she [turns] up dead', so I went and I told the prosecutor for the Supreme Court, and I said, 'the officer said there is a recording,' and he said, 'Miss Mai, we need it, the case is going on,' and then I went back [to the police officer] and I said, 'we need the recording, the prosecutor is asking for it,' and he said, 'I don't know where the recording is; The recording went missing!' I said 'Jesus, what is happening?'"

Mai denies the assertions of Commissioner of Police, Chester Williams, that her daughter had been involved in a lovers' quarrel which ultimately led to her gruesome murder. Instead, Mai stated that her daughter was a pivotal witness in a court case, and she believes that this is what led to Keona Ara's death.

"She was a key witness in a case; after she turns up dead, and when CIB went to my house, I told them, 'this right here, this mixup will cost my daughter her life' and I told them to their [faces] that," Mai said.

Mai said that she had been trying to establish contact with the Director of Public Prosecution in an attempt to appeal the ruling which set free the men who she believes murdered Ara, but that the 21-day period within which an appeal can be filed has since elapsed, and she is now looking into other legal remedies.

"I have been telling them that I need to appeal this case. I've been to the DPP office. I've been back to the Supreme Court. I've been back to the DPP office, and they told me, 'she's not there." Mai said. "I spoke to someone who works with the DPP and they told me on what grounds I want to appeal, so I said, 'I am not satisfied with the outcome of the case", Mai went on to say.

7News reported last night that they received a statement from the Director of Prosecution, Cheryl Lynn Vidal, who explained that a key witness's statement, which "connected the accused to the offence" had not been forwarded to the court and the DPP's office, as they should have been, and, according to 7News, "when Vidal went to inquire at the Clerk of Court, it still could not be found, which led her to make an official police report. She said that an investigation had commenced but the police never shared the results of the



Accused killers of minister's father plead guilty

year-old Belizean mason; and 26year-old Angel Cardenas, a Belizean construction worker, of Trial Farm in the Orange Walk District, pleaded guilty to manslaughter.

Back in 2014, the family of

Cervantes, Sr., became concerned when he did not come home for lunch at noon, and when they contacted him via phone, he was reportedly acting strange and speaking in an unusual tone of voice. Later, it was reported that Cervantes, Sr., had been abducted from his cane farm on the San Roman Road on Tuesday, July 1, and his body was found several days later, on July 5, partially decomposed and buried in a shallow grave on a farm just three and a half miles away, near the Honey Camp Lagoon on the outskirts of

The trio were arraigned on July 11, 2014, before Magistrate Merlene Moody. They were read joint charges of murder, keeping a firearm without a gun license for a 12-gauge pumpaction shotgun, and keeping unlicensed ammunition for five 12-gauge cartridges that were allegedly found in their possession at the time.

Orange Walk Town.

"I think it's the best legal justice that

could've been gotten: one of them pleaded guilty to murder and the other two pleaded guilty to manslaughter. I think it's the best that legal justice could have been obtained under our system and we'll have to live with it. Like you said, it's been a long time, almost 8 years, we have been awaiting. I think two witnesses have passed away over that time and one Crown witness also passed away during that time. But in the end, they knew what they did, and they accepted what they did, and thus their pleas," stated Hon. Ramon Cervantes, Jr., who is the Minister of State in the Ministry of Foreign Affairs, Foreign Trade and Immigration.

The three men have not yet been sentenced for the crimes to which they respectively pleaded guilty, but Hon. Cervantes, Jr., told reporters that his family is allowed to submit Victim Impact Statements to sway the court's sentencing decision.

"On our side, we're also allowed to submit statements, victim impact statements, which will also be taken into account, I believe in the sentencing. So, [as] I said, we're more than halfway there, and I think in the sentencing again, the best that our legal justice system can do will be done," Hon. Cervantes, Jr., noted.

The alleged mastermind behind the abduction and murder of Cervantes, Sr., however, is still at large. Manuel Castillo, also known as "El Pelon", was also named in the charge sheet, but escaped from the country along with his common-law wife, Avicela Duran leaving behind their home in Orange Walk. However, Duran has returned to the country and has cleared her name of any allegations of wrongdoing in connection with the abduction/murder. Castillo, however, remains at large. Cervantes mentioned that he had spoken to the Commissioner of Police, Chester Williams, numerous times regarding the matter, but there has been no progress in efforts to locate and detain Castillo.

"I have spoken to the Commissioner of Police a few times, and he said that it's with Interpol. I hope more movement would be done on that part, from the part of the police. I really hope that they take it more seriously and press on it, but that's what the Commissioner has told me—it's with Interpol," Cervantes, Jr. mentioned.

Cervantes, Jr., expressed his gratitude to everyone who supported him and his family in the aftermath of the tragedy.

"I just want to thank everyone who supported us during all this time. Nothing can bring back our father, but his legacy lives on. We should follow his good example and let always good things come out of it. I want to thank the people of Orange Walk, of Belize, everywhere. Thank you for being supportive of us. Thank you for being there for us always," he said.

After appearing before Justice Herbert Lord, the three alleged killers were taken back to the Belize Central Prison to await sentencing, which is scheduled to take place on March 28. There will be a mitigation hearing on March 23.

The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). The main beneficiaries of the Project are: (a) the Government, which will have more revenues to implement its public policies; (b) taxpayers, who will have more support and a digital environment to fulfil their tax obligations; and (c) the population, from the government policies implemented. Through this project, the Belize Tax Service Department (BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS)) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

The BTSD management has identified the need for a modern audit approach based on risk analysis. The BTSD Strategic Plan states that:

"BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. As an important aspect of the RMP, risk mitigating strategies will be proposed for application against potential and existing risks. The plan will highlight all areas of risks including risk-based assessments, risk-based audits, risk-based sector and taxpayer segmentation, compliance risks (registration, filing, reporting and payments) and international risks. Risk mitigation reduces the extent of exposure and ensures that the strategic objectives are achieved."

The consulting services ("the services") includes the contracting of a consulting firm for a period of ten (10) months to Prepare, Implement and Execute a New Audit Model, making use of the range examination and risk-based techniques (to include analytic tools for audit). The main activities of the consultancy include:

- 1. To assess the status of BTSD taxpayer audit strategies and operations for all tax type.
- 2. To review the Audit Division organization and resources, as well as the staff skills.
- 3. To suggest the strategy for centralization/decentralization of the audit.

Court extends injunction against CWU

from disbursing a \$1.5-million ex-gratia payment to stevedores who belong to the union. They will have to wait until May 10 and 11, when the court will further hear a case brought by their employer, the Port of Belize Limited(PBL), seeking to block the exgratia payment that was made to the aggrieved workers on the waterfront. This week, during the budget presentation in the House of Representatives, Prime Minister John Briceno rose to introduce a supplementary appropriation bill to approve the \$1.5 million payment to the stevedores. This bill is now set to go to the Senate this Friday for final approval. But the claimant, PBL, via its attorneys, has thrown another curveball at the union and government, and is now claiming that the payment should have been made from a contingencies account, which remains dormant and uncapitalized.

During this week's sitting of the House of Representatives, Prime Minister Briceno stated, "Regrettably, quite apart from the impact on the Port and stevedores that these disputes caused, the wider implications of shutdowns and work stoppages at the Port are all too obvious. Commerce is held at ransom. Paralysis in the import and export process, even for a few hours can cause substantial commercial losses across the economy, drive up the price of goods and create scarcity essential imports. The Supplementary Appropriation Bill, which I now table for consideration, is for the ex gratia payment of 1.5 million dollars, as agreed between the Port Authority of Belize, Ministry of Public Utilities and Logistics, and the Christian Workers Union on behalf of the stevedores, in a Memorandum of Understanding signed on February 3, 2022. This one-time payment recognizes that circumstances at the Port of Belize have changed since privatization in 2002, in other words, that certain commitments the stevedores understood were made to them have evolved in a different manner than they understood them to be."

In reference to the dire impact of the standoff between PBL and the stevedores in January and the unforeseen and urgent nature of the issue he added, "Given that just over a month, at the height of the standoff, hundreds of containers were stranded, ships were being turned away from Belize, millions of dollars in imports and exports came to a standstill, millions of dollars in tax revenues were being lost, and the business climate stood to suffer potentially irreparable damage, Government judged that there was an urgent and unforeseen need to settle this matter promptly, and did so upon the terms set forth in the MOU. These terms included the immediate resumption of work at the Port by stevedores, and payment by Government to the stevedores of the sum of 1.5 million dollars in a timely manner, which the government duly effected."

The Memorandum of Understanding signed between the government and the CWU was effected in late February, and the CWU immediately commenced

efforts to put processes in place and get the necessary paperwork ready to pay over a hundred stevedores their portion of the humble payment on February 28, the date set out in the agreement for the payment. That process was brought to an abrupt halt by the injunction, which apparently resulted in a blockage of other important bank accounts needed for the CWU to pay its expenses. The president of the CWU had even told reporters that as a result of the injunction they had become a "financial pariah".

In a recent interview, Hector Guerra, one of the attorneys for the claimant, said that the case hinged on the government's issuance of the ex-gratia payment without the requisite parliamentary approval. He had stated, however, that even if the approval was granted they would revisit the matter (an apparent indication that they would find other legal grounds for blocking the payment).

This Friday, a Senate meeting is scheduled, and it is expected that the supplementary appropriation for the \$1.5 million will be rubber-stamped by the upper house at that meeting. Despite this, the attorney for the claimant, Godfrey Smith, in an interview today, presented a new narrative:

"It must come, according to the Constitution, not from the Consolidated Revenue Fund but from another fund called a Contingencies Fund, and it appears that the payment did not come from that," Senior Counsel Smith said.

He added, "the government can in a legitimate situation of urgent and unforeseen expense, must be genuinely urgent and definitely unforeseen, you can by special warrant make an expenditure, but it must come from a Contingencies Fund set up for that purpose into which monies have been voted for these unforeseen expenses. And then when you spend it out, you have to go back and take the appropriate document appropriations to parliament to replenish it. The government did set up this Contingencies Fund last year when it amended the Finance and Audit Reform Act and introduced the Contingencies Fund, but it appears that no monies have been put into it. So, put simply, you cannot, the Constitution does not allow you, even if it is urgent and unforeseen, even if it's legitimately urgent and unforeseen, you cannot draw it from the Consolidated Revenue Fund, it has to come from a special fund."

As we have previously reported, the Contingencies Fund was established about 6 months ago, in October of 2021, and makes provision for issuance of urgent and unforeseen payments where no other law is available. The issue with the argument from the claimant's attorney is whether or not the Contingencies Fund has even been activated - since it has not been capitalized since its establishment 6 months ago. The amendment to the Finance and Audit Reform Act, however, outlined that such capitalization should take place at the start of the fiscal year.

As mentioned, the budget for the Financial Year 2021-2021 was read sometime in April 2021. This amendment to the FARA was gazetted

in October of the same year. The most recent budget has been presented and will be debated in a matter of days, but there is no indication as yet if the established Contingencies Fund will be capitalized.

Senior Counsel Godfrey is claiming, in reference to the recent judgment of Chief Justice Michelle Arana, that the case will be used to shed light on the grey nature of this area of law -- as it relates to the authorization of expenditure from government coffers. To a number of Belizeans, however, what seems more likely is that the judgement to which he refers is being used as a pretext by PBL and its affiliates to extend the economic pain that the injunction has caused to the stevedores

The entity that Smith is currently representing in this case appears, on the surface, to be using a comparatively small payment, of a little over \$1 million dollars that was paid to address the hardships suffered by the stevedores, as the basis for making a legal point. It is to be noted, however, that this entity—believed by most Belizeans to be a cluster of entities (PBL, Waterloo Enterprises, Belize Bank Limited) controlled by the "Ashcroft Alliance"has been known to readily join any case in which it has even the slightest of interest, as an "interested party". Yet, there is no indication that they in any way made any attempt to be involved in the case brought against the former prime minister, Rt. Hon. Dean Barrow, for the spending of \$1.3 billion literally a thousand times more than the amount given to the stevedores without parliamentary approval. There seemed to be have been no interest on the part of the alliance at that time. It might also be interesting to note that there was no objection by the alliance that reportedly controls PBL over a decade ago when the then PUP administration provided the Belize Bank with a government guarantee for a private loan to a private healthcare facility without receiving Cabinet's approval. And the records do not indicate that any protests or objections were put forth by that alliance when that administration proceeded to divert funds granted to the country for public purposes to the Belize Bank in an attempt to settle that debt.

In a May 2007 issue of the AMANDALA, entitled, "Belize Bank will defend UHS guarantee in court," it was noted that it was the Association of Concerned Belizeans that brought a case to the court in an effort "to restrain the Government from paying the guarantee [to Belize Bank] without first getting permission from the National Assembly. The article further said, "The claimants say that the Government guarantee of the UHS debt was unlawful, because neither Cabinet nor the National Assembly had approved it, and therefore the Government should not pay it. The Government and the Belize Bank disagree." Again, there was no objection to this type of arrangement by the "Ashcroft Alliance"— of which the Port of Belize Ltd. and the Belize Bank (both of which were involved in the privatization that affected the stevedores) are said to be a part. This is the very entity that is now being represented in the attempt to block payment to the stevedoressupposedly with the aim of upholding parliamentary processes.

Senior Counsel Godfrey Smith unabashedly remarked to reporters, "What this whole case is about is the manner in which you go about making expenditure of public monies, taxpayers' monies from the public purse. It comes at a very opportune time because ...the judgment of former Chief Justice Kenneth Benjamin where he made certain pronouncements in terms of whether you could validate expenditure with supplementary appropriations, some doubt has been thrown into because of the failure of a perfected order and so on. So the issue, of the law remains unsettled and it needs to be clarified. "

Justice Lisa Shoman accepted that this question was of a serious enough nature to grant the extension of the interim injunction until the resolution of the matter in the two-day session scheduled for May 10 and 11. Until then, the payment which was to have been made to stevedores almost three weeks ago, and which has since received the approval of the House of Representatives, is still effectively blocked.

conclusion to the complainant, despite requests." The witness, who according to reports had indicated she feared for her life, had at some point provided another statement that was later deemed to be unreliable.

Vidal also told *7News* that she had never received any indication that there was an audio recording, and that the police officer who, according to Mai, had made reference to the existence of an audio recording, had denied having any knowledge of it when asked about it.

It is to be noted as well that, according to *7News*, Vidal has stated that she was never informed that Mai had been

seeking to meet with her.

According to *7News*, Vidal also pointed out that the period within which Mai can seek to appeal the ruling will not commence until a written judgement has been delivered, but the DPP expressed doubts that an attempt to appeal the verdict would be successful.

Mai is seeking assistance to file a civil suit but needs assistance to do so.

"The attorneys are there. They are there ready to take up the challenge, but as you know, to even sit and talk to an attorney, it costs money," noted Mai.
