Belize "legalizes it!"

The bill for the legalization of cannabis, read for the third time today, was supported in its drafted form by the government side in the Senate, but due to serious concerns raised, further amendments will be announced.



BELIZE CITY, Thurs. Mar. 31, 2022 Yesterday, the Senate passed into law the Cannabis and Industrial Hemp Control and Licensing Bill of 2022, which, in conjunction with the recently amended version of the Misuse of Drugs Act, legalizes the recreational use, commercial production and sale of cannabis throughout the country of Belize. The laws legalize cannabis use for adults only and put in place a framework for the rollout of the



Senate yesterday, the budget for this coming fiscal year, 2022-2023, was passed into law. The 1.3-billiondollar budget is reportedly the largest in Belize's history, but according to the Prime Minister, it is being rolled out at a time when stormy economic headwinds are projected. Senator Eamon Courtenay, Leader of Government Business in the Senate, went to great lengths during his defense of the budget to present a catalog of accomplishments of the current administration that resulted from what he considers prudent management over the last year.

"The projected outturn, as set out in the revenue estimates, is one billion, one hundred and ninety-two million, approximately nineteen



Businesses pledge to support safe houses for domestic violence survivors

BELIZE CITY, Tues. Mar. 29, 2022 The National Women's Commission (NWC) partnered with Ministry of Human the Development, Families, and Indigenous Peoples' Affairs as well as the UN's Spotlight Initiative this Tuesday to host a signing ceremony during which a number of companies and local businesses pledged ongoing support to safe houses that provide shelter for domestic violence victims. Those enterprises included the Belize Water Services Limited, F.T. Williams & Associates, and FAST Construction. The area representative for Belmopan, Hon. Oscar Mira, and Belize City Councillor Javier Castellanos were also there to pledge their support.

According to a press release issued by the NWC, the commission has been working towards enhancing the quality of services provided by safe houses, including providing added training to safe house workers and volunteers. The commission has noted that there is an urgent need for the sustained upkeep of these shelters, as they play an important role in protecting displaced victims (and survivors) of gender-based violence or human trafficking as well as their children.

In addition to thanking those entities which pledged their support, the National Women's Commission also encourages other businesses to commit to the ongoing initiative.

LIU begins school outreach program

BELIZE CITY, Wed. Mar. 30, 2022 As part of a Ministry of Home Affairs initiative aimed at steering youths who live in gang zones, away from a life of crime, the Leadership Intervention Unit embarked on a school outreach program earlier this week. On Monday, personnel from the LIU made a stop at the first of several Belize City schools that the unit plans to visit: Maud Williams High School. Then, on Wednesday, March 30, the LIU went to Gwen Lizarraga High School, where they spoke with 30 teens of varying ages.

"What transpired is a school outreach program that we're presently having within the different schools in Belize City. This is a collaboration the Leadership Intervention Unit is doing with the Ministry of Home Affairs, the

Ministry of Youth and Sports, and, of course, the Police Department, the Community Policing Unit. We're trying to wrap around service to support students who are in school. We know that many times gangs target young boys and girls going to school, and we think it's very important to engage [with] these young people who are in school to make sure that they understand that there's a support system that is available to help them get through school and life in a whole in Belize City," explained William Cadle, chairman of the LIU.

Cadle further remarked, "It's no secret that parenting is an issue here in Belize. In some instances, some of these young [people] really don't have that level of nurturing and assistance from their parents, and we can not play a blind eye to this. It's really evident in the classroom setting, and when you meet these young people, the lack of respect and discipline, and so in that regard we are very much cognisant that it is important to look at the root cause of crime and violence."

Anthony Campbell, a former member of the PIV gang, accompanied the members of the unit on their visit to the two high schools and spoke to the students.

"In life, you need to have people that will help guide you. Sometimes we out here don't have someone that can we can express our problems to, somebody to talk to, because some people feel because they are [a] certain level, so you're nobody. But [few] things someone listens and says can make a difference in a youth's life. This can make a youth be someone different, even though we're not seeing it. Some are here laughing and some are taking it seriously. Like right now, a little one said that he wants to talk to me. Why? Because he feels the inspiration," said Campbell.

The LIU chairman noted that the Ministry of Home Affairs has been conducting a family needs survey, which has entailed interviewing "different families to find out what their needs are" in an effort to determine "the necessary assistance that some of these family need and create that support system holistically for all the individuals across the country." He pointed out, however, that "Belize City is where the hub of violent activity [is]", and thus the initial efforts of the unit and the Home Affairs Ministry will be targeted at Belize City youths and their families. "...We're starting here and then we branch out to the districts," he said.

Teen dies in 3-vehicle collision

Delso Antonio Alveno, 19, a resident of Orange Walk, died in a 3-vehicle collision on the Philip Goldson Highway.



occurred at about 7:30 on Tuesday night as Alveno was heading to Belize City from Orange Walk.

Initial police reports indicate that the dump truck, which was being driven by Steven Laing, 27, an Orange Walk Town resident, was heading in the direction of Orange Walk Town, when, somewhere between Miles 37 and 38, the Saturn Vue driven by Alveno allegedly crashed into the front of the truck. after which the Ford F-150, which was being driven by Jose Hernandez, 40, a resident of San Estevan village, hit the rear end of the truck. When police arrived at the scene, Alveno was trapped inside his vehicle, while the dump truck was parked on the right side of the highway with extensive damage to its front portion and the Ford F-150 behind it. Alveno was retrieved from his vehicle and transported to the Karl Heusner Memorial Hospital for medical attention but succumbed to his injuries and was pronounced dead on arrival. Laing and Hernandez, on the other hand, received only minor injuries.

pending an investigation. According to a friend of an eyewitness of the accident who was interviewed by *7News*, however, Laing might not have been at fault.

"... MOFA cracking down on illegal migrants/human trafficking

"Belize has a serious migration problem," said Hon. Eamon Courtenay, who has proposed that the Ministry of Foreign Affairs begin to further enforce immigration laws.

BELMOPAN, Tues. Mar. 29, 2022 In today's meeting of the Senate, Minister of Foreign Affairs, Foreign Trade, and Immigration, Hon. Eamon Courtenay addressed the increasing number of undocumented migrants entering the country, remarking that Belize currently has a "serious migration problem." According to Hon. Courtenay, to solve this problem and reduce the number of illegal migrants entering the country, as well as the number of trafficked persons and persons using Belize as a transit point, the ministry will be enforcing local immigration laws. He added that the Ministry will be working diligently to reduce the flow of illegal migrants into Belize-stating firmly that "the laws of Belize will be applied." "Efforts—and I'm going to be clear and unapologetic-efforts continue up until this very morning to attempt to undermine the laws of this country. People pretending that they are representing people who want refugee status, people pretending that they're representing people who should not be repatriated as the law requires. Madam President, there is a serious migration problem in this

country," stated Minister Courtenay. A huge part of the problem, says Hon. Courtenay, is the fact that persons continue to arrive in Belize posing as asylum seekers before fleeing to other nations shortly after.

The Ministry's crackdown on immigration recently resulted in the detention of a group of nine Cuban nationals—seven adults and two minors-who were detained after being caught attempting to enter the country undocumented on February 15. This week, after having spent 50 days at the Kolbe Foundation, those persons narrowly escaped deportation and would have been placed on a flight to Cuba had the Human Rights Commission of Belize not intervened on the basis of the "Great Writ" of Habeas Corpus, a fundamental constitutional right that protects persons against unlawful imprisonment by demanding they be subjected to a fair trial in court before any action is taken against them. Previously, in January, AMANDALA reported on the authorities' initial decision to denv entry to 37 passengers who arrived at the Philip Goldson International Airport aboard a COPA Airlines flight. While some of those passengers were eventually

repatriated, eight of them, all Venezuelan nationals, were allowed to stay after stating that they wished to seek refugee status. Those persons never made it to the Immigration Department to apply for asylum, however, and reports quickly surfaced that they had left the country en route to Mexico. During his address in the Senate, Minister Courtenay suggested that incidents such as these have been continuously occurring. in migrants as persons flee their homes in search of a better quality of life, in search of better opportunities, or out of a fear of persecution, with most of them headed to North America. As a result of this, many organizations, including the Center for Migration Studies of New York and the American Immigration Council, have begun to propose that governments pursue alternative-and more humane—approaches to tackling the migration issue rather than resorting to the detention and subsequent deportation undocumented immigrants who are often in need of protection, as they are the most at risk of being trafficked or exploited.

These two incidents and the countless others that have occurred, however, are the telltale signs of not only a migration problem but issues that are much larger, which according to UNICEF

New publishing company seeks to spark literary renaissance

Bent Pin Press has published its first anthology of Belizean poems and prose.

The first issue of an annual anthology of Belizean poems and prose was officially released last Saturday by the newest publishing enterprise in the country, Bent Pin Press. The process started in March 2021, and culminated with the publication of *Issue No. 01*, which features the work of 17 Belizean storytellers whose poems and short fiction pieces made the final cut from a pool of nearly 200 submissions, according to the editor-in-chief of Bent Pin Press, Samantha Singh.

"It's definitely been an adventure," Singh stated, "there's been a lot of ups and downs, and it's also been a learning process for me, for sure, but it's been so rewarding. It's been so great to work with so many different writers within the country."

That collaboration came from an effort to support Belizean writers and to reinvigorate Belize's literary culture while creating a platform through which local artists can gain international exposure.

"I think that the real reason why we wanted to start Bent Pin Press is, we really are interested in supporting the writing community locally. It's a personal passion, I think.... To be able to provide another place for the writers in Belize to come together and work together was really the push, and I think more than that, we wanted to have a place that is both Belize and a part of the international community, so really I think those two principles together are why we wanted to found Bent Pin," Singh explained. While the editorial board had no set theme in mind initially for this first issue, they said that truly intimate Belizean experiences seen through the eyes of the Belizean authors is a refrain in the content that reverberates through the entire anthology. Singh noted, "What we ended up with, I think, came together to represent a truly Belizean experience, a very intimate personal experience that Belizeans can relate to. They are pieces as opposed to speaking to Belize as a tourism destination or a place to visit or a place that is beautiful, it spoke to the Belizean experience and living as a Belizean."

Andre Habet, the assistant editor of Bent Pin Press, pointed out that targeting unpublished and up-andcoming talented writers was also a primary motivation.

"There were a lot of people who felt like their work did not have a home space to go towards. They couldn't imagine who would be interested in it, and so when Samantha started announcing Bent Pin Press coming about to me, I was interested in us finding those people, the people who have been writing privately for a very long time and just really

because of lack of experience, because of lack of apprenticeship, they didn't know what it would take to get their work published, and so in one way Bent Pin Press serves as an entry point to people who I hope are published much more widely published beyond Bent Pin Press right," Habet said.

He added, "This is hopefully just the start for them, that not only are they published here, but hopefully through other workshops, through other panels in the future we can do. I want Belizean writers to be elevated to where you know when somebody goes to a store in the United States, in the UK, in our Caribbean sisters and brothers' countries, that they go in a store and they see a book by a Belizean author, they recognize that name from maybe some other journal, and they want to pick up a book, you know, pick up a novel, pick up a book of poetry."

One of the writers whose poetry is featured in this first issue of Bent Pin Press's literary journal is the author of Crossroads: A Collection of *Poems*, Khaila Gentle, who is incidentally, also a staff writer with us here at AMANDALA. Her dexterous style of storytelling has already captivated many in Belize and abroad, with her book of poems is receiving praise and respect from various quarters. In reference to the selection of writers such as Gentle, the assistant editor of Bent Pin Press, Andre Habet, said, "it's really just wise on our part to hitch our bandwagon on to the people who are gonna be stars."

The team at Bent Pin Press includes its publisher and editor-in-chief, Samantha Singh; co-editor, Bianca King; and assistant editor, Andre Habet. These three are also readers of the pieces, along with Gisselle Hernandez, who is responsible for public relations, and Alina Scott.

Issue No. 1 features cover artwork by Taiwanese-Belizean artist Yaoling Lee. The cover image is one of her many personal sketches depicting everyday life in Belize. In the scene featured in this particular piece of art, people are buying fast food at a popular joint in the heart of the city, Fibbers. Singh said that her stumbling upon the piece turned out to be serendipitous, since it meshed perfectly with the mood of the overall publication.

"It's not the sort of piece that she typically sells; those are her sketches, personal pieces for her, as she shared with us, but it's about the beauty that she sees in parts of Belize that other people don't that I think is the spirit of a lot of pieces and the sort of work we are looking to publish," Singh shared.


percent higher than was budgeted. On the expenditure side, the recurrent expenditure of one billion, two hundred and seventeen million was slightly higher than budgeted. Madam President, on any measure, on any reckoning, that is prudent stewardship by the Honorable Prime Minister and the team in the Ministry of Finance. Let us not forget, Madam President, let us not forget the historic Blue Bond negotiated by the People's United Party and concluded by the People's United Party. It was this government, history will recall, that vanquished the Super Bond that was a noose around our collective necks for far too long. It was this single, brilliant Blue Bond transaction that caused this public debt – the public debt of this country, to move from one hundred and thirty-three percent of GDP to one hundred and eight percent of GDP, twenty-five percentage points, Madam President." A referendum could only delay the inevitable

Last week *Krem News* reported that a handful of pastors, members of the National Evangelical Association (NEAB) and Roman Catholic priest, John Robinson had gathered at the National Assembly steps to show their disapproval of the Cannabis Control and Licensing Bill, 2022 that was being introduced in the National Assembly by the Minister of New Growth Industries and Home Affairs, Hon. Kareem Musa. The religious leaders had been vociferously in favor of marijuana remaining a wholly prohibited product, when a previous government moved to decriminalize 10 grams of the drug for personal use, in 2017, and now that a government is moving toward freeing up the drug even further, the religious leaders have stepped up their offensive.

The World Health Organization softened its position on marijuana for medicinal use in 2020, moving it from its list of "most dangerous drugs", but this change has had no influence on pastors in Belize. They might give an ear to medical marijuana, but they don't want us to grow it. They consider marijuana a deadly drug, and they're pushing for a referendum, with the hope that the people would vote against legalizing it for recreational use and maybe even turn back the decriminalization of 10 grams. Judging from what is taking place in Mexico, where they are close to legalizing recreational marijuana, and the US, where many states have done so, a referendum in Belize could only achieve a delay of the inevitable.

In the US, it is by way of referenda that recreational use of marijuana is now legal in a number of states in that country.

At the fore in lobbying for states to vote on the status of the drug is the US's "Marijuana Policy Project", a nonprofit organization based in Washington, D.C. which was founded in 1995 with the stated vision to create "a nation where marijuana is legally regulated similarly to alcohol, marijuana education is honest and realistic, and treatment for problem marijuana users is noncoercive and geared toward reducing harm."

One by one, states in the have been USA decriminalizing or legalizing marijuana for recreational BALLOTPEDIA, use. а nonprofit, nonpartisan online political encyclopedia in the US, states that by mid-2021 eighteen states in the US had already legalized recreational marijuana. Legislators in the US are on the verge of regulating marijuana similarly to the way that alcohol is regulated all across that nation. In Belize, our government is moving toward alcohol-type regulations to control marijuana, but not without great resistance. Former government minister, Wilfred Elrington, wrote last week in a column in The Reporter titled "Dons, Dealers and

Dors" that "the evidence is irrefutable that the legalization of marijuana does much more harm than good to the poor and the powerless in those societies where it has been legalized!" Mr. Elrington did not cite his sources, but it is generally accepted that marginalized persons are more at risk than their better off peers.

The local lobby against legalizing marijuana has opined that if the drug were to be given such status by GOB, it would be interpreted as a blessing and lead to explosive use of it by our nation's youth. In every aspect of their lives, more has to be done for this group, but on the whole legalizing marijuana is not the great threat to them that many make it out to be. In Colorado, where recreational use of marijuana was legalized in 2012, the Colorado Department of Public Health and Environment said "the proportion of Colorado high school students reporting using marijuana ever in their lifetime remained statistically unchanged between 2005 and 2019."

Pastor Robinson, in making the Catholic Church's case against legalization, spoke about a visit he made recently to an area in California, USA. Pastor Robinson said California, "one of the richest places in the world…legalized recreational marijuana back in 2016 (and) it is now unrecognizable, with homeless people living in the streets…many or perhaps most of them are addicted to drugs." Greg Rosalsky, in a discussion of homelessness in California aired on the highly regarded *NPR*, said the president of the National Alliance to End Homelessness, Nan Roman, said the root cause of people living in the streets of California is that "housing has gotten way too scarce and expensive." Rosalsky mentioned poverty, mental illness and chronic drug use as contributors to the problem.

Pastor Robinson said if parents "cannot stand up and say no to this bill, how can we expect our children to say no to drugs?" The *Amandala* respects the position of the churches and all the advocates who work to deter the use of drugs and alcohol. This newspaper stopped accepting advertisements for cigarettes decades ago, and while it has criticized the state's 'roughing up' of Rastafarians who use the drug in their religious ceremonies, it has never encouraged the smoking of marijuana. However, there are adults who like the drug, and making it illegal has been disastrous.

The determined Mr. Elrington, in his story in *The Reporter*, said "the dealers, dons, and dors, easily compromise our political and public service elites making it virtually impossible for them to carry out their duties in the best interest of our country." As observed in the US, prohibiting alcohol led to the corrupting of their political leaders and security forces, and caused mayhem in the streets as gangs fought each other for a share of the illegal gains. A wise man somewhere said *insanity is doing the same thing over and over and expecting different results.* The US, recognizing the folly of prohibiting the drinking

Honduran Supreme Court orders extradition of former president

The Honduran Supreme Court has ordered that Juan Orlando Hernández, former two-term president of Honduras, be extradited to the US on drug trafficking and firearms possession charges.

TEGUCIGALPA, Honduras, Wed. Mar. 30, 2022

The Supreme Court in Honduras has authorized the extradition of the country's former president, Juan Orlando Hernández, to the United States, where he will be facing drug trafficking and firearms possession charges after being accused by US prosecutors of participating in a wideranging drug-trafficking scheme between 2004 and 2022.

An unprecedented investigation, which highlights Honduras' role as a critical transit point for the smuggling of massive amounts of cocaine from South America to the United States, uncovered evidence indicating that the former president allegedly shielded persons engaged in the illicit activity. According to Honduran news outlets, Hernandez accepted millions of dollars in bribe money in exchange for protecting drug traffickers from investigation and prosecution as well as aiding those persons in the use of weapons, which include machine guns.

While Hernandez has denied all claims made against him, he was arrested in mid-February during an expansive stakeout at his home and since then, he has been in police custody.

A statement issued by the family of Hernandez pointed out that the decision made to extradite the former president does not amount to a criminal conviction. The statement further claims that the accusations are in fact the handiwork of Honduran narcos themselves.

"We're ready and confident that

we'll be able to show the U.S. justice system that these accusations are a revenge plot from Honduran narcos whose empire of crime and violence Juan Orlando destroyed," the statement asserted.

Hernandez's lawyer, Hermes Ramírez, told Honduran media that his client was ambushed by authorities and claims that the warrant used is illegal, because he has immunity as a member of the regional Central American parliament.

"They are trying to trample on the rights of President Hernandez," Ramirez said.

Tony Hernandez, the former president's brother, is currently serving a life sentence with an additional 30 years in a US federal prison in connection with a related drug trafficking investigation. US

authorities believe former president Hernandez was a co-conspirator in the operation, channeling drug money to help fund his presidential campaigns. However, those allegations have been denied by Hernandez.

Hernandez was replaced as president last month by leftist leader Xiomara Castro, Honduras' first female president, after serving 8 years in office.

Un referéndum solo podría retrasar lo inevitable

La semana pasada, Noticias Krem informó que cinco pastores, miembros de la Asociación Evangélica Nacional (NEAB por sus siglas en inglés) y el sacerdote católico romano, John Robinson, se habían reunido en los escalones de la Asamblea Nacional para mostrar su desaprobación del Proyecto de Ley de Licencias y Control de Cannabis, 2022 que estaba siendo presentado en la Asamblea Nacional por el Ministro de Nuevas Industrias de Crecimiento y Asuntos Internos, el Honorable Kareem Musa. Los líderes religiosos habían estado a favor de que la marihuana siguiera siendo un producto totalmente prohibido, cuando un gobierno anterior se movió para despenalizar 10 gramos de la droga para uso personal, en 2017, y ahora que un gobierno está avanzando hacia la liberación de la droga aún más, los líderes religiosos han intensificado su ofensiva.

La Organización Mundial de la Salud relajó su posición sobre la marihuana para uso medicinal en 2020, moviéndola de su lista de "drogas más peligrosas", pero este cambio no ha tenido influencia en los pastores en Belize. Puede que quieran prestar atención a la marihuana medicinal, pero no quieren que lo cultivemos. Consideran que la marihuana es una droga mortal y están presionando para que se lleve a cabo un referéndum, con la esperanza de que la gente vote en contra de legalizarla para uso recreativo y tal vez incluso revoquen la despenalización de 10 gramos. A juzgar por lo que está pasando en México, donde están cerca de legalizar la marihuana recreativa, y en Estados Unidos, donde muchos estados lo han hecho, un referéndum en Belize solo podría lograr un retraso de lo inevitable.

En los EE. UU., es a través de referéndum que el uso recreativo de la marihuana ahora es legal en varios estados de ese país. A la vanguardia del cabildeo para que los estados voten sobre el estado de la droga se encuentra el "Proyecto de política de la marihuana" de los EE, una organización sin fines de lucro basada en Washington, D.C., que fue fundada en 1995 con la visión declarada de crear "una nación donde la marihuana es reegulada legalmente, de manera similar al alcohol, la educación sobre la marihuana es honesta y realista, y el tratamiento para consumidores problemáticos de la marihuana no es coercitivo y está orientado a reducir el daño".

Uno por uno, los estados de EE. UU. han ido despenalizando o legalizando la marihuana para uso recreativo. BALLOTPEDIA, una enciclopedia política en línea no partidista y sin fines de lucro de los EE. UU., afirma que, a mediados de 2021, dieciocho estados de los EE. UU. ya habían legalizado la marihuana recreativa. Los legisladores en los EE. UU. están a punto de regular la marihuana de manera similar a como se regula el alcohol en toda esa nación.

muchos pretenden. En Colorado, donde se legalizó el uso recreativo de la marihuana en 2012, el Departamento de Salud Pública y Medio Ambiente de Colorado dijo que "la proporción de estudiantes de secundaria de Colorado que informaron haber usado marihuana alguna vez en su vida se mantuvo estadísticamente sin cambios entre 2005 y 2019".

El pastor Robinson, al presentar el caso de la Iglesia Católica en contra de la legalización, habló sobre una visita que realizó recientemente a un área en California, EE. UU. El pastor Robinson dijo que California, "uno de los lugares más ricos del mundo... legalizó la marihuana recreativa en 2016 (y) ahora es irreconocible, con personas sin hogar viviendo en las calles... muchos o quizás la mayoría de ellos son adictos a las drogas". Greg Rosalsky, en un debate sobre las personas sin hogar en California que se transmitió en la prestigiosa NPR, dijo que el presidente de la Alianza Nacional para Acabar con las Personas sin Hogar, Nan Roman, dijo que la causa fundamental de que las personas vivan en las calles de California es que "las viviendas se han vuelto demasiado escasas y caras." Rosalsky mencionó la pobreza, la enfermedad mental y el uso crónico de drogas como contribuyentes al problema.

El pastor Robinson dijo que si los padres "no pueden levantarse y decir no a este proyecto de ley, ¿cómo podemos esperar que nuestros hijos digan no a las drogas?" Amandala respeta la posición de las iglesias y de todos los defensores que trabajan para disuadir el uso de drogas y alcohol. Este periódico dejó de aceptar anuncios de cigarrillos hace décadas, y aunque ha criticado el "maltrato" por parte del estado a los rastafaris que usan la droga en sus ceremonias religiosas, nunca ha fomentado el consumo de marihuana. Sin embargo, hay adultos a los que les gusta la droga, e ilegalizarla ha sido desastroso.

El determinado Sr. Elrington, en su nota en The Reporter, dijo que "los traficantes, los capos y los vendedores comprometen fácilmente a nuestras élites políticas y de servicio público, lo que les hace prácticamente imposible cumplir con sus deberes en el mejor interés de nuestro país". Como se observó en los EE. UU., prohibir el alcohol condujo a la corrupción de sus líderes políticos y fuerzas de seguridad, y provocó el caos en las calles cuando las pandillas lucharon entre sí por una parte de las ganancias ilegales. Un hombre sabio dijo en alguna parte que la locura es hacer lo mismo una y otra vez y esperar resultados diferentes. Los EE. UU., reconociendo la locura de prohibir el consumo de alcohol, legalizaron las bebidas espirituosas allá por 1933.

Nuestros líderes de la iglesia no podrían ser criticados si están un poco celosos al ver a tantos miembros potenciales de sus rebaños que, en su desesperación por aliviar la angustia mental y fisica causada por la pobreza extrema y la vivienda inadecuada, recurren al alcohol y la marihuana en lugar de la Palabra. De hecho, sería grandioso ver los bancos repletos de almas ansiosas, pero en el mundo del libre albedrío, un regalo especial del Todopoderoso, las personas toman decisiones, y aunque es lamentable cuando tomamos decisiones no tan saludables, siempre y cuando no estemos interfiriendo directamente con nuestros vecinos, nuestros derechos deben ser respetados. Criminalizar la marihuana fue un desastre, y despenalizar 10 gramos es solo una tirita. Utilizar un referéndum para tratar de retrasar que el Gobierno de Belize tome el control de la producción, distribución y uso de la droga no ayudaría en nada. Lo que debemos hacer, mientras el Gobierno procede a legalizar la marihuana, es observarlos en cada paso del camino, para garantizar lo mejor para nuestra gente, con especial énfasis en nuestros niños y jóvenes para ayudarlos a mantenerse alejados de las drogas y el alcohol.

En Belize, nuestro gobierno se está moviendo hacia regulaciones similares al alcohol para controlar la marihuana, pero no sin una gran resistencia. El exministro de gobierno, Wilfred Elrington, escribió la semana pasada en una columna en The Reporter titulada "Dons, Dealers and Dors" que "la evidencia ¡Es irrefutable que la legalización de la marihuana hace mucho más daño que bien a los pobres y desamparados en aquellas sociedades donde ha sido legalizada!". Elrington no citó sus fuentes, pero en general se acepta que las personas marginadas corren más riesgo que sus pares en mejores condiciones.

El cabildeo local en contra de la legalización de la marihuana ha opinado que si el Gobierno de Belize otorgara tal estatus a la droga, se interpretaría como luz verde y conduciría a un uso explosivo de la misma por parte de la juventud de nuestra nación. En todos los aspectos de sus vidas, se debe hacer más por este grupo, pero en general, legalizar la marihuana no es la gran amenaza para ellos que

Wagner commended the awardees for their contributions, and highlighted the important role that women often play in society


"To all you fierce, accomplished, gifted women here today, I say good afternoon, and I want you to know that I am honored to be here before you. Your contributions to your households,

AMANDALA got the chance to speak with one of the awardees— Miss Lula Bennett, a renowned Belizean hairstylist and jewelry designer, who told us that she feels both humbled and grateful that her work is being recognized. "Serving is the greatest, you know, but sometimes we serve a lot, and people don't-even with your children-sometimes they don't recognize the effort that you do. But I'm glad that the Belize City Council looked at my portfolio and said, 'well you know, Lula's been contributing to the society, whether it's been doing hair or uplifting people, because when they come to your salon you uplift their spirit through the extra work that you do'," she said. Bennett told AMANDALA that she chose Open Door Believers Chapel as her charitable organization, and said that she is looking forward to seeing the children from Southside Belize that attend the church benefit from the donation that will be made on her behalf by the City Council.

The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). The main beneficiaries of the Project are: (a) the Government, which will have more revenues to implement its public policies; (b) taxpayers, who will have more support and a digital environment to fulfil their tax obligations; and (c) the population, from the government (BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS)) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

The BTSD management has identified the need for a modern audit approach based on risk analysis. The BTSD Strategic Plan states that:

"BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. As an important aspect of the RMP, risk mitigating strategies will be proposed for application against potential and existing risks. The plan will highlight all areas of risks including risk-based assessments, risk-based audits, risk-based sector and taxpayer segmentation, compliance risks (registration, filing, reporting and payments) and international risks. Risk mitigation reduces the extent of exposure and ensures that the strategic objectives are achieved."

The consulting services ("the services") includes the contracting of a consulting firm for a period of ten (10) months to Prepare, Implement and Execute a New Audit Model, making use of the range examination and risk-based techniques (to include analytic tools for audit). The main activities of the consultancy include:

- 1. To assess the status of BTSD taxpayer audit strategies and operations for all tax type.
- 2. To review the Audit Division organization and resources, as well as the staff skills.



1. the Belize Draft Specification for Marking and Labelling of Medical Gas Cylinders

Belize lacks standards in the medical gases industry especially when it comes to safety and most importantly life-saving oxygen and medical gases. This standard provides for minimum requirements for labels and markings on compressed gases in cylinders and cryogenic liquid container cylinders containing medical gases namely for medical air, oxygen, carbon dioxide, helium, nitrogen, nitrous oxide and mixtures. Labels shall be applied to compressed gases and cryogenic liquid containers to identify the container contents and to warn of principal physical and health hazards associated with the container and its contents.



The royal visit of the Duke and Duchess of Cambridge, Prince Williams and his wife Kate, came to an end with a visit to the Bahamas, where they were once again met by protest from residents. This time, the Rastafarian community in the country attempted to stage a protest in front of a primary school that the couple visited. They were reportedly removed from the area by police. In his remarks during a state dinner in Jamaica, Prince William aligned himself with the sentiments of his father, Prince Charles, who during a ceremony in Barbados at which the island officially became a republic, said, "the atrocity of slavery forever stains our history". During his

remarks William said, "I want to express my profound sorrow. Slavery was abhorrent. And it should never have happened."

While this statement falls short of an explicit apology, the remarks are being seen as unprecedented. A statement issued by Kensington Palace yesterday said that the duke took the opportunity to reflect, and admitted that the visit has brought a sharper focus on the past and how the peoples of the countries visited will decide upon their futures.

"I know that this tour has brought into even sharper focus questions about the past and the future. In Belize, Jamaica, and The Bahamas, that future is for the people to decide upon. But we have thoroughly enjoyed spending time with communities in all three countries, understanding more about the issues that matter most to them!" Prince Williams remarked in the release.

During Friday's sitting of the House of Representatives, Minister Henry Charles Usher, who had recently announced the establishment of the People's Constitutional Commission, said that in revisiting the laws of Belize, it may be time to revisit our governance structure, which means the people would choose whether or not the country should remain a parliamentary monarchy or become a republic. Another body that was recently established by the government is a Good Governance Unit, which, according to Minister Usher, will be the secretariat for the People's Constitutional Commission.

"The G.G.U., the Good Governance Unit, will also be the Secretariat for the People's Constitutional Commission, which will have a comprehensive look at the laws of Belize, including the Constitution, as well as the way we are governed. Madam Speaker, the process decolonization is enveloping the Caribbean region. Perhaps it is time for Belize to take that next step in truly owning our independence. But, it is a matter that the people of Belize must decide on," said Minister Usher. It must be noted that the UBAD Educational Foundation released an open letter to Minister Usher urging him to ensure that there is sufficient representation of the black Belizean community both locally and from the diaspora on the newly formed constitutional commission.

Woman raising funds for sick mom dies in RTA

Safira Teul, a 23-year-old mother of 3, died on Sunday in a traffic accident that occurred in an area between the San Roman and Maya Mopan villages in the Stann Creek District.

BELIZE CITY, Tues. Mar. 29, 2022 A young mother of three who had been delivering tamales made by her family as part of an effort to raise funds for her ailing mother, tragically lost her life after a traffic accident on Sunday morning, March 27. Safira Teul, 23, had reportedly been on her way back to her home when she was in an accident that occurred on the Southern Highway between the villages of San Ramon and Maya Mopan in the Stann Creek district at around 7:00 a.m.

She was reportedly seated in the passenger side of a vehicle that was heading from San Roman Village to her home in Maya Mopan when, as they drew near to a cemetery, there was a blowout of the left front tire of the vehicle near a curve. At that point, the driver lost control of the vehicle and it overturned—resulting in severe injuries to Teul that eventually led to her death.

Her brother, Christopher Teul, told reporters that a farmer who was on his way to his plantation saw the accident and rendered assistance. However, Safira succumbed to her injuries while being transported to the Southern Regional Hospital.

He said: "Luckily, there was a farmer that was heading to his farm on a motorcycle with his son-in-law on that same morning, and he was the first person to be on the scene. He actually saw when the vehicle was turning over and he responded and noticed that there were 4 occupants of the vehicle. He then sent his son-in-law to the field. because they were having a marathon on the field on that same day in the village. My brother was also on the field". "My sisters were doing delivery and the first thing that came to my mind was, 'this is my sisters', so he hurriedly got a vehicle and proceeded to the scene and that was when my sister, my little niece, and brother-in-law came

So the vehicle that my brother took to reach the scene, [he] carried them to the hospital [Independence Polyclinic], and then my sister was moved from the polyclinic to Southern Regional Hospital in Dangriga where she passed away in the ambulance," recounted Teul.

Safira Teul leaves behind 3 children all under the age of 7-yearsold, and Christopher Teul is pleading with the general public for financial assistance to partially cover the family's funeral expenses.

"My sister left behind her 3 children—her 6-year-old, 4-yearold, and 2-year-old daughters. If the public or anyone is willing to help financially in any way, they can; everyone is welcomed. I can be reached at 665-3358. I have a Belize Bank account ... Belize Bank's number is 214695010160000. Everybody is welcome to donate. We're still planning the funeral, as a post-mortem must be conducted on her, so we're just waiting to finalize when will be the wake and the funeral," he said.

ZEE EDGELL EULOGY

"LET MY THOUGHTS COME TO YOU WHEN I AM GONE, LIKE THE GLOW OF SUNSET AT THE MARGIN OF STARRY SILENCE"

RABINDRANATH TAGORE

How do you sum up a life entire in only a few minutes? How can you capture eighty years of an amazing, rich, beautiful existence in anything less than a novel? And how could anyone do so when the subject is Belize's most prolific and celebrated writer and a beloved teacher? Impossible.

Zelma Inez Tucker was born on Cleghorn Street, in Belize City, British Honduras, on October 21, 1940, to Veronica and Clive Tucker - a notable Creole Family; one of a bevy of siblings, some of whom I always refer to as the Fabulous Tucker Girls : Martha, Zee, Laura, Monica and Ava. Her brothers were Barry, Clive Jr., Alexander and Lenton. Her family was large and loving.

Zee, like many of us, attended Holy Redeemer School, and St. Catherine Academy, and it can fairly be said that she lived much of the time and places featured in perhaps her most celebrated novel, *Beka Lamb*. Zee Edgell's compelling novel of a span of time in the life of 14-year-old Beka Lamb is a redolent capsule of a bygone Belize City through the observant eye and knowing pen of a girl who was once herself 14.

This is how it begins: "On a warm November day, Beka Lamb won an essay contest at St. Cecilia's Academy, situated not far from the front gate of his Majesty's Prison on Milpa Lane."

And just then you have no doubt that this was here, in Belize, and it was about an SCA girl. It is so tempting—and I confess that I truly could not resist the temptation-to read Zee's debut novel, published a year after our Independence in 1981. to see if I could data-mine her work of fiction for clues about the young life of a writer who so obviously knew what she was writing about; a girl who, like Beka, was no "flat-rate Belize Creole, but a person with a 'high mind'". Like Beka, Zee was destined to make the shift from "the washing bowl underneath the house bottom to books in a classroom overlooking the Caribbean Sea" and we are all the richer for it.

Lest there be any doubt that Zee was destined to be a writer, you should know that at the tender age of

18, she worked as a trainee reporter at *The Daily Gleaner* in Kingston, Jamaica, in the late 1950s. These were heady, turbulent times in our Caribbean, and Zee was obviously alive to the struggle of Black Caribbean leaders for independence and self-determination.

In 1965, Zee earned a Diploma in journalism from Regent Street Polytechnic (now the University of Westminster) in England, and the following year, 1966, Zee began her first stint of teaching at St. Cecilia's Academy, I mean, SCA which was situated not far from the front gate of his Majesty's Prison on Gaol Lane.

While still teaching, Zee also became one of the founders of *The Reporter* newspaper in 1967, and in 1968, she met the wonderful Alvin George Edgell, who had come to Belize with the development agency, CARE. Al and Zee were married in Belize in 1968.

And in short order came the twin loves of their lives – Holly, a year later in 1969, and Randall in 1975. Al's work took Zee and the children to Nigeria, the United Kingdom, to Afghanistan, to Bangladesh and to Somalia — where he wound up his development career working for Save the Children.

Zee, Al and their young family settled in Belize City in the early 1980s and Al began to do consulting work and served as a lecturer at the emerging University College of Belize (now the University of Belize). Zee, in true triple threat Superwoman fashion, came home to teach again at SCA (where I had the honor to be in her class) and also served as the Director of the Belize Women's Bureau (also known as the Women's Dept.), 1981-82.

And if that were not enough, her debut novel, *Beka Lamb*, which was also the very first Belizean novel published after Belize gained its independence, in that same year earned the 1982 Fawcett Society Book Prize.

There should be no doubt that Zee cared deeply about women, development and our place in the new Belize. From 1986 to 1988, Zee served again as Director of the Women's Department under a different political administration.



• And in 2007, Time and the River, about Leah Lawson, daughter of a slave owner and a slave woman in Belize, dreaming of a better future and forced to make difficult choices.

Writers like Zee are gifted beings who hold up a mirror to our faces so that we are obliged to see who we are. There is no gift more precious, or more rare, and Zee had that by the bucket-full. And she clearly loved to teach. I can attest to the fact that she was a wonderful mentor, guide and teacher. In 1988-89, Zee served as a lecturer at the University College of Belize (now the University of Belize).

In the early 1990s, Zee was offered an assistant professor position at Kent State University in Kent, Ohio, and Al and Zee moved to Kent, where Zee became a professor of English with tenure from 1992 to 2009. She retired from Kent State University in 2009, as a full professor of English. Talk about a "high-minded person"!

In 2007, our Zee was made a Member of the British Empire for her services to literature and the community; and in 2009, she was awarded an Honorary Doctorate in Literature, from the University of the West Indies at Cave Hill, Barbados, 2009. I believe she is the sole Belizean writer so far to be so distinguished by my alma mater.

After retirement, Al and Zee moved to St. Louis, to be closer to Holly, Randy and Randy's growing family.

But Zee left her family (and us) too soon in 2020, but those of us who believe, know that she is with her soulmate of 52 years, the incomparable Alvin Edgell. Al and Zee are survived by their son Randall and his wife Emily Shavers Edgell, and their daughter Holly; as well as by three grandchildren: Isaac Edgell, Sophia Edgell and Simon Edgell.

This is but the skimming of the life of Zelma Inez Tucker Edgell. You will each no doubt have many stories, poignant, funny, memorable, to tell each other about her life, her times and her many deeds and accomplishments. Tell the stories; this is how you who are nearest and dearest to her, keep her memory alive. The rest of us will have her words, always – her four novels and her short stories – and they will teach us again and again, who we were, where we came from and who we are.

The GWU strike of October 1952

A nation-wide strike called in October 1952 by the GWU and in which the manual government employees participated was the high point of the PUP counter-pressure on the colonial government. Indeed, the strike demonstrated that the attempt to stifle the ascendancy of the PUP required much more than the establishment of a buffer electoral institution.

Secondly, the constitutional modification could not have been a gift, since the NP's negligible influence had thrown the burden of opposing the PUP onto the colonial administration. The defensive attitude which the Governor had adopted in the first few months of the political ferment in 1950 gave way to an offensive and belligerent approach.

Government pressure was exerted upon the two PUP allies, the GWU and the BELIZE BILLBOARD, to alter their relationship with the party. In October 1950, government communiques and advertisements were withheld from the newspaper. The boycott did not only deny the **BELIZE BILLBOARD** access to reliable information, but dealt it a serious financial blow.

The government also denied the **BELIZE BILLBOARD** the services of both its editors, Richardson and Goldson, when they were sentenced to imprisonment for eighteen months on charges of sedition against the

Governor in 1951.

It also attempted to discourage the GWU from supporting the party. In a letter to the GWU, it discredited the PUP leaders as demagogues interested in their "own personal and political ambitions ... and as tools in the hands of aliens, who, for their own purposes wish to embarrass the British government and to perpetuate a state of discontentment." The situation, the letter concluded, could only steel the employers in their opposition to labour.

This attitude in fact was particularly true in the case of the BEC, which continued to deny the workers in its lumber camps the right to join the GWU and placed all kinds of obstacles to the entry of union officials into its veritable domain. In other words, the British government's message to the union was clear and straightforward. If the latter needed to contract a marriage, as its President, Pollard, claimed in 1950, then it was incorrect of the union to conclude that it had "seen no other possible suitor eligible for such a marriage, except the PUP and the **BELIZE BILLBOARD.**" There was also the BEC which offered greater prospects as a partner.

This reaction was typical of colonial administrations. As B. C. Roberts has observed about the

Labor shortage pushing citrus industry to the brink of crisis


With citrus falling off trees and a shortage of workers in the fields, undocumented workers are traveling from Central America to fill the labor gap.

BELIZE CITY, Thurs. Mar. 31, 2022 Farms in the citrus belt of southern Belize have been bushhogged, and trees are covered with fruit that is already falling, but a dire shortage of field hands is pushing the citrus industry into crisis mode-with picking and bagging of citrus lagging behind (to an unprecedented extent) what would have typically been harvested at this juncture in the season. Native-born residents of the area, however, are reluctant to take on the back-breaking work of picking citrus and filling sacks to be deposited on trailers before finally being towed off to the juice-processing factory or sold on the local market. Each sack, almost completely filled, earns a laborer between \$1.00 and \$1.50, and one of those bags would be difficult to even lift.

It is against this backdrop in the citrus industry that, on Saturday, March 19, an anti-narcotics sting operation in the south resulted in the interception of 39 undocumented Central Americans who said they were enroute to pick oranges in one of the local orchards down south.

The bus was reportedly stopped near Maya King Farm, where 27 adults and 12 minors were identified. Reports are that 8 of the adults are from Honduras, 1 is from El Salvador, and 18 are Guatemalans. It is common for entire families at times to work on large farms as fieldhands during harvest season, and according to initial reports on the incident, this seems to have been the case—with some of the minors (ranging from 6 to 17 years of age) reportedly being the children of the adults who were on the bus.

According to police, all of the children under age 13 were reportedly



accompanying their parents, but those between 14 and 17 years of age were working as unaccompanied minors on the farms.

John Zabaneh, who reportedly owns the bus on which the laborers were found, insisted to *7News* that in general the farm owners in the citrus belt do not employ underaged workers, and went on to suggest that it is possible that a few minors "slipped through the cracks."

"... There are exceptions, like I said, a few slip through the cracks, where they did not come with their mother or father; they came with their older brother or they come with an uncle, and for these people that you mentioned, that is unacceptable. The least they will accept is mother, father and grandmother. They told me that themselves. So they might have come with an uncle or an older brother or an auntie, besides those that come with mother, grandmother, father and things like that. But they are [making a] mountain out of a mole hill. I am telling you that. People who came, a few bring their kids and they are making a big thing out of this. It's nothing to be

Cayo man murdered in Belize City

BELIZE CITY, Thurs. Mar. 31, 2022 At around 10:00 o'clock on Wednesday night, March 30, 27-yearold Windell Neal, an unemployed Petticoat Alley resident, originally from Santa Elena Town, Cayo District, was fatally shot near the junction of North Front Street and Rhaburns Alley on the north side of Belize City while socializing. It has been reported that Neal went along with a few of his companions to purchase drinks at an establishment on Victoria Street and later went to a yard located inside Rhaburns Alley, where the group began to socialize. While the group was socializing, an unknown gunman approached them and fired a single gunshot at Neal, fatally injuring him. When police arrived at the scene at around 10:09 p.m., they saw the motionless body of Neal with a gunshot wound to his body surrounded by a

pool of blood.

Local artist, Alex Sanker, who is a resident of Rhaburns Alley, expressed his concerns about this recent murder that occurred in his neighborhood. alarmed about, honest to God. I would say little things can't be a hundred percent, but when you see the thing outrageously in high incidents, then. We are talking 4 people," he said.

He went on to lament the circumstances currently facing the industry. "The fruit is falling to the ground. This will be a disastrous year, nobody to harvest the fruit. It's so slow. Other years at this time at the year this is the peak of the crop. For instance, I would be doing 5, 6 of these big trailer loads—900 boxes each—I would be doing between 5 and 6 of those for the day. I am scraping one right now per day, and other farms are doing worse, a lot worse," he said.

A release from the Anti-Trafficking in Persons Unit states, "there are apparent labor violations, to say the least. These children should not be allowed to do labor-intensive work at a farm where heavy equipment such as trucks and tractors operate."

Initial reports are that, following the detention of the adult laborers by police, a number of calls were made to police by high-ranking government officials, including the Minister of Agriculture, Hon. Jose Mai, who, unconfirmed reports say urged police to release those persons and have them continue on their way, but when interviewed yesterday he said that he called to ensure that the process was being handled properly. (Ten of the minors had been placed in the care of the Anti-Trafficking in Persons Unit, which reportedly endeavored to reunite them with their parents.) "Our calls were made to ensure that we're doing the right things. Taking into consideration that we're losing fruits right now. The calls were made for us to do the right thing, do the proper investigation, not to release anybody who was guilty of wrongdoings, but to do proper investigation before we accuse anybody," Mai said. As mentioned, the police's initial investigation revealed that none of the detained persons had any identification documents or local work permits; however, Minister Mai maintained that the laborers couldn't be accused without evidence. "Many times, we accuse people without the proper evidence, so our call was to ensure that due diligence is done, and whoever is liable will

have to be liable. But if somebody is just being targeted for whatever reasons, that is unfortunate, and we don't want that to be the case. It's not the case, and we don't want that to be the case," Hon. Mai stated.

He went on to pledge that he would not allow the citrus industry to collapse and indicated that the country will inevitably have to rely on laborers from our Central American neighbors as fieldhands for harvesting the citrus crops, but said that it has to be done the right way, which involves strict adherence to international labor and child rights conventions.

"We have to import labor, but it has to be done the proper way. We cannot have children laboring in the field, and not only in citrus—the sugar cane industry too, because you know that there are conventions against child labor and so on, so we are signatory to these conventions and we must abide by them, not only citrus, banana, sugar up north, but we do have a problem with the availability of labor in the country, right, and it's a sad thing..." Mai remarked.

He had also stated, when asked whether there would be a decline in the citrus industry in the country, "I hope not, especially under my ministry, under my watch. We inherited an industry which is really in ICU. We invested, right now, we have invested 15 million dollars or we are ready to invest 15 million dollars which is procured from the DFC to rehabilitate farms.... The situation with the 35 persons, I cannot discuss that, because another ministry and department, I don't want to go down that way, but we are going to solve that problem. That is what our government does, this government solves problems."

It is to be noted that last week, while delivering an address in Spanish Lookout, the Minister of Foreign Affairs, Foreign Trade and Immigration, Hon. Eamon Courtenay, stated, "The government of Belize believes pure and simple that Belizeans should be offered employment before foreigners. Many migrants are illegally entering Belize seeking temporary employment and being employed before they make their way northwards. We have an increase in the number of child labor, underaged children who should be in school are toiling in fields for a pittance that the government of Belize will not tolerate this much longer. We will fight child labor, we will fight human trafficking, and we will fight for a living wage for all lawful workers." He also noted, during a budget debate in the Senate yesterday, "After neglect and negligence, our government is renewing the citrus industry with an investment of 15 million dollars over three years. That money, Madam President, is being made available through the Development Finance Corporation, and we continue to work with the farmers to ensure a lawful supply of migrant workers to reap their fruit."

"Let's be real. It's 2022-who is killing out one another? We need to move on, but by moving on we need to start valuing life, and that is what we're losing in this country-value. There's no family value, no friendship value, no nothing; there's nothing. Do you know where a lot of this learn from? A lot of these learn corruption, no opportunities, lack of opportunities; there's no hope for these youths. I have kids that come to my gate every day that come and beg. Out here is rough. At the end of the day, when you really watch what's going, what we have introduced for the youths coming up, which is the future of tomorrow, it's sad to say [that] there's no future for these guys," lamented Sanker. Police are investigating.

relationship between trade unions and politics during colonial rule, "Unions have been counselled against forming too close an attachment to political parties because this has made their acceptance and recognition by employers more difficult. It is hard enough in any circumstances to persuade employers, who have been used to determining conditions of employment without interference to accept willingly an obligation to bargain with a newly developed union. If the union is also engaged in making a political attack on the employer's position in the territory, the hostility it arouses is an additional handicap to its recognition." He might also have added that the employer becomes more obdurate when he has a close relationship with the colonial administration.

industry in Belize, which is to be overseen by a Cannabis Control Commission. Senator for Government Business, Hon. Eamon Courtenay, highlighted during the Senate meeting that every person wishing to have cannabis in their possession must hold a Cannabis Identification Card.

"Clause 5.2, an application for a cannabis ID card, the person must be at least 21 years of age. That is to ensure that there are -- as best as possible when it's regulated -- it doesn't get into the hands of children. Obviously, it's no guarantee, but it is an attempt by the law to say that it is 21 years and older who will be lawfully allowed to possess cannabis. And it sets out, Madam President, the other prescribed documents that must be presented, and the fee for that ID card," Courtenay explained.

The government of Belize has opted to create a local cannabis industry through which it will be able to tax and regulate ganja usage across the nation and will be offering a range of licenses for anyone desirous of entering that industry. It will be required, however, that at least 30% of the shareholders of such enterprises be citizens of Belize, and applicants must undergo an Interpol check before being granted any license.

As reported earlier this week, the National Evangelical Association of Belize (NEAB), along with a few Catholic priests and other churches, had called for a referendum on the matter and the senator representing the country's churches had supported the business senator, Hon. Kevin Herrera in his attempt to prevent the bill from being read through all its stages yesterday. Those attempts failed, and eventually, Senator Bishop Alvin Benguche decided against the calling of votes. In his remarks, he stated, "Perhaps, no matter how many consultations are held, in so far as the church is concerned, this is not the direction that we should be going at this time ... " Senator Benguche highlighted obstacles and difficulties that legalization would create in the banking sector. "When we talk about this being a cash-only industry, and we know why the business people know why they know that we cannot, we ought not, and we should not be dealing with that kind

of money within the banking sector, we know that and how it will be affected as adversely as a country if we do," Senator Benguche remarked.

"I think in a way, it may actually cause us more problems, and we just over the past three years, we had a little of the problems within our banking system. I mean, I remember the company in the business community, mine included, had tremendous problems working with banks because of the corresponding banking issues that we are having, moving our money from one country to the other, and I think that is why the banks don't want to touch it, and I think if the local banks don't want companies' money who are dealing in this industry, then what we are talking about, Madam President, is that we would have to run this through a cash system," Senator Herrera commented.

He added, "It may bring unnecessary risk to our banking system and risk the other businesses who are operating in other aspects of the economy, so I wonder if it's a risk too high for us to take at this point."

Those in dissent didn't have a sufficient number of votes to stop the three readings of the bill, but senators who opposed the bill took the opportunity to voice the concerns they had with the bill. Hon. Darrell Bradley, UDP senator, noted that there were mixed views even within his own party on how to approach the debate of this bill, but said that he appreciates that there is a balancing act at play.

Family of US man murdered in Belize receives \$3.3 Mil



State courtroom on Friday, March 25, came after a three-and- a-half-hour deliberation, during which the jury arrived at the conclusion that Tracy Nessl had willfully "committed battery" against McNamara and caused his death. She will be ordered to pay his children, Caleb McNamara and Jennifer Ralston, \$3.3 million in damages.

According to Stritmatter Firm, which is providing legal representation to Caleb and Jennifer, Tim McNamara and Tracy Nessl began dating in 2012. Within months, McNamara had paid off all of Nessl's bills, had named her on his life insurance policy, and had made her the sole beneficiary in his will. A year later, the couple married, with McNamara purchasing 50 acres of land in Belize and placing it in both their names. Wanting to start a new life after being shunned in their hometown for

resources to ensure that those things have minimal negative impact on our society. It is that we do not support the bill and we do not support the policy of the bill, that is within the sphere of the political aspect of society, and I do not know that that is something that would merit a referendum," Senator Bradley went on to state.

For his part, OJ Elrington, sworn in as a temporary senator for this sitting, touched on the need for the Cannabis Identification Card, adding that requiring users to pay \$50 to receive that permit is tantamount to recreating a regime that targets those persons in possession of small quantities of marijuana.

"Of significant concern to me immediately is section 5, which requires a licence in effect for mere possession, and with that, not only do you need a licence, but you also must pay \$50...for many of the persons that bill was created for, if it is that is the case, that it would create a regime, where once again, we would be criminalizing small quantities," Elrington observed.

During Senator Courtenay's closing presentation, he responded to some of the assertions made by those opposed to the bill. "I have not heard of a single case, of a person attempting to go into a bank to deposit money and the bank saying, 'no, I nuh di tek your money because I want know if you di buy and sell marijuana'... We sit here and talk about threats to the banking system when the United States is about to pass the Safe Banking Act to allow for the banking of the proceeds of the sale of marijuana this month." He added, "The position is as far as this side of the Senate is concerned. We support the legislation as drafted. Serious concerns have been raised, and proposed amendments and issues that have been discussed, debated, we will take those on board and we will propose at the appropriate time, after consultation, further amendment."

the incestuous nature of their relationship, they then began to build on the property located in Boston Village off the Old Northern Highway. But in December 2014, McNamara would be found dead on that property, with a single gunshot wound to the back of his head.

McNamara's wife claimed that it was suicide—a claim that she maintained even during the 2022 trial. But local investigators eventually found that McNamara had been murdered, citing splatters of blood on Tracy Nessl's blouse, the trajectory of the bullet, and a lack of gunpowder on the victim's hands as evidence. By that time, however, Nessl had left the country, returning to Soap Lake, Washington, to live on the McNamara family farm, which she now owns.

After the murder, Belize police put out an Interpol warrant for Nessl's arrest but were unable to pursue the matter any further, since it required the US to allow for extradition and the Federal Bureau of Investigation (FBI) had no jurisdiction. This is what led McNamara's children to file a civil murder suit in Washington in 2015, claiming that Nessl had "seduced, murdered, and deceived" their father for financial gain. They were able to file the suit under Washington's Slayer Statute, which states that a person may not benefit from a property if they had killed a person to get it. That trial began on March 7, 2022, and concluded last Friday.

"...the jury announced its verdict in favor of criminal murder. Specifically, Defendant [Tracy Nessl] committed battery against Tim McNamara which proximately caused his death. Her actions were unlawful and willful. Plaintiffs did not want a dollar more from Defendant than what she took," read the statement released by Stritmatter Firm after the verdict was delivered.

Tim McNamara and Tracy Nessl married in 2013 while keeping their blood relation a secret, but by 2014, witness reports state that the couple's relationship had soured, with McNamara having discovered that Nessl had an affair. According to the family, Tim McNamara had begun to distrust his wife. Furthermore, the family's attorneys reported that in October 2014, just two months before the murder, Nessl had purchased a 9mm pistol in North Carolina and had it shipped to Belize. She had the firearm licensed on December 2nd of that year. The verdict delivered last Friday will see Caleb McNamara and Jennifer Ralston awarded roughly \$3.3 million in damages: \$77,000 in economic damages to the estate, \$1.8 million in personal damages of Timothy McNamara, and \$725,000 in damages to each of the children as McNamara's beneficiaries. So, while Tracy Nessl remains a free woman, she will be required to pay the family every dollar that they say she had taken from their father.

Sunday Wood and Conejo sign boundary agreement

In February we reported on a similar inter-boundary agreement signed by four Maya villages, and over the weekend, the most recent boundary agreement between Maya villages was made possible when a team of Mayan women who received training in GPS mapping took the arduous hike to the boundary location with village leaders, and verified the line between the villages.

"Today is a historic day for me; first time see how they do the boundary signing," said Rosa Teul, a villager from Conejo and one of the women who took the trek through the swampy jungle to pinpoint the limits. She added, "I was a part of the team that went to do the verification along with the alcalde and chairman of Conejo... [I] went there to help them to navigate to the area where they want their boundary line; it was a challenge but it was accomplished, we went safely and we came back safely."

The leaders and some residents of Conejo village met in Sunday Wood, where, after negotiations and some deliberations on the boundary limits of the villages, they came to a final agreement.

Maya Choc, executive director of SATIIM, said that the leaders were impressed with the resilience of the women of the village who took a previous trek about two weeks ago and asked them to accompany them as they undertook this process.

"So the mapping is one component, but there are also the negotiations, discussions surrounding the boundary, because these are legally binding agreements that communities are entering in," Choc said.

Choc noted that while the discussion about the boundary between the villages has been ongoing since January of this year, there were some challenges before this agreement was finalized.

"There were some challenges within the two communities in terms of conflict areas, but I am very happy that both communities were about to settle that matter with the assistance of community people. We strongly believe that everything should come from the community; we're only there to support, so when you are having conflict, it is important that you hear from others: how do you go about doing this? And also recognizing that there are times when there have to be a give and take—you lose some, but you win some as well ... so I'm happy to see that the leaders were able to sort that out, not on their own. They had to go back to their community and explain to them what transpired, they had to explain their conclusion and why it is that they believe that this is the best way to go, and I think it worked out well because the community said 'well, we accept it,' and for that reason, we have now completed that boundary," Choc said.

As mentioned, the agreement on village delimitation is the 5th of the 8 steps of the Delimitaton: Principles and Methodology agreed between Government of Belize representatives and the Maya communities in Toledo as part of the process that has been laid out for the implementation of the Caribbean Court of Justice's consent order to clearly define and delimit the territories of the Maya people.

Donicio Shol, mapping expert and Land Tenure Facility Project coordinator, at the Julian Cho Society, said in a February interview that up to 22 villages have consented to auto-delimiting, adding "not to say that others are not in the process, but there are different steps."

This signing was supported by SATIIM, and according to a representative from the Toledo Alcalde Association, is not a part of the work they lead.

That is -- the staff rate is growing at 17% over that period of time. Yet, the revenues grew only by 8.5%. The reason I'm bringing that up, Madam President, is because there's been a significant concern, both by the unions as well as the private sector, that there's an ever-ballooning public



According to Statutory Instrument 61 of 2022, which was gazetted today, March 31, the Ministry of Health and Wellness has reached the conclusion that, since the threat of community spread of COVID-19 has dwindled at both the district and national levels, most restrictions can be safely lifted. The Ministry has noted, however, that it is still necessary to prevent the spread of COVID-19 by persons arriving at any land or sea ports. As a result, tourists entering the country must present proof of a negative COVID-19 test result, whether arriving by land or by sea, and if they fail to do so they must be tested at their point of entry. Furthermore, Belizeans leaving the country must be fully vaccinated. All other restrictions, however, will be lifted.

Despite the lifting of restrictions, though, the Karl Heusner Memorial Hospital has issued a memorandum informing that the use of face masks on the hospital's premises remains mandatory.
