





### Channel 7 apologizes to PM Briceño for Hon. Shyne's comments

BELIZE CITY, Mon. Apr. 4, 2022 Following a UDP leadership convention on Sunday, March 27, and the emergence of Hon. Moses "Shyne" Barrow as the new leader of the party, Hon. Barrow appeared as a guest on Jules Vasquez's Uncut talk show, which was initially aired on Wednesday, March 30. While he was a guest on that show, Barrow faced the characteristically tough questions posed by Vasquez-a number of which highlighted his past as a gangster rap artist and cast doubt on his suitability for the role he is now playing, as UDP leader and leader of the opposition. At several points during the discussion, while trying to defend his eligibility to hold national office, Hon. Barrow referred to allegations made against other prominent politicians. One of his assertions—regarding Prime Minister Briceño and his late father, Elijio Briceño, who had served as the Minister of Energy and Communications under Rt. Hon George Cadle Price, would be viewed by many as defamatory. And those defamatory remarks that he made were later re-aired during the following day's newscast.

Within less than 48 hours after the airing of the show, two letters were issued by Courtenay Coye LLP, legal representatives of the Prime Minister, to demand an apology, and also threatening to seek damages if such apologies weren't forthcoming. One was addressed to Tropical Vision Limited (Channel 7) and another to Hon. "Shyne" Barrow himself. In the letter to Channel 7, the Prime Minister demanded a cessation of all circulation of the interview with Barrow, as well as a public retraction and apology on the media house's website and social media platforms, and proof of deletion of the video and related comments from all platforms and archives. The letter also indicated that compensation of \$100,000 for the tarnishing of Hon. Briceño's reputation would be sought and stated that, should an apology draft not be submitted for approval within two days, legal proceedings would follow.

On 7News' Monday night broadcast, the apology letter that was drafted by the media house was shared with the public. That letter stated, "On Wednesday, 30th March 2022, during the live airing of Channel 7's Uncut, the guest, Shyne Barrow, Leader of the Opposition, stated that the Prime Minister of Belize, John Briceno, was associated with a cartel. The host of that program, Jules Vasquez, as well as Channel 7News, wish for all its viewers in Belize and abroad to know that they regard those statements as untrue and without any factual basis whatsoever. Mr. Vasquez emphatically denied the allegations during the live broadcast of the show. We sincerely regret that those untrue statements were made on Channel 7 and any hurt and distress it may have caused Prime Minister Briceno and his family. We unreservedly apologize to Prime Minister Briceno and his family, retract those offensive statements in their entirety and undertake not to have them repeated either on Channel 7 or any of its digital and social media platforms. It is our genuine hope that this apology and retraction will repair any injury or emotional distress suffered by the Prime Minister as a result of the broadcast." As mentioned, Hon. Barrow received a similar letter on April 1 from Courtenay Cove LLP in which he was instructed to cease republication of the interview, and to send a retraction and apology to Channel 7 and Channel 5 and all associated social media platforms. Barrow, however, has yet to publish any apology or retraction of his statements. It remains to be seen whether he will do so, or whether he will pay the \$100,000 compensation that was demanded.

Tourism dependent countries beware

WASHINGTON D.C., USA, Wed. Apr. 6, 2022

At a press briefing held today by Pan-American Health the Organization (PAHO) and the World Health Organization (WHO) on the current COVID-19 situation in the Americas, it was revealed that while cases (and deaths) across most countries have significantly declined, the number of new infections is beginning to rise once again in some places, particularly in countries where there has been increased tourism and travel in conjunction with the relaxation of public health measures. The Director of PAHO, Dr. Carissa F. Etienne, in her opening remarks at the briefing reminded the region that quite often, what has happened elsewhere in the world is a foreshadowing of what the Americas may face—citing the recent dramatic COVID-19 surges seen in Europe and East Asia that were caused by the BA.2 Omicron subvariant.

"Time and time again we've seen how the infection dynamics in Europe are mirrored here just a few weeks later. In fact, Omicron BA.2 has already been detected in 8.7% of the sequences reported from South America in global databases," said Dr. Etienne, who also noted that in North America—Canada specifically—the number of cases increased by one-third over the past week while hospitalizations increased by ten percent.

Additionally, the region continues to record more than 620,000 new cases every week, and 15 Caribbean countries and territories have already begun to see a surge in new infections. Dr. Etienne further noted that reports of deaths have risen in some countries but stated that this might have been caused by countries reclassifying the cause of past deaths and subsequently listing them as COVID-19 mortalities. Nevertheless, the PAHO Director stressed the fact and vaccination easily accessible to everyone so as to prevent new outbreaks and protect health systems in the event that there is a surge in cases.

"Countries must also continue to monitor this virus to stay prepared for what is coming next. Throughout the pandemic, testing has been a critical tool to track COVID spread. But today some countries have changed their testing strategies, making it more difficult to get the full picture of BA.2 in our region. Countries must keep testing capacity in place so we do not go into this next wave blind," she said.

The PAHO Director, who stressed that the pandemic is not over, emphasized the need to be cautious and to remain cognizant of basic health and safety protocols, whether traveling or staying at home, to prevent the spread of COVID-19. These include always wearing a well-fitting mask when around other people, staying at least one meter away from others, and avoiding the three C's (closed spaces with poor ventilation, crowded places, and close contact settings) even where restrictions have been relaxed.

Another top priority, said Dr. Etienne, is for countries to continue to make evidence-based decisions. She stated that over the past few weeks many countries in the Americas have scaled back public health measures, some prematurely so.

"As travel restrictions have loosened, case counts have risen in countries that rely on tourism, especially in parts of North America and the Caribbean where vaccination coverage is low," she said.

The PAHO press briefing comes just one day before World Health Day, which will be celebrated under the theme, "Our Planet. Our Health." Referencing the theme, the Director also touched on climate change, making an urgent call for the countries in the region to work together to withstand not only this next phase of the pandemic but also the climate crisis in an effort to create a healthier and more sustainable future. "It is undeniable that climate change has presented significant threats to our region's health. Higher temperatures and air pollution have led to rises in cardiovascular and respiratory diseases in the Americas. Extreme weather events, droughts, and wildfires have caused crop failures and displaced people from their homes, driving malnutrition and forced migration," she said. As we prepare for the next emergency, she added, PAHO and WHO are counting on countries across the Americas to continue making health their collective priority.

that the risk of further surges cannot be ignored.

"We cannot ignore the risk of further COVID-19 surges in other parts of the region. We must face it together, with caution but also with confidence, because we know what it takes to protect our people. First, it is important to continue filling out vaccination gaps to protect the most vulnerable," she stated, highlighting the higher likelihood of hospitalization among the elderly and the immunocompromised.

During the press conference, it was also revealed that more than 685 million people in the region have been completely vaccinated. But according to the PAHO Director there is still more work to be done—that includes making COVID-19 testing



# **Residents react to parking meter pilot project**

The Belize City Council's pilot project has been receiving mixed reviews since its implementation on Monday, with some residents saying it has inconvenienced them while others have said that it was just what the city needed.

The Belize City Council's Parking Meter Pilot Project, which has been in the works for some time and is a part of the council's efforts to regulate commercial parking throughout the city, has been receiving mixed reviews since its implementation this past Monday. This project, meant to target areas of high congestion where repeat parking infractions occur and to provide equitable parking opportunities for all, has seen new parking meters installed on Newtown Barracks from The Ramada Princess Hotel to Midtown Restaurant and on Albert Street from its intersection with Orange Street to its intersection with Dean Street.

While there were seemingly no public objections during the installation of the meters, in a matter of days following the project's commencement, park vendors, entrepreneurs, and residents quickly began to voice their discontent. A number of vendors and entrepreneurs have told the media that they were never consulted about the execution of the project. The collective qualm is that businesses have seen an immediate and drastic decrease in customer inflow because it now costs a fee to park in front of their establishments. Some of the business owners also lamented the fact that even they must pay the fees associated with parking in front of their own storefronts, which is an unwelcomed expense, especially following the financial blows caused by the COVID-19 pandemic.

During an interview this week, Mayor Bernard Wagner told local media that while each vendor was not consulted personally, there were briefing sessions held with the president of an association of park vendors as well as the area representatives of the constituencies where the meters are now placed, Hon Tracy Panton and Hon. Kareem Musa. The mayor also added that while the project is in its early stages and residents need time to adjust, it has been successful for its intended purposes thus far:

"Our objective is really to regulate the spaces. To have it be shared in an equitable fashion with all residents having the opportunity to use that space. Anything new obviously will have glitches and pushback, but we're in day two. I would recommend that you give the council three months, and thereafter we see how it's working. But it's day two. And I drove in the



city Monday morning, I drove along Albert Street, and I see this project working. People are having access to park in front of Brodies, in front of Downtown Plaza, in front of Smart. And they're using it, and it's just how we adapt to change."

The Belize City Council has also scheduled a public consultaion meeting for Thursday, April 7 at the House of Culture, during which residents will be able to voice their concerns.

While some residents have expressed resounding dissatisfaction with the pilot project, though, there are those who have stated that it was just what the city needed, citing the huge reduction of traffic congestion on both Albert Street and Newtown Barracks.

"It's nice to drive in front of BTL Park and not have to be stopping as vehicles park on both sides where you have to pull [over] to let another vehicle pass, the traffic flows smoothly...now we can get some parking without having to circle trying to find a space," wrote one person on social media.

"I agree with pay parking. Truth be known, most all roadside parking spots [are] used as long- term parking for workers in the area. Businesses suffer from those people. Pay parking is good for businesses and shoppers," wrote another.

At the moment, the mayor says the council is open to conversation and may make adjustments to the project, but that the public should give the project at least a few months to see how successful it truly is. Parking meter prepaid cards can be loaded with different values that are purchased from authorized dealers. Currently, meter rates stand at \$1.50 per half hour and \$3.00 per hour between 6:00 a.m. and 6:00 p.m. from Monday to Thursday and between 6:00 a.m. and 7:00 p.m. on Fridays and Saturdays, with Sundays and holidays being non-operational days.

instead of abstaining along with 58 other countries. Twenty-four nations of the 193member General voted Assembly against the U.S.-led initiative. Barrow said that he thought there was no good reason to be concerned that Belize's abstention would impact the Belize-Guatemala dispute currently before the International Court of Justice or our relationship with Guatemala who voted yes along with the United States. Former Foreign Minister Wilfred "Sedi" Elrington echoed Barrow's opinions, expressing confidence that the ICJ would decide on the facts, but that Belize had to be concerned by what had happened in Ukraine, which he described as a proxy war between Russia and the United States. "We need good neighbours," he told



# GoB: no further hikes in gas prices; bus fares going up

BELIZE CITY, Thurs. Apr. 7, 2022

In an effort to alleviate the "gas pain" being felt by Belizeans countrywide, Cabinet has approved several measures that are aimed at ensuring that fuel prices are stable. Among these measures is the capping of the price of regular gasoline at \$13.50 per

gallon. According to a press release issued today following the regular meeting of Cabinet, the Government has established a firm cap on both diesel and regular gasoline pump prices, with the price of diesel to remain at \$13.41 per gallon. Without the cap on diesel, which was made possible through a reduction of excise taxes by 57%, the cost of diesel would have risen by \$2.13 per gallon, which would have seen the price at the pump shoot past the fifteen-dollar mark to an astounding \$15.54.

According to the GoB release, this cap in fuel prices will be maintained through the use of a fuel price stabilization fund—by means of which government will set aside extra funds that are generated when acquisition costs fall and use these funds to offset surges in such costs at a later time. It is something Prime Minister John Briceño had alluded to when speaking to reporters two weeks ago.

The Prime Minister had explained on March 29, following a meeting with key stakeholders, "Fuel is going to be a long discussion, but basically what we have been talking when we met with them is that there were.... many people in the industry want to have certainty, they want to be able to cap fuel at a price and keep it at that price so that if the price goes up, we are looking at setting up a fund from where we can get how to be able to pay the taxes and then when the prices go down, we keep it at that price until we can pay off the funds. So we hope that by next week Tuesday. I mean we had a long



have once again asked my ministry, Agriculture, Transportation and Tourism to sit down and to try to come up with a right formula as to how we are going to be addressing that."

Prime Minister Briceño had mentioned that he had discussed the matter with representatives of the Belize Bus Association, the churches, the NGO community, and other social partners.

Additionally, Cabinet has approved measures to minimize the increase in bus fares—expected to go up on April 15th. According to another press release from the Government, commuters can expect their public transport fares to increase by the following amounts for both regular and express runs:

• Below 13 miles – \$0.25

- 13 to 25 miles \$0.50
- Above 25 miles \$1.00

The approved measures include a fuel subsidy of \$0.91 per gallon that will be granted to eligible bus operators over the next six months, which according to the press release will represent over \$1 million in savings to commuters. The Government will also be providing subsidies to eligible tour operators.

"Eligible tour operators will be beneficiaries of a capped fuel subsidy jointly funded by the Government of Belize and the Belize Tourism Board in the sum of \$1.5 million for a period of up to six months," noted the release.

Incidentally, it was also announced this week that the price of LPG that is currently in the country was lowered by 13 cents per gallon. In urban areas, the retail price for a 100-pound tank of LPG will be \$142.

refreshingly so—character on the Belizean political scene, and garnered much attention for his sharp tongue and his coining of phrases such as "flippin" and "madda fish" that made his manner of speaking amusing and distinct.

He was born in 1947, while Belize was still known as British Honduras, and grew up in the mahogany camps of the Stann Creek District. He attended Lyman College and served with the British Honduras Volunteer Guard.

Hulse, who during his final public appearance in an interview with 7News' Jules Vasquez referred to himself as a product of his times—a grassroots man from the valley with a deep love for the south—would also eventually go on to help develop much of the Stann Creek district, serving as a Minister under both the Esquivel and Barrow administrations and bringing roads, schools, and access to electricity to many villages in the area. Referring to the development projects he undertook in the 1990's, he told Vasquez, "Up to then there was not a single lamp post in Stann Creek, there was not a single water pipe in Stann Creek, there were no roads, there was no phone, there was nothing out there, and they could say whatever they want. The fact is there was nothing.... We developed, I created, some of those villages, and the villages that existed before me, I developed with another thousand lots. So I developed, I created and help develop Middlesex, Hummingbird, Valley Community, Steadfast, Alta Vista, Pomona, Hope Creek, Sarawee, Silk Grass, Hopkins, Sittee, Maya Center, Santa Rosa, San Roman, George Town, Maya Mopan, Red Bank, San Juan, Seine Bight, Placencia and Mango Creek. In that time, I put in lights, water, brought phone out there, built schools in every village -- you all know that I worked hard. Never liked what happened, but I paved the Hummingbird, I paved the Southern Highway, I got Hopkins road paved, we built and paved Placencia road."

Notably, when asked by Vasquez why he was not a wealthy man after having served as a government minister for a number of years, he remarked, "Riches? Any madafishing salary are riches, and you are putting children through school and sometimes you have 4-5 of them in there? The only way as a politician you could come out rich is if you are hustling." He also stated during that interview that he was intolerant of two things—"stealing and laziness".

"Other than that I don't care what kind of life you want to live. You want to drink every day, you want to rot every day -- do whatever you flipping want, 'cause I'm not living with you, but when we are at work and all of us are collecting taxpayers' money, work for it -- it done," he went on to say.

Tanya Felicia Hulse wrote on the passing of her father on Facebook, stating, "It is with a collapsing and profound sense of loss that I share with you the news of the passing of our beloved father. Words cannot sufficiently describe how heavy the grief is that weighs on my heart. But I am grateful that the good Lord was merciful enough to give him rest from his suffering."

"There could never be another like the legend and giant of a man that is my father. The strength and bravery he showed to the end. I am so proud and blessed that God allowed me to share this life as his daughter," she added.

Despite his two-year battle with cancer, Hulse had remained in high spirits, even in the few weeks leading up to his passing, having spent plenty of time contemplating his mortality and even planning his own funeral.

A state service will be held for Hulse on Monday, April 11, at Mile 20 on the Hummingbird Highway at 10:00 a.m. Melvin Hulse leaves behind his eleven children along with a host of friends and family members, including his extended families—the United Democratic Party and residents of the Belizean south. intercepted and their occupants—a Belmopan resident and two persons from Orange Walk—apprehended.

While nothing and no one else was found inside the vehicles, the MIT officers later found 18 persons, 16 Cubans and 2 Nicaraguans, hiding in a nearby area. Those persons were also detained at the Orange Walk Police Station and shortly after were handed over to the Immigration Department. The three persons who were initially apprehended, suspected of being human smugglers, are likely to be charged.

Just two days later, on Thursday, April 7, the Ministry of Foreign Affairs, Foreign Trade and Immigration issued a press release addressing the issue of foreign nationals, particularly Cubans, who have been entering the country using irregular means.

"These Cuban nationals are utilizing the Refugees Program to avoid repatriation and are being handed over to Help for Progress," it stated, adding that to date, the department has seen the illegal entry of a total of 39 Cuban nationals whose primary aim has been to reach the US/Mexico border while using Belize as a transit point.

AMANDALA reached out to the Chief Executive Officer in the Ministry of Foreign Affairs, Foreign Trade and Immigration, Dr. Gilroy Middleton, who wrote to us that the Ministry will continue working with ATIPS (the Anti-Trafficking in Persons Unit) "to address these situations and ensure that our prosecutors are prepared for the upcoming legal proceedings."

The press release issued by the

Ministry of Foreign Affairs, Foreign Trade and Immigration also revealed that, on April 6, 2022, a representative from Help for Progress visited the Ministry and informed the Assistant Director with responsibility for Enforcement that 13 Cuban nationals who had been released to the Human Rights Commission of Belize after two court rulings on March 18 and March 23, were no longer at the shelter. According to the CEO, this is all the information that the Ministry has gathered regarding those persons so far.




# Improve conditions and Belizeans will harvest the crops

Last week Belize's Foreign Minister, Hon. Eamon Courtenay, remarked in the Senate that Belize has a "serious migration problem" and that the government will be making a strong move to apply the laws to check the number of illegal persons entering and being trafficked through Belize. Worldwide people are on the move, and not only in war-torn regions. The 2020 World Migration Report estimated that 281 million persons, 3.6% of the world's population, migrated that year.

Presently, the GOB has initiated an amnesty program which it says should see upwards of 40,000 persons being regularized, on the way to becoming citizens of Belize. Speaking on our migration history, an information sheet published by the Ministry of Foreign Affairs, Foreign Trade and Immigration says that in 2010 the Statistical Institute of Belize couldn't provide statistics on undocumented immigrants, but a census they did that year showed that 14.2% of our population was born abroad. The Immigration Department's information sheet said Belize has had two amnesties, with 8,680 undocumented immigrants being registered in 1984 and 11,168 migrants gaining permanent residence status in 1999. An aborted 2010 amnesty was expected to register more than 20,000 persons.

Across the globe, countries roll out the red carpet for immigrants who have special skills or have money to start up industries or invest in existing ones. Immigrants who work "dirt cheap" are in demand too, where there are labor-intensive businesses that aren't extremely profitable for the owners, or the owners are rapacious.

Illegal migrants who are using our country as a transit point

or are trafficked persons are a concern, but the greater problem for Belize are those who come in on work permits and do not return to their home country after their permits expire. Around 50% of workers' permits go to the agriculture sector, and a large number of these workers move on to work in tourism, and construction.

Belizeans have a lot of sympathy for persons who want to come here to make a better life, but it is necessary to control the number of persons who come on a work permit and stay, or just sneak into the country. Charity begins at home, and there is a great need for us to first secure the futures of Belizeans who have not yet gotten a fair share of the pie. When the present government promised that all of us would win, it was speaking specifically to the thousands, the more than 50% of Belizeans, who are barely scraping by. It is primarily because of the level of destitution in the country that some Belizeans have expressed reservations about the 2022 amnesty, even though the Immigration Department insists most of the persons who will be registered have been living here for some time.

immigrants begins in the agriculture sector, where cheap labor is a necessity, except in times when prices for our products on the world market are high. It's extremely wishful to think that all the workers who get permits to work here seasonally will go home and stay home when the harvesting is over. If Belizeans don't harvest the crops, the population of illegal persons will grow.

There was a time when most of the field workers in the major agro industries were Belizean. It won't take much for those days to return, but it won't if farm owners have their way. They generally prefer foreign laborers because they are far easier to manage, they don't ask for more pay, and they are uncomplaining about poor living conditions. There's nothing illegal there. It's capitalism.

If GoB is serious about solving the immigration problem it will ensure that Belizeans get those jobs. The first move must be to provide a subsidy aimed at getting farmers to improve housing conditions for farm workers. Harvesting is not for everyone, but if housing conditions are decent, there should be no trouble finding able-bodied persons in rural and urban Belize who are eager to join the seasonal work gangs.

#### Lord Ashcroft is not a good "ambassador" for his people

Putting aside the contention that the United Kingdom hasn't done nearly enough to make reparations for its role in slavery and its colonial past in Belize, what the British have done by way of grants and technological assistance is being eroded by one of that nation's sons, Lord Ashcroft, who is just about the worst ambassador.

Understandably, the British will support their citizens, and those who do well abroad are especially favored, because for centuries people on those islands have depended on their overseas "investments" to maintain their high standard of living. Business is never a tea party, but there are things such as respect and social responsibility that these foreign corporates must consider when doing business in an independent foreign country.

Local political leaders, the PUP, made a bad error when they allowed Ashcroft and his crowd to purchase control of our telecommunications company, BTL. The foreign-controlled BTL ignored the PUC, resisted the expansion of telecommunications to not-so profitable areas, and would not allow VOIP. The PUP got "wap" at the polls for their mistake.

The succeeding UDP government had no choice but to take back BTL. Those who insist on hollering that we hurt our foreign investment potential when we took back BTL don't know how proud nations operate. Nations go to military and economic wars to protect their assets, and to preserve their dignity. All wars cost. (Though what we paid to get back BTL needs to be thoroughly investigated.)

The latest excesses, atrocities linked to Ashcroft are an application for an injunction to block an ex gratia payment GoB made to the stevedores at the Port of Belize Ltd., and a lawsuit against said stevedores over a short strike. To raise funds to counter the latter vicious attack in court, the stevedores are presently on a dollar drive. Belize offers special incentives to attract foreign investment, but sometimes honey attracts not so desirable flies. If Belizeans looked closely, they would see that both Belize governments have been beyond fair in their dealings with Ashcroft, but without a thought of our goodwill, he turned around and bit us. It is the worst when you bring someone into your house and they abuse your hospitality. As they go about doing business, the British try to project class, and a firm belief in fair play. The low mark of the British is their hooligans who have behaved boorishly at times at football matches. Lord Ashcroft acts like some nouveau riche who wiggled his way to the top, and now is getting some perverse joy out of using his money to bully and shame Belizeans. He should drop his case and treat the stevedores with respect, if only to stop embarrassing the UK. He is no good ambassador.


### Escapee Edward Saldano, Jr. surrenders

### Mejoren las condiciones y los beliceños cosecharán los cultivos

La semana pasada, el Ministro de Relaciones Exteriores de Belize, el Honorable Eamon Courtenay, remarcó en el Senado que Belize tiene un "problema migratorio serio" y que el gobierno hará un movimiento fuerte para aplicar las leyes para controlar el número de personas ilegales que ingresan y son traficadas a través de Belize. La gente de todo el mundo está en movimiento, y no solo en las regiones devastadas por la guerra. El Informe sobre Migración en el Mundo 2020 estimó que ese año migraron 281 millones de personas, el 3,6% de la población mundial.

En la actualidad, el Gobierno de Belize ha iniciado un programa de amnistía que, según dice, debería regularizar a más de 40.000 personas, en camino a convertirse en ciudadanos de Belize. Hablando de nuestra historia migratoria, una hoja informativa publicada por el Ministerio de Relaciones Exteriores, Comercio Exterior e Inmigración dice que en 2010 el Instituto de Estadística de Belize no podía brindar estadísticas sobre inmigrantes indocumentados, pero un censo que hicieron ese año mostró que el 14.2% de nuestra población nació en el extranjero. La hoja de información del Departamento de Inmigración dice que Belize ha tenido dos amnistías, con 8.680 inmigrantes indocumentados registrados en 1984 y 11.168 inmigrantes obteniendo el estatus de residencia permanente en 1999. Se esperaba que una amnistía abortada de 2010 registrara a más de 20.000 personas.

En todo el mundo, los países despliegan la alfombra roja para los inmigrantes que tienen habilidades especiales o tienen dinero para iniciar industrias o invertir en las existentes. Los inmigrantes que trabajan "muy barato" también tienen demanda, donde hay negocios intensivos en mano de obra que no son extremadamente rentables para los propietarios, o donde los propietarios son rapaces.

Los inmigrantes ilegales que utilizan nuestro país como punto de tránsito o son personas objeto de trata son una preocupación, pero el mayor problema para Belize son aquellos que llegan con permisos de trabajo y no regresan a su país de origen después de que vencen sus permisos. Alrededor del 50% de los permisos de los trabajadores se destinan al sector agrícola, y una gran cantidad de estos trabajadores pasan a trabajar en el turismo y la construcción.

Los beliceños tienen mucha simpatía por las personas que quieren venir aquí para hacer una vida mejor, pero es necesario controlar la cantidad de personas que vienen con un permiso de trabajo y se quedan, o simplemente se cuelan en el país. La caridad comienza en casa, y existe una gran necesidad de que primero aseguremos el futuro de los beliceños que aún no han recibido una parte justa del pastel. Cuando el gobierno actual prometió que todos ganaríamos, estaba hablando específicamente a los miles, más del 50% de los beliceños, que apenas sobreviven. Es principalmente debido al nivel de indigencia en el país que algunos beliceños han expresado reservas sobre la amnistía de 2022, a pesar de que el Departamento de Inmigración insiste en que la mayoría de las personas que se registrarán han vivido aquí durante algún tiempo. Todas las autoridades saben que la clave para controlar a los inmigrantes ilegales comienza en el sector agrícola, donde la mano de obra barata es una necesidad, excepto en momentos en que los precios de nuestros productos en el mercado mundial son altos. Es extremadamente ilusorio pensar que todos los trabajadores que obtengan permisos para trabajar aquí por temporada se irán a casa y se quedarán en casa cuando termine la cosecha. Si los beliceños no cosechan los cultivos, la población de personas ilegales crecerá. Hubo un tiempo en que la mayoría de los trabajadores de campo en las principales agroindustrias eran beliceños. No pasará mucho para que esos días regresen, pero no será así si los dueños de las fincas se salen con la suya. Generalmente prefieren trabajadores extranjeros porque son mucho más fáciles de manejar, no piden más pago y no se quejan de las malas condiciones de vida. No hay nada ilegal allí. Es el capitalismo.

Si el Gobierno de Belize se toma en serio la solución del problema de la inmigración, se asegurará de que los beliceños obtengan esos trabajos. El primer paso debe ser proporcionar un subsidio destinado a lograr que los agricultores mejoren las condiciones de vivienda de los trabajadores agrícolas. Ese trabajo no es para todos, pero si las condiciones de vivienda son decentes, no debería haber problemas para encontrar personas capacitadas en zonas rurales y urbanas de Belize que están ansiosos por unirse a las cuadrillas de trabajo estacional.

#### Lord Ashcroft no es un buen "embajador" para su pueblo

Dejando de lado la afirmación de que el Reino Unido no ha hecho lo suficiente para hacer reparaciones por su papel en la esclavitud y su pasado colonial en Belize, lo que los británicos han hecho a través de subvenciones y asistencia tecnológica está siendo erosionado por uno de los hijos de esa nación, Lord Ashcroft, que es casi el peor embajador.

Es comprensible que los británicos apoyen a sus ciudadanos, y aquellos a los que les va bien en el extranjero son especialmente favorecidos, porque durante siglos la gente de esas islas ha dependido de sus "inversiones" en el extranjero para mantener su alto nivel de vida. Los negocios nunca son una fiesta de té, pero hay cosas como el respeto y la responsabilidad social que estas empresas extranjeras deben tener en cuenta al hacer negocios en un país extranjero independiente.

Los líderes políticos locales, el PUP, cometieron un grave error cuando permitieron que Ashcroft y su gente compraran el control de nuestra empresa de telecomunicaciones, BTL. El BTL controlado por extranjeros ignoró a la Comisión Reguladora de Servicios Públicos, resistió la expansión de las telecomunicaciones a áreas no tan rentables y no permitió voz IP. El PUP fue vapuleado en las urnas por su error.

El siguiente gobierno UDP no tuvo más remedio que recuperar BTL. Aquellos que insisten en gritar que dañamos nuestro potencial de inversión extranjera cuando recuperamos BTL no saben cómo operan las naciones orgullosas. Las naciones van a guerras militares y económicas para proteger sus activos y preservar su dignidad. Todas las guerras cuestan. (Aunque lo que pagamos para recuperar BTL debe investigarse a fondo).

Los últimos excesos, atrocidades vinculadas a Ashcroft son la solicitud de una orden restrictiva para bloquear un pago ex gratia que hizo el Gobierno de Belize a los estibadores de Port of Belize Ltd., y una demanda contra dichos estibadores por una breve huelga. Para recaudar fondos para contrarrestar el último ataque vicioso en la corte, los estibadores están actualmente en una campaña para recaudar fondos. Belize of rece incentivos especiales para atraer inversiones extranjeras, pero a veces la miel atrae moscas no tan deseadas. Si los beliceños miraran de cerca, verían que ambos gobiernos de Belize han sido más que justos en sus tratos con Ashcroft, pero sin pensar en nuestra buena voluntad, se dio la vuelta v nos mordió. Lo peor es cuando se lleva a alguien a casa y abusan de su hospitalidad. A medida que hacen negocios, los británicos intentan proyectar clase y una firme creencia en el juego limpio. La nota baja de los británicos son sus camorreros que se han comportado de forma grosera en ocasiones en los partidos de fútbol. 

When I was a young university student in the United States running around with black activists, I didn't want to hear anything about the fact that there were Africans who had enabled and facilitated the kidnapping and enslavement of their own African people for their own enrichment and the enrichment of European slave traders. But, facts are stubborn things: Africans sold other Africans.

In the Western media nowadays, we hear a lot about all the brutality taking place in the Ukraine, which has been attacked by Russia, but we Belizeans know very, very little about what has occurred in Zaire

(previously the Belgian Congo) over the last six decades since the country, perhaps the richest in the world where natural resources are concerned, was granted political independence by Belgium in 1960.

It is generally accepted that Patrice Lumumba was an honest, sincere leader who wanted the best for his Congolese people, but there was another Congolese, a man by the name of Moise Tshombe, who controlled the wealthy Katanga province, who was prominent in the murder of Lumumba because, like some of the African chiefs in the slavery days, he was on the payroll of the European predators.

We don't have to go anywhere to see that the paradigm of Africans participating in the butchering of other Africans remains a terrible reality, because almost every day in Belize some black youth kills another black youth with a highpowered automatic pistol.

In a previous column, I explained to you that the Russian people are not considered classic Europeans by the "tappa tappa" Scandinavian and Anglo-Saxon Europeans. But the Ukrainians are considered fully European. The Russians are considered a Slavic people, whatever that means. To us, as Belizeans of color, however, we see

the Russians and the Europeans as basically the same thing -- white people.

Anyway, so much for Russians and Ukrainians. It has been very, very painful to me to watch our own Belizean people of color accept all the pieces of silver handed out by Vladimir Ashcroft for the crushing of the interests of black Belizeans. The excuse is that this is what attorneys do. This is their professional modus operandi. They don't see right and wrong, as such. It's all about pipers, moneys, and tunes.

In the larger sense, human beings do very cruel things to other human beings because we want power and money. Western companies wanted control of Congolese resources at the lowest possible prices, so they paid for the murder of Patrice Lumumba, who wanted the best possible deals for his Congolese people. The Russians are murdering the Ukrainians because they want control of Ukrainian resources in order to become more powerful and wealthy.

What is puzzling for people like me is how God and religion fit into planet earth's reality. There are some of us who do cruel things while masquerading as Christians. These are Belizeans who are considered the successful ones of our country. But Jesus said clearly and pointedly that His kingdom was not of this world.



### BWS has asked the PUC to review its Final Decision for 2019-20 Full Tariff Review Proceeding

Pursuant to the Section 32 of the Public Utilities Commission Act, Belize Water Services Limited has formally written to the Public Utilities Commission to request a review of the Decision made in its 2019-20 Full Tariff Review Proceeding (the "2020 Decision").

The 2020 Decision would have caused an across-the-board 2.25% tariff increase to become effective April 1, 2022.

In an effort to mitigate the effects of the COVID-19 pandemic and its resulting impact on the lives of our customers and Belize's economy, BWS felt that asking the PUC to review its Decision was the right thing to do.

The PUC has been asked to expedite the review and in the interim, the PUC has instructed BWS to suspend implementation of the scheduled rate adjustment pending the outcome of its review.

## Installation of friendship group Mexico—Russian Federation: Part 2

Permit me, our dear readers of this column, to present to you the following which was published on Youtube on March 23, 2022 entitled "En VIVO/ Instalación del Grupo de Amistad México - Federación de Rusia" (Installation of the friendship group Mexico - Russian Federation). I find what the Ambassador of Russia to Mexico, His Excellency, Victor Coronel, said in the Honorable Chamber of Deputies in Mexico City to be of utmost importance. Part 2 is as follows:

I would like to remind you that the current situation in Donbass and Ukraine is a consequence of the unconstitutional coup that took place in February 2014... The new Kiev regime began the fight against the Russian language and culture in a country with millions of Russianspeaking people... Someone asks me, what Nazism can we talk about today in Ukraine? Yes you can. We, well, my colleagues, my diplomats, brought information confirming the development of Nazism in Ukraine. Please distribute these pieces of evidence to your deputy friends and well, even to representatives of the media. Extrajudicial executions of political opponents in the persecution of dissidents have become a new normal among stretchers in Ukraine. I have a lot of respect for the Ukrainian people, the brother people of the Russian people. But I cannot have respect for this current government of Ukraine and I am going to give you an example that has nothing to do with Russia or with what is happening today in Ukraine.

I think you know that every year in the UN General Assembly a resolution is voted that condemns the economic and commercial blockade of the US against Cuba. They vote for it every year. It has enormous support from countries. Only two countries vote against, traditionally the US and Israel. Last year, on instructions from Washington, the Kiev government did not dare to vote in favor of this resolution. He abstained, despite the fact that in the 1980s and 1990s after

the catastrophe at the Chernobyl nuclear power plant, the Cuban government, for 20 years, offered help, totally free medical help, to Ukrainian children who had the consequences of this catastrophe at the atomic power plant. Thousands, tens of thousands of Ukrainian children with their mothers, with their families, passed through Cuba to the Cuban government, receiving medical attention all at the cost of the Cuban government. Today, I repeat, the Ukrainian government does not dare to support the resolution of the UN National Assembly that condemns the commercial blockade against this valuable island.

I have to mention another thing; the massacre in the city of Odessa, the Ukrainian city of Odessa, perpetrated by Ukrainian radicals, was one of the most heinous acts that went unpunished so far.... These events were welldocumented with photos and videos. However, I reiterate, 8 years have passed and not a single person has been imprisoned for this terrible crime.

Meanwhile, the Kiev regime continues to carry out incessant attacks against the civilian population of Donbass. On March 14, the Ukrainian tactical missile attack killed 20 civilians and injured 28 people, including children in the center of the city of Donetsk, which was a deliberate attack on civilians. It is worth mentioning that the missile had a warhead with receipt ammunition whose use in residential areas is classified as a war crime. However, we are still open to dialogue with the Ukrainian side. Several rounds of negotiations have already been held, as well as the meeting of the foreign ministers of Russia and Ukraine on the sidelines of a diplomatic forum in Turkey. There is some progress on the question of humanitarian routes. At the same time, the Ukrainian side hinders the education of local residents and foreign citizens of dangerous areas, as well as, does not spread information about community corridors among the population. There were cases when the nationalists shot civilians who wanted to leave the combat zones. Precisely, this happened on March 6 when fighters from the nationalist Azov battalion opened fire on civilians who were traveling through the Mariupol humanitarian corridor. Recently, as I said, we have faced a media campaign, unprecedented in its scale and preparation against our country.... All over the world we see many manifestations of discrimination and racial hatred.

# "Absolutely nothing wrong" – PM on Coye's financial license

Allegations of a conflict of interest have been made against Minister of State in the Ministry of Finance, Hon. Christopher Coye and one other minister due to their being granted a Financial Institution License. But according to Prime Minister Hon. John Briceño, there is nothing unethical about the issuance of the license, which was reportedly granted during the previous UDP administration.

BELIZE CITY, Wed. Mar. 30, 2022 In response to recent allegations of a conflict of interest on the part of Minister of State in the Ministry of Finance, Hon. Christopher Coye, who reportedly co-owns, with another minister of government, a company known as PHX Capital Limited that was granted a Financial Institution License by the Central Bank of Belize and has since been operating in the financial sector, Prime Minister Hon. John Briceño has stated that there is "absolutely nothing wrong."

"He's the Minister of State. I am the Minister, and I am responsible, so

at the end of the day, if there's something wrong, you hold me responsible, not Chris Coye," said the Prime Minister to local reporters.

According to a public notice published by the Central Bank of Belize, a license to carry out financial business granted to PHX Capital Limited was issued by the then Governor of the Central Bank, Joy Grant, on June 1, 2020—an entire five months before the November 2020 general elections that resulted in a change of administration, following which Coye was appointed as a Minister of State in the newly elected PUP government. And since the license was approved under a UDP government, Prime Minister Hon. John Briceño is insisting that there is nothing unethical about Coye's ownership of a financial enterprise while himself serving as the Minister of State in the Finance Ministry.


"I don't remember what the name is, but they [the two ministers] do have a sort of limited financial license...I don't want you to quote me, but yes, they've had this from in the UDP days, so if there's a conflict, maybe you should have talked to Dean Barrow back then," remarked the Prime Minister.

Phoenix Capital Limited is listed in Belize's Companies Registry as an international business company (IBC). Hon. Christopher Coye, in response to the recent allegations, has stated that the licensed company isn't conducting any business with the Government of Belize nor is it operating in the banking sector, since the license granted is only for conducting "financial business".

Of note is the fact that the person who reportedly unearthed the documentation for the financial license and raised concerns about a possible conflict of interest is former Governor of the Central Bank, Manuel Vasquez. Vazquez replaced his predecessor, Joy Grant, in April 2021 and was set to serve a five-year term after signing a contract with GoB. He was removed from the post, however, a mere five months later, with differences between Vasquez and the board of the bank being cited as one reason for his termination.

According to a report made by *Love News* in August 2021, Vasquez wrote several emails to his staff before his departure, with one of them stating that he had faced "stiff opposition from the Ministry of Finance and special financial and economic sector interests" including one major banking institute in Belize. In that email, Vasquez also stated that he had tried his best to "restore the integrity and operational autonomy of the bank."

But Prime Minister Briceño has vehemently denied that the issuance of the license had anything to do with Vasquez' departure. In fact, he told local media that Vasquez's concerns had been addressed and he had withdrawn his objections to the issuance of the license back in 2021. "The facts are that they have a company that was operating under the UDP government. The UDP government approved those licenses and when the former governor, Manuel Vasquez, found out about it because, apparently, when he found it in a different file where it did not belong. in some filing cabinet, he then started to ask about it, and then he was toldand he found out-that there was nothing wrong. It was straightforward. There is absolutely nothing wrong. And it ended as that. So, the former Governor, that has nothing to do with his stepping down as the Governor of Central Bank," said Prime Minister Briceño.



Kwéyòl, the French-based Creole language spoken by over half of St. Lucia's population, will soon be fully integrated into the country's education system. Education officials hope to ensure that students will one day be able to read and write in Kwéyòl as well as they do in English.

In working towards fully integrating Kweyol into the country's schooling system, St. Lucian education officials have created a Language Education Policy and Plan which was presented to education officers, principals, and other stakeholders this week during a consultation forum. Also presented was a Draft Implementation Plan which will be used to move the policy forward and which focuses on teacher professional development, curriculum and assessment, resource acquisition, and development and research.

According to St. Lucia Times



*News*, the move to integrate the vernacular language, known locally as Patwa (Patois), into schools is being made in an effort to ensure that students are bi-lingual by the end of primary school and bi-literate by the

end of secondary school, after which they would be as fluent in Kweyol as they are in English—particularly in the areas of reading and writing. The initiative, which was conceptualized by the language department of St.

"Specifically, the project addresses a very important issue of the status of the Creole language within the education system. The key objective being the development of an implementation plan which would essentially transform policy into action, paper into practice," she stated.

The policy and implementation plan were presented on Tuesday, April 5, to education officials and other stakeholders, who were given an opportunity to offer their feedback and suggestions on the policy before its implementation.

"Overall, our goal is to ensure that our learners, who are the most important clients in this process, benefit from their tenure within the school system. And, of course, teachers are very critical to learners achieving learning objectives within the classroom," commented Dr. Kathy Depradine, the head of the Modern Language Learning Unit at Sir Arthur Lewis Community College.

Discussions and consultations regarding the National Language Education Policy and the Implementation Plan will continue up until July of this year, when it is expected to be officially presented.





# 6,000 gang members in El Salvador arrested in 10 days

SAN SALVADOR, El Salvador, Wed. Apr. 6, 2022 The Government of El Salvador's

recent crackdown on gang members has resulted in thousands of arrests in less than two weeks and has also sparked some criticism by the office of the UN's High Commissioner for Human Rights. On March 27, 2022, just a few days after gang-related violence led to the deaths of 87 persons (62 of which occurred in just one day), Salvadoran president



Nayib Bukele announced а countrywide state of emergency, and placed blame specifically on the Mara Salvatrucha gang (MS-13) for the deaths. Since then, the country's law enforcement has been targeting all those suspected of being gang-affiliated, and at the time of the writing of this article, over six thousand men and women had been arrested. to

According

reports from Bryan Avelar of Guardian newspaper UK, the continued arrests have led to countless distraught families across the Central American nation searching for information regarding the fate of their relatives. Those families have claimed that even those who only work or live in gangdominated areas have been arrested.

Since the declaration of the state of emergency two weeks ago, several constitutional rights in the country have been suspended, including the right to be presumed innocent, the right to legal counsel, and the right to be informed of one's rights at the time of arrest. Throughout the course of the "war on gangs," President Bukele has frequently taken to Twitter to share updates related to the arrest of alleged gang members whom he has often referred to as "terrorists". Just this week, he tweeted that exactly 6,894 gang members had been captured in 11 days. He also went on to suggest that those arrests are going to continue. Furthermore, Bukele has used Twitter to speak out against those who might want to criticize his actions, going as far as to accuse the media, NGOs, and other entities of siding with the gangs.

#### "Do you know how many countries have decided to help us in the war against gangs? Exactly: NONE. Do not come later and try to tell us what we should have done or not do, when at the moment that we could have needed your help, you left us alone," states one of Bukele's tweets.

The office of the United Nations High Commission for Human Rights has issued a statement in response to the Salvadoran government's crackdown, criticizing what it has called the cruel and inhumane treatment of those arrested as well as the reported use of "unnecessary excessive force" by police.

The Government's most recent move in the crackdown on gangs has also resulted in what some have called a direct attack on the freedom of the press. On Wednesday, April 6, it was revealed that El Salvador's congress had passed several laws that could subject those in news media-whether radio, television, written, or digital-to possible sentences of up to 15 years in prison for sharing messages from any of the country's gangs. Despite protests from some, many Salvadorans, weary of the gangrelated violence, have commended President Bukele for his efforts.

### **BDF soldier charged with murder**

Prison after brutally beating an Orange Walk resident, whom he then left for dead, following a disagreement that reportedly erupted over a borrowed lighter. The incident, which occurred on Friday night, April 1, and was captured on video footage recorded by an onlooker's mobile phone, unfolded a little after 10:00 p.m. near Central Park. It was there, at the heart of Orange Walk Town, that 38-year-old Estevan Baeza and the soldier, Private Raheem Williams, got into an argument over the lighter that Williams had borrowed from Baeza but refused to return. That argument quickly escalated and ended on the median of the road with 27-year-old Williams punching and stomping a seemingly already unconscious Baeza before casually walking

away. And, unfortunately, it wasn't until the BDF soldier had finished his brutal assault on the 38-year-old that onlookers and passersby stopped to render aid. Shortly after, Baeza was placed in a police pickup that transported him to the hospital.

(Williams was reportedly pursued by two MIT police officers and was apprehended a few lanes away from the scene of the incident.)

Despite being taken to the hospital, however, Baeza passed away early Monday morning, just as his family was traveling to Belize City to pay for the facial and cerebral CT scan that doctors had told them he would be needing.

Vicenta Baeza, Estevan's mother, told local media that before her son's untimely death he had visited her and asked for coffee. Soon after, he told her that he was leaving to purchase tacos or fried chicken.

"He came to ask me for some coffee, so I gave it to him, and he said, 'Ma, I will go and get some tacos or fry chicken'. If I knew that would have happened to him, I would have held him, but I couldn't, because he was hungry and wanted to eat out. He wanted to eat something, and the man shouldn't have done that to my son because he is a human being and not an animal. The discipline that they gave the man was for war, not to kill Belizeans," said the grief-stricken mother.

She also noted that her son was not known to be belligerent or aggressive, and pointed out that she had taught all her children to be respectful.

"Maybe he had a beer. I can't say what my son was doing when they were out there but the man shouldn't have done that. I want justice for my son. He used to help me with money, clothes," was her sole source of financial assistance. She also shared with reporters her understanding of the sequence of events that led to her son's death. "He lends the BDF the lighter and

food, and pills," she stated. She

lamented that her son, who worked

at a "place where they packed

the BDF gave 2 other persons the lighter and that's when my son said, 'give me the lighter' and... then they started to fight, and like how the solder is bigger and more fit than my son, who is small, the BDF should have backed off. He punched him, threw him on the ground, he stomped him in his throat, he stomp his face, burst his head, burst his throat; he couldn't breathe. He pushed him down on the ground and that burst his head," she said.

Hon. Oscar Mira, the Minister of National Defence and Border Security and a retired Major of the Belize Defence Force, spoke with AMANDALA about the issue, and informed us that the BDF plans to ensure that its soldiers get all the counselling that they need.

"We have counselling sessions for all our soldiers, and we have just completed the counselling workshop. It is ongoing, but it is something that we're going to continue. It's something that we're going to make sure that every BDF soldier has the opportunity to seek counselling and sessions with companies and with the platoons whenever they are in operation," he stated, adding that he believes there might be a need to start providing counselling after soldiers finish their tours along the border.

Acting Deputy Commander of the BDF, Lieutenant Colonel Brandon Garcia, also spoke about the incident, and told local media that Williams' heinous actions are a violation of all the principles that are taught to those who enlist.

"When we saw that video, it is an indication of what a commander of the Belize Defence Force doesn't tolerate. We have a zero-tolerance policy for any brutality against civilians...We sensitize and educate our soldiers. We provide psychosocial support. We provide sensitization on international humanitarian law, because both when they are deployed in the jungle on the borders and [in] that urban environment these things apply," Garcia stated, later adding that soldiers are taught to treat civilians humanely and to follow the law of the land. "We are not above the law in any way," he said. According to Lt. Col. Garcia, Private Williams, who was reportedly stationed at Colonel Eyles Camp in Orange Walk Town, had been evaluated psychologically before joining the force, and since joining he had not exhibited any violent tendencies. When asked whether Williams will have a future





# **Churches' call for referendum gains steam**

process through which the use, cultivation and sale of marijuana would be legalized in the country.

This week the United Democratic Party and the National Trade Union Congress of Belize (NTUCB) issued public statements backing the call for a referendum, though none of those parties have yet indicated what specific question would be asked of the public in the proposed plebiscite.

"In the name of Democracy, let the people decide in a referendum," states a press release issued by the United Democratic Party, which also notes that one of the party's guiding principles is to "heed the will of the majority of citizens" that it has sworn to serve.

The Leader of the Opposition and newly elected UDP leader, Hon. Moses "Shyne" Barrow, has previously voiced his support for the push to legalize marijuana.

In January of 2021, Hon. Barrow wrote a statement to local media in which he indicated that he would support an amendment to the Constitution for legalization of marijuana, citing the fact that, in December 2020 the then Presidentelect of the United States had gone on record in support of the federal legalization of cannabis.

"Legislation to legalize marijuana is long overdue in Belize and would reverse the failed policy of criminalizing marijuana which would take steps to address the heavy toll this policy has taken, particularly on poor communities," he had stated.

It is to be noted that last Friday, April 1, the U.S. House of Representatives passed a bill to end the federal ban on marijuana.

Belize had, under a UDP administration, decriminalized possession

of up to 10 grams of marijuana via a bill passed by the National Assembly on October 20, 2017, and that bill was signed into law by the then Governor General, Sir Colville Young, on November 3, 2017.

At that time the leadership of the NEAB had hosted a press conference to complain that the Government had passed that law too fast, without carefully considering their objections.

The Cannabis and Industrial Hemp Control and Licensing Bill that was passed last Wednesday, like the previous decriminalization bill, received bi-partisan support in both houses of parliament, but the social senators, particularly the church and labor senators, strongly voiced concerns and called for more time for further consideration of their concerns and objections.

Hon. Eamon Courtenay, the Leader of Government Business in the Senate, told the chamber before calling for the vote: "It is this Senate, the social partners, the senators, who objected to the format of the previous bill. We changed that. They objected to the new composition set out in the bill. We changed that. They objected to the discretion of the minister to remove. We changed that. They requested money be indexed. We put that in. They wanted money for education. We put that in. They wanted money for policing administration of the bill that is in there. We introduced a taxation on it. All of that and more. Not around the residency of residential areas or schools. We put that in, and yet we are here being told that we're hearing and not listening. Madam President, I don't worry about it. I don't operate like that."

After the vote, Courtenay said he would ask that the signing of the bill into law by Governor General Dame Froyla Tzalam be delayed by a month to address any further concerns. Those expressions of concern are coming from various quarters. This week, the National Trade Union Congress of Belize (NTUCB) was another entity which came forward to express its support of the NEAB, BEAC and the Council of Churches' call for a referendum, and, like the United Democratic Party, it cited the upholding of democracy as its motivation.

"The National Trade Union Congress of Belize (NTUCB) is calling upon the Government of Belize to immediately stop the commencement of the proposed cannabis legislation," stated its press release.

The NTUCB then went on to demand that the Government of Belize conduct "countrywide consultations to sensitize and listen to the positions of Stakeholders, Social Partners, and the wider public," in addition to holding a referendum.

The dissenting secular organizations have not indicated whether they will join the religious groups' logistical effort to gather the almost 20,000 signatures needed to trigger a referendum. Hon. Kareem Musa, the bill's sponsor and the Minister of New Growth Industries, has stated that he regards further delay and a referendum as a massive waste of taxpayers' money.

He stated in an interview on one local television station: "It is the taxpayers of the country that will actually have to pay, and it's in the millions of dollars; let's be real. So, you have 2 mass political parties that are supporting a particular bill, we already know mobilizes voters when it comes to a referendum, so you imagine you have the PUP and the UDP mobilizing constituents for a yes vote and so we kind of already know what the outcome of the vote will be, so I believe it will truly be a waste of resources unnecessarily ..."

Reliable reports are that Hon. Shyne Barrow was only joined by two other members of the caucus of interim constituency caretakers (31) and members of the Central Executive Committee (20) who met and considered the call for a referendum. Reportedly those were Giovanni Alamilla (Pickstock) and Edmond "Clear The Land" Castro (Belize Rural North), who is a Rastafarian.

It is reported that the overwhelming majority of the delegates at the NTUCB caucus supported the call for a referendum on the issue of the legalization of marijuana in Belize.

The referendum proponents face the end of the month as a deadline to gather and submit their signatures and petitions for verification to the Governor-General.

As of January 31, 2022, Belize had a total of 186,893 registered voters, and the valid signatures of 10% of those voters would be needed to trigger a referendum.

The Referendum Amendment Bill was passed as part of the Belize Constitutional Sixth Amendment Bill on August 22, 2008, and survived challenges all the way to the Privy Council, whose judgement in March 2010 ensured it became the law of the land.

In August of 2008, the Barrow administration had introduced the Sixth Amendment to the Constitution in the House of Representatives and the package of amendments was tied up in the courts for 20 months. One of the most compelling of the multiple legal challenges ironically was the question of whether the government was obligated to hold a referendum before passing some of those amendments because they altered the fundamental rights granted to citizens under the Constitution.

The Supreme Court of Belize and the Belize Court of Appeal found that a referendum should have been held, though it was unclear at what stage, but a dissatisfied Barrow administration successfully appealed to the Privy Council.

In October 2011, the courts found that the Government of Belize was under no obligation to hold a referendum on the Belize Eighth Constitutional Amendment, despite the petitioners having gathered 20,000 signatures.

In February 2012, the Governor General disallowed enough signatures to thwart Oceana's attempt to trigger a referendum on offshore oil exploration.

In December 2013, the Elections and Boundaries Commission rejected a petition by the PUP to trigger a referendum for the recall of then Cayo Northeast area representative Elvin Penner because the petition lacked 300 more valid signatures.

The NEAB, BEAC, The Council of Churches, the NTUCB and the UDP must hope that despite the record of failure of all prior attempts, this time their attempt will be the charm.

AMANDALA. "We can't look to Russia and the US continues to work for us."

He did not think the vote would affect our relationship with the US or Guatemala, but we had to be concerned that Taiwan might be worried. The Chinese breakaway republic is claimed by China and continually faces the threat of invasion by its larger neighbour. Taiwan has given Belize tremendous foreign aid to the tune of hundreds of millions of dollars in grants and loans. "I would not have abstained." Elrington said. "We are not that far removed from their (Taiwan's) position. We must be principled." Former foreign minister Assad Shoman told AMANDALA that he would have wanted to vote no, but he did not think the vote would have any material effect on the ICJ, or our relations with either Guatemala or the United States. However, he said, he thinks Belize did the right thing by abstaining. Belize's current minister of Foreign Affairs Eamon Courtenay told KREM News today that "Belize has repeatedly condemned the illegal Russian invasion of Ukraine, and we have condemned the clear breaches of international humanitarian law by Russia. We have called for a ceasefire and for an end to this unnecessary and very damaging war. In our view, the negotiations should be encouraged and facilitated. The suspension of Russia from the HRC does not help with the overarching objective of a return to peace. We strongly encourage independent investigations to corroborate the atrocities in Ukraine

followed by bringing perpetrators to justice. The war must end and war criminals prosecuted."

Barrow thought while Courtenay's assessments were on point they did not represent a principled stand.

Indeed, Madam Lisa Shoman, now a Belize supreme court judge and a former foreign minister said: "We Belizeans have always stood for certain principles, foremost among which is independence and self-determination. I cannot think of any good reason to abstain when these ideals which we cherish are at stake. "

Of note is that just two months ago, Belize and Russia had made an agreement to remove visa requirements, thus allowing Belizean to travel to Russia visa free for up to 90 days and vice versa. Additionally, the year 2021 had marked 30 years of established diplomatic relations between Russia and Belize.

with the BDF, Lt. Col. Garcia noted that the disgraced soldier will be suspended from the force and that his dismissal will hinge on the outcome of his case.

"When this matter went in front of the court, I understand he was charged for the unlawful death of Baeza. [It is to be noted that Williams was charged with murder.] Our procedures [are] simple. This is a matter for the court, and we will be making submissions to our Security Service Commission to ensure that he is suspended until the outcome of his case," he said. On Monday, April 4, the BDF, as well as The Belize Bar Association, had condemned Williams's brutal actions via press releases, and both organizations expressed their condolences to the family of Estevan Baeza. Also, according to Lt. Col. Garcia, members of the Belize Defence Force met with the family of Baeza shortly after his death to extend their condolences, and the BDF will also be helping the family to cover funeral expenses.

When speaking to reporters earlier this week, Baeza's mother had remarked, "I would like to ask the BDF to give me the weekly money my son used to give me to help myself. I believe in God; I am not like him who hurt my son."
