
### Tragedy at female oss Country race

### **Bloody weekend in** the Belize district

Three men were gunned down in the Belize District over the past weekend in separate incidents. The three shootings—two in Belize City and one in Mahogany Heights—were just a portion of the bloodshed that was seen across the country in a span of four days.

A series of murders rocked the Belize District over this past weekend-each of which reverberations through the respective communities in which the victims belonged,



with one of the shootings causing great sorrow within the community of local music artists and among football enthusiasts while another deeply grieved those who had benefited from the acts of a reputed Good Samaritan in the Mahogany Heights community.

The murder of that Mahogany Heights resident occurred on Friday night. April 8, at around 7:30 p.m. Police arrived at a Pine Street address in

### **Human Rights Commission responds to MOFA**

"There is nothing unlawful or illegal about anyone entering Belize without proper papers and requesting asylum," states a press release from the Human Rights Commission

The Human Rights Commission of Belize (HRCB) issued a press release this past week addressing the Ministry of Foreign Affairs, Foreign Trade, and Immigration's recent comments regarding the influx of irregular Cuban migrants into the country. In the release, the Commission outlined its stance on the matter, stating that it remains committed to ensuring that the rights of all persons, migrants, and refugees included, are upheld under the law and noting that "there is nothing unlawful or illegal about anyone entering Belize without proper papers and requesting asylum."

Last week, the Ministry of Foreign Affairs, via a press release, stated that migrants, particularly those from Cuba, have been exploiting the country's refugee program in order to use Belize as a transit point for reaching the US/ Mexico border. That release was issued shortly after the Minister of Foreign Affairs, Hon. Eamon Courtenay, had stated during a Senate meeting that the Ministry would be doing all that it

could to reduce the flow of irregular migrants into Belize, adding that the country currently has a "serious migration problem."

Hon. Courtenay's promise to crack down on illegal immigration was made just as a group of nine Cuban nationals, including two minors,

narrowly escaped repatriation. After having been detained at the Belize Central Prison for approximately 50 days, those persons were scheduled to be placed on a flight back to Cuba. The Human Rights Commission, however, had stepped in, taking out a habeas corpus and demanding that the group be allowed a fair trial in court before any action was taken against them.

A similar scenario had emerged after the Supreme Court had ordered the release of a group of Cubans who had been detained after being denied the opportunity to apply for asylum. Shortly after, it was revealed that those persons had left the country without informing any authority. But the Human Rights Commission says that, in this case, the only law that those persons broke was leaving in contravention of immigration laws which require that persons leave through specified exit points.

"They were free to leave... We all have freedom of movement, and no restriction had been placed on them. Additionally, in our country we have unmanned, uncontrolled borders," stated the Commission in reference to the matter.

In its release, the Commission further added that irregular migrants should not be charged for illegal entry nor should they be sent to prison with the general prison population—which includes actual convicted criminals—to await transportation out of the country.

During an interview this week, the Minister of Home Affairs, Hon. Kareem Musa, was asked by local reporters whether the situation involving the Cuban nationals could "pose a threat" to the country. Hon. Musa, however, stated that it was a question he would have to direct to the Ministry of Immigration before he could give a response.

AMANDALA reached out to the Ministry of Foreign Affairs for comment regarding the HRCB's statement, but we received no response.

## Two bodies found over the weekend

Over the last few days, two bodies were found in separate locations in the country—one was that of a Chinese national who apparently drowned, while the other belonged to a victim of a stabbing.

On Friday, April 8, sometime after 9:30 a.m., the body of 64-year-old Yichao Li, a resident of 2nd Street South, Corozal Town, was found in the water on the shores of that town. Li was fully dressed and floating in a facedown position. He was later identified by his son, Daquan Li, 36, also of Corozal.

According to ASP Fitzroy Yearwood, Communications Director of the Belize Police Department, a postmortem examination conducted on Li's body revealed no sign of foul play. The cause of his death was listed as asphyxia due to inhalation of fluids as a consequence of drowning.

Later, on Sunday, April 10, the body of Daniel Gutierrez, 16, who had been reported missing a few days earlier, was found at around 7:42 a.m. somewhere near the Isidoro Beaton Football Stadium. There was a stab wound on the left side of Gutierrez's chest, and his body was already showing early signs of decomposition. According to ASP Yearwood, Gutierrez had been reported missing by his aunt on Tuesday, April 5. Currently, police have 2 persons detained for questioning in connection with the murder of the Belmopan teen.

Oswaldo Gutierrez, Daniel's father, told local media that the last time he

heard from his son was on Tuesday when the teen went to borrow a bike from his aunt.

"The last hour that they saw him was on Tuesday night when he went to borrow a bike from my sister; that was about 8 o'clock or 8:30, something like that. From there, he said he was going to buy at the shop or something he went to buy. But the thing is, he didn't come back to my mother's house, because he was supposed to sleep there that night, and that's why I wasn't expecting him to reach home," he said.

Oswaldo believes that his son's death might have been the result of some conflicts that the teen may have had.

"Well, I believe maybe he had problems with someone and didn't tell anyone, so that's why we can't know anything more or less what happened to him because he didn't tell anyone if he had an enemy or anything or there. So it's kind of hard to know, because he didn't tell anyone about anything," he said.

According to Gutierrez, his son wasn't a problem child, but he had been apprehended a few times by law enforcement personnel due to his habit of wandering on the streets.

"Police have taken him several times, because he [likes] to be out on the street, and they don't want him on the street. Some police already know him and they don't want him on the street, but he [didn't] want to listen, but that was all the problem," said Gutierrez.

Police have yet to establish any motive for the murder of Daniel Gutierrez.

## Teen dies in Gales Point motorcycle accident

17-year-old Joshua Samuels was killed when the motorcycle he was driving, crashed into a lamppost near the Gales Point Manatee cemetery.

A teenager from Gales Point Manatee in the Belize District lost his life when the motorcycle he was riding, crashed into a lamppost in the village on Saturday, April 9. According to initial police reports, at about 6:00 o'clock that evening, 17-

year-old Joshua Samuels was driving his motorcycle in the vicinity of the Gales Point Manatee Cemetery when the motorcycle reportedly rammed into the lamppost. He was transported to the Southern Regional Hospital (SRH) by family members, but unfortunately succumbed to the injuries that he received.

Samuels' body remains at the morgue of the Southern Regional Hospital, where it will undergo a postmortem examination. Meanwhile, police are carrying out an investigation to determine whether the teenager had been licensed to drive the motorcycle.

"It's unfortunate, and it happened to a youth, 17 years old, so I know that our officers will investigate this also to find out what was the cause of this accident. Anywhere a life is lost, we investigate until proven that it happened naturally, and then we leave it to the family to deal with their loss," said ASP Fitzroy Yearwood, Communications Director for the Belize Police Department.

### Andre Vega wins appeal

The son of former Deputy Prime Minister Gaspar Vega no longer has to repay the Government of Belize—and the people of the country—the \$400,000 he had been ordered to pay by Supreme Court judge Courtney Abel in a 2019 Supreme Court ruling, since that ruling was overturned at the Court of Appeal.

Almost six years ago, Belizeans became aware of what appeared to have been a sordid series of land transactions that enriched two persons, one of whom was the son of the Minister in charge of the Lands Department, Gaspar Vega, at the expense of Belizean taxpayers. Those two persons— attorney Sharon Pitts and Andre Vega (son of former UDP Minister Gaspar Vega) had purchased private land from an apparent middleman affiliated with Minister Vega, who had bought it from GoB for a few thousand dollars, and a short time after, when the private ownership of the land was "discovered", they were each paid \$400,000 so that government could reacquire the land. The inappropriate nature of the series of transactions—the sheer obscenity of the process by which a young man gained hundreds of thousands of dollars as a result of a transaction orchestrated by a government department headed by his father—had prompted many Belizeans to call for justice. And it had appeared that the "justice" they had sought had been served when, in 2019, a Supreme Court judge had ordered Andre Vega

to pay back the money he had received from GoB. Vega had appealed that ruling, however, and last week, the Court of Appeal made the decision to throw out the 2019 Supreme Court ruling that required Vega to repay \$400,000 to the Government of Belize.

Readers may recollect that in October of 2016, it came to light that Vega's father and then Deputy Prime Minister, Gaspar Vega, who was the Minister of Natural Resources at the time under the previous UDP administration, had, in January 2013, approved the sale of a little over an acre of land located near the Haulover Bridge to Hilmar Alamilla, who was an associate of Minister Vega. While the value of the 1.057-acre seafront parcel, located between the Caribbean Sea and the Philip Goldson Highway, was assessed at several thousand dollars, Gaspar Vega, who was also the Minister of Natural Resources, via a directive to former Lands Commissioner Wilbert Vallejos, approved the sale of the plot for a discounted \$2,500, notwithstanding the \$6,000 value assigned within the department. Alamilla received the title to the land in May 2013, and in December 2013, only months later, Alamilla would then sell the plot to the Deputy Prime Minister's son at a

price of \$15,000. There was no acknowledgement at the highest levels of the Ministry that the land was privately owned, despite reports that there are documents which show that land surveyors in the ministry had indicated to their superiors that the land was privately owned. When GoB thus found itself having to reacquire the land, which already had a private owner, the Lands Department became liable to compensate Vega and Pitts a whopping market value of \$400,000 each in taxpayer monies.

When the transactions became known to the public, there was huge outcry, and the Barrow administration did not have much choice but to remove Gaspar Vega from his ministerial post, which was later followed by his resignation. While Andre Vega's attorney maintained that the charges brought against him were unfair, since the error was made by the Lands Department and not due to any corrupt act of his client. Justice Courtney Abel ruled that Vega was "unduly enriched" and had to return the money received in 2016.

Pitts had also been ordered to pay back what she had received, and while it was reported in 2018 that she had headed into mediation in order (in the words of Solicitor General Nigel Hawke) to "arrive at an amicable solution", Vega had opted instead, through his attorney, to file an appeal in 2020. The Court of Appeal in their ruling last week stated that the Supreme Court fell into error by "absolving the GOB from blame for the consequences of its wrong in



issuing the Minister's Fiat Grant 182 of 2013." To that end they ruled that the blame for any wrongdoings in the matter was unjustly transferred to Andre Vega, "instead of laying it squarely at the feet of the GOB where it truly belonged".


Notably, at the time of the scandal, it had been said that an audit of the Lands Department would be conducted to determine who was liable for what took place and to see whether a criminal investigation was necessary, but the Auditor General at the time, Dorothy Bradley, later indicated that the department's records were not reliable enough to produce a substantial report of findings to the public. In March 2021, Auditor General Bradley had stated, "The truth is that we spent almost 2 and a half years at Lands, trying to gather information... And when we started to reconcile that information, we could not, because the information was terribly distorted... So, it wasn't credible for us to put out there."



### PC to answer for not intervening in bus terminal beatdown

A video recorded via cell phone that shows a mentally disturbed woman in the nude attacking another woman at the Novelo's Bus Terminal in Belize City has garnered much attention, particularly because the footage, which shows one woman throwing another into the closed shutters of a store at the front of the bus terminal and then stomping her, also revealed that a police officer was present during the altercation. The woman police officer can be seen hiding inside the terminal,

refusing to intervene, and, according to some onlookers, even giggling, while other onlookers asked for someone to stop the fight.

In Monday's police media briefing, Commissioner of Police, Chester Williams spoke on the matter and stated that the police officer will be asked to explain why she did nothing to stop the two women.

"Certainly the video was sent to me. I must express my extreme disappointment in the actions of the police in question. It shows that indeed these two females were having an altercation and a female police officer standing back, hiding, and appeared to be laughing and I don't know if she was laughing [at] what was taking place. But whatever it may be, her actions certainly are a breach of discipline. A clear act of neglect of duty and that matter has been referred to PSB and they're dealing with the matter," stated Commissioner Williams.

The Commissioner also mentioned that it is the duty of police officers to serve and protect the public. He believes that if the officer was not capable of rendering assistance, she should have called for backup.

"As police officers, we do have a responsibility. We took an oath of

office to serve and to protect the public. In our oath it says, 'that we must do so fairly without -favor, affection and ill will' and it is expected that we uphold that oath. If it is that the officer in question felt that she was not in a position to adequately address the issue without being harmed, then at the very least she could've called for support to come so that the matter could have been addressed. So I'm not going to convict her, but she needs to explain what happened [and] why certain things were not done and that is what the investigation is going to reveal," he said.

the Mahogany Heights community, where they found a man's motionless body in a sitting position on the floor near the door of the home. The man, identified as Carlton Gladden, 52, also known as "Yankee", had sustained a gunshot wound to the body. Gladden was transported to the Karl Heusner Memorial Hospital (KHMH) where he was pronounced dead on arrival.

Marlon Dunn, a neighbour of Gladden, whom Gladden had often gifted with food, clothing and other necessities, told 7News, "Earlier in the day, he came over to our house and he brought some stuff so we could eat, because we don't really have anything to eat, and he's the only one who's been helping us around here. So Friday night we were in the house, me and my son, and we were watching movies and we heard two gunshots. So I asked my son what that sounds like. He said, 'Dad, it's gunshots.' So I told him, 'Let's stay inside the house, so he stayed in the chair. I stayed on the floor and lie in my bed. Couple minutes after that, he come outside and he saw Mr. Yankee's burglar bar door open and his front door open, so when he looked across he saw Yankee on the ground in a sitting position with his head leaning on the door."

While the police are still investigating, the Communications Director of the Police Department, ASP Fitzroy Yearwood, told local reporters that they believe that the murder was possibly drug-related.

AMANDALA was able to speak with Karen Gladden, the sister of the deceased, who said that she only has fond memories of her brother.

"With him, Carlton was the type of person that was always good, and when he love, he loves hard. I remember he was in love with this girl and the girl broke his heart, and he cried. That boy was something else when he loves you; he'll love you hard. He had a dog and the dog got killed; he cried. That's just how he was. He was really, really sweet. It's kind of hard to talk about him, but my thing with him is he would give you the world... He had gotten in trouble one time, and the police brought him home because they said they wanted

nothing to happen to him because he was a good kid, so that's how sweet and good he was that he didn't do anything to him," she said.

Gladden was often regarded as somewhat of a hero in his community, since he had assisted many residents with food, money, and even clothing.

The second and third murders in the Belize District both took place in the city and occurred within an hour of each other on Saturday night. Sometime around 6:35 that night, police arrived on Jones Street in Belize City, where they found the body of Mark Anthony Lord, a 39-year-old construction worker, lying face-down on the street with gunshot wounds in his body.

According to police, Lord had been walking on Jones Street when he was approached by an unknown gunman who fired several shots at him, which caused his death. Due to swift police response, two male persons were apprehended, and a 9mm pistol—believed to be the murder weapon—was recovered. And on Tuesday, April 12, police arrested and charge Darbin Joel Romero, 21, for the murder.

Almost an hour later, at around 7:35 p.m., prominent Belizean semi-pro footballer and local reggae/rap artist, John King, was shot and killed. According to reports, 28-year-old King was sitting inside a residence located on Victoria Street, which was reportedly the home of a friend, where, incidentally, he had previously been wounded by gunshots in June of last year, when he heard someone outside the home shout "evil" several times. (It has been reported that "Evil" was reportedly the nickname of an associate of his). When King ventured outside the residence to see who it was, an unknown gunman opened fire on him. The 28-year old ran back into the home, and collapsed in the bathroom shortly after. He was then rushed to the Karl Heusner Memorial Hospital (KHMH), where he succumbed to his injuries moments later while receiving treatment.

John King is known throughout the country as a semipro-football player who last played for Caesar Ridge FC. As previously mentioned, in June of last year, King was shot at the very residence on Victoria Street where he

was killed on Saturday. However, that previous gunshot injury—a wound in the buttocks—had not been lifethreatening. Thereafter, King had begun to perform on the local music scene, and his voice has been described by many as distinct and evocative.

Henry Gillet, manager of the Caesar Ridge FC, spoke with *AMANDALA* about his interaction with King, who according to police, was not a gangmember.

"I've [known] John King for a long period of time; I would say about 15 years. I know John King as a smooth, upcoming, young, talented, athlete, I didn't know he was a rapper. I know John King as a football player. John King played in almost all the semipro football clubs in Belize. John King is a cool, outgoing young man. He's not out there creating problems, creating violence. He just likes playing football, he likes to dance, and he likes to rap. So what happened to John King, it really touched me, as John King isn't that person that's in the streets. Yes, he grew, played ball and grew up in the Jungle area, but that doesn't mean because he's from that area he's a bad person," Gillett said. (King, who reportedly grew up in the Jungle area, played football at a young age with the Brown Bombers youth football club while he was a student at Hoy Redeemer primary school.)

Following King's death, there has been an outpouring of expressions of grief, as well as tributes, from both local artists and various football associations to which King had belonged. On Sunday, the Football Federation of Belize (FFB) posted the following statement on social media: "It's always a sad day when we have to make these types of posts, but it's even more heartbreaking when it's about an individual full of so much potential who lost his life to gun violence." The FFB further stated, in reference to the passing of King, who had played for a number of football teams, including the Belmopan Bandits, the Belize Defence Force FC, the San Pedro Pirates, Police United and Verdes, "Footballers and musicians from across the country are mourning this great loss."

"We will always remember you as

a happy team player," noted the San Pedro Pirates, who remarked that they were "saddened by the bad news of the passing of a former player."

The Caesar Ridge Football Club, with whom King had been playing this season, stated in a post that it "mourns the death of its current player" and remarked that "Belize football has lost a great, young and prominent talent who has represented Belize regionally and internationally."

During Monday's police press briefing, Commissioner of Police Chester Williams stated that while King himself was not a gang member, he may have been targeted for his affiliation with some members.

"From our investigation, Mr. King is not known to be a gang member; that's the truth. [Does] he hang out with gang members? Yes. He does have associates who are gang members, but he was not out there as a gang member. Perhaps he was targeted due to his affiliation with certain gang figures, and from the way the incident occurred, it certainly appeared as if he was indeed the target. It's hard we're still trying to wrap our fingers around this one to ascertain a motive, and we're not been able to get one. Until we do get one, then we will be able to say definitively who is likely to retaliate," he stated.

The COMPOL then went on to highlight the fact that none of the weekend killings, including those that occurred outside the Belize District, are connected. He also noted that additional police personnel will be dispatched to the Mahogany Heights area as well as to Belize City.

"We are ramping up our police presence on the ground. We have put additional features to our Mahogany Heights operations as well as our operations in the City where we're now going again at these gang members with a view to see how we can stem any further retaliation. We have engaged the LIU, who will also be looking at intervention with those with whom we can do an intervention. But our primary objective is to make sure that we do what we can to solve them and [the ones] we're not to solve, we'll look at other measures to prevent any further retaliation in respect to these murders," he said.



### Questionable law sets up Belize for fleecing

In the novel *The Adventures of Oliver Twist*, by Charles Dickens, Mr. Bumble questioned the wisdom of "the law" when he was told in court that he had some responsibility for his wife's wicked doings. He, Mr. Bumble, did not have clean hands, and in fact the law had him dead in the crosshairs. Laws don't drop out of a hat; they are thoroughly thought out, so it's not surprising that Mr. Bumble was guilty as charged; however laws, like all things conceived or made by man, aren't perfect. Indeed, some laws and their workings befuddle us.

It's possible that in the coming days or weeks we'll be able to process what in the world is going on re: the recent news that we owe apologies and maybe hundreds of thousands of dollars to former government ministers who were interrogated about their handling of the people's assets. If that isn't puzzling enough, we also have to process an April 7 *Channel Seven News* report that the court had ruled in favor of a party we thought owed us \$400,000 for compensation he got from GoB, for land he got from GoB that GoB couldn't give him.

Our poor little brains — how can we wrap it around cases like these, and others that cost the people even more? So very often we are left flabbergasted by cases involving the government and land. Land sold by the government and people for a pittance, for hundreds or a few thousand dollars, is turned into winnings in the millions of dollars for some parties. It makes the *Lotto* look like child's play.

Starting at the beginning, the government, in the service of the people, sells land to citizens/businesses for those persons/entities to develop, either to construct houses to shelter their families, or to create farms or other businesses, activities that

serve to increase the wealth of the nation. Sometimes, because of poor planning or error, government sells land that it later needs for the expansion of roads or the construction of hospitals, clinics, schools or playgrounds. The government then moves to reacquire portions of the land it sold.

The process for GoB to acquire/reacquire land is very simple. The government and people have a need and the government's experts identify the most suitable parcel for the purpose and sets about acquiring it. The government's agents assess the value of the parcel and make an offer: cash or an alternative parcel. The landowner can challenge the government's offer. If the individual challenges the assessment, and they and the government can't come to an agreement, the matter ends up in court.

It's incredible. The government sells land to individuals and businesses at rock bottom prices. But when government needs to reacquire land, in the best interest of the people, the people's funds get raided.

Too many people want more than what the government offers. They want to go to court, to the law, to extract from the government and people of Belize cash based on the full market value of the land. Understandably, people cold-bloodedly seek the best price they can get in a private transaction. But transactions between government and individuals, as evidenced by government never selling land at full market value, are not completely moneyoriented. There is a fault in the law. It protects the rights of individuals to the max. Its protection of the rights of the government and people is feeble.

In its 2020-25 manifesto the UDP pledged that if it was returned to power it would address a valuation system that gave large sums to landowners when government needed "to correct a mistake or acquire land in the public interest." Although that pledge is not in the present government's manifesto, it has to, while its mandate is still fresh, make a move to address this problem.

All wealth is based on land. There are expeditions by the wealthy, powerful countries in the world to the moon and other far-off places, for the purpose of accessing more material wealth. They might be successful, as well as they might not; what is for sure is that what exists at this time is here, on earth. The land—developing it, trading it, strategically reserving portions of it—brings wealth to a nation. Gouging the government and people for reacquired land only enriches individuals.

The capitalist system is based on respect for private ownership, but that can't be to the detriment of our country. We are twiddling our fingers while our people descend deeper and deeper into poverty. While some take advantage of the national treasury, more than 50% of Belizeans are experiencing serious financial hardship. In their hopeless state, some desperate Belizeans turn to stealing, armed robbery, and other extremely violent activities, all for the purpose of surviving. The millions being legally plundered from the government and people are funds that could be used to bolster NHI, improve education, subsidize public transportation, and fix our roads.

It's either the government fixes the law, all weak laws, or Belizeans develop a conscience, start asking what we can do for our country. Every year during the September celebrations period, the government gives out awards to deserving citizens. There should be an award ceremony for citizens who had land taken away for a public purpose, and showed a conscience for the government and people of Belize.

The recent exposure of businesses that are charged with owing GST has given those enterprises a bad look, but those business persons will have their day in court to dispute the charges or explain how they fell into arrears. Those who owe GST pale beside those who are effectively "fleecing" the government and people over land reacquisition necessitated by poor government planning or error.



### Cuestionable ley deja abierto a Belize para ser desplumado

En la novela *Las aventuras de Oliver Twist*, de Charles Dickens, el Sr. Bumble cuestionó la sabiduría de "la ley" cuando le dijeron en la corte que tenía alguna responsabilidad por las malas acciones de su esposa. Él, el señor Bumble, no tenía las manos limpias, y de hecho la ley lo tenía cabal en el punto de mira. Las leyes no caen de un sombrero; están minuciosamente pensadas, por lo que no sorprende que el Sr. Bumble fuera culpable de los cargos; sin embargo, las leyes, como todas las cosas concebidas o hechas por el hombre, no son perfectas. De hecho, algunas leyes y su funcionamiento nos confunden.

Es posible que en los próximos días o semanas podamos procesar qué mundos está pasando con relación a la reciente noticia de que debemos disculpas y tal vez cientos de miles de dólares a ex ministros de gobierno que fueron interrogados sobre su manejo de los bienes de la gente. Si eso no es lo suficientemente desconcertante, también tenemos que procesar un informe de *Channel Seven News* del 7 de abril de que el tribunal falló a favor de una parte que pensamos que nos debía \$ 400,000 por compensación que recibió del Gobierno de Belize, por tierras que recibió del Gobierno que el Gobierno no le podía dar.

Nuestros pobres cerebros pequeños: ¿cómo podemos hacerlos entender casos como estos y otros que le cuestan aún más a la gente? Muy a menudo, los casos que involucran al gobierno y la tierra nos dejan estupefactos. La tierra vendida por el gobierno y la gente por una miseria, por cientos o unos pocos miles de dólares, se convierte en ganancias de millones de dólares para algunas partes. Hace que la lotería parezca un juego de niños.

Desde un principio, el gobierno, al servicio del pueblo, vende terrenos a ciudadanos/empresas para que esas personas/entidades desarrollen, ya sea para construir casas para albergar a sus familias, o para crear fincas u otros negocios, actividades que sirven para aumentar la riqueza de la nación. A veces, por mala planificación o error, el gobierno vende terrenos que luego necesita para la ampliación de caminos o la construcción de hospitales, clínicas, escuelas o parques infantiles. Luego, el gobierno toma medidas para readquirir porciones de la tierra que vendió.

El proceso para que el Gobierno adquiera o vuelva a adquirir tierras es muy simple. El gobierno y el pueblo tienen una necesidad y los expertos del gobierno identifican la parcela más adecuada para el propósito y se proponen adquirirla. Los agentes del gobierno evalúan el valor de la parcela y hacen una oferta: efectivo o una parcela alternativa. El propietario puede impugnar la oferta del gobierno. Si la persona impugna la evaluación y ellos y el gobierno no pueden llegar a un acuerdo, el asunto termina en los tribunales.

Es increíble. El gobierno vende tierras a particulares y empresas a precios bajísimos. Pero cuando el gobierno necesita readquirir tierras, en el mejor interés del pueblo, los fondos del pueblo son saqueados.

Demasiadas personas quieren más de lo que ofrece el gobierno. Quieren ir a los tribunales, a la ley, para extraer del gobierno y del pueblo de Belize dinero en efectivo basado en el valor total de mercado por la tierra. Comprensiblemente, las personas buscan a sangre fría el mejor precio que pueden obtener en una transacción privada. Pero las transacciones entre el gobierno y los individuos, como lo demuestra el hecho de que el gobierno nunca vende la tierra al valor total del mercado, no están completamente orientadas al dinero. Hay una falla en la ley. Protege los derechos de las personas al máximo. Su protección de los derechos del gobierno y del pueblo es débil.

En su manifiesto 2020-25, el UDP prometió que, si volvía al poder, abordaría un sistema de valoración que otorgaba grandes sumas de dinero a los terratenientes cuando el gobierno necesitaba "corregir un error o adquirir terrenos de interés público". Aunque ese compromiso no está en el manifiesto

del gobierno actual, tiene que, mientras su mandato aún está fresco, tomar cartas en el asunto para abordar este problema.

Toda la riqueza se basa en la tierra. Hay expediciones de los países ricos y poderosos del mundo a la luna y otros lugares lejanos, con el propósito de acceder a más riquezas materiales. Pueden tener éxito, así como también pueden no tenerlo; lo que es seguro es que lo que existe en este momento está aquí, en la tierra. La tierra, desarrollarla, comercializarla, reservar estratégicamente porciones de ella, trae riqueza a una nación. Extorsionar al gobierno y al pueblo por tierras readquiridas solo enriquece a los individuos.

El sistema capitalista se basa en el respeto a la propiedad privada, pero eso no puede ser en detrimento de nuestro país. Estamos jugueteando con los dedos mientras nuestro pueblo desciende cada vez más a la pobreza. Mientras que algunos se aprovechan del tesoro nacional, más del 50% de los beliceños están experimentando graves dificultades financieras. En su estado de desesperación, algunos beliceños desesperados recurren al robo, el robo a mano armada y otras actividades extremadamente violentas, todo con el propósito de sobrevivir. Los millones que se saquean legalmente del gobierno y la gente son fondos que podrían usarse para reforzar el Seguro Nacional de Salud, mejorar la educación, subsidiar el transporte público y reparar nuestras carreteras.

O el gobierno arregla la ley, todas las leyes débiles, o los beliceños desarrollan una conciencia, comienzan a preguntarse qué podemos hacer por nuestro país. Todos los años, durante el período de celebraciones de septiembre, el gobierno otorga premios a los ciudadanos que lo merecen. Debería haber una ceremonia de premiación para los ciudadanos a quienes se les quitaron tierras para un propósito público y mostraron una conciencia por el gobierno y el pueblo de Belize.

La reciente exposición de las empresas que están acusadas de adeudar impuestos sobre bienes y servicios les ha dado una mala imagen, pero esas personas de negocios tendrán su día en la corte para disputar los cargos o explicar cómo se atrasaron. Aquellos que deben tales impuestos palidecen al lado de aquellos que efectivamente están "desplumando" al gobierno y a la gente por la requerida readquisición de tierras por la mala planificación o el error del gobierno.

# From the Publisher From XE Day X Experiments of the Publisher Publ

Most of us adult Belizeans have spent varying amounts of time trying to figure out the contradictory psyche of Lord Michael Ashcroft. His business activities in Belize have enriched him massively and made us Belizeans very seriously indebted to him in several instances. But he has said, on more than one occasion, that he loves Belize.

Well, it is possible to love Belize, the country, and not have any real affection for the people, us human beings who call ourselves Belizeans. Lord Ashcroft does not love us Belizeans: he loves his own bank accounts.

Now the development philosophy of laissez-faire capitalism exalts the man who can rise to the top of the heap financially. In laissez-faire capitalism, anything goes, and by any means necessary. So insofar as Belize's development philosophy is concerned, Lord Ashcroft is the ultimate superstar. He demands our respect because of his business accomplishments, which have enriched him and impoverished Belize.

Personally, I don't dislike Lord Michael. But, I am certainly not his friend. I spend much time trying to understand him, because there is no way we Belizeans can survive this English predator without understanding what is driving him, apart from just pure money.

So then, the thing that jumps out at us is the fact that he lived in British Honduras as a child for three years - from late 1953 to late 1956. His father had been a British soldier, and

was posted here as a public officer in the colonial administration.

The most important and sensational episode in the young Michael Ashcroft's three years in the colony was the national election of April 1954, when the intensely anticolonial People's United Party (PUP) defeated the pro-British National Party (NP) by a huge margin. There were nine electoral constituencies here at the time, and the NP won only one — in Toledo, where the patriarchal Sam Vernon's personal power propelled the NP candidate, Charles Westby, to victory in "The Forgotten District."

(There were four independent candidates in that election — Fred Westby in Belize West; John Smith in Belize North; Fred Hunter in Belize Rural; and William Gegg in Corozal.)

The eight victorious PUP candidates were described as "PUP-GWU" candidates in Myrtle Palacio's very valuable work, WHO AND WHAT IN BELIZEAN ELECTIONS 1954 to 1993. The PUP and the GWU (General Workers Union), in other words, were in a coalition in 1954. Their 1954 election victory was epic, and it was a victory for the roots people of Belize, the majority of whom were black in 1954, and it was a defeat for the imperial British, and for the Belize Estate and Produce Company (BEC), which had dominated the local economy from the nineteenth century.

The 1954 election was a very tense and emotional one in the capital city,

where a third of the colony's population lived at the time. Two of the PUP leaders and candidates, Leigh Richardson and Philip Goldson, had been jailed for sedition by the British and had served nine months in Her Majesty's Prison in 1951. So the 1954 election was great vindication for Leigh and Philip.

I was a child who turned seven on April 30 that year. It has always seemed to me that the most emotional contest in 1954 involved the fact that the very first PUP leader (the party was founded in 1950), Johnny Smith, had resigned from the PUP after Richardson and Goldson were jailed. The National Party did not offer a candidate in George Price's Belize North division. Johnny Smith ran against him as an Independent candidate, clearly supported by the NP, and bitterly reviled as a "coward" and "traitor" by the PUP-GWU members and supporters whom he had deserted. (Incidentally, Mr. Price beat Smith very badly, 3 to 1. and Smith soon went into exile in the United States. In 1954, Belizeans were extremely passionate about their post-devaluation politics.)

A little English boy like Michael Ashcroft, who was attending St. Catherine Academy primary school section for privileged children, was an absolute nobody in Belize in 1954. I repeat, he was nobody, nothing. Belizeans were excited about the PUP, and about Ludwig Lightburn, who was fighting his way to fame in Mexico and the United States. Well, needless to say, nobody in 1954 has become somebody today.

In 1955, Bob Turton, Belize's most powerful native businessman, who had first pushed his personal secretary, George Price, into Belize's politics in 1944, died. Turton had been the most serious enemy of BEC and the British, so that when he died in 1955, it was the year immediately after his greatest victory over his hated rivals -- BEC and the British. (Turton had major business connections in the United States, including the Wrigley chewing gum company in Chicago.)

On my father's side, I am descended from a Scotsman by the name of James Hyde way back in the late eighteenth century. Very few of us understand the complexities of what we know as the "United Kingdom" or as "Great Britain." As I understand it, the monarchy today consists of four different peoples — English, Scottish, Welsh, and Irish. (Ireland is an independent country, but Northern Ireland is a part of Great Britain.)

Lord Ashcroft is an Englishman, and the English people are the dominant force in the United Kingdom. It is a bit confusing to me, but there was a sensational episode in the history of the Scots and the English which you will find interesting. I ask your indulgence for this bit of historical aside.

In the sixteenth century, Scotland and England had two separate queens --Mary Queen of Scots had become Queen of Scotland in 1542, while her cousin, Elizabeth I, became Queen of England in 1558. The problem at that time of violent hatred between Protestant (Anglican) England and Roman Catholic Spain was that Mary Queen of Scots was a Roman Catholic. English Catholics, who were being persecuted, considered Mary the legitimate Queen of England. Protestant English were terrified that Protestant Elizabeth, the daughter of Henry VIII, might be assassinated by Spanish agents and that Mary Queen of Scots would become Queen of England, as well as Scotland. (Mary was Elizabeth's cousin and heir to the English throne through her Tudor grandmother, Margaret, Henry VIII's older sister. Elizabeth was the granddaughter of Henry VII, and Mary was his great-granddaughter.)

It happened that Mary became involved in a major sex scandal, which ended up with her legal husband being killed. She had to run south to Elizabeth for protection. ## Installation of the friendship group Mexico-Russian Federation—Final Part

Permit me, our dear readers of this column, to present to you the following, entitled "En VIVO/Instalación del Grupo de Amistad México - Federación de Rusia" (Installation of the friendship group Mexico-Russian Federation), which was published on Youtube on March 23, 2022. I find what the Ambassador of Russia to Mexico, His Excellency, Victor Coronel, said in the Honorable Chamber of Deputies in Mexico City to be of utmost importance. The final part is as follows:

The owner of the American company, Meta, of Facebook and Instagram, changed its rules and "temporarily" allowed hate messages against members of the Russian army, as well as blocked Russian media

accounts such as RT en Español, etc. In an act of censorship on YouTube, he also suspended the RT channel in Spanish. Russian culture and sports also turned out to be victims of this smear campaign. All over the world, concerts by our artists, the participation of our teams in sporting events, and even seminars dedicated to Russian literature are being cancelled. How can it be that recently, three weeks ago, the Russian team came to the Paralympics in China, in Beijing? The less valid athletes with physical defects who were preparing for these Paralympic games for four years, and when they arrived in China, the International Olympic Committee banned them from participating in the games.

And finally, two more things, there is a lot of speculation about the accession to Russia of the Crimean peninsula. Taking advantage of it, I mean, I never say annexation; it was accession, because many forget that this accession was the result of a popular vote by the population of the peninsula. Back then, in the year 2014, well I understand that they know something about history, they know a lot, and they know perfectly well that the Crimean peninsula was always an integral part of Russia since the time of Catherine the Great. In 2014, a popular referendum took place in Crimea. Almost 90% of the population of the Peninsula participated in that referendum. Of the participants, 98%

voted, more than 90 percent voted to join Russia. This was the result of the expression of the popular will. And selfdetermination of peoples, as you know, is one of the basic principles of the United Nations organization. I'm going to give it to you, well, there are many double standards. You know perfectly well that Argentina has been claiming its rights over the Malvinas Islands or, well, the Falkland Islands, for a long time. If I am not mistaken, 7 or 8 years ago, Great Britain installed a referendum in the Falkland Islands where 3,000 people live. The population voted to remain integrated, to remain part of Great Britain. There they respected that demonstration of the popular will. Because they don't want to respect it with respect to Crimea, I ask.

And finally, we highly value the position, the position of the government of the United Mexican States in the face of the Ukrainian crisis. After the start of the special Russian military operation, we are in constant permanent contact with our colleagues from the Mexican Foreign Ministry, with colleagues from the secretariat of foreign delegations. And I want to assure you, we highly respect the position of demonstrating several times by the President of Mexico, Andrés Manuel López Obrador, by the Secretary of Foreign Affairs—Marcelo Ebrard, that Mexico will never unite with anti-Russian sanctions, and that it will never, despite requests from the Ukrainian government, ever supply Ukraine with weapons. I want to assure you that I have no doubt that what is happening these days will in no way affect Russia's relations with Mexico, which continues to be one of our oldest and most important partners in the Latin American region. As an example, in the year 2021 alone, despite COVID, despite all the restrictions, our trade between our countries increased almost more than 2 times compared to the year 2020, reaching the record figure of 48 billion dollars.

I understand that everyone has their agendas. There is a certain time limit and to finish, once again, I want to thank Deputy Alberto Anaya Gutiérrez, and all the members of this friendship group. We respect him very much, we value him very much, his gesture in these difficult times, and I have no doubt that this friendship group will greatly support the relationship between our countries, the further development of our contacts, between our populations, between our parliamentarians, between our states and our governments. 

The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). Through this project, the Belize Tax Service Department(BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS)) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

BTSD staff integrity is a concern for its management. The BTSD strategic plan indicates that: "Corruption has devastating effects on the integrity of any organization. At the BTS the effects would be particularly harmful as corrupt activities could compromise the collection of revenue; impede tax compliance; negatively impact the image of the Agency and reduce the public's confidence in the Agency's ability to objectively administer taxes.

As such, an Internal Audit Division will be executed to conduct investigations into alleged employee misconduct and ensure that commensurable disciplinary actions are taken when staffers are found culpable. Additionally, a new Employee Code of Conduct will be drafted, which will be instructive on the standards of Professional Conduct. Given that partnerships with the public are important in combating corruption, Outreach Programs will be utilized to engage civil society and to aid in deterring and reporting immoral activities."

La mayoría de nosotros, los beliceños adultos, hemos pasado distintas cantidades de tiempo tratando de descifrar la psique contradictoria de Lord Michael Ashcroft. Sus actividades comerciales en Belize lo han enriquecido enormemente y nos ha dejado a nosotros los beliceños seriamente endeudados con él en varios casos. Pero ha dicho, en más de una ocasión, que ama a Belize.

Bueno, es posible amar a Belize, el país, y no tener ningún afecto real por la gente, nosotros los seres humanos que nos llamamos beliceños. Lord Ashcroft no nos ama a los beliceños: ama sus propias cuentas bancarias.

Ahora, la filosofía del desarrollo del capitalismo de laissez-faire exalta al hombre que puede llegar a la cima financieramente. En el capitalismo de laissez-faire, todo vale, y por todos los medios necesarios. Así que en la medida en que al desarrollo de Belize se refiere, Lord Ashcroft es la superestrella definitiva. Exige nuestro respeto por sus logros empresariales, que lo han enriquecido a él y han empobrecido a Belize.

Personalmente, no me disgusta Lord Michael. Pero, ciertamente no soy su amigo. Paso mucho tiempo tratando de entenderlo, porque no hay forma de que nosotros, los beliceños, podamos

sobrevivir a este depredador inglés sin entender qué es lo que lo impulsa, aparte de puro dinero.

Entonces, lo que nos llama la atención es el hecho de que él vivió en Honduras Británica cuando era niño durante tres años, desde finales de 1953 hasta finales de 1956. Su padre había sido soldado británico y fue asignado aquí como funcionario público en la administración colonial.

El episodio más importante y sensacional en los tres años del joven Michael Ashcroft en la colonia fueron las elecciones nacionales de abril de 1954, cuando el Partido Unido del Pueblo (PUP), intensamente anticolonial, derrotó al Partido Nacional (NP por sus siglas en inglés) pro-británico por un amplio margen. Había nueve distritos electorales aquí en ese momento, y el NP ganó solo uno: en Toledo, donde el poder personal del patriarcal Sam Vernon impulsó al candidato del NP, Charles Westby a la victoria en el "Distrito olvidado."

(Hubo cuatro candidatos independientes en esa elección: Fred Westby en el Oeste de Belize; John Smith en el Norte de Belize; Fred Hunter en el Área Rural del Distrito de Belize; y William Gegg en Corozal).

Los ocho candidatos victoriosos del PUP fueron descritos como candidatos

"PUP-GWU" en el valiosísimo trabajo de Myrtle Palacio, WHO AND WHAT IN BELIZEAN ELECTIONS 1954 to 1993 [QUIÉN Y QUÉ EN LAS ELECCIONES BELICENAS 1954 a 1993]. El PUP y el GWU (Sindicato General de Trabajadores), en otras palabras, estaban en una coalición en 1954. Su victoria electoral de 1954 fue épica, y fue una victoria para la gente de de la base de Belize, la mayoría de los cuales eran negros en 1954, y fue una derrota para los británicos imperiales y para Belize Estate and Produce Company (BEC), que había dominado la economía local desde el siglo XIX.

La elección de 1954 fue muy tensa y emotiva en la ciudad capital, donde vivía entonces un tercio de la población de la colonia. Dos de los líderes y candidatos del PUP, Leigh Richardson y Philip Goldson, habían sido encarcelados por sedición por los británicos y habían pasado nueve meses en la prisión de Su Majestad en 1951. Así que la elección de 1954 fue una gran reivindicación para Leigh y Philip.


Yo era un niño que había cumplido siete años el 30 de abril de ese año. Siempre me ha parecido que la contienda más emotiva en 1954 involucró el hecho de que el primer líder del PUP (el partido fue fundado


en 1950), Johnny Smith, renunció al PUP después de que Richardson y Goldson fueron encarcelados. El Partido Nacional no ofreció un candidato en la división del Norte de Belize de George Price. Johnny Smith se postuló contra él como candidato independiente, claramente apoyado por el NP, y fue vilipendiado amargamente como un "cobarde" y "traidor" por los miembros y simpatizantes del PUP-GWU a quienes había abandonado. (Por cierto, el Sr. Price venció a Smith abrumadoramente 3 a 1, y Smith pronto se exilió en los Estados Unidos. En 1954, los beliceños eran extremadamente apasionados por su política posterior a la devaluación).

Un niño inglés como Michael Ashcroft, que asistía a la sección de la escuela primaria de la Academia de Santa Catalina para niños privilegiados, era un absoluto don nadie en Belize en 1954. Repito, era nadie, Los beliceños estaban nada. entusiasmados con el PUP y con Ludwig Lightburn, quien luchaba por alcanzar la fama en México y los Estados Unidos. Bueno, no hace falta decir que nadie en 1954 se ha convertido en alguien hoy.

En 1955, murió Bob Turton, el

### **Cruel Britannia**

At the height of the British Empire, just after the First World War, an island smaller than Kansas controlled roughly a quarter of the world's population and landmass. To the architects of this colossus, the largest empire in history, each conquest was a moral achievement. Imperial tutelage, often imparted through the barrel of an Enfield, was delivering benighted peoples from the errors of their ways — child marriage, widow immolation, headhunting. Among the edifiers was a Devonshire-born rector's son named Henry Hugh Tudor. Hughie, as he was known to Winston Churchill and his other chums, pops up so reliably in colonial outposts with outsized body counts that his story can seem a "Where's Waldo?" of empire.

He's Churchill's garrison-mate in Bangalore in 1895 -- a time of "messes and barbarism," the future Prime Minister complained in a note to his mum. As the century turns, Tudor is battling Boers on the veldt; then it's back to India, and on to occupied Egypt. Following a decorated stint as a smokescreen artist in the trenches of the First World War, he's in command of a gendarmerie, nicknamed Tudor's Toughs, that opens fire on a Dublin stadium in 1920 -- an assault during a search for I.R.A. assassins which leaves dozens of civilians dead or wounded. Prime Minister David Lloyd George delights in rumors that Tudor's Toughs were killing two Sinn Feiners for every murdered loyalist. Later, even the military's chief of staff marvelled at how nonchalantly the men spoke of those killings, tallying them up as though they were runs in a cricket match; Tudor and his "scallywags" were out of control. It didn't matter: Churchill, soon to be Secretary of State for the Colonies, had Tudor's back.

## I feel shame": Pope apologizes to Indigenous people of Canada

VATICAN CITY - Pope Francis apologized on Friday for the Roman Catholic Church's involvement in a system of Canadian boarding schools that abused Indigenous children for 100 years, and said he would travel to Canada as part of a process of healing and reconciliation.

His apology comes after Canada was jolted last year by the discovery of evidence that more than 1,000 people, most of them children, were buried in unmarked graves on the grounds of some of the former schools.

"I feel shame -- sorrow and shame -- for the role" that Catholics played "in the abuses you suffered and in the lack of respect shown for your identity, your culture and even your spiritual values," Francis said.

Francis spoke during an audience at the Apostolic Palace with dozens of delegates from Canada's three largest Indigenous groups, who had traveled to the Vatican in the hope that he would apologize to survivors in Canada. This was the first apology to the Indigenous people of Canada from a pope and was a reversal of Francis's earlier position.

"I ask for God's forgiveness and I want to say to you with all my heart: I am very sorry," Francis said, adding that he joined with Canadian bishops "in asking your pardon."

From the 1880s to the 1990s, the Canadian government ran a system of compulsory boarding schools that a National Truth and Reconciliation Commission called a form of "cultural genocide." The Catholic Church operated about 70 percent of the schools in the system.

- 6. We believe that there is an alarming discrepancy between the education offered on the Northside and the education available on the Southside of Belize, where the majority of African Belizeans live. The Southside education systems are outdated, irrelevant, unattractive, colonial, and racist.
- 7. The single greatest concern of the UBAD Educational Foundation (UEF) is the upgrading of the educational opportunities available to young African Belizeans, who have been the principal participants in the gang wars which have broken out in our urban areas.
- 8. The UBAD Educational Foundation will seek the accumulation of funds and resources to pursue its educational

programs, but the UEF is non-profit in nature.

- 9. We believe the discrepancy in the educational opportunities being offered to our children and young people cannot be addressed by the political parties, because that is not the job of political parties. There is the need for a private, community-based institution to upgrade the educational systems available for African Belizeans, hence the UBAD Educational Foundation, formed on Sunday, March 10, 1996.
- 10. The primary concern of the Foundation is the education of African Belizeans, but the UBAD Educational Foundation is not racist or discriminatory in nature. All Belizean young people may participate in systems and programs created by the UBAD Educational Foundation.

En el siglo XVI, Escocia e Inglaterra tenían dos reinas diferentes: María, Reina de Escocia, se había convertido en Reina de Escocia en 1542, mientras que su prima, Isabel I, se convirtió en Reina de Inglaterra en 1558. ### DROP THE VICTIM CARD, NOBODY CARES

Belize is truly fortunate that some of the racial hostility that exists between ethnic groups in other countries does not exist here, despite our ethnic diversity. However, we would be naive to pretend that no tension or prejudice exists between groups, but despite this, we should all do our part to keep Belize free of racial hostility.

While race as a basis for prejudice and discrimination is not prevalent in Belize, classism and the varied assumptions that go along with it is here. A friend told me recently that he witnessed an interesting incident where a Mestizo mother was telling her son to stop acting like "den Southside boy"; obviously her son's mannerism and demeanor reminded her of a behavior that she didn't approve of and one she associated with certain youths from a certain section of Belize City. While this is not directly racism, it's easy to see how it can get that interpretation if we don't understand the context in which that mother spoke. This can even be more disconcerting, especially when we hear of government's intention to "normalize" as much as 60,000 migrants, mostly from Guatemala, Honduras and El Salvador, already living in the country illegally.

It's becoming acceptable to see many young black males, and to a certain extent older black men, depend too much on the 'victim card' when trying to get a job, a loan, a scholarship, or just sympathy for their situation; in other words, "help me because I am a victim". My point here is we have to

get off this welfare card because many people who come from more disadvantaged backgrounds take life as they find it and do what they have to do, legally, to survive; in other words, they refuse to play the 'victim card'.

The use of the 'victim card' is nothing exclusive to young black males in Belize; in fact, it has become an established strategy for correcting perceived injustices within a system. A perfect example of this is the 'Affirmative Action' (AA) approach used in the US to correct years of unequal treatment of African Americans in that country. The rationale for AA was that African Americans should be given special consideration over whites in jobs, education, housing, etc., in order to correct the years that African Americans had been deprived of equal

justice in every aspect of civil rights in that country. So the Civil Rights Act of 1964 was a federal attempt to correct this systemic discrimination. As a result of the AA policy many African Americans have received a jumpstart, a kind of 'skip to the front of the line' support, to correct the built-in historical injustice.

Women in the US have also used the 'victim card' to highlight the fact that some kind of AA should also exist to address the injustices built into the system that deprives women of equal rights. So the Women's Movement used the same Civil Rights Act to advance their agenda even more effectively than the African Americans for which the Act was originally enacted for. There are many other examples of where the 'victim card' was an appropriate strategy to correct systemic injustices.

The problem with using the 'victim card' comes when the victim perceives that he/she has a right over others by virtue of the fact that they have gone through what others have not. Clearly the statistics are revealing that many of our black male youths are falling through the cracks and need special interventions to address their peculiar socio-economic, psychospiritual traumas, but resorting to the 'victim card' as the basis for our intervention is not the correct approach.

There are many beggars in the city today. Some are clearly victims and need a helping hand to pull them through their temporary hard times till things get better. Some, however, have decided to turn begging into a daily profession while others have turned their misfortune into an opportunity to work their way out of their dilemma. Who do you think will get the most support—the perpetual victim, or one who is asking for help to help themselves?

It is almost becoming an accepted fact now that black men in Belize City are lazy and want everything for free. Despite its derogatory nature, this is a growing opinion, even among many black Belizeans who cite all kinds of examples to verify their viewpoint. They say, look how the Chinese, Indians and Arabs own all the stores that black Belizeans once owned on Albert Street. Look how the new Belizeans, from Central America, have established themselves over the last twenty-five years. They say, unlike these new Belizeans, if you offer a black man in the city a job he is more concerned about how much you will pay him, and if the price is not right, he would prefer to be without a job than to work for what he considers below his value.

This may sound like generalization, but you make your own anecdotal observations of these matters and see what we are dealing with. We have developed a culture of dependency is Belize City where to be a perpetual 'victim' is becoming commonplace for many young men.

We all know that working hard and

working smart is the key for survival, especially in this depressed pandemicinfected economy that we face in Belize today, but how many people are waiting for the "right" job before they will accept any job? How many are satisfied to stand on the sidelines and complain instead of getting out there and finding a job and, failing that, making a job? And yes, in regard to those who use their entrepreneurial skills to do illegal trade rather than sitting around and begging, Respect, for their effort to use their survival skills, especially when they have hungry mouths at home to feed; but we must equally warn them that that is a dead-end street with glitter in the front but death or jail at the back-end. Just look at those who went before you, bro. Crime, really don't pay in the long

The fact is there are many legal ways to generate an income, albeit small, but such jobs have no glitter attached to them; they may be dirty and backbreaking and pay below the minimum wage, but they can sustain you till you find something better. They say that 'necessity is the mother of invention' and that there are lights at the end of every dark tunnel, but if you don't live in a culture that encourages you to work with what you got and to not become dependent on someone to do for you what you can do for yourself, you will miss many opportunities to improve your situation.

Constantly crying about the halfempty glass and failing to acknowledge what assets you have to work with eventually kills creativity and renders you forever dependent. We've all heard the story of the man who prayed vehemently to God to bless him with shoes because he had none...he became vexed in spirit because his prayers went unanswered until one day he met a man who had no feet but was yet cheerful and productive; clearly he met a man who had learned to work with what he had.

It is the responsibility of government to stimulate an enabling environment where jobs are created both in the public as well as the private sector. A good government would have targeted the employment of its citizens as a top priority. But be that as it may, the individual citizen has no excuse to rely on the 'victim card' permanently; if jobs are not readily available, then one has to find his own way to avoid dependency. So, in response to the mother mentioned in the early part of this essay, being a 'southside boy' should be no more derogatory than being a 'northside boy'; to paraphrase Dr. Martin Luther King: judge a boy not from what side of town he comes from but from the content of his character. ### BBA prez says bus fare increase necessary

BELIZE CITY, Mon. Apr. 11, 2022

Last week the Government of Belize announced that an increase in public transport fares would come into effect on April 15<sup>th</sup> and that, to reduce the size of the increase in those fares, it had approved fuel subsidies for bus operators that amount, in total, to approximately \$1 million.

According to the Government's press release, the subsidies, which will be initially given to bus operators for a period of six months, have allowed the increase in bus fares to be capped at \$1.00, rather than the \$3.00 increase for one-way trips that had been proposed by bus operators.

"The Government of Belize will be providing a monthly fuel subsidy to bus operators traveling in excess of 13 miles (one-way) for the number of gallons used. The fuel subsidy was approved for a six-month period with a cap on diesel at \$12.50 which will represent over \$1 million in savings to commuters," it stated. The decision was made during last Monday's Cabinet meeting following months of negotiations between the Belize Bus Association (BBA) and the Department of Transport, including Minister of Youth, Sport, and Transport, Hon. Rodwell Ferguson, and the CEO in that ministry, Marconi Leal.

Thomas Shaw, president of the Belize Bus Association, when speaking to local reporters about the government's recent decision, said that he applauds them for making such a bold move, especially in light of Government's previous reluctance to lower the cost of fuel, since fuel taxes



are one of its main sources of revenue.

"This is something that we've been clamoring for for years, but whenever we approach and we say we're looking for subsidies, especially when it comes to fuel, they told us, from the other administration, they told us point blank that government isn't really gonna touch that dial, because that's where the government actually makes most of its money from, you know," said Shaw.

He also noted that while an increase in bus fares is long overdue and is needed to keep bus operators afloat, he is fully aware of the impact that the COVID-19 pandemic has had on Belizeans as well as the added strain that a large price hike would have on commuters.

"When we came in and we met for the first time, we had made a proposal whereas the Minister, the CEO, everybody was on board and we told them actually what the operators would be looking for or what the association would be looking for for its operators in order for them to actually stay afloat. But, you know, whenever we have consultations like that, it still has to go to Cabinet. But when it went to Cabinet, the Government, they were mindful that it would have been a bit burdensome to pass on all that hike in bus fares to the commuters. So when they took it to Cabinet, the decision was made that well, yes, they're going to give us half of what we had asked for in bus fares and the government would be taking the other half, so the commuters would be paying some and the Government would be taking a loss for the next six months," he explained.

According to Shaw, it remains to be seen what will transpire after GoB's six-month term for the distribution of subsidies comes to an end. But he says that he hopes to get some form of written agreement from the Government sometime soon; otherwise, in six months' time, the association would be back at square one.

"If the fuel drops, then there will be no subsidy. Then we have to go back to the table and then we go back to square one—initially what we had asked for," he said.

When asked whether he sees an increase in bus fares as necessary, Shaw responded without hesitation:

Yesterday, April 10, turned out to be a day of double tragedies in Belizean cycling that will not soon be forgotten. With the 31st Women Cross Country due to take off from Columbus Park in San Ignacio, two male cycling stalwarts were on their way towards the twin towns to provide live video coverage of the race from their motorcycle. Sadly, neither the motorcycle driver, Kadeem Banks, nor his video-camera holding passenger, Edison "Vintage" Usher, would reach their destination. as reports were that the motorcycle experienced major difficulties and ran off the road in the vicinity of Cotton Tree Village, where the driver died on the spot, while his passenger passed away a few minutes after being transported to the Western Regional Hospital. The news of the

incident quickly engulfed the cycling community who were eagerly anticipating the live-streaming of the race, the way the same duo had voluntarily rendered a week earlier for the Junior Cross Country. A grief stricken cycling veteran, Andrew Ordonez, who had also previously done live-streaming of the races on the same motorcycle, said the news of his friends' tragic demise left him in a state of shock and at a loss for words; but he vowed to continue their legacy and their exemplary love for the sport by making a personal effort to do the live-streaming by motorcycle of the upcoming Holy Saturday Cross Country Classic in their memory.

of the devastating tragedy, out in San Ignacio at Columbus Park the Women Cross Country Classic nevertheless got under way with 11 female cyclists, eight (8) of whom would manage to complete the 73-mile journey to BTL Park in Belize City. And, while the chronicling of the station prize winners along the course of the race would normally give an idea of the ups and downs of the riders, where the breaks occurred and which cyclists were appearing stronger as the race wore on, this one was pretty straight forward, and decisively so. There were only two foreigners in this race, Americans Katy Sorrell and Morgan Stern, both of USA Team Cardinal, and they simply blew away the rest of the field. Indeed, all but 4 of the 47 station prizes along the route were taken by these two, who first seized control of the race at the Santa Elena roundabout, briefly relinquished leadership to 6-time champion Alicia Thompson at Galen University in Central Farm, and then re-asserted themselves to sweep all the remaining station prizes on their way to Belize City, crossing the finish line at BTL Park with arms clasped for 1st and 2nd place. Meanwhile, the nearest group of four Belizean cyclists had not yet even approached Belize City limits at Burdon Canal bridge.

In the station prize tally, Kedisha Francis (unattached) took the first at Hawksworth Bridge. Gabriel Lovell (Lovell/Digi) took the next two at Public Works Santa Elena and Eden High School. The 4th station prize at Santa Elena Roundabout was grabbed by Morgan Stern (Cardinal), with teammate Kay Sorrell (Cardinal) stepping up to take the next two station prizes at Cayo Cargo and Running W Meats. Then our own Alicia Thompson asserted herself to grab the 7th station prize at Galen University; and Belizean fans would have thought we had a "horse" in this race to the finish. But a rude awakening it was, for the American duo proceeded to destroy the field, totally dominating the rest of the race, with the remaining station prizes all

being shared between Katy and Morgan, who eventually opened almost a half hour gap between themselves and the rest of the peloton.

For Belize cycling fans it was another tragedy, not being able to at least see a Belizean in contention near the finish

of the race, as they would have anticipated, had defending champion Kaya Cattouse been involved along with arch-rival Alicia Thompson, in which case they both, currently the two most dominant Belizean female cyclists, would likely have teamed up to face the foreign challenge. Of course, when we contacted Kaya, who is

presently at a team training camp in California, her remark was, "I would have been able to take them both on myself." As it turned out, local cycling fans had to settle for a group of four Belizean women battling for third place at the finish.

In the end, it was Americans Kay Sorrell 1st and Morgan Stern 2nd, both of Team Cardinal, crossing the finish line together in 3:23:17. (The record by Mexican Brenda Aguayo in 2003 is 3:07:29.) Taking 3rd place was Alicia Thompson (Bze. Bank Swoosh, 3:53:09); 4th Gabrielle Gabourel (C-Ray Cycling, 3:53:09); 5th Paulita Chavarria (Chavarria Cycling, 3:53:09); 6th Patricia Chavarria (Chavarria Cycling, 3:53:09); 7th Kedisha Francis (unattached, 4:01:47); and 8th Fiona Humes Castillo (BFSC, 4:02:20).

A special trophy for the youngest rider to complete the race was also awarded to Junior rider Gabrielle Gabourel.



### Churches have collected "13,000 plus" signatures

and call for a referendum on the legalization of marijuana led by the National Evangelical Association of Belize (NEAB), the Belize Association of Evangelical Churches (BAEC), and the Belize Council of Churches, has gained traction,

garnering the public support of the Belize Association of Principals of Secondary Schools (BAPSS), the United Democratic Party (UDP), and even the National Trade Union Congress of Belize (NTUCB). Most recently, a press release from the Churches Referendum Team sent via the NEAB claims that over 13,000 signatures have been placed on a petition to call for a referendum in just six days—approximately 70% of the number needed to trigger a national referendum.

One prominent figure that has shown support for the movement via the petition is former Prime Minister, Rt. Hon. Dean Barrow. The former UDP leader said that the petition came to him by way of his daughter's school, St. Catherine Academy, following a parent-teacher meeting at which Principal Salome Tillett gave

a presentation on the matter and subsequently circulated the petition to the parents.

Barrow also indicated that, apart from wanting to support SCA's principal in realizing her goal of gaining a certain number of signatures for the petition, he was already inclined to sign due to the banking implications for the country:

"It is clear to me that unless marijuana were to be legalized at the federal level in the United States of America, no correspondent bank offering their services to the commercial banks in Belize will be able to continue with those services if the commercial banks in Belize had anything to do with monies that are proceeds from the marijuana trade. I think in view of that, we absolutely should not pass or sign the bill into law at this stage," he said.

He then went on to make his view clear, stating that not only would this make larger corporations "unbankable," but it would also affect average Belizeans who consume marijuana recreationally.

"Remember now that, under the UDP, there was decriminalization, which allowed the small man to possess ten grams and smoke his ten grams. Now, under this bill the small man has to buy a license and enter into a register. In fact, all the licensees will be placed on a register, which the register will be publicly available. The small man, having placed himself on that register by way of the purchase of a license will, in my view, then also become 'unbankable'. So, if he or she had an account at any of the commercial banks, the moment that they go on that register, in my view, the banks will cancel their accounts," he said.

Minister of New Growth Industries, Hon. Kareem Musa, has previously stated that while the bill is still in its third round of changes, it has essentially already been passed, given that the majority of the members of both the current administration and the Opposition have approved it. During his interview, though, Hon. Dean Barrow also stated that it is not too late for the bill to be stopped, because while the referendum wouldn't be binding, it would give the citizens who oppose the bill a chance to leverage the support they have received to convince the Government to repeal the law, adjust it and reintroduce it with what they believe to be more appropriate stipulations.

Also apparently in support of the churches' push for a referendum is Lord Michael Ashcroft. The British politician and multibillionaire (who happens to own the majority of Belize's banking sector) recently tweeted that he is in agreement with Belize's former prime minister and claimed that he too will be signing the petition.

The National Evangelical Association of Belize (NEAB) has been vocal about their disapproval of the bill, and has stated that "the growth and distribution of marijuana creates and/or enhances societal and moral ills already plaguing our country". They have also asserted that the Government of Belize had failed to meet with the Council of Churches to discuss the matter transparently.

"Let the voice of the people decide if the legacy we will leave our children and grandchildren will be a Belizean society polluted and crippled by drug culture," wrote the Churches Referendum Team via a press release from the NEAB.





### Delivery men charged for false robbery report

BELIZE CITY, Mon. Apr. 11, 2022

Two employees of a Santa Elena delivery company (Joseph Freight Limited) who reported that they were robbed were arraigned in the Belize City Magistrate Court on Monday, April 1, on a single charge of committing a mischievous act after it was discovered that they had lied to the police.

Delivery man Mark Anthony Umana, 22, and his assistant, Esvin Vernon, 31, reported to the police that while making deliveries on Friday, April 8 on Curl Thompson Street, three armed men approached them and held them at gunpoint, stealing a total of \$2,950 that belonged to the company for which the men worked. When police began investigating the reported crime, however, they quickly discovered that the duo had lied and that no such crime had occurred. They asked the personnel at a store in front of which the robbery occurred whether such an incident had taken place, and were told that no such crime had happened on the store's premises. Surveillance footage obtained from the area in which the purported robbery had taken place confirmed this, and soon after, the two men were arrested and charged.

According to *7News*, the men subsequently took the police to the delivery van they had been using, which had been impounded at the Racoon Street Police Station as evidence, and they retrieved from the back of the van a waist bag, inside of which was \$2,950—the money that they said had been stolen.

Communications Director of the Belize Police Department, ASP Fitzroy Yearwood spoke about the incident at Monday's police press briefing. He noted that on Friday, the police had sent out a release asking those engaged in money collection or deliveries to reach out if they needed police assistance when making deliveries or collecting money in the city. A few hours later, Umana and Vernon would take advantage of that notice by police.

"We're taking these reports very seriously," said ASP Yearwood. "We sent out a general appeal to these cargo truck operators. We know everybody is expecting their little barrel and box from the States, and we saw an increase in it and now these two took that opportunity to try to mislead us, and we have to make them pay for what they're doing."

The men were taken to court, where they immediately pleaded guilty and were fined \$150 each in addition to a \$5 court fee, all of which must be paid by May 3—otherwise, the duo will face six months in jail.

### Tragedy at female Cross Country race

Women's Cross Country Classic race this past Sunday. The early-morning race was set to be streamed live on social media, but an announcement made by the Cycling Federation of Belize a few minutes after 8:00 that morning revealed that the broadcast had to be canceled due to the tragic accident involving Edison Usher, a long-time commentator and broadcaster of the race also known as DJ Vintage, and Kadeem Banks.

Sometime around 7:10 a.m. on Sunday, Banks was driving his motorcycle, with Usher as a passenger, towards San Ignacio for the commencement of the Women's Cross Country Cycling Classic when, according to reports, the motorcycle's gas tank exploded somewhere in the Cotton Tree area.

Both men were thrown off the bike and severely injured, with Banks dying at the scene. Usher was rushed to the Western Regional Hospital for treatment but passed away less than an hour later.

Police Communications Director ASP Fitzroy Yearwood spoke about the tragic accident during a press briefing on Monday, informing local media that currently police are awaiting a report from the Motor Vehicle Inspector in order to determine what exactly had caused the motorcycle to explode.

At the conclusion of the Women's Cross Country Cycling Classic's awards ceremony, the vice president of the Cycling Federation of Belize, Dion Leslie, announced the passing of the two men, and shortly after, a moment of silence was observed in their honor. Leslie spoke briefly with local media about the huge

impact the loss of the two men has had on the Belize cycling family.

"Both Vintage, as he's lovingly known—Edison Usher—and Banks, as we know him as well, Kadeem Banks, are no strangers to the cycling family or anyone that's been around cycling. Vintage is an avid cyclist himself. I think he also is the president of the Weekend Warriors cycling club. Apart from that, he is a formal executive of the Cycling Federation and he's been around on various teams. I think the last position he held was coach at Westrac Cycling Club. And Kadeem, of course, is no stranger, the Banks family, to cycling. It's a tremendous loss, not only to the Federation but all its members, all the brothers and sisters that make up the federation and all the fans on a whole, it's really hard," he said.

According to Leslie, many of the

cyclists, most of whom were friends of the two men, only became aware of their deaths when it was announced at the awards ceremony. The shock and devastation, as he noted, was immediate, and palpable.

"When I got the news this morning, I was in complete shock. I'm still at a loss for words. I don't know what to say about it. What we understand is that there was an accident around Cotton Tree and both gentlemen flew off of the bike on their way to San Ignacio, where they would be bringing live coverage of the 31st Women's Cross Country Classic. They never made it, unfortunately. I know Mr. Banks succumbed to his injuries on site while Vintage was taken to the hospital, where he later succumbed to those injuries at the hospital. So to the cycling family, this is a great loss. Every single one of us, we feel it deeply. If you paid any attention you would see some of the women cyclists actually crying on stage when they heard the news, because we didn't tell them what happened. They weren't told until the race was completed, because they're good friends. We know Vintage's girlfriend or commonlaw, Nicole, was also an avid cyclist and traveled several times with the federation to compete internationally," added Leslie.

Leslie extended condolences to the family and friends of both men on behalf of the Cycling Federation, including its president, Orson Butler, the executive, and the extended cycling family.


"They brought cycling to hundreds of thousands of people across the globe. They did their jobs. But you know, I lost two great friends and a lot more cyclists lost two great friends," Leslie said.

and 8 deaths. The Ministry has noted, however, that 7 of those 8 deaths are previously unreported deaths that have been reclassified by the Epidemiology Unit as being caused by COVID-19, with 1 death dating back to October 2021, 1 occurring in November 2021, and 3 occurring in February 2022.

"We expect to report more deaths in the coming days and weeks as we continue our review," stated the Ministry. In its latest update, the Ministry of Health and Wellness also noted that the most effective way to stop new COVID-19 variants is by limiting the spread of the virus. "Regardless of the variant, the same health measures protect us from getting COVID-19," added the Ministry.

### BBA prez says bus fare increase necessary

"Absolutely," he said. In fact, he believes that an increase in fares has been long overdue.

"What we're getting right now is what we should have gotten twenty years ago. Because when we were asking for that, fuel was just like six or seven dollars a gallon. Where we are right now, fuel is like thirteen dollars a gallon, so basically it's so hard, because it feels so hard to the commuters and the public. Due to the fact that they took so long to address the situation, whenever you want a raise right now, it's like you're going like a hundred, two hundred percent. But in reality, there is a need. There is a need, and the Government sees there is a need," he responded.

The Minister of Transport, Hon. Rodwell Ferguson, told local media that a fuel subsidy was, ultimately, the best choice for easing the burden of increased bus fares for commuters.

"I am trying to be reasonable with the commuters because we understand the crisis the country is in—the crisis the world is in—so if we pass on all the costs of the consumer, the commuter, then they will say nothing is there for me, and so from government level and government standpoint we had to come up with a subsidy. And Government agreed that they're going to subsidize the bus industry for a period of six months. We are going to revisit it after six months to see if the price of fuel goes down, and we want to cap the price of diesel for them at \$12.50 a gallon with the subsidy. And so, while they would not get their [full] increase, they would get a subsidy. I think it comes up to \$1.1 million, and it varies based on the miles that they do, and it's \$185,000 a month subsidy they are going to get from the Government of Belize to make sure that they can provide the services to the commuters

across this country," said Minister Ferguson.

The fuel subsidies being provided by the Government will benefit all qualified bus operators—meaning any operator in possession of a valid road service permit.

The increase in bus fares taking effect this Friday will be as follows: a \$0.25 increase for any trip under 13 miles, a \$0.50 increase for trips between 13 and 24 miles and an increase of \$1 for any trip longer than 25 miles.
