While Cabinet has rejected bakers' request for an increase in the controlled price of bread, bakeries and stores have already rolled out new prices to the general public.

Cabinet announced that there will be no increase in the controlled price of bread at this time. The decision was made after a Cabinet meeting at which proposed price a d j u s t m e n t s submitted by local bakers were tabled by Minister of Agriculture and Food Security, Jose Mai.

# Application to strike out redistricting case fails

The Belize Peace Movement's redistricting case continues after the Elections and Boundaries Commission's application to strike out the case failed.

BELIZE CITY, Thurs. Apr. 28, 2022

Acting Chief Justice Michelle Arana, in a judgment handed down this week, refused to grant the application brought by the Elections and Boundaries Commission to strike out the Belize Peace Movement's redistricting case. The application was based on assertions by the commission that the Belize Peace Movement failed to file certain documents within agreed timelines, which was a breach of the Civil Procedure Rules. CJ Arana, however, after reviewing the submission from the parties, determined that the case was of "fundamental constitutional importance" and that it would be

# Education Ministry to overhaul "absolutely overloaded" curriculum

Come August, Belize's education system is expected to undergo a major overhaul. Minister of Education, Hon. Francis Fonseca says that it's critical that students are learning "what matters."

The Minister of Education, Culture, Science, and Technology, Hon. Francis Fonseca, has stated that the Ministry's plan for curriculum reform in the country's education system will be put into motion this August. That plan will be focused on what he calls "fundamental reform."

"The curriculum is absolutely overloaded. It's absolutely overloaded, and we intend to reduce what they call learning outcomes. We have talked about this already, and make sure that our students are learning what matters—it's critical," stated the Minister.

In a country like Belize, says Fonseca, it is imperative to remember

that education has to be tied to national, and economic, development.

"So we have to be educating our people to be a part of growing Belize, of developing Belize, and equipping them with the skills, the knowledge, the information, the values, the attitudes they need to be effective participants in the development of Belize," he remarked.

Along with its plan for curriculum reform, one of the main challenges facing the Ministry currently is recovering the years of learning that students have lost due to the pandemic.

"Our students have been effectively out of the classroom for two years. Yes, we've tried to do learning packages and we've done some virtual learning, but there's no replacement for the classroom. And so there has been a loss of learning. And so we have specific plans aimed at addressing those gaps that have been created over the last two years," he stated.

When asked whether that recovery will affect the curriculum reform plan in any way, Minister Fonseca said that the two initiatives will be taking place side by side:

"They are two separate things, but the

whole idea behind curriculum reform is to provide, you know, a more, a better quality education to our students. So the two things will run together, parallel. We intend to unveil the new curriculum, again, in August as well. And that new curriculum, I think, will be a much more effective curriculum, a much more focused, much more targeted curriculum. And so that as well will provide us with an opportunity to focus more on recovery. So I see the two things as being parallel, working together," he said.

Hon. Fonseca also noted that the Ministry is feeling confident about the countrywide return to full-time face-to-face learning. He stated that another of their main priorities at the moment is getting those students who have not yet returned to the classroom in some form to do so, as the number varies from district to district. While over 80% of students in the northern part of the country returned to school, other communities have only seen around 60% of their students returning.

"We have a lot of work to do in that regard—making sure that everybody feels safe and that people understand and appreciate the importance and the

urgency of getting their children back into the classroom," he stated.

At present, students have not been having classes on Fridays—a part of the agreement that the Government had made with the unions after negotiating the terms of public officers' 10% salary cut. But according to Hon. Francis Fonseca, that will change come August, since public workers will have their salaries fully reinstated on July 1st. As a result, the new school year will see students returning to a full five-day school week.

# PM visits Cuba


Today, the Prime Minister of Belize, Hon. John Briceño, and officials from the Ministry of Foreign Affairs in Cuba are holding talks as a part of the activities scheduled for the PM's official visit to the island nation. The PM left the country yesterday accompanied by a 5-person delegation consisting of the Minister of Foreign Affairs, Hon. Eamon Courtenay; Minister of Health and Wellness, Hon. Kevin Bernard; Minister of Home Affairs and New Growth Industries, Hon. Kareem Musa; Minister of Tourism and Diaspora Relations, Hon. Anthony Mahler; and C.E.O. in the Ministry of Foreign Affairs and Foreign Trade, Ambassador Amalia Mai. He is scheduled to return on April 30, 2022.

A number of other activities are scheduled to take place during the Prime Minister's visit, but, according to the Ministry of Foreign Affairs, one issue that has emerged as a priority area for the two nations is an upsurge in the number of Cuban migrants irregularly entering the country. Currently, there is a case before the Supreme Court of

Belize that was brought by the Human Rights Commission on behalf of Cuban nationals who were facing deportation from Belize. The Human Rights Commission is claiming that those personsitutional rights

were denied by Belizean authorities following the imposition of fines and a removal order to return those persons back to Cuba, despite the fact that those persons indicated that they did not want to return to their home country.

The allegation against the government of Belize is that they were denied the right to seek asylum. However, many Cuban nationals are utilizing the refugee programs in the country to avoid repatriation to Cuba and instead are being handed over to Help for Progress, through which assistance is provided to them. Sixteen Cuban nationals were apprehended in early April by the Mobile

Interdiction Unit. That case has been adjourned until May 6, 2022.

While the nature of the talks which will be held between the high-level Belizean delegation and officials from Cuba is still not clear, the ever-present problem of migration in the region continues to be a pressing matter, and fears are that more Cuban nationals may be using the country as a transit point to enter Mexico and ultimately the United States of America.

Belize, in an agreement with Cuba, has committed to sending back any Cuban seeking to enter Belizean via irregular means.

This visit to Cuba is taking place just before Cuba's International Workers Day celebrations, which are to be held on May 1, but the Prime Minister is expected to return home before that date. The Cuban Institute of Friendship with the Peoples has said that over 800 foreign delegates will be in the country from April 30 (the last day of the PM's trip) to May 2, to participate in forums designed to explain the impact of the over 60 + years US embargo, or *El bloqueo*, still imposed against the country.

Sources say that groups will participate in a protest march on May 2 and also a debate event in Havana.

# National Women's Commission calls for end to stigma attached to domestic abuse

A press release issued by the National Women's Commission this week strongly condemns the recent spate of gender-based violence that has been seen in the country, noting that at least one of those incidents resulted in the death of a woman, Ms. Tracy Thompson.

Thompson, who had been a long-time

victim of abuse at the hands of her excommon law husband, was brutally murdered in her Calcutta home by her abuser. Shortly after Thompson's death was reported by local media, Vanessa Reyes, who had also been a victim of abuse at the hands of her former partner, Christon Rocha, shared her own story. Over the Easter weekend, Reyes narrowly escaped being killed during a brutal knife attack by Rocha, who

stabbed her in the face and who currently is still wanted by police.

In its press release, the National Women's Commission has called not only for the stigma surrounding gender-based violence to be addressed but also for the implementation of programs that engage and empower women as well as programs that engage and rehabilitate perpetrators of violence against women. The Commission has sworn to increase

awareness on the issue and to embark on educational campaigns that make victims know how to get help, as well as to continue its educational intervention program to challenge discriminatory attitudes and beliefs, and to re-socialize the Gender-based Referral Pathway for GBV frontline responders.

According to the National Women's Commission, one in three women, or 736 million worldwide, experience physical or sexual abuse at the hands of an intimate partner. The Commission has called for Government authorities to exercise a zero-tolerance approach to violence against women.

# Belize's primary caregivers attend mental health workshops

Around fifty of Belize's primary care physicians and nurses will be attending a series of training workshops on the Mental Health Gap Action Programme Intervention Guide (mhGAP-IG) between now and June 2022 in an effort to improve the quality of mental health services available in the country. The workshops, made possible by the Ministry of Health and Wellness in partnership with the Pan American Health Organization/World Health Organization (PAHO/WHO) and with funding from the European Union (EU), are aimed at addressing the stigma and lack of public awareness surrounding mental health issues in the country as well as addressing the current shortage of

psychiatrists and mental health care providers in Belize especially in light of the increased demand for better mental health services.

According to a press release from the Ministry of Health, the program will enable all four health regions (Central, Southern, Northern, and Western) to integrate mental health services into their primary care, thus increasing access to mental health services across the country.

The Mental Health Gap Action Programme, created by the World Health Organization in 2008, was designed to

improve primary care services for mental, neurological, and substance use (MNS) disorders in low and middleincome countries. Particularly, the programme focuses on depression, psychosis, suicidal ideation, behavioural disorders, and disorders due to alcohol and psychoactive substances.

"Successful scaling up [of mental health services] is the joint responsibility of governments, health professionals,



civil society, communities, and families, with support from the international community. The essence of mhGAP is building partnerships for collective action," stated the WHO.

The intervention guide, mhGAP-IG, provides non-specialists—including doctors, nurses, managers, planners, and other health workers—with the necessary tools and information needed to make adequate clinical decisions. In addition to promoting improved listening and communication skills, it will enable them to detect and treat common MNS disorders and to know when to make the proper referrals for specialized services.

"Belize has a population of about 410,000 people but only 16 psychiatric

nurse practitioners, five psychiatrists, and one psychotherapist," stated Dr. Fidel Cuéllar, the Deputy Director of Public Health and Wellness of the Ministry of Health at the launch of the workshops.

What that means, said the Director, is that mental health care is not readily available to the general population of Belize—a gap that the Ministry is attempting to close with this new program. Dr. Cuéllar also pointed out that as many as one in four persons has suffered or will

suffer from a mental health condition such as anxiety or depression.

"The delivery of mental health services in primary care is cost-effective and efficient. Assuring person-centred mental health services that are integrated into primary care services helps achieve our collective goal of achieving universal health access and coverage," noted Dr. Edwin Bolastig, the Health Systems and Services Advisor at PAHO/WHO.

Since the induction of the WHO Mental Health Gap Action Programme, over 100 countries have benefitted from it, with persons being treated for issues like depression, schizophrenia, and suicidal ideation even in places with limited resources.

"ill-suited" for the claim to be struck out due to a procedural error.

CJ Arana's judgment states, "It is a claim of fundamental constitutional importance which calls for the court to fulfill its role as the vigilant and fearless watchdog of the constitutional rights of the citizenry."

She further noted in her judgment that striking out the application "is a draconian measure of last resort.'

While the Elections and Boundaries Commission's attempt to squash the legal proceedings brought by the BPM failed, the judge decided not to adjudicate on matters 4 and 6 of the original Fixed Date Claim form, which are now considered moot in her view. Those sections of the claim contained a request that the electoral divisions be altered or redivided and that elections scheduled for the year 2020 be stayed until the Commission complied with section 90(1) (a) of the Constitution, both of which, Chief Justice Arana pointed out in her judgment, "has been overtaken by events", since the general elections which led to the replacement of the UDP government that was in place at that time with a new PUP administration occurred almost one year five months ago, and the administration has fast-tracked the redistricting process with the funding and establishment of the Redistricting Task Force.

In regards to further proceedings related to the current redistricting case, the attorneys for both parties agreed on the timelines for submission, and a perfected order setting out timelines was handed down by the presiding judge.

The attorney for the Belize Peace



Movement, in his oral submission, articulated that this case in question goes to the heart of democracy in Belize, and highlights vital questions that need to be answered by the court.

"Has there been compliance by the **Election and Boundaries Commission** with the 'one man, one vote' principle as mandated by the Consitution of Belize....? Is there malapportionment of electoral constituencies and is there a proposal laid before Parliament as expressly required by the mandatory language used in section 9 of the Constitution to remedy that malapportionment?" he stated.

The Belize Peace Movement's redistricting case continues with case management, as the salient matter of equal representation remains on the

# PM in breach of office, says PSU

"I want to make a request of the Prime Minister, to kindly start respecting his office and respecting the office of public officers...," said PSU president, Dean Flowers.

office and outright disrespect to the professionals within the public service. Some of the flowers that were brought into the country as a result of the intervention of both Cabinet Ministers, who made calls to public officers within the Customs and Forestry department to facilitate the clearance of the plants at the border and to abort an attempt to inspect and possibly confiscate them, are reportedly listed as endangered and **invasive species** by the Convention on International Trade in Endangered Species (**CITES**), to which Belize became a signatory.

While concerns about the potential impact of the possible presence of such species in the country and the lack of compliance with the CITES treaty

remain front and center, the PSU president has been particularly focused on the brazen admission by the PM that he used his political office to issue a directive to public officers—something that Flowers finds stunning.

"If there is any intervention to be made, where any matter is concerned, that intervention ought to come through the proper authorities, which in my view would be a supervisor or a head of department!" Flowers said.

In regard to the derailment of the processes for inspecting and possibly confiscating certain plant species, the PM admitted to using his office to facilitate the importation of the questionable plants at two separate points in the process. "Again, Minister Mai called me, the Minister responsible—the people at the Customs

Department to ask them to please process that permits, or that order, or else if it stays on the other side, it is going to spoil," Hon. Briceño said in reference to the first call he made.

That call was made to the Customs Department so that the plants could enter the country. After what Flowers described as an overnight operation (at the end of the working day on April 11) to release the plants and hand them to the plant seller, Diani Chan, there was an attempt by Forestry Department personnel to inspect and confiscate some of the plants at Chan's private premises. It was at that point that a second call was made by the PM—a call that he again admits to making.

"I said that I am asking you as Prime Minister to please allow them to come in, and then, we can deal with the facts afterward." This is what the Prime Minister said he told the Forestry officer during that second call after the Forestry officers reportedly sought police assistance to confiscate the flowers.

During this telephone exchange, the Forestry officer reportedly told the Prime Minister that the only person who could call him with a directive was his supervisor, then the officer, according to PM Briceño, hung up the phone. The Prime Minister said the person was very rude, and according to Flowers, they received reports that the PM was forceful in his request to the officer—an undertone he personally classifies as intimidation.

"So, I will be speaking with the Minister. I'm not shying away from that," Prime Minister Briceño said when telling local reporters how he would address the rude response of the Forestry officer. Although he was not explicit about what would be done to address the purported insubordination of the officer, it is anticipated that some disciplinary action might be forthcoming for the public servant, although Flowers fails to see any grounds for such a course of action.

"Essentially that is what this has come down to—a public officer who simply was carrying out the instruction of his superiors. He was carrying out the legal instructions of his superiors to look at what was being imported and to confiscate and destroy what was not authorized or legal to be in the country," Flowers stated.

In regard to the issue of the importation of the plants themselves, and the potential harm that could be caused to our local flora, the Prime Minister had told the Forestry officer that those facts could be addressed later

"I said that I am asking you as Prime Minister to please allow them to come in, and then, we can deal with the facts afterward!" PM Briceño said he told the officer.


Flowers said he was not surprised.

"I'm not surprised that the Prime Minister pretty much threw good governance out the window when he said "deal with it afterward—mek they come in'. Clearly, he was not concerned as to whether or not these species were invasive, whether or not they were harmful, would be harmful to the local flora of the country. He wasn't concerned with that, he was more concerned in doing a political favor and throwing the public officer under the bus," Flowers remarked.

We reached out to Diani Chan, who said she has sought legal advice on the matter and would say nothing more at this time.

Late this evening, a leaked correspondence from the Ministry of Sustainable Development; Climate Change, and Disaster Risk Management confirmed that the public servant in question has been placed on a 5-day administrative leave effective tomorrow April 28, 2022, to May 5, 2022.

The letter signed and sealed by the CEO of the Ministry, Dr. Kenrick Williams, states, "The purpose of this Administrative Leave is as a result of your failure to act in a professional manner in accordance with the Belize Constitution (Public Service) Regulation, 2014, Part 7, Code of Conduct, 4(1)(2)(a) and (b)."





# Together we can and must win this battle against murder

Since we got our independence in 1981 it has been as consistent as the sun rising and setting every day that the main opposition party, after spurts in violent incidents, charges that the government is impotent in dealing with violent crime, and makes calls for the Minister of Home Affairs to resign. Already, at least twice since the PUP took office in November 2020, the main opposition, the UDP, has called out the government for its failing management of violent crime.

UDP chairman, Senator Hon. Michael Peyrefitte, recently stated at a press conference that "the crime situation has gotten completely out of control", and that the government and people must "make some serious changes before the situation becomes irredeemable." In fact, our murder rate last year wasn't more horrific than it was in other years in the last two decades, and the statistics for the first three months of this year puts us on course for a rate lower than our worst years. However, our worst years being some of the worst in the world, we need to see a dramatic reduction in murders before we can be listed among the most peaceful nations, as we were prior to independence.

Since the turn of the century Belize has been averaging well over a hundred murders per year: Between the seven-year period 2015 to 2021 we averaged 129 murders per year, with a low of 102 in 2020, the year Covid-19 visited our country and forced us into a lockdown. A hundred murders in a year means more than a hundred lives lost. It also means a hundred murderers out there, a hundred souls lost, twisted in ways that are hard to comprehend; a hundred families and many friends who mourn, or are consumed by revenge because our country has completely fallen down on

delivering justice; and hundreds of children and other dependents who have lost a major source of financial support.

Belize and three other countries in Central America -Guatemala, El Salvador, and Honduras - are among the most murderous nations in the world. Much blame for the extremely high number of murders in our region is put on the transshipment of drugs, particularly cocaine, but not all of the countries in Central America have become so homicidal. While Belize and the aforementioned countries shockingly average over 30 murders per 100,000 persons per year, Panama and Costa Rica average a far less barbarian 11 murders per year, and Nicaragua, with its socialist government, averages less than

Most social scientists say that poverty is at the root of violent crime in our country. Battered by Covid-19, corruption in government, and failing agroindustries, Belize has never been so poor. The poverty alleviation programs by the previous government were insufficient. The initiatives the present government has introduced should bear some fruit, but they are too limited

to have the impact we desperately need.

There are other major contributors to our disastrous state. Unequal wealth distribution, gangs and turf wars, a miserable justice system, a revenge culture that has been cultivated by the failed justice system, all figure in the loss of love and respect for human life.

The past two decades have been terrible. Many have grown despondent, accepting that violent crime will always be with us. Some turn away from the local newscasts, unable to cope with the endless spilling of the blood of our brothers and sisters. We did not nip violent crime in time and now we reap the bitter harvest for that failure. How could we have arrived at a place where some of us find glory in killing our Belizean brother or sister?

Our country is crushed under the weight of murders, and we don't have forever to right our ship. Our pain is great, and as the UDP Chairman said, our problem is too much for any single government to solve. The UDP Chairman said government, the Opposition, AND people (social partners and community organizations) will have to get involved to halt this scourge in our nation. We came together to fight Covid-19, and a similar effort we must make to significantly reduce murders. It is the most important battle we have to fight. It is a battle we must win, now.

## **CSSPAR** said GOB forgot Labor

Belize's foremost think tank, CSSPAR (Centre For Strategic Studies, Policy Analysis And Research), led by former Ambassador and CEO in the Ministry of Foreign Affairs, Mr. David Gibson, in a paper sent to the Prime Minister charged that the PM and his government are ignoring Labor. In the paper, "Recognizing the Role of Labour as an Equal Partner in Belize's Development", CSSPAR said that if government recognized the value of Labor in the development of this country, it would have been included in the recent Belize Investment Summit, which was held in San Pedro last year. Foreign investors and prominent local business persons were seated at the summit hosted by the GOB, but our labor leaders weren't at the table.

CSSPAR says that the economic model we have been following since independence has yielded steady growth, but not enough, as the more than 50% of our people who are living in poverty attest. CSSPAR says Government and Business falsely assume that subduing Labor will yield a better outcome for our people, when it is the opposite, when it is the unleashing of Labor's potential that will see our country rise out of poverty.

CSSPAR says the last time the minimum wage was increased was in 2012, when the rate was set at \$BZ3.30 per hour, and that in 2003, when the minimum wage was \$3.00 per hour, private interests had advocated for it to be fixed at BZ\$2.00 per hour. Looking at the present initiative to raise the minimum wage to BZ\$5.00 per hour, CSSPAR says that in the period 2005-2008 expert studies had shown that the minimum living wage was between BZ\$4.50 and \$6.58 per hour. CSSPAR says that by today's measure, Belizeans earning less than BZ\$8-\$10 per hour are living in poverty.

We don't need to look back very far to prove what CSSPAR is saying. The disdain for Labor in Belize was at its boldest during the recent impasse between the Port of Belize Ltd. and the stevedores, generational workers at the port. Local private business interests unabashedly sided with foreign business interests to put Labor in its place. In fact, local private business interests continue to side with foreign business interests that have gone to court with their high-priced lawyers in their agenda to show Labor that it has no place at the table.

The GOB, to its credit, did show some support to Labor on this one, but overall, as CSSPAR noted, Labor is an afterthought in the economic development of our country, and if that isn't righted our poverty issues will persist.

# Ruben Campos, Sr. passes at 70

Former UDP Orange Walk South and North area representative, 70-year-old Ruben Campos, Sr., who also was a Cabinet Minister during two past UDP administrations, passed away on Friday, April 22 after a long battle with prostate cancer.

Campos served two terms as a government minister—first as a Minister of Health and Sports, and later as a Minister of State in the Ministry of Education. He held the first ministerial post under the first UDP administration

headed by Manuel Esquivel, from 1984 to 1989, and later held a ministerial post during a subsequent Esquivel administration, which lasted from 1993 to 1998.

After losing his bid to be the area representative for the Orange Walk Central division in the 1998 general elections, Campos remained active in public life and in the party that he loved so dearly.

On Saturday, April 23, Leader of the Opposition, Hon. Moses "Shyne" Barrow, recalled in a social media post the moments the two spent together during the House of Representative sittings.

"Minister Campos would give me a copy of the House orders of the day as we sat in the gallery, me studying the art of the debate and parliamentary procedures and him mentoring me during the breaks to focus on the youth, music, and sports as the key factors for national development and a successful political career," stated Barrow in the post.

The Leader of the Opposition ended his social media post by praising Campos for his dedication to the UDP and the country.

"Your selfless dedication to Party [and] for Country will forever be celebrated as the benchmark for a political life of service," said Barrow.

Notably, Campos is the fourth member of Manuel Esquivel's 1993-1998 UDP administration to pass away this year. Manuel Esquivel died in February, Elito Urbina in March, and earlier this month Melvin Hulse passed away after a battle with colon cancer.

The former Orange Walk area representative was laid to rest on Wednesday, April 27, in Orange Walk Town.

# Three men charged for sexually abusing minors

BELIZE CITY, Thurs. Apr. 28, 2022 This week, three isolated but equally

gut-wrenching incidents of sexual abuse against minors were reported across the country. In connection with those incidents, three men, all over the age of 40, have been arrested and charged, and a police investigation continues into each of the acts of abuse.

One of the persons who has been charged is a 64-year-old man who is accused of inappropriately touching a 7-year-old girl, who is said to be his step-granddaughter. It was also reported that on another occasion, he attempted to have sexual intercourse with the child. After the incidents were reported, the child was medically examined. The results of that examination indicated that she had been carnally known, and her injuries were classified as grievous harm.

The second incident involved a 42-year-old farmer who had reportedly

been living, and having sexual intercourse, with two sisters, one of whom is reportedly a 15-year-old minor. The 15-year-old, who made the report to the police, informed them that they have lived with the man in Orange Walk since October 2021. Again, a medical examination confirmed that the teenager was carnally known.

And finally, on April 12, a 28-year-old woman and her 6-year-old daughter reported to police that on the previous day the child was taken to a bedroom by her 45-year-old uncle, who touched her inappropriately. Her injuries were classified as grievous harm, and it was determined that she was carnally known.

All three men have since been charged with assault of a child by penetration, and rape of a child. The farmer from Orange Walk was additionally charged with 7 counts of unlawful sexual intercourse.

#### INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Shareholders of: Heritage Bank Limited

#### **Qualified Opinion**

We have audited the financial statements of Heritage Bank Limited (the Bank), which comprise the statements of financial position as at December 31, 2021 and 2020, and the statements of profit and other comprehensive income, statements of changes in equity and statements of cash flows for the years then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the effects of the matters described in the *Basis for Qualified Opinion* section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of The Bank as at December 31, 2021 and 2020, and of its financial performance and its cash flows for the years then ended in accordance with International Financial Reporting Standards (IFRSs).

#### **Basis for Qualified Opinion**

At December 31, 2021, the Bank has not adopted IFRS 9 – Financial Instruments as explained in Note 2a to the financial statements. The Bank does not classify its financial instruments nor impair its financial instruments in accordance with IFRS 9.

The Bank currently uses standards that has been superseded by IFRS 9 to classify, measure and present financial instruments.

The Bank currently uses the incurred loss model prescribed by the Central of Belize in the Domestic Banks and Financial Institutions Act, Circular No. 2 of 2020.

In the absence of sufficient and appropriate audit evidence to evaluate the impact compliance with IFRS 9 would have on the financial statements, we are unable to assess whether the current positions would be materially different.

#### **Basis for Opinion**

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Bank in accordance with the International Ethics Standards Board for Accountants' *Code of Ethics for Professional Accountants* (IESBA Code), and we have fulfilled our other ethical responsibilities in accordance with the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

#### Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with IFRSs, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Bank's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Bank or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Bank's financial reporting process.

#### Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users on the basis of these financial statements.

As part of an audit in accordance with ISAs, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the unconsolidated financial statements, whether due to fraud or error; to design and perform audit procedures responsive to those risks; and to obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

# Juntos podemos y debemos ganar esta batalla contra el asesinato

Desde que conseguimos nuestra independencia en 1981, ha sido tan constante como que el sol sale y se pone todos los días que el principal partido opositor, después de rachas de incidentes violentos, acusa que el gobierno es impotente para hacer frente a los delitos violentos y pide al Ministro de Interior que dimita. Ya, al menos dos veces desde que el PUP asumió el cargo en noviembre de 2020, la principal oposición, el UDP, ha criticado al gobierno por su manejo fallido de los delitos violentos.

El presidente del UDP, el Honorable Senador Michael Peyrefitte, declaró recientemente en una conferencia de prensa que "la situación del crimen se ha salido completamente de control", y que el gobierno y el pueblo deben "hacer algunos cambios serios antes de que la situación se vuelva irreparable". De hecho, nuestra tasa de homicidios el año pasado no fue más horrible que en otros años en las últimas dos décadas, y las estadísticas de los primeros tres meses de este año nos ponen en camino a una tasa más baja que nuestros peores años. Sin embargo, nuestros peores años siendo algunos de los peores del mundo, necesitamos ver una reducción dramática en los asesinatos antes de que podamos figurar entre las naciones más pacíficas, como lo éramos antes de la independencia.

Desde el cambio de siglo, Belize ha tenido un promedio de más de cien asesinatos por año: entre el período de siete años de 2015 a 2021, promediamos 129 asesinatos por año, con un mínimo de 102 en 2020, el año en que Covid-19 visitó nuestro país y nos obligó a un cierre. Cien asesinatos en un año significan más de cien vidas perdidas. También significa cien asesinos por ahí, cien almas perdidas, retorcidas de maneras que son difíciles de comprender; cien familias y muchos amigos que lloran, o se consumen en la venganza porque nuestro país ha fallado completamente en hacer justicia; y cientos de niños y otros dependientes que han perdido una importante fuente de apoyo económico.

Belize y otros tres países de América Central, Guatemala, El Salvador y Honduras, se encuentran entre las naciones más asesinas del mundo. Gran parte de la culpa del altísimo número de asesinatos en nuestra región se le atribuye al trasbordo de drogas, particularmente de cocaína, pero no todos los países de Centroamérica se han vuelto tan homicidas. Mientras que Belize y los países antes mencionados promedian sorprendentemente más de 30 asesinatos por cada 100.000 personas por año, Panamá y Costa Rica promedian 11 asesinatos mucho menos bárbaros por año, y Nicaragua, con su gobierno socialista, promedia menos de 7.

La mayoría de los científicos sociales dicen que la pobreza está en la raíz de los delitos violentos en nuestro país. Golpeado por el covid-19, la corrupción en el gobierno y las agroindustrias en quiebra, Belize nunca ha sido tan pobre. Los programas de alivio de la pobreza del gobierno anterior fueron insuficientes. Las iniciativas que ha introducido el gobierno actual deberían dar algún fruto, pero son demasiado limitadas para tener el impacto que necesitamos desesperadamente.

Hay otros contribuyentes importantes a nuestro estado desastroso. La distribución desigual de la riqueza, las pandillas y las guerras territoriales, un miserable sistema de justicia, una cultura de venganza que ha sido cultivada por el fallido sistema de justicia, todo figura en la pérdida del amor y el respeto por la vida humana.

Las últimas dos décadas han sido terribles. Muchos se han desanimado, aceptando que el crimen violento siempre estará con nosotros. Algunos se rehusan a mirar los noticieros locales, incapaces de hacer frente al interminable derramamiento de la sangre de nuestros hermanos y hermanas. No cortamos el crimen violento a tiempo y ahora cosechamos la amarga cosecha de ese fracaso. ¿Cómo pudimos haber llegado a un lugar donde algunos de nosotros encontremos gloria al matar a nuestro hermano o hermana beliceñ@?

Nuestro país está aplastado bajo el peso de los asesinatos, y no tenemos para siempre para enderezar nuestro barco. Nuestro dolor es grande y, como dijo el presidente del UDP, nuestro problema es demasiado para que lo resuelva un solo gobierno. El presidente del UDP dijo que el gobierno, la oposición Y el pueblo (interlocutores sociales y organizaciones comunitarias) tendrán

que involucrarse para detener este flagelo en nuestra nación. Nos unimos para luchar contra el Covid-19, y un esfuerzo similar debemos hacer para reducir significativamente los asesinatos. Es la batalla más importante que tenemos que pelear. Es una batalla que debemos ganar, ahora.

# CSSPAR dijo que el Gobierno se olvidó de la fuerza laboral

El grupo de expertos más importante de Belize, el Centro de Estudios Estratégicos, Análisis de Políticas e Investigación (CSSPAR por sus siglas en inglés), dirigido por el ex Embajador y Director Ejecutivo en el Ministerio de Relaciones Exteriores, el Sr. David Gibson, en un documento enviado al Primer Ministro acusó que el Primer Ministro y el gobierno está ignorando a la fuerza laboral. En el documento, "Reconociendo el papel de la fuerza laboral como socio igualitario en el desarrollo de Belize", CSSPAR dijo que si el gobierno reconociera el valor de la fuerza laboral en el desarrollo de este país, habría sido incluido en la reciente Cumbre de Inversión de Belize, que fue celebrada en San Pedro el año pasado. Inversionistas extranjeros y destacados empresarios locales estaban sentados en la cumbre organizada por el Gobierno de Belize, pero nuestros líderes sindicales no estaban en la mesa.

CSSPAR dice que el modelo económico que venimos siguiendo desde la independencia ha arrojado un crecimiento constante, pero no suficiente, como lo atestiguan más del 50% de nuestra población que vive en la pobreza. CSSPAR dice que el gobierno y las empresas asumen falsamente que someter a la fuerza laboral producirá un mejor resultado para nuestra gente, cuando es lo contrario, cuando es la liberación del potencial de la fuerza laboral lo que hará que nuestro país salga de la pobreza.

CSSPAR dice que la última vez que se aumentó el salario mínimo fue en 2012, cuando la tarifa se fijó en \$BZ3,30 por hora, y que en 2003, cuando el salario mínimo era de \$3,00 por hora, los intereses privados habían abogado por que se fijara a BZ\$2,00 por hora. En cuanto a la iniciativa actual de aumentar el salario mínimo a BZ\$5,00 por hora, CSSPAR dice que en el período 2005-2008 estudios de expertos habían demostrado que el salario mínimo vital estaba entre BZ\$4,50 y \$6,58 por hora. CSSPAR dice que según la medida actual, los beliceños que ganan menos de BZ\$8-\$10 por hora viven en la pobreza.

No necesitamos mirar hacia atrás muy lejos para probar lo que dice CSSPAR. El desdén por la fuerza laboral en Belize fue más audaz durante el reciente estancamiento entre Port of Belize Ltd. y los estibadores, trabajadores generacionales en el puerto. Intereses comerciales privados locales se pusieron descaradamente del lado de los intereses comerciales extranjeros para poner a la fuerza laboral en su lugar. De hecho, los intereses comerciales privados locales continúan alineándose con los intereses comerciales extranjeros que han ido a los tribunales con sus abogados de alto precio en su agenda para demostrarles a la fuerza laboral que no tienen lugar en la mesa.

El Gobierno de Belize, para su crédito, mostró algo de apoyo a la fuerza laboral en este caso, pero en general, como señaló CSSPAR, la fuerza laboral es una ocurrencia tardía en el desarrollo económico de nuestro país, y si eso no se corrige, nuestros problemas de pobreza persistirán.

The thought of riding a tuk-tuk floored JV. "Me? Ride a tuk-tuk? I'd rather die," he told Grampa. My grampa was very wise, but on this one I daresay he came up short. If you're

going to commute between Belize City and Corozal Town, you need a bike a whole lot bigger than a tuk-tuk.

There's an ego story as big as a cruise ship behind speeding. These guys who roar through villages, especially the ones on the big bikes, it's a power thing, just like the boss show *Brom Bones* ran on Ichabod Crane. If the authorities are serious about cutting down accidents, they have to put the cramp on them. See, it is our nature to respond to challenges. Allow speeding in populated areas and you'll have more speedsters on the highway. If you want to show off on your bike, organize a bike show, at a location outside of populated areas.

Ahem, no sailor worth his salt ever runs their boat on a reef, or turns it over, unless it's a sailing dory; but if you ride horses, one day you're going to get thrown; and if you ride motorbikes, one day both you and the bike will be on the asphalt.

The Ministry of Transport must make it mandatory that all bike riders wear appropriate protective gear. # **OW** fire station gets renovated

ORANGE WALK TOWN, Mon. Apr. 25, 2022

A ceremony was held in Orange Walk Town on Saturday, April 23, to mark the completion of the renovation of the only fire station in the district.

During his remarks at the ceremony, the Prime Minister of Belize, Hon. John Briceño, said that the substandard conditions at the fire station should have been addressed by previous administrations.

"It is unfortunate that the previous government blew away a billion-dollarsplus... A lot of that money was squandered for them to try to get re-elected. But yet, they forgot the basic necessities that our people require and that our people deserve. The Fire Service is a... I want to say a wonderful, but it's a bad example of that neglect," remarked Hon. Briceño.

Minister of Sustainable Development, Climate Change and Disaster Risk Management, Hon. Orlando Habet, spoke about how the renovation process began.

"First thing when we got into office was to do a complete run-through all of our departments and units, and one of the ones that we spend a lot of time with was with the Fire Department, looking from Corozal down to Toledo. Indeed, it is fitting to say now at that time we found out that most of our fire stations were in a deplorable condition.... And when we brought this up in Cabinet and subsequently in the House of Representatives, we found that the fire station, the headquarters in Belize City, had been sold during the time of the previous administration without having an alternative to put our Fire Department to have a headquarters, and of course, not only to have a headquarters itself as a building, but the important people who drive the department forward. And so Cabinet was very supportive and instead of constructing one only national headquarters with the monies, we decided, with the support of Cabinet, we will



construct six new fire stations and refurbish seven fire stations throughout the country," stated Minister Habet.

Following the ceremony, during an encounter with local reporters, Minister Habet further noted, "We have 2.8 million dollars—monies that were acquired from the sale of the headquarters in Belize City. And from our resources and whatever government can provide, we're looking at three million dollars to do the six new fire

stations, the seven refurbishments. I think we're purchasing two new vehicles and amenities such as a fridge," he said.

## British Virgin Islands Premier arrested in DEA cocaine sting

MIAMI, United States, Thurs. Apr. 28, 2022
The Premier of the British Virgin Islands
(BVI), Andrew Alturo Fahie, and the BVI's
Director of Port Authority, Oleanvine
Maynard, have been detained in Miami by
the United States' Drug Enforcement
Administration (DEA) on charges of money
laundering and conspiracy to import cocaine
into the United States. Also arrested was
Kadeem Maynard, the son of the port
authority director, although he was not in

According to the *Miami Herald*, Fahie and Maynard were detained at Miami-Opa-Locka Executive Airport after meeting with undercover DEA agents posing as drug traffickers belonging to the Mexican Sinaloa Cartel to check out a shipment of \$700,000 in cash on an airplane destined for the British Virgin Islands.

United States authorities told the *Herald* that the duo had been in Miami for a cruise convention but visited the airport after the agents informed them about the money—telling them that it was a payoff for allowing the future passage of cocaine loads through the British Virgin Islands into the United States.

Both government officials are expected to appear in a Miami federal court on Friday afternoon.

Andrew Fahie has been serving as the BVI Premier since February 2019. Thursday's drug bust is not the first time that the Premier has been at the center of controversy. In 2003, reports surfaced that he was being investigated for money laundering. Additionally, the UK is currently conducting an unrelated corruption investigation of Fahie's government.

The British Virgin Islands has been a major transshipment point for cocaine bound for the United States since the 1980s. And Fahie is not the first head of state to have been charged with violating US drug laws.

The video is entitled "Cometen Error. EEUU se desquicia, inician cacería contra diputados PRO AMLO. Noroña involucrado". Part 2 is as follows:

"Following the mass killings by the Russians in Bucha, politicians who oppose supplying Ukraine with necessary weapons or imposing new sanctions will be held morally responsible for all subsequent casualties. Had qualified that devastating sanctions should be applied to Russia, an embargo on Russian oil, gas and coal, closing all ports to Russian ships and merchandise and more". (Fátima Ramírez read the above in Spanish from LaJornada dated April 4, 2022)

What flavor do you want in your icecream?! So they come and use the representative, the president of Canada, Justin Trudeau, who had a meeting with President Obrador and no, not mainly to talk about our economic relations, but rather to talk about the issue of Ukraine. Do me a favor! "On the phone today, President Obrador and I shared our concerns about the humanitarian impact of the war in Ukraine — and I invited him

to take part in this week's #StandUpForUkraine event in support of Ukrainian refugees and others who have been displaced". [Tweeted President Justin Trudeau on April 5, 2022] And I will point out that it was our country that put the issue of humanitarian aid on the table at the UN, due to the conflict between the two nations. As if they want to get the credit.

We continue with the tweet. "We also



spoke about the relationship between Canada and Mexico, the trade and economic ties between our two countries, and the work we are doing together to advance shared priorities". Well, there you have it, using other nations, putting the hook. Meanwhile, a Texan legislator asks that they take away their visas as people, who cannot see them in the US for having done their job in the union congress. We had friendship meetings with different nations and there they saw how we met with the Russian ambassador. Well, that's why they want to remove them. "US congressmen asks to revoke the entry of 25 'pro-Russian' Mexican politicians". Among them is Fernandez Noroña. "The congressman is from the United States of Mexican origin, or Vicente González, from the 15th district of Texas, asked the Secretaries of State, Anthony Blinken, and National Security, Alejandro Mayorkas, to revoke the visas and entry and stay permits of 25 politicians of Mexico who participated in the Mexico-Russia friendship committee... # PM steps in for importer of invasive plants

PM Hon. John Briceño and Agriculture Minister Hon. Jose Mai have both admitted to making personal calls to allow the release of quarantined plants being brought into the country by plant seller Diani Chan. Questions have been raised, however, about whether the importation of some of those plants, which are said to be invasive/endangered, violates the CITES convention.

Prime Minister John Briceño has admitted to local media that he did in fact make a call to expedite the clearance process for a number of quarantined plants belonging to a local plant seller. Since the public became aware of the apparent preferential treatment that enabled one businesswoman to bring in the reportedly prohibited species, some have been wondering about the potential impact that the presence of potentially invasive plant species could have on the country's local flora and fauna, as well as the effects that a possible blacklisting of some local exports due to the apparent violation of the CITES convention, could have on the country. According to Hon. Briceño, however, his call to the Forestry Department was just an effort to get officials who tend to purposely drag their feet to promptly get the job done for the Belizean public.

Corozal plant seller Diani Chan had been in the process of clearing her imported plants when that process was brought to a halt by officers of the Forestry Department—reportedly because they became aware that some of those plants are considered invasive or endangered under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) regulations.

Chan, who is the owner of Botanical Garden by Roselynn, had reportedly received several permits from the Belize Agricultural Health Authority (BAHA) to import several thousand plants. Had some of those plants been listed under CITES, however, additional documentation would have been needed to allow for their clearance; without them, the plants would have to be confiscated by the Forestry Department and destroyed. And it appears that this is what the Forestry Department sought to do. It reportedly called BAHA and the

Customs Department to inform them that Foresrry Department personnel would come on the following day, April 12, to inspect the plants (which arrived at the border on April 11) and possibly confiscate any prohibited species. That enforcement process was aborted, however, and Chan was eventually able to get her plants out of quarantine as a result of the intervention of Prime Minister John Briceño, who said he stepped in after receiving calls from Minister of Agriculture Hon. Jose Mai. It was at that point that an initial call was made by the PM to the Customs Department so that the plants could be handed over to Chan.

When asked about the matter last week—including about whether this "special treatment" could potentially affect Belize's CITES standing—the Prime Minister said that he merely provided help to a small business owner who has struggled to get her plants across the border on several occasions.

"I think what's important here is to be able to get the entire picture as to what had happened. I was called by the Minister of Agriculture. Very frustrated, he was saying that Miss Chan—I don't know Miss Chan—is a young entrepreneur trying her best to start a new business that has done everything possible to be able to import her plants to Belize," he said.

According to the Prime Minister, Chan, despite supposedly having all her permits, was stopped at the border on April 11 and prevented from bringing in her plants. Minister Mai had called Prime Minister Briceño and asked him to request that the Customs Department let Chan through.

In regards to why he felt it necessary to take steps to speed up the clearance process, the Prime Minister said, "If it stays on the other side, it is going to be, ehm, they're going to spoil—they're going to die. And so I had to

make that inspection on April 12 and finding that the plants had already been handed over to Chan, Forestry officers reportedly went to Chan's private premises, where they reportedly met some resistance. According to PSU president Dean Flowers, "they were jeered at for their enforcement attempts." Forestry officers then reportedly went to get the assistance of police so that they could proceed with confiscating and destroying any prohibited plants. This was the point at which Minister Mai once again reached out to the Prime Minister and requested that he intervene.

"This time around, I was in the middle of a meeting again, and Minister Mai called me again, very frustrated again. He said the same person is having the very same problem and was saying that now BAHA had approved...and that everything was in place. I think he even said that Forestry had approved a permit for them to bring in these. And now that there was a staff member from the Forestry Department that was now attempting to take away these plants," he said. (However, according to 7News, which reportedly did a follow-up query, sources have indicated that "no such permit from Forestry exists".)

Prime Minister Briceño told local media that he quickly called the officer in charge at the department, who reportedly responded rudely and then hung up on him.

"The officer in charge was very rude in the way he behaved. He said only his boss can call him. And I said that I

am asking you as Prime Minister to please allow them to come in, and then, we can deal with the facts afterwards since it was already here," Hon. Briceño said.

Whether or not those "facts" were dealt with, however, remains to be seen. The Prime Minister also further explained that the officer he spoke with mentioned nothing about CITES.

When speaking to reporters about his decision to intervene, Prime Minister Briceño made an effort to underscore what he sees as a huge problem in many government departments.

"One of the biggest problems that we have in government, and the Forestry Department is no exception is not the only one, sorry: All of the other departments, they all have their rules, and sometimes they drag their feet. We have the problem with DOE, with Geology, with Lands Department, and you have people that want to provide a service to our citizens; you have people that invested a lot of money; you have small businesses like this individual, like Miss Chan who di put her life savings trying to get a permit and to try and open a business and when we drag our feet we create serious problems. In this instance, I simply got involved simply because Minister Mai was trying to get it done and could not get it resolved, and I called, yes I called," he said.

The Prime Minister then went on to insinuate that the bigger problem at hand is that certain government workers purposely drag their feet when addressing

matters that need to be resolved because they want compensation (additional to the salary they receive from GoB) for what

Notably, Minister of Agriculture, Hon. Jose Mai has objected to public claims that government departments must prevent the importation of plant species that are deemed endangered or invasive under CITES regulations, in order to avoid the blacklisting of exports such as seafood and lumber from the country.

"Those CITES... have to be converted into a law that authorizes the ministry to issue permits or to confiscate or to destroy. Now that is still in committee and committee stage, so you cannot act before the law is passed. So that was where the technical people from BAHA and Forestry were having a problem," he

He then explained, in regard to what occurred when Chan attempted to import her plants, "When she got to the border, there seemed to be some kind of controversy with BAHA and Forestry. was saying that they needed to give a import permit and then my BAHA technical group was saying, 'Minister, BAHA is the only competent authority that can authorize this.' Forestry has said that we are signatories to CITES, which are multilateral conventions for the protection of endangered species, animal and plant and so on. But these are CITES, but they are not yet law. As a matter of fact, that CITES bill is still in at the committee stage."

# Abandoned building gutted by fire on Cran Street

BELIZE CITY, Wed. Apr. 27, 2022


An abandoned building on Cran Street in Belize City which was said to be frequented by drug users and the homeless was destroyed by a fire on Tuesday night. The National Fire Service reported that they got the distress call around 9:30 p.m., and when they arrived on the scene a raging fire fueled by strong winds presented some challenges to firefighters. The building was set to be demolished, according to Station Supervisor, Kenneth Mortis, who identified the owner of the property as Delia Williams, a Belizean living in America.

"We extinguished that fire not before facing some of the minor challenges of the nature and the wind and what not. That fire had us shifting our tactics; the wind played a little role and almost had us a bit bamboozled; however, we were successful. We learned that the building had been abandoned for some time. The owner, one Ms. Delia Williams who resides in the U.S., had left the building, and we gathered that when she did return to Belize it would have been for demolishing and the construction of a new establishment on the property," Mortis reported.

The building was reportedly vacant for almost 5 years, and there was no electrical connection in the structure, which led neighbors to believe that the fire was set by a group of persons who use the building for illicit activities. Members of the National Fire Service, while acknowledging that they've received reports of such activities, including the smoking of crack, have said that they are unable to confirm definitively if those persons contributed to the fire.

"That is a possibility, however; if that is a concrete factor towards the cause of the fire, then the possibility to determine that would be next to slim. [Whatever] means or whatever source they used to acquire

# **August Pine Ridge farmer dies in road accident**

Marlin Nadir Hernandez, 34, a laborer of San Estevan Village, died when his motorcycle collided with a pickup truck.

SANESTEVAN VILLAGE, Orange Walk District, Wed. Apr. 27, 2022

A 34-year-old laborer of San Estevan Village, Orange Walk District, was killed on Monday, April 25, when his motorcycle collided with a pickup truck on the San Estevan Road.

The pickup, which was coming from the opposite direction and was being driven by Hilmer Torres, a 35-year-old farmer of August Pine Ridge, reportedly collided with the victim, Marlin Nadir Hernandez, at about 7:00 p.m. that evening, and Hernandez died shortly after on the scene.

Rebecca Chan, Hernandez' sister, a Spanish speaker, told local reporters about the information they have so far received about the incident. Her comments, translated into English, are as follows: "Right now, we don't know what happened. The version they told us is that he had the fault, but we don't know anything else, only what the police told us. Until right now, we don't know anything. I haven't seen them or know what will happen. The only thing we heard was that he wanted to overtake another car, but we don't know if there was any witness and if anyone saw it or know something so they can inform us, because I don't think that someone would like the same thing to happen their loved one,"



said Chan.

Chan said that she does not believe that her brother was under the influence of alcohol at the time of the accident because he works at night and was heading to his job when he left home.

"He was okay! He worked the night before and the following day he stayed here all day and was acting normal with everybody, and suddenly he said he was going to Orange Walk and we didn't see him again... The only thing that my mother told him was to be careful and to come back home," Chan said.

"He has been very careful when driving,

especially with a motorcycle. He wasn't that person that will ride around the village fast; he would drive carefully," continued Chan.

Chan commented on the type of person that her brother was.

"He was my only brother, and we're

all girls. He was a good worker and always working and always willing to help others who weren't his family members. He had a lot of friends. I didn't want him to die," said Chan.

Torres was detained by police pending investigation.

heat in that building, that's up for grabs. We've established that the building wasn't furnished; as we rightly mentioned it was abandoned. We learned that the building had no electricity. So your guess is as good as mine indeed. Did these alleged street peddlers use that building? I'm gonna say street peddlers for lack of a better word. Were they the actual illegal occupants of that building? Did they contribute to the cause of that fire? Unfortunately, those questions will not be answered, as we tried our best to at least have an identifiable person to, well he was occupying this building, or she was occupying this building," Mortis said.

Neighbors say the quick response by firefighters, with the assistance of members of the community, helped to avert what could have been greater losses. Houses adjacent to the intense fire had also caught fire, which led to partial heat damage to a few neighboring homes and damage to a nearby vehicle.

"That particular structure that sits on the eastern portion of the building received

fire damage to the eaves and fascia board. There was a structure that sits across the street. That tells you that the heat was so intense last night that that building, fortunately, only suffered a loss to the plastic gutters. Unfortunately, the vehicle, which was an 01 Isuzu Rodeo, suffered more heat damage to various parts of the front of the vehicle not limited to — but including the windshield, the two rearview mirrors, the bumper, and the 2 indicator lights, all located at the front. We noticed that the eastern side of the building, which housed the San Cas warehouse suffered heat [damage] at the top of the building, where the zinc is located. We noticed that a few of the cameras at the front were damaged by the heat as well," explained Mortis to local

It has additionally been reported that some of BEL's power lines in the area were damaged by the fire, and an assessment was ongoing to determine the extent of any damage that was possibly caused to cables and power lines belonging to local cable companies and DIGI.

# The Incas

The Incas have the double distinction of presiding over the largest empire of the ancient Americas and one of the shortest-lived. Sprawling along the Pacific Coast and across the Andes Mountains to the edge of the Amazon rainforest, their domain took in parts of present-day Colombia, Ecuador, Peru, Bolivia, Chile and Argentina, encompassing nearly 800,000 square miles and perhaps 12 million people. Yet the empire endured only from about A.D. 1400 to 1532. In The Inca, Kevin Lane, a researcher at the University of Buenos Aires, offers a concise and wellillustrated introduction to this bygone realm, describing its history and culture and chronicling its rise and fall.

The technology of the Incas was formidable. They smelted minerals such

as copper, tin, lead, bronze, gold and silver. They were expert engineers, building hundreds of rope suspension bridges and thousands of miles of roads, which were used by relays of runners and caravans of llamas to connect all corners of the empire. They transformed the landscape with irrigation canals and mountainside terraces for raising crops, most notably the potato. They also constructed finely detailed stone buildings, many of which still stand, most famously at Machu Pichu, the 600-yearold royal mountain retreat in the mountains of Peru.

## **IGNACIO RAMONET: The Cuban intervention** in Africa that's best known was in Angola. Do you recall how that started?

FIDEL CASTRO: Yes, I remember perfectly. After what was called the "Carnation Revolution" in Lisbon in April 1974, Portugal's colonial empire began to fall apart. The country had already been weakened by a long reactionary, pro-Fascist, pro-Yankee government, by economic ruin and the ravages of the patriotic war that made the empire unsustainable and finally topped it.

I remember earlier that in 1973, when the colonial government fell, most of Portugal's African colonies — Guinea-Bissau, Cape Verde, Sao Tome and Mozambique — gained their complete independence and were recognized by the progressive government that was in power at the time in Lisbon.

But in the case of Angola, which was the largest and richest of Portugal's colonies in Africa, the situation was different. The government of the United States implemented a covert plan -- this plan has been revealed now; until just a short time ago, Washington was "innocent," it "had nothing to do with what happened there" to crush the legitimate interests of the Angolan people and impose a puppet government. A key point was a

(US) alliance with South Africa to train and equip certain organizations created by the Portuguese colonial regime to frustrate Angola's independence and turn it into virtually a condominium for Mobutu, the corrupt dictator of Zaire, the former Belgian Congo.

This Mobutu was one of the biggest thieves that's ever lived — no one knows where the \$40 billion he stole is now, what banks it may be in, or what government helped him to collect those tens of billions of dollars in a country where there was practically nothing left -- no uranium, no copper, no supplies of lots of other products -- because it had been one of the major European colonies in Africa.

But so anyway, the plan was to turn Angola into a condominium for corrupt Mobutu and South African Fascism — a South Africa whose troops Washington didn't hesitate to use to invade Angola. Dictators, terrorists, thieves and confessed racists were constantly, and without the slightest scruple, incorporated itno the ranks of the so-called "free world," and not many years later, US president Ronald Reagan called them, in an incredibly cynical phrase, "freedom fighters."

# "Jungle" residents save man who set himself on fire

BELIZE CITY, Wed. Apr. 27, 2022

Quick response from residents of the hutment in the Pickstock area commonly known as "the Jungle" saved the life of a 21-year-old who reportedly set himself on fire sometime after 9:30 on Tuesday night. The National Fire Service was called to the scene, but when firefighters arrived, they found no trace of fire. They later discovered that the young man had set himself ablaze in one of the rooms in an apartment in the hutment.

"We've learned that just after midnight, we received another distress call for a potential fire in the Jungle area, and upon our arrival, we actually did not see, we did not find any fire, but we did learn that the fire was extinguished prior to our arrival. This gentleman, 21-year-old Idelfonso Ku, had reportedly made an attempt to set himself ablaze inside one of the rooms in the building. Up to this point in time, I cannot tell you the degree of burns that he did sustain on his body; however, kudos to the quick response of the other occupants in the building and the neighborhood. They managed to extinguish that fire, and I was made to understand that he was rushed to the medical facility for treatment and, as I said, the degree of burns is not forthcoming to us as yet," Station Supervisor of the National Fire Service, Kenneth Mortis, said.

Reports are that the incident took place in the home of John King, a much-respected Belizean artist and semi-pro football player from the area who was fatally shot in the community just two weeks ago while visiting a friend of his who resides in the area.

While there is no indication what led Ku to try to set himself ablaze, he is lucky to have been found in time by the other residents of the area.

"What would drive somebody to try to literally set themselves ablaze? That's a question that only Mr. Ku could answer. I don't even know if any of the other family members could answer why he would do such a thing. Again, it's unfortunate. Let's hope that he has a speedy recovery and that the damages aren't as severe as it may seem," Kenneth Mortis said.

The Government of Belize (GOB) has received financing from the Inter-American Development Bank (IDB) for the execution of a five-year tax modernization project entitled "Strengthening of Tax Administration" (BL-L1031). The main beneficiaries of the Project are: (a) the Government, which will have more revenues to implement its public policies; (b) taxpayers, who will have more support and a digital environment to fulfil their tax obligations; and (c) the population, from the government policies implemented. Through this project, the Belize Tax Service Department (BTSD) has procured a Modern Integrated Tax Administration System (the Revenue Management System (RMS)) and is presently in the implementation process. This new system will be used in the management of the Belize Tax Administration.

The BTSD management has identified the need for a modern audit approach based on risk analysis. The BTSD Strategic Plan states that:

"BTSD will explore the introduction of a Risk Management Plan (RMP) to properly respond to the risks identified on a timely basis, to minimize overall compliance burden for both the taxpayers and the tax administration. As an important aspect of the RMP, risk mitigating strategies will be proposed for application against potential and existing risks. The plan will highlight all areas of risks including risk-based assessments, risk-based audits, risk-based sector and taxpayer segmentation, compliance risks (registration, filing, reporting and payments) and international risks. Risk mitigation reduces the extent of exposure and ensures that the strategic objectives are achieved."

The consulting services ("the services") includes the contracting of a consulting firm for a period of ten (10) months to Prepare, Implement and Execute a New Audit Model, making use of the range examination and risk-based techniques (to include analytic tools for audit). The main activities of the consultancy include:

# Christobal Mayen, football legend

BELIZE CITY, Thurs. Apr. 27, 2022

Belize City fans first took notice of footballer Christobal Mayen when he visited the MCC during its heyday in the late 1960s-early 1970s as a wing forward on the then Belize City champions San Joaquin, who were back-to-back champions in 1969-70 and 1970-71. The 1971-72 season was incomplete due to a controversy that erupted late in the season when it appeared that the Spurs football team was on the verge of claiming the championship.

According to another 1970s football great, goalkeeper Rupert "Canalete" Anderson, R.I.P., Christobal had previously played some senior football with him on a declining Brodies team probably around 1967-68, and also the following year on a team named Belize Global, which achieved a big upset victory over the then highly rated Rocking-R team out of Cayo that featured many of the later Avenger stars. Migrating from southern Belize, as did his brother, the legendary Locario "Malanga" Mayen, Stobal had later moved further north to join his elder brother in San Joaquin.

At some point over the next couple years, 'Stobal came to reside in Belize City, and was involved with a young group of players from the Lake Independence area, who had entered the senior division competition as Berger Lakers in the 1973-74 season, in which they placed 3rd. The team was at the

time being managed by popular market butcher, Lester "Bailar" Smith, but it is not yet clear if he actually recruited Stobal from San Joaquin to join his bunch of youths. What is certain is that his football abilities and natural leadership skills saw Stobal quickly become a major force on the team, and he soon assumed the role of player/coach. Having once been with a championship team, Stobal obviously knew what it took to become a champion.

As his former teammate with San Joaquin, Stobal at some point lured another legend, Raymond "Lee Mole" Alvarez to join him with the Laker boys, now with the sponsorship of Berger 404, and that duo remained steadfast through a number of years.

With Stobal's leadership, Berger 404 won back-to-back Belize City championships in 1974-75 and 1975-76

That success was soon thwarted, as the team essentially split in half, with some players following manager Bailar with a new team, Chito's Rangers, sponsored by Chito Mai of Orange Walk. The rest stayed with Stobal and Berger 404, who also eventually had some changes of sponsor, thus the team name change in ensuing years to Witz All Stars, Haig Dimple and Belikin; while Bailar's group also later changed a few sponsors and team names, including Royal Rental, BTA Lakers and Duurly's. Eventually, in the latter

80s, the two camps reconciled, and the team out of the Lake was named Duurly's Belikin or Belikin Duurly's with Christobal Mayen as head coach. Except for the 1983-84 and 1985-86 city competitions won by Milpros teams from the Plaza (sponsored by Parra's and Coca Cola, respectively), all the Belize City championships from 1977-78 until 1990-91, after which the semipro league was launched, were shared between the two teams from the Lake, and Stobal figured prominently as player, player/coach and finally as coach. (Note: Although Bailar was manager, Chito's consisted of players from various districts, but mainly Belize City and Orange Walk.)

Aside from his many championships over two decades, among the highlights of Christobal's sterling football career in Belize before migrating to the US sometime in the 1990s, was leading his team, then named Belikin, to the first national club competition championship in the 1981-82 season to commemorate Belize's Independence in 1981. And before that, in 1978 Stobal was player/coach of a Belize selection accompanied by then BFA vice-

chairman Evan X Hyde that went undefeated through 5 games played in Mexico. Featured on page 94 in the X's book, "Sports, Sin And Subversion," many fans have considered that team one of the best Belize selections ever. Of course, not all the players on the team were necessarily the best in Belize City or the country at the time, but the enormous talent assembled and the cohesion and chemistry the team enjoyed resulted in success on their international tour that has not since been duplicated.

This is by no means a complete documentary of the football career of Belizean football legend, Christobal Mayen. We do need to hear many more important details of his career "from the horse's mouth;" but just to refresh the young minds of today's players about the footsteps they are aspiring to walk in, we share below a brief excerpt from an *Amandala* newspaper story from the past datelined: MCC, Sun. Oct. 17, 1976. The story, titled "Christobal of

Berger 404," begins like this: **Christobal of Berger 404** MCC, Sun. Oct. 17, 1976

"The first division marathon opened with a flourish this morning and it was dominated, fittingly, by Christobal Mayen, leader of defending marathon and season champions Berger 404.

"After a marchpast of the eleven competing teams this morning and a sensible opening address by the Hon. Senator Said Musa, himself sponsor of a junior team, the tournament began. After it was all over, Berger 404 emerged again as champions having defeated Charger 1-0, Marine and Service 1-0, White Label 1-0, and Roses 1-0. The champion scored in all four games and on three occasions it was Mayen.

"He is not an imposing man physically, but Mayen has an extraordinary strength and dignity which expresses itself in the smooth control, sprinting bursts, constructive distribution and a deadly finality in front of the goal...'

## **Bar Association** says referendum results are nonbinding

on the legalization of marijuana, the Bar Association of Belize published a document in which it provided legal insight into the status of the Cannabis and Hemp Bill and the legalities surrounding it—which included an assertion by the association that, in Belize, the results of a referendum are not binding and cannot prevent the passing of a bill.

"The Government may still pass the Bill legalizing the production and sale of marijuana even if the majority votes against it in a referendum," states the document, titled "The Cannabis and Industrial Hemp Control and Licensing Bill 2022: An Insight into the Bill and Potential Referendum". Choosing to ignore the results of a referendum, however, could lead to a major political fallout for any administration.

In the document, the Bar Association also notes that, under the Constitution, there is no requirement for the Government to consult with parties after a bill has been

The Cannabis and Hemp Bill, having been approved by Cabinet, the National Assembly and the Senate, now only requires assent from the Governor General in order to become law. Upon the passing of the bill in the Senate, however, the leader of government business, Hon. Eamon Courtenay, had indicated that the Government would hold off on sending the Bill to the Governor General for approval for a period of 30 days in order to allow for "good faith consultations with social partners".

The Bar Association reiterated this, adding that if any consultation is conducted during this time, it would only be an act of good faith by the Government.

During an interview this week, Hon. Francis Fonseca told local media that he is, as expected, in full support of the Cannabis and Hemp Bill, underscoring the fact that it has already been approved by the Senate.

"Listen, Cabinet approved that bill. The National Assembly, of which I am a member, approved that bill, passed it into law. The Senate approved the bill, passed it into law. So, that is where it is. Obviously, the bill has the support of the Cabinet. It has my support as a member of Cabinet and as a member of the National Assembly. So that's where it is," he stated.

When asked about the churches' call for a referendum—and the possibility of them obtaining the signatures of the requisite 10% of the population of registered voters in order to trigger that referendum, Hon. Fonseca stated "let's see what happens," before asserting that a referendum cannot come after the first reading of a bill—comparing the current situation to that of the Prime Minister of Belize v Alberto Vellos case of 2008.

"As you know, there is case law that says, the clear dicta in that case law says that a referendum cannot come after a first reading. You can take a look at the Vellos case in which that matter was discussed. So, the law, you can argue both sides of the law, and obviously the Church is quite free to challenge in court any decision that we ultimately make, but it will be a Cabinet

# Bakers denied price increase, for now

well as materials used during production and in packaging. Most notable was the increase in the price of wheat due to the ongoing war between Russia and Ukraine, which are two of the world's largest exporters of that grain. When the Caribbean Millers Association issued a release indicating that it had written to local governments to request that millers be allowed to raise the price of flour, it became even clearer to many Belizeans that what was taking place was regional, and that an increase in the price of flour and bread was already in the works.

A 10-ðårñånt price increase in the price of flour was projected—with the price of La Gitana flour expected to rise from 90 ñånt¾ à ðîund to 99 cents a pound, and the price of Bebe Aqua to jump from 99 ñånt¾ per pound to \$1.02. And this week, some Belizeans began to see an increase in the price of bread on the shelves of some local stores. Reports are that some stores and bakeries are reportedly selling bread formerly priced at \$1.75 per pack for \$2.50.

However, during an interview earlier this week, Minister of Education Francis Fonseca noted that, because the prices of flour and bread are controlled by government, and since government has not yet given the green light for any change in the base prices of those products, any increase in the price of bread is illegal, and store owners selling at new rates are in direct violation of the law.

"They are in absolute contravention of the law. It is illegal. It's illegal. They have no authority to do that. Bread is a controlled price substance, so they have no authority to do that. And until the law is changed, until there is some approval for the price to change, they are in violation of the law," Fonseca said.

Fonseca further explained that Cabinet had asked the Minister of Agriculture and Food Security, Hon. Jose Mai, to present a paper on the ongoing issue so that a substantive discussion could be carried out before any decision was made.

Today, a Cabinet brief announced to the public that a decision had been

made, and that there is to be no increase in the price of a 16-ounce loaf of bread at this time. The decision was made after a review of a submission by Hon. Mai which outlined bakers' request for an increase to the controlled price of the 16-ounce loaf and approval of an increase to wholesale prices.

The release noted, "Cabinet determined that no price increase will be allowed at this time. In addition, Cabinet instructed the Minister of Agriculture, Food Security, and Enterprise to engage with the Association of Bakers to ensure other alternatives to minimize the possibility of drastic increases in the price of a 16-ounce pack of bread."

Jose Mai, during an interview today, however, told local reporters, "You know, bread is a regulated commodity, it is price-controlled and priceregulated. The bakers submitted to us that they want to increase the price of bread by 75 cents wholesale and 75 cents retail. They did provide enough evidence to show that their cost of baking the bread has gone up to \$1.81 cents a pound; they are selling at 1.75, so they are selling below. So we looked at and analyzed it, and presented it to Cabinet. Cabinet did not say no. They are saying, I think, we need to do further research, further engage the bakers, because bread is a daily thing. We have asked our Director of Food and Supplies to meet again with the bakers to look at the structure of pricing we have and to see where it is possible to minimize the increase. We are not saying that they will not get an increase; we are saying, let us study carefully, any increase in any commodity right now will put additional suffering on our people. Now I want you to understand something: the bakers will not be the first or the last to come..."

We can confirm that some stores and bakeries have already gone ahead and increased their prices and that the price of some baked treats has also increased. It remains to be seen how Cabinet's directive will be enforced to ensure that there is not a hike in the price of the bread on local store shelves.

# Revelers "back pan di road" this September

With a history dating back to the 18th century, Carnival in the Caribbean has long been a celebration of culture, freedom, resistance, and emancipation. And come September 3, 2022, Carnival in Belize will make its long-awaited return.

News of the return of Belize's Carnival Road March on September 3, 2022 has been received with great jubilation all across the country, including at the official announcement ceremony held at the Belize City House of Culture this past Tuesday. The theme for this year's road march, quite fittingly to some, is "We outside! We back pan di road!"

Vice president of the Carnival Association, Patrick Thompson, echoed the excitement embodied in this year's theme during his opening address at Tuesday's ceremony—the very first official Carnival event for 2022.

"It has been two years. Two long-awaited years, people, since we have not reveled and 'go on bad through the street,' as we would say," he said.

Thompson, who noted that, "since its inception in 1974, Carnival is and will be one of the highlights in our September celebrations," then proceeded to tell those in attendance at the ceremony, "It gives me great pleasure and is an honour to announce the return—and I say the return of Carnival in Belize 2022."

To assist with the preparations for the return of Carnival celebrations after a two-year hiatus due to COVID-19, the Ministry of Education, Science, Technology, E-Governance, and Culture (MoESCT) handed over a cheque for twenty thousand dollars to the Belize Carnival Association. Hon. Francis Fonseca, Chairman of the National Celebrations Commission and Minister of Education, Science, Technology, E-Governance, and Culture, spoke of the growth that Carnival has seen across the country over the years.

"Everywhere I go, everywhere I run into

people all over the country—because as you know, Carnival really started out as a Belize City thing, but it really has grown and really multiplied over the years and has really become a national Carnival that people from every walk of life, people from all corners of the country look forward to with great anticipation, great excitement, great enthusiasm," he said.

The Ministry is also planning to provide additional assistance to the association throughout the months leading up to Carnival Day.

"We want to return with a bang. We want this year to be good. We want everybody to feel the excitement, feel the rhythm of the beat. We want everybody to get out there and truly enjoy the comeback of Carnival in 2022," added the Minister of Culture.

"After 2 lonnnnnggggg years we are happy to say we are back! Grease up

those knees and backs! Pull out those flags & rags! Get in those workouts! Cause come Sept. 3rd we are on the road once again!" stated the Belize Carnival Association in a social media post.

During an interview with local media, Hon. Francis Fonseca said that one of the most frequent questions he has received as the National Celebrations Committee Chair over the past year is "when will Carnival come back?" and that he is happy to finally be able to give an answer to that question.

"As of now, we should return fully to pre-pandemic Carnival, and of course everybody is free to take their own precautions, and if you want wear your mask, you wear your mask, but there's no requirement for that. So it's a full return—that's our hope and we certainly hope that that doesn't change over the next few months," he said.

Hon. Fonseca also spoke on plans to take Carnival to another level—something which the Carnival Association seems to agree with, as this year, Carnival bands are being requested to register as businesses.

The origin of Carnival, at least in the Caribbean, can be traced back to the island nation of Trinidad and Tobago—when, in the late 18th century, plantation owners would, prior to the start of Lent, hold masquerades and balls, which indentured workers and freed slaves were prohibited from attending. The slaves then began to throw their own celebrations, dubbed Canboulay.

While Trinidad Carnival takes place a week before Lent, however, Belizean Carnival, which was founded in 1975, is a significant part of its Independence Day celebrations in September.

decision, and I don't wanna get ahead of that decision," said Hon. Fonseca.

The Bar Association has noted, however, that the two cases are completely different. While the case of the Prime Minister of Belize v Alberto Vellos was a response to a motion to pass a constitutional amendment, the matter being protested by the Churches of Belize has to do with the passing of a regular law. When it comes to the former, Section 3 of the Referendum Act (which has since been repealed) dictated that any move to change fundamental rights under the Belize Constitution required the Government to hold a referendum before the second reading of a Bill.

The case brought against the Prime Minister by Alberto Vellos and three other claimants was in response to a proposed constitutional amendment (the Sixth Constitutional Amendment Bill 2008) and the claimants requested that the Prime Minister submit a Writ of Referendum to the Governor General before any decisions were made on the amendment.

The churches, however, are seeking a referendum based on a provision that allows for one to be held once a required number of votes is obtained.
