



Ivan Ayuso, accused embezzler, receives disclosure

BELIZE CITY, Wed. June 8, 2022

In January of 2021, Ivan Ayuso was arrested and charged for embezzling over a million dollars of public funds from the National Sports Council, where he had been employed as a senior pay clerk. Today, he returned to court, where he was

served with a full disclosure of the evidence that the Financial Intelligence Unit (FIU) will be using against him in his upcoming case.

The 43-year-old Ayuso was accused of mismanagement of public funds and embezzlement in 2020 after a report from the then Auditor General, Dorothy Bradley, indicated that he had been manipulating pay sheets at the National Sports Council so that he could be paid multiple times. That report also found that Ayuso, over the course of the year covered by the report, had diverted somewhere around \$400,000 (\$416,228) into three of his personal accounts. Eventually, however, it was discovered that more than twice that estimated amount-over one million dollars-was actually unaccounted for at the Council. Ayuso was arrested and charged for theft, uttering upon a forged document, and money laundering of one million, ninety thousand, two

hundred and twenty-seven dollars and thirteen cents. His bail was set at \$300,000, but he was unable to meet it and was remanded to the Belize Central Prison.

Ayuso was represented in court today by Senior Counsel Ellis Arnold, while the FIU's Janelle Thomas Sharp was the case's prosecutor.

Ayuso is expected to return to court on August 19, when he will stand before Senior Magistrate Aretha Ford for the preliminary inquiry into the case. If Magistrate Ford determines that enough evidence against him exists, he will then head to the Supreme Court for trial.

Back in 2004, Ayuso, who was a cashier at the time, was accused of setting a fire that caused the Paslow Building to burn down. It was alleged that he did so to presumably ensure the destruction of certain records in order to cover up an earlier misappropriation of funds, but he was acquitted a year later.

When he spoke to reporters on Monday during a police press briefing, Commissioner of Police. Chester Williams seemed to indicate that, unlike many Belizeans who are doubtful about the allegations that Jasmine Hartin, facing charges for the death of Police Superintendent Henry Jemmott, had contracted local gangs to carry out a "hit" on both Williams and a local magistrate, he has reason to believe that there could be some truth in the claims.

The Police Commissioner indicated that, although Hartin, after being questioned about the allegations in mid-May, had been subsequently released due to the lack of any evidence to support any claims that she had contracted someone to kill the COMPOL, he has not ruled out the possibility that she could be guilty of ordering such a hit. He is basing this suspicion on disturbing text messages that he said he had previously received from Hartin.

"She is not completely off the hook as yet. The investigators are still doing certain things. Certain things were said,

and I personally have received a number of text messages from Ms. Hartin. How she got my number, I don't know. But, she has found ways to message me, prior to the alleged threat being made. That is why I have no difficulty believing that she might have made some threats, because of the content of the message I had received from her. Be that as it may, I am not involved in the investigation, and for good reasons. I don't want to come across as if I am influencing the investigation, because I am a subject of it, in terms of being a complainant. But, the investigators have certain things to do to be able to ascertain if in fact the threats were made, and then we see how we proceed from there," said COMPOL Williams.

The claims that Jasmine had ordered a hit on the Police Commissioner were made by Lionel Neal, her former maintenance worker who, according to a police report filed by Jasmine, had been trying to extort her. That maintenance worker had subsequently been charged for attempting to sexually assault her, although he claimed he had been in a sexual relationship with her.

Manatee calf found dead in Corozal

LOS PINOS, Corozal District, Thurs. June 9, 2022

On Saturday, June 4, a male manatee calf was found dead within the Corozal Bay Wildlife Sanctuary (CBWS)-the first such death reported for this year. The young male, in seemingly perfect health, washed up on the beach and was found in Los Pinos, Corozal, a few miles west of Sarteneja village. The research team from the Sarteneja Alliance for Conservation and Development went to the scene promptly and performed a necropsy on

the male calf.

It was a little over 5 feet, 5 inches, or 169 centimeters, in length with a thick body fat layer indicative of a healthy manatee. There were no signs of injury or swelling, nor was any indication of trauma to the internal organs found, so at this time its death remains a mystery.

"Further examination was conducted, however, the cause of death remained undetermined. All observations were recorded by the

The Elections and Boundaries Commission has announced via a press release issued on Thursday, June 9, that PUP senator, Collet Montejo, has been appointed as a member of the Redistricting Task Force.

The task of Montejo is to supervise all the fieldwork for the gathering and provision of all information that is to be considered by the task force regarding the physical layout of each electoral division, the various facilities within those divisions and the level of accessibility to transport within each constituency, as well as the distribution of the population across those constituencies throughout the country. The task force is responsible for

making recommendations to the **Elections and Boundaries Commission** as it proceeds with a redistricting exercise.

The Commission says that it continues to place a high priority on this critical exercise, which is expected to be completed in 2023.

Climate Change key on 9th Summit of Americas agenda

LOS ANGELES, California. Thurs. June 9, 2022

Climate Change and the realities of ever-increasing global temperatures are currently a prominent topic of discussions at the 9th Summit of the Americas taking place in Los Angeles. Today the Prime Minister of Belize, Hon, John Briceno, held a meeting with leaders from CARICOM and Latin America who had a sit-down with Canadian president Justin Trudeau. According to a Facebook post by PM Briceno, during the meeting he explained a little about the Blue Bond debt-for-conservation swap initiative in Belize.

"I explained our Blue Bond initiative as Belize's response to debt and fiscally responsible management as well as innovative climate change action. Belize does its part and the developed countries need to step up and do their share while lobbying others to do same," Prime Minister Briceno stated in his Facebook post today. When he was interviewed yesterday, he made a similar point — telling developed countries that mere access to loans to address the various crises will no longer be enough.

"Climate Change is a clear and present danger for Belize and the Caribbean. The issues of climate change that have been caused by the developed countries like the United States...," the PM said. He added, "We are continuing to put pressure on developed countries like the United States, Canada, and Mexico, to be able to do more work to reduce the



emission that causes the Earth to get warmer, because we are facing the consequences."

He said that recognition of this issue must be followed by discussions about the accompanying issue: access to financing.

"We can't continue to finance our way out of crisis. The pandemic is a good example. We have borrowed a lot of money in the region, Belize, and by the time we got into government, it was already at 133% of GDP. Janet Yellen, the Secretary of the Treasury, and Blinken, the Secretary of State, have sent a letter to the Caribbean. Certainly I got a letter where they said that they are prepared to work with the World Bank, IDB, and other IFIs to make it easier for countries like ours to access funding at lower interest rates whenever we are facing these crises, but for us, it's more than that. We cannot continue to borrow ourselves out of these crises. I believe that the United States and developed countries have a moral responsibility to countries like us; they are the ones that have caused this problem. We are doing our part, we are protecting our forest, we are protecting our ocean space, we are doing more than they are doing, so they then now need to be able to give us the money so that we could continue to do the work, to do the adaptation changes that needs to be done...," the PM remarked.

In speaking about addressing the climate crisis, President Joe Biden, during his remarks at the inaugural

ceremony of the summit, said, "When I hear 'climate', I think jobs — goodpaying, high-quality jobs that will help speed our transition — to a green economy of the future and unleash sustainable growth; jobs in developing and deploying clean energy; jobs in decarbonizing the economy; jobs in protecting biodiversity of our hemisphere; jobs that will provide dignity of being able to feed your family, give your children a better life, and envision a future of possibilities."

Projects aimed at achieving this include the Renewables in Latina America and the Caribbean Initiative, which seeks to accelerate the transition to clean energy in LAC. The major goal


Nora Parham posthumously pardoned

BELIZE CITY, Thurs. June 9, 2022 On Wednesday, June 5, 1963, at 8:00 a.m., Nora Parham was executed at the old Belize Central Prison on Gaol Lane, and on the 59th anniversary of that wrongful execution by the state, she was posthumously pardoned.

Parham was the only woman to be

And 59 years later, she was posthumously pardoned in Belize City in a ceremony attended by several government officials, along with her eight sons.

"Today, the family looks at this event, having sad and painful memories, but with great joy. It speaks volumes in favour of concern and needed action for relief and protection of abused women and victims of domestic violence. Every major town in Belize should have some place, man, with personnel that take these issues seriously and take it compassionately. Where each case is recorded and appropriate action is taken. We have heard the government's sentiment and desire to make these issues a priority; we are proud to be associated with this," stated Harold Parham, son of Nora Parham.

During the ceremony, Prime Minister of Belize, Hon. John Briceño, gifted Harold Parham the Belizean National Flag in honor of his mother.

To make the pardoning official, Cabinet Secretary Stuart Leslie read the legal instrument which put into effect the pardon in the absence of Governor-General Froyla Tzalam.

Peyrefitte sends more FOIA requests

The chairman of the United Democratic Party, Senator Michael Peyrefitte, has sent two additional letters invoking the Freedom of Information Act in his quest to access information about the amount of money paid by government to lawyers and other professionals who hold ministerial posts or other high-ranking positions in the administration. One of the two most recent letters was sent to

the Governor-General, H.E. Dame Froyla Tzlam, requesting the declarations of permission given to Minister of State in the Ministry of Finance, Hon. Christopher Coye, and Minister of Foreign Affairs, Foreign Trade and Immigration, Hon. Eamon Courtenay so that their firm, Courtenay Coye LLP, could be contracted by the government of Belize. (The Belize Constitution bars ministers and senators from entering into contracts with the government without expressed permission from the Governor-General.)

This is Peyrefitte's second set of letters in just a little over two weeks. The first was sent directly to the office of the Prime Minister requesting a list of the specific amounts paid out to Courtenay and Coye, who have become the government's go-to legal representatives. The request called for disclosure of payments already disbursed and sums owed to the law firm and to Queen's Counsel Douglas Mendes.

The Prime Minister, Hon. John Briceño, had given his assurance that the information would be provided before the end of the 14-day period following the request, as required by legislation governing such matters. Additionally, Courtenay and Coye have publicly stated that they have nothing to hide, and while Peyrefitte says that he had received some documents, he says that they were not official and until those documents and an official response letter are sent,



he is doubling down on his efforts.

The recent request made to the Governor-General is for the letters of permission she would have had to sign to allow the two members of the National Assembly, Courtenay and Coye (who are members of both the Cabinet and the Senate) to have their firm handle cases for the government. Without this letter, Peyrefitte points out, they both would have to vacate their seats in the Senate forthwith.

The Belize Constitution, section 64(2) states, "A Senator shall also vacate his seat in the Senate if he shall become a party to any contract with the Government for or on account of the public service, or if any firm in which he is a partner or any company of which he is a director or manager shall become a party to any such contract, or if he shall become a partner in a firm or a director or manager of a company which is a party to any such contract."

The proviso annexed to this subsection, however, allows members to declare their business to the Governor-General before contracting with the government or at least as soon as possible after any such contract has been entered.

"...the Governor-General, acting in his own deliberate judgment, may exempt any Senator from vacating his seat...," the proviso states.

As mentioned, none of the documents that were requested have yet been officially disclosed.

administration has high hopes and expectations for this would-be hemispherical assembly. Prime Minister of Belize, and current Chairman of CARICOM, Hon. John Briceño, flew out to Los Angeles yesterday to attend the Summit from the 8th to the 10th of June, despite CARICOM taking an initial stand with the three excluded countries. That stance taken by the regional body later disintegrated—with most leaders from the Caribbean in LA for this summit.

"I believe that as the Chairman of CARICOM and the Prime Minister of Belize it was important for us to be here so that they can hear us not only as CARICOM but also so that they can hear us as Belize," PM Briceño remarked in an interview yesterday. He added, "CARICOM generally decided that who wants to participate or wish to participate they can. We do not have a list of who is going to be able to be here or not here, but we just decided that those that can make it, should make it, and several of us are going to be here."

Yesterday, during a meeting of the Summit Implementation Review Group that was broadcasted live, the US Secretary of State, Antony Blinken, and the Secretary-General of the OAS, Luis Almagro, delivered remarks. Blinken said that this summit will focus on five major areas: greater health and pandemic resilience, closing the digital divide, accelerated transition to clean energy, doubling down on investment in climate resilience, and finally, advancing democracy.

"We all know the democratic process is not always easy or swift. That's true within a single democracy. It's amplified when we bring together dozens of democracies, as we've done for this summit. But the fact is, we also acknowledge our shortcomings. They're out in the open. We don't sweep them under a rug. And we work to try to address them together, and ultimately that is the greatest strength that we bring to the table as democracies. And there are few regions in the world like this one, where you see so many democracies – from the left, from the right, from the center – that are able to set out a shared roadmap for addressing complex

Almagro said. He went on to say that the summit is an opportunity for leaders in the region to reaffirm their commitment to democracy.

"Citizens who achieve this and the peoples who achieve this authority is through the adoption of a plan of action geared to strengthen this democratic governance. That's why it's more important than ever now that the governments, institutions, enterprises, and the citizens of the Americas work together to deal with these challenges and to create new opportunities to advance in the – with the objectives of the ninth summit," Almagro said.

The White House stated in a release issued yesterday, June 7, "Our Administration and partners will push back against the threats to our democracies by fortifying democratic institutions, investing in civil society, strengthening independent media, and following through on a regional digital transformation that is transparent and equitable."

To forward this agenda, the administration intends to implement the Inter-American Action Plan on Democratic Governance, invest in civil society; devote \$42 million to the Voices (Voces) Initiative to protect, defend, and promote civic space in Central America; and promote independent media and information integrity **and** global partnership for action on gender-based online harassment and abuse.

Notably, Brazil's Jair Bolsonaro and Mexico's Andrés Manuel López Obrador decided not to attend the Summit due to the Biden administration's exclusion of Cuba, Venezuela, and Nicaragua. Belize's Hon. John Briceño had signaled his intention to attend after "extensive consultations" with other leaders in the region, and he had remarked that it would be a good opportunity to speak about the assistance needed by the region to respond to the COVID-19 pandemic and regional debt.

During his official remarks today, in the presence of the other heads of state, he took the opportunity to also highlight the region's position on the exclusion of the three nations. He said, "The power of the Summit of the Americas is the space it provides for all the countries of the Americas to dialogue and to agree on joint actions. This summit belongs to all of the Americas. It is therefore inexcusable that all countries of the Americas are not here, and the power of the Summit is diminished by their absence. It is incomprehensible that we would isolate countries of the Americas which have provided strong leadership and contributed to the hemisphere on the critical issues of our times. Cuba has provided consistent unmatched cooperation in health to almost twothirds of the countries in this hemisphere, including Belize. The illegal blockade against Cuba is an affront to humanity. In fact, it is un-American. The time has come, Mr. President, to lift the blockade and build back bonds of friendship with the people of Cuba. Similarly, Venezuela has done so much toward energy security for the




BTL's investment in "content": likely a big plus for Belize

Commenting on Belize Telemedia Limited's (BTL) acquisition of Alternative Networks Ltd. (ANL), Leader of the Opposition, Hon. Shyne Barrow, sounded a lot like Lord Ashcroft when he said BTL was buying into "a dying industry", that cable is a "dinosaur." Back in 2021, on his television station, Channel Five, a smirking Lord Ashcroft said, "When you hear things that, ah, Belize Telemedia is thinking of buying cable companies, where cable is a dying industry...you say, what is happening here? Is there a plan?" Lord Ashcroft opined that the best bet Belize had for BTL was to sell it to an international operator to raise much needed foreign currency.

Lord Ashcroft spoke as if he had genuine concern for BTL and the Belizean people, but we have seen that every counsel he gives and decision he makes is calculated to increase the profits of his businesses. Our fortunes and his are not always mutually exclusive, but far too often in our associations with him we end up bust. Claiming to have no financial interest in negotiations that would return BTL to public ownership in 2015, he and PM Barrow concluded a settlement agreement in Miami that included a not insubstantial allocation of funds which Barrow said would be "spent in Belize on charitable projects for the good, welfare and wellbeing of the people of this country." We are yet to see any of these charitable projects.

Returning to Ashcroft's counsel, the management at BTL appeared to be not too interested in it. From the get-go, when he took over the chairmanship of BTL, former senator Mark Lizarraga promised that the company would be exploring every avenue to increase profits for the company's many small local shareholders and the government and people of Belize.



After doing its due diligence, for over a year, BTL decided to acquire ANL. According to *Krem News*, the relatively small and unknown ANL is a "cable company out of the West which offers internet access to Belmopan, Belize City and surrounding areas, (and) provides IP-TV service or internet television via the application SWITCH TV for mobile phones and homes, (an app that is) akin to Netflix..."

Interestingly, Krem News noted that "both the Minister of Public Utilities and the Prime Minister told the media they knew nothing about the purchase ... " The Leader of the Opposition, besides saying the acquisition of cable makes no sense, said BTL paid \$6 million for the company, a price which he considered exorbitant, corrupt. The "sweethearts" at ANL are believed to belong to both of our country's major political parties. That wouldn't be a new thing. Numerous big companies and law firms feature affiliates from both sides of the aisle.

waiting for independent local experts to comment on. The deal has major political implications. For a long time now, much of the fortunes of our main political parties have ridden on the stewardship of BTL. The UDP pulled a very fast one in 2015, when PM Dean Barrow announced a great victory re: the reacquisition of the company, and before the people realized they'd been had, he raced off to the Governor General and called a general election, which his party won. In time the people found out it was a poorly negotiated deal, and in 2020, the next general election, the UDP was obliterated at the polls. Of course, it's little consolation to punish political leaders when they fail.

There will be the inevitable discussions about value for money, about whether our majority publicly-owned telecommunications company made a great transaction or this deal was improper and impractical. Mr. Lizarraga, like former senator, Godwin Hulse, has a big reputation to defend. When the day is done, so much depends on the integrity and competence of the captains we put to steer our various public enterprises.

At the very least, the eyebrows of the owners/managers of local companies that provide internet and content went up when they heard the announcement of BTL's acquisition, for the intent here is for the national company to take a greater share of the market. It is to be seen how much of a win it will be for rank-and-file Belizeans, but if the prime minister's argument for competition holds, there will be benefits coming our way.

On Tuesday, BTL's CEO, Ivan Tesecum, told *Love FM's* Hipolito Novelo that the acquisition is all about "quad play" — BTL creating a one-stop shop of fixed phones, mobile phones, internet, and content (streaming movies). One of the big stories at BTL has been the tremendous fiber optic capacity the company possesses that wasn't being exploited. Tesecum said the entry of BTL into the delivery of legitimate content was "a natural evolution", similar to what other like companies abroad have done and are doing, and it will allow the company to maximize on its fiber-to-home asset.

Interestingly, Tesecum made no mention of cable, which might be an oversight or a decision by BTL that the cable doomsayers are right. There aren't any published statistics on the viewing habits of Belizeans, but BTL's due diligence might have shown it to be different from that of Americans. In the US, cable is trending downward, but it is far from being on life support. Sara Lebow, reporting in *eMarketer* on research done on the viewing habits of people in that country recently, said "among those ages 55 and older, **38%** spend more time watching content on cable than on any other platform", while 40% spent "most of their video viewing time with those digital services." She also reported that 21% of adults between 42 and 55, 16% of adults between 26 and 41, and 9% of adults

There could be positives beside the improvement of BTL's bottom line. The potential for cheaper and better services could be a big win for users of telecommunication products. There is also much room for the production of local content.

Presently, the content on television is predominantly foreign. In the area of Belizean content, the staples for local television stations are limited to talk shows, karaoke contests, and sporting events. There is little investment in the production of documentaries, sitcoms, and movies, largely because they are too costly and private companies are consumed with quick profits. BTL, the national company, has the resources and should have the vision, to invest in content that will advance the culture and cultures of Belize.

As the Prime Minister keeps saying, competition is good. Today, with BTL's expansion, there should be more profits for our company, we should get better and cheaper services, and owners/producers of local content should have a new business on the block vying for their products.


More than 1500 Covid-19 cases

There are now 1,655 active cases in the country

BELIZE CITY, Thurs. June. 9, 2022

The daily C O V I D - 1 9 report issued by the Ministry of Health and Wellness on Thursday, June 9, indicated that 201 more persons have tested positive for the virus, which brings the total number of active COVID-19 cases in the country to 1,655.



While the Ministry of Health and Wellness COVID-19 infographic illustrates a steadily rising number of such cases, it is also notable that in Thursday's report, no new death was reported, but a total of 81 recoveries was recorded. However, there are 9 infected persons hospitalized at the Karl Heusner Memorial Hospital.

The Belize District leads the other districts in the number of new infections, with 90 new cases, followed by the Cayo District with 64 cases, Stann Creek with 24 cases, and San Pedro Town with 10. The Toledo and Orange Walk districts registered 5 cases, and there were three new cases in Corozal.

According to the MOHW's statistics, the positivity rate stands at 18.01%.

Collected data from the MOHW for June 6 to 8 shows that there were 705 new cases, 438 recoveries, and no reported deaths related to COVID-19 over that three-day period.



PC Trapp's and Min. Espat's lawyers face off

An altercation during the Teakettle village council elections between Minister Julius Espat and WPC Alicia Trapp has led one side to call for an arrest and the other to threaten to bring a defamation suit if an apology is not given.

BELIZE CITY, Wed. June 8, 2022 What could turn out to be an extensive legal joust has begun between the attorneys representing WPC Alicia Trapp, a female police officer whose common-law husband was reportedly a candidate in the recent Teakettle village elections, and Cayo South area representative, Minister Julius Espat. Both sides are making serious allegations against the other. The initial allegations were made by WPC Trapp, who claimed in a Facebook live video that Minister Julius Espat had made insulting remarks to her and pointed his finger near to her face on Sunday afternoon in front of a Teakettle village

council election polling station. In a letter sent yesterday to the Commissioner of Police by Trapp's lawyer, well-known UDP attorney Orson "OJ" Elrington, however, the nature of her allegations were notched upward-with references to both verbal and physical assault being made in Elrington's correspondence. The response from Espat and his legal representative, Andrew Marshalleck, SC, was swift. Marshalleck, an attorney from Barrow & Company LLP, has sent a letter to WPC Alicia Trapp demanding an apology for what he and his client call a "patently false" statement that "constitutes a grave



libel upon our client". They have demanded an apology forthwith for Elrington's assertions in the letter to the COMPOL that Trapp was "verbally and physically attacked" and a publication of a retraction statement on her behalf.



The letter issued by Marshalleck states, "While you claim to have several witnesses who are willing to be witnesses to a criminal trial, if necessary, we are to say that our client is in

La inversión de BTL en "contenido": probablemente una gran ventaja para Belize

Al comentar sobre la adquisición de Alternative Networks Ltd. (ANL) por parte de Belize Telemedia Limited (BTL), el líder de la oposición, el Honorable Shyne Barrow, sonaba mucho como Lord Ashcroft cuando dijo que BTL estaba comprando parte de "una industria moribunda", que el cable es un "dinosaurio". En 2021, en su estación de televisión, Channel Five, un sonriente Lord Ashcroft dijo: "Cuando escuchas cosas que, ah, Belize Telemedia está pensando en comprar compañías de cable, donde el cable es una industria moribunda... dices, ¿qué está pasando aquí? ¿Hay un plan? Lord Ashcrof señaló que la mejor apuesta que Belize tenía para BTL era venderla a un operador internacional para recaudar la moneda extranjera que tanto necesitaba.

Lord Ashcroft habló como si tuviera una preocupación genuina por BTL y el pueblo beliceño, pero hemos visto que cada consejo que da y cada decisión que toma están calculados para aumentar las ganancias de sus negocios. Nuestras fortunas y las suyas no siempre se excluyen mutuamente, pero con demasiada frecuencia en nuestras asociaciones con él terminamos en quiebra. Afirmando no tener ningún interés financiero en negociaciones que devolverían BTL a la propiedad pública en 2015, él y el primer ministro Barrow concluyeron un acuerdo de solución en Miami que incluía una asignación no insignificante de fondos que, según Barrow, se "gastarían en Belize en proyectos caritativos para el bien, el bienestar y el confort de la gente de este país". Todavía no hemos visto ninguno de estos proyectos caritativos.

Volviendo al consejo de Ashcroft, la gerencia de BTL parecía no estar demasiado interesada en ello. Desde el principio, cuando asumió la presidencia de BTL, el exsenador Mark Lizarraga prometió que la empresa exploraría todas las vías para aumentar las ganancias de los muchos pequeños accionistas locales de la empresa y del gobierno y el pueblo de Belize.

Después de hacer su debida diligencia, durante más de un año, BTL decidió adquirir ANL. Según *Noticias Krem*, la relativamente pequeña y desconocida ANL es una "compañía de cable del oeste que ofrece acceso a Internet a Belmopán, la Ciudad de Belize y las áreas circundantes, (y) brinda servicio de IP-TV o televisión por Internet a través de la aplicación SWITCH TV para teléfonos móviles y hogares, (una aplicación que es) similar a Netflix..."

Curiosamente, Noticias Krem señaló que "tanto el Ministro de Servicios Públicos como el Primer Ministro dijeron a los medios que no sabían nada sobre la compra..." El Líder de la Oposición, además de decir que la adquisición del cable no tiene sentido, dijo que BTL pagó \$6 millones por la empresa, precio que consideró exorbitate, corrupto. Se cree que los "favorecidos" de ANL pertenecen a los dos principales partidos políticos de nuestro país. Eso no sería algo nuevo. Numerosas grandes empresas y bufetes de abogados cuentan con afiliados de ambos lados del pasillo. Hay cuestiones técnicas y el costo de la adquisición de ANL (cuando se revele), sobre los que estamos esperando que los expertos locales independientes comenten. El acuerdo tiene importantes implicaciones políticas. Durante mucho tiempo, gran parte de la fortuna de nuestros principales partidos políticos ha dependido de la administración de BTL. El UDP nos tomó el pelo en 2015, cuando el primer ministro Dean Barrow anunció una gran victoria en relación con: la readquisición de la empresa, y antes de que la gente se diera cuenta de que los habían engañado, corrió hacia el gobernador general y convocó elecciones generales que ganó su partido. Con el tiempo, la gente descubrió que era un acuerdo mal negociado, y en 2020, en las próximas elecciones generales, el UDP fue barrido en las urnas. Por supuesto, es de poco consuelo castigar a los líderes políticos cuando fallan.

Habrá discusiones inevitables sobre la relación calidadprecio, sobre si nuestra compañía de telecomunicaciones de propiedad mayoritariamente pública hizo una muy buena transacción o si este trato fue inapropiado y poco práctico. Lizárraga, al igual que el exsenador Godwin Hulse, tiene una gran reputación que defender. Al final del día, mucho depende de la integridad y competencia de los capitanes que ponemos para dirigir nuestras diversas empresas públicas.

Por lo menos, las cejas de los dueños/gerentes de las empresas locales que brindan internet y contenido se levantaron cuando escucharon el anuncio de la adquisición de BTL, ya que la intención aquí es que la empresa nacional tome una mayor participación en el mercado. Está por verse cuánto de una victoria será para los beliceños de la base, pero si el argumento del primer ministro a favor de la competencia se mantiene, habrá beneficios en nuestro camino.

El martes, el CEO de BTL, Ivan Tesecum, le dijo a Hipólito Novelo de *Love FM* que la adquisición tiene que ver con "quad play": BTL creando una ventanilla única de teléfonos fijos, teléfonos móviles, Internet y contenido (transmisión de películas). Una de las grandes noticias en BTL ha sido la enorme capacidad de fibra óptica que posee la empresa y que no estaba siendo explotada. Tesecum dijo que la entrada de BTL en la entrega de contenido legítimo fue "una evolución natural", similar a lo que han hecho y están haciendo otras empresas similares en el extranjero, y permitirá a la compañía maximizar su activo de fibra hasta el hogar.

Curiosamente, Tesecum no mencionó el cable, lo que podría ser un descuido o una decisión de BTL de que los agoreros del cable tienen razón. No hay estadísticas publicadas sobre los hábitos de espectadores de los beliceños, pero la diligencia debida de BTL podría haber demostrado que es diferente a la de los americanos. En los EE. UU., el cable actualmente tiene una tendencia a la baja, pero está lejos de estar en soporte vital. Sara Lebow, informando en *eMarketer* sobre una investigación realizada recientemente sobre los hábitos de visualización de personas en ese país, dijo que "entre los mayores de 55 años, el 38% pasa más tiempo viendo contenido en cable que en cualquier otra plataforma", mientras que el 40% pasa "la mayor parte de su tiempo de visualización de videos con esos servicios digitales". También informó que el 21 % de los adultos entre 42 y 55 años, el 16 % de los adultos entre 26 y 41 años y el 9 % de los adultos menores de 25 años aún ven cable.

Podría haber aspectos positivos además de la mejora de las ganancias de BTL. El potencial de mejores y más baratos servicios podría ser una gran victoria para los usuarios de productos de telecomunicaciones. También hay mucho

espacio para la producción de contenido local.

Actualmente, el contenido en la televisión es predominantemente extranjero. En el área de contenido beliceño, los elementos básicos de las estaciones de televisión locales se limitan a programas de entrevistas, concursos de karaoke y eventos deportivos. Hay poca inversión en la producción de documentales, comedias y películas, en gran parte porque son demasiado costosas y las empresas privadas se consumen con ganancias rápidas. BTL, la empresa nacional, tiene los recursos y debe tener la visión para invertir en contenido que promueva la cultura y las culturas de Belize.

Como sigue diciendo el Primer Ministro, la competencia es buena. Hoy, con la expansión de BTL, debería haber más ganancias para nuestra empresa, deberíamos obtener servicios mejores y más baratos, y los propietarios/ productores de contenido local deberían tener un nuevo negocio en la escena buscando sus productos.



The British, of course, are something special. I'm not talking morality: I'm talking diplomacy.

I remember when I was a child here in the 1950s, the British would always enter a British Army team in the Belize City senior football competitions. The soldiers would usually be very good, very organized, totally committed to the team concept, but towards the end of first halves the tropical heat would normally cause them to begin to fade. But I personally can't remember the British players being anything other than gentlemanly, even when they began to lose.

The diplomacy in the process had to do with the fact that the British were, essentially, humbling themselves before us black Belizeans who were, in every single respect, their subjects. The master was bowing down before his servant.

I can't move on in this column without recounting a Stretch Lightburn joke, courtesy of the one Paul Cain. Stretch said that the great Paul Cain said one time that we Belizeans were the only black people in the world who were guarded by white men when we

went to bed. We're talking, again, about the 1950s, when British Honduras was a colony protected from Guatemala by British soldiers.

In the last couple months, I've had sit-downs, separately, with two of my third form Belize Technical College students from the 1968/69 school year. Perhaps I will tell you about these conversations sometime, but the reason I brought up the subject was the controversy which has recently erupted at two Ladyville pre-schools because they were refusing to admit a dreadlocked child to their classes. Both are religiously affiliated schools -Christian.

I believe I got to know the father involved, Kevin Pollard, when we both lived in the First Street area of King's Park (late 1970s, 1980s). Kevin has chosen a road of courage and principle which may lead to problems for his son. I say this because religion is so very, very powerful in the school system of this country, and all responsible parents have their children's education as a primary consideration.

I have said to you before that

Rastafarianism is a religion which emerged in the 1930s in Jamaica with its roots in Garveyism. But I think most Belizeans are reluctant to accept Rastafarianism as a religion.

But I have also said to you before that most of the power of Roman Catholicism, just as an example, comes largely from its superb collection of schools all over the world. When Ignatius Loyola organized the Jesuit order of clerics in the 1540s, his express intention was to use education to fight the Protestant forces in Europe which had the previously invincible Roman church

reeling in countries like England, Scotland, Germany, France, the Netherlands, and so on. In this respect, the Jesuits have been very successful. They are in the vanguard of Roman Catholic missionary work. Incidentally, my second son, Cordel, went to an American university on a half-scholarship from the Jesuits.

The mention of Belize Technical College factors into this essay because Technical was the first government secondary school established in British Honduras. This was in 1952, when we were still a British colony. Technical was fabulously successful.

The school is dear to me because I taught there as my first job in Belize after returning home; my maternal uncle, Buck Belisle, was the viceprincipal there; and his oldest daughter, Georgia, was to have become the Technical principal to succeed Owen Morrison in the early 1990s until party politics intervened. Oh, and my oldest son, Mose, is a Technical high school and Sixth Form graduate.

Technical's incredible success was of concern to the Roman Catholic hierarchy, so much so that the legendary Fr. Leo Weber, S. J., the

boss of St. John's College, opened a vocational section at SJC in the early 1960s. But that was just educational competition, I presume. I now sincerely believe that Technical incurred the wrath and hatred of the People's United Party (PUP) when Socorro Bobadilla led Technical students on a citywide rampage which closed down all the Belize high schools during the Heads of Agreement uproar in 1981.

The incident has never been properly investigated, but recently what I got to understand was that the

Technical administration and staff did not intervene to prevent Socorro from leading the insurrection. This would never have happened at any of the religious schools in Belize.

We can't deal with this subject adequately in a newspaper column. I surely admire Kevin for his courage and principle. Courage, I say, because we know the Romans used to feed Christians to lions.

In other words, courage can be a problematic proposition. I worry about the implications for his son. I saw what the power structure in Belize did to Technical. I still don't believe my eyes.

Los británicos, por supuesto, son algo especial. No estoy hablando de moralidad: estoy hablando de diplomacia.

Recuerdo que cuando era niño aquí en la década de 1950, los británicos siempre metían un equipo del ejército británico en las competencias de fútbol senior de la Ciudad de Belize. Los soldados solían ser muy buenos, muy organizados, totalmente comprometidos con el concepto de equipo, pero hacia el final de las primeras mitades el calor tropical normalmente hacía que comenzaran a desvanecerse. Pero personalmente no puedo recordar que los jugadores británicos fueran otra cosa que caballeros, incluso cuando comenzaban a perder.

La diplomacia en el proceso tuvo que ver con el hecho de que los británicos, esencialmente, se estaban humillando ante nosotros, los beliceños negros, que éramos, en todos los aspectos, sus súbditos. El amo se inclinaba ante su sirviente.

No puedo continuar en esta columna sin contar un chiste de Stretch Lightburn, cortesía de Paul Cain. Stretch dijo que el gran Paul Cain dijo una vez que nosotros, los beliceños, éramos los únicos negros en el mundo que estaban protegidos por hombres blancos cuando nos acostábamos. Estamos hablando, nuevamente, de la década de 1950, cuando Honduras Británica era una colonia protegida de Guatemala por soldados británicos.

En los últimos dos meses, tuve reuniones, por separado, con dos de mis estudiantes de tercer grado del Colegio Técnico de Belize del año escolar 1968/ 69. Tal vez les hable sobre estas conversaciones en algún momento, pero la razón por la que mencioné el tema fue la controversia que estalló recientemente en dos escuelas preescolares de Ladyville porque se estaban negando a admitir a un niño con trenzas rastas en sus clases. Ambas son escuelas afiliadas religiosamente: cristianas.

Creo que conocí al padre involucrado, Kevin Pollard, cuando ambos vivíamos en el área de First Street de King's Park (fines de los 70, 1980). Kevin ha elegido un camino de valentía y principios que puede traerle problemas a su hijo. Digo esto porque la religión es muy, muy poderosa en el sistema escolar de este país, y todos los padres responsables tienen la educación de sus hijos como una consideración primordial.

Les he dicho antes que el rastafarianismo es una religión que surgió en la década de 1930 en Jamaica con sus raíces en el garveyismo. Pero creo que la mayoría de los beliceños son reacios a aceptar el rastafarianismo como religión.

Pero también les he dicho antes que la mayor parte del poder del catolicismo romano, solo como ejemplo, proviene en gran parte de su magnífica colección de escuelas en todo el mundo. Cuando Ignacio de Loyola organizó la orden jesuita de clérigos en la década de 1540, su intención expresa era usar la educación para luchar contra las fuerzas protestantes en Europa que tenían a la anteriormente invencible iglesia romana tambaleándose en países como Inglaterra, Escocia, Alemania, Francia, los Países Bajos y demás. En este sentido, los jesuitas han tenido mucho éxito. Están a la vanguardia de la obra misionera católica romana. Por cierto, mi segundo hijo, Cordel, fue a una universidad estadounidense con una media beca de los jesuitas.

La mención del Colegio Técnico de Belize es un factor en este ensayo porque el Colegio Técnico fue la primera escuela secundaria gubernamental establecida en Honduras Británica. Esto fue en 1952. cuando aún éramos una colonia británica. El Colegio Técnico tuvo un éxito fabuloso. Ah, y mi hijo mayor, Mose, se graduó de la escuela secundaria y de sexta forma del Colegio Técnico.

El increíble éxito del Colegio Técnico

preocupó a la jerarquía católica romana, tanto que el legendario p. Leo Weber, C. de J., el jefe del Colegio San Juan (SJC por sus siglas en inglés), abrió una sección vocacional en SJC a principios de la década de 1960. Pero eso fue solo una competencia educativa, supongo. Ahora creo sinceramente que el Colegio Técnico provocó la ira y el odio del Partido Unido del Pueblo (PUP) cuando Socorro Bobadilla dirigió a los estudiantes del Colegio Técnico en un alboroto en toda la ciudad que cerró todas las escuelas secundarias de Belize durante el alboroto por el Preámbulo de Acuerdo en 1981.

El incidente nunca ha sido debidamente investigado, pero recientemente lo que llegué a entender es que la administración y el personal del Colegio Técnico no intervinieron para evitar que Socorro liderara la insurrección. Esto nunca hubiera sucedido en ninguna de las escuelas religiosas de Belize.

No podemos tratar este tema adecuadamente en una columna de periódico. Seguramente admiro a Kevin por su valor y principios. Valor, digo, porque sabemos que los romanos solían alimentar a leones con cristianos.

En otras palabras, el valor puede ser una proposición problemática. Me preocupan las implicaciones para su hijo. Vi lo que la estructura de poder en Belize le hizo al Colegio Técnico. Todavía no puedo creer lo que ven mis ojos.

Fisherman charged over \$150,000 for Fisheries violations!

A fisherman who was ordered in the Magistrate Court to pay a total of roughly \$150,000 for fishing violations, said that he only did it to pay outstanding school fees for his kids.

BELIZE CITY, Wed. June 8, 2022

On Sunday, June 5, the Belize Fisheries Department, along with the Belize Coast Guard, successfully conducted two major busts at Lighthouse Reef and Glover's Reef respectively-both of which involved the discovery of prohibited catch in the possession of fishermen who, in the case of the two men found at Glover's Reef, had ventured into protected areas where they should not have been fishing. In total, five fishermen were detained and were facing a raft of charges for a number of fishing offenses, for each of which they would have to pay a fine.

The final tally for the long list of offenses was staggering-over a hundred and fifty thousand dollars for one of the men.

On Tuesday, June 7, the three fishermen who were caught out at Hat Caye, along the Lighthouse Reef-38year-old Leroy Samuel Ruiz, 26-yearold Denielle Anselmo Solis, and 28-yearold Wilbert Omar Rivas, were arraigned in the Magistrate's Court in Belize City and were read five fisheries offenses jointly.

The charges read to the trio were for possession of Nassau Grouper fillet (1 count), possession of fillet fish without a skin patch (1 count), and possession of prohibited fish (3 counts) - which included 12 angelfish, 12 triggerfish, and

76 parrot fish.

Only one of the theee men, Leroy Ruiz, would take responsibility for all the offenses, however-thus paving the way for the charges against the other two (Rivas and Solis) to be withdrawn. Ruiz, after pleading guilty to the offenses, told the court that his desperate need to pay outstanding school fees for his children had driven him to commit what he had known were violations of the current Fisheries laws.

Because it was Ruiz's first offense, the magistrate fined him \$10,000 for each

of the five listed offenses, which, together with the \$5 cost of court fee for each offense, totaled \$50,050. To this was added a fine of \$100 each for the grouper fillet, a \$3,400 fine for the 68 fish fillets without the patch, \$24,000 for the angel fish and triggerfish, and \$76,000 for the parrot fish, which had all been found in a white crocus bag on the boat in which the men had been fishing. In total, Ruiz will thus have to pay a fine of \$153,525 between September 30 and



Fish confiscated

December 3 of this year if he is to avoid a 9-month prison sentence that he would have to serve in lieu of payment. It is also possible that, if he fails to pay the fines, the authorities will seize his personal property, including household items of his, to cover the amount he has been ordered to pay.

After the charges against Solis and Rivas were withdrawn by prosecutor Calmam Hall, however, they were free to leave the court.

BDF's Camp Belizario gets refurbished kitchen

CENTRAL FARM, Cayo District, Tues. June 7, 2022

A ceremony was held on Tuesday, June 7, to mark the completion of the refurbishment of the kitchen at the Belize Defence Force's Camp Belizario in Central Farm, Cayo District, which had been in a state of disrepair for almost two years.

Minister of National Security, Hon. Florencio Marin, Jr., told local reporters that the renovation project began in November of last year.

"... The overall structure was good so we basically just needed to clean it out inside, but we cleaned it up so that it is clean and it is [healthy] for our soldiers to be in a good environment. I believe they had to refix the roof. I saw a video where it was coming down. It was just really horrible. We couldn't have our soldiers eating out of this kitchen. Thankfully, now, we have something good that they could have a decent meal," stated Minister Marin.

Lt. Col. Jermaine Burns, Commanding Officer for the 2nd Infantry Battalion for the BDF, also noted, "The makeshift kitchen that we had in place to feed the men wasn't close to as large as the space. So the first thing is the expansion of the area that we will be feeding the men and providing meals from. We were using a very small building at the back of this same existing building. The building gives us the opportunity now to do our butchering, our storage, our dining, and preparation of the meals all in one. And it still has extra offices for our quarter masters that administrate approximately ninety men at a time with their goods and services that they require with respect to logistics," said Burns.

Additional renovations to other buildings on the grounds will also be carried out through a loan from the Central American Bank for Economic Integration (CABEI).

"We have an unlimited amount of work that we need to get done-the office headquarters, the medical center that is in the background, the communication center, and definitely we have the sleeping quarters of the soldiers. We just need to tackle them one by one, and when the economy grows, and suddenly we can do it at a more accelerated pace," said Minister Marin.

The cost of the refurbishment of the Camp Belizario Kitchen is estimated to be a little less than \$100,000.

In exercise of the powers conferred upon it by the Public Utilities Commission Act, the Water Industry Act, the Water and Sewerage (Tariffs) Byelaws, and all other powers thereunto enabling, the Public Utilities Commission (hereinafter referred to as "the Commission") hereby notifies the general public that it has made and issued the **Belize Water Services Limited (BWSL) 2022 Annual Review Proceedings Initial Decision** (hereinafter referred to as "the Initial Decision").

On May 3, 2022, BWSL made a submission for an Annual Review Proceeding under Article 27 of SI 67 of 2002 citing that they faced Exceptional Circumstances in its execution of its Business Plan with the financial effects caused by COVID-19. In its Submission, the Company claimed that rising input prices and lower sales revenues had resulted in an accelerating in the Mean Water Rate (MWR), and therefore requested the Commission approve an increase in revenue yields of 5% by changing the tariff structure and adding a fixed charge to non-residential customers.

On June 2, 2022, the Commission made an Initial Decision, accepting the condition of Exceptional Circumstances as presented by BWSL, but made a determination that BWSL has scope to grow its business and lower its cost structure thereby maintaining the MWR below the currently approved \$17.49 per 1,000 gallons. Therefore, the Decision of the Commission is that the Tariffs, Fees and Charges levied by BWSL will remain unchanged for the period April 1, 2022 to March 31, 2025.

evening shows a badly damaged front portion of a white SUV (a Toyota RAV 4) that was supposedly being driven by Garcia in the middle of the road. A bus with a severely damaged rear bumper, also parked on the road, is also seen. (Some media reports are indicating that the Toyota RAV 4 hit the bus while attempting to overtake it.)

The UDP also took the opportunity in its press release of accusing COMPOL Williams of politicizing his office in an effort to seek the favor of the ruling party.

"The chair of the Commissioner of Police should be no seat for a political puppet auditioning to masters for an electoral run. It is no wonder why morale in the Police Department is at an all-time low," the UDP release stated. Commissioner Williams, however, in contrasting the manner in which the accident involving Garcia was handled with the way an accident last week that involved the UDP's OJ Elrington was dealt with, noted that all procedures were followed in the case of Garcia's accident. After being asked by a reporter if a urine sample had been taken from Garcia, COMPOL Williams said, "I can say that all the procedures regarding accidents were followed in that particular instance, as opposed to when OJ crashed and the procedures were not followed. In this case all were followed, and Mr. Garcia has been arrested and charged in respect to that accident."

John Has Big Dreams

John is a young adult who comes from a very humble and poor family. He is trying to survive. He has big dreams. Someday, he would like to be a doctor, an engineer, or an architect. He looks around him and sees so many well-dressed people with nice cars. He walks the streets and sees beautiful buildings, houses where people from the elite class live, and poor John thinks to himself,

"What can I do to at least have a roof over my head where I can rest and water doesn't come in when it rains, or the sun doesn't peek through the cracks in the mornings and the overbearing heat at noon where I have to leave so early because, well, I can't stand being in my shack so hot. What am I going to do to get a good job

and not be getting a little thing from here to there, sweeping the street, removing mud from places, or chopping a place where they don't pay me more than a few cents, since labor is so cheap?"

While John was working, he met a man who had asked him to do his errands, and John, a young man, although poor, badly dressed, was honest, and one day he asked the man, "What could I do to improve my living conditions?"

The man told him, "My son, you need to study."

John: "But how am I going to study when I don't even have elementary school?

The man: "Look, there are some good schools here in Belize where

you can study for a degree, and once you have your certificate or diploma that you are a qualified person in the degree you decide to take, you are going to earn very good money."

And John says, "How do I come in? The man replied, "Well, go raise your money, save it and when you have enough you apply to be accepted in the school of studies."

Well, John did what the man had told him. He obeyed, took into account and began to raise his little money. But to do that he had to stop eating what he ate, which was almost nothing, and he decided to eat tortilla with salt, and some pepper to give it a little flavor with a bottle of water, but it wasn't one of those purified bottled waters that they sell now. No, it was just any old bottle, and he would refill it at a faucet one way or another, that is. He didn't have the means to buy purified water, so he filled the bottle wherever he could, and with that he ate, supported himself, raised his little money until he had the amount to enroll in this very renowned school.

He was finally able to submit an application, which was accepted, and he was able to start studying. He continued doing the little jobs that he always did, and little by little he paid until he finally graduated. He felt happy and finally said to himself, "I have achieved my dreams." The government had made a salary table, and his salary as a specialist in his career was \$100 an hour, since the minimum wage was \$5 an hour and he, as an engineer, obviously already a specialist, also qualified at such a renowned institution, well-known throughout the world; damn, that is the official salary that he should receive. Poor John did not know that there was another school around the corner that gave a certificate to do the same work that he did, for which persons were paid \$10 an hour.

And there you have John, looking for a job, and nobody wants to hire him because he is very expensive; they have to pay him \$100 an hour; it is impossible. But he was lucky enough to be hired by the government. Well, yes, the government obviously has a lot of money, with the people's taxes, and he was well-compensated, oh yes. But how many of those Johns are there with certificates? Are they all going to work with the government? They won't fit. They do not fit. Thousands upon thousands with their Bachelor's degrees, their doctorates, and their Master's degrees—they don't fit in government. It's not possible. The government doesn't make that much money for that. Could it be? Well, there they are without work. But that person who has his certificate where he earns \$10 an hour, had a job. So much so, that he was able to go to work with a person who earned a salary of \$5 an hour, and that person was able to save \$20 of his salary to pay two hours of work to the \$10 qualified person to do the same job that the engineer would do that



charged \$100 an hour.

What kind of world is this right? So many speeches are heard which are so convincing, whereby we believe. All that is true is that there is hunger: 60 percent of the people of Belize are messed up, are suffering. They do not have a job, they do not have a way to support themselves, and this is not something that has just recently been happening. This was from before the pandemic. Poverty is immense in Belize, very immense. And there are investments here and there, investments that the banks give, investments from such and such a country which donated an amount of money for this and that, so much money that they donate, so much money here and there, so many loans that they make, but, where is it? Where is it? People are still hungry; there are no jobs; smuggling continues.

There are PUP smugglers, there are UDP smugglers, and so on. You change the government, there are smugglers from that government; you change to the other government, there are smugglers from that other government. It's just that. Nothing more. The other had 13 years, that's good. Hopefully those who had the opportunity got rich. How many years is this one going to get? Who knows, but let those who are close to them take advantage, because, well, once they no longer have money, they no longer have a job. Once the people kick them out, well, it's over. I mean, what's the use of a role that makes you an engineer or an architect or a doctor or whatever, if there's no work. There isn't.

There are no medications. How many people complain, how many people are asking for assistance to buy medicine, because there aren't any? Of course, they are in pharmacies for sale, but they are very expensive; it is for people who have the money to buy. How do they do that? Who knows. But there is no Tylenol for children or adults at the public clinic. What? Don't these people have the right to live? What are they talking about? Sometimes I wish they would explain themselves better, because they are not understood. They speak a language that who knows what it is, both one and the other, cannot be understood. Forty-one years of independence, and there is still immense poverty. It's not only in Belize, it's worldwide. And don't tell me that 'Russia is to blame': please don't talk nonsense. Enter into history and you will realize what the human being is. That's where the answer to any question is. The past tells us what is in the present, and the present shows us the face of the future.

COMPOL points

to lull in crime

BELMOPAN, Tues. June 7, 2022 At a police press briefing held on Monday, it was the Commissioner of Police, Chester Williams, rather than Police Department's the Communications Director, ASP Fitzroy Yearwood, who addressed members of the media, and the Police Commissioner took the opportunity to highlight a recent lull in weekend crime that he attributed to efforts made by the Police Department and the Leadership Intervention Unit (LIU) to reduce gun violence in the city.

"Certainly, there is a lot being done by the police. And as you know, we have the multi-sectoral approach to fighting crime, where we now have the input from different organizations, particularly on the Southside of Belize City. We also have the ongoing basketball tournaments for the different groups in Belize City, and the Belize District, by extension. And we believe that the efforts of everybody on the ground, including the police officers who are policing the different areas, are bearing fruits," Commissioner Williams said.

He then added, "We're not going to celebrate as yet. There's still a lot of work to be done. There are still many ongoing tensions with different groups in the city that we try to deal with. But what we try to do as best we can is to utilize the LIU in conducting interventions. As we hear of some issues between two different parties or a group, then we would normally send LIU to bring them to the table, see what the issues are, and try to resolve them."

He pointed as well to other initiatives that are in the pipeline: "In the near future, we're looking at taking some of these guys to Punta Gorda Town for somewhat of a retreat. And then, we're also going to sign very shortly the MOU between the police and a private citizen with respect to twenty-five acres of land by the Rhaburn Ridge Area that will be used for farming by these young men again. And then we have the activity we were planning for Mountain Pine Ridge with them. So, there's a lot we're doing with these youths with a view to see if we can bring them to the table and try to diffuse their issues in a way that is not going to bring violence, as opposed to them taking a gun and try to resolve issues, when in fact that only make the issues worse," said COMPOL Williams.

Belize celebrates its barrier reefs 10,000th birthday

World Oceans Day, June 8, falls in the middle of a week-long celebration of the UNESCO World Heritage Site's 10,000 years of existence.

BELIZE CITY, Wed. June 8, 2022

The Ministry of Blue Economy & Civil Aviation, along with the World Wildlife Fund (WWF), has been celebrating the 10,000th anniversary of the formation of the Belize Barrier Reef with a week of special programs and events, which included a World Oceans Day Expo held on June 8 at the Buttonwood Bay Park in Belize City.

World Oceans Day is celebrated annually on June 8. Nadia Bood, Senior Program Officer at the WWF Mesoamerica, spoke with AMANDALA about the significance of such a day and the importance of promoting the preservation of Belize's marine environments.

"Today we're doing this expo to showcase our marine environment—our reef system—and the goods and services that it provides to our country," she said.

Bood explained that the World Oceans Day Expo provides an opportunity for the Government of Belize, conservation NGOs, and businesses whose livelihoods are tied to the barrier reef to interact with members of the public, raising awareness about the important role that oceans—and the reef—play in the lives of everyone on the planet, which is an effort that could ultimately bring about change.

Oceans, which make up over 70% of

the planet and produce over 50% of the world's oxygen, are becoming increasingly threatened by the effects of climate change, pollution, acidification, and reduction in biodiversity. By raising awareness about all the ways in which humanity is reliant on the oceans, and promoting the increased implementation of sustainable practices, Bood said, we can continue to benefit from the environment in the long term.

"We want to continue to benefit from our marine resources, and to be able to do so, we need to engage the public; we need to engage the stakeholders that are dependent on these ecosystems to let them know that, together, we can make this happen for the long term," she stated.

Opening the day's events was the Director of Blue Economy, Maxine Monsanto, who shared the theme for this year's World Oceans Day: "Revitalization: Collective Action for the Ocean". She also highlighted some of the goals of this year's celebrations, which include gaining a better understanding of the importance of the oceans as well as raising awareness about the importance of Belize's marine environment.

The expo featured booths from various conservation and marine protection organizations such as Oceana Belize, the Belize Audubon Society, the Coastal Zone Management Authority & Institute (CZMAI), the Belize Fisheries Department, and the Wildlife Conservation Society


Two other events that were a part of the Belize Barrier Reef's 10,000th birthday celebrations

was a gala held under the theme "A Night Under the Sea" on Friday, June 3, and a Family Fun Day in Placencia on Sunday, June 5. The final event will be a Sargassum Community Beach Clean-Up on San Pedro, Ambergris Caye, this Friday. The Belize Barrier Reef, approximately 185 miles long, was made a UNESCO World Heritage Site in 1996 as a result of its

physical and cultural significance. In 2009, the reef was at risk of losing its status after being placed on the UNESCO List of World Heritage in Danger sites but was removed from that list almost a decade later due to a series of conservation efforts which included an imposed moratorium on offshore drilling and oil exploration in Belize.

In the interests of academic accuracy, I simply must point out to those of you who are serious readers that the section of Peter Ashdown's article ("The problem of Creole historiography") which was reproduced on pages 28 and 29 of last weekend's issue of this newspaper is only that -- a section. (The original article stretches from pages 142 to 152 of the Second Edition of READINGS IN BELIZEAN HISTORY, a May 1987 St. John's College publication.)

I chose not to reproduce the entire article, thus making it mandatory for serious readers to do their own research, because at one point Ashdown criticizes a prominent Belizean personality (now deceased), and I think that if this newspaper published the entire article, it would open an old UBAD wound.

Now, of course, the younger Belizean generations have heard almost nothing about UBAD, and I'm not going to try to educate them in this column, for different reasons.

I will say this, however, that after all these fifty years, I have come to the conclusion that when the UBAD riot of May 29, 1972, threatened to become an outright insurgency, as president of the organization I should have acted in a more proactive manner. I should have put down my foot, because my instincts told me at the time that it was time for us to disperse, to disappear. I had too much respect for the officer who had become inflamed, and chose to go about the business of taking some of the Miss Afro Honduras candidates to their homes in an automobile. In retrospect, I gave up my leadership that night, and, also in retrospect, that was the beginning of the end of UBAD.

In February of 1970, a situation which


was somewhat similar had developed with respect to UBAD Minister of War, Charles X "Justice" Eagan. He was twice my age, and much more experienced in the streets than I. The seditious arrests of myself and the late Ismail Shabazz had suggested to me that the ruling People's United Party (PUP) had raised the stakes of the quarrel between us to a point where my book learning/training would become somewhat irrelevant.

Whatever, Justice became the de facto UBAD leader. Justice, myself, and Charles X Stamp ended up being tried in the Supreme Court in January of 1971. X Stamp and I were acquitted, but Justice went to jail.

I want to end this short column by saying to the attorney Godfrey Smith, who is not and has never been my friend, that his research into the devastating tragedy which ended the people's revolution in Grenada in 1983 is of massive importance. I give credit where credit is due.

What happened in Grenada, a small Eastern Caribbean island and former British possession which was the site of the only successful black power rebellion in the 1970s (1979), is that the two major leaders, Maurice Bishop and Bernard Coard, ended up in a violent confrontation. Bishop was slaughtered by machine gun fire, the United States invaded, and Coard spent decades in jail.

In 2022, as we Belizeans face the potential trauma of this International Court of Justice (ICJ) hearing in the months and years ahead, the pressure on our various leaders will be immense. This ICJ faceoff with Guatemala is serious business, and we can see now, 2022, that regional white power rules almost absolutely in these parts. Belizeans, we have a problem.



Water taxi fares are up!

BELIZE CITY, Wed. June 8, 2022

Persons who use water taxis to travel to and from the cayes—whether for a recreational outing or for work purposes etc.-will now find themselves paying up to 50% more than they had previously been spending to cover the cost of traveling to or from the islands, since the Belize Port Authority has finally authorized an increase in the cost of both oneway and round trip tickets for water taxis this month-after it had blocked earlier attempts in March by water taxi operators to up their rates. According to Port Commissioner Major H. Gilbert Swaso, the increases, seen at both major water taxi operators, are the direct result of rising fuel prices.

Readers will recall that back in late March some operators attempted to raise boat fares but were prevented from doing so after the Belize Port Authority (BPA) issued a release stating that those price hikes were "unlawful and illegal".

This week, Swaso explained to local reporters that such a move was made by the BPA because those operators

were increasing their fares "arbitrarily". Subsequently, however, those operators submitted formal requests for an increase in passenger fares which have since been approved by the BPA and took effect on June 1.

And while the new prices, which include what Swaso has labeled a fuel surcharge, are not permanent, they are expected to increase and decrease based on the local market prices of fuel.

With the newly approved increases, a roundtrip ticket from Belize City to San Pedro, originally \$55, will now cost travelers a total of \$79 while the price of one-way tickets has gone up from \$31 to \$41. Persons traveling from Belize City to Caye Caulker will now have to pay \$61 for a roundtrip ticket with Caribbean Sprinter (formerly Ocean Ferry) and \$59 with San Pedro Belize Express as opposed to the previous \$37-increases of around 60%.

According to the Belize Port Authority, official personnel will be sent to the various water taxi terminals to ensure that operators are compliant and also that passengers are not being overcharged.



possession of photographs and video of the surrounding events showing your behavior and indeed has witnesses in the hundreds willing to testify that there was in fact no such verbal or physical attack by our client."

As was reported in the Tuesday issue of the AMANDALA, in the Facebook live video, Trapp, who was dressed in civilian clothing at the time, claimed that she was approached by Espat, who attempted to scold her for her wearing a red shirt and being under a tent with UDP supporters. Trapp went on to assert that she was approached because of the color of what she was wearing, a red sports shirt which bore no printed insignia or message that indicated a UDP affiliation. She said that as a police officer of 9 years, she felt ashamed and disrespected.

"Mr. Julius Espat came to my face and pointed and tell me I cannot be [expletive] there underneath the UDP tent. What's wrong with this minister, ah? First Abelardo Mai disrespected Mrs. Tracy Panton; now this next minister wah come and disrespect me just because I da wa police officer and I inna civilian clothes? And he tell me I can't wear no red shirt. What is wrong with him? I can wear any color I choose to, and even if I mi want wear wa white or wa blue shirt, I know who I will vote for. Da none ah his business that," WPC Trapp said during her live video, in which Espat could be seen a stone's throw away.

However, this week, when interviewed by *7News*, Espat gave a slightly different account of the events that took place that day and in fact indicated that it was WPC Trapp who was initially the aggressor.

"We were out there. There are two tents out there, as you're aware of how politics happens. You had the UDP tent, which she was under, and you had the PUP tent where we were. A supporter of ours came up and took a picture of her, and I was beside him. She saw him and took a picture of her. She walked up to us and aggressed us and said, 'Why are you taking a picture of me?' And a conversation started. It was seconds, and then, it ended. Then all of a sudden, this thing [got] blown out of proportion, with so many cameras out there, so many people there. Every single movement that is made, if it was such, an issue would have been caught on camera. It's not like you have to go buy a large Panasonic camera, these days. Every phone has a camera on it. And so, she did notwhen she made her statement to the police is recorded, she did not say it was physical abuse. Now, today, her attorney is saying it's physical abuse ...," stated Minister Espat.

He further commented, "The only thing I could say ... is when you start a lie, you have to continue lying. I

was surprised today when I saw a letter written by her attorney and to the Commissioner of Police. It was sent to me by various media houses. In that letter, she alleges that I verbally and physically abused her. But you have to go back to what happened when she was doing a live broadcast of the event, which was supposedly seconds after we had our conversation. And in that live, if you go through it step by step, there is absolutely no mention of any physical abuse. And so, all of a sudden now, a physical abuse allegation comes up. This is not something that was held behind closed doors. This was something that was held in front of hundreds of people. There were police officers out there. Everything is there. So, I am now forced to have my attorney deal with the situation and I will. I will take it all the way because they have now gotten to the point of defaming my character, and that is important."

And indeed a letter was sent promptly by Hon. Espat's attorney to the Commissioner of Police, Chester Williams. In the letter, Marshalleck requested an update on the investigation into the allegations made against Espat by WPC Trapp, since a formal report was made on Sunday evening with allegations of assault and battery against Espat.

The Commissioner of Police, Chester Williams, also received a letter from Trapp's attorney, OJ Elrington, who in that piece of correspondence, challenged Commissioner Williams' assertions that the Public Service Regulations forbade WPC Trapp from openly participating as a UDP party supporter at the village council elections, and that she would be disciplined for those actions and for breaching the police social media policy by making public comments via a Facebook live video after the supposed altercation. (Those comments were made by Commissioner Williams at a police press briefing on Monday.)

Elrington in his letter posited that the COMPOL, by making those comments, misinformed the public, and he indicated that any attempt to punish his client would be met with "swift legal action," since, he said, it would amount to a direct breach of her constitutional rights.

Elrington is contending that the set of rules to which his client, a junior police officer, is subject, is laid out in the Police Act and not the Public Service Regulations, as stated by Williams during an interview with local media. Williams has actually confirmed that there are regulations in the Police Act that outline the code of conduct required of police officers like Trapp, but he pointed out that there are provisions in that legislation that bar police officers from involvement in political activities.

According to Commissioner Williams, going live on social media for political reasons amounts to a "major offense" according to subsections 1(a) and 2 of Section 24A of the Police Act.

Section 24A 1(a) states that no police officer shall "in any public place or in any document or via any social networking website or other medium or means of communication, whether or not within Belize, publish any information or express any opinion on matters of national security interest or with national or international political implications."

Elrington's justification of Trapp's behavior, however, hinges on his focus on subsection 24A 1(b)l, which appears to suggest that officers are only barred from holding official roles and cannot be barred from being a supporter of a political party.

Subsection 24A (1) is subject to subsection (3), which states that police officers may depart from section 1 if they are acting on official instruction in the execution of their duties, or if the information is published as a lecture approved by the Commissioner of Police given at an educational institution, or an article approved by the Commissioner.

While legal debate is ongoing about whether Trapp violated the regulations governing the conduct expected of a police officer, and whether she should be subject to disciplinary measures for any such violation, the United Democratic Party is calling for a more severe type of punitive action to be taken against Hon. Espat. The party is in fact calling for charges to be brought against him, and for his arrest. A press release issued by the UDP yesterday states, "It has now been more than 48 hours since the report was filed and still no charges have been levied against Espat. To add insult to injury, the police officer assaulted by Julius Espat is now facing disciplinary action by Commissioner Williams while the alleged abuser has not even been approached by police." It added, "Police officers are constantly being abused by PUP politicians and their goons with no support from the Commissioner."

FOOTBALL IN BELIZE — THE SAME OR WORSE SINCE BERTIE CHIMILIO

an article that was published in Caribbean Life newspaper about the state of football in Belize under the management of the then FFB president Bertie Chimilio and the problems FIFA was having with bribery to vote for their representatives. Since Chimilio left the scene about eleven years ago, the football situation has not improved much, and some can argue that it has gotten worse. All the presidents who replaced him made several promises, to improve the quality of football that is being played in our country, but they have failed to do so. The challenge for our country of Belize is to still develop a football team that can play football competitively in the region and the international arena to

compete and win a World Cup.

The FIFA organization was able to recover from their scandals and concentrate on football development in the countries that are FIFA members. They got rid of most of the incompetent officials who were elected because of payoffs and bribes to get votes from their organizations. Some of them had little experience, expertise, knowledge, or love and passion for the sport of football. All they were interested in was the money that FIFA gave them to manage the sport in their respective countries. For the football players, former football players, fans, business sponsors, supporters and the Government of Belize to allow FFB to continue running football in Belize the way they are managing it and expect better results is wishful thinking. Nothing will change unless we all come together and demand some drastic changes in FFB. Problems remain in league elections,

competition, high school competition, college/university competition, inter-district competition and the methods in selecting a national team.

Our government of Belize cannot wait for FIFA to discipline their officials before they plan for the improvement of football in the country. The Minister of Sports must become proactive and get himself involved in this process. I think the Minister should formulate a Sports Commission, to examine the problems with all sports in Belize. At the conclusion of their findings, they will be asked to make recommendations to our country, as to what we can do to improve our quality of sports.

Over the years, judging from my own experience when I played football in Belize, selecting a national football team was always unfair. Many of the people who were chosen to represent the country, were not selected because of their abilities and capabilities. A majority of them were selected because of favoritism. A selection committee should be formed that will be empowered to manage this process.

Through their committee, they can select three of the best players for each position and send them to the training camp to compete among themselves for the positions. However, they must bear in mind that some of our country's rated players are out of the country playing and must be allowed to meet their contractual obligations, but as Belizeans these players should be given the opportunity to participate in the process to represent our country.

In the United States there are many Belizean American players, in a wide range of sporting fields with excellent training, talent, experience, and professional skills. I am not too sure about the new way in selecting our country's national football team. I was told that over the years the country used the team that won the national football tournament as the core team. Then they added other players from several teams to make up the national team. I am opposed to this method and prefer when a national committee is formed, to select three of the best players countrywide for each position. They will then subsequently attend training camp to compete among themselves for the positions. Belize has six districts, with each one having a president and committee members who are familiar with the players. Among themselves they should be able to formulate the rules and regulations for selecting the best players for each position in their districts. In addition they could also consider having the fans vote for the best player for each position in the country. This could make the selection process look more transparent, like what is done in the United States for some sports. The government of Belize will have to start soliciting funds for this project, and I am more than convinced that many diehard football fans, businesses, former football players and others will be glad to contribute towards this worthy cause. Sports can be a way to generate employment and income in our country.

For that to occur, we must change our views about it and organize the way the games are being played. We can no longer afford to look at sports from an entertainment perspective only, but as a business also. This is a golden opportunity for the Minister of Sports to demonstrate how serious he is. If he waits too long, he will give the FFB the opportunity to regroup, mobilize and continue to control football in the same fashion in Belize with little success. Since Chimilio left FFB, the organization has received millions of dollars to improve football, but nothing much has improved. I was informed that they even received money to establish a Belize Football Hall of Fame (BFHF) for our players, and they have not done it. If they have failed to show appreciation to our players, then they are not serious, in my opinion. When you are spending more money and you are not getting much return on the money you spend, it is time to rethink about the way you are conducting your business.

The Belize football national team is yet to qualify for the Second Round in the World Cup qualifying games. We are still in the doomsday scenario of football in Belize. Belizeans have been waiting too long to see a high-caliber football team represent their country. The recent failures for Belize to qualify for the World Cup and the CONCACAF tournaments, give us a golden opportunity to change the way football business is being conducted in our country. I am now calling on the Minister of Sports to use his power and act. This chaos and confusion over football in Belize must come to an end, if we are to have any future in this sport.

Youth Services Department launches fatherhood skills training program

On Monday, June 6, the Department of Youth Services, in partnership with the Leadership Intervention Unit (LIU), launched a fatherhood training program, which is aimed at providing participants with key skills and insights that will enable them to be better fathers.

A group of 30 at-risk young men, many of whom did not grow up in a household in which their father was present, will be the first set of program participants and will be taught about the various roles that a father should play in his children's lives and how to effectively carry out the duties of a father.

Kevin Dawson, Director of the Leadership Intervention Unit, in his comments at the launch of the program, highlighted the purpose of the workshop and noted the critical role played by a parent, particularly a father.

"This workshop is not to suggest that the guys we're working with are not good fathers, but what we want them to do is to understand the nature and responsibility

of being a parent. I'm hoping that there are some tips that they can gather from this workshop that they can use in their everyday lives so that they can improve the relationship with their children," he said.

He further remarked, "... there is a stigma that surrounds these young men in terms of gang violence, and so we want them to understand that where their children are concerned, there must be a level of responsibility and concern that cannot have their families involved in whatever their everyday lifestyle is that will affect them either by going to prison or dying or getting affected by violence in the streets and family comes first; that's the key thing."

Kevin Cadle, Director of the Department of Youth Services, mentioned that a Christian group from the US called "Band of Brothers" will be taking the young men on a retreat from June 8 to the 11, and it is there that the education process will commence.

"We're actually launching an official camp for young men who have to a certain extent not had the opportunity to really and truly reach out to their own children

and be fathers to their children. And therefore, as a result of that, we have reached out to a group of Christians in the United States called, 'Band of Brothers' and through our relationship, we're getting ready to launch an official program whereby in the first instance we will literally take the young men out to Matachica, a retreat center, where they will actually teach them about fatherhood," Cadle said.

"... What we have in Belize is a situation, especially in Southside Belize City, is a situation of matrifocality. And matrifocality is whereby women are actually the mother and father in their homes. And so we're trying to see how we can work that gap and strengthen our men so that they can become fathers and be able to take care of their children, which also will lead to a reduction of crime and violence in our society," continued Cadle.

Summit of the Americas: A squandered opportunity at critical time

A fiasco, a flop, a disappointment: These are just some of the ways that political analysts and Latin American and Caribbean leaders are describing the Summit of the Americas, which is being hosted by US President Joe Biden in Los Angeles.

Even before the summit began this week, the main subject of conversation was not how regional leaders would tackle key common challenges, such as migration, climate change, and economic disparity and cooperation.

Nor was it about how the United States would take advantage of a unique opportunity to put its relationship with Latin America back on track, after four years of neglect under former President Donald Trump.

Instead, even before it began, what fractured the only venue in which the heads of all the countries in the Americas can sit down face to face was Biden's decision to exclude the presidents of three nations: Nicaragua, Cuba and Venezuela. It is not an issue of support for those countries' respective leaders, Daniel Ortega, Miguel Diaz Canel, and Nicolas Maduro. Most countries in the region consider them authoritarian and undemocratic, as does Washington.

But by unilaterally excluding three nations that are part of the Americas, arguing that they do not meet the necessary democratic requirements, the White House has turned the clock back to the pre-Obama era.

"It was a mistake and we will say so at the summit," said Chile's President Gabriel Boric as he arrived in Los Angeles.

"No one can save him or herself alone. We have to join forces to achieve better development. We have a right to say that exclusion if not the way. Historically it has never achieved results. And when the United States attempts to exclude certain countries, ultimately it only serves to reinforce their [leaders] actions at home." A boycott

Mexico's President Andres Manuel Lopez Obrador had warned Biden that he would boycott the summit if he excluded the three countries, prompting pleas from the White House, which sent former Democratic Senator Christopher Dodd to the region to try to contain the looming crisis.

nations.

Such a snub underscores just how much US influence has waned in its own region.

Mexico's Foreign Minister Marcelo Ebrard, who is attending the summit in his president's place, said the decision to not invite Cuba has set the summit back a decade. "It is a serious error to freeze out countries," Ebrard said.

In a bid to ensure that the leader of Latin America's largest democracy would also not stay home, the White House cut a deal with Brazil's President Jair Bolsonaro, a staunch ally of former President Trump. Biden agreed to hold bilateral talks with his Brazilian counterpart, but according to the White House, he refused a request to not bring up thorny issues, such as the Amazon and Bolsonaro's attacks against the country's Supreme Court and Electoral Tribunal. Just before leaving for Los Angeles, Bolsonaro shot back, saying that he was still not convinced that Biden has not stolen the 2020 presidential election from Trump - a provocation that does not bode well for discussions between the leaders of the two largest economies in the Americas. A question of priorities The summit also begs the question: how does Biden expect to manage an unprecedented migration crisis in the Americas when Venezuela, a country from which more than six million people have

fled, is not part of the conversation?

Neither are Cuba and Nicaragua, home to tens of thousands of migrants who are heading mostly to the US.

It all seems to go back to the question of priorities, and the fact that for decades Latin America has not been near the top of the list for the US.

Former Peruvian President Pedro Pablo Kuczynski once commented on a conversation he said he had with Trump. "He told me that Latin America was like a

good sleeping dog, and that there was no need to wake it up," said Kuczynski.

Recent events suggest that such a view is not only shortsighted, but counterproductive for US strategic interests. China is now the number one trading partner for South America's largest economies -Brazil, Argentina, Chile and Peru-which produce much of the world's copper, lithium, soy and corn. And while China's influence grows steadily in Central America as well, Washington's once-unchallenged leadership in its former "backyard" has arguably descended to historic lows.

The Summit of the Americas, which has taken place every three years since 1994 (delayed only by the coronavirus pandemic), is a key event that once drew much excitement. "I promise you Americas may be remembered as a squandered opportunity at a critical time. First published by Aljazeera

Big Creek's \$30 mil facility

Manager at ASR Group-Belize Sugar, mentioned to reporters during the tour, "This facility came about because the owners of Big Creek Port took a decision to dredge this port to 11 meters depth and permits much larger vessels to come in to load on the caye side here. So that 11 meters depth allows the vessel which you see this morning which is a 30,000-ton bulk carrier to come and berth alongside the cave and get loaded alongside the caye... This is the first time a vessel of that size has come and berth and loaded a raw material such as sugar from the caye side itself. That enables us to get a much faster loading rate, and when I say much faster, I mean we used to load 500-tons of sugar a day [and now] we're looking at between 5 and 7,000tons a day.'

He further stated, "The way raw sugar is marketed in the world is against a global price; we call it the New York number eleven price. It's the raw sugar price and it is a traded price, so it is there all the time. But that price is based on the fact you could load sugar at least four thousand tons a day. Now in the past, we couldn't achieve that, so every ton of sugar we were selling, there was a discount for the amount of time it was taking to load that sugar. We just today, well yesterday when the loading started, overcome that bottleneck and that barrier. That enables us to get a much faster loading rate. And when I say much faster, I mean we used to load, say, 500 tons of sugar a day. We're now looking at somewhere between five and seven thousand tons a day. So that is a major saving for the whole industry."

"It boils down to what you used to have—weeks of loading, it's now down to days and it took a lot of hard work, a lot of investment. If you don't make the investment, you can't think about the payback coming through. And this is a significant investment that BSI has made," highlighted Zaid Flores, Managing Director at the Port of Big Creek.

McLachlan additionally explained, "The facility itself is a major warehousing facility and a molasses storage facility. It's got all the things that go with that, the conveyor systems and everything else, and of course, a major fleet of vehicles to bring sugar and molasses from Tower Hill, down to this facility to enable the loading to take place, and of course, a very stateof-the-art conveyor system for loading into the ship, which is portable. You can move it up and down the ship's length."

Father says schools rejected_.

admission to not one but two Ladyville primary schools because of the child's dreadlocked hairstyle. Since then, he has taken to the media to express his outrage at what he has called blatant discrimination against a child with dreadlocks.

Kevin Pollard, who first took to social media to voice his frustration with the two schools, Ladyville Evangelical Primary School and Ladyville Seventh Day Adventist Primary School, has claimed that, despite explaining that his son's long, locked hair is a part of their family's customs and religious beliefs, the management of both schools refused to enroll the child.

Pollard spoke with AMANDALA on Wednesday and told us that, since then, he has gotten no closer to enrolling his child in primary school. And as the start of the new school year draws closer, his frustrations have only been mounting.

"Well, at this time I've been trying to get him into other schools, but we are running out of time. I've tried two other schools so far, but they don't have any space, so I'm still trying at this time," he said.

Earlier this week, in response to the aggrieved father's accusations, the General Manager of the Union of Evangelical Churches of Belize Schools (UECB), Eutemio Chi, spoke with reporters from *7News*. He claimed that the 5-year-old boy was rejected not because of his hair but because the school had already enrolled the maximum number of students that it could accommodate and simply could not accept any more students.

According to Chi, Pollard came to enroll his son after the school's May 19 registration deadline and was told that the school, Ladyville Evangelical, had no more space. The school administration then informed him that his child could be put on the waiting list. Had they been denying the boy's enrollment for any other reason, said the General Manager, they would not have suggested placing him on the list.

We asked Pollard about the alleged miscommunication, and contrary to Chi's claims, he told us that he had gone as far as sending the principal of the school photos of his son and that, initially, there was no issue. The school administration even went as far as getting what he says was the last available admission form and giving it to him, making no mention of a waiting list the first time he spoke with them.

"The second day when I went, the principal was not there. I spoke to the vice principal. The vice principal now said 'we don't have space'... I think that's a sign right there that, okay you know what, you're not going to allow my child to come to this school," he said.

"Now you're telling me to go to other schools because you have a long waiting list—you did not tell me this the day before," he added.

According to Pollard, other parents have had similar experiences with the school.

We reached out to the second school, Ladyville SDA Primary School, but the principal was unavailable on both occasions.

Of note is that, according to Chapter 36 of Belize's Education Act (Revised Edition 2003), refusing admission of any citizen or resident of Belize into a school based on race, ethnicity, language, political affiliation, or perceived social and economic status is unlawful, as is the refusal of admission into a governmentaided school based on religion.

Despite his frustration, Pollard says that he is not looking to take any legal action.

"I just would like for the schools to follow the rules. They want us to follow the rules, then they need to follow the rules as well. I've been speaking to other people that went through the same thing and they filed lawsuits and they won. With this being said, you would think that across the board, this would be something that is law, meaning that this school cannot say 'oh we're not gonna do this' and this other school can say 'we're gonna do this'. That shouldn't be," he stated.

Pollard told us he feels that, in a society where persons with dreadlocks are government CEOs, ministers, lawyers, and business owners, a child should never be prevented from continuing their education because of their hair.

Nevertheless, countless persons, Belizean and otherwise, have over the years found themselves subjected to antiquated policies that, whether directly or indirectly, promote hair-based discrimination.

is to achieve 70% renewable energy across the region by 2030.

During his official remarks today at the summit, Prime Minister Briceno said, "Action must include the Paris 2030 delivery agenda. We demand firm plans for developed countries for emission reduction targets in line with the 1.5 degrees centigrade Paris Agreement Temperature goal, a plan to scale up climate finance beyond the floor of the \$100 US billion annually through 2025, and doubling of adaptation finance."

"Today, Vice President Harris announced the U.S.-Caribbean Partnership to Address the Climate Crisis 2030 (PACC 2030). PACC 2030 is the Biden-Harris Administration's new initiative involving fresh commitments to — and integration of — climate adaptation and resilience and clean energy programs across the Caribbean region." A statement from the White House noted. The overarching goals are Strengthening Energy Security and Promoting Climate Adaptation and Resilience, with four pillars intended to forward those objectives; those include: Improving Access to Development Financing, Facilitating Project Development, and Investment, Enhancing Local Capacity Building, and Deepening Collaboration with Caribbean Partners.

presence of CARICOM heads of state today. The first pillar looks at access to financing.

"Recognizing that access to financing is critical to achieving the region's climate and clean energy objectives, PACC 2030 will work to expand existing access to project financing and unlock new financing mechanisms to support climate and clean energy infrastructure development in the region. Key actions under this pillar will include increasing U.S. International Development Finance Corporation (DFC) financing for climate and clean energy projects in underserved Caribbean countries, as well as collaborating with multilateral development banks (MDBs) and multilateral climate and environmental trust funds to improve the policy environment and unlock access to additional infrastructure financing for the Caribbean." The statement from the White House is outlined in explaining the first pillar. CARICOM Secretary-General, Carla Barnett in her remarks following Harris' address said, "We are therefore pleased to have this conversation we are aware that our own public sector fiscal constraints limit the extent to which our governments can finance a transition to renewables and therefore the undertaking to provide sources of financing that our private sector can access is really very important." We will have more on the PACC 2030 initiative in a subsequent issue.

of four listed Acts. Notably, however, the Village Council Act is not included explicitly on the list.

The legislation states, "A public officer shall not participate actively on behalf of any political party or candidate in any elections held under the - (a) Representation of the People Act; (b) Belize City Council Act; (c) Belmopan City Council Act; (d) Town Councils Act."

During a recent interview, Minister of Public Service and Constitutional Reform, Hon. Henry Charles Usher, noted the aforementioned absence of the Village Council Act, Chapter 88 from the list to which the prohibition in the Public Service Regulations applies, and he pointed out that such elections within villages were meant to be neutral and that section 60(2) only restricts participation by public officers who are representing a political to contest the Georgeville village council election.

During Monday's police press conference, COMPOL Williams said, "For the most part, if he were to be elected the chairman of Georgetown, he would not be a police officer. He would be out by then. That is one. Two, he is not aligned with a political party. He is running as an independent in Georgetown."

This is in contrast, the COMPOL said, to WPC Trapp, who may face sanctions from the Professional Standards Branch for her apparent participation in village council elections in Teakettle and her subsequent publication of a live video in which she railed against alleged insults which she said were hurled at her by PUP Cayo South area representative, Hon. Julius Espat, during Sunday's Teakettle village council elections.

Jose Abelardo Mai lambasted the Opposition for their claims that local farmers are suffering losses as a result of their crops rotting in the ground due to poor sales, Leader of the Opposition, Hon. Moses "Shyne" Barrow visited San Carlos, Orange Walk, where he found that the crops are indeed rotting.

commented about the matter on her Facebook page.

Those comments, however, prompted a crudely worded rebuttal by Minister Mai at the most recent sitting of the House of Representatives last Friday, June 3. "She spoke about carrots and putting old pictures from under their term, Madam Speaker. She is confused...," he had remarked.

He went on to say, "Confusing carrots fi something else, definitely. You are confused, my dear. So, Madame Speaker, when you put nonsense on Facebook like that, it is shaming, man. Let me tell you something, you need to correct yourself. Unconfuse yourself. When you go and sit down on the carrots and take a photograph, I will believe it. The next time you go to San Carlos, you go and sit on the carrots and take a photograph and make it evidence. Do not come here and lie. You are deceiving people. Unconfuse your sensation, please," he had said.

And while Hon. Panton did not take a trip to the Orange Walk village, the Leader of the Opposition, Hon. Moses "Shyne" Barrow did, and he confirmed that the carrots are indeed rotting.

"Thousands of dollars in spoiled carrots in San Carlos, Orange Walk!" wrote the Opposition leader on his social media page Wednesday, alongside a photograph of himself inspecting the crops.

In a subsequent public statement he said, "... it was very disheartening to see thousands and thousands of dollars in carrot crops, and onions as well, completely spoiled and wasted. Which is exactly the report that the Honourable Tracy Panton, my colleague from Albert, gave to the Minister."

Barrow said that he paid a visit to the farmers of San Carlos alongside Lupe Magana, Orange Walk South caretaker for the UDP, to "address their concerns about their spoiled crops". He claimed that the carrots had flowered and spoiled "due to Minister Mai allowing import license for Mexican carrots" and also blamed the Government's inability to control contraband. In a video also shared by the Opposition Leader, the UDP caretaker can be heard explaining that the carrots, ready to be harvested, have been in the ground for about six months now. Hon. "Shyne" Barrow has proposed that the Government make a greater effort to ensure that local farmers sell all their produce before

opening the market to imported vegetables. He criticized the Briceño administration for approving licenses for the importation of Mexican produce without giving farmers the opportunity to sell their crops.

Notably, Minister Mai, when the reports of the rotting carrots had first surfaced, had stated, "But I do not know of carrots rotting in the fields. My technicians were asked to go out and give me a comprehensive report. The report hasn't come in as yet this morning, but from the preliminary report I got, there are no carrots rotting in the field. But there is a slow movement of carrots, because again, they over-supply, and we're trying to ensure that no contraband comes. We're trying to manage that well."

Minister Mai had also indicated that he had attempted to establish a trade arrangement with El Salvador, through which carrots grown in Belize would have been bought by that country, but he said that locally produced carrots did not meet El Salvador's size requirements, and as a result Belize has not been able to sell its carrots to that foreign market.

Just one day after news of the rotting carrots broke, the Ministry of Agriculture, Food Security, and Enterprise issued a press release informing that "for the first time in the history of Belize, carrot farmers are on track to produce enough carrots to supply the local market for up to 10 months." The release also addressed Barrow's accusations that the Government has been excessively approving importation licences, stating that since October of last year, no new permits have been issued and that any imported carrots on the local market are the result of contraband.

According to the release, up until 2020, local farmers were only able to supply the local market with carrots for six months, hence the need for importation. The press release then goes on to applaud the efforts of local farmers in carrot-growing communities, including San Carlos.

Previously, the Minister of Agriculture had stated that while there were supposedly no carrots rotting in the fields, farmers were having trouble selling them due to overproduction.

Caribbean region, through its innovative financing programs. Venezuela's absence is unforgivable."

Prime Minister Gaston Brown of Antigua and Barbuda, despite strong comments on the matter of exclusion of the three states, also departed for LA yesterday, and Jamaica's Prime Minister, Andrew Holness, is in attendance at the summit as well. Mia Mottley, the Prime Minister of Barbados, is also in attendance. By all indications, the only Caribbean leader reportedly not in attendance is Prime Minister of St. Vincent and the Grenadines, Prime Minister Ralph Gonsalves.

The Secretary-General of the Bolivarian Alliance for the Peoples of Our America (ALBA), Sacha Llorenti, said in a press conference on May 31 that the 9th Summit of the Americas has already failed and that it is "neither a summit nor a Summit of the Americas."

He said, "The United States has no interest in promoting democracy or human rights", and "what it wants is for its conditions to be imposed and its interests prioritized above the common interests of the region."

Reports are that the Community of Latin American and Caribbean States (CELAC) has planned a summit parallel to that of the one being hosted in Los Angeles where representatives from Cuba, Venezuela, and Nicaragua could participate.

"Since the outbreak of COVID-19, Venezuela, Syria, and Iran have been grappling with severe difficulties with a struggling economy and strained medical resources due to prolonged US sanctions. Under such circumstances, the US, rather than halting those sanctions, redoubled them, making things even worse for these countries." China's Foreign Ministry Spokesperson Zhao Lijian said in a recent press conference.

He added, "Under the pretext of so-called democracy and human rights, the US has been ganging up to suppress countries that have different opinions, wantonly abused unilateral sanctions, and interfered in and manipulated the internal affairs of countries in Latin America and the Caribbean. This is typical hegemony that gravely violates the purposes of the UN Charter and the basic norms governing international relations, and seriously contravenes the sovereignty and dignity of countries in the region. China firmly rejects this. I would like to stress that Latin America is by no means a 'front court' or 'backyard' of a certain country, and the Summit of the Americas is not a 'Summit of the United States of America'. The US scheme to interfere in regional affairs by taking advantage of its capacity as the host of the Summit of the Americas is doomed to fail."

crossing over to California while President Biden is still in that state. The US Migration Policy Institute says that Los Angeles is the home of more immigrants from Mexico than anywhere else in Central America.

On the issue of migration, Prime Minister Briceño stated that they have made requests to access a portion of the \$1.9 billion in private-sector funding being provided to boost job opportunities in the region in hopes of stemming the tide of migration into the United States. PM Briceño said we will need funds to protect our own borders, and he pointed out that most of the caravan headed to the US are coming from El Salvador, Honduras, and Guatemala, some of our direct neighbors.

"The US refers to them as the Northern Triangle, and have been talking to them as to how they could address the threat of migration to the US. Now we are told that Vice-President Harris is going to announce a \$1.5 billion to assist these three countries to be able to control the migration coming into the United States. We've said it to them already, and I'll repeat it again: we feel very strongly that we should also be included with these other three countries, because once you block off those other three countries, what are they going to do? They are going to come to Belize; we don't have the resources; we don't have the manpower to be able to stop a migrant caravan of 5, 10 thousand people. So, we feel strongly that we should be included in a part of this discussion and also with the funds that are being made available in Central America,' PM Briceño said.

During his official remarks this evening at the summit, the PM took the opportunity to illustrate the economic reality of CARICOM member states in light of the ongoing COVID-19 pandemic, and recent strains brought on by the war in Ukraine.

"Notwithstanding the six percent recovery in global growth in 2021, CARICOM member states, except for Guyana, recorded an average growth rate of one percent. A few member states experienced even further GDP losses, ranging from negative one percent to negative 6.3 percent. Member states were expected to record a stronger growth performance in 2022, but the effects of the war, rising inflation, rising oil costs, and further supply chain distributions have led the IMF to downgrade growth projections for the region. We cannot continue on this path; the recession was not of our making. We have come to Los Angeles to agree on specific deliverables on climate change, debt relief, access to concessionary financing, energy, and food security," PM Briceño said.

"The ministry categorically states that, at this time, there is no massive oversupply of carrots, only a shift in supply from the rest of the country to San Carlos and Concepcion," said the release.

The Ministry also added that it is normal to have 3% to 5% of losses in carrots in the field, claiming that anyone saying otherwise is misleading the Belizean public and is engaging in "political mischief" and "recklessness".

It must be noted that a caravan of thousands of migrants is en route to the US-Mexican border in hopes of The summit concludes on Friday, June 10. Prime Minister Briceño returns on the 11th.
