# Florencio Marin, Sr., the savior of the sugar industry?

A number of eyebrows were raised when it was reported that former PUP Cabinet minister, and father of two current Cabinet members, 80-year-old Florencio Marin, Sr., had been contracted to serve as a oneyear advisor to the government of Belize, specifically to assist the Sugar Industry Control Board (SICB), in brokering a new commercial agreement between the sugar cane farmers represented by the Belize Sugar Cane Farmers Association (BSCFA) and the company which mills and exports the cane, Belize Sugar Industries Ltd. (BSI). That agreement is due to expire on July 31, 2022, which is roughly two months away, and at this time the industry is being held together by a fragile interim agreement, signed by the parties in January of this year following a standoff that had threatened to derail the sugar harvest.

Notably, the interim agreement that is currently in place was a hastily cobbled-together arrangement that required the mediation of both the Prime Minister and the Minister of Agriculture after an



## PM: Bread price announcement to be made at House meeting!

In late April, some Belizeans began to notice an uptick in the price of locally produced packs of bread in various grocery stores and supermarkets, and reports began circulating that the price of bread had indeed "gaan up"! For many members of the public, it was an inevitability that they had been expecting, due to the increased prices of various ingredients used by bakers in the preparation of their dough as well as materials used during production and in packaging—most notably the increase Prime Minister of Belize, Hon. John Briceño, in reference to an impending hike in the price of bread, said that an announcement about the price of bread will be made at the upcoming meeting of the House of Representatives.

in the price of wheat due to the ongoing war between Russia and Ukraine, which are two of the world's largest exporters of that grain. Confirmation a few weeks earlier from the Controller of Supplies in the Supplies Control Unit of the Ministry of Agriculture Lennox Nicholson, the ADM Belize mills, which produces La Gitana and Bebe Agua flour, had submitted a request for an increase in the controlled prices had further solidified the expectation that a bread price hike could not be avoided. And when

local bakers also submitted requests for permission to increase the price of bread, most Belizeans thought the new prices were a done deal.

But during that last week in April of this year, when a number of bakeries and stores started selling

bread formerly priced at \$1.75 per pack for \$2.50, several members of Cabinet informed the public that the price hike had not been approved.

An AMANDALA article dated Wednesday, April 27, stated that during an interview earlier that week, "Minister of Education Hon. Francis Fonseca noted that, because the prices of flour and bread are controlled by government, and since government has not yet given the green light for any change in the base prices of those products, any increase in the price of bread is illegal, and store owners selling at new rates are in direct violation of the law."

"They are in absolute contravention of the law. It is illegal. It's illegal. They have no authority to do that. Bread is a controlled price substance, so they have no authority to do that. And until the law is changed, until there is some approval for the price to change, they are in violation of the law," Hon. Fonseca had said.

The public was then informed that Cabinet had asked the Minister of Agriculture and Food Security, Hon. Jose Mai, to present a paper on the bakers' request so that a substantive discussion could be carried out before any decision was made.

Subsequently, however, the Cabinet issued a brief which stated, "Cabinet determined that no price increase will be allowed at this time. In addition, Cabinet instructed the Minister of Agriculture, Food Security, and Enterprise to engage with the Association of Bakers to ensure other alternatives to minimize the possibility of drastic increases in the price of a 16-ounce pack of bread."

The AMANDALA had thus reported, "Cabinet has announced that there will

be no increase in the controlled price of bread at this time. The decision was made after a Cabinet meeting at which proposed price adjustments submitted by local bakers were tabled by Minister of Agriculture and Food Security, Jose Mai."

Today, however, the Prime Minister of Belize, while talking to local reporters, made remarks that seem to indicate that the government might be ready to allow bakers, who have been saying that their expenses now exceed their earnings, to make price alterations so that they can stay financially afloat.

GoB might officially give that green light to the bakers tomorrow, June 3, during the upcoming sitting of the House of Representatives.

Hon. Briceño told local media on Thursday, June 2, that the Minister of Agriculture, Food Security & Enterprise, Hon. Jose Mai, who had submitted to Cabinet the bakeries' proposals for adjustments to the price of a 16-ounce loaf of bread, will be making an announcement at tomorrow's House of Representatives meeting regarding the Cabinet's decision.

"We're trying to find a way to minimize the increase in bread. Everybody knows that price will have to go up, and we're trying to find creative ways on how we can hold down the price as best as we can, and Minister Mai, who's his responsibility, will be making an announcement tomorrow at the House meeting," said PM Briceño.

June 1, 2022 Multiple clusters of the Monkeypox viral infection known to cause flu-like symptoms and pus-filled skin lesions—have been identified in over a dozen countries where the virus is not usually reported, including Australia, the United Arab Emirates, and several nations across Europe and North America. As a result of this, the World Health Organization (WHO)



The Governor General of Belize, H.E. Dame Froyla Tzalam, will be attending Queen Elizabeth II's Platinum Jubilee this week in London. The Platinum Jubilee Central Weekend, which takes place from 2nd to 5th June, is being held in celebration of the 70<sup>th</sup> year of the Queen's reign.

"The Queen has ruled for longer than any other monarch in British history, becoming a much loved and respected figure across the globe," said a press release from the Governor General's Office.

Queen Elizabeth II is the first British

monarch to celebrate a Platinum Jubilee, having reigned since February 6, 1952, and is the longest reigning female monarch in the world. The length of her reign surpassed that of her greatgreat-grandmother Victoria, who reigned for 63 years, in 2015.

According to the British government, the weekend-long celebration will be a "once-in-a-generation show," mixing "the best of British ceremonial splendour and pageantry with cutting-edge artistic and technological displays."

Dame Froyla Tzalam will be joined by other Governor Generals and Heads of State from across the Commonwealth. During her time away, Ambassador Stuart Leslie will be acting as Deputy Governor General.

BURRELL BOOM, Belize District, Tues. May 31, 2022

A family of five in Burrell Boom village is asking for the public's help after the recent heavy rains caused their home to collapse. The house, which was supported by wooden beams that had been decaying over time, toppled over on Monday with the family, who narrowly escaped severe injury, inside.

Owner of the home, 46-year-old Merlin Hob, told reporters that she felt

the house rocking in the early hours of the morning. While Hob and four of her five children were able to exit the falling house unscathed, one of her sons was injured, albeit not severely, by a falling fridge.

The single monther, who is seeking to rebuild the home in order to provide shelter to her children, has asked for the public's assistance. For those wishing to help out, whether in the form of food, clothing, building supplies, or financial assistance, Merlin Hob can be contacted at 600-7266. was located 50 feet away from the scene of the shooting and who is the older sister of the man who was the gunman's target.

According to police reports, at around 7:15 p.m., Anthony Parham, 19, a Belizean construction worker of Curassow Street, Belize City, was walking on Curassow Street from the direction of Raccoon Street towards Cemetery Road, and was approached by an unknown triggerman who fired a barrage of bullets in his direction when he reached the corner of Curassow and Gibnut Streets.

When the shots were fired, Joanna Parham, 30, who is reportedly the older sibling of Anthony Parham and who was sitting about fifty feet away from the scene of the shooting, was wounded in her body. The bullets that were fired also reportedly damaged two vehicles Shemar Gillett, arrested and charged with multiple offenses

in the area.

Joanna Parham was transported to the Karl Heusner Memorial Hospital for medical treatment.

On Wednesday, June 1, police formally arrested and charged wellknown football player, Shemar Gillett, 18, in connection with the shooting.

Gillett has been charged with two (2) counts of use of deadly means of harm, two (2) counts of wounding, and two (2) counts of harm.

# **BEL moving toward renewable energy**

Solar, wind, and battery energy are the future of Belize's energy generation, say BEL's senior managers. BEL is transitioning from reliance on Mexican energy supplier, CFE.

key point made by the managers was that data drawn from its most recent *Leastcosts Generation and Transmission Study* clearly indicates that the best path for the country is a transition to solar, wind, and battery energy, all renewable sources, which will be generated incountry, and according to one representative from BEL, this would reduce the reliance on Mexican power from Comisión Federal de Electricidad (CFE).

Last Friday evening, power supply was interrupted across the country unexpectedly, and BEL, in a release on the matter, had indicated that they lost supply from Mexico's CFE, but were able to reconnect the entire country through the reorganization of power supply from local independent power producers which taught Karique Marin, Manager of Distribution Planning and Engineering at BEL, a key lesson:

He explained, "BEL lost supply from CFE at approximately 3:55 p.m., due to a fault on the Yucatan grid. The dispatch profile at the time comprised CFE, BECOL, BELCOGEN, Santander, and BAPCOL. At the time of the incident, approximately the 56% of energy to BEL customers was supplied by CFE." When this supply went down, local producers were able to produce enough energy to keep certain sections of the country connected, but a total grid failure was imminent.

"We did, however, later on, suffer a total power outage for the entire country as our local IPPs were unable to support the demand of these areas that remained online. All the local IPPs were highly responsive during this critical time. When the grid collapsed, that was during the restoration process, and as mentioned, we did not have as much local supply to match the load. So, we did lose the entire grid." Marin explained, but he noted that they took a little over two hours to restore power, by synchronizing the local IPPs to the grid to re-connect before CFE reconnected.

"The system was restored before we reconnected at the CFE. So, what happened was we brought on local supply that was then synchronized to the grid, and then re-energized most customers within that two and a half hours. Learning from this incident, however, BEL and its IPPs will make adjustments to restore as quickly as possible for any future event." Marin said. At this time, BEL is reliant on energy from CFE as the source of 55% of the grid's energy, according to the BEL representatives, with local IPPs producing energy using hydro and biomass sources that together produce approximately 45% of the energy supply needed to maintain the roughly 110-megawatt grid. The company is seeking to put in place more renewable energy generation technology to tap into the local energy potential, and allow those sources to feed the grid and provide our primary source of power,

while the power from Mexico would serve as a backup supply when there are opportunities to take advantage of more competitive prices.

Sean Fuller, General Manager, Commercial and Retail Services, of BEL explained, "The study is saying we can have as much as 45 to 60 megawatts additional solar, on the network. It also speaks of wind technology that we're able to be able to experiment with, based on the studies that are showing the potential for wind in certain areas of the country. It also calls for battery systems, where we will install ten or 20 megawatt-sized battery technology systems for an immediate response when we have issues on the network, and also for solar intermittency."

He said that while there is room for utilizing natural gas plants as an energy source as well, this current phase of their efforts is focused on generating renewable energy using the sun, wind, and batteries. For solar energy operations, which, as mentioned, have the potential to generate as much as 60 megawatts of power for the grid, the company is looking to distribute solar infrastructure to its customers, which will generate the electricity they need, while any surplus energy would be channeled to the national grid. Persons who already have solar panels are allowed to sell their excess energy to the company.

"We want to be able to compensate customers for the energy they export back to the grid, but we are also contemplating providing, in fact, we've done the studies, we've done the development of customer propositions to be able to offer our customers solar PV systems where we will own and operate the solar on your roof. You will have zero out-of-pocket. we will install the solar on your roof, you will enjoy the benefit of green energy, you will enjoy the benefit of the cheaper sources or the cheaper energy from that solar PV system, you will remain our customer and so there will not be a revenue loss. It will just simply mean that the sources of energy that we have to purchase to supply will also come from you," Fuller said.

The BEL reps said that the transition to local production of renewable energy will stabilize the cost of power, and reduce the variability of prices by reducing the reliance on fossil fuel, while making Belize an independent power producer itself, with potential down the road to sell excess energy to Mexico and Guatemala. And while we currently produce renewable energy at the hydro and biomass plants in Belize, reliance on those sources will depend on various environmental factors, driving home the importance of the rollout of the three new proposed sources. The BEL managers said that they expect no additional cost to customers for the rollout of this project and suggested, in fact, a possible reduction in the cost of power for customers when these renewable sources are rolled out.

# Above-normal hurricane season predicted!

A warm Atlantic basin and prevailing La Niña conditions point to a highly active season ahead.

temperatures in the Atlantic Basin and ongoing La Niña conditions. Of note, this is the seventh consecutive aboveaverage Atlantic Hurricane Season, according to the National Oceanic and Atmospheric Administration (NOAA). This year, the Climate Prediction Center at NOAA is indicating that there's a 65% chance there will be above-average storm activity during the season, which runs from June 1 to November 30, while there's a 25% chance of a near-normal season, and a 10% chance of a belownormal season.

It is being projected that between 14 to 21 named storms will form, and between 3 and 6 of those could become major hurricanes (Categories 3, 4 and 5).

Ronald Gordon, Chief Meteorologist, says that the dominant La Niña conditions are the primary factor driving the projections for an active season.

"The first factor this year is indicating that we are unlikely to have an El Niño and more likely to have La Niña conditions. Briefly, an El Niño situation would tend to suppress activity because of the fact that you'd have more storms developing over the eastern Pacific Ocean, and when those storms develop, they tend to vent a lot of strong breeze that at the higher levels of the atmosphere and resulting in what we call wind shear, which will tear tropical systems apart. On the contrary, La Niña, you would have less activity on that size, therefore less vertical wind shear and therefore more support for tropical cyclone activity on the Atlantic side," Gordon pointed out.

He added, "The other factor is whether the Atlantic basin is warmer than normal or cooler than normal, and that factor is also favorable for tropical cyclone development, because this year, it appears that the Atlantic basin will be warmer than normal. The warmer the sea surface temperatures, the more fuel you have for tropical cyclone development. "

According to NOAA, along with these factors, weaker tropical Atlantic trade winds and an enhanced West A release from the NMS and NEMO states, "Seasonal predictions give us an indication of how active a particular hurricane season is expected to be, but they do not tell us when a particular hurricane season will develop or where it will track once developed. One or more of the 14 to 21 named storms forecast to develop this season could hit the country, or none at all. Therefore, as a nation located in an area vulnerable to the hazards posed by tropical cyclones, we should be prepared each year no matter what the forecast is."

Ret'd Lt. Col. Shelton Defour, NEMO Coordinator, reminded all Belizeans to create an emergency plan of action in the event of a storm.

"Important is having your emergency family plan, having some degree of emergency food and water. We know there are some people who would be able to do that, but those who can, need to plan, need to stack up, and as I heard somebody say on a media house this morning, if you don't have your plan on paper stick on your refrigerator, at least have the plan in your mind. You must know what you need to do in times of disaster, and those who can help, we are obligated to help the less fortunate. So it has to be a team effort and a community effort. That is what Belize is built on, so in those times of emergency, we are asking for that mindset to look out for and support those who are needy," Defour said.

He reminded citizens to also make a plan for pets, often left behind in times of emergency, since animals will not be allowed in hurricane shelters.

"We strongly recommend, based on what we are seeing on the landscape, meaning there are quite a few places now that are available to shelter pets, so we would like to ask people to make plans for their pets, so that they can take their pets to some place of safety before boarding buses or going to shelters...We need to make sure that the priority for saving lives are people, even though we are very close to our pets and we need them," NEMO Coordinator Defour said.

The NMS will launch a 24-hour forecast for the major municipalities and will "also be issuing a more detailed and graphically enhanced once-weekly tropical weather outlook," NEMO said in its release. The last hurricane to make landfall in Belize was Nana, a category 1 storm which struck the country on September 3, 2020, causing minor damage across the country. Later that year, two storms, Eta and Iota, battered Guatemala and caused historic flooding in Belize and across Central America. Last year, the storm that passed nearest to Belize was Hurricane Grace, which made landfall in Tulum, Mexico.

"As it relates to, obviously there was a

African Monsoon will also contribute to the increased activity this season.

"An enhanced West African Monsoon supports stronger African Easterly Waves, which seed many of the strongest and longest lived hurricanes during most seasons," a recent article from NOAA outlines.

In Belize, the MET office and NEMO held a press conference yesterday to remind citizens of the start of the hurricane season and to advise each family to begin creating a plan in the event of a disaster.

shock [with] the increase in fossil fuels which impact both the generation at Caye Caulker, the generation at the Mile 8 substation facility and the BAPCOL facility down south that are reliant on fossil fuels. Niche plans that we have that start immediately is for us to be less reliant on these facilities and more reliant on renewable energy resources — solar, wind and the cheap power that we can when it's available from Mexico," Fuller said.




## Close the door on Dermens

Former three-time UDP government minister, John Saldivar, has repeatedly told Belizeans about all the wonderful things he was able to do with funds he received from Lev Dermen, a crook whose present residence is a US jail. Mr. Saldivar isn't the first Belizean to receive funds from suspect persons/ sources, but he is the one who got burned the worst. Mr. Saldivar won a convention to lead the UDP, and three days later he was forced to step down after his association with the unsavory Dermen was revealed. PM Barrow made it appear that it was his sole decision that Mr. Saldivar's suspect association was too damning for him to hold such a high position, but undercurrents suggest there was considerable pressure from a powerful foreign country.

It is rare, almost unheard of, for someone to give out substantial sums of money with no strings attached. It was revealed that Mr. Dermen, a naturalized American with business ties to Turkey, wanted to be an honorary consul to Belize. His ambition reportedly was frowned on by the US government, but his friends, particularly Saldivar, didn't give up their support for him readily. The fraudster reportedly had discussions with a number of other UDP ministers, in his quest to be a voluntary diplomat.

It isn't known why Dermen was so determined to be appointed as an honorary consul to Belize. OCCRP, the Organized Crime and Corruption Reporting Project, says that by convention (the Vienna Convention on Consular Relations (1963)) honorary consuls do not have diplomatic immunity, nor are their family members or employees covered by immunity provisions. The honorary consul post aside, Dermen must have felt he was making a great investment. In 2020, Saldivar was a leading

candidate in a convention to decide who would lead the UDP into the next general election, and if fortune smiled on his candidacies, Mr. Dermen, to put it politely, would have had a direct line to the Prime Minister of Belize.

Another unwholesome person who apparently had a business connection with our political leaders was Won Hong Kim, a South Korean. Somehow, Mr. Kim, who was in a jail in Taiwan and could show no records of ever visiting Belize, was issued a Belize passport. Minister of State at the time, Elvin Penner reportedly signed immigration documents for Mr. Kim, for which deeds he was subsequently removed from office. We don't know Mr. Penner's interest; maybe he was a Good Samaritan. We know what Mr. Kim's interest was. Media reports say he was trying to avoid being extradited to South Korea, where he was wanted for embezzling huge sums of money from a shipping company. Belizeans are not naïve. They have watched local leaders engage with crooks, and with rapacious local and foreign entities that get extraordinary favors from our governments. They have literally watched local leaders grow fat in office, while the poverty rate in our country increases year after year. Belizeans know that if we will get our governments to serve the people better, we have to control the people who sponsor the political parties. As Marco A. Lopez wrote last week in the *Amandala*, in his article titled, *"Fiesta o Partido?"*, "Our so-called political parties, while they give lip-service to the importance of checking the monster of campaign financing and baggage that comes along with it, make no true attempts to implement the necessary changes, to protect themselves from predators, and more importantly the assets and interests of the Belizean people."

The people's cry for our political system to be protected hasn't been successful, but they keep fighting. A main platform of third parties such as the VIP and the BPP was that we establish campaign financing laws. The NTUCB took to the streets prior to the last general election, and primary among their demands was for politicians to disclose campaign contributions over \$1,000, for limits to be placed on the amounts individuals and businesses could contribute to political parties, and for donors and their donations to be disclosed to the public during election season.

The people thought they had found a champion when the PUP, a party which has held office on a number of occasions but which had been turned away at the polls three consecutive times beginning in 2008, promised to address the problem. In its 2020-to-2025 manifesto, the PUP swore not only to make the Elections & Boundaries Commission more independent, fix election dates, and register political parties, but also to "introduce campaign finance reform with legislation to ensure disclosure of campaign contributions." Speaking on his party's promise to the people, then opposition leader, Hon. John Briceño, told *Channel Five* there was a need to define and set standards for political parties, and that we had to decide if we will have a private, a public, or a private-public model for campaign financing.

No matter the political system, the party that sits in government controls the purse of the country, and both saints and sinners will try to get their tentacles into the ones on top. It's no stroll in the park to control campaign donations. Even the self-proclaimed world's best democracy, the USA, has difficulty protecting their electoral system. Ms. Miriam Marks, in a discussion of timely disclosure of campaign financing in a 2016 article in *Zócalo Public Square, a magazine of ideas from Arizona State University*, exposed deep flaws in their system.

Marks said that by law, information on the financing of political campaigns must be divulged, but the identities of the largest donors to "super PACs (the main money-vehicle through which candidates receive donations) cannot be determined until months after the contributions were made." Also, "social welfare groups that are not required to disclose their donors...

It's not an easy task to control campaign financing, but it cannot be that vermin and voracious feeders have such easy access to our leaders and so much influence on our electoral process. It is urgent that we devise and implement sensible campaign financing laws. It will take serious work, and if the PUP will deliver on its promise of campaign financing reform, it had better get on with the job.

The party has been in office a year and a half now, and not only has no bill been tabled, but the party hasn't even engaged the people in a discussion. The PUP doesn't mind tabling bills straight from the party's think tank, and having us express our views afterward. This one they haven't come close to touching.

Quite likely the PUP is under "manners" from the suspects who perennially fund their party. No doubt the party loves the status quo very much and would want to ride it some more. But Belizeans have had it with the rotten system. They demand a system that isn't a wide open door to more Dermens.

## Fisher Folk Month 2022

Nominations are open for the Fisher of the Year Award 2022

BELIZE CITY, Thurs. June 2, 2022

The month of June is being observed in Belize and the Caribbean as Fisher Folk Month, during which the efforts of fisher folks who provide the nation with seafood are being acknowledged. This year, Fisher Folk Month is being observed under the theme: "Collective Action for a Safe and Resilient Belizean Fisheries".

The members of the Fisher Folk Month Planning Committee consist of representatives of the Belize Fisheries Department; Caribbean Regional Fisheries Mechanism (CRFM); Caribbean Network of Fisherfolk Organizations (CNFO); and the Wildlife Conservation Society (WCS).

Communications Director for the Wildlife Conversation Society of Belize, Deseree Arzu, appeared on Krem's *Wake up Belize Morning Vibes* show and spoke about the activities being planned for this month.

"It's not only in June, but we decided that June is an appropriate month, because on the 29<sup>th</sup> is actually Caribbean Fisher Folk Day, so we try to arrange activities in consultation with these same fishers so that we also celebrate Caribbean Fisher Folk Day, which is the day that we chose every year to recognize the Fisher of the Year along with two outstanding fishers, so that's the highlight of the month of activities," said Arzu.

Management and Development at the Caribbean Regional Fisheries Mechanism Secretariat, also appeared on the morning show, during which he stated, "Events like this, months like this, where we raise that awareness, where we bring that them into the conversation, where we recognize them for what the role fishers play in the society. And when you think about it, fish is very important for food security. It's an important source of protein. We have to recognize that, and involving them in the discussion [and] recognizing them is part of that collectivity."

As part of that effort to recognize fisher folk, awards will be presented to two outstanding members of the fishing community who will be receiving the Outstanding Fishers and the Fisher of the Year 2022 awards respectively. Nominations must include the nominator's name and contact information, the fisher's name, and the nominator's relationship to him/her, as well as the number of years the nominee has been fishing, whether he/she belongs to a cooperative and/or association; and the name of the cooperative or association. Nominators should also submit a copy of the nominee's fisher-folk license and a 250word essay explaining how the fisher is involved in fisheries management and sustainable fishing practices, and how he or she has shown resilience in this sector by remaining an active fisher. The deadline for submissions is Monday, June 20.



## Media personality accused of sexual assault

### BELIZE CITY, Thurs. June 2, 2022

A well-known media personality from the Cayo District, Javier Gutierrez, has been accused of sexually assaulting a female employee of the Belize Border Management at the Western Border, where Gutierrez was serving as the site manager.

The alleged incident took place on June 20, 2021, when, according to the alleged victim, Gutierrez put his hands inside her shirt and touched her breast. Since that incident occurred, police have been investigating the matter, and

on May 16 of this year, they issued a warrant for his arrest.

Notably, the allegations made by the victim have been bolstered by the claims of another female worker at the facility who has publicly made similar allegations against Gutierrez.

After Gutierrez was charged for two counts of sexual assault at the Benque

Viejo Police Station, bail was provided for him by a Justice of the Peace, so he was able to avoid a stay at the Belize Central Prison. He is expected to appear in court on Thursday, June 2, for arraignment.

## Baby eats poisoned bread

ORANGE WALK, Wed. June 1, 2022

A two-year-old baby girl from San Felipe Village, Orange Walk District, is being treated at the Karl Heusner Memorial Hospital after she swallowed a pesticide that is intended for agricultural use but that was being used in her home to kill rats.

The child's mother, Noemi Santos, 33, a San Felipe resident, told police that on Tuesday night, May 31, at about 7:00 p.m., her husband, Orlando Santos, 42, placed pieces of bread soaked in Lannate pesticide on top of the headboard of their bed in order to kill any rats in their home.

A few moments later, their two-yearold daughter, Melanie Santos, was seen eating the pieces of bread left for the rats. Orange Walk police reportedly received a call shortly after (presumably from the alarmed parents) that notified them that a female had ingested poison and was experiencing convulsions.

The child was rushed to the Northern Regional Hospital and then to the Karl Heusner Memorial Hospital, where her condition is listed as critical but stable.

In an interview with *7News*, Miriam Serrut, Registrar of Pesticides at the Pesticides Control Board (PCB), indicated that Lannate is one of the deadlier agricultural pesticides and is not intended for domestic use.

"... It is a serious issue that concerns us a lot that pesticide retailers are recommending pesticides that are

intended for agricultural use; they're recommending it for other uses. That practice has got to stop .... Pesticides are poisons. And Lannate, for example, contains an active ingredient called Methomyl. Methomyl is highly hazardous—all these formulations, they belong to the higher level of hazard. They present the highest level of hazard, especially, well in the case of Methomyl, which is the active ingredient of Lannate. The lethal dose for that is 358 milligrams per kilo of body weight. So it becomes even more critical if we're talking about a child, because it's less body weight."

Serrut also indicated that, fortunately, there is an antidote that can counter the effects of Lannate. It is known as atropine, and this is presumably what's being used to treat the child at the Karl Heusner Memorial Hospital.

## Que se le cierra la puerta a Dermens

El tres veces exministro de gobierno UDP, John Saldivar, les ha dicho repetidamente a los beliceños sobre todas las cosas maravillosas que pudo hacer con los fondos que recibió de Lev Dermen, un bandido cuya residencia actual es una cárcel estadounidense. El Sr. Saldivar no es el primer beliceño en recibir fondos de personas/fuentes sospechosas, pero es el que más fue quemado. El Sr. Saldivar ganó una convención para liderar el UDP, y tres días después se vio obligado a renunciar después de que se revelara su asociación con el desagradable Dermen. El primer ministro Barrow hizo parecer que fue su única decisión que la asociación sospechosa del Sr. Saldivar era demasiado condenatoria para él para ocupar un puesto tan alto, pero las corrientes ocultas sugieren que hubo una presión considerable de un poderoso país extranjero.

Es raro, casi inaudito, que alguien entregue sumas sustanciales de dinero sin condiciones. Se reveló que el Sr. Dermen, un estadounidense naturalizado con vínculos comerciales con Turquía, quería ser cónsul honorario en Belize. Según los informes, su ambición fue mal vista por el gobierno de los EE. UU., pero sus amigos, particularmente Saldivar, no renunciaron su apoyo a Dermen fácilmente. Según los informes, el estafador tuvo conversaciones con varios otros ministros UDP, en su búsqueda de ser un diplomático voluntario.

No se sabe por qué Dermen estaba tan decidido a ser nombrado cónsul honorario de Belize. OCCRP, Organised Crime and Corruption Reporting Project, dice que por convención (la Convención de Viena sobre Relaciones Consulares (1963)) los cónsules honorarios no tienen inmunidad diplomática, ni sus familiares o empleados están cubiertos por disposiciones de inmunidad. Aparte del cargo de cónsul honorario, Dermen debió sentir que estaba haciendo una gran inversión. En 2020, Saldívar fue uno de los principales candidatos en una convención para decidir quién lideraría al UDP en las próximas elecciones generales y, si la fortuna sonriera a sus candidaturas, el Sr. Dermen, por decirlo con amabilidad, habría tenido una línea directa al Primer Ministro de Belize.

Otra persona malsana que aparentemente tenía una conexión comercial con nuestros líderes políticos fue Won Hong Kim, un surcoreano. De alguna manera, al Sr. Kim, que estaba en una cárcel en Taiwán y no podía mostrar antecedentes de haber visitado Belize, se le emitió un pasaporte de Belize. El Ministro de Estado en ese momento, Elvin Penner, supuestamente firmó documentos de inmigración para el Sr. Kim, por lo que posteriormente fue destituido de su cargo. No conocemos el interés del Sr. Penner; tal vez era un buen samaritano. Sabemos cuál era el interés del Sr. Kim. Los informes de los medios dicen que estaba tratando de evitar ser extraditado a Corea del Sur, donde lo buscaban por malversar enormes sumas de dinero de una compañía de embarque.

Los beliceños no son ingenuos. Han visto a los líderes locales involucrarse con ladrones y con entidades locales y extranjeras rapaces que obtienen favores extraordinarios de nuestros cantidades que las personas y las empresas pueden contribuir a los partidos políticos, y que los donantes y sus donaciones se darán a conocer al público durante la temporada electoral.

La gente pensó que había encontrado un campeón cuando el PUP, un partido que ha ocupado el cargo en varias ocasiones pero que había sido rechazado en las urnas tres veces consecutivas a partir de 2008, prometió abordar el problema. En su manifiesto de 2020 a 2025, el PUP juró no solo hacer que la Comisión de Elecciones y Límites sea más independiente, fijar las fechas de las elecciones y registrar los partidos políticos, sino también "introducir una reforma financiera de campaña con legislación para garantizar la divulgación de las contribuciones de campaña." Hablando sobre la promesa de su partido al pueblo, el entonces líder de la oposición, el Honorable John Briceño, dijo a *Channel Five* que había una necesidad de definir y establecer estándares para los partidos políticos, y que teníamos que decidir si tendremos un modelo privado, público o privado-público para el financiamiento de campañas.

No importa el sistema político, el partido que se sienta en el gobierno controla el dinero del país, y tanto los santos como los pecadores intentarán meter sus tentáculos en los de arriba. Controlar donaciones de campaña no es un paseo por el parque. Incluso la autoproclamada mejor democracia del mundo, Estados Unidos, tiene dificultades para proteger su sistema electoral. La Sra. Miriam Marks, en una discusión sobre la divulgación oportuna del financiamiento de campañas en un artículo de 2016 en *Zócalo Public Square, una revista de ideas de la Universidad Estatal de Arizona,* expuso fallas profundas en su sistema.

Marks dijo que por ley, la información sobre el financiamiento de las campañas políticas debe ser divulgada, pero las identidades de los mayores donantes a los "súper comités de acción política (PAC por sus siglas en inglés) (los principales vehículos de dinero a través del cual los candidatos reciben donaciones) no pueden determinarse hasta meses después de que se realizaron las contribuciones." Además, "los grupos de bienestar social que no están obligados a revelar a sus donantes... ejercen su influencia financiando candidatos y súper PAC en el anonimato".

No es una tarea fácil controlar el financiamiento de campañas, pero no puede ser que las alimañas y los voraces alimentadores tengan tan fácil acceso a nuestros líderes y tanta influencia en nuestro proceso electoral. Es urgente que diseñemos e implementemos leyes sensatas de financiamiento de campañas. Requerirá un trabajo serio, y si el PUP cumple su promesa de reformar el financiamiento de campañas, será mejor que se ponga manos a la obra con el trabajo.

El partido ha estado en el cargo por un año y medio y no solo no se ha presentado ningún proyecto de ley, sino que el partido ni siquiera ha involucrado a la gente en una discusión. Al PUP no le importa presentar proyectos de ley directamente del grupo de expertos del partido y que después expresemos nuestros puntos de vista. Este, ni se han acercado a tocarlo.

Es muy probable que el PUP esté bajo los "modales" de los sospechosos que financian perennemente su partido. Sin duda, el partido ama mucho el statu quo y querría aprovecharlo un poco más. Pero los beliceños están hartos del sistema podrido. Exigen un sistema que no sea una puerta abierta de par en par a más Dermens.

gobiernos. Literalmente, han visto a los líderes locales engordar en el cargo, mientras que la tasa de pobreza en nuestro país aumenta año tras año. Los beliceños saben que si queremos que nuestros gobiernos sirvan mejor a la gente, tenemos que controlar a las personas que patrocinan los partidos políticos. Como escribió Marco A. Lopez la semana pasada en el *Amandala*, en su artículo titulado "¿Fiesta o Partido?", "Nuestros supuestos partidos políticos, mientras hablan de la importancia de controlar el monstruo del financiamiento de campañas y el bagaje que viene con eso, no hacen verdaderos intentos de implementar los cambios necesarios, para protegerse de los depredadores y, lo que es más importante, los bienes e intereses del pueblo beliceño".

El clamor del pueblo para que se proteja nuestro sistema político no ha tenido éxito, pero siguen luchando. Una plataforma principal de terceros partidos como el VIP y el BPP fue que estableciéramos leyes de financiamiento de campañas. This May 29 was the fiftieth anniversary of a major uprising in the streets of Belize City. It was an African Liberation Day march organized by the United Black Association for Development (UBAD), which became a kind of riot on Albert and Regent Streets when dark descended on the old capital, and afterwards became, to a certain extent, an insurgency, apparently organized on the spot.

Over the decades, I have written several times about this incident(s), but I don't believe anybody else has. It's time for other people to comment, or do investigative journalism; otherwise May 29 of 1972 will end up like July 22/ 23, 1919 — a notable phenomenon swept under the academic rug by powerful people with racist agendas, and then perhaps revived several decades down the road by researchers from abroad.

Whatever, one of the things I want to discuss today is Prohibition, and bootlegging. When the United States outlawed the manufacture and consumption of alcohol in 1919-this is what is referred to as Prohibition by scholars. (Prohibition lasted until 1933.)

When the U.S. outlawed alcohol, this was not the case in Canada, which is on

the northern border of the U.S., and other British possessions in the region. So those gangster businessmen who wanted to do alcohol business in America had to establish contacts with sources in places like Canada and British Honduras.

My father, who will become 99 a few days from now if God is willing, told me that my grandfather, James Bartlett Hyde, used to run alcohol (whisky and rum) from Belize up along the Mexican Gulf Coast to an area in Louisiana named Westwego. I believe Westwego is near to New Orleans, which I think is Louisiana's largest city. I suppose people from New Orleans would motor to Westwego to pick up the illegal product, whereupon the Belizeans were free to return home.

My grandfather was in the employ of a businessman named Bob Turton (Robert Sydney Turton), who sponsored the trips to Westwego, but there were other prominent Belizeans who owned powerful boats who were in the bootlegging business.

My grandfather on my father's side was very light-skinned. Family members say that he told them he met Belize people in New Orleans who he believed preferred for him to pretend not to know them.

When I was younger, I lamented the fact that so much of our history here is unwritten. But now I understand that rich foundations and universities in the United States finance writers and researchers to study subjects like these in America, and that is why a written record of so many things exists in the U.S., whereas in Belize none of our youth know anything about Hankin Barrow or Slim Terror Cadle. I'm just saying.

There's been a lot of talk in the last few weeks about race and ethnicity in Belize. This is because of a proposed amnesty program which will make black Belizeans even more of a minority in The Jewel. I have not said anything publicly about this, one reason being that I've said so much over the last five-plus decades.

In my best days, the adult support which enabled me to survive was only about four percent of our population. Today, I am an elder, and Belizean society and culture have changed so much that I have become an onlooker, trust me. Perhaps I am now even a dinosaur. There are cameras and phones and electronic devices/communications all around us. Everything has speeded up, spectacularly.

It is said that if you don't know your

history, you are condemned to repeat it. For me, that was the case with May 29, 1972, 53 years after July 22/23, 1919. Our younger Belizean generations, just like ours was, have been deprived of all the recent history of their forebears.

What we didn't fully understand way back in the UBAD days was how important violence and the threat of violence were in our daily lives. British Honduras appeared to be a peaceful British enclave surrounded on all sides by violent Latin republics. When the British cast us adrift in 1981, all we knew how to do was "leave it to God." That is why I have insisted on the value of the Peter Ashdown essay to which I referred a few weeks ago. We Belizeans had been living a colonial lie. We were not ready to co-exist in the violent environment into which political independence thrust us. Our society proceeded to implode.

No disrespect to religion, but in the cases of both Spain and England, they imposed religion on us after they had subjected us to their violence and maintained the threat thereof. That is why Peter Stallard hung Nora Parham. He had to keep us scared. But today, we Belizeans will celebrate the platinum. That is the essence of confusion. Seriously.

Fue una marcha del Día de la Liberación Africana organizada por la Asociación Negra Unida para el Desarrollo (UBAD por sus siglas en inglés), que se convirtió en una especie de motín en las calles Albert y Regent cuando la oscuridad descendió sobre la antigua capital, y luego se convirtió, hasta cierto punto, en una insurgencia aparentemente organizado en el lugar.

A lo largo de las décadas, he escrito varias veces sobre este(s) incidente(s), pero no creo que nadie más lo haya hecho. Es hora de que otras personas comenten, o hagan periodismo de investigación; de lo contrario, el 29 de mayo de 1972 terminará como el 22/23 de julio de 1919: un fenómeno notable barrido debajo de la alfombra académica por personas poderosas con agendas racistas, y luego quizás revivido varias décadas después por investigadores del extranjero.

Lo que sea, una de las cosas que quiero discutir hoy es la Prohibición y el contrabando. Cuando los Estados Unidos prohibió la fabricación y el consumo de alcohol en 1919, los académicos se refieren a esto como Prohibición. (La prohibición duró hasta 1933.)

Cuando EE. UU. prohibió el alcohol, este no fue el caso en Canadá, que se encuentra en la frontera norte de EE. UU., y otras posesiones británicas en la región. Así que aquellos negociantes gánsteres que querían hacer negocios con el alcohol en Estados Unidos tenían que establecer contactos con fuentes en lugares como Canadá y Honduras Británica.

Mi padre, que cumplirá 99 años dentro de unos días si Dios quiere, me dijo que mi abuelo, James Bartlett Hyde, solía transportar alcohol (whisky y ron) desde Belize a lo largo de la costa del golfo de México hasta un área de Luisiana llamada Westwego. Creo que Westwego está cerca de Nueva Orleans, que creo que es la ciudad más grande de Luisiana. Supongo que la gente de Nueva Orleans viajaría en automóvil a Westwego para recoger el producto ilegal, después de lo cual los beliceños podían regresar a casa.

Mi abuelo era empleado por un hombre de negocios llamado Bob Turton (Robert Sydney Turton), que patrocinaba los viajes a Westwego, pero había otros

Mi abuelo por parte de mi padre era de piel muy clara. Los miembros de la familia dicen que él les dijo que conoció a personas de Belize en Nueva Orleans que creía que preferían que él fingiese no conocerlos.

Cuando era más joven, lamentaba el hecho de que gran parte de nuestra historia aquí no esté escrita. Pero ahora entiendo que ricas fundaciones y universidades en los Estados Unidos financian a escritores e investigadores para estudiar temas como estos en los Estados Unidos, y por eso existe un registro escrito de tantas cosas en los Estados Unidos, mientras que en Belize ninguno de nuestros jóvenes sabe nada sobre Hankin Barrow o Slim Terror Cadle. Sólo digo.

Se ha hablado mucho en las últimas semanas sobre la raza y el origen étnico en Belize. Esto se debe a un programa de amnistía propuesto que hará que los beliceños negros sean aún más una minoría en La Joya. No he dicho nada públicamente sobre esto, una de las razones es que he dicho mucho durante las últimas cinco décadas.

En mis mejores días, el apoyo adulto que me permitió sobrevivir era solo alrededor del cuatro por ciento de nuestra población. Hoy soy un anciano, y la sociedad y la cultura de Belize han cambiado tanto que me he convertido en un espectador, créanme. Tal vez ahora soy incluso un dinosaurio. Hay cámaras, teléfonos y dispositivos electrónicos/ comunicaciones a nuestro alrededor. Todo se ha acelerado, espectacularmente.

Se dice que si no conoces tu historia, estás condenado a repetirla. Para mí, ese fue el caso del 29 de mayo de 1972, 53 años después del 22/23 de julio de 1919. Nuestras generaciones más jóvenes de beliceños, al igual que la nuestra, se han visto privadas de toda la historia reciente de sus antepasados.

Lo que no entendíamos completamente en los días de UBAD era cuán importante era la violencia y la amenaza de violencia en nuestra vida diaria. Honduras Británica parecía ser un pacífico enclave británico rodeado por todos lados por violentas repúblicas latinas. Cuando los británicos nos arrojaron a la deriva en 1981, todo lo que sabíamos hacer era "dejárselo a Dios". Por eso he insistido en el valor del ensayo de Peter Ashdown al que me referí hace unas semanas. Los beliceños habíamos estado viviendo una mentira colonial. No estábamos preparados para coexistir en el entorno violento al que nos empujaba la independencia política. Nuestra sociedad procedió a implosionar. Sin faltar el respeto a la religión, tanto en el caso de España como en el de Inglaterra, nos impusieron la religión después de habernos sometido a su violencia y mantenido la amenaza de ella. Por eso Peter Stallard colgó a Nora Parham. Tenía que mantenernos asustados. hoy, los beliceños Pero celebraremos el platino. Esa es la esencia de la confusión. En serio.

## No value for money in hiring "top" lawyers, PM

Junior lawyers in the employ of government weren't too pleased when the PM said they didn't have the savvy to go up against the high-priced bohgaz in private employ. Hmm, on a straight line, it is true that junior lawyers will get walloped by senior ones. Why, then, aren't we consoled that the GOB is about contracting senior lawyers to appear for us in court? It is because, when in our employ, they lose all our cases. Whoa there, we don't need them. With the right support, junior lawyers can defend us well.

I think we need to get to the bottom of what's going on here. Let's get this very, very clear. If all the facts are laid on the table, there is no doubt how a case will go. Take Section 53, for example. That was simply a judge's interpretation of rights. The court case was almost only theater. Before Caleb went to court, the judge already knew what he would do, if Caleb's crowd didn't absolutely botch their arguments.

There are cases where all the facts aren't on the table, and that's when the work of lawyers is premium. But lawyers aren't the only group that is capable of gathering facts. The reality is, there's a group that is more capable at gathering information. The daily workload of scientists – doctors, physicists, chemists, agronomists, and pathologists, and the daily workload of historians make those groups the masters of research.

These groups not only know how to dig out facts, but their minds have a clarity that is unmatched in other fields. That explains, in my opinion, why Manuel Esquivel's approach to the BTL case was superior to that of Barrow and his battery of high-priced lawyers.

The following is taken from page 268 of the book, *Still Waters*, which was written by Kathy Esquivel: "Manuel [our

former PM] supported Dean's efforts to take back ownership of BTL...[he] thought that Dean's reliance on his own legal acumen as a guide was unwise...Manuel admits that he does not have a magic formula that would have worked better, but thinks that it was ill-advised to assume that being morally right would be an advantage in foreign law courts." Of course, where this morality angle really sucked was in the UHS case. What were Dean and his party thinking?!

My bwai, gyal, more from *Still Waters*, re: taking back BTL: "[Manuel] believes that it would have been better to take an incremental approach, starting with litigating on the lawfulness of the transfer of the Golden Share to Ashcroft." Go, Manuel!

Look, Braa, you could have taken me, a total dummy on law, off the streets, and I could not have done worse than the brilliant UDP lawyers did. You don't have to go to law school to know that courts abroad will protect foreign investors. That was/is strictly to do with capital crimes and the sensational hanging.

The legal profession doesn't look so good. Why did Senate president Carolyn Trench Sandiford say she decided not to study law? Aiyayai, everyone knows that juries make no sense in murder trials in this era. You don't have to be an A-student; you just have to look at the numbers.

Ah, I've been to court twice. In the first, I told the prosecution that my evidence really belonged to the defense. In court, the defense used my evidence to win the case. The court shocked me when the judge, after his ruling, returned the weapon that was used to cause injury, to the one who had used it. That judge later got himself mixed up with big lawyer people and was chased out of court.

The second time I went to court, the accused pleaded guilty before I gave my testimony, which would have set him free. I believed the accused stole two dollars from my home, after breaking my window and entering it. He was arrested because he fit the description I had given and because he was found in our village. I expected if I got to the stand that I would have been asked to swear on the Bible that the person in the dock had entered my house. There are a few special individuals who with one glance at a stranger can pick them out of a police lineup of similar-looking people. I'm not gifted that way.

I didn't have any guilt trip later, becuse the accused had a string of other charges pending that were similar to the breaking and entering charge in my village. But you know why I rehashed those stories? The first is wikidnis. The second is that in a murder trial with a jury, all a defense lawyer has to do is shake an eyewitness testimony, and his client gaan clear. But in a murder trial with a judge, defense lawyers have to do a whole heap more than make a reluctant eyewitness waver.

The lawyers never produced a pound of beef, but they eat rib-eye. Fair enough, if rich people want to pay them the dough. But we can do much better with the ones we can afford, if we give them the support they need. My, former PM Manuel Esquivel hit the nail directly on the head. Ouch, lawyers taking morality to a foreign court against big business. And we paid them through our noses for that! It's nothing but a charade, a sham.

How could any formidable lawyer so misunderstand the system he was brought up in? Bah, Hubert Elrington once said of our former leader that he was all glitter and no substance. Because our PetroCaribe soft loans and BNE taxes were such a large sum that the UDP couldn't waste it all, along the way, we got some real pretty toys. 





#### 1. BACKGROUND

- 1.1 The Government of Belize, through the Ministry of Finance (MOF) is embarking towards the modernisation of the tax administration by merging the existing IncomeTax Department (ITD) and the Department of General Sales Tax (DGST) into a single function-based tax administration, and procuring and implementing a new Integrated Tax Administration System (ITAS).
- 1.2 In order to facilitate the process, the Tax Modernization Program was initiated and comprises of five main projects/components including: (a) Communication and Change Management; (b) Organization/Human Resources (HR)/Infrastructure; (c) Business Processes Reengineering; (d) Legislative Framework; and (e) Information Technology. These will be implemented in phases, with the existing core areas of the ITD and DGST operating as the new, consolidated functional organization, the Belize Tax Service (BTS).
- 1.3 To support this endeavour, the GoB has requested the support of the Inter-American Development Bank (IDB) to fund a five-year project "Strengthening of Tax Administration" (BL-L1031). The main objective of the Project is to strengthen Belize's tax administration aimed at increasing tax revenue collection, through the following specific objectives: (a) increasing the effectiveness of the Government to collect taxes, through improvement in the tax administration governance and; (b) increasing tax administration efficiency, through improvement in the operational processes and modernization of the technological infrastructure.
- 1.4 A Program Management Office (PMO) supports the implementation of the Program along with the consolidation of the BTS. The MoF is the Executing Agency (EA) of BL-L1031. For this purpose, a Project Executing Unit (PEU) will be established in the PMO with concrete technical, administrative, financial, control and planning, monitoring and evaluation responsibilities for the IDB-funded initiative.
- 1.5 In this regard, a vacancy exists for the Procurement Officer for the PEU under a contractual arrangement with the MoF, and as part of the BL-L1031 initiative.

#### 2. OBJECTIVE AND SCOPE OF WORK

2.1 The objective of the position is to lead the execution of the procurement activities of the PEU in accordance with the provisions of the Project and the Bank's procurement rules and procedures and the MoF procurement guidelines, when applicable. In particular, the Procurement Officer is responsible for the overall and day to day activities for the procurement of goods, services and works of the Project subject to IDB policies and requirements and in accordance with the Project Operational Manual (POM).

#### 3. **RESPONSIBILITIES/ACTIVITIES**

- 3.1 The main responsibilities of the Procurement Officer include, among others:

  - (d) Prepare necessary bidding documents, prepare the Terms of References (ToRs) and review specifications prepared by Technical Staff, organize and execute all bid openings and evaluation processes, prepare evaluation reports and corresponding draft contracts.
  - (e) In coordination with the Project Coordinator and Financial Officer, prepare the ToRs and bidding documents for the annual audits.
  - (f) Ensure contracting of consultants, suppliers and contractors is in accordance with IDB procurement policies and GoB policies, laws and regulations.
  - (g) Ensure that prospective contractors, suppliers and consultants are duly constituted and are ongoing concerns.
  - (h) Issue contracts for signature by relevant parties.
  - (i) Manage the validity of contracts during their execution.
  - (j) Assist the Project Coordinator in the submission of monthly activities reports and prepare the quarterly procurement reports following a pre-approved Bank format.

BELIZE CITY, Wed. June 1, 2022 Two of three men who were reportedly involved in a robbery at Midtown grocery store on Albert Street on Saturday

afternoon, May 28, have been arrested. It has been reported that at about 3:35 p.m. that day, 22-year-old Shawn Humes and 23-year-old Selvin Waight, who both reside on Wagner's Lane, which is located near to the store, allegedly pointed a gun at the owner of the store, Layas Ahmad, through the security bars and forced him to let them into the establishment. When they were inside, they began what was apparently a search along the aisles of the store, then they reportedly pushed Ahmad to the back of the store, and they began searching behind the counter until they found the spot where Ahmad's cash was stored. They then took the cash and proceeded to leave the establishment, reportedly with a third person who had been on the lookout outside the store while his companions carried out the robbery inside.

Humes and Waight were caught by police and were arraigned on Tuesday, May 31, before two separate magistrates, despite being charged with robbery for the same incident.

Both men pleaded not guilty; however, due to the nature of the offense, they were denied bail and remanded to the Belize Central Prison until July 25, 2022.

Police are in search of Zerrick Ramos, who they believe was also involved in the robbery and played the role of a lookout.

The robbery on Saturday was the third time that Midtown grocery store has been robbed since it opened in 2019.

Earlier this week, the Police Department's communications director, ASP Yearwood, told reporters, "... I mean, this is a daring Albert Street Robbery, one of the streets that I consider the safest in this city. And for them to come and ruin people's thoughts about Albert Street, by doing something like this, we have to bring them to justice."

## **Public Service going digital**

### GOB and UNDP launch digital transformation course for public officers



#### BELIZE CITY, Wed. June 1, 2022

An initial cohort of 40 public officers will undergo an intense 4-week training in digital transformation. The coursework that will guide the training—"The Digital Transformation in Belize Course" was tailor-made by the E-Governance and Digitalization Unit and the United Nations Development Program (UNDP) with the aim of equipping Belize's public officers across both local and central government with the tools necessary to address the needs of citizens and customers seeking to access government services online.

CEO of the Ministry

of E-governance, Jose Urbina, said that the project is being funded by the UNDP in conjunction with the government of Belize. "Our main objective is for us to be able to facilitate the process for our citizenry so they are able to apply for a birth paper, and apply for a police record, or any services that are facing their needs in a much easier and resilient manner," CEO Urbina said.

This effort marks the start of the rollout of digital public service, which is a key part of the National Digital Agenda that was launched by the Briceño administration last year, and it is expected that the transition into online service will help remove many of the bottlenecks that have reduced speed and effectiveness of service inside key government offices.

"We've partnered with the UNDP in executing a tailor-made course for public servants ... it's gonna be four modules, whereby they are going to learn best principles in how do we adapt new services going online, what are the principles for infrastructure, but how do we do so in very safe protocols and ensuring that the safety of our citizens is a priority when we are going online," said Director of the E-Governance and Digitalization Unit, Alexia Peralta.

The course is geared at providing public officers with the skill set that will be necessary for them to engage in capacity building within the public service and various sectors of municipal government. Subsequent to their participation in the course, those public officers and municipal personnel will return to their respective ministries and identify the ways in which they can make the process more efficient. This process of assessment will then bring into clear view the digital gap within ministries so that plans and programs can be designed to address such gaps, said Peralta.

"It's really and truly a program that was highlighted in the National Digital Agenda that we launched last year in highlighting the need to also understand at a micro level, at a ministerial level, what are some of the challenges we have in going online and how do we best support that transition progress throughout the next couple of years," Peralta said.

The Ministry of Governance's CEO, Jose Urbina, said that this transition to a digital public service will hopefully reduce the large amounts of time spent waiting in line to access government services and will reduce the likelihood of exploitation by corrupt public officers who request payment from the public in exchange for the fast-tracking of services.

"Unfortunately, that has been the perception, and in fact the case, not the perception, and what we seek to do is look at high impact areas ... Lands, Vital Statistics, Immigration. Those are the departments where we see long lines, and long lines of frustrated Belizeans, that they need to go apply for a document to be told that they are missing something. The outcome and our vision is for us to facilitate these services and not only to digitize and to allow for digital transformation within these departments but also to connect them together," Urbina said.

This interconnectivity of data from various ministries and departments will aid in fast-tracking the processes used by citizens every day, but could also lead to an increased security risk, since personal information will now be stored in an online environment. CEO Urbina drives home the point that compliance with all security regulations will be key. "If you have processed or renewed a passport and you have given your information, and you need to go do a police record, for example, and you need to input similar information, then the databases would be shared, and the information would be pulled out and populated in the new form-the digital form that you are now applying for, so this is the interoperability functions that we are seeking to achieve between ministries and, of course, in compliance with all the security and the data-sharing act that we must comply with to ensure that the citizen data is being shared securely across networks," Urbina explained.



# SHRIDATH RAMPHAL CENTRE: TRADING THOUGHTS IS THIS THE CARICOM WE WANT AT FIFTY?

Forty-nine years ago, regional Prime Ministers agreed to the establishment of the Caribbean Community (CARICOM). Since then, the region has had numerous successes and advancements in deepening regional integration. As the region counts down to CARICOM's 50th anniversary, the author is pondering: What is in store for CARICOM at 50? Will there be an acceleration of integration? Or, will there be a meaningful pause on our progress? This current generation of leadership inherited several trade barriers as a result of outdated legislation prohibiting intra-regional trading within the region. We need to prioritise trading within the region and removing the outdated barriers to regional trade so that goods may move freely.

We continue to speak about achieving food security, but the only way this can be achieved is by comprehensively determining the external and internal factors affecting our countries' food system. Within CARICOM, the regional Presidents and Prime Ministers comprise the main decision-makers; however, they are guided by several technical organs. There is a need to move beyond the ministerial meetings and convene business-to-business meetings, distributor sessions, trade missions and establish regional consumer watchdogs. The region has been missing a dedicated voice of the people, for the people, by the people who will argue that we do want cheaper chicken in our supermarkets from Guyana or Trinidad. The regional consumer watchdog should be the entity to argue that we want access to

the cheapest high nutrient fruits and vegetables across the region, even if it means we can get Belizean oranges that usually sell 10 for US 50 cents or Trinidadian locally grown pineapples that dwarf any imported ones. We need an entity that is truly interested in working around trade barriers to ensure that a basket of goods for a 4-person household in any single CARICOM member state should not exceed a week of minimum pay.

The Private Sector would argue that trading within the region has its unique challenges due to logistics and its desire to trade in large volumes via containers. I would argue that regional businesses should first establish demand within the CSME Member States and settle on at least 2-3 pallets per destination rather than a container load. Rather than imports from the Canadian manufacturer, Lassonde Industries, the owner of the popular Adam and Eve fruit juices, our supermarkets should stock the entire TruJuice line owned by TradeWinds Citrus Limited from Jamaica. Larger private sector entities should consider establishing intraregional distribution points as a means of sharing the contents of a bi-monthly container, which should then be distributed across the Caribbean.

The future must include the reduction of regional asymmetries. I remain concerned that the majority of the Caribbean population do not have access to affordable and modern medical science or health care. I'm concerned that in Haiti, the Covid-19 pandemic will live on past the 2022 regional timeline because of the lack of data being collated as to the number of Covid-19 patients and survivors; I'm concerned that in Jamaica the ordinary man's access to vaccines will be determined by a capitalist way of thinking rather than a welfarist position, and I'm concerned that in St. Vincent and the Grenadines, the right of a mother to safely deliver a baby in the public system is woefully inadequate and does not meet a basic regional standard. Could it be that we've dropped the ball and refused to impose standards or even regulations? Could it be that we've stopped being our neighbour's keeper and prefer to operate as islands alone in the big Atlantic Ocean? Could it be that we've stopped prioritising our CARICOM Community?

There must come a time when we choose to look within the region first, and research and determine what services and goods can be provided within the region. Formal policymakers may not consider this, but it is hoped that this message reaches them that the Caribbean region can provide for our needs and wants. Let us not venture out extra-regionally to Third States but consider what can be found intraregionally. A perfect example of this: the enterprising Barbadian fishermen are now forced to venture 178km to Kingstown, St. Vincent and the Grenadines to refuel their fishing boats with cheaper diesel than in Barbados.

We need immediate bridges, whether by air or via sea or physical bridges connecting the landmasses of the CARICOM region. We need immediate 24-hour connectivity for our goods, people and services to move. With this connectivity, we need a single domestic space to reduce pressure on the ports of entry to ensure that they can truly function and focus on our regional development. Let us create spaces for those amongst us who work directly with cargo; we need to train stevedores and truckers who can facilitate this hourly movement across and within our borders. We need businesses and service providers specialising in sustainable transport and the blue economy. As the summer of 2022 approaches and the Caribbean Community plans to launch the 50<sup>th</sup> anniversary celebrations, the region is at the proverbial fork in





## Full speed ahead for vaccination of kids

#### BELMOPAN, Tues. May 31, 2022

The Ministry of Health and Wellness began its campaign for the vaccination of children aged 5 - 11 this week following an official ceremony during which it received 124,800 doses of the Pfizer pediatric vaccine that were donated by the Republic of Slovakia through funding from the European Union (EU).

Speaking at the ceremony, which took place on Tuesday, were Mr. Xavier Canton-Lamousse, Team Leader of the EU Technical Support Office to Belize; Ambassador Amalia Mai, CEO of the Ministry of Foreign Affairs, Foreign Trade and Immigration; and Dr. Julio Sabido, CEO of the Ministry of Health and Wellness.

Dr. Julio Sabido remarked that the procurement of COVID-19 vaccines has been one of the country's greatest achievements during the past three years of the pandemic.

"Throughout all the uncertainties of COVID-19, there is the certainty that COVID-19 vaccines protect against severe disease and death," he remarked, also noting that up until now, children under the age of twelve have been completely unprotected against the virus.

At a press briefing held last week by the Ministry of Health, Karl Heusner Memorial Hospital pediatrician, Dr. Cecilio Eck also highlighted this fact. Eck, a recovering COVID-19 patient, stressed the importance of vaccinations and pointed out that, with the relaxation of COVID-19 health measures, the country's pediatric population remains one of the most vulnerable groups in Belize.

According to the Health CEO, the Ministry's vaccination campaign has so far been received positively by members of the community.


At present, the Pfizer vaccine is the only one with a formulation for 5 to 11-



year-olds. The donation of 124,800 doses has provided the country with enough vaccines to give at least a first shot to the entire target population of 76,000 children.

The donation was made possible through the funding of the European Union. During his remarks, Mr. Xavier Canton-Lamousse noted that the EU has been working in partnership with PAHO for almost 20 years to improve the quality of healthcare in Belize.

**NOTE**: In a previous article it was reported that the donation was made by the country of Slovenia. The donation of Pfizer pediatric vaccines was given to Belize by the country of Slovakia and was funded by the EU.

## Cyclist knocked down on Stann Creek Valley Road

STANN CREEK, Wed. June 1, 2022 On Friday night, May 27, Francisco Pop, a 47-year-old field captain, was knocked off his beach cruiser bicycle by a moving vehicle near Mile 14 on the Stann Creek Valley Road.

the main ways the zoo, a non-profit organization, keeps its animals fed visitors are encouraged to donate fresh fruits, vegetables, and meat if possible, paying homage to Sharon's strategy of garnering in-kind support to keep the zoo running.

"In the very early days of the zoo, when there was no income, no structured sources of income coming in, she would give free tours and show people around the zoo, and in turn, people would give a little something from their own backyard. So if they had extra mango, some extra live chickens, or whatever it may be, this is how they kept the zoo shored up," he added.

According to Andrewin-Bohn, inkind donations, especially of fresh produce and other agricultural products, were how the zoo survived not only in its fledgling years but during the COVID-19 pandemic as well.

While the zoo has still not-fully recovered from the effects of the pandemic, it has come a long way: having gone from reducing its total number of employees from 58 to 30 at the height of the pandemic to employing over 40 persons this year.

"We're slowly recovering; we're getting back on our feet. Our programs are coming back ... we're seeing more visitation, so that means that we're in a better position to feed the animals, pay the staff, keep the lights on and do more

The Ministry of Public Service is conducting a customer service survey to gauge the customer service capacity of public officers and pinpoint areas for improvement. Minister responsible for both Public Service and E-Governance, Hon. Henry Charles Usher, said that both the survey and the digital transformation will help improve the public service which he said coincides with an effort within the Quality Service Unit to look at the quality assurances across the public service.

"I look at one department, for instance, Vital Statistics. I can't understand why it is that somebody has to travel all the way here from Toledo to apply for a birth certificate. This should be done online; this should be done digitally," Minister Usher said. Creating systems that protect citizens' data will be of key importance in this transformation. In Belize and across the Caribbean, cybercrime has been on the rise, largely by smaller groups of hackers and individuals. Forms of cybercrime include phishing, which involves hackers posing as institutions to target users, as seen in attacks on banks and individuals in Belize. Ransomware is used to steal money from businesses by taking their encrypted data for ransom. Data theft occurs when a company's or government's data is stolen by hackers and sold on the black market. There are also brute force attacks on websites and servers to crash or slow down service.

of the socially oriented programs that we used to do before the pandemic," Andrewin-Bohn said.

This Saturday, visitors will also have a chance to meet the many faces that help to keep the Belize Zoo and Tropical Education Center up and running, as the entire management and staff will be present on-site along with a host of tour guides.

The zoo will be offering various souvenirs, including commemorative tshirts as well as free copies of the children's book *Adventures of Hoodwink the Owl*, which Matola authored.

Ever since its establishment in 1983, the primary focus of the Belize Zoo has been showcasing native wildlife and providing a home to animals in need. It was created after Sharon Matola, then in her late twenties, was left to care for 17 animals that had been used in a wildlife documentary. Those animals, tamed and used to humans, could not be placed back in the wild. In a 1995 interview with *The Washington Post*, Matola explained how she was at a crossroads when she had to decide what to do with them.

"I either had to shoot the animals or take care of them, because they couldn't take care of themselves in the wild," she'd stated.

Over the next four decades, what began as a small "backyard" menagerie of a few animals, including two jaguars, two macaws, a boa constrictor, and a few parrots, would grow into a home for over 200 animals belonging to over 45 species, all native to Belize.

All of the animals at the Belize Zoo have either been born at the zoo, rescued, orphaned, rehabilitated, or donated by other institutions—one of the many aspects of the zoo that have earned it the title of "Best Little Zoo in the World".

## The problem of Creole historiography

The pre-devaluation history of modern Belize is the history of the development and dominance of a Creole society. While other ethnic groups may have inhabited the land area of the country and figured in the census rolls, they were, in the words of Dr. Grant, " ... in the colonial society but not OF it."

For all practical purposes, until the political awakening of December 1949, the local politics and economics of the Colony were made and manipulated in the capital, and the capital was Creole and elitist. The values and attitudes of the Creole "aristocratic" families" with whom the Colonial Government shared power were the forces which dictated not only the Colony's constitutional and economic progress, but also the Colony's vision of its own history. That vision, understandably, was one which equated the history of the Colony with the history of the development of the Creole majority and particularly with the history of the privileged class within that group.

#### THE TRADITIONAL HISTORY

It was traditionally a glorious history. It originated with the British logwood cutters and their slaves who had successfully beaten back the might of Imperial Spain in 1798. The victory at St. George's Caye, it was held, was only made possible because of the unity of purpose between master and slave — a unity which was unique because "slavery hardly existed in the Settlement." It existed to the degree that emancipation was necessary in 1834, but this too was hailed as a triumph of British liberalism, for it bound black and white together in their devotion to the British throne: a coming together, manifested in the steady creolization of the population after 1838 as intermarriage between the descendants

of the old Baymen and those of the free-coloured and ex-coloured and exslaves, became more frequent. Between the end of the apprenticeship and the 1880s, a Creole society had come into being.

It was a society which venerated the European genes in its composition. The mother country was the master of the world and the Creole, of all the disparate groups of the Colony, was the most closely linked with the master race. The elitist sons of that race came from the mother country to administer the Empire's only Central American colony and the Creole aristocracy was on hand to aid them in so doing.

Colonial administrator and Creole aristocrat fed off each other in a community of interest. The one sought to divide and rule by being a separate, privileged class over the inarticulate labour force: the other sought to imitate the overlord's culture and to retain its stranglehold over the Colony's

economy and labour by a show of deference to the Imperial power. In such a way both the loyalty of the Colony to the Empire was retained, and the Creole elite's capture of the Colony's wealth and institutions were preserved and entrenched.

This symbiosis was nurtured not only by the mythology and romance of the past but by continuous contact, blood sacrifice and the aspiration of imperial award. The Creole elite sent its sons to walk in the fair meadows of the Cam and the Cherwell, and encouraged them to regard Oxford, Cambridge, Edinburgh and London as their spiritual homes. For not only did the sons of Empire live to protect those fields and cities, but they died also in Picardy and Flanders and in the Battle of Britain, and were buried in foreign but not alien soils far from the yards they had known as children.

For the survivors, the hope of an imperial decoration was the crowning achievement. In war as in peace, the honours of Empire were as much a part of the Creole elite's aspiration as was the accumulation of wealth in commerce or in the professions.

The commitment to the Empire and the British throne by this privileged class was sincerely held and the rewards sincerely attained, but it could only last while the psychology of Empire lasted. With the attack on imperialism and colonialism after 1945, the Creole elite was faced with a crisis of conscience. The new political forces were not only anti-imperialist but anti-British. It was no longer just the pin-pricks of carping at the lethargy of constitutional change and at economic development, but an attack on the very foundations and fundamentals of the belief in the British way of life. In being so, it was just as much an onslaught on the Creole aristocracy as it was on the British administration, and in the ensuing conflict the privileged class had no choice but to align itself with the old order and against the forces of "treason" and "revolution" which sought to topple the king and sweep away his court and favourites as well.

The outcome of the struggle was never in question, because a new world order was in the making, but apart from the political crisis of 1949-54, which was the manifestation of the Belizean experience of that trauma, there arose and still arises the problem of the redefinition of Belize's history.



Following are some excerpts from that release:

"The group stage of the second edition of the CNL will be played in June 2022 and March 2023 with home and away play across the region, prior to a centralized CNL Finals in June 2023 which will include the League A group winners competing to be crowned 2022/ 23 Concacaf Nations League champions."...

"The CNL was established to create a more consistent set of matches for all men's national teams across the region. Teams were split into Leagues A, B and C and the competition provided an exciting qualification route to the 2021 Gold Cup. The CNL also includes promotion and relegation between editions, creating opportunities for all teams to move within the system as they improve, and to dream of reaching new heights."...

"The 2022/23 CNL will qualify teams to the 2023 Concacaf Gold Cup in a format which will ensure intense competition on the field throughout the group stage. CNL League A group winners and runners-up, and League B group winners will qualify directly to the 2023 Gold Cup group stage. CNL League A group third place finishers, League B group runners-up and League C group winners will qualify to the 2023 Gold Cup Preliminary Round."

"The CNL campaign will commence with six matches on Thursday, June 2, 2022. Anguilla vs Dominica (4pm ET) kicks things off in League C, prior to four League B matches including French Guiana vs Guatemala (5pm ET), Belize vs Dominican Republic (6pm ET), Barbados vs Antigua and Barbuda (7:30pm ET) and Guadeloupe vs Cuba (8pm ET). A Central American rivalry will kick things off in League A with tomorrow night's Panama vs Costa Rica (730pm ET) match sure to capture the imagination of fans in both countries."

Twenty-three players were named to represent Belize in a series of games in a bid to qualify for the CONCACAF Nation's League.

The Football Federation of Belize (FFB) has announced the names of the twenty-three players who will be representing Belize on the country's men's national team, which will be participating in several matches in the next two weeks in an attempt to qualify for the CONCACAF Nation's League.

The qualifying match is an opportunity for the national team to make it to the seventeenth edition of the CONCACAF Gold Cup in 2023. The selected players include Belizean footballers who are playing in countries such as the United States, Honduras, and the United Kingdom.

Ian Jones, team manager of the national men's team, told reporters, "When we had the opportunity to go to Gold Cup, we lost three points because we were unable to land in French Guiana. This time around, we didn't take that chance. Our tickets have been booked over a month ago; everybody has their French visas to enter, and so French Guiana won't steal three points from us this time. They need to win it on the field. I want the public to know this won't be like last time."

Evral Trapp, captain of the team, expressed optimism about the team's chances for victory at the games. "We have some experienced players and we

got some young players, and we got a good mix, and I think if we go out on Thursday and move the ball like how the coach [wants] and we do it as a group, I think on Thursday, we should get that victory [that] we need," he said.

Deon McCaulay, a striker on the team, also is hopeful about the team's prospects for qualifying for a CONCACAF Gold Cup spot.

"First of all, I think we have a very talented group of players right here. It is not impossible for us to make the Gold Cup with the team that we have. It is just up to us to give a hundred percent [to] the country, and I would like more passion from the people, not

only on social media but also in the stadium. I personally think that we have a very good group. I know that everybody here is going to give a hundred percent, and with the competition that we have, the hardest team would probably be Guatemala, but we are not [underestimating] anyone. But for us, we are going into each game one at a time and [getting] a result in each of the [games] that we are playing. And if we do that, we'll definitely make it back to the Gold Cup," he said.

### WHO: Monkeypox likely won't become pandemic

And as of Sunday, May 29, there have been over 200 confirmed Monkeypox cases in countries where the virus is not endemic. Most of those cases have not been linked to travel to endemic nations.

When asked whether the outbreak has the potential of becoming a global pandemic, Technical Lead for Monkeypox at the WHO, Rosamund Lewis stated "we don't know, but we don't think so."

Lewis also stated that, while the organization is not concerned about a global pandemic, there is currently a window of opportunity for the world to collectively stop the outbreak. According to a report by CNBC, Sylvie Briand, the Director of Epidemic and Pandemic Preparedness and Prevention at WHO, stated that the organization does not want people to panic and think that the viral outbreak is like COVID-19.

In its Disease Outbreak News update, the WHO outlined ways in which the public can protect itself from the virus, including being aware of symptoms, practicing good hygiene, and practicing safe sex.

The Monkeypox virus causes usually mild flu-like symptoms quite similar to those of now-eradicated smallpox, including a pustular rash, fever, headaches, muscle aches, swelling, and back pain. It is transmitted through lesions in the skin, bodily fluids, or contaminated materials such as bedding. Its incubation period is normally 6 to 13 days. Unlike the Varicella virus, which causes chickenpox, lesions caused by the Monkeypox virus appear mostly on the face, arms, and legs as well as the eyes, mouth, and genitals. Named after having been identified in monkeys in a Danish lab in 1958, Monkeypox is endemic in several areas in Central and West Africa. While the first human case was identified in 1970, it remained mostly unnoticed until the final stages of the eradication of smallpox.

Health experts have yet to learn more about its genetic makeup apart from the fact that it is a DNA virus, meaning it is unlikely to be transmitted or mutate as easily as RNA viruses such as COVID-19.

According to the WHO, the smallpox vaccine appears to be 85% effective at preventing Monkeypox.

As cases in non-endemic nations continue to rise, the African continent has reported up to three times as many cases in just this year, Associated Press News reports. And while nations like the US and Germany have begun to deploy hundreds of vaccines, Dr. Adesola Yinka-Ogunleye of Nigeria's Monkeypox working group has noted that such measures have never been employed in the countries most affected by the virus. "It's a bit uncomfortable that we have a different attitude to the kinds of resources we deploy depending on where cases are," noted Dr. Jimmy Whitworth, a professor at the London School of Hygiene and Tropical Medicine who called this a "moral failing".

## **Stake Bank's** appeal denied

Environmental Clearance Plan (EPC) granted by the Government of Belize to Portico Enterprise Limited, which is aiming to construct a cruise port that would directly compete with Stake Bank's cruise terminal. On April 26, Stake Bank Enterprise Limited, the developers of the Port Coral cruise ship facility, applied, via attorney Andrew Marshalleck SC, for leave to appeal the decision, but on Monday, Justice Lisa Shoman dismissed that application.

Stake Bank first made its application for judicial review back in July of 2021, asserting that the granting of Portico's ECP was unlawful and did not meet statutory requirements. Its lawyers, Glenn D. Godfrey and Company, represented by William Lindo, Jr., at the time managed to get leave for their case to be heard, but Justice Shoman ruled that they failed to file the substantive application within the mandated 14day-period. Lindo had insisted, however, that the application had been submitted online before the deadline.

The application was eventually struck down, and the request to appeal Justice Shoman's decision has now also been denied, thus ending this particular legal effort by Stake Bank Enterprise Limited to have an inquiry launched into the economic viability of the construction of other cruise ports within Belize City. This is unless that company decides to take its matter to the Court of Appeal.

Another interested party in this case is Waterloo Holdings Limited, the proposed developer of a cruise and cargo port facility at what is now the Port of Belize Limited. That company's effort to receive environmental clearance for their project was rejected by the National **Environmental Appraisal Committee** (NEAC). They have appealed to Minister of Sustainable Development, Hon. Orlando Habet, but have since decided to submit a new application. Habet has indicated that, in this case, the appeal will have to be withdrawn.

Recently the Minister of Tourism has pointed to the need for docking facilities in the country that can facilitate the major cruise ships they are in conversations with, and reduce the use of tendering. (He did not indicate whether his ministry had assessed the potential environmental impact of such a move and whether the additional revenue would justify the damage that could be caused.) The construction of Stake Bank Enterprises Limited's Port Coral facility is well underway and is located about 12 miles from the development at Port of Magical Belize. Between the two is Waterloo's proposed cruise and cargo facility.

## Florencio Marin, Sr., the savior of the sugar industry?

The senior statesman, long retired, has been contracted by the government to advise SICB in ongoing sugar industry negotiations, Agriculture Minister Hon. Jose Mai says there is no one more experienced in, or knowledgeable of, the sugar industry. PSU president Dean Flowers calls it a "slap in the face" of young public officers.

impasse in negotiations between BSCFA and BSI caused a delay in the start of the sugar crop in December. It had been initially hoped that earlier that month the two parties would have finalized the terms of a new commercial agreement prior to the scheduled expiration in January 2022 of the agreement that was previously in place. But the BFSCA had insisted that the revenue-and-cost-sharing formulas in the agreement be altered in the new agreement so that farmers could get a larger share of the earnings, while ASR/ BSI had insisted that, following the millions they had invested in updating production processes, such a concession was one they couldn't afford to make. Both parties refused to budge, resulting in a week-long postponement of the start of the processing of harvested cane. During that period, members of the BFSCA used their trucks to block the entrance to the ASR/BSI factory, and even after the interim agreement was finalized and operations resumed, the relations between the two parties were still strained—and there were threats of lawsuits by BSI and other northern sugar growers associations for the losses they reportedly incurred as a result of the standoff.

Interestingly, when the interim agreement between ASR/BSI and BSCFA had been signed-thus allowing the commencement of milling at the start of January, the AMANDALA, in an article dated Wednesday, January 5, 2022, had stated, "Joining the Prime Minister in the efforts to broker a truce between the parties were other northern area representatives, Florencio Marin, Ramon Cervantes, Ramiro Ramirez, and Agriculture Minister Hon. Jose Mai. The BSCFA chairman told local media that their involvement fasttracked the process."

That article also noted the continuing bitterness in the relations between BSI and BSCFA, when it stated, "The company, in a release issued on December 30, stated, 'BSI does not condone the illegal tactics and threats of violence to pressure concessions from the mill. There is no place for such a tactic in a modern sugar industry. This will only damage the credibility of the whole industry, and call in question whether under such a volatile atmosphere it will be safe to operate the mill." With the stakes as high as they are, experience and expertise will be key to striking a balance that ensures both parties are willing to continue to play their respective roles in generating sugar export revenue, which is so critical to the well-being of the economy, and both the Prime Minister, Hon. John Briceño, and Minister of Agriculture, Hon. Jose Mai, in the face of questions about the propriety of hiring someone with such close ties to Cabinet, have publicly stated that they believe Marin, Sr. is the person who is most equipped to salvage the very volatile sugar industry.

During remarks on Friday, Minister Mai said, "Mr. Marin is a very wellrespected and known gentleman in the sugar belt. He has a long of friends and people who respect him in the sugar industry. The sugar industry right now in the north is in a very difficult situation because of the new agreement that the farmers and the millers need to sign, and there is a lot of tension. I think that bringing on Mr. Marin, as a person who is well-respected and a very experienced politician, would bring some kind of resolution to this, so to speak, conflict between the cane farmer and the association."

PM Briceño, for his part, said that the inclusion of Marin in the process might in fact keep the parties at the table in the negotiations to come.

"Everybody knows that Florencio Marin is one of the most knowledgeable persons when it comes to the relation between the cane farmers in BSI. We had in the 28th of December in 2021, we had a strike by the farmers and they shut down the mill for almost about a week. The factory claims that they lost about a million dollars. Farmers lost probably the same, and we believe that at this critical moment when the farmers and BSI continue to negotiate for a commercial agreement, that it is important that we can have someone that is able to speak to both parties and to keep them together without fighting," PM Briceño said. (Notably, prior to the signing of the interim agreement, cane farmers had marched to the Prime Minister's home and demanded his resignation.)

The Prime Minister said that he asked Marin, Sr., to serve as an advisor who will facilitate the negotiations at a very critical juncture-when both parties (BSCFA and ASR/BSI) are on the edge. And a Ministry of Agriculture memo dated April 26 reportedly confirms that such an arrangement was made with the senior Marin. "We don't want another strike to occur. We don't want cane fields being burnt down, and that you know, that we have a sabotage. We want to make sure that the sugar industry, an industry that has a direct impact on the people of the north in the Orange Walk and Corozal District, an industry that has a direct impact on our 5,000 cane farmers, that we can keep things calmly, that we can keep both sides together talking at all time, and hopefully for the next year or so that he can help us to be able to move this industry forward," PM Briceño said. Members of the United Democratic Party, however, have condemned the decision to hire Marin Sr. (the father

John Bodden, the Ministry's Health Disaster Coordinator, told local reporters about the importance of the annual meeting, normally held before the start of the hurricane season, as well as the importance of collaboration within the health sector.

"We have to recognize that there is no one single entity in this country that can have all the necessary manpower or human resources that are required for a response. And so whenever we come together, we can network, and we can collaborate, and we can agree in terms of how we can provide effective

of the Attorney General, Magali Marin Young, and Minister of National Security, Florencio Marin, Jr.), who will reportedly be paid \$36,000 for his oneyear tenure. UDP chairman, Senator Michael Peyrefitte, mentioned during remarks to reporters, that while he respects the veteran statesman, he does not think he should be paid \$36,000.

"I have great respect for him, but one, I don't think he needs thirty-six thousand dollars; two, I don't think you can keep hiring people like that, especially the father of two sitting government ministers in the face of you telling public servants that they can't get their increases back, you can't institute a five-dollar minimum wage. You cannot in that environment hire the father of two ministers to work in the sector," Peyrefitte said in an interview with local media.

He added, "I don't think that there is a need for Mr. Marin to make an additional salary. Why can't he in the goodness of his heart, with all his experience in the sugar industry just come and offer his services as a friend to the government and as a friend to communication and response to the general public," he explained.

Bodden also took the time to underscore how important it is for families to prepare for disaster as well. A proper family preparedness plan, he says, is essential for an effective response.

Also present at the meeting was the Chief Executive Officer of the Karl Heusner Memorial Hospital (KHMH), Chandra Nisbet Cansino. As the only tertiary referral hospital in the country, Cansino noted, the KHMH must always be prepared for disaster, and the CEO says that they are.

"Our standard plan is that we withstand up to a Category 3 [hurricane] at the KHMH, and anything beyond a Category 3, we evacuate," she said.

"The critically ill patients would come to the Western Regional Hospital area. And then, we are a referral hospital, so if we have patients that are referred to us, they would then be referred back to their respective hospitals and other patients would be shared between San Ignacio Hospital, Western Regional, and possibly Orange Walk Hospital," she added.

### **El Salvador committing** 'massive' rights violations, Amnesty says

At least 18 people have died in state custody during sweeping gang crackdown, Amnesty International says in new report.

Authorities in El Salvador have committed "massive human rights violations" in a sweeping gang crackdown, Amnesty International has said, including arbitrary arrests, violations of due process, torture and ill-treatment.

In a new investigation released on Thursday, the UK-based rights group said at least 18 people have died in state custody since the administration of President Nayib Bukele in late March declared a state of emergency to stem gang violence.

The figures come from Salvadoran nonprofit organisation Cristosal, which said all those who died had been male. Some died due to lack of timely medical attention and others had shown signs of suffering aggression, such as bruises, it said.

Amnesty also pointed to mass hearings of up to 500 detainees charged at the time. The majority are prosecuted, even in the absence of evidence, according to the report.

"On the pretext of punishing gangs, the Salvadoran authorities are committing widespread and flagrant violations of human rights and criminalizing people living in poverty," Erika Guevara-Rosas, the rights group's Americas director, said in a statement.

"Instead of offering an effective response to the dramatic violence caused by gangs and the historic public security challenges facing the country, they are subjecting the Salvadoran people to a tragedy," Guevara-Rosas said.

Bukele's government declared a state of emergency on March 27 following a record surge in homicides in the Central American nation.

Rights groups and United Nations experts have slammed the move, which sent troops into the streets and gave security forces powers to arrest people without a warrant, among other curbs to

But despite the criticism, the Salvadoran government has defended its policies.

On Wednesday, during a speech marking his third year in office, Bukele said his government was on the verge of "winning the war against the gangs" and questioned the countries and international groups that have accused his administration of abuses of authority and human rights violations.

"Whatever they say, whatever they do, whatever they write, they attack again and again, I tell you: They are not going to stop us. We have God and the Salvadoran people on our side," Bukele said.

El Salvador's presidency, the justice and security ministry, the police and the army did not immediately respond to requests for comment from the Reuters news agency about the content of Amnesty's report.


Gangs thrived during El Salvador's civil war from 1979 to 1992, then spread throughout Central America and into part of Mexico. The Salvadoran authorities have estimated that there are approximately 70,000 gang members in the country.

On Wednesday, Bukele's security minister, Gustavo Villatoro, pledged that the government's "war" on gangs will continue, even though the homicide rate has dropped sharply. "This war is going to continue for as long as necessary and to the extent that the public continues to demand it," Villatoro said.

## **Agatha claims 9** lives; 4 missing

BELIZE CITY, Thurs. June 2, 2022

The first hurricane for the Eastern Pacific hurricane season, Agatha, made landfall on Monday as a category two storm. Mexican authorities have confirmed that 9 persons lost their lives and 4 others are currently missing as a result of the storm.



Hurricane Agatha knocked out power and telecommunication services near the coastal town of Puerto Angel on the Pacific coast before dissipating as it traveled through Mexico-its remnants emerging in the Yucatan Peninsula.

now a tropical disturbance in the Atlantic basin, is headed in the direction of Cuba and Florida, and was located just on the tip of the Yucatan Peninsula today at 4:00 PM CDT.

The system has a 90% chance of formation over the next 48 hours, the National Hurricane Center (NHC) says, adding that heavy rain is expected to continue in the eastern Yucatan, and over the Cayman Islands, and western Cuba.

"Life-threatening flash flooding and mudslides are possible across western Cuba," the NHC states in its first advisory on the system. Tropical storm conditions may develop between Friday night and Saturday.

It is highly likely that the remnant of the first system to develop in the Eastern Pacific will give rise to the first system for the 2022 Atlantic Hurricane Season.

## **Colombian rescuers inch** towards trapped miners

**Rescue workers in Colombia are** working against the clock to save 14 coal miners who have been trapped deep under ground since Monday.

The men were cut off after an explosion thought to have been caused by a build-up of gases ripped through a tunnel.

The blast's expansive wave hit one miner on the surface who has since died from the burns he sustained.

Mining accidents are not uncommon in Colombia, with 148 deaths recorded in 2021.

Relatives of the miners have been holding a vigil by the banks of a little

given different estimates as to the depth at which the men are trapped. The regional mining secretary, Jhon Olivares, said they were 200m (650ft) below ground while some local media reported that they could be as far down as 300m.

Mr Olivares said that the mine was operating legally. It had been closed in 2021 due to a high concentration of gases but had been given the green light to reopen on 19 May, he said.

The rescue work has also been hampered by a build-up of gas as well heavy rains.

"Conditions are very complicated. The impact caused by the explosion was strong and the subsequent fire has generated contaminating gases," Mr Olivares explained. The explosion was so powerful that flames shot 15m from the tunnel's entrance, where they engulfed Fabio Cáceres, the 37-year-old miner who has since died. Engineers have been working to ventilate the shafts and officials said the rescue workers had managed to advance 150m so far. Colombia's civil defence force said it was working around the clock to free the miners. The accident happened at La Mestiza coal mine near El First published Zulia in northern Colombia by BBC news.

civil liberties.

The emergency measure has been extended twice in Congress, where Bukele's party holds a majority.

Since it was first invoked, the police and the army have arrested more than 36,000 people accused of belonging to gangs, including 1,190 minors, according to official figures.

Amnesty International and other rights groups are concerned that innocent people are likely being swept up in the raids. Salvadoran families have also said they are getting little to no information about detained loved ones, who they say were rounded up despite having no gang ties.

In its report, Amnesty said the arrests are often arbitrary, and based on people's appearance, unfounded accusations, being related to a gang member, having a prior criminal record, or living in a gangcontrolled neighbourhood.

"We are going to continue to confront this cancer, and we have said it before and we stand by it, this war will continue until the gangs are eradicated from the territory of El Salvador."

Multiple surveys show that 70 percent of Salvadorans support the government's current measures to reduce gang crime, a problem that has driven thousands of people to leave the country.

The gangs' power is strongest in El Salvador's poorest neighbourhoods, where the state has long been absent. They are a drain on the economy, extorting money from even the lowest earners and forcing businesses that cannot or will not pay to close.
