The Government of Belize announced at the sitting of the House of Representatives that the country submitted its Counter-Memorial to the Registrar of the International Court of Justice (ICJ) today in response to Guatemala's territorial, insular and maritime claim—five days before the

June 8 deadline. The team from Belize was reportedly in England recently putting the final touches on this recent submission. In announcing this historic step, the Prime Minister, Hon. John Briceño, told the members of the House, "Our Counter-Memorial provides a strong defense to Guatemala's Memorial or their claim and resolutely defends the

Nationality Act amended for Amnesty 2022

During Friday's sitting of the House of Representatives, the first reading of the Belize Nationality (Amendment) Bill 2022 was tabled to provide for the regularization of up to 60,000 irregular migrants living in Belize.

Asylum seekers and undocumented migrants living in Belize will soon have the opportunity to receive permanent residency, and some eventually citizenship, as a result of the Amnesty 2022 program being forwarded by the Briceño administration. On Friday, when the Prime Minister, Hon. John Briceño, introduced an amendment to the Belize Nationality Act to lay the groundwork for the amnesty program to be carried out, he said that there will be time for consultation and debate on this amendment before the next two readings and that the program will not officially begin until Please turn to Page 12 after the amendment's passing

Two separate search operations conducted by the Belize Fisheries Department on Sunday, June 5, led

to several fishermen being fined a total of \$130,000 BZD for illegal fishing activities.

COMPOL condemns those who record rather than render assistance

BELIZE CITY, Mon. June 6, 2022 Commissioner of Police Chester Williams, who over the weekend was made aware of a disturbing incident involving a young woman at a popular Belize City restaurant and bar, has criticized persons who stop to record victims of crimes rather than rendering aid. He also

stop to record victims of crimes rather than rendering aid. He also expressed disappointment in police officers' delayed intervention in the matter, but said that it was most likely due to a misinterpretation of a specific local law.

On the night of Friday, June 3, a young Belize City woman became

the victim of what most suspect was a spiked drink. The young woman, showing signs of distress, appeared in the common area of the bar with the lower half of her body exposed. She was then revictimized when other patrons, rather than assisting her, took out their phones and filmed the ordeal. The Commissioner, like many members of the public, has condemned the acts of these persons, noting that the Police Department will be exploring the possibility of levying cyber-crime-related charges.

"Instead of trying to get something to cover the young lady from being exposed, they just took out their phones and videoed and then leaked it to the public. It speaks volumes to the society that we are currently living in," said Williams.

In the case of the police officers that were present, Commissioner Williams said that their initial lack of action was most likely due to ignorance of the law—with them having been under the impression that male police officers

were not allowed to intervene in incidents involving a woman that is exposed.

"The law does not say that male police officers cannot intervene in situations involving women. It simply says that male police officers cannot search [them]. In this case, she would not be searched. In this case, the officers would be acting to protect the woman from being exposed," he stated.

The Commissioner of Police told local reporters that he feels the matter demands an investigation, but as no formal complaint has been made, it will be difficult to do so.

The proprietor of the restaurant and bar where the incident took place issued a statement this week stating that he is "extremely sorry" for what occured Friday and that the bar's management is "glad that we had customers with training who assisted the police and our manager in dealing with the situation."

"To the person or persons who did this I say to you that you are the scum of the earth," added the bar owner.

Bread prices not going up

Minister of Agriculture, Food Security and Enterprise, Hon. Jose Mai says that the government cannot support the proposed increase in the price of bread and that "people need to eat."

Hon. Jose Mai, Minister of Agriculture, Food Security & Enterprise, announced during a meeting of the House of Representatives on Friday that the Government of Belize

will not be authorizing an increase in the price of the 16-oz loaf of bread sold in the country.

The last time the price of bread saw an increase in its wholesale price was in 2008, under the last PUP administration, which was caused by the increased cost of flour, and since then the wholesale price of bread has



remained steady at \$1.50, and the retail price of \$1.75 has also been unchanged.

In April of this year, however, the bakers submitted a proposal to the Cabinet in which they sought approval to increase the price of a 16-oz loaf of bread by 75 cents due to the increased cost of various ingredients used in the production and packaging of bread—

PM introduces \$6.2 million loan motion for COVID-19 response

At Friday's sitting of the House of Representatives, the Opposition criticized the Government of Belize for the large number of loan motions that it has tabled in the House, stating that they have been borrowing at an "irresponsible rate."

At Friday's sitting of the House of Representatives, Prime Minister Hon. John Briceño rose to present a loan motion for US \$6.2 million from the International Bank for Reconstruction and Development. The loan would be used to fund the country's COVID-19 response, and would partially be used for the purchase and deployment of vaccines as well as the strengthening of the country's health system.

"The loan proceeds will significantly assist the Government of Belize in its continuous efforts to contain and mitigate the spread of, and deaths caused by COVID-19, and strengthen the ability of the health system to respond to future health emergencies," the PM stated.

While not addressing the COVID-19 recovery loan motion specifically, the Leader of the Opposition, Hon. Moses "Shyne" Barrow, rose to criticize the Briceño administration for its constant borrowing—the very thing

MOHW receives equipment from NHI

National Health Insurance (NHI) handed over a wide array of equipment to the Ministry of Health and Wellness and the Civil Society Organization Hub today, including three Gene X-pert machines, viral load kits, furniture, laptops, and digital cameras.

The equipment, procured through funding from a Global Fund grant that aims to support recipients in improving services to key population groups, will be used to aid the documentation of work as well as the monitoring and evaluation processes involved in the response to HIV/AIDS and Tuberculosis (TB).

Present at the handing over ceremony was Dr. Ramon Figueroa, the General Manager of NHI.

"Today represents but one of the many good things to come. But nothing else, no equipment, no money, no additional personnel will be as important as the individual and collective commitment to address the issue surrounding HIV/AIDS and TB and the discrimination that is directed at groups in our society," noted Dr. Figueroa.

Minister of Health and Wellness, Hon. Kevin Bernard expressed his gratitude for the donation and commended the continued work of the National HIV/AIDs team in biomedical strengthening and decentralization of screening and testing services for HIV, TB, and COVID-19 across Belize, even as the country faces another wave of COVID.

"It is clear that we must reiterate the importance of enhancing surveillance at all points, even more so with the current threat and presence of Monkeypox disease in neighboring countries," remarked Hon. Bernard.

The Belize Cancer Society (BCS), resumed its annual Cancer Walk on Saturday, June 4, with a new Belize City route. This is the first time in the history of the sensitization event that participants marched through the streets of the old capital, since the route is usually from Ladyville to Belize City. Cancer Walk 2022 was held under the theme "Celebrating Life". On Saturday morning participants started their walk at the Marion Jones Sports Complex on Princess Margaret Drive and took a circuit across the Southside and Northside of Belize City, before returning to the Sports Complex.

This annual event was on pause for two years due to the COVID-19 pandemic but is a major fundraising event for the BCS, which usually sells shirts to participants. The services provided by the BCS include providing access to cancer care information, counseling and support, and the NGO's advocacy focuses on lobbying for policies and legislation to facilitate affordable, available, effective, and efficient services for citizens.

The Belize Cancer Center in Dangriga works hand in hand with the BCS and now has a satellite location at the Belize City BCS office. According to the president of the Belize Cancer Society, cancer has become one of the leading causes of death in the country.

The mayor of Belize City, Bernard Wagner, gave the welcome address to kick off the inaugural Belize City route on Saturday morning.

Tropical Storm Alex forms after flooding South Florida

MIAMI, Florida, Sun. June 6, 2022

After causing widespread flash flooding across South Florida this past weekend, Tropical Storm Alex, the first named storm of the 2022 Atlantic Hurricane Season, is now headed

towards Bermuda. Alex, which partially emerged from the remnants of the Eastern Pacific hurricane Agatha, gained tropical storm level strength off the eastern coast of Florida late Sunday evening, but long before that, the effects of the storm proved devastating, both for residents of the USA's "Sunshine State" and persons in parts of Cuba.

While just a tropical system at the time, Alex—then known as Potential Tropical Cyclone One—claimed at least



three lives in Cuba and destroyed dozens of homes in Havana on Friday,

according to reports from authorities.

In Florida, the system brought over a foot of intense rains over some areas, particularly along the east coast, along with strong winds and flash flooding. On Saturday, Miami officials cautioned the public against traveling, as several roads were rendered inaccessible due

Family friend robs Cayo woman of \$12,000

A Santa Elena woman was robbed by a so-called family friend of over \$12,000 and her vehicle.

Police are searching for Jonathan Cruz Bahadur, a resident of San Ignacio Town, who allegedly stole over \$12,000 on Thursday, June 2, from 35-year-old Sheree Bateman, a businesswoman of Santa Elena, Cayo District, whose vehicle he was reportedly driving at the time.

According to initial police reports, while Bateman was returning from Belmopan to San Ignacio in her White 2009 Mitsubishi Outlander, which was being driven by Bahadur, Bahadur unexpectedly diverted from their route and drove down a feeder road.

When Bateman asked him why he had taken that unexpected turn, Bahadur reportedly claimed that he knew a shorter route. Not long after, however, he asked Bateman to open a bag she had in her possession which contained over \$12,000 and which belonged to Bateman's brother, and when she

declined his request, he physically assaulted her.

In fear for her life, Bateman reportedly jumped out of the moving vehicle while Bahadur was driving along the Loma Luz Boulevard and received a number of injuries to her body.

Police later recovered the Outlander on Bishop Martin Street in Santa Elena, and are seeking Bahadur for questioning.

Married Persons Protection Amendment Bill tabled

The Briceño administration reintroduced its Senior Courts Bill and its Married Persons (Protection) Amendment Bill 2022 at last Friday's House of Representatives meeting. Both bills are expected to change the way divorces are handled in court, with the latter removing the fault grounds on which a person can file for judicial separation and replacing them with incompatibility as the primary basis for divorce.

Minister of Education, Culture, Science, & Technology, Hon. Francis Fonseca, explained that the Married Persons (Protection) Amendment Bill seeks to address two objectives: to update the country's laws as they relate to divorce and judicial separation "to meet the needs of an ever-evolving society" and to remove any discriminatory provisions against women that are currently present in the

"Regrettably, the provisions of the current act mean that men and women are not entitled to equal treatment under the law, and additionally the requirement for an applicant to rely on the misbehaviour of one's spouse to secure an order for judicial separation

promotes an atmosphere of blame for the breakdown of the marriage between parties," he noted.

The bill, said Fonseca, would eliminate the need for one spouse to accuse the other of "misbehaviour" to justify an application for judicial separation.

A Cabinet brief issued in early May explained the reason for the new amendment, stating that the Family Court is often "bogged down" by acrimonious family proceedings "not conducive to the family healing and moving on". The passing of the bill would see amendments made to the Marriage Persons (Protection) Act, Chapter 175 in the Substantive Laws of Belize, Revised Edition 2020.

The Minister of Education also explained how the Senior Courts Bill would change the way matters of separation would be dealt with. According to Fonseca, the bill, much like the Married Persons (Protection) Amendment Bill, removes provisions that are discriminatory based on sex, allowing spouses to have equal footing in divorce proceedings.

"It removes archaic and offensive language to modernize the law. It also establishes a rules committee, which is chaired by the Chief Justice," he explained.

COMPOL on his work trips

On Saturday, May 21, the Commissioner of Police, Chester Williams, departed the country to attend an INTERPOL conference in Leon, France. Following the conference, COMPOL Williams traveled to the Bahamas to attend the 36th Annual Association of Caribbean Commissioners of Police (ACCP) event, which commenced on Monday, May 30, and ended on Friday, June 3.

The COMPOL told reporters that he was in France consulting with the INTERPOL authorities on ways to ensure that the organization is evolving in a way that will more fully align it with the needs of the member countries.

Williams, while talking to members of the local media on Monday, June 6, during the weekly

police press briefing, explained, "The trip to France, as well as the one to the Bahamas, was working visits, and there's a lot that garnered from those two trips. In France, we basically just looked at amending the constitution of INTERPOL to try to make it more workable for member states. As well, [as] to make sure it aligns with international law and our domestic laws. So it was the meeting of the governing group of INTERPOL that met in Leon, France. I was happy to be a part of that group to look at these very important aspects of the work that INTERPOL does on a daily basis."

He went on to state, "We have made certain recommendations for amendments, and those

Opposition calls \$750,000 allocated to International **Music Festival a waste**

Member of the Opposition and r e representative for the Albert Division, Hon. Tracy Panton, rose during the most recent sitting of the House of Representatives on Friday to address what she calls "wasteful spending taxpayers' money" to cover the costs of holding the Belize International

Music & Food Festival, which is set to take place this summer. The Belize Tourism Board will be spending an estimated \$750,000 on the two-day mega-concert, and Panton believes that three-quarters of a million dollars could be used in more beneficial ways.

"Music festivals and food festivals have been used for years, particularly in the Caribbean region, to attract tourist arrivals to our country at a time that is considered the low tourism season. So it's not a novel idea. But the timing, Madame Speaker, of putting together a tourism concert in less than two months under the guise that it will help to improve tourism arrivals in Belize is nothing short of stupid," said Hon. Panton, also pointing out that she has years of experience in tourism marketing, having served as Director of Tourism for Belize for over 15 years.

Hon. Panton went on to highlight the country's current economic crisis, with soaring gas prices and inflation rates at record highs, which have created needs within the community that the funds allocated for the festival could be used to address.

"Tour operators are falling out of the sector left right and center, and the BTB seems to be unable to provide meaningful relief and support. But yet we are to prepare to spend \$750,000, almost a million dollars, on a poorly

planned concert," she stated.

Panton pointed out that the money could be used to provide food pantry programs in vulnerable communities, create greater access to education, or improve other government ministries. She also noted that the local artists performing in the concert would be paid much less than their international counterparts.

Hon. Tracy Panton's comments did not go without a response from the government side of the House. Minister of Education, Culture, Science, and Technology, Hon. Francis Fonseca, rose to speak in place of the Minister of Tourism, Hon. Anthony Mahler, who was not present. Fonseca called Panton's statements an attempt at politicizing something positive.

"It's this type of intervention, really, that you know has the Belizean people in a position where they really feel like politics has lost its way. For every single issue we attempt to score political points, even where this is clearly a case of the BTB trying to do something positive for Belize, something positive for our creative community, obviously something positive for the tourism industry," he stated.

Hon. Fonseca also said that the Government is anticipating a return of over 3 million dollars on the \$750,000 investment.

Hon. Francis Fonseca introducing the Senior

Courts Bill at Friday's sitting of the House of Representatives

BELIZE CITY, Mon. June 6, 2022

After being deferred at the previous sitting of the House of Representatives, the Senior Courts Bill was introduced by Minister of Education, Hon. Francis Fonseca last Friday on behalf of the Attorney General's Ministry, marking the start of a reorganization of the judiciary in Belize, notably the first-ever since independence.

"Belize has not implemented any meaningful reforms in the upper courts since attaining independence, despite the well-known challenges present in our upper courts. It is evident that proper reform of the court administration is needed to ensure efficiency and consistency in the judicial system," Fonseca said. He remarked that the bill is all about strengthening the administration of justice, and, as previously reported, its goal is to "improve the efficiency, accuracy and consistency" of the judicial system of Belize.

Senior Courts Bill introduced

"The bill really represents, Madam Speaker, the most progressive and comprehensive restructuring of the judiciary ever undertaken in our nation's history, "Minister Francis Fonseca said.

A Cabinet release issued in early May states, "Cabinet has also given its approval for the introduction of a bill to address consequential amendments to the Belize Constitution to provide for the additional judicial office holders as well as to provide for the office of the Chief

Justice to be the administrative leader of the Supreme Court and Court of Appeal as well as for the renaming of the Supreme Court to that of the High Court. The office of the President of the Court of Appeal is being retained, but shall be subject administratively to the office of the Chief Justice."

Minister Fonseca further explained in the House that, in addition to this, "The Chief Justice is to be assisted by a president of the Court of Appeal, two senior judges to the high court, one senior judge for the Criminal Division, and one senior court judge for the Civil Division. This will allow for the Criminal Division to have a dedicated full-time head to improve the timely delivery of justice in that division, as well as having a full-time leader in the Civil Division to provide for greater efficiency in the Cvil Division."

He noted that there will also be specialized divisions and additional judges that will increase efficiency within the judicial system.

"There are to be specialized divisions, which is intended to lead to greater efficiency. There is to be a commercial division, which will deal with contracts, torts, and corporate matters. A constitutional and public law division will deal with constitutional challenges, judicial review claims and case stated matters, and then a family and trust law division, which will deal with family trust and probate matters, and such division as the Chief Justice over time may think necessary to add. Specialized courts, of course, lead to specialized judges who can more effectively and swiftly deal with matters, having become familiar and developing expertise in particular areas of the law," Minister Fonseca shared.

Fonseca said that along with the

senior judges, masters, judicial assistance personnel, and the Chief Registrar will be introduced in the Criminal and Civil Divisions of the Senior Courts.

"Very importantly, Madam Speaker, it provides for video recording to eventually replace typewritten transcripts, which are time-consuming and costly to produce and which delay the appeal process and judgment delivery," Minister Fonseca also announced.

He said that a consultation process was undertaken by the Attorney General's Ministry during the months of February, March, and April of this year and indicated that the proposed bill that has been tabled is a reflection of those consultations. The bill has been referred to the Constitutional and Foreign Affairs Committee for further examination

Fishermen face stiff fines for Fisheries violations

boat cleaning fish fins and fillets that appeared to be legal catch.

However, authorities did a thorough search of the vessel and discovered a white crocus bag under a plank that contained fish fillets. And after opening the bag, they found 74 Spotlight Parrotfishes, 2 Midnight Parrotfishes, 12 Angelfishes, and 8 Ocean Triggerfishes, which are protected under the new Fisheries Research Act.

According to Hampton Gamboa, Fisheries Enforcement Officer for the Belize Fisheries Department, the fine for being caught with such species is 1,000 BZD per piece, and the three men will be sent to court on Tuesday, June 7.

In addition to the fishes that were found in the crocus bag, 68 fish fillets were found without the required skin patch, for which the men will be subject to a separate fine ranging from \$50 to \$100 BZD for each violation.

Later in the night, two individuals were caught fishing at the Glovers Reef, which is known to be a protected conservation area. The duo were found with 61 undersized conch in their shells. They will be charged for four different fisheries offenses and will face a minimum fine of 5,000 BZD.

Gamboa told local media that enforcement efforts for the department are challenging, as offenders often commit violations at night, while the enforcement officers are sleeping.

"Normally for us, we try to ensure that we have [a] presence as much as possible, and of course, we know that with the challenging efforts when it comes to enforcement, it's very costly. And as you can see, we have to be battling with the timing of being out there [at a] certain time of night as well as early morning. We have certain issues that we're looking at right now when it comes to the closed season of

lobsters and when people are moving

these lobsters and when they are

actually harvesting them. Sometimes while we are in our beds, 3:00 or 4:00 in the morning and the daybreak, guys are out there harvesting, so it is a challenging venture when it comes to enforcement ... as you can see, we're looking at almost, for these two offenses, 130,000 BZD in fines and penalties," said Gamboa.

CEO of the Ministry of the Blue

CEO of the Ministry of the Blue Economy, Kennedy Carillo, noted that the ministry is aware of the illegal activities that are taking place within Belize's waters and mentioned that enforcement officers will be out monitoring.

"We know that many of the persons that are engaging in this are very well aware that activity's illegal. But that is why they go out at 10:30 at night, because they are under the assumption that they are doing it at a time when there are no enforcement officers, but we want people to know that we're taking our responsibility very seriously and that our enforcement officers are there with greater presences than ever before," said CEO Carillo.

While in office, our lawyer/politician friend was most aptly situated as

Attorney General to accomplish some legislation in this vital area. But the tone of his recent essay might suggest that there were restrictions placed on his hand by the forces of "human greed" elsewhere during his administration.

Well, if the driving force of greed is anywhere near as strong as our friend implies, it can hardly be considered a blight on the current administration that campaign financing legislation has not seemed a priority for them. After all, there is much to accomplish "for the people" in many areas of government that demand urgent attention. And we must admit that, despite some mistakes, they are getting a whole lot done. So, it should be no surprise that drafting and enacting legislation that would restrict their own hand at election time, is not high on the priority list of any government. But if our out-of-office lawyer-politicians are true to their proclaimed desire for good governance, they can prove their sincerity by putting in the work on drafting campaign finance legislation now, and discussing it with the people, before presenting it to the House for the government side to publicly say "yea" or "nay." Indeed, besides criticizing the perceived wrongs of the governing party, those in opposition have a job to do also; and this is one area in which the people need them to take the bull by the horns—if they are serious and not themselves choking with human greed—and start drafting campaign finance legislation for political parties in Belize.



Abogados-políticos y financiación de campañas: un trabajo para los perdedores

Un exministro de gobierno de Belize, un abogado experimentado, y aunque con buenas intenciones, invirtió en dos páginas completas de comentarios/filosofía en el periódico Reporter el pasado fin de semana, donde entregó un impresionante resumen del desarrollo de la civilización humana desde sus inicios más remotos hasta donde estamos en la actualidad. Y todo para llegar a la conclusión de que las tragedias y tribulaciones resultantes del comportamiento humano, incluso los efectos tipo Armagedón del Calentamiento Global que ahora nos sobrevienen, son todos inevitables porque la naturaleza humana está impulsada por la codicia. Pero tal empresa comienza "en casa", porque la generosidad se puede enseñar mejor con el ejemplo.

Y así volvemos a nuestra propia "Cámara", donde una vez residió nuestro buen amigo, y que por mucho tiempo ha resistido el grito constante de la gente por "buena gobernanza", comenzando con la demanda de una legislación de financiamiento de campañas. A lo largo de los años, y después de muchos cambios de gobierno, los votantes beliceños han llegado lentamente a la conclusión de que gran parte de su frustración por la falta de buena gobernanza se debe al amplio campo abierto del financiamiento de campaña no regulado ni documentado de nuestros partidos políticos cuando llega la época de elecciones. In the interests of academic accuracy, I simply must point out to those of you who are serious readers that the section of Peter Ashdown's article ("The problem of Creole historiography") which was reproduced on pages 28 and 29 of last weekend's issue of this newspaper is only that -- a section. (The original article stretches from pages 142 to 152 of the Second Edition of READINGS IN BELIZEAN HISTORY, a May 1987 St. John's College publication.)

I chose not to reproduce the entire article, thus making it mandatory for serious readers to do their own research, because at one point Ashdown criticizes a prominent Belizean personality (now deceased), and I think that if this newspaper published the entire article, it would open an old UBAD wound.

Now, of course, the younger

Belizean generations have heard almost nothing about UBAD, and I'm not going to try to educate them in this column, for different reasons.

I will say this, however, that after all these fifty years, I have come to the conclusion that when the UBAD riot of May 29, 1972, threatened to become an outright insurgency, as president of the organization I should have acted in a more proactive manner. I should have put down my foot, because my instincts told me at the time that it was time for us to disperse, to disappear. I had too much respect for the officer who had become inflamed, and chose to go about the business of taking some of the Miss Afro Honduras candidates to their homes in an automobile. In retrospect, I gave up my leadership that night, and, also in retrospect, that was the beginning of the end of UBAD.

In February of 1970, a

situation which was somewhat similar had developed with respect to UBAD Minister of War, Charles X "Justice" Eagan. He was twice my age, and much more experienced in the streets than I. The seditious arrests of myself and the late Ismail Shabazz had suggested to me that the ruling People's United Party (PUP) had raised the stakes of the quarrel between us to a point where my book learning/training would become somewhat irrelevant.

Whatever, Justice became the de facto UBAD leader. Justice, myself, and Charles X Stamp ended up being tried in the Supreme Court in January of 1971. X Stamp and I were acquitted, but Justice went to jail.

I want to end this short column by saying to the attorney Godfrey Smith, who is not and has never been my friend, that his research into the devastating tragedy which ended the people's revolution in Grenada in 1983 is of massive importance. I give credit where credit is due.

What happened in Grenada, a small Eastern Caribbean island and former British possession which was the site of the only successful black power rebellion in the 1970s (1979), is that the two major leaders, Maurice Bishop and Bernard Coard, ended up in a violent confrontation. Bishop was slaughtered by machine gun fire, the United States invaded, and Coard spent decades in jail.

In 2022, as we Belizeans face the potential trauma of this International Court of Justice (ICJ) hearing in the months and years ahead, the pressure on our various leaders will be immense. This ICJ faceoff with Guatemala is serious business, and we can see now, 2022, that regional white power rules almost absolutely in these parts. Belizeans, we have a problem.

En aras de la precisión académica, simplemente debo señalar a aquellos de ustedes que son lectores serios que la sección del artículo de Peter Ashdown ("The problem of Creole Historiography") que se reprodujo en las páginas 28 y 29 de la edición del fin de semana pasado de este periódico es sólo eso: una sección. (El artículo original se extiende desde las páginas 142 a 152 de la segunda edición de READINGS IN BELIZEAN HISTORY, una publicación de St. John's College de mayo de 1987).

Elegí no reproducir el artículo completo, para que así fuese obligatorio que los lectores serios hagan su propia investigación, porque en un momento Ashdown critica a una prominente personalidad beliceña (ya fallecida), y creo que si este periódico publicara el artículo completo, abriría una vieja herida UBAD.

Ahora, por supuesto, las generaciones beliceñas más jóvenes no han escuchado casi nada sobre UBAD, y no voy a tratar de educarlos en esta columna, por diferentes razones.

Diré esto, sin embargo, que después de todos estos cincuenta años, he llegado a la conclusión de que cuando el motín de UBAD del 29 de mayo de 1972 amenazó con convertirse en una insurgencia abierta, como presidente de la

organización yo debería haber actuado de una manera más proactiva. Debería haber adoptado una actitud firme, porque mi instinto me dijo en ese momento que era hora de que nos dispersáramos, de desaparecer. Le tenía demasiado respeto al oficial que se había inflamado, y opté por dedicarme a llevar a algunas de las candidatas a Miss Afro Honduras a sus casas en un automóvil. En retrospectiva, renuncié a mi liderazgo esa noche y, también en retrospectiva, ese fue el comienzo del fin de UBAD.

En febrero de 1970, se había desarrollado una situación algo similar con respecto al Ministro de Guerra de UBAD, Charles X "Justice" Eagan. Él tenía el doble de mi edad y tenía mucha más experiencia en las calles que yo. Los arrestos sediciosos de mí y del finado Ismail Shabazz me habían sugerido que el gobernante Partido Unido del Pueblo (PUP) había subido las apuestas de la disputa entre nosotros a un nivel hasta donde mi aprendizaje/entrenamiento académico se volvería algo irrelevante.

Sea como fuere, Justice se convirtió en líder de facto de UBAD. Justice, Charles X Stamp y yo terminamos siendo juzgados en la Corte Suprema en enero de 1971. X Stamp y yo fuimos absueltos, pero Justice fue a la cárcel.

Quiero terminar esta breve columna diciéndole al abogado Godfrey Smith, quien no es y nunca ha sido mi amigo, que su investigación sobre la devastadora tragedia que puso fin a la revolución popular en Granada en 1983 es de enorme importancia. Doy reconocimiento donde se debe reconocimiento.

Seven ministries sign road safety proclamation

The goal is to reduce serious road traffic accidents by 50% by the year 2030 across the world.



Ministers signed Road Safety Decade of Action proclamation

BELIZE CITY, Mon. June 6, 2022

Today, the CEOs of several ministries met to sign on to a proclamation pledging support for the United Nations Decade of Action for Road Safety. First launched in October 2021, the Global Plan for the Decade of Action was developed by the World Health Organization and the United Nations Economic Commission for Europe. Today the government ratified its support to realize the goal set out in the action plan, "to reduce serious road traffic crashes and serious injuries on the highways by 50% by the year 2030," a release from GoB states.

The proclamation was signed by the chief executive officers from the ministries of Economic Development; Transport; Education; Health & Wellness, Infrastructure Development, and Housing; Finance; and National Security, along with a representative from the Belizean Youth for Road Safety. The second road safety project, centered on the United Nations Pillars of Action for Road Safety, is being funded by the Caribbean Development Bank.

The Project Manager, Zane Castillo, stated today at the official signing, "Whereas the government of Belize in conjunction with the Caribbean Development Bank has already demonstrated its commitment to implementing successful road safety projects through the country's first road safety project, whereas the government of Belize is executing its second road safety project, and whereas the long-term road safety plan for Belize has

already set its target of preventing at least 50% of road traffic deaths and injuries by 2030. Therefore, the government of Belize on June 6, 2022, pledges it support for the Decade of Action 2021-2023."

In Belize, road traffic accidents are frequent and many times fatal. Just last weekend there were three accidents in the vicinity of Belize City, and another fatal accident in the south.

"Unfortunately, as of April 30, 2022, 16 fatalities resulting from road traffic incidents have been recorded% an average of four per month," a release from the government of Belize states.

The second road safety project is aimed at strengthening the capacity of relevant stakeholders to provide mental health care to victims of accidents.

"Currently, the post-crash care system only focuses on the important short-term goal of saving lives, concentrating on physical recovery; however, little attention has been given to the mental health effects on both victims and relatives. To address this, the Second Road Safety Project, through relevant stakeholders, will also strengthen the capacities of key Belizean professionals working in emergency services and post-crash care by imparting knowledge and skills in psychosocial support," the release outlines.

The mentioned ministries, along with the Police Traffic Unit, municipal traffic departments, BERT, and PAHO, continue to partner for the execution of this second road safety project.

After their first proposal, in which they requested permission to increase the price of bread by 75 cents—to a \$2.25 wholesale price and \$2.50 retail price—was not approved, they sent a second proposal to Cabinet in which they suggested a 50- cent increase, and finally, in their third proposal, they

asked that government approve a 25-cent increase. Mai then mentioned that the Cabinet considered the proposed price adjustments and decided to not allow an increase in the controlled price of a 16-ounce loaf of bread at this time.

"This government, under the leadership of Honorable John Briceño, has approached this issue delicately, considering first and foremost the impact and [a] potential increase to have on the most vulnerable members of our society. While we have the utmost respect for private enterprise and wholeheartedly believe they are entitled

WPC claims Julius Espat insulted her

TEAKETTLE VILLAGE, Cayo District, Mon. June 6, 2022

A woman police officer identified as WPC Alicia Trapp will likely be disciplined by the Professional Standards Branch of the Police Department for a viral video that was published live on her Facebook page. In the video, she alleges that the Minister of Infrastructural Development and area representative for Cayo South, Hon. Julius Espat pointed his finger in her face and used crude words when he spoke to her—apparently because he was angered by the fact that she was participating in the Teakettle Village Council Election as a United Democratic Party supporter.

While she says that she was insulted by the minister, today Commissioner of Police Chester Williams stated that her actions violated the police's social media policy and rules against open participation in a political party.

During her video, WPC Trapp identified herself as a police officer in civilian clothing and shared that she was approached by Hon. Espat, who attempted to scold her for her wearing a red shirt and being under a tent with UDP supporters. She said explicitly that she was approached because of the color of what she was wearing, a red sports shirt which didn't have anything imprinted on it that indicated a UDP affiliation. She said that as a police officer of 9 years, she felt ashamed and disrespected by Hon. Espat's approach and felt compelled to go live and condemn his actions.

Area representative Hon. Julius Espat was seen in her video just a stone's throw away from where she proceeded with her own criticism of Hon. Espat and what she referred to as a trend for PUP ministers to disrespect women.

"Mr. Julius Espat came to my face and pointed and tell me I cannot be *explicit* there underneath the UDP tent. What's wrong with this minister, ah? First Abelardo Mai disrespected Mrs. Tracy Panton; now this next minister wah come and disrespect me just because I da wa police officer and I inna civilian clothes? And he tell me I can't wear no red shirt. What is wrong with him? I can wear any color I choose to, and even if I mi want wear wa white or wa blue shirt, I know who I will vote for. Da none ah his business that." WPC Trapp said on her live video.

The Commissioner of Police said, however, that WPC Trapp was never to have taken to social media to rant.

"Having listened to the video

footage, even if we were to disregard her confrontation with the Hon. Julius Espat, as police officers we do have a code of conduct, and we do not expect our members to be ranting and raving on social media the way she did. It certainly is a clear violation of our social media policy, that's one; secondly, under the Public Service Regulation, it clearly stipulates that public officers are not supposed to engage in any political activity or to show themselves to be preference to a certain political party," COMPOL Williams said.

The COMPOL said that while WPC Trapp attempted to suggest that she was participating in the village council election as an independent voter, and that her wearing a red shirt was a matter of coincidence, some of her own remarks made her affiliation clear.

"She made mention to the fact that Alberto August was standing their with 'our posters', so she said our posters, and it turned out those posters that Alberto August has were UDP posters, so she automatically aligned herself with a political party" COMPOL Williams said.

Additionally, in the live video, WPC Trapp alleged that a member of Espat team described only as Ms. Mari, pushed and slapped Alberto August. "She came just because Mr. August was standing right there at the entrance with our posters, and he is supporting the chairman from Teakettle, and she came and push him, and because he didn't want to move, she came and slap him on his face. Is that right? Please, people," she said.

Unconfirmed reports are that WPC Trapp is supposedly the wife of the UDP chairman candidate of the village.

COMPOL Williams said that as a police officer she should not have been out there as a supporter of any party, and added that a person who places himself or herself in a political environment should expect nasty encounters.

"Everybody knows the Hon. Espat to be a political animal, not in a bad way, and so if you put yourself in the political arena, you must take what comes to you. You can't get inna pig pen and nuh get expect to get muddy. It's simply that, and so it's a matter that has been passed on to the Professional Standards Branch, and they will look at it and see where we do from there," the COMPOL remarked. He said that she is certainly at risk of facing disciplinary charges, although he could not say of what nature at this time.

"... The request to increase the price by 75 cents was presented to Cabinet and given due consideration. The record shows Cabinet could not support a 50% increase in the controlled wholesale price. The Ministry and Supplies Control Unit [was] instructed to meet with the bakers and engage [in] negotiations to identify a more feasible alternative... I am pleased to announce to this honorable House and the nation that this PUP government will not authorize any increase [in] the controlled price of a 16oz loaf of bread," continued Minister Mai.

It has been reported that the government might instead be providing subsidies to the bakers to cover their increased costs in order to ensure that bread prices do not rise.

Russian missiles more powerful than reported

It seems as if the Russia/Ukraine conflict will take longer than was anticipated by the western world. According to different mediums of communication, the NATO countries will supply the president of Ukraine, Volodymyr Zelensky, with the most modern high-tech weaponry to defend his country against Russia. I could go over every single thing he's doing, and that should put Europe on very high alert, especially with the Iskandar dismissal. Very easy to around, it can move it in any semi truck, pull it out, and boom. In fact, four of these can fit in a semi truck. Just a 53-foot trailer. Pull it out and immediately, there you go, and how easily could he move all these all around Europe? That's the question. So, there's over 20 different payloads that he has that he could put on the Iskandar. He's putting the weakest one on all of them, and you're going to learn that Zelensky, because of this and, him using it last night, is already talking about surrendering, and that's because last night he blew up all of his reserve troops while they were sleeping in their barracks.

Now I know you think that's evil. But that's exactly what we did with the

Republican Guard in Desert Storm when we were fighting Saddam Hussein. And we didn't use the mechanized cable. We used the mechanized cavalry. They went in and cluster-bombed them. And that's how we won the war. Well, Putin just did the same thing with this Iskandar missile. That's not half of it. The other thing is that, remember the Poseidon, it was told to the whole world for years that it was a 100-megaton cobalt wave nuclear torpedo. Turns out it's 200 megatons, okay? It has what's called a plasma cloud that surrounds it, and it's again highly maneuverable. So, he testfired this just yesterday from the Gorbachev, and his hypersonic Zircon cruise missile is now the fastest thing. You can see it going right here [Video clip shown]. And it's a scary sight. But the thing is, they shot it out of the same porch that they were shooting their caliber missile out of, which basically means it's kind of like how the Americans use the sidewinders. They can be shot out of everything now. Okay. So it's highly maneuverable. We thought it had a 500-kilometer range, but we just saw it go 1,000 kilometers. Again, it doubled what they claimed. Two stage uses: fuel first, then scram jet.

around, so whether it was stoppage of water (prostate), or pneumonia or whatever, they were just waiting round to die. And death was a big deal, still a mystery, back then.



Nationality Act amended for Amnesty 2022

and the issuance of accompanying regulations.

Persons who qualify under one of the eight criteria that have been outlined by GoB will be given an opportunity to go through the application process, which, according to the Department of Immigration website's page on the Amnesty 2022 program, will require that applicants take 7 steps before they are granted a permanent residence card.

To qualify to apply for this amnesty program, undocumented migrants will have to meet one of the following requirements: be a registered asylum seeker with the Department of Refugees before March 31, 2020; have resided in Belize before 31st December 2016; have at least 1 child born in Belize on or before December 2016; have completed any level of schooling in Belize; be married to a Belizean, or be in a common-law union with a Belizean for at least 5 years; be a child or victim of human trafficking referred by the Department of Human Resources, or have maintained gainful employment in Belize for 5 years.

Those persons will have to apply to the department, which will determine their eligibility and set up an appointment with the applicant before their application is submitted. They will have to submit a police record and also be interviewed by the police at their home address. Once the application is approved, then payment for the permanent residency will have to take place before they are finally able to receive the card. According to the Prime Minister, these approved persons will have to wait 5 years before they can apply to become Belizean citizens.

"It is important to stress that successful applicants would have to wait at least 5 years before they can apply to become Belizean citizens; permanent residents are not eligible to vote in general and municipal elections," the Prime Minister said.

According to data from the World Migration Report 2020, Belize has experienced the greatest percentage of population growth linked to migration in the region over the last 10 years. The report states, "All the top 20 countries experienced an increase in the size of

their populations during this period, with the largest proportional population changes occurring in Central America. Belize had the greatest percentage change, with its population increasing by 24 percent from 2009 to 2019. It was followed by Guatemala and Honduras, whose populations grew by nearly 23 and 20 percent respectively."

While the majority of the undocumented persons living in Belize are from the neighboring republics in Latin America, the Department of Immigration notes that a growing percentage of persons are coming from Haiti, China, and Africa.

"Most of the migrants who have settled in Belize are from the neighboring republics, with increasing numbers from Haiti, China, and Africa. Migrants from the Central American republics are, in the main, fleeing gang-related violence and seeking employment opportunities. Migrants from Haiti are fleeing political-related violence, ungovernability, and economic opportunities, whilst those from China are primarily seeking economic opportunities," the Prime Minister said in his remarks at Friday's House sitting.

The recent census done in 2010 shows that 14.2% of persons living in Belize were born abroad, and the new ongoing census being carried out by the Statistical Institute of Belize may likely show an increased percentage, since the currently stated percentage does not reflect the number of persons that have moved to Belize over the last 10 years—an estimated 40 to 60 thousand persons. At this time, the Belize Refugee Department has 73 confirmed refugees documented and 4,030 persons with asylum seeker status; it must be noted that Guatemalan citizens are not eligible to seek asylum

The first amnesty program held in Belize was done 3 years after independence in 1984 when 8,680 undocumented migrants were regularized; in 1999, during a second amnesty program, an additional 11,168 were registered. An estimated 20,000 undocumented migrants were estimated to be in the country in 2010, but an amnesty program scheduled for that year was never executed. Based on these numbers, the Immigration

sovereignty, the territorial integrity, and independence of Belize."

Belize's submission today marks a decisive step in a process that has dragged on since December 2008 when the Special Agreement was first agreed on by both countries. The ICJ, located in The Hague, Netherlands, acts as the judicial arm of the United Nations. The court became the official arbiter of the dispute in June 2019, with the submission of the Special Agreement and the accompanying Protocol.

Subsequently, due to the COVID-19 pandemic, the court was forced to adjust the time limits at the request of the Guatemalan government and agreed to extend that country's deadline for submission of its Memorial from June 8, 2020, to December 8, 2020. At the time, the agent from Belize stated to the court in a letter that two months would be a sufficient extension, in their view. Belize's date of submission was then moved from June 8, 2021, to June 8, 2022.

Guatemala is due to submit its reply to Belize's Counter-Memorial by or on December 8, 2022, exactly 6 months after our deadline date. Belize will have another six months to submit a rejoinder to Guatemala's reply, with a deadline set for June 2023, before a date for oral arguments is set.

The Prime Minister, in his remarks to the House, said, "June 3 is a historic day for Belize. I can report to this honorable House and to the Belizean people that earlier, Belize filed its Counter-Memorial at the International Court of Justice in The Hague."

He also gave a snapshot of the timeline: "By this special agreement, Guatemala must submit its reply to Belize's Counter-Memorial by December 3, 2022. Belize will have six months thereafter to deliver our rejoinder, so that by June 2023 we expect the written pleadings in the case to have closed. This, of course, assumes that there will be no further events or eventualities that might delay this case," PM Briceño said.

The COVID-19 pandemic, as mentioned, caused a delay in the

mentioned, caused a delay in the Department estimates that up to 60,000 undocumented migrants may be living in the country, many being subjected to daily violations of their human rights because of the vulnerability resulting

from their irregular status.

The PM says this is one of the primary reasons for the exercise. "What we are doing is something that is necessary, something to be able to regularize the status of these people. Many of these people are being taken advantage of by unscrupulous business people, both the men and women, and in some instances these children are forced to work in the fields to be able to help their families. So it is not about politics ...," the PM said.

He remarked that this amnesty program is the right and necessary thing to do. According to the Department of Immigration, irregular migration breeds illegality and abuse. It stated, "Many migrants find themselves victims of human trafficking – modern-day

process. The PM thus said that if there are no other interruptions in the process, a date as early as 2024 could be set for oral hearings.

"Assuming that there is no further delay, the court will proceed to set a date for hearing, which I am advised can occur in 2024 if not before," he said.

At this time, only a few are privy to the details of Guatemala's Memorial and Belize's Counter-Memorial, since the court rules forbid any disclosures of the pleadings from either party. The Prime Minister reassured citizens, however, that a strong case has been submitted for Belize.

"Belizeans can rest assured that a strong, clear, and powerful case has been made for all our territory, continental and insular, as well as the maritime areas as determined by international law," PM Briceño said.

In his remarks, the PM also called on the Guatemalan government to adhere to the agreed upon Confidence-Building Measures of 2005 and to prevent their citizens from engaging in illegal activity on Belize's side of the border.

"We continue to appeal to Guatemala to adhere to the Confidence Building Measures in place since 2005, which requires, for example, our government, both governments, to clear the areas around the three reference markers at Gracias Adios, Garbutt Falls, and Aguas Turbias. The Guatemalan government also undertook to dissuade its citizens from crossing illegally into Belize. But, we continue to have problems with Guatemalans occupying Belize near the Western Border. Narcotrafficking continues to pose a security problem, while illegal logging, farming, pouching and mining continues to cause significant damage to our environment and wellbeing. Similarly, the Guatemalan government has refused to abide by repeated commitment to negotiate Confidence Building Measures regarding the Sarstoon River in defiance of appeals by international bodies. Again, we urge the government of Guatemala to put into effect its undertaking the agreed CBS for the Sarstoon," the Prime Minister said.

slavery. Irregular migrants, because of their vulnerability, are often employed at very low wages and work in dreadful conditions. Additionally, many are paid 'off the books' and therefore generate little tax revenue. Some of the migrants are gang members or former gang members and engage in serious criminal activities in Belize. Many have children in Belize and enter relationships, which leads to complications. There are families where both or one parent is irregular, but their children are regular. Registering the children in school exposes the parents, and there is a tendency not to enroll them. Of course, any irregular migrants access social and other services and therefore add to the cost-of-service delivery."

The legal framework for Amnesty 2022 will be put in place by this recently introduced amendment. After that legislation is passed, the government will

Veteran defenders, **Willie and Charro pass** a week apart

BELIZE CITY, Mon. June 6, 2022

Even while former Berger 404 defender Larry "Charro" Bennett was already a week in KHMH, we received word that former Landivar sweeper and captain, Clarence "Willie" Williams had passed in Florida, USA.

Willie reportedly had recently suffered a stroke, and was in rehab when he suffered a second stroke and passed on Thursday, May 26.

Charro had been ailing for a few months and was hospitalized on May 19 at KHMH where he passed on Friday, June 3.

Charro played flank defense on a number of Belize City championship teams, starting with the 1974-76 Berger 404 back-to-back Belize City football champions, later with champions Chito's Rangers, and he was also a member of that memorable Belize selection that travelled undefeated in 5 games played in Mexico back in 1978. Willie was the sweeper/captain of a tough defence that carried Landivar to a number of championships in the late 1960s and

early 1970s, even while their striking Landivar and other teams for a trip force was not formidable, winning many a 1-nil game. Willie may have migrated to the US sometime after their last Landivar championship in 1974.

While Roger's post focused on Larry, who was known to be ailing at the time, he didn't mention the Landivar sweeper, who was most likely Clarence "Willie" Williams. Willie was a few years older than Charro. Willie was the sweeper on an Amateur Sporting Club team that was reinforced with some players from to Agua Dulce, Vera Cruz in July (or August?) of 1972.

Larry Bennett was a defender by nature. He was a wall with "Salad Oil" with the Berger dynasty of the 1970's and early 1980's. They won about four championships together. However, I distinctly remembered what a game in what I believe was Larry's first year with Berger 404 in the 1973-74 season. Landivar was the defending champs and during the match Larry literally marked the dangerous Landivar left winger Half-a-D Pascascio very hard. Every time the midfielder forwarded a pass to Half-a-D for a run through Larry was always alert and stopped Halfa-D. Half-a-D was sneaky and tricky. With ten minutes left in the game, lack of experience eventually took its toll on Larry. He took his eyes off Half-a-D one time too much and the latter got the run-through pass, and Half-a-D was too far ahead of Larry. Half-a-D went in all alone on the left side and smoked a low grounder past Bunucal. Landivar won 1-0.

Rest In Peace, brothers Larry "Charro" Bennett and Clarence "Willie" Williams.

Funeral arrangements for Willie are in the U.S., while we understand that Larry's funeral will be held later this week or on the weekend.



US-bound migrant caravan leaves southern Mexico

TAPACHULA. Mon, June 6, 2022 (Aljazeera) — Several thousand migrants have set out from southern Mexico in a caravan bound for the United States, which is hoping to address regional migration during talks at the Summit of the Americas this week in Los Angeles.

Migration activists said the group, which left from the Mexican city of Tapachula on Monday, could be one of the region's largest migrant caravans in recent years.

The caravan was estimated to include 4,000 to 5,000 people, mostly from Central America, Venezuela and Cuba, The Associated Press reported, while witnesses told Reuters that the group counted approximately 6,000 people.

Mexico's National Institute for Migration did not provide an estimate of the group's size and provided no additional comment on the caravan.

Caravan organiser Luis Garcia Villagran said the group represented various nationalities of people fleeing hardship in their home countries, including many from Venezuela.

"These are countries collapsing from poverty and violence," he said. "We strongly urge those who attend the summit ... to look at what is happening, and what could happen even more often in Mexico, if something is not done soon."

Tapachula serves as a key point in the journey of many migrants and asylum seekers hoping to reach the US, with thousands arriving in the city in Mexico's

southeastern Chiapas state in recent

For months, people have complained that Mexico's strategy of containing them in the southernmost reaches of the country has made their lives miserable. Many carry significant debts for their migration and there are few opportunities for work in Mexico's south.

Ruben Medina, of Venezuela, said he and 12 members of his family found themselves in southern Mexico because of his country's president, Nicolas Maduro.

"[We have] been waiting about two months for the visa and still nothing, so better to start walking in this march," Medina told AP. "They gave us an appointment for August 10 in [the asylum commission], and we don't have the money to wait," said Joselyn Ponce of Nicaragua. "We had to walk around hiding from immigration, there were raids, because if they catch us they will lock us up."

The caravan set off as Mexican President Andres Manuel Lopez Obrador said he would not attend the Summit of the Americas, serving a blow to the Biden administration's efforts to use the meetings to build more regional cooperation on migration.

US President Joe Biden, who promised to reverse some of his predecessor Donald Trump's most restrictive immigration policies, has been under pressure to address increasing numbers of asylum seekers arriving at the country's southern border with Mexico.

The US hoped to end a contentious border restriction known as Title 42 last month, but a federal judge on May 20 blocked that effort.

The policy, which allows US authorities to turn away most people who arrive at the border without giving them a chance to apply for protection, has been slammed by migration advocates as a violation of US and international law.

Despite the restriction, many asylum seekers continue to make long and often arduous journeys to Mexican border cities and towns, in hopes of being allowed to enter

the US.

Over the years, thousands have joined caravans in hopes that walking in large numbers would provide them with greater protection and success. Authorities in

Guatemala and Mexico broke up several previous caravans before they could reach the US border, however.

Colombian migrant Robinson Reyes, 35, said he hoped the group would attract the attention of leaders at the Americas

"We want a future for our children ... we want to cross Mexico without any problems," he said. "God willing, they can talk and resolve this."

Cuba floods: At least two dead as heavy rain hits island

Mexican president Andres Manuel Lopez Obrador says he will boycott the event over guest list that excludes Cuba, Nicaragua and Venezuela.

CUBA. Mon. June 6, 2022 (BBC news)

At least two people have died in Cuba's capital, Havana, after the remnants of Hurricane Agatha brought heavy rain and floods to the Caribbean island.

The Cuban weather service said the downpours would

last until Saturday afternoon, bringing more than 20cm (8in) of rain to some places.

Western and central areas of the country, including Havana, are the worst affected.

Hurricane Agatha hit Mexico last Monday, killing nine people.

Nearly 2,000 people have evacuated their homes in Havana, and around 50,000 people in and around the city are without electricity.

Evacuation centres have been prepared to shelter people from the rain, the state-affiliated Cuban News Agency reported.

The storm is the remnant of Hurricane Agatha, which hit Mexico's west coast last week killing nine people.

It was the strongest hurricane ever recorded in the country during the month of May.

The weather system has now moved north-east towards the Gulf of Mexico, and is likely to become the first named tropical storm of the season. It is expected to bring heavy rain to the US state of Florida.

Cuba is no stranger to hurricanes, but climate change has increased the intensity and frequency of the powerful storms.

In 2019, amendments were made to the Cuban constitution which commit the government to confronting climate change, recognizing it as a threat to the survival of the human species.

Tracy: Minister Mai "crossed a dangerous line" in House

The sitting of the House of Representatives this past Friday was rife with disputes, one of which led to what the UDP has called a "shameless display of misogyny" after a heated debate quickly became insolent.

The exchange took place after Prime Minister Hon. John Briceño introduced a loan motion for the expansion and rehabilitation of the Philip Goldson Highway, which Hon. Panton rose to oppose. The US \$24 million loan, which would be used to repair 16 miles of the highway (from Miles 8.5 to 24), has been approved by the Central American Bank for Economic Integration (CABEI), of which Belize is a member and from which it is thus eligible to receive financial and technical assistance.

While Panton did not dismiss the importance of infrastructure development, she criticised the government's continued borrowing at what she called an "irresponsible rate". She also pointed out the government's constant flip-flopping between celebrating the country's economic rebound and lamenting about austerity.

During her address, Hon. Panton used a term that some have deemed offensive to refer to the Government's irresolute stance on its economic performance, which garnered criticism from Cayo South area rep, Hon. Julius Espat. Hon. Panton quickly apologized for using the term and retracted her statement, extending an apology to all Belizeans.

This was not the case, however, when the member for Orange Walk South and Minister of Agriculture, Hon. Jose Abelardo Mai, rose to support the motion. After criticising the previous administration for mishandling the country's infrastructural development, Hon. Mai turned his attention to Hon. Panton, calling her "confused" and then bringing up the topic of carrots—an issue to which Hon. Panton had referred when she had made previous public statements about the purported losses being suffered by carrot farmers in Orange Walk (Mai's constituency) whose crop is supposedly rotting in the ground because of sub-par sales locally.

"She spoke about carrots and putting old pictures from under their term, Madam Speaker. She is confused. Confusing in the sensation to pee-pee and to poo-poo," he remarked, eliciting laughter from other members of the House.

"Confusing carrots fi something else, definitely. You are confused, my dear. So, Madame Speaker, when you put nonsense on Facebook like that, it is shaming, man. Let me tell you something, you need to correct yourself. Unconfuse yourself. When you go and sit down on the carrots and take a photograph, I will believe it. The next time you go to San Carlos, you go and sit on the carrots and take a photograph and make it evidence. Do not come here and lie. You are deceiving people. Unconfuse your sensation, please," added Hon. Mai, who also told Hon. Panton that if she truly cared for local farmers, she would have attended the National Agriculture and Trade Show

to witness the work they have been doing.

After Friday's events, Hon. Panton took to her social media page to voice her discontent, calling Hon. Mai's comment that she should go sit on the carrots—a comment which she says was laced with sexual innuendo—completely unparliamentary.

"Abelardo Mai, is that how you

"Abelardo Mai, is that how you speak to a woman? Is that how you speak to your mother, your sister, and your wife?" she wrote, calling the Orange Walk South representative a disrespectful fool.

"Where are Rossana and Dolores? In fact, where was the House Speaker, Valerie Woods, did she really miss the sexual innuendo of this fool?" added Hon. Panton.

But while the three women called out by Hon. Panton were silent, the United Democratic Party was quick to condemn the House members, calling Hon. Mai's comments and the supporting laughter a "most shameless display of misogyny" and expressing disappointment that the Speaker of the House did not reprimand Hon. Mai.

"The United Democratic Party is appalled at the nasty verbal assaults directed at Hon. Tracy Panton in today's meeting. We strongly condemn the comment made by the Member from Orange Walk South, Jose Mai, and call shame on all the members who laughed and cheered him on," stated the UDP.

The party has accused Speaker Woods of chairing the House using a laissez-faire approach and allowing House members on the Government side to "insult, belittle, and bully members of the opposition bench." Additionally, the party has called on the Speaker to demand an apology from Hon. Mai and to censor him.

Also speaking out against Hon. Mai's comments was the United Democratic Party National Organization of Women (UDP NOW), who with their own press release have demanded an apology for Hon. Panton not only from Minister Mai but also from the Prime Minister who, not long after Hon. Mai, said to the Albert area rep, "don't get excited; you might get a stroke right now, just relax."

The UDP has noted that this was not Hon. Briceño's first instance of using "offensive tactics" against the Albert area representative.

UDP NOW condemned Hon. Mai's comments as being "condescending, lewd, distasteful, and disrespectful."

"The Member from the House of Representatives from Orange Walk South, the Hon. Jose Abelardo Mai, crossed a dangerous line yesterday," wrote Hon. Tracy Panton on Saturday.

According to her, Minister Mai has since contacted her to give her somewhat of an apology, stating that "what she thought she heard is not what he meant to say" and calling the matter a miscommunication. She has said, however, that the matter requires a public apology.

to flood waters rising to up to 12 inches. "This is a dangerous and lifethreatening situation. Traveling during these conditions is not recommended. It's better to wait. Turn around, don't drown," wrote The City of Miami on Twitter.

Between Friday and Saturday, somewhere around 100 vehicles became stranded in floodwaters throughout Miami, reports CNN.

According to the Mayor of Miami Beach, Dan Gelber, the storm put the city's drainage pumps—recently installed in response to increased flooding in the area caused by climate change—to the test. He told local reporters that, since Saturday, the flood waters have been dissipating.

Late Sunday evening, the center of Tropical Storm Alex was located some 395 miles west of Bermuda. With maximum sustained winds of 65 mph, it is expected to pass north of the island on Monday, causing up to 2 inches of rain

While the Atlantic Hurricane Season officially began on Tuesday, June 1, the formation of Alex marks an unusually early start. Last month, the National Oceanic and Atmospheric Administration (NOAA) published their predictions regarding this year's hurricane season, forecasting an above-average year with at least 14 named storms.
