"Phantom" carbon credits being sold from Belize?

A company listed as Forest Carbon Offsets LLC is selling carbon credits from the Boden Creek Forest Carbon Project; sales are being verified by an out-of-date Verra Registry. The CEO in the Ministry of Sustainable Development, Climate Change and Disaster Risk Management, Kenrick Williams, says no regulated market for the sale of carbon credits has yet been established in Belize



Yesterday, the Ministry of Sustainable Development, Climate Change, and Disaster Risk Management issued a release warning "companies purporting to sell carbon credits from within the country" and noting that the government has not sanctioned those transactions

and that all authorization to engage in those sales would have to be given by the government. While the release was issued in response to some posts on social media that alluded to such unsanctioned sales, AMANDALA has come across an investigative report done by The Nikkei Asia, the largest financial newspaper in the world, which indicates that carbon credits issued for

the Boden Creek Ecological Preserve Forest Carbon Project (BCEP) are still being issued after CO2 reduction work in the area ended under the project.



British-South African resort owner killed in PG


SAN ANTONIO, Toledo District. Thurs. June 16, 2022

The lifeless body of Kevin Brown, 70, a British-South African retiree and owner of a small resort with an organic farm known as Farm Inn, which is located about a mile away from San Antonio Village on the Jalacte Road in the Toledo District, was found at the resort with apparent gunshot wounds on

Monday, June 13. There have been conflicting reports about the specific location on the property at which the discovery of the body was made—with initial reports indicating that he was found floating face-up in a pool on the grounds of the resort, while subsequent reports have stated that he was found on the floor of his office.

CARICOM trying to restore correspondent banking—PM

At the first official press conference held by the Prime Minister since his being elected into office in November 2020, Hon. John Briceño spoke on several foreign affairs issues concerning the country and the region, including correspondent banking. The derisking carried out by US banks, which have ended their relationships with several banks in the region in order to avoid possible sanctions due to strict banking regulations, have caused numerous challenges for small CARICOM countries, and was a topic that was brought up during a side meeting at the IX Summit of the Americas, where the Prime Minister and other CARICOM Heads of State were, once again, able to meet with US congresswoman Maxine Waters.

During that meeting, a discussion was held on how the region could restore correspondent banking relationships with the US.

"In the meeting with Maxine Waters, what she was suggesting is to hold a congressional committee meeting and to invite CARICOM leaders to go and to talk about it, and she's hoping that eventually, she could have a carve-out for the Caribbean to see how we can have these banks provide services to the region," he stated.

"Because as we pointed out that there is a more responsibility from the banks that you can't just cherry-pick your customers, you need to provide services to everyone," he added.

The Prime Minister noted that getting the US to address the issue has, in the past, been frustrating since, before now, neither the banks nor Congress have been willing to cooperate.

"As I mentioned at our meeting, we feel like a ping-pong ball, because they are saying that it is not them, it is the banks, and the banks are saying that it is not them, it is Congress and it seems that no one is prepared to make a definitive decision in trying to resolve this problem," said the Prime Minister.

Foreign Minister Hon. Eamon Courtenay also spoke on the matter, and he described the double standard that currently exists in the world of banking—where the rich countries that condemn smaller nations for money laundering and terrorism are never condemned themselves—as "a bit difficult to stomach."

"We find it curious that the Caribbean, let's speak about the Caribbean, is being pressured on money laundering and anti-terrorism. But it was curious that once the sanctions were announced against Russia, the billions of dollars that they say is the proceeds of money laundering were found in London, in New York, in Geneva," said Minister Courtenay.

In April of this year, at the Caribbean Financial Access Roundtable Meetings held in Bridgetown, Barbados, Prime Minister Mia Mottley expressed similar sentiments, pointing out that while the countries routinely placed on antimoney laundering lists receive relatively little international financing of any sort, those that have never and will never be listed are where most money laundering, regrettably, takes place. That meeting was where Prime Ministers Mottley and Briceño were first able to meet with Congresswoman Waters.

Over the years, Belize has lost about 85% of its previously established correspondent banking relations.

El Salvador loses \$50 M as cryptocurrency market crashes

SAN SALVADOR, El Salvador, Thurs. June 16, 2022

With the rapid decline of the cryptocurrency market and a recent sharp drop in the value of Bitcoin, El Salvador has reportedly lost over fifty percent of what it invested in the market.

According to VICE News, El Salvador's government purchased a total of 2,301 Bitcoins for \$105.6 million. Those Bitcoin reserves, however, lost 51% of their value on Monday and are now only worth \$51.6 million, representing a loss of more than fifty million dollars for the Central American nation.

Earlier, in January, the International Monetary Fund (IMF) had

recommended that the country liquidate its Bitcoin reserves and fully abandon using the cryptocurrency as legal tender. The country's government, however, outright refused.

Despite the possible threat that the cryptocurrency crash poses to the country's economy, El Salvador's government remains seemingly unperturbed. On Monday, Finance Minister Alejandro Zelaya said at a press conference that there is still an "extremely minimal" fiscal risk, noting that the decline in the value of Bitcoin does not represent more than 0.5% of the national budget.

In September 2021, El Salvador became the first country to accept Bitcoin as legal tender, amid much criticism from both inside and outside the nation.

suffered gunshot wounds in the center of his chest, his left palm, the right side of his back, and near his left ear.

His body was reportedly found at about 3:00 p.m. on Monday afternoon by Jim McArthur, a farmer and friend of Brown who lived nearby and who went to visit him, but found that the front door of the home/establishment was locked. He reportedly shouted Brown's name and knocked more forcefully, but there was no reply. Recent reports are indicating that McArthur then entered the home through an open door at the back and discovered Brown's lifeless body on the floor.

McArthur subsequently contacted Brown's wife, who resides in Placencia, to inform her of what had happened, then he called the police.

After police arrived at the scene,

Brown's body was transported to the Punta Gorda Hospital, and moments after 6:00 p.m. on Monday night, he was pronounced dead.

When asked about the incident by local reporters, Commissioner of Police Chester Williams stated, "From what investigators are seeing or what investigators saw on the scene, it would appear to be a robbery gone wrong, and the place was ransacked and several items were missing, including the deceased's licensed shotgun, and so there are persons that we are looking at with the hope that we'll be able to get some positive leads to be able to solve this murder in Punta Gorda."

Police are yet to detain any persons in connection with Brown's death.

Brown's daughter is reportedly offering a \$2,000 reward for any information that leads to the arrest of her father's murderer.

An out-of-date carbon-reduction projects database controlled by Verra, a US-based NGO, lists BCEP as the main operator of the project; this is despite a takeover by Forest Carbon Offsets as the main operator in October 2017, and a reported temporary control by a US coal company in 2017 also. The issue here is that there is every indication that 190,000 tons of carbon credit were produced up until 2015, and none after that period, suggesting the US-based controllers and successor of the BCEP stopped forest conservation activities.

In 2021, however, Japan Petroleum Exploration (JAPEX) purchased 120,000 tons of carbon credits from the BCEP to offset a vessel of liquified natural gas sent to Japan. The credit purchase was verified by Verra, the company says. The company, Verra, has still not updated its database, according to the investigative report.

In 2021, Fauna and Flora International purchased the land covered by the carbon offset program to prevent it from being converted to farmland, its spokespersons say. That non-profit

organization will not be paid for any credits, since they do not control the project itself.

While the sale of old carbon credits is not itself a violation of any current law, it brings to the fore how important it is that carbon credit buyers vet the quality of the carbon offset projects from which they purchase credits to achieve their carbon neutrality goals.

Experts think this case in Belize is just the tip of the iceberg; reports of forests being mowed shortly after carbon credit certificates were issued in India and Uruguay have surfaced. A call for increased and independent oversight, to ensure that carbon credits are not purchased from defunct or old projects is now seen as absolutely necessary.

"The discovery of outdated information published by a certification organization points to a major lapse of oversight. Buyers of credits issued for the Belize project were not aware that the main project operator had changed," the Nikkei article states.

The project description outlined on the REDD project database website states, "The core objective of this project is to commercialize the forest carbon offsets at the Boden Creek Ecological Preserve near Punta Gorda, Belize, Central America. This property has been the site of a groundbreaking effort to use eco-tourism as a funding source for land preservation. Before project implementation, the land was under immediate threat of land conversion for agriculture, containing international protected biodiversity. The Boden Creek Ecological Preserve is a private preserve that owns the project site, leased to Belize Lodge and Excursions (BLE). BLE is an ecotourism enterprise with four ecolodges and tourism packages that promote conservation, community development, and the use of sustainable practices within BCEP."

According to the available data, the project started in 2005 and is listed to end in 2029, but the available information was last updated in June of 2020 and does not reflect FFI's purchase of the project area since they acquired the land in 2021. Today, CEO of the Ministry of Climate Change, Kenrick Williams, told local media during an interview that a framework for the sale of carbon credits from the country has not yet been finalized. He said that there are entities selling carbon credits under the voluntary system.

During his remarks, CEO Williams said, "We just want to notify that company should engage the ministry, as it is legislatively, there're no penalties. That legislative framework is being outlined as we speak ... other ministries are in a process of developing that legislative framework to guide this process. Now, all of this fits in the broader framework of, again, the UN framework convention on Climate Change. The outcome of COP26, for example, influences how this market works, and this itself is not very clear. The negotiations continue, and so we have been trying to devise a framework based on some of the outcomes of the decision at COP as it will influence the national and international markets."

He stated that small-scale and commercial projects will impact the national carbon project—although no reference was made to the Boden Creek project during his remarks.

"What the Ministry of Sustainable Development is concerned about is as it relates to the carbon budget. Once you purport to sell 100 tons of carbon, that affects our total quota available ... based on our forest stand, nationally.

Minister Courtenay: US's exclusion of 3 countries in region "myopic, shortsighted, misguided"

"Bilateral discussions are taking place, but they want us to believe that when it comes to the entire hemisphere these countries are dictatorships. Well, if they can have relations with them, and we can have relations with them, and this is Summit of the Americas, there is absolutely no justification for excluding them ...," Senator Eamon Courtenay said.

Prime Minister Hon. John Briceño's speech at the Summit of the Americas was lauded by the *New York Times* as "remarkable", and was described by that newspaper as a public chastisement of US president Joe Biden. The PM's remarks were delivered just a moment after Biden left the lectern. In the joint press conference he held yesterday with Minister of Foreign Affairs, Hon. Eamon Courtenay, however, Prime Minister Briceño objected to assertions that he had chastised President Biden.

"No, I was not publicly chastising the president. I need to point out, first, that was publicly known what was CARICOM's position, and I went there to speak as the Chairman of CARICOM, and at the same time for Belize. Belize has been very clear that the Summit of Americas should be inclusive; it is a summit that is defined by geography, not by ideology, and I felt strongly that all countries should be invited ...," PM Briceño said.

Foreign Affairs Minister Hon. Eamon Courtenay subsequently pointed out that the United States has been engaged in diplomatic relations with both Cuba and Venezuela recently, and moreover, that the Summit belongs to the Americas, unlike the United States Summit of Democracy held last December that PM Briceño attended.

"The 9th and 10th of December last year, President Biden hosted the Summit of Democracies, Prime Minister Briceño attended. Cuba, Nicaragua, and Venezuela were not invited because that was an American conference, an American summit. As the Prime Minister has said, the Summit of the Americas does not belong to the United States; the United States merely hosted the summit. The summit belongs to the Americas; the last two Summits these countries attended. It is curious to me, that less than a month ago the United States announced new measures with Cuba's supposed dictatorship. It is curious to me that about two months ago the United States and Cuba actually had bilateral talks on immigration, one of the main topics of the summit," Senator Courtenay said.

In regard to relations with Venezuela, Senator Courtenay remarked, "It is curious to me that less than a month ago the United States announced a waiver to do business with Venezuela. It is curious to me that less than a month ago, the United States National Security Council sent a delegation to negotiate with Venezuela. Bilateral discussions are taking place, but they want us to believe that when it comes to the entire hemisphere, these countries are dictatorships. Well, if they can have relations with them, and we can have relations with them, and this is the Summit of the America, there is absolutely no justification for excluding them ...," Senator Eamon Courtenay said.

Hon. Courtenay further noted that a

key purpose of the summit was to look at the pressing issues (such as migration within the hemisphere) that were being hashed out in discussions at the summit, and he said that the exclusion of Cuba, Venezuela and Nicaragua defeated the purpose of the talks.

"How can we talk about migration as a hemispheric problem and two of the countries that are countries of origin how hundred and thousands and millions are excluded? How do you find a solution for the problem if you exclude those countries? How can you talk about COVID-19 recovery—when the country that was on the frontline around the world when there was no vaccine is not invited to be part of the discussion on dealing with the continuing problem and future pandemics? We regard that as myopic, we regard that as shortsighted, we regard it as misguided. Mr. Barrow [the Leader of the Opposition, who condemned PM Briceño's objection to the US's exclusion of those three countries] appears to be trapped in a mindset set in the Cold War ...," Senator Courtenay said.

During the recent UDP press conference, UDP leader, Hon. Moses "Shyne" Barrow, who, as previously mentioned, had indicated that the country should not be supporting "dictatorships" simply because it has received some form of aid from such nations, pointed out that his remarks were personal and do not reflect the collective view of the UDP.

"My position, my position, my position - we have not had an opportunity as a party to discuss, because people ask for reform, but do you really want reform? Or do you want the thing to continue the way they did for the last 40 years. I don't believe in that. I also don't believe in homogenous democracy, I believe in diversity ... in Cuba, you don't even have a press corps, and I have a problem with that. I appreciate what they have done for Belize, but I have a problem with dictatorships as a leader of the opposition. In Cuba, those people who are publicly chiming me and attacking me that are part of the party, they would go missing in Cuba. That's what dictatorship looks like ... I am not saying as prime minister I would not have relations with Venezuela and Cuba, but that would not be a wholesale relationship that, okay, you give Petro Caribe, you give medical scholarships and I will say you know, human rights violations don't matter, democracy doesn't matter ...," said Barrow.

Senator Courtenay stated, however, that Belize's diplomatic position remains non-judgmental of the internal politics of countries—noting that even in the United States, there are many who question the legitimacy of election results.

"For Belize, we have an activist foreign policy where we are friends to all and enemies to none. We work to advance the interest of Belize and the region without judging the internal politics of any country," Senator Courtenay said.

PM away on 3week working trip

BELIZE CITY, Thurs. June 16, 2022

For the first time since he took office in November 2020, the Prime Minister of Belize, Hon. John Briceno, alongside the Minister of Foreign Affairs, Hon. Eamon Courtenay, met with members of the local media at the Laing Building in Belize City, on Wednesday, June 15, and at that press conference he announced he will be out of office for three weeks.

The PM's extended absence from the country commences on Thursday, June 16, when he will embark on travels that will see him visit three continents to hold meetings with a number of international organizations. His first stop will be in Brussels, Belgium, where he will attend the EU Development Days Conference, to which only three other CARICOM leaders have been invited, and his last stop will be in Guyana, to which he will be making an official visit.

The objectives of Prime Minister Briceno's international trip are to establish connections with the other Commonwealth countries, strengthen relationships face-to-face with the European Union partners, which play a crucial role in Belize's development, and surrender chairmanship of CARICOM.

"I leave for the summit, and yes, it is early, because I will be in Brussels, where I have been invited to attend the EU Development Days Conference to discuss development issues. Only three CARICOM Heads have been invited: Belize, Dominica, and Trinidad and Tobago. In Brussels, I'll be meeting with the EU heads of government, including the Prime Minister of Belgium. I'll be pushing for the establishment of an EU delegation in Belize and continue our campaign for VISA-free access to the EU. As you all know, the EU is one of our largest donors and our second-largest trading partner," PM Briceño told local media on Wednesday.

He further explained, "... From Brussels, Belgium, I go to Rwanda for the Commonwealth Heads of Governments Summit. There will be the

election of the secretary-general. Foreign Minister Johnson Smith, and Baroness Scotland are vying for the post. We also have some bilateral lined up with Commonwealth partners. On the way back, I will stop off in Lisbon, Portugal for the World Oceans Summit. Here Belize will be featured for our successful negotiation on the Blue Bonds. I'l also going to be meeting with potential investors on the matter of renewable energy. We want to see how we can harness all that sargassum and turn it into electricity, so I'll be having some meetings on this as well."

"Finally, from Lisbon, I go to Suriname to hand over the chairmanship of CARICOM to the incoming president pro-temperate, President Santokhi of Suriname. The CARICOM Heads will be meeting over three days to discuss regional matters. Thereafter, [at] the invitation of President Ali, I travel to Guyana for an official visit," concluded PM Briceño.

According to PM Briceno, the cost of his international travels will be covered by a number of international financial institutions.


During his absence, Deputy Prime Minister, Hon. Cordel Hyde, will be acting as Prime Minister.

A press release issued this evening states, "The Office of the Prime Minister informs that the Hon. John Briceño departed the country, today, en route to Kigali, Rwanda, to attend the 22nd Commonwealth Heads of Government Meeting (CHOGM)."

Guns and drugs found in WPC's home

Stephanie Patten, charged with keeping firearms and ammunition without a gun license and possession of controlled drugs with intent to supply

Patten and the three men subsequently appeared in the Magistrare Court in Belize City (where members of the Police Department's G13 unit were present to ensure heightened security) and were charged for possession of controlled drugs with intent to supply, keeping prohibited ammunition (2 counts), keeping ammunition without a license (2 counts), illicit trafficking of firearms, and possession of unregistered bulletproof vests — a total of seven counts.

Alifah Elrington, who is prosecuting the case, told the court that she would indicate to the court within 14 days whether the matter would be handled summarily or on indictment. Magistrate Tricia Pitts Andersen thus decided not to allow the four detainees to submit a plea, and after the case was adjourned, they were remanded to the Belize Central Prison until August 9, but will have the opportunity to apply for Supreme Court bail

Patten was represented by attorney Richard "Dickie" Bradley in court, but attorney Leeroy Banner, who is representing the three men, was not present in court for the arraignment.

In reference to the operation which led to the arrest of the four persons, Commissioner of Police, Chester Williams told reporters yesterday, "There was an operation launched in Orange Walk Town by police, and during that operation, the home of a female police officer was searched. That search yielded one M4 Carbine rifle, two ninemillimeter pistols, [and] several .223 rounds of ammunition, as well as several nine-millimeter rounds of ammunition, including some cocaine, [and] some crack cocaine."

Reports are that the police officers who conducted the operation spotted two bags which contained 200 rounds of ammunition along with magazines and a 9 millimeter pistol upon their entry into the home, amd they went on to discover 13 more rounds of 9 millimeter ammunition when they searched



Constable Patten's room. The three men were in another room, and when police searched that room they found one black Glock 22 .40 caliber pistol with an extended magazine, in which there were twenty-one (21) live rounds. Additionally, they came across another extended magazine, in which there were twenty-seven live rounds and an M-4 carbine rifle with a magazine containing twenty-five (25) live rounds. Finally, in a third room they found three bulletproof vests and several GSU uniforms —a type which is no longer being used by the Police Department.

The prohibited features on the rifles—including the extended magazine on one pistol and a modification on one firearm that converts it into a fully automatic weapon with the push of a button—suggest that they were not being kept for legal purposes, but were part of the arsenal of a criminal operation.

According to Patten's attorney, Richard "Dickie" Bradley, however, she was in no way associated with any such operation, and the items found in her home were taken there without her awareness or consent.

"What happened is clearly acting on some kind of tip-off, the police actually did a raid at a residence in which they broke down the door, went in and were very successful in finding the various items, including prohibited firearms, about 200 rounds of ammunitions, assorted ammunitions fitting the different firearms that were found — 3 firearms in total. They throw in bulletproof vests; they also claim that they found a small quantity, 9 grams, of crack somewhere in the residence. What this is, is somebody took a large quantity of ammunition and 3 firearms into a property without getting any permission and so on and so forth and everybody that is found in that property, the police have a duty to arrest all of them," Bradley told a 7News reporter.

Questions are now arising among members of the public, however, about the extent of Patten's possible involvement in the criminal underworld, since her recent arrest is not the first time she has been detained for a criminal offense. Patten, who according to one local television newscast, is reportedly married to another police officer, was charged in 2018 for physically assaulting a female patron inside a nightclub in Orange Walk Town. Two years later, in 2020, Patten was once again facing criminal charges after she, along with three women and a female minor, was found with 23.4 pounds of marijuana.

One of the other women, however, took sole responsibility for the possession and trafficking of the drugs, and as a result the charges against Patten were dropped. Her association with

flights from the Caribbean nation.

At a press conference held on Wednesday, at which both the Foreign Minister and Prime Minister Hon. John Briceño spoke to the media, Hon. Courtenay revealed that over the next six weeks, the government will be declining all requests for chartered flights from Haiti to land in Belize.

"We have taken a decision this week, and I informed Cabinet yesterday, that we have requests over the next six weeks for a number of flights to come—charter, Haiti-Belize—in collaboration with Civil Aviation. We are not going to allow them to land, and if we have to reverse the provision of Haitians coming to Belize without a visa, we are going to do so," he said.

About a year ago, Minister Courtenay sought the approval of Cabinet for Haitians to be allowed visafree entry to Belize, because, as he noted, that is a requirement under the revised Treaty of Chaguaramas. According to the Minister, however, since then there has been a significant number of Haitians arriving in the country on a one-way ticket with no hotel reservation but claiming that they are tourists. This, combined with a recent Yahoo News article that revealed charter flights are being used to smuggle Haitians out of their country, is what spurred the Minister's decision.

The article, titled "Charter business thrives as US-expelled Haitians flee Haiti", explains how Haitian influencers have been advertising businesses that offer charter flights to South America for persons who were previously expelled from the US and are seeking to return. Those businesses, says the National Coordinator of Immigrants in Chile, have been exploiting desperate Haitians for profit.

"Many of the customers are Haitians who had been living in Chile and Brazil before they made their way to the Texas border in September, only to be expelled by the Biden administration and prevented from seeking asylum. They are using the charter flights to flee Haiti again and return to South America ... Some, clearly, plan to make another try to enter the United States," states an excerpt of the article.

According to Minister Courtenay, the Ministry of Immigration seeks to protect migrants from being abused and trafficked by smugglers. According to him, the Ministry of Immigration is currently trying to "clean up a very difficult situation."

A cabinet brief released late this evening states," The Minister of Foreign Affairs, Foreign Trade and Immigration informed Cabinet of the increase in requests for permits to allow charter flights from Haiti to Belize with Haitians. The ministry has carefully assessed these applications and is satisfied that they are not genuine tourist flights. Accordingly, in consultation with the Ministry of Blue Economy & Civil Aviation, permission to land will not be granted. The minister is considering revoking visa-free travel to Belize for Haitians. "

"Phantom" carbon credits being sold from Belize?

Let's say, for example, we estimate that there is 100 metric ton that is available as a country to sell. X company decides to sell 20 tons of those credits, that affects the national quota, so that means there are only 80 tons on the market left. What is missing from this process is that there is no review verification of the methodology, ensuring that there are real benefits that

are going to the forest, and the land tenure—there are several assessments that we would have to look at to ensure that is a viable project and it's not greenwashing or carbon washing ... because again it affects the available carbon we have on sale on the market," CEO Williams said.

We reach out to CEO Williams on the matters highlighted but have received no reply up to press time this evening. We will continue to follow.

such persons, however, and her previous run-ins with the law might have been seen as a sufficiently strong indication that she possibly was not fit to serve as a law enforcement officer, but when faced with queries about why Patten had not been removed from the Police Department, Police Commissioner Williams noted that she previously had not been convicted of any drug trafficking charges, but that it is less likely that she will be able to evade prosecution following this most recent bust.

"Well, she was charged, but someone else took the rap, and she got off. In this case, it's different now. The items are found in her home. I don't see if someone goes and pleads guilty how she can get off...," Williams commented.

It appears, however, that a similar attempt was made by one of the three men today to take responsibility for the weapons and drugs found in Patten's home. However, because Magistrate

Tricia Pitta Andersen did not allow the submission of pleas, that person was not allowed to plead guilty. In regard to that attempt to submit a plea, attorney Richard "Dickie" Bradley said, "... One of the persons asked to speak to the magistrate after all the charges have been read and they were already told they were remanded — one of the persons said that 'I am taking responsibility for the items that were found, but I would like to speak to my attorney, who is not me."

Commenting on the possible presence of rogue officers within the Police Department, Commissioner of Police Chester Williams said, "Every day we try our best to keep our officers out of line, and when we find that they step out of line and where we find they have stepped out of line, we do our best to discipline them, and I can tell you again, we are dismissing police officers every day."



Will PM's waves at 9th Summit of Americas wash good things ashore?

Hon. John Briceño, our Prime Minister and Chairman of CARICOM, made some big waves at the 9th Summit of the Americas held in Los Angeles, USA, when he challenged the host nation for its failure to invite Cuba, Nicaragua, and Venezuela to the sessions, and called on the hosts to work harder at addressing the problems in our region. Hon. Briceño said the non-invitees should have been there because "geography, not politics, defines the Americas." Several nations in the Americas boycotted the Summit to protest the exclusion of the three countries, who weren't invited because their governments are out of favor with the US. Sonia Pérez D., of the Associated Press, said Guatemala, also a no-show, stayed away because the Biden administration had criticized its government for reappointing an attorney general "the U.S. accuses of protecting the corrupt."

PM Briceño said we need a more "socially just Americas", and he warned that the region and the world "are at the tipping point", facing "existential threats" such as climate change, a crushing debt crisis, poverty, irregular migration, and division. He praised Cuba and Venezuela for the excellent support they have given to the less developed countries in our region over the years. He described the six-decades-long US embargo on Cuba as an "illegal blockade", and declared it to be "un-American."

Mark Keller , Elizabeth Gonzalez , Hope Wilkinson and Carin Zissis, in a story published by AS/COA (Americas Society, Council of the Americas), said the 1st Summit of the Americas was convened by US president Bill Clinton in 1994 and its aim was to develop a/ new relationship/ with the hemisphere in the post-Cold War environment. The Summits are held every three or four years, and only democratically elected leaders in the Americas are invited. Cuba, the story

says, traditionally "has not participated, though it joined both the 2015 and 2018 Summits."

The US has been leading the Western Hemisphere for around 200 years. With the announcement of the Monroe Doctrine in 1823, the US declared that it was taking charge in the West. The US's National Archives says the Monroe Doctrine is "the best known U.S. policy toward the Western Hemisphere" and its mission was to warn "European nations that the United States would not tolerate further colonization or puppet monarchs." After WWII, US dominance would extend beyond the Americas, across the globe to Europe, Africa, and Asia, everywhere.

A former colony of the British, the US insisted it wasn't interested in making colonies of the nations in the Americas, but implicit in the Monroe Doctrine is that it expects us to cooperate. It's not a one-sided arrangement. In return for American business folk/businesses getting royally handled, the US ensures that there is stability in the West. When governments fail to "cooperate," they are destabilized, through interference in the democratic

process, or through orchestrated insurrection.

How the US handled Panama's separation from Colombia is instructive. The website history.com says, "In 1903, Panama declared its independence from Colombia in a U.S.-backed revolution," and after the dust settled "the U.S. agreed to pay Panama \$10 million for a perpetual lease on land for the canal (Panama Canal), plus \$250,000 annually in rent."

The US has failed numerous times as the leader of the Americas. The US was cozy with the corrupt Cuban dictator, Fulgencio Batista, who stymied the democratic process and allowed his country to become a playground for American gangsters. When Fidel Castro and his band overthrew Batista in 1959, the US, instead of recognizing its failure in Cuba and trying to make amends, allied with anti-Castro elements that sought to violently remove him. This forced the Castro regime to turn to the USSR, to bolster their revolution.

In 1954, ruthless CIA agents overthrew Jacobo Arbenz, the democratically elected president of Guatemala. According to files from the *Baltimore County History Labs Program*, the American multinational, United Fruit Company (UFC), apart from owning Guatemala's telephone and telegraph system and much of its railroad track, had gained control of 42% of Guatemala's land and won exemption "from paying taxes and import duties." Arbenz's reformist government redistributed undeveloped private lands to landless farmers, and he allowed Guatemala's 4,000 communists to participate in the country's politics. When Arbenz expropriated idle lands from UFC, the company rejected the compensation the government had proposed and swung into action, screaming that the Arbenz government was communist.

Repeatedly, the greed of some US citizens has hurt their image and caused pain in the region. John Dulles was US Secretary of State, and his law firm represented UFC; Dulles brother, Allen, was the Director of the CIA. They and other highly connected Americans who had interests in UFC, conspired and drove Arbenz out of government. The Baltimore papers say a surprised Arbenz turned to the US government for support when he came under attack, not knowing that the US's CIA had organized the coup against him. After the US betrayal, Guatemala would fall into a bloody civil war that lasted 36 years.

Apart from facilitating rapacious US businessmen, US foreign policy has engendered environments where local elites amass millions, while crushing poverty is the lot of the masses. The Americans fight communism, while their policies have helped make many countries in the Americas hotbeds of discontent. Its war against cocaine has made Belize, El Salvador, Guatemala, Honduras, and Mexico some of the most murderous places on earth.

The people of the Americas are grateful to the US for the relative stability in our region, admire its democracy, and yearn for its standard of living. We know the US doesn't have all the blame for the problems in our region. But it has played no small role. Disappointingly, the single leader who showed the compassion and understanding the Americas need is reviled at home. Jimmy Carter, the US's 39th president (1977-81), cut back support to cruel military regimes in the region, helped Belize on its path to independence, eased as much pressure as he could off Cuba, and signed a treaty with Panama that gave the people of that country ownership of the canal in 1999.

After Carter left office, the US returned to its brand of "colonialism" that gives unfettered run to American businessmen and local elites, and leaves the masses to scramble for crumbs. Today, just about the only hope for destitute people living south of the Rio Grande is to join caravans, trek through Mexico, and scale their (American) wall that was built to keep us out.

PM Briceño spoke boldly. There are many challenges presently plaguing our region—crushing poverty, unbelievably horrific levels of violence, and escalating global warming-induced natural disasters. Our banking system is crippled by severe US-instituted restrictions. These are critical times, and the people of the Americas need the US to engage us in meaningful dialogue. That's why the PM made waves when he spoke at the summit.

Dickie: "hit" allegations against Jasmine are bogus.

Amid allegations that she hired gang members to kill a local magistrate and the Commissioner of Police, and following the departure of her ex-partner, Andrew Ashcroft, from the country with their twin 5-year-old children, Jasmine Hartin has taken her plight to the Canadian media, and through those outlets has begged Prime Minister Justin Trudeau for help.

BELIZE CITY, Wed. June 15, 2022

The attorney for Jasmine Hartin, set to stand trial for the May 2021 killing of Police Superintendent Henry Jemmott in San Pedro and accused of ordering a hit on both the Commissioner of Police and a local magistrate, says that the allegations being made against his client, at least in regards to the purported hit, are "bogus".

Richard "Dickie" Bradley spoke briefly with the media on Wednesday about the fact that Hartin is still being investigated for threats made against the Police Commissioner, Chester Williams, as well as the alleged hit.

"In regards to the allegations against poor Miss Jasmine, that she is trying to

kill, she is trying to make arrangements to kill the Commissioner of Police, that is hogwash," stated Bradley.

Hartin was taken into police custody for questioning regarding the matter back in May but was released shortly after. This month, however, Commissioner Williams told local reporters that Hartin is not yet off the hook. Still, Bradley is confident that nothing will come out of the investigation and, subsequently, the case.

"Now, by now you know that the police have gone through every phone—the alleged hit person, all his phones have been thoroughly checked; Jasmine's phone was taken away, likewise, every phone, everybody's phone was checked. Nothing," he added.

According to the Police

Commissioner, Jasmine Hartin has, on numerous occasions, sent him "disturbing" text messages, the content of which makes it easy for him to believe that she made attempts to harm him. Hartin's

attorney asserts, however, that those texts are irrelevant to the allegations being made against her.

Bradley also spoke to local media about the departure of Andrew Ashcroft, Hartin's ex-partner, who just a few weeks ago was granted legal custody of their two children, from the country.

On Monday, Ashcroft issued a press release stating that he, along with the



children, would be leaving Belize for the Turks and Caicos to develop a hotel similar to the Alaia.

"I hold no ill will or malice towards Jasmine and wish her well with the court proceedings in which she is facing charges of manslaughter, cocaine possession, and common assault," he wrote.

Ashcroft further noted that he had gifted Jasmine ten percent of the shares of the holding company of The Belize Alaia Hotel and that he intends to provide her with their fair value "after obtaining an independent valuation."

"You ever hear somebody announce that they're leaving the country?" Bradley questioned sardonically, "when supposedly, and I use the word guardedly, supposedly, the matter of the custody decision is being appealed in the Supreme Court of the country?"

¿Las olas del PM en la 9. Cumbre de las Américas traerán cosas buenas a tierra?

El Honorable John Briceño, nuestro Primer Ministro y Presidente de CARICOM, causó gran revuelo en la IX Cumbre de las Américas celebrada en Los Ángeles, EE. UU., cuando desafió a la nación anfitriona por no haber invitado a Cuba, Nicaragua y Venezuela a las sesiones, y llamó a los anfitriones a trabajar más duro para abordar los problemas en nuestra región. Briceño dijo que los no invitados deberían haber estado allí porque "la geografia, no la política, define a las Américas". Varias naciones de las Américas boicotearon la Cumbre para protestar por la exclusión de los tres países, que no fueron invitados porque sus gobiernos no están favorecidos por EE. UU. Sonia Pérez D., de Associated Press, dijo que Guatemala, que tampoco se presentó, se mantuvo alejada porque la administración de Biden había criticado a su gobierno por volver a nombrar a una fiscal general "a la que EE. UU. acusa de proteger a los corruptos".

El primer ministro Briceño dijo que necesitamos una América más "socialmente justa", y advirtió que la región y el mundo "están en un punto de inflexión", enfrentando "amenazas existenciales" como el cambio climático, una crisis de deuda aplastante, pobreza, migración irregular, y división. Elogió a Cuba y Venezuela por el excelente apoyo que han brindado a los países menos desarrollados de nuestra región a lo largo de los años. Describió el embargo estadounidense de seis décadas contra Cuba como un "bloqueo ilegal" y lo declaró "antiestadounidense".

Mark Keller, Elizabeth Gonzalez, Hope Wilkinson y Carin Zissis, en un artículo publicado por AS/COA (Sociedad de las Américas, Consejo de las Américas), dijeron que la Primera Cumbre de las Américas fue convocada por el presidente estadounidense Bill Clinton en 1994 y su objetivo era desarrollar una nueva relación con el hemisferio en el entorno posterior a la Guerra Fría. Las Cumbres se realizan cada tres o cuatro años, y sólo son invitados los líderes democráticamente elegidos de las Américas. Cuba, dice la nota, tradicionalmente "no ha participado, aunque se unió a las Cumbres de 2015 y 2018".

Estados Unidos ha estado liderando el hemisferio occidental durante unos 200 años. Con el anuncio de la Doctrina Monroe en 1823, Estados Unidos declaró que se hacía cargo de Occidente. Los Archivos Nacionales de EE. UU. dicen que la Doctrina Monroe es "la política estadounidense más conocida hacia el hemisferio occidental" y su misión era advertir a las "naciones europeas que Estados Unidos no toleraría más colonizaciones ni monarcas títeres". Después de la Segunda Guerra Mundial, el dominio estadounidense se extendería más allá de las Américas, por todo el mundo hasta Europa, África y Asia, en todas partes.

Una antigua colonia de los británicos, EE. UU. insistió en que no estaba interesado en hacer colonias de las naciones en las Américas, pero implícito en la Doctrina Monroe está que espera que cooperemos. No es un arreglo unilateral. A cambio de que los empresarios/negocios estadounidenses se manejen como reyes, EE. UU. se asegura de que haya estabilidad en Occidente. Cuando los gobiernos no logran "cooperar", son desestabilizados, a través de la interferencia en el proceso democrático o a través de la insurrección orquestada.

Es instructivo cómo Estados Unidos manejó la separación de Panamá de Colombia. El sitio web history.com dice: "en 1903, Panamá declaró su independencia de Colombia en una revolución respaldada por Estados Unidos", y después de que el polvo se asentó, "Estados Unidos acordó pagarle a Panamá \$10 millones por un arrendamiento perpetuo de tierra para el canal (Panamá Canal), más \$250,000 anuales en renta".

Estados Unidos ha fracasado en numerosas ocasiones como líder de las Américas. Estados Unidos se mostró cómodo con el corrupto dictador cubano, Fulgencio Batista, quien obstaculizó el proceso democrático y permitió que su país se convirtiera en un patio de recreo para los gánsteres estadounidenses. Cuando Fidel Castro y su banda derrocaron a Batista en 1959, Estados Unidos, en lugar de reconocer su fracaso en Cuba y tratar de enmendarlo, se alió con elementos anticastristas que buscaban destituirlo violentamente. Esto obligó al régimen de Castro a volverse hacia la URSS, para impulsar su revolución.

En 1954, despiadados agentes de la CIA derrocaron a Jacobo Arbenz, el presidente democráticamente elegido de Guatemala. Según archivos del *Programa de Laboratorios de Historia del Condado de Baltimore*, la multinacional estadounidense United Fruit Company (UFC), además de ser propietaria del sistema de teléfonos y telégrafos de Guatemala y gran parte de sus vías férreas, había obtenido el

control del 42% de las tierras de Guatemala y obtuvo la exención "del pago de impuestos y derechos de importación". El gobierno reformista de Arbenz redistribuyó tierras privadas no desarrolladas a agricultores sin tierra y permitió que los 4.000 comunistas de Guatemala participaran en la política del país. Cuando Arbenz expropió las tierras ociosas de la UFC, la empresa rechazó la compensación que había propuesto el gobierno y entró en acción, gritando que el gobierno de Arbenz era comunista.

Repetidamente, la codicia de algunos ciudadanos estadounidenses ha dañado su imagen y causado dolor en la región. John Dulles fue Secretario de Estado de los Estados Unidos y su bufete de abogados representó a la UFC; El hermano de Dulles, Allen, era el director de la CIA. Ellos y otros estadounidenses altamente conectados que tenían intereses en UFC, conspiraron y sacaron a Arbenz del gobierno. Los periódicos de Baltimore dicen que Arbenz, sorprendido, recurrió al gobierno de los EE. UU. en busca de apoyo cuando fue atacado, sin saber que la CIA de los EE. UU. había organizado el golpe en su contra. Luego de la traición de Estados Unidos, Guatemala caería en una cruenta guerra civil que duró 36 años.

Además de facilitar a los rapaces empresarios estadounidenses, la política exterior estadounidense ha engendrado entornos en los que las élites locales acumulan millones, mientras que la pobreza aplastante es la suerte de las masas. Los estadounidenses luchan contra el comunismo, mientras que sus políticas han ayudado a que muchos países de las Américas sean focos de descontento. Su guerra contra la cocaína ha convertido a Belize, El Salvador, Guatemala, Honduras y México en algunos de los lugares más asesinos del mundo.

Los pueblos de las Américas están agradecidos con los Estados Unidos por la relativa estabilidad en nuestra región, admiran su democracia y anhelan su nivel de vida. Sabemos que Estados Unidos no tiene toda la culpa de los problemas de nuestra región. Pero no ha jugado un papel menor. Lamentablemente, el único líder que mostró la compasión y la comprensión que las Américas necesitan es vilipendiado en casa. Jimmy Carter, el presidente número 39 de los EE. UU. (1977-1981), redujo el apoyo a los crueles regímenes militares de la región, ayudó a Belize en su camino hacia la independencia, alivió toda la presión que pudo sobre Cuba y firmó un tratado con Panamá que otorgó al pueblo de ese país la propiedad del canal en 1999.

Después de que Carter dejó el cargo, EE. UU. volvió a su tipo de "colonialismo" que da rienda suelta a los empresarios estadounidenses y las élites locales, y deja a las masas luchando por las migajas. Hoy en día, casi la única esperanza para las personas indigentes que viven al sur del Río Grande es unirse a las caravanas, caminar por México y escalar el muro (estadounidense) que se construyó para mantenernos alejados.

El PM Briceño habló con valentía. Hay muchos desafíos que actualmente aquejan a nuestra región: pobreza aplastante, niveles de violencia increíblemente horribles y desastres naturales inducidos por el calentamiento global en aumento. Just one day after Ashcroft's departure, Hartin, once again, turned to an international audience to plead her case, this time via the Canadian media. In a video recording sent to the *Toronto Sun*, Hartin asks Prime Minister Justin Trudeau for his intervention:

"Dear Mr. Trudeau, my name is Jasmine Hartin. I'm a Canadian citizen living in Belize. I was involved in a terrible accident last May that resulted in the death of my friend," she says.

In the recording, Hartin also claims that, since her arrest following the shooting death of Superintendent Henry Jemmott, she has been denied a proper investigation and has often been harassed and threatened.

"I've been told I'm not safe if I remain in this country," she states.

Additionally, Hartin claims that she has often been "very vocal" about the

Supt. Arzu, not yet retired, elected chairman of Georgetown village council

GEORGETOWN, Cayo District, Tues. June 14, 2022 Senior Police Superintendent Daniel Arzu, following his victory in the Georgetown village council elections this week, is set to become the new Georgetown village council chairman. But Arzu, who was nominated as an independent candidate in his home village earlier this month, is not expected to retire from his position as the Department's Police

Southern Regional Commander until later this year, according to Commissioner of Police Chester Williams.

When Arzu's plans to vie for the village council chairman post were first announced, the legality of the senior officer's candidacy came under some scrutiny, due to what was seen as a potential conflict of interest. Those concerns, however, were dismissed by Commissioner Williams, who had noted that, since Arzu is an independent candidate and is not aligned with any political party, he was completely free to run.

The Police Commissioner had also suggested that by the time Supt. Arzu possibly became the Georgetown village council chairman, he would have already been retired.

"Mr. Arzu is proceeding on pre-

retirement leave very shortly. For the most part, if he were to be elected the chairman of Georgetown, he would not be a police officer. He would be out by then," he had stated.

Previously, The Minister of Public Service, Hon. Henry Charles Usher, had told *News5* earlier this month that, under Section 60 (2) of the Public Service Regulations, public officers are allowed participation in village council elections because "village councils are, by their very nature, they should be neutral."

When approached by local reporters this week about whether the fact that village council elections have recently been politicized will result in a change in that policy, COMPOL Williams stated that it is a matter for the Public Service Minister and his C.E.O.

Dangriga punta artist reportedly killed by minor

Well-known Dangriga punta rock artist, Robert "Culu" Coote, was allegedly killed by a 17-year-old male.

DANGRIGA, Stann Creek District, Wed. June 15, 2022

Robert Michael Coote, a well-known punta rock artist and fisherman of Dangriga Town in the Stann Creek District, was shot dead on Monday night on St. Vincent Street in Dangriga, and there are reports that the person who has been detained for the shooting is a 17-year-old minor.

According to initial police reports, Coote, also known as "Culu" or "Kunku Man," was standing in front of a Chinese gaming establishment at around 7:45 on Monday night when he was approached by a male individual who fired a number of bullets in his direction. As many as 9 of those bullets wounded Coote (who was reportedly known as a "mediator" in his family) in his chest, arm, pelvic area, and legs.

Coote was transported to the

Southern Regional Hospital for treatment, but succumbed to his injuries shortly after.

At the scene, investigators found seven 9mm expended shells and four fragments.

Shortly after the shooting, police apprehended a 17-year-old male minor who they believe is the alleged triggerman, and who at the time he was stopped by police was carrying a 9mm pistol which police believe is the murder weapon.



Russia removes its U.S. Embassy amid nuclear talks—Part 1



PGIA to receive new X-ray machines and canine unit

The installation of new X-ray machines and a canine unit at the Philip Goldson International Airport's arrival lounge comes as part of an agreement made between BAHA, OIRSA, and the Ministry of Agriculture.

BELMOPAN, Tues. June 14, 2022

Through the signing of a Memorandum of Understanding (MOU) by the Belize Agricultural Health Authority (BAHA), the International Regional Organization for Plant and Animal Health (OIRSA), and the Ministry of Agriculture, Food Security, and Enterprise, the quarantine inspection services at the Philip Goldson International Airport (PGIA) will be upgraded through the implementation of new non-intrusive pre-inspection methods. These methods will be made possible by means of the installation of two X-ray machines, which will be used for inspection of arriving travelers' baggage at the PGIA's arrival lounge, as well as new canine inspection units.

Minister of Agriculture, Hon. Jose Abelardo Mai spoke with the media about the significance of the agreement. He noted that, while the non-intrusive inspection processes might be new to Belize, they are common in other airports in the region.

"I was in the USA the other day passing through to Guyana, and the USDA quarantine service had their dogs in there walking among the people sniffing the bags, so it's not something that's uncommon. It's very common, especially now with people trying to get back to normality, where you start travelling more, so you'll see more of these programs in place where they're

scanning and ensuring to protect the agriculture sector. Everybody does that, so it's not an uncommon thing," said Minister Mai.

Country Representative for OIRSA, Fermin Blanco also spoke to local reporters, explaining what the preinspection process entails.

"Quarantine inspections are what BAHA physically does at the airport, but pre-inspection means that we are using state-of-the-art technology to scan the luggage using a machine to see what is inside. Us at OIRSA, we cannot open luggage, but we scan it and see what is inside, and if we detect any organic material inside the luggage, we tag it so that it goes to BAHA for BAHA to inspect it physically," he said.

Blanco also spoke about the implementation of the new canine inspection procedure.

"We trained canine units in Panama, and we use them here. We walk them around the arrival lounge, and the canine is trained to detect organic material as well—mainly vegetables and meats. So once the canine also detects luggage with organic material in it ... the dog detects it, and the handler tags the bag, and that bag goes to BAHA for inspection," he said.

The quarantine inspections serve to prevent the introduction of pests and diseases into the country, including African Swine Fever and Fusarium wilt, the latter of which has been ravaging



COMPOL: Carl Reneau's death possibly gang-related

Carl Reneau, 33, was murdered in broad daylight on Fabers Road Extension.
COMPOL Williams says his death could have been gangrelated or retaliation for previous crimes he committed.

BELIZE CITY, Wed. June 15, 2022

Two years ago, Carl Reneau, 33, was charged for the murder of Jaheem Mahler, 15, which occurred in 2017, but he was acquitted of that charge. This week, however, on Monday, June 13, 2022, Reneau was murdered in broad daylight on Fabers Road Extension in Belize City, and the Commissioner of Police, Chester Williams, says Reneau's death could have been gang-related or could have been retaliation for one of the violent acts which Reneau had in the past been accused of carrying out.

At about 2:00 p.m. on Monday, Reneau had just left his sister's home and was riding his bicycle on Fabers Road Extension en route to buy food when he was ambushed and was reportedly shot as many as six times and left for dead. His bicycle and a pair of slippers were left on the scene.

Reneau was acquitted in 2020 of the 2017 murder of Jaheem Mahler and later that same year was also acquitted of the attempted murder of Robert Hower. It has also been reported by *7News* that in 2013 he had been charged for allegedly stabbing two 15-year-olds and that in 2013 he had faced charges for the murder of Brian Williams and for the attempted murder of Delroy Matura.

His stepfather thus remarked this week to local media, "...he is not an innocent guy. He is a dangerous guy; don't play with that boy. The other day he got into a problem and he told me that he won his case of attempted murder and came smiling." And yet, the grieving stepfather who raised Reneau also remarked, "He was so good to me."

banana crops in South America.

When asked whether the implementation of an added layer of security would slow down the arrival process at the PGIA, Blanco explained that from January to March, OIRSA worked alongside the Ministry of Tourism to conduct a pilot project during which the time needed for preinspection to take place was evaluated. He noted that the process did not take up a significant amount of time.

Other areas of cooperation covered by the MOU include data collection and management as well as capacity building.

The agreement was signed by Hon. Jose Abelardo Mai, Minister of Agriculture, Food Security and Enterprise; Mrs. Zoe Roberson Zetina, BAHA Managing Director; and Mr. Efraín Medina Guerra, OIRSA legal representative.

Micah resigns

"I hereby resign. Rebel Forever, Micah," An email sent from Micah Goodin to Mayor Bernard Wagner states.

BELIZE CITY, Wed. June 15, 2022

Today was the deadline for deputy mayor of Belize City and elected city councilor Micah Goodin to submit his resignation from the deputy mayor post to the Belize City Council in order to avoid being removed through a vote by his fellow councilors. Reports this week are that he sent a resignation letter to the Prime Minister, Hon. John Briceño, yesterday. Last week, the Belize City Council had granted Goodin an extension to the initial deadline in order to give him time to resign of his own volition and thus avoid a forced removal at the hands of the other members of the council-most of whom had expressed their desire for him to step down from the deputy mayor post.

A release from CitCo had indicated that "at his request" the council decided to grant him until today, June 15, to tender his resignation. It was confirmed

yesterday evening that his resignation has been tendered.

A press release issued today by the City Council indicated that the council had accepted Goodin's resignation and that Councilor Allan Pollard will be occupying the deputy mayor post.

The release stated, "In a special council meeting held today, the elected officials of the Belize City Council officially accepted Deputy Mayor Micah Goodin's resignation from the Deputy Mayor's position. As a result, the officials in attendance unanimously voted to fill the vacant seat and elected Councillor Allan Pollard Jr. as the Deputy Mayor of Belize City for the 2022-2023 term."

The calls for Goodin's resignation were prompted by a shooting incident on May 14 of this year, during which shots were allegedly fired by Tarique James, one of the men in a group that was in Goodin's car, which had been leaving a bar on Newtown Barracks at which members of the group had been involved in a disagreement, which Goodin had reportedly tried to quell. The shots fired from Goodin's vehicle were allegedly reciprocated by shots from Kenyon Tillett which grazed Tae Medina, a young shadow councilor who had been in Goodin's vehicle.

The members of the council would subsequently meet in a caucus, at which Councilor Vaughn tabled the motion at adjournment, and Goodin was first asked to resign from his post. The deputy mayor was not present, however. He reportedly stormed out before the motion could be tabled, a motion which received unanimous support from all councilors who were present, according to Mayor Bernard Wagner.

Mayor Wagner has indicated that the



members of the council have noted a series of misjudgments in the actions of Deputy Mayor Goodin that are unbefitting of one holding office as an elected official.

Belize participates in 12th WTO Ministerial Conference

BELMOPAN, Tues. June 14, 2022 After not being held for five years, the 12th Ministerial Conference of the World Trade Organization (WTO) is taking place in Geneva, Switzerland this month, with Belize being represented by the Minister of State for Foreign Affairs, Foreign Trade, and Immigration, Hon. Ramon Cervantes, and other senior officials.

According to a Government of Belize Press Office release, the conference—which runs from June 12 to 15 and is being attended by ministers from 164 member countries—comes at a

"critical juncture" for international trade, as the global challenges that it faces continue to affect the cost of living for Belizeans.

Minister Cervantes addressed other

attending ministers and heads of delegations, highlighting the fact that trade and the smooth functioning of the multilateral trading system continue to be challenged by climate change, the COVID-19 pandemic, and the ongoing war in Ukraine, all of which threaten global food security.

"The WTO remains one of the most democratic Member-driven global institutions, and we must strive to make it better, and more responsive to changing global challenges," he said.

At the conference's opening ceremony, World Trade Organization Director-General Ngozi Okonjo-Iweala noted that member nations have a chance "to show the world that the WTO can step up to the plate" and to show that multilateralism works.

During the four-day conference, attending member countries are expected to discuss issues such as the WTO's

reform, the Trade-Related Aspects of Intellectual Property Rights (TRIPS) waiver for COVID-19 vaccines, pandemic response, fishery subsidies, agriculture, and food security.

Hon. Cervantes expressed Belize's support for the reform of the World Trade Organization, highlighting the importance of adhering to principles of transparency, inclusiveness, consensusbased decision-making, fairness, and equity in the rights and obligations of WTO members.

"We must do our citizens justice and address a most urgent matter for economic recovery—the rise in the cost of living. Rising shipping costs have increased the cost of living in Belize, hindering our post-pandemic recovery, even though we have shown tremendous resilience in recovering from the 2020 economic fallout," said Minister Cervantes, who urged members, particularly those from developed nations, to seek a resolution to the issue of rising shipping rates.

The World Trade Organization is the only global international organization that deals with the rules of trade between nations. Its last Ministerial Conference was held in Buenos Aires in December 2017. The conference, which is the highest decision-making body of the organization, is usually convened every two years.

"I just believe that when you have young people, liquor, guns, egos, that's a recipe for disaster," Mayor Wagner noted in a recent interview.

Since the incident, Goodin's two licensed firearms were confiscated—the second of which was retrieved by police officers who went to his home. The Commissioner of Police, Chester Williams, has since requested a letter from Goodin and the alleged triggerman in the shooting incident, Tarique James, that would explain why their licenses should not be taken away. The letter would be taken into consideration as part of the department's investigation to determine whether their firearm licenses will be revoked following the mid-May shooting.

COMPOL Williams told local reporters, "I know that police had gone to Micah's house and removed another licensed firearm that he had, because he had two licensed firearms and he has since been written to, asking for him to show cause why his gun license should not be lifted. I checked with my legal office just a few minutes ago to ascertain if in fact he had received the letter asking to show cause. I have not received a legal response from the office, so I cannot say if we will remove it or no, but I cannot at this stage prematurely state that his license will be revoked. That would be tantamount to making a decision without having given him the opportunity to be heard, and so I will await for his response to the letter that was written to him, and based on his response then I will determine whether or not the license will be repealed."

For the school year of 1964/65, the administration of St. John's College Sixth Form admitted some young ladies into the first year of its traditionally two-year "Advanced Level" studies. Most of the young ladies were high school graduates from St. Catherine Academy, but I also remember at least three girl students from the Cayo District.

At that time the Sixth Form was physically comprised only of two one-flat ferro-concrete buildings, located on the far eastern side of the campus. The buildings had previously been used as residential dormitories for foreign students from the upper classes of Central and South America. These students were referred to as "internos." (I don't know when SJC began that program, but it had been ended by the time the 1964/65 school year began.) Amazingly, I can remember some names of internos -- Oscar Elvir, Reynaldo Martorell, Jesus Canales, Edgar Escalante ...

Immediately south of the buildings was the SJC football field, which was also used for baseball after Gene Adams, an American Peace Corps, began pushing baseball in Belize City high schools.

The southern of the buildings was used mostly for science laboratories, to the best of my recollection, whereas the northern building was where the academic classes were held. The small office of the new

Sixth Form dean, Ronald Zinkle, S. J., was also housed there. There may have been a small library. I don't remember.

The young men from St. John's College (the SJC high school class of '63) had studied on the high school campus from January to May/June of 1964, if my memory is correct. So our first year of Sixth Form was really only a half year. To the best of my knowledge, we were the only Sixth Form class in British Honduras/ Belize history that did "A" Levels in a year and a half instead of the full two.

The new dean, Zinkle, an American of Germanic stock from Eau Claire, Wisconsin, was very proud of his new assignment. My sense was that the SJC president, Fr. Leo Weber, S. J., had given Zinkle the assignment with the intent for the new SJC Sixth Form to become a kind of flagship of tertiary education in selfgoverning Belize. And, the SJC Sixth Form did become a real leader. Many young men from prominent Protestant Belizean families who would normally have attended St. Michael's College Sixth Form or Wesley College Sixth Form went north to SJC Sixth Form instead. (I don't know when the Belize Technical College established its own Sixth Form, but I know BTC Sixth Form became very prominent and competitive in the 1970s.)

Zinkle and I had issues, but I was not aware of his conflicts with some of the new girl students until many years after I had left the school. Zinkle was conscious of his power, and very hardline.

None of the young ladies who ran afoul of Zinkle, so to speak, have ever spoken or written publicly about these clashes. A couple of them have recounted their experiences to me privately.

Anyway, a couple of the Sixth Form ladies from that class have informed me of the death of Beverly Griffiths, nee Borden, in the United Kingdom recently. She had married a British army officer, but maintained her ties to Belize. Beverly was quite a lady, and we mourn her passing.

There are several recent deaths we must note which have not been as widely publicized in the old capital as we Belizeans used to do in the old days of horse-drawn hearses. I wish to mention here Francis Acosta, Baxter Matthews, and two of our footballers from the 70s—Charro Bennett and Clarence "Willie" Williams.

Willie was a Wesley College graduate who lived on Turton's Lane down the street from me on Regent Street West. He starred as the central defender of the championship Landivar teams, and I wish to note here that he was a quiet man of dignity and strength.

Respect is due, and given.

estudiantes extranjeros de las clases altas de Centroamerica y Sur América. Estos estudiantes eran llamados "internos". (No sé cuándo el Colegio San Juan (SJC por sus siglas en inglés) comenzó ese programa, pero lo habían terminado cuando comenzó el año escolar 1964/65). Sorprendentemente, puedo recordar algunos nombres de internos: Oscar Elvir, Reynaldo Martorell, Jesús Canales, Edgar

Inmediatamente al sur de los edificios estaba el campo de fútbol SJC, que también se usó para el béisbol después de que Gene Adams, un miembro del Cuerpo de Paz estadounidense, comenzara a impulsar el béisbol en las escuelas secundarias de la Ciudad de Belize.

El edificio sur se usaba principalmente para laboratorios de ciencias, según recuerdo, mientras que el edificio norte era donde se llevaban a cabo las clases académicas. La pequeña oficina del nuevo decano de la preparatoria, Ronald Zinkle, C. de J., también se encontraba allí. Puede haber habido una pequeña biblioteca. No recuerdo.

Los jóvenes del Colegio San Juan (la promoción de la escuela secundaria SJC del 63) habían estudiado en el campus de la escuela secundaria de enero a mayo/ junio de 1964, si no recuerdo mal. Así que nuestro primer año de preparatoria fue en realidad solo medio año. Que yo sepa, fuimos la única clase de preparatoria en la historia de Honduras Británica/Belize que presentó los examenes a nivel "A" en un año y medio en lugar de los dos completos.

El nuevo decano, Zinkle, un estadounidense de ascendencia germánica de Eau Claire, Wisconsin, estaba muy orgulloso de su nueva asignación. Mi sensación fue que el presidente de SJC, el p. Leo Weber, C. de J., había asignado a Zinkle la tarea con la intención de que la nueva preparatoria SJC se convirtiera en una especie de buque insignia de la educación universitaria en el Belize

autónomo. Y, la preparatoria SJC se convirtió en un verdadero líder. Muchos jóvenes de prominentes familias beliceñas protestantes que normalmente habrían asistido a la Preparatoria del Colegio San Miguel o del Colegio Wesley en su lugar fueron al norte a la Preparatoria SJC. (No sé cuándo el Colegio Técnico de Belize estableció su propia preparatoria, pero sé que la preparatoria del Colegio Técnico de Belize se volvió muy prominente y competitiva en la década de 1970).

Zinkle y yo teníamos problemas, pero no me di cuenta de sus conflictos con algunas de las nuevas alumnas hasta muchos años después de haber dejado la escuela. Zinkle era consciente de su poder y era de línea muy dura.

Ninguna de las jóvenes que tuvieron problemas con Zinkle, por así decirlo, ha hablado o escrito públicamente sobre estos enfrentamientos. Un par de ellas me han contado sus experiencias en privado.

De todos modos, un par de las damas de la preparatoria de esa clase me

informaron de la muerte de Beverly Griffiths de Borden, recientemente en el Reino Unido. Se había casado con un oficial del ejército británico, pero mantuvo sus vínculos con Belize. Beverly era toda una dama, y lamentamos su fallecimiento.

Hay varias muertes recientes que debemos señalar que no han sido tan ampliamente publicitadas en la antigua capital como solíamos hacerlo los beliceños en los viejos tiempos de los coches fúnebres tirados por caballos. Quisiera mencionar aquí a Francis Acosta, Baxter Matthews y dos de nuestros futbolistas de los años 70: Charro Bennett y Clarence "Willie" Williams.

Willie era egresado del Colegio Wesley que vivía en Turton's Lane calle abajo de mí en la calle Regent Street West. Actuó como el defensa central de los equipos campeones de Landivar, y deseo señalar aquí que era un hombre tranquilo de dignidad y fuerza.

El reconocimiento es debido, y se entrega.



COMPOL: WPC Trapp won't be criminally charged

While witness statements and photos seem to indicate that WPC Alicia Trapp, not Minister Julius Espat, was the aggressor during their Teakettle altercation, the Commissioner of Police says Hon. Espat is unlikely to press charges for now.

BELIZE CITY, Wed. June 15, 2022 Police Constable Alicia Trapp, who last week brought allegations of verbal and physical assault against Minister of Infrastructure and Development Hon. Julius Espat following a confrontation at the Teakettle village elections, is not expected to be charged with assault, according to Commissioner of Police, Chester Williams. On Monday, the Police Commissioner issued a letter to Trapp's attorney, Orson "OJ" Elrington, in which he stated that the allegations made by Trapp in her police report are contradicted by witness statements and pictures taken during the



altercation and that she could be arrested and charged with Common

Assault. In speaking with local reporters on Tuesday, however, Commissioner Williams explained that Minister Julius Espat does not wish to take court action against the police constable.

"...based on that, she will not be charged criminally as outlined in the letter to her attorney yesterday. I think what Mr. Espat is hoping for is that her and her attorney retract their statement, and based on that then he will determine if he will proceed with the matter before the court," said Commissioner Williams.

Last week, Minister Espat's legal



On Tuesday, June 14, in the return match in French Guiana, our Jaguars played a better game, acame up short, 1-nil, on another strike by French Guiana's Sarrucco, this one at the 80th minute.

Despite some harsh Facebook criticisms of our national team coach, David Perez Asensio, at this sports desk we have to reserve such criticisms for the limited hand dealt coach David, and which we have to acknowledge that he handled exceedingly well, despite Belize ending up at the bottom of Group D and in grave danger of being relegated to League C.

French Guiana leads Group D with 10 pts, next is Guatemala with 7 pts, Dominican Republic with 4 pts, and Belize with 1 pt. Belize has a game each remaining against Guatemala and the Dominican Republic to try and avoid relegation to League C when the Nations League tournament resumes in March of 2023.

We refuse to scapegoat coach David Perez for whatever didn't go right with our Nations League drive. If there is blame to issue out anywhere, we would be inclined to put some on the FFB leadership, who allowed the Premier League of Belize to languish in limbo for months because they did not approve of its elected president; and the hastily assembled "Top League" did not provide the level of competitive intensity to best prepare our players for international combat.

representative, Senior Counsel Andrew Marshalleck, issued a letter to WPC Trapp and her attorney demanding an apology and a full retraction of her statement, termed "libelous" and "false".

Trapp had accused Minister Espat, via a Facebook Live video, of insulting her and pointing his finger in her face allegedly because he was angered by her presence at the elections as a UDP supporter. The evidence gathered by police over the past week, however, suggests that Trapp, not Espat, was the aggressor. This new development comes on the heels of an investigation of WPC Trapp by the Professional Standards Branch, initiated after it was suggested that she had breached the Police Department's social media policy when she made her remarks on the Facebook video.

When asked whether an imbalance of power—a government minister versus a police officer—could have played a part in influencing the witness statements that

implicate Trapp, Commissioner Williams said that he doubts any of the witnesses were fearful when giving their statements.

"As a matter of fact, many of them were independent-minded people who were out there. So, I do not ascribe to the fact that people said what they said because they fear retribution from the minister. I don't think so," he stated.

The Commissioner of Police further stated that WPC Trapp put herself in the position she is now in.

"If you step into a boxing ring with Mike Tyson, you expect to get knocked the hell out. And you cannot expect that you will be pet and powdered there. She stepped into the political arena and she had an exchange of words with the minister," he stated.

The COMPOL had expressed similar sentiments last week. The United Democratic Party, on the other hand, has criticized the Police Commissioner, and both the Leader of the Opposition, Hon. Moses "Shyne" Barrow, and the UDP chairman, Michael Peyrefitte, expressed support for WPC Trapp during a UDP

press conference this week.

"I have never seen, in my legal time, a person goes to the police station and makes a complaint, that person's attorney is then written to by the Commissioner of Police who acts as a defense attorney for the person who is being complained against, judge, and jury and declared the man not guilty," said Peyrefitte.

WPC Trapp, who had previously been assigned to work at Cabinet meetings as part of the security detail, has reportedly been removed from that post by the Commander of the Belmopan Police Station since the Teakettle incident.

Her lawyer has also indicated that it is possible that she might pursue civil legal action against Minister Espat.

corruption in Belize, and as a result, she and her business venture have been ruined by an unnamed "they". She pleads to the Canadian government to help ensure she has a "fair trial" and an "ethical investigation" and to help her reunite with her children and return to Canada.

The interview with the *Toronto Sun* is the third time that the Canadian-born socialite has appeared before cameras since Superintendent Henry Jemmott was shot in the back of the head with his own service weapon on May 28,

2021. Her first televised appearance took place in October 2021, when she was featured on CBS's 48 Hours. She was then featured in the Discovery Plus documentary, One Bullet in Belize, which premiered on the one-year anniversary of Jemmott's death.

In regards to the killing of Jemmott, Hartin is expected to be indicted in the Supreme Court any time now. The June session of Supreme Court proceedings began on Monday, and many persons, including the family of Superintendent Jemmott, expected to see the Canadianborn socialite in court on the first day.
