But when it comes to corporate giants such as Vulcan Materials Company and Waterloo Investment Holdings, that often proves difficult.

BELIZE CITY, Thurs. Aug. 25, 2022 Deputy Prime Minister and Minister of Natural Resources, Petroleum and Mining, Hon. Cordel Hyde, says that the efforts of giant corporations to exploit the country's natural resources for exportation abroad is very reminiscent of colonialism. The minister is one of a few Government officials that have publicly spoken out against Vulcan Materials Company's interest in aggregate mining at White Ridge Farm in Gales Point Manatee. Today, he once again expressed his strong views on the matter to the media.

According to Hon. Hyde, as an independent nation, Belize should have the power to reject developers that it has no interest in working with. Large, multinational companies, however,

Ashcroft/Waterloo "threatens" GoB again

While Waterloo Investment Holdings has been publicizing its submission of an updated Environmental and Social Impact Assessment (ESIA) for its proposed cruise terminal at the Port of Belize Ltd. and has been touting a public consultation on the proposal that is to be carried out on Thursday, September 1, 2022 at the Biltmore Plaza in Belize City, it seems that the company has been taking another, more aggressive approach behind the scenes—one that appears to be based on threats. Those threats hint at the economic pain that a Lord Ashcroft-financed legal team

House passes bill for extra \$12 Mil for tropical wave-related repairs

The repairs were made by the Ministry of Infrastructure Development during and after last week's tropical wave. The funds will also be used to put in place proper drainage in those areas most severely affected.

Earlier this week, it was reported that Cabinet had given its support for the supplementary appropriation of BZ \$12 million by the Government to cover the cost of emergency repairs made due to damages caused by last week's tropical wave. On Wednesday, during the Sitting of the House of Representatives, the Briceño administration tabled two supplementary appropriation bills, totaling \$16 million, which includes that \$12 million.

The Minister of Infrastructure Development and Housing, Hon. Julius Espat, presented the motion, detailing the extent of the damage that was seen across the country after an estimated seven inches of rainfall. In addition to compromising several parts of the Philip Goldson Highway, the heavy rainfall also led to massive flooding which, according to the Minister, was a direct result of a lack of adequate drains and culverts.

As was mentioned in the Tuesday issue of the AMANDALA, shortly after the tropical wave passed, The Ministry of Infrastructure Development & Housing (MIDH) began working on alleviating the impacts of flooding across the country, including in the villages of Caledonia, Libertad, and San Roman, in the Belize River Valley, and along the Guinea Grass Road.

"Perhaps these are possible signs that the effects of climate change will be a greater challenge to us at the MIDH and maybe for the country on a whole, in fact, for the world on a whole as we go forward," said Minister Espat during the House sitting.

In response to objections from area representative for the Albert division, Hon. Tracy Panton, Minister Espat rose to give an even more extensive breakdown of the reasons for the spending of \$12 million on repairs.

"Yes, it was a rain that came that passed over us for two days. Yes, we had substantial damage. Yes, if it would

rain for more than two days a week or two, we would be in dire infrastructural problems. Why is this so? It is because the Government that she [Hon. Panton] was a member of, neglected the infrastructure of this company—especially the rural communities—for thirteen years, and Mister Speaker, all we are doing is trying to bring it up to an acceptable level," he said.

Leader of the Opposition, Hon. Shyne Barrow, agreed that the construction of additional culverts and drainage is in the best interest of the country. He did add, though, that the Government should be investing more to address what he called a "human development crisis".

"The Leader of the Opposition is in agreement, because I know he has been in those villages, and he has seen it—and when he was there, it wasn't raining; it was about to," added Minister Espat.

According to Espat, of the twelve million dollars requested, the Belize District has been allocated \$6.7 million

dollars; the Orange Walk District, \$4 million; and the Corozal District, \$1.25 million. These areas, said Hon. Espat, were the most severely affected by the rains due to a lack of natural drainage.

"Everybody that you speak to in the country that is knowledgeable of infrastructure—from the villagers to the engineers—all agree that we as Belizeans and as a government need to invest more in draining our communities," he stated.

Bread subsidies still on hold



In early June of this year, after the government reviewed a proposal for an increase in a 16ounce loaf of bread that had been submitted by the country's bakers in April, the Minister of Agriculture, Food Security & Enterprise, Hon. Jose Mai, announced during a meeting of the House of Representatives

that the Government of Belize would not be authorizing such a price increase.

According to Mai, the bakers in an initial proposal had sought a 75-cent increase, and in a second proposal they suggested a 50-cent increase. After those two proposals were not approved, they requested permission to raise the price of the 16-ounce loaf of bread, which is sold at a price of \$1.75, by 25 cents. However, none of those proposals were approved by Cabinet—despite the struggle of bakers to generate enough revenue to cover the ever-increasing costs of production—including the rising price of flour. (Most recently, an 11% increase in the price of Bebe Agua flour was reported.) Mai had indicated, however, that "The Ministry and Supplies Control Unit [was] instructed to meet with the bakers and engage [in] negotiations to identify a more feasible alternative ... ". Not long after, GoB indicated that subsidies would be provided to offset increases in the price of flour in order to ensure there are no major hikes in the most essential of foods—bread.

That subsidy has not yet been provided for the bakers, however. And when questioned about the lack of response by the government to the plight of the country's bakers, the Prime



Minister, Hon. John Briceño, said that the subsidy has not yet been approved because an agreement has not been reached with ADM Mills, the only flour mill in Belize, due to the constantly changing price of wheat and other conditions that have been repeatedly altering the terms of negotiation between GoB and the mill. "When we already think that we have a settlement then—for instance, wheat went up again, and we have spoken with Minister Mai that Supplies Controls have to meet with the flour mill," the PM explained.

He also referred to a discrepancy between the system of measurement used by the mill and the measurement system used by the Supplies Control Unit, which he says has created loopholes that can be exploited by the mill—enabling them to raise prices without being subject to the enforcement measures of the unit. In Belize, the imperial system is used to measure weight, and thus the price of a 100pound sack of flour is controlled, but according to the PM, the company uses the metric system of measurement, and thus produces a 45-kilogram sack of flour, which is not subject to price controls.

American man dies in Belmopan RTA

A48-year-old American national from California—Steven James Savarda—lost his life on Wednesday evening in a single-car road traffic accident at the entrance of Belmopan in front of the Belmopan branch of Bravo Motors, near the Agriculture Showgrounds.

According to initial police reports, Savarda was exiting Belmopan and heading onto the George Price Highway in his 2014 Audi SUV when, upon reaching between Miles 47 and 48 on the Hummingbird Highway, he reportedly lost control of his vehicle. The SUV then careened into a drain and crashed front-first into a culvert off the right side of the highway in front of Bravo Motors.

When police and medical personnel

When police and medical personnel arrived at the scene, they found Savarda in the driver's seat and began to make checks on Savarda, who was unresponsive and had no pulse. Savarda's lifeless body was transported to the Western Regional Hospital, where he was pronounced dead at 5:53 p.m. that day by medical officers.

"So that's not price controlled. I mean they are playing games. The price control is basically on the pound of flours, so because those things are constantly changing, we constantly have to be meeting with them on negotiations," said Prime Minister Briceño.

He further suggested that, although the government is committed to keeping the price of bread as low as possible, Belizeans should consider preparing more flour tortillas and johnny cakes at home, which may be a cheaper option.

"We are committed to try to keep the bread as low as possible, because that is something that people, everybody, uses every day, but also we have to start to do more Johnny cakes, and more flour tortillas at home, you know, because that end up, it being a little bit cheaper than buying the bread," the PM said.

Dorothy Bradley to be reappointed Auditor General

The former Auditor General retired in 2021, but according to the president of the PSU, Dean Flowers, her tenure was filled with grievances.

Former Auditor General Dorothy Bradley will once again be taking up the position for the next two years, come September 1st. During the sitting of the House of Representatives on Wednesday, a motion to appoint someone to act as Auditor General was tabled, with the Government recommending Bradley as the appointee.

Bradley retired in December 2021, and since then there has been no Auditor General of Belize, as the Government has been unable to find someone to fill the vacant position.

Upon rising to present the motion, Prime Minister Hon. John Briceño stated that as Auditor General, Bradley did "an exceedingly good job."

One of the highlights of her tenure was the drafting of updated legislation in line with the LIMA and Mexico Declaration for the Independence of Supreme Audit Institutions. That updated legislation, which was praised by regional counterparts, would allow the Auditor General to function independently of the Executive branch of government.

Also, under Bradley's leadership, the Office of the Auditor General was able to expose corrupt activities that were ongoing within the Immigration and Nationality Department during the period 2011-2013—including the illegal sale of passports and visas and, according to the US Embassy in Belize, "granting of Belizean citizenship to foreign nationals" (without the requisite due diligence) during the Barrow administration. The Auditor General's Report on the irregularities in the department, which was prepared under Bradley's headship, ultimately prompted Senate Special Select Committee public hearings in late 2016, during which high-level government officials and sitting Cabinet ministers were questioned.

Bradley was one of the first persons

interviewed by that committee, which was chaired by then senator Aldo Salazar. And in reference to her report which prompted those hearings and other notable work she has done, the Prime Minister, Hon. John Briceño, told local reporters this week, "You know, she was the one that went there and audited and did the tough work and work that then government was not too pleased about, and they were used to attack her for that. And we want to bring her, we want her to continue to do the same kind of work. If they find anything that our government is doing wrong, they need to call us out. So that is the only way we can get governments to be able to walk the straight line."

According to the Prime Minister, the Government has been trying to find a suitable candidate to fill the vacant position, but, eventually, they came to a consensus that reappointing Bradley for the next two years would allow a smoother transition for her successor.

When interviewed by the media this week, however, the president of the Public Service Union, Dean Flowers, has claimed that many public officers working under Bradley had many grievances with her, which fostered an 'atmosphere of animosity''.

According to the PSU president, Bradley, during her tenure, did not enjoy the confidence of the majority of her staff. It was a statement highlighted by the Leader of the Opposition, Hon. Shyne Barrow, who rose against the motion to reappoint Bradley.

The Opposition Leader stated that he could not support the motion and called it a lazy approach by the Government. Those on the government side of the House, though, vehemently disagreed. The Minister of Public Service, Hon. Henry Charles Usher, rose to support Bradley's appointment, calling her a "nononsense professional."

"She has carried out her role as Auditor General with professionalism. She has carried out her role as Auditor General, not exhibiting any favor for any political party. As a matter of fact, the former Prime Minister even commented on the role and the work done by Miss Dorothy Bradley when he said that she gets her work done,"

Following her retirement, Bradley moved on to become a member of the United Nations Independent Audit Advisory Committee. She had first taken up the role of Auditor General in 2011, when she left her Chief Elections Officer post to replace Edmund Zuniga.

The Auditor General's Office plays a key role in ensuring transparency and accountability in the use of public funds and assets.



Man found with crushed on highway

Jermaine Christopher Patnett, 36, was found with his head crushed in Ladyville.

The motionless body of Jermaine Christopher Patnett, 36, was found in an area between Miles 6 and 7 on the Philip Goldson Highway early Wednesday morning. When police arrived at the scene, they saw Patnett, whose identity was unknown at the time, dressed in a blue and green checkered shirt with black long jeans pants, and barefooted. Reports are also indicating that his head was crushed when his body was found, although no information has yet been provided on what could have caused such an injury.

According to initial reports, at about 1:08 a.m. Wednesday morning, police officers received a call from a concerned person who informed them that someone was lying on the road, and at the time, no one was at the scene to provide any additional information or identify the person. Patnett was thus initially referred to as "John Doe" at the National Forensic Science Service and was transferred to the Karl Heusner Memorial Hospital, where he was pronounced dead by medical officials.

Patnett was later identified by his


brother, based on the tattoos on his arm. A post-mortem exam will be carried out on his remains to determine the official cause of his death.

Causeway still under review -CEO Williams



Committee (NEAC) to the developers of Port Coral, who view the causeway as a vital part of the project. While former ministers who were part of the then UDP administration have made public declarations that no green light was given for the construction of the causeways, the apparent 2019 approval of the project in the documents held by the Department of Environment (DOE), seems to indicate otherwise.

Now, the DOE is once more conducting a review of the proposal—meaning that there is currently a pause on that particular part of the project. Development of the Port Coral cruise port at Stake Bank continues, however, despite the holdup in the construction of the causeway. Also, the developers, Feinstein Group, seem to still include the causeways as a key part of their project, since they state on their website, "Stake Bank and Ocean View Grand will be connected to each other via a vehicular causeway, and another causeway will connect Ocean View Grand to the mainland."

Ocean View Grand, which is a second project that is part of the development, is to be located on the island of North Drowned Caye, which is to be connected via the causeway to the mainland. At one point, an option was on the table to tender boats from Stake Bank to North Drowned Caye and have a causeway constructed from that island to the Belize City coastline, a distance of about 2 miles or so. That option is seemingly no longer being considered.

The mainland construction was set to be completed this year, and is to be followed by the completion of the construction of two berthing piers which will facilitate 4 Oasis-class ships. The approval of the causeway hangs over the head of this development, since removing the need for tendering travelers by boat and instead using the vehicular path connecting the two islands to Belize Cityis a major selling point for cruise lines, which are aiming to stop the practice of tendering entirely by 2024.

major One concern environmentalists, however, is the fact that the causeway would likely run directly across waters through which manatees habitually travel.

"Manatees are found in many areas in Belize, but Swallow Caye, a mangrove island which is part of a group of mangrove cayes in the area called Drowned Cayes near Belize City, has a good number of animals. Estimates show that between 15 to 20 manatees are in the area at any one time—possibly even more if you include the other areas around Swallow Caye (Seashore, 2001)," a study titled, "Manatee Watching at Swallow Caye, Belize", written by Esther Chuc, states.



UDP's financially sound BISL move saved flag from disgrace

The announcement this week that the government has reached an agreement with the Ashcroft Group and a Panamanian law firm on the buyout/takeover of Belize International Services Limited (BISL), is concerning due to the amount of money we have to pay out from our meager resources, but it was a move that had to be made. We took over the company; we had to pay for it.

BISL, which managed the International Merchant Marine Registry of Belize (IMMARBE) and the International Business Companies Registry (IBCR), had led our flag into international disgrace, seriously jeopardizing both our dignity and our capacity to do business abroad. In 2013 Belize was blacklisted by the European Parliament's Fisheries Committee, on allegations that a number of ships flying our flag were engaging in unscrupulous activities. Also, according to the *Amandala*, a major bone of contention was "Belize's open merchant ship registry, administered by IMMARBE, which allows foreigners, including Europeans, to be able to register their vessels in Belize and land products in the EU under tax-free status, using IBCs (International Business Corporations) registered in Belize."

The situation was intolerable, and the government of 2013 (UDP) under Prime Minister Dean Barrow, to clean up IMMARBE, and also to address the contract of BISL, which it believed had not been properly gotten, took it over.

A PUP government had renewed BISL's contract in 2003, for 10 years, to 2013, at which time a new government would have decided if it wanted to continue the relationship, pursue a relationship with another group, or take over the company. But the 2013 government (UDP) found that a PUP government, in 2005, had gone ahead and extended BISL's contract, to 2020.

In 2005 it was clear that the PUP government that had allowed the Ashcroft Group so many opportunities would lose its mandate in 2008, or whenever the next general election was called. It appeared that the PUP might have had to call the general election early, either out of respect for the British parliamentary system we inherited, or because of severe pressure from the people. The leaders of the day would have to explain why in 2005 they made the giant leap of giving BISL an extension to operate from 2013 to 2020.

Putting aside the legal aspects of the matter, it ended with the CCJ declaring that the government of 2013 (UDP) was in the wrong when it took over BISL. This week, the present government (PUP) says we came off the better after arriving at a "discounted" settlement, US\$38.25 million. PM Briceño said many negative things about how the Barrow governments did business, but from his report, it is clear that since taking over BISL, our country has done very well on the bottom line

On Monday night, Belizean educator, historian and activist, Ms. Sandra Coye asked the hosts of Love FM's Monday night business show, if they knew what our government would be giving up for this

"discounted" settlement. Neither knew. What we know is that since the takeover, our flag is a lot more respectable on international waters.

From blocking VolP to blocking KREM and Channel 7

Former Prime Minister, Dean Barrow, insists his government didn't pay too much to get back BTL. Briefly, the saga began when a PUP government allowed Lord Michael Ashcroft and his group to gain controlling shares in the company, and the Ashcroft Group proceeded to use the company as a cash cow, with no regard for the development of the country.

Apart from failing or refusing to help the PUP fulfill its manifesto promises in the area of telecommunications, BTL under the Ashcroft Group forced out many small shareholders, and moved to ensure that BTL remain a monopoly. With its monopoly control, BTL was able to block Voice over Internet Protocol (VoIP), solely in the interest of profits. From the perspective of a private company, that was understandable, but it was wholly intolerable for the country and its development, especially considering that BTL, like the Port of Belize, was a creation of our government and people.

Blogger Steve Ellis, in his story, "The History of VoIP Solutions: How it Revolutionized The Modern Business", said "Just like how the telephone, a massive achievement in human history, fundamentally changed the way we communicated as a species, so did VoIP for the modern business." Ellis said that by 2003 a quarter of all voice calls made was via VoIP, and this occurred because it made an expensive endeavor, long distance/international phone calls, into "an inexpensive activity so long as a stable internet connection and basic communication hardware is present."

The people of Belize got VoIP on April 30, 2013, after a Belize government (UDP) had taken full control of the company. Too many Belizeans either don't know or have forgotten what it was like before our country got back control of BTL. Ignoring employees of the Ashcroft Group, who understandably express regret that BTL was taken from his control, those who think the government overreached or are noncommittal need to do some research, to separate themselves from their ignorance. The story of BTL under the control of the Ashcroft Group is that it wasn't interested in the development of the country, only in profits for its shareholders.

PM Barrow has said that over time Belizeans will come to realize that the price we paid to get back BTL wasn't too high. As it relates to our dignity, no price was too high to get back the company, and as it relates to the development of our country, probably no price was too high either, though we could have gotten a much better deal if the Barrow UDP hadn't treated the company much like their very own private property.

The Ashcroft Group didn't stop at blocking VoIP; it moved on local television stations, KREM TV and Channel 7, blocking them from usage of the fiber optic cable. According to the *Amandala*, KREM TV was told by cable operators that the Ashcroft Group wanted the station to run free ads for BTL, in return for usage of the fiber optic cable.

The *Amandala* said KREM TV's manager, Mose Hyde, described the Ashcroft Group's attack on the station as "ludicrous", that it amounted to asking local networks to pay for the expansion of the cable companies, to pay for HBO, Showtime. Hyde said, "This argument about us paying is hogwash. The day this thing broke, the boss of CBC ... admitted that BTL requested KREM and Channel 7 not be put on." Prior to the Ashcroft Group blocking KREM TV on cable, it had blocked KREM's streaming service off the Internet without notice.

History shows that BTL, prior to privatization, had been growing from strength to strength; it was our nation's flagship, a company that was focused on the development of our country, a company we could all be proud of. And then, with it falling into private hands, it became an instrument for profits for its shareholders, and a company that trampled on our dignity and the businesses of local entrepreneurs. Those are the facts.

National Meteorological Service discusses improving weather and climate services

BELIZE CITY, Tues. Aug. 23, 2022

The National Meteorological Service of Belize hosted a forum this week during which there were high-level discussions on improving the national framework for weather and climate services. That framework, said the CEO of the Ministry of Sustainable Development, Climate Change & Disaster Risk Management, Dr. Kenrick Williams, will allow for better use of meteorological data and will broaden the scale of services provided by the Met Office.

According to Deputy Chief Meteorologist Ronald Gordon, the National Meteorological Service had three main objectives during the meeting: presenting to stakeholders the services provided by the Met Office,

How can weather and climate data be used to improve services across the country? That is the question that was posed by the MET Office during this week's high-level discussions.

presenting the products the MET Office provides and how those products can be scaled up, and evaluating how their services and products can be integrated into projects in which stakeholders

"The mechanism or the national framework of climate services is basically a mechanism to collaborate between the National Met Services and the stakeholders that use climate information and weather information," Gordon said.

The portfolio of the Ministry of Sustainable Development is coupled with two other key portfolios: Disaster Risk & Climate Change, and according to the CEO in that Ministry, Dr. Kenrick Williams, the Ministry is looking at how those portfolios can continue to integrate data from the Met Service to address issues of vulnerability across

One of the main questions asked during the forum was how can longseries data be utilized to inform decision-making, including when it

comes to addressing natural disasters such as the widespread flooding caused by last week's tropical wave.

"We currently use the data at the level of the productive sector—so the farmers, and those in energy, and transport and others use that short-term forecasting to inform, for example, farming and the impact on pests and diseases. We want to see how we can scale up a national framework that informs a more long-term adaptive management for Belize and really addresses that long-term mitigation in terms of the impact of climate change," Dr. Williams said.

Meteorological data, said the CEO, can do much more than inform farming practices. The Ministry is looking at how it can be applied in areas such as health, project management, infrastructure development, and even education.

Yohnny Rosado wants an apology

The tour operator says that the way he has been portrayed in the media after purchasing a vehicle in Belize that he did not know was stolen has tarnished his name, which poses a threat to his livelihood.

Yohnny Rosado, the well-known owner of Butts Up Cave Tubing enterprise, has maintained that he knew nothing about the stolen status of the Volkswagen Atlas that was confiscated from him by the police, and this week the businessman and tour operator is demanding an apology from the Government and the Commissioner of

Rosado has been in the media spotlight for several weeks now after a vehicle he purchased was found to be stolen. The vehicle, a Volkswagen Atlas which cost Rosado \$65,000, was confiscated by police in early August.

On Friday, Commissioner of Police Chester Williams suggested that the Volkswagen, stolen from a car rental company in Chicago, is likely a part of a larger illicit ring and said that Rosado should sue the dealer that sold him the vehicle and gave him a falsified title as well. The Commissioner also stated that the vehicle would be remaining in the possession of the Police Department.

Rosado held a press conference on Tuesday, during which he said that, while he does not wish to sue anyone including the Police Department—he does want an apology.

"All I did was buy a vehicle from Mr. Roberto Villanueva, and that is what has me in a mess—missing a vehicle, sixty five thousand dollars, and my name has been [tarnished]. I depend on a clean name to do a clean business in tourism,"

Rosado, who sold a parcel of land to purchase the vehicle, says that the entire situation has been a complete nightmare

"I wish for Chester Williams to apologize to me. I wish for the Traffic Department to apologize to us—me and

my family. I wish for the Customs Department to do a better job. I wish for everything to be retracted. But I'm pretty sure that none of this will happen," he

More than anything else, the disgruntled businessman is upset with those who allowed the stolen vehicle to be brought into the country to be sold—something which he says is most likely a common occurrence.

Those persons mentioned by Rosado include Hon. Marconi Leal, area representative of Belize Rural North, whose name was allegedly on the customs appraisal form used in connection with the importation of the vehicle—apparently in an effort to reduce the customs duties paid by Roberto Villanueva. Hon. Leal has told local reporters, however, that he "had no interest in that vehicle, (and) just asked Customs to assist a friend with a little discount on the duty".

Rosado stated at the press conference that he does not want to sue the government, because when persons sue the Government, they are simply shooting themselves in the foot, since the money used to pay them back ultimately belongs to the people.

Tribute to a beloved father and pillar of the Belizean Community.

Or. Jose Meguel, born March 19 1962 in San Lazaro village, Orange Walk came from very humble beginnings and rose to a height that few have achieved as a pillar of the Belizean medical and healthcare community. There is no disputing that he was a great man who influenced many people and saved countless lives. In Cuba, he graduated from Salvador Allende Medical School from 1981 until 1987 and continued his studies there as a General Surgeon from 1987 until 1991. Upon finishing his studies, he returned to Belize to fulfil his dreams of advancing medicine in his home country. Since February 3rd, 1992 he has been offering an unbroken service to the Belizean community, a period of over thirty years. During this period he offered medical and surgical care both in the public and private sector for the community in Belize. He was the head of the Surgery Department at Karl Heusner Memorial Hospital in Belize City from 2001 until September 2016, which he also helped to develop. In 2004, he attended a postgraduate certificate course in Developing and Organizing Trauma System in the Rambam Medical Center in Haifa, Israel. He was the founder of and first recipient of the Taiwan scholarship programme which allowed him to attend a three month course in minimal access surgery in Taijung Veterans General Hospital in Taiwan. He was Vice President of the Belize Medical and Dental Association (BMDA) until he was inevitably elected as President in 2015. He held his presidency for five years until 2020. In 2017, he attended the World Medical Association General Assembly in Chicago in which he represented the BMDA for the first time. He was incredibly proud of his roots and fought to bring Belize to the world stage of the medical community.



Though most of Belize remembers him for these achievements, his unwavering service to the Belizean community, and his many accolades, to his two daughters, he was a carefree and goofy man who loved to live life to the fullest each and every moment of the day. Our father was a true humanitarian, who also shared a passion and love for history, music, art, and everything that life has to offer. Our father wasn't a perfect man, but in spite of all his flaws, we loved him. He taught us how to ride our bikes and how to drive a car. He took us on our very first dates and would always help us sneak donuts without our mom finding out. We will always remember his smiling face, his happiness and his unbridled joy. His daughters will forever remain his junior and chiweena. His strength, discipline, confidence, and goofy personality make for stories that we will cherish for the rest of our lives. Dad, your absence makes our hearts ache, you are gone too soon and we miss you terribly. Wherever you are, you will always be in our hearts.

La acción financieramente sólida sobre BISL del UDP salvó la bandera de la desgracia

El anuncio de esta semana de que el gobierno ha llegado a un acuerdo con el Grupo Ashcroft y una firma de abogados panameña sobre la compra/toma de control de Belize International Services Limited (BISL), es preocupante debido a la cantidad de dinero que tenemos que pagar de nuestros escasos recursos, pero era una movida que había que hacer. Nos hicimos cargo de la empresa; tuvimos que pagar por ello.

BISL, que administraba el Registro de la Marina Mercante Internacional de Belize (IMMARBE por sus siglas en inglés) y el Registro de Empresas Comerciales Internacionales (IBCR por sus siglas en inglés), había llevado a nuestra bandera a la desgracia internacional, poniendo en serio peligro tanto nuestra dignidad como nuestra capacidad para hacer negocios en el extranjero. En 2013, Belize fue incluido en la lista negra por la Comisión de Pesca del Parlamento Europeo, sobre las denuncias de que varios barcos que volaban nuestra bandera estaban realizando actividades sin escrúpulos. Además, según *Amandala*, una de las principales manzanas de la discordia era que "el registro abierto de buques mercantes de Belize, administrado por IMMARBE, que permite a los extranjeros, incluidos los europeos, poder registrar sus buques en Belize y desembarcar productos en la UE bajo estado libre de impuestos, usando las Corporaciones Comerciales Internacionales) registradas en Belize."

La situación era intolerable, y el gobierno de 2013 (UDP) bajo el primer ministro Dean Barrow, para limpiar IMMARBE y también para abordar el contrato de BISL, que creía que no se había obtenido correctamente, se apoderó del registro.

Un gobierno PUP había renovado el contrato de BISL en 2003, por 10 años, hasta 2013, momento en el que un nuevo gobierno habría decidido si quería continuar la relación, buscar una relación con otro grupo o hacerse cargo de la empresa. Pero el gobierno de 2013 (United Democratic Party, UDP) descubrió que un gobierno PUP, en 2005, había procedido y había extendido el contrato de BISL hasta 2020.

En 2005, estaba claro que el gobierno PUP que había permitido tantas oportunidades al Grupo Ashcroft perdería su mandato en 2008, o cuando fuera que se convocaran las próximas elecciones generales. Por respeto al sistema parlamentario británico que heredamos, o por la fuerte presión del pueblo, parecía que el PUP tuvo que convocar las elecciones generales temprano. Los líderes del día tendrían que explicar por qué en 2005 dieron el gran salto de darle a BISL una extensión para operar de 2013 a 2020

Dejando a un lado los aspectos legales del asunto, terminó con la Corte Caribeña de Justicia declarando que el gobierno de 2013 (UDP) estaba equivocado cuando se hizo cargo de BISL. Esta semana, el gobierno actual (PUP) dice que salimos ganando después de llegar a un acuerdo "descontado", US\$38,25 millones. El primer ministro Briceño dijo muchas cosas negativas sobre cómo los gobiernos de Barrow hacían negocios, pero de su informe queda claro que desde que asumió BISL, a nuestro país le ha ido muy bien en el resultado final.

El lunes por la noche, la educadora, historiadora y activista beliceña, la Sra. Sandra Coye preguntó a los presentadores del programa de negocios de los lunes por la noche de Love FM, si sabían a qué estaría renunciando nuestro gobierno por este acuerdo "con descuento". Ninguno sabía. Lo que sabemos es que desde la toma de posesión, nuestra bandera es mucho más respetable en aguas internacionales.

Del bloqueo de VoIP al bloqueo de KREM y Canal 7

El ex primer ministro, Dean Barrow, insiste en que su gobierno no pagó demasiado para recuperar BTL. Brevemente, la saga comenzó cuando un gobierno PUP permitió que Lord Michael Ashcroft y su grupo obtuvieran acciones de control en la empresa, y el Grupo Ashcroft procedió a utilizar la empresa como fuente de ingresos, sin tener en cuenta el desarrollo del país.

Además de fallar o negarse a ayudar al PUP a cumplir las promesas del manifiesto en el área de las telecomunicaciones, BTL, bajo el Grupo Ashcroft, expulsó a muchos pequeños accionistas y actuó para garantizar que BTL siguiera siendo un monopolio. Con su control monopólico, BTL

pudo bloquear Voz sobre Protocolo de Internet (VoIP), únicamente en aras de las ganancias. Desde la perspectiva de una empresa privada, eso era comprensible, pero era totalmente intolerable para el país y su desarrollo, especialmente considerando que BTL, como Port of Belize, fue una creación de nuestro gobierno y nuestra gente.

El bloguero Steve Ellis, en su nota, "La historia de las soluciones de VoIP: cómo revolucionaron los negocios modernos", dijo: "Al igual que el teléfono, un gran logro en la historia de la humanidad, cambió fundamentalmente la forma en que nos comunicamos como especie, también lo hizo la VoIP para el negocio moderno". Ellis dijo que en 2003 una cuarta parte de todas las llamadas de voz realizadas se hicieron a través de VoIP, y esto ocurrió porque convirtió un esfuerzo costoso, llamadas telefónicas de larga distancia/internacionales, en "una actividad económica siempre que se disponga de una conexión a Internet estable y un hardware de comunicación básico".

El pueblo de Belize obtuvo VoIP el 30 de abril de 2013, después de que el gobierno de Belize (United Democratic Party, UDP por sus siglas en inglés) tomó el control total de la empresa. Demasiados beliceños no saben o han olvidado cómo era antes de que nuestro país recuperara el control de BTL. Ignorando a los empleados del Grupo Ashcroft, quienes comprensiblemente lamentan que BTL haya sido arrebatado de su control, aquellos que piensan que el gobierno se extralimitó o no se comprometen necesitan investigar un poco, para separarse de su ignorancia. La historia de BTL bajo el control del Grupo Ashcroft es que no le interesaba el desarrollo del país, solo las ganancias para sus accionistas.

El Primer Ministro Barrow ha dicho que con el tiempo los beliceños se darán cuenta de que el precio que pagamos para recuperar BTL no fue demasiado alto. En lo que respecta a nuestra dignidad, ningún precio fue demasiado alto para recuperar la compañía, y en lo que respecta al desarrollo de nuestro país, probablemente ningún precio fue demasiado alto tampoco, aunque podríamos haber obtenido un trato mucho mejor si el UDP de Barrow no hubiera tratado a la empresa como si fuera su propia propiedad privada.

El Grupo Ashcroft no se limitó a bloquear VoIP; se movió contra las estaciones de televisión locales, TV KREM y Canal 7, impidiéndoles el uso del cable de fibra óptica. Según *Amandala*, los operadores de cable le dijeron a TV KREM que el Grupo Ashcroft quería que la estación publicara anuncios gratuitos para BTL, a cambio del uso del cable de fibra óptica.

Amandala dijo que el gerente de TV KREM, Mose Hyde, describió el ataque del Grupo Ashcroft a la estación como "ridículo", que equivalía a pedir a las cadenas locales que pagaran por la expansión de las compañías de cable, que pagaran por HBO, Showtime. Hyde dijo: "Este argumento de que paguemos es una tontería. El día que surgió esta noticia, el jefe de CBC... admitió que BTL solicitó que no se agregaran KREM y el Canal 7". Antes de que el Grupo Ashcroft bloqueara a TV KREM por cable, había bloqueado el servicio de transmisión de KREM en Internet sin previo aviso.

La historia muestra que BTL, antes de la privatización, había ido creciendo cada vez más; era el buque insignia de nuestra nación, una empresa enfocada en el desarrollo de nuestro país, una empresa de la que todos podíamos estar orgullosos. Y luego, al caer en manos privadas, se convirtió en un instrumento de lucro para sus accionistas, y en una empresa que pisoteaba nuestra dignidad y los negocios de los empresarios locales. Esos son los hechos.

ASR's ace

I was on the side of the UDP GOB when they didn't support the sugarcane farmers' initiative to take control of the sugar factory. The logic behind my little "vote" is simple. Ah, some things in the world have changed since, but some things have not...in this present world structure, as it was then, we are dependent on multinationals for our market for certain commodities.

In 1985 the Esquivel government closed down the Libertad Sugar Factory. Elizabeth Morgan, in a story in Caricom Today, said "through the centuries, with some exceptions, Caribbean sugar exports to Britain benefited from preferential market access and good prices. From the 1960s, there were also quotas from the USA following the Cuban revolution,"

but "the fortunes of sugar would slide from the 1980s as the USA began to subsidize its domestic sugar producers and drastically reduced quotas to overseas suppliers."

Morgan said the Caribbean, "once covered in sugarcane now only has four countries remaining in significant production, Belize, Jamaica, Guyana and Barbados."

Sugar is not lobster or red snapper fillet, or Belize citrus in the old days. There was a time when our orange and grapefruit grown on sour orange rootstock in the rich, deep soils of the Valley, was the most prized in the world. People from abroad used to buy our citrus to blend with theirs, to bring up their quality. I don't think that is so anymore. I know that in our efforts to combat a notorious virus, Tristeza, we changed from sour orange rootstock to a number of others, and the fairly recent Citrus Greening has severely hurt our quantity and quality.

Sugar has a different story. Looking at the bare facts, nobody is scrambling to buy our sugar. Hence the UDP (I bet the PUP in government now too) support for this alliance with multinationals.

But that doesn't mean our GOB and our cañeros should roll over. There is indeed a point when we must say, basta, we are going back to tortilla and beans. Our GOB has to make sure our cañeros get the best possible deal from ASR/BSI, and our smaller producers especially need support to get into other activities. It's high time that farmers get into value-added products. Don't let anybody talk bad about "spirited" drinks. There isn't an economy in the world, especially ones in a capitalist state, that can survive "dry".

America's Beer, Wine & Spirits Retailers, at the website ablusa.org, says "the 2018 Economic Impact Study of America's Beer, Wine & Spirits Retailers [created] more than 2.03 million jobs from direct retail alcohol sales, [paid] more than \$47.9 billion in local, state and federal taxes", that the direct impact of the "retail industry [spirits] is more than \$122.63 billion annually; the total economic impact of the industry is \$363.33 billion annually; and the industry is responsible for 1.65 percent of the U.S. economy based on total GDP."

I believe there is a place for a farmers' factory, but I don't believe it can focus on bulk sales of sugar. We can put up a good fight at home and abroad with confectioneries that are native to our country. I believe a good opportunity in ethanol is slipping us by because we are biting hard into talk about electric vehicles. GOB must pressure ASR/BSI to open those books on bagasse. It's nonsense for that crowd to say that farmers weren't in on it at the beginning, so the ship passed by.

Yes, ASR has an ace, a big ace – we cut them een or they cut it out. But we shouldn't allow anyone to walk on us. As Mr. Alfredo Ortega of the BSCFA said, we are used to eating tortilla and beans.



Senior auditors decry poor hiring practices in Audit Dept.

The president of the PSU, Dean Flowers, says that poor management of the personnel in the Audit Department has been an ongoing issue for years now.

BELIZE CITY, Tues. Aug. 23, 2022

A group of auditors from the Office of the Auditor General have written to the CEO in the Ministry of Public Service, Rolando Zetina, to voice their objection the "poor, insensitive, and ineffective administration" of their office. One of the main areas of concern for the auditors is the process through which vacant posts are filled.

The auditors' letter specifically makes reference to nine posts—including the post of Deputy Auditor General—that were filled between the 15th and 18th of October, 2021. Also among those posts were five

Supervisor of Audit posts, and, according to the letter, the persons selected to fill those five positions do not have the required experience and academic qualifications that were outlined when the vacancy was advertised. That specific post required candidates who either had a Master's degree, 5 years' experience as an Examiner of Accounts I, or a Bachelor's degree with five years in a senior position.

The auditors claim that those who do qualify for the positions were completely disregarded. Furthermore, the letter raises the issue that persons with no experience in public auditing were brought in to become

supervisors—which it referred to as "insulting". The letter then goes on to describe the overall practices within the Ministry of Public Service as demoralizing and unfair.

According to the letter, the Ministry of Public Service has proposed to fill five additional vacancies at the Audit Department. The auditors have asked that serious and genuine consideration be given to those in the office who are qualified.

"Bringing in new people over existing staff demoralizes us and undermined the progress and development of our office and our career advancement within the public service," said the letter.

Today, the president of the Public Service Union, Dean Flowers, weighed in on the matter. He told the media that what is transpiring at the Audit Department comes as no surprise to the Public Service Union, saying that it has been an ongoing issue.

"I believe that the media and the general public would recall that, as far back as 2017, there were some dissent and unease within the Office of the Auditor General. The former Prime Minister and the former CEO and Minister of Public Service all failed to address what has been ongoing issues of poor management and administration of the personnel within the Audit Department," he said.


With the retirement of the previous Auditor General, Dorothy Bradley, said Flowers, the union had hopes that there would have been some improvement in the department. Unfortunately, there has been none.

According to the PSU president, the former administration "ran away" from addressing the human resources troubles of the Auditor General's Office. And while he does give credit to the current administration for having commenced dialogue with the office, he says that they are not moving quickly enough.

While Flowers could not speak in depth about the specific positions mentioned in the letter from the auditors, he did say that the ongoing practice of recommending persons for positions that they are unqualified for is not specific to the Audit Department. Nevertheless, he said, it should be a cause for public concern, especially when it comes to a department that is so key to ensuring transparency and accountability in the public sector.

"Conversations are happening, but for you to fix the kind of problems that exist within the Audit Department, feathers will have to be ruffled," Flowers said.

Dear Editor,

In reference to the investigative reports recently made via 7News Belize, as to the David L. McKoy Business Centre Building for Social Security Board in the City of Belmopan, which refer to my person as the architect responsible for the design and the alleged challenges in its construction, allow me to set the record straight as to my participation in this project.

On November 29, 2015, a public bid was made inviting architects to submit a financial proposal in line with providing Architectural Consultancy Services for the Preparation of Designs and Bill of Quantities for the structure in mention a four-storey ferro-concrete commercial building for Social Security Board in Belmopan.

My firm, LAR Architect & Associates, registered under the Companies Act (January 2000), was successful in the bid. The contract was signed on July 8, 2016,

between CEO Richard Flowers for Social Security Board and Luis Alberto Ruiz for LAR Architect & Associates.

When the project was officially commissioned, the Client, being Social Security Board, provided us with the list of requirements and artist images in line with the expectations of the project.

Each of the four floors in the building would follow an open concept, in which tenants would subsequently install their own partitions. The first three floors would include an appendix-like structure with the same characteristics.

Each level would include a centralized toilet area with both the male and the female units. The toilets would be able to accommodate 70 persons per floor. The idea behind a centralized system of toilet cubicles was to avoid having toilets all over the building. Social Security would oversee accessibility to these toilets whenever tenants were to install their cubicles. This would minimize expenses. The fire extinguishing system was to be the

responsibility of the leasing client.

The floors would also include a main access stairway, two elevators and an emergency exit with a push bar door. For safety reasons, the building was to be hurricane proof for the expected wind speed in Belmopan. Included as well was a fire protection system for the steel columns. A centralized AC system was not considered by the Client due to the open tenancy.

Initially the building was going to be constructed on the site of the old Plaza Theater. Social Security Board then opted to use the property adjacent to the Social Security headquarters building, the reason being that the building at the Plaza Theater site would have been secluded behind DFC with limited parking space. Both sites are property of Social Security Board. With a new location, having the façade of the building facing west, we recommended installing double-6-mm glass panel windows, with the exterior being solar reflective.

Once the final design had been approved by the Social Security Board, the Construction Drawings and the Technical Specifications were developed. The electrical installation drawings and diagrams were submitted to the Public Utilities Commission (PUC). Upon approval by PUC on November 7, 2016, the dossier was passed on to Social Security Board, addressed to the then CEO, Dr. Colin Young. Social Security Board subsequently forwarded the drawings to the Local Building Authority (LBA) Unit of the Belmopan City Council

for approval. The 'No Objection' to the Proposed Development was granted by the LBA on January 17, 2017.

After the LBA approving process was completed, contractors were invited to bid for the construction of the project. Five offers were emailed to me for evaluation in June of 2017. The offers ranged from \$8,916,559.62, being the lowest tender, to \$12,973,451.63 being the highest. The evaluation of tenders was then submitted to the Social Security Board for its consideration, and this concluded the terms of my contract.

In summation, allow me to close by saying that my firm was not in any way involved during the construction phase of the building in mention. LAR Architect & Associates was never called upon, consulted, or contacted in whichever manner concerning any missing information, uncertainty, or discrepancy that may have arisen during the construction phase. LAR Architect & Associates, therefore, is unacquainted, and disassociates itself from, any modification to the original design or incongruence that may have occurred in the process.



One of them replied, "Thank you, honorable John. Note that many here have a place to live, but many others do

police at the Benque/Melchor border, before being transferred to El Salvador, where he was immediately placed in jail.

Lucero, also known as "Rockero," who is suspected of carrying out notably vicious crimes in El Salvador and has been labeled a "terrrorist" by that country's authorities, was stopped last Monday by

Belizean law authorities who observed some striking tattoos on Lucero that were particularly menacing in appearance, and decided to run a quick search in the law enforcement database. They then found out that Lucero was wanted in El Salvador.

Belizean authorities thus



communicated with their Salvadoran police counterparts, and last Thursday, members of the Belize Police Department and the Immigration Department handed him over to Guatemalan police at the western border. Lucero was then handed over to the Transnational Anti-Gang Center

of El Salvador.

PNC El Salvador, the local police department in El Salvador, posted on social media that Lucero is known as an MS 13 terrorist and will be held in custody until his trial. The Salvadoran police department added that Lucero could be imprisoned for up to 30 years.

China experiencing "worst heatwave in climatic history"

As a result of the heatwave and drought, industries have shut down, millions have lost power, and the depth of parts of the Yangtze River is at record-breaking lows.

BEIJING, China, Wed. Aug. 24, 2022
It has received minimal coverage by western media up until this week, but for the past seventy-four days, China has been gripped by what experts are calling the worst heatwave in global climatic history. As a result, the country is also experiencing a severe drought which has led to the water level of the Yangtze River—the third largest river in the world—reaching


It is the longest heatwave on record for China since record-keeping began in 1961 and has impacted up to 600 million people. One report by *Bloomberg News* says that several factories have been shut down as the heat continues to put a strain on

never-before-seen lows.

energy grids. As a result, China's economy, already made fragile by frequent COVID lockdowns and a property crisis, has taken a massive hit.

In Sichuan, large numbers of residents have taken refuge from scorching temperatures in airraid shelters. The province, reports *Bloomberg*, is the hardest hit by the drought due to its

high dependence on hydropower— China's largest source of clean energy. While the heat has increased energy

demand by over a quarter, the decrease in water levels has reduced dam generation by half.

According to the World Meteorological Organization (WMO), China's heatwave this summer has broken "all records". This week alone, more than 240 cities have forecasted temperatures above 104 degrees Fahrenheit (40 degrees Celsius).

According to a report by *The Guardian*, local authorities have been urged by the Government to take all available measures to ensure that crops survive the extreme heat.

China is not the only place contending with record-breaking climate-change-induced events. Just this week, the European Drought Observatory (EDO) reported that Europe is currently experiencing the worst drought seen in the region in 500 years.

From the Publisher

There was a very bad mistake in my Tuesday column last week, the Tuesday newspaper being printed only online. I caught the mistake when I read over the column when it was reproduced in our Friday hard copy

For decades, from the 1980s, I had a secretary by the name of Odessa Robinson Smith who typed all my material. It ended up that she was the only one who could read my terrible handwriting. I think Odessa migrated to New York after the coronavirus pandemic began, so I have been doing my own typing since then, and I hate it.

In any case, on Tuesday I typed that "hundreds" of Japanese had been killed by the Hiroshima and Nagasaki atomic bombs in August of 1945. It should have been "hundreds of thousands" instead of hundreds — hundreds of thousands in each of the cities.

Anyway, my column today, apart from seeking to correct that Tuesday error, is intended to flesh out an aspect, a very important aspect, of the John Kennedy assassination in 1963 which I had not mentioned in my Friday

When Miguel Ydigoras Fuentes, an army general, was elected President of Guatemala in 1958, I was just a child, maybe eleven years old. Fuentes was very aggressive where the Guatemalan claim to British Honduras was concerned, and there was great concern in the majority black Belize City, where many people felt the ruling People's United Party (PUP), which Rt. Hon. George Price had taken over from Hon. Leigh Richardson and Hon. Philip Goldson in 1956, was not hostile enough to said claim.

The United States administration of President Dwight D. Eisenhower, had cut a deal with the Fuentes administration to have Cuban exiles trained on a coffee estate in Guatemala for an invasion of Cuba, which Fidel Castro had taken over by revolution in January of 1959.

John Kennedy found this plan for a so-called Bay of Pigs invasion of Cuba by Cuban exiles on his desk when he assumed the presidency of the United States in January of 1961.

Fuentes later claimed that in return for his allowing Guatemala to be used to train the Cuban exiles, the U.S. government had promised him support for Guatemala's claim to the British colony. There is no doubt that he was very aggressive where the Belize claim was concerned, and Philip Goldson, who had entered into a coalition with Fuller's Herbert National Independence Party (NIP) in 1958, was using his newspaper, THE BELIZE BILLBOARD, the leading newspaper in British Honduras, to counter Fuentes' rhetoric and activities, such as trying to cross the Benque Viejo border, and boost the morale of alarmed Belizeans.

Anyway, when the Cuban exiles finally invaded Cuba in April of 1961, there was a critical moment in the invasion when the Cuban exiles needed air cover from the U.S. government. One assumes it was the American "deep state" which had come up with the original invasion plan during the Eisenhower administration. When that "deep state," and the Cuban exiles, called for the air cover in desperation, Kennedy refused.

The Cuban exiles were then overwhelmed by the Cuban defenders, led by Fidel himself, and about 1300 of them ended up prisoners in Cuban jails. Castro later exchanged them for American farm tractors.

Figuring out why President Kennedy refused the air cover is not for me to try to do. What we know is that there were Cuban exiles and members of the American deep state who became very, very angry with Kennedy and his decision. Students of the Kennedy assassination believe that Kennedy's decision to refuse to provide the Bay of Pigs air cover contributed substantially to the assassination conspiracy against him.

It's interesting to note that Fuentes' decision to host the training of the Cuban exiles in Guatemala, sparked a nationalist rebellion in the Guatemalan army in late 1960, led by Marco Antonio Yon Sosa and Luis Turcios Lima. Many scholars view that army rebellion as the beginning of the Guatemalan civil war, which lasted for thirty-six years.

That civil war may have contributed to Great Britain's being able to push through political independence for Belize, because the Guatemalan civil war was very bloody and out of control in 1981, and the rest of the world looked favorably on Belize's quest for self-rule.

Well now, here we Belizeans are presently confronted by this International Court of Justice (ICJ) arbitration. My personal opinion is that we are in the hands of the Americans. You will say, of course, what do I mean by that. Well, can you deny that we were in the hands of the British until 1981?

In closing, I would like to say that there are some Belizeans here who focus exclusively on the activities and dangers of the Mexican cartels. These Belizeans never mention the American Mafia, but there is such a thing as cross-border crime.

Belize City, 16 August 2022: The Central Bank of Belize hereby informs the public that the Bank of England has notified that it will withdraw the legal tender status of £20 and £50 paper banknotes on 30 September 2022. After this date, only polymer banknotes will be legal tender. The Bank of England is encouraging both individual and institutional noteholders such as financial institutions to use, deposit, or exchange these banknotes by 30 September 2022.

Members of the Belizean public holding these paper banknotes are advised to submit them for exchange at their domestic bank. Institutional noteholders in Belize should continue to return these sterling banknotes to the Central Bank for repatriation to the Bank of England.

Note that after the 30 September 2022 deadline, holders of paper sterling banknotes will no longer be able to use them in transactions.

Bread and circuses! Needless to say, old Charlie's loss was decisive! I also remember the Falklands or Malvinas war! The Argentine Junta was in trouble, so they decided to distract the people by starting a war with the British! That didn't end well for them, but, bread and circuses!

It is getting harder to fool the people, in this time of advanced technology, the instant news and media availability, so we now have a new form of bread and circuses: disinformation! It blankets every corner of the world! Sometimes the more outrageous the claims and lies, the more believable they become, mainly to the less informed. We see it every day, especially in America, where the most famous con artist of all times, I mean that sincerely, has transformed the American landscape into an Alice in Wonderland world of fantasy! America was divided during the Civil War, but at least each side knew what they were fighting for—no doubts in their minds that they were on the right side of history. They understood what was at stake, right or wrong! Now the divisions are even more serious, more alarming, more vainglorious!

Presently, we are weaving our way through these prisms of fantasy and reality! UDP bans public criticism of party by members

BELIZE CITY, Mon. Aug. 22, 2022

During a press conference this Monday, the chairman of the United Democratic Party, Senator Michael Peyrefitte, said that the party has, once again, agreed on a way forward, following a National Party Council meeting that was held on Saturday. According to Peyrefitte, at that meeting major decisions regarding the future of the party were made—one being that all persons wishing to remain a member of the party must comply with the directives and decisions of the UDP's National Party Council (NPC), the second highest body in the party.

"This weekend, all parties were duly invited, and a quorum was present, meaning all decisions passed have to be followed by anyone in the UDP who wants to remain in the UDP. The NPC believed that they wanted to reemphasize certain aspects of the UDP constitution, and we all agreed to be bound by it," said Senator Peyrefitte.

It was the first in-person meeting held by the National Party Council in several years and took place after weeks of failed attempts at uniting the fragmented Opposition. One part of the party's constitution that was reemphasized during the meeting was Article 5(6) (d), which states that criticism of persons or processes within the party must take place in the private councils and committees of the Party rather than in the public domain.

According to Senator Peyrefitte, everyone present at the meeting agreed



that infighting would stop—which will include the removal of any posts on social media that criticize the party.

"We move forward. We have one enemy, and it's the PUP, not each other," he said.

Hopefully, said Peyrefitte, all members of the party will, going forward, agree to submit to the due authority of the NPC. But, in regard to those who do not wish to comply, he believes that they have already made a decision on "where they stand in the party."

Also during Saturday's meeting, the NPC appointed a new Secretary General. Former vice president of the Senate, Juliet Thimbriel, will now be responsible for the day-to-day operations of the party and the supervision of the UDP headquarters' staff.

Four women residing in Belmopan were arrested on Monday after police officers found over 15 grams of crack cocaine during a search of a home where the women were staying. The four were thus slapped with drug-related charges.

The women—Dirannie Lopez, 22; Brenda Monterrosa,

49; Gilriam Mejia, 49; and Laura Aguirre, 19, were present at a home on Guyana Street, in the San Martin area of Belmopan, where police located a transparent plastic bag, inside of which were five smaller bags that contained pieces of crack cocaine, which together weighed 16.6 grams.

The four were formally charged with

possession of controlled drugs with intent to supply another.

Following their arraignment in court, the women posted statements on social media in which they insisted that they are innocent of the charges against them and are not involved in any drug-related activity. The four are currently out on

Robbers target home of US missionaries

SANTA ELENA TOWN, Cayo District, Mon. Aug. 22, 2022

An American missionary couple is traumatized after their home in Santa Elena, Cayo, was broken into last night. The robbers who entered their home, however, later fled empty-handed.

The wife told police that at around 11:40 p.m. she was upstairs of the couple's home when she heard a bang on the front glass door. When she went to investigate the noise, she found herself facing an unknown masked man with a scarf over his head, who held her captive.

She later heard her husband downstairs shouting to someone, "Don't kill me", which was followed by the sound of a single gunshot. Upon hearing the commotion, the robber who was holding

her hostage let her go and ran downstairs. She then went to check on her husband, who was unharmed, and he told her that he had been responding to the same noise when someone grabbed him, pointed a gun at his head, and demanded money.

He further related that while he was being held captive, he told one of the robbers that he and his wife did not keep money at the house. It is unclear at this point what was the robber's immediate response or whether there was a struggle, but a single gunshot was fired at the kitchen floor and hit the carpet. Both robbers then fled the home without acquiring any money or valuables.

Police have detained one person for questioning as part of their investigation into the incident.

Interestingly, the Wikipedia story says, "by the end of the colonial period, the blacks thought of themselves as Colombians and felt superior to the Amerindians, who officially occupied higher status, were nominally free, and were closer in skin color, facial features, and hair texture to the emerging mestizo mix."

My final extract from this Wikipedia piece, says "those blacks who achieved freedom sometimes moved into Amerindian communities, but blacks and zambos remained at the bottom of the social scale and were important only as a source of labor."

Vulcan Mining Still Failing to Win the Hearts and Minds of Gales Point

At 2:00 p.m. on Saturday, August 20, 2022, the residents of the Gales Point Manatee (GP) community and other concerned Belizeans met with representatives of the Vulcan Materials Company, a mining company headquartered in Birmingham, Alabama, USA. They gathered in a field adjacent to the community's school to learn more about the proposed limestone mining operation in the nearby Sugar Hill area, presently under ownership by White Ridge Farms. Under three tents, plus another refreshments, Vulcan representatives made themselves available to questions about the project, outlining the potential community impacts; the proposed port; and their environmental impact mitigation strategies.

The meeting followed Minister of Natural Resources, Hon. Cordel Hyde's public opposition to the project earlier this month, and was arranged so Vulcan could address Gales Point residents' questions and concerns about the mine. The tents featured various posters and brochures, and representatives attended to questions about the scale of the dredge the necessary port would require, the training for a range of mining and support staff jobs, and the extraction process the mine would use.

The last of those received some

attention in an August 8 7News interview, where Vulcan VP of External Affairs, Janet Kavinosky made a distinction between strip-mining, a term that often carries connotations of environmental destruction, and Vulcan's proposed method of 'aggregate quarrying,' which Kavinosky described as "taking big rocks and breaking them down to little ones". Asked to validate Kavinosky's distinction, hydrologist Dr. Ed Boles said that while the methods might vary, their differences are ultimately negligible. Both methods require stripping the forest above the mining site, and would negatively hinder the ecosystem services provided by the limestone hills and forest, including managing the quality and flow of water through the area's landscape.

A few attendees had no prior knowledge of Vulcan, and others mentioned having conducted internet searches of their own and learning about the company's contention with ten other countries for purported environmental harm. Some in attendance were curious about the possibility of steady employment once the mine began operation; others wanted to know the extent of the mine's impact on the surrounding landscape, and a small contingent voiced the possibility of Vulcan potentially supporting alternative



UDP protests: "Life haad out ya!"

BELIZE CITY, Wed. Aug. 24, 2022 "Life haad out ya!"

Those were the words echoed by disgruntled Belizeans on Tuesday as they marched through the streets of Belize City demanding a decrease in the cost of living. The demonstration was orchestrated by the United Democratic Party who, despite being denied a permit by the Police Department, went ahead with their plan of marching to the Shell Gas Station located on Central American Boulevard, which they believe is owned by the Prime Minister's family.

Today, the UDP is saying that if the demands of the people are not met by the Government soon, an increase in resistance can be expected. That list of demands, chanted by the people on Tuesday and posted on the UDP's social media pages shortly after, is not a long one. The Opposition is telling the current administration to do three things: lower

gas prices, lower the cost of living, and stop corruption. According to the Leader of the Opposition, Hon. Moses "Shyne" Barrow, those demands are all being made in an attempt to provide relief to the Belizean people.

The protest began in front of the UDP headquarters on Youth for the Future Drive, and as it made its way toward Central American Boulevard, the size of the crowd gradually increased. Standing front and center was Hon.

Barrow, who was flanked by several longtime party members, including Port Loyola standard bearer, Philip Willoughby; former Belmopan area rep, John Saldivar; former Lake

Independence standard bearer, Dianne Finnegan; and UDP senator and second deputy leader of the party, Beverly Williams. Also present was party chairman, Michael Peyrefitte, who, on Monday, confidently told the press that he would be protesting even if he were the only person to show up.

When asked by *KREM News*' Marisol Amaya, how he felt about the turnout (estimated to be 200 by *7News*), Senator Peyrefitte said that it came as no surprise, as there are many who want their voices and their opinions to be heard by the Government.

"With all that's happening and not happening, I doubt very much that I'm the only one who wants to see some change and who wants to send a message to the government," he stated.

In regard to the small size of the crowd, Senator Peyrefitte said that the fact that they were protesting without a valid permit may have impacted the turnout, with many persons fearing arrest or police aggression. While there were some police officers present, they had little to no interaction with the crowd.

While in front of the Central American Boulevard Shell Gas Station, the Leader of the Opposition spoke with reporters.

"We believe that it is a conflict of interest to have a Prime Minister that has vested interest in a gas station, and now we have the highest gas prices ever. That is problematic, and we need action. We want action," he said.

"Bring down the gas prices. Bring down the cost of living. Stop the corruption," shouted Hon. Barrow.

Back at the UDP headquarters, the party leader was asked whether the recent conflicts within the United Democratic

Party (including the recent expulsion of former member of the UDP central executive Delroy Cuthkelvin and the recent disciplinary measures brought against former UDP leader Patrick Faber) made it difficult to organize the protest, he did not give a direct answer.

"As the responsible opposition, we cannot allow distractions to take away from our responsibility to advocate on behalf of the Belizean people. That is exactly what we are doing with the Chairman, the Deputy Party Leader, and the grand leaders of this party, which are the delegates and the party faithful and the Belizean people," he said.

"For the past two years, the Opposition, whether in question to the Ministers in the House of Representatives, whether in the media, we have been asking the Government to respond appropriately to the plight of the suffering people, and that has not taken place," he added.

The Opposition Leader called the rise in the cost of living, particularly the record-breaking increase in fuel prices, borderline inhumane and noted that it has affected even working-class persons who have since been "pushed to the margins of poverty."

"We deserve a Government that is going to take into consideration our quality of life. We deserve a government that will use our taxpayer dollars to our benefit," he told the press.

According to the Leader of the Opposition, Tuesday's protest was "only the beginning" and the first of many.

Notably absent from the protest were UDP parliamentarians Hon. Tracy Panton (Albert area rep) and Hon. Patrick Faber (Collet area rep).

Belize powerlifting team returns

After competing in the 19th annual North American Powerlifting Federation (NAPF) championship in Panama City, six Belizean athletes brought back gold and bronze medals to the jewel.

BELIZE CITY, Tues. Aug. 23, 2022

A team of eight Belizean powerlifting athletes, four males and four females, has returned to the country with two gold and four bronze medals in their respective classes after competing in the 19th annual North American Powerlifting Federation (NAPF) Regional Classic Powerlifting Championships, a six-day tournament which was held in Panama City, Panama, and which had the participation of over 200 athletes from 15 countries.

Alida Sharp represented Belize in the Women's Master II 52 kg category, while the country was represented by Edith Ruiz in the Women's 57kg category, Jacqueline Alas in the Women's Open 63 kg Category, and Nerry Sho in the Women's 76 kg category. The four men representing Belize at the tournament were Leo Matura in the Men's Open Category, Robert Williams in the Men's Masters 1 Open 120 kg Category, Khalid Usher in the Men's Open 93 kg Category, and William Murillo in the Men's Juniors 105 kg Category.

On the first day of the competition, Alida Sharp was the first to capture the gold in her respective category, and set a new record for the squat, the bench press, and total points in the Master's II 52 kg category. Following Sharp's gold medal performance, Robert Williams also achieved the gold medal in his category.

Williams, who also participated in the competition in 2018 in Mexico and received a gold medal, stopped by the AMANDALA along with several of his teammates and granted us an interview about their experience competing internationally.

"Man, Panama was a great trip! If anybody knows me, I did [a] strongman competition in Belize [in] 2016, '17, '18, and '19, but due to the pandemic, everything was shut down, and thanks to Khalid [Usher] and his crew of Belize Powerlifters Association, we launched this initiative and we were able to go out internationally. So I went to Panama with high hopes, because I was already accustomed to lifting heavy weights, but then I did have to adjust my training ... So I went out there, I did it, I did it the best and brought back the gold to Belize," Williams said.

The Belize Powerlifting Association is the brainchild of Usher, the president of the association, who developed the concept in 2018 along with his university colleagues, after competing in the same tournament in Mexico without receiving any medals. Then later that same year, a fully formed association returned to Mexico City and returned with two gold and one bronze medal.

Usher said one of the takeaways from the trip to Panama was seeing how other associations conduct their operations and getting insights into how to create a better association in Belize.

"When we were out there, and it's the same thing with the athletes, we saw a lot of hope for the future. That's the main takeaway from the competition. We saw where we need to go and what we need to be capable of. We got to network with a lot of them. We got to see what well-established associations how [to] work, how their athletes operated, and it was a very good learning experience for everyone," he said.

William Murillo, who is the youngest member of the team, and who brought back a bronze medal, told us about his

industries in the area instead of mining. Dennika Bowen, a Gales Point resident and tourism student, opposed the mine, calling it a threat to eco-tourism opportunities that would come with the completion of the Coastal Road's present upgrade.

Gales Point resident, Anton Andrewin, Jr., said he did not want Vulcan to operate in Belize after previously working for the company last year, expressing frustration about the company prohibiting marijuana users from work as well as a back injury received on the job. Gales Point village chairman Jay Altschaf and Nancy Bailey, also in attendance, recalled taking other residents to the hospital following back and groin injuries sustained while carrying Vulcan's heavy drilling equipment up the hills during the initial survey phase conducted in late 2019 to early 2020—work that many described as 'hard labor.' In a follow-up, Vulcan said that it was aware of one employee being injured and taken by them to Dangriga's hospital and requiring stitches on his hand and that "in 2021, 94% of their facilities had zero lost-time injuries." Vulcan Materials and its subsidiaries have incurred 82 workplace safety and health violations for the years 2000-2022, according to the US national policy research center, Good Jobs Still, which aggregates information across US federal agencies.

The day's event didn't proceed as Vulcan hoped once it began. Community members almost immediately shared their exasperation with the meeting's format to the Vulcan representatives and the media. Several described the separate tents as a "divide and conquer" strategy, and voiced dissent to the representatives for what some felt was a manipulative tactic to deceive attendees. Meanwhile, Vulcan representatives assured them that it considered the three information

tents a means to limit a small number of personalities from dominating a 'town-hall-style' panel meeting. The community members offered to move the chairs and tents to alter the meeting format, but Vulcan maintained their preference for their original plan, later adding it had hoped to provide greater opportunities to address individual concerns.

Forty-five minutes after the meeting began, a few of the village's drummers, including local legends Emmett Young and Bombay, got out their instruments under the 'Community Impact' tent. They played while others danced and sang. For thirty minutes they transformed a small portion of the event into a gathering of joyful resistance, with various elders stepping in for a dance. The musical protest started to disband once several in the crowd encouraged those playing to depart the field altogether rather than wait for Vulcan to change their mind. By 3:14 p.m., many who had arrived from the village left the field, remaining at their vehicles across the road, at the school grounds, or at neighboring residents' yards, while a few continued to visit the tents and talk to Vulcan's representatives.

Of those that departed the field, Andrewin, Jr. was among them. He stated he viewed the company's resistance to changing the meeting format as another instance where the mining company was attempting to deceive the villagers, and take advantage of their individual unawareness of mining to persuade them. Bailey, owner of Manatee Lodge, voiced agreement with that interpretation of the day's event. She and several others wore shirts made for the day with the slogan "Nah Play We Fi Idyat."

At the end of the meeting at 4:00 p.m., Jimmy Flemming of Vulcan Materials said that while he was somewhat disappointed by the meeting, he and Vulcan were

first international competition in powerlifting.

"... I'm still in shock that I brought back a medal and I brought back this bronze, because I got one of my lifts overturned. I lifted a total that earned me a silver, but they overturned it ... it is something I'm going to cherish, and it's something that I want to build. I'm focused now on improving on this medal, and I'm aiming for a silver or gold, and I'm more motivated. I see myself in years to come competing in powerlifting here in Belize and outside," said Murillo.

Sho, who has been a personal trainer for 5 years, commented on the stigma of women who are ridiculed for being in the gym.

"That is from the days of our ancestors and the olden time when we

felt like the woman's job was to just be in the kitchen to be taking care of the house. We're so past that; we have come a long way Lifting weights will not make you look manly, it will just grow your muscles [and] make you look better. The way your body turned out is the way your body has been structured, but you don't need to be scared to lift," she said.

The Belize Powerlifting Association

The Belize Powerlifting Association is aiming to send out three of its women athletes to compete in the IPF (International Powerlifting Federation) World Classic Championships in Canada in October. Usher, along with Ruiz, and Alas, captured bronze medals for Belize in their respective categories, while Matura placed 4th and Sho finished 5th.

undeterred in commencing with the Environmental Social Impact Assessment (ESIA) and continuing in their talks with the people of Gales Point. The US company is committed to buying the White Ridge Farms property and is currently working through its shortlist of potential consulting firms that would prepare the document for review by the National Environmental Appraisal Committee (NEAC), who would then vote and make a recommendation to the Department of the Environment.

Since then, CEO of the Ministry of

Sustainable Development, Kenrick Williams, has told *News5* that "[Vulcan's mine] may not be an investment that has the support of the government" and that they would hold a preliminary meeting with them by week's end. It is yet to be determined if Vulcan will succeed in rallying the necessary public support for its mining interests. For now, those opposed in the village seem to outnumber its advocates, and they are continuing in their efforts to preserve Gales Point's unique ecologies and the sustainable life many have cultivated in this Kriol community.

House passes Supplementary Appropriation Bill to settle...

The payment to the Ashcroft Alliance's BISL for BZD 76.5 million dollars will go to the Senate for final approval;

Prime Minister Briceño said this payment ends all legal claims related to the matter

of Belize (IMMARBE) and the International Business Companies Registry (IBCR). The bill was approved in the House with little resistance from the Opposition and will now be sent to the Senate to be rubberstamped before payment is made to Waterloo Investments Holdings and Morgan y Morgan (a Panamanian law firm), the two former owners of the registries operated under BISL.

The PM, in explaining the reasons for the payout, said that the debt, to which up to \$17,000 in interest is added daily, would balloon in size if not settled; and he further noted that this settlement, which is a little more than half of the amount initially demanded, will end the claim definitively and thus remove another legal claim that has been looming over the Belizean public.

"The claim was for over 65 million US dollars or 130 million Belize dollars. The BISL claim, I must stress, grows every day, with daily interest depending on the eventual core compensation of between BZ\$4,000-\$17,000 a day, and so after the proposed settlement, government will still net US48,615,000,789. Simply put, government pays this now so that it can avoid paying a whole lot more at some time in the future," PM Briceño said.

PM Briceño then pointed to the action which prompted the litigation that resulted in the claim—a decision by the Barrow administration to take over the two registries managed by BISL. By doing so, Barrow brought an end to a contract with BISL that had been extended by a former PUP administration—an act by Barrow that BISL claimed was wrongful. That contract was first granted in 1993, but in 2003 was extended—allowing the company to continue managing the registries until 2013. However, two years later, in 2005, they were given a subsequent extension to operate from 2013 to 2020. It was an extension that the Barrow administration considered unlawful, and in 2013, it took control of the registries. The company then filed a claim on March 26, 2015, against the government for damages caused by a breach of the contract, but both the country's Supreme Court and Appeals Court ruled in favor of the government. The company, however, pursued litigation all the way to the Caribbean Court of Justice, which ruled in favor of the company and ordered the Supreme Court to determine a quantum.

At the House of Representatives meeting on Wednesday, however, the Leader of the Opposition, Hon. Moses "Shyne" Barrow, asserted that the 2005 agreement was done under the table and was illegal.

"What the Prime Minister did not mention is that no one knew about the 15-year extension that then Prime Minister Musa gave to BISL. I don't even think the Cabinet at the time knew about the secret agreement," Barrow claimed.

Another member of the Opposition, Albert area representative, Hon. Tracy Panton, questioned how the government has been able to allocate sufficient funds to clear this legal claim but postponed the marijuana legalization referendum because of its estimated 5-million-dollar price tag.

"In one payment we can settle a 38.5 million US dollars, 76 million dollars [Belize] on the backs of the Belizeans. Wasn't it just the last House meeting when the government coerced the churches to say we will put a hold on the referendum on marijuana because we can't be afforded the \$5 million? But yet, Mr. Speaker, we can find 76 million dollars to meet this debt obligation

in one payment, not through a payment plan, not in installments, that would be less burdensome for the Belizean people—in one payment," Panton said.

When interviewed by reporters after the House meeting, the Prime Minister reiterated that the payment of the settlement would be final, and he pledged, in the spirit of transparency, to share all the documentation related to the settlement with the public.

"The point that I would like to make is that the \$38.25 million US, of which 11.5 million is going to be paid in Belize dollars, is final. That's it. We won't owe them anything. They are not going to come later and say, 'Oh, you owe me court fees or lawyer fees'—nothing; we will settle there. From our end, we have not received the bills from Dr. Ben Rossovich, Senior Queen Counsel, and also from Hallmark Advisory. From what I understand, and I need to get more clarity, I don't think we're going to get a bill from them. They just want it to help to settle this, did this issue and felt that it was, you know, we just had to do trying to save money for the Belize people," Prime Minister Briceño

Current Minister of Foreign Affairs and Lead Senator for Government Business, Hon. Eamon Courtenay, was one of the lawyers representing BISL in its claim against the government of Belize prior to the 2020 general elections. His law firm, Courtenay Coye LLP, which is also part-owned by Minister of State in the Ministry of Finance, Hon. Chris Coye, is expected to collect a hefty sum for their work representing the Ashcroft Alliance in this case. The PM, in an interview yesterday, said that Courtenay recused himself from the Cabinet meeting at which the matter was discussed, and had nothing to do with the settlement agreement reached between the Government and BISL.

"What I can tell you, Courtenay and Coye did not participate in the settlement. They participated in going

to court up to 2020, but since [they] have come into the office they have had no participation on this, and Minister Courtenay walked out at mid-day before this issue came up to Cabinet, and Minister Coye was out of the country with his family," PM Briceño said.

Notably, during the discussion of the supplementary appropriation at the House of Representatives meeting on Wednesday, Minister of Education, Culture, Science and Technology, Hon. Francis Fonseca, pointed to the need for Belize to adhere to the rule of law.

"This settlement requires each of us to ask one fundamental question: are we as a nation committed to the rule of law? Are we a nation of laws? Or are we a rogue nation? That's the fundamental question. Are we a rogue country that thumbs its nose at the highest court in our jurisdiction, the Caribbean Court of Justice? That really is the only question before us today," stated Fonseca.

One such judgment handed down by the CCJ which met resistance from the Belize government at the time (the Barrow administration) was the Universal Health Services (USH) judgment order— an order to pay the Belize Bank compensation for a guarantee provided by the Musa administration for a loan received by private investors in the Universal Health Services (UHS) hospital. There had been allegations of illegality and ethical violations surrounding that deal prior to the CCJ ruling however—with reports that a grant of over \$20 million from Venezuela to fund the construction of houses (in addition to another \$20 million granted by Taiwan) was diverted to the bank by the Musa administration, as payment to settle the claim, without National Assembly approval. In 2008, Prime Minister Barrow told the public, "... There is the written agreement that made it absolutely plain that this was an international agreement committing the government of Belize to use these

funds for the specified purposes. \$9 million was for use in home improvement loans and the other ten million, which Amalai Mai instructed the Venezuelans to send to an account in the UK held in the name of the Belize Bank, was for use in new home construction. The confirmation note sent by the relevant Venezuelan agency, BANDES is the Spanish acronym, to the Belize Bank with respect to the fact that the \$10 million had been wired, had clearly on the face of it wording that said that this was in connection with the disbursement being made to the government of Belize for use in housing construction..." (7News transcript—March 2008)

He then went on to state, "...
the enormity of what has been
done is compounded by this fact:
forty million dollars gifted to us by
Venezuela and Taiwan was paid
over to the Belize Bank. We did
not end up owning the hospital,

notwithstanding that \$40 million was paid. That money was then, as we understand it, deposited in the name of a charitable trust registered in Nevis but operating at a Turks and Caicos Belize Bank account." An AMANDALA article in May 2009 had said that Musa at one point was "facing a charge of theft in relation to the payment of ... US\$10 million—the grant coming from the Government of Venezuela to Belize, billed for housing for the poor—to pay the UHS debt" to the Belize Bank.

And thus it was that, after the CCJ subsequently issued a judgment which ordered the then Barrow administration to settle the Belize Bank's claim, that administration refused to comply. Parliament at the time voted against a supplementary bill that was tabled to cover the debt, which former Prime Minister, Dean Barrow, referred to as "immoral."

The Belize Bank, owned by a subsidiary of Waterloo Investment Holdings Limited, took the case in 2019 to the Supreme Court and was given leave to use unpaid business tax to recover the sums from the claim. There is no indication if a firm agreement was reached between the government and the bank to finally determine a settlement for that debt, and there is no indication if the sum owed by the government, a total of 95 million dollars at the time it was quantified, is still growing. A timeline is not set for when Belize Bank will stop using funds that should be allocated for business tax to settle the UHS claim.

During yesterday's interview, the PM spoke briefly on the matter, and claimed that it had already been settled. "That has already been negotiated. That has already been settled, and they are using the tax monies to be able to pay themselves, but no, they have not come to us and said, 'mek we work out something, make we discount and pay it off'. No, they have not come to us with something like that."

Waterloo "threatens" GoB again

Just one day after government announced that an agreement was reached to settle a claim brought by Waterloo Investments Holdings' BISL, a January 2022 letter from Waterloo's chairman, Lord Michael Ashcroft, in which he threatens legal action for a supposed breach of a UK-Belize treaty for the Promotion and Protection of Investments, was leaked. It appears to be a more aggressive tactic aimed at wresting approval of Waterloo's proposed cruise terminal from GoB, and has entered the public domain just days before the scheduled public consultation on the new ESIA for the project takes place.

could cause the country through another lawsuit if Waterloo's most recent multimillion-dollar enterprise in the country is not approved. Specifically, what has been leaked is a letter penned by the chairman of Waterloo, Lord Michael Ashcroft, who in that letter, threatened legal action against the Government of Belize if the Promotion and Protection of Investments 1982 agreement between the UK and Belize was not upheld by the government.

The letter was sent in January, following the rejection of the company's first EIA by the National Environmental Appraisal Committee (NEAC) and Department of the Environment (DOE) late last year—a decision that had prompted the company to both lodge an appeal and to make accusations, of supposed solicitation of bribes by members of the NEAC—allegations that it never provided any further details about, even after being prodded by the Minister of Sustainable Development, Hon. Orlando Habet, to do so. And thus, the Ministry's attempt to investigate Waterloo's claim that "the NEAC recommendation accepted by the DOE ... came following Waterloo's refusal to pay bribes to certain NEAC members in exchange of 'assisting' Waterloo in answering NEAC's question in the environmental screen process" stalled because Waterloo made no attempt to substantiate the claims.

The letter sent by Lord Ashcroft nonetheless admonishes the government for the rejection of the first submission for environmental clearance tabled by Waterloo. Ashcroft's letter stated that he and the UK shareholders of Waterloo are entitled to compensation under the Promotion and Protection of Investments 1982 agreement between Belize and the UK, since they have already invested upward of 5 million dollars in the project.

The letter finally invited GoB to "amicably settle the above dispute" within three months from the date of the letter or "the investors will be entitled to submit this dispute to international arbitration."

This is not the first time that Ashcroft has used the UK-Belize treaty as a basis for seeking millions of dollars of compensation from GoB. A December 2009 AMANDALA article entitled, "Ashcroft's attorneys invoke UK-Belize treaty to claim +\$200 million," reported that, in 2009. "By way of formal notice to Prime Minister Dean Barrow and Attorney General Wilfred Elrington, **Dunkeld International Investment** Limited (a Turks and Caicos company affiliated with British tycoon Michael Ashcroft) ... indicated that it [was] invoking foreign arbitration for damages and losses of at least BZ\$200 million

and up to \$400 million, following the nationalization of Belize Telemedia Limited (BTL) in August. The notice of arbitration makes reference to a treaty Belize signed with the UK back in 1982, with a 1985 amendment signed by Barrow, as Minister of Foreign Affairs, extending the treaty to the British territory of the Turks and Caicos."

The letter sent by Ashcroft in reference to his most recent proposed venture the Waterloo cruise port—was sent to the Prime Minister, Hon. John Briceño, in January of this year, as mentioned, and all indications point to steps being made to avoid yet another bout of litigation with the Ashcroft Alliance—with Waterloo's appeal being heard, and a new ESIA being submitted to the DOE for review and being uploaded on their website. Waterloo is now knee-deep in a process to seek approval of its project, and a positive assessment of that project's environmental and social impact—with public consultation scheduled for next week.

But the letter sent by Lord Ashcroft was issued before any final determination was made about the environmental impact of the project. And it also made no mention of the still-ongoing assessment of the social impact of the project. Neither does it acknowledge the gravity of any of the other considerations that would impact any decision by GoB—including the approval already given to two other cruise terminal projects (Stake Bank's Port Coral and Portico Enterprise's Port of Magical Belize) which would be operating, along with any proposed Waterloo port, within a small geographical area (an 8-mile radius) in the Belize District. What is seemingly suggested in the letter is that none of that matters—that perhaps the sheer fact that a UK investor is desirous of building a port obliges the government to issue an approval or risk violating this investment treaty. Questions have thus surfaced about what exactly are the terms of such a treaty—and whether it requires a country to disregard any environmental harm or social harm that could be caused in order to ensure compliance. Some in the public are wondering how Lord Ashcroft could be requesting payback for money he spent of his own volition to develop a project, the approval of which was never guaranteed. There is, in fact, an even more gnawing question in many Belizeans' minds: were any assurances given to the Waterloo investor, either by this current administration, or the previous one?

The threat of litigation in the letter is real, and is particularly haunting because of the timing of the leak—just a day after the announcement that GoB would be paying Waterloo's Belize International Services Limited (BISL) approximately \$76.5 million dollars (\$38.25 million US) after the company took its claim against

Next steps

In light of the above, the GoB is invited to amicably settle the above dispute under Article 8(1) of the UK-Belize BIT. As prescribed therein, in the event that no amicable settlement is reached within three months of the date of this letter, the Investors will be entitled to submit this dispute to international arbitration under Article 8 of the UK-Belize BIT.

the government of Belize through all the courts in the judicial system before getting a judgment in its favor at the Caribbean Court of Justice.

The Tuesday issue of the AMANDALA reported, "The company, BISL, was contracted in 1993 to manage two registries for Belize, the International Merchant Marine Registry of Belize (IMMARBE) and the International Business Companies Registry (IBCR), and was given an extension in 2003 to operate from that year until 2013. Two years later, in 2005, they were given a subsequent extension to operate from 2013 to 2020. The government, however, considered the 2005 extension unlawful after taking over control of the registries in 2013. The company then filed a claim on March 26, 2015, against the government for damages caused by a breach of the contract, but in October 2016, current acting Chief Justice Michelle Arana ruled in favor of the government, deeming the agreement to be unconstitutional, illegal and void. The case was taken to the Court of Appeal, where the Justices of Appeal dismissed the appeal and affirmed the ruling of then Justice Arana. The company finally got a favorable ruling after seeking redress at the highest appellant court, the Caribbean Court of Justice (CCJ), which ruled that the government acted unlawfully when it seized control of the two BISL registries. The court further ordered that damages be assessed by the Supreme Court and paid to the claimant in its judgment."

This is just one example of how Waterloo has used its vast financial resources to fund relentless litigation in order to forward its business goals. Another legal battering at the hands of Waterloo would likely cost the Belizean public millions of dollars, making the proximity of the BISL settlement and the leak, or "release," of the letter unsettling.

The fears about potentially devastating harm that could be caused by the project, however, are also very real. The issue of the placement of dredged material generated during the initial phase of construction of a cruise terminal at the Port of Belize was one aspect of the environmental impact of the project which caused the conservation community to sound alarm. Such dredging would be necessary to create an access channel to allow Oasisclass cruise ships to berth directly on the Belize City shoreline at the proposed cruise terminal—but there were concerns about possible damage to the Belize Barrier Reef. Following the outcry, the company had adjusted its plan to dump 7.5 million cubic meters of dredged material at an off-shore location (between English Caye and the Turneffe Atoll) and had suggested instead in an EIA addendum that it would dispose of the material at near-shore and on-shore locations

"The volume of dredged material that will be generated by the dredging operation will require placement in onshore and nearshore locations," the 2022 ESIA draft by Nextera Environmental and Engineering Consultants on behalf of Waterloo states.

The Belize Water Services, however, lodged a public complaint last year to the DOE regarding the placement of the new proposed dump site—which the company said is between its sewer ponds and the sea, and on top of an important mangrove wetland used for wastewater treatment.

"BWS is greatly concerned by the developer's proposal to dredge and to place 7.5 million cubic meters of dredged material between the location of BWS's sewer ponds and the Caribbean Sea," the letter, sent in September 2021, states.

The company's release goes on to state, "Based on the EIA report addendum, the near-shore and on-shore locations for placement of dredged material lie directly on top of the natural mangrove wetland used as part of the wastewater treatment process and extend well beyond the present-day Caribbean Sea shoreline. BWS anticipates a serious disruption of the established treatment process, as well as an increase in the challenges of meeting the regulated effluent limits for discharges from domestic wastewater treatment systems into Class 1 waters."

In regard to the possible impact of such a project on our marine areas, the stakes are even higher because of the commitments the country made when it entered the Blue Bond financing arrangement with the Nature Conservancy (TNC)—an agreement which allowed the country to shed hundreds of millions of dollars of public debt by retiring the Superbond at a discounted rate that almost halved that debt. That arrangement also paved the way for many more potential opportunities for financing and investment based on preservation of the marine environment—all of which could be placed at risk if projects such as Waterloo are not properly assessed.

In fact, in a recent interview, the local representative for The Nature Conservancy in Belize, Julie Robinson, said that one of the 8 commitments made by the government of Belize as a part of the Blue Bond conservation funding agreement was to strengthen the EIA process.

"One of the commitments that

facilities in the country.

"The goal of this particular trip is to bring the potential architects and builders to get a layout of the land [at] the different facilities that may be at our disposal so that we can start putting together a plan to develop the stadiums [like the] MCC Grounds, Rogers Stadium, National Stadium, and any other government-owned facilities, which is what private-public partnership entails. This is just an exploratory [trip] to figure out what is feasible ... The grand scheme is, hopefully, to have a layout over the years coming to build a national facility that can foster, develop the youths all the way to the national teams at a youth class level just on par like everyone else," he said.

He added, "... Ultimately, this is something that we want to spread through the districts and through the villages. Each village has a park; some have a large enough to have a small track, and I believe that it's not that expensive to put a track on a field; it's not really that expensive."

Meyers further noted the impact that such enhanced facilities and programs could have on at-risk youth and on crime-reduction efforts. "The numbers are there. Everywhere you go, there is a structured athletics program through youth development that drastically reduces crime. Not just gang violence, or crime. We use sports to reduce stress and increase morale [and] increase productivity ...," he said.

Meyers went on to state that for some time now he has been conveying to the Belize Athletics Association his willingness to train the local athletes in the country to compete on the international stage. However, there has been no reply from the Association to indicate acceptance of his offer

"I don't just coach my kids. I coach all over. I was offered a lot of money to go and coach a Division Two university, which I've turned down because I have a goal to be here. I want to help here. What's frustrating is that I have people knocking down my doors for me to train their athletes, yet my own country doesn't even return emails. So I would say the relationship is at this point, tenuous at best. I have communicated several times in regards to my children competing for Belize. My training is a year in advance; everything I have is planned out for an entire year, where they're going to race because we have Olympic dreams. In order to effect change [within] the Association, it starts communication and transparency, which I don't see as yet. I've asked with zero response what status within the Association I am willing to help. I'm willing to be here, but I need to know what [my] status is," Meyers explained.

Before the exclusive interview ended, Meyers mentioned that he has arranged for four Belizean high school studentathletes to get scholarships to attend St. Jago College in Spanish Town, Jamaica, for four years, during which they will participate in track and field training exercises.

"I have an agreement with Jamaican College and St. Jago College, for four scholarships. They want four boys. They don't have to be superstars or all-stars, but as long as I give them my approval that they have the ability, and they'll have the desire to go to Jamaica. Full scholarships; room and boarding, transportation; back and forth, to Jamaica to attend St. Jago High School and run track and field for four years ... If we can identify up to four boys, we can get them to Jamaica by September 1, next week, so long as they have all their shot records, their families are involved, and communicate. I'm sure it'll take more than September 1, but on September 1, I'll have four scholarships available for four young men to attend St. Jago High School and four more for Jamaica College, but wouldn't be till the following year," Mevers said.

for an answer.

"We should have the power to say to any company, 'you know what, your money is not good here. You know what, thanks, but it is okay. We do not want that kind of investment. We are concerned about other issues, and so you may want to move on to another country.' We have that right. We're an independent, sovereign nation. If we can't do that, then we are not," he said.

Minister Hyde confirmed today that representatives from Vulcan have requested, via the US Embassy in Belize, to meet with him. And while he has not fulfilled that request, the representatives have met with the Ministry's CEO and the Mining Director.

"We are dealing with giant companies. We are dealing with multinationals that are used to getting their own way," added Hon. Hyde.

Despite repeated and staunch objections from the people of Belize, developers have continued in their efforts to launch proposed projects in various communities. That includes Vulcan Materials.

This past Saturday, residents of Gales Point, a Kriol village. met with representatives from the company. There, some villagers made their message clear: they want nothing to do with Vulcan. Despite that response, the company has written a letter to the people of Gales Point, stating that they have been "energized by the productive conversations" that they had with the residents.

According to that letter, the company will continue to seek input from the village as well as from government leaders, local NGOs, scientists, and regulators. Vulcan also notes that this week, it plans to begin providing jobs to the people of Gales Point that will "pay a minimum of double the current minimum wage". According to the letter, some persons have already expressed interest in taking up those jobs.

"We understand that there are some who have already made up their minds about this project. But we also know from both our conversations with the government and with village residentsthat there are many others who support this project," wrote the Vulcan White Ridge Project Team.

Similarly, Waterloo Investments Holdings, a company believed to be owned by the Ashcroft Alliance, has continued in its efforts to get its proposed port expansion and cruise tourism village project approved, despite having been rejected by members of the public on at least three occasions during public consultations due to social and environmental concerns.

"For me, this whole Vulcan situation kind of reminds me of Ashcroft. There are some people who are just too big for this country," noted Minister Hyde.

The people of Gales Point, says Hyde, are resolute in their no. He also said that the environmental damage likely to result from mining in the area is "unthinkable".

"You're talking about our animals." You're talking about our marine life. You're talking about our hicatee, our manatees, our turtles, our fishes, our trees, our mountains that will never be the same. So why should we go down that road for a few jobs here and a few nickels there, while the rich multinationals will exploit our raw materials and ship that abroad?" Hyde

"You know what that sounds like to me? That smacks of slavery. That smacks of colonialism. That's the very same thing that the ancestors of the Gales Point community fought against-escaped from slavery hundreds of years ago because they could not deal with that. They shunned that kind of thing," Hon. Hyde further remarked.

Vulcan Materials Co. was recently ordered to cease its operations in Mexico, allegedly due to environmental and labor abuses committed while operating in Ouintana Roo. The company has subsequently brought numerous lawsuits against the country's government, including one for \$1.5 billion.

The company's representatives have requested to meet with the Ministry of Sustainable Development. Vulcan also plans to submit an Environmental Impact Assessment (EIA) Report in the near future.

government has made is to strengthen its environmental impact assessment regulations, and so it is a process. That process, that EIA process, needs to be revised; it needs to be strengthened," Robinson said in an interview with KREM News' Marisol Amaya.

She added, "What was brought to light when we were going through this process was that the EIA process itself needed to be improved upon. We needed to do things like, for example, look at the cumulative impact of projects rather than just on their own, because we are working in an area where you have connectivity, and if you have projects A, B, and C right next to one another, you are having a much greater impact, but the EIA process does not allow you to look at the cumulative impact."

As a part of the Blue Bond agreement, the government is thus required to strengthen its EIA regulations before proceeding with any major development projects. No set timeline is set for the revision and update of the EIA regulations, but Robinson said that a Marine Spatial Plan being drafted by the parties will be used to guide developments of this nature.

The Blue Bond Agreement was signed in November of last year. It was at that time that the government made the commitments, which included the revision and update of the EIA regulations process. It is to be noted, however, that while Robinson indicated

that TNC can advise the government to put a pause on the approval of new developments until the revision is completed, she pointed out that after a project has started, bringing it to a halt would open the door for legal action against the government. It is an indication that Blue Bond commitments must be considered BEFORE approval for any potentially harmful project is issued, rather than after a project has been given the green light.

"As part of the agreement that we have, we can only push as far as to say that it remains consistent with Belizean law. We can advise—so things like, when you are looking at Waterloo or any of the cruise ship developments, is the EIA process has already started, then perhaps a pause can be placed on it until we are able to look at the process. However, it is not necessarily something that can be stopped. I think if you were to put a stop order or something like that, the government would expose themselves to being sued because, according to the law, they are starting a process. What we are trying to make sure if that process is as robust as it possibly can be. So we could request if that process is going through—we could request and say, 'hey, let's put a pause on this until we have had a chance to review that environmental impact assessment process and strengthen it to take into consideration', like when you talk about the cruise ship, you are talking about three cruise ports that are all like in a within an 8-mile radius of one another," Robinson said.
