

# Pharmacy Express withdraws SSB Ioan application

Controlled drugs were removed from two of the four drugstores located at the Fort Street Tourism Village (and owned by Pharmacy Express), which were searched by police and Ministry of Health officials. Their attorney, who called the search illegal, said that a closure order had been issued to the drugstores by the Health Ministry.

### Waterloo resubmits EIA to DOE

## **Dr. Zabaneh: Belize firmly supports Taiwan**

BELIZE CITY, Thurs. Aug. 11, 2022

Longstanding tension between Taiwan (formally known as the Republic of China, Taiwan) and China (the People's Republic of China (ROC)) has escalated in the past few weeks following the Speaker of the US House of Representatives Nancy Pelosi's controversial visit to Taiwan. The congresswoman's visit on Tuesday, August 2, took place as part of a tour of Asia by US Congress, though a stop in Taiwan was not officially on her itinerary.

It was the first time in twenty-five years that a US House Speaker had visited the island nation and was preluded by numerous threats of retaliation from China. Since then, China has increased its military operations near Taiwan.

Just this Wednesday, eleven Chinese

## IMPACT Justice supports Belize's constitutional reform



BELIZE CITY, Thurs. Aug. 11, 2022

The current laws of Belize are being reviewed with the assistance of the Improved Access to Justice in the Caribbean (IMPACT Justice) project and the Regional Law Revision Center Inc., a non-profit organization located in Anguilla. The exercise, which is being funded by the Canadian government, started on June 23 and is expected to be completed by March 2023. This study of our laws will complement the work of the People's Constitutional Reform Commission and will assist in pinpointing areas in need of improvement.

The joint release issued today by the University of the West Indies and IMPACT Justice states, "In requesting the assistance of IMPACT Justice in this exercise, Hon. Magali Young, SC, Attorney General of Belize, mentioned that since these laws had not been revised in over 18 years, it was of critical importance that the exercise be undertaken in order to improve not only the efficiency of the legal system but also ensure certainty of the law for citizens, legal practitioners, and even law enforcement."

The IMPACT Justice project is being implemented through the Caribbean Law Institute Center from inside UWI's Faculty of Law and has been in operation for almost 10 years with funding from the Canadian government. The support of the body

will aid our process of law revision in the country.

Of note, the organization has also donated legal books to 11 Magistrate's Courts across the country. This is in line with a recommendation that was made following a study of the Magistrate's Courts in Belize which was conducted by the organization. The Situational Analysis of the Magistrate's Courts of Belize was commissioned by Attorney General Magali Marin Young SC, in mid-2021 and was released in March of this year.

The study included a site visit to the lower courts and published recommendations suggesting that new magistrates be provided some sort of mentorship and guidelines, that online subscriptions of legal resources and digital recording equipment be purchased, and that a digital payment system be put in place.

An article published in March 2022 by www.Caribbeannewsglobal.com states, "Another key recommendation, which will be undertaken with the assistance of the IMPACT Justice Project, is the purchase of certain key legal materials for the use of magistrates at all of the Magistrate's Courts."

They have since made steps to forward this recommendation.

"In total, 88 books (8 per Magistrate's Court) have been purchased on topics including the Interpretation Contracts, of Commonwealth Caribbean Criminal Practice and Procedure, Commonwealth Caribbean Property Law, Commonwealth Caribbean Tort Law, Commonwealth Caribbean Family Law, Commonwealth Caribbean Land Law, Criminal Evidence and Money Laundering," the release, issued this evening, states.

In a Tik Tok video that was posted on Tuesday night, a person who appears to be a police officer can be seen carrying contraband beer during the daytime across the Belize-Guatemala border at Arenal, which is located in Cayo and straddles the border between the two countries. The video shows the officer with his arms around crates on which the Corona beer logo can be seen as he lumbers along an uphill path at the border crossing. In the video there is a Spanish caption. The English translation of that caption is, "how when the police say 'don't contraband"".

The Tik Tok video was subsequently uploaded to other social media.

The Commissioner of Police, Chester Williams, after viewing the low-resolution video, has said that the police believe they know the identity of the officer, who was dressed in a camouflage uniform known to be

## Tracey Betancourt still wanted for murder

San Pedro resident Tracey Betancourt is still wanted by the police for murder of American businessman Lamont 'Monty' Lipka. Last month, on July 28, the Supreme Court case against Betancourt, 25, and 38-year-old Leon Walford concluded, with both being found guilty. Betancourt, however, who was out on a fifty-thousand dollar bail, was not present in court when the verdict was delivered. Since then, police have been unable to locate Betancourt, and she remains a fugitive.

Lamont Lipka was the owner of Tropicana Bar and Grill in San Pedro Town. He was brutally killed, in front of workers and patrons, on May 13, 2018 when a gunman—eventually identified as Walford—walked into the restaurant, located on Coconut Drive, and shot him in the head, neck, chest, abdomen, and arms.

In November of that year, Tracey Betancourt was arrested and charged for Lipka's murder and conspiracy to commit murder, with ASP Alejandro Cowo stating during a police brief that there was sufficient evidence tying Betancourt, then 21 years old, to the murder. Shortly after, police located and

arrested Walford for the shooting as well.

Betancourt is no stranger to the law, having been charged for drug trafficking in September 2016 and for keeping ammunition without a gun license in 2017.

A flyer from Crime Stoppers Belize notes that there is a warrant of arrest out for the 25-year-old and asks members of the public to be on the lookout for her. Those with any information about her whereabouts are asked to call Crime Stoppers at 922, or to contact police at the nearest police station or use the P3 App.

### Belize Business Bureau applauds GoB for its new policies

BELIZE CITY, Wed. Aug. 10, 2022

The Belize Business Bureau says that recent transformative policies implemented by the Government of Belize will be "the hallmark" of the Briceño administration's first term in office.

In a recent press release, the Bureau commended the Government for the reduction of public debt from 133% to 89% of GDP, the "inclusion of all sectors" in the constitutional reform process, and especially the promotion of growth of small businesses through its recent MSME strategy and roadshow.

The president of the Belize Business Bureau, Arturo Lizarraga, told the media this week that the new policies being rolled out by the government reflect its listening ability—in the case of constitutional reform—as well as its fiscal management skills, in the case of the reduction of public debt.

"It's transformative, because we've been in a downturn. We've been in a state of shock for many years. It's not two years of COVID. It's almost like fifteen," said Lizarraga.

He then noted that during the last administration, a greater focus was placed on the nationalization of large companies—BTL and BEL—as opposed to supporting small businesses.

In its press release, the Belize Business Bureau also proposes that the Government take its MSME strategy even further by holding off on taxes and GST for MSMEs during their first four years

in operation as well as providing them access to duty exemption. According to the BBB, these additional policies would spur investments, lower risks, and improve profitability for small business owners. They could also push businesses in the informal sector to enter the formal sector, which would "create a larger tax base with data—big data—on how small businesses are growing the economy."

The Bureau's president, in speaking with the media, also expressed the organization's full support of the proposed increase in the minimum wage from \$3.30 to \$5.00 per hour. This differs from the stance of the Belize Chamber of Commerce and Industry, which has stated that it supports the increase but has expressed the view that it should be done in phases and with certain conditions.

"You have to embrace the Chamber's willingness to want to wait and protect big businesses on that not implementing the \$5. The Business Bureau's role is very clear—give them the 5 bucks. Stop delaying," Lizarraga said.

### **BDF soldiers get** land titles

On Thursday and Friday of last week, the Ministry of Natural Resources, which has been hosting mobile clinics at various locations in the country, to provide Lands Department services to members of the community who might find it difficult to travel to Belmopan to access such services, took its mobile operation to Price Barracks in Ladyville—the headquarters of the Belize Defence Force (BDF). At the end of the clinic on Friday, over 200 soldiers and civilian staff of the BDF, as well as 150 police officers and members of the Belize Coast Guard, had received the assistance needed to purchase their land title at the clinic. It was a fulfillment of a promise that had been made to them by the Minister of Natural Resources, Hon. Cordel Hyde.

He had explained to local media last week what prompted his decision to host a mobile clinic especially for members of the country's military. "The birth of this is a few months ago at our Sandhill land clinic. The BDF came out in droves. It must have been a couple buses of them, and so we promised them that they don't need to subject themselves to that, that we'll bring a special operation for them here. I don't think they believed. We've put it off a couple times, but we're here, and really it's about giving them a special treatment, because what we are going to do is, we are issuing purchase price approvals for them, and then they are going to pay, because they've said they had the money to pay, so they're going to pay immediately and apply for title immediately, and so we are hoping that by tomorrow to issue the titles to these folks," he told a local reporter on Thursday.

He further noted, "We understand that they don't have the time to chase their land matters. They're very busy. They're dispatched all over the country in very remote places, and it's impossible for them to spend the time and the energy to chase down their matters. As it turns out, some of the officers we were able to help are retired officers. They are retired and were not able to complete their land transaction, so we consider this to be a very big deal, and we're happy that we had this opportunity to fulfill that promise."

Jermaine Burns, was one of the soldiers who received a land title. "It wasn't a few minutes ago when I received my title that it felt really good to see the level of commitment that our government has put into today's activities to see the projects through, because we have cited these areas for over the past three years and we've been trying in and out to try and get the soldiers something, some sort of benefit for serving the country, and I'm glad today that we've done that. I'm glad to do that; I have capitalized on the process to secure one of these for myself," he said.

"I feel privileged and blessed that the ministry took the initiative to bring it here to us as soldiers, because due to our schedule and operations we don't have the time like others to go out, so it's good that they brought it here. And it's not only one day. They made it a two-day event so soldiers that couldn't make it yesterday made it today. They made the process much easier for us,' Cpl Jereen Chun, a member of the BDF, told local media on Thursday.

"Finally getting land for myself, it's been a good experience. For a while, it seems like it was going a long period, but eventually, it came to fruition. Better process. This clinic helped a lot in speeding up the process for us," said Cpt. Pierce Coleman, a BDF pilot.

Minister of Defence and Border Security, Hon. Florencio Marin, Jr., has also publicly applauded the initiative.

Plans are also reportedly being made to host a mobile ckinic especially for members of the Belize Coast Guard.

## **CITCO Youth Innovation** summer camp ends

150 kids from various parts of the city were given certificates for completing CITCO's Youth Innovation Incubator Summer Camp.


To conclude the Belize City Council's Youth Innovation Incubator Summer Program, which was organized by the Belize CITCO, along with its partners from the central government and the private sector, 150 kids from all parts of the city were awarded certificates for completing the month-long activities.

The summer program was aimed at providing participants with an opportunity to educate themselves on subjects such as financial literacy, leadership skills and music, free of cost.

On Wednesday, August 11, members of the local media were present at the House of Culture when the camp's closing ceremonies took place, during which camp participants were recognized for their involvement.

"Normally, summer programs would just have that sporting component, but we wanted to be a broad-based type of summer, where you not only have the sporting component, but you have the self-development process as well. You have music, [and] swimming, and you have been able to self-development—all of that types of areas we were looking at. And so, when we did this program here, it was to engage over 150 kids in our community throughout those four weeks. But clearly, from the outcome today, we can see we made an impact with our youths," said Mayor of Belize City, Bernard Wagner.

Mayor Wagner highlighted the escalating crime in the city—much of which is being carried out by gang members, and he noted that initiatives such as the Youth Innovation Incubator Summer Camp is a way of preventing young ones from possibly embarking on



such a path.

"We recognized there is this issue with gangs in our communities ... [a] huge amount of gangs. We want to be able to assist in this area by attacking it from the early stage. You have to be able to change the mindset of our kids, of our youths, providing avenues, [and] providing social programs. This gang warfare is not good for the city; it is not good for the country. It is a process where it can only get worse, and so we as leaders in our community have to be able to stop it at the point, engage our kids, engage the kids from the different neighborhoods [and] have them understand that, listen, all of us feel the same pain. All of us feel the same challenges. Why would you growing up, as you turn from a child to a youth, begin to harbor this hate? That is what is happening in our community. There is this strong hatred in our community, and it [crosses] political lines, it crosses communities; it is rampant in the urban areas. And so we at the municipal level, want to be certain in changing that mindset," said Mayor Wagner.

live upstairs. Ten persons in total are left without a home following the fire on Tuesday night.

An argument between the woman and her ex-common-law husband is what is believed to have prompted him to set the fire. He had threatened that he would burn down the house, according to Gabriela Lamothe, Marie Lamothe's daughter, who also had to escape from the home. Ronaldo Sebastian thankfully awoke in the heat of the fire and was able to alert the rest of his relatives, after first bolting to secure his grandmother.

They are certain that Lamothe's excommon-law husband committed the crime, and the matriarch has since been in conversation with police over the incident. The chairman of the village told

local media that the family would be accommodated in a house for at least a month or two until they can pick up the pieces of their lives.

The elder woman and her granddaughter have been sleeping in a makeshift tent, while the others slept in an old vehicle that was in the yard, as they tried to stay dry during the constant rains the country experienced this week. They are asking the public for any contributions that can help them get back on their feet, since everything they owned was destroyed in the fire.

"For right now the neighbour and NEMO is trying to help her out and lend her a house for the meanwhile across from where she lives. NEMO is helping her with mattress and little stuff to get together. But if anybody else could come in and give something like groceries, because she lost everything. It's really sad, but I'm a person that believe in God and to me the most important thing is that my mom and my family is safe," Gabriela told a local reporter.

There has been no indication whether the man believed to be the arsonist has yet been detained by police.

## Female parliamentarians demand apology from PlusTV

Plus TV host and owner, Louis Wade has been criticized for what some have called offensive language used on his morning talk show.

The Women Parliamentarians Caucus has written to the board of the Belize Broadcasting Authority (BBA) to condemn the use of offensive language by PlusTV talk show host Louis Wade on the morning of July 25 on the show Rise N Shine. Wade, who is a member of the BBA as well as the elected media representative set to sit on the People's Constitutional Commission, had been addressing the recent backlash surrounding his appointment to that constitutional reform body when he used a phrase which some have deemed offensive and in poor taste.

He is quoted as saying, "Nation-building is for giants, not——wussies".

The Caucus is demanding an apology from the Belmopan media house, and, in addition to writing the Belize Broadcasting Authority, issued a press release, stating:

"The Caucus takes this opportunity to remind all those in leadership roles that to use words associated with the genitalia of women to convey weakness, or a cowardly man, or being 'less than a giant,' is offensive, disrespectful, discriminatory, and continues the patriarchal narrative that women are weaker than men."

The term used by Wade, noted the Caucus, is one that has misogynistic connotations and one that is also unacceptable to use in reference to members of the LGBT community.

"We call on PlusTV to issue a public apology for the use of the word on its media," said the release.

Included in the letter to the BBA, written by Hon. Valerie Woods, who is the interim chair of the Caucus and the Speaker of the House of Representatives, are the Terms and Conditions for on-air television licenses issued by the BBA, which states that licensees should "exercise care and discretion" to ensure that the programs broadcasted do not include lewd, perverse, or sexually explicit material that promotes "crime and public disorder".

Guideline 17 of the Terms and Conditions also states that licensees should organize programming with "a sense of good taste and a desire to positively educate and entertain people of Belize of various ages and cultures."

"It has been two (2) weeks since this incident occurred on PlusTV with no retraction, apology from the media house nor any corrective action from the BBA," states the letter.

The Women Parliamentarians Caucus was established by female members of the country's National Assembly in February of this year. It includes members of both the House of Representatives and the Senate.

### **Waterloo resubmits** EIA to DOE

The owners of the Port of Belize Limited have resubmitted their EIA to the Department of the Environment for approval. A third public consultation is expected to be held—despite members of the public rejecting the proposed development on numerous occasions.

(DOE) this week has revealed, however, that the Port has resubmitted an application for review of its EIA to the Department.

The notice informs the public that the document is available for viewing at the Port Loyola Library, National Library Service, Leo Bradley Library, and Turton Library Center, all in Belize City, and invites persons to submit their comments regarding the report to the DOE by September 2. It also notes that a public consultation will be held at the Best Western Biltmore Plaza Hotel on September 1 at 6:30 p.m.

When the NEAC first rejected Waterloo's proposal in 2021, it cited six reasons, including the fact that insufficient consultations had been held with the population living nearest the proposed site.

Earlier that year, the UBAD Educational Foundation (UEF) visited the Port Loyola community and conducted interviews to assess how informed residents were on the proposed development. Most persons knew little to nothing about the project and even less about its possible effects on the community.

In an article dated Thursday, July 7, 2022, we made reference to remarks made by chairperson of UEF, Sista Yaya Marin Coleman, who, during an AMANDALA interview, pointed out that, when it comes to discussing the proposed development, the people who are set to be directly affected those in Port Loyola—often remain voiceless, while all other entities, including the investors and the government, get their say.

The proposed expansion at the Port of Belize Ltd., expected to cost around BZ \$400 million, has been lauded by developers as an opportunity for employment, economic growth, and a boost in tourism. Despite this, environmental advocates, NGOs, and concerned members of the public have raised numerous concerns over the years about the potential environmental and social impacts that development will have on the surrounding communities and the ecosystem. Most notably, the large-scale dredging and the dumping of dredged material could severely impact the surrounding environment, so much so that even the Belize Water Services Limited (BWS) has openly rejected the proposal.

In July 2020, Waterloo Investment Holdings made its first attempt at conducting a public consultation, during which most in attendance gave a resounding "no" in response to the project. A second consultation was held in September 2021, and the proposed development received just as much opposition as it did the year before.

councilor Pauline Soberanis-Tillett as the new Deputy Mayor of Belmopan, to replace councilor Daren Swasey.

The issue is, however, that a vote was not carried out prior to the appointment, in accordance with the Belmopan City Council Act, Section 19 (2) (e).

"The Councilors hereby inform the residents of Belmopan that this decision was not made in accordance with the Belmopan City Council Act Section 19(2)(e) which, through a decision of the Caucus, decided that appointments must be made by vote of the entire council. Furthermore, the term of the current Deputy Mayor Daren Swasey is still in effect until September 2022. We vehemently oppose the dictatorial appointment of a new Deputy Mayor," the release from the councilors stated.

Interestingly, the person named as the appointee to occupy the Belmopan deputy mayor post, Pauline Soberanis-Tillett, has also declined to take the post. "We did not have a meeting, voting or anything for me to have been elected; therefore, I decline," she has stated.

There is currently no indication what led Mayor Palacio to make this announcement regarding

appointment of Soberanis-Tillett, but it is a decision that has so far backfired. Among a flurry of comments posted by the public on social media following the announcement, was a statement by Simeon Lopez, the former mayor of Belmopan, who remarked, "The Mayor has no authority to unilaterally appoint the Deputy."

# Population growth and race/ethnicity concerns

The Ministry of Immigration announced recently that a surprisingly low number of persons who are illegally in Belize had applied to have their status regularized through a special amnesty program that began last month; however, when the program is completed, the ministry expects that between 40,000 and 60,000 persons, mostly from Central America, will have availed themselves of the opportunity to come out of the shadows. After their statuses are regularized, individuals will have the opportunity to apply to become full citizens. If the number anticipated by the GOB is realized, and they all move on to citizenship, in a short period the number of citizens in Belize will have expanded by more than 10%.

Colonial Belize (British Honduras) aimed for a population of 300,000 by 1975, but in that year our population was only 133,000 persons. It was more than a quarter century later, in 2007, that our population reached 300,000. Allen D. Bushong, in the online book published by the University of Florida, *AGRICULTURAL SETTLEMENT IN BRITISH HONDURAS: A GEOGRAPHIC INTERPRETATION OF ITS DEVELOPMENT*, says in 1959 the Downie Report, a study commissioned by the government, projected that for Belize to be viable as a country, its population would need to increase at a rate of 14,000 persons yearly.

Bushong said that there were numerous studies on our "under population problem" prior to the Downie report, and they all looked to the Caribbean, particularly to densely populated Jamaica, for people to increase our population. According to Bushong, between 1953 and 1957 "the average number of arrivals and departures was 149 and 67 per year for an average yearly net gain of 82." The bar for entry into Belize might have been set too high. Immigrants had to engage in

agriculture; make a deposit of US\$84; have the funds to buy/lease a parcel and develop it; build a house; have a police certificate of character; and on top of that the authorities considered "a minimum sum of US\$1,400 per person proof" that they would not become "a financial burden on the colonial government."

Bushong said an estimated 200 to 300 Central Americans crossed "freely back and forth" daily to work in the timber industry, but there were no official records to show whether the country experienced "a net gain or loss from such relatively short-distance migration."

Census reports suggest that Central Americans didn't find Belize an especially attractive place to live during the colonial period. Our attractiveness as a home for Central Americans increased when Guatemala and El Salvador were ravaged by civil wars, and those who had aims to reach the United States discovered that we were a good place from which to launch attempts at US entry. Over the last four decades, thousands of immigrants have come to Belize, mostly from Central America, and that has contributed greatly to a near tripling of our population, from 144,000 in 1980 to an estimated 400,000 at this time.

There is much to be gained from a larger population, the greatest positive by far being increased economic opportunities. With a larger market, Belize's manufacturers will be more competitive; the cost of producing goods will be lower, the profits greater. Those in the arts and entertainment sector would also benefit from an expanded local market for their products.

There are disadvantages to a larger population, and these include more stress on environmental resources — our forests, our wildlife, our marine stock, our water quality; more demand on public schools and hospitals; and the end of the laid-back world that many of us cherish, the world where everyone knows everyone. One "cost" of immigration-led growth is the change in the racial makeup, and in Belize the Afro group has seen a dramatic fall as a percentage of the population. In 1980, 39.7% of Belize's population was Creole/Kriol, and in the last census it had fallen to 24.9%; in 1980, 7% of Belizeans were Garifuna, and that has fallen to 6.1%.

The change in Belize's racial makeup, from Afro to Mestizo/Maya, is inevitable; only the rate of that change is controllable. We are a country with strong Caribbean roots, but we are far from the Caribbean islands; we have strong Mestizo/Mayan roots, and we are near to countries with millions of Mestizo/Mayan people.

No racial majority ever gave up its place as meekly as Afro Belizeans have. In the US, a country that has been European-dominated ever since that group massacred and started displacing the Plains Indians of North America around two hundred years ago, the inevitable flow of non-European peoples from countries south of the Rio Grande has met great resistance. Those who are genetically European are using the ballot, stiff immigration laws, and a wall to protect their majority.

Of great concern to Belizeans is the impact on the local culture, which could get run over if the influx of new peoples is too rapid. Belize is just about the most unique country in the world. Our culture began forming over 300 hundred years ago, and it became more flavorful during the last 200 years with the infusion of many races/ethnic groups from across the globe who, to escape war and economic deprivation, came to this "tranquil haven of democracy."

The process was slow, and while not as perfect as well-seasoned beans cooked over slow fire, our melting pot of peoples is a special thing. Largely, we go to the polls, and the color of a candidate's party flag is far more important than the color of their skin. Largely, there is intermarriage between the races/ethnicities, though members of those groups that came after the first Great War don't usually marry members of the Afro groups.

To preserve, improve what we have, we must face the issues that confront us. Our failure to properly address the poverty in some areas, particularly in parts of the old capital, threatens the welfare of all. A caller to the WuB morning show noted that many employers in Belize now demand that applicants for jobs be conversant in both English and Spanish. This is a concern (to Belizeans who only speak English) that is not too difficult to address. The language of government is English, and being an English-speaking country in this region is not only unique, it's an advantage. We need to talk about these things.

Regularizing the thousands who are here illegally is the humane thing to do, the Belizean thing to do, but we must be careful "how we do it." We mustn't hide our heads in the sand. American television is like the invasion of a foreign army of 10,000, one of our former leaders said. If the "regularizing" isn't properly managed, in a few years Belize won't look like the country we know today. Some change is good. But we don't want to lose our unique flavor.

## **Gagged man in viral video denies** abuse allegations

BELIZE CITY, Thurs. Aug. 11, 2022

A video of a man gagged and tied up by a woman who appeared to be his common-law wife went viral on social media this week. The woman accused the man of sexually abusing their child, and had him bound by the hands and feet at knifepoint. The visibly distraught individual, since identified as Dorian Anderson, 35, has

publicly denied the allegations made against him in the video - which, according to reports, is at least two months old.

The incident took place in Ladyville. Anderson, who has described the allegations against him as baseless and

untrue, told local media that he had gone to the home to deliver some money to the woman when the incident took place. He has further claimed that she, the mother of his child. stole the entire contents of his wallet following the incident.

Before his going public, many viewers of the video had expressed approval of the actions of the mother, who was

praised for taking justice into her own hands. But now many are questioning the validity of her story. The police will be left to determine whether or not her claims are true, since Anderson, the man seen tied up in the video, has filed a report against the woman, who remains

## **San Pedro father arrested for** rape of daughter

A 52-year-old construction worker from the island of San Pedro was charged with incest after his teen

unidentified. He called for a medical examination of the child to be done, and if it is determined that the child has not been abused, he wants the mother of the child to face punitive action, including imprisonment.

Protecting the child's identity is paramount, since the allegations made are of a serious nature, and it has still not been determined if the claims made in the video are genuine or not. At this point, however, this viral video which has been seen by thousands of persons online has already marred the reputation of Anderson, who says that he might even be at risk of losing his job.

daughter reported to police that he had raped her on numerous occasions over a period that spanned several years.

The 17-year-old minor, in the presence of her mother, told San Pedro police that the forcible sexual acts by her father, continued to take place until she was 15—two years ago.

After carrying out an investigation, police arrested the father and charged him with incest.

He is expected to be arraigned in the San Pedro Magistrate Court.

# Preocupaciones sobre el crecimiento de la población y la raza/etnicidad

El Ministerio de Inmigración anunció recientemente que un número sorprendentemente bajo de personas que se encuentran ilegalmente en Belize habían solicitado la regularización de su estatus a través de un programa especial de amnistía que comenzó el mes pasado; sin embargo, cuando se complete el programa, el ministerio espera que entre 40.000 y 60.000 personas, en su mayoría de Centroamérica, hayan aprovechado la oportunidad de salir de las sombras. Después de que se regularicen sus estados, las personas tendrán la oportunidad de solicitar convertirse en ciudadanos de pleno derecho. Si se cumple el número anticipado por el Gobierno de Belize, y todos pasan a la ciudadanía, en un corto período el número de ciudadanos en Belize se habrá expandido en más del 10%.

El Belize colonial (Honduras Británica) apuntó a una población de 300,000 para 1975, pero en ese año nuestra población era solo de 133,000 personas. Fue más de un cuarto de siglo después, en 2007, cuando nuestra población alcanzó los 300.000 habitantes. Allen D. Bushong, en el libro en línea publicado por la Universidad de Florida, AGRICULTURAL SETTLEMENT IN BRITISH HONDURAS: A GEOGRAPHIC INTERPRETATION OF ITS DEVELOPMENT, dice en 1959 que el Informe Downie, un estudio encargado por el gobierno, proyectó que para que Belize sea viable como un país, su población tendría que aumentar a un ritmo de 14.000 personas al año.

Bushong dijo que hubo numerosos estudios sobre nuestro "problema de población insuficiente" antes del informe Downie, y todos miraron hacia el Caribe, en particular hacia la densamente poblada Jamaica, en busca de personas para aumentar nuestra población. Según Bushong, entre 1953 y 1957 "el número promedio de llegadas y salidas fue de 149 y 67 por año para una ganancia neta anual promedio de 82". El umbral para ingresar a Belize podría haber sido demasiado alto. Los inmigrantes tuvieron que dedicarse a la agricultura; hacer un depósito de US\$84; tener los fondos para comprar/arrendar una parcela y desarrollarla; construir una casa; tener un certificado policial de carácter; y además las autoridades consideraban "una suma mínima de US\$1.400 por persona como prueba" de que no se convertirían en "una carga financiera para el gobierno colonial".

Bushong dijo que aproximadamente entre 200 y 300 centroamericanos cruzaban "libremente de un lado a otro" diariamente para trabajar en la industria maderera, pero no había registros oficiales que mostraran si el país experimentó "una ganancia o una pérdida neta por una migración de tan corta distancia".

Los informes del censo sugieren que los centroamericanos no encontraron a Belize un lugar especialmente atractivo para vivir durante el período colonial. Nuestro atractivo como hogar para los centroamericanos aumentó cuando Guatemala y El Salvador fueron devastados por guerras civiles, y aquellos que tenían como objetivo llegar a Estados Unidos descubrieron que éramos un buen lugar desde el cual lanzar intentos de entrada a Estados Unidos. Durante las últimas cuatro décadas, miles de inmigrantes han llegado a Belize, en su mayoría de América Central, y eso ha contribuido en gran medida a casi triplicar nuestra población, de 144.000 en 1980 a un estimado de 400.000 en este momento.

Hay mucho que ganar con una población más grande, y lo más positivo es, por mucho, el aumento de las oportunidades económicas. Con un mercado más grande, los fabricantes de Belize serán más competitivos; el costo de producir bienes será más bajo, las ganancias mayores. Aquellos en el sector de las artes y el entretenimiento también se beneficiarían de un mercado local ampliado para sus productos.

Hay desventajas para una población más grande, y estas

incluyen más presión sobre los recursos ambientales: nuestros bosques, nuestra vida silvestre, nuestra población marina, nuestra calidad del agua; más demanda en las escuelas y hospitales públicos; y el final del mundo relajado que muchos de nosotros apreciamos, el mundo donde todos conocen a todos. Un "costo" del crecimiento impulsado por la inmigración es el cambio en la composición racial, y en Belize el grupo afro ha visto una caída dramática como porcentaje de la población. En 1980, el 39,7% de la población de Belize era criolla/kriol, y en el último censo había descendido al 24,9%; en 1980, el 7% de los beliceños eran garífunas, y eso ha caído al 6,1%.

El cambio en la composición racial de Belize, de afro a mestizo/maya, es inevitable; sólo la tasa de ese cambio es controlable. Somos un país con fuertes raíces caribeñas, pero estamos lejos de las islas del Caribe; tenemos fuertes raíces mestizas/mayas, y estamos cerca de países con millones de personas mestizas/mayas.

Ninguna mayoría racial jamás renunció a su lugar tan mansamente como lo han hecho los afrobeliceños. En los EE. UU., un país que ha estado dominado por los europeos desde que ese grupo masacró y comenzó a desplazar a los indios de las llanuras de América del Norte hace unos doscientos años, el flujo inevitable de pueblos no europeos de países al sur del Río Grande se ha encontrado con grandes resistencia. Aquellos que son genéticamente europeos están usando las boletas electorales, leyes de inmigración rígidas y un muro para proteger a su mayoría.

De gran preocupación para los beliceños es el impacto en la cultura local, que podría ser arrollada si la afluencia de nuevos pueblos es demasiado rápida. Belize es casi el país más singular del mundo. Nuestra cultura comenzó a formarse hace más de 300 años, y se volvió más sabrosa durante los últimos 200 años con la infusión de muchas razas/grupos étnicos de todo el mundo que, para escapar de la guerra y las privaciones económicas, llegaron a este "refugio tranquilo de democracia".

El proceso fue lento, y aunque no tan perfecto como los frijoles bien sazonados cocinados a fuego lento, nuestro crisol de pueblos es algo especial. En gran parte, vamos a las urnas, y el color de la bandera del partido de un candidato es mucho más importante que el color de su piel. En gran parte, hay matrimonios mixtos entre las razas/etnias, aunque los miembros de esos grupos que vinieron después de la primera Gran Guerra no suelen casarse con miembros de los grupos afro.

Para preservar, mejorar lo que tenemos, debemos enfrentar los problemas que nos confrontan. Nuestra incapacidad para abordar adecuadamente la pobreza en algunas áreas, particularmente en partes de la antigua capital, amenaza el bienestar de todos. Una persona que llamó al programa matutino WuB señaló que muchos empleadores en Belize ahora exigen que los solicitantes de empleo sepan inglés y español. Esta es una preocupación (para los beliceños que solo hablan inglés) que no es demasiado difícil de abordar. El idioma del gobierno es el inglés, y ser un país de habla inglesa en esta región no solo es único, es una ventaja. Tenemos que hablar de estas cosas.

Regularizar a los miles que están aquí ilegalmente es lo más humano que se puede hacer, lo beliceño para hacer, pero debemos tener cuidado con "cómo lo hacemos". No debemos esconder la cabeza en la arena. La televisión estadounidense es como la invasión de un ejército extranjero de 10.000, dijo uno de nuestros ex líderes. Si no se gestiona adecuadamente la "regularización", en unos años Belize no se parecerá al país que conocemos hoy. Algún cambio es bueno. Pero no queremos perder nuestro sabor único.

The late Dr. Leroy Taegar's opinion was that the reason that poor people (East Indians, Creoles, Garinagu, etc.) had been able to inhabit the waterfront lands in Belize and Honduras for so long was because the big money did not know how to build hurricane-resistant structures for all those years. When the oligarchy could build massive, powerful structures on the prime real estate on the waterfront, they were moving the poor off these lands, because the waterfront real estate had shot up in value.

I regret that the conversation was a brief one insofar as that particular topic was concerned. Taegar and I moved on to other things. So that, for instance, I have no idea when precisely the oligarchy, both domestic, American, and otherwise, began buying out the waterfront, from Belize to Honduras.

We know that resistance by the Garifuna people to these oligarchical incursions has been met with deadly violence in Honduras. Garifuna leaders have disappeared and have not been heard of since.

In the case of Belize, a Garifuna friend of mine, as long ago as the turn of the century, took me on a ride south of Hopkins. For miles and miles the waterfront had been taken over by strangers and the oligarchy. The result was that Hopkins would not be able

to expand south.

Our newspaper editor published a fascinating post in last week's edition from a Belizean lady who lives in St. Louis. She was explaining how the big people devalue specific real estate with nefarious initiatives, such as guns and drugs and gangs, so that they can buy cheap and then "gentrify" the area.

Two or three decades ago, the late Galento X Neal, who had migrated to New York City in the early 1970s before returning home two or three decades ago, tried to explain to me how Harlem had been "gentrified" and grabbed up by high-flying white people. ("Gentrification" was a concept new to me.) Remember, historically Harlem had been the depressed home of Afro-Americans who lived in the Manhattan borough of New York City. (New York City has five boroughs — Brooklyn, Manhattan, Queens, Bronx, and Staten Island.)

Next to Harlem, Brooklyn was, it seemed to me, the next "blackest" area of New York, but Brooklyn was more middle-class than Harlem, which was definitely roots until Whitey decided he wanted it, or wanted it back. Whatever.

Where am I going with this? Before Hopkins experienced bloody disaster a week and a half ago, the Southside real estate of Belize City had been in the process of being devalued for more than three decades. As the St. Louis lady described in her post, which was with reference to the Hopkins incident, somebody orchestrated the flooding of the Southside with guns, drugs, and gangs. Somebody wants the Southside real estate, but they want it cheap. Somebody wants to "gentrify."

If you ever talk to Clinton Canul Luna, he will describe watching a similar process in an area south of Acapulco (Mexico). Luna had been sent as a child to Acapulco, a famous tourist destination, by his mother to live and work after Hurricane Janet destroyed Corozal Town in 1955. Luna learned so much he ended up managing high-class hotels and later became active in trade union activities before returning to Belize in the early 1990s.

We'll be promised jobs and development on the Southside. This is always the bait. But the jobs and development are bogus. Our people will just become third millennium slaves. The gentrification of the Southside will destroy all the dreams our grandparents and great grandparents had cherished when they began fighting for self-rule in 1950.

Mr. Price did not like the tourism concept. Neither do I. But Mr. Price

is dead, and I consider myself an anachronism. Hence, we are both irrelevant. The people who are relevant are all those Belizeans who have achieved success in the American diaspora and dream of returning home to retire in the Belize they remember with love and nostalgia. But there's a problem. The Belizean diaspora is not organized, and the oligarchies in Guatemala, Honduras, and Belize are.

You need to study the shadowy oligarchy in the south of Belize. After that, you can mix in Amnesty and the International Court of Justice (ICJ) arbitration. For me, these things add up to a Belize which will be different from the one my generation knew.

You may notice, readers, that my writing is not really passionate. I would view this column only as an attempt to record some aspects of our history over the last century, with my focus being on my disappointment with the futility which always seems to accompany recent diaspora efforts to be active in The Jewel.

(As somewhat of an aside, when Samuel Haynes, Jr., visited Belize a couple years ago and was interviewed by Nuri Muhammad on KREM Radio/TV, I spoke to him afterwards and asked him if it was true that his famous father did not fly in airplanes. He said that, to the best of his knowledge, his dad had never flown in an airplane.)

I met the late Samuel Haynes, Sr., in 1965 at a meeting held by Hon. Philip Goldson at the Audubon Ballroom in Manhattan. I was 18 years old and knew nothing about the 1919 Ex-Servicemen's uprising or Mr. Haynes' famous career. As the years went by (Mr. Haynes, Sr., died in 1971), it seemed to me that the late Compton Fairweather, chairman of the British Honduras Freedom Committee, was giving a lot of credit for the formation of the Freedom Committee to Mr. Haynes.

Back in those days, New York City was the leader of Belize's diaspora population. Today, that leadership role belongs to the Los Angeles diaspora community, but they have not been able to achieve the cohesion and strength which the Freedom Committee had.

It may be a reach to say that the Freedom Committee saved Belize from Guatemala. We do know that the Freedom Committee was able to bring pressure on Great Britain, which wanted to sell us out. Today, it is the United States which is selling us out. Only the Los Angeles diaspora can organize Belize people abroad in time to neutralize some of the sellout initiatives I believe I see taking place. For what it's worth, that is my thesis today — Wednesday, August 10, 2022.

como armas, drogas y pandillas, para poder comprar barato y luego "gentrificar" el área.

Hace dos o tres décadas, el difunto Galento X Neal, que emigró a la ciudad de Nueva York a principios de la década de 1970 antes de regresar a casa hace dos o tres décadas, trató de explicarme cómo Harlem había sido "gentrificado" y absorbido por la gente blanca pretenciosa. ("La gentrificación" era un concepto nuevo para mí). Recuerden, históricamente, Harlem había sido el hogar deprimido de los afroamericanos que vivían en el distrito de Manhattan de la ciudad de Nueva York. Después de Harlem, Brooklyn era, me parecía, la siguiente zona "más negra" de Nueva York, pero Brooklyn era más de clase media que Harlem, que definitivamente era de la base hasta que el güero decidió que lo quería, o que lo quería de vuelta. Lo que sea.

¿Adónde voy con esto? Antes de que Hopkins experimentara un desastre sangriento hace una semana y media, las propiedades inmobiliarias de la Zona Sur de la Ciudad de Belize habían estado en proceso de ser devaluadas durante más de tres décadas. Como describió la dama de St. Louis en su publicación, que se refería al incidente de Hopkins, alguien orquestó la inundación de la Zona Sur con armas, drogas y pandillas. Alguien quiere las propiedades inmobiliarias de la Zona Sur, pero las quieren baratas. Alguien quiere "gentrificar".

## The Belize the lawyers made

I understand the disappointment of many when our GoBs have applied states of emergency when the police's efforts can't stay the violence in the land. The disappointment is greatest for those who have many friends and family in areas where the brutal measure is applied. Yes, I listened to my nephews, Mose on Krem WuB and Cordel on the television evening news. For them it must be especially difficult, because they know that had our postindependence governments done the right things, which include some of the excellent initiatives that Kremandala has been pushing for decades, there would be hope where there is despair.

Many that live in these areas are victims of terrible injustice. They watched totally greedy elements of the PUP and the UDP make off with the country's assets so they and their children could drive Floyd Mayweathertype bling rides in the rich streets of the USA, yes, hobnob with the rich and famous in Miami and Los Angeles. For Kremandala, that organization's sports initiatives that would have created job opportunities were stymied, and their efforts to have African and Maya history included in the curriculum of our schools so that our youth would have greater knowledge of their roots, were

The disdain for sports is incredible.

There are few ball fields and courts in Belize City, and the deficiency is particularly pronounced in the oldest parts of the city. The present government is celebrating its efforts to rehabilitate the old Berger Field on Vernon Street, and kudos are deserving, but they need to explain how they allowed a gas station to be built on a piece of land nearby. There wasn't any need for a gas station there, because there is one just a couple blocks away. That parcel should have been acquired and used to build a basketball/volleyball court.

The biggest "donor" to our doom is our ineffective justice system. I've told you that these young men commit violent crimes, and the guilt is on the nation. They are victims of a system that thinks it can be soft, victims of a Belize that was made by Belizean lawyers. The feeble justice system has led to a Hatfield/McCoy revenge story playing out in our country.

The state is obligated to deliver justice. It hasn't. The research has not been done to show precisely when our country stopped bringing people who commit murder to justice. We know it began sometime after we became a self-governing country.

In our country which our lawyers made, one of these lawyers, speaking in defense of the pathetic justice system, said that Belizeans are guilty of hypocrisy when they clamor for harsh penalties for those who commit violent crimes, because when a loved one of theirs is accused of a serious misdeed, they seek out the best lawyer they can afford, to get them off. Indeed, many people get soft when the one going to the gallows or facing life imprisonment is their own. But there is no problem there, because we can afford for individuals to break down. In fact, that is expected. What we absolutely cannot afford is for the state to be soft too. And Belize is mashmelo soft. That's the main root of our violence problem.

We are where we are now: a people in despair. It's tough; our young men have many reasons to be angry, but they cannot let their anger lead them to commit violent acts. The best laid plans are wasted if there is violence in the neighborhood. It's no chicken and egg story here. Development won't come in a land where there is violence.

This violence in our country, there is poverty and lack of education and poor wealth distribution at its root, but the biggest cause of violence is a justice system that's a miserable failure.

### Facts about Belize going to the ICJ

It's a fact that the Webster's Proposals, the Heads of Agreement and the Ramphal/Reichler Proposals did not call for changing the Hondo to the Sarstoon and the Benque Viejo to Halfmoon borders of our country. The sinister Webster's sought to create a situation where we would have needed to get our independence from both Great Britain and Guatemala.

Looking at the last proposal, the Ramphal/Reichler, the disappointing Guatemalans made it plain they wouldn't entertain that, because there was no offer of land.

The deal for Belize to go to the ICJ was "signed, sealed and delivered" in December 2008, when we signed on to the *compromis*. What Belizeans agreed to in May 2019, 55% to 45% if I remember correctly, was *fait accompli*, a done deal 10 years previously. There are Belizeans who think we could have said no. Oy!

Ambassador Martinez explained the decision best. Taking a little liberty with his words, he said we are giving Guatemala an honorable discharge from their ugly claim. Where I agree with the

ICJ naysayers is that we prostrated ourselves. Aiyayai, no country has ever put up its entire territory for adjudication! Daam yes our pride is wounded. But I don't know what it gains us to hate Guatemala for what she made us do.

Guatemala has no land to get. They have no rights here. There are some good neighbor things that we could have agreed on without their mad claim. Hopefully when the court dispenses the sense, those over there who are bullies will stop being covetous.

## From too much teaching to Colombia president's inaugural address


I don't know why this women's caucus made such a long speech and felt they had to demand an apology. All they had to say was: we don't like those words.



## Moises Cal steps away from pending PSC chairman appointment



BELIZE CITY, Wed. Aug. 10, 2022

Moises Cal, the former diplomat and PUP standard bearer who was accused of possible money laundering after being found with over a million U.S. dollars (undeclared) in his luggage at a

Panama airport in 2007, has quietly withdrawn from a process that was underway to possibly appoint him to be the new chairman of the Public Services Commission. It was the Prime Minister himself who had recommended Cal and who had publicly defended Cal in the face of public criticism that followed reports of the possible appointment.

In reference to Cal (who was in possession of a diplomatic passport when detained in Panama), Prime Minister Briceño told reporters, "... We all make mistakes in life, and you can reform your life. Whether Mr. Cal did or did not do it—it was allegations. It has never been proven in court. He was never arrested..."

The United Democratic Party, however, had vehemently opposed the consideration of Cal as a candidate for such a critical post. "The place for the disgraced former diplomat Moises Cal

is not the chair of the Public Service Commission but perhaps a chair in jail," a UDP press release issued in July had said.

The possible appointment was also opposed by the president of the Public Service Union, Dean Flowers, who had told the media that the membership of the union would be polled to determine the collective stance of those members in regard to Cal's possible chairmanship of the PSC.

After it became known—via a senior government source—that Cal had quietly withdrawn his name last week from consideration for the post, Flowers stated that Cal's decision to step aside, whether it was a personal one or prompted by the government, is good news.

"The issue of Mr. Cal is not a personal one. It is one based on principles," Flowers said. He further pointed out that the law demands that persons appointed to such offices be without reproach and of good character.

Cal, however, became, in the eyes of many, a disgraced public figure after the incident in Panama. In 2007, Moises Cal allegedly flew to Panama with one million U.S. dollars in undeclared cash in his luggage and a diplomatic passport, even though he had left the Ministry of Foreign Affairs to be a PUP standard bearer for Belmopan. It is alleged that Cal, after being detained, paid over \$100,000 in bribes to Panamanian officials so that he could leave the country before being questioned by police. Prior to his detainment, he had reportedly come under scrutiny by Panamanian authorities after reportedly making 14 trips to that country in a 3month period. He has never publicly addressed the allegations against him.

Since then, despite keeping a lowprofile, he has continued to be involved in the affairs of the People's United Party, and according to Prime Minister Briceño, has also done some charitable acts in the community.

"He, I believe, has been an active citizen in Belize, in Belmopan, and has been, I believe, a good citizen. He is always assisting people, and—many people don't know this, but—helping poor people. For Christmas he helps several families and children with food. So, I believe he has the qualities to be able to be the Chair of the Public Service Commission," the Prime Minister had told local media after the public became aware of the possible appointment of Cal as PSC chairman.

As a previous issue of AMANDALA had reported, before his fall from grace, Moises Cal served as an ambassador for the Minister of Foreign Affairs and Foreign Trade and was Belize's representative in the Central American Integration System (SICA) during the Musa administration. He also served as an ambassador to Nicaragua and Costa Rica for Belize before resigning from his ambassadorial roles to vie for a seat as area representative of the Belmopan division.

With Cal's withdrawal from consideration for the post, three persons recommended by the Public Service Union could possibly be considered for the post, which became vacant after the retirement of the previous PSC chairman, Charles Gibson, in June. Those three persons, who have all been public servants, are Marilyn Ordonez, David Gibson and Sandra Hall. Notably, there appears to be a pressing need for someone to assume the PSC chairmanship, since, according to PSU chairman Dean Flowers, there are disciplinary matters, as well as matters related to retirement benefits and issues involving promotion and appointments that need to be addressed promptly.

## Killer of PC Marvin Locke pleads guilty

BELIZE CITY, Wed. Aug. 10, 2022

It was a brazen act that stunned the public—the fatal stabbing of a police constable, Marvin Locke, 49, outside the Racoon Street Police Station in 2017. The man who did it—52-year-old Honduran national, Marcial Toledo—had waited at the station for Locke to appear before killing the officer, and this week, on Tuesday, August 9, he pleaded guilty to murder before Supreme Court Justice Susan Lamb.

In March 2017, Toledo had apparently arrived home intoxicated and claimed he had been told that his wife had been seen along with PC Locke that day. A few hours later, after telling his wife what he allegedly heard, he went to the Racoon Street Police Station and sat there until Locke appeared (reportedly when PC Locke was coming off his shift), and the two men proceeded to talk.

They then went outside the station to continue their conversation, and it was at that point that Toledo took out a knife and stabbed Locke 5 times, including a stab to the chest that would later cause the officer's death.

Locke's colleagues quickly intervened in an attempt to save their fellow officer's life, but Toledo then tried to stab one of them. This prompted another officer to hit Toledo on the head with a cement block.

PC Locke succumbed to his injuries around 5:15 p.m. that evening, just a few hours later.

Since the incident almost 5 years ago, Toledo has been remanded at the Belize Central Prison

The case management for his trial began last Friday, and it was reportedly at that point that Toledo indicated to the court that he was considering entering a guilty plea for murder. He formally did so on Tuesday and must return to court on September 23 for his sentence hearing.

## Salvadoran national sentenced to 15 years for rape of child, 5

BELIZE CITY, Wed. Aug. 10, 2022 Salvadoran national, Bairo Gomez, who in June pleaded guilty to raping a 5-year-old child in October of 2018, was sentenced this week to 15 years in prison.

On June 29 of this year, Gomez pleaded guilty to the crime, which spared the child the trauma of recounting the event at a trial. He had been denied bail after being deemed a possible flight risk due to his nationality and was remanded to the Belize Central Prison.

Gomez begged for leniency from the court and apologized for his actions.

Justice Susan Lamb took into consideration the years Gomez has served while on remand, and thus he will only serve an additional 11 years and 2 months of his 15-year sentence, which is the minimum mandatory sentence that can be handed down by law for the offense of rape of a child.

## "RTA" victim in OW likely beaten to death

ORANGE WALK, Mon. Aug. 8, 2022
When the body of an Orange Walk
man—47-year-old Israel Chable—was
found on the side of the road in San
Jose Village in the early hours of
Saturday morning, August 6, it was
intially presumed that he had been the
victim of a hit-and-run incident. But
details that have been emerging since
the discovery of the body seem to be
pointing to another cause of death.

To begin with, the injuries seen on the body, according to the Commanding Officer of the Crimes Investigation Branch (CIB), Alfonso Aban, were not the kind of injuries typically sustained by the victim of a road traffic accident. Chable, in fact, according to what his grieving sister, Urbelina Escaragga, told reporters, appeared to have been bludgeoned to death. Escaragga even made reference

to rumors circulating in the village that there was a misunderstanding over money that might have led to the murder.

Escarraga related to local reporters in Spanish the rumors she had heard in the village—rumors that Chable was killed over money that was owed to him by a friend.

'There are many rumors about what happened to him. He works in Ladyville and often comes home late, but that day he came home early, at around 6 o'clock. Supposedly, some of the workers had received letters that they have been dismissed, but he was not dismissed. He says that one of his friends was laid off, but the guy owed him money, so he went to San Jose to collect [it] from his friend... When we saw him, he was sitting right leaning against his bicycle, and his slippers were in front of him. We've been hearing a lot of rumors that his friend never paid him, and maybe they did something [to him] while he was coming home. We were told that he was also at a bar, and they followed him home and hurt him. We think that it is an injustice, because the autopsy revealed that he had an injury to his mouth and head that looks like a machete wound, and there is no way that someone can die from falling off a bicycle. We just want answers, and we want someone to pay for what has happened," she said (in Spanish).

Chable, after being found on the road, had been taken to the Northern Regional Hospital, where he was pronounced dead on arrival by medical officials.

While police are currently uncertain about the cause of Chable's death, they have confirmed that a man who was found on Saturday night, August 6, on the street in Corozal was the victim of a hit-and-run accident, but they do not yet know that person's identity. At about 10:00 that night, they saw the unidentified man suffering from various injuries to his body in the middle of the street in downtown Corozal near St. Francis Xavier Credit Union.

According to police reports, the man had been walking on 5<sup>th</sup> Avenue in Corozal Towm in a north to south direction, and when he reached an intersection at 2<sup>nd</sup> Street, a black car hit him from behind and left the scene.

The unidentified man was taken to the Corozal Community Hospital, where he received treatment but reportedly passed away.

Police are investigating.

## All stakeholders should get a place on the PCC—an opportunity Belizeans didn't get in '81

### HISTORY OF THE BELIZE CONSTITUTION

In the general election of November 1979, the People's United Party (PUP) ran on a platform that included a push for independence. The PUP's opponent, the United Democratic Party (UDP), favored delaying independence until the territorial dispute with Guatemala was resolved. Although the PUP won only 52 percent of the vote, it carried thirteen of the eighteen seats in the House of Representatives and thus received a mandate for the preparation of an independence constitution. On January 31, 1981, the government issued the White Paper on the Proposed Terms for the Independence of Belize. The National

Assembly appointed a joint select committee to consider the proposed terms and to solicit input from all organizations in the country, but that was not done.

The PUP accepted the widespread support for a monarchical form of government, based on the British parliamentary system, but also suggested a number of amendments to the proposal. The House of Representatives adopted the committee's report on March 27, 1981. The Belize Constitutional Conference was then held at Marlborough House, London, between April 6 and April 14, 1981. Although invited to participate, the leader of the opposition, the United Democratic Party, in the House of Representatives, Dr. Theodore Aranda, and other representatives of the UDP declined to attend. Participating in the meeting at Marlborough House were only the Belizean delegation, headed by C.L.B. Rogers, Deputy Premier of Belize, and the British delegation, headed by Nicholas Ridley, Secretary of State for Foreign and Commonwealth Affairs, along with their respective experts. The report issued by the Belize Constitutional Conference set out the structure and content for the independence and constitution of Belize.

The British Parliament legislated the final steps leading to Belizean independence in the Belize Act 1981, which received royal assent on July 28, 1981. The act granted Queen Elizabeth II the power to provide Belize an independence constitution and to set a date for Belizean independence by an Order in Council. The act also recognized Belize's self-governing status, with provisions for its right to amend the so-called Constitution Order. The Queen issued the order on July 31st 1981. In Belize, the National Assembly passed the new constitution, the governor gave his assent on September 20, 1981, and Belize became independent the following day.

#### **CRITIQUE**

When Premier George Price and his People's United Party were negotiating the independence of Belize with Great Britain's prime minister Margaret Thatcher and secretary of foreign affairs Nicholas Ridley, the British drafted a document entitled "HEADS OF AGREEMENT" to settle the Guatemalan claim to our country as a pretext for our independence.

The People's United Party (PUP) accepted the document, but the leader of the opposition (United Democratic Party) (UDP), Dr. Theodore Aranda, his party and a majority of the citizens of Belize, were all against these proposals. Riots broke out throughout the entire country. In this document there were provisions to give our country to Guatemala and to deny us as citizens of Belize our rights to our territory. Attached below is a copy of those proposals in the Heads Of Agreement:

The United Kingdom and Guatemala shall recognize the independent State of Belize as an integral part of Central America, and respect its sovereignty and territorial integrity in accordance with its existing and traditional frontiers subject, in the case of Guatemala, to the completion of the treaty or treaties necessary to give effect to these Heads of Agreement.
- 2. Guatemala shall be accorded such territorial seas as shall ensure permanent and unimpeded access to the high seas, together with rights over the seabed thereunder.
- 3. Guatemala shall have the use and enjoyment of the Ranguana and

## **MOHW hosts Workplace Wellness Forum**

A Workplace Wellness Forum held this week by the Ministry of Health & Wellness focused on addressing the importance of physical well-being as well as mental health—something which the Director of Public Health & Wellness, Dr. Melissa Diaz Musa, says has become a priority in many workplaces across the globe.

According to Robyn Daly, a nutritionist in the Ministry of Health & Wellness, the main objective of Tuesday's forum was to help administrative officers identify wellness strategies that they can begin to incorporate in their workplaces.

"Many staff have challenges—it could be mental health, it could be stress, it could be eating challenges, whatever it may be, but we want to see more being done within the workplace," she said.

The Ministry's heightened focus on

wellness includes promoting health literacy, improving health education, and reaching out to the population to ensure that they have healthy and stress-free working environments, especially in light of the fact that many persons spend the vast majority of their days at the workplace.

Having a stress-free working environment, says the Director of Health & Wellness, includes ensuring that one's workplace allows for flexibility when it comes to "getting up and moving around", promoting healthy habits, and "ensuring that the place you spend the most of your working day is a place that promotes and enhances that preventative care and that wellness function."

The World Health Organization (WHO) has reported that, in the first year of the COVID-19 pandemic alone, the global prevalence of anxiety and depression increased by a "massive" 25%. In the population of adults aged 18-29, the effects were even worse.




This, says the WHO, should have been a wake-up call to all countries to step up their mental health services and support.

"COVID has caused significant stress in populations globally, and we have seen that as well in Belize, even among healthcare workers, so it's important that employers, supervisors, create a wellness space at your workplace," said Dr. Diaz Musa.

The Workplace Wellness Forum also focused on promoting preventative care—something just as important as therapeutic care.

## Troy Banner remanded to prison for harming newborn



BELMOPAN, Tues. Aug. 9, 2022

In this Tuesday's issue of AMANDALA, we reported that Camalote resident Troy Banner had been detained and charged for causing injuries to his 15-day-old baby, and we can now confirm that Banner has been remanded to the Belize Central Prison for committing grievous harm, cruelty to a child, and wounding.

Banner appeared unrepresented on Tuesday in the Belmopan Magistrate's Court, where he was denied bail and remanded until September 13.

The two-week-old infant had been rushed to the hospital over the weekend after suffering a fractured arm, which Banner claimed was caused by the baby falling from a bed. Bruises were also visible on the child's face and back.



This is the third known instance of alleged child abuse by Banner, who, in 2019, was charged with manslaughter for the death of his 2-month-old son. He has also been publicly accused of child abuse by his ex-common-law wife, who is also the mother of his eldest son.

## Statement by H.E. David Kuan-Chou Chien, Ambassador of Republic of

August 10, 2022

The US congressional delegation, led by House Speaker Nancy Pelosi, recently visited Taiwan from August 2<sup>nd</sup> to 3<sup>rd</sup>. During her visit, Speaker Pelosi voiced strong support for Taiwan's democracy and raised the profile of Taiwan internationally. Right after Speaker Pelosi's departure, however, China conducted large-scale military exercises and launched ballistic missiles in the waters surrounding Taiwan. We strongly condemn China's extremely irresponsible behavior.

China's targeted, large-scale military exercises are serious provocation. By using Speaker Pelosi's visit to Taiwan as a pretext, China pursues its true intentions in a number of ways. Firstly, China has

threatened Taiwan militarily for years, and it continues to upgrade its efforts. China aims to now influence the international community's freedom of navigation in the waters and airspace of the Taiwan Strait by denying that it is an international waterway. On this occasion, China tries to routinize its actions in an attempt to disrupt the long-term status quo across the Taiwan Strait. Secondly, China has used the drills in its military play-book to prepare for the invasion of Taiwan. It conducts not only military exercises and missile launches, but also cyberattacks, disinformation, and economic coercion, in an attempt to weaken public morale in Taiwan. Thirdly, in terms of the range of its missile tests, China is clearly trying to deter other countries from interfering in its attempt to invade Taiwan. In other words, China's real intention behind these military exercises is to alter the status quo in the Taiwan Strait and the entire region. This has already brought significantly unstable elements into the mix, threatening the regional and global

In facing China's military exercises, Taiwan's people, society, military and government have displayed resilience and confidence, and remained calm. Despite China's continued attempts to intimidate Taiwan, the Taiwanese people will not panic and are resolved to not be defeated. Taiwan will continue to staunchly uphold its free and democratic way of life. Acting upon its beliefs with the same determination, Taiwan will continue to defend its sovereignty, freedom, democracy, and prosperity. We also call on the international community to support Taiwan in unison and put a stop to China's irresponsible threats and ambitious expansion, and jointly safeguard the value of freedom and democracy, to maintain a free, stable and prosperous world.

We would like to extend our appreciation to the Government of Belize, led by Hon. John Briceño, Prime Minister, for the prompt support and reaffirming to strengthen the strong and close bilateral relationship between Belize and Taiwan. As Belize and Taiwan share the values of democracy, freedom and human rights, and have enjoyed a rock-solid friendship and partnership for the past 33 years, Taiwan will continue to work together with Belize to consolidate our long-lasting partnership.

Sapodilla cays, and rights in those areas of the sea adjacent to the cays, as may be

- 4. Guatemala shall be entitled to free port facilities in Belize City and Punta
- 5. The road from Belize City to the Guatemalan frontier shall be improved; a road from Punta Gorda to the Guatemalan frontier shall be completed. Guatemala shall have freedom of transit on these roads.
- 6. Belize shall facilitate the construction of oil pipelines between Guatemala and Belize City, Dangriga and Punta Gorda.
- 7. In areas to be agreed an agreement shall be concluded between Belize and Guatemala for purposes concerned with the control of pollution, navigation and fishing.
- 8. There shall be areas of the seabed and the continental shelf to be agreed for the joint exploration and exploitation of

minerals and hydrocarbons.

- 9. Belize and Guatemala shall agree upon certain developmental projects of mutual benefit.
- 10. Belize shall be entitled to any free port facilities in Guatemala to match similar facilities provided to Guatemala in Belize.
- 11. Belize and Guatemala shall sign a treaty of cooperation in matters of security of mutual concern, and neither shall permit its territory to be used to *support subversion against the other.*
- 12. Except as foreseen in these Heads of Agreement, nothing in these provisions shall prejudice any rights or interests of Belize or of the Belizean people.
- 13. The United Kingdom and Guatemala shall enter into agreements designed to re-establish full and normal relations between them.
- 14. The United Kingdom and Guatemala shall take the necessary action to sponsor the membership of Belize in the United Nations, the Organization of

American States, Central American organizations and other international organizations.

15. A Joint Commission shall be established between Belize, Guatemala and the United Kingdom to work out details to give effect to the above provisions. It will prepare a treaty or treaties for signature by the Signatories to these Heads of Agreement.

16. The controversy between the United Kingdom and Guatemala over the territory of Belize shall therefore be honorably and finally terminated.

Signed at London, the 11th day of March 1981, in the English and the Spanish language, both texts being equally authentic.

In looking at these proposals, no Belizean citizen in their right mind would agree to these proposals, and the Belize government knew that. In 1968 the American government appointed an American diplomat by the name of Bethuel M. Webster to negotiate the dispute

between Guatemala and Belize, and he submitted a similar document known as the "WEBSTER PROPOSALS". There is little or no difference between these two documents, and the intention of the British was the same, which was to give Belize to Guatemala to settle the dispute. A British diplomat later said that the proposals were used only as a matter of political expediency.

#### THE WEBSTER PROPOSALS

Negotiations between the United Kingdom and Guatemala in search of a solution to Guatemala's claim to Belize were bilateral negotiations until 1962. It was a significant historical moment, because in that year delegates from Belize were permitted for the first time to participate in the Anglo-Guatemalan negotiations which took place in San Juan, Puerto Rico, with the U.K. and Guatemala as principals.

## Bill Russell, who transformed pro basketball, dies at 88

A Hall of Famer who led the Celtics to 11 championships, he was "the single most devastating force in the history of the game," his coach Red Auerbach said.

Even before the opening tipoff at Boston Celtics games, Bill Russell evoked domination. Other players ran onto the court for their introductions, but he walked on, slightly stooped.

"I'd look at everybody disdainfully, like a sleepy dragon who can't be bothered to scare off another wouldbe hero," he recalled. "I wanted my look to say, 'Hey, the king's here tonight."

Russell's awesome rebounding triggered a Celtic fast break that overwhelmed the rest of the N.B.A. His quickness and his uncanny ability to block shots transformed the center position, once a spot for slow and hulking types, and changed the face of pro basketball.

Russell, who propelled the Celtics to 11 N . B . A . championships, the final two when he became the first Black head coach in a major

American sports league, died on Sunday. He was 88.

His death was announced by his family, who did not say where he died.

When Russell was elected to the Basketball Hall of Fame in 1975, Red Auerbach, who orchestrated his arrival as a Celtic and coached him on nine

championship teams, called him "the single most devastating force in the history of the game."

He was not alone in that view: In a 1980 poll of basketball writers (long before Michael Jordan and LeBron James entered the scene), Russell was voted nothing less than the greatest player in N.B.A. history.

Former Senator Bill Bradley, who faced Russell with the Knicks in the 1960s, viewed him as "the smartest player ever to play the game and the epitome of a team leader."

"At his core, Russell knew that he was different from other players—that he was an innovator and that his very identity depended on dominating the game," Bradley wrote in reviewing Russell's remembrances of Auerbach in "Red and Me: My Coach, My Lifelong Friend" (2009) for The New York Times.

In the decades that followed Russell's retirement in 1969, when flashy moves delighted fans and team play was often an afterthought, his stature was burnished even more, remembered for his ability to enhance the talents of his teammates even as he dominated the action, and to do it without bravado: He disdained dunking or gesturing to celebrate his feats.

In those later years, his signature goatee now turned white, Russell reappeared on the court at springtime, presenting the most valuable player of the N.B.A. championship series with the trophy named for him in 2009.

Russell was remembered as well for his visibility on civil rights issues.

He took part in the 1963 March on Washington for Jobs and Freedom and was seated in the front row of the crowd to hear the Rev. Dr. Martin Luther King Jr. deliver his "I Have a Dream" speech. He went to Mississippi after the civil rights activist Medgar Evers was murdered and worked with Evers's brother, Charles, to open an integrated basketball camp in Jackson. He was among a group of prominent Black athletes who supported Muhammad Ali when Ali refused induction into the armed forces during the Vietnam War.

President Barack Obama awarded Russell the Presidential Medal of Freedom, the nation's highest civilian



There was a time when Belizeans of African descent were the clear majority in this 8,867. This was under British rule, and there was heavy law-and-order in the settlement/colony.

Since Belize achieved political independence, law-and-order has broken down, defence attorneys rule, and our Jewel has become wild, especially at night and especially on weekends.

Wilfred "Sedi" Elrington was Foreign Minister in the Dean Barrow UDP Cabinets from February 2008 to November 2020. But if you read his columns in THE REPORTER, it's as if he were talking about total strangers when he discusses such as his former Cabinet colleagues.

Here is what Mr. Elrington wrote on Friday: "It is patently unjust, scandalous, shameful and disgraceful that politicians who are the servants of these said people, and their relatives and cronies, are enriched to the point where they become millionaires in only a few five-year terms in office while the constituents who elected them to office and whose interest they swore to serve, wallow in poverty and misery in hellish shelters for in excess of forty continuous years."

That very same Friday the newspaper was published, Sedi's older brother, Hubert, who was a Cabinet minister in the UDP governments of 1984-1989 and 1993-1998, told KREM Radio's Marisol Amaya, apparently with reference to the three UDP governments in which Sedi served from 2008 to 2020, "They are a bunch of crooks."

Both Hubert and Sedi are attorneys, and the Elrington family success must be given respect, because they are not brown Belizeans who benefited from any kind of white paternity. As Afro Belizeans, they are the real deal, but it doesn't matter to me what kind of Belizean you are: if you are exonerating yourself from Cabinet issues when you were sitting at the same Cabinet table,

then you must be taken to task.

Before I continue, let me tell you that a source this week told me that Sedi had put the Samuel Haynes Institute (corner Mahogany and Oleander Streets) into a trust, so that he could remain in charge after the PUP ousted the UDP in 2020. He had funded that school immediately after being elected as Pickstock area representative in 2008 with \$200,000 Lord Michael Ashcroft handed him. We will be watching to see what his position is on Waterloo.

I am in possession of a copy of a check made out to Hubert Eric Elrington for \$10,000 on June 7, 2019 from Pickstock Development Association funds. Hubert is not from Sedi's Pickstock constituency. He lives in Caribbean Shores. So this was a questionable transaction. If anyone asked, the story would have been that the check was for Hubert to supply plywood.

When I was appointed to the Senate by then Governor-General, the late Dame Minita Gordon, my term of office was from 1993 to 1998. The UDP's Leader of Government Business in the Senate during that period was Sedi Elrington.

In my speech on one of the budgets presented by Dr. Manuel Esquivel's administration during that period, I brought up the matter of African and Mayan history, which I had been calling for from late 1969. Sedi's reply was: "The people don't want it."

Well, no institution has done more than Kremandala to promote African and Mayan history, and no one has created more jobs in the old capital ghetto than Kremandala. Straight like that. Sedi is a multimillionaire who hoards his money: he does not create jobs. I don't believe he is in a position to preach to anyone about the Afro-Belizean crisis in The Jewel.

I give respect to his personal success, but in Sedi Elrington's case, I would say: talk is cheap.

## Caribbean Youth Fellowship participants discuss improving education opportunities

The first cohort of youth to participate in the Caribbean Youth Fellowship Program led a discussion on possible policies that can be implemented to improve education opportunities in Belize

BELIZE CITY, Thurs. Aug. 11, 2022

Today at the Belize Best Western Biltmore Plaza, the International Republican Institute (IRI), through the Caribbean Youth Fellowship (CYF), held a roundtable discussion with a number of young Belizeans on the possibilities of advancing education opportunities for the country's youth population through recently developed policy proposals. The discussions were spearheaded by the first cohort of participants in the recently concluded CYF Program—a program that seeks to increase the political engagement of young leaders in the Caribbean.

Prior to the discussions, those individuals presented the two policy frameworks that they created during the length of the CYF program—one that

seeks to achieve equitable secondary education access and another that tackles the limited financial opportunities for access to tertiary education in Belize—to a number of officials in attendance, including representatives from Belize's financial institutions and the Ministry of Education, Culture, Science & Technology, who gave constructive feedback afterward.

Michel Fritz II, leader of one of the two groups that took part in the CYF program, presented a policy framework for secondary education reform. Lack of access to equitable secondary education, said Fritz, is an inalienable barrier for students across Belize, mainly due to a lack of financial resources, a lack of social support services, and a lack of legislation that ensures children remain in school.

"Education is the key to advancing the country, so if we are not adequately

educating or do not have equitable access, there remain barriers to an increased quality of life," he said.

The first group of CYF participants made several suggestions for addressing this, including increasing the mandatory age for being in school—which the Government recently accomplished—and increasing the minimum employment age from 14 to 16, which would allow children to complete their secondary level of schooling.

Having bipartisan agreements, added Fritz, is one way to ensure that these new policies remain in place, even with changes in government.

Amillin Mendez was the leader of the second group of participants, which gave a presentation on addressing the limited financing available to persons seeking tertiary education.

Pursuing a Bachelor's degree, said

Mendez, costs most Belizeans a little bit over \$24,000 in tuition alone. And while several financial institutions, like DFC, provide accommodative tertiary education funding, interest rates can range from 7.5% to 14%, and funding criteria is often quite burdensome.

"So how do we effect effective changes? Let us start by finding solutions for sustainable financing. Let us study the root problems, examine the sources of the problems, magnify the indicators, and be keen on the consequences," said Mendez.

"Let us open the conversation on where tertiary education fits in terms of a national strategy for the government," she added

As we mentioned, the presenters received constructive feedback from those in attendance at the forum, including the Minister of State in the Ministry of Education, Culture, Science & Technology, Hon. Dr. Louis Zabaneh.

Natalie Ewing Goff, the General Manager at DFC, and Alvaro Alamina, the General Manager of the National Bank of Belize, also gave their thoughts, acknowledging that, when it comes to providing better financial opportunities to those seeking tertiary education, there is still some work to be done. Both institutions committed to looking into what can be done to improve those opportunities.

This is the first time that a forum of this nature has been held in Belize. Marcelo Salas, the Regional Program Director for the Caribbean at IRI, spoke with the media at the end of the presentations on the purpose of having such programs.

"We saw that [the Caribbean] is a region that's growing very fast economically but also in its stability in political development, and the stabilization of democracy. You know, these are very young democracies that are full of energy, and we thought that it would be important to support the growth and development," he said.

"We started our initiatives supporting youth—young leaders—because we see that the present and the future of these countries are in the hands of these youths. And the more that we can do to support them to develop their skills, the better it will be for the countries in the Caribbean," he added.

on curative care, hospital care, but what we've got to do is also refocus on primary care and prevention and promote wellness. So, wellness doesn't necessarily mean the absence of disease, but having that mental and physical wellness and well-being," said Dr. Melissa Diaz Musa.

The Ministry is hoping to push people to focus on the aspects of wellness that have been neglected since the start of the COVID-19 pandemic, such as physical screenings for cancer. According to Dr. Diaz Musa, cervical and breast cancer remain two of the leading causes of death in women, along with prostate cancer in men.







## **Pharmacy Express withdraws SSB Ioan application**

Ministry—specifically involving pharmaceutical suppliers within the country. The four pharmacies where the search took place are owned by Pharmacy Express—a company that has been in the spotlight for the past few weeks after it was announced that the Social Security Board might be lending the company \$7 million to cover costs related to "refinancing and inventory purchases". It was an announcement that prompted the Ministry of Health to issue a press release in which it cited concerns about the company.

Those concerns, however, had just been words on paper until yesterday afternoon, August 10, when ministry personnel swooped in to do an inspection of Pharmacy Save, Pharmacy Express, Village Discount Pharmacy, and RX. The raid was reportedly put into motion after a senior drug inspector voiced suspicions that the pharmacies have been providing controlled drugs to tourists without a prescription or the appropriate license. The inspection started as early as 7:00 o'clock on Wednesday morning, some reports say, and was initially carried out by ministry officials, who soon had to call on the police for help after some pushback from the company owners and store managers, who claimed that the Health Ministry had no authority to conduct such a search.

After police officers with warrants entered the establishment, a large amount of controlled drugs was confiscated from the location, some of which were taken out of drawers that had been locked. (Calls had been reportedly been made to the owners in an attempt to get them to go to the premises to open the drawers, but they seemingly did not comply with those requests.) But in the middle of the operation, when drug seizures had been made at only two of the four pharmacies, the raid was abruptly halted—allegedly after a call from some higher-up within GoB. That halt to the raid reportedly took place around 4:00 in the evening.

And all indications are that there will be further fallout as a result of the raid, which the owners of the company—Angela and Julius Zabaneh—and their attorney, Senior Counsel Godfrey Smith, represented by Hector Guerra, are classifying as illegal. The attorneys told *7News* that the police were preventing workers from leaving the stores and managers from executing a closure order handed down by the Health Minister to the company. Smith further told *7News* that the government can "expect lawsuits". As mentioned, the owners had reportedly cited the illegality of the raid at

an earlier point, when Ministry of Health personnel had started their inspection, and had noted that no search warrant was provided. As reported, however, police later arrived with warrants to continue the search and to open drawers that were locked.

Inside those locked drawers, sources say, was a large quantity of controlled drugs that, under the Misuse of Drugs Act, cannot be legally sold without a permit. Those drugs were reportedly taken to the Central Health Region for storage and documentation.

In its Public Notice of Investment, the Social Security Board had stated that the \$7 million loan which it might have granted to Pharmacy Express Limited is for "refinancing and inventory purchases." Following public condemnation of the possible loan, the company had issued a release in which it stated, "Our business caters strictly to foreign clientele who arrive on cruise ships. Noteworthy is that our products have never and will never be distributed in the local market."

After public expressions of concern about the loan in late July, the Ministry of Health and Wellness had noted possible licensing issues with the company. Pharmacy Express Limited (PEL), which is reportedly headquartered at Mile 5 on the George Price Highway, reportedly shares a building with Medigen International Limited, a company believed to be its affiliate, and which, as a recent AMANDALA article had reported, "had been awarded tender for the importation of Pharmaceutical and Related Medical Supplies shortly after appearing on the list of licensed pharmaceutical establishments" in 2021. It had been reported by 7News, however, that the Ministry of Health "has had issues with Medigen ... which won a number of tenders last year—but with whom they have had supply problems."

This most recent controversy has thus brought to the fore a cluster of other public concerns related to this company, pharmaceutical supply processes, and the Ministry of Health.

These concerns stem from moves that took place within the Health Ministry as far back as August of 2021. At that time, the Ministry was headed by Hon. Michel Chebat, and several months would still pass before the shakeup in the Ministry that led to Hon. Kevin Bernard becoming Minister of Health. At that time, the public became aware of the awarding of pharmaceutical supply tenders in August, following the issuance of a call for tenders (for submission in March) in February 2021. The announcement of the awards in August was, as stated by *7News* at the time, "unprecedented in terms of lateness".

What was more notable, however, is that, while well-known, large-scale importers of pharmaceutical supplies such as Brodies received tenders to provide only small amounts of "pharmaceutical and related medical supplies to the Ministry of Health" and Wellness, new and unknown companies, including Medigen International Limited, were on the List of Licensed Pharmaceutical Establishments for the first time in 2021. And that company-Medigen International Limited—seemed to be a favored supplier, which 7News had said, "zoomed to the front of the line ahead of the long established importers — to the surprise of many".

Even more alarming, however, was a report that surfaced at about the same time, in August 2021, that the Ministry of Health was no longer requiring a Certificate Of Good Manufacturing Practices—an optimal standard of quality that pharmaceuticals from any supplier would have to meet. Instead, only a certificate of Good Distribution Practices is now required.

"That means that many of the new suppliers selected for tenders this time around may be sourcing their pharmaceuticals on the cheap from India- and they will not have that gold standard GMP certification," *7News* had said.

Notably, when questioned about the raid yesterday at the pharmacies in the Fort Street Tourism Village, Director of Health and Wellness, Dr. Melissa Diaz Musa, told *7News* in a text message, "I don't have any comment at this time. (The) team is conducting evaluation of pharmacies throughout the country."

Late this evening, a release from the Social Security Board (SSB) announced that Pharmacy Express Limited has withdrawn its application for a loan from the statutory body. The SSB release notes that only the Health Ministry submitted a written expression of concern about the loan, and it further explained that "The MOHW's objection was on the basis that presently PEL is not in possession of a pharmaceutical license to operate, and therefore the entity was operating without a license and should not be dispensing or supplying pharmaceuticals to the public...."

The statement from SSB also indicates that while the company did not issue any response denying or qualifying the claims made by MOHW, they had written a letter on August 9 to the CEO of SSB.

In that letter, the SSB said, "PEL informed that they were withdrawing their loan application, to which the SSB responded by accepting same. Consequently, this brings the loan approval process and inquiry, in relation to the PEL matter to an end."

La gentrificación de la Zona Sur destruirá todos los sueños que nuestros abuelos y bisabuelos tenían cuando comenzaron a luchar por el autogobierno en 1950.

Al Sr. Price no le gustaba el concepto de turismo. A mí tampoco. Pero el Sr. Price está muerto, y yo me considero un anacronismo. Por lo tanto, ambos somos irrelevantes. Las personas que son relevantes son todos aquellos beliceños que han logrado el éxito en la diáspora estadounidense y sueñan con regresar a casa para jubilarse en el Belize que recuerdan con amor y nostalgia. Pero hay un problema. La diáspora beliceña no está organizada y las oligarquías de Guatemala, Honduras y Belize sí lo están.

Necesitan estudiar la oscura oligarquía en el sur de Belize. Después de eso, pueden mezclar la Amnistía y el arbitraje de la Corte Internacional de Justicia (CIJ). Para mí, estas cosas suman un Belize que será diferente al que conoció mi generación.

Pueden notar, lectores, que mi escritura no es realmente apasionante. Vería esta columna solo como un intento de registrar algunos aspectos de nuestra historia durante el siglo pasado, con mi foco siendo mi decepción con la inutilidad que siempre parece acompañar los esfuerzos recientes de la diáspora de ser activos en La Joya.

(Marginalmente, cuando Samuel Haynes, Jr. visitó Belize hace un par de años y fue entrevistado por Nuri Muhammad en Radio/Televisión KREM, hablé con él después y le pregunté si era cierto que su famoso padre no volaba en aviones. Dijo que, hasta donde él sabía, su padre nunca había volado en un avión.)

Conocí al difunto Samuel Haynes, Sr., en 1965 en una reunión celebrada por el Honorable Philip Goldson en el Audubon Ballroom de Manhattan. Yo tenía 18 años y no sabía nada sobre el levantamiento de los ex-militares de 1919 o la famosa carrera del Sr. Haynes. A medida que pasaban los años (el Sr. Haynes, padre, murió en 1971), me pareció que el difunto Compton Fairweather, presidente del Comité de Libertad de Honduras Británica, estaba dando mucho crédito por la formación del Comité de Libertad al Sr. Haynes.

En aquellos días, la ciudad de Nueva York era el líder de la población de la diáspora de Belize. Hoy, ese rol de liderazgo pertenece a la comunidad de la diáspora de Los Ángeles, pero no han podido lograr la cohesión y la fuerza que tuvo el Comité de la Libertad.

Puede ser una exageración decir que el Comité de la Libertad salvó a Belize de Guatemala. Sabemos que el Comité de la Libertad pudo ejercer presión sobre Gran Bretaña, que quería vendernos. Hoy es Estados Unidos el que nos está vendiendo. Solo la diáspora de Los Ángeles puede organizar a la gente de Belize en el extranjero a tiempo para neutralizar algunas de las iniciativas de traición que creo que están teniendo lugar. Por si sirve de algo, esa es mi tesis de hoy, miércoles 10 de agosto de 2022.

## Veterans rule; waiting for another "golden generation"

BELIZE CITY, Thurs. Aug. 11, 2022 I watched the NBBA Interdistrict Championship game on TNC 10 last Saturday night, where the performance of two veteran players

at the FFB Stadium reminded me that we don't yet have another "golden generation" of football stars to take us to the next level. It's coming soon, hopefully. With former national team striker Harrison "Cafu" Roches leading the attack and opening the scoring for Griga Conquerors FC against Belmopan's Atletico FC, and the Griga defense anchored by another former national team player, Evan Mariano, who served the pass that Deon McCaulay used to

send Belize to the Concacaf Gold Cup back in 2013, it was clear that age was not enough of a factor at the current Interdistrict level for this crop of young players to assert themselves over the veterans. Cafu indeed played like a young buck, trailing the play aggressively in attack, and there are rumors that Mariano will be appearing in the upcoming, some say already started, Premier League of Belize Opening Season 2022-2023. Another outstanding veteran on the Griga squad was Jacinto "Fowl" Bermudez in defense.

While there are no guarantees that these "old timers" will be able to hold their own at the PLB level, they clearly have garnered enough football intelligence and experience to go along with still formidable physical hardware to contribute effectively for at least a portion of the ninety. And more, they are still entertaining and possessing of some loyal fans still searching for their likes among the new crop of footballers.

On the subject of veterans, I am also reminded of the Over-40 championship a couple weekends ago

Yabra was pressing for the security goal, and a couple fine run-through passes from Manu to Jarro were thwarted by the outcoming Aaron Buckley who intercepted a number of plays near the edge of the eighteen. But it was the astute veteran David "Manu" McCaulay who sealed the deal for Kulture Yabra, surprising Buckley on one such move with a high lob from forty yards out that sank into the back of the net beyond the reach of the back pedaling and diving Buckley. 2-2 tie; and suddenly Kulture once again had a 2 goal cushion and only 10 minutes remaining. It stayed that way until the long whistle, giving Kulture Yabra the aggregate 5-3 series win and the championship.
