An initial investigation revealed that a Canadian national identified as military veteran John Roy Smith, 43, acted as the driver for the three shooters. He has been charged along with Brian Andrews, Kenyon Moore, and Sherwin Moore (all from Sittee River) with two counts of murder.

Two persons are dead; and eight others were wounded after what can only be described as an act of terrorism that shocked the peaceful coastal community of Hopkins early Sunday morning. Three men from Silk Grass Village reportedly stormed into Wabinaha Night

Club in Hopkins with firearms—first murdering who police believe to be the targeted victim, Noah Moro, 23; and thereafter opening fire on the patrons in the club indiscriminately. Another man, 56-year-old Honduran national, Emilio Garcia, who had reportedly tried to close the doors of the club to block the

OSH Bill being revisited by BCCI, trade unions

BELIZE CITY, Wed. Aug. 3, 2022

The Occupational Health and Safety (OSH) Bill is aimed at ensuring safe working environments for employees in Belize through the establishment of minimum standards for safety in the workplace. The Bill was first tabled in the House of Representatives in January 2014, but the process of implementing it has been a painstakingly slow one. According to Belize Chamber of Commerce and Industry (BCCI) president Marcello Blake, though, the bill is being revisited, and the Chamber has finished its final review of it.

"We have actually concluded all the reviews, and what we've done now is created a marked-up version of the bill.

Cannabis legalization shelved

The Minister of New Growth Industries, Hon. Kareem Musa, says the hefty price tag of the referendum is the reason for the delay, not concerns raised by the banking community

The process of legalizing cannabis in Belize and launching a cannabis industry has been put on pause after a recent meeting between the churches and

government officials. There had been speculation that concerns raised by the banking community may have been the impetus behind the shelving of the marijuana legalization bills, which have gone through three readings—in both the lower and upper houses of the Belizean parliament—with only final assent from the Governor-General being necessary for them to be put into effect. The recently amended Misuse of Drugs Act and the Cannabis and Industrial Hemp Control and Licensing Bill 2022 had laid the legal framework for a legal cannabis industry in Belize, but an offensive from the churches, which garnered the requisite number of signatures to trigger a referendum on the matter, has brought efforts to get

GoB officials conduct site visit at Sarstoon FOB



Sarstoon FOB meeting

BELIZE CITY, Thurs. Aug. 4, 2022

Government officials today visited the Sarstoon Forward Operating Base (FOB) to conduct a site survey and gather data that will be used to formulate recommendations to fortify the military base. A few weeks ago, AMANDALA reported on the severe erosion that has affected the stability of the ground on which the Sarstoon Forward Operating Base (FOB) is built and has caused a portion of that land to become submerged in the southern seas. The FOB's front stilts are already under water, and as a result a decision was made to evacuate the approximately 12 soldiers who were stationed at the base to prevent any mishaps that could lead to their injury.

Those soldiers, who were transferred to a base in Barranco Village, are taken to the island to stand guard from 6:00 a.m. to 6:00 p.m. daily. Following the visit to the site by key government officials in the National Security, Environment and Infrastructure Development ministries, the government will proceed with the development of a plan to address the situation at the Sarstoon FOB.

"The visit follows reports concerning

the integrity of the FOB due to erosion. During the visit, engineers conducted a site survey and collected data with a view to making recommendations for immediate and short-, medium- and long-term improvements. Once the engineers present recommendations, the ministry intends on tabling before Cabinet for consideration," a release from the government of Belize said.

Present during the site visit were retired Brigadier General (Ret'd) Dario Tapia, CEO of the Ministry of National Defence; and CEO Kenrick Williams, representing the Ministry of Sustainable Development, Climate Change, and Disaster Risk Management. Civil engineer, Irvin Thimbriel from the Ministry of Infrastructure Development and Housing, and Alan Garcia, also from that Ministry.

Executive officer of the First Infantry Battalion, Justo Veliz, Jr., was also present, as well as Devin Azueta, Communications Officer in the Ministry of Sustainable Development, Climate Change, and Disaster Risk Management.

No announcement has been made about what specific steps will be taken to address the issues at the FOB.

that industry off the ground to a sudden

The referendum, which was set to take place by early September, has been put on hold after the government and churches agreed to hit the pause button. When recently interviewed by local reporters, Prime Minister Hon. John Briceño said that his Minister of State in the Ministry of Finance, Hon. Chris Coye, had a meeting with key players in the banking community who expressed concern over the legalization, and how the industry could affect correspondent banking relations.

Minister of New Growth Industries, Hon. Kareem Musa, for his part, has acknowledged those concerns and how critical it is to preserve correspondent banking relations in Belize, but pointed out that the cannabis industry in Belize would be entirely cash-based — meaning revenue from the cannabis and industrial hemp industry would not be deposited in, or handled by, local banks with international correspondent banking relationships.

He noted that it had always been the intention within his ministry to have the cannabis industry operate on a cash-only basis, and he went on to point to the fact that the industrial hemp industry, among others in Belize, is considered cashbased.

"Correspondent banking is a live issue at all times for Belize and for the Caribbean, but what I can tell you is that countries like Jamaica, and Antigua, are moving towards it; Trinidad is about to pass their legislation, and St. Vincent. Those countries are moving toward the legalization of cannabis. As I always say, it is a cash industry, so when you ask me about banking- banking does not necessarily come into the picture unless you are banking your cannabis dollars,"

He further noted that even the United States' cannabis industry is a cash-based enterprise.

"In the Caribbean and the great United States, where it is a 92-billion dollar industry, it is a cash industry, so individuals who are engaged in the cannabis sector do not go and deposit their funds within the banks. That does not happen even in America," Hon. Musa said.

Minister Musa went on to suggest that maybe a local institution with no international correspondent banking facility may be an option for the handling of earnings within the industry.

He pointed out, however, that the greater concern at this juncture of the process is the cost of the referendum, which the government has already set aside \$5 million to cover in a recent supplementary appropriation. The process of having Belizeans vote on whether they support or oppose marijuana legalization, however, could cost much

more than what was budgeted, and has caused the government to decide to stall the process.

"The real point is that it is a costly referendum, and so it's \$5 million it would have cost for us to do this referendum, and to me that is the real reason, but at the same time as we put a pause on the legislation, we have time to tighten up whatever loose ends there may be in terms of correspondent banking, but in my respectful opinion that will never be tied up," Minister Musa outlined.

He also indicated that the government and other stakeholders will have to figure out a way to work around the global banking reality facing the cannabis industry.

"We will have to figure a way whether it [be] opening community banks or credit unions that do not have correspondent banking in order to bank the dollars here in Belize. That is the solution, and there are several international companies who have expressed interest to come and open these community banks here, so there are solutions to that, but like I said, the primary concern at this time is the cost of the referendum," Hon. Musa said.

Minister Musa emphasized, however, that commercial banks in the country would need to do additional due diligence to ensure the funds being deposited at their institutions are not proceeds from the cannabis industry—a concern that had reportedly been raised by one of the country's major banks.

"What it does is that it imposes obligations on the local banks to do their due diligence to make sure that the funds that they are receiving are not related to, whether it is a cultivation license or a dispensary license, the banks just have to ensure that they are not receiving funds from the cannabis-related businesses. There are several other cash industries already in existence in Belize; for example, the cattle that we transship to Guatemala, tobacco, and the cigarette industry at the Free Zone—that is a cash industry. The hemp business right now in Belize ... the funds received in relation to that industry is not accepted by the banks, and so cash industries are normal in Belize. We have to understand that, but there is a greater concern, because there is so much revenue to be earned from cannabis that in fact, the local banks are saying, 'we want to make sure there are no issues for us'," Hon. Musa outlined.

For now, however, the legalization of cannabis in Belize is on pause.

Late this evening, the churches and the Government of Belize released a joint statement which made that pause in the holding of a referendum (and the legalization of marijuana) official. The release states, "The Church Leaders on behalf of the petitioners and the Government of Belize request of the Governor General to defer the issuing of the Writ of Referendum until a date to be determined."

NSUB wants rep on People's **Constitutional Commission**

Monday, August 1, was the proposed launch date for the People's Constitutional Commission, and while Prime Minister Hon. John Briceño has suggested that there will be no more additions to the list of groups represented on the Commission, the demands for inclusion have continued. Just this week, the National Students Union of Belize wrote to the Minister of Public Service & Constitutional and Political Reform, Hon. Henry Charles Usher, expressing concern at the "lack of students' participation" in the PCC.

In that letter, dated August 1, the National Students Union of Belize (NSUB) states that the Constitution of Belize is built on inclusivity that diminishes "economic and social privileges" and notes that students are no more or less important than any other group of citizens in Belize.

"We maintain that tertiary level students' participation in the national development processes of Belize is nonexistent, despite its relevance and our several requests throughout the years," the letter goes on to state.

The NSUB also asserted in the letter that denying them the opportunity for active participation in the constitutional reform process would be deemed "democratic backsliding" and may infringe on their constitutional rights "due to a lack of true and equal representation."

The union, whose members are students at the tertiary level in universities and junior colleges across Belize as well as those abroad, is the first-ever students' union in Belize and is also a member of the Commonwealth Students Association and the Caribbean Students' Union, and an honorary member of the National Trade Union Congress of Belize (NTUCB).

In its letter, the NSUB states that while the government's recent consultation with both them and the Young Leaders Alliance of Belize (YLAB) is commendable, it demonstrates a concern for "throughput legitimacy".

We note that last week the Young

Leaders Alliance of Belize, after consulting with the Good Governance Unit in the Ministry of Public Service & Constitutional and Political Reform, was allowed to serve as the Youth Representative on the People's Constitutional Commission.

The NSUB states that they are still hopeful that the Director of the Good Governance Unit, Caesar Ross, will "hold

his promise" to assist the union in obtaining a seat on the commission.

While the NSUB and several other groups, including the UBAD Educational Foundation (UEF), the Belizean diaspora, and the East Indian Council of Belize. have lamented their exclusion from the PCC, one group that will see themselves

Woman fatally stabs man during domestic dispute in Belize City



A domestic dispute led to a stabbing incident that claimed the life of one Belize City man this week. In the wee hours of Tuesday morning, 27-year-old Shantel Williams and 39-year-old Louis Adolphus were in the midst of an argument at Adolphus' home on Curassow Street, when Williams stabbed her common-law-husband in the shoulder.

According to the Commissioner of Police, Chester Williams, Louis Adolphus was seen walking on the street after being stabbed, and he even managed to give the police his account of what transpired between him and Williams. Adolphus reportedly then asked the police to take him to the Karl Heusner Memorial Hospital (KHMH), where, moments later, he succumbed to his injuries while undergoing treatment.

Williams is currently in the custody of the police, and according to the Police Commissioner, she has claimed that she



acted out of self-defense.

"We know that there are previous complaints of domestic abuse that she had filed with the police, and so the matter is with the DPP's office at this time, and they will determine if in fact the lady will be charged, and, if yes, what she will be charged for," he said.

Burnt remains of drug plane found in Crique Sarco

CRIQUE SARCO, Toledo District, Wed. Aug. 3, 2022

While a number of police officers in the Stann Creek District were responding to a mass shooting at a nightclub in Hopkins Village in the wee hours of Sunday morning, reports were received that a suspected narco jet had made landfall in the southern part of Belize in the vicinity of Crique Sarco, Toledo District, and by the time law enforcement personnel arrived at the scene later, only the burnt remains of the aircraft were in the area.

Sometime between 11:30 a.m. and 10:00 p.m. on Sunday, July 31, members of the Belize Defence Force (BDF) and the Belize Police Department were deployed to an offroad about 6 miles away from Crique Sarco village in the Dolores area. When the members of the joint operation arrived at the location, they saw an illegal airstrip measuring about a mile in length and a double-engine airplane that was about 30 feet long on the said airstrip.

When local reporters questioned the Commissioner of Police, Chester Williams on Tuesday, he noted that over the weekend when the landing

occurred, Hopkins Day festivities were taking place in that village, and officers from the Police Department's quick response team had been out doing patrols in the village and the surrounding area. He went on to say that when the department received reports of the entrance of a suspected drug plane into Belize's airspace, a number of officers had to be redeployed to the location of the reported landing.

"When we do have these events, we have Hopkins Day, we had the music fest in San Pedro. Anytime we have major events, you'll find that we'll deploy our quick response team and our specialized units to assist in policing those events. And so, the quick response team from Dangriga was in charge of policing and patrolling Hopkins, due to the Hopkins Day event. When we had the information of the night plane in our airspace, the police officers, the quick response team that was in Hopkins, had to leave Hopkins to respond to the plane, and that left Hopkins open with no patrol, because they were the ones who were patrolling. The team subsequently, along with the BDF team, conducted searches in the southern part of the country as information was that one

Sports Council worker on Darren Banks shooting: It wasn't me!

Michael Morris Meighan, 32, a National Sports Council employee, whose attorney, Norman Rodriguez, turned him in to police on Tuesday after the Police Department announced he was the prime suspect in the murder of former PIV Bloods leader Darren Banks last Monday, tearfully denied the claims made by police this week, and has said that the false accusations against him have ruined his life.

Over the weekend, the Belize Police Department released a wanted poster that indicated that Meighan was suspected of being involved in the murder of 42-year-old former PIV Bloods leader, Darren Banks, who was gunned down in broad daylight in the St. Martin De Porres area at about 6:00 in the evening on Monday, July 25.

According to last week's issue of AMANDALA, the former PIV gang boss, who was left for dead in a drain after being shot multiple times at the corner of Amandala Drive and Ebony Street in Lake Independence, had stepped away from a life of crime after being diagnosed with Schizophrenia while serving a 3-year prison sentence for a firearm and ammunition that were found during a police raid.

While police so far have no evidence confirming the identity of the triggerman, they have pointed fingers at Meighan, who was reportedly seen at the time of the Banks' murder, near the scene of the shooting in a vehicle that he uses to carry out his duties as a messenger for the National Sports Council.

Notably, the wanted poster issued by police referred to Meighan as a resident of Ebony Street, but he told 7News that he has never lived at such an address and has never been involved in any gang activity.

"I lose my job, I lose my reputation, [and] I lose everything. Then on the wanted poster, they put my address as Ebony Street. I have never ever lived on Ebony Street. I don't even have family members in that area. I don't have any kind of involvement in the Martin De Porres area. I don't have any family, no friends in the BLC area, in the PIV area ... So you are telling me if you don't have any questioning for me and you all questioned me after the murder and you don't have any evidence to charge me — you will send me up in the State of Emergency too? Which gang? I am not a gang member," he lamented.

However, when questioned by local Wednesday, reporters on

"If he was so innocent, why did he not show up to work the next day after the shooting? These are the things, you know. These young men go and find attorneys, line them up and come and say to the police what they want the police to hear. But we are no fools. We have video footages that showed that vehicle near the murder scene. We have video footages that show after the murder took place, the vehicle raced down from there and went over a bridge, and went to Roger's Stadium. If he was so innocent, police went to look for him the next day at his workplace; he was a no-show ... And it showed also at the Sports Council that he was the one who signed out for the vehicle; he was the one in the vehicle," said COMPOL Williams.

Interestingly, in June of this year, Meighan had been featured in local newscasts after he was shot and robbed on Princess Margaret Drive while turning into St. Thomas Street. COMPOL Williams was asked if the police are looking at any possible connection between that robbery and the murder that Meighan is now accused

"It's something we need to look at, because yes, just months ago, he was the victim of a robbery in the vicinity of the Marion Jones Stadium. We are not certain as to who the persons were who did that robbery, because I think in his statement, he had mentioned then that he did not know who the persons were," he said.

So far, no charges have been levied against Meighan.

of the planes faded in the Dolores area. They went into the area, they conducted searches, and the burnt remains of the plane [were] found," Commissioner Williams said.

Williams noted that no visible markings could be observed on the airplane, which was reportedly a King

Air 200, because only the aircraft's charred remains were at the site after it had been completely destroyed by fire. According to Police Commissioner Chester Williams, none of the cargo that is believed to have been onboard the plane has been found, nor was anyone found in the area.

Alrick Smith - man with "nine lives" - killed in front of MORE FM

after being shot on a number of previous occasions, was executed a little after 10:00 p.m. after briefly being a guest on a MORE FM radio show at the Rene Villanueva Media Center on Slaughterhouse Road on Thursday night, July 28.

Smith's final moments were captured by the surveillance camera, and in that footage, he could be seen entering the building along with a female companion at around 9:46 p.m. The footage also shows a silver Chevy Equinox stopping in front of the building for a few seconds after Smith entered, then driving off. That same vehicle would return to the scene a few minutes later.

While in the building, Smith and his female companion made their way to the studios of MORE FM, where a regular Thursday night radio show featuring Blue Steel Sounds was in progress, and Smith, in a short segment, joined the hosts onair to promote his business, Car Guys, and to give away cash prizes to some listeners.

After Smith's participation in that segment was done, he exited the building at around 10:03 p.m. and was casually greeted by some bystanders who were in front of the media center. At that point, he stepped outside the frame of the surveillance camera and was no longer visible in the recorded footage. That was the point at which he was besieged by bullets that purportedly were fired by the occupants of the silver Chevy Equinox that was seen earlier. He reportedly died on the spot. The car, with the gunmen inside, then sped away.

Notably, dents could be observed on the doors of the Chevy Equinox that had been seen in the surveillance camera footage of the shooting, and over the weekend, images of burnt remains of that same vehicle (which was found on the John Smith Road) were circulated throughout social media. On Tuesday, Commissioner of Police, Chester Williams confirmed to local media that it was the getaway vehicle used by the shooters.

On the following day, Commissioner Williams informed the media that his department had found out that the Chevy Equinox used in the murder was brought into the country by Jody (Jedd) Burgess of the St. Martins De Porres area and was sold to Justin Usher, who flew out of the country on the day after the murder took place. Williams additionally noted that on the night of Smith's murder, two persons were seen in the vehicle—one being a relative of Burgess and the other being Burgess' close associate, according to reports.

"From what we made to understand, is that the day after the shooting, Justin Usher left the country. Certainly, him leaving the country may have been preplanned, because you can't just go to the

airport and show up and catch a plane. You need to book your ticket at least 48 hours ahead. Notwithstanding that, though, we do believe that Justin Usher has some questions to answer. The two persons who we have been told were in the vehicle, we also have been reliably informed that one of them may be on their way to the US through the back; we're still trying to confirm that. So what we have done is that to inform our Mexican counterparts, we have also put out wanted posters for Justin Usher and we will see if we can locate the other individual who is [a] close relative to Jody Burgess, who we believe is still in the country. But that group of four, we believe has all the answers to the murder of Alrick Smith, as we have now confirmed that his murder was inter-gang related," explained Compol Williams.

Williams then went on to point to possible motives for the murder: "Certainly, from what we have obtained, it is over a woman. We also have second information that it may be over money, but the most credible one is that it is over a woman," he said.

Before turning his life around and becoming a reputable car dealer, Smith was a notorious gang figure in the streets of Belize City and had been charged with numerous offenses. In 2014, he was accused of attempting to kill four on-duty police officers. Also, in 2016, he was accused of seeking to murder an entire family.

Notably, Thursday night's shooting was the most recent of a series of attempts over the years to end his life, and the success of that final attempt startled many of his loved ones, who had begun to believe that he could defy death. In 2019, a gunman attempted to end his life, but only grazed him at the back of his head. Later that same year, he was shot at while socializing on Curl Thompson Street.

Kayla Flowers, Smith's sister, told local reporters that his family had expected that he would become the target of gunmen again, but they did not expect another shooting to occur so soon, and they had begun to believe that he would survive any such attempts.

Flowers recalled how close she and her brother were during their childhood, when they were inseparable.

"[We] grew up together. Everything that we do together. If he is going to fix a bike, it would be me and him together. If he goes driving around to go look for someone, it would be me and him together. We're always around. When he was younger, he had a lot of girlfriends, and I used to be the one he would take when he used to buy ice cream, and if he liked you he would buy you ice cream. That's the way how I know him, that's the way we grew up. We did everything together," she said.

Interestingly, the chairman of the United Democratic Party, Senator Michael Peyrefitte, made an explosive claim in relation to the Alrick Smith murder while he was a guest on the UDP's morning radio show, *Fus Ting da Mawning*. According to Peyrefitte, a police corporal with ties to the current administration might have been involved in the shooting, but attempts by police to detain him for questioning as a possible person of interest were suddenly halted after a call was made by a person of high rank within the administration, who instructed the

Pelosi dares China

The visit to Taiwan this week by Nancy Pelosi, the House Speaker in the United States of America, and the third most powerful Biden administration leader after President Joe Biden himself and Vice-President Kamala Harris, came after Mainland China threatened some kind of military action to demonstrate its anger at the prospect of such a visit. Mainland China considers Pelosi's Taiwan visit a slap in their face, because they believe the island to be a part of the Chinese state.

Since Pelosi arrived in Taiwan, the most important supplier of semiconductors (semiconductors are critical components in the manufacture of strategic equipment and weaponry) to the United States, China has been carrying out aggressive military exercises in space which, strictly speaking, is Taiwanese. The danger here is that the Taiwanese may react to the Chinese provocations and trigger a situation which could result in a confrontation between the Americans and the Chinese. (The Americans consider themselves defenders of the Taiwanese.)

This is not pleasant to contemplate, because the U.S. and China are nuclear powers. Meanwhile, in Ukraine there is concern over Russian activity in a massive nuclear plant which is inside

Ukraine territory.

I think that the Democratic Party is supporting the Pelosi visit to Taiwan in order to have the Biden administration appear strong at a time when Biden's Democratic administration is trailing the Republican Party badly in polls preceding mid-term Senate and Congressional elections later this year in the United States.

When you combine the Pelosi visit to Taiwan with the months of increasing tension between the U.S. and Russia because of America's open financial and military support for Ukraine, you will conclude that our world has become a much more dangerous place recently. In the words of Robert Nesta, "See them fighting for power, but they know not the hour."

In October of 1962, planet earth came close to nuclear catastrophe when one of the members of America's Joint Chiefs of Staff, Air Force General Curtis LeMay, called for a nuclear attack on Cuba, where Russia had installed missiles at the request of Cuban leader, Fidel Castro.

In Belize (then British Honduras), we were totally unaware of the danger. We did not know that Castro was very angry when the Russians backed down and removed the missiles. Fidel risked nuclear war in defence of Cuban sovereignty.

Commissioner Williams, however, denied those allegations and told reporters that it was he, Williams, who told the officers to refrain from detaining the police officer, since there was in fact no sound basis for believing the officer was in any way involved in the shooting or connected to the shooters.

"In the wake of the murder [of] Alrick Smith, we had received information that the vehicle that was involved in the murder was parked at a particular house in the Japan area of Ladyville. Based on [the] information obtained, I directed that the police go to the house and retrieve the vehicle as well as whoever is the occupant of the particular home. Police visited the area ... the house was seen with no one inside. I ordered a surveillance team be put in place to ascertain who lives at the house, because if the policeman that they were saying lived at that particular house, we know for a fact that he does not live there. He lives miles and miles away. And we also know for a fact that his parents also do not live there. They live much more down the road. So at the end of the day, certainly, the police officer that they were saying lived at the house or parents lived at the house, neither of [that] information was true," said Commissioner Williams.

Williams further explained, "... somehow I was made to understand that, [the] directive was given to go and pick up the particular police officer and detain him. That information reached me, and I was the one who called the team that went to detain the officer and told them to stand down because of the fact that it is clear that he had absolutely nothing to do with the house, where he was alleging the vehicle was parked, and neither did he have anything to do with the investigation ... I, again, insisted that we ascertain who lives at the particular house; that was done, and we [learned] that the person who lives [in] the house is a guy who works as an air traffic controller at the PGIA, and we got this information through the landlord. What we also learned, the police officer in question, he did live at the house. Over four years ago he moved out from that house and now resides with his wife miles and miles away."

Smith leaves behind three children: two girls and one boy.



Violence, grief, and financial ruin

Belize has rarely seen violence on a scale equal to what occurred in peaceful Hopkins over the weekend when a gunman or gunmen opened fire at a nightclub where Belizeans were enjoying part of the Hopkins Day festivities organized by that village's village council. At the end of the shooting, which police reports say was ignited by a personal confrontation, not gang warfare, the families and friends of two people, a young man and a middle-aged man, were grieving their deaths; dozens of people were traumatized, eight of them with gunshot wounds; one man was in custody and three men were on the run; and the Hopkins Village Council and all the villagers felt the air go out of a weekend they had spent months preparing for.

In the weeks leading up to countrywide Village Council Elections this year, the National Garifuna Council (NGC) made a call for villagers in traditional Garifuna villages to vote for individuals of Garifuna ethnicity. Eyebrows were certainly raised by this call, but at its core the NGC was just seeking to preserve the culture of this relatively small group in our country.

The Garinagu are a proud, progressive people, and their villages are close-knit, peaceful communities where everyone is known by their name. A village-council hosted event in a Garifuna village was one of the last places in our country where we would have expected ugly violence to break out. What happened in Hopkins is no reflection on the villagers. It's our country; there is mad violence all over, especially in urban areas, and in the night vicious visitors came to Hopkins and shattered the village's tranquility.

In the immediate aftermath of the horrific gun violence, the NGC issued a press release expressing sympathy to the victims, particularly the families who lost loved ones, and expressed its

concern about the "farreaching negative impact this
type of inhumane, criminal act
can have on the reputation of
our Garifuna community." The
chairman of the Hopkins
village council, Mr. Macario
Augustine, used social media
to express his grief over the
unfortunate violence the night
before, and to inform
Belizeans across the land that
the festivities would continue
as planned, with heightened
security.

The leaders of the village must have done some hard thinking before they decided against cancelling the events they had planned for Sunday. The tremendous investment of Hopkins' residents has to be emphasized. Some villagers probably put their entire year's savings into preparing items for sale on Hopkins Day. The payments for some children's/ youth's school books and uniforms might have depended on the sales from their family's booth.

These violent acts not only take lives; they suck the economic life out of our communities. It's an ongoing crisis that government after government has been impotent in addressing. After all the hard work, the planning

and investment, there should be joy. Instead, there is unimaginable grief, horrific trauma, and major financial losses for many people because of unconscionable violent acts.

Another SSB loan goes under the microscope

Alarm bells ring every time the Social Security Board (SSB) issues a loan, especially since a PUP government came to power in November 2020. The PUP failed in three consecutive elections, in 2008, 2012, and 2015, and one explanation for the party being snubbed at the polls is the belief of many that between 1998 and 2008, when the party was in power, its appointees did not handle the SSB's funds with the best judgment.

The SSB can't stand pat; it can't bury the "talents." The SSB has to grow its fund so that it can meet its obligations to beneficiaries, and to that end SSB directors and its investment committee are charged to make sound investments in economically sound/socially desirable projects. Many entrepreneurs seek SSB loans because the interest rates are significantly lower than they can get at the banks.

In 2019 the fund stood at over half a billion dollars, and as then chairman, Doug Singh said, much of it sat at the banks earning little interest. In 2016, Singh thought it was a great investment opportunity for the SSB to lend Santander \$12 million at 7% and 8%, but the company backed out because Belizeans didn't like the idea of the SSB lending money to foreigners. In 2014, the SSB, under Chairman Singh, was "allowed" to lend over \$10 million to the Citrus Growers Association (CGA), after Denzil Jenkins, chairman of the CGA subsidiary, ICL, lowered the anxiety of Belizeans a few degrees with the information that the SSB would be making almost 6% more off its funds by lending it to the CGA, than it would make if the money was left in the banks.

Those loans mentioned were on the table during years when the UDP was in government, but even though the UDP was on a high after cleaning up messes at the SSB and DFC made by the PUP, particularly the PUP 1998-2003 administration, the scrutiny was intense.

Caution flags were flying when the SSB recently announced that it was lending \$20 million to the DFC, but the DFC quickly put fears to rest with the claim on its website that this latest loan was one of 24 it had received over the years from the SSB, and that in its 59-year history it hadn't defaulted on any of its debt obligations. That one having been addressed, next in line is a proposed \$7 million loan to Pharmacy Express Ltd., a company few had heard of prior to it applying for SSB funds.

It is claimed that the company has put up collateral that is worth three times the sum it hopes to borrow, but that hasn't stopped Belizeans from clamoring for the SSB to do more scrutiny of this company before lending it the people's money. A couple days after information was published about the proposed loan, the Ministry of Health & Wellness expressed "some concerns", and Cabinet, in a meeting on July 28th, said it recognized the "autonomy of the SSB but supports the importance and necessity of ensuring that all relevant information regarding Pharmacy Express Limited is shared with SSB before a final decision is made in respect of the loan."

As noted, SSB loans are much sought after, and ever since a PUP government was less than careful with the people's funds—the details of such misdeeds or missteps lying buried in a Commission of Inquiry report that has never been published—Belizeans have kept a particularly keen eye on the Board's transactions. It's possible that Pharmacy Express Ltd. can generate sufficient cash flow to service a \$7 million loan and that its collateral is as good as Placencia land, factors that would make it a fair bet. But the company will have to open its books to more examination. That's because Belizeans, having been bitten before, become very wary whenever they hear of a new investment of the people's funds by the SSB.

Poet Roy Davis talks love, racism, and more in new collection, Fooley Me

"I love all ah deh," he added.


Included in the collection is the titular piece, "Fooley Me," which speaks about Davis' own personal struggle with drug addiction and how he managed to overcome it.

"Freedom" is a poem about the former journalist's brief stint in jail, written during the 18 days when he found himself incarcerated.

Other poems include "Deception," which focuses on racism; "Sing to Me", a tribute to the melodic blackbird; and "Juana Maria," a tribute to marijuana (otherwise known as Mary Jane).

In the book's preface, Davis notes that he penned the poems in his collection to "enlighten, entertain, and be a source of wisdom to those who read them."

As has been mentioned, Davis, who previously published a collection of original Bra Anansi and Bra Tiger stories entitled *All in One*, is also a former journalist and court reporter. He



began writing for the *Reporter* in 1979, and remained there for a total of four years. Soon after, he would join the team at AMANDALA for four years before going on to do freelance work.

Fooley Me was compiled and proofread by Sean Taegar, who Davis says was instrumental in helping him put together the collection, alongside publisher Margaret Reynolds, owner of Reynolds Desktop Publishing.

When we contacted him, Davis told us that he had just recently sold his last copy of *Fooley Me*, but he is hoping to print more in the near future. Until then, persons interested in reading the book can visit the Leo Bradley Library, where a few copies are available.

Looks like Social Security has Money to Burn!

The Belizean populace is irate! The country is furious—angry at their Social Security Board (SSB) for a slew of investments that not only total an exorbitant sum but are very questionable, to say the least. In case you're living under a rock, for context, the Social Security Board has just recently made public an intent to lend a whopping 20 million dollars to the **Development Finance Corporation** (DFC) and an inconceivable and incomprehensible 7 million dollars to a private pharmaceutical company! Now, if your head is getting tight and you're deeply suspiring at this news, you have every right to! Because what in the good heavens of a ridiculous investment is this? The only logical thing that one can think is that Social Security must have money to burn!

Before we get to the 7 million for the private pharmaceutical company, let's


Then, to further compound an already egregious situation, the SSB announced a further 7-million-dollar loan to a private pharmaceutical company. Now, from all sides and all



Violencia, dolor y ruina financiera

Belize rara vez ha visto violencia en una escala igual a la que ocurrió en el pacífico Hopkins durante el fin de semana cuando un hombre armado o hombres armados abrieron fuego en un club nocturno donde beliceños disfrutaban parte de las festividades del Día de Hopkins organizadas por el consejo de la aldea de ese pueblo. Al final del tiroteo, que según los informes policiales fue provocado por una confrontación personal, no por una guerra de pandillas, las familias y amigos de dos personas, un joven y un hombre de mediana edad, lloraban su muerte; decenas de personas quedaron traumatizadas, ocho de ellas con heridas de bala; un hombre bajo custodia y tres hombres a la fuga; y el consejo de la aldea de Hopkins y todos los aldeanos sintieron que se les iba el aire de un fin de semana para el que habían pasado meses preparándose.

En las semanas previas a las elecciones de los consejos aldeanos de todo el país este año, el Consejo Nacional Garífuna (NGC por sus siglas en inglés) hizo un llamado a los aldeanos de las aldeas garífunas tradicionales para que votaran por personas de la etnia garífuna. Este llamado ciertamente causó asombro, pero en esencia, el NGC solo buscaba preservar la cultura de este grupo relativamente pequeño en nuestro país.

Los Garinagu son un pueblo orgulloso y progresista, y sus aldeas son comunidades pacíficas y unidas donde todos son conocidos por su nombre. Un evento organizado por un consejo aldeano en una aldea garífuna fue uno de los últimos lugares en nuestro país donde hubiéramos esperado que estallara una violencia fea. Lo que sucedió en Hopkins no es un reflejo de los aldeanos. Es nuestro país; hay violencia loca por todas partes, especialmente en las zonas urbanas, y en la noche visitantes viciosos llegaron a Hopkins y destrozaron la tranquilidad del pueblo.

Inmediatamente después de la terrible violencia armada, el NGC emitió un comunicado de prensa expresando su simpatía por las víctimas, en particular las familias que perdieron a sus seres queridos, y expresó su preocupación por el "impacto negativo de gran alcance que este tipo de acto criminal e inhumano puede tener sobre la reputación de nuestra comunidad garífuna". El presidente del consejo de la aldea de Hopkins, el Sr. Macario Augustine, utilizó las redes sociales para expresar su dolor por la desafortunada violencia de la noche anterior y para informar a los beliceños de todo el país que las festividades continuarían según lo planeado, con mayor seguridad.

Los líderes de la aldea debieron haber pensado mucho antes de decidir no cancelar los eventos que habían planeado para el domingo. Se debe enfatizar la tremenda inversión de los residentes de Hopkins. Es probable que algunos aldeanos hayan invertido los ahorros de todo el año en la preparación de artículos para la venta en el Día de Hopkins. Los pagos de los libros y uniformes escolares de algunos niños/jóvenes podrían haber dependido de las ventas de la caseta de su familia.

Estos actos violentos no solo cobran vidas; absorben la vida económica de nuestras comunidades. Es una crisis continua que gobierno tras gobierno ha sido impotente para abordar. Después de todo el trabajo duro, la planificación y la inversión, debería haber alegría. En cambio, hay un dolor inimaginable, un trauma horrible y grandes pérdidas financieras para muchas personas debido a actos violentos desmesurados.

Otro préstamo de SSB pasa bajo el microscopio

Las campanas de alarma suenan cada vez que la Junta de Seguridad Social (SSB por sus siglas en inglés) emite un préstamo, especialmente desde que un gobierno PUP llegó al poder en noviembre de 2020. El PUP fracasó en tres elecciones consecutivas, en 2008, 2012 y 2015, y una explicación para el partido siendo desairado en las urnas es la creencia de muchos de que entre 1998 y 2008, cuando el partido estuvo en el poder,

sus titulares no manejaron los fondos de la SSB con el mejor criterio.

La SSB no puede quedarse quieta; no puede enterrar los "talentos". La SSB tiene que hacer crecer su fondo para que pueda cumplir con sus obligaciones con los beneficiarios y, con ese fin, los directores de la SSB y su comité de inversiones están encargados de realizar inversiones sólidas en proyectos económicamente sólidos/socialmente deseables. Muchos empresarios buscan préstamos de la SSB porque las tasas de interés son significativamente más bajo de lo que pueden obtener en los bancos.

En 2019, el fondo superó los 500 millones de dólares y, como el presidente de ese entonces, Doug Singh dijo, gran parte se encontraba en los bancos ganando poco interés. En 2016, Singh pensó que era una gran oportunidad de inversión para la SSB prestarle a Santander \$12 millones al 7% y al 8%, pero la empresa se retractó porque a los beliceños no les gustó la idea de que la SSB prestara dinero a los extranjeros. En 2014, a la SSB, bajo la presidencia de Singh, se le "permitió" prestar más de \$10 millones a la Asociación de Productores de Cítricos (CGA por sus siglas en inglés), después de que Denzil Jenkins, presidente de ICL, la subsidiaria de CGA, redujera la ansiedad de los beliceños unos pocos grados con la información de que la SSB obtendría casi un 6% más de sus fondos prestándolos a la CGA, de lo que obtendría si el dinero se quedara en los bancos.

Esos préstamos mencionados estuvieron sobre la mesa durante los años en que el UDP estuvo en el gobierno, pero a pesar de que el UDP estaba en un punto alto después de limpiar los problemas en la SSB y la Corporación Financiera de Desarrollo (DFC) hechos por el PUP, particularmente la administración PUP de 1998-2003, el escrutinio fue intenso.

Las banderas de precaución ondeaban cuando la SSB anunció recientemente que estaba prestando \$20 millones a la DFC, pero la DFC rápidamente disipó los temores con la afirmación en su sitio web de que este último préstamo era uno de 24 que había recibido a lo largo de los años de la SSB, y que en sus 59 años de historia no había incumplido ninguna de sus obligaciones de deuda. Habiendo abordado ese tema, el próximo en línea es un préstamo propuesto de \$7 millones a Pharmacy Express Ltd., una compañía de la que pocos habían oído hablar antes de que solicitara fondos de la SSB.

Se afirma que la empresa ha ofrecido una garantía que vale tres veces la suma que espera pedir prestada, pero eso no ha impedido que los beliceños clamen a la SSB para que haga un mayor escrutinio de esta empresa antes de prestarle el dinero del pueblo. Un par de días después de que se publicara la información sobre el préstamo propuesto, el Ministerio de Salud y Bienestar expresó "algunas preocupaciones" y el Gabinete, en una reunión el 28 de julio, dijo que reconocía la "autonomía de la SSB pero apoya la importancia y la necesidad de garantizar que toda la información relevante sobre Pharmacy Express Limited se comparta con SSB antes de que se tome una decisión final con respecto al préstamo".

Como se señaló, los préstamos de SSB son muy buscados, y desde que un gobierno PUP fue menos que cuidadoso con los fondos de la gente (los detalles de tales fechorías o pasos en falso yaciendo enterrados en un informe de una Comisión de Investigación que nunca se ha publicado), los beliceños han mantenido una atención particular en las transacciones de la Junta. Es posible que Pharmacy Express Ltd. pueda generar suficiente flujo de caja para pagar un préstamo de \$7 millones y que su garantía sea tan buena como la tierra de Placencia, factores que la convertirían en una apuesta justa. Pero la compañía tendrá que abrir sus libros para un mayor examen. Eso es porque los beliceños, habiendo sido mordidos antes, se vuelven cada vez más cautelosos cada vez que se enteran de una nueva inversión de los fondos del pueblo por parte de la SSB.

The quote at the top of this column, from Hubert Howe Bancroft, is not totally relevant to the core content of this column, but religion has surged to the top of matters for discussion in Belize over the last few months, primarily because of the mobilization of Christian churches here to prevent the legalization of marijuana being proposed by the Government of Belize. In addition, a leading Christian pastor luminary, Louis Wade, Jr., has been chosen by his media colleagues to represent the media in a new constitutional reform commission.

Because of religion's discussion prominence recently, I thought it was important to present Bancroft's argument that Christianity, historically, was just as barbarous as, and sometimes more so, than some of the Indigenous religions in the Americas which have been historically indicted by the said Christian faiths.

Today, I want to tell you about a part of our history in this settlement of

Belize/ colony of British Honduras—that there was once a black family here which owned a newspaper, printing presses, and wrote books on matters as critical as the 1931 and 1961 hurricanes.

The Cain family was at the height of its prestige and power during the Garveyite era in the first part of the twentieth century. They were led by two brothers, if my information is accurate, who were Herbert and Ernest Cain.

When the United Black Association for Development (UBAD) was founded in February of 1969, we opened an office at no. 45 Hyde's Lane, in a warehouse-type building. Our landlord was a Chinese Belizean, I believe, and that landlord was quickly pressured by the ruling People's United Party (PUP) and gave UBAD notice to move from his building.

I remember distinctly that Mr. Ernest Cain, who had written the books about the two hurricanes, came to us and gave us an emergency home on Racecourse Street, next to the bridge across the canal, which I think was known as Brooklyn Bridge. Mr. Cain was a fine and upstanding gentleman, a man of dignity.

One of his sons (or nephews, I'm not sure) owned a printing business on New Road. I never met Mr. Herbert Cain, Mr. Ernest Cain's brother who had been a major player in the Cain newspaper, which was called THE BELIZE INDEPENDENT.

In the Garveyite era in the first part of the twentieth century, the population of British Honduras, especially Belize Town, the capital, was overwhelmingly black, as we can see from an examination of the 1919 uprising in Belize Town.

It was still challenging to be a "Spanish" (Mestizo) in Belize Town when I was growing up in Belize City in the 1950s. Boxing was one avenue through which Mestizos, such as the late Hipolito Bautista, Sr., would show their courage and mettle, and gain respect

I can't understand how the story of the Cain family has just disappeared from the annals of Belize's history. I suppose it was my personal responsibility to record the Cain story, but Paul Cain, a star of the family, whom I got to know through Stretch Lightburn, was living and working in Los Angeles at the time. So, that's my excuse.

I've been in public life here since 1969, and none of the big boys ever asks my opinion of this self-inflicted genocide which is taking place amongst our black youth. I'm not begging for attention: what I'm doing is pointing out that there is a racist power structure in place here which Belizeans pretend they cannot see. That power structure branded me a pariah from 1969, but it will take them a little while to "disappear" me from Belize's history. There is stuff down in black and white. They will have to resurrect Diego de Landa. I'm just saying.

"En sus religiones, los americanos eran paralelos al resto de la humanidad. Cada religión deriva su forma y color de la mente de los adoradores, para que por sus dioses podamos conocerlos. De las naciones elevadas emanan castas y refinadas concepciones de la deidad; de naturalezas brutales vienen concepciones rudas.

"El cristianismo es la más elevada y pura de todas las religiones; pero si estudiamos los preceptos morales de las naciones americanas más destacadas, veremos que en muchos aspectos no se quedaron atrás, y de hecho en algunos casos se adelantaron al cristianismo.

"Es cierto que los aztecas practicaban el sacrificio humano, con todos sus horrores concomitantes; pero ¿qué eran las guerras religiosas, la expulsión de los judíos, la matanza de los infieles, la quema de los herejes, sino sacrificio humano?

"Además, mientras nos alejamos con horror de la piedra de los sacrificios de los aztecas, donde las víctimas humanas eran tratadas como dioses y desde donde sus almas eran enviadas directamente al Paraíso, sin embargo, encontramos entre ellas poco del más infame de los crímenes, la persecución por la opinión, tampoco leemos que su ingenio haya sido puesto a prueba por la invención de máquinas de la tortura más insoportable, como lo vemos en la historia del cristianismo, torturas que, mientras mataban el cuerpo, se creía que consignaban el alma a agonías eternas."

La cita en la parte superior de esta

columna, de Hubert Howe Bancroft, no es totalmente relevante para el contenido central de esta columna, pero la religión ha ocupado el primer lugar en los temas de discusión en Belize en los últimos meses, principalmente debido a la movilización de iglesias cristianas aquí para evitar que el Gobierno de Belize proponga la legalización de la marihuana. Además, un destacado pastor cristiano, Louis Wade, Jr., ha sido elegido por sus colegas de los medios para representar a los medios en una nueva comisión de reforma constitucional.

Debido a la importancia de la reciente discusión sobre la religión, pensé que era importante presentar el argumento de Bancroft de que el cristianismo, históricamente, ha sido tan bárbaro, y a veces más, que algunas de las religiones indígenas en las Américas que históricamente han sido acusadas por dichas creencias cristianas.

Hoy, quiero contarles sobre una parte de nuestra historia en este asentamiento de Belize/colonia de Honduras Británica: una vez hubo aquí una familia negra que era propietaria de un periódico, imprentas y escribía libros sobre temas tan críticos como los huracanes de 1931 y 1961.

La familia Cain estuvo en el apogeo de su prestigio y poder durante la era Garveyita en la primera parte del siglo XX. Eran dirigidos por dos hermanos, si mi información es precisa, Herbert y Ernest Cain.

Cuando se fundó la Asociación Negra Unida para el Desarrollo (UBAD por sus siglas en inglés) en febrero de 1969, abrimos una oficina en el número 45 Hyde's Lane, en un edificio tipo almacén. Nuestro arrendador era un beliceño chino, creo, y ese arrendador fue rápidamente presionado por el gobernante Partido Unido del Pueblo (PUP) y dio aviso a UBAD que tenía que mudarse de su edificio.

Recuerdo claramente que el Sr. Ernest Cain, quien había escrito los libros sobre los dos huracanes, vino a nosotros y nos dio una casa de emergencia en la Calle Racecourse, al lado del puente que cruza el canal, que creo que se conocía como Puente Brooklyn. El Sr. Cain era un caballero fino y honrado, un hombre de dignidad.

Uno de sus hijos (o sobrinos, no estoy seguro) era dueño de una imprenta en New Road. Nunca conocí al Sr. Herbert Cain, el hermano del Sr. Ernest Cain que había sido un actor importante en el periódico de Cain, que se llamaba THE BELIZE INDEPENDENT.

En la era garveyita de la primera parte del siglo XX, la población de Honduras Británica, especialmente la Ciudad de Belize, la capital, era abrumadoramente negra, como podemos ver en un examen del levantamiento de 1919 en el Municipio de Belize.

Aún era un desafío ser "español" (mestizo) en el Municipio de Belize cuando crecía yo en la Ciudad de Belize en la década de 1950. El boxeo era una vía a través de la cual los mestizos, como el difunto Hipólito Bautista, Sr., mostrarían su coraje y temple, y ganarían respeto.

No puedo entender cómo la historia de la familia Cain simplemente ha desaparecido de los anales de la historia de Belize. Supongo que era mi responsabilidad personal registrar la historia de Cain, pero Paul Cain, una estrella de la familia, a quien conocí a través de Stretch Lightburn, vivía y trabajaba en Los Ángeles en ese momento. Entonces, esa es mi excusa.

John: "That's very kind of you, Ma'am, I'll pass, I'll be there."

They hung up and continued their journey. Around 7:00 p.m., John arrived at Susan's house. They parked the truck in the yard, got out, and Susan came out excitedly to greet them affectionately and invited them to come into the house. Once there, she ushered them into the dining room and they took a seat. She served both John and Tony and sat down at the table as well.

Susan: "John, aside from the invitation I gave you, I wanted to

talk to you."

John: Yes, Ma'am, tell me. I'm all ears."

Susan: "Look, I heard you had a meeting with the alcoholic people at Rainbow Beach."

John: "Yes, it is indeed so."

Susan: "And how was the meeting?"

John: "Well, it was fine. I'm just going to have another one. There's a little problem that, well, I don't know how I can help those people to get out of that mess they're in."

Susan: "It seems to me that it is very difficult. Since I don't know if there is a rehab centre here where they could be placed in order to help them so they can care for themselves. You know that they can only do so if that person wants."

John: "Yes, you are right, Ms. Susan."

John: "Yes, you're right. It's a social problem, and I don't think the government has funds to open some sort of rehabilitation center to help these people."

Susan: "I think you're right. But can you imagine how much money the company earns?"

John: "Well, I can't imagine."

Susan: "About how many people went to your meeting?"

John: "About 70 people, I think."

Susan: "Seems, it wasn't all of them. I mean, while you had your meeting,

those 10 were at my taco stand."

John: "Yes, well, we don't know how many there are."

Susan: "Can you imagine in all of Belize, how many there are of those?"

John: "I wouldn't know. I don't think they've done any head counts or recorded how many of those people there are."

Susan: "It's not just them. There are also people who are economically stable who buy it. They are people with money. I don't know what that thing contains that is so addictive. Can you imagine, John, that there were 50,000 people in the country of Belize that took that thing and each consumed 3 daily. How much money would that be per day?"

John: "At least, it must be about \$750,000."

Susan: "And per month?"

John: "It would be approximately \$22,500,000."

Susan: "And how much does the government earn in taxes?"

John: "I wouldn't know. I've never realized they charge tax for it. I have no idea. Well, it's a big deal."

Susan: "Yes, it is a great business for the company and I doubt that they will stop producing that article that these people like so much."

John: "You are right."

Susan: "And I don't know if the company gives anything in exchange for that damage that is being caused not only to some people but also to the country."

John: "Yes, I think you are right, Ma'am."

So, they continued talking. They finished eating; he thanked the lady for the tasty food and left. They hit the road again. After that conversation, John kept thinking about what the lady had told him, and said to himself, "I think I'm going to talk to the boss. Let's see what

In one of his most recent columns,

There is tremendous frustration in our land. Everywhere there is violence, and this has prompted our authorities to copy the El Salvador blueprint with a recent roundup of persons believed to be involved in criminal business. We can expect local human rights activist lawyers and intellectuals to holler foul, and maybe we will get some bruising in the foreign press as the defenders of human rights reach out to add clout to their cause.

If he hasn't, Brother Canul needs to explore our justice system and its giant failure in all of this. Foolishly, Belizeans embraced criminal lawyers when they started beating the system in the courts. Oh, we were quick to blame the police. In truth, they had a big share in the problem, a number of them being corrupted because of the insane drug

laws. But the big fault is the system. We shouldn't cheer for the acquittal of a person accused of murder. On every acquittal we must lament; if not the accused, then who?

Justice died in Belize when we got independence. There are a number of reasons why civilians become violent, many of them economic – poverty, disparate wealth, and corruption. The number one cause for people becoming violent is injustice, and the worst injustice is unpunished violent crime.

We have been averaging nearly 125 murders per year in our little country over the last two decades, with less than 200 convictions. What an unjust country we live in. If we kept a record, the most used term in these past two decades within our justice system would be *nolle pros*, insufficient evidence.

I would like Brother Canul Luna to explore what fellow *Amandala* columnists Janus and I recommended to fix this justice disaster. Janus, in his "New Jurisprudence," said the defense and the prosecution must work together in all murder cases, and he wasn't talking about the little fraud thing they do in evidence sharing

I suggested that we build a comfortable prison specifically for individuals who would have been let go on the *nolle pros*, the insufficient evidence. I suggested that

the state hire a battery of lawyers and detectives totally dedicated to unearthing new evidence in these cases. No one should walk away from a murder charge for iffy reasons. We need every stone to be turned in cases where blood is shed.

Worse will follow molasses truck accidents if we don't step in

It was a disappointing decision by ASR/ BSI to truck sugar instead of ship it by river and sea. No one can be happy about the wear and tear increased trucking will cause on the highways, and the worry that more huge trucks on our highways will lead to more accidents. No amount of prayers can stop the road wear and tear, and they aren't working in accident prevention either. ASR/BSI trucks have been involved in a couple spectacular smashups recently, fortunately neither fatal. We have to act before it gets worse.

We have a problem here, and luckily the remedy isn't expensive. After the most recent accident, Shawn Chavarria of BSI told Channel Five that the company is very conscious about safety, and among their safety measures are limiting and

monitoring the speed of their trucks. Chavarria said their trucks are fitted with GPS equipment so they can monitor their drivers from the factory, and they have set maximum speeds of 45 mph for truck drivers transporting sugar and 35 mph for molasses trucks.

We all know about the dangers of speeding, but you can also travel too slowly. Some years ago I told a story about my friend getting pulled over on the Mexican highway for driving at what he considered a brisk 45 mph. If you don't know about the dangers of going too slow, just get in a vehicle and feel the pain of traveling behind a big truck doing 35. Those BSI speeds won't work. They will cause traffic to gum up on the highway, and that will lead to frustration, and bad decisions will follow.

These big trucks need to travel at night, between 10 p.m. and 5 a.m. They'll need a fleet of drivers, so they can have a good rotation of fresh guys behind the wheels. They must select drivers who have good night sight and equip them with goggles that enhance night vision and every other aid that is available. They will wreck the roads, but the felony shouldn't be compounded by accidents too.

Amidst violence surge, Belize can't return to business as usual

On Emancipation Day, as I listened to and reflected on the deeply powerful and somber "I have a dream"



speech delivered by Dr. Martin Luther King in his quest for freedom and justice, a particular line echoed deeply in my mind. In the midst of recent escalating levels of violence in our jewel, I pondered the fact that King's speech also emanated when the U.S. had reached a breaking point regarding injustices committed against its black citizens. King's stern and resolute warning was that the nation could not go back to business as usual... "Those who hope that the Negro needed to

blow off steam and will now be content, will have a rude awakening if the nation returns to business as usual", he said.

Belize reached a most disturbing tipping point when we recorded our first mass shooting incident in Hopkins last weekend, in which almost a dozen persons were shot, including two who were fatally wounded in a crowded bar hosting a community dance. While it was bad enough that there has been relentless bloodshed on our streets as a result of targeted gang rivalry, this new occurrence of an unexpected, reckless, indiscriminate mass shooting in the peaceful village of Hopkins, not known for violence, has left Belizeans all over the country more deeply troubled. Clearly, this nation, which only a few generations ago was regarded as a "peaceful haven of democracy", has continued over recent years to be consistently ranked as one of the most

violent countries in the world.

Such an unprecedented level of violence has got to have all of us citizens insisting strongly to the government, the churches, civil society, business community, schools, and families, that if we are to avoid a further rude awakening, this nation cannot go back to business as usual. This is a national collective mental illness of crisis proportions that urgently needs to be addressed. There are deeply hurt, neglected, and violently angry people who urgently need healing interventions in order to prevent the further unleashing of the state of violence that they already have within them.


The current situation must be treated with extreme urgency, making it one of our highest national priorities to find every means necessary to devise the most effective national strategy to systemically address the problem of

relentless crime at the root level. If society's institutions remain apathetic to this level of violence and adjust their acceptance of this trend, it will, like cancer when left untreated, more aggressively spread and become more dangerous and destructive to our country. If this situation is not effectively addressed now, the more emboldened our criminal elements will become, the more difficult it will be to resolve.

As a Belizean youth, I do not get the impression that there has been a strong sense of urgency being collectively conveyed by our society's institutions to address this deepening problem. Instead, all institutions seem to be continuing business as usual, without a sense of urgency to devise as many plans as possible for effective targeted interventions to support the nurturing and transformation of values among youths. We should implement and increase programs that lead to empowering learning experiences in the school system; and increase the number of committed youth organizations to develop positive values and skills among youths; as well as the number of interventions for a decrease in abuse and violence within and among families. Collectively, these have deep impacts on our youth and are bound to escalate to future generations if this business as usual status quo continues.

Belizean youths across the country are left with many unanswered questions regarding the current state of affairs. Since then, over 1,000 youths (mainly black males) have been killed as a result of gun violence over the past few years. How many more would have to be killed before institutions awaken from their sleeping business-as-usual mindset? And if not now, then when? If not now, when will be the right time for us to amend our laws, judicial processes, and our failed justice system? If not now, then when will be the time to implement the strictest of intervention measures to nurture consistent mental/emotional health and wellness practices throughout our schools? If not now, then when will we come together as a society to plan and implement strong, effective systems in which criminals do not feel immune to the law: and commit increasingly atrocious crimes which put everyone at risk and compromise freedom, sense of security and way of life? When will be the time to invest in nurturing positive values, through sports, creative and expressive arts, and productive skills training among youths, especially those outside the school system? What type of nation is the adult population across institutions, leaving behind for us youths? Is the apparent lack of engagement by too many adults to stop this crisis, the legacy to leave for future generations?

At this critical juncture, we can no longer sit back and hopelessly and nonchalantly wait for the usual, slow, and inefficient process of our failed justice system to work. It has been proven time and time again that our system is hopelessly broken. A nation or state that cannot adequately provide



Man, 24, gets life sentence for murder of businessman Ruben Perez

BELIZE CITY, Mon. Aug. 1, 2022

On Friday, July 29, Keon Dennison, 24, was sentenced by Supreme Court justice Ricardo O'Neil Sandcroft to life in prison for murdering 47-year-old businessman, Ruben Perez in 2015

A 2015 AMANDALA article reported that the incident, which took place in November of that year, was captured on surveillance camera footage. In the footage, Dennison and Tyrone Reid, a Belmopan resident, were seen entering the premises of Perez's business, Perez Hardware Store, at the corner of Vernon Street and Western Avenue.

At that point, the footage shows Perez getting up from behind his desk, where he had been sitting, with his phone in his hand. He walked towards the entrance of his business, where Reid and Dennison, who were seen entering the establishment, began a struggle with him.

During that struggle, Perez was shot twice – once in the abdomen and once in the head. After he was shot, his assailants fled the scene on bicycles, but they returned and stole Perez's cellphone, after which they headed in the direction of Lord Ridge Cemetery, on the George Price Highway.

Dennison had been on remand at the Belize Central Prison since his detainment five years ago, and in May of this year, he was tried by a judge without a jury and was found guilty of the crime. On Friday, Dennison was given a life sentence by Justice Sandcroft and will serve 20 more years in prison before becoming eligible for parole.

Crown Counsel Riis Cattouse prosecuted the case against him.

His accomplice, Reid, who had

pleaded guilty to the crime, was also given a life sentence without the possibility of parole until after serving a total of 25 years (including his time

on remand) in prison.

Dennison and Reid were 18 and 19 respectively when they murdered Perez.

justice and protection for its citizens is a failed state. This nation is at a critical juncture. The time to act in transformative ways and also to find ways to resolve this national crisis of violence is now.

Government officials, Minister of National Security, Commissioner of Police, church leaders, civil society, the business community, please let us see you act effectively to bring forth the interventions that are necessary. While youths are seeking answers, you all have the experience, or ought to, to bring this dangerous societal decay to a halt. How can we call our society a free society if we all live in a society where citizens are increasingly fearful to exercise their constitutional freedoms without becoming a victim to violence?

The time is now to devise a collective and inclusive national intervention plan without the divisive bickering that has added to the chaos in this country. The process should include relevant local and international stakeholders at the table to discuss how we can most efficiently and effectively reduce the prevalence of violence and its inclinations by way of anger, jealousy, envy and hatred in the homes, schools, offices, and wider community. Let us also find ways to heal personally and collectively, knowing that verbal and physical violence inflicted against others mainly come from persons who have deep wounds buried in the mind that can be triggered mindlessly if not healed. Every possible avenue for rebuilding our nation, including lessons learned from abroad, must be

looked at. The tendency to rely mainly on the Police Department to solve this very complex multidimensional issue is short-sighted and will continue to show failure, even when manpower is increased. This is far more than a police problem. It requires efforts at various levels of society, all working in unison with a strong, sustained sense of urgency, and a passion that we are undertaking a mission on which our lives and that of future generations literally depend, and we cannot fail. There must be a renewed effort with the strongest conviction of all institutions that we can and must do all that is necessary to break this destructive cycle of violence. Just as resources were secured to pave even the remotest highways in this country, such resources must be found to pave a new social environment where Belizeans can learn to respect and enjoy individual and community life in peace and harmony.

SOE declared in Lake I

BELIZE CITY, Tue. Aug 2, 2022

Gang members and affiliates embroiled in an ongoing, bloody rivalry in the St. Martin de Porres community were caught off-guard Saturday morning when police officers stormed into the area and trucked them away for 30 days of detainment at the Belize Central Prison. It was a State of Emergency (SOE) that was put into effect in an effort to staunch the bloodshed that's been taking place as a result of a feud between the PIV Bloods and the Back-a-Land Crips that most recently led to the execution of former PIV leader Darren Banks last Monday near Ebony Street. Of the 80 persons on the list of individuals being sought by police, between thirty and fifty-five persons (possibly more) have so far been detained under this latest SOE. Members of the Belize Defense Force are also assisting the police officers who have been deployed in the area.

"As you would know, there is an intense feud between the Back-A-Land Crips and the PIV Bloods, and that feud

"We are ensuring that we have police presence at every corner of the city as best as we can. Yes, the emphasis now is on the St. Martin's area... The regulation for the State of Emergency do give the police a number of powers; we are not going to exercise all those powers unless there is a need for us to do so, and it will only be exercised against those rivaling groups and not the law-abiding citizens," Commissioner of Police, Chester Williams said on Saturday.

has resulted in many shootings, two of which have been fatal," Commissioner of Police, Chester Williams told local media in a Saturday morning interview. He went on to note that those shootings have taken place despite pledges by members of the warring groups to "hold the peace" after mediation sessions carried out by the Leadership Intervention Unit (LIU), which has staged a number of interventions in an attempt to broker some truce between those groups.

The SOE will last for 30 days, and might possibly be extended, depending on how the individuals who have been rounded up, respond to the detainment

and mediation efforts.

"We ensure that we capture also the Back-A-Town area. As you would know, Back-A-Town is a close affiliate of the PIV, and we also capture Mayflower, because Mayflower is a close affiliate of the Back-A-Land. So we tried to see how we can get the different groups that are involved in this feud, and to let them go to prison and hopefully while they are in prison they should be able to cool off," Williams said.

He said that the area in which these individuals reside is difficult to police during times of flare-ups because of the proximity between the zones in which the

various groups operate.

"As a matter of fact, some of the opposing gangs live in the territory of the rival group, and so it is extremely hard for law enforcement, so we think at this time the State of Emergency is the best solution to be able to bring to the situation under control, and I want to send a sound warning, to the other groups who are holding it down at this time. If it is that they choose to go down this path, then they will face a similar fate," Commissioner Williams went on to say.

In response to the news that PC Alicia Trapp intends to take legal action against him, Commissioner of Police Chester Williams says that, while "anybody can sue", there is no guarantee that PC Trapp's lawsuit will be a successful one.

"I have gone through the fixed date claim form which was filed by her attorney, and I can say certainly that is not going to hold water. No way," said Commissioner Williams to our colleagues at KREM last Saturday.

The civil suit filed against the Commissioner, the Attorney General, and the Belize Police Department by PC Trapp's attorney, Orson "OJ" Elrington last week, claims that the disciplinary action being taken against her as a result

of comments she made on Facebook live video following an altercation with the Minister of Infrastructure and Development, Hon. Julius Espat, was "discriminatory" and goes against her constitutionally protected rights of freedom of expression and freedom of political opinion. PC Trapp is demanding a declaration from the court that the Police Department unfairly restricted her constitutional freedoms and that the disciplinary action is unlawful.

In June of this year, Trapp was involved in a confrontation with Minister Espat during the Teakettle village council elections. Shortly after, she began a livestream on Facebook, during which she claimed that Minister Espat had insulted her and pointed his finger in her face. Days later, she went on to allege that the PUP Minister had verbally and physically assaulted her. Those allegations were dismissed after witness statements and pictures taken during the altercation showed that Trapp, and not Minister Espat, was the apparent aggressor.

While Minister Espat did not press criminal charges against the police corporal, she is currently facing a disciplinary tribunal for violating the Police Department's social media policy by going live on social media for political reasons.

In a letter sent to the Commissioner of Police in June, attorney Orson Elrington had indicated that any attempt by the Department to punish his client would be met with "swift legal action."

The Police Commissioner and the Police Department are expected to be represented in court by the Attorney General's office. Commissioner Williams has expressed confidence, however, that Trapp's suit will not go very far.

"Anybody can sue. The thing is how far it is going to reach. And I cannot hold anything against her attorney for doing what he is doing. That is his job—he's been paid to do that—and I can't hold it against her, she's exercising her rights. The matter is going to the courts and the court is going to determine the matter in terms of whether or not what is being claimed is correct or the action we took is right. So, it's a matter for the court to decide," said Williams.

ILLINOIS, CHICAGO, Tues. Aug. 2, 2022

The family of 22-year-old Christopher Williams, a Belizean who moved to the US at the age of 12 and attended high school in Illinois, Chicago, where he lived with his aunt, is mourning his death after he was shot multiple times during a gas station robbery while he and his cousin and her boyfriend were purchasing gas.

Williams' aunt, Michelle Walford, who also resides in the US, described to a local media outlet the series of events preceding her nephew's death. She told them that while Williams, her daughter and her son-in-law were purchasing gas at the gas station in Beach Park on Tuesday, July 26, a gunman entered the establishment and demanded their belongings.

When they told the robber that they didn't have anything, he reportedly fired a barrage of bullets at them. Christopher was hit four times, while Walford's daughter was hit twice in the

leg and her boyfriend was hit three times in his back.

Christopher Williams succumbed to his injuries on Thursday morning at around 7:15.

"He was humble. Nobody thought Christopher could even talk, because he was not the talking kind. He didn't have any friends that we know of. His friends were his girlfriend, his brotherin-law, and my kids. Those were his friends. Those were the only people I know of that he would always be with, so when this happened it was a shock to us," Walford said.

The family of Williams has opened a GoFundMe account in an effort to raise funds to bring his body home to Belize for burial in Lords Bank village.

On the 22nd of August, Williams would've celebrated his 23rd birthday.

Life in decades!

A friend of mine called me the other day, asking me if I remember a murder that happened behind the Continental Club on Freetown Road, in the late 60s, early 70s. Of course I had; it was such a rare occurrence back then, that of course it sticks out. You know, we go through life, living and working and becoming responsible adults, and before you know it, we're up there in years. You start wondering, where did all that time go? Of course I won't mention who committed the murder or who the victim was—families and all that, would be upset, bringing up the bodies, so to speak.

After I hung up following the call from my friend, I started to divide my life into decades, starting with the 1950s to present day. The first two decades were the longest, transitioning from childhood to youth. What I recall of the 1950s was that I lived in 4 different places, went to 4 different schools, 4 different sets of friends. One of those friends was Pete Soberanis, whose grandfather had a barbershop right next to British Honduras Broadcasting Service, on Queen Street. A kindly old man to me. It's only later on in life I learned what a special man he was, what a national treasure! The 50s seemed to last for a lifetime—growing up, those formative years, when you held everything before you, in awe, no matter how slight or trivial the experience was.

The 1960s! What a decade! Also

drawn out while one experienced adolescence, puberty, girls, and more lasting friendships, through primary to secondary schools. The decade that innocence was lost, up to a point. But it dragged on, and I for one, never wanted it to end. It was the perfect time, at least for me.

Then came the 70s, 80s, 90s, up to present day, almost a blur because of the quickening pace of the years, of life, of living. A year seemed like 6 months, as if though time itself was moving at breakneck speed. You could hardly catch your breath before something new distracted you, spared you the experience of a boring existence! Your life changed, for the better, mostly, with family, kids, a great education and a promising career! You patted yourself on the back! Doing a great job, pal!

Then one day you realize that you are much older, much wiser, and that you can feel autumn in the air. That smell of promises of a great retirement, healthy, happy, fulfilled! Not for all of us, but definitely for some. You realize that things that used to be important, that mattered greatly to you, don't anymore. You have lived long enough not to dwell on the small stuff. It's time for comfort and relief! Just go with it. Some of us try to relive our youth, our lives! We can't! Just go with it.

SIB: June inflation rate was 6.7%

Out of all municipalities, Orange Walk Town, once again, reported the highest rate of inflation, while Independence village reported the lowest.


The Statistical Institute of Belize (SIB) has revealed that the overall national inflation rate for June 2022 was 6.7%, primarily due to an increase in consumer prices for motor vehicle fuels, food, and liquid petroleum gas (LPG), which are notably higher than what they were in June 2021. The Consumer Price Index report released last week also pointed to increases in the cost of transportation services, restaurant services, entrance fees to cinemas, and household cleaning products as well.

As has been the case in previous months, a surge in prices of products in the "Transport" category, which

includes fuel pump prices, was the main contributor to the inflation rate. This time around, it accounted for almost half of the overall increase in consumer prices, with average prices up by 27.7% when compared to June of last year. The price of premium gasoline registered the highest increase, having gone from \$11.76 per gallon in June 2021 to \$15.87.

Additionally, said the SIB, passenger transport services were up by 13.8%, as higher bus fares, international airfares, taxi fares, and sea fares were seen across the country.

In the "Food and Non-Alcoholic Beverages" category, price increases for cereal products, including rice, flour, and bread; meats, including poultry, beef, and pork; cooking oils;



fresh produce, including watermelons, cabbages, and Irish potatoes; and dairy products, such as natural milk and eggs, also contributed significantly

to the inflation rate.

LPG prices, which come under the category of "Housing, Water, Electricity, Gas and Other Fuels" were 27.1% percent higher than they were in June of 2021, with the average cost of a 100-lb cylinder of gas rising from \$113.02 to \$143.67. Furthermore, prices for construction materials for household use were up by 14.3%, while rent was up by 0.6%.

The only major category within which a decrease in prices was recorded was "Information and Communication". This is owed to a decrease in the cost of internet services.

When it comes to inflation rate by municipality, Orange Walk Town, once again, reported the highest figures, with a rate of 9.6%. (It stood at 9.4% in April and 9.7% in May). This was attributed to increases in the prices of food items, home rental costs, restaurant services, laundry products, soaps, detergents, women's clothing, and haircuts in that locality. The lowest inflation rate—5.1%— was recorded in the village of Independence.

In May, the national inflation rate stood at 6.6%, while it was 5.8% in April.

The SIB also issued a report on the country's imports and domestic exports for June 2022, noting that imports were up by 19.8% while exports had increased by 112.5%. According to the SIB, total domestic exports increased by \$31.1 million—going from \$28.1 million in June 2021 to \$59.7 million in June 2022. The main driver for this increase was sugar, with earnings from the industry more than tripling. According to the SIB, this was due to the fact that a bulk shipment of sugar was recorded this year, while no shipments were made in June of last year.

Other gangs in other areas will be monitored closely during this time as well as the Police Department embarks on an effort to prevent any outbreaks of gun violence in other parts of the city, COMPOL Williams said.

"The George Street, Rocky Road, Jump Street area is still of concern to us, likewise the [inaudible] Extension area. We know that they have had their flare-ups as well, and we are watching them closely. If it is we see that they begin to rear their ugly head again, then we know what to do," Williams said.

Commissioner Williams assured the public that the police will not be exercising all its powers under the SOE this time around, and that an effort will made to limit the impact on the law-abiding citizens of the community. He did say, however, that "gang members will not be allowed to breathe."

"I want to assure the law-abiding

citizens that we will do what we can to ensure their safety and at the same time to make sure that they are able to move around their communities freely. The gang members will not be allowed to breathe. We will be right in their back, making sure that they are not given the opportunity to do what needs to be done, and those who are on our list of potential troublemakers will be detained," COMPOL Williams said.

Interestingly, Senator Michael Peyrefitte, who is the chairman of the United Democratic Party and its Shadow Minister for National Security, has made an explosive allegation. He is claiming that members of the Police Department are aware that the shooting of Alrick Smith stemmed from a matter of a personal nature and was not gang-related. He thus called into question the department's justification for the State of Emergency in the Lake Independence area. Peyrefitte claimed that the Minister of Home Affairs, Hon. Kareem Musa, signed a declaration

for what he (Peyrefitte) described as an unannounced SOE, which, according to Peyrefitte, was triggered by the murder of Alrick Smith.

He told 7News' Jules Vasquez, "I have good information, credible information, that the whole State of Emergency situation came about with the murder of Alrick Smith. There was a feeling in the department that once that murder took place that there would be some serious retaliation. The investigation, however, led the police to realize that that was not a gang-related

crime. It was a personal situation that led to that crime, and hence there wasn't the aggression and the press conferences and the usual barrage or blitz or police activity in that area, because they realize it was not gang-related, and even the gang elements in the streets were telling the

police this is not gang related, this is personal."

In response to these allegations, Commissioner Williams, when interviewed by reporters yesterday, said "Mr. Peyrefitte was the Minister of National Security with three SOEs under his leadership, and everyone, including you, the media, who are not lawyers [and] who have never been the Minister, you all know that when it comes to [the] State of Emergency, the Minister of National Security or Home Affairs [does] not sign any declaration. The declaration of an SOE is signed by [the Governor General]. For him to say that the Minister [Kareem Musa] signed a declaration for the State of Emergency again is total nonsense. To make matters worse, he said that it was called unannounced. For Christ's Sake, have we ever announced [the] State of Emergency? Have we? If you announce it, you defeat the purpose. You will be alerting the people who are supposed to be picked up in the SOE that you're coming for them and they'll go on the run. He knows better!"

For his part, Minister of Home Affairs, Hon. Kareem Musa, said, "Very quick action had to be taken. We had received very reliable information that certain retaliation would have taken place, and so I believe it was Saturday morning, it was imposed, and if it were a weekday, I'm sure the media would have had an opportunity to interview us, but it happened on a Saturday morning, following the Friday shooting. And so, that is the reason why."

Traffic officers in new Enforcement Department granted the power to arrest

Starting this month, residents of Belize City can expect to see greater enforcement of traffic laws, with the creation of a new Enforcement Department and the issuance of tickets for parking meter violations.

BELIZE CITY, Tues. Aug. 2, 2022

The Belize City Council will begin to increase the enforcement of traffic laws this month with the establishment of a new Enforcement Department, created through the merging of the Traffic Department and the Special Constables Unit. As a part of the merger, 43 traffic wardens were sworn in as Special Constables and equipped with the power to make arrests this past Friday.

According to Belize City mayor Bernard Wagner, the goal of the merger is to strengthen the traffic department's enforcement team and ensure that there is a unit that can effectively respond to traffic infractions.

"Every day we see the infractions. Some of them are minor infractions. Some of them are larger infractions, but clearly, we need to change the culture in the city with respect to all types of infractions. The driving of vehicles on the sidewalks, the traffic violations, the running of the red lights, the buses in the evening time, those need to be curbed—and the only way we could curb them is to have a more effective and efficient group that now has the power to arrest," said Mayor Wagner to reporters after the swearing-in ceremony held at the House of Culture.

During his speech at the ceremony, the Mayor noted that many traffic

officers have complained that residents often show them no respect. The launch of the new department, he added, may very well be one of the most important initiatives taken on by the Council. He

told the media that, now, those officers, and the entire department, are in a much better position.

"Previously, we had traffic officers who didn't have that power to arrest. All they had was the ticket. That clearly nuh mi di work, and so we felt that by giving them now that teeth of the power of arrest we are in a much better position," he said.

The 43 new Special Constables were trained by Senior Superintendent Leslie Wade, the Director of Training at the Police Training Academy in Belmopan. Their training sessions covered a broad range of topics, including constitutional rights, road traffic law, powers and methods of arrest, report writing, and intoxicating liquor license.


Officers who were already part of the former Special Constables Unit also took the training which, according to the Belize City Council, served as a refresher course.

The new Enforcement Department features four units: the Traffic Unit, the Internal Security and Discipline Unit, the Trade and Liquor License Unit, and the Parking Meters Unit. Those officers belonging to the Parking Meters Unit are expected to be hard at work as early as the first week of August, since the issuance of tickets for parking meter violations commenced on Monday, August 1.

In a public notice released last week, the City Council urged residents to continue familiarizing themselves with the parking meters as the pilot project period progresses. According to Mayor Wagner, the first quarter of the one-year-long project has been completed, and, so far, residents of the city are slowly adapting.

"We've received some of the data. We have over 700 hours of usage on the Albert Street side and about half on Princess Margaret by the DIGI Park side. But we're very comfortable with the usage," he said.

The Mayor also noted that the council plans on making some adjustments, including creating a "stop zone" for customers of the vendors located inside the DIGI Park.





Magnitude 4.9 quake on Honduras coast felt in Belize

LACEIBA, Honduras, Tues. Aug. 2, 2022 A moderate earthquake that occurred off the coast of Honduras was felt in some parts of Belize on Tuesday morning. According to the European-Mediterranean Seismological Centre (EMSC), the quake occurred some 89 kilometers (55.3 miles) northwest of La Ceiba, Departamento de Atlantida, Honduras at 9:17 a.m. local time.

The earthquake was listed as measuring 4.9 on the Richter Scale and did not cause any significant damage, although light vibrations were felt by persons located up to 122 km (75 miles) away from the epicenter.

The Caribbean HIV response is in danger

New data released by UNAIDS shows that despite the Caribbean's 28% decline in new HIV infections since 2010, new infections have trended upwards in Belize. An estimated 14,000 people contracted HIV in the region during 2021. That translates to 270 new HIV infections every week!

While the Caribbean has not had the increase in new infections experienced in other places, the rate of decline is far too slow. Thousands of avoidable HIV infections every year are making it harder and more expensive to ensure that the targets to end the AIDS pandemic by 2030 are reached.

Of particular concern is that onethird (34%) of new infections last year were among Caribbean young people ages 15–24. There were twice as many young women (23%) contracting HIV as compared to young men (11%). The new data also points to an increased risk for "key populations," including gay men and other men who have sex with men, sex workers, people who use drugs and transgender people. We are facing a prevention crisis. Every new infection is a hole in the HIV response bucket—a requirement for future resources.

Deaths due to AIDS fell by half in the region since 2010. Still, 5,700 people died of AIDS-related illnesses in the Caribbean last year. As of the end of 2021, 84% of people living with HIV in the Caribbean were aware of their status. (Belize was one of just a few countries in the region to have achieved at least 90% for this testing target.) Eighty-three percent (83%) of all diagnosed people were on treatment. Of these, 87% were virally suppressed. The Caribbean is currently below the global averages for both HIV

treatment coverage and viral suppression.

Viral suppression matters. A person living with HIV who sustains an undetectable viral load is unable to pass the virus on to others. It is therefore in everyone's interest to support people in getting tested, starting treatment early and achieving an undetectable viral load.

The human and financial cost of not ending AIDS by 2030 would far outweigh the cost of the immediate and necessary action to turn the ship around. The good news is that success is possible. We know how.

First, we must address the inequalities that stop people receiving HIV prevention, testing and treatment services. Even where HIV services are available, intolerance and worry about experiencing injustice can make people fearful to learn their status, make it difficult for them to access treatment and undermine their ability to stay the course. The cost of inaction is too high

a price to pay, and so leaders in the Caribbean must act now to save lives.

In diverse settings, countries and communities are taking action to end inequalities and close gaps. Building on this momentum, policymakers need to strengthen their understanding of localized epidemics to focus on eliminating the inequalities that are slowing progress against the pandemic. Jamaica became one of the first countries to join the Global Partnership for Action to Eliminate All Forms of HIV-related Stigma and Discrimination. This pioneering partnership between civil society, the State Minister of Health and Wellness and parliamentary leaders is working at the country level to translate this commitment into concrete action.

We must also work to realize human rights for all. Punitive and counterproductive laws and policies must be removed. Just recently, Antigua and Barbuda joined Belize, Guyana and Trinidad and Tobago—the growing list of Caribbean countries where discriminatory laws were successfully challenged in the courts.

We need increased commitment by governments to review the legal landscape and remove laws that are a barrier to the HIV response. More must also be done to establish positive protections, such as anti-discrimination and hate crime legislation while working to change prejudiced social attitudes.

We must make a new push for HIV prevention. Countries urgently need to elevate the political and financial prioritization of HIV prevention and move to large-scale implementation of prevention projects so that innovations such as pre-exposure prophylaxis (PrEP) become much more widely accessible, especially to the key populations. (PrEP is daily medicine taken by an HIV negative person who is at substantial risk to prevent contraction of the virus). In the past year, Guyana has shifted its policy, ensuring that PrEP is available nationwide to anyone who needs it, particularly those who are most vulnerable.

As part of this prevention push, we must ensure young people have the education and services they need to stay healthy. After decades of debate and commitments, the region still does not have a comprehensive and consistent strategy for giving all young people the knowledge and support required to stay HIV-free. This entails providing comprehensive sexuality education, youth-friendly sexual and reproductive health services as well as psychosocial support to address the specific needs of at-risk youth.

Ending AIDS is a political and social choice. This is a promise we must keep.



Mexican busted with crystal meth

BELIZE CITY, Mon. Aug. 1, 2022

On Thursday, July 28, a Mexican construction worker from Guanajuato, Mexico, was caught with 9 kilos or 8,913 grams of crystal meth by members of the Belize Police Department and the Belize Defence Force in the Ramonal area of Patchakan Village in the Corozal District.

According to police reports, at around 1:00 o'clock that afternoon, law enforcement personnel who were on patrol in the area, where an illegal border crossing is located, saw Lagunas standing in some bushes with two bags in his hands. Upon sighting the officers, Laguna reportedly attempted to flee, but the officers followed him, and they were able to

apprehend him about 100 feet away from the area where he had been spotted.

The officers then looked into the bags Lagunaa had been carrying, but they did not see marijuana or cocaine—which have many times been found during busts in the area. Instead they saw four aluminum cylinders, and inside each of those cylinders were two transparent

plastic bags that contained a substance that the officers suspected to be crystal meth (short for crystal methamphetamines).

On the following day, Lagunas appeared in the Magistrate Court and was charged with possession of controlled drugs with the intent to supply to another. He was then remanded to the Belize Central Prison.



motionless when he was found.

According to an initial police report, Chun was last seen on Saturday heading to Mafredi Village on his motorcycle prior to the accident, and at about 6:00 a.m. the following day, he was found dead on the road by a passerby.

Police are also investigating another motorcycle accident that occurred at Mile 6 on the Hummingbird Highway in the Stann Creek District. The victim, Desmon Bernard, a 48-year-old Belizean truck driver of Havana Street, lost control of the motorcycle he was riding, which collided into the guard rail of the Southern Highway.

Reports have indicated that Bernard was test driving a Suzuki 1000 Ninja motorcycle on a journey from Dangriga toward Belmopan when he was flung off the motorcycle after he allegedly lost control of the bike, which crashed into the guard rail of the Southern Highway.

Bernard sustained head and body injuries and was transported to the Southern Regional Hospital, where he passed away due to his injuries while receiving treatment.

Heads up, and thanks for a great effort, Belizean girls!



that industry off the ground to a sudden halt.

The referendum, which was set to take place by early September, has been put on hold after the government and churches agreed to hit the pause button. When recently interviewed by local reporters, Prime Minister Hon. John Briceño said that his Minister of State in the Ministry of Finance, Hon. Chris Coye, had a meeting with key players in the banking community who expressed concern over the legalization, and how the industry could affect correspondent banking relations.

Minister of New Growth Industries, Hon. Kareem Musa, for his part, has acknowledged those concerns and how critical it is to preserve correspondent banking relations in Belize, but pointed out that the cannabis industry in Belize would be entirely cash-based—meaning revenue from the cannabis and industrial hemp industry would not be deposited in, or handled by, local banks with international correspondent banking relationships.

He noted that it had always been the intention within his ministry to have the cannabis industry operate on a cash-only basis, and he went on to point to the fact that the industrial hemp industry, among others in Belize, is considered cash-based.

"Correspondent banking is a live issue at all times for Belize and for the Caribbean, but what I can tell you is that countries like Jamaica, and Antigua, are moving towards it; Trinidad is about to pass their legislation, and St. Vincent. Those countries are moving toward the legalization of cannabis. As I always say, it is a cash industry, so when you ask me about banking—banking does not necessarily come into the picture unless you are banking your cannabis dollars," he said.

He further noted that even the United States' cannabis industry is a cash-based enterprise.

"In the Caribbean and the great United States, where it is a 92-billion dollar industry, it is a cash industry, so individuals who are engaged in the cannabis sector do not go

and deposit their funds within the banks. That does not happen even in America," Hon. Musa said.

Minister Musa went on to suggest that maybe a local institution with no international correspondent banking facility may be an option for the handling of earnings within the industry.

He pointed out, however, that the greater concern at this juncture of the process is the cost of the referendum, which the government has already set aside \$5 million to cover in a recent supplementary appropriation. The process of having Belizeans vote on whether they support or oppose marijuana legalization, however, could cost much more than what was budgeted, and has caused the government to decide to stall the process.

"The real point is that it is a costly referendum, and so it's \$5 million it would have cost for us to do this referendum, and to me that is the real reason, but at the same time as we put a pause on the legislation, we have time to tighten up whatever loose ends there may be in terms of correspondent banking, but in my respectful opinion that will never be tied up," Minister Musa outlined.

He also indicated that the government and other stakeholders will have to figure out a way to work around the global banking reality facing the cannabis industry.

"We will have to figure a way—whether it [be] opening community banks or credit unions that do not have correspondent banking in order to bank the dollars here in Belize. That is the solution, and there are several international companies who have expressed interest to come and open these community banks here, so there are solutions to that, but like I said, the primary concern at this time is the cost of the referendum," Hon. Musa said.

Minister Musa emphasized, however, that commercial banks in the country would need to do additional due diligence to ensure the funds being deposited at their institutions are not proceeds from the cannabis industry—a concern that had reportedly been raised by one of the country's major banks.

"What it does is that it imposes obligations on the local banks to do their due diligence to make sure that the funds that they are receiving are not related to, whether it is a cultivation license or a dispensary license, the banks just have to ensure that they are not receiving funds from the cannabis-related businesses. There are several other cash industries already in existence in Belize; for example, the cattle that we transship to Guatemala, tobacco, and the cigarette industry at the Free Zonethat is a cash industry. The hemp business right now in Belize ... the funds received in relation to that industry is not accepted by the banks, and so cash industries are normal in Belize. We have to understand that, but there is a greater concern, because there is so much revenue to be earned from cannabis that in fact, the local banks are saying, 'we want to make sure there are no issues for us'," Hon. Musa outlined.

For now, however, the legalization of cannabis in Belize is on pause.

Late this evening, the churches and the Government of Belize released a joint statement which made that pause in the holding of a referendum (and the legalization of marijuana) official. The release states, "The Church Leaders on behalf of the petitioners and the Government of Belize request of the Governor General to defer the issuing of the Writ of Referendum until a date to be determined."



gunfire, was also shot. (According to some reports, he stumbled over a body during that attempt to save lives and was shot by the gunman when he fell onto the floor.) The other shooting victims, including three police officers who were transported to, and treated at, the Southern Regional Hospital, all are listed as being in stable condition or have been released.

This incident is only the second instance of a mass shooting in recent Belizean history, according to Commissioner of Police Chester Williams: in 2008, 14 persons were shot at the Putt Putt Night Club in Belize City. But this shooting, unlike that 2008 incident, occurred in the fastestgrowing tourism hub and vacation spot in southern Belize—Hopkins village, known as a destination that offers visitors peace of mind within a tranquil community.

Commissioner of Police, Chester Williams has told reporters that the bloody incident, which took place sometime after 1:00 in the morning, stemmed from an altercation between the three accused shooters—Brian Andrews, 28; Kenyon Moore, 25; and Sherwin Moore, 35—and the first victim, Noah Moro, over a woman toward whom the three men had made



them to not cooperate with police, and said that police were not able to get much information from the men due to that lack of cooperation.

"The attorney told the accused men not to cooperate with police investigators, and so they all choose to remain silent during the entire interview process. Notwithstanding that, we do have sufficient evidence, based on eyewitnesses, as well as video footage, to indicate that these three young men are the culprits in respect to the shooting in the Wabinaha Night Club

advances. According to Compol Williams, Moro, who was with the woman, approached the men, and it was this act of intervention on his part that marked the start of the altercation. The men are said to have left and returned shortly after, being driven by a Canadian national since identified as John Roy Smith.

It was at that point, according to police, that they barged into the club, shot Moro fatally, and proceeded to engage in indiscriminate gunplay that resulted in a second death and injuries to 8 others before they left the establishment in a vehicle being driven by Smith. Police detained Smith shortly after the incident.

A glance at his Facebook profile will show a banner linked to the Canadian Army, and in his profile photo, if one looks closely, the three accused men can be seen alongside him. We have confirmed that he is a veteran of the Canadian army who has been retired for over a decade and moved to Belize just 6 months ago. He was reportedly residing in Sittee River, where the three accused gunmen also reportedly have lived.

On Monday, it was announced that the three persons believed to be the triggermen were captured near Silk Grass, and according to Police Commissioner Williams, at the time of their capture they were being driven by an attorney who indicated that he was on his way to hand over the accused to police. He was also taken in for questioning.

Commissioner Williams has accused the men's defense attorney of directing

by not having an adequate exit."

"It is clear that a 15-year-old should not be in a bar or nightclub, which must be reserved for adults. We call on law enforcement to fully investigate the management of the nightclub and to let the law takes its course for this grave infraction," a press release issued by the NCFC this morning states.

Compol Williams has noted as well that the police officers who were shot at the club—Superintendent Gerald Jones, PC Rudel Pau, and PC Pamela Zuniga—were only doing a routine stop and check and were not assigned to be security at the club. He said that the management instead had a civilian serving as a security guard. It has also been reported that no weapon searches were conducted on persons who entered the club.

Mass shooting in Hopkins: 2 | OSH Bill being revisited by BCCI, trade unions

So, instead of having what we were looking at—documents and Excel sheets and all of that in different parts—we've compiled all of that into the bill, so there's a marked-up version that unions are going to review," he said.

Blake informed the press that, after the unions have conducted a final review, the Bill's stakeholders will submit their joint position on it in writing to the Minister of Local Government (Hon. Oscar Requena) for consideration.

When the bill was first introduced eight years ago, the then Prime Minister of Belize, Rt. Hon. Dean Barrow, stated that while the objectives of the OSH Bill were "laudable", implementing it would come at a huge financial cost.

In the January 28, 2014 issue of AMANDALA, Barrow is reported to have said that "it is perhaps time, and maybe even overdue, that Belize makes this quantum leap forward."

"But, let nobody be under any illusion about the substantial burden and cost that will come to the Government, as regulator and employer, as well as to the private sector, including small business persons and self-employed individuals, who will also have to become compliant—even if they employ just one person," he added.

Soon after the bill was tabled, numerous stakeholders in the business sector and various industries raised concerns about various parts of it, including the proposed introduction of fines which, according to the BCCI, could easily cripple any small business.

Back in 2019, shortly after the tragic death of two construction workers at the Belize City Civic Center, the Belize Chamber of Commerce and Industry released a statement declaring that it fully supported and had always been committed to the passage of the Occupational Safety and Health Bill.

The two workers died after a platform on a scaffolding collapsed and sent six men plummeting to the floor that lay some 50 feet below them. The other four workers received extensive injuries. Jose Contreras, a witness to the tragic incident, told AMANDALA in an article dated Friday, September 13, 2019, that one man had pointed out the fact that the scaffolding was faulty, noting that the 2×6inch piece of lumber supporting the platform "had a belly" and needed to be replaced.

While the BCCI had called for amendments to be made to the bill, in its 2019 statement it also noted "the record will show that at no point has the BCCI ever opposed the Bill itself."

Today, the Chamber maintains that while it is important to continue to look out for employees and ensure that they are working in a safe environment, "it can't be to the detriment of businesses."

"Also in [the bill], it shares the onus of the responsibility, because the employee is just as responsible as the employer in cases where there are health and safety issues, and so it is important that we continue to ensure that our members are going to be adhering but also covered from certain levels of risk where the employee chooses not to utilize the resources that have been given to them by the employer," said the BCCI president.

Nunez was thus charged yesterday in the Dangriga Magistrate's Court for admitting the 15-year-old minor into the club and failing to provide a male and female security guard.

AMANDALA spoke to a resident of Hopkins who is the father of one of the shooting victims and who chose to remain unidentified. He was on the scene of the crime and confirmed that no police were on duty at the club at the time of the

"As I reach the club, like about 10, 15 minutes after that the thing happen. Good thing I was there, because if I never deh there, maybe it could mi be worse. It coulda mi be maybe one of my sons or me. I mi had a feeling and said, just make a goh. The guys they just pass, the mad dog everybody, they gone da the front door, and look like they mi got the thing plan long time. Dey gun mi already cock, gone da the front door and just start open up fire pan everybody and they send one da the back door, and the back door was close right, so there was no access for anybody get out, cause that padlock up. Da like everybody trap inna the place," the eyewitness told us.

He said that the front door was ajar, and that he was near the door when they kicked it open and began to shoot.

"I was right at the door, and I shet in the door. I end up stomp in the door make they nuh see nobody. He just start blast

ata the building, stomp open the door and start blast again. Da soh everybody start get it, and then I tell yo the next gunman, the next man run da the back door and he start shot through the back door too so nobody can't go front nor back, just have to take cover, lay down, and pray for the best," the eyewitness said.

The eyewitness, whose 18-year-old son was shot during the incident, said that two police officers arrived on the scene while the gunmen were still making their escape, but that those officers failed to take any steps to apprehend them. He said that he then rushed both his son and the wounded 15-year-old female to the

Interestingly, while the eyewitness acknowledged that he did see glimpses of an altercation at the bar of the club about 20 minutes before the shooting took place, he does not believe that the altercation over a woman at the club was the reason for the spiteful shooting.

While the motive for the shooting is yet uncertain, the Chairman of the Hopkins village council, Mr. Macario Augustine, wanted to make it clear that the incident, which took place on Hopkins Day, does not reflect what the community is about. "In regards to the unfortunate incident that occurred in our village last night, I want to assure the public that it is an isolated incident...", he said in a video message on the day after the shooting.
