# Caged and forgotten!

Derrick Uh, 20, was found dead after being detained and kept in a locked police van for over 14 hours. He was reportedly forgotten by the officers who confined him. "HE WAS LEFT THERE WORST THAN AN ANIMAL," his sister posted on social media.

COROZAL, Mon. Aug. 15, 2022

A family is seeking answers from the Police Department; their loved one, 20-year-old Derrick Uh, a resident of Cristo Rey, died after being detained and apparently forgotten inside a locked police prison van for almost 14 hours. According to reports, Uh was found dead around 5 o'clock on Sunday evening, after being inside the van from around 1:00 a.m. on Sunday morning, when he was confined, reportedly for

drunkenness at the San Joaquin Fair being held in Corozal.

The prison van was taken to the Corozal Police Station, where it was parked, but the victim, Uh, was never taken out of the van and placed in the cell block. The Commissioner of Police, Chester Williams, reported that two to three officers were involved in the detention, and somehow they all purportedly forgot that the man was still at the back of the prison van — their memory being jolted only after another officer found the youth dead,

reportedly with his lips swollen and with ruptures on its surface due to the sweltering heat.

"Yesterday evening, when the driver of the van, who usually takes the vehicle to prison to ferry prisoners went to service the van to make sure it was roadworthy for today, he discovered the lifeless body of the young man in the back


# Faber kicked out of UDP Central Executive

## BDF soldier dies while returning from colleague's funeral

Lance Corporal Roxanne Hill lost her life in a road traffic accident after attending the funeral of another BDF soldier, Private Micah Miguel, who reportedly took her own life.

The life of 37-year-old Lance Corporal Roxanne Goff Hill of the Belize Defence Force came to a tragic end on Thursday, August 11, at around 6:40 p.m. when the vehicle in which she and ten other BDF soldiers were traveling collided with a Toyota 4-Runner that was traveling in the

opposite direction near Cotton Tree village in the Cayo District. Ironically, the soldiers had been on the way back from the funeral of Micah Miguel, a young female soldier, 23, which had been held in Hopkims village in the Stann Creek District, when the tragic accident occurred.

Hill had been seated on the passenger side of the BDF van when, between Miles 42 and 43 on the George Price Highway, the van collided head-on with

# SSB to invest \$3 million in repairs on McKoy Building

BELMOPAN, Mon. Aug. 15, 2022

The David L. McKoy Building in Belmopan, which houses the Social Security Board and headquarters as well as the Office of the Prime Minister, was inaugurated in June, 2021. Today, that building, an \$8.2 million investment via the Social Security Investment Fund, is in need of retrofitting, and the SSB is expected to spend an additional \$3 million on repairs.

Prime Minister Hon. John Briceño briefly addressed the matter during an interview with the media last week, during which he noted that the building was badly designed.

"The architect supposedly seems to have made a number of—or overlooked a number of things that should have been in the design. We could have made it political, but we did not. We decided that now we have a problem. We have the people's money. We just can't walk away from it. And Social Security is going to spend the extra money to be able to repair it, because we have to fix it," he said.

During the inauguration ceremony last year, the Investment Chairman of the SSB, Reynaldo Magaña, stated that the SSB's investment in the construction of the building was expected to be recovered in ten years at an 8.2% rate of return.

"This is a solid investment, in the investment portfolio that will generate the necessary returns to keep the fund fluid, to service short-term and longterm benefits for the people of Belize for years to come," Magaña said.

## **National Adaptation Plan for** coastal areas launched

The government of Belize is hosting consultations with key stakeholders in three coastal communities to gather data

The impact of climate change on the coastal areas and marine ecosystems in Belize is expected to be just as severe or in some cases worse than what is projected for small island developing states across our region. We have seen the erosion of coastlines and cayes, a noteworthy level of coral bleaching caused by rising sea temperatures, and the impacts of storms such as Eta and Iota, which have caused historic floods in the country. The climate change reality is ever-present for Belize, and, today, after stakeholder consultations, the country launched its National Adaptation Plan to begin actively addressing its impacts on Belize's coastal and marine areas.

The Ministry of Economic Development, which is the National Designated Authority for the Green Climate Fund in Belize, has played an active role in looking at the adaptation systems needed by the government to brace for the expected effects of global warming on Belize.

CEO in that ministry, Dr. Osmond Martinez, said that this national adaptation plan is the first developed for

Belize that addresses the coastal areas, and he expects that they will determine what mechanisms and systems must be put in place, and will establish a proper system to collect empirical data, that will hopefully guide decision-making and policy.

He said that stakeholders, during consultations that have been held, highlighted issues pertaining to erosion and the need to replant mangroves along the coast, the rising sea temperatures, and sargassum problems, among many other issues.

Today, the Ministry of Blue Economy started its own consultation as a part of the adaptation project. In total, four Climate Change Vulnerability and Livelihood consultations for the coastal area and fisheries are planned in collaboration with the Food and Agriculture Organization and Belize's NDA, the Ministry of Economic Development.

"The consultations are a deliverable of the GCF readiness project entitled, 'Enhancing adaptation

## Classroom learning resumes across country

As a new school year approaches, schools across the country are preparing to fully resume a mode of learning that was the norm prior to the onset of the Covid-19 pandemic: face-to-face learning in the classroom.

When members of the local media caught up with the Minister of Education, Hon. Francis Fonseca, he remarked that the nation's education system is ready to make a full restart.

"It's obviously been a challenging period for education and for our country, but we believe our education system is ready to make a full restart. So we've been working with all of our stakeholders in education, and we're excited about the opportunity this year. We've been doing a lot of work over the summer. We've had a very good 'Let's Catch Up' summer program, and still going on, to try to help targeted groups of young people so that they're better ready for the new school year. So a lot of work has been going on, and we think we'll have a very successful academic year," said Hon.

Hon. Fonseca also noted, in regard to a program that has been introduced to provide free education to four Southside schools: "We're on target

with the Education Upliftment Project, 'Together We Rise'—four government schools on the Southside of Belize City, so things are going well. That's a comprehensive program that not only provides free tuition and fees but also provides a healthy start [for] feeding programs in each of these schools. We provide our students with uniforms, books, with digital devices and we're also doing infrastructure work at these schools to improve the learning environment. So everything is on track, and we're excited for the new school year."

## Call center agent stabbed; friend charged

Jose Velasquez, 28, a resident of Courtney Crescent, in Belize City, has been charged in connection with the stabbing of Bryan Coleman, a 23-yearold call center agent, which occurred early on Friday morning, August 12.

Coleman and Velasquez were reportedly socializing with a group of friends, after returning from a night out, when an argument erupted between the two at around 1:00 a.m.

It was reported that Velasquez left, and presumably headed home, but he returned to the group with a knife and proceeded to stab Coleman.

Coleman was taken to the Karl Heusner Memorial Hospital for medical treatment, and survived the attack.

Since then, Velasquez has been charged with attempted murder, the use of deadly means of harm, and dangerous harm.

Velasquez is expected to be arraigned in court this week.

# Women Parliamentarians accept Louis Wade's apology

On the morning of August 11, Pastor Louis Wade, during Plus TV's *Rise and Shine* morning show, apologized for the offence caused by the "unfortunate interpretation" of comments he made on July 26.

"We seek to apologize to those who found offense with my comments," said Wade.

The Plus TV host also stated that the comments he made on the *Rise and Shine* show in July were not intended "as a reference to a gender" nor were they intended "to be understood as a derogatory or disrespectful meaning to genitalia of a woman."

"I apologized on July 28, 2022 for the unfortunate interpretation, which was not intended nor premeditated and is truly regrettable," he added.

On that same day, both the Belize Broadcasting Authority (BBA) and the Women Parliamentarians Caucus acknowledged Wade's apology, with the BBA writing a letter to the interim chair of the Caucus, Hon. Valerie Woods, thanking them for bringing attention the "questionable language" used by Wade.

"He has assured the BBA Board that he in no way made those comments with the intent to be demeaning and to inflict any harm whatsoever. His word choice was cause for public concern; as a consequence, Mr. Wade has retracted said comments and has given a formal

apology," wrote BBA chairman, Evan

In response to that letter, as well as Wade's statement, Hon. Valerie Woods said that it is a step in the right direction. The Speaker of the House of Representatives thanked the BBA and Plus TV for addressing the issue.

"There will always be those who don't get it, who don't agree that this should have been taken on or don't consider the importance and impact of language. The hope is to increase the numbers who do," she said.

On Friday, August 12, the National Evangelical Association of Belize (NEAB) issued a press statement expressing support for Pastor Wade and referring to the public demand for accountability from him as a part of "recent efforts to completely mischaracterize him for various ulterior agendas."

In the release, the NEAB states that "after two separate explanations, clarifications, and apologies from Pastor Wade, the persistent untrue attacks raise severe questions as to ulterior motives of some of those seeking to vilify and discredit him."

"We affirm Pastor Louis Wade, Jr. as a man of God and urge all Belizeans to use discernment concerning whatever motives of those who persist in wrongfully attacking him," added the NEAB.

# Aviation hub concept has great potential, says Civil Aviation CEO

The International Civil Aviation Organization (ICAO) will be conducting safety audits on its Member States next year, and according to the CEO in the Ministry of Civil Aviation & Blue Economy, Kennedy Carrillo, the Ministry expects, undoubtedly, a pass for Belize.

In preparation for the audit, COCESNA and the Federal Aviation Administration have committed technical support to Belize—expected to be the first country in the region that will be audited, come next year.

"We have done a lot of work, and

we've had to play catch up on a lot that had not been happening, but also we have COCESNA, who are our technical partners who will be coming in country to assist us," said Carrillo.

The audit is expected to focus on how effectively member states that are a part of ICAO have implemented critical elements of a safety oversight system. It will tackle eight audit areas: Primary Aviation Legislation and Civil Aviation Regulations, Civil Aviation Organization, Personnel Licensing and Training, Aircraft Operations, Airworthiness of Aircraft, Aircraft Accident and Incident Investigation, Air Navigation Services, and Aerodromes and Ground Aids.

## PM comments on Pharmacy Express loan application withdrawal

"It shows, or it gives proof, that the system is working," Prime Minister Hon. John Briceño said.

Last Thursday, the Social Security Board (SSB) released a statement informing the public that the 7million-dollar loan application made by Pharmacy Express, a private company which owns four drug stores in the Fort Street Tourism Village (FSTV), has been withdrawn. The withdrawal of the application seemed to have been prompted by public opposition to the possible loan. Those entities which opposed the granting of a loan to the company included the Ministry of Health and Wellness, which subsequently carried out a raid on the company's Belize City drug stores at the FSTV. It has been confirmed that the company was operating without having been granted the required license to sell pharmaceuticals by the Ministry of Health and Wellness, and as a result, the ministry lodged its written opposition to the loan application (the only written objection recorded) and informed the SSB that the company was not in possession of a pharmaceutical

When speaking to local reporters about all the events stemming from the announcement that the SSB was reviewing the company's loan application, Prime Minister Hon. John Briceño noted that the way things unfolded, and the outcome of that process—the company's withdrawal of its loan application show that "the system is working." He said that although a proverbial firewall exists between SSB and the government of the day, the statutory body still cannot act totally independent of the policies that are in place.

"Social Security Board, they have an investment committee within Social Security. From that, it went to the investment committee for the board, for support to the board. Based on that, it went to the board, and then the board decided that they would approve that loan," PM Briceño said.

The next step, he noted, was the notice of investment issued by the SSB to get feedback from the public. It was at this point that the proposal was subject to a firestorm of opposition within the public domain, and a subsequent late Sunday evening release issued by the MOHW that cited "concerns" over the proposal.

"The most important thing was that the Ministry of Health and Wellness realized that, hold on, this company has been operating without a license, so if they are operating without a license, then that would be a reason to be disqualified, but I am told that the company decided to withdraw its loan application, and so that's where it ended," PM Briceño said.

According to the PM, the loan application went before two investment committees inside the Social Security Board without being aware that the applicant company was not in possession of the required license to carry out the sale of pharmaceuticals. When asked if this should be an indictment of the SSB's investment committee, the PM replied, "This should be a lesson to everyone, especially, particularly the investments committee, but even the board, that they have to make sure that they cross all the T's and dot all the I's before they approve a loan for any company, because at the end of the day this is the people's money and we need to do everything possible to protect the people's money."

As it pertains to any legal implications that may arise from last week's raid of Pharmacy Express' drugstores at the Fort Street Tourism Village, the PM said that he was informed that warrants were presented. Attorneys for the owners of the company, Julius and Angela Zabaneh, had told local media that the raid was illegal, and that the government should expect a lawsuit. So far, there are as yet no indications that any legal action has been taken.

"It's an opportunity for them to come and find out if our country should really be certified to be providing the airline services that are coming to Belize," explained CEO Carrillo.

When it comes to legislation and regulations, the CEO says that the Ministry has worked with Cabinet to approve at least eight regulations that "were sitting on desks."

ICAO serves as the global forum of

States for international civil aviation. Not only does the organization conduct compliance audits, but it also develops policies and standards for civil aviation, provides assistance, and builds aviation capacity for its Member States.

"Some of this can have an impact on the decision of airlines to travel to Belize, and so we are moving very quickly to prepare for that 2023 audit," added the CEO.

# **PUP Chairman meets Belmopan City Council**

Chairman of the People's United Party, Hon. Henry Charles Usher, mediated a meeting between the members of the Belmopan City Council and the area representative for the municipality, Hon. Oscar Mira, to address the infighting that has been ongoing within the council. Last week we reported on the apparent tension which

seemed to be reaching a boiling point inside the Belmopan CitCo — the most recent source of contention being a release issued by the office of the mayor that named councilor Pauline Soberanis-Tillett as deputy mayor, without a vote among council members. Tillett subsequently declined the appointment following the issuance of an unsigned press release, seemingly by some councilors. Belmopan mayor, Madam Sharon Palacio, and all the councilors, two of whom joined via Zoom, were present at Friday's intervention and, according to reports, have mended fences in order to move forward with the work of the people of Belmopan.

"The Belmopan City Council was elected by the people of Belmopan to serve the residents of Belmopan. They were elected by a big majority; they were elected as a team, and they continue to work as a team. They have pledged today to continue that work, and they will make sure that the residents of Belmopan receive the absolute best service working together with the area representative for Belmopan," the PUP chairman said.

While he gave reassurances of a sound working relationship going forward, he explained that the release issued by the office of the mayor on the appointment of a deputy mayor was "jumping the gun".

"In March of this year, councilor Darren Swasey was elected by the council, by his colleagues to be the Deputy Mayor. At that meeting it was also decided that there would be a rotation so that everyone would have a chance to be the deputy mayor of Belmopan. Of course, before the next person is selected, there had to be a meeting to make that selection. This meeting did not happen in time, and so that press release went out – really it was jumping the gun a little bit in terms of who would be the next Deputy Mayor of Belmopan," Usher stated.

A caucus meeting is to be held on August 31. Such meetings are usually scheduled to take place on the last Wednesday of the month, but the tension within the council has caused significant time to pass by since a meeting was last convened. Usher informed that until such a meeting is held, and a vote is carried out for a new person to hold the post of deputy mayor, councilor Darren Swasey will remain in the post.

Following the issuance of the release by Mayor Palacio, some councilors took to social media to criticize the move, and in the process placed internal council matters in the public domain. The PUP Chairman said this behavior is not condoned.

"We want to be very clear that the party does not condone this type of behavior coming out, these negative comments, the negative post being put out there when really what should be done is that you have a proper meeting inside," the PUP chairman said.

For Mayor Palacio's part, she said that with a consultative approach, opinions will necessarily clash.

She said, "Today, was a very good example of the usage of the consultative approach, whereby you can see us here today and opinions clash, definitely, but we come out with a unified approach. The people of Belmopan elected us for a reason, and we don't have a lot of time remaining, so the bottom-line is,

from here onward, we will ensure that the people of Belmopan get exactly what they deserved."

The current deputy mayor, Swasey, was also at the head table and said, "While we will never stop having disagreements, we will never agree on every single thing, today we have found a unity of purpose, as is one of the tenets of the People's United Party, and we will move forward."

The intention of the council is to have all councilors get a chance to serve as deputy mayor, as was agreed in the March election. This is a first according to Usher, and is being seen as a progressive step.

He said, however, "But also the

decision has to be made by the council as to who that person will be, and even if there is a change in portfolios and so on, that's done at the caucus level."

Area representative for Belmopan, Hon. Oscar Mira, in his contribution from the head table, noted that while the council and his constituency office have separate mandates, they both work for the people of Belmopan.

Mira said, "I will continue working with the Belmopan City Council. As it is said before, we might have differences in priority, but at the end of the day it is for us to find common ground and work towards serving the people of Belmopan."

Mayor Palacio is still confident that the team will be able to achieve the goals they promised to the voters of Belmopan.

"The goals that we set out to accomplish will be accomplished, and all of you, everybody, the entire country, the entire Belmopan, the entire world need to understand that we as a council inherited garbage; everything was in a disarray," she said.

motorcycle to work this morning.

Details are sketchy at the moment; however, initial reports received by AMANDALA are indicating that Watson was riding his motorcycle on his way to work when he lost control of the bike near the Mile 6 junction of the Hummingbird Highway and crashed into a guard rail. He reportedly died almost instantly due to the impact of the collision.

Watson, who was a vocalist in the Gilharry Happiness Band in the early 2000's, was well-known throughout Corozal Town and parts of the Corozal District.

"He started his singing career as a member of the Gilharry Happiness Band in the early 2000s [and] he used to work with me because I was the keyboard player for the band. So that's when he started, and he sang with us until the band closed down. He ventured into other bands here in Corozal," said David Watson, an uncle of the deceased.

Watson leaves behind two kids; a boy, and a girl.

A post-mortem examination is yet to be done on Watson's body.

In related news, police are still trying to identify the victim of a hit-and-run accident in Bella Vista Village on Sunday, August 14.

According to initial reports, an unidentified man, labeled as "John Doe", was hit by a vehicle in the vicinity of the village's water system. John Doe was taken to the Independence Polyclinic, where he succumbed to his injuries.

Police are yet to identify the driver of the vehicle who caused the death of John Doe

Plans for the proposed aviation hub city include establishing a hub for commercial flights, a regional hub for cargo, and even a training school for air traffic controllers.

Aug. 15, 2022 CEO in the Ministry of Blue Economy and Civil Aviation, Kennedy Carrillo, says that the Ministry's proposed aviation hub could provide an opportunity to not only attract tourists but to also establish a regional cargo hub. Back in July, Hon. Andre Perez, the Minister of Blue Economy and Civil Aviation, proposed to Cabinet a plan for the transformation of one of Belize's airports and the surrounding area into an aviation hub. That plan, which

Milestones, like birthdays and anniversaries, are occasions for us to reflect on our past journey as we forge ahead in trying to enjoy this life that God has given us, and in trying to make it better for ourselves and our loved ones near and far; for our community, country and the world at large; and especially for the children, and those yet unborn to inherit this blessed earth. And as *Amandala* marked its 53rd anniversary this past Saturday, we can't help but acknowledge that, with all the challenges and obstacles facing our founding organization, UBAD, in our Belize communities back in 1969, there was still an abundance of "peace and love" throughout those communities, despite the "haad time" and poverty that existed then, leading many to seize the earliest opportunity to "go through di back" to the States. In the poorest of communities, we said "the struggle goes on"; but unlike today in 2022, there was not the pervasive language of hate, about "turf" and "beefs" and "disrespect" sparking retaliation and lethal violence; or the frequent news reports of cold-blooded "hits", broad daylight executions and

home invasions; and just as disturbing, the establishment of myriad gang-dominated areas, so that youths are often restricted in their movements in the city due to gang rivalries that could quickly become violent and even lethal.

There were always "bases" and "gangs" in the old capital, and there were sometimes rivalries, mostly played out in sporting encounters; but it was never a life and death affair. And there was not this hatred, of one gang for another, that has become rampant within our communities, and that has come to dictate the course of living for the recent and current generations of young Belizeans.

The gangs themselves are not the problem; the violence and lawlessness are; and the anger and hatred that spawn this violence and crime are the well-spring of this current wave that has engulfed our social fabric for the past few decades. And with the persistent futility of many Band-Aid efforts over the years, it is now clear that if the root is not tackled seriously, this problem will remain with us and grow even more in the coming years. Amandala sounded the warning over five decades ago, and the message to "pharaoh" remains the same today: "Let my people go!"

What is a gang, but a group of individuals working together in unity and cohesion to achieve an objective? On the old waterfront, and even still today, there are work gangs at the Port that perform an important task of removing cargo from ships and delivering them to our customs warehouses. There are work gangs in the field in various endeavors, be it agricultural or industrial-type work. The negative stigma of "gangs" is obviously because of this particular brand of illegal gang activities that has become a part of our troubled existence in recent times. And "where did it all begin"?

Well, we have seen it all unfold before our eyes, those of us who "will see". We've always had poverty here, and despite that, we had a "whole lotta love." And we've always had crime too, but on a much smaller scale, so that the justice system could cope with the situation, and thus all were encouraged to "walk the straight and narrow path."

But, as a writer from St. Louis observed in *Amandala* recently, come the 1980s and you "drop drugs," "drop guns," and some fast-moving cash to "pay crooked cops," and suddenly we have a big gang problem in Belize. And all the preaching from the pulpits and the political rostrums has not gotten to the root of this problem, which has kept growing bigger each time it seems the head has been chopped off. Nothing much changes when a notorious gang leader is incarcerated or killed. Another takes his place.

If we are serious about wanting to solve this problem, then, like our Mayor suggested, we have to be real. It's about "changing that mindset." When we were all poor, we struggled together, helped one another, and yes, quarreled sometimes. But in this new reality, with drugs and guns and fast-moving cash, suddenly a few of us are "making it", and others want "a piece of the action." Competition in business becomes fierce, and there is a bigger boss from "high society" running the show, so for the "small fries" in our various neighborhoods, it's "dog eat dog" and survival of the fittest. Gang warfare is inevitable as long as gangs are involved in the illegal drug business. Because it is illegal, gangs must battle to maintain their "turf", their area of doing business – sales. Simple. And the burning poverty in their communities becomes breeding grounds for the gangs to enlist new "soldiers" and gain sympathy and support from those who receive "help outs" and "hand-outs" from time to time. It's not rocket science. Gangs are sustained by the loyalty from impoverished communities who accept from the gang leaders the help they don't get from "society".

We can hire a thousand more police officers, or call more and more "states of emergency"; but the problem is not going away. We've been "barking up the wrong tree" for too long. An old Kriol proverb says, "Full belly tell hungry belly, 'kip heart'." In more modern times, the artist Tanya Carter sang, "You've got to show me, that your love is real." And some of us put it another way: "Put your money where your mouth is."

This is where we are in 2022. Many Belizeans are poor, but we are a wise people. Desperation will always make some people do wrong things. And if the obscenely wealthy amongst us do not care that there are masses of desperately poor citizens trying to figure out "weh di next meal di cohn from," then things may have to get a lot worse to make them "get the sense." The Mayor may be on to something; but the financiers of our two major political parties may not be on board with that approach. They believe in big business and trickle-down crumbs for the masses. Government's recently announced "\$40 Million Micro-Small-Medium Belizean Enterprises" initiative could be a meaningful thrust towards spreading the love and pushing back the walls of hate in our communities, but a lot depends on how this project is executed.

Keep watch, Belizeans! There are big financial sharks about, and they are always looking for a feeding frenzy for themselves. Our leaders must think of the suffering masses first. After the land, we need the food, and our people will "flee from hate." Feed the hungry, work the land, and bring back the love, Belize!

# All stakeholders should get a place on the PCC—an opportunity Belizeans didn't get in '81

#### The Webster Proposals (cont.)

Belize had not yet achieved self-government, and so the delegates were members of the Executive Council, which comprised Hon. George Price, who later became Prime Minister of Belize; Mr. Albert Cattouse; and Hon. Louis Sylvester, along with Hon. Harrison Courtney, Sr., as the delegation's legal adviser.

The main thrust of these negotiations was to seek a solution to the dispute through economic cooperation. The parties agreed to request the Economic Commission for Latin America (ECLA) to undertake a study of the implications of closer economic cooperation between Belize and the Central American states with a view to Belize joining the Central American Common Market. It was also agreed to establish a tripartite committee, to be composed of representatives from Guatemala, Britain and Belize charged with the task of promoting mutual economic and social development between the peoples of Guatemala and Belize.

Although ECLA was commissioned to undertake the study contemplated, little else emerged from the agreements reached at San Juan. The tripartite committee was never appointed and diplomatic relations between the U.K. and Guatemala were broken in 1964, when Belize achieved internal self government. Guatemala protested that the U.K. had failed to consult her on this constitutional advance for Belize as she was obliged to do.

In June 1965, Britain, in consultation with Belize, agreed with Guatemala to submit the dispute to a Mediator appointed by the United States Government. The Mediator, Mr. Bethuel M. Webster, delivered his report in April 1968, in the form of a draft Treaty, the main provisions of which may be summarized as follows:


i. Article 1 of the draft treaty provided that British Honduras would be granted independence under the name of Belize not later than 31st December 1970.

ii. Article 2 obliged Belize and Guatemala to grant to each other's goods free entry through their ports and free transit through predetermined routes of each country.

iii. Under Article 3, the port of Belize City would be declared a duty-free port for the benefit of Guatemala and placed under the control of a supra-national Authority. Guatemala was obliged, at the request of Belize, to provide similar facilities for Belizean goods.

iv. Article 4 guaranteed nationals of each country free movement in the territory of the other as well as the right to the same treatment as was accorded by each country to its own citizens. This included the right to freely acquire and dispose of personal real property.

v. Under Article 9, Guatemala and Belize agreed to establish a supranational Authority to be charged with

the responsibility of carrying out certain powers and functions, including the supervision and control of free ports, as well as the designation of transit routes. Britain was required to pay to the Authority US \$4 million to assist the Authority to perform its functions under the Treaty.

vi. Article 10 provided that Belize would join CACM before 31st December 1970 with financial assistance from Britain.

vii. Article 13 obliged Guatemala and Belize to consult and cooperate with each other on such matters of mutual concern in foreign affairs as may be raised by either government.

viii. According to Article 14, the defence of Belize would be handled within the framework of the Inter-American Treaty of 1947, to which Belize would accede. In that event it would not be necessary for Belize to conclude bilateral defence arrangements with any other country.

The plan placed the defence, foreign affairs and, to a certain extent, the economy of Belize under Guatemalan control after independence. The normal channel of communication to international bodies by the Belize government was to be through the Guatemalan government. The two governments were to consult on matters of external defense, but this was tantamount to Belize being subjected to the dictates of Guatemala. Even the provision of internal security in Belize, a responsibility expected with independence, was to be the subject of consultation and co-operation. Belize was to accept a customs union with its neighbor, which was to be allowed free access to its Caribbean ports and territorial waters. It was to be rewarded with Guatemala's support for its entry into the Central American community and into the Inter-American community and in particular into the Organization of American States (OAS) and the Inter-American Development Bank (IDB).

In sum, it is believed that the proposals exclusively committed Belize to a hemispheric destiny as a satellite or department of Guatemala.

Nowhere in the document was it stated that the Guatemalan claim was revoked. Nor was Belize explicitly given the right to seek membership in the Commonwealth, the United Nations or international bodies outside of the Inter-American system. She was, in short, denied the prerogative of an independent state to choose, or reorder at least some

of the priorities of her future.

With regard to the country's internal politics, the proposals also made few concessions to the dominant, traditional social values. For example, degrees granted from outside Belize or Guatemala were excluded from the reciprocal recognition of educational qualifications. This undermined the dominant British orientation of the educational system in Belize and, in the absence of post-secondary facilities, virtually decreed Guatemala as the new center of higher learning for Belizeans.

Bearing in mind the great disparity between Guatemala and Belize in terms of population and resources, the end result of these proposals, taken together, would have been the effective domination of Belize by Guatemala. Belize accordingly declared that these proposals were totally unacceptable. Indeed so unacceptable were they, that unrest and disturbances erupted in Belize even before the government had an opportunity to signify its total rejection of the proposals as incompatible with the aspirations and rights of the people to achieve full sovereignty as a free and independent nation.

Requests were made to the government of the U.K. "to seek other means by which the Anglo-Guatemalan dispute may be satisfactorily and honorably settled so as to allow the country to pursue its unimpeded course to unfettered and sovereign independence." On 20 May, 1968 the Secretary of State for Foreign Affairs, Mr. Michael Stewart, announced that since the draft Treaty was not acceptable to Belize, it was not acceptable to the British Government. The British should not have included the Heads of Agreement as a pretext for Belize to be granted our independence.

By doing this they were placing an undue burden on the government and citizens of Belize that they could not accept. They also knew what happened when the Webster Proposals were handed down to the Belizean government and citizens in 1968. A Constitution is the most sacred document a nation and people have in a democracy.

Under the conditions in which Belize was granted its independence on September the 21st 1981, the British government and the Government of Belize were both not acting democratically. The British government wanted to get rid of the colony of Belize and its citizens because they saw the people and country as an economic burden to them. They forgot the slavery they imposed upon some of our citizens of Belize in order to secure free labor, centuries of exploiting Belize's natural resources to the benefit of their citizens in Great Britain, and the atrocities they committed against the Maya and the Garifuna people in the southern part of Belize before it became a part of the country of Belize.

On the other hand, Premier George Price and his People's United Party wanted independence from Great Britain, even if we were not granted a Defense Guarantee from Great Britain to protect us from a Guatemalan invasion. He saw Independence as the only way for Belize and its citizens to build their nation. This I considered to be a huge risk to take. Guatemala has been threatening to invade Belize on several occasions prior to and after our Independence, and Belizeans should never ignore their threats. The territorial Guatemalan claim to Belize remains unresolved to this day, and the matter has been submitted to the International Court of Justice for a final resolution. Whether the ruling of the court will satisfy these two nations is yet to be seen.

This process to now be carried out by the People's Constitutional Commission should be the most significant constitutional deliberations our country has ever held since the birth of our nation, Belize, in 1981 and all stakeholders should be welcomed to participate in it. I would like to see the commission deal with all the serious problems our country has been facing since our Independence. Some of the issues that I am concerned about are the lack of independence of the three branches of government, namely the Executive, Judiciary and Legislative; too much power given to the Prime Minister and his Ministers; continued interference of the Prime Minister and Ministers in the daily duties and functions of the police and civil servants; the unequal distribution of our nation's wealth and resources; corruption; the inequality in distribution of lots and lands; race discrimination problems; the abuse of power by the Prime Minister and the members of his government, unfair hiring practices, vindictiveness by government in power; the absence of civil rights agencies to enforce our laws to protect all of our citizens, despite their ethnicity; the buying of our citizens' votes without any penalty; the use and abuse of ministerial discretion; the need to grant Indigenous citizens their rights based on the UNDRIP treaties, international law, conventions and our Constitution, especially as it relates to their rights and jurisdiction over their lands and all issues that are stifling Belize's progression toward being a nation to reckon with in the future.

I am convinced that If we have a successful constitutional reform process, Belize will become the nation that we yearn for as one people and one nation. If not, we shall remain a nation that is fragmented without a true purpose to benefit all of us as citizens of this beautiful nation that we all dearly love, Belize.







# Conquistando el odio

Existe este fuerte odio en nuestra comunidad, y (cruza) líneas políticas, cruza comunidades; es rampante en las áreas urbanas. #### Lunes, 15 de Agosto de 2022

Los hitos, como los cumpleaños y los aniversarios, son ocasiones para que reflexionemos sobre nuestro viaje pasado a medida que avanzamos tratando de disfrutar esta vida que Dios nos ha dado y tratando de mejorarla para nosotros y nuestros seres queridos cercanos y lejanos; para nuestra comunidad, país y el mundo en general; y especialmente para los niños, y los que aún no han nacido para heredar esta bendita tierra. Y mientras Amandala celebraba su 53º aniversario el sábado pasado, no podemos dejar de reconocer que, con todos los desafíos y obstáculos que enfrentaba nuestra organización fundadora, UBAD [por sus siglas en inglés], en nuestras comunidades de Belize allá por 1969, todavía había abundancia de "paz y amor" en esas comunidades, a pesar de los tiempos difíciles y la pobreza que existían entonces, lo que llevó a muchos a aprovechar la primera oportunidad de "irse mojados" a los Estados Unidos. En las comunidades más pobres dijimos "la lucha sigue"; pero a diferencia de hoy en 2022, no existía el lenguaje generalizado del odio, sobre "territorio" y "rivalidad" y "falta de respeto" que desencadenaba represalias y violencia letal; o los frecuentes reportajes de noticias sobre "golpes" a sangre fría, ejecuciones a plena luz del día y allanamientos de morada; e igualmente inquietante, el establecimiento de innumerables áreas dominadas por pandillas, de modo que los jóvenes a menudo ven restringidos sus movimientos en la ciudad debido a las rivalidades entre pandillas que rápidamente podrían volverse violentas e incluso letales.

Siempre hubo "bases" y "pandillas" en la antigua capital, y a veces hubo rivalidades, en su mayoría se desarrollaban en encuentros deportivos; pero nunca fue un asunto de vida o muerte. Y no existía este odio, de una pandilla por otra, que se ha vuelto desenfrenado dentro de nuestras comunidades, y que ha llegado a dictar el curso de vida de las generaciones recientes y actuales de jóvenes beliceños.

Las pandillas en sí no son el problema; lo son la violencia y la anarquía; y la ira y el odio que engendran esta violencia y crimen son el manantial de esta ola actual que ha engullido nuestro tejido social durante las últimas décadas. Y con la inutilidad persistente de muchos esfuerzos de curitas a lo largo de los años, ahora está claro que si la raíz no se aborda con seriedad, este problema permanecerá con nosotros y crecerá aún más en los próximos años. *Amandala* hizo sonar la advertencia hace más de cinco décadas, y el mensaje al "faraón" sigue siendo el mismo hoy: "¡Deja ir a mi pueblo!".

¿Qué es una pandilla, sino un grupo de individuos que trabajan juntos en unidad y cohesión para lograr un objetivo? En la antigua zona costera, y aún hoy en día, existen cuadrillas de trabajo [llamadas "work gangs" en inglés con la palabra 'gang' teniendo también la definición de pandillas] en el puerto que realizan una importante labor de retirar carga de los buques y entregarla a nuestros depósitos aduaneros. Existen work gangs en el campo en diversas labores, ya sea de tipo agrícola o industrial. El estigma negativo de los "gangs" se debe obviamente a este tipo particular de actividades ilegales de pandillas que se ha convertido en parte de nuestra problemática existencia en los últimos tiempos. ¿Y "dónde empezó todo"?

Bueno, lo hemos visto todo desarrollarse ante nuestros ojos, los que "veremos". Aquí siempre hemos tenido pobreza y, a pesar de eso, teníamos "mucho amor". Y siempre hemos tenido delincuencia también, pero en una escala mucho menor, para que el sistema de justicia pudiera hacer frente a la situación, y así se animó a todos a "caminar por el camino recto y angosto".

Pero, como observó recientemente un escritor de St. Louis en *Amandala*, llega la década de 1980 y "dejan caer las drogas", "dejan caer las armas" y algo de dinero rápido para "pagar a los policías corruptos", y de repente tenemos un gran problema de pandillas en Belize. Y toda la prédica desde los púlpitos y las tribunas políticas no ha llegado a la raíz de este problema, que se ha ido agrandando cada vez que parece que le han cortado la cabeza. Nada cambia mucho cuando un notorio líder de una pandilla es encarcelado o asesinado. Otro toma su lugar.

Si de verdad queremos resolver este problema, entonces, como sugirió nuestro alcalde, tenemos que ser reales. Se trata de "cambiar esa mentalidad". Cuando éramos todos pobres, luchábamos juntos, nos ayudábamos unos a otros y, sí, a veces nos peleábamos. Pero en esta nueva realidad, con drogas y armas y dinero en efectivo que se mueve rápidamente, de repente algunos de nosotros estamos "triunfando", y otros quieren "una parte de la acción". La competencia en los negocios se vuelve feroz, y hay un jefe más grande de la "alta sociedad" que dirige el espectáculo, por lo que para los "pelagatos" en nuestros diversos vecindarios, es "perro come perro" y la supervivencia del más apto. La guerra entre pandillas es inevitable mientras las pandillas estén involucradas en el negocio de las drogas ilegales. Debido a que es ilegal, las pandillas deben luchar para mantener su "territorio", su área de negocios: las ventas. Simple. Y la pobreza extrema en sus comunidades se convierte en caldo de cultivo para que las pandillas enrolen nuevos "soldados" y ganen la simpatía y el apoyo de quienes reciben "ayudas" y "dádivas" de vez en cuando. No hace falta ser un genio. Las pandillas se sustentan en la lealtad de las comunidades empobrecidas que aceptan de los líderes de las pandillas la ayuda que no reciben de la "sociedad".

Podemos contratar mil policías más, o pedir más y más "estados de excepción"; pero el problema no va a desaparecer. Hemos estado "ladrando al árbol equivocado" durante demasiado tiempo. Un viejo proverbio criollo dice: "barriga llena, dice a barriga hambrienta, manténganse esperanzados". En tiempos más modernos, la artista Tanya Carter cantó: "Tienes que mostrarme que tu amor es real". Y algunos de nosotros lo expresamos de otra manera: "Pon tu dinero donde está tu boca".

Aquí es donde estamos en 2022. Muchos beliceños son pobres, pero somos un pueblo sabio. La desesperación siempre hará que algunas personas hagan cosas malas. Y si a los obscenamente ricos entre nosotros no les importa que haya masas de ciudadanos desesperadamente pobres tratando de descifrar "de dónde vendrá la próxima comida", entonces las cosas tendrán que empeorar mucho para que "entiendan la realidad". El alcalde puede haber dado con algo; pero los financistas de nuestros dos principales partidos políticos pueden no estar de acuerdo con ese enfoque. Creen en los grandes negocios y en las migajas que se filtran para las masas. La iniciativa recientemente anunciada por el gobierno de "\$40 millones para micro, pequeñas y medianas empresas beliceñas" podría ser un impulso significativo para difundir el amor y hacer retroceder los muros del odio en nuestras comunidades, pero mucho depende de cómo se ejecute este proyecto.

¡Manténganse en alerta, beliceños! Hay grandes tiburones financieros por ahí, y siempre están buscando un frenesí alimentario para sí mismos. Nuestros líderes deben pensar primero en las masas que sufren. Después de la tierra, necesitamos la comida, y nuestra gente "huirá del odio". ¡Alimenten a los hambrientos, trabajen la tierra y traigan de vuelta el amor, Belize!

A diaspora friend of mine last week e-mailed me some video footage of what looks like new weaponry developed by Lockheed Martin, an American company which specializes in military equipment. The weaponry was really awesome.

Around the same time, the American cable television channels were reporting that the Russians had suffered the destruction of seven of their warplanes, the worst such one-day disaster for the Russians since World War II.

It is reasonable to speculate that the Russian problem may have been caused by the Ukrainians' making use of all the high-tech weaponry they have been given by the Americans.

Meanwhile, the Russians have taken over the largest nuclear plant in Ukraine, and they are using said plant to store some of their war equipment. A successful Ukrainian attack on such a plant could result in massive nuclear catastrophe.

Now all this is taking place for me around August 8, a day I was thinking may have been the anniversary of the atomic bombing of Hiroshima by the United States in 1945. I did an online search and found that the United States had dropped atomic bombs (one each) on Hiroshima on August 6 and on

Nagasaki on August 9 of 1945.

Belizeans, you must note that the anniversaries of the bombings of Hiroshima and Nagasaki were ignored by the American television stations we watch in Belize. Hundreds of Japanese died in the most horrible way you can imagine, and victims continued dying from the effects of the bombs for many years afterwards.

Now a loyal American may argue that the Japanese were refusing to surrender, months after Germany had fallen to the Americans and the Russians, and months after the German Nazi leader, Adolf Hitler, had committed suicide, along with his mistress, at the end of April of 1945.

The third Axis ally, Italy, had long since seen their Fascist leader, Benito Mussolini, run out of town by the Allies (the United Kingdom, the United States, and their allies such as the French Resistance forces.)

Searching the online information on the Hiroshima and Nagasaki bombings, I discovered that the United States had been obliged to get permission from the British before bombing the two large Japanese cities. How interesting, beloved.

It was also of great interest to me that Japan's Emperor Hirohito did not

announce his nation's unconditional surrender, in a radio address, until August 15. Why did he take so long? All I can say is that the Japanese people have a historical culture of incredible militarism and bravery. If this is of interest to you, you should seek to read the novel SHOGUN, written by James Clavell, I believe.

The testing for all these nuclear weapons took place in islands in the South Pacific — beautiful, pristine creations of Almighty God. The damage to the environment was horrific. You can watch the television channels of the "developed nations" of the world, and they do not speak about this.

So now we are looking at this phenomenon they are calling "climate change." I'm not a scientist. But it seems to me logical to assume that the atmosphere above planet earth has been severely compromised by all these nuclear tests and bombings carried out by the "developed nations" of the world, the same ones who send their missionaries to us to drill us in Judeo-Christianity. In fact, Israel, supposedly the chosen people of God, became a nuclear power some years ago.

About fifteen or twenty years ago, I said to a very good friend of mine, that

there are certain projects which are too big for Belize. My friend was vehement in his disagreement with my thesis. He did not feel anything was too big for Belize. A few days ago, I heard the PLUS TV Christians with the same type of thinking my friend had proposed to me: nothing was too big for Belize.

But Don Hector Silva, who is a strong PLUS supporter, called the show to disagree with the "big projects" people. He noted the Dan Davis story in the 1950s, the Dan Ludwig story in the 1960s (I think), and one other example which I don't remember presently, during the leadership of the Rt. Hon. George Price, when Mr. Price's caution definitely proved well-advised, as time went along.

I said to you last week that, personally, I am an anachronism. But where our world has reached today should be carefully studied by these younger generations who will make key decisions all over the planet. There are some valuable lessons in the coronavirus pandemic. If we insist on overwhelming The Jewel with projects and people from all over the planet, we may have to stop and think things over. You can see that a few of us have gotten rich off big projects and big people. A few Belizeans get rich: you and I feel pain.

La semana pasada, un amigo mío de la diáspora me envió por correo electrónico algunas imágenes de video de lo que parece ser un nuevo armamento desarrollado por Lockheed Martin, una compañía estadounidense que se especializa en equipos militares. El armamento era realmente impresionante.

Casi al mismo tiempo, los canales de televisión por cable estadounidenses informaban que los rusos habían sufrido la destrucción de siete de sus aviones de combate, el peor desastre de un día para los rusos desde la Segunda Guerra Mundial.

Es razonable especular que el problema ruso puede haber sido causado por el uso que los ucranianos le han dado a todo el armamento de alta tecnología que les dieron los estadounidenses.

## The "Neo-Cons" — Part II

Permit me, our dear readers of this column, to present to you Part 2 of the following analysis, which I find to be of much interest. It was posted on Youtube in Spanish by Diario Público under the heading "Los 'neocons': ¿quienes son y que tienen que ver con las guerras recientes? - Inna Afinogenova" (The 'neocons': who are they and what do they have to do with recent wars? - Inna Afinogenova) on July 29, 2022. It is as follows:

With such opinions at such critical times, anyone would think that his political career, or at least his diplomatic career, would be over. Nothing is farther from reality. Currently he is serving as deputy secretary of state in the Biden administration. He is undoubtedly a conciliatory figure and is far from being under suspicion for the handling of a crisis like the current one, taking into account the interests of all those involved. Another of the illustrious neoconservatives must also ring a bell; his name is Elliot Abrams — a specialist in Latin American issues. During the Reagan administration, he became involved in the Iran-Contra

scandal, which involved financing the Nicaraguan contra movement to attack the Sandinista government and doing so by selling weapons to Iran and through drug trafficking, no less. He is also linked to the UStrained death squads that murdered some 1,000 people in the village of El Mozote in El Salvador. Trump's former security adviser, John Bolton, who a few weeks ago acknowledged having participated in a few coups there, is another representative of this current, and we could list more and more names, but the question one asks at this point is: How did they manage to influence both the foreign policy of an entire country and the minds of all kinds of people, both inside the US and abroad?

I'll give you a keyword: think tanks — respectable academic institutions, strategic think tanks, these independent bodies that train countless political analysts that will frame all US foreign policy. The Foundation for the Defense of Democracies, the Henry Jackson Society, the Hudson Institute, the New American Century Project, the Institute for the Study of the Internet and perhaps the best known, the NED, the National Endowment for

Democracy. February, a few weeks before the Russian invasion of Ukraine, the Mind Presse published portal investigation in which it stated that the NED spent some 22 million dollars to finance nationalist youth organizations and train politicians and media related to the US in Ukraine, a country that the head of the NED baptized as the jackpot in Europe. All this theory would obviously have much more weight if Russia had never invaded *Ukraine*, *because*, *with the invasion*, any information on the subject that does not follow the prevailing narrative is almost automatically discredited as pro-Russian and disqualified. But the fact is that neither is the neocon movement something that the supporters of conspiracy theories have invented, nor is the war in Ukraine the first nor the second nor the third that occurs with these people influencing the policies of the most powerful





#### Referendum postponement regret grrr

Former third party leaders Paul Morgan and Patrick Rogers were on the WuB early last week discussing this move by the government to form the People's Constitutional Commission, tasked with making comprehensive reforms, and both men say the GOB has no so such mandate—such a reform not being one of their 2020-2025 manifesto promises. I'm not for this constitution commission either, so I have no complaint there.

The present government does have a super majority, thanks to the UDP messing up badly, and with their special advantage they can change just about any part of the constitution they want. But they're taking advantage here. In a previous column I opined that they were pushed into this overreach by the social partner senators, but that's no excuse, and that's not my beef today.

The GOB estimated it would cost between 3 and 5 million dollars, a very steep price with 60% poverty in the land, our economy battered by Covid-19, a war in Europe, high fuel prices, high prices of everything, and a threat of monkey pox. A referendum would also take up a lot of our time, and we've lost so much of that recently.

The churches felt strongly against weed, and thousands felt strongly that this business should go to a referendum. Ouch, people bex because the GOB was big enough to say, okay, we'll hold a while, and the churches were big enough to say, thank you for holding.

Last thing on this referendum: it was obvious that the GoB wasn't campaigning to win a yes vote. 

# Shooter of man in DVD store pleads guilty

BELIZE CITY, Mon. Aug. 15, 2022

In June 2017, Jermaine Franklin, 36, was shot several times in the back shortly after he entered Teddy's Music, a DVD/CD store on King Street, and was left for dead. The man accused of firing those shots, Kashief Gallego, 30, has, after spending 5 years on remand at the Belize Central Prison, pleaded guilty to the murder.

A little after 6:30 p.m. on the evening of the murder, Gallego, who resided at #72 East Canal at the time —just a half block away from Teddy's Music, reportedly followed Franklin into the store (pretending to be a customer), and not long after, he fired a number of



shots at Franklin, then fled the scene.

When Gallego was detained by police, he gave a caution statement to them in which he said, "Yesterday, I saw him at Teddy's and I took it [personally]. There was no one behind the motive; it was personal between me and him."

On Thursday, August 11, he appeared in court before Justice Susan Lamb and entered a guilty plea for murder. He was represented by attorney Erin Alexis Ouiros.

Gallego is set to return to court on September 23 for his sentence hearing.

# Conditions that led to Micah Miguel's death to be investigated

The acting Chief of Staff of the BDF says that the internal investigation into the claims made by Private Micah Miguel before her death will be as transparent as possible.

BELIZE CITY, Sun. Aug. 14, 2022

A team has been assembled to investigate the events that may have pushed BDF soldier Micah Miguel to take her own life, says the acting Chief of Staff of the Belize Defence Force, Lt. Colonel Jermaine

Burns. According to Lt. Colonel Burns, that team includes two representatives from the Ministry of Human Development, as well as persons from the Police Department, which will ensure neutrality and transparency.

"The BDF has picked their team already, and we are already doing what we need to do as preparation for this investigation," said Lt. Colonel Burns

The internal investigation is expected to begin sometime this week.

The 23-year-old soldier took her own life on July 29 at the home of her aunt and was laid to rest on Thursday. The Belize Defence Force made an agreement with Miguel's family that the investigation would commence after her funeral.

"We didn't want to be going back-



and-forth with them too much, and we wanted that when we got information tangible enough to discipline anyone, if that needs to be the case, we wouldn't having them guessing, and it would be something solid from us to say, 'this is what we know took place'," explained Burns.

The media had been made aware of Micah Miguel's death and the circumstances surrounding it by her family, who claim that she had been a victim of physical and psychological abuse at the hands of her colleagues at the Price Barracks BDF compound. According to the Chief of Staff, those persons believed to be behind that abuse have been named already, although their identities cannot be disclosed.

"There are text messages, and there are pictures out there, and I hope that those text messages and pictures get to the right persons that are investigating this case. I hope that those persons are dealt with with the strictest regulations against them, if it is in fact that they come into question for this matter," he said.

The allegations by the family of Micah Miguel compound previous ones made by former members of the force that a culture of abuse exists within the BDF. Lt. Colonel Burns says that when he first heard of the alleged abuse, he was distraught.

"I was very concerned about the way, I would say, the culture has changed ... I didn't believe then that

we would have people of that sort in our organization," he said.

Lt. Colonel Burns told the press that he feels the honourable thing to do is to give both Micah Miguel and her family some form of justice.

"There's a lot of rumours around in respect to the case with Private Micah. There's a lot on social media. It's unfortunate that as soon as someone says something or alludes to something, that everybody else just pulls along the same line. We want to remember Micah for the good soldier she was and the inspiration she is to the females on the force. We want to remember her for standing up, and in many ways she has inspired other soldiers to stand up," he said.



# C-Ray Cycling Club congratulates Goran and Gabrielle Gabourel

planning and increasing climate resilience in the coastal zone and fisheries sector of Belize', and will take place in Belize City on August 15 and 16, 2022; in Dangriga Town on August 19, 2022, and in San Pedro Town on August 22, 2022," the release states.

This National Adaptation Plan project was launched in February 2022 and is said to be geared toward increasing the resilience of the coastal zones and fisheries sector in Belize to climate change impact. Patrick Faber, former party leader and area representative for the Collet Division, to notify him of his immediate removal from the party's Central Executive.



Faber, a trend of dictatorial behavior and departure from the UDP constitution. The videos and text posts are similar in tone and content to scathing videos and commentary circulated by Delroy Cutkelvin, who was recently kicked out of the party by the Ethics and Integrity Committee last month.

Chairman Peyrefitte said, however, that expulsion is not a punitive measure being considered for Hon. Faber as yet and that he hopes it never reaches that point. Instead, he said, the party's Central Executive is simply trying to initiate a conversation with the former party leader about what they perceive to be an ongoing attack on the reputation of the party. Hon. Faber has refused to take down the social media posts, and just this evening directed a fresh attack at current party leader, Hon. Moses "Shyne" Barrow.

"Shyne insists on running a dictatorship, systematically violating the UDP constitution and trying to silence those who speak out against him. Honorable Tracy Panton, an upstanding and inspiring parliamentarian who came within two votes of becoming Party Leader, is unconstitutionally removed from the Central Executive Council and replaced with a junior politician of questionable ethics and integrity," Hon. Faber posted

Over the weekend, Melvin Hewlett was endorsed to become the Eastern Regional Leader of the UDP, replacing Albert area representative, Hon. Tracy Panton. Chairman Peyrefitte said that she and others were placed as interim leaders, and were never legally put in place by means of an election. He said that Hewlett was the only person to submit his name for the region and was therefore chosen.

Hon. Faber's comments before this endorsement were, "It's the height of nonsense when you illegally remove a winner to replace her via an unconstitutional process, with a man who



barely got 500 votes in the general elections. Are we really serious about fixing our party? How can a novice lead the largest and the traditionally most important region of our party? We have tried to discuss these idiotic moves privately in our party

These comments were made on August 13, three days after a motion passed by the UDP's CEC.

"You were officially notified on August 11th, 2022 and you still have not complied with the CEC's insistence that your public attacks of the party and its members be removed from your official Facebook immediately," the letter to Hon. Faber

The post this evening on Hon. Faber's official page stated, "Former UDP Leader Honorable Patrick Faber rightly condemns the move as idiotic. So now, the unholy trinity running the UDP has removed Honorable Patrick Faber, the former leader, from the Party's executive in order to silence him. From undemocratic to downright unbelievable. "

While tensions seem high once again in the UDP, Peyrefitte hopes that this move brings the issue to a head and prompts the various sections of the party that are at odds to come to the table, but he implied that with the various factions all seeking to lead the party, these clashes are inevitable.

"For some people, when several people want the one particular thing and that thing cannot be chopped in two, not even by Solomon, it is that thing or no thing, and when several people will have it at any cost, then that is an issue that you will have. There is nothing that you can do to appease them," Peyrefitte said. He added, "We have a leader of the party, and you have to respect that leader."

includes an initial feasibility study, was wellreceived Cabinet. According to CEO Carrillo, when it comes to the aviation hub, the potential is great, and as a part of its plan, the Ministry of Civil Aviation is looking into the possibility of opening a training school for air traffic controllers.

The feasibility study to be conducted by the Ministry for the proposed hub will include determining whether or not it will be located in Belize City, though according to the Civil Aviation CEO, it is unlikely that

## Alleged killer of security guard captured by police

ARMENIA, Cayo District, Thurs. Aug. 11, 2022

After being on the run from the police for about two weeks, Jeremio Xol, who is suspected of killing a primary school security guard, was finally captured by authorities.

On July 27, the Police Department released a wanted poster that

informed the public that the police were in search of Xol, who was wanted for questioning in connection with the ongoing investigation into the murder of a 33-yearold security guard of Armenia Government Primary School, Oscar

At around 4:00 p.m. on Thursday, April 14, Chiac left his home en route to the school to replace the other security guard who had previously been on duty and to start the night shift. However, he was seen



around the village socializing and drinking with others, and at some point he got into an argument with three other male persons which possibly resulted in his violent death.

At around 9:50 a.m. the following day, Chiac's motionless body was found in a crouched position in a pool of blood on the school grounds on the second floor of one of

its buildings. There were reportedly blunt force injuries on his body when it was

At the time, police detained two other persons along with Xol in connection with the murder, but those two—20-year-old Bernabe Xol, and a 16-year-old minorwere released from police custody. Police then, based on evidence gathered, pinpointed Xol as the primary suspect.

## Roaring Creek man charged for fatal RTA

Jermano Bol, 55, was charged for multiple road traffic offenses which claimed the life of Max Samuel Pop.

COTTON TREE, Cayo District, Thurs. Aug. 11, 2022

Multiple charges have been brought against Jermano Bol, 55, a Roaring Creek resident, in connection with a fatal road traffic accident between Miles 43 and 44 on the George Price Highway that claimed the life of Max Samuel Pop, 27, a Franks Eddy Village resident. The incident took place on Sunday, August 7, in the vicinity of King's Children's Home in Cotton Tree Village in the Cayo District.

According to reports, Bol was driving his red Toyota pickup truck along a route that leads from Belmopan to Belize City, when he collided with Pop's truck, which had been traveling in the opposite direction. As a result of the collision, Pop received severe head and body injuries and reportedly died on the spot, while Bol was transported to the Western Regional Hospital for medical treatment.

Police tested blood samples from Bol which were taken while he was at the Western Regional, and the results confirmed that Bol had been under the influence of alcohol while driving his vehicle. He was thus charged with manslaughter by negligence, causing death by careless conduct, driving a motor vehicle without due care and attention, driving a motor vehicle with alcohol concentration above the prescribed limit, and negligent grievous harm.

Pop's grieving wife, Brenda Lara, who

had been in the truck with Pop at the time of the accident, told 7News that they were heading home after traveling to Benque

when Pop attempted to pull the truck to the side because they saw Bol's vehicle swerving on the road.

"...We were coming from Benque, from the border... we were going to pick up his brother to drop him at his house, and when we reach by children's home we saw this vehicle coming like swerving on the road and the man, he was drunk, and he said, 'Babe, I'll just pull on the side because that man is drunk', and he was going off the road, and when I felt, I just gone blank and when I woke up my little brother was taking me out of the vehicle and I saw Sam on the other side and he was trapped in the vehicle. He couldn't come out. I tried to take him out, but some people reach and told me not to because he was still breathing slightly. I was talking to him; he was bleeding from his ears, his nose, and he just... and the young lady from Cotton Tree, she assisted me, she said 'he's still breathing'. The ambulance took long; it took like about fifteen minutes to reach. When the paramedics reach, they told me he had already passed away," she said.

of the van. It was taken to the Corozal Hospital, where it was pronounced dead," COMPOL Williams said.

Commissioner Williams went on to say that both a criminal and an internal police investigation have since been launched, and emphasized that no stones would be left unturned in investigating this tragedy.

"Those police officers who are responsible for placing the young man in the back of the vehicle will have to be dealt with some way or the other. The file will be prepared and sent to the DDP Office for instructions, and then we move forward from there," Williams said.

The Office of the Director of Public Prosecutions (DPP) will determine if and what criminal charges will be levied against the officers involved. COMPOL Williams has noted, however, that the officers who were deployed at the fair were improvising, since there is no detention center in the village, and they were thus using the police prison van as a makeshift cell during the festivities.

Uh, who was detained at the fairgrounds, would have had adequate ventilation leading up to the parking of the van at the Corozal Police Station. Whether or not he was unconscious or was, as reports say, intoxicated, has not been confirmed, but the conditions that led to his death were almost certainly excruciating.

"It is a secure area to keep prisoners, so long as the engine is running and the air is circulating, and in the absence of a police station and cell, they were improvising, which I cannot kill them for that. But the thing is, when they arrived at the police station, they ought to have made sure that the young man was removed from the van, and that was where things went wrong." Williams said.

Police Commissioner Williams additionally noted that no noise was heard coming from the van on Sunday, and no signs that the victim was trying to escape were visible inside the holding area of the prison van.

It will be up to the courts to determine whether or not leaving the young man in the vehicle was intentional and not an oversight on the part of the officers involved.

When asked if there are any indications of foul play — some intention of the officers to harm Uh—Williams responded, "While I have seen some discourse on social media, to the effect that the officers intentionally left the young men, I just

can't buy that. I don't think that they would do something like that, and again to prove a person's intent, is extremely difficult. Again, I say that they are humans beings. I don't want anybody to think that we are defending the police, cause I am not defending the actions. I said that what they did was wrong and has to be dealt with, but at the same time I must be fair, and cannot make assertions that are not supported by evidence."

He added, "I cannot say that it was deliberately done, but certainly there is some degree of gross negligence and carelessness, and that is what we are looking at."

The Police Department is also bracing for a lawsuit that will likely be brought by Uh's family.

"Certainly, the family will have a right to sue, and I am certain that they are going to sue, and we have to pay the price," Williams said.

Investigators are currently piecing together the facts pertaining to this terrible incident. Williams said that he has not spoken to the officers involved in the incident as yet, but feels terrible as the head of the Police Department.

"Honestly, I feel terrible, and I feel for the family. I cursed enough yesterday, and if it would not be unethical to curse on the media, I would curse right now, because it really pisses me off," he commented, adding, "I can ensure the public that we are not going to cover nothing. We are going to be open and frank with the people and let the people understand exactly what transpired," Williams told local reporters.

At the time, he had not spoken to Uh's family as yet, but he said that he will perhaps reach out to them. Family members, friends and many members of the public who are shocked by the manner of Uh's death have taken to social media to call for justice for the young man.

One of his sisters, Vanessa Uh, posted," What I feel the most is the way you died. You suffered so much. I couldn't be at your side and pray for you."

Another of his sisters posted, "#JusticeforDerrick - My little brother was just a young man full of life. I know sometimes he was in problems but he just never did something that bad to deserve to be killed that way. If he did something wrong why they didn't report he and just put him in jail and let us know. Where is CHESTER and where is our PRIME MINISTER to all things

# BDF soldier dies while returning from colleague's funeral

into a bus in front of it.

Lance Corporal Hill reportedly died on the spot, while her 10 other colleagues received various degrees of injuries to their bodies.

Lieutenant Colonel Jermaine Burns, Chief of Staff in the Belize Defence Force, explained to reporters that the 4-Runner entered into the lane of the oncoming BDF van to avoid crashing into a bus in front of it that was seemingly making a left turn but aborted the attempt amd pulled back into the lane after it saw the oncoming BDF van.

Lt. Col. Burns also indicated that the driver of the van, Lance Corporal Mansfield Danderson, displayed no signs of being intoxicated.

Burns said that Hill was a courageous member of the force and was one of the first women in the

force to take up the challenge of flight training.

The Ministry of Finance, Economic Development, and Investment issued a press release in the wake of Lance Corporal Hill's death.

"Whenever such incidents occur, many lives are negatively impacted; not only physically and financially, but also psychologically by the pain and grief it causes," the release noted.

The Ministry of Economic Development and the Second Road Safety Project Executing Unit extended their condolences to the family of Corporal Hill and wished a speedy recovery to those injured in this incident.

Hill was celebrating her birthday on the day she tragically lost her life. She leaves behind her common-law husband of 7 years, and her two children.

The Young Leaders Alliance of Belize issued a statement calling for a thorough investigation and justice, saying that the action of the police amounted to manslaughter by negligence.

"YLAB recognizes this undoubtedly cruel and unconscionable act as nothing less than manslaughter by negligence," the release states.

The Prime Minister also released a statement on the incident. That release, which refers to the death of Uh as a "tragedy beyond comprehension", goes on to state, "As a father of three sons, I grieve along with the parents and loved ones of Derrick Uh. Based on preliminary information received, his death was a tragedy and a travesty, and I stand with the rest of the nation in demanding full and complete answers."

The Prime Minister went on to make the following pledge in the release: "As Prime Minister, I can assure the family of Derrick Uh, and the nation, that no stone will be left unturned in the investigation of events leading to his death. There will be no excuses taken, and no delays in getting to the bottom of what appears, at this time and without medical evidence, to be heinous and criminal neglect."

"I am saddened, appalled and disgusted. We all should be. I extend heartfelt condolences to his family," the Prime Minister further stated.

The Opposition, the United Democratic Party, issued a release of their own, in which they stated that the party "demands a transparent and impartial investigation into the death of young Derrick Uh and emphatically condemns the gross negligence of his arresting officers that resulted in hours of inhumane torture and eventual death."

The UDP goes on in the release to "extend condolences to the Uh family and friends and offer legal or any other form of support that may be needed to seek justice for Derrick."

"Fourteen hours, imagine being shackled in a hot prison box for fourteen hours, crying out for help as your life force slowly slips away. Nobody could have heard Derrick's cry in that dark van on a sweltering summer day," states the UDP in the concluding paragraph of the release.
