

Older Persons Week 2022 is observed

The Executive Director of HelpAge Belize, Ms. Ivorine Bulwer, told us on Thursday that Older Persons Week 2022 is being celebrated across the length and breadth of the country in a multitude of ways. Those engaging celebrations will culminate on Saturday, October 1, when nations across the globe will be observing International Day for Older Persons-a day dedicated to celebrating the lives of senior citizens and challenging the negative stereotypes that exist around ageing.

This year specifically, the focus of Older Persons Week is on resilience, especially that of older women, in a changing

world. Here at home, it is being observed under the theme "The Resilience and Contributions of Older Women", and, according to Ms. Bulwer, the contributions of older women to the development of this nation have been plenty.

"Our women have always been behind our political leaders," she said.

She then went on to highlight the fact that our women have been pioneers and forces of change in a number of areas, including social services, health, and education. We were reminded of women like Sybil Reyes, Hazel Hutchinson, and Bernice



York—all outstanding educators who showed a great deal of care and concern for the older population.

Ms. Bulwer also brought attention to the many former nurses, such as Audrey Courtenay, who played a pivotal role in advancing healthcare in Belize. Those exemplary nurse leaders, as Bulwer called them, helped to nurture and train upcoming nurses at home and abroad, going so far as to assist them in securing scholarships. As a result, Belize saw great progress in critical care nursing, public care nursing, anesthetics, and more.

SIB reports 13.5% GDP growth, tripling of rum production

BELIZE CITY, Wed. Sept. 28, 2022 Today at the Radisson Fort George Hotel, the Statistical Institute of Belize (SIB) reported on Belize's Gross Domestic Product (GDP) for the months of April to June 2022, the second quarter of the year. According to SIB's Statistician II, Christopher Hulse, the country saw economic growth of 13.5% this past quarter, as compared to the same period in 2021.

The total value of goods and services produced for the second quarter was \$1.315 billion, owed in no small part to increased production in the secondary and tertiary sectors. The secondary sector, which accounts for processing, manufacturing, and construction, saw what the SIB calls "modest growth" of 1.5%, with the production of beverages and flour seeing increases of 27% and 29.2%, respectively. In the beverage category, the SIB reported that rum production was up by 191%. This was mainly due to the fact that the lifting of all COVID-19 restrictions led to an increase in social activities and events, thus leading to an increase in demand. For similar reasons, the tertiary sector, which includes the "Transport" and "Hotels and Restaurants" industry, saw growth of 17.3%. In the primary sector, there was a 7.9% decrease in production, particularly due to decreases in the production of sugar cane and bananas.

The Statistical Institute of Belize reported that for the second quarter of 2022, the economy grew by 13.5%, due to increases in beverage production, fruit deliveries, and electricity generation.



games like Bingo and Chalupa. There was even a small party held at Kiki Witz Resort in Belmopan.

"They were eating in style, they had access to the pool. They were dancing ... Quite a number were going down to the ground and coming up back," Bulwer said.

On Wednesday, Belize City Mayor Bernard Wagner was the keynote speaker at an event held at the HelpAge Belize City location on Wilson Street. There, he spoke with guests about the role that women like Jane Usher and Gwen Lizarraga have played in the development of Belize over time.

HelpAge Belize has been providing services to older persons across the country since 1984, when it was first established as an NGO. Today, there are a total of eleven HelpAge sites across the country, including the Sister Cecilia Home for the Elderly in Belize City and the Octavia Waight Center in San Ignacio. According to the Executive Director, the NGO's mantra is "aging with dignity." Their services include looking after the basic fundamental needs of elderly persons, including their health and social needs, in addition to providing support in the event of disaster. But while Belize has a population of approximately 37,000 elderly persons, HelpAge currently only serves a total of 1,200, which is why the organization is committed to working with the community and other organizations, such as the National Council on Ageing, to do what it can to reach the wider elderly population. "We cannot do this alone," noted Ms. Bulwer.

on older women, Ms. Bulwer told *Amandala* that the men have not been forgotten.

"We are also inclusive of our older men," she said, as she spoke fondly of legendary male educators such as the recently departed Owen Morrison. Morrison was the former principal of the Belize Technical College, and a man who left a lasting impression on hundreds of lives.

"These persons have passed on, but we have had great educators across the length and breadth of the country," she added.

In addition to recognizing the contributions of older persons to society, Older Persons Week 2022 has also included nationwide activities and celebrations. Those activities include picnics, tea parties, and

SIB statisticians report on second quarter GDP

In the case of the latter industry, a decrease in harvesting was attributed mainly to labor shortages, while unfavorable weather contributed to reduced sugar cane crop. The increase in citrus production occurred, not only because of an increase in the number of citrus harvesters, but because trees planted over the last few years to offset losses due to Citrus Greening have finally started to produce fruit.

The Statistical Institute of Belize also reported on the country's external trade numbers for January to August 2022. Imports rose by 34.8%, while domestic exports increased by 11.3% respectively.

For the month of August alone, however, imports increased by 20.8%, while exports decreased by 44.5% from what was seen in August 2021. The main reason for the fall in exports was the decrease in sales of sugar and bananas. Revenues from sugar, specifically, fell by a drastic \$31.1 million.

Despite this, there were also reports of increased sugar exports to CARICOM due to greater quantities of sugar being purchased by the region.

Gilbert "Bertie" Ellis celebrates his 106th birthday

The Statistical Institute of Belize (SIB) report on Belize's consumer price index for the month of August is indicating a national inflation rate of 7.4%—a 0.7% increase from last month. Unsurprisingly, the main drivers of the inflation rate were increases in the cost of fuel, transportation services, and food. According to the SIB, price changes in the "Transport" category remained the single greatest contributor to the overall national inflation rate, as half of the increase in consumer prices in August was seen in that category of goods and services. The cost of premium gasoline alone was more than fifty percent higher than premium gas prices last year, having registered an increase of \$5.91. The prices of diesel and regular gas rose by \$2.76 and \$2.32, respectively. The prices of items in the "food and non-alcoholic beverages" category have also been steadily increasing since January 2022. Wednesday's report revealed that in August there was the highest recorded rate of increase in

prices of items in that category since the start of the year-an inflation rate of 8.2% when compared to August 2021. The cost of basic food items, such as cereal products, dairy, meats and fresh produce all saw notable increases for the month. Lower prices were recorded, however, for items such as oranges, beans, and cabbages. Higher prices at restaurants and cafes contributed to an inflation rate of 5.8% in the category of "Restaurants and Accommodation Services" and an increase in cinema entrance fees and pet food prices contributed to the "Recreation, Sport, and Culture" inflation rate of 7.6%. Over the past few months, the town of Orange Walk has had the highest inflation rate of all municipalities in the country, and the month of August was no different. This time, the town's inflation rate of 9.1% was considerably higher than the national average. Consumers in the northern town saw increases in taxi fares, construction materials for household use, restaurant services, food items, and more. Belmopan, on the other hand, recorded the lowest inflation rate of all the municipalities, at 5.7%.

Ellis gained fame in the Belizean community as a batter and bowler in cricket. Ellis became the captain of the Rovers cricket team in 1938, and he played for that team for four years before going on to play for the Sussex team. During his time active as an sportsman, he also became the first president of the Amateur Boxing Association and the captain of a domino team, and was later inducted into the Cricket Hall of Fame.

Even after his days as an athlete had reached an end, he remained active in sports at the management and administrative levels.

He recalled that his first job involved helping a man by the name of Mr. Franklin

freeze ice cream after school, through which he earned 50 cents a week, which he referred to as "big money" at that time. In 1936, he began working for the Santiago Castillo enterprise and retired in 1981, after a period of 45 years at the company, during which he advanced from being an entry-level laborer to a chief warehouse keeper.

In 1967, Ellis was made Justice of the Peace, and he also chaired the Social Welfare Board for four years. He also

> served as chairman of the Rent Assessment Board.

Another of Ellis's life achievements was serving as the first president of the Harmony Housing Association, formed with 15 members in the 1950s. Jeff O'Brien and Sir Colville Young were among the members of the association who were successful in obtaining houses and lots along West Collet Canal



Job-seeking teen killed by group of men

Carl Lamb, 18, passed away on Monday night after being ambushed and mauled by a group of men while in the Antelope Street Extension area, where he lived with his mother. Police have released no details on the incident yet, but it has been reported that Lamb received death threats some months ago. Lamb was reportedly walking on



an unnamed street in the area when about 4 or 5 men pounced on him, and during the attack he received a fatal stab wound to the chest. It is believed that an older man, said to be 41-years old, was also involved in the attack that claimed Lamb's life.

Shanna Allen, Lamb's mother, reportedly found her son in a pool of muddy water and his own blood. He was pronounced dead shortly after reaching the Karl Heusner Memorial Hospital (KHMH) sometime after 7:00 on Monday night.

What could have led to the brutal murder is still uncertain, but there have been unconfirmed claims that he might have been the object of some animosity because of a female who expressed interest in him but had a jealous exboyfriend. His grieving mother has said that he was a helpful and loving son and was trying his best to get a job so that he could assist her financially. He was scheduled to attend a job interview on Tuesday this week, one day before his life was taken, and according to his mother, he had been hopeful that he would get a job.

Allen told local reporters that she became concerned when she started to observe that lights in the area were off when Lamb would walk past a certain section of the London bridges in the community at night.

Police have made no arrests in connection with this most recent murder in the Antelope Street area of Belize City.

representative, Hon. Marconi Leal, Sr., and officials of the Lands Department in an effort to get more land for Crooked Tree villagers. But they would never attend that meeting. At about 8:30 a.m., while journeying along the Philip Goldson Highway, all three men sustained injuries that would cause their deaths in a collision that occurred near Sandhill Village. The Isuzu D-Max reportedly ran head-on into a passenger bus belonging to Silva's Bus Line which was heading in the opposite direction toward Corozal and which veered into its lane to avoid hitting persons on the road after a taxi abruptly stopped on the highway. Two of the three men in the Isuzu D-Maxchairman of Crooked Tree Village, Brandon Gillet, 32; and the driver of the vehicle, James Dawson, 59-died instantly, while the driver's nephew, Eustace Dawson, Jr., 31, died before noon at a private hospital while receiving treatment.

According to reports, the accident occurred on a curve near Mile 17 on the Philip Goldson Highway in Sandhill Village. The Silva's passenger bus crossed onto the left lane of the highway and placed itself in the direct path of the incoming D-Max, which, according to some reports, was traveling at high speed—resulting in a deadly collision that caused extensive damage to the Isuzu pickup. So extensive was the damage that first responders had to use the Jaws of Life to extract James Dawson and Brandon Gillett from the vehicle, in which they were trapped.

The conductor of the Silva's passenger bus, Jonathan Estrada, told local reporters that the accident was caused by a taxi that stopped in the middle of the road.

"It was a taxi's fault. They stopped in the middle of the road, and to not crash into the taxi or kill the people that were standing there, we came off the road, but look like the Hilux, he got shocked and he come off the road and, head on. But we weren't going fast. It was the pickup that was going fast, and they crashed into us and thing, and all of this happened. So when we did, we come off the road completely because you can see what happened. The Dmax looked like he got frightened and come off of the road and came into [us] headon. And dah what killed them is mostly their speed, cause they were going fast," he said. It has been reported that the same taxi left the scene after the accident, without any aid being offered by its occupants. Following the accident, Minister Leal, with whom the men were scheduled to meet, told local reporters, "It's a sad day, not only for Crooked Tree, but these guys are well known all over Rural North, so it's a crushing blow for all of us. I was heading to Belmopan. We were supposed to have a meeting with them along with myself and Lands [Department], because we're trying to get more land in Crooked Tree for residents of Crooked Tree. These guys are working for the people. They're on the job. When I got

the message, I had to hurry call and cancel the meeting and try to get back here to support the family."

Leal noted Gillett's unrelenting efforts to pursue the interests of residents of his village, and said that he had in fact been at Gillett's home over the weekend and they had discussed Gillett's plans to improve Crooked Tree. "I was at his house Saturday night, me and my wife and my son, the CEO, just socializing, just talking about what we can do

for Crooked Tree. and for this to happen just a few days after, it's really sad, knowing that he's so aggressive, want to get things done for Crooked Tree, and a young man. I think about his wife and his son. I love his son, little Warren. When I heard it's three of them, I started to wonder if it's the chairman and his son, the son in there. That's why we had to ask, and no, it's not Warren. because I love Warren so much," he said.

The families of Gillet and Dawson are both grieving this tremendous loss. The Gillett family, in particular, has experienced a tragedy of this nature before. In 2003, the father of Gillett, Warren Tillett, was killed in an accident on the Western Highway.

In reference to James Dawson and his nephew, Eustace Dawson, Jr., Minister Leal said, "I don't know Eustace that well. I knew his dad more than I knew the son, but I was at a workshop like a month ago with cattle, so I know he's into the cattle business, and he was there asking a whole lot of question, and that was when I really got to know the young man. But James, I know him for years, many, many years, and I know he's a worker for his community ..." Notably, the men were also scheduled to meet with representatives of the Livestock Department on the morning that the accident occurred.

A candlelight vigil was held in Crooked Tree Village at its multipurpose building to honor the lives of "Brandon Gillett's Funeral Expenses", with the goal of raising 10,000 USD.

The driver of the Silva's passenger bus, 21-year-old Joel Disus of Guinea Grass Village, was served with a Notice of Intended Prosecution (NIP), and tonight, police reported that he has since been charged.


At UN, PM Briceño talks global finance, climate colonialism, and injustice to some nations

Just two days prior to the 77th Session of the United Nations General Assembly in New York, on September 23, our country celebrated its independence, which we got in 1981 after the United Nations (UN) declared in 1975 that we had an inalienable right to self-determination and independence, with our territory intact, but our Prime Minister, Hon. John Briceño, was in far from a festive mood when he spoke to the world body.

PM Briceño condemned the Russian invasion of Ukraine, he demanded Taiwan's inclusion in the community of nations, and he called for "an independent Palestinian state within its 1967 borders, with all attendant rights, including the recognition of East Jerusalem as its capital."

The Russian invasion, especially coming on the heels of the Covid-19 pandemic, has added stress to recovering economies across the globe, apart from threatening to unleash a deadly nuclear war. Taiwan, which has not only existed but thrived apart from Mainland China, is blocked from its rightful place as an independent nation/member of the UN because of Mainland China's threat of an invasion if it attains such status. Palestine, which was carved up by the world's powers in 1967 to give an independent state to displaced Jews, has seen its territory overrun by the said Jews who have, with the support of the US, acquired and developed a massive military arsenal.

The dramatic increase in the cost of goods, the disruption of the supply chain and skyrocketing inflation, are realities that are having a severe impact on the social situation in the less developed world. PM Briceño said poverty in Belize has risen by 10% since 2018, and in this world of heightened climatic risk we are a "hurricane away from catastrophe."



The PM said there must be a major change in the global financial infrastructure, instead of "tinkering at the edges." He said financial flows to vulnerable countries have declined, when they need debt relief, concessionary financing.

PM Briceño spoke about growing poverty in the poorer countries because of "climate colonialism". He said the great expectations emerging from COP 26 in Glasgow in 2021 were but a "paper promise", that our countries continue to suffer for something we did not cause, that the victims are being punished while the victimizers are being spared. The PM said that countries like Belize, which experienced losses in the trillions of dollars during the colonial period, are being ravaged by climate changeinduced weather disasters. He said "reparations are overdue." In 1492 Christopher Columbus was shipwrecked in the Caribbean, off the coast of Haiti, and there began the worst genocide, the worst slavery, and the largest transfer of wealth the world has ever seen. Columbus and the peoples of Europe brought diseases that wiped out millions in the Americas, and through their superior weaponry they subjugated the peoples of the so-called New World. The Europeans bought/

captured over 12 million Africans, and transported them in ships to the Americas, where they forced them and their children to labor on sugar and cotton plantations for more than 200 years. Through genocide and the enslavement of Africans, and then colonialism, the Europeans transported the wealth of Africa and the Americas to their countries, wealth which they used to advance the lives of their own citizens, while the peoples of Africa and the Americas were deprived.

PM Briceño called for the harsh US embargo on Cuba to be lifted. In 1959, Cuban dictator Fulgencio Batista was forced to flee Cuba, and in 1962, "in response to certain actions taken by the [new] Cuban Government" (US Dept. of State), the US, under President John Kennedy, proclaimed an embargo on trade between the two countries.

UN Affairs, at the website <u>https://news.un.org</u>, said that in June, 2021, for the 29th consecutive year the UN General Assembly overwhelmingly called on the US to lift the embargo. *UN Affairs* said a total of 184 countries "voted in favor of a resolution to demand the end of the US economic blockade on Cuba ... with the United States and Israel voting against." There were also three abstentions – Colombia, Ukraine, and Brazil.

PM Briceño expressed grave concern over the deteriorating situation in Haiti, and called on the UN to introduce a robust and comprehensive program to support the island nation.

After Haiti took its independence from France in 1804, the country became a safe haven for escaped slaves. Haiti provided a refuge for the South American hero, Simón Bolivar, and helped him militarily when he returned to South America in 1816 to liberate it from Spanish rule.

But the Europeans ganged up on the island to prevent its people from achieving economic success. To avoid war with France, in 1825 a Haitian government was forced to commit to paying the French government the incredible sum of 150 million francs. The US invaded and occupied Haiti from 1915 to 1934.

The destabilized Haiti has been led by a series of dictators, some democratically elected; the island has been battered by earthquakes and hurricanes; her people are mistreated wherever they go. Human rights activists say that Haitians who are in the Dominican Republic, some illegally and many who have lived in that country for years, are being hounded and chased across the border which the nations share.

In 2021 the president of Haiti was assassinated, and much of the country has fallen into the grip of violent gangs. Last year a bus carrying our national football team, which was in Haiti for a World Cup qualifier, was held up by an armed gang.

Haiti, the poorest country in our hemisphere, is in turmoil. Will the UN heed the PM's call? If it doesn't, then Haiti might have to find its answer in the "pink tide" that is sweeping across our region. In Honduras, El Salvador, Mexico, Bolivia, Colombia, and Peru, socialist governments, not communist, not Russian satellites, have been voted into power by people who have become tired of waiting for the imposed US economic system to address the needs of the masses. Those of us who love our brothers and sisters in Haiti must pray for that country to be caught in that tide, so their people can enjoy the prosperity only a properly administered "mixed economy" can bring. PM Briceño also spoke about our case before the ICJ, re: the Guatemalan claim to our territory. He called on the international community for its support, especially in helping us manage our daily challenges along the borders. The FCD (Friends for Conservation and Development) is in a constant battle to keep Guatemalans from crossing over and violating our land, and recently there was an incident where Guatemalan soldiers entered our territorial waters and removed our flags from Sarstoon Island. The PM's calls were heard around the world, but how the world's more and most powerful nations will respond is to be seen. Hopefully, they respond appropriately, but we all know it's up to us, for only the people can save the people. It's up to us to double our efforts to curb violence, protect our territory and environment, and end poverty in our nation.

BTB and Carnival Cruise Line hold recruitment exercise

Approximately 100 Belizeans were at the Belize Best Western Biltmore Plaza getting information about possible employment with Carnival Cruise Line. Hundreds of jobs are available, says BTB's Director of Quality Management and Capacity Development.

BELIZE CITY, Tues. Sept. 27, 2022

Today, Carnival Cruise Line, with the assistance of the Belize Tourism Board, held its first information session in Belize to provide Belizeans with information about opportunities for possible employment on a cruise ship. This is the first recruitment event in Belize of this nature, according to the BTB's Director of Quality Management and Capacity Development.

"BTB collaborated with the Carnival Cruise Line, one of our legacy partners for cruise tourism here in Belize, and basically it's an event to build awareness about the employment opportunities that exist in Carnival Cruise Line and their various brands for Belizeans to take advantage of. Today we had a team from Carnival coming down and explaining what it is to live to work and to be on a cruise line for around 100 Belizeans that attended today," Castaneda said.

He said that they are planning to hold additional events of this nature with other cruise lines, such as Norwegian Cruise Line, MSC Cruises, and Royal Caribbean, in order to possibly open the door for career opportunities for skilled Belizean workers.

"There may be a career opportunity and a career path that a Belizean that is working in a bar right now may be able to take on in a cruise line, housekeeping. We are very skilled in areas like tourism and hospitality services and all of that, so we believe the Belizean labor force is able to provide satisfactory services within the travel and trade industries and including cruise," he explained.

The cruise lines themselves are seeking more employees from their call destinations to provide services on their vessels. Castenada went on to say

"After Covid-19, the cruise lines have said, 'you know, we want to hire

people from the region, because we believe that would be the best services and experience that we can provide to our guests.' So that's why, like many other countries in the region, we are also providing this platform for people to see what the opportunities are," he said.

Belizeans who have received training in hospitality in Belize thus have an opportunity to take advantage of the jobs available on the various cruise lines as the rebound of the tourism industry continues.

"You would find that in destinations like Belize that are very heavily dependent on tourism, we have a lot of people that have been trained in hospitality services, and that's why we are focusing on that today. So, people that have worked in hotels, restaurants, in different areas of the service industry, we believe that we are as competitive, because we have been competitive for decades now," he said. Castaneda believes that competitive edge will give Belize the opportunity to provide great ambassadorship on the cruise lines which make calls in Belize.

Ruth Dolan, Hotel Talent Attraction Manager for the Carnival Cruise Line, agreed, telling local media, "Our guests really like to talk to local people about getting recommendations for places to go-and who better than people who live in the country?"

BDF and GAF meet following BTV Sarstoon incident

BELIZE CITY, Wed. Sept. 28, 2022

According to the Belize Defence Force (BDF) Chief of Staff, Lt. Col. Jermaine Burns, members of the BDF will be meeting their Guatemalan counterparts at a session that is routinely held under the auspices of the Organization of American States (OAS). At the top of the list of topics to be discussed will be the recent incursion into Belizean territory by the Guatemala

Navy, which seized two Belizean flags planted on Sarstoon Island by the Belize Territorial Volunteers (BTV), who placed the flags on the island during an annual ceremony carried out by the BTV to celebrate Belize's independence. According to Wil Maheia, who had led the BTV group to the island, the Guatemalan soldiers, who had tried to block the passage of their boats, had asserted that the island is the property of Guatemala. Burns said, however, that this incident is out of the ordinary, since the GAF has for the most part maintained a neutral presence in the last few years.

"We have Cadenas there at the very end of the Sarstoon and that our most southern conservation post on top of that hill, and so every other week we must patrol the Sarstoon to change over manpower there. We've never had any issues with the GAF, so it's surprising. It's almost like they had something against Wil, you know, for them to have accosted him and his crew," Burns commented. Notably, it is Lt. Col. Burns who will be heading the BDF delegation to Guatemala, and he has already stated his intention to mention the incident to the GAF (Guatemalan Armed Forces).

"We'll see where the discussion will go in respect to what they have to say about it, because [we] haven't had a flare-up like this in as much as two, three years, so it is a concern and we didn't expect this out of them," Burns said.

It has been suggested that the absence of Belizean soldiers at the Forward Operating Base (FOB) on Sarstoon Island, due to coastal erosion that prompted the relocation of soldiers who were stationed there to a base in Barranco, has emboldened the GAF to assert military force over the area. Lt. Col. Burns, noted, however, that although BDF soldiers do not sleep at the FOB at night, the soldiers do go to the base on the island every day. As mentioned, the current arrangement became necessary due to erosion of the ground on which the foundation posts of the front of the FOB building are located, which has compromised the structural stability of the building-thus placing the soldiers' well-being at risk. According to Burns, however, the government has assessed the area and is in the process of selecting a contractor to carry out rehabilitation works. "I can assure you, as we speak, there are men in the Sarstoon and at the FOB, they leave from Barranco at first light and they leave from the FOB at last light, and I know the plans for the rehabilitation of the FOB are well on the way. I think it is at the point where

they are sourcing a contractor now and get out there and finish up. So that is what to hasten on, to get our men back out there, patrolling the Sarstoon as we have been. I don't know if that gave the Guatemala Armed Forces a false sense of our security there, that in fact, they thought that we pulled out, so we are no longer interested in the Sarstoon. I hope that is not the case," Burns said.

Burns went on to commend the calm demeanor of the BTV group, and said that he hopes that the actions of the GAF were not an attempt to provoke acts of aggression by the group.

"It's strange, something ... I don't know if it was provoking, if they were trying to provoke our civilians or what the case was, but they know from the military standpoint our approach won't be aggressive. I don't know if they thought they could have aggressed the civilians to try and get them to a level of aggression where they would have done something, and then provoked the GAF to react, almost like they were baiting the civilians. And I hope that is not the case," Burns noted.

The meeting with the GAF, which takes place tomorrow, will hopefully shed some light on the state of mind of the group of Guatemalan soldiers who confronted the BTV group that day, and who can be seen in cellphone video footage (captured by the BTV) insisting that Sarstoon Island belongs to Guatemala.

"I saw those videos, and, just like you, I am equally alarmed, and I am eager to hear the answers from the practitioners tomorrow in Guatemala, the guys that are actually the bosses of those that are on the ground. Because

system, there is a lot to be desired. Those were the sentiments expressed by Belize City Mayor, Bernard Wagner in an interview with KREM News this weeksentiments shared by a large portion of the Belizean populace.

According to the Mayor, contrary to the belief expressed by the Belize Bus Association that the "Driving

Belize to Electric Mobility" pilot project will displace current operators, the project, which is being implemented in the City with the help of the UNDP and the EU, is aimed at giving the transport system a much needed facelift after decades of stagnation.

Through the program, Belize City will be receiving a total of three electric buses which the Mayor says will be fully equipped with the latest technology.

"Our endgame is really to serve our people. Our residents deserve the best. That is how I look at it. That is how my council looks at it. We have been experiencing situations where residents have been getting wet on buses. We have to, as the leaders, be able to give the best to our residents. They deserve the best, and these operators have had years and years to improve their buses, and they have done nothing to improve their companies,"

said Mayor Wagner.

The new buses will not prevent current bus owners from operating on their usual routes. What they will do, says the Mayor, is grant the residents of Belize City a choice.

"The existing buses will continue to do their route. The people will have the choice-do I want to support BBOC or do I want to get on a modern A/C bus that is efficient, that is reliable, and that is contributing to the lowering of CO2 in our city that contributes overall to the climate change impacts that are taking place around the world," he said.

In addition to providing buses that are powered by electricity and equipped with WIFI, the pilot project will also allow for the development of a bus tracking app. This will allow passengers to keep track of the arrival times of buses.

"It will be very, very affordable, costwise. It will be so affordable for the residents of this city. And so I hear the nonsense that is being spoken by some of the bus owners-they want to keep progress down, and that is where we go our separate ways," added the Mayor.

The Council, said Mayor Wagner, in no way desires a monopoly over the city's buses.

"Competition is very important, because you know when competition happens the people benefit, and that is what we're trying to do here as well," he stated.

Earlier this week, it was reported that the Belize Bus Association (BBA) and Belize City Shuttle had sent a letter to the resident representative of the United Nations Development Program to object to the manner in which the pilot project was being implemented-without the involvement of the current bus operators, whose revenue streams might be disrupted.

"We propose that the pilot be executed with the existing stakeholders," the letter stated.

The Tuesday issue of the AMANDALA referred to remarks made by the owner of Belize City Shuttle, Philip Jones, who said that the existing bus operators are the most appropriate entities to implement the pilot project in partnership with the government and UNDP, and it mentioned the BBA's assertion in the letter that the bus operators have "extensive reallife experience with managing bus fleets and years of commitment to the development of the industry." "Why are we excluded from sitting with the UNDP along with the members that are getting this grant? We should be a part of this; we shouldn't be excluded. If you say you want to improve the transportation industry, who is the fittest one? We have real-time experience, knowledge. We have been doing this from we jumped out of pampers, most of us. So why is it that we are not included?" Jones questioned. The Tuesday issue of the AMANDALA noted that Jones questioned how a pilot project could be done with no inclusion of members of the bus association and quoted him as saying, "You can't put us at a disadvantage. You cannot do that; that's unfair for the association; that's unfair for the bus industry."

En la ONU, PM Briceño habla de finanzas globales, colonialismo climático e injusticia hacia algunas naciones

Apenas dos días antes de la 77 Sesión de la Asamblea General de las Naciones Unidas en Nueva York el 23 de septiembre, nuestro país celebró su independencia, la cual conseguimos en 1981 luego de que la Organización de las Naciones Unidas (ONU) declarara en 1975 que teníamos un derecho inalienable a autodeterminación e independencia, con nuestro territorio intacto, pero nuestro Primer Ministro, el Honorable John Briceño, estaba lejos de un ambiente festivo cuando se dirigió al organismo mundial.

El primer ministro Briceño condenó la invasión rusa de Ucrania, exigió la inclusión de Taiwán en la comunidad de naciones y pidió "un estado palestino independiente dentro de sus fronteras de 1967, con todos los derechos correspondientes, incluido el reconocimiento de Jerusalén Este como su capital".

La invasión rusa, especialmente después de la pandemia de Covid-19, ha agregado estrés a las economías en recuperación en todo el mundo, además de amenazar con desatar una mortal guerra nuclear. Taiwán, que no solo ha existido sino que ha prosperado aparte de China continental, está bloqueado en el lugar que le corresponde como nación independiente/ miembro de la ONU debido a la amenaza de invasión de China continental si alcanza tal estatus. Palestina, que fue dividida por las potencias mundiales en 1967 para dar un estado independiente a los judíos desplazados, ha visto su territorio invadido por dichos judíos que, con el apoyo de los EE. UU., adquirieron y desarrollaron un enorme arsenal militar.

El aumento dramático en el costo de los bienes, la interrupción de la cadena de suministro y la inflación disparada, son realidades que están teniendo un impacto severo en la situación social en el mundo menos desarrollado. El primer ministro Briceño dijo que la pobreza en Belize ha aumentado un 10 % desde 2018, y en este mundo de mayor riesgo climático estamos a un "huracán de distancia de la catástrofe". El primer ministro dijo que debe haber un cambio importante en la infraestructura financiera mundial, en lugar de "hacer pequeños ajustes". Dijo que los flujos financieros a los países vulnerables han disminuido, cuando necesitan alivio de la deuda, financiación concesionaria.

El PM Briceño habló sobre el aumento de la pobreza en los países más pobres debido al "colonialismo climático". Dijo que las grandes expectativas que surgieron de la COP 26 en Glasgow en 2021 no eran más que una "promesa de papel", que nuestros países siguen sufriendo por algo que nosotros no causamos, que las víctimas están siendo castigadas mientras que los victimarios son perdonados. El primer ministro dijo que países como Belize, que experimentó pérdidas de billones de dólares durante el período colonial, están siendo devastados por desastres meteorológicos inducidos por el cambio climático. Dijo que "las reparaciones están atrasadas".

En 1492 Cristóbal Colón naufragó en el Caribe, frente a las costas de Haití, y allí comenzó el peor genocidio, la peor esclavitud y la transferencia de riqueza más grande que el mundo jamás haya visto. Colón y los pueblos de Europa trajeron enfermedades que acabaron con millones en las Américas, y con su superior armamento subyugaron a los pueblos del llamado Nuevo Mundo. Los europeos compraron/capturaron a más de 12 millones de africanos y los transportaron en barcos a las Américas, donde los obligaron a ellos y a sus hijos a trabajar en las plantaciones de azúcar y algodón durante más de 200 años. Mediante el genocidio y la esclavitud de los africanos, y luego el colonialismo, los europeos transportaron la riqueza de África y las Américas a sus países, riqueza que utilizaron para mejorar la vida de sus propios ciudadanos, mientras que los pueblos de África y las Américas se vieron privados. El primer ministro Briceño pidió que se levante el duro embargo de Estados Unidos contra Cuba. En 1959, el dictador cubano Fulgencio Batista se vio obligado a huir de Cuba, y en 1962, "en respuesta a ciertas acciones tomadas por el [nuevo] Gobierno cubano" (Departamento de Estado de EE. UU.), EE. UU., bajo la presidencia de John Kennedy, proclamó un embargo sobre el comercio entre los dos países. UN Affairs, en el sitio web https://news.un.org, dijo que en junio de 2021, por vigésimo noveno año consecutivo, la Asamblea General de la ONU pidió abrumadoramente a los Estados Unidos que levantara el embargo. UN Affairs dijo que un total de 184 países "votó a favor de una resolución para exigir el fin del bloqueo económico de Estados Unidos contra Cuba... con Estados Unidos e Israel votando en contra". También hubo tres abstenciones: Colombia, Ucrania y Brasil.

El primer ministro Briceño expresó su grave preocupación por el deterioro de la situación en Haití y pidió a la ONU que introduzca un programa sólido e integral para apoyar a la nación isleña.

Después de que Haití se independizó de Francia en 1804, el país se convirtió en un refugio seguro para los esclavos fugitivos. Haití proporcionó un refugio para el héroe sudamericano, Simón Bolívar, y lo ayudó militarmente cuando regresó a Sur América en 1816 para liberarla del dominio español.

Pero los europeos se unieron en la isla para evitar que su gente lograra el éxito económico. Para evitar la guerra con Francia, en 1825 un gobierno haitiano se vio obligado a comprometerse a pagar al gobierno francés la increíble suma de 150 millones de francos. Estados Unidos invadió y ocupó Haití desde 1915 hasta 1934.

El Haití desestabilizado ha sido dirigido por una serie de dictadores, algunos elegidos democráticamente; la isla ha sido azotada por terremotos y huracanes; su pueblo es maltratado dondequiera que va. Los activistas de derechos humanos dicen que los haitianos que están en la República Dominicana, algunos ilegalmente y muchos que han vivido en ese país durante años, están siendo acosados y perseguidos a través de la frontera que comparten las naciones.

En 2021, el presidente de Haití fue asesinado y gran parte del país ha caído en manos de pandillas violentas. El año pasado, un autobús que transportaba a nuestro equipo nacional de fútbol, que estaba en Haití para un partido de clasificación para la Copa del Mundo, fue asaltado por una banda armada.

Haití, el país más pobre de nuestro hemisferio, está en crisis. ¿Atenderá la ONU al llamado del primer ministro? Si no es el caso, es posible que Haití tenga que encontrar su respuesta en la "marea rosa" que se extiende por nuestra región. En Honduras, El Salvador, México, Bolivia, Colombia y Perú, gobiernos socialistas, no comunistas, no satélites rusos, han sido elegidos al poder por personas que se han cansado de esperar que el sistema económico impuesto por los EE. UU. aborde las necesidades de las masas. Aquellos de nosotros que amamos a nuestros hermanos y hermanas en Haití debemos orar para que ese país sea atrapado en esa marea, para que su gente pueda disfrutar de la prosperidad que solo puede traer una "economía mixta" adecuadamente administrada.

El PM Briceño también se refirió a nuestro caso ante la CIJ, sobre el reclamo guatemalteco a nuestro territorio. Pidió a la comunidad internacional su apoyo, especialmente para ayudarnos a manejar nuestros desafíos diarios a lo largo de las fronteras. Los Amigos para la Conservación y el Desarrollo (Friends for Conservation and Development, FCD) está en una batalla constante para evitar que los guatemaltecos crucen y violen nuestra tierra, y recientemente hubo un incidente en el que soldados guatemaltecos ingresaron a nuestras aguas territoriales y quitaron nuestras banderas de la isla Sarstún.

Los llamados del primer ministro se escucharon en todo el mundo, pero está por verse cómo responderán las naciones más poderosas del

mundo. Con suerte, responderán apropiadamente, pero todos sabemos que depende de nosotros, porque *solo el pueblo puede salvar al pueblo*. Depende de nosotros redoblar nuestros esfuerzos para frenar la violencia, proteger nuestro territorio y medio ambiente y terminar con la pobreza en nuestra nación.

Orange Walk woman beaten by landlord with metal pipe

ORANGE WALK, Thurs. Sept. 29, 2022

Jennifer Reneau, 36, a mother of two who was residing on Sapodilla Street in Orange Walk Town, underwent surgery on Thursday, September 29, on her fractured arm, which is one of several injuries she reportedly received when she was allegedly attacked with a metal pipe by her landlord, Eddy Tillett.

According to reports, Reneau had just arrived at her

residence after an extended shift at the Northern Regional Hospital, where she works, when she encountered Tillett on the veranda of the residence with a metal pipe, with which he proceeded to attack her.

Reneau, who apparently had told Tillett that she would be moving out of the residence, told 7News that, in addition to her fractured arm, Tillett hit her on every part of her body while she was trying to prevent him from hitting her in the face.

"The babysitter hurried [to] grab my baby and put the baby in the house. Right by the door, everything started

but you can't just tell me like that. I need to find a house before I

> have to pay you the rent. I am coming out [of] the house.' But he never understands that," Reneau told 7News.

> It is unclear what type of tenancy arrangement had existed between Tillett and Reneau, and whether there had been any violation of the terms of that agreement.

Tillett has been charged with three offenses: burglary, wounding, and damage to property, and is expected to appear in the Magistrate Court in Orange Walk on Thursday.

Reneau is searching for a new place to reside and until then she will be staying with a relative at their home.

GOB moves forward in implementing National Cybersecurity Strategy

On Thursday, stakeholders gathered at the Belize Biltmore Plaza to discuss the development of an action plan for the implementation of the National Cybersecurity Strategy over the course of the next six months. The strategy, which was first launched in November 2020, is aimed at addressing cybersecurity threats and challenges faced by Belize in order to increase preparedness for, and responsiveness to, these threats.

Since the National Cybersecurity Strategy 2020 - 2023 was launched two years ago, there has been some progress in securing cyberspace within the country. The passing of a Cybercrime Act and the establishment of a digital forensic laboratory are two examples of that progress. As 2023 fast approaches, however, there is still much work to be done.

During the forum, stakeholders discussed the potential areas of priority within the strategy as well as the actionable steps that can be taken to tackle those priority areas.

During his opening remarks, Minister of Home Affairs and New Growth Industries, Hon. Kareem Musa, noted that Belize's connectivity and dependence on internet-based platforms has grown exponentially over the past ten years, and even more so as a result of the COVID-19 pandemic.

"As you would notice over the past few years, cybercrime is becoming more and more of a priority, not just for Belize but across the world. We see cyber-attacks happening all over, especially in our region; some countries [and] some parliaments have been breached and it takes so many different forms, because we are living now in a new digitalized era – the Metaverse, so to speak. And with all the opportunities that come with being a part of this new revolution, there are also vulnerabilities, also a risk, [and] breaches that can take place, and so this is very important for us as a

The minister has taken this same sentiment in his approach to helping the industry recover and revive. Civic pride is a culture of giving back. Through the BTB's Frontline Hero initiative, the BTB has awarded dedicated professionals for their service during the pandemic. The Minister has been at the groundbreaking ceremonies for the Placencia Polyclinic, the Teakettle Facilitation Center, and the Berger Field Development in Belize City. He has stopped in to watch students at Belize Elementary School demonstrate their robotics skills, he was there to kick off the Mundialito Tournament at the MCC Grounds, he sat in meetings to develop tourism in Dangriga and made it for other meetings with the Diaspora in Los Angeles, New York, and Washington. The Minister has personally been there to hand over lap tops, vehicles, and monetary donations to worthy Belizeans and Belizean organizations. Leadership calls for toughness

In a US college football game last week, Notre Dame versus University of North Carolina (UNC), late in the fourth quarter, one of the UNC players was called for unsportsmanlike conduct, for twirling the ball, and one of the announcers berated the referee for calling the penalty. Indeed, twirling the ball is not overly boastful, and the player didn't really make a show of it, but as the announcer's companion noted, the referee didn't have a choice; he had to apply the rule. Disappointingly, the announcer who took exception insisted that it was a stupid call.

Thankfully, the announcer who was sober stood his ground. It was not the referee's prerogative. Like the foot soldiers in the poem "The Charge of the Light Brigade", by Alfred Lord Tennyson, the referee's place was not to reason why, not to question the wisdom of the rule.

Some people like to talk, but in simulated life, sports, referees just follow the rules. It's a little different in the real thing. Leaders have rules to guide them, but sometimes they do have to make decisions that are outside of the script. Sometimes, they just have to be tough.

I know that the engineers muffed the design when they "improved" Bolton Bridge, near where I lived in Belize City when I was a child, or the contractor blew it. The end of that story is that after they finished the work, the best truck drivers couldn't make the turn off Bolton Bridge into West Canal. My paternal grampa, seeing their dilemma, pulled in his fence over three feet. They did break his fence a few times before my grampa hailed my granny's godson, Simeon Ebanks, to help him pull back the fence. I don't know if my grampa got tired of waiting for the authorities to step up. They didn't. He did.

The engineers or contractors absolutely messed up the north side of the George Price Highway when they

improved it, and it is beginning to look like forever and ever that the people in my village will pay, if the GOB doesn't make a tough decision. Two things went miserably wrong with the job. There are too many culverts. A simple inner road would have taken out the need for 80% of them along the stretch of highway. The second story is that on that side of the highway some people encroached, pushed their property line into the buffer zone. The end story is that on the east side of the village school children and everyone who wants to get from here to there have to walk/ride on the highway.

I have much personal bias in this one. Sometimes I need a tool or nails, and there's a store that sells hardware a little over a mile east from where I live. But half the distance there I have to walk on the highway. I bex bad about what happened here. Bah, I hate driving. I love walking, nayli as much as George Price and Micky Craig.

Leaders have to make tough decisions sometimes. I don't know how Julius and his team are going to do it, but this wrong has to be put right fu all a wi who live in the village, especially the children.

Assad's insults

It being accepted that you can't teach an old dog new tricks and a leopard can't change his spots, I'm not after converting Assad Shoman, nor his legion fans who drool over his every word. I'm just about putting some things right, for Belizeans who haven't explored other sides of the story, and for foreigners who come here and haven't had the time to get under the surface to the other threads in our national story.

In his most recent piece, "Why Belize Needs A People's Constitution", the gentleman couldn't resist throwing some blows at our association with the British – what's new? I guess he was about encouraging his crowd. Whyare those suspects in need of reassurance? I'm not aware of anybody bothering them and their disappointing interpretation of our history.

Assad's achievements aside, and he did quite a bit in support of the peaceful, constructive Belizean Revolution, he has the common guilt of many, which is carrying their baggage wherever they go. He's a mature man now, but no matter that, he couldn't get through his essay without throwing some slander at September 10.

His first mischievous salvo was directed at members of our society who receive titles from the UK. "And so," he says, "every year we witness the sorry spectacle of peoples in their former colonies dribbling over their 'honours' like MBE, which means member of the British EMPIRE!" Hmm, I'll never get one; I haven't even been offered a JP. Bah, there's this constant attack on Dame Froyla by some of his friends, for her accepting the GG's position, when, they say, the British did so much wrong to the Maya here.

Whenever you listen to a man or read his message, keep in mind the source, where he comes from. Assad is a Palestinian Belizean. Palestinians are very unhappy with the British. I don't suggest Mr. Shoman doesn't have tons for his beef there. I suggest that the Maya of Toledo didn't have the same experience with the British that the Palestinians did.

According to BBC News, "The State of Israel was proclaimed on 14 May 1948, the culmination of nearly 2,000 years of hopes by Jewish people...The Balfour Declaration by the British government in 1917, enshrined in a League of Nations mandate in 1920, had said that a 'national home for the Jewish people' would be founded in Palestine, while preserving the 'civil and religious' rights of non-Jewish communities there. General Assembly voted (resolution 181) to partition Palestine between a Jewish and an Arab state, with Jerusalem under an international regime. The Jews agreed but the Arabs did not. They called the declaration of the State of Israel 'al-Nakba', the catastrophe."

Speaking of the daam British at work here, he said, "they were especially good at confounding people in Belize, as we were taught that slavery was 'not as bad' here, and that slaves fought shoulder to shoulder alongside their masters, preferring slavery under the British" and that he knew "of no other former slave society (and Belize began life as a slave society) that actually celebrates a day when the slave masters won the right to continue enslaving the people for forty more years."

Assad has a lot of facts, but I don't see him as a fair fighter. Hmm, allow me a little pause to segweh briefly to O. Nigel Bolland. I owe him an apology, for putting him in the same boat with Assad. I believe that occurred because whenever I'm reading Assad I think of that gentleman, maybe because of their joint effort in a book, maybe because Assad references his work so often. I've read far more Assad than Bolland.

Returning to Mr. Shoman, if life was a straight line, if the world was black and white, he wouldn't be so off-base. But in a world as complicated as the one that we live in, really, it is low sophistry for one to ignore the many variables in the soup.

We've heard the story that the 10th was a made-up thing, a hundred years after a skirmish, that the white Creoles here threw a parade to fool the people. For starters, I think we should find out who the people were who were fooled. We're talking 1898 here. I say, sure, the government was colonial, and BEC owned thousands and thousands of acres, but the records show that many Kriols had a little piece, some quite a bit of the Jewel. Braa, the folk here had something to celebrate.





Belize participates in 41st ICAO General Assembly

MONTREAL, Canada, Tues. Sept. 27, 2022

A delegation from the Ministry of Blue Economy and Civil Aviation is in attendance at the 41st General Assembly of the International Civil Aviation Organization (ICAO) that is currently ongoing in Montreal, Canada. More than 2,500 delegates from 193 member states have convened at the General Assembly, which is called once every three years by the ICAO as part of an effort to secure the highest possible standard of global aviation.

The delegation from Belize, which includes Minister of Civil Aviation, Hon. Andre Perez, and CEO of the Ministry, Kennedy Carrillo, among other Civil Aviation officials, will focus on promoting policies "regarding unruly passengers aboard aircraft, cybersecurity, gender equality, economic development, and environmental protection," a release from the Civil Aviation Ministry states.

Also on Belize's agenda is a call for the inclusion of Taiwan in ICAO decisionmaking processes, in light of the country's crucial role in global air traffic.

"Belize notes that Taiwan plays a crucial role in international aviation activities as in 2019, prior to the COVID-19 pandemic, its airspace managed 1.85 million flights which moved a total of 72 million travelers. In 2021, Taiwan saw the movement of 2.92 million tons of cargo through its airspace, much of which was vital to the COVID-19 recovery process," the release from the Ministry states.

Belize also plans to discuss its proposal recently approved by Cabinet for Belize City to become an airport hub city as well as other undertakings that will "continue to formalize its home-

grown initiatives set out in its strategic plan," the release states.

Leon Perez to be tried in Supreme Court for Coast Guard officer's death

BELIZE CITY, Wed. Sept. 28, 2022 On Monday, September 26, Senior Magistrate Aretha Ford ruled in a preliminary enquiry that Leon Perez, 39, who is accused of fatally stabbing a Belize Coast Guard officer, Elston Morter, 28, on Independence Day (September 21) last year, will be tried Leon Perez, 39, is to stand trial in the Supreme Court for the murder of Belize Coast Guard officer, 28-yearold Elston Morter, on Independence Day in 2021

in the Supreme Court during its January 2023 session.

Perez, who is being represented by attorney Ian Gray, opted to reserve the right to submit his alibi in writing within seven days, which will have elapsed on Monday, October 3.

Morter and a friend of his, Marcel Adrian Gill, a 28-year-old security guard, had been socializing at Gill's home in Hattieville when the two men decided to go to Perez's home, which was nearby, but while they were there, an argument flared up between the three men, and during the dispute, Perez allegedly pulled out a knife and proceeded to fatally stab Morter and injure Gill.

Morter and Gill were transported to

the Karl Heusner Memorial Hospital, where Morter passed away due to his injuries. Gill, however, survived the attack. Perez was arrested and charged with murder days after the incident.

Armed robbers raid Lin's Super Store

SANTA ELENA TOWN, Cayo District, Thurs. Sept. 29, 2022

On Wednesday, September 28, Lin's Super Store, which is located beside the La Loma Luz Adventist Hospital on the George Price Highway in Santa Elena, Cayo District, was robbed by three men who stole cash as well as the 9mm pistol of the security guard at the establishment.

When police arrived at the scene, the owner of the store, Chinese businessman Peter Chen, told the authorities that at around 4:40 p.m. that day, three men arrived on two motorcycles.

Chen recounted to police that the men, who were wearing long jeans pants, and long dark-colored shirts with green traffic vests, held his security guard who was standing at the front door at gunpoint and stripped him of his firearm. The men then proceeded to enter the store and searched the two cash registers, both situated at the entrance of the establishment.

They took approximately \$1,500.00 from each cash register, then grabbed Chen and stole his wallet, which contained his personal identification cards and \$300 in cash.

Police are investigating.

BWS and Cuban Entities Collaborates to strengthen cooperation



On September 16, 2022, BWS signed an official Memorandum of Understanding with the National Institute of Hydraulic Resources of Cuba (NIHR), that will strengthen the exchange and co-operation between Belize and Cuba on issues related to water and sanitation. Belize's Ambassador to Cuba Mrs. Annie-Lou Burns Martinez was very instrumental in coordinating the visit of our contingent who were able to visit some water facilities and to discuss a way forward.

- Provide technical advice and support on the use of groundwater as an alternative solution during periods of drought, this may include from research stage.
- Provide short and long-term training (at all levels) on topics of interest, including educational opportunities

- Sharing new Concepts and ideas for supply of water to tourist areas, especially for the Cayes in Belize.
- Scheduling of visits to Belize for the Cuban Delegates based on needs and agreements made during the mission, as well as the exploration of the hydraulic systems in Belize.

• To identify suppliers in the water and sanitation sector, evaluating the possible integration into the projects for both countries.

• Realization of laboratory analysis of water quality and characterization of residuals including advice for the accreditation of tests and laboratories.

- Assisting with the accreditation of the water and sanitation lab in Belize.
- To explore business relationships for the procurement of pipes, accessories, and other resources.
- Create alliances to work in other countries of the region with the possibility of obtaining financing and other benefits in the water sector of both countries.

BWS extends our gratitude to: our Prime Minister Hon. 
Speech of President Gustavo Petro at the UN

Permit me, our dear readers of this column, to present to you the following speech, which I find to be of utmost importance. I would like to highlight how the president of Colombia, Gustavo Petro Urrego, delivered his speech. He did not read it from a written script, which means that he didn't prepare any; instead he spoke every word straight from his mind and heart. The following is the speech President Petro gave at the 77th Session of the United Nations General Assembly, dated September 20th, 2022. It is as follows:

"I come from one of the three most beautiful countries on Earth. There is an explosion of life there. Thousands of multicolored species in the seas, in the skies, on the land... I come from the land of yellow butterflies and magic. There in the mountains and valleys of all greens, not only the abundant waters flow down, but also the torrents of blood. I come from a country of bloody beauty. My country is not only beautiful, it is also violent. How can beauty be combined with death? How can the biodiversity of life erupt with the dances of death and horror? Who is to blame for breaking the spell with terror? Who or what is responsible for drowning life in the routine decisions of wealth and interest? Who leads us to destruction as a nation and as a people? My country is beautiful because it has the Amazon Jungle, the Chocó Jungle, the waters, the Andes Mountain ranges, and the oceans. There in those jungles,

planetary oxygen is released and atmospheric CO2 is absorbed. One of those plants that absorbs CO2, among millions of species, is one of the most persecuted on earth. At any cost, its destruction is sought: it is an Amazonian plant, it is the coca plant, the sacred plant of the Incas.

As in a paradoxical crossroads, the jungle that is trying to be saved is at the same time destroyed. To destroy the coca plant, they throw poisons, glyphosate, en masse that runs through the waters; they arrest their growers and imprison them. For destroying or possessing the coca leaf, a million Latin Americans are murdered and two million Afro-Americans are imprisoned



The US Government-funded Millennium Challenge Corporation (MCC) has selected Belize as one

of only two countries in the world for a five-year government to government grant to fund a program aimed at reducing poverty and stimulating economic growth.

in North America. Destroy the plant that kills, they cry from the north, but the plant is just one more plant among the millions that perish when they unleash fire on the jungle. Destroying the jungle, the Amazon, has become the slogan followed by states and businessmen. The cry of scientists baptizing the Jungle as one of the great climatic pillars does not matter. For the power relations of the world, the jungle and its inhabitants are to blame for the plague that plagues them. The power relations are plagued by the addiction to money, to perpetuate oneself, to oil, to cocaine and to the hardest drugs in order to be able to anesthetize more. Nothing more hypocritical than the speech to save the Jungle. The jungle is burning, gentlemen, while you wage war and play with it. The jungle, the climatic pillar of the world, disappears with all its life. The great sponge that absorbs the planetary CO2 evaporates. The saving jungle is seen in my country as the enemy to defeat, as the undergrowth to be extinguished. The space of coca and of the peasants who cultivate it, because they have nothing else to cultivate, is demonized.

For you, my country is of no interest to you except to throw poisons into your jungles, take your men to jail and throw your women into exclusion. They are not interested in the child's education, but rather in killing his jungle and extracting the coal and oil from his entrails. The sponge that absorbs the poisons is useless, they prefer to throw more poisons into the atmosphere. We serve them to excuse the emptiness and loneliness of their own society that lead them to live in the midst of drug bubbles. We hide from them their problems that they refuse to reform. It is better to declare war on the jungle, its plants, its people. While they let the forests burn, while hypocrites persecute the plants with poisons to hide the disasters of their own society, they ask us for more and more coal, more and more oil, to calm the other addiction: that of consumption, that of power, that of money. What is more poisonous for humanity: cocaine, coal or oil? The opinion of the power has ordered that cocaine is the poison and must be persecuted, so it only causes minimal deaths by overdose, and more by the mixtures that its ruled clandestine causes, but, instead, coal and oil must be protected, so that its use can extinguish all mankind. These are the things of world power, things of injustice, things of irrationality, because world power has become irrational. They see in the exuberance of the jungle, in its vitality, the lustful, the sinful; the guilty origin of the sadness of their societies, imbued with the



unlimited compulsion to have and consume. How to hide the loneliness of the heart, its dryness in the midst of societies without affection, competitive to the point of imprisoning the soul in solitude, if not by blaming the plant, the man who cultivates it, the libertarian secrets of the jungle.

According to the irrational power of the world, it is not the fault of the market that cuts down on existence, the fault lies with the jungle and those who inhabit it. Bank accounts have become unlimited, the money saved by the most powerful on earth can no longer even be spent in the time of centuries. The sadness of existence produced by this artificial summons to competition fills it with noise and drugs. Addiction to money and having has another face: drug addiction in people who lose the competition, in the losers of the artificial race they have transformed humanity into. The disease of loneliness will not be cured by glyphosate on the jungles. The jungle is not to blame. The culprit is their society educated in endless consumption, in the stupid confusion between consumption and happiness that allows, yes, that the pockets of power are filled with money. The culprit of drug addiction is not the jungle, it is the irrationality of its world power. Give a blow of reason to his power. Turn on the lights of the century again.

The war on drugs has lasted 40 years. If we do not correct the course and it continues for another 40 years, the United States will see 2,800,000 young people die of overdose due to fentanyl, which is not produced in our Latin America. You will see millions of Afro-Americans being imprisoned in their private prisons. The imprisoned Afro will become the business of prison companies, a million more Latin Americans will be murdered, our waters and our green fields will be filled with blood, they will see the dream of democracy die both in my America and in Anglo-Saxon America. Democracy will die where it was born, in the great Western European Athens. By hiding the truth, they will see the jungle and democracies die. The war on drugs has failed. The fight against the climate crisis has failed. Mortal consumption has increased, from soft drugs to harder ones. There has been a genocide on my continent and in my country; millions of people have been sentenced to prison. To hide their own social guilt they have blamed the Jungle and its plants. They have filled speeches and policies with no reason. I demand from here, from my wounded Latin America, to put an end to the irrational war on drugs. Reducing drug use does not need wars, it needs us all to build a better society: a more supportive, more affectionate society, where the intensity of life saves us from addictions and the new slaveries. Do you want less drugs? Think of less profit and more love. Think of a rational exercise of power. Do not touch the beauty of my country with your poisons. Help us without hypocrisy to save the Amazon Rainforest to save the life of humanity on the planet. You gathered the scientists, and they spoke with reason.

With mathematics and climatological models, they said that the end of the human species was near, that its time is no longer millennia, not even centuries. Science set off the alarm, and we stopped listening to it. The war served as an excuse for us not to take the necessary measures. When actions were most needed, when speeches no longer served, when it was essential to deposit money in the funds to save humanity, when it was necessary to get away from coal and oil as soon as possible, one war and another and another were invented. They invaded Ukraine, but also Iraq, and Libya and Syria. They invaded in the name of oil and gas. They discovered in the 21st century the worst of their addictions: addiction to money and oil. Wars have served as an excuse for not acting against the climate crisis. The wars have shown them how dependent they are on what will end the human species. If you observe that the peoples are filled with hunger and thirst and migrate by millions to the north, towards where the water is; so you lock them up, build walls, deploy machine guns, shoot at them. They expel them as if they were not human beings; they quintuple the mentality of those who politically created the gas chambers and the concentration camps, they reproduce 1933 on a planetary scale.

The great triumph of the assault on reason. Do they not see that the solution to the great exodus unleashed on their countries is to return to the water to fill the rivers and the fields to be filled with nutrients? The climatic disaster fills us with viruses that swarm us, but you do business with medicines and turn vaccines into merchandise. They propose that the market will save us from what the market itself has created. The Frankenstein of humanity is in letting the market and greed act without planning, giving up the brain and reason. Kneeling human rationality to greed. Why war if what we need is to save the human species? What is NATO and empires for, if what is coming is the end of intelligence? The climatic disaster will kill hundreds of millions of people and listen well: it is not produced by the planet, it is produced by capital. The cause of climate disaster is capital. The logic of relating to each other to consume more and more, produce more and more, and so that some earn more and more produces climate disaster. They articulated the logic of expanded accumulation, the energy engines of coal and oil and unleashed the hurricane: the chemical change of the atmosphere that is deeper and more deadly. Now in a parallel world, the expanded accumulation of capital is an expanded accumulation of death. From the jungle lands and beauty. There where they decided to make an enemy of an Amazon jungle plant, extradite and imprison its growers. I invite you to stop the war, and to stop the climatic disaster. Here, in this Amazon Jungle, there is a failure of humanity. Behind the bonfires that burn her, after her poisoning, there is an integral, civilizational failure of humanity. Behind the addiction to cocaine and drugs, behind the addiction to oil and coal, is the true addiction of this phase of human history: the addiction to irrational power, profit and money. Here is the huge deadly

Dead fish vendor found on Chan Pine Ridge Road

CHAN PINE RIDGE, Orange Walk District, Mon. Sept. 26, 2022

A post-mortem examination was done on the body of 59-year-old Sergio Giovanni Valdez, a fish vendor whose body was found at about 6:00 a.m. on Thursday, September 22 on the Chan Pine Ridge Road. The postmortem results confirmed that Valdez, who was shirtless and had several facial injuries when he was found, died as a result of chop wounds.

According to ASP Fitzroy Yearwood, Communications Director of the Belize Police Department, Valdez's death was caused by a spinal injury that resulted from chop wounds. ASP Yearwood also highlighted that investigators are canvassing the area and are pleading with the residents of the area to come forward with any information regarding Valdez's death.

ASP Yearwood was asked by several reporters whether there are any surveillance cameras in the area which might have recorded the events which led to Valdez's death. ASP Yearwood said that he is unsure whether cameras or proper lighting are in the area.

BDF soldiers injured in crash were headed to military meeting

BELIZE CITY, Tues. Sept. 27, 2022

According to Belize Defence Force (BDF) Chief of Staff, Lieutenant Colonel Jermaine Burns, the BDF soldiers involved in a road traffic accident on Monday were

headed to the northern border when the incident occurred. Burns said, in an interview with KREM News, that the soldiers were to be picked up by their Mexican counterparts at the border and taken into a meeting. But that never occurred, because, as we



reported in the Tuesday edition of *Amandala* this week, the vehicle that they were travelling in careened off the road somewhere near Mile 22 on the Philip Goldson Highway.

Burns said that other members of the BDF were participating in the conference when they learned that the vehicle overturned near the Maskall junction. The driver, reportedly, had lost control. The occupants of the vehicle, three soldiers, received multiple injuries, including to the head. They were, however, expected to be released from the hospital by Tuesday morning.

Whether or not the accident was caused by a vehicular malfunction is still being assessed. Lt. Col. Burns does not believe that speeding played a role in the accident, since the vehicle, considered a small class vehicle in the Belize Defence Force, was "an old vehicle".

Former butane importers win claim against GOB

Gas Co. Ltd., Southern Choice Butane Ltd., and Belize Western Energy Ltd. to compensate them for losses suffered when the government passed legislation that essentially designated one official importer of butane to the country: the National Gas Company. The companies, seeking to regain their place in the local butane industry, had also requested that the legislation, the National Liquefied Petroleum Gas Project (NLPGP) Act, be struck down, along with four other constitutional claims, but were only granted relief to compensate them for their losses claimed before the 2021 amendment of the 2019 legislation.

In her judgment, Justice Arana, who will soon ascend to the Court of Appeal, reasoned that the passing of the NLPGP Act amounted to an expropriation of the property once held by those companies which had dominated the industry for a considerable number of years, since they had engaged in importation of butane for countless years (three decades) prior to the passing of the legislation by the Barrow administration in 2019.

Those companies, which are Central American enterprises, thus lost their place in the industry after being supplanted by a single entity that is partially owned by government (25%), while private shareholders own 75%. According to remarks made by attorney Audrey Matura in 2020, the private entities with partial ownership include M and M Limited of Sittee Street; GA Roe and Sons, of Coney Drive; BELCO of Mile 63 of the George Price Highway; Gilbert Canton and Bowen and Bowen Limited. But she noted that the largest number of shares was held by an American-registered company by the name of B.W.T. Holdings LLP, whose address is listed as 164 Industrial Parkway, Jackson, Minnesota, U.S.A.

That new monopoly entity, the NGC, was given a 15-year tax break. A Belize Chamber of Commerce and Industry Policy Tracker stated in 2020, "In terms of exemptions, the Bill proposes to exempt the National Gas Company (Belize) Ltd. (the 'Developer') from duties, taxes and imposts levied or imposed under the likes of the Income and Business Tax Act, the General Sales Tax (GST) Act, Customs and Excise Duties Act, and the Exchange Control Regulation Act." "The direct effect of the exercise of legislative power in this at the bar is that, in one fell swoop, customers in Belize who formerly relied on the Claimants to provide their LPG needs for the past 30 years became customers of NGC, the sole importer licensed under both Acts to date," Justice Arana's written judgment states. Last October, the Government of Belize moved to adjust the NLPGPAct, thus opening the door for importation by private entities under an amendment that allows a tendering process for butane importation.

exclusivity of the right to import that was granted to the NGC, which, in the view of the claimants, who were already in the industry, was a breach of their constitutional rights. The amendment was geared at instituting a tendering process to allow other companies to import butane, but the claims are that the standards set in the amendment are too high for the former importers to meet. Notably, under the amendment, LPG can only be imported through supervised tendering.

Today, when interviewed by reporters, attorney Audrey Matura, who was representing the former butane importers, outlined how difficult it would be for a company other than the NGC to meet those standards.

"So the law is saying now, okay, you could import. But you could import if you one of two things — the first one is you can build you own terminal that NGC has. The terminal has to be 1.5 million US gal. capacity and the terminal have to meet all the requirements that we say and we'll give you a license. However, the reason it is unattainable is because, 1. NGC already has the leg up, 2. The market is not big enough for two terminals, 3. NGC got concession and tax exemptions, and so many investments from within the government.....and even after, if my clients go and invest in a facility, nothing in the law says that they will be given the license." Matura said today.

In an interview today, Matura pointed out that a portion of Justice Arana's judgement notes that had the law not been amended in October 2021 by the PUP administration, all claims made by her clients would have been successful.

"In my respectful view, if the original Act had remained unamended, the Claimants would have succeeded on all the issues raised in this claim, because the monopoly created by that original Act clearly violated all the Claimants' constitutional rights as they have averred," the judgement states.

During the interview, Matura noted, "What I notice has happened, it was a trend of the Barrow administration, that any time they are losing in court, they hurry change the law to win, and I was very disappointed that the Briceno administration would stoop so low to that kind of strategy as well, and so that amendment and they made that they believed cured everything could not have cured everything, because the main thing is, can these people really import?" In November 2021, following the introduction of the amendments to the legislation, Matura had lamented, "It is at the point where we were making final legal submissions in writing and then we were to have oral submissions in December and the judge would give her decision in writing. But when we saw that this new legislation came out, of course we were shocked, because here we have a case that touches and concerns the very issue that this legislation is seeking to amend. And we were never consulted, our clients were never approached or anything. And so, we believe that it's unfortunate that in Belize that the government is able to take the power of the legislature to try and undermine the actual process of

15 more migrants caught crossing Mopan River

BELIZE CITY, Wed. Sept. 28, 2022

The Police Department's Mobile Interdiction Team (MIT) reportedly intercepted 15 Central American migrants attempting a pre-dawn crossing of the Mopan River yesterday morning. The groupconsisting of 6 adult males, 5 adult females and 4 minors—was found near Paslow Falls in the Cayo District. They were trying to evade the checkpoint in Bullet

Tree Falls when the MIT encountered them. The migrants, who are from Honduras, El Salvador, and Nicaragua, are currently in the custody of the Immigration Department and may face charges for illegal entry.

This week we reported on the detention of 27 Cuban migrants near the Belizean western border. Earlier this month, a group of 16 Cubans were in a boat that drifted toward the shore of Ambergris Caye after malfunctioning out at sea, and various other instances of the detention of Cuban and Central American migrants have been reported since the start of this year.

In April, the Government of Belize, through its Ministry of Foreign Affairs, noted an upsurge in the number of Cuban migrants since the reopening of the land border. There has been some friction between the Human Rights Commission in Belize and the government due to their differing approaches to managing this upsurge—with the government making claims that some Cuban nationals have utilized refugee programs in order to avoid

repatriation back to their home country. They reported in April that 13 Cuban nationals released to the Human Rights Commission following a court ruling in March fled from the shelter. Those persons never returned, and likely crossed the border.

Reports are that the current wave of Cuban migrants exceeds the number of migrants involved in the two largest waves, the Mariel Boat Lift in 1980 and the Balsero Crisis in 1994, combined.

The nation of Cuba has been hardpressed by the unilateral US embargo in place since 1961, which was exacerbated by additional sanctions imposed by the U.S. at the height of the Covid-19 pandemic. Those additional sanctions, which include blockages on the procurement of life-saving medicines and medical supplies, have placed great strain on the country's healthcare system.

The US embargo also resulted in a shortage of food across the island nation during that time, triggering in 2021 the largest anti-government protest since 1994.



PLB teams in mad scramble to reach playoffs


Bandits still hopeful; strikers getting hot



along with it devastating storm surges and winds of up to 155 miles per hour (mph).

US President Joe Biden has said that Ian could possibly be the deadliest storm in Florida's history. This comes after some early reports of substantial loss of life, reports ABC News.

By Thursday morning, Ian had weakened to a tropical storm, but it is flooding.

Ian has also left more than two million persons without power.

"You're looking at a storm that's changed the character of a significant part of our state. And this is going to require not just emergency response now, in the days or weeks ahead. I mean, this is going to require years of effort to be able to rebuild and to come back," added DeSantis. Just as Ian had made landfall near the island of Cayo Costa, DeSantis warned state residents of the catastrophic flooding that was to come, the Washington Post reports. He had also advised residents to treat Ian the way one would treat a tornado approaching their home. Since the early hours of Thursday morning, emergency first responders have been hard at work carrying out search and rescue missions. President Biden has declared a major disaster in the state due to the destruction caused and has offered federal aid for local and statewide recovery. On Tuesday, Ian struck Western Cuba. There, it left two persons dead and damaged buildings nationwide, BBC reports. The storm had also caused an island-wide power outage that affected some 11 million people. Two days later, power is finally, albeit slowly, being restored across the country.



even more cemented in the new amendments that are being proposed. When I read the provision, it was as if they took our legal submission and for every point, they made an amendment. That's how I see it. That is my personal view; It is to defeat something that's already before the court. And I will say that with a bit of fear, because now I understand the level of power..."

At this time the National Gas Company stores all the butane it imports into the country at its marine bulk terminal at the Big Creek Port in Independence, Belize, and at two distribution depots, one in Belmopan and another in Orange Walk.

Lead attorney for the Government, Andrew Marshalleck, has told local media that only a fraction of what was being claimed by the companies was granted in the judgment. He further reasoned that while the approximately 11-million-dollar judgment may seem to be a staggering amount to the average Belizean citizen, on an industry level such an amount is just a drop in the those were not upheld by the court, since they were not substantiated, according to the presiding judge. The written submission of claims made in March 2021 was, however, upheld and is as follows:

Gas Tomza and Western Gas claimed \$1,963,441.28 for loss of wholesale clients. Gas Tomza also claimed \$2,120,698.00 for loss of sales from retail customers, and another 1,405,123.00 for loss of sales from distribution and its concession plant. Western Gas claimed \$574,105.00 for loss of sales from non-retail customers and \$572,402.00 from losses at bulk and wholesale and distribution and concession plant sales. Zeta Gas recorded a total loss of \$2,488,937.12. In addition to this, \$1,772,074.85 was paid to Belize Western Energy as damages for loss of goodwill.

No vindicatory damages were awarded. The attorneys representing the claimants were Douglas Mendez, Senior Counsel; Audrey Matura and Jose Alpuche.

The government or claimants will have the option to appeal this judgment

area of the Corozal District a little before 7:00 p.m. last night. Residents of the area have reported hearing gunshots, and when police arrived they found the victim in an unconscious state with three apparent gunshot wounds.

His grey Toyota Corolla was missing — presumably stolen by the perpetrators. (It was later reported that the abandoned car was found in a cane field.) Also missing were a silver bracelet, ring, and chain that belonged to Flowers, and his wallet and black Alcatel cell phone were also not found.

Flowers, who was a police officer prior to becoming a taxi driver, was identified by his common-law wife, Barbara Acosta, shortly after the discovery of his body. He was last seen alive at the Corozal Venus Bus line taxi union parking lot, where the person who requested his services approached him. Of note, the person was reportedly riding a bike when he arrived, and Flowers reportedly placed the bike in the trunk of his car, and drove off to the purported destination with the victim.

One of Flowers' daughters told local reporters that her father typically stopped providing taxi services at 6:00 p.m. daily, and would only have given a ride to someone he knew. She thus believes that the person who approached her father was someone with whom he was acquainted.

No one has yet been arrested in connection with this recent murder. Police are investigating.


there will be representatives from the maritime element at this meeting tomorrow. Now, what is being said at the diplomatic level, I'm not sure. I haven't been privy to that," Burns said, adding that he is sure that the Ministry of Foreign Affairs has been engaging its counterpart in Guatemala.

This week, the Minister of Foreign Affairs, Hon. Eamon Courtenay, told 7News that they have verbally protested the illegal incursion into Belizean waters by the Guatemala military, and that they have also "lodged a strongly worded written protest." He also said that the flags that were taken by the GAF would be placed back in Belizean custody today and that Prime Minister Briceño briefed the OAS Secretary General personally on the matter yesterday. Hon. Courtenay further indicated that he has invited the foreign minister of Guatemala to meet in Lima, Peru, next week to discuss the incident and other

matters.

Those matters are to include the incursion on Belizean land by residents of an adjacent village on the Guatemala side of the border, Barrio El Juda. For some years now, Guatemala nationals from the village have been crossing over into Belizean territory, which is located about 20 miles from the Xunantunich archeological site. Some buildings erected by the villagers on Belizean land have been dismantled with the permission of the OAS, but more structures are being placed in the area, and clearings are being seen.

At this time, no illegal cattle ranching is taking place in the area, but other parts of land near the border are used as pastures illegally. Recently, the Friends for Conservation and Development (FCD) and BDF met to devise a strategy to address this issue of illegal cattle ranching in Belizean territory, which has been carried out to a large extent in protected areas for a number of years.

Marshalleck, after stating that "the compensation is the court's estimate of the value of the goodwill that was taken and passed over to NGC when the law was passed," pointed out the following to a 7News reporter: "... You also have to balance it against what was gained. If it were, for instance, that you were dealing with the compulsory taking of your national telecommunications company, and the challenge resulted in a 10-million-dollar award, you have to look at it in the overall context of the overall value of what was being dealt with. So, while you're stunned by the 10-million-dollar figure - and that's a lot of money for you and me, in terms of the industry, that might not be the case."

A September submission outlined some new claims by the companies, but

within the next 28 days—a possibility that Marshalleck said would be looked at closely. One of the attorneys for the former butane importers, Audrey Matura, said that they will follow the instructions handed down by the clients in regards to a possible appeal, but pointed out that the precedent set in this case should be of concern to all Belizeans.

"In terms of commerce, every business person doing business in Belize should be worried, because right now in the tourism industry the government could say, 'okay, I don't think everybody should just own their own hotel.
