


WPC shot; fighting for her life





Public officers suffering without a PSC Chair – PSU

BELIZE CITY. Thurs. Oct. 13, 2022 The Public Service Union (PSU) has issued a statement condemning the Office of the Prime Minister's failure to appoint a new Public Services Commission (PSC) chairman as well as to fill other key vacancies on the PSC in a timely manner, and has also accused the Government of wanting to politicize the Commission.

The PSU president, Dean Flowers, in outlining the reasons for the union's reference to a possibly partisan agenda on the part of GoB, cited the current government's decision to call for the resignation of the former PSC chairman and other commissioners who had been under appointed the past administration. Since then, however, the current administration has failed to replace the commissioners whose terms of service officially ended in June 2022.

Ambulance's collision with busito causes student's death

A road traffic accident on the Philip Goldson Highway claimed the life of Jorge Vargas, 21, a sixth-form student of Centro Escolar Mexico Junior College, and as many as six persons were severely injured when an ambulance crashed into the mini-bus in which they were traveling back home to Corozal.

RANCHITO, Corozal District, Thurs. Oct. 13, 2022

A collision between an ambulance and a mini-bus between Miles 82 and 83 of the Philip Goldson Highway in Ranchito Village, Corozal, caused injuries to a number of students and a sick minor, and claimed the life of a sixth-form student of Centro Escolar Mexico Junior College, Jorge Vargas, 21. Vargas and four other students had been traveling in a mini-bus en route to Corozal Town, where his mother was waiting to pick him up, when an ambulance which was carrying a sick minor and was heading in the opposite direction, crashed into the vehicle.

The collision occurred when the ambulance, which was transporting the sick minor and her mother from the Corozal Community Hospital to the Karl Heusner Memorial Hospital in Belize City, attempted to overtake a truck and collided head-on with the mini-bus, which was being driven by Carmelo Kau, 49, and was taking the students to Corozal Town after a day of classes. (Notably, while reports have mentioned that the ambulance was overtaking a truck, it is known that incoming traffic must pull over to the side of the road, thus allowing a vehicle being used by first responders, such as an ambulance, to pass through. On Thursday, October 13, Commissioner of Police, Chester Williams, noted at a police press briefing that many Belizean drivers have shown a reluctance to do "That's one of the issues we have SO. here in Belize. Only in Belize do certain things happen. We know already that once you hear the ambulance, the police, or the fire siren, it means that you must clear the way for an emergency, and certain drivers just have no regard [for] that and would want to race with the ambulance or with the police or the fire truck, which is wrong," Williams said.



the driver of the ambulance, Louis Canelo, 33, and the nurses who were accompanying him.

One of the first persons to arrive at the scene was the Dean of Centro Escolar Mexico Junior College, Hugo Gonzalez, who told members of the local media that he was alerted by a teacher of the school about the accident.

In its statement, the PSU notes that public officers have been faced with a number of challenges and unresolved issues as a result of this, and that, over the past two months, the union has received countless calls from officers waiting to be appointed, those who have pending disciplinary matters before the Commission, and "desperate" retired public officers whose salary advances have been exhausted and as a result are both without an income and unable to receive retirement benefits.

Flowers said that, given that the government had called for the resignation of those former commissioners, it would only be reasonable to expect that suitable replacements would have already been identified.

"But now we know that the call for their resignation had little to do perhaps with the manner in which they were functioning and more to do with politics, because here we are two years after and this current administration is struggling to identify a Belizean citizen that is in high standing and that has the integrity and the knowledge and the experience about the public service to be able to do a good job and carry out the roles and the functions of the Public Service Commission," he added.

The PSU believes that there are a number of persons in the country who are competent enough to sit on the Commission. One such individual is Mr. Alfredo Cruz, whom the PSU has recommended for the position of PSC Chairman.

According to Flowers, however, it would seem that none of those competent Belizeans are to the liking

the post, Mr. Cruz, is not only knowledgeable and experienced in the inner workings of the Commission but also is a man of "high integrity and high moral standing."

While the government continues to drag its feet in appointing new members to the Public Services Commission (PSC), the PSU president says that public officers, especially retirees, continue to suffer.

Among those suffering public officers, said Flowers, are "the retirees that have given so much of themselves to the people and the government of Belize, and who have already been inconvenienced by poor administration within the public service ... whose files might have went to the Treasury Department incomplete and had to be returned, and who have been waiting for well over a year-and in some cases over two years-to get their super annuity benefits."

Some of those retirees, he added, have been unable to pay even their basic recurring bills, including mortgage payments, utilities and medicine purchases, and the PSU is thus of the view that the long outstanding gratuities should be paid with interest.

"When the government owes its political financiers, whether it is via a court judgment or otherwise, they pay them with interest. And in business, when you owe somebody, you pay them with interest. When taxpayers such as public officers and the business community owe the government tax, they must pay them with interest. The government has a duty and a responsibility, therefore, to pay these individuals what is due to them with

"When I got there, some of the students had already been transported to the Corozal Community Hospital, then I saw the body of Jorge Vargas was still on the scene of the accident," he said.

While Vargas died at the scene, three other students of Centro Escolar Mexico Junior College, as well as a student at another institution, sustained serious injuries.

According to Gonzalez, the condition of one of those students, Anthony Tzib, who is from Patchakan Village, seems promising, since Tzib, who was taken to the Corozal Community Hospital, recognized Gonzalez when he went to the hospital and "called [him] by name". According to Gonzalez, another injured student, Armando Patt, was transported yesterday morning from the Corozal



of the Office of the Prime Minister.

In an Amandala article dated Thursday September 22, 2022, we reported that Mr. Cresencio Sosa had been nominated by the Prime Minister to be the new Chairman of the PSC. This took place shortly after the withdrawal of controversial former diplomat Moises Cal from consideration for the post following objections from the public. That article further noted that the government was awaiting an affirmative response from the Opposition so that Sosa's appointment could have been finalized. Since then, however, Sosa has withdrawn from consideration for the role, leaving the government once again without a nominee to serve as PSC Chair.

Flowers says that the individual whom the PSC has recommended for interest," said the PSU president.

Flowers went so far as to suggest that the retirees seek legal advice and take the government to court if their gratuities are not paid to them with interest.

In its press release, the Public Service Union has also called on the Office of the Prime Minister to task the Auditor General with assembling a "competent team of Public Officers" to address the issue of aging income tax returns that extend as far back as five years or more. It notes that delays in the processing of income tax returns for public officers may well be due to "gross negligence, incompetence, and even corrupt or irregular payroll and hiring practices that must be investigated and corrected." The PSU further stated that all money due on those returns should be paid to public officers with interest.

Faber accuses ex of "selling" footage of domestic incident

The latest footage that has surfaced of a domestic incident involving Collet area representative Hon. Patrick Faber was reportedly recorded in May 2022 (according to a date stamp on the video) by Faber's ex-girlfriend, whom Faber accused in a social media post of selling the video to his political rivals

Hon. Patrick Faber has, once again, found himself embroiled in controversy after the circulation of a political ad that features video footage of him in a domestic dispute with his current fiance. After rhe surfacing of the video, the Collet area representative has, in a social media post, accused the mother of one of his children, who is an ex-girlfriend of his, of recording the incident, which took place while their young daughter was present, and selling the video to his political opponents in an act of jealousy.

The video featured in the ad shows Faber and a woman in a struggle as each of the two tries to wrest a set of car keys from the hands of the other. As the incident unfolds and slowly escalates, a child can be seen standing in the corner of the shot. Eventually, an angered Faber head-butts the woman.


The video also features a voice overlay of comments made by Commissioner of Police Chester Williams during a past interview, in which he spoke out against domestic abuse. During this week's police press briefing, the Police Commissioner said that the production of the ad has disappointed him.

"I want it to be known that I have nothing to do with the ad, and I disassociate myself from it completely, for I have not authorized anybody to use my voice in order for them to achieve their own political objective," said Williams.

He then added that, if the ad is broadcasted, he plans to take action against whoever airs it. Nevertheless, Commissioner Williams has maintained his position of being vehemently against domestic violence.

"I would never support [someone] who stands for domestic violence, because I do believe that we must learn to respect and cherish our women and children," he said.

Not long after the incident was made public, Hon. Patrick Faber's girlfriend, the woman who filmed the incident, Nickiesha Polanco, spoke out about the UDP parliamentarian's long history of domestic abuse. She stated, via a post on social media, that she made the decision to step away from her relationship with Faber out of concern for her safety and that of her daughter. She added that the video footage is that of a recent incident



"People need to stop enabling abusers. People need to stop blaming the victims and the victims need to stop blaming themselves," she wrote.

In a since-deleted comment under that Facebook post, Faber lashed out at his ex, accusing her of having an "evil, nasty, destructive personality." Faber further accused her of selling the video to his political rivals—an accusation she has forcefully denied.

According to the Commissioner of Police, the incident shown in the video was "already addressed long ago" by the Police Department.

It is believed that the ad was produced by Faber's political opponents within the United Democratic Party. The Collet area representative and a number of party members have been in conflict with each other for months now. Most recently, in an Amandala article dated Friday, September 23, 2022, we reported that Faber's application to once again be the party's standard bearer for the Collet division had been denied by the UDP Nominations Committee. According to a letter from the Committee's chairperson, this was because Faber allegedly failed to comply with at least three articles in the UDP Constitution by publicly criticizing the party on social media.

A few of Faber's UDP colleagues, including Hon. Tracy Panton, Alberto August, and Lee Mark Chang, publicly spoke out against the committee's decision and requested that Faber be allowed to run.




BELMOPAN. Thurs. Oct. 13, 2022 Police have arrested a 27-year-old Harmonyville vendor, John Horace, following the coldblooded murder of 38-year-old marine biologist Celso Cawich. Originally a resident of the Orange Walk District, Cawich lived, and owned a business, in the Harmonyville area of Cotton Tree Village at Mile 41. He was reportedly assailed by two male persons who entered his place of business on Saturday evening. Around 6:30 p.m. that day, police were called to the village, where they found him suffering from multiple gunshot wounds. Cawich was rushed to the hospital for medical attention, but passed away shortly after. Police are currently still uncertain about the motive for this recent murder in a relatively quiet community - although the incident might have appeared to be an attempted robbery.

Marine biologist executed in Harmonyville

"It would want to look like the initial intent was a robbery, and from what witnesses have described, they are saying that when Mr. Cawich made a movement as to go towards his waist for some reason, that was when the gunmen opened fire on him," the Police Department's communications director, ASP Fitzroy Yearwood, said during today's press briefing.

According to Yearwood, the abrupt moves of the victim, who reportedly stepped backward a bit after the men entered the establishment and made their demands, might have jolted the gunmen into opening fire. The two men, who reportedly had a getaway vehicle waiting for them, escaped following the shooting. Yearwood further noted that it appears, based on the statements received by police, that no robbery took place following the shooting. There is no indication that Cawich. who was a conservation-oriented UB lecturer, was involved in any illegal activity that could have imperiled his life. However, according to one villager from Harmonyville, he had detained and handed over a man to the police sometime before the shooting. A villager who chose to remain anonymous told reporters that a man who claimed someone was trying to kill him had run into her home, seeking refuge. The man, whose identity has not yet been revealed, did not want to leave her home but was eventually removed

from the residence with the help of some men working in the area and the victim, Cawich, who had been on his way to Cotton Tree to buy items for his store.

Cawich reportedly detained the man and handed him over to the police. Later that evening, he was shot and was rushed to the hospital by his wife, but unfortunately passed away. Prior to the arrest of Horace, it had been reported that two persons were in police custody after the shooting, and three other persons were being sought by police.

Cawich is being remembered as a helpful and community-oriented

member of Harmonyville.

"He is a very kind person, helpful, and respectful person that I know for so many years," said one villager, who further remarked, "I was very shocked. I did not expect they would have killed him. I mean everybody here in the village was very shocked, and we cried, because he was a very nice person, kind, loving, so we did not expect this to have happened to him."

On Tuesday, a 19-year-old from Belize City identified by police as Jalen Oshen was charged for the crime of robbery in connection with this recent murder recently.

Pomona man killed by companion's ex-lover

POMONA, Stann Creek District, Tues. Oct. 11, 2022

Doratian Rogatian Salam, 43, was detained over the weekend by police, who had issued a wanted poster notifying the public that they were seeking him for questioning in connection with the murder of 29-year-old Kevin Williams, a construction worker of Pomona Village, Stann Creek District, which occurred early on Saturday morning, October 8.

Reports are indicating that at around 1:30 that morning, Salam had been riding his motorcycle when he saw Williams walking alongside a woman with whom Salam had been in a romantic relationship. (Williams and the woman had reportedly been at a bar in the village earlier.) According to reports, Salam then came off his motorcycle and pulled out a rusty ice pick, with which he proceeded to stab Williams four times with three wounds being inflicted on Williams' chest.

Yearwood, told reporters that police are following several leads, and they are awaiting instructions from the Office of the Director of Public Prosecution (DPP) before levying charges.

Yearwood confirmed that the woman with whom Williams had been walking, Ana Budna, 39, had been previously in a relationship with Salam. "It is not a secret that they may have been involved in a relationship [before] this incident, and I wouldn't want to put all that out until we know what would be the nature of the charges," he said.

Williams was transported to the Southern Regional Hospital by a passerby, but died of his injuries while undergoing treatment. On Monday, October 10, Salam handed in himself to Dangriga police in the presence of his attorney, Oscar Selgado.

A post-mortem examination was conducted on Williams and the results of that exam confirmed that his death was caused by hypovolemic shock and internal exsanguination (internal bleeding) due to multiple stab wounds. Salam was later charged for murder.

Hurricane Julia kills 28 and counting in Central America



Devastation in Venezuela. Julia continued its path of destruction in Venezuela. Heavy rain caused five streams to overflow and a landslide in Las Tejerías, some 50 kilometers (31 miles) southwest of the capital Caracas, which killed at least 25 people. More than 50 were missing.

BELIZE CITY, Tues. Oct. 11, 2022

The storm that, at its strongest point, was Hurricane Julia has weakened since making landfall this weekend, but it continues to dump heavy rain over parts of Central America and Mexico, and, according to officials, has caused at least 28 deaths in Central America, as of Monday. According to one report from *NPR*, those deaths include fourteen in Guatemala, nine in El Salvador, four in Honduras, and one in Nicaragua.

In a press conference with the media on Tuesday, the National Emergency Management Organization (NEMO) confirmed that, so far, there has been no major loss of life or severe injuries due to the storm here in Belize.

Amid heavy rain, which has led to widespread flooding across the region, the death toll in other parts of Central America continues to rise. In Guatemala, at least five people have died as a result of a hillside collapsing onto their house and burying them, according to that country's disaster prevention agency. Just recently, Guatemala's president, Alejandro Giammattei, declared a "state of calamity," which is expected to last for the next 30 days

In El Salvador, the collapse of a house led to the deaths of five soldiers. The soldiers were among a group of military personnel involved in recent anti-gang raids. They were taking refuge in the house, located in the town of Comasagua. Two persons also died in the town of Guatajiagua after the wall of their house collapsed.

According to reports from *PBS News*, one man died when he was swept away by floodwaters and another after a tree fell on him.

The capsizing of a boat in northern Honduras led to the death of five persons, while strong currents swept away one 22year-old woman.

In addition to the still rising death toll, there are also dozens of persons still missing, including in Venezuela, where a massive landslide destroyed over 300 homes in the city of Las Tejerias. According to reports, residents had mere minutes to flee their homes before an avalanche of mud and debris rolled down the mountainside and into neighborhoods. On Sunday, the president of the South American nation, Nicolas Maduro, declared a three-day period of mourning for the lives lost during the landslide.

After first making landfall on Nicaragua's coast as a Category 1 hurricane on Sunday, Julia weakened into a tropical storm and made its way into the Pacific later in the day. By Monday, the storm had weakened even further but has continued to cause heavy rain over Guatemala. Julia is the second system on record to have crossed from the Atlantic Ocean to the Pacific with at least tropical storm-level strength. The first was Bonnie, which did so earlier this year.

US Embassy donates backlog-reduction equipment to Belize's judiciary

On Wednesday, October 12, the Belize judiciary received several pieces of equipment from the US Embassy as a part of the US government's Backlog Reduction Program.

The equipment, which has an estimated value of \$400,000 BZ, will be used to reduce the number of pending criminal cases that are before the courts.

The handing-over ceremony took place

to expand access to the prison for adjournments and bail applications so that magistrates throughout the country would be able to have access to the prisoners who are on remand. So, that is part of it. Presently, there are four access points at the prison. So that access points are set....So, it's only the Belize Supreme Court and I believe two Magistrate Courts in Belize that have that. Now, this would allow for magistrates, wherever in the country of Belize, to be able to access through a wifi-connected laptop," she said.

Young further pointed out that the equipment will also provide a reduction in costs for taxpayers who finance the transportation of convicts and persons on remand to the courts. "You would also have prisoners from Punta Gorda who would be brought a couple of days in advance, the same in San Pedro. You have situations that we have seen, where prisoners have gotten injured due to traffic accidents; I believe in Orange Walk that has occurred. You have where the prison is on lockdown for whatever reason and the prisoners are not able to have access to the courts. This will alleviate that completely," she said. During her comments at the ceremony, the Chief Justice of Belize, Hon. Louise Blenman, stated, "It is critical that litigants are provided with easy access to justice that is fair and efficient, failing in which fundamental rights may be impacted. More recently, inefficiencies in the delivery of justice were forever laid bare during the COVID-19 pandemic. This state of affairs does not augur well, since, for example, potential investors who have a genuine interest in Belize will be reluctant to come to Belize. And if they are of the informed view that crimes are not effectively prosecuted and punished, all of this can have the effect of undermining Belize's development and eroding its stability. As a matter of urgency, the Judiciary and Magistracy will be reformed and modernized in order to be able to properly serve the

in the Supreme Court and was attended by officials representing the Supreme Court, Magistrate Court, the Police Department's Prosecution Branch, the National Forensic Science Service, and the Financial Intelligence Unit.

Georgia Belizaire, INL Justice Sector Program Specialist at the US Embassy, explained, "So there are laptops, scanners, and desks, particularly for updating the case management system. There are also security cameras for the court. There are servers because as much case goes into the case management system, they're going to need to actually expand their storage capacity. So, it's basically stuff to improve on the case management program."

The Registrar General of the Supreme Court, Trienia Young, further outlined how the equipment will be used: "The equipment is to be shared between the Supreme Court and the Magistrate Court. Part of the equipment is to go to the prison people of Belize," said Chief Justice of Belize, Hon. Louise Blenman.

Her comments were echoed by the US Embassy's Charge d'Affaires, Leyla Moses-Ones, who highlighted the joint relationship between Belize and the US through the International Narcotics and Law Enforcement Affairs (INL), which has been established since 2016.

"The current program aims to reduce the criminal case backlog through supporting legislative reform and, as the Chief Justice said, the development and enhancement of a case management system that rests on modern, digital technologies. It represents an investment, not only in the courts but sort of a spiritual investment in swift justice that means so much, as the Chief Justice said, not only for Belizean communities but for the broader implications in the country's stability and economic prosperity," she said.

It was also noted that the efforts to reduce the backlog in cases have so far been According to the National Hurricane Center, as the week progresses, there is still a risk of life-threatening flash floods and mudslides across much of Central America and Mexico.

fruitful—with a 42% reduction being achieved over the last few months.

Belizaire, the INL Justice Sector Program Specialist at the US Embassy stated, "When we started, the system was doing something like 49,000 cases. We're down to 19,000 to 20000+, which is quite incredible. And it was a lot of effort from the court to do that. Success can only come if the government wants that success, and obviously, they want it."




Spend that "wage increase" on local products, NOT foreign goods

In his Independence Day address, Prime Minister John Briceño announced that in January 2023 his government will be delivering on a campaign pledge of his party, to increase the minimum wage from \$3.30 per hour to \$5.00 per hour. The last time the minimum wage was increased was a decade ago, in 2012, when it was increased from the \$3.10 per hour set in 2010 to the present \$3.30.

The 2010 wage increase wasn't across the board. The International Labour Organization (ILO), at the website <u>www.ilo.org</u>, said the minimum wage rate in Belize was adjusted to BZ\$3.10 per hour in August 2010 "for all workers except manual/agricultural workers." Apparently, not all workers will qualify for the full increase that the PUP promised when it contested the November 2020 General Elections. *Amandala* journalist, Ms. Khaila Gentle, reported last week that the government was carrying out a number of consultations with the public, and that personnel from the Ministry of Rural Transformation, Community Development, Labour, and Local Government had explained that their objective was "to discuss the impact of the increase for unskilled workers and those engaged in elementary occupations, interventions required to ensure compliance, and a potential formula for gradual increase in specific sectors and future wage adjustments."

The PUP had promised to deliver on the minimum wage increase as soon as the economy roared back from four consecutive quarters of negative growth under a previous administration. But the pandemic followed, and to add to our economic woes, war came to Europe. The cruel bombardment and occupation of parts of Ukraine by Russia



has led to a massive increase in the cost of two essential tools of industry: fuel and fertilizers.

Our economy has improved since we were in the full grip of the pandemic, but no one, not even the most die-hard PUP, claims to hear a roar. The fact is that our economic engine has never hummed. We might have improved beyond the too familiar disappointing "sputter" in the second decade of this new millennium, that period when the oil money was pouring in, if our once robust citrus and shrimp industries hadn't dipped to near non-performance because of two devastating diseases.

Earlier this year, on July 1, the GOB's Press Office had announced that a task force had been set up "to oversee the gradual implementation of the five-dollar minimum wage", and the PM had explained that the reason his government had to move cautiously was because it needed to ensure that the economy could absorb the increase. The Belize Chamber of Commerce and Industry (BCCI) had expressed support for a gradual implementation of the increase, because it would give businesses time to adjust to the change.

Now the captain of our ship has shifted gears and announced that we are opening the throttle, to near full speed ahead. Some skeptics are wondering where the money will come from. Skeptical employers worry that persons who are presently making \$5.00 per hour will demand more, and those who are presently earning more than \$5 per hour will also want more when they see people below their pay scale jumping up to their level. It shouldn't matter what anyone else makes; indeed we should be happy to see our less fortunate brothers and sisters get a boost but, alas, this world doesn't work that way.

It can't be that the GOB, seeing the disarray in the main opposition, the UDP, is thinking about an early election, just two years into its mandate. The previous party in power, the UDP, might have been on that course when in June 2015 it agreed to a well-deserved 8% salary increase for public officers and teachers, retroactive to April of that year. In September 2015 PM Barrow followed that with the announcement that a very favorable agreement had been reached on the nationalization of BTL. One month later he dissolved the House of Representatives, and on November 4, 2015, just 3 years and 8 months into its five-year mandate, Barrow and his UDP rolled over the PUP at the polls for a third consecutive time.

There are concerns about this increase which will become law in January 2023, but independent studies show that the minimum wage, even at \$5.00 per hour, is woefully low. A decade ago, a \$5 minimum wage would have indicated that our economy was beginning to fire on all cylinders. In 2022, \$5 per hour doesn't look like much, and it cannot buy much.

Earlier this year the PM stated that a too high wage increase could "create incredible inflation that can lead us to devaluation." Today, the all-important peg to the US dollar remains 2 (BZ\$) to 1(US\$), but data from the Statistical Institute of Belize (SIB) shows the purchasing power of the Belize dollar is far less than what it was a decade ago. Looking at staples, **ground beef** was \$4.29 per pound in 2012, and it now sells for \$6.04 per pound, an increase of 40%; **rice**, sold at \$1.08 per pound in 2012, is now \$1.57 per pound, an increase of 45%; **flour**, which had a price of \$0.92 per pound in 2012, is now \$1.22 per pound, an increase of 32%; **eggs**, sold at \$2.90 per dozen in 2012, now cost \$4.56 per dozen, an increase of 57%; and the price of **whole chicken**, which was \$2.59 per pound in 2012, is now \$3.03 per pound, an increase of 17%.

The skeptics wonder where the money will come from, but for the GOB it wasn't an option; it had to implement the increase. It is important for the economy, for Belizeans involved in commerce and industry to respond positively. Actually, there are a number of ways the increase in the minimum wage will benefit businesses. Greater purchasing power for workers means more sales, and



The GOB making good on its promised wage increase won't take any of us out of poverty, but it will surely help us get by. Workers of Belize, if we want more than getting by, if we want to get by "betta", we have to pay more attention to our dollar. We can continue along the same path we're on, and watch inflation erode our gains away, or we can make a necessary about turn.

We need to spend less on foreign luxury goods. We have to root out or curb our appetite for products from abroad that we are "addicted" to. We need to prioritize products that are made in Belize. The expiration dates and nutrition information on labels are important, but equally or more important is the strip at the bottom that says it is made at home.

When we buy goods made in Belize, we expend less foreign exchange, which means more of our dollars stay at home and work for us, to help us all win. That wage increase isn't that much. Its impact will be much greater if we spend it wisely. PAYSCALE

We Are Losing Grip On Poverty

In the midst of the global pandemic, Covid-19, the poverty rate in Belize was reported at a staggering 52%! Now if that doesn't immediately give you chest pain and raise your blood pressure levels, let me break down what a 52% poverty rate indicates. A poverty rate of 52% means that more than half of our country is unable to provide the basic necessities that are needed for sustenance and survival. A 52% poverty rate indicates that in a room with an average of 100 ordinary people, 50 of them are poor. It means that there's a pretty good chance that the person sitting next to you on that bus ride did not have breakfast and has no idea where the next meal or copper is coming from. But to utterly compound this already terrible situation from bad to worse, it was recently reported that the poverty rate is projected to rise, propelled by incendiary inflation and subsequent stagflation which, when all put together, is causing us to lose our grip on poverty in Belize.

Every day we turn on the news, we are eerily reminded of the crippling effects of poverty, which is highlighted on various platforms. It is now made even more abundantly clear with the advent of technology and the proliferation of mass media, which highlights and broadcasts the plight of the poor and suffering in this country. While poverty has always plagued us, the number of families in the country who were unwittingly subjugated to the bitter and callous trenches of penury and destitution has been exacerbated since the onset of the global pandemic. that we have begun to get a hold of the virus and have made significant strides to stymie and reduce new infection and mortality rates, we have inadvertently begun to lose our grip on poverty.

The cost of living in Belize has skyrocketed, and the crippling effects of inflation have taken their unjust place in our homes. The price of almost everything has risen, except, of course for salaries and wages. The sustained increase in the price of fuel in this country has led to a higher cost of transportation, which also, as an underlying corollary, has increased the cost of goods and services. A \$50 trip to the grocery store has become a burdensome \$120 now and a onceshopping cart of groceries has been reduced to the most affordable shopping basket of absolute necessities. Belizeans are now faced with the harsh dilemma of carefully selecting between the most critical needs while cutting down is now the constant refrain; that is of course for those who are able to.

That is because there are many who don't even have anything to even curtail. Yes, there are many of our citizens who wake up lacking, in total and complete want for basic needs. There is no money, no food and the shelter that they share doesn't even constitute a decent abode. UNICEF reports that while the poverty rate for the general population in Belize is generally high, the outlook for children is grim. The report notes that up to 50% of children in Belize under the age of 15 years are marred by the hardships of indigence and poverty while 58% of youths under the age of 18 are classified as multi-dimensionally poor. It goes on to cite that UNICEF and ECLAC estimate that 6 out of every 10 children in Belize lack at least one of the basic needs that are required for sustenance and survival. This is bad, very bad, and this grimacing report cites the rather chilling and inherent poverty situation in Belize that needs urgent redress.

The current path that we are on to seriously address the issues of poverty in this small developing jewel is less than sufficient and quite frankly, unacceptable. Belize is a small country, you know, with a billion-dollar budget, yet almost half of the country suffers from impoverishment and destitution. Little over 400,000 people in this country and half of our children are lacking their basic needs and are already subject to indigence and penury; having not even been privy to a fair start in life. Go figure what the outcome will be if we allow 50% of our children (who are the near future of the country) to continue through poverty into adulthood without stemming it: a repeated and calculated cycle of poverty is the only thing that will be birthed from that. We have seriously got to recognize this as a state of emergency and pool resources together to combat this as a matter of urgency. No excuses can be had. We must address this seriously and with grave concern, because we are losing our grip on poverty!

Gasten ese "aumento salarial" en productos locales, NO en productos extranjeros

En su discurso del Día de la Independencia, el Primer Ministro John Briceño anunció que en enero de 2023 su gobierno cumplirá una promesa de campaña de su partido, de aumentar el salario mínimo de \$3.30 por hora a \$5.00 por hora. La última vez que se aumentó el salario mínimo fue hace una década, en 2012, cuando pasó de los \$3.10 la hora fijado en 2010 a los \$3.30 actuales.

El aumento salarial de 2010 no fue generalizado. La Organización Internacional del Trabajo (OIT), en el sitio web www.ilo.org, dijo que la tasa del salario mínimo en Belize se ajustó a BZ\$3.10 por hora en agosto de 2010 "para todos los trabajadores excepto los trabajadores manuales/agrícolas". Aparentemente, no todos los trabajadores calificarán para el aumento completo que prometió el PUP cuando se presentó a las Elecciones Generales de noviembre de 2020. La periodista de *Amandala*, la Srta. Khaila Gentle, informó la semana pasada que el gobierno estaba realizando una serie de consultas con el público y que el personal del Ministerio de Transformación Rural, Desarrollo Comunitario, Trabajo y Gobierno Local había explicado que su objetivo era " discutir el impacto del aumento para los trabajadores no calificados y aquellos que se dedican a ocupaciones elementales, las intervenciones requeridas para garantizar el cumplimiento y una posible fórmula para el aumento gradual en sectores específicos y futuros ajustes salariales".

El PUP había prometido cumplir con el aumento del salario mínimo tan pronto como la economía se recuperara de cuatro trimestres consecutivos de crecimiento negativo bajo una administración anterior. Pero siguió la pandemia y, para aumentar nuestros problemas económicos, llegó la guerra a Europa. El cruel bombardeo y ocupación de partes de Ucrania por parte de Rusia ha llevado a un aumento masivo en el costo de dos herramientas esenciales de la industria: combustible y fertilizantes.

Nuestra economía ha mejorado desde que estuvimos en pleno control de la pandemia, pero nadie, ni siquiera el PUP más recalcitrante, afirma haber escuchado un rugido. El hecho es que nuestro motor económico nunca ha zumbado. Podríamos haber mejorado más allá del demasiado familiar y decepcionante "chisporroteo" en la segunda década de este nuevo milenio, ese período en el que el dinero del petróleo estaba llegando a raudales, si nuestras industrias de cítricos y camarones, que alguna vez fueron sólidas, no se hubieran hundido hasta casi dejar de funcionar debido a dos enfermedades devastadoras.

A principios de este año, el 1 de julio, la Oficina de Prensa del Gobierno de Belize había anunciado que se había creado un grupo de trabajo "para supervisar la implementación gradual del salario mínimo de cinco dólares", y el primer ministro había explicado que la razón por la que su gobierno tuvo que moverse con cautela fue porque necesitaba asegurarse de que la economía pudiera absorber el aumento. La Cámara de Comercio e Industria de Belize (BCCI por sus siglas en inglés) había expresado su apoyo a una implementación gradual del aumento, porque había llegado a un acuerdo muy favorable sobre la nacionalización de BTL. Un mes después disolvió la Cámara de Representantes, y el 4 de noviembre de 2015, apenas 3 años y 8 meses después de su mandato de cinco años, Barrow y su UDP derrotaron al PUP en las urnas por tercera vez consecutiva.

Existen preocupaciones sobre este aumento que se convertirá en ley en enero de 2023, pero estudios independientes muestran que el salario mínimo, incluso a \$5.00 por hora, es lamentablemente bajo. Hace una década, un salario mínimo de \$5 habría indicado que nuestra economía estaba comenzando a funcionar a toda máquina. En 2022, \$5 por hora no parece mucho y no puede comprar mucho.

A principios de este año, el primer ministro declaró que un aumento salarial demasiado alto podría "crear una inflación increíble que puede llevarnos a la devaluación". Hoy en día, la paridad más importante con el dólar estadounidense sigue siendo de 2 (BZ\$) a 1 (US\$), pero los datos del Instituto de Estadística de Belize (SIB) muestran que el poder adquisitivo del dólar de Belize es mucho menor de lo que era hace una década. En cuanto a los alimentos básicos, la carne molida costaba \$4.29 la libra en 2012 y ahora se vende a \$6.04 la libra, un aumento del 40 %; el arroz, que se vendía a \$1.08 la libra en 2012, ahora cuesta \$1.57 la libra, un aumento de 45%; la harina, que tenía un precio de \$0.92 la libra en 2012, ahora cuesta \$1.22 la libra, un aumento del 32%; los huevos, que se vendían a \$2.90 la docena en 2012, ahora cuestan \$4.56 la docena, un aumento del 57%; y el precio del pollo entero, que era de \$2.59 por libra en 2012, ahora es de \$3.03 por libra, un aumento del 17%.

Los escépticos se preguntan de dónde saldrá el dinero, pero para el Gobierno de Belize no era una opción; tuvo que implementar el aumento. Es importante para la economía, que los beliceños involucrados en el comercio y la industria respondan positivamente. En realidad, el aumento del salario mínimo beneficiará a las empresas de varias maneras. Un mayor poder adquisitivo para los trabajadores significa más ventas, y trabajadores más felices significan más producción.

Que el Gobierno de Belize cumpla con su aumento salarial prometido no sacará a ninguno de nosotros de la pobreza, pero seguramente nos ayudará a salir adelante. Trabajadores de Belize, si queremos algo más que salir adelante, si queremos salir adelante "mejor", tenemos que prestar más atención a nuestro dólar. Podemos continuar por el mismo camino en el que estamos y ver cómo la inflación erosiona nuestras ganancias, o podemos dar un giro necesario.

Necesitamos gastar menos en artículos de lujo extranjeros. Tenemos que erradicar o frenar nuestro apetito por los productos del extranjero a los que somos "adictos". Necesitamos priorizar los productos que se fabrican en Belize. Las fechas de vencimiento y la información nutricional en las etiquetas son importantes, pero igual o más importante

daría tiempo a las empresas para adaptarse al cambio.

Ahora el capitán de nuestro barco ha cambiado de marcha y ha anunciado que estamos abriendo el acelerador, casi a toda velocidad. Algunos escépticos se preguntan de dónde vendrá el dinero. Los empleadores escépticos se preocupan de que las personas que actualmente ganan \$5.00 por hora exijan más, y aquellos que actualmente ganan más de \$5 por hora también querrán más cuando vean que las personas por debajo de su escala salarial saltan a su nivel. No debería importar lo que ganan los demás; de hecho, deberíamos estar felices de ver que nuestros hermanos y hermanas menos afortunados reciben un impulso, pero, qué pena, este mundo no funciona de esa manera.

No puede ser que el Gobierno de Belize, viendo la desorganización en la principal oposición, el UDP, esté pensando en una elección anticipada, apenas dos años después de su mandato. El anterior partido en el poder, el UDP, pudo haber estado en ese rumbo cuando en junio de 2015 acordó un merecido aumento salarial del 8% para funcionarios públicos y docentes, retroactivo a abril de ese año. En septiembre de 2015, el Primer Ministro Barrow siguió eso con el anuncio de que se es la tira en la parte inferior que dice que está hecho en casa.

Cuando compramos productos fabricados en Belize, gastamos menos divisas, lo que significa que una mayor parte de nuestros dólares se quedan en casa y trabajan para nosotros, para ayudarnos a todos a ganar. Ese aumento salarial no es tanto. Su impacto será mucho mayor si lo gastamos sabiamente.

UN celebrates 10-year anniversary of International Day of the Girl Child

BELIZE CITY, Tues. Oct. 11, 2022

This past Tuesday marked the tenyear anniversary of the UN's International Day of the Girl Child. It was first observed in 2012, ten months after a United Nations General Assembly declared October 11 a day to recognize the rights of, and unique challenges faced by, girls around the world.

It is a day dedicated to promoting the empowerment of girls and the fulfilment of their human rights, and this year's theme was "Our Time Is Now—Our Rights, Our Future."

"Today, we celebrate our girls and advocate for their inclusion in decisionmaking on issues of national importance and also on all issues that impact their lives and development," wrote Prime Minister John Briceño this week. The Prime Minister also expressed support for his wife, H.E. Rossana Briceño, and the work that she carries out as the Special Envoy for Women and Children.

On Tuesday, the Special Envoy highlighted three key areas that demand greater attention from the international community when it comes to empowering young girls: supporting the leadership of adolescent girls at the forefront of change efforts, increasing resources and investments for them, and improving access to and uptake of inclusive adolescent girl-centered services at all times, but especially in crisis response and recovery. There has been much progress in securing equality and rights for young girls in society, but as H.E. Rossana Briceño suggested, there is still work to be done.

The Child Development Foundation of Belize (CDF Belize) notes that Belize has one of the highest prevalence of child marriage or early unions in the region.

"The practice is often arranged by parents. Often parents think that they are securing the wellbeing of the girl, but these arrangements interrupt or end education; promote teenager pregnancy and have a high rate of domestic violence and exploitation," said the organization.

The Belize Olympic and Commonwealth Games Association, in speaking about the inequalities that affect women in sports, stated that access to and participation in sports activities, representation at coaching and management levels, media coverage, and wage gaps, are all issues still plaguing young girls and women today.

According to UNESCO's Director-General, Audrey Azoulay, if we want our progress in empowering young girls to continue (the gender gap in global access to education is close to zero, and the proportion of girls completing primary school has increased by 20% over 25 years), then we must continue our efforts.

"The pandemic has increased risks to girls' education, with lockdowns contributing to a decrease in girls returning to school. School closures could lead to an additional 10 million early marriages of girls over the next 10 years. We must therefore give girls the tools they need to succeed – and create an environment that allows them to do so," she said.

A part of that effort, added the Director-General, is developing appropriate public policies for girls' and women's education. It also means fighting the underlying causes of school dropouts, like early and unintended pregnancies.

"Today's more than 1.1 billion girls are poised to take on the future," notes the UN. "Every day, girls are breaking boundaries and barriers, tackling issues like child marriage, education inequality, violence, climate justice, and inequitable access to healthcare. Girls are proving they are unstoppable."

The last two years have taught us not to take the small things for granted.Therefore, while the threat of Covid-19 has abated with the help of vaccines and booster shots, the BTB has expanded its efforts to thank and reward frontline heroes.



The BTB Frontline Hero initiative was first launched in September 2021. The campaign initially focused on frontline workers in the medical field who aided during the Covid-19 pandemic. With the threat of the pandemic significantly reduced, the campaign has shifted to focus on heroes within the Tourism Industry itself. The objective of this campaign is to highlight individuals whohave served at the frontlines of the tourismsector and who have provided the kind of excellence that has kept the industry going. Nominees for this initiative are selected with the help of industry partners such as the Ministry of Health and Wellness, PGIA, the Police Department, Customs etc. Apart from the BTB's gratitude, the organization offers a small token of its appreciation by presenting the nominees with a cash rewardand a staycation package sponsored by hoteliers. These heroes have given much more to the industry than can be stated in one reward, but the BTB and the Ministry of Tourism and Diaspora Relations hope that they know that they are appreciated for their steadfastheroism.

Theorganization's appreciation for its industry heroes cannot be overstated. Earlier this year, Mr. George Nicholson, a taxi driver who has served at the PGIA for over 22 years, was the first industry hero to be rewarded. More recently, Police Constable 989 Rolando Tino Oh became the second recipient. As a member of the Tourism Police Unit (TPU) for over 18 years, PC Oh has dedicated his service to the industrywhile conducting regular checks at hotels, resorts, and archeological sitesin San Ignacio. Any job worth doing is worth doing well. These two heroes have proven that, and the Belize Tourism industry has benefited tremendously from it. A hero by any other name is still a hero. However, the idea of what heroism looks like hasshiftedsince the pandemic. The people whocontinue to bravely do their jobs despite the tremendous setbacks that the industry has experienced over the years and especially since 2020, are what real heroes look like.

Taiwan's participation can strengthen international cooperation to fight transnational telecommunication fraud in the post-pandemic era

Fraud is disrupting people's livelihoods in the post-pandemic era

The internet is very much part of daily life in the post-pandemic world. Working,

studying, shopping, and conducting other transactions online have become commonplace. But the digital financial services that have developed from these activities are an easy target for criminal organizations and have also made investigating crime more complicated for the police. In 2021, Taiwan reported fraud-related losses of NT\$5.61 billion (equivalent approximately to US\$186 million), indicating that fraud has seriously damaged national economic development. There is little doubt that fraud poses a formidable challenge to countries worldwide.

In recent years, fraud has become more diverse and sophisticated and scammers are working in new and constantly

Belize Climate Week 2022

BELIZE CITY, Wed. Oct. 12, 2022

Yesterday, Belize Climate Change Week officially started with an initial session focused on sensitizing Indigenous people to climate change and biodiversity. Today, October 12, is now known in the country as Indigenous People Resistance Day, and in line with the principles underlying that national holiday, a representative from the Maya and Garinagu communities was engaged in a knowledge-sharing session organized by the Belize National Climate Change Office and the Belize National Biodiversity Office.yesterday.

The session created an opportunity for representatives from those Indigenous groups to be heard and engaged in conversation geared toward collective involvement in activities that are part of a national effort to address the impacts of climate change.

The second session, held in the afternoon, focused on youth and youth negotiators.

"This afternoon's session of our Climate Change Week saw the vibrant engagement of young and enthusiastic individuals from across Belize as they participated in a mock Conference of Parties (COP) dialogue alongside Belize's very own COP27 Delegation of Young Negotiators," a release from the Ministry of Sustainable Development, Climate Change and Disaster Risk Management stated.

COP27 will be held in Sharm El Sheikh, Egypt, in November of this year.

evolving ways. Schemes involving cryptocurrency—recently a hot commodity—have inflicted heavy losses on victims. When Taiwan's police investigate cases, they often encounter difficulties arising from the fact that servers, recipient accounts, and cryptocurrency exchange platforms used by perpetrators are based overseas. This prevents officers from stopping the transfer of money in time to help the victims and makes it more difficult to track down suspects.

The inflow of profits from fraud and other illegal activities involves money laundering, tax evasion, and other crimes that undermine domestic financial regulatory systems and erode the sovereign authority of governments. Police cooperation between Taiwan and other countries would help reduce the number of fraud cases and contribute to the administrative efficiency of governments worldwide.

International cooperation is needed to combat the use of virtual currencies for money laundering

Virtual currencies are a high-risk-highreward commodity. They have grown increasingly popular in investment markets. As the average person does not fully understand how virtual currencies work, these investments have become a common instrument of organized fraud. Taiwan police have recently discovered that money laundering by criminal groups using virtual currencies mostly involves proceeds from investment fraud. Victims are lured into registering with a fake investment platform and when they try to withdraw funds after making a profit, the customer service system-operated by the criminal group—requires them to pay additional taxes of 10 to 20 percent before the withdrawal can be approved. Even if the payment is made, the criminal group continues to fabricate further demands that the account be replenished in order to cover, for example, transaction fees.

Criminal organizations have shifted their tactics from buying mule bank accounts to using virtual currency wallets, thus lowering the risk of police detection when funds are withdrawn. The gangs open phony accounts with virtual currency exchanges, where identity verification procedures are relatively relaxed. Once a victim makes a deposit into a designated account, the scammers quickly transfer the money multiple times, eventually moving it to a cold wallet. It is then switched to another exchange, where it is converted into legal tender. Crypto wallets that do not require user authentication and have no upper limit on transactions are a convenient tool for money laundering. The victim, perpetrator, and location of the crime are usually in different countries. Thus, transnational cooperation is needed to effectively crack down on the common practice of concealing illegal gains and converting them into legal assets.



Sam Waight organize a House party and take us to the site, to see this magnificent bridge he made over the Belize River?...I want to see it, Barrow wants to see it, and my brother, Sedi, who will kick the stuffings out of George Price in Pickstock in the next general elections, he wants to see it...Mister Speaker, this bridge, there's never been another like it...this isn't Brooklyn Bridge, which was sold...this isn't London Bridge, which fell down...this one never made it across the river! When the scuba divers are done finding the Titanic, we've got a job for them, to find the Sam Waight PUP Bridge over Iguana Creek."

Hmm, I don't know if I have all that speech down word for word: it's like 89-98 PUDP we're talking about — a time when the PUP was led by the unelected Ralph Fonseca, and Luke Espat was that gang's version of Arguelles and Imer. But if I missed a few words here, and added a few words there, I'm sure you get the gist.

You know, maybe it is Hubert to blame for the wasted 13 years of UDP, 2008 to 2020, when instead of fixing all the wrongs of the PUP predecessors, they milked them for political gain. I don't have all the details about the design, but I was able to ask a few questions of people working on the bridge because it's not far from my neighborhood. 



Ancient Maya elite may have suffered from chronic mercury poisoning

Studies have found evidence of use of the metal at sites in Mexico, Belize, Guatemala, Honduras, and El Salvador.

A review article published in the journal Frontiers in Environmental Science has revealed that high concentrations of mercury were found in numerous sites once occupied by ancient Maya civilizations, leading experts to believe that many of the elite Maya may have suffered from chronic mercury poisoning.

Archaeologists have been researching and attempting to understand the ancient Maya's long history of mercury use for some time now. Cinnabar, a mercury compound, was often utilized for ceremonies and for decorating artefacts. According to Nicholas Dunning, a co-author in the study and a geologist at the University of Cincinnati, the ancient Maya believed that cinnabar contained ch'ulel or "soul force".

"The brilliant red pigment of cinnabar was an invaluable and sacred substance...but unbeknownst to them it was also deadly, and its legacy persists in soils and sediments around ancient Maya sites," he said.

The review article featured a study

of all literature related to research done on a total of ten sites in Mesoamerica (Mexico, Guatemala, Belize, Honduras, and El Salvador). Soil and sediment samples from seven of those ten sites had mercury concentrations above what is known as the Toxic Effect Threshold (TET) of 1 part per million (ppm). Tikal, for example, had mercury concentrations of up to an astounding 17ppm. Other sites, such as Marco Gonzales, located on Ambergris Caye, and Chan b'i, located in Southern Belize, yielded samples with near undetectable levels.

The Effect on Human Health

According to the article, entitled "Environmental legacy of pre-Columbian Maya mercury", the large volume of research that exists on the Maya's use of mercury shows that the exposure to the toxic metal via cinnabar-based paints on ceramics, the use of cinnabar and elemental mercury in ritual and ceremonial activities (including burials) and, probably, the seepage of mercury into food and water, was likely to have caused numerous negative health impacts.

In the case of Tikal, evidence has

suggested that many of the ancient elite suffered from mercury poisoning due to prolonged exposure. One 2020 report found that Tikal's water reservoirs had grown contaminated with mercury due to runoff from ceremonial burial grounds. (The tombs of many rulers were described as being covered with cinnabar powder). This may have been one of the many contributors to the city's collapse in the ninth century.

Chronic mercury exposure is known to cause damage to the central nervous

system, kidneys, and liver, as well as severe metabolic syndrome. Notably, one of Tikal's last rulers during the Terminal Classic period, Dark Sun, was believed to have been "pathologically obese" as a result of said syndrome.

Duncan Cook was the lead author on the review paper. Upon its publication, he issued a statement, noting that mercury pollution in the environment is usually found in

Minister Courtenay addresses 52nd OAS Gen. Assembly



Hon. Eamon Courtenay, Minister of Foreign Affairs

LIMA, Peru, Fri. Oct. 7, 2022

"Inequality and discrimination abound in the Americas"-those were the words of Minister Eamon Courtenay as he addressed the 52nd General Assembly of the Organization of American States last Friday in Lima, Peru. Minister Courtenay, in his address, highlighted a drastic increase in inequality across the Americas that he attributed to the COVID-19 pandemic, and high commodity prices. This is in contrast to what was taking place in the early 2000s, when, according to Minister Courtenay, a substantial decline in inequality was seen across the region.

"Poverty fell on average from 42.3% in 2002, to 23.1% in 2018, as vast swaths of the population moved into the middle class. However, the COVID-19 pandemic and the end of high commodity prices have increased hemispheric inequality," Courtenay stated.

He spoke directly about the effects of systemic racism and its negative impact on development across the region.

"Mr. President, inequality is a vestige of our colonial past, colonialism that spawned structurally unequal societies, replete with racism and racial inequality. Today this legacy threatens the stability of our political systems, weakens our social fabric, and fosters unjust societal income inequality in Latin America and the Caribbean is a cancer," Minister Courtenay went on to say.

He also made note of the wage disparity seen across the Americas: "The richest ten percent earns twentytwo times more than those in the bottom ten percent. The richest one percent takes in twenty-one percent of the income of our economies, while the top ten percent collect more than half of the pre-tax national income. This is the inequality that we must come together to fight against," he said.

Courtenay further noted that while the constitutions of countries in the region are aimed at fostering equality, the reality on the ground is very different—with persons of African descent and Indigenous peoples of the Americas continuing to be among the poorest and most discriminated against in the region.

He then remarked that the view held by many of those disadvantaged groups, that governments are unfair, is a result of the inequality that is still unchecked in developing countries, and he asserted that the fight against racial discrimination and securing reparations for the oppressed peoples of the region is of high importance.

"Afro-descendants make up 25 percent of the population and indigenous peoples, but across the region, both groups are far more likely to be poor. This is inequitable, and this is why Belize joins the ever-louder chorus that calls for reparations. People of African descent and the indigenous peoples of the Americas must be compensated for the injustices they have suffered," Courtenay said.

In regard to access to affordable climate financing, Courtenay pointed out that Belize is among the top 5 countries in the world currently generating 50% renewable electrical energy, but is still one of the countries that will be most affected by the negative impacts of climatic events.

"The current climate crisis presents a stark picture of these inequalities," Courtenay said, adding, "we enjoy a stellar record for environmental conservation, but that will not save our low-lying coastline and the fabulous reef system from the imminent ravages of climate change. We need access to imminent climate financing, and we need it now." Courtenay said.

Highlighting other global and regional issues, he stated, "We in Belize are unrepentant multilateralists. We envision a world order that rejects war and condemns the Russian Federation for its illegal war against Ukraine. But, Mr. President, the OAS, we cannot credibly fight injustice and discrimination if we continue to allow an unelected and illegitimate man to sit amongst us. The sanctions against Venezuela are discriminatory, and that punishment must end. We will not win the fight against injustices and discrimination until the illegal blockade against Cuba is lifted."

Our democracy is strong!

Julia's waves topple Monkey River home

A house in Monkey River toppled into the sea as a result of rapid coastline erosion due to the battering of the Monkey River coastline by waves whipped up by Hurricane Julia. Other Monkey River residents are trying to save their homes.

MONKEY RIVER VILLAGE, Toledo District, Mon. Oct. 10, 2022

The impact of Hurricane Julia on Belize is still being assessed within the country by disaster response officials. The effects of that storm, however, were perhaps most dramatically witnessed in the coastline village of Monkey River, where residents saw the real-time and horrific effects of coastal erosion, with at least one iconic house in the village being claimed by the battering waves of the seas. Over the weekend, video footage that was released on social media showed residents trying their best to try to shore up their properties to prevent damage by the heavy waves associated with Hurricane Julia.

One house, the residence of the late Ms. Eleanor Sandlin, was claimed by the waves and toppled into the sea following the further weakening over the past few days of the eroded beachfront on which it was located by the wind and waves whipped up by the hurricane. Footage shows the balcony of the house, which overlooked the sea, collapsing into the water, which has been continually encroaching on what was once land in the village.

"We had rain all day Sunday,"

Monkey River chairperson Ekoydia Cuevas said in an interview with KREM News. "Sometime before day, that's when villagers started to experience all the water coming into the house, the waves washing against the houses, bringing all the sand and stuff inside," she said.

She said that no one was living in the house that fell in the sea.

This iconic house and its late owner were well-known and loved in the village, and the destruction of the property marks a significant milestone in Monkey River's battle to save the village from coastal erosion.

The land on which the house sat, which was initially located in the center of the village, according to locals, underwent years of erosion which eventually led to it becoming beachfront property. During those years in which that transition took place, a football field, cemetery, and other parts of the village were washed away by the sea as a result of years of erosion.

Rachel Graham, a resident of the village, stated in a Facebook post, "This loss is the combined effect of coastal erosion from misdirected highlevel central decisions swayed by

private interests over the needs of coastal communities, storm surge from more impactful storms and rising seas. Climate change is here. It's no longer at our doorstep, it has taken our doorstep. And in Ms. Eleanor's case, it is taking the whole house. "

the collapse of the house into the sea can be attributed to the recent hurricane and strong wave activity, years of ongoing erosion have been plaguing the community of Monkey River, and continue to encroach on the real estate of the village and the livelihood of its residents.

Nayib Bukele's speech

Permit me, our dear readers of this column, to present to you the following speech which I find to be of utmost importance. I would like to highlight how the President of the Republic of El Salvador, Nayib Armando Bukele, delivered his speech. He did not read it from a written script, which means that he didn't prepare any. Instead, he spoke every word straight from his mind and heart. The following is the speech President Bukele gave at the 77th Session of the United Nations General Assembly, dated September 20, 2022. It is as follows:

Madam President of the General Assembly, my compatriot and Ambassador to the United Nations; Your Excellency as Heads of State and Government; distinguished members of different delegations; my wife Gabriela and my daughter Layla; ladies and gentlemen, and principally to the peoples of the nations of the world:

I bring you greetings from the land of surfing, volcanoes, coffee, peace, Bitcoin and freedom. Almost all of the above is easily verifiable: anyone who goes to El Salvador will find the best surfing beaches in the world, volcanoes everywhere, incredible coffee; you will be able to walk with peace and tranquility through any corner of our country, and especially, you will find a united people fighting for their freedom. And that is precisely what I have come to speak about on this podium, at the United Nations General Assembly. Of freedom. The one that my people yearn for, and the one that all the peoples of the world yearn for. And it is that freedom is a word that is easy to say; but that requires struggle, perseverance and many sacrifices, for it to be true. The freedom to choose where we want to go and how we want to achieve it. The freedom to define our path as human beings.

But to be free, like much of what defines us, depends on how others see us, but, above all, on how we see ourselves. Therefore, in addition to deciding that we want to be free, it is an essential requirement that the powerful respect our freedom. I come from a people that for a long time saw itself as less than the others. I come from a people where we never had the courage to make our own decisions. I come from a people where our destiny was always controlled by others. I come from a people that only owns the smallest country in the American continent. And that, even that small property on that little piece of land, that you can barely see on the map, is not respected by countries that have a lot more territory, a lot more money, a lot

more power and that CORRECTLY think they are the owners of their country; but who INCORRECTLY think that they also own ours. And it is that a group of powerful countries not only have much more than all the others, but they also believe that they are owners of the little that the countries that are not powerful have. It is as if someone lived in a very small and very humble house, but had a very, very rich neighbor, whose house is a beautiful and gigantic palace, with immense extensions of land and unimaginable treasures. Whoever lives in the little house respects and admires his neighbor; it doesn't bother him that the other is immensely richer than him; he is happy in his little house, but he has decided to improve it; he is going to paint it, fix it and furnish it better, with effort, of course, but he is sure it will be worth it. All good up to there. Until the rich neighbor decides that his poor neighbor does not have the right to fix up his house, he does not have the right to buy other furniture or paint the walls. The rich neighbor has decided that he not only owns his palace, but can also give orders in the small house of his poor neighbor. And the order is that everything has to continue badly, as it was before. Arrangements are not authorized. The poor neighbor should not oppose his rich neighbor; he should not envy him, he should not aspire to have what the rich neighbor has, he should not pretend that he will give orders to his palace or demand that he change the marble from his room. But the poor neighbor should at least have the right to clean HIS house, patch and paint HIS walls, change HIS furniture, plant flowers in HIS GARDEN and change HIS roof for one that doesn't leak and covers him from the rain. That cannot bother the rich neighbor, who cannot demand that he put back the old furniture, cut the flowers, strip the walls, remove the new roof (which is also working for him), to put back the roof that was before, with the aggravating circumstance that that leaky

roof never worked. The rich neighbor has no authority to demand that his poor neighbor return to the past. In the first place, because he would have no reason to pretend to rule in someone else's house. Second, because this poor neighbor already tried to follow orders and could not have done worse. And thirdly, because what he is doing IS WORKING for the first time. Why should his neighbor force him to go back to how he was before? For what purpose? To achieve what? Shouldn't he be glad that his poor neighbor is doing a little better than before? That is why I say that freedom is something that we still fight for in our country, El Salvador. Because although on paper we are free, sovereign and independent, we will not really be until the powerful understand that we want to be their friends, that we admire them, that we respect them, that our doors are wide open to trade, so that they visit us, to build the best

possible relationships, but what they can't do is come to command in our house. And not only because it is ours, but because it would not make sense to undo what we are achieving: In a very short time, El Salvador has gone from being LITERALLY the MOST DANGEROUS country IN THE WORLD, to being on the way to being the SAFEST country IN AMERICA. We went from being a country unknown to many and those who knew it, knew it because of the gangs, because of the dead, because of the violence, because of the war. We went from that to being a country known for its beaches, for surfing, for its volcanoes, for its financial freedom, for its good government and for having put an end to organized crime. And those achievements, which are just beginning and have been achieved in a very short time, are immense for us. And we have the right to protect them and continue on the path of our development.

That's why I said that freedom is something we still fight for. Because we still need recognition of our right to be free. To be truly independent. I wanted to use this podium to say these words, because perhaps they will not only resonate in my country, El Salvador, but also in other peoples of the world, who like mine, want to build their own path, with freedom. Some will be able to do it before, others later; for some it will be easier, for others more difficult. But it will be faster if powerful countries help us, instead of condemning us. And if they don't want to help us, at least they shouldn't get in the way. Each people should find their own way. And each people will find friends in the search for that path. To these countries, I humbly offer the friendship of this small country, the smallest in America, the country of surfing, volcanoes and pupusas. The country that is still fighting for its freedom, but is about to achieve it. 3 years ago, I was here, on this very podium at the United Nations. At that time, I told you that this format was already obsolete. Now, 3 years later, it is even more so. But perhaps it will still be of some use; perhaps it will serve, among many other things, for this representative of this small country, the smallest in the American continent, to humbly remind you that these United Nations were not created to divide, to destroy or to submit; but to relate to each other, to work together, to build a better community of countries and to seek solutions to the world's problems; but with absolute respect for the sovereignty, independence and selfdetermination of each country and in the way that the Charter of the United Nations itself says, in the First Principle of how this Organization would be: "The Organization is based on the principle



contemporary urban areas and industrial landscapes.

"Discovering mercury buried deep in soils and sediments in ancient Maya cities is difficult to explain, until we begin to consider the archaeology of the region which tells us that the Maya were using mercury for centuries," said Cook.

The most recent discovery of mercury at a Maya site occurred at Lamanai in Belize. Beneath a ball court, archaeologists found a small bowl containing liquid mercury along with a small amount of cinnabar powder. Additionally, at Caracol, archaeologists found a cache beneath structure A6 containing "least 664.7 grams of elemental mercury along with other artefacts".

While there have been decades of research dedicated to understanding the ancient Maya's long history of mercury use, there are still some gaps in that research. The study notes, for example, that more information is needed on the environmental persistence of mercury, including environmental consequences, if any, and the effect that it may have on present-day archaeologists.

There is also still very little known about how, why, or when the Maya began to obtain and use mercury-based material, though it is believed that they transported it along trade routes much as they did with jade and obsidian.

SRC TRADING THOUGHTS Pound Volatility: What implications for Caribbean tourism and trade?

Winter is coming! And not in the Game of Thrones sense. The big news in currency markets on Monday, September 26, 2022 was the British pound (GBP)'s record slump against the United States dollar (USD). It seems unfathomable now that years ago one UK pound was worth some 2 USD. Then early that Monday morning in September, the pound dropped to the equivalent of US \$1.03 at one point, almost reaching parity with the greenback before rebounding slightly in the afternoon and recovering somewhat since then. However, that day was the closest in history that the GBP/USD rate has come to parity and marks one of the most volatile periods the Sterling has experienced since the turmoil of the Brexit referendum in June 2016 and its aftermath.

But what does this volatility of the UK pound and UK economic developments more generally mean for the Caribbean? This SRC Trading Thoughts discusses this state of affairs and potential implications for the Caribbean's tourism and trade with one of its major trading partners.

What accounts for the pound's depreciation?

One of the simplest answers for the pound's depreciation against the dollar is that the latter is experiencing strong appreciation against other world currencies, as often happens when there is global uncertainty leading investors to retreat to the safety of the US dollar. But several other factors, including recent political and economic events in the UK, also explain the pound's most recent depreciation.

After emerging victorious in the race to replace then disgraced Prime Minister Boris Johnson as Conservative Party leader, current UK Prime Minister Liz Truss has inherited a UK economy on the brink of recession, if the Bank of England's projections of two consecutive quarters of negative GDP are proven true. Some pundits, like the economists at S&P Global Ratings, say the UK economy is already in a full recession. Volatile energy prices fueled by the Russia-Ukraine conflict have spiked inflation in major world economies, including the UK. Though global energy prices have dropped somewhat in recent weeks, UK households face a winter with rising costs of food and gas diminishing their purchasing power. Inflation in the UK is currently running at 9.9%, as reported by the UK Office of National Statistics (as at August 2022), which is a dip from July's 10.1% but remains elevated. Moreover, the decline in global oil prices might be short-lived. At its justconcluded Vienna meeting, the Organisation of the Petroleum Exporting Countries plus Russia (OPEC+) announced its decision to cut daily oil production by 2 million barrels, which could drive up oil prices once again, with concomitant consequences for global inflation. To cool inflation, the Bank of England (BoE) has raised its key interest rate to 2.25%, which is the highest level since

the 2008/2009 global financial crisis. It follows the US Federal Reserve's third straight significant rate hike on September 21 to do the same for the US economy. The BoE has further said in its statement that it "will not hesitate to change interest rates by as much as needed to return inflation to the 2 percent target sustainably in the medium term, in line with its remit".

On September 23, 2022, the newly appointed UK Chancellor of the Exchequer, Kwasi Kwarteng, delivered a 'mini-budget' in which he announced several fiscal measures to help UK households mitigate the effects of spiraling prices. The main problem, however, was the huge tax cuts announced, which were largely unfunded and included a proposed scrapping of the top personal income tax rate of 45% for the highest income earners, therefore benefiting the wealthiest taxpayers in the middle of a cost-of-living crisis. Not only were the proposed tax cuts deeply unpopular in the UK, but it rattled financial markets, accounting for that Monday's unprecedented drop in the Sterling's value and also spiking rates for new mortgages and remortgages in the UK for the first time since 2008.

The move was also strongly condemned internationally. The International Monetary Fund (IMF), in a statement issued on September 27, 2022, made the unusual step of publicly critiquing the policy proposals of a major G7 country and urging a "reevaluation" of the proposed policies. On September 28 the BoE intervened to purchase UK bonds in order to restore stability and calm markets following a historic sell-off of UK government bonds by investors in the wake of the policy announcements. On October 3 2022, the Chancellor subsequently announced a reversal of the Government's proposed removal of the top personal income tax rate of 45%. The pound has since regained some value, but as at Wednesday, October 5, 2022, it remains at a low rate of 1 GBP to \$1.13 USD.

Implications for the Caribbean

The Pound's record low rates are a potential mixed bag for the Caribbean. Starting with the positives, Caribbean Community (CARICOM) Member States imported US\$596 million in goods from the UK in 2021, according to ITC Trade Map data. Depending on the pricing terms of supplier contracts, Caribbean importers could find importing from the UK cheaper due to the stronger US dollar vis-à-vis the UK pound. Caribbean tourists to the UK and students pursuing studies in that country will find that their money will go further. However, this gain is offset somewhat by the record inflation - the fastest rate in four decades. Now to the negatives. The UK is a leading tourism source market for the Caribbean region and for some countries, like Barbados, is the biggest source market. With the UK facing a winter of uncertainty, UK travellers,

The Keeping Up with Language, Culture, Heritage, and Arts Symposium features lectures and presentations on publishing in Belize, archaeology, entrepreneurship, Belizean culture, anthropology, ancient and modern history and more.

BELIZE CITY, Wed. Oct. 12, 2022

From the plight of the Christian Workers Union's stevedores, to periods of poverty, to the innovation of the ancient Maya, the topics explored during the Heritage Education Network Belize's second annual Belize KULCHA Symposium ran the gamut. The three-day symposium took place last week and concluded on Friday.

The annual symposium is aimed at creating discussion around community issues and innovative practices in Belize. The main areas of focus are language, literature, and poetry; culture and cultural heritage (both tangible and intangible), archaeology, and anthropology; heritage and history (including natural heritage); and fine and creative arts in Belize.

This year's symposium's three main themes were Archaeology and Cultural Heritage Management in Belize, Belize's Culture in Historical and Modern Context, and Celebrating Lamanai's Nomination to the World Monument Fund's Watch List.

Dr. Dylan Vernon, who recently published his book on Political Clientelism in Belize was one of four presenters who explored Belize's culture in historical and modern context. His talk focused on the role that ethnicity and party politics play, and have played, in Belize's political culture. Dominique Noralez presented "Sitting at the Dock: Sugar and Cream, the Case of the Stevedores of the Christian Workers Union", during which she explored the establishment and history of one of Belize's most prominent unions as well as the

struggles that the members of that union have faced at the hands of capitalist interests.

Under the theme of Archaeology and Cultural Heritage Management in Belize, Dr. Amy Thompson and Aidan Hunt both focused on Belize's Maya history, with Dr. Thompson discussing indigenous landscapes and village formation, particularly that of the Mopan and Q'eqchi' Maya, while Mr. Hunt focused on British colonial policy towards the Icaiche Maya.

On Friday, the KULCHA Symposium presentations were centered on celebrating the recent nomination of Lamanai to the World Monuments Fund Watch List, focusing especially on the relationship between Lamanai archaeologists and the local communities that surround the site, including the village of Indian Church.

The World Monuments Watch is an initiative by New York-based NGO World Monuments Fund to draw international attention to cultural heritage around the world that is threatened by neglect, vandalism, or disaster. The Heritage Education Network Belize successfully nominated Lamanai to the list in March of this year in an effort to underscore the greater need for action against climate change, imbalanced tourism, underrepresentation, and other issues that threaten the site and other places like it. 

Truck driver rescued on flooded Coastal Road

A daring rescue was caught on film yesterday around noon after a truck and its driver were swept off the Coastal Road by rushing flood waters. The driver sought refuge on the top of his truck as workers from construction the company working on the road came to his aid. Reports are that the vehicle began overturning after the driver missed the road and got stuck at the edge of the embankment.

The man is seen holding onto the top of the vehicle as the strong currents raged past him, while on the dry portion of the road the men from the construction company were creating a belt by tying ratchet straps together. That belt was thrown to the driver, who scurried toward it — groping for it in the murky waters with one hand while holding onto the truck with the other.

He got a hold of the belt and tied it around his body securely before sliding his feet off the top of the truck, and was pulled to safety by the men on the other side.

World Mental Health Day 2022 focuses on making mental health a global priority

BELIZE CITY, Tues. Oct. 11, 2022

According to the World Health Organization, close to 1 billion persons have a mental health disorder. Despite this, relatively few have access to adequate mental health services. This past Monday, October 10, the international community, along with WHO and the UN, observed World Mental Health Day under the theme "Make Mental Health and Wellbeing a Global Priority for all."

In a statement released by the Ministry of Health & Wellness, Hon. Kevin Bernard explained that this year's theme was chosen to address the inequalities in mental healthcare that were exposed by the COVID-19 pandemic as well as the impact that the pandemic had on mental health globally. During the first year of the pandemic alone, depression and anxiety increased by 25% around the world. WHO has stated that the pandemic has triggered a global mental health crisis due to increased short and long-term stress. Here at home, Belize reported a 31.5% increase in anxiety disorders. This World Mental Health Day, the WHO has made a call for greater investment in mental health care for all. The Karl Heusner Memorial Hospital (KHMH) has answered that call recently, by providing training for staff on how

Sandhill man killed in freak accident

Denbigh Grinage, 45, of Sandhill Village, Belize District, was accidentally killed when part of a dump truck fell on his head.

BISCAYNE VILLAGE, Belize District, Fri. Oct. 7, 2022

Denbigh Grinage, 45, of Sandhill Village, Belize District, lost his life on Friday, October 7, in Biscayne Village, Belize District, when the box of a dump truck fell on his head while he was working in the sandpit.

Reports indicated that at around 1:30 in the afternoon that day, Grinage was working on the truck's hydraulic system between the chassis and the box of the dump truck, when the box crushed part of his forehead, killing him instantly.

The brother-in-law of the deceased, Jacinto Hernandez, told local reporters that while Grinage and others were "putting on the pan" of the truck, he pulled out a wooden board from his side and was supposed to go around and

pull the other board. However, Grinage stretched forward and pulled out the other wooden board, causing the box of the truck to collapse and kill him.

"Actually, it didn't slap all the way down. It just came down a bit and smashed a part of his forehead," said Hernandez, who remarked that Grinage was "a cool guy, hardworking ... handyman."

Grinage had no children.

including those in the Caribbean diaspora, might be less inclined to travel to the Caribbean region, especially given the higher airfares. Moreover, those like High Net-Worth Individuals (HNWIs) who do decide to travel, might also spend less due to diminished purchasing power, which could adversely impact our countries' tourism receipts. Pound volatility could also once again impact foreign direct investment in Caribbean countries' second-home markets, in which UK residents are among the main purchasers and renters of luxury accommodations.

market, given higher inflation and lower purchasing power of the average UK consumer. Caribbean countries' tourist arrivals and receipts from the UK could also be adversely affected due to the average UK consumer's lower purchasing power.

This, like other shocks before, further reiterates the critical need for continued diversification of our mostly tourism-dependent economies and tourism source markets, including intensifying efforts to build travel and trade links with Asia and Latin America and more recently, Africa. Supal Street Gang member confesses to murder in leaked recording

BELMOPAN, Wed. Oct. 12, 2022

Over the weekend, an audio clip from a well-known member of the Supal Street Gang in Belize City was leaked to members of the local media, and in that recording, the notorious street figure can be heard confessing to serious crimes, including two recent murders that took place in Ladyville, and theft.

During the weekly police press briefing on Tuesday, October 11, members of the local media questioned Commissioner of Police, Chester Williams-who recognized the voice of the gang member

in the clip—about what could be done to prosecute that individual on the basis of the recorded confession. However, the gang member whose voice is seemingly heard in the recording is in hiding in the US, and no charges have yet been levied against him in connection to the murders mentioned in the audio clip.

Notably, it is yet to be confirmed whether the voice heard in the recording is indeed that of the well-known gang member, and, according to Commissioner Williams, for charges to be levied on the individual, such a confirmation would have to be done through voice analysis.

"There certainly will be a lot that will be required to be done. Yes, we need to have some voice recognition expert who would be able to ascertain without any doubt that the person in the voice clip is indeed him. Yes, you and I who may have come into contact with him on numerous occasions can say at first glance that the voice is his, but we still need to go beyond that. And then we need to see whether or not the information in the voice clip is indeed credible, that what he described had actually occurred. Once that is ascertained, then we can look at perhaps producing a warrant because, to some extent, he is promoting gang activity

and under the gang regulations, we certainly will be able to charge him," Commissioner Williams told reporters.

He further explained, "Once we would produce the warrant for his arrest, then we would inform the U.S. authorities and Interpol to indicate that he is wanted in Belize on that particular charge. Once he is captured and returned to the country, then we can proceed with court proceedings against him in respect thereof. And if it is we can get more in respect to the murders that he alleged in the voice note that was committed by him or his group, then certainly the charge of murder can also be looked at."



unemployment driven by the pandemic, criminal organizations set up call centers in various parts of the world and recruited people on a large scale through online advertising. The scammers used attractive slogans like "easy job" and "fast financial freedom" and promised stable and legal employment in other countries. Victims only discovered after arriving that the jobs involved fraud or were not what they expected. Some even had their passports confiscated, were deprived of their freedom, and were beaten or sold to other unlicensed businesses if they refused to comply. If they asked to quit, they were forced to pay exorbitant fines or threatened with organ removal to compensate the gangs.

Human trafficking is a serious issue that needs to be addressed by the global community. Fraud rings take advantage of the convenience of the internet to recruit people of different nationalities through multiple channels to work in scam call centers around the world. Taiwan police have long spared no effort to crack down on this type of transnational crime. This year, they have received reports of Taiwanese citizens being held against their will and forced to engage in fraudulent activities in Cambodia, the Philippines, the United Arab Emirates, and other countries by illegal organizations set up by Chinese nationals. International cooperation is urgently needed to rescue the victims and fight such crimes.

In 2021, Taiwanese and Vietnamese police jointly cracked down on a fraud ring in Taiwan that was forcing Vietnamese migrants who had overstayed their visas to engage in scams targeting their fellow compatriots. The racket earned the criminals VND3.29 billion (equivalent to about US\$140,000). In cooperation with other foreign law enforcement agencies, Taiwan's police have uncovered several cases of organized crime outside Taiwan linked to cross-border fraud and human trafficking. They worked with Montenegro in 2020 and with Turkey in 2021 to clamp down on organized crime involving perpetrators, victims, and locations in multiple countries. In the joint operation

with Montenegro, 92 suspects were arrested for defrauding more than 2,000 victims of a total of NT\$632.78 million (equivalent roughly to US\$21 million). These cases not only underscore the importance of cooperation among countries to combat crime but also highlight the need for concerted efforts to protect human dignity and values.

Taiwan's contribution will benefit the world

Taiwan has a high regard for the rule of law and human rights. The Constitution of the Republic of China (Taiwan) upholds the ideal that national sovereignty resides with the people and explicitly provides for the protection of people's rights and freedoms. The government strictly prohibits any action that infringes on the rights of others. Transnational crime often involves multiple countries and areas, which can hinder investigations. In the post-pandemic world, criminal tactics will continue to evolve and new methods will emerge. In investigating new forms of criminal activity, experience is invaluable. Taiwan is willing to share its experience in solving crimes. Today, telecommunications and cyber fraud are conducted across borders and transnational crime rings are organized and departmentalized. This poses a challenge to the sovereignty of nations and undermines livelihoods, economies, and law and order. Taiwan is keen to exchange intelligence with partners and assist other countries in staving off threats from overseas and combating organized crime within their borders.

Police officials are entrusted with the heavy responsibility of maintaining law and order. Their top priority is to protect people's lives and property. Given that crime has taken on increasingly diverse forms, police are facing even greater challenges. To fight modern crime, law enforcers need a firm understanding of the latest criminal developments so that they can prepare for the future and be ready to respond decisively. Looking ahead, Taiwan's police will continue to work with partners worldwide. No place should be overlooked in fighting the pandemic or tackling crime. The international community can count on Taiwan.



Why not mention those? Well, that's part of the censorship. Other speakers included U.S. Senate candidate Diane Sare, former CIA operatives Graham Fuller and Ray McGovern. Again, there's a link at the bottom of the page for you to watch this, and I would encourage you to watch it and share it.

Now, since it's Friday, I'm going to take three questions that I think out of the many that were said sort of get at what's on people's minds. Several people asked about stories that are appearing in the press. The fact that the New York Times two days ago had a story on the U.S. government's response to the assassination by car bomb of Darya Dugina, which the Russians have said was done by Ukraine, and also on The Daily Mirror ran an article on 'Revenge killings' in Ukraine, citing Ukrainian officials saying "they are shooting like pigs, collaborators". So, why is that coming out now? What does this portend? Now, the New York Times article cites U.S. intelligence officials, naturally unnamed, but they say that they have concluded that Ukraine is behind the killing of Darya Dugina, the daughter of Russian philosopher Dugan, that the U.S took no part in these killings, that American officials admonished Ukrainian officials for the assassination and, the article said they expressed concern that future such attacks quote, "could widen the conflict..." unquote. Now, the Russian spokesman for President Putin, Peskov, said with qualifications that this is a positive sign, but he did express concern that it could be an effort by the United States quote, "... to absolve themselves of responsibility for some plots for future terror attacks that Ukraine may be involved in..." unquote. Now, this is of course, quite a significant statement, because the U.S. putting out this statement is quite

unusual, given that the U.S. has so far tried to keep a certain distance from the dirtier aspects of the war going on in Ukraine. But the people who wrote this story in the New York Times know the story which was the subject of the EIR conference and which we've publicized, namely of U.S.-NATO involvement in drafting hit lists or kill lists produced by the committee, the Ukrainian committee, to combat disinformation and Myrotvorets and that Dugina was on that hit list. So, why was that not mentioned? If in fact, you're coming clean and say we're not involved in this, why are there U.S. officials at the meetings of this committee and why have they funded it? So, meanwhile you have a Zelensky spokesman, Podolyak, who admitted quote, "We have other targets on the territory of Ukraine". So, our demand is that all U.S.-NATO support be ended for these institutions that are producing these lists and that the role of Western governments, instead of funding these kinds of provocations, instead of supporting the intimidation and possible killing of people who disagree with the U.S. and Western policy, that the U.S. government should be engaged in demanding an end to the fighting instead of stoking the flames of war, and it raises an additional question: why is there no outcry from the West against the targeting of people who are opposing questions, such as, shouldn't we have a security architecture for Russia and Ukraine? This is the demand of the Schiller Institute. This is why 31 people who have participated at Schiller Institute conferences have been put on these hit lists. So, it shows that minimally, the New York Times story is only part of the story, but that one suspicion that it's part of a cover-up, as Peskov may have been implying, certainly, is real.

I would encourage you to join our mobilization to get the U.S. Congress to stop funding these operations. The Congress should stop funding the war in general, stop shipping arms to the Ukrainian military, but in particular, Congressional funding that's going to civil institutions in Ukraine that are trying to silence American voices in the United States. That's not only un-American, it's unconstitutional and should be stopped. Now, the second question: Why did Liz Truss reverse the tax cut? Now, this was a very important event, because her whole economic policy was based on a huge tax cut modeled on the Margaret Thatcher policy from the mid-1980s, at the same time, pumping money to bail out bankrupt firms, both supposedly to fight inflation. Now, this is just a complete confused jumble of idiocy. She and Kwarteng, the chancellor of the Exchequer, actually believe that a big tax cut will stimulate the economy, when the fact is that inflation is robbing people of their ability to keep their homes warm and feed their children with food, and fuel going through the roof and wages is stuck. The situation in the United Kingdom is ripe for an explosion, and there's a significant backlash with a strike wave developing-rail workers, dock workers, nurses and so on. Meanwhile, the UK credit rating was

Bombshell: Pfizer Exec admits COVID vaccine never tested on preventing transmissions



NEVER TESTED ON PREVENTING TRANSMISSIONS

BRUSSELS—During a hearing today on the European Union's COVID-19 response, Pfizer's president of international developed markets, Janine Small, admitted that its vaccine had never been tested before its release to the general public on its ability to prevent the transmission of COVID when asked by Dutch politician and a current Member of the European Parliament (MEP) Robert "Rob" Roos.

"Regarding the question around did we know about stopping immunization before it entered the market...No.," Small replied with a smirk when asked by Roos if the Pfizer' COVID vaccine was ever tested to stop the transmission of the virus before it entered the market.

She continued, "We have to really move at the speed of science to really understand what is taking place in the market."

It was not clear from the questioning of Ms. Small if she were referring to the Pfizer BioNTech (BNT162b2) vaccine which is authorized under Emergency Use Authorization or Comirnaty which is the FDA-approved vaccine. Under an Emergency Use Authorization, vaccines cannot be mandated.

According to the August 2022 article, *The Pfizer BioNTech* (*BNT162b2*) COVID-19 vaccine: What you need to know, it states that there "is modest vaccine impact on transmission" to prevent COVID infection.

In response to the COVID-19 pandemic, the EU implemented a wide range of health policies with its EU Vaccines Strategy and initiatives, one being EU Digital COVID Certificates which exempted persons from "free movement" restrictions. The EU implemented "free movement" restrictions to slow down the spread of coronavirus and protect the health and well-being of all Europeans.

EU Parliamentarian Roos, exposed an alleged misinformation campaign by Pfizer with the release of his video tweet today. In it he called the actions "criminal", "scandalous" and "a cheap lie."

Below is a transcript of Roos' Twitter post:

"If you don't get vaccinated, you're antisocial. This is what the Dutch prime minister and health minister told us. You don't get vaccinated just for yourself, but also for others. You do it for all of society, that's what they said. Today, this turned out to be complete nonsense.

"In a COVID hearing in the European Parliament, one of the Pfizer directors just admitted to me at the time of introduction, the vaccine had never been tested on stopping the transmission of the virus.

"This removes the entire legal basis for the COVID Passport. The COVID passport that led to massive institutional discrimination as people lost access to essential parts of society. I find this to be shocking, even criminal."

"This is scandalous. Millions of people worldwide felt forced to get vaccinated because of the myth that 'you do it for others.' Now this turned out to be a cheap lie.

at Marjory Stoneman Douglas High School in Parkland, Florida, has been spared the death penalty.

A jury recommended that the defendant, 24, should instead spend the rest of his life in prison for the 14 February, 2018 shooting.

Family members of victims were visibly upset and angry as the decision was read out in court.

A sentencing hearing has been set for 1 November.

The gunman, Nikolas Cruz, pleaded guilty to the murders in October last year. It was the deadliest mass shooting case ever to reach a jury trial in the US.

The verdict sparing him from capital punishment was described as "unreal" and "wrong" by relatives of those killed at a press conference afterwards.

"I could not be more disappointed in what happened today," said Fred our families today."

The jury's decision was also a blow for prosecutors, who had repeatedly sought to prove that the crimes were "cold, calculated and premeditated" and met Florida's definition of "aggravating factors" that warrant the death penalty.

A unanimous decision would have been needed to issue a death sentence.

As each of 17 counts was read out in court, it emerged that while jurors agreed there were factors that would warrant the death penalty, at least one juror believed there were also "mitigating factors" that instead warranted life in prison.



WPC shot; fighting for her life

Leonel Rowland, who is a resident of Dangriga, was also wounded during the shooting. By all indications, he was the gunman's target, since Commissioner of Police, Chester Williams has pointed out that there had been a tense verbal exchange between the shooter and the victim just before the attack.

"From what we gather, the suspect and the other victim, Rowland, had an exchange of words before shots were fired. Mr. Rowland had an exchange of words before shots were fired. Mr. Rowland is disputing having any altercation with the suspect, but we do have a credible witness to us that... and so we are waiting for Mr. Rowland to recover. He can be interviewed more in-depth to see if he will be forthcoming," stated Commissioner Williams. The Police Department is also asking any member of the public who might have information related to this shooting to come forward.

WPC Arzu was not on duty at the time of the shooting, and according to Williams, was seated in the passenger side of a vehicle being driven by Rowland when the shots were fired by the suspect toward the driver's side, where Rowland was seated. Some of the bullets passed him and hit the rookie police officer, who is originally from Punta Gorda, but who has been working at the Dangriga police station since joining the force as part of the last police intake.

According to police, when Rowland was transported to the Western Regional Hospital, he was in a stable condition, but he was subsequently transferred to the KHMH last night. Since then, there has been no update on his condition.

PC Arzu's family and her colleagues at the Police Department continue to hope for a miracle, given the dire prognosis from doctors. COMPOL Williams said they will decide, on the basis of advice from doctors who have been overseeing the medical care administered to Arzu, whether she will be transferred to the Belize Medical Associates for private care. He said that a key concern is the risks involved in physically transferring Arzu, who had been placed on life support, to another facility.

Police have not yet definitively identified the gunman who wounded Rowland and WPC Arzu, but members of the Police Department's Mobile Interdiction Team (MIT) are currently pursuing one suspect for questioning and police are waiting for an opportunity to interview Rowland, who might be able to provide information which could lead to the eventual detention of the shooter. At this point, they are making a collective plea for prayers for the speedy recovery of WPC Arzu.

\$3.1 million found during "Mine Beer" factory raid

the Caribbean International Brewery Company factory in the Orange Walk District. This is the facility at which production of Mine Beer—a recently introduced alcoholic beverage that has been gaining ground in the Belizean market-takes place. That company's brand, however, has possibly been damaged due to allegations of human trafficking made against it after the discovery of 8 Chinese nationals, including the owner of the company, at the factory, despite the expiration of their visitors permits. The 8 Chinese men were charged with violating the conditions of their visitors' permit, while the manager at the facility, who is a Belizean, is facing 8 counts of employing persons without a valid work permit. They were arraigned at the Orange Walk Magistrate Court in Friday and subsequently remanded to the Belize Central Prison, but their attorney, Marcel Cardona, is reportedly trying to get a bail hearing for the men held as soon as possible.

Officers from the Police Department and Immigration Department personnel, along with members of the Antitrafficking of Persons Unit, carried out the two-day sting operation on the strength of a search warrant for illegal labor at the facility, which is located in Carmelita Village in Orange Walk. During the search, the \$3.1 million dollars, which reportedly included some US currency, was found in a safe at the facility. The owners of the company are reportedly claiming that the money that was found is actually the proceeds of September beer sales, but the Financial Intelligence Unit (FIU) currently is in possession of the cash, and according to the Commissioner of Police, Chester Williams, they are this week applying "to the court for permission to seize the money, pending the outcome of a money laundering investigation." During that investigation, they will determine if indeed the funds are proceeds from legal sales

and if the requisite taxes were paid.

In regard to that investigation, Commissioner Williams stated at a press briefing this week, "It's an ongoing investigation. I am sure that if it is that they can produce receipts indicating the collection of that sum and to show that they have paid their fair share of taxes, then the Income Tax and the FIU department are going to release the funds back to them. It is not illegal once you can prove how you get it and you can prove that you have paid your fair share of taxes."

He went on to point, however, to allegations of a grave nature being made against the company—that it may have been withholding the passports of the Chinese nationals found during the raid, but he noted that those Chinese nationals are not cooperating with the police, who are carrying out a human trafficking investigation. The company has said that, in fact, the men found themselves stuck in Belize due to Covid-19-related travel restrictions in China, and that they had been scheduled to leave the country on October 11.

When speaking to reporters yesterday, however, Commissioner Williams countered that explanation by stating, "... that's another issue with them and their country, but even if that were the case, the Immigration Department in Belize is open, and if they wanted to stay longer due to unforeseen circumstances back in their country, then they could have visited the Immigration Department and asked for an extension."

The company is claiming, however, that the raid was malicious and has accused the Police Department of being used by entities with a separate agenda. Today, AMANDALA spoke to the public relations personnel of the Caribbean International Brewery Company, who told us that there is no additional information that they can currently provide, since the matter is before the courts, but they are planning to hold a press conference with their attorneys.



stolen passports.

As we reported in *Amandala* on September 8, the Government of Belize will be launching its new e-passport system later this month. Last week, Minister of Foreign Affairs, Foreign Trade, and Immigration, Hon. Eamon Courtenay, confirmed that the launch date is likely to be October 24.

In that interview, Hon. Courtenay said that he expects the new passport system will significantly reduce the extremely long lines that citizens have had to deal with at the Passport Office in Belmopan over the course of the past year. That is because, with the implementation of the new system, the application process will be digitized—meaning that persons will be able to apply in their own districts by setting an appointment online. Hon. Courtenay also noted that, hopefully, the new passport system will eliminate the petty corruption that has been reportedly taking place in the Department.


What had been uncertain at the time of that interview, however, was the cost of the passports, since, according to the Immigration Minister, the matter was still before Cabinet.

"There is a debate—you know how these things are. People are living in very difficult times," said Minister Courtenay.

According to Courtenay, two key matters were being considered during the discussions about the proposed increase: the affordability for the Belizean populace as well as the recovery of the 20 million dollars that was invested into the project.

"But on the 24th we will launch and all these details will be finalized. We're finalizing the legislation for the new passport, and I think it will be a tremendous increase and benefit to the Belizean people," he said.

Just under two weeks before the launch of the new e-passport system, the proposed prices for the new passports have been leaked. Those prices include \$200 for an adult passport, valid for 10 years; \$150 for a minor's passport, valid for 5 years; and \$100 for a temporary passport that is valid for 1 year. Additionally, renewing a lost or stolen passport may cost \$200 plus the passport fee. The news has



Julia causes flooding and damage across Belize

The flooding of Belize's rivers, damage to houses and power lines following a freak-weather event, and the spotting of a crocodile in a residential part of Belize City are just a few of the effects of Hurricane Julia on the country.

BELIZE CITY, Tues. Oct. 11, 2022

The passage of Hurricane Julia this past weekend has caused widespread flooding throughout parts of Central America, including in Belize, where the storm's outer bands produced torrential rains that flooded western, central, and southern areas of the country.

On Tuesday, the National Meteorological Service, along with the National Emergency Management Organization (NEMO) and Ministry of Sustainable Development, Climate Change, and Disaster Risk Management, held a press conference to address the flooding and the damage caused by Julia.

According to Chief Meteorologist Ronald Gordon, some parts of southern Belize, such as Placencia and Middlesex, received between six and eight inches of rainfall over the weekend. Then, on Monday, as the remnants of storm Julia moved west, areas in the Cayo district experienced "upwards of three inches of rainfall in a very short period of time."

Apart from heavy rainfall, Julia also produced heavy winds of 15-25 knots and severe thunderstorms. In the Lake Independence area of Belize City, residents on McKay Boulevard made reports on Sunday of what they claimed to have been a tornado. Roofs were torn off and power lines were downed due to extremely heavy gusts of winds.

One eyewitness of the event, Marsha Valencio, reported that while she was in her living room, a sudden gust of wind ripped the roof of her home completely off, after which her furniture and other belongings became soaked with rainwater. Outside, her zinc fence was destroyed, and several neighboring houses had also suffered damage. According to Valencio, emergency personnel, as well as the police and Lake Independence area representative Hon. Cordel Hyde, were quick to respond.

Valencio, who is now trying to find the funds needed to rebuild her home and replace her belongings, said, "We are trying to get assistance from the Minister, Cordel Hyde, because he came the night to come check up on us. He came and asked us to go into shelter. He came personally and told us to get an invoice to see what he could help with, but if anybody else out there can assist, we can really appreciate it." are waiting for floodwaters to recede. Additionally, NEMO is bracing itself for the significant amount of flooding that is likely to affect the Belize River Valley area in the coming days as floodwaters move downriver from the west to the east.

"The water is cresting in the Belize River in the Cayo District—it's moving downhill at a rapid pace, and so with the inundation, where the ground was already saturated in those areas due to pooling and accumulation of water, it means now that you have this second wave of floodwaters that will reach into places like Crooked Tree," Defour said.

The Belize River Valley has already been grappling with flooding caused by rain, and the incoming floodwaters are expected to exacerbate things even further. NEMO has warned persons in that area to follow advisories and to move their belonging and their animals to a safer location. The effects of the flooding, said Col. Defour, may be seen as far down as Lord's Bank and in parts of Ladyville.

"We implore the Belizean people, the public, to take the advisories [seriously]—don't play in floodwaters. The Ministry of Health is concerned about dermatitis and about gastrointestinal illnesses which are on the increase due to contaminated waters," he said.

Over the past two days, Belizeans have been documenting the large-scale flooding that has been occurring in various municipalities as well as the damage that has been caused across the country. In Belize City, residents reported seeing a small crocodile in Home Protector Park. It is believed that the animal was driven out of its natural habitat by floodwaters.

The flooding of the Sibun River has made parts of the Coastal Road impassable due to deep water. On Tuesday, one truck driver found himself stranded atop his vehicle after having driven off the submerged road. At some point, the truck keeled over in the waters swashing over the road, and he had to be rescued.

Meanwhile, residents of the village of Monkey River down south, who have been grappling with coastal erosion for years now, were forced to battle the unforgiving sea during the height of the passage of the storm, with at least one house having been lost to the rough water. The losses experienced due to Julia, however, were not limited to homes and personal belongings. According to NEMO, the agriculture industry is expecting significant losses. The Minister of Sustainable Development, Climate Change, and Disaster Risk Management, Hon. Orlando Habet, explained during Tuesday's press conference that a large amount of the production of agricultural food items in the Spanish Lookout area was affected, including soy beans, black beans, corn, and red beans.

Oil spill in Benque caused by Westline Bus Co., says DOE

A release from the DOE states that a 1,100-gallon container of waste oil ruptured, causing the oil spill. The exact quantity of oil that was released has not been determined.

the incident took place is on a slope – causing oil to run down into a drain that leads to the Mopan River.

According to the DOE, the spill was not reported by the company. The release from the DOE states that it was yesterday, when personnel from the DOE conducted a site inspection, that an "oil spill which was not reported by the bus company, was observed on the land and discharging into the nearby drain. "

Employees of the company are reportedly assisting the DOE personnel with the cleanup of the location, but a full assessment of the oil spill

cannot be made yet, since the quantity of the spilled waste oil has still not been determined.

"There is no indication at this time that the oil has entered into the Mopan River; however, it is possible that contamination can occur once the flood waters recede," the release from the DOE states.

The DOE further stated in the release that the company kept no record of the amount of waste oil that was stored in the container. Waste oil is classified as a hazardous substance under the Environmental Protection Act (EPA). In a subsequent release, the DOE reminded businesses and the general public that those substances should be stored properly in line with the best practices and standard requirements.

"The contamination of the environment as a result of noncompliance with these requirements

when the rains came and the flooding increased, some of these [products] went underwater, some of them are still underwater. Maybe there will be a certain percentage that will still be able to be harvested, however, spoilage commences very quickly because they're now soaked up with water-they'll have to be put through a drying process, which is also expensive," he said. A full assessment of the losses sustained within the agriculture industry will commence after floodwaters in the Cayo district, and then in the Belize River Valley, have receded. Until then, the Ministry along with NEMO will be sending out a team to conduct preliminary assessments via helicopter. Right after Julia dissipated, meteorologists began looking at the possibility of another tropical cyclone developing just north of the country, due to a trough of low pressure over the Bay of Campeche. The disturbance has since become the 11th named storm of the 2022 Atlantic Hurricane Season — Tropical Storm Karl, and the Mexican government reportedly issued a tropical storm watch for parts of the Mexican coast. Karl is not expected to affect Belize, and weather conditions should improve in the next few days.

A pollution abatement notice has been issued to the company to ensure that measures are implemented to avoid further impact from the spill. The DOE has also announced that they will seek advice about possible legal action that could be taken against the company under the EPA.

In an interview yesterday evening with KREM News' Marisol Amaya, however, Sergio Chuc, proprietor of the Westline Bus Co., said that the oil spill is not the result of negligent disposal practices by the company, but that a crack in the container led to the leakage of a little over 100 gallons of waste oil, and that because of the flooding caused by Hurricane Julia, no one was at the company's garage over the long weekend to notice.

"Unfortunately, over the weekend, with the heavy rain and the flooding, no one was at the garage, and last night it was found out by the chief mechanic, " Chuc said. The crack was located near the valve of the 1100-gallon tank that holds all the waste oil from the company after oil changes.

"The tank had a little over 100 gallons of waste oil in it. By this morning when they wanted to deal with it, all the oil had seeped out — this is coming from the garage, and unfortunately it went into the drain," Chuc went on to say. According to Chuc, although the entire contents of the container ---about 100 gallons of waste oilleaked out into the drain, the flood water created a blockage that prevented the oil from flowing to the Mopan River, which is about 300 to 400 yards away from the drain. He therefore suggested that all the oil which leaked out the container is still in the drain. A cease-and-desist order was issued for the closure of the garage on Westline Bus Company's premises for 96 hours. The DOE has stated that there is currently no estimated timeline to indicate how long it will take to complete the cleanup of the spill.

According to the Chief Meteorologist, the freak event is known as a microburst and was the result of the severe thunderstorm occurring in that area.

"You have these sudden surges of wind coming down, hitting the surface of the ground and spreading out very rapidly, which resulted in of course some damage to some structures. I believe they were roof damage, for the most part, and downing of powerlines in that area as well," he explained.

The National Coordinator of NEMO, Colonel Shelton Defour, says that it is still too early to assess the entirety of the damage caused by Julia, and officials

The third student, however, Aaliyah Marokin, 20, suffered multiple fractures -including to the hip, arm and leg-as well as abrasions to her head. Her family was reportedly told at the Northern Regional Hospital that she would need emergency surgery by a specialist. and she was thus transported to the Karl Heusner Memorial Hospital, but according to the family, she did not receive the urgent surgery when she arrived at the KHMH but was placed on a waiting list and given morphine. She will thus be at home for as long as three weeks before the surgery takes place, and the family is distressed about the further harm she could suffer as a result of the delay.

"When she reached to Belize, they told her they would just give her morphine for the pain, bandage her hand, her leg, and they told her they would not be doing any surgery and that she would be on a waiting list and this surgery could potentially take place until end of month's time. Now, she's a 20-year-old with her whole life there — what if any complications happen, infections, happen. She has a broken leg, a broken hand, and all you can do is just bandage it? We need reasons as to why she's on a waiting list....telling us a waiting list, telling a mother who had previously went through a loss that her next child is there crying out of pain and all you could give her is morphine to put her to sleep, and if she gets addicted to this drug, what are we going to do?," a relative of Marokin lamented to *7News*.

The family is reportedly seeking possible assistance from other medical facilities or private practitioners and is asking the Ministry of Health to intervene.

The fourth injured student, Jaheem Williams, was reportedly in and out of consciousness and reportedly received an emergency CT scan when he was taken to the Karl Heusner Memorial Hospital.

Teachers are going through a very difficult time coming to accept the fact that he is no longer with us. In the history of our school, this is the second student we have lost [in] the fifteen years we have been in operation. Some teachers couldn't really have a class, especially his homeroom had to undergo some sessions with the counselor during the course of the day because they were very unstable and could not concentrate," he said.

According to Riveroll, Vargas would routinely be at home after classes at 2:30 p.m., but on the day of the accident, Vargas contacted his mother to inform her that he would be late, as he needed to stay and prepare for a presentation at school. He was to have called his mother at 3:30 p.m. to notify her of his arrival so that she could pick him up at My Lights, but it was a call that she would never receive. Dr. Riveroll mentioned to local reporters that Vargas was very active in the community. He recently participated in the Corozal Carnival and was a wellknown athlete who played for Pelican FC, an amateur football club in Corozal.

AMANDALA was able to speak to a teammate of Vargas, Abner Itzab, who told us that the two were both members of the Pelicans FC and that their bond grew when they became classmates at CEMJC.

Itzab said that Vargas had the drive to become the best player on the team, but was also willing to assist his friends both on the football field and in the classroom.

On Wednesday, October 12, the Ministry of Health and Wellness sent its condolences to the family and friends of those affected by the tragedy via a press release and strongly condemned irresponsible driving on the highways.

The Director of Public Prosecution's office will issue recommendations on whether charges will be brought against any of the drivers in connection with the collision.

in terms of the situation in England, no special status for the city of London. It's about time that the city of London gives up its imperial dreams and be forced to live under a regulated system in which none of them have any real experience, because they're so used to running governments and running central banks.

Now, the last question is: what do you make of the announcement by OPEC that they're going to reduce the production of oil? This was played up in the media as a rejection of an appeal from Biden, a slap in the face to the United States. So, why was this done? Well, as we've been reporting, much of the world is rejecting the sanctions policy of the western governments as well as the Green New Deal policy, which simply says fossil fuels are polluting, are causing man-made climate change and have to be shut down. That's a hard sell for the West to convince the Saudis to do that, but the reduction of production is partly oriented toward making sure the prices are sustained, because if you dramatically increase production and distribution of oil, the Saudis fear that this might reduce their profit, but more importantly, there's a shift away from the unipolar superpower order where the United States and London can order nations what to do. Now, we're seeing something fairly interesting occurring: the Biden Administration is now appealing to Venezuela, which the U.S. has been engaged in a bipartisan commitment to overthrow the government there and the sanctions from the United States are estimated to have killed between 40 and 50,000 people. Now, the United States is going to Venezuela because they need oil, and especially, they're trying to get a deal for Chevron. So, you can see the desperation. We saw it in Germany when Chancellor Schultz went to the Middle East to make all kinds of promises and to beg for natural gas and liquefied natural gas and oil and came back basically empty-handed. Again, the solution is not to look for special deals for your country but to recognize that the global financial system is broken; the Great Reset is rejected by most countries because it's based on taking away their sovereignty, and as long as you have countries such as Russia and China which can stand up against these demands, then, you'll see support coming from countries like Indonesia, from Brazil, from the oilproducing countries which are looking for a consistent commitment to real physical economic production and being paid for their products with real money as opposed to funding money.

And so, I think the important thing here is not so much the question of are the Saudis rejecting Biden; most of the world is rejecting the demands for sanctions against Russia, and countries are looking at how they can move away from submitting to the unreasonable and unacceptable demands coming from the sole superpower backed by the military force of the United States and NATO. The new Electronic Passport

Issuance and Control System (e-PICS) will grant Belizeans the use of an epassport, which features an electronic chip that stores necessary personal information and a passport photograph. According to Minister Courtenay, the passports will be efficient and fully secure thanks to the biometric verification features with which the chips will be equipped.

Amandala reached out to the Ministry of Immigration for confirmation of the new passport prices, but we are still awaiting a response.


