A leaked Government of Belize circular dated September 8, 2022, has revealed that, on July 1 of this year, approval was given for an increase in living and entertainment allowances from \$750.00 to \$1,500.00 monthly for chief executive officers in various Cabinet ministries. It is a revelation that has not been received well by much of the Belizean public, especially public officers whose salary increments are still

When asked about the matter and how such an increase in allowances can be justified, considering the current state of the country's finances, Prime

Minister Hon. John Briceño responded that the apparent increase is simply a reinstatement of the allowances that the CEOs had been receiving in May 2020, following a period during which their allowances had been reduced. The circular, sent by the Cabinet Secretary, Stuart Leslie, indicates that the reinstatement took effect on July 1,

Coast Guard officer charged with arson


BELIZE CITY, Wed. Oct. 26, 2022

Emmanuel McFadzean, 30, a resident of Double Head Cabbage Village, Belize District, who has been a member of the Belize Coast Guard for 12 years, has been criminally charged with three counts of arson for allegedly causing a fire that destroyed a 38-foot Boston Whaler belonging to the Belize Coast Guard, which was dry-docked on the Coast Guard compound at Mile 5 on the George Price Highway for maintenance.

According to Tuesday's issue of the AMANDALA, shortly before 8:00 p.m. on Saturday, October 22, just before a fire flared up on the vessel, a few members of the Coast Guard had seen someone exiting the vessel, and moments later they saw the vessel in flames.

McFadzean is facing charges for the damage done to three vessels—one count of arson for the damage that the fire caused to a 38-foot boat and two 200 Yamaha outboard engines; another count of arson for the damage done to a 38-foot Colombian boat, which was in the care of the Coast Guard; and one count of arson for the destruction of the Boston Whaler and three 250 Mercury outboard engines.

On Tuesday, October 25, McFadzean, who, according to some reports was allegedly stealing fuel from the Boston Whaler when the fire started, was charged in the Magistrate's Court, where he appeared along with his attorney, Richard "Dickie" Bradley, who is being assisted by another attorney, Leeroy Banner. The

Senior Magistrate explained to him that the offense is an indictable one for which he will be tried in the Supreme Court, where his plea would be taken.

McFadzean was granted bail in the sum of \$10,000 plus two sureties of \$5,000 each. He must report every Friday to the Ladyville police station between 6:00 a.m. and 6:00 p.m. and surrender all his travel documents.

Some reports have suggested that there has been an active gas theft ring among some members of the Coast Guard. However, when AMANDALA asked RearAdmiral Elton Bennett, Commandant of the Belize Coast Guard, about such reports, he stated that he is unaware of the operation but that there have been incidents of theft.

Mud Street resident killed in the Jane Usher Blvd. area

Shortly after 6:30 p.m. on Monday, October 24, Calvin Palma, a 32-year-old fisherman who resided on Mud Street in the Jane Usher Boulevard area, was fatally shot in front of a shop at the corner of Curl Thompson Street and Mud Street, just a few houses away from his home.

According to police reports, Palma went to a nearby shop to make a purchase, and on his way back, an unknown gunman approached him and fired as many as 7 shots in his direction, then fled the scene. Palma's motionless body was later seen in a small drain.

Palma has a very extensive criminal past. Back in 2004, when he was only 14 years old, he was charged with attempted murder for stabbing Lewis Hamilton. Previous attempts had also been made on his life. In 2009, he was a victim of a drive-by shooting on Nurse Findley Crescent. Also, in that same year, he was charged for possession of an unlicensed firearm and ammunition.

In 2020, he was among a group of Belize City men who were sought by police for detention under a state of emergency.

Calvin Palma is the third member of his family to be executed in a span of 4 months. In June, Palma's younger brother, Iwin Palma, 24, was fatally shot in Ladyville, and last month, the body of his uncle, Philip Palma, 55, who had been reported missing, was found buried in a shallow grave.

Ricardo Palma, the father of Calvin Palma, told *7News* that he last spoke to his son last month when they were in search of his brother, and his son had told him that he was changing his life.

"... When I spoke to him, he always tell me, 'Dad, I've been through so [many] problems. I'm trying to change my life.' But I don't know if this is the way he means to change his life, I don't know," he said.

The common-law wife of Palma, with whom he had been in a relationship for 4 years, also told local reporters that Palma had put his life of crime behind him and had become a family man.

Butane tank explodes in Battlefield Park

On Wednesday morning, October 26, a butane tank exploded at around 10:45 a.m. at the Fish and Chip's food stall at the Battlefield Park in downtown Belize City and caused injuries to two of the cooks at the stall – Danica

Rowland, 40, and her sister, Shantel Andrew, 30, who were burned on their hands and feet.

According to initial police reports, while butane company workers were at the establishment filling the stall's tank, one of the cooks tried to check the stove by igniting a spark. That caused flames to burst forth, which was followed by a mini explosion. Then, when the butane company workers attempted to remedy the situation by detaching the gas hose from



the fryer, a much larger blaze flared up.

The fire was ultimately "outed" when they turned off the gas valve, and it was later discovered that a hose connected to the tank was not properly sealed and was leaking—which created the circumstances that led to the fire when the tank was filled.

Rowland and Andrew received burn injuries to their hands and feet and drove themselves to the Karl Heusner Memorial Hospital, where Rowland remained admitted for treatment.

reportedly took care of his common-law wife's kids and recently moved to the Jane Usher Boulevard area about 5 months ago.

So far, two men have been detained for questioning by police in connection with Palma's death.

A new sister city for Belize

BELIZE CITY, Wed. Oct. 26,

The city of Angleton, Texas, has a population of over 19,400 and is located in Brazoria County, just a stone's throw away from Houston. As of this month, the small Texan city and the Old Capital (Belize City) are officially sister cities.

Last week, a delegation led by Mayor Bernard Wagner travelled to Angleton to meet with its

mayor, Jason Perez, and the president of the Brazoria County Hispanic Chamber of Commerce, Ms. Gina Aguirre, who made the connection between the two cities possible, along with a host of councilors of that city council and the city manager, Chris Whitaker.

That delegation included members of the Belize City Council, Stephanne Hamilton and Kaya Cattouse, as well as the City Administrator Stephanie Lindo-Garbutt and a number of representatives from the education, tourism, business, youth, and sports sectors.

On Monday, October 17, the group received a Texas welcome from Mayor Perez and his team, followed shortly

after by a tour of the city's parks and recreation areas. According to the Belize City Council, their hosts provided them with "key insights into fostering inclusive and resilient communities." The delegation also got a chance to visit Angleton High School, where they were treated to lunch, courtesy the school's culinary students, and were granted a tour of the facilities.

Mayor Wagner told Angleton reporters that he was impressed by the high school's Career and Technical Education Center, stating, "It's awesome

City. They are our future and backbone of any nation."

The following day, representatives held fruitful discussions around the topic of college education. President of the University of Belize, Dr. Vincent Palacio, gave a presentation on the national university and also had the opportunity to learn about Angleton's Brazosport College, via a presentation by that college's president, Dr. Vincent Solis. The group

discussed the possibility of having student and staff exchanges between the two institutions.

Later that day, both parties signed the official sister city agreement, the duration of which, said Angleton City Manager Chris Whittaker, is "forevermore."

Several months ago, Whittaker approached Brazoria County Hispanic Chamber of Commerce president, Gina Aguirre, in search of a potential international partner. Aguirre, according to Angleton news reporters, already had Belize in mind.

"We talked a little bit about how the two cities have similarities. They had to come up with the bio of the city and an overview of what the city is ... We have an international ambassador that specializes in sister cities. He called me the next day and said he was flying to meet with the Belize ambassador," she said.

Shortly after that, in May, the mayors of both cities met via Zoom.

With the signing of the sister city contract, Belize City and the City of Angleton have agreed to collaborate meaningfully for the development of both cities in areas such as art, commerce, disaster risk management, technology, sports, public health administration, and technical and vocational education.

The signing was followed by a celebratory toast. This year, Belize also established sister city relations with Newark, New Jersey.


Elise-Gayonne Vernon, 21-years old, will be representing her village of Biscayne

enforcement agencies on October 6 and 7 will be held by the Financial Intelligence Unit, pending an investigation into allegations of money laundering, tax evasion, and human trafficking. The attorney representing the company in its attempt to prevent the FIU from seizing the funds, former prime minister Dean Barrow, has called on Magistrate Rogers to state the case to the Supreme Court, in order for that higher court to hand down a determination on the matter.

This is a process that will take place over a period that will likely stretch beyond three months—meaning that the company will nonetheless be bereft of funds needed to cover its operational expenses for an extended period. Barrow has acknowledged that this is the case and said that the company has had to secure bridge financing in order to keep its operation afloat. "They've said they had to go and borrow money at, I don't know the rate of interest, but no doubt extortionate, but they've done that, and so they continue to operate. It is still one hell of a strain, and they are being prejudiced, but they are going to be able to survive ...," he said.

Barrow noted, however, that the application will set the stage for a constitutional claim for his clients against the government of Belize.

"Look, in my view, this magistrate was never going to do other than accede to the application for continued detention, so nothing is lost by getting ahead, and we would have to go to the Supreme Court. Nothing is lost by getting a head start on now. By the time we get to the Supreme Court, as I said the application she is considering will be moot, because 3 months would have passed, but we will then have the chance to establish that she proceeded absolutely wrongly ... and that if she proceeded correctly, either her procedure is unconstitutional or the law permitting such a procedure is unconstitutional. Either way, my clients will be then be entitled to demand and receive redress," Barrow explained.

Attorney for the FIU, Godfrey Smith, says that a case to decide an interim matter has been blown out of proportion by the company and its attorney. He said that the FIU had simply sought to hold on to the cash temporarily pending its tax evasion investigation, and the company had not been facing any imminent forfeiture of the money to the government. While he said that neither guilt nor innocence are being determined in this proceeding, the company, which manufactures "Mine Beer" and whose owner was charged for

It has been over a week since fifteen-year-old Arthur Thomas of Gardenia Village, Belize District, was injured when one section of a wooden house that was being transported on a trailer on the Philip Goldson Highway hit him while he was heading towards Sandhill

Village on his bike around 4:00 in the afternoon on Tuesday, October 18.

According to local media reports, Thomas was traveling in the direction of Belize City, the same direction in which the trailer was headed, when planks of wood that were projecting from the sides of the structure hit him. After he was hit, Thomas, who was in an unresponsive state, was quickly transported to the Karl Heusner Memorial Hospital, where he received treatment.

He was discharged later that same day. When he was subsequently examined at a private hospital, however, his family was told that Thomas must undergo an emergency life-saving surgery, as doctors discovered that he was suffering from



internal bleeding and had suffered from bone fractures as a result of being hit.

Thomas's father, Fred Thomas, told us that the family had to pay a \$1,500 deposit before his son was admitted at the private facility. He further explained that he had reached out yesterday, Wednesday, October 26, to the company that was carrying the wooden structure which hit his son, but so far they have been unable to access funds to cover medical costs through the company's insurance scheme.

Currently, Fred Thomas is searching for a facility in the region that can conduct surgery on his son before resorting to making a trip to the United States. Persons wishing to assist can contact him at 672-6378

Eruptions nightclub managers charged for admitting minor

Mirna Portillo, 44, and Hector Choj, 51, managers of one of the most popular nightclubs in Belize, Eruptions Nightclub, which is situated at Mile

11½ on the Philip Goldson Highway, have been criminally charged for admitting a person under 18 years of age—a 17-year-old female minor—into the club, which is an offense under the Liquor License Act, Section 44(3b), Chapter 150. That same minor was allegedly drugged following her entry into the club and was subsequently raped sometime between Friday night and Saturday morning. She was later seen walking on the highway in a partially nude state after she awoke in a vehicle wearing just her underwear after seemingly losing consciousness.

The female minor had reportedly attended a wake in Ladyville on Friday night, October 21, but then went to the Eruptions nightclub with some friends later that night and consumed a few drinks before becoming unconscious.

When the minor awoke at about 7:00 the following morning, she was partially nude inside a vehicle approximately a mile away from the nightclub. The minor reportedly told police that she had no recollection of the events that occurred after she had a few drinks at the nightclub, but she noted that she had been robbed



and raped.

The man accused of raping her, 25-year-old Michael Llewellyn Flowers, appeared represented on Monday, October 24, in the Belize City Magistrate Court, where he was charged with one count of rape. Flowers has said that the victim was intoxicated, but he insisted that the intercourse he had with her was consensual. Flowers was remanded to the Belize Central Prison and is scheduled to return to court on December 29.

Mima Portillo told a local media outlet that she ascertained, upon reviewing security footage that was recorded on the night of the incident by the club's cameras, that the female minor did not purchase any drinks and entered the establishment already intoxicated.

The management of the Eruptions nightclub released the following statement. "The club does not encourage underage drinking nor allow minors within the establishment... The management takes this time to notify all customers that a form of identification must be presented at all times before entering the club."

As the UDP sinks, the orchestra plays!

Just when you think one couldn't go any farther than rock bottom, they prove you otherwise! And here, I am referring to the ongoing anarchy that continues to prevail and reign supreme inside the loyal opposition, United Democratic Party. They are our sworn opposition who are tasked and charged with the fiduciary responsibility to be guardians of our democracy and watchdogs over the political process through which the government executes plans and manages our affairs. So we can't turn a blind eye to this inability to get their act together and serve their best in their capacity. It's our business, and the opposition is failing, and it's failing badly, and thus we must speak of it and be concerned about what is taking

When I objectively survey the state of the affairs within the UDP, where a stable democracy is concerned as a viable opposition, it's not going to happen anytime soon, nor in the foreseeable future.

Behind the troubles of Afro-Belizeans

Afro-Belizeans living in Belize – the Creoles/Kriols and Garinagu — have never had much economic power, and for decades their fortunes have been dwindling. The Creoles (Kriols) comprise less than 25% of our population, but in 2017, 50% of persons serving time in Belize's main jail were from that group. The Belize Crime Observatory listed the 2021 murder rate in the area of Belize where the most Afro-Belizeans live, as being a staggering 72.64 per 100,000. Insincere or naïve Belizeans tell Afro-Belizeans to pull themselves up by their bootstraps. Sincere Belizeans, and fortunately there're many of them in our beautiful country, want to find out what's going on with their brothers and sisters, and how they can form links to help them improve their condition.

It's important for people to observe what's going on around them, so they can learn and emulate the good things they see in their neighborhood, and avoid the bad things. While observing what's going on with their neighbors, people must keep a firm grip on themselves, so they don't fall victim to pride, if they are more successful than their neighbors, or envy, if their neighbors have more than they have.

Things were simple when countries were peopled by a single group (tribe). But there has never been a nation without problems. There will always be divisions among individuals and peoples—divisions over religious beliefs, political beliefs, economic policies, wealth distribution, social positions, and the location where people live (rural vs urban). In countries that have more than one group, race and cultural issues are added to the mix.

In our Belize, we have more than a fair share of differences to divide us, if we allow them to. It is hard to pin down which of the potential

dividers is the most volatile in the rest of the world. We have seen so many countries split apart over political, economic, and religious differences, and along tribal lines. Our country is blessed with many groups, and we boast to the world about the harmony that exists here; indeed, we have had a fairly long run of peace between and among our many groups, but having seen what has happened in other parts of the world, we have to know that if we don't work at it, things could fall apart.

Ask any Belizean to tell you which group is the hardest to deal with, and they will unfailingly say, Afro- Belizeans, particularly the Creoles/Kriol. A number of non-Afro groups in Belize came here to escape war, poverty, or religious persecution, so few are strangers to hardship. Even the Mayan groups, the original peoples of this land, many of them are here because within the borders demarcated by the European conquistadors, they were oppressed. While nearly all of our groups have experienced troubles, none face the unique hardships of the Afro-Belizeans.

Briefly, since the Europeans introduced a blond, straighthaired, blue-eyed, thin-lipped, narrow-faced man as God, people

of African descent, being farthest from that phenotype, have been maltreated and maligned. The fact is that Jesus the Christ, direct son of God or prophet, did not look like the picture painted by the Europeans, but they have used their world dominance attained via the barrel of the gun to impose their bias.

Briefly, the modern Belize was built on the backs of people who were predominantly of Afro-ethnicity. Naturally, over time the percentage of Afro-descendant people in the population has diminished because Belize is surrounded by countries peopled by Maya and Mestizos, the latter also called Hispanic.

Natural phenomena, as we are seeing with climate change, play an important role in the movement of peoples. In 1961, Hurricane Hattie, a cataclysmic storm that was tracking north, away from Belize, made an unexpected turn to the southwest, a turn that had epochal ramifications, particularly for Afro-Belizeans. Belize City, Gales Point, Mullins River, and Dangriga (then Stann Creek Town), the population centers with the highest concentration of Afro-Belizeans, were devastated. Around 70% of Belize City was destroyed; the US opened its borders for Belizeans left destitute by the storm, and there was a massive exodus of Belizeans, mostly Afro-Belizeans, from our shores.

Afro-Belizeans have watched their percentage of the legal population decrease further over the years— in the 1980s when thousands from neighboring countries took refuge here to escape civil wars, and this year, when an amnesty for people who are here illegally will cause their percentage of the population to fall even more. For many Afro-Belizeans it is taking some getting used to, the number of places that are being taken over by faces different from theirs.

Consider what happened after slavery "ended". We entered the age of colonialism, and the Afro population (Creoles/Kriols) was groomed to serve the colonial masters in the public sector – as public servants, teachers, police officers. Meanwhile, the colonial government started focusing on agriculture, as the forest stock in a forestry-dominated economy had been severely depleted. A small segment of the Afro population engaged in the productive sector, those in the rural areas in agriculture, and those who lived on the coast, in fishing. The majority of Afro-Belizeans, locked in the main urban area of the country, now find themselves competing for scarce jobs with new Belizeans who accept wages that are the bare minimum.

Jobs as laborers in agriculture are available, but unattractive to the urban Afro-Belizean because living conditions on farms are poor, and wages are of necessity low, so that our raw products can compete on the world market. Added to the unattractive wages and poor living conditions is the fact that farm owners prefer pliant foreign laborers, who come to work on seasonal work permits.

By no means are Afro-Belizeans the only group that is stressed. The Afro groups have reason to complain, but so do the other Roots groups. For example, the grocery business was dominated by our Mestizo group, and they have lost their share of that to the Asian group that arrived after Belize began selling economic citizenship in the 1980s.

Things can only be well if all are getting a sufficient share of the pie. It is the worst of times for Afro-Belizeans, because not only are they experiencing serious economic woes, but violence, mainly triggered by poverty and the US drug war, is stymying the group's efforts to thrive. Bullets are flying, and the young men, young women and children too, are falling. In this violent environment, Afro-Belizean entrepreneurs are trapped, unable to give their all in pursuit of their daily bread on streets that have been taken over by thugs. Parents live in fear every moment their children are outside of their homes.

Afro-Belizeans have every reason to call on the country's political leaders to help the group overcome their troubles. Afro-Belizeans can't look for other groups to "put out" for them; some of them have problems too, but it's important for other groups to have a better understanding of their Afro brothers and sisters, because we share this space and we are all Belizeans.

Belizean-American inventor André Gray tops *London Defender'*s "Power 100" list

Gray, hailed as the Godfather of Internet Inventions, has topped the London Defender's "Power 100" Most Influential People in the World list, which took an astounding four months to compile.

BELIZE CITY, Tues. Oct. 25, 2022

Without many of the inventions of Belizean-American André Gray, social media as we know it would not exist. He is credited with being responsible for at least 80% of how smartphones and the internet work and has been hailed as the world's No. 1 inventor every year for the past 33 consecutive years.

The Godfather of Internet Inventions, as he is often called, is credited with a number of revolutionary innovations that have helped to shape the world of technology. Take the voicemail icon, displayed on every single mobile phone ever made, for example. He designed it in 1988. That year, he also created the world's first internet bot, inkling, complete with artificial intelligence.

Gray's inventions also include

Retrogrooves, the world's first DJ software (1989); Microgrooves-E, the world's first mobile phone multimedia player (1998); Online Music Sales Certifications (1999), and much more—all of which went on to shape the world of online digital media, including social media, an industry that is now worth trillions of dollars.

Having had a curious mind for as long as he could remember, Gray says that the inventor's life chose him, rather than the other way around. His father, Joseph Gray, was an attorney and his mother, Eleanor, a stay-at-home mom for much of his younger years. In 1981, at the age of 15, he migrated to the United States.

In a December 2021 interview with the *Los Angeles Tribune*, Gray remarked that when it comes to money, his views are aligned with those of Nikola Tesla. Tesla was known for wanting to improve the lives of people—for free—and did not care much about personal profit. Likewise, Gray, as per his Twitter bio, firmly believes in open source and inventing for the benefit of humanity rather than primarily for profits.

According to the *London Defender*, in the process of creating their "Power

100" list, they opted to avoid "superficial inclusion" of world famous celebrities and instead chose seriousminded people "who are really making an indelible impact upon the world now." And while the writers and editors at the *Defender* took an astounding four months to deliberate on who would be on their official list, the number one title was almost a given.

"If there is one true unassailable genius in the world today, it is this great inventor," stated the *London Defender*.

Other notable figures on the Power 100 list include Barbados Prime Minister, Mia Amor Mottley at the sixth position; Ren Zhengfei, the founder of the Huawei phone company, who holds

Accommodation for your accommodations?

The Hotels and Tourist Accommodation Act, Chapter 285 of Laws of Belize, is very specific about everything tourism related. The Law includes specifics about establishments such asrooms, apartments, apartment studios, condominiums, and vacation homes that are rented to local or foreign tourists. As the statutory body representing the Ministry of Tourism and Diaspora Relations, the BTB is intentional about ensuring that industry standards, pertaining to accommodation rentals, areunderstood and upheld. These standardssafeguard that service remains consistent across all aspects of theBelize Tourism Product. Accommodations are animportantcomponent of any visitor's experience, therefore; they must be standardized. The BTB Hotel Amnesty Program was designed with tourists' accommodations in mind.

Why Amnesty? With new platforms such as Airbnb, VRBO, Vacasa, HomeToGo, and Homestay, it is easier now to create short term rentals than ever before. The ability for anyone to create rentals and increase overnight stays is a plus for Belizetourism, however those accommodations must be registered and licensed to operate within the industry. Some proprietors, particularly those who started their operations during Covid-19, may have neglected to consult with the BTB and local Lawsto better understand their obligations and important role in the industry. The legal responsibilities of those wishing to rent to touristsare clear under the Hotel



and Tourists Accommodation Act. Therefore, as a part of its recovery strategy, the BTB and the Government of Belize (GOB), created this programfor anyone who has already opened tourists' accommodation properties (primarily rooms, apartments, apartments studios, condominiums, and vacation homes) but have not yet legallyregistered their operations. Importantly, this program helps renters avoid future legal and taxation penalties. Additionally, under the BTB Hotel Amnesty Program, these properties can become official members of the Belize Tourism offer and access all the resources and support available to them through the BTB.

The word "amnesty" has been in use since the late 16th century. It can be defined as "a ruling authority's pardon of past offence". The BTB does not regard new accommodations for local and foreign tourists as an offence. However, the organization is responsible to ensure that all travelers, foreign or domestic, renting in Belize can expect asafe and consistent experience across the industry and across the country. The GOB has decided to remit arrears. Their entire approved Accommodation Tax (Remission or Arrears) Bill, 2022 is the proof. Sign up now and taxes owed will be forgiven. It is essentially, a legal accommodation for unlicensed tourists' accommodations. Even more accommodating, is that applicants are given the entire month of October to apply to the Registrar of Hotels for amnesty, but they have until December 31st to complete the licensing process once they are approved.

Victor Hugo once said of amnesty that "it is as good for those who give it as for those who receive it- it has the admirable quality of bestowing mercy on both sides". The BTB Amnesty Program will benefit all parties concerned. For this reason, the -ism we underscore this week is "Altruism" because sometimes it's not all about the bottom line. A little goodness in business can go a long way. For the GOB, pardoning legally owed taxes in this case is an act of good will. For the public, applying for proper licensing is an act of trust. For the BTB, creating the program is a practice of good ethics and faith for its stakeholders. To apply for the program, download the application athttp://bit.ly/3xVCTgH.



Detrás de los problemas de los afrobeliceños

Los afrobeliceños que viven en Belize, los criollos/*Kriols* y los garinagu, nunca han tenido mucho poder económico y, durante décadas, sus fortunas han ido disminuyendo. Los criollos (*Kriols*) comprenden menos del 25% de nuestra población, pero en 2017, el 50% de las personas que cumplen condena en la cárcel principal de Belize eran de ese grupo. El Observatorio del Crimen de Belize enumeró la tasa de homicidios de 2021 en el área de Belize donde vive la mayoría de los afrobeliceños, con un asombroso 72,64 por 100.000. Los beliceños insinceros o ingenuos les dicen a los afro-beliceños que se levanten por sus propios medios. Beliceños sinceros, y afortunadamente hay muchos de ellos en nuestro hermoso país, quieren saber qué está pasando con sus hermanos y hermanas, y cómo pueden formar vínculos para ayudarlos a mejorar su condición.

Es importante que las personas observen lo que sucede a su alrededor, para que puedan aprender y emular las cosas buenas que ven en su vecindario y evitar las cosas malas. Al observar lo que sucede con sus vecinos, las personas deben controlarse firmemente a sí mismas, para no ser víctimas del orgullo, si tienen más éxito que sus vecinos, o de la envidia, si sus vecinos tienen más que ellos.

Las cosas eran simples cuando los países estaban poblados por un solo grupo (tribu). Pero nunca ha habido una nación sin problemas. Siempre habrá divisiones entre individuos y pueblos: divisiones sobre creencias religiosas, creencias políticas, políticas económicas, distribución de la riqueza, posiciones sociales y el lugar donde vive la gente (rural versus urbano). En los países que tienen más de un grupo, se agregan a la mezcla cuestiones raciales y culturales.

En nuestro Belize, tenemos más que una buena cantidad de diferencias para dividirnos, si lo permitimos. Es difícil precisar cuál de los divisores potenciales es el más volátil en el resto del mundo. Hemos visto tantos países divididos por diferencias políticas, económicas y religiosas, y por líneas tribales. Nuestro país está bendecido con muchos grupos, y nos jactamos ante el mundo de la armonía que aquí existe; de hecho, hemos tenido una racha bastante larga de paz entre nuestros muchos grupos, pero habiendo visto lo que ha sucedido en otras partes del mundo, debemos saber que si no trabajamos en ello, las cosas podrían desmoronarse.

Pregúntenle a cualquier beliceño que les diga con qué grupo es el más difícil de tratar, e indefectiblemente le dirán afro-beliceños, particularmente los criollos. Varios grupos no afro en Belize llegaron aquí para escapar de la guerra, la pobreza o la persecución religiosa, por lo que pocos son ajenos a las dificultades. Incluso los grupos mayas, los pueblos originarios de esta tierra, muchos de ellos están aquí porque dentro de las fronteras demarcadas por los conquistadores europeos, fueron oprimidos. Si bien casi todos nuestros grupos han experimentado problemas, ninguno enfrenta las dificultades únicas de los afrobeliceños.

Brevemente, desde que los europeos introdujeron como Dios a un hombre rubio, de cabello lacio, ojos azules, labios delgados y rostro angosto, las personas de ascendencia africana, que son las más alejadas de ese fenotipo, han sido maltratadas y difamadas. El hecho es que Jesús el Cristo, hijo directo de Dios o profeta, no se parecía al cuadro pintado por los europeos, pero ellos han usado su dominio mundial alcanzado a punta de pistola para imponer su parcialidad.

En pocas palabras, el Belize moderno se construyó sobre las espaldas de personas que eran predominantemente de etnia afro. Naturalmente, con el tiempo el porcentaje de afrodescendientes en la población ha disminuido debido a que Belize está rodeado de países poblados por mayas y mestizos, estos últimos también llamados hispanos.

Los fenómenos naturales, como estamos viendo con el cambio climático, juegan un papel importante en el movimiento de los pueblos.

En 1961, el huracán Hattie, una tormenta catastrófica que avanzaba hacia el norte, alejándose de Belize, dio un giro inesperado hacia el suroeste, un giro que tuvo repercusiones trascendentales, en particular para los afrobeliceños. La Ciudad de Belize, Gales Point, Mullins River y Dangriga (entonces el Municipio de Stann Creek), los centros poblacionales con la mayor concentración de afrobeliceños, quedaron devastados. Alrededor del 70% de la Ciudad de Belize fue destruida; EE. UU. abrió sus fronteras para los beliceños que quedaron en la indigencia por la tormenta, y hubo un éxodo masivo de beliceños, en su mayoría afrobeliceños, de nuestras costas.

Los afrobeliceños han visto disminuir aún más su porcentaje de la población legal a lo largo de los años: en la década de 1980, cuando miles de personas de países vecinos se refugiaron aquí para escapar de las guerras civiles, y este año, cuando una amnistía para las personas que están aquí ilegalmente hará que su porcentaje de la población disminuya aún más. A muchos afrobeliceños les está costando acostumbrarse a la cantidad de lugares que están siendo ocupados por rostros diferentes al suyo.

Consideren lo que sucedió después de que la esclavitud "terminara". Entramos en la era del colonialismo y la población afro (criollos) fue preparada para servir a los amos coloniales en el sector público, como servidores públicos, maestros, policías. Mientras tanto, el gobierno colonial comenzó a centrarse en la agricultura, ya que la reserva forestal en una economía dominada por la silvicultura se había agotado gravemente. Un pequeño segmento de la población afro se dedicaba al sector productivo, los del área rural a la agricultura y los que vivían en la costa a la pesca. La mayoría de los afrobeliceños, encerrados en la principal área urbana del país, ahora se encuentran compitiendo por los escasos trabajos con los nuevos beliceños que aceptan salarios mínimos.

Los trabajos como trabajadores agrícolas están disponibles, pero no son atractivos para los afrobeliceños urbanos porque las condiciones de vida en las fincas son malas y los salarios son necesariamente bajos, para que nuestros productos crudos puedan competir en el mercado mundial. A los salarios poco atractivos y las malas condiciones de vida se suma el hecho de que los propietarios de fincas prefieren trabajadores extranjeros dóciles, que vienen a trabajar con permisos de trabajo estacionales.

De ninguna manera son los afrobeliceños el único grupo que está estresado. Los grupos afro tienen motivos para quejarse, pero también los otros grupos de la base. Por ejemplo, el negocio de las tiendas de comestibles estaba dominado por nuestro grupo mestizo, y ellos han perdido su parte de eso ante el grupo asiático que llegó después de que Belize comenzó a vender ciudadanía económica en la década de 1980.

Las cosas solo pueden ir bien si todos obtienen una parte suficiente del pastel. Es el peor de los tiempos para los afrobeliceños, porque no solo están experimentando graves problemas económicos, sino que la violencia, provocada principalmente por la pobreza y la guerra contra las drogas de EE. UU., está obstaculizando los esfuerzos del grupo para prosperar. Las balas vuelan y los jóvenes, las jovencitas y los niños también, están cayendo. En este ambiente violento, los empresarios afrobeliceños están atrapados, incapaces de darlo todo en busca de su pan de cada día en calles que han sido tomadas por matones. Los padres viven con miedo cada momento que sus hijos están fuera de casa.

Los afrobeliceños tienen todas las razones para pedir a los líderes políticos del país que ayuden al grupo a superar sus problemas. Los afrobeliceños no pueden buscar que otros grupos velen por ellos; algunos de ellos también tienen problemas, pero es importante que otros grupos tengan una mejor comprensión de sus hermanos y hermanas afro, porque compartimos este espacio y todos somos beliceños.

Early Wednesday morning, I telephoned Clinton Canul Luna in Corozal because I could not remember the name of the second of the treaties that the United States and the United Kingdom (Great Britain) signed in the 1850s, a few years before the U.S. "godfathered" the critical and historic 1859 treaty between Guatemala and Great Britain with respect to the territorial boundaries of British Honduras.

I remembered the Clayton-Bulwer treaty, but could not remember the name of the second treaty.

Luna said to me, "Do you know where I am? I'm in the hospital. I was attacked yesterday by bees in Finca Solana, and some neighbors saved me by lighting fires."

Luna is about 78 years old. If I were liquid the way I used to be, I would try to bring him to Belize City so that he could educate our younger generations on KREM Radio and Television. Young people nowadays don't like to read: they want to write, put things, on social media.

Anyway, old codger that I am, I know enough about the computer to search for information, such as the name of the second treaty, which is Dallas-Clarendon, signed in 1856, subsequent to Clayton-Bulwer, signed in 1850.

As a result of the January 6, 2021 attack by Donald Trump supporters on the U.S. Capitol building in Washington, we learned that the last time that this happened was in 1812, when the British did it.

The history of the relationship between the U.S. and the U.K. has always intrigued me. Since the U.S., then a British colony (thirteen of them, in fact), declared independence from Great Britain in 1776, and, with the aid of the French, fought off the monarchy and established a constitutional, democratic republic, there have been periods when the Americans and the British, whom we have known as the best of friends for many decades, have had occasional disagreements.

In 1823, the U.S. flexed its muscle by declaring the so-called Monroe Doctrine, essentially declaring their hegemony in this Western Hemisphere. Spain had controlled most of the Western Hemisphere after Columbus entered the Caribbean in 1492, but the Spanish were forced to concede independence to Mexico and the Central American republics in 1821. The Central American republics soon broke away from Mexico, and then they began fighting amongst themselves.

In the 1830s, there was a Central American war between the liberal element, led by Francisco Morazan, representing Honduras and Salvador, and a conservative force, led by Guatemala and their Rafael Carrera (supported by the Church), who was president of Guatemala when the aforementioned 1859 treaty was signed.

By 1839,1840, Guatemala and Carrera had defeated Morazan. The British were, of course, all the while ensconced in Belize, but they also controlled the Bay Islands, now the property of Honduras, and the Bluefields territory, which is now Nicaragua's. The treaties of the 1850's constituted pressure on the British by the Americans to cede these territories, while permitting continued British possession of Belize, hence the 1859 treaty, which Carrera signed on behalf of Guatemala. (He died in 1865.)

This week controversy erupted in Belize because of a claim to Belize's Sapodilla Islands by Honduras, who placed that claim a few decades ago in their constitution. This controversy took us Belizean elders back to the 1981 Heads of Agreement, when a clause in that agreement allowed Guatemalans to "use and enjoy" Belize's Ranguana and Sapodilla Cayes. And it took us back to 1991, when Hon. Philip Goldson broke away

from the United Democratic Party (UDP), because the then Opposition UDP's leaders, the late Dr. Manuel Esquivel and Hon. Dean Barrow, were supporting the Maritime Areas Act (MAA) initiative being pushed by the ruling People's United Party (PUP).

There are complications surrounding these breathtakingly beautiful islands which are in the Caribbean Sea about equidistant from the southern land mass of Belize and the northern land masses of Honduras and Guatemala. The complications involve the very strong suspicion that there are massively valuable hydrocarbons in this area of the sea, which includes the point where the maritime rights of Belize, Honduras, and Guatemala intersect.

When you introduce "valuable hydrocarbons" into this discussion, then the monster American oil companies will become very much interested, and the foreign policy of the government of the United States, the most powerful nation in the world, will have to defend the interests of their oil companies.

So then, the Sapodilla issue underlines the fact that we Belizeans feature some articulate attorneys, but a military which is not competitive with those of the two republics which are relevant to the controversy.

In international relations, my understanding from the great Vincent Starzinger at Dartmouth was, I think, that might makes right. Washington, in other words, holds the relevant cards here. Or, this is how it appears to this Starzinger student.


the deal would bring them their very own social partner representative—lock, stock, and barrel.


Honduras claim will extend ICJ timeline

The government is attempting to have Honduras' claim to the Sapodilla Cayes addressed at the International Court of Justice (ICJ) by signing on to the Pact of Bogotá treaty. If no resolution is reached in regard to the claim at the current time, the ICJ may not deliver a final determination regarding rightful sovereignty over certain maritime areas within Belize's territory. As a result of the possible inclusion of Honduras' claim in the case currently before the court, however, the, ICJ's final decision may be delayed by an additional year—or more. The UDP has called for a referendum on the matter.

BELIZE CITY, Thurs. Oct. 27, 2022

Many Belizeans had not been aware that, since 1982, Honduras has maintained a claim to the Sapodilla Caye Range (a cluster of islands located about 40 miles offshore of Punta Gorda in the Toledo District that is said to be "home to the most concentrated area of beaches in all of Belize") in Article 10 of its Constitution. That claim, however, was overshadowed by the aggressive steps

taken by Guatemala to assert a claim over large swaths of Belizean territory, including the Sapodilla Cayes. At this particular juncture, however, following the submission of a memorial and counter-memorial by Belize and Guatemala at the International Court of Justice (ICJ) in an attempt to resolve that country's claim over Belizean territory, Honduras' claim has suddenly become a matter that is of concern—something



that could prevent the ICJ from determining who in fact owns certain portions of Belize's maritime areas, including the Sapodilla Cayes in the southernmost part of the country. This is a specter that suddenly emerged to haunt Belizeans when the Lead Senator for Government Business in the Senate, Hon. Eamon Courtenay, introduced on

Monday a resolution for the country to sign on to a pact that would enable Belize to include Honduras' claim in the matter currently being adjudicated at the ICJ. The undertones of his presentation suggested that it is a serious matterand that a complete confirmation of what is Belizean territory could be at stake.

The 2005 Special Agreement, signed on to by both Belize and Guatemala, has led them to this process of arbitration that is currently underway at the ICJ, in an attempt to "put an end to any and all differences" regarding the ownership of insular and maritime territories. What is now appearing to be a major oversight, however, is the failure to include the Honduran claim over the Sapodilla Cayes Range (which consists of 14 islands, including Hunting Caye, Tom Owens Caye, and Lime Caye, as well as a 39,000-acre section of the barrier reef) in the list of questions posed to the Belizean public in a 2019 referendum which followed an education campaign that was heavily tilted toward ICJ adjudication. Although Belize's legal team is prohibited from disclosing particular details about the case, that team, at this critical juncture, when Belizeans were expecting a final ruling to be possibly two years away, has recommended that Belize accede to the Pact of Bogotá in order to include Honduras's claim with the Guatemala claim that is currently before the ICJ.

Hon. Courtenay stated in the Senate on Monday, "We have been advised by international lawyers that the position of the current case brought by Guatemala against Belize may not result in a final settlement as required and requested by the Belizean people because the Honduran constitution claims

sovereignty over the Sapodilla Cayes." He further explained during that Senate meeting, "We do not believe that the Honduran claim is credible. Because both Belize and Guatemala claim the Sapodillas in the ICJ case, which said cayes are claimed by Honduras in its constitution, it is our understanding that Honduras will feel obliged to intervene in the Belize/Guatemala case, now before the ICJ to assert its claim to the Sapodillas. Madam President, Belize and Honduras have excellent relations. After taking legal advice, we have engaged the Honduran government with a view to negotiating a resolution of their claim to the Sapodillas on the basis of Honduras acknowledging Belize's exclusive sovereignty over the Sapodillas. Regrettably, this has not been successful. If, as we believe is likely, Honduras applies to intervene in the case now before the court, it is likely to affect

Taiwan injects momentum into the global transition to net-zero emissions

Chang Tzi-chin Minister of the Environmental Protection Administration Republic of China (Taiwan)

October 2022

The world has embarked on the transition to net-zero emissions. The innovative approaches to international cooperation highlighted in the Paris Agreement—which calls for wide cooperation by all countries to meet global reduction targets—are gradually taking shape. Taiwan is willing and able to cooperate with international partners to jointly achieve net-zero transition, mobilize global climate action, and ensure a sustainable environment for future generations.

As the world's 21st-largest economy, Taiwan has an important influence on economic prosperity and stability in the Indo-Pacific region. In particular, Taiwan's semiconductor industry

occupies a pivotal position in international supply chains. The industry actively cuts the use of energy resources in its production processes by developing new technologies and new models. Through ever-evolving semiconductor innovations, it has developed numerous smart applications of electronic devices and promoted global energy conservation. Taiwan is carrying out substantial climate actions and vigorously advancing energy transition. As of May 2022, cumulative installed renewable energy capacity had reached 12.3 GW, a significant 60 percent increase from 2016. From 2005 to 2020, Taiwan's GDP grew by 79 percent. Over the same period, greenhouse gas emission intensity fell by 45 percent, demonstrating that economic growth has been decoupled from greenhouse gas emissions.

On Earth Day of April 22, 2021, President Tsai Ing-wen announced

Taiwan's goal of net-zero emissions by 2050. In March 2022, the Executive Yuan published Taiwan's Pathway to Net-Zero Emissions in 2050. The roadmap outlines four major transition strategies in energy, industry, lifestyles, and society. Resting on the twin governance foundations of technology research and development (R&D) and climate legislation, the strategies are supplemented by 12 key sub-strategies. These are wind and solar power; hydrogen; innovative energy; power systems and energy storage; energy conservation and efficiency; carbon capture, utilization, and storage; carbon-free and electric vehicles; resource recycling and zero waste; natural carbon sinks; green lifestyles; green finance; and just transition. By integrating intra-governmental resources, Taiwan will develop a stepby-step action plan to reach its targets.

In building the foundations of technology R&D needed to achieve netzero transition, Taiwan will focus on five areas: sustainable energy, low carbon, circularity, carbon negativity, and social science. The Greenhouse Gas Reduction and Management Act is being amended and will be renamed the Climate Change Response Act. The amendments will make net-zero emissions by 2050 a long-term national reduction target, improve the effectiveness of climate governance, add a chapter on climate change adaptation, strengthen information

disclosure and public participation, and introduce a carbon pricing mechanism. The act will provide economic incentives for emissions reduction, guide low-carbon and green growth, and contribute to completing the foundations of national climate legislation and governance. Taiwan's long-term vision for 2050 is to make the transition to net-zero emissions the new driving force of national development. By creating competitive, circular, sustainable, resilient, and secure transition strategies and governance foundations, Taiwan will stimulate economic growth, encourage private investment, create green jobs, promote energy independence, and improve social well-being.

Due to political factors, Taiwan is excluded from international organizations and cannot participate substantively in discussions on global climate issues. It is difficult for Taiwan to stay abreast of current developments and properly implement related tasks. This will create gaps in global climate governance. Taiwan has limited independent sources of energy and an economic system that is oriented to foreign trade. If it cannot seamlessly link with the international cooperation mechanisms under the Paris Agreement, this will not only affect the process of Taiwanese industries going green but will also undermine the stability of



Workers in France clash with cops during protest for better

Due to the sanctions implemented against Russia, we can have an understanding of the situation that is taking place today in the countries that make up the European Union. The elite neoliberals of the Western world thought that Russia was going to fall on its knees and would have been an easy prey to split and divide it among the participants of such venture. However, after 8 months of a constant war, things have changed, and the optic seems as if the European Union would become colonized by the head or leader of the North Atlantic Treaty Organization. A juicy market for the USA. Nonetheless, permit me, our dear readers of this column, to present to you the below report which I find to be of interest. The

following was posted on YouTube by WION on October 18, 2022, under the heading "Gravitas| France: Workers clash with cops during protest for better pay". It is as follows:

France, Italy, Belgium, Spain. Four leading European economies. All four have witnessed mass protests in recent days. All four happened because of exactly the same reasons: rising food prices, out-of-control energy bills and lower wages, basically, the ongoing cost-of-living crisis. It is now hitting Europe hard. Today, Europe witnessed one more protest, in France. Yes, the European power is quickly becoming a hot spot for these protests. Just look at these visuals. Over the weekend we saw large crowds on the streets of Paris, and

today trade unions took to the streets. There was a massive crowd on the streets of Paris and going by some reports, scuffles broke out between the cops and the protesters. So, what do these protesters want? They are demanding higher salaries. These protests are being called Emmanuel Macron's stiffest challenge yet, but he isn't the only European leader who is facing this challenge. The entire economy of the Euro area is now being tested. Why is the European economy hurting? That's our cover story tonight on Gravitas.

Let me tell you what's happening in France. It was a day of major disruptions. Trade unions called for a nationwide transport strike. The reason,

as I said earlier, is the demand for higher salaries. The unions were holding talks with the government; they remain in a deadlock. The move by the trade unions comes after workers at refineries staged a walkout. This disrupted the distribution of fuel across France. Remember these long lines. For nearly three weeks, drivers struggled to get fuel as several fuel depots were closed down. Even now, French drivers are struggling.

- "It's been two weeks now that the French government says that it will be fixed in the week. What week? We don't know. It's starting to be too long now. We professionals, but also the individuals, we are fed up. Seriously! A solution needs to be found." (Mohamed Mahrouk, taxi driver)

- "I live pretty far in the suburbs, and in the suburbs, there is no petrol at all. I came to Central Paris now to find some. As I am a courier, I need petrol to be able to work, as simple as that." (Samba Cissé, courier)

French president, Emmanuel Macron, was forced to step in. He issued orders and forced some workers on strike to return to work. The negotiations have clearly broken down, because the French government is in no mood to relent. Recently, the French Finance Minister declared the time for talks is now over.

Today's protest is a response from the unions. They are clearly doubling down. Workers staged a protest at prominent areas in Paris. They believe the French government is treating them unfairly. Listening now to what some of the transport workers have to say about this.

- "Today the wages at the RATP for someone who comes in, he comes in a bit above the minimum wage. It's 1400 to 1500 francs, so, it's largely insufficient, given that the company has changed the working conditions since August; we work one or more. I have 15 years seniority at the RATP and I barely get 2,000 Euros." (John Borges, bus driver at RATP)

- "Today, there are several reasons, but the main one is the revaluation of salaries. The index point has been frozen for more than 10 years. It was revalued this year by 2.2 percent, but in the view of the inflation over this year and over the last 10 years, it is not enough for employees." (Bertrand Hammache, General Secretary, CGT RATPUnion)

Now, that's the kind of story you'll hear all around Europe these days, because the region is going through an economic turmoil. Rising inflation is hurting people's pockets. The cost of living has gone up, and the Euro area is finally feeling the shock of Russia's war in Ukraine.

Europe is not the transitory shock. The geopolitical realignment of energy supplies in the wake of the war is both broad and permanent. Winter 2022 will be challenging, but winter 2023 will likely be worse." (Pierre-Olivier Gourinchas, International Monetary

Those words are significant. It isn't a transitory shock. That was the assessment from the International Monetary Fund. Winter is almost here, and protests across the region are intensifying. It seems like people across Europe are already hurting. We showed you these pictures yesterday; again, they are from France. Thousands of protesters hit the streets on Sunday against rising prices. On the same day, there were protests in Rome. Again, people were demanding relief from rising gas and electricity prices. Similarly, there have been protests in Brussels, London, Madrid, and Budapest. All this in recent weeks. The war in Ukraine has tested Europe's solidarity. So far, they have presented a largely united response against Russian aggression, but the crisis within European economies presents a challenge to their unity. And now, to get more perspective, joining me now from Madrid in Spain, is Jamie Martinez. He's an economic advisor. Jamie, thanks for joining us. Now my first question: we're seeing protests across France over the cost-of-living crisis; in fact, Europe is on the boil. We saw some visuals. In fact, do you see this crisis getting worse?

<u>Jamie's response</u> "Yeah, this growth, as I said before, the growth in the level of prices is giving more pressure to the labor and trade unions in France, which now they are asking for higher salaries and announcing nationalized strikes in the country. Of course, this keeps more pressure, and there is a big political risk for the government of Macron, which is now working the national budget for the next year, for 2023, and for sure we can expect that the situation is going to get worse, because the labor unions in France are very strong, and they are going to demand higher salaries, accurate increase, but I think that despite this rig, weights increases should be moderate to avoid an inflationary spiral where the new wages fuel additional price increases."

Right. Jaime, the entire economy of the Euro area is being tested. My question to you is, did experts and analysts anticipate this?

<u>Jamie's response</u> "I think, the European Union, in terms of economy, is now facing a huge risk of recession. As for instance, the United States, it became, it went, into recession in the last semester, but now a European Union is having a lower economic growth in terms of consumption, investment and of course also in terms of exports, because this problem of the inflation is affecting worldwide, but that's why I think to tackle the problem of this high inflation in Europe it is necessary to reduce the public spending of the government. For instance, talking about France and the

international supply chains. public can spend in terms of GDP is a 59, which is very high in comparison with other countries of the OCCD."

Right. You raise some valid points about what needs to be done, but my question now is, what happens from this point on? The French president, Emmanuel Macron, was in fact forced to step in, but talks seemed to have broken down. Is this the beginning of a wider movement, perhaps, similar to the Yellow Vest protests?

Jamie's response - "Well, I will be in there to bet if it's going to be that worse in terms of if this movement

is going to export in the whole continent of Europe, but yes, of course, we can expect more pressure from all the trade unions in Europe, claiming higher salaries, and I think governments in Europe and they will have to respond with more moderation, because of course we can understand that workers are claiming more salaries, but as I said before, we can avoid if we want to avoid inflation and spiral, right, we have to be very moderate with this increase of salary and also, doing so, and maybe reducing the government spending, the

public spending, the fiscal policy of Europe will be in coordination with the monetary policy addressed by the European Central Bank."

Right. Jamie, thanks so much for all those inputs and thanks for joining us on Gravitas. We'll of course continue to get you all the updates of what's happening in Europe, all because of the cost-of-living crisis.

the Belize/Guatemala case. Once the ICJ becomes aware of the claim by Honduras to the Sapodillas, there is a significant risk that the court would not delimit the maritime areas that pertain to the Sapodillas, thereby leaving unresolved a large part of our maritime entitlement. Indeed, the ICJ may decide not to pronounce sovereignty over the Sapodillas as well, even between Belize and Guatemala. This would mean that sovereignty over a very important part of our sovereign domain, the Sapodillas and the maritime areas pertaining to it, will remain unresolved ..."


Since Honduras is not a party to the Special Agreement, they would not be able to be included in the current case at the ICJ; and this would prevent the court from being able to issue a final decision on the sovereignty exercised by the countries over particular pieces of territory. As a result, the Government of Belize decided to seek approval from the Senate for the country to sign on to the Pact of Bogota treaty, also known as the American Treaty on Pacific Settlement. The treaty compels nations of Latin America to resolve disputes peacefully, first exhausting dispute resolution options regionally before going to the United Nations and seeking to have the case heard at the ICJ.

Courtenay stated in the Senate that they have not been able to resolve the Honduran claim, but made no note of specific attempts made in the past or recently to attempt a resolution. "We have been trying to resolve this issue with Honduras and have not been able to successfully resolve it," Courtenay said. Lead UDP senator and former Attorney General, Michael Peyrefitte, remarked in response, however, that, as far as he is aware, Honduras has not made any official moves to assert such a claim or to challenge the sovereignty of Belize.

"Honduras has not expressed in any official way, to my knowledge, that they

have any issue with Belize and the sovereignty of what we know to be Belize. So why drag them in? And in any event, the people went to a referendum with Guatemala in their mind. Now, if it has come to the attention of certain people that we need to make an adjustment to the process to the point where we may bring a third country into this thing, that could extend the process another couple years. That is a decision for the Belizean people." Peyrefitte stated in an interview yesterday.

The UDP has thus called for a referendum on the matter.

The World Health Organization's One Health Initiative seeks to balance the health of humans with that of animals, plants, and the environment that they share—all of which are very intricately linked—through multisectoral collaboration. On Tuesday, the Pan American Health Organization (PAHO), along with the Ministry of Health & Wellness (MOHW) and the World Health Organization (WHO), held the official launch ceremony for Belize's own National One Health Program.

The One Health Program will allow Belize the opportunity to address zoonotic and vector-borne illnesses with never before seen efficiency. According to Dr. Noreen Jack, the PAHO/WHO Representative in Belize, that is because the initiative, made possible through funding from the European Union, will involve the efforts

1776 y, con la ayuda de los franceses, luchó contra la monarquía y estableció una república constitucional y democrática, ha habido períodos cuando los estadounidenses y los británicos, a quienes hemos conocido como los mejores amigos durante muchas décadas, han tenido desacuerdos ocasionales.

En 1823, EE. UU. mostró su fuerza al declarar la llamada Doctrina Monroe, declarando esencialmente su hegemonía en este hemisferio occidental. España había controlado la mayor parte del hemisferio occidental después de que Colón ingresó al Caribe en 1492, pero los españoles se vieron obligados a conceder la independencia a México y las repúblicas centroamericanas en 1821. Las repúblicas centroamericanas pronto se separaron de México y luego

comenzaron a luchar entre ellas mismas.

En la década de 1830, hubo una guerra centroamericana entre el elemento liberal, dirigido por Francisco Morazán, que representaba a Honduras y El Salvador, y una fuerza conservadora, dirigida por Guatemala y su Rafael Carrera (apoyado por la Iglesia), quien era presidente de Guatemala cuando se firmó el mencionado tratado de 1859.

Para 1839,1840, Guatemala y Carrera habían derrotado a Morazán. Los británicos estuvieron, por supuesto, todo el tiempo instalados en Belize, pero también controlaban las Islas de la Bahía, ahora propiedad de Honduras, y el territorio de Bluefields, que ahora es de Nicaragua. Los tratados de la década de 1850 constituyeron una presión sobre los británicos por parte de los estadounidenses para que cedieran estos territorios, mientras permitían la continuación de la posesión británica de Belize, de ahí el tratado de 1859, que Carrera firmó en nombre de Guatemala. (Él murió en 1865.)

Esta semana estalló la controversia en Belize debido a un reclamo de las Islas Sapotillos de Belize por parte de Honduras, quien colocó ese reclamo hace unas décadas en su constitución. Esta controversia nos llevó a los ancianos beliceños a los Preámbulos del Acuerdo de 1981, cuando una cláusula de ese acuerdo permitía a los guatemaltecos "usar y disfrutar" de los cayos Ranguana y Sapotillos en Belize. Y nos llevó de vuelta a 1991, cuando el Honorable Philip Goldson se separó del Partido Demócrata Unido (UDP por sus siglas en inglés), porque los entonces líderes de la Oposición UDP, el finado Dr. Manuel Esquivel y el Honorable Dean Barrow, estaban apoyando la iniciativa de la Ley de Áreas Marítimas (MAA por sus siglas en inglés) impulsada por el gobernante Partido Unido del Pueblo (PUP).

Hay complicaciones en torno a estas islas de una belleza impresionante que se encuentran en el Mar Caribe, aproximadamente equidistantes de la masa terrestre del sur de Belize y las masas de tierra del norte de Honduras y Guatemala. Las complicaciones involucran la sospecha muy fuerte de que existen hidrocarburos de gran valor en esta zona del mar, que incluye el punto donde se cruzan los derechos marítimos de Belize, Honduras y Guatemala.

Cuando se introduce "valiosos hidrocarburos" en esta discusión, entonces las monstruosas compañías petroleras estadounidenses se interesarán mucho, y la política exterior del gobierno de los Estados Unidos, la nación más poderosa del mundo, tendrá que defender los intereses de sus empresas petroleras.

Entonces, el tema Sapotillos subraya el hecho de que los beliceños contamos con algunos abogados articulados, pero un ejército que no es competitivo con los de las dos repúblicas que son relevantes a la controversia.

En las relaciones internacionales, mi entendimiento del gran Vincent Starzinger en Dartmouth fue, creo, que el poder hace la razón. Washington, en otras palabras, tiene las cartas relevantes aquí. O, así es como le parece a este estudiante de Starzinger.



PG veteran footballer, Mike Flores, reflects on David Cruz, Sr.

If and when Punta Gorda opens its football Hall of Fame museum, Mr. David Cruz, who



recently passed away on October 19, 2022, must be featured among the top five for his stellar contributions to the development of football in this town and the district. Many players were impacted by his coaching, mentoring,

and guidance to bring out the best, during those years in the 1970s and 80s when P.G. used to field outstanding national football players.

When I was 16 years old, I used to watch the training of the Toledo selection team. For some reason, at a few of their training practices, the team had no goalkeeper, since their goalie, Gully Petillo, was sick. As a result, whenever the players scored in the empty goal post, I, as a young teenager, would retrieve the ball for them from the bushy prickle patch behind the goal post. After a while, I got tired of going in the prickle patch, so I drew nearer to the goal post and tried to stop the ball as best as I could so I wouldn't have to go there. I voluntarily did this for the team during their practice. Eventually, I stood about 3 feet behind the goalposts and was catching or stopping most of the balls.

One day I got to the field late since I

took a longer time selling bread for my grandmother because it didn't "raise" well. Interestingly, when I got there, the players were just standing around and not practicing.

As soon as I got to the field, the coach, Mr. David Cruz, asked me, "Mike, you ready?"

"Ready fu what, Sah?" I asked, puzzled.

"To go in the goalpost" he responded.

"Me, Sah?" This time I was in shock. How could I, a young teenager, be the goalie of these senior players?

"Yes, you," Mr. Cruz insisted.

Still dazed, I slowly walked to the posts, and training began. In the middle of training, senior player Milaad Nunez walked to the coach, and I noticed them talking while glancing at me. Milaad then asked me to bring the ball to him. Immediately he started to train me to serve as goalkeeper for the team.

Training was four days a week.

Within a few weeks I was traveling with the team on the stake body PWD truck driven by Joe-Joe Avila for a major game with Dangriga. The team included John-John, Chuck Gutierrez, Oak Lambey, Pancho Paulino, Pike Avila, Mirung Augustine, Lawkins Garcia and others. At midday that Sunday before that afternoon game, Mr. Cruz mustered the players in one room. He sent for me from my room and gave me my first goalkeeper uniform. Soon after the team arrived at Carl Ramos Stadium that afternoon, I was given the ball and instructed to run along the sideline to the middle of the field while the team followed behind. I couldn't believe this moment had arrived; serving as a goalie for a big game not too long after I was only a ball boy for the team. The run leading the team to the middle of the field to start the game was scary as I listened to the packed stadium of unwelcoming home team spectators cursing at us, the visiting team, trying to intimidate us so that we lost our morale, knowing that we were a very strong rival team. "As to the lee maaga one with di ball, we wa bruk-up fu he lee r*ss". I knew that such a comment was directed at me.

The game began; at the end of first half, P. G. was down 1-0. During the halftime break, while our coach, David Cruz, was being interviewed by Radio Belize live, I heard him telling the announcer, Evan X Hyde, in a calm but stern and confident voice that we were going to win the game. Right away I felt a huge relief, as those words injected something into me, a confidence that all was not lost and that we would win. Long story short, our P. G. Toledo selection team won the game 3-2.

In the other game against Corozal, that opposing team scored two easy goals against me in the first 10 minutes of play. Mr. Cruz, knowing that something was wrong with me, took me out the game, and we lost. After we returned to P.G., grown folks gave me some dirty looks, and hurled insults, blaming me for the team's loss. Feeling dejected, I didn't show up for training for two days. As a goalie, it was hard for me to have people celebrate my skills on the day of winning and then a week later turn around to hurl insults after the team lost.

Mr. Cruz was very concerned that I was missing training. He came to my house to find out what happened. "Mike, last week when we defeated Stann Creek, everybody was praising you, wanted to be your friend, your high school celebrated you." I explained to him that I quit because it was difficult to take the love-hate relationship in which one moment everyone was praising and celebrating my skills then soon after they were chastising and blaming me the goalie for the loss of a game. As a teenager, I was finding it too difficult to carry such a burden. Mr. Cruz keenly listened and smiled as I shared those feelings and reassured me, "That's the way people are; some will like or hate you for whatever reason. Don't let it get in your head; that's life." Never having a role model in my life,

Honduras claim will extend ICJ timeline

"My contention is this, that is not a decision for 13 people who nobody elected. Nobody elected the 13 of us to make a decision on something that affects the Belize-Guatemala issue," Peyrefitte said, following the Senate meeting on Monday. He remarked that the possibility of addressing the claim to Honduras through acceding to the Pact of Bogota surfaced in June of this year, following conversations with the co-agents of the ICJ case, during which the possibility of addressing the Honduran claim was discussed.

Belize's counter-memorial was submitted to the ICJ in early June of this year, within the timeline set out by the court for the review of Guatemala's claim. Notably, Guatemala was scheduled to submit its reply on 8 December 2022, and Belize's rejoinder from Belize would then have been submitted on June 8, 2023.

Senator Courtenay has stated that Belize's signing on to the Pact of Bogota will allow the ICJ to hand down a full decision without the country having to embark on a new legal proceeding against Honduras, which could delay a final ruling on the ownership of certain parts of Belizean territory for a number of years.

"We were advised that if we join the Pact of Bogota and commence a claim against Honduras and bring that to the ICJ, then we can say, the Guatemala v Belize and Belize v Honduras cases are related because of this overlap of the claim of sovereignty, resolve it once and for all," Courtenay said, noting that the objective of the 2019 referendum, which was to bring an end to all claims, would be achieved if this is done.

"If we don't bring Honduras into the court, our advice is that it is likely that we will have to commence yet another case, suing Guatemala and Honduras to resolve sovereignty over the Sapodillas," Courtenay said. He thus pointed out that addressing the Honduras claim at the same time that Guatemala's claim is dealt with at the ICJ would be the most efficient way to resolve the matter finally in order for Belize to "achieve its strategic

those profound words of David Cruz remain permanently engraved in my deepest thoughts.

Mr. David Cruz, a soft-spoken man with a wealth of knowledge, was the best coach I ever had. If Belize had more role models who mentor and empower youths to excel through their talents and skills like Mr. Cruz did to make a profound difference in my life, this country would be a much better place for youths. objective of obtaining a conclusive determination of its territorial sovereignty over all its continental, insular and maritime territory, including the Sapodilla Cayes."

Courtenay said that this would extend the duration of the proceedings at the ICJ—thus delaying a final ruling by about a year at the most. "It may delay it for some months. The guesstimate is anywhere from months to a year in order to get the whole Honduras case—the Honduras case is a very narrow and simple thing, who has sovereignty over these particular cases. That's not a long case. It's not like the one that Guatemala has commenced which is going back from time immemorial, where they are trying to prove that they owned or were sovereign of, over Belize. So we expect the pleadings to be quick," he said.

Senator Peyrefitte, however, has estimated that introducing the Honduras claim to the matters being adjudicated at the ICJ could lengthen the ICJ's adjudication process by a few years, and he speculated that it may be part of the agenda of the current administration to do so. "I think they want this matter to be decided not before the next general elections, and if all matters remain this way, then I think a decision will come in sometime around 2024 given the historical record of the court in terms of them hearing cases and deciding on it," Peyrefitte claimed.

He said that he was informed of the motion that was introduced by Senator Courtenay shortly before the Senate meeting on Monday, and a few hours before it was brought to the House of Representatives. "Yesterday morning, the Leader of Government Business texted me and said they are bringing the Pact of Bogota to the Senate," he told local media on Tuesday. He pointed out, however, that the social partner senators—representing the country's churches, NGOs and business community respectively (including Senators Benguche, Chanona and Herrera, who supported the motion), seem to have known about the motion well ahead of time, and had written remarks prepared. "The way the social partners responded in the Senate, to me, one, was extremely shameful and two, they clearly knew that that matter was coming to the Senate before 8:20 Monday morning. They clearly had a discussion, and they knew that that matter was coming and they had time to prepare their responses that seem to be very similar to me," he said.

"If you notice, I think they might have been more in the know than the PUP senators, because the 5 other PUP senators had nothing to say on this issue," Peyrefitte added. He went on to say that the pros and cons of signing on to the Pact of Bogota need to be explained to the Belizean people.

Notably, when stating support of the motion, the senator who represents the business community, Kevin Herrera, remarked, "It's something that has been before us for over a hundred years or more, in fact. We grew up with this issue, Madam President. It's something that has always plagued us, but I think there's an opportunity for us right now to finally resolve it. We wouldn't want to have any issues hanging out there that would prevent a definitive resolution to this

claim. So, I think it is the responsibility of the government to bring all the pieces together, those that were not put in the initial claim, to bring those together ... I don't think that if we have something hanging out there, that will be possible. So, from all the information that I've seen, from all literature that I've read about it, and from all the advice we've seen, this seems to be the route that is most advisable. So, I support the motion."

Senator Janelle Chanona, who represents the country's NGO's, went on to point out in the Senate, "I think it was a missed opportunity before the first vote to also call out such a critical aspect of what we're dealing with ... I don't think, as we have been advised, that we want to end this matter before the court only to have to [go] back to address the Honduran claim. My question, then, on behalf of those I represent, is why didn't we take the opportunity during that—as we now know—very expensive campaign effort to make sure that this was addressed to the Belizean people."

Senator Courtenay later made reference to that question posed by Senator Chanona—regarding why the Honduras issue was "not featured prominently during the campaign for the referendum". He then remarked, "The only person in this chamber who has an obligation and a duty to answer that question is the Honorable Senator Michael Peyrefitte, who championed the referendum, championed a 'yes' vote, and presented to the Belizean people an argument—you all remember this? 'Ironclad.' Do you remember this? 'Slam dunk.'"

It is still unclear why Honduras' claim to the Sapodillas Cayes was not included

in the referendum carried out by Belize (under a UDP administration) and Guatemala in a purported attempt to address all territorial disputes. While a referendum would allow for an education campaign and would make it possible for the government to gauge the views of Belizeans on the matter of signing on to the Pact of Bogota, carrying out such a process would also extend the overall timeline for conclusively determining the territorial integrity of Belize—unfinished business that has been hanging over the Belizean people's heads.

The possible introduction of this second claim at the ICJ as early as possible is seen as a more feasible course of action by former attorney general, Godfrey Smith.

Prime Minister John Briceno informed the media today that they held a meeting with the social partners, during which they discussed the Pact of Bogota, and Honduras' claim to the Sapodilla Cayes.

"We continue to maintain very good bilateral relations with Honduras, but this is a matter that has to be addressed, and they themselves understand that. Their foreign minister has already approached our foreign minister and said 'we will have to adjust this now that you have taken this to the ICJ', and the judges of the ICJ would not touch the Sapodilla Cayes because they would realize now that it's not only Guatemala but it's also Honduras," said Briceno.

More importantly, the Prime Minister noted that timing is a concern, since in 2024 new ICJ judges will be elected to sit on the court for a term starting in 2025.

"So if we don't address this now, who knows—we may have to start the process all over," he said.

Belmopan Trojans host workshop on emotional control

BELMOPAN, Tues. Oct. 25, 2022

Over the weekend, the Belmopan Trojans, a basketball team in Belmopan founded by Aldo Manzanero over 15 years ago, held a workshop for members of the team and youths from the surrounding community on the psychological aspects of decisionmaking on and off the court, along with emotional control.

The kids that we serve tend to have unusual family circumstances, from broken homes, single- mother households, and every single one in this generation has some psychological issue and some emotional stress that they have to deal with. We find that if we deal with that early before it grows, and they learn to manage [it], [which] leads to more mature children at an earlier age. When we say mature we don't mean physically, we mean emotionally—being able to deal with the stresses of life and be able to defuse certain situations, even among friends and family members, because every time when we have a child that can't control their emotions, we have a

situation where we have losses that we aren't willing to accept. The idea is to have the kids be able to defuse situations that will come up in their lifetime," stated Manzanero.

Jeremy Vargas, a registered clinical psychologist, who led the workshop, explained, "You don't understand what you're feeling, then you don't know how to navigate it, and a lot of times for Belizean young men, we aren't given the opportunity to experience emotions. We only express emotions in [highly] intense situations, which [are] when we have fights at school, when we have backtalking to parents or guardians; we have disobedience, and usually those things happen as a third or fourth level of intervention, when in fact the first is sadness or upsetness or confusion, and young men in Belize aren't educated to understand those emotions. They are actually taught to be strong and sturdy, to be rocks, [and] there's nothing wrong with that, but you also need to respect where they're coming from as well. A rock is strong because it is made up of smaller parts together, and those smaller parts are important for men."

High drama in final week of PLB regular season 3 teams still in contention for 4th playoff spot



company, which manufactures "Mine Beer" and whose owner was charged for employing nine foreign residents without proper permits, has called the raid and seizure of their money a direct attack, and their attorney has indicated that while this portion of the case is effectively over, he is confident that they will be vindicated in the Supreme Court.

Barrow will seek to challenge the constitutionality of the Magistrate's interpretation of section 38 of the Money Laundering Act and the constitutionality of the section itself.

Smith, the attorney for the FIU, says that they will resist the case-stated application. He agrees that this portion of the case is effectively over, but interestingly pointed out that Barrow, in his role as former Prime Minister in 2016, was the one who spearheaded the amendment of the Money Laundering Act to allow for the inclusion of section 38, a provision that he is now willing to challenge in the High Court.

"Mr. Barrow made an application for the case stated, in the Supreme Court, challenging the constitutionality of the law and certain things the Magistrate did. on which the full salaries of public officers and teachers were reinstated, after those public workers had endured a 10% salary cut.

"Remember the CEOs, their allowances were cut. So what we're doing basically is just giving them what they had before the pandemic," said the Prime Minister, who, at first, refused to address the issue any further.

Throughout the course of this year, Belizeans have continued to lament the skyrocketing prices of goods and services as the country, like many parts of the world, continues to grapple with record levels of inflation. To many of those Belizeans, the increase in allowances may feel like a slap in the face. But according to Prime Minister Briceño, there is empirical evidence that shows that the country—including its people—is doing better than ever.

"If you look at the empirical evidence, more and more Belizeans are working. Right now the unemployment rate is at 9.2%. That's the lowest rate in the past five years. The new labor survey is going to be out soon ... and it seems that it shows that unemployment is going to go down even more," he said.

response and management, and contributes to global health security," said Dr. Jack.

Minister of Health & Wellness, Hon. Kevin Bernard, said in an interview after the launch ceremony that the main focus of the initiative is the fact that human activity affects the environment and, likewise, changes in the environment can affect human health.

"What One Health is trying to highlight here is that we have to start to look at not just human health, but we also have to find how we can link that with animal health and our environment," he stated.

Health has no borders, said Minister Bernard, and as such the local and regional collaboration that will be made possible through the initiative via data sharing will allow not just Belize but also its neighboring countries to effectively respond to issues that may affect human, animal, and environmental health.

In his opening address, Minister Bernard acknowledged the importance of preventing, predicting, detecting, and responding to global health threats such as the COVID-19 pandemic. He also said that the holistic vision of the One Health program provides a module for protecting and promoting the health of populations through interdisciplinary collaboration.

"We are now in an era where globally it is recognized that enabling environments need to be created for health to emerge. This is what would aspire health and wellness to emerge and not diseases when we do not control the environmental and social risks," he stated.

So far, Belize is one of two countries in the Americas that have recently made progress in establishing the One Health initiative. The president of the Public Service Union, Dean Flowers, noted when he was interviewed by the media today that public officers are disappointed with the way they are treated by the Government in comparison to Cabinet CEOs.

"We're talking about fifteen thousand public officers thereabout. So of course, any increment tied to that number would be substantially higher than the thirty-one or thirty CEOs who are receiving this benefit. However, what we're saying is that when you have roughly 80-81% of public officers earning less than \$31,000 a year and then you have thirty CEOs earning in excess of about 85 to 90 thousand dollars a year, there is absolutely no way you can justify that more needs to be given to them," Flowers said.

The PSU president added that the Belizean public should, rightfully, be upset.

The United Democratic Party has also publicly denounced the increase in CEO allowances, noting in a press release that, while public health facilities are faced with a shortage of basic medical supplies and equipment, including gloves and gauze, CEOs are receiving a 100% increase in their allowances. In that release, the UDP calls the increase an act of disrespect toward public officers and toward the Belizean people.

"The party calls on the government to rescind this allowance increase and make funds available to reinstate the Public Officers' increments and purchase medical supplies and medications which are in shortage at the public health facilities across the country," stated the UDP.

American Health Organization/World Health Organization (PAHO/WHO) and the Ministry of Health & Wellness (MoHW), with funding support from the United States government. The project is an attempt to reduce the number of road traffic incidents (RTI's) in the country, which has increased considerably in recent years.

The billboards will be focused particularly on two primary causes of traffic accidents: speeding and drunk driving, and will remind drivers not to 'wait till it's too late' to make the right decision before getting behind the wheel of a vehicle to drive on the roads and highways.

RTIs are recognized as one of the leading causes of mortality/morbidity, and it has been predicted that by 2030, such accidents will be the fifth cause of mortality in the world. According to data from Joint Intelligence Coordinating Centre (JICC), from January to September 2022, there were 234 road traffic incidents in Belize and 338 road traffic injuries, 63 of which were fatal.

A billboard has been installed in each district in the country at the following locations: Mile 6.2 on the Philip Goldson Highway; Mile 78.5 on the Philip Goldson Highway; Mile 66.5 on the George Price Highway; Mile 14 on the George Price Highway; Mile 8 on the Southern Highway; and Mile 6.5 on the Stann Creek Valley Road.

KHMH Workers Union says...

A widespread shortage of supplies needed to administer treatment, and issues with income tax deductions and pension payments to healthcare workers are some of the issues of concern raised by the Karl Heusner Memorial Hospital Workers Union during its press conference this week. KHMH CEO Chandra Cansino says management was caught off guard.

shortages in medical supplies, but in a letter sent to the Prime Minister, John Briceno, and Minister of Health and Wellness, Kevin Bernard, the union also outlined issues related to the income tax and pension arrangements for healthcare workers. According to the union, they were promised a meeting with Minister Bernard at which their concerns could be addressed. but that meeting has been postponed twice and is now scheduled to take place sometime around mid-November, after Minister Bernard's return from Taiwan.

The postponement is, in the view of the union, unacceptable, since they have asserted that leaving the issues unaddressed for the next three weeks may likely lead to a "collapse" in the delivery of primary care at the national referral hospital.

"He did say that he is willing to meet with us between the 12th and 16th of November, but by the time the Minister comes back from where he goes, Karl Heusner will fall," Andrew Baird, president of the KHMHWU, pointed out. He said that the difficulties being faced at the facility require urgent attention, and they cannot wait for another two to three weeks to be addressed.

"The users of the institutions continue to suffer. The staff of the institution is being asked to carry water in baskets. This cannot continue. We will stand no more in silence, and these needs and concerns of the KHMH must be addressed now - people will die." Baird forewarned, adding that the failure in the health system needs to be addressed.

The union members noted that in addition to the fact that they have not gotten the chance to have a meeting with government officials after they sent a letter to both PM Briceno and Minister Bernard in early September, they also have found it difficult to arrange necessary discussions with the hospital's management, who, they claim, are disconnected from the reality on the ground within the institution. This has impacted the morale of the staff and could lead to a mass resignation of workers from the institution, Baird said.

"Generally there is a sense of unworthiness among the staff at Karl Heusner. There is a sense of not wanting to come to work; there is a sense when you come to work, how am I going to do my job?" Baird said. He added, "if we can't have simple things like gloves to work, how do they expect our performance?"

One nurse, Darwin Slusher, said that in one instance, it took him up to 25 minutes to get the supplies needed to begin administering life-saving care to a gunshot victim. There have also been reports of nurses having to attempt to resuscitate adults using a pediatric resuscitation bag.

"That's death, but we do it because we love our job and we will try whatever means, knowing that it is not effective, but yet they act as if all is fine and dandy at the KHMH," Baird said.

There were also complaints about having to work under a leaky roof-leading to concerns about the stability of the structure which houses the facility.

Minister of Health and Wellness, Kevin Bernard, for his part said in an interview yesterday that he has never shied away from meeting with the union and that he had offered to have a Zoom meeting recently, but according to him, when he received the agenda the union had outlined for discussion,

he realized that Ministry of Finance reps would have to be present to provide input from that ministry.

"The people at the union did write the Prime Minister and myself sometime in September, or in the middle of September celebrations, activities. Right after, I traveled to the World Health PAHO Conference, I did see to the union representative, who also, by the way, is a member of the KHMH board.... In fact, let me say this. And for the record, we are — we had scheduled at 4:00 Monday [a Zoom] meeting because I told them I would not have been able to do the face to face at, in this specific week. But can we do this, I'm prepared to do this Zoom meeting. At 9:30 in the morning, I got an agenda: item one. I could have addressed immediately — the issue of the medication concerns and supplies that they are talking about. But on the agenda, they have some other things that I believe needs the input of the Ministry of Finance and other people that has pensions, the issue of income tax. I cannot go there and make decisions on my own unilaterally. I have to consult. I have to be able to have the people that have that responsibility to be able to sit on. It's similar to what we did with the nurses when we went and we had to involve Labour; we had to involve Ministry of Finance because of the Ministry of Health cannot make those decisions on its own." Minister Bernard stated.

The union, however, has claimed that he had ample time to have such a discussion, since the agenda topics had been listed in the letter delivered to him and PM Briceno in early September.

Bernard did note, however, that efforts are underway to address the shortage of medical supplies for healthcare institutions across the country and that his ministry is aiming to improve the tendering process for medical supplies to ensure that these supplies are within the country in a timely manner.

"We know that there have been the issues of medical supplies and pharmaceuticals, and we know that that had been an issue, but we are working on that," Minister Bernard said.

He further explained, "We are working on it, on that. In fact, KHMH is receiving medical supplies and pharmaceuticals as we speak. From the past two weeks, they have been getting—now there are certain factors that were beyond our control. We can't, we can't change that. But these, the suppliers are receiving stuff. Then we, as we receive them, there's a process now; we cannot issue medication because the supplier receive it in country today. Tomorrow it goes out. We have to inspect; it takes a process and we do that. When these inspections are done, so that we know that the supplier is bringing the right medication that was tendered and that people are getting the correct medical medicine that was approved to be brought in."

He also addressed another concern put forward by Dr. Alain Gonzalez at the press conference: the need for a functioning CT scan machine at the KHMH, since the hospital's patients currently have no choice but to access such services at private facilities, where the cost of getting a CT scan is sometimes twice what they would have paid at the KHMH.

"We have stepped in and we have written to the Contractor General for us to ensure that we go to a selective bidding process, because it's urgent that we get the CT scan

BSCFA, Oscar Alonzo, while BSI has indicated that it is willing to give the farmers the right to audit its financial reports, which are presented in the form of a document known as a Net Strip Value (NSV) statement, the farmers currently have no means of verifying the accuracy and relevancy of the statements. This, he says, is why they have been asking BSI for additional documentation.

"In that manner, they have offered, in my view, a red herring, in terms of saying 'we will give you the right, and we will include in the commercial agreement a clause that gives BSCFA the right to audit the figures that [are] in that NSV statement'," Alonzo said.

The BSCFA says that it is not asking for an audit—that the farmers simply want some level of transparency that will allow them the confidence that they're getting paid fairly for their product. And according to Alonzo, the audited accounts, invoices, and management statements that could make that possible have not been made available to them by BSI since 2014.

"There is nothing wrong with [giving BSCFA] the right to audit, but in our view that right would be meaningless if the figures that they will propose to us for us to audit do not reflect the true value before we attempt to audit," he said.

"We're not asking to audit their operations," Alonzo reiterated. "What we are asking for is documentation—detailed documentation—that will enable us to verify the cost that they are deducting from the gross revenues for the sales of sugar and molasses to determine if we are getting fair payment for our product."

The sugar crop season is set to begin less than two months from now. The standstill has led both sides to claim that the viability of their operation would be put at risk if a reasonable agreement is not made

When interviewed by local reporters, the CEO of the KHMH, Chandra Cansino, agreed that the hospital has been facing supply shortages and noted that they have tried to offset the scarcity by procuring items in-house and not depending on the Central Medical Stores when supplies are not available. But with a limited subvention (\$2.4 million monthly) from the government going primarily to covering salaries (between \$2.1 and 2.2 million), they have to at times depend on obtaining medical supplies on credit or relying on other facilities for some help.

Bernard said.

She said, however, that the hospital has been getting supplies steadily for the past week or so, as pointed out by Minister Bernard.

had stated that farmers would likely begin phasing out of the sugar industry if the conflict is not resolved.

Apart from a lack of transparency that Oscar Alonzo says has fueled an atmosphere of distrust for decades now, another point of contention between BSCFA and BSI/ASR is the BSCFA's proposal to split gross revenues at a 40/60 ratio, with the millers receiving 40% and the producers (the farmers) receiving 60%.

Javier Keme, chairman of the Finance Committee of the BSCFA, explained that the 40/60 formula is not something the association chose arbitrarily, but is in fact a model used in various parts of the world.

"In Mauritius, there is 78% for the producers and 22% for the mill from the gross revenues. In the case of Costa Rica, there is 65.5% for the producers and the rest for the mill. In Mexico, there is a straight split of 57% for the producers and 43% for the mills. And in Guatemala, it's 56/44. And here in Santander, we have a split of 54/46, but there is an additional benefit that the farmer gets on top of the 46% from the payment of sugar, which is a \$3 for the use of bagasse, per ton, for the sale of electricity to the national grid," he said.

According to Keme, the 40/60 split is a simpler and, more importantly, transparent formula that will remove the distrust that the producers feel towards the millers thus creating a better working relationship between the two entities.

The overhead costs that BSI/ASR had been deducting from the gross revenues, Keme further explained, would be included in the company's 40%, under the arrangement being proposed by BSCFA. BSI/ASR has suggested, however, that it would not be feasible for them to cover all those overhead costs-which include transport and shipping—on their own.

Note: In a previous article we incorrectly stated that the 60/40 split would result in 40% of gross revenues going to the sugarcane farmers and 60% to the millers. What we should have stated is that 60% would go to the producers and 40% to the millers.

supplies in medical institutions points out, "Cabinet has also given its approval for the MoHW to start the tender process earlier so contracts can be signed with suppliers by mid-December every year. This will give suppliers a three-month lead time to be able to source AND deliver pharmaceuticals and medical supplies."

CEO Cansino said that at this time the KHMH management and the Health Ministry both are trying to slowly bridge the gaps following the Covid-19 pandemic, and she remarked that while she, as a former registered nurse, understands the concerns of the union, the press conference and some of the comments made at the conference caught her off guard.

Andrew Baird, president of the KHMHWU, sits on the KHMH board, and according to Cansino, did not discuss with management some of the matters highlighted at the press conference before stating them publicly, adding that she was very disappointed with that decision.

"My last discussion with Mr. Baird was very cordial," CEO Cansino said, "so we were caught blind-sided by this action, and so that is disappointing to me."

CEO Cansino said that they have been actively working on a document to present to the government to request an increase in the subvention received by the KHMH, and have allowed the union representative one day out of the week to work on completing the draft of the Collective Bargaining Agreement.
