

Mental Health Association: Don't blame cops for Francis Ramos' death

The association has stated that the shooting of Francis Ramos is a reminder that Belize is in dire need of long-term solutions to deal with those very few mentally ill persons who pose a threat to others and themselves.

BELIZE CITY, Thurs. Nov. 24, 2022 Belize's Mental Health Association has issued a public statement in response to the death of Francis Ramos, Jr., who was shot by police on the Swing Bridge in downtown Belize City after charging at them while wielding a knife. According to the association, the shooting brings into focus, once again, the country's need for long-term solutions to deal with the minority of mentally ill persons who pose a danger to themselves and others.

"Unfortunately, mental illness is rarely a priority and after a few days of finding people to blame, we tend to move on to other issues," the statement notes.

Ramos, 48, is believed to have suffered from mental illness, and AMANDALA's records show that he has, on more than one occasion, acted violently toward the public as well as law enforcement. On July 22, 2013, Ramos was sentenced to 7 years in prison after pleading guilty to attempted murder, following an incident in which he stabbed the boyfriend of a relative of his three times some two weeks

Supreme Court building falling apart!

With water damage, the continued growth of mold, and collapsing ceilings, the Supreme Court building is in a state of disrepair that was worsened by the recent passing of Hurricane Lisa.

Recent ceiling collapses, combined with extensive water damage sustained during Hurricane Lisa and the unbearable stench of mold in several courthouses, have rendered Belize's Supreme Court building practically uninhabitable. On Sunday night, a portion of the ceiling of the Magistrate's Court, which is housed in the historic building, came tumbling down. On Tuesday, the same occurred

Men accused of British filmmaker's murder acquitted

The award-winning British filmmaker met his end in the Rivera area of Belmopan after spending years working in a studio in the jungle, where he shared a home with his wife, Carol

BELIZE CITY, Thurs. Nov. 24, 2022 Richard Foster, 74, an awardwinning British filmmaker who had made Belize his home and had been involved in a range of conservation efforts, was robbed and brutally murdered in August 2018 by men who apparently entered his home and ransacked it before kidnapping Foster and taking his car. His body was found in the Rivera area of Belmopan a few days after the crime had taken place. Yesterday, the three men accused of his brutal killing—Andrew Clark, Derwin Jones, and Anthony Pascasio—were acquitted in the Supreme Court after the presiding



judge ruled that the prosecution failed to prove without a shadow of a doubt that the men were guilty of the crime.

Former Treasury Department clerk pleads guilty to embezzlement

BELIZE CITY, Thurs. Nov. 23, 2022

David Enriquez, a former employee of the Treasury Department, pleaded guilty to the embezzlement of almost \$500,000 last week. Enriquez was charged with three counts of false

accounting in April, 2015. He stood accused of diverting three separate sums of money between March 2014 and January 2015.

On March 14, 2015, Enriquez, a second class clerk at the time, siphoned \$225,296, which was to have been sent to the Toledo Community College. The money was instead diverted and placed into an account for the Seine Bight Community Training Program at the Dangriga branch of the Belize Bank and was later withdrawn by Enriquez.



Then, on January 12, 2015, \$47, 638, which was also intended for the Toledo Community College, was diverted and placed into an account under the name Octaviana Lopez of a Dangriga address. That deposit was also withdrawn by Enriquez. Two weeks later, on January 28, he diverted and subsequently withdrew another \$225, 296.

On the advice of his attorney, Enriquez pleaded guilty to all three counts of false accounting last Thursday, and was fined \$12,000.

Foster had been residing at the Savannah Guest House, his business and home, for a number of years with his wife, Carol Foster, who had been in the United States at the time of the incident and had tried to call Foster shortly after the incident but got no response. She had then asked the caretaker for the guesthouse to check on Foster, but when the caretaker went to the home the following morning, he found that it was open and had been ransacked. Foster, however, was not there.

The caretaker then called the police, and it was discovered, during a search of the premises, that two guns, a 9mm pistol and a shotgun, and Foster's Toyota Hilux, were missing. The vehicle was found by police later in the day in the Mahogany Heights area in the Cayo District, in the bushes on a back road, and there were reportedly blood stains on the seat.

That night, police, acting upon information they received, discovered Foster's body on the east bank of Roaring Creek. Foster had suffered head injuries, and there were ten stab wounds on his body.

An AMANDALA article had reported that "Although blood was found in Foster's house and car, it was not substantial enough to indicate that he was killed in either place. There also was not enough blood found by the creek to indicate that he had been killed there."

It has been reported that in the Supreme Court trial of the three men accused of the brutal crime, the primary evidence that was presented was the testimony of Derwin Jones, one of the three accused men who became the prosecution's lead witness after the prosecution withdrew its case against him. Jones claimed that while he was

with Pascasio and Clark when they burglarized the Foster's home and that he was also with them in Foster's truck when they went to the riverside in Belmopan, he was not involved in the murder that took place at that location.

Jones testified that he saw Pascasio walk Richard Foster down to the riverside, and that he also witnessed the fatal stabbing of Foster by Pascasio.

While the presiding judge did not find the testimony of Jones to be credible and also doubted the credibility of the purported alibis offered by Pascasio and Clark, he ruled that there was not sufficient proof to convict the men of the crime, and thus acquitted Pascasio and Clark.

According to an AMANDALA article dated August 9, 2018, "Richard Foster was a pioneer in the establishment of The Belize Zoo. In 1983, a filmmaking team that was headed by Foster, who was the cinematographer, came to Belize to film a documentary called 'Selva Verde'." According to the article, the now deceased founder of the Belize Zoo, Sharon Matola, had accompanied the team as the animal caretaker, and after filming, Matola "remained behind and created a makeshift zoo for the 17 animals."

That article further stated, "Shortly after producing the documentary, Foster moved to Belize and became naturalized. He and his wife, Carol, filmed many nature documentaries for National Geographic and BBC right here in Belize, and developed them at their guest house at Mile 29 on the George Price Highway. Some of Foster's films include 'Tales from Belize: Underwater World' and 'Paradise on the Edge'; 'Mysteries of the Ancient Maya'; 'Land of the Anaconda'; 'Jungle Nights'; 'Jaguar: Year of the Cat'; 'Hope – The Harpy Eagle'; sequences

Samuel August pleads guilty to killing his child, 5, and exmother-in-law with a backhoe

BELIZE CITY, Tues. Nov. 22, 2022

In November 2018, Samuel August, Sr., was charged for killing his young son and his exmother-in-law and injuring a teen girl. He had driven a backhoe into the home in which they slept on October 31 of that year. This Tuesday, four years later, the former Belize City Council worker appeared before Supreme Court Justice Susan Lamb and pleaded guilty to two counts of murder and one count of attempted murder.

On October 31, 2018, in the early hours of the morning,

residents in the Fabers Road area were awakened by the sound of heavy equipment driving through the neighborhood—a large backhoe was traveling down the street at an alarming speed. That backhoe was being driven by a then 35-year-old Samuel August, who, after completing a work shift (during which he had presumably operated the backhoe), crashed it into the small concrete flat in which his three children, their cousin, and their grandmother were sleeping. August's 5-year-old son,

Samir August, was killed during the ordeal, while a thirteen-year-old girl was badly injured. The boy's grandmother, 53-year-old Louise Young, also sustained injuries that would cause her death.

An AMANDALA article had reported that "the backhoe destroyed the front portion of the house, which was the bedroom where Young and little Samir were asleep. Samir was killed instantly (his body was discovered later in the rubble.), while Young was flung outside the house and landed in the mud in the yard." Young would later be rushed to the Karl Heusner Memorial Hospital, where she succumbed to her injuries shortly after.

Chaos ensued in the moments following the initial collision, which had been caused by an enraged August who had lost custody of his children to their grandmother just one day prior, and from whose salary maintenance payments would be deducted to finance her care of the kids. After the backhoe had rammed into the home, the thirteen-year-old girl ran out of the house, and August followed after her as she took refuge in a neighbor's house, and crashed the backhoe into that home as well. The neighbor reportedly fired shots at August in response.

August fled the scene, but was detained by police soon after. He was then taken to the Karl Heusner Memorial Hospital for treatment of injuries he sustained during the incident. He later escaped from the hospital, however, stealing a vehicle in the process, and then,

for the highly acclaimed BBC documentary *Planet Earth*; and much more. The Fosters won two Emmys and many other awards for their work in Belize and around the world. Although they still made films, of late they had been primarily focused on conservation efforts."





The house on Fabers Road into which August drove a backhoe

in an ironic twist of fate, crashed the car into a parked backhoe on the Philip Goldson Highway before being recaptured by police.

It had been reported in an AMANDALA article dated Wednesday, November 14, 2018 that "after the car smashed into the backhoe, August was observed inside the vehicle stabbing himself with pieces of glass from the car's broken window."

His sentencing is scheduled for January 12, 2023. Before that, on December 14, Supreme Court Justice Susan Lamb will hear mitigation pleas from August's attorney, Orson Elrington. Justice Lamb has ordered a psychiatric evaluation for August, the result of which will be taken into account during sentencing.

Sometime after the incident, August, who used the name "Trey Wills" on Facebook, wrote an apology, stating "I can't forgive myself" and claiming that he had been depressed and under the influence of drugs and alcohol after having lost custody of his children.


It has been reported by one media outlet that it was the discovery that maintenance payments had been deducted from his salary and given to his mother-in-law (his children's guardian) that reportedly triggered August's murderous rage.

He is currently already serving a seven-year sentence for the theft of the vehicle he had stolen during his escape from the hospital.

Caribbean International Brewery seeks leave to file judicial review application

Attorney Dean Barrow today applied for the sitting magistrate to recuse herself from the proceedings on the grounds of an appearance of bias. Godfrey Smith, attorney for the Attorney General's Ministry, also representing Magistrate Deborah Rogers, argues that there is no personal involvement on the part of the magistrate and as a result, no bias or appearance of bias on her part.

Attorney for Caribbean International Brewery Limited (C.I.B.L.), senior counsel Hon. Dean Barrow filed for permission to launch a judicial review application last week as the company embarks on an effort to challenge the decision of Orange Walk Magistrate Deborah Rogers and the office of the Attorney General to allow the Financial Intelligence Unit to withhold (until it completes its investigation into possible tax evasion and money laundering) \$3.1 million dollars that was seized from C.I.B.L.'s compound during a raid by law enforcement in early October.

If granted leave, Barrow and his clients will have the opportunity to argue that the sitting magistrate erred in her decision and that the constitutional rights of his clients were violated—opening the door for the company to seek compensation from the government for any losses suffered by the company due to the withholding of the funds.

While the lower court has not yet handed down a judgment, Barrow is doubtful that there will be a reversal of Magistrate Rogers' decision at that level, so he has taken the next step to put the matter before the Supreme Court. During the session in the Orange Walk Magistrate's Court in which Rogers issued her ruling, he called for a 'case stated' to be submitted to the upper court. Such a legal move was an attempt to have Magistrate Rogers state the case against his clients to the Supreme Court so that her decision could be reviewed and possibly overturned. During that process, however, the funds would have remained in the custody of the FIU. Barrow has since altered his strategy—withdrawing his call for a "case stated" last week and instead starting the judicial review application.

In regard to the reasons for his application to bring a judicial review claim. Barrow told local media, "I opted for the judicial review because I thought that way, I would have a chance, albeit slim, to get a stay, and if I would have been able to succeed in getting the stay, that would have practically meant that the money would have had to be returned. Going the route of the *case*

stated would mean that there would be no chance of getting that sort of interim order, and we would have had to wait until eight-nine months, long after the fact, and then just try to settle for damages if we were still able to show that what the magistrate did was wrong. So, that was the reason for electing to go the route of judicial review."

As previously mentioned, Magistrate Rogers ruled that the Financial Intelligence Unit would be allowed to hold the cash that was seized from the company's Carmelita facility in Orange Walk pending investigation. According to Barrow, that decision was erroneous, and he is hoping that the Supreme Court will find that the magistrate did err and caused injury to his clients if permission is granted for the courts to hear the judicial review application.

For now, the matter has been put off to a later date, since the attorney for the respondents, senior counsel Godfrey Smith, was just retained over the weekend and was not prepared to argue the judicial review.

A stay on the previous matter, requested by Barrow as a part of his application for permission for judicial review, was not granted by the sitting judge. Such an injunction would have prevented the magistrate from continuing the proceedings and caused the money to be returned to the company.

Barrow explained, ""I made my case, and she [Magistrate Rogers] found—she declined to grant the interim stay. She said that when she looked at the balance of convenience, her position was that harm has already been done to my clients. They're already suffering harm, and they seem to be managing. So, she did not think that it would be right to grant a staywhich would mean that they get back immediately, in effect, making the extended judicial review proceedings almost academic. She said that she heard us about our clients being prejudiced as long as the money is being detained. But, she said, if you succeed with a judicial review, they can be compensated with a suitable award in damages. In other words, the loss that they're undoubtedly suffering from

Big Creek Port accountant killed in Honduras


PUERTO CORTEZ, Honduras, Wed. Nov. 23, 2022

Arturo Magaña, 69, a well-known Belizean who was employed at the Big Creek Port for many years as an accountant, was gunned down last Wednesday, November 16, in Puerto Cortez, Honduras by a lone gunman.

According to Honduran media outlets, Magaña, accompanied by his wife, was in the Rio Mar area of Puerto Cortez on a personal trip when the murder—which appeared to be a contract killing—occurred.

Magaña's wife reportedly said that as they were leaving the hotel at which they were staying to purchase dinner, a man on a motorcycle whom they did not know approached them and fired shots in Magaña's direction, fatally injuring him at the scene

In a post on their social media page, the Big Creek Group of Companies described



Magaña as one of Belize's best accountants.

"A family man, a quiet man, dedicated, hardworking, and one of Belize's best accountants. He will be missed by his wife, children, extended family, and directors, management, and staff of the Big Creek Group of companies," they said.

Sandhill triple murder suspect caught, but no evidence

No official arrest has yet been made in connection with the triple murder in Sandhill that claimed the lives of Emerson Garcia, 43; Jareem Davis, 20; and Charleston Jenkins, 19,

who were gunned down inside Garcia's residence last Thursday at around 10:00 p.m. The man suspected of killing the men is in police custody, but according to the Commissioner of Police, Chester Williams, there is at this point no concrete evidence to link him to the crime.

As reported in the Tuesday issue of the *Amandala*, the three men's lifeless bodies were discovered by Jennifer Augustine, the grandmother of Jenkins, who reportedly went over to Garcia's residence for some cigarettes. Augustine's calls went unanswered, which resulted in her entering the home, where she saw the three men on the ground, and initially thought they were sleeping. However, she later realized that the men were covered with blood and called the neighbours.

Police later arrived at the scene, and all three men were taken to the Karl Heusner Memorial Hospital (KHMH), where they were pronounced dead.

Police have indicated that the shooting of the men was possibly drug-related, as marijuana was reportedly sold at the residence at which the shooting occurred. They also stated that Garcia was likely the intended target, and Jenkins and Davis were at the wrong place at the wrong time.

Commissioner of Police, Chester Williams told local reporters yesterday that the main suspect is in police custody. However, due to a lack of evidence, it is hard to link him to the shooting.

"I know we have the main suspect in custody, but again, getting the evidence to tie him to the crime is extremely difficult due to the fact that there is no eyewitness. We have also found the vehicle that we believe was involved in that particular incident, but again, nobody saw what happened, so we are trying to see what we can come up with that will be able to tie him and his associates to the particular crime," said Williams.

to a section above the court building's stairs. And while no employees were injured during either occurrence, the collapsed ceilings forced most court proceedings to come to a temporary emergency halt.

According to Chief Magistrate Sharon Fraser, the current state of the court building is nothing less than frustrating. The collapse of the roof and the subsequent pausing of court services, however, was something she had expected.

"This is an emergency. I mean, we can't help it. I know I looked at the dome yesterday and I said to them, 'you know what, this is going to fall', and lo and behold. Like I said, I'm only grateful it happened during the night when nobody was really around so that we didn't have to worry about anybody getting hurt," she said.

Most affected by the damages is the carrying out of trials, since the portion of the court that had to be closed houses four courtrooms as well as the holding cells. For the time being, virtual hearings are being conducted for some prisoners, while other matters, such as arraignments, will be done using a hybrid virtual-physical process.

Three weeks ago, on November 2, during the passage of Hurricane Lisa, a portion of the iconic building's roof was ripped off. As a result, a number of the Supreme Court chambers were relocated to the National Bank of Belize building. As for the Magistrate's Court, Chief Magistrate Fraser says that a walkthrough of the building the day after the storm had passed revealed that the damage was extensive. At the very least, three courtrooms, especially courtroom #4, had suffered water damage after heavy rains poured through the missing portion of the roof and then came downstairs. Then, this past weekend, an additional onslaught of heavy rains compounded that damage.

"It then meant when we came here Monday, I met a courtroom where the entire ceiling, all the light fixtures, electrical stuff, everything was down. The place was full of water and the mold—the smell of the mold was just unbearable. So, a decision was taken that I would close down that side of the building, which is the left side of this building," said Frazer.

The court building's state of disrepair, however, is not a new matter. For quite some time now, those working in the building have had to contend with water retention and the unpleasant smell of mold, made even worse after Hurricane Lisa, since the loss of the building's roof meant that even the smallest amount of rain led to water leaking in. And even without the rain, water remains trapped within the court's ceilings.

Just recently, Chief Magistrate Fraser instructed magistrates to avoid using the rooms where there was extensive water damage and mold growth.

"We were rotating the courts so they would go in, do their matters, and we take turns to use the two courts that are in the front, with a hope that once it is they had put a tarp over the roof, we maybe would have been able to continue operations and serving the public as best as we can," she said.

"All of this is really unfortunate for me, because we just invested money in demolding that side of the building. I mean, for a department where we're strapped for funds, you know, we found the money to ensure that at least it was safe and sanitary for persons to operate there. We know how deadly mold is. And quickly, before you know it, you could actually smell it. You walked in there, you smelled it. Now it's worse," she added.

The Chief Justice and the Attorney General's office as well as the Ministry of Infrastructure Development and Housing have all been made aware of the current status of the Magistrate's Court, and since Tuesday, the Ministry has conducted an initial assessment of the building.

"They know the urgency of addressing the issue facing us at this time, so I don't feel at any point that we're being ignored, that we're not being looked at and nobody is not understanding the seriousness of this matter," said Chief Magistrate Fraser.

And while Hurricane Lisa exacerbated the ongoing collapse of the Supreme Court building, Chief Magistrate Sharon Fraser says that the storm might just have been a blessing in disguise, since now it may speed up the process of permanently relocating the court to a new location on Chetumal Street. But until that process begins, the Magistrate's Court, especially the four courtrooms that are currently most affected, will need to be housed elsewhere, and that may prove to be a challenge.

The major issue when it comes to finding a temporary location for the Magistrate's Court, Fraser says, will involve financing—specifically rent, since the government will have to find the funds to pay rent for a department for which a budget allocation for rent expenditure had not been required before.

On Wednesday, Minister of Infrastructure Development & Housing, Hon. Julius Espat, told the press that, over the years, the historic Supreme Court Building, which is over a century old, has certainly not been maintained. He said that, currently, his ministry is doing all that it can to see to the matter and that, despite the damages, assessments have not deemed the building completely structurally unsafe for future use. Starting this week, however, the building will be

decommissioned temporarily so that no one utilizes it while it is repaired.

"We are working, based on our capacity, but everything will be dealt with adequately. This building is a special one, though. The compound is a special one—you're talking the court house, the Treasury building and the Court of Appeal. I think it deserves special attention. And that is what we will be doing," Minister Espat said.

The Infrastructure Minister also addressed the fact that the government has inherited many government buildings that have not been maintained for more than fifteen years.

"That is a cultural problem that we have in government. We tend to like the idea of building new buildings and cutting the ribbons, and we don't have any budget in place to maintain. That is also another proposal that this ministry will

be providing to Cabinet to see if a budget can be allocated to continuous maintenance of public buildings," he stated.

When it comes to the Supreme Court building, Minister Espat said engineers found that there were several sections of the building's roof that are rotted and will need to be replaced. He added that the ministry will also be ensuring that repairs are done to meet a standard that will allow the building to better resist damage from hurricanes, Category 1 or otherwise.

"The building is salvageable, though it will take resources to bring it back to where we believe it should be. And that's why I am insisting it's a historical building—we can't just put anything there. It's the last of our historic buildings in Belize, and we have to do it right," he said.



Maybe small sugarcane farmers should get their own factory

When, in 2015, the GOB approved a 50% increase in the controlled price of sugar sold on the local market, from 50 cents to 75 cents per pound, many believed the increase was entirely for farmers, who had been agitating for support because of the severely depressed price for sugar on the world market. But only 65% was for farmers; 35% was for the millers, ASR-BSI, consistent with the revenue-sharing agreement between the groups.

Arguably, their long pockets and their access to markets abroad were the reasons why our government (UDP) favored a foreign company holding majority shares in BSI. Just three years after buying majority shares in BSI, around 80%, ASR shouldn't have needed assistance from the government and people of Belize because of a temporary fall in the price of sugar. ASR probably lucked into that share. GOB quite likely felt it had to include the local shareholders in the company when it reached into the pockets of Belizeans, and ASR "coat-tailed" them to its share of the "shuga."

The late Richard Harrison, an economist, in a 2017 story "Belize – paying A.S.R. to own B.S.I." that was published by *Breaking News*, calculated that the GOB "facilitated the way for us Belizeans to pay for ASR to own our sugar industry" when it approved special tax concessions for the company, and "raised the price of white sugar by \$0.25 per pound."

Our small farmers are losing ground yearly. This is the reason for the present impasse between ASR-BSI and BSCFA. The large farmers are eager for the season to begin. The small farmers, and some large farmers who support them, are demanding a change in the revenue-sharing agreement, one that gives farmers a larger share of the pie, and the millers aren't budging.

The GOB has said that it's not its place to intervene beyond facilitating the negotiations because the entities are private. While some consider that a cop out, the GOB is restrained by certain important conventions.

The divide between the millers and the small farmers might be too large to be bridged. In this environment where the GOB has its hands tied behind its back, it might behoove our leaders to look for other ways to help our small farmers. One way might be to facilitate the ownership of a factory by the small sugarcane growers.

Despite the hard times, Belizeans would quite likely support a small increase in the controlled price of sugar, solely for the benefit of small farmers. Mr. Harrison's 2015 research showed that 37,620, 000 pounds of sugar is consumed locally, of which 26,334,000 pounds is plantation white. If the price of sugar is increased by 5 cents, \$2 million per annum would be derived from local sales of 40 million pounds, for small farmers only, to help them pay for their factory.

PreposterousWaterloo

It could have been a ruse, Waterloo's proposal to dump 7.5

million cubic meters of silt between the Turneffe Atoll and English Cay. Waterloo announced that a team of highly specialized environmental scientists had thoroughly researched the disposal of the silt in that area, and had declared it environmentally sound. Dumping the silt onshore and near shore could never approach the costs of dumping it ten to fifteen miles away in open sea. So, why wasn't that proposal forwarded first, before the preposterous proposal to dump the material near our reef?

Some Belizeans weren't very concerned about the environmental consequences. They were ready, eager, for the massive dredges to get on with the job. These individuals lost all reason when they heard \$400 million, the estimated investment. That is a lot of money, and like a moth drawn to a flame, like a piece of steel drawn to a magnet, they were ready to say yes to the preposterous scheme.

We have to wonder about the Belizeans who knew this was a preposterous proposal, but still put their credibility on the line. For them, was it only about a pay day? Did they stop to consider that gullible Belizeans might have carried the day, and they would have been part of a sacrilege? Or were they certain that the Belizean people would never have entertained such a scheme?

For Waterloo, foreigners, the preposterous proposal had no consequences. If Belizeans were such suckers to go along, it was their country that would have been identified as hypocritical and stupid. And if they balked, why, all along the better deal for them was to dump the 7.5 million cubic meters of silt onshore, and near shore.

How this receivership that formed Waterloo got control of the Port of Belize (PBL) is as labyrinthine as the dealings over the ownership of BTL. To date, no one has gone beyond superficially unraveling the knots, the webs around these key Belizean assets. BTL ownership has been restored to Belizeans, at great cost, and after the United Democratic Party had milked every ounce of political mileage it could get from it. But key questions remain unanswered. Ditto for PBL. Belizeans don't know what happened here, exactly how this receivership ended up with control of this vital asset.

Control Waterloo has, and now, after preposterously proposing to dump silt in the sea, preposterously threatening to call in the British government to intervene on their behalf, and preposterously charging members of the NEAC (National Environmental Appraisal Committee) with begging them for bribes, they are poised to reap the profits for decades, maybe centuries to come.

Interestingly, at the last consultation about its project proposal, Waterloo sang loudest about the many advantages to Belize if the bulk storage facilities at PBL were improved, this after it had stymied improvement of the facilities for a decade, this after declaring that bulk storage improvements would come ONLY IF it got its cruise terminal project approved.

Dumping silt onshore and near shore doesn't carry near the risks that dumping it ten miles out at sea does. But there are risks. Some experts say the silt curtains Waterloo proposes to set up will not stop siltation of the inner reef between Port O' Stuck and the Triangles, and deepening the channel near to Belize City will expose that area to more powerful waves when hurricanes hit.

Our people need jobs. But we must not sell ourselves short. If the NEAC is of the view that the environmental hurdles have been cleared, questions still have to be answered about what is in this Waterloo project for Belize. How much of that \$400 million investment will go to purchase Belizean materials, hire Belizean-owned equipment, and employ Belizeans? How much tax will our people derive from a foreign-owned company that is led by one who has proven to be a poor corporate citizen, and has been questioned in his home country, the UK, for avoiding being taxed? Finally, what will little Belize City do with three cruise ports? In the cruise sector, will Waterloo just take away jobs from Port Coral on Stake Bank?

"Tour-isms" "Art is Communication"

Belize is no stranger to beauty. Travelers from across the world come here to revel, play in, and appreciate the natural splendor that abounds our small country. Mother Nature is her own artist, and her paintbrush is a tough actfor any mortal to follow, but sometimes an artist can deliver images that captivates. The mural on Fort St. is on a concrete wall in a busy area but it is somehow still organic and authentic. The mural is the kind of beauty that wasplanned for, prepped for, and expertly executed. The Belize Tourism Board (BTB)commissioned local visual artist, Keion George Griffith to put his brush to work with the Fort Street wall as his canvas. The incentive behind this beautification project, is the organization's multi-faceted approach to expanding and improving the Belize Tourism Product. The mural is a part of a larger project meant to uplift the city by deepening the experiencethat local and foreigner visitors have as they move around the Old Capital. Post Covid-19, the BTB included a new cultural dimension to our tourism offerings. Director of Industry Development, Mr. Josue Carballo, described the mural as one that "captures the essence of our people." Keion Griffithconsiders art as a form of communication. So, if art is communication, what is the mural saying?

The mural is saying that Belizeans are beautiful, diverse, and creative. The bright, life size portraits of Belizean men, women, and children speak to our history, dance, celebration, youth, and our wisdom. Griffith explains that his intention was to paint the images with a focus on the hands to honor the artisans, sculptors, hair-braiders, and jewelers, who work in the area. If art is communication, the mural communicates Belizean life, Belizean spirit, and Belizean poetry.

The mural is a project for the people and the industry. The BTB supports art, and it supports local artists. Beauty, talent, and culture transcend time, space, and

nationality. The paintings will tell a different story to each person. The point is that each viewer gets to interact with it to receive their own message. That is culture. Tal vez los pequeños cañeros deberían tener su propia fábrica

Cuando, en 2015, el Gobierno de Belize aprobó un aumento del 50% en el precio controlado del azúcar que se vende en el mercado local, de 50 centavos a 75 centavos la libra, muchos creyeron que el aumento era totalmente para los agricultores, que habían estado pidiendo apoyo debido al precio severamente deprimido del azúcar en el mercado mundial. Pero solo el 65% era para los cañeros; el 35% era para los molineros, ASR-BSI, en consonancia con el acuerdo de reparto de ingresos entre los grupos.

Podría decirse que sus amplios bolsillos y su acceso a los mercados en el extranjero fueron las razones por las que nuestro gobierno (UDP) favoreció a una empresa extranjera para poseer una participación mayoritaria en BSI. Solo tres años después de comprar acciones mayoritarias en BSI, alrededor del 80 %, ASR no debería haber necesitado la ayuda del gobierno y el pueblo de Belize debido a una caída temporal en el precio del azúcar. ASR probablemente tuvo suerte con esa participación. Es muy probable que el Gobierno de Belize sintiera que tenía que incluir a los accionistas locales en la empresa cuando buscó en los bolsillos de los beliceños, y ASR los "atrapó" con su parte del azúcar.

El finado Richard Harrison, economista, en una nota de 2017 "Belize: pagando a A.S.R. para ser dueño de B.S.I." que fue publicado por Breaking Belize News, calculó que el Gobierno de Belize "facilitó el camino para que nosotros, los beliceños, pagáramos para que ASR fuera dueño de nuestra industria azucarera" cuando aprobó concesiones fiscales especiales para la empresa, y "aumentó el precio del azúcar blanca en \$0.25 por libra."

Nuestros pequeños cañeros están perdiendo terreno cada año. Esta es la razón del actual punto muerto entre ASR-BSI y BSCFA. Los grandes cañeros están ansiosos por que comience la zafra. Los pequeños cañeros, y algunos grandes cañeros que los apoyan, están exigiendo un cambio en el acuerdo de reparto de ingresos, uno que les dé a los cañeros una mayor parte del pastel, y los molineros no están cediendo.

El Gobierno ha dicho que no le corresponde intervenir más allá de facilitar las negociaciones porque las entidades son privadas. Mientras que algunos consideran que es un escape, el Gobierno está restringido por ciertas convenciones importantes.

La división entre los molineros y los pequeños cañeros podría ser demasiado grande para superar. En este entorno en el que el Gobierno tiene las manos atadas a la espalda, podría ser conveniente que nuestros líderes busquen otras formas de ayudar a nuestros pequeños cañeros. Una forma podría ser facilitar la propiedad de una fábrica por parte de los pequeños cañeros.

A pesar de los tiempos difíciles, es muy probable que los beliceños apoyen un pequeño aumento en el precio controlado del azúcar, únicamente en beneficio de los pequeños cañeros. La investigación de 2015 del Sr. Harrison mostró que 37,620,000 libras de azúcar se consumen localmente, de las cuales 26,334,000 libras son de azúcar blanca. Si el precio del azúcar aumenta en 5 centavos, se derivarían \$2 millones por año de las ventas locales de 40 millones de libras, solo para los pequeños cañeros, para ayudarlos a pagar su fábrica.

Waterloo absurdo

Podría haber sido una artimaña, la propuesta de Waterloo de verter 7,5 millones de metros cúbicos de sedimentos entre el Atolón de Turneffe y Cayo Inglés. Waterloo anunció que un equipo de científicos ambientales altamente especializados había investigado a fondo el desecho del sedimento en esa área y lo había declarado ambientalmente adecuado. Verter el sedimento en la costa y cerca de la costa nunca podría acercarse a los costos de descargarlo a diez o quince millas de distancia en mar abierto. Entonces, ¿por qué no se envió primero esa propuesta, antes de la absurda propuesta de arrojar el material cerca de nuestro arrecife?

Algunos beliceños no estaban muy preocupados por las consecuencias ambientales. Estaban listos, ansiosos, para que las enormes dragas siguieran con el trabajo. Estos individuos perdieron la razón cuando escucharon \$400 millones, la inversión estimada. Eso es mucho dinero, y como una polilla atraída por una llama, como una pieza de acero atraída por un imán, estaban listos para decir que sí al absurdo plan.

Tenemos que preguntarnos acerca de los beliceños que sabían que esta era una propuesta absurda, pero aún así pusieron su credibilidad en juego. Para ellos, ¿se trataba solo de un día de pago? ¿Se detuvieron a considerar

que los crédulos beliceños podrían haber triunfado y que habrían sido parte de un sacrilegio? ¿O estaban seguros de que el pueblo beliceño nunca habría considerado tal plan?

Para Waterloo, extranjeros, la descabellada propuesta no tenía consecuencias. Si los beliceños fueran tan tontos como para seguir adelante, sería su país el que habría sido identificado como hipócrita y estúpido. Y si se oponían, bueno, todo el tiempo el trato mejor para ellos era arrojar los 7,5 millones de metros cúbicos de sedimentos en la costa y cerca de la costa

Cómo esta receptoría que formó Waterloo obtuvo el control de Port of Belize (PBL) es tan laberíntico como los tratos sobre la propiedad de BTL. Hasta la fecha, nadie ha ido más allá de desenredar superficialmente los nudos, las redes alrededor de estos activos clave de Belize. La propiedad de BTL ha sido restaurada a los beliceños, a un gran costo, y después de que el Partido Demócrata Unido hubiera exprimido cada gramo de beneficio político que podía obtener de él. Pero preguntas clave siguen sin respuesta. Lo mismo sucede con PBL. Los beliceños no saben qué sucedió aquí, exactamente cómo esta administración judicial terminó con el control de este activo vital.

Control tiene Waterloo, y ahora, después de proponer absurdamente arrojar sedimentos en el mar, amenazar absurdamente con llamar al gobierno británico para que intervenga en su nombre y acusar absurdamente a los miembros del Comité Nacional de Evaluación Ambiental (NEAC por sus siglas en inglés) de pedirles sobornos, están preparados para cosechar las ganancias durante décadas, tal vez siglos por venir.

Curiosamente, en la última consulta sobre su propuesta de proyecto, Waterloo cantó más fuerte sobre las muchas ventajas para Belize si se mejoraran las instalaciones de almacenamiento a granel en PBL, esto después de haber obstaculizado la mejora de las instalaciones durante una década, esto después de declarar que las mejoras de almacenamiento a granel vendrían SOLAMENTE SI obtuviera la aprobación de su proyecto de terminal de cruceros.

Verter sedimentos en la costa y cerca de la costa no conlleva los riesgos que conlleva arrojarlos diez millas mar adentro. Pero hay riesgos. Algunos expertos dicen que las cortinas de sedimentos que Waterloo propone instalar no detendrán la sedimentación del arrecife interior entre Port O' Stuck y Triangles, y profundizar el canal cerca de la Ciudad de Belize expondrá esa área a olas más poderosas cuando golpeen los huracanes.

Nuestra gente necesita empleos. Pero no debemos subestimarnos. Si el NEAC es de la opinión de que los obstáculos ambientales se han superado, aún quedan preguntas por responder sobre lo que hay en este proyecto de Waterloo para Belize. ¿Cuánto de esa inversión de \$400 millones se destinará a comprar materiales beliceños, alquilar equipos de propiedad beliceña y emplear a beliceños? ¿Cuántos impuestos obtendrá nuestra gente de una empresa de propiedad extranjera dirigida por alguien que ha demostrado ser un ciudadano corporativo mediocre y ha sido cuestionado en su país de origen, el Reino Unido, por evitar pagar impuestos? Finalmente, ¿qué hará la pequeña Ciudad de Belize con tres puertos de cruceros? En el sector de los cruceros, ¿Waterloo simplemente le quitará puestos de trabajo a Puerto Coral en Stake Bank?

The French writer Balzac (1799-1850) once wrote that behind every great fortune there is a crime. One assumes he allowed for the existence of multiple crimes giving birth to these fortunes as opposed to a singular criminal act.

When Bob Turton died in 1955, he was the richest native in British Honduras, but a chiclero by the name of Eleuterio Hernandez had tried to kill him with a pistol. He caught Turton

on one of his fingers. The reality of such a homicide attempt suggests that the reports are true that Turton was a man who exploited chicleros mercilessly.

After Turton, the richest native in British Honduras became Santiago Castillo, Sr. One of my few business friends has told me that early in his business career, San Cas, who came from the Orange Walk District, had a partner whom he treated in a dishonorable way. I'm just saying what was said to me.

Leaving the Balzac quote aside, I would say that, generally speaking, one is most unlikely to become wealthy if one entertains compassion in his soul. But Belizeans claim that this is a Christian nation, and the hallmark of Christ's teachings, as I read in the New Testament, was compassion, love for one's fellow human beings.

When I came home from school in 1968, I could quickly recognize the Belize to which I had returned. It took a while, but I soon felt at home.

Today, I don't recognize this Belize of 2022 in which I live. There is so much going on here which is amazing, even frightening, to me. In Belize City, there are signs of enormous wealth all around us in vehicles, buildings, yachts, and so on. Presumably, there are also massive bank accounts in the institutions which make this Belize City the country's financial capital which it is. Recently, the authorities found three-plus million dollars lying around in a Carmelita business. The key here is "lying around."

When I was a child, clearly most Belizeans were relatively naive, because we did not rate money the way we do today. Our emphasis was on living together in harmony. Yes, we criticized our neighbours behind their backs, but we were quick to assist those same neighbours if they needed help in any way. And we did a lot of social mingling, even across classes, and we held daily conversations with our neighbours.

All this has changed radically. All we focus on today is money and material things. Perhaps more discouraging is how we isolate ourselves from each other. In Belize, neighbours are no longer neighbours. We are strangers to each other.

Three-plus years ago I had an idea, a vision, for a garden of sports in the 7 acres where the KREM Radio tower is presently located. This is the Lord's Bank/Ladyville/Lake Garden area. I think, though, that the Belizeans who live around the site where these 7 acres are located, are not interested in anything which may be of bother in any kind of way. They have a Greta Garbo mentality. Leave me alone. This, I must respect. A man's home is his castle.

The mentality which now rules the urban areas of Belize is the product of cable television, to a great extent. Add all these internet-featuring high-tech telephones, and the isolation has become exaggerated. Belize's soul is dead. I don't know this place.

I have always said to you that there is only a small group of Belizeans, perhaps 4 percent, who take the things I say seriously. The vast majority of Belizeans are committed to the Christianity which the conquering Europeans have handed us through the schools they established and control. But there is a massive contradiction in Belize to my mind. You love your cable and your phone more than you love your neighbour. You lust for wealth more than you treasure truth. Therefore, you, Belizeans, are bogus Christians. Straight up.

Cuando Bob Turton murió en 1955, era el nativo más rico de Honduras Británica, pero un chiclero de nombre Eleuterio Hernández había tratado de matarlo con una pistola. Cogió a Turton en uno de sus dedos. La realidad de tal intento de homicidio sugiere que los informes son ciertos de que Turton era un hombre que explotaba a los chicleros sin piedad.

Después de Turton, Santiago Castillo, Sr. se convirtió en el nativo más rico de Honduras Británica. Uno de mis pocos amigos de negocios me dijo que al principio de su carrera empresarial, San Cas, que vino del distrito de Orange Walk, tuvo un socio a quien trató en una manera deshonrosa. Solo estoy diciendo lo que me dijeron.

Dejando a un lado la cita de Balzac, diría que, en términos generales, es muy poco probable que uno se vuelva rico si tiene compasión en su alma. Pero los beliceños afirman que esta es una nación cristiana, y el sello distintivo de las enseñanzas de Cristo, como leí en el Nuevo Testamento, fue la compasión, el amor por los demás seres humanos.

Cuando regresé a casa de la escuela en 1968, pude reconocer rápidamente el Belize al que había regresado. Me tomó un tiempo, pero pronto me sentí como en casa.

Hoy no reconozco este Belize de 2022 en el que vivo. Están sucediendo muchas cosas aquí que son asombrosas, incluso aterradoras, para mí. En la Ciudad de Belize, hay signos de una enorme riqueza a

nuestro alrededor en vehículos, edificios, yates, etc. Presuntamente, también hay cuentas bancarias masivas en las instituciones que hacen de esta Ciudad de Belize la capital financiera del país que es. Recientemente, las autoridades encontraron más de tres millones de dólares tirados por allí en un negocio de Carmelita. La clave aquí es "tirados por allí".

Cuando yo era niño, claramente la mayoría de los beliceños eran relativamente ingenuos, porque no evaluábamos el dinero como lo hacemos hoy. Nuestro énfasis estaba en vivir juntos en armonía. Sí, criticábamos a nuestros vecinos a sus espaldas, pero éramos rápidos en ayudar a esos mismos vecinos si necesitaban ayuda de alguna manera. E hicimos mucha mezcla social,



I remember the year when Shane dreamed in goal, and Tiliman, of Yaabra, burned him from 30 yards. Ah, Shane, he had the physical gifts to be a top ten portero in the world, but he liked to get bored. I remember the year when it came down to penalties against Sagitun. When I saw Camalote's Locho Coye step up to take his turn, I

knew he would *ops*. If it had been his brother, Makoati, a striker, it would have been pigeon hole. Locho, a *bakop*, booted it high, way high, and over.

I won't go into more explanations about how a minister owning a team undermines the integrity of the game. Businessmen in the big countries jostle to sign stars and athletes who appear to have star potential, and they buy and sell them like regular merchandize. Of course, the athletes get a big fat cut. Until I spoke with Ray, I didn't know that that "game" had arrived in Belize. There's so little investment in athletes in our country. Really, how can you fight over what you didn't make? Well, I was slow. Some were operating at a higher level. It's all legal, and apparently John's thoughts were up there.

Now, John is before the nation pleading for us to defend his name after the US government designated him a corrupt person. I don't know that he is. What I know is that he kept very bad company. And what I know is that after he had fallen, I wrote a few times that he needed to put on sackcloth and back off for a while. When a businessman misjudges a talent, sees too much in a player that has little growth potential, he

and his club pay for their misjudgment. When a political leader misjudges the people he engages with, a nation pays. You don't get more big-time notorious than Mr. Mason and Mr. Dermen.

It has occurred to me that John accepted he had blundered, but he feared that if he stepped back there'd be no tomorrow. Khalid, if the UDP hasn't sullied him too much, is formidable. A horse like that might not want to go back into the stables if he gets in the race.

But Khalid has a dilemma even if John gets the sense this time. Darrell Bradley and Michael Peyrefitte have, wisely, decided not to run in the next general elections. With its present configuration, which John created in his desperation to save his hide, the UDP is looking to be out of office for three terms. Bah, only the Americans are enjoying this.



GoB meets with the Belize Coalition of Medical Professionals



BELIZE CITY, Wed. Nov. 23, 2022

On Monday, the Office of the Prime Minister and representatives from the Ministry of Health and Wellness, as well as the Financial Secretary, Joseph Waight,

held a meeting with the Belize Coalition of Medical Professionals (a recently formed alliance of the Belize Medical and Dental Association, the Belize Nurses Association and the Karl Heusner



Memorial Hospital Workers' Union) at the Western Regional Hospital in Belmopan, and they engaged in discussions of seven areas of concern that the group had highlighted in a letter

sent to the government and in a press release issued earlier this month.

On November 10, an ad-hoc group of medical professionals who referred to themselves as the "Belize Coalition of Medical Professionals" released a scathing joint release in which they gave the government an ultimatum—to meet with them by Friday, November 18 to hold discussions on 7 key problem areas in the healthcare system. The meeting with the group did not take place within that designated time period, but one member of the tripartite coalition, the Belize Nurses Association, met with the Minister of Health and Wellness, Hon. Kevin Bernard, last week prior to the ultimatum date. At that meeting, according to Bernard, a primary area of concern highlighted by the nurses—medical supply shortages was the primary topic of discussion, rather than the 7 points listed by the coalition.

Last week, during an interview, Health Minister Hon. Kevin Bernard suggested that the coalition was actually a unilateral initiative being spearheaded by Andrew Baird, the president of the KHMH Workers Union, but Monday's meeting proved that the coalition is in fact a group of entities.

The areas of concern that the medical professionals are demanding that the government address include: "1. The extreme shortage of medical supplies, pharmaceuticals, and human resources; 2. A salary review for healthcare workers, clarification on pension status, and the exemption of income taken from the severance of KHMHA employees; 3. Reduction of income tax for all healthcare workers; 4. Revision and implementation of the Belize Health Sector Strategic Plan 2014-2024, the compendium of allowances, the nursing review document of 2007, circular 6 of 2012, and patient transfer standard policy; 5. Appointment of members of key medical associations on the MOHW tendering committee; 6. Provision for health insurance for all healthcare workers; and 7. Defining higher education and experience in a health-related field as a pre-requisite for the appointment to the post of Minister of Health."

According to a release published on the Prime Minister's social media page, the meeting was held with the goal of establishing an agreement and charting a path forward. "Our pledge going forward is a collaborative cordial working relationship for the improvement of the health system and providing health services for our people," the release states.

Lord's Bank man points lost Police Department gun at cop



Joel Choco, charged with keeping a firearm and ammunition without a gun license

LORD'S BANK, Belize District, Wed. Nov. 23, 2022

Joel Benito Choco, 26, a construction worker of Lord's Bank Village, Belize District, who pointed a firearm at a police officer during a police search of a bus on which he had been traveling, is now facing multiple charges. Just about a week before, however, another police officer who was not at the scene of the search had been disciplined by the Police Department for losing the gun that was found in Choco's possesion (a police-issued pistol) while he was on special duty.

Choco was reportedly onboard a bus on Monday, November 21, when police intercepted it at the Lord's Bank junction. At that point, the officers saw Choco running towards the back door of the bus, and they set chase after him.

When he found himself cornered, Choco allegedly pulled out a firearm that had been tucked near his waist and pointed it at one of the officers. One of the officers responded by firing a warning shot, which caused Choco to surrender his weapon. He was then arrested, and was later charged with "kept firearm without a gun license" and "kept ammunition without a gun license" in the Magistrate's Court.

What the police later discovered, however, is that the 9-millimeter pistol that they took from Choco, which contained seven live rounds of 9-millimeter ammunition, was actually the property of the Belize Police Department, and had been reported missing over a week ago after it was misplaced by an officer on special duty at MJ's nightclub.

The officer, Police Constable Marcus Locario, 43, had been internally disciplined by the Belize Police Department after losing his department-issued gun earlier this month while on special duty. According to reports, on Saturday, November 12, Locario went to


GoB to amend Fiscal Incentive legislation

BELIZE CITY, Wed. Nov. 23, 2022

The Government of Belize is expected to soon amend the Fiscal Incentive Act as part of its efforts to facilitate greater investments in Belize and to increase employment across micro and small businesses in the country. Forty-six companies met with representatives of various government ministries on Friday and participated in the Fiscal Incentive Legislation Amendment Consultation in Belize City, which was hosted by the Ministry of Investment. Among the government officials who attended the consultation were the CEO of the Office of the Prime Minister, Narda Garcia; representatives from the Ministry of the Attorney General, and reps of other government regulatory bodies

A release from the Government of Belize Press Office states that enterprises in the agriculture, manufacturing, and tourism sectors are positioned to benefit from the amended legislation, which, according to them, "will support the continued growth of MSMEs and the implementation of projects that would enhance Belize's economic growth." Customs duty and revenue replacement duty exemptions will be among the benefits to be granted to successful applicants.

Caye Caulker gets premier health facility

CAYE CAULKER, Wed. Nov. 23,

Fifteen months ago, the Ministry of Health and Wellness broke ground in Caye Caulker Village to mark the start of construction of a premier health facility, and on Monday, November 21, an inauguration ceremony was held in celebration of the completion of the building, which will also serve as a hurricane shelter.

The financing for the \$1.4-million health center came through a loan from the Caribbean Development Bank (CDB) along with the Social Investment Fund (SIF), which acted as the implementing agent.

On August 21, 2021, former Minister of Health and Wellness, Hon. Michel Chebat, when speaking to local reporters about the project, highlighted the need to provide more comprehensive health services to the residents on the island, and at the inauguration ceremony, current Health Minister, Hon. Kevin Bernard, emphasized how important it was to ensure that adequate health services are provided on the island.

"Caye Caulker is one of Belize's prime tourist destinations and deserves



adequate health facilities for both residents and visitors. I am told that Caye Caulker has an average population of 5,000 persons, and when tourists come to this community, that can go up to as much as 9,000. Having trained medical personnel is not enough to provide quality health services. Equally important is having good infrastructure with adequate examination and observation rooms, the right equipment, and also medication. The building, as already highlighted, has also been built with a flat roof for future expansion. And I want to say that today, I am saying this publicly, with the commitment of our CEO in the Office of the Prime Minister and as the chairperson of SIF, has expressed support to the ministry for the expansion of this building so we can also provide for us to be able to house the doctors and the nurses and to be able to provide additional services here in Caye Caulker. So that is the commitment we are making here today," Minister Bernard said.

Hon. Andre Perez, representative for Belize Rural South, expressed similar sentiments and pointed to the health center as one of the many commitments fulfilled by the government.

"It is the accomplishment of a commitment made to the people of Caye Caulker. This health center is more than just a building. It means, for the first time, residents in this community will have access to proper health care in a proper facility. This

government has fulfilled yet another promise in Plan Belize. This will undoubtedly result in a healthier community and it would mean that residents and visitors alike can be confident that when the need arises,

health services will now be available. Visitors to Caye Caulker can now be assured that health services are available, and this contributes to the overall tourism package that La Isla Carinosa has to offer," said Perez.

The 11th Commonwealth Youth Parliament is being held this week in Trinidad and Tobago, and Belize is being represented by Kalen Middleton and Daril Avila, both of whom are members of the Young Leaders Alliance of Belize (YLAB). The five-day event runs from November 20 to 24, and this year saw the participation of some fiftyeight youths who acted as elected representatives of a fictional country.

Trinidad's House Speaker, Bridgid Annisette-George, gave the opening remarks at the beginning of the event.

"This is a momentous event for us at the parliament, as it presents a few firsts. This is the first time we are location host for the Commonwealth Youth Parliament, CYP. This is the first

in- person CYP since the COVID-19 pandemic seized the world," she stated.

On Tuesday, participants were granted the opportunity to debate a mock parliamentary bill, the Remote Work Bill, 2022. The bill focused on the implementation of a four-day work week as well as permanent work-fromhome arrangements.

Kalen Middleton, who hails from Belize City, was a government member and contributed to the fierce debate on the passing of the bill.

"In 2020, the COVID-19 pandemic caused global CO2 emissions to

plummet five percent to 34.81 billion metric tons. This is because we were forced to confine to our homes and work remotely," said Middleton during her speech, which she says she worked on tirelessly.

Daril Avila, an athlete and youth leader, acted as a member of the Opposition, pointing out some of the bill's flaws.

"Firstly, and very importantly, Madam Speaker, polling shows that one of the challenges faced by the population regarding working from home is that internet penetration is low on smaller islands, and where internet connectivity exists, the service is often unstable. Additionally, all five islands experience frequent disruption in power supply. Given these circumstances, it is a recipe for economic disaster for our labor force to be able to work

Agriculture Ministry and FAO launch feeding program and other projects

BELMOPAN, Tues. Nov. 22, 2022

On Monday, the Ministry of Agriculture, Food Security and Enterprise launched two new technical cooperation projects in collaboration with the Food and Agriculture Organization (FAO) that are valued at about \$200,000 US each. The projects focus on policy development in different sectors of the Ministry as well as the creation and improvement of digital agriculture services.

According to the Minister of Agriculture, Hon. Jose Mai, the projects were the result of a direct request by the ministry to the FAO.

"We realized that we had different weaknesses and deficiencies. It is unacceptable to have agriculture as the backbone of a country, but yet we don't have sound agriculture policy," said Minister Mai to reporters at the launch of the projects.

The project that focuses on policy development will place emphasis on seed policy as well as backyard poultry, marketing, and indigenous territories. According to a press release from the Ministry, it aims to improve the livelihood of rural farmers and indigenous people "through the adoption of an enhanced governance and policy framework enabling diversification through regional trade."

The second project, said Minister Mai, will address the weaknesses of current existing digital agriculture programs.

"We realized that while we have very good programs in place, there are still weaknesses. For example we have BAIMS—Belize Agriculture and Information Management System—which is good as it is today, but it needs to be updated regularly, or whatever you have on there is useless. So we found that

weakness, and again we asked FAO to help us to strengthen that," he said.

The improvement to those digital systems will include the introduction of a marketing intelligence program which will allow users to have regularly updated information on what is currently on the agriculture market for sale.

Another collaborative project by the Ministry of Agriculture and FAO is their feeding program initiative. Through the initiative, which is also being carried out in collaboration with the Government of Mexico and CARICOM, some 488 primary school students have been receiving free, healthy meals daily.

The Resilient School Feeding Project is a part of a larger initiative known as the "Cooperation for Climate Change Adaptation and Resilience in the Caribbean" Initiative, or the Resilient Caribbean Initiative, for short.

Over the past year, six schools in Belize have had their kitchens upgraded and equipped with new appliances. Numerous school cooks have also been trained in food safety and the preparation of healthy meals. Those schools are Biscayne Government School, Chan Chen Government School, Guinea Grass RC, Lucky Strike Government School, Santa Martha Government School, and San Joaquin RC.

"Proper nutrition is important for a child's growth and essential to learning at school. The school feeding program offers our children a proper diet, which

perform special duty at MJ's Night Club with his 9-millimeter pistol that contained 1 magazine with 14 rounds of 9-millimeter live rounds, which was assigned to him. Upon coming off duty at 4:00 in the morning the following day, PC Locario reportedly took a ride on a motorcycle with a co-worker to the Prosecution Branch Office.

All that Locario claims to recall doing while he was at that office is sitting on a chair, and at some point, he said, he fell asleep. According to Locario, he was awakened by a police officer who asked him if he was going to catch his bus, and he told him that he would catch the 5 o'clock bus. He said that his superior then requested the firearm, and it was seemingly at that point that Locario realized that he did not have the gun. He said that he was not sure whether he arrived at the Prosecution Branch Office with the firearm or not.

On Friday, November 18, PC Locario appeared in front of a disciplinary tribunal to answer to a single charge of "Lost By Neglect" and was fined \$200 and sub-charged \$3,195 to cover the cost of the gun and an additional \$17.00 to cover the value of (14) rounds of ammunition.

LIU presents donations to Southside community programs

Leadership Intervention Unit (LIU) donated a number of items to three community initiatives in the St. Martin De Porres of Lake Independence in Belize City to assist them in their respective afterschool programs.

The three persons who received the donations—Olga May Gordon, of neighborhood watch, Eyes of the Jaguar; Perry "Sticks" Smith of Days

of Healing; and Gordon "Timmy" Stamp of Jah Love Evening Program—have been conducting their respective after-school programs for years.

The donation is a part of LIU's

multi-sectorial approach to preventing and combating crime in the city.

"If you listen to Miss Olga May or Timmy, [they'll] tell you that they have not received any type of assistance from any government before, so this is a huge step in the right direction. Obviously, there are a lot more resources that we need to get within these communities for positive programs like these and positive initiatives, so this is just one small step, and we hope to make many others in the coming days ahead," said Hon.

Gordon told local reporters that she has been operating her after-school program for 7 years and began the program with 40 children using her own funds to purchase items for the kids.

"It is hard to bring 40 children right here and to facilitate them to give them snacks. And everything I used to do I did from my pocket... Sometimes for the week, I spend about \$450 because I give them snacks. They used to come three times per week, Monday, Wednesday, and Friday, and we used to give them something nutritious, and if something come up that we have to do a party, then I do a party for them,"

"... down the line, I've been asking when can we meet the Minister? And we couldn't meet the Minister, but then Mr. Dawson said 'you will soon meet him'. Finally, they asked us to write out what we needed, and I wrote it, but I wrote it with a down spirit, because I thought it wouldn't come true, and thank God, it came through today," Gordon added.

Smith noted that the donations will be used to feed his kids who participate in his programs after school.

"These resources here will help us tremendously, because we can't have youths come and say 'you'll be with me for two hours,' and a child is hungry, and I'm wondering, how will I store the food? Where's the refrigerator? Where's the stove that will cook food? Because we don't know if these kids have eaten during the course of the day. They might go to school from 8:00 in the morning, eat during lunch, and by the time you meet me by 3:30 or 4:00 they are hungry again," said Smith.

Stamp, who has been running his afterschool program for more than 30 years, has seen a generation of children entering the program at his residence on Dean Street and expressed similar gratitude for the donation.

"This assistance comes in very handy. We appreciate it, we don't worry about the past, we worry about the future. Right now we have a team that's working [and] our goal is to see how we can put up some more evening [programs] and get these kids to work moving. We need to save the leaders of tomorrow; if they'll be the leader of tomorrow, then we need to try to save them now," said Stamp.

The donation to each program is valued at \$5,000.



being operationally squeezed as a consequence of not having all this money that they would use as working capital can be dealt with by a proper award in damages if you win down the road, which I don't quarrel with that."

As a result, the case continued today in Orange Walk.

Today, during that continuation of the case in the Magistrate Court, Barrow entered an application to the court to have Magistrate Rogers recuse herself from that first proceeding since she is the main defendant in the judicial review application, and is represented by Smith, who, as mentioned, was retained over the weekend to represent the respondents to the challenge brought by Barrow. Smith is also the attorney for the FIU in the case currently being heard by the sitting magistrate.

Barrow argued that this creates an appearance of bias. In an interview with local media yesterday he explained, "The application for judicial review, or for permission to bring a judicial review, is to challenge the magistrate, her jurisdiction, the orders made on the basis that those orders are a nullity, unlawful, [and] without the proper authority under the statute within the context of which she purports to operate. So, she is the respondent—or the first respondent—to our application. She is a party. The judicial review is basically against her. The Attorney General is the second respondent.... But secondly, because the agents of the state that seized the money, the police, are functionaries of the Attorney General—as is the magistrate, not a function of the Attorney General, per se. But she is a state agent. She is a judicial officer operating for and in the service of the Government of Belize. And so, the Attorney General, representing the Government of Belize, is the entity that when we make this challenge against the magistrate, it is the Attorney General who has the responsibility of providing representation for the magistrate.

"That is what was in issue on Tuesday. When we got there on Monday, and Mr. Smith asked for time, he indicated, as I recollect, that he had just been retained over the weekend by the Attorney General. He had been retained by the Attorney General but to - as it were - represent all the agents of the state. That had to have included the magistrate. Otherwise, nobody represented the Magistrate vesterday and on Monday? [That] makes no sense.... He represented the magistrate and defended the magistrate against the application that we brought, an application that arose out of this case that's before the magistrate; in my submission, the magistrate can't get the benefit of representation by Mr. Smith yesterday, and then come back sit today, and allow herself to hear Mr. Smith in his representation of one of the parties before her when Mr. Smith has just represented her."

Brazil great Pele congratulated United States forward Timothy Weah for scoring his debut goal in the World Cup in the Americans' 1-1 draw with Wales.

Weah got his goal in the 36th minute of Monday's game to become the first player to score against Wales in a World Cup since Pele, who was 17 years old when he did it in 1958. That was the last time Wales played at the World Cup before this year in Qatar.

Weah posted a photo of him celebrating the goal on Instagram and Pele congratulated him in the comments section.

"Congratulations. It was a beautiful goal. Keep dreaming, dreams come true," Pele wrote.

Weah responded to "Papa Pele" by thanking him for the "inspiring message."

"It is such a blessing and an honor to receive such an inspiring message

from The King himself," Weah wrote. "Thank you for everything you've done for the world and us young black men. Grandes Abracos."

The 22-year-old Weah is the son of George Weah, the current president of Liberia and the 1995 world player of the year. Weah has scored four goals in 26 appearances for the United States.

(AMANDALA Sports Ed.: The young Timothy Weah is following in some large footsteps, indeed. According to

en.wikipedia.org, his father George Weah "... played as a striker in his prolific 18-year professional football career, which ended in 2003. He is the first African former professional footballer to become a head of state." Furthermore, it continued, "Widely regarded as one of the greatest African players of all time, in 1995, Weah was named FIFA World Player of the Year and won the Ballon d'Or, becoming the first and only player to win these awards while representing an African country internationally. In 1989, 1994 and 1995, he was also named the African Footballer of the Year, and in 1996, he was named African Player of the Century. Known for his acceleration, and dribbling ability, in addition to his goalscoring and finishing, Weah was described by FIFA as 'the precursor of the multi-functional strikers of today'. In 2004, he was named by Pelé in the FIFA 100 list of the world's greatest living players.")





the Attorney General's agents, and by extension the sitting magistrate, SC Smith, noted that the judicial review is directed against the decision made by the adjudicator and not the person herself.

"Our position on that is in judicial review proceedings, where decisions of any tribunal are challenged, it's the decision, it's not the magistrate personally," he said. He went on to state, "It's not the magistrate in her personal decision. It's a decision that one is dealing with. So, questions of bias based on family connection, based on interest don't arise. There are established grounds for actual bias and the appearance of bias. In this case, the magistrate is not personally involved."

Barrow is doubtful that a judicial review decision will be handed down before the decision of the sitting magistrate in the lower court, and, as mentioned, has opted not to "waste time" waiting for the magistrate's decision. Magistrate Rogers made mention of the series of applications being brought by Barrow and commented that they have been an obstruction that have delayed the handing down of a final decision on the substantive matter. Barrow has said that they will now rely solely upon the judicial review going forward and will submit no more applications as a part of the lower court proceeding.

last week designated as "significantly corrupt" by the US State Department (USSD), and he and his immediate family are now barred from entering the United States. The reason for the designation, according to a written statement issued a day after US Secretary of State Anthony Blinken announced the designation, is the US government's belief that Saldivar "accepted bribes in exchange for improperly facilitating the acquisition of Belizean immigration documents" and "interfered in public processes for personal gain". Those claims, according to Barrow, will be reviewed by a committee that will include the chairman of the party, Michael Peyrefitte; and the chairpersons of the UDP's ethics committee (Aldo Salazar), rules committee (Ashton McKenzie), and nominations committee, as well as the party's legal advisor, which prior to the announcement of the formation of the Special Committee was attorney Estevan Perrera.

Barrow reportedly informed his executive of the formation of the committee via a text message which stated that it was a "Special Committee to allow for due process and swift conclusion of the matter considering...the extremely serious allegations being made by our greatest bilateral partner.". He had further noted in his message to the UDP executive, "it is not just legal innocence or guilt. We are a mass Party and we must take into consideration public sentiments as relates to key issues such as corruption, personal misconduct and any other actions that exposes the UDP institution to a breach of public trust and lack of confidence which will have damning ramifications...in the next General Elections."

Notably, however, Perrera sent a text message to a local television station (Channel 7) shortly after an announcement of the formation of the committee was made on that station's morning show, to indicate that he would not be sitting on that body. According to *7News*, he stated in that message, "The US State Department made a decision, and that fact remains. I am not going to be a part of a committee that will speak against or possibly challenge that decision whether directly or indirectly." The response by the UDP leader to Perrera's stance was swift. According to 7News' Jules Vasquez, just a few minutes after Perrera announced that he would not be serving as legal advisor, Barrow "sent out [a] party notice" of the removal of Perrera from that post.

When questioned about that prompt move, Barrow, who has referred to Perrera's decision to avoid what Vasquez referred to as running "afoul of the State Department" as "selfish", told local media, "He's no longer the legal advisor because you don't have an option in a matter like this. This is not about Steve Perrera, this is about the institution of the UDP, and when you take on the responsibility of being the legal advisor, that is a hefty burden to carry, so when the burden becomes overwhelming you don't say 'I di take this off, unu deh pan unu own'."

"We are a sovereign nation; we are the constitutional Opposition, and no personal consideration should be made when dealing with such a weighty matter. We

have to deal with it. That is what transparent good governance is; we just don't say yea or nay; we deliberate, we consider," Barrow went on to say.

He added, "The fact that he does not want to face this serious matter is unacceptable to me."

The Special Committee was officially convened on Tuesday, November 22. By next Friday, December 2, that committee will hear testimony from Saldivar.

"This is not an occasion of legal guilt or innocence; that is one of the considerations. What we have to consider is what is in the best interest of the party, what is in the best interest of public confidence, and if someone is being accused or in the proximity of corruption repeatedly will not render public confidence, that is something that we have to look at. You can't expect that a designation will be made and I will say 'okay, that's it. Off with his head'," Barrow remarked.

Whether or not Saldivar will remain a viable candidate for the UDP's Belmopan division following the decision of the Special Committee is still uncertain.

"Whether or not these accusations, these allegations, that have dogged him, since he was a minister, since he was expelled from the Cabinet, since he had to resign as party leader. If now, with a designation from the (US) Secretary of State, have we reached that point — that enough is enough, is a very valid question, that I don't want to prejudice the deliberation of the Special Committee, but that is the question that they will have to ask themselves, "Barrow said.

In his latest social media post, Saldivar wrote, "Just because the mighty United States has said what it has said does not make it the truth, does not mean it should not be tested in a court of law. They are humans just like us. They are not infallible. They are gullible, they can be wrong, and they have been wrong before, sometimes intentionally so. Someone could have lied to them. Someone has lied to them. Their evidence must be tested in a court of law. Anything else would be unfair and unjust and a dangerous precedent to set for our young and fragile democracy."

Reports are that he has activated his political machinery to begin campaigning in Belmopan as scheduled. And on Thursday afternoon, he maintained his innocence throughout an hour-long press conference, during which he called the US State Department's designation of him an attempt to thwart his political career.

"Whether it be on behalf of the United States government, or whether it be on behalf of the Belize government, or whether it be on behalf of the enemies within my own party, I cannot tell you," he said.

During the press conference, Saldivar also said that he is planning to have his attorney write to the media to warn them against repeating any allegations that cannot be proven in a court of law, adding that he intends to take legal action against any media house that does so.

"Let me state, therefore, for the record, as I have stated many times: I am innocent of any allegations that have been made against me. At no time have I participated in any corruption at the Immigration Department while I was the minister or even before or after," he stated.

Mental Health Association: Don't blame cops for Francis Ramos' death

earlier. Later, in 2021, Ramos was charged with aggravated assault upon a police officer after charging at that officer with a machete. During that incident, he was subdued with a shot to the leg.

Ramos' final encounter with the police would take place on the morning of Wednesday, November 23, 2022. Police officers had arrived in the downtown area of Belize City in search of Ramos in response to complaints that he had been brandishing a butcher knife at pedestrians. At around 10:00 a.m., they cornered him on the Swing Bridge. Amateur footage of what transpired moments after that has already been circulating across the internet. In that footage, at least eight police officers can be seen surrounding Ramos, three of them standing on the guard rails above him, two behind him, and two more—one in civilian clothing directly in front of him.

The officers reportedly ordered Ramos to put the knife down several times, but he refused to comply. Shortly after, three warning shots were fired. Those shots brought the hustle and bustle of one of Belize's busiest areas to a halt, but they did nothing to deter Ramos. Minutes later, he charged at the officers, knife in hand, arms swinging. The officer in civilian clothing fired one shot, hitting Ramos in the leg, and then another, which hit him in the other leg. But Ramos continued charging forward, and that was when a final, fatal shot was fired.

In response to the incident, Commissioner of Police Chester Williams held a press conference at which he defended the actions of the officers. Some members of the public have criticized the police for firing shots in such a heavily traversed area. And other members of the public have questioned whether Ramos' life could have been somehow spared. The Commissioner, however, maintains that the officers handled the situation as best as they could have.

"If you were in that position, what would you have done? I am not, or I was not, on the bridge to say what I would have done, but certainly, anybody in their right mind is not going to try and aggress an alleged madman with a knife ... what would have happened if one of the officers jumped from off the railing of the bridge to where the individual was? It would take one simple move and he would stab and kill the police. Police officers are humans," Commissioner Williams said.

According to the Commissioner, the police did what could have been done, given the circumstances, and the

department has since ordered both a criminal and an internal investigation. When the investigation is completed, the file will be sent to the Director of Public Prosecution's office for the DPP to determine if she is satisfied that the police had acted in self-defense

Minister of Home Affairs, Hon. Kareem Musa, also spoke on the matter, extending condolences to the family of Ramos. He called the incident an unfortunate one that resulted from very difficult circumstances.

"I'm sure none of those officers woke up this morning and said, 'You know what, I want to go and shoot someone on Swing Bridge today.' That's not what they want to do, but in the circumstances, to protect their own lives and the lives of others, they were forced to do that," he said.

The Mental Health Association (MHA) has stated that Wednesday's incident is not an isolated one, and, in fact, there have been far too many that were similar in nature. To lessen such occurrences, the association says that, rather than finding someone to blame, there needs to be proactive solutions that identify those at risk of becoming a danger and those that find treatment regimens to avert future tragedies.

"It is unfair to blame families when there are inadequate resources for them to turn to. There is nowhere that can temporarily house someone who is becoming violent and is resistant to taking medication," the association's statement says.

It further notes that the police should not be blamed either.

"As the law currently stands, they cannot detain someone who has not committed a crime, although there is a strong probability that they might do so in the future. Changing the law would require a space to keep such persons. Neither the psychiatric unit at Palm Centre nor at the prison have the personnel or physical resources," the statement continues.

The MHA is advocating for the establishment of a Psychiatric Forensic Unit in Belize, one that is supported by a "robust legal framework" that will safeguard the rights of individuals and the public. The association has also called for specialized training of police officers to work with mental health professionals to diffuse dangerous situations when they arise. They have stated that they are ready to work with the Ministries of Health, Human Development, and National Security to address the situation by finding funds for a psychiatric unit and the accompanying legislation.

Saldivar said that his attorney has written to the United States Embassy, the Government of Belize, and the US State Department on his behalf, inquiring about the evidence that was used against him.

"There is a talk—because I know you will ask—about a boat ride on the Coast Guard boat, and I would like, if you will permit me, to dismiss that out of hand. Because I cannot for the life of me see how the United States government would want to declare me the first designation in this country because I took a

businessman on a boat ride to visit installations of the Coast Guard," he stated.

According to the former Belmopan area representative, no mention was made of the "tranches" of cash he received from Lev Dermen in the US State Department's designation, and this, he feels, exonerates him of any wrongdoing in regard to the campaign contributions he received from the convicted US fraudster.

"I have never used my office for personal gain," Saldivar said.
