Retired public workers who had endured a wage and increment freeze between 1995 and 1997 and who were compensated by the government with shares in what was then Belize Telecommunications Ltd., are lamenting the fact that they still haven't received the dividends from those shares, which were placed in a trust, and they are intent on receiving a payout from that fund, which reportedly now totals a whopping \$8 million.

Nov. 29, 2022 On Friday, December 2, former Belmopan area representative and Minister of National Security, John Saldivar, who just about two weeks ago was designated as "significantly corrupt" by the US Department of State after an announcement by the US Secretary of State Anthony Blinken, is scheduled to appear before a UDP Special Committee that has been set up to review the allegations against him. The review is being carried out in an effort to afford Saldivar what the UDP leader, Hon Moses "Shyne" Barrow has referred to as due process. In what seems to some to be an attempt to give the committee process a semblance of an impartial judicial proceeding to

determine Saldivar's innocence or guilt, the UDP is now asking the US Department of State to hand over any evidence of its claims against Saldivar—a request to which, many say, the United States is unlikely to respond.

UDP chairman Michael Peyrefitte, who sent the written request to the US on behalf of the party, told the media during a Zoom press conference this week, "We have a member of our party who is looking to enter into a convention to represent our party and a designation is given like the one that was given not only against him but his wife, his children, a minor child, everybody except the dog and so we want to see what evidence they are depending on or what evidence they use to come to that decision so that the UDP may look at that evidence and come to our own decision, so we just wanted to know what they had because they didn't present any information. ## \$5 minimum wage by New Year

BELIZE CITY, Thurs. Dec. 1, 2022

In exactly one month, the minimum wage will be increased from \$3.30 to \$5.00 an hour. Prime Minister John Briceño confirmed this earlier this week when asked by a local media about the timeline for the implementation of the increase.

The last time the minimum wage was increased was in May 2012, over 10 years ago. A Minimum Wage Task Force was set up in March of this year, and in July, government, with the assistance of a consultancy agency, PPF Capital Belize Limited, began consultations with stakeholders on the implementation of the \$5-dollar minimum wage.

A few days ago, the Minister of Labor, Hon. Oscar Requena, announced that those consultations were completed, and that a final report, entitled the "Plan for the Gradual Implementation of the Five-Dollar Minimum Wage" had been submitted. Minister Requena further announced last week that on January 1, New Year's Day, the new minimum wage will come into effect. Concerns about possible layoffs and the raising of prices of goods and services by businesses to meet the additional salary expense have been raised by the Belize Chamber of Commerce and Industry (BCCI). The BCCI has stated that it supports the increase in the minimum wage, but has suggested a phased approach to the increase in order to give businesses time to prepare for, and possibly avert, any financial fallout. "We aren't advocating for an overnight shift from \$3:30 to \$5.00, definitely not, but we feel that there can be a middle ground where there are the increases that can be planned for and then of course over a reasonable period of time that we do

get to that five-dollar price point or salary range," the president of BCCI, Marcello Blake, said during an interview in July.

At the time, he stated that a formula to calculate and adjust the minimum wage gradually would be more feasible, to ensure that businesses have time to plan for the changes, and that employees currently collecting wages in the \$5-an-hour range be given a proportionate salary increase as well. The report from PPF Capital is set to be presented to the Cabinet for any final modifications or tweaks. During last week's interview, Minister Requena said that they have worked closely with stakeholders, including the BCCI, and are convinced that they have to increase the minimum wage at this time, given the increased cost of living and the reality of inflation. "So, we will continue the discussion. I am certain that at the end of the day cooler heads will prevail, and we want to be fair. We want to ensure the wealth distribution ends up in an equitable manner so that all Belizeans can benefit," Hon. Requena said.

evidence and think of a way forward,"

He went on to state, "We're saying, show us the statements even that were made against this person. Give it to the local police department. Give it to the DPP. Have them institute charges. And then that would possibly have a huge effect on our position that we would take as a party. But when you just say 'we're designating you' and give no evidence we have a right to ask what that evidence is. You have to understand, you know. There has not been a request for extradition you know. There has not been an indictment in the U.S. you know. He has not been charged with nor legally accused of anything."

Peyrefitte did note, however, that the way the public perceives the matter could have political implications and that the party will have to take this into account when deciding to whether to allow Saldivar to represent the UDP. "The goal will be to make a recommendation that we believe is in the best interest of the UDP. You have to balance perception with fairness as well. So there will be deliberations, there will be a discussion on the matter and everybody who will be sitting in that room will have the best interest of the UDP at heart and we have to take everything into consideration before we make a recommendation," he said.

As reported, Saldivar, who the US State Department accuses of being involved in "significant corruption while serving in his public position as a Belizean minister" was quick to refer to his designation as "baseless", and "malicious" in posts on his Facebook page and addressed the nation last Thursday in a press conference to declare his innocence and reaffirm his intentions to seek to seek to serve as UDP standard bearer in the Belmopan constituency by participating in an upcoming Belmopan convention.

Peyrefitte also commented that while Saldivar conceded to committing an "error" by utilizing a Coast Guard vessel to take convicted US fraudster Lev Dermen on a trip for personal purposes (something Peyrefitte himself views as an "abuse"), he does not see this as sufficient to impose such a designation on his colleague.

Peyrefitte also seemingly used the designation imposed on Saldivar to raise questions about the conduct of those who are a part of the current administration—issuing what almost seemed to be a warning to the current members of the PUP government:

"When you behave in a certain way in office, there will be a day of reckoning you know. And you have to understand that how you comport yourself when you're in office is very important because things may come against you that may be fair or unfair. But you have to be very careful that you go out of your way to not just do the right thing but to also seem to do the right thing. If you notice, you don't see the PUP celebrating this at all because they may very well know that their own day of reckoning may soon come given their performance and their behavior over the first two years of being in government," he said.

Saldivar in his press conference seemed to suggest something similar by referencing previous bribery allegations that had been made against the now Prime Minister Briceño during his tenure as the Minister of Natural Resources. Upon his return from Venezuela on Monday, Hon. Briceño was asked about those allegations, which he immediately denounced:

"As to the issue of the so-called bribe, let's start with the obvious. Don't you think that if the Barrow administration felt that there was some sort of bribery, they would not have taken me to court a long time ago? They were in government for thirteen years. They had thirteen years to levy charges against me, and they did not, because they know it is a stupid thing," he said.

The UDP Special Committee is expected to make a decision by December 9.

## Law enforcement officers receive cybersecurity training

BELIZE CITY, Mon. Nov. 28, 2022 Since the passing of the Cyber Crime Bill in November 2020, The Minister of Home Affairs, Hon. Kareem Musa, has been exploring ways of strengthening the government's National Cyber Security Strategy 2020-2023. In September, Hon. Musa publicly stated that GoB is focused on three key areas in the implementation of their strategy: the development of a national legal framework to address cybersecurity; developing capacity for incident response and infrastructure protection; and putting in place mechanisms to support education and awareness. This week, further progress was made in achieving these objectives when 99 police officers convened at the National Police Training Academy on Monday to participate in a two-day capacity-building symposium. At the symposium, which was funded by the United Nations Office

on Drugs and Crime (UNODC), the officers, along with personnel from the Magistracy, and the office of the Director of Public Prosecutions. received training in Cybercrime for First Responders and Digital Forensic Analytics. Topics covered during the program included virtual platforms, digital evidence concepts, proper management of a chain of custody, forensic extraction from mobile devices, and data extraction from computers, etc. The symposium concluded on Tuesday with the participants presenting a report as well as a court defense simulation. There was also a visit to the Police Department's forensic lab. During a press briefing held on Monday, Commissioner of Police Chester Williams stated that cybercrime has been a challenge for Belize's police force, especially where bullying is concerned. ## Belize City Council Receives Half Million Grant from Japan

BELIZE CITY, Thurs. Dec. 1, 2022

In a ceremony held at City Hall on Wednesday, November 30, 2022, the Belize City Council and the Embassy of Japan in Belize officially signed a grant contract worth \$534,100.00 BZD. This grant falls under the Government of Japan's Grassroots Human Security Project, which allows developing countries to apply for grant assistance to be allocated to projects that promote economic and social development at the grassroots level. The program welcomes project applications that address challenges in multiple areas such as agriculture, health, environment, sanitation and more. In March 2022, the Belize City Council submitted their application for funding to purchase two new garbage compactor trucks. The signatories on this grant contract are Mayor Bernard Wagner of Belize City and H.E. Ambassador Kazuhiro Iryu of the Embassy of Japan here in Belize.

According to Mayor Bernard Wagner, with this grant, the council's fleet of compactors will now increase from three to five, and this purchase



should notably improve garbage collection. Mayor Wagner also noted that the procurement of these trucks are even more vital due to the impact of Hurricane Lisa on Belize City after it made landfall on November 2, 2022.



Japan recently held celebrations in October of this year in honor of the 40th anniversary of diplomatic relations between Belize and Japan, and Ambassador Iryu made note of this celebration in his address at a handing-over ceremony and expressed his wishes to continue nurturing the relationship with Belize on behalf of the Japanese

government.

Other municipalities which have previously benefited from the Government of Japan's Grant Assistance for Grassroots Human Security Project include the Corozal Town Council, Punta Gorda Town Council, Orange Walk Town Council and the San Ignacio and Santa Elena Town Council.

## Retired teacher, 80, spared prison sentence for drug charges

Brenda Vasquez, 80, a retired teacher, appeared in the Magistrate's Court in Belize City on Wednesday, November 30, along with her son, Giovanni Vasquez, 42, and grandson, Kristian Young, 29, where they were found guilty of drug offenses due to the discovery of marijuana in their home. However, the family will not be serving any time in jail.

According to reports, three persons were present in Brenda Vasquez's home on Lauren Burgess Crescent in the Belama area in October 2020 when police raided the residence and discovered parcels of weed inside a box of Fruit Loops cereal as well as a box of Lucky Charms cereal, in which there were also several blocks of weed brownies.



When the trio appeared in court, Senior Magistrate Baja Shoman found them guilty of possession of a controlled drug with intent to supply, but their attorney, Mansel Thurton, expressed annoyance about the verdict and was cautioned by Senior Magistrate Shoman



about his tone.

Brenda Vasquez pleaded to Senior Magistrate Shoman for leniency in consideration of her age and heart condition and said that she would like to spend the rest of her life in peace. Her son and grandson also pleaded for

leniency, as it is their first conviction, and begged for a fine instead of being incarcerated.

After hearing the family's plea, Senior Magistrate Shoman sentenced the three to a fine of \$3,315 each, which must be paid on February 28, April 30, and May 30 of next year. Otherwise, the family members will have to serve 6 months in prison.

## World AIDS Day

BELIZE CITY, Thurs. Dec. 1, 2022 On Thursday, December 1, Belize joined the international community in observing World AIDS Day. This year's theme is "#Equalize".

An estimated 3,500 persons are living with HIV in Belize, while 38.4 million persons are living with HIV globally.

In an interview with *Krem News* this week, Enrique Romero, chairman of the National AIDS Commission (NAC), stated that much progress has been made since the virus was first discovered in the 1980s.


"Tremendous progress has been made globally. Even in our small and beautiful country of Belize, we have made some steps, people would call them baby steps but nevertheless, they are steps in the right direction. Before my time, I understand that people were taking about 6 or 7 pills a day for HIV; now it's down to one, and Belize is one of the countries that are transitioning to a new medication that is proven, scientifically proven, very important, in reducing the quantity of the virus in your system," said Romero.

He added, "... I saw on the TV the other day, American news, that there is now an injection for HIV. You take one month, you skip a month, and take it the other month, so we have had advances, hopefully, that will be in Belize sometime."

Romero encouraged Belizeans to be

more tolerant and to look out for each other in order to end HIV/ AIDS by 2030.

"Belizeans are known to be tolerable people. Belizeans are known to be respectful people, loving people, and look out for our people, but somewhere down the road in the past few years we have lost some of our essences, so it is just a matter of us regaining that essence, that core, that makes us who we are as Belizeans. We're loving people, tolerant, so we need to regain that essence and look out for our brothers and sisters, and that's the comprehensive holistic approach that needs to be taken for us to end AIDS," he said. .



Romero noted that the NAC has introduced HIV self-testing to eliminate the stigma of going to a health facility to do a test.

## 8 years later, duo convicted of teen student's murder

Clement Bol, Jr, and Ashley Meighan have been convicted for the 2014 murder of Chryslin Gladden

The duo accused of killing 16-yearold Chryslin Gladden have both been found guilty of the 2014 crime, and are awaiting sentencing, which is scheduled for January 30, 2023. The two persons convicted of the crime— Clement Bol, Jr., and Ashley Meighan, who was a teen at the time of the incident, have both been on remand in prison for eight years after being arrested and charged for the brutal stabbing murder of young Gladden, who was a recent graduate of Wesley College high school when she was killed.

Her body was found beside a grave in the Lord Ridge Cemetery on Saturday, August 2, 2014, lifeless and with multiple stab wounds. Besides her, a 10-inch blade believed to be the murder weapon was reportedly found.

In August, 2014, when Bol, who was 23-years old at the time, and Meighan were charged, Roberto Novelo, a police sergeant who briefed reporters about the arrests, had said that the motive for the murder of Gladden "was jealousy and hatred." Reportedly, there had been a number of run-ins between the promising teenager and Meighan, who had been one of her classmates at Wesley College.

It had been reported that surveillance camera footage showed the two teenage girls walking on Central American Boulevard on the night before Gladden's body was found. (Gladden had not returned to her Neal Pen Road home after that walk.)

Early the following morning,

Gladden's body was discovered. The brutal stabbing which caused her death was reportedly witnessed by one man, who claimed that he had been in an intoxicated state when he saw the grisly events unfold. He said he saw a car park by the cemetery, and that two young women exited the vehicle. Shortly after, he said, there was an argument between the young woman and a man, who then stabbed Gladden in her back and proceeded to stab her again after she screamed. The witness said that the man then dragged her into the cemetery and continued stabbing her. Following the murder, the man reportedly wiped the bloody knife, but while he was doing so, the knife fell, and he was unable to find it, since it was dark.

Police found the knife the following morning.

According to a 2014 AMANDALA article, Gladden was "an only child of her mother and the honor student had just gotten money from her mother that same Friday to register for classes at the University of Belize."

approach to the rollout of a Free, Prior, Informed Consent (FOIC) protocol which would govern the implementation of those rights to be "disappointing".

In January of this year, the Government of Belize had announced via a Cabinet brief the approval of a Free, Prior Informed Consent (FPIC) protocol, which it said, would "guide consultations with Maya communities, whether by government or private entities, in keeping with government's commitment to the implementation of the 2015 Consent Order of the Caribbean Court of Justice". However, what it did not mention is that the other key party in the implementation process—the representatives of the Maya community, had not approved that protocol and, in fact, claimed that they were not fully consulted about it. In an exclusive interview in January with AMANDALA, Cristina Coc, spokesperson for the Toledo Alcaldes Association (TAA) and Maya Leaders Alliance (MLA), had stated that the Maya communities rejected the Government's proposed FPIC protocol. Nonetheless the document was sent to the Caribbean Court of Justice (CCJ), without seemingly having the consent of those groups.

"The protocol was sent out to the Caribbean Court of Justice by way of a surprise to us. We have not seen this protocol; it has not been consulted with us, and it certainly does not carry our consent as the appellants to the CCJ consent order," Coc had said. Coc had further noted that although they had not had a chance to thoroughly look at the revised version of the FPIC protocol, they had already spotted wording that was cause for concern.

"Just on the surface, we immediately flag that the Government is calling it a consultation protocol, and even in the body and language of the protocol, it continues to use this ambiguous term of consultation rather than consent, which is what is ultimately the safeguard," she had said. She had also stated, according to an AMANDALA article dated Thursday, January 27, 2022, that "The protocol does not meet the requirements of the CCJ's 2015 order, since the court at the last compliance hearing made it clear to the government that meaningful and timely consultations were to be carried out with the appellants, the MLA and TAA." That article further noted that "Agreeing on the FPIC Protocol is necessary for establishing a Consent Order which would govern the use of the natural resources in Maya communal territory and future interactions between the Maya leadership and the GOB. The CCJ has been mediating the implementation of the land rights since 2015 but continue to receive complaints from the Maya representatives that the Briceño administration has been neglecting due process and opted to proceed with implementation without buy-in from their indigenous counterparts." When the government and the Maya representatives were back before the court at a compliance hearing in early May, however, the acrimony in the relations between the two was clearprompting presiding judge Justice Wit

to state, "I think all present would agree that we have to lower the temperature maybe and get back to a more practical working relationship between the parties, because that relationship has to be maintained whether some like it or not."

Lead counsel for the government at that compliance hearing, Andrew Marshalleck, had even stated, "We need to get back to rebuilding the relationship and reestablishing if possible the trust and confidence in each other in pursuing the steps that need to be taken to achieve the objectives that we all agree must be achieved."

Justice Wit had, in response, expressed the faintest hope that increased cooperation between the Maya reps and the government was possible. "Yes, well, you never know, miracles do happen ... and it should not really be a miracle ... but we will see how thing goes," Justice Wit had said.

But at the most recent compliance hearing, it was clear that there had not been the type of cooperation that the judge was hoping for—something that the court referred to at that hearing as a disappointment. Specifically, the court became aware that the government commenced a process of implementation of the FPIC without sending the final version of that document to the Maya reps.

The current CCJ president, Justice Adrian Saunders, asked Marshalleck, "Were the Appellants sent an English language version - the final copy?". To this, Marshalleck responded, "With the new title? I don't think so". This prompted Justice Saunders to state, "Mr. Marshalleck, I don't know. I don't quite understand how this process evolving. Because all of this, you know, that is being done arises not out of the Government's own deliberate desire to do what it thinks best for Belize and its people. It arises out of litigation. And it arises out of litigation where the parties consented to an order. Now, this is a very novel, awkward kind of order because it is one where one side of the litigation has the responsibility of implementing that order. But, they have to implement it in good faith and in a spirit that respects the fact that the implementation emerges out of a consent order, where there are litigants on the other side. I am disappointed to hear that the FPIC Protocol, which is an important aspect of implementing that consent order, could be finalized by one party and be implemented, and the other party has not seen the final version. That is very disappointing." On Wednesday, a joint statement issued by the Maya Leaders Alliance, the Julian Cho Society and the Toledo Alcaldes Association on Wednesday further pointed out that the CCJ had to remind Senior Counsel Andrew Marshalleck and members of the Attorney General's Office that "the international community is keeping its gaze on Belize as it implements the novel Consent Order agreed to by the Parties." The statement goes on to assert that if the government continues to exclude the Maya from the implementation process, they risk going against the ruling of Hon. Dr. Abdulai Conteh who, in his 2010 judgement in the case of Maya


November 30—officially starting the 2year tenure of this Integrity Commission.

The commission, established under the Prevention of Corruption in Public Life Act, is now fully operational. Prior to this swearing-in, some concerns had arisen over a lack of funding for the commission to execute its responsibility as mandated under the legislation which

This commission was first appointed in May of this year and includes chairperson Andrea McSweaney McKoy and members, George Swift, Zçe Roberson-Zetina, Ricardo Moguel, Katherine Meighan, Payal Ghanwani, and Jaraad Ysaguirre —seven members in total.






## An intentional act or an accident on our western border?

On November 26, a Belize Defence Force soldier stationed at the Valentin Conservation Post along the Belize/Guatemala western border was shot in the buttocks by an unknown person. There is some speculation that the shot came from the Guatemala side of the border, but thus far, maybe because the wound to the soldier isn't life-threatening, and Guatemala's claim to Belize's territory has reached the International Court of Justice (ICJ) for resolution, it hasn't caused a ripple in the relations between Belize and Guatemala. It is likely that if a Guatemalan soldier had been shot in the rear end, and it was suspected that the shot came from the Belize side of the border, the temperature would have been considerable.

Reporting on the shooting, Commissioner of Police, Chester Williams, said we know that the shot didn't come from the stock issued to our soldiers because all their ammunition had been accounted for. Commissioner Williams said that the slug is an important key to their investigation, and after a surgical procedure on the soldier is done to extract it, it will be sent to the National Forensic Science Service for ballistic testing, where the type of bullet, the type of gun it was fired from, the direction from which the bullet that hit the soldier came, and other things will be determined.

Any news of violence at the western border sets off alarm bells, primarily because of the Guatemalan claim to our territory. As noted, that claim is now before the ICJ, where Belize has, some say incredibly, for as long as the matter is before the court, "on paper" given up its sovereignty. Some would say the noble interest of peace justifies our agreeing to settle the matter there.

A number of incidents on the western border have been extremely



confrontational. Ambassador James S. Murphy wrote in his book, A Compendium of Relevant Documents – The Guatemalan *Claim to Belize*, that the year 2000 was a particularly bad one for Belize-Guatemala relations. A Guatemalan national was shot and killed in January that year, when a BDF patrol returned fire on attackers, and in February, in what Murphy describes as the most serious violation of Belizean sovereignty, "a twenty-five member GAF [Guatemalan Armed Forces] patrol entered Belize, kidnapped a four-member joint BDF/Police patrol near San Vicente Village, Toledo, marched our security officers across the border into Guatemala, and then charged them with illegal entry." Also, in May that year a 25-member GAF patrol "entered Belize and approached two villages in the Toledo District." Later that year, in November, Belize and Guatemala, under the guidance of the Organization of American States (OAS), accepted the recommendation of the "Facilitators" — Sir Shridath Ramphal and Mr. Paul Reichler that a temporary regime be created on the western border, as a buffer between the two countries. Murphy said this regime, called the Adjacency Zone, is "comprised of

territory lying within one kilometer east and one kilometer west of what the Agreement called the Adjacency Line, actually the existing land border between the two countries."

The most contentious incident since then occurred in 2016 when a 13year-old boy was unfortunately shot and killed. BDF soldiers, who along with a conservation group had been investigating an illegal land clearing, returned fire when that group came under attack around nightfall. The boy's body was found when they were leaving the area. Guatemala's president, Jimmy Morales, described the incident as cowardly and Guatemalan troops amassed in the area. Belize's Prime Minister, Dean Barrow, told the world that Belize has a long history as a peace-loving nation, and the GOB expressed its regret over the incident and turned to the OAS to conduct an investigation.

Some illegal land clearings in our territory are directly related to the relentless drugs war that was created by the Americans to stop the flow of South American cocaine, and marijuana into their country. This war has caused a lot of carnage, and created many millionaire drug dealers. Aggressive, enormously rich drug barons, unable to deposit their millions directly into the banking system, cut down virgin forest in Guatemala's Petén Department, and cross the border into Belize and cut down virgin forest which protects critical watersheds in the Chiquibul and Columbia Reserves, to make pastures to graze their cattle. These operators run afoul of our conservation group, Friends for Conservation and Development (FCD), who, along with our security personnel, fight to protect our resources.

Until the US "allows" for the legalization of these natural hallucinogens, and addresses their problem through education and regulation, as all countries should, the turmoil will remain in our region.

Landless Guatemalans are also responsible for some illegal cutting down of forest in Belize. Guatemala has always been controlled by the rich, and a bloody civil war that lasted nearly 40 years didn't end with the masses, mainly indigenous groups, gaining a greater share in that country. The possibilities look ripe to landless Guatemalans when they gaze across the border at the lush Chiquibul and Columbia forests. They have frequent run-ins with the FCD and our security personnel who try to prevent poaching of our prime flora and fauna, and the cutting down of forest to establish farms.

The tension was raised a notch when the Guatemalan Ministry of Foreign Affairs, in a November 19 release, condemned Belize's recent application to take Honduras' claim to the Sapodilla cays to the ICJ. Senator Michael Peyrefitte (UDP) told *KREM News* that Belize has every right to exercise its legal options, and that what Guatemala properly should do is "withdraw" their "unfounded claim."

The comments from Guatemala might have been just gamesmanship. When Guatemala cited delays caused by the Covid-19 pandemic and asked for a 12-month extension to submit its Memorial to the ICJ. Belize's Ministry of Foreign Affairs objected and suggested that 2 months would be sufficient for them. In the end the ICJ settled on a 6-month extension. The present government in Guatemala has not been as belligerent as previous ones, maybe because the claim is before the ICJ, but Guatemala is known to be a bully when dealing with the much smaller Belize. The shooting coming on the heels of the abrasive comments from Guatemala has caused Belizeans to wonder if the shot could have been fired maliciously by the GAF. In September Wil Maheia's Belize Territorial Volunteers planted two Belizean flags on our Sarstoon Island, and the GAF removed them. The flags have since been returned. To date, we don't know what happened on the border on Saturday. Was some careless person cleaning their gun and it went off and hit our soldier? Did someone shoot at an animal in the bush, missed, and the errant bullet hit our soldier? Were unscrupulous parties trying to scare off our security agents so they can have a free run on our land? Did the bullet come from the gun of a member of the GAF? Was the shooting an accident, or intentional?




make popular, the adventures that await there.

## ¿Un acto intencional o un accidente en nuestra frontera occidental?

El 26 de noviembre, un soldado de la Fuerza de Defensa de Belize estacionado en el Puesto de Conservación Valentin a lo largo de la frontera occidental entre Belize y Guatemala recibió un disparo en el trasero por parte de una persona desconocida. Existe cierta especulación de que el disparo provino del lado guatemalteco de la frontera, pero hasta ahora, tal vez porque la herida del soldado no pone en peligro su vida, y el reclamo de Guatemala sobre el territorio de Belize llegó a la Corte Internacional de Justicia (CIJ) para resolución, no ha causado una onda en las relaciones entre Belize y Guatemala. Es probable que si un soldado guatemalteco hubiera recibido un disparo en la parte trasera y se sospechara que el disparo provino del lado de la frontera de Belize, la temperatura habría sido considerable.

Al informar sobre el tiroteo, el Comisionado de Policía, Chester Williams, dijo que saben que el disparo no provino de las existencias entregadas a nuestros soldados porque se habían contabilizado todas sus municiones. El Comisionado Williams dijo que la bala es una clave importante para su investigación, y luego de que se realice un procedimiento quirúrgico en el soldado para extraerla, se enviará al Servicio Nacional de Ciencias Forenses para pruebas balísticas, donde se determinará el tipo de bala, el tipo de arma desde donde se disparó, la dirección de donde vino la bala que golpeó al soldado, entre otras cosas.

Cualquier noticia de violencia en la frontera occidental enciende las alarmas, principalmente por el reclamo guatemalteco sobre nuestro territorio. Como se señaló, ese reclamo se encuentra ahora ante la CIJ, donde Belize, según algunos, increíblemente ha renunciado "en papel" a su soberanía, mientras el asunto esté ante la corte. Algunos dirían que el noble interés de la paz justifica que aceptemos resolver el asunto allí.

Varios incidentes en la frontera occidental han sido extremadamente conflictivos. El Embajador James S. Murphy escribió en su libro, *A Compendium of Relevant Documents – The Guatemalan Claim to Belize*, que el año 2000 fue particularmente malo para las relaciones Belize-Guatemala. Un ciudadano guatemalteco fue muerto a tiros en enero de ese año, cuando una patrulla de la BDF devolvió fuego a los atacantes, y en febrero, en lo que Murphy describe como la violación más grave de la soberanía de Belize, "una patrulla de veinticinco miembros de las Fuerzas Armadas de Guatemala (GAF por sus siglas en inglés) ingresó a Belize, secuestró una patrulla conjunta de cuatro miembros de la BDF y la policía cerca de la aldea de San Vicente, Toledo, hizo marchar a nuestros oficiales de seguridad a través de la frontera hacia Guatemala y luego los acusó de entrada ilegal". Además, en mayo de ese año, una patrulla de la GAF de 25 miembros "ingresó a Belize y se acercó a dos aldeas en el distrito de Toledo".

Más tarde ese año, en noviembre, Belize y Guatemala, bajo la guía de la Organización de los Estados Americanos (OEA), aceptaron la recomendación de los "Facilitadores" — Sir Shridath Ramphal y el Sr. Paul Reichler — de que se creara un régimen temporal en la frontera occidental, como amortiguador entre los dos países. Murphy dijo que este régimen, llamado Zona de Adyacencia, está "compuesto por territorio que se encuentra dentro de un kilómetro al este y un kilómetro al oeste de lo que bancario, talan la selva virgen en el departamento de Petén en Guatemala, y cruzan la frontera hacia Belize y talan la selva virgen que protege las críticas cuencas hidrográficas en las Reservas de Chiquibul y Columbia, para hacer pastos para pastar sus ganados. Estos operadores entran en conflicto con nuestro grupo de conservación, Amigos para la Conservación y el Desarrollo (FCD por sus siglas en inglés), quienes, junto con nuestro personal de seguridad, luchan para proteger nuestros recursos.

Hasta que Estados Unidos "permita" la legalización de estos alucinógenos naturales y aborde su problema a través de la educación y la regulación, como deberían hacer todos los países, la agitación seguirá en nuestra región.

Los guatemaltecos sin tierra también son responsables de la tala ilegal de bosques en Belize. Guatemala siempre ha estado controlada por los ricos, y una sangrienta guerra civil que duró casi 40 años no terminó con las masas, principalmente grupos indígenas, ganando una mayor participación en ese país. Las posibilidades parecen perfectas para los guatemaltecos sin tierra cuando miran al otro lado de la frontera hacia los exuberantes bosques de Chiquibul y Columbia. Tienen roces frecuentes con la FCD y nuestro personal de seguridad que tratan de evitar la caza furtiva de nuestra excelente flora y fauna, y la tala de bosques para establecer fincas.

La tensión aumentó un poco cuando el Ministerio de Relaciones Exteriores de Guatemala, en un comunicado del 19 de noviembre, condenó la reciente aplicación de Belize para llevar el reclamo de Honduras a los Cayos Sapotillos ante la CIJ. El senador Michael Peyrefitte (UDP) dijo a *KREM News* que Belize tiene todo el derecho de ejercer sus opciones legales y que lo que Guatemala debería hacer es "retirar" su "reclamo infundado".

Los comentarios de Guatemala podrían haber sido solo juegos. Cuando Guatemala citó retrasos causados por la pandemia de Covid-19 y solicitó una prórroga de 12 meses para presentar su Memoria ante la CIJ, el Ministerio de Relaciones Exteriores de Belize objetó y sugirió que 2 meses serían suficientes para ellos. Al final, la CIJ decidió una prórroga de 6 meses.

El gobierno actual de Guatemala no ha sido tan beligerante como los anteriores, tal vez porque el reclamo está ante la CIJ, pero Guatemala es conocido por ser un matón cuando se trata de Belize, que es mucho más pequeño. El tiroteo que se produjo inmediatamente después de los comentarios abrasivos de Guatemala ha hecho que los beliceños se pregunten si la GAF podría haber disparado maliciosamente. En septiembre, los Voluntarios Territoriales de Belize de Wil Maheia plantaron dos banderas beliceñas en nuestra isla Sarstún y la GAF las retiró. Desde entonces, las banderas han sido devueltas.

Hasta la fecha, no sabemos qué pasó en la frontera el sábado. ¿Estaba una persona descuidada limpiando su arma y disparó y golpeó a nuestro soldado? ¿Alguien disparó a un animal en el monte, no le dio a su blanco y la bala errante golpeó a nuestro soldado? ¿Estaban intereses sin escrúpulos tratando de asustar a nuestros agentes de seguridad para que pudieran tener una carrera libre en nuestra tierra? ¿La bala provino del arma de un miembro de la GAF? ¿Fue el tiroteo un accidente o fue intencional?

The case of the missing businessman, Owen Tucker, intrigued me, despite my semi-retirement from case research. It was a routine "missing person" announcement in the media early last week, but after a couple days it seemed to me that I knew this name. I did not recognize the 66-year-old person in the photograph, but the name seemed somehow familiar.

Our newspaper has a brilliant lady (computer specialist) who works with us who lives in Biscayne, the area from which Mr. Tucker had disappeared.

I believe it was on Saturday afternoon that I got Deshawn's cell number from Jacinta, the business manager, and called Deshawn, who began to fill in some of the vacant spaces in the story.

By then, it seemed to me that Owen Tucker was a person who had attended Wesley College in the mid/late 1970s and had won a Belize Open Scholarship. But, he had been abroad for many years, and I couldn't find anyone to confirm my speculations.

Now, I no longer research stories at our newspaper. But, here was a Belizean who had made a major investment in the Crocland project which had been a Luke Espat concept during the days in the early years of this century when Michael Ashcroft was pouring money on him like crazy, and the daring Luke had bought the Port of Belize, begun the Crocland project and begun building the Renaissance Towers mega hotel. Spectacular stuff, by Belizean standards.

The Owen Tucker investment in Crocland indicated that he was moving in the big leagues of business. How does a man who is so big disappear from the same area, Biscayne, where his major business investment is located?

On Monday this week, I made contact with a source who directed me to a fairly close Owen Tucker relative, who is himself a business powerhouse in Belize. His company secretary gave

La inversión de Owen Tucker en Crocland indicó que se estaba moviendo en las grandes ligas de los negocios. ¿Cómo un hombre tan grande desaparece de la misma zona, Biscayne, donde se encuentra su principal inversión empresarial?

El lunes de esta semana, me puse en contacto con una fuente que me dirigió a un pariente bastante cercano de Owen Tucker, quien también es una potencia empresarial en Belize. La secretaria de su compañía me dio un número de celular, después de lo cual me puse en contacto con dicho pariente y me presenté.

La conversación no se alargó, porque no quería involucrarlo en este asunto que comenzaba a parecerme completamente trágico. Quería que confirmara los aspectos del Colegio Wesley y la beca abierta de la biografía de Tucker, y lo hizo. Owen Tucker había discutido su inversión en Crocland con su pariente, pero no habían estado en contacto durante tres semanas antes de la desaparición de Owen. Ahora bien, esta es una historia para que nuestros periodistas locales profundicen. Para mí, lo que me enoja es cómo un beliceño que trae dinero del extranjero para invertir en su tierra natal es asesinado de manera tan brutal. No conocí al Sr. Tucker personalmente, pero lo recuerdo como un joven tranquilo y respetuoso. Hace un par de semanas escribí que no reconozco este Belize de 2022. Este incidente es una advertencia para los beliceños que deciden regresar a casa después de un largo tiempo en el extranjero. Este lugar está fuera de me a cell number, whereupon I made contact with said relative, and introduced myself.

The conversation was not extended, because I did not want to involve him in this affair which was beginning to appear completely tragic. I wanted him to confirm the Wesley College and Open Scholarship aspects of the Tucker biography, and he did. Owen Tucker had discussed his Crocland investment with his relative, but they had not been in contact for three weeks before Owen's disappearance.

Now this is a story for our local journalists to dig into deeper. For me, what angers me is how a Belizean who brings money from abroad to invest in his native land is murdered so brutally. I didn't know Mr. Tucker personally, but remember him as a quiet, respectful young man.

A couple weeks ago, I wrote that I don't recognize this Belize of 2022. This incident is a warning to Belizeans who decide to return home after a long while abroad. This place is out of control. One of the reasons for The Jewel being out of control is that bigtime business people in the "legitimate" circles are in contact with the most violent "shatazz" in the streets.

I am reminded of the Therese Blake

murder near her home in the exclusive Barracks area. The millionaire heiress daughter of the business magnate, James Blake, Therese was shot and killed in her own vehicle two decades or so ago. As I remember it, this sensational murder was never solved. Of course, this is how it is with the vast majority of murders in Belize.

Belize is a country which began living a lie after political independence in 1981 and after the first change of government in 1984. Mr. Price was not a saint. There were people close to him who had gangster tendencies, but I don't believe things were out of control, not the way they are now. Mr. Price had the personal power to keep things Belizean under relative control.

To me, insanity began when Belize began selling passports and opening our society to total strangers, massively wealthy strangers, and so on and so forth. Some Belizean attorneys got very rich off this exercise, but various, traditional aspects of our society began to unravel.


Owen Tucker returned to a Belize where life is cheap. This was not The Jewel he left after winning the Open Scholarship. It is terrible what was done to him. And for what? A small business dispute?

## The United States of Gun – The Story Never Ends

Literally a week does not go by without another mass killing in the United States. Recently, the death toll has been increasing like the scoreboard for some insane video game, with mass killings every few days. And there is no end, indeed not even respite, in sight.

It is ironic that in a country that claims some kind of exceptionalism that the carnage continues unabated. The gun lobby and the gun manufacturers literally insure with their massive political donations and 24-7 propaganda machine that there will always be a critical mass of lawmakers in virtually every state and always in the Congress that will block any meaningful changes in the laws in the near, and sadly, bloody future.

With a Supreme Court that has now established a new and lethal interpretation of the Second Amendment which will very likely result

in opening the remaining floodgates that will result in a virtual tsunami of guns and consequent deaths. And the irony is that the Second Amendment literally says nothing about the right of individuals to own guns, to wit:

A well-regulated militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed. (emphasis added)

Even a casual visitor to the pages of the Constitution with only a gossamer thread of knowledge about American history will know that the Second Amendment was the reflection of the very real memory of the British colonial power dismantling state militias that were key to the American Resistance in 1775 and onwards. There is literally no indication in the writings of Madison, Hamilton, Franklin and any of the other key framers of the Constitution that the Second Amendment was intended to mean that every person had a constitutional right to own a gun.

Even granting that the Constitution has been reinterpreted to reflect the times, the reality is that well over 60 percent of the American population, when asked, favors some kind of gun control laws, rules and regulations. Yet we are supposed to believe that this socalled inalienable right is worth the lives of tens of thousands of men women and children who die from guns.

In this country guns are the leading cause death among of children (emphasis added). There is no so-called developed nation on the planet that would find that such a statistic as acceptable. Yet in this so-called exceptional country the proponents of gun carnage will send their crocodile tears and empty thoughts and their profane prayers to the survivors and this daily deluge of blood.

Almost exactly ten years ago, a 20year old by the name of Adam Lanza

killed his mother and then went to the Sandy Hook Elementary School where he shot and killed 26 people, including 20 children between the ages of 6 and 7 years of age with an AR-15 style automatic rifle. And then he shot himself in the head.

Reports of the carnage were too awful to photograph. Let it suffice to say that the carnage was so complete that parents of the children were only able to identify their sons and daughters by the clothing that they had been wearing when they left for school or, in some truly horrific cases, only by DNA evidence.

It was said at the time that, if this country could not do something about gun violence and mass shootings after Sandy Hook, it never would. And then.... in the last ten years this country has done nothing of substance.

If, ten years after Sandy Hook and after ten years of more dead men, women and children this country cannot seriously address the issue of gun violence, then it is quite possible that this country will shoot itself to death in some kind of demented suicide pact.

This country has more guns than people. And if this killing continues unabated, there will continue to be fewer people than guns.

There is no rational interpretation of the Second Amendment that justifies any American should be forced to live in the United States of Gun in order to satisfy the insatiable greed of gun manufacturers and those men and women who foresee an apocalypse where only having a gun will save you.

Clearly, this story never ends.

## **D-Line's scintillating chilena**

Hey, the World Cup is on. It happens every four years, and every time I am reminded of our greats in the period when I was a child. This WC is the most controversial one ever, and how the US and Iran clashed in a do-or-die match to decide who would move on to the knockout round, well that couldn't be scripted. No, I don't agree with cynics who I expect are saying that for losing, all the Iranian players will get green cards to the land of milk and honey within the next few years. The US is boring, but if it's about money, I would have put mine on them over Iran in Qatar.

A fan of Pelé linked me to the Richarlison goal for Brazil that has everyone talking. Nice, very nice. It earned its place to be talked about, quite rare indeed, a shot that demands quite a skill set and presence of mind. *The Business Standard* called it a bicycle kick, and the title of its article discussing that goal is, "A bicycle kick goal in World Cup: A feat that Pelé couldn't but Richarlison could achieve." But it wasn't the true bicycle kick, not the true chilena.

In the article, the *Standard* said Pelé wrote in his autobiography, "I have just three-four of my 1,283 goals with a bicycle kick. It's difficult, and my greatest regret is that I have never scored a bicycle kick goal in a World

Cup." The *Standard* says a bicycle kick goal is "as rare as it gets," and it "combines spontaneity and science, art and acrobatics, physicality and elasticity." Yap, it does. The *Standard* says one Sandip G, writing about the bicycle kick in a recent *Times of India* report, said: "It is like a bullet fired from the paintbrush of an artist, designed in the needle of a geometrician's compass, requiring a dancer's feet, a bullfighter's physicality, a poet's imagination and a gambler's enterprise for the perfect execution."

Richarlison's goal was the mucheasier-to-pull-off scissors kick. Ah, I've seen a picture of Pelé pulling off a true chilena. I saw D-Line pull off one too. It's no ordinary feat.

Hey, some of this story might be old news from this corner, but I'm certain there are some snippets here that I haven't related before. In the mid to late 1960s, Landivar, Independence, and BEC were the big Belize City teams. There were tournaments that included the top teams from the districts, and some not so tops. I saw Queen's Park Rangers. Salada Eleven wasn't so good. I loved the flamboyant Columbus and the delightfully named Rummy Martinez of La Victoria. The brother might have been named Romel, so drink a rum on a Krismos maanin might have had nothing to do with his colorful moniker.

Big Fred Martinez was a fearsome

striker from San Joaquin, and the midfield of that club featured the elegant Malanga; their tireless and acrobatic full back, P&G, and their lockdown stopper, hmm, can't remember his name today. I didn't like Maya Ortega of Avengers because Cayo-ans and Independence haters said he was better than my heroes, Di Mohga and Big Mole.

Peeta of R-A-C became an immortal, my hero forever, when he stopped Keith Gardiner's penalty in injury time to preserve a 2-1 victory over the hated Landivar. But I wasn't pleased with his team's leader, D-Line, when the following week he led R-A-C out of the MCC Grounds at halftime after a disputed call. I held my seat behind the southern goal for some time, hoping R-A-C would return to the field, until the word came that they were well on their way to the Hummingbird in their truck.

I worked hard to earn my 10 cents, the fare for the games on the weekend. From midday on Saturday I was a perfectly behaved boy, and on Sunday mornings I put on my dress pants and shirt, and shoes, and went to mass, all just so my mother didn't ground me on Sunday afternoon.


D-Line wasn't thinking of little ball hounds who lived for Sunday afternoons at the MCC when he pulled his team. Worse was to come the following season. That year, Landivar, the richest club in Belize, loaded up like the daam Yankees and Dodgers. In those days players were lucky to get an orange at half time. I learned that after games Salva Habet, Landivar's owner, took his players to a club and treated them to fried chicken, a "whole" half bird. In the 1960s chicken was expensive, a Sunday dish only, definitely so in the city. Madaz, a "whole" half chicken!

With the Gardiner brothers, Keith and Charlie, and Angus, Landivar was already a super team, but they went on a raid that gutted their closest rivals, Independence and BEC. Those bohgaz, they plundered Koako, Baba, and Gyas from Independence. They snatched, more likely bought, the flamboyant goalkeeper, Bowza, from BEC, and that club's midfield general, Mimi. They had Kalibuhm on their right wing, but I believe they'd recruited him from the year before. And they went to Stann Creek and stole D-Line from R-A-C.

That season was no contest. No, no team in this country, maybe no team in the world could have matched Landivar that year. But ball hounds, they never give up. Sometimes lee man do fall big tree. So, when BEC played them, I was on the bench behind the southern goal, praying for a miracle. BEC always gave Landivar trouble, but not this time.





## No plans for seismic testing YET, says PM



BELIZE CITY, Wed. Nov. 30, 2022 Oceana Belize is currently collecting the signatures of Belizeans as part of an effort to trigger a referendum on whether or not the government should seek input from the public before issuing approval for any type of offshore exploration. The environmental organization, which is dedicated to preserving the marine environment, is, in essence, seeking to oblige the government to carry out a referendum if they desire to conduct any offshore activity.

Vice President of Oceana Belize, Janelle Chanona, explained to the media a few weeks ago at a press conference that in a September 9 conversation she had with the Prime Minister, Hon. John Briceño, he allegedly confirmed his administration's desire to proceed with seismic testing in Belizean waters

without the prior approval of the public-despite a moratorium against offshore exploration in Belize.

Such a course of action by GoB, however, would have to be presented to, and approved by, the National Assembly before the commencement of any such undertaking.

PM Briceño says that no such confirmation was given and that no plan for seismic testing has even reached Cabinet, but when asked if such plans might perhaps be in the pipeline, he said that it would have to be "addressed sooner or later."

Shortly after Oceana's press conference, at which Chanona announced the petition drive and revealed that the current administration may want to engage in offshore oil exploration, the government issued a press release which stated that the administration simply wants to be able to identify and quantify what natural resources, such as oil or natural gas, might be lying below the seabed in the outer bands (beyond the reef) of our exclusive economic zones for the purposes of leveraging/negotiation.

When interviewed recently, PM Briceño said, "I'm saying from our perspective, what is it that we want to do, if we get to the point where there could be potentially oil in our exclusive economic zone, again not by the Barrier



## Russians at the border

I was reading an article in the NYT highlighting the fact that Russians fleeing the war, and who end up at the southern borders, are being detained in immigration prisons. ## TO GOB: PUT IN PLACE LANGUAGE/CULTURE CURRICULUM FOR ALL ETHNIC GROUPS

It is to the advantage of all governments in this world to have a language and culture curriculum for all the ethnic groups in their countries. This will help the ethnic groups to know more about each other's cultures, to foster mutual respect and understanding among themselves as citizens of their nation states. Especially countries like Belize that were colonized by Great Britain and other European colonizers which took away their rights as citizens to speak their languages and practice their culture. It can also help to build the country's nationalism and to reduce prejudice and racism. Racism exists in Belize just as it does in many other countries in this world. Many of our Belizean people do not want to accept this fact, which we experience in our daily lives in our country.

We the Garifuna people are among the 400 million people on this earth who speak one of the 6,000 indigenous languages that exist. Most of us are struggling to preserve our languages that we have been speaking for centuries before the Europeans came to our lands and established their colonial rule. They then passed decrees and laws forbidding us from speaking our native language and practicing our culture. This is what the French and the British did to us in our native land, "Yurumein," now known as St. Vincent and the Grenadines, up until the war ended in 1796. About 5,000 of our people were removed from our mainland island and taken to one of our other islands, Balliceaux, where we were tortured, imprisoned, killed, and some of our people were buried there.

In 1797, about 2,500 of our people who survived the torturing, inhumane treatment and conditions they endured at Balliceaux, were packed up like cargoes and taken to the island of Roatan in the country of Honduras, where they were dumped on April 12, 1797. At the time our people arrived in Roatan, our language was already mixed with French. Now that we were brought to Roatan, our language was influenced by the British and the Spanish. Both the British and the Spanish did not want us to intermingle with the other ethnic groups in their colonies, so they isolated us from them.

The British hated us because of the fight we waged against them, to protect our nation and to avoid being their slaves. They also did not want to run the risk of our people assisting the slaves in Saint Vincent, the neighboring islands, Belize, Nicaragua and their colonies to rebel against them for their freedom. This was also the same for the Maya and other indigenous people in Central America who were victims of Spanish colonization and genocide.

Like the French and the British, the Spanish established their language as the official language for all their colonies. The Indians fought to retain their land and preserve their language and culture by running away from them. Yet, the Spanish pursued them and killed all those who resisted their rule. When the French, British, Spanish, and the other European colonial countries made their languages the official languages for their colonies, they did this with the intent to eradicate all the other languages that were spoken in their occupied territories. Why? Because they knew that the language of an ethnic group is the essence of their culture.

Once the native languages were removed by them, they were in a better position to control and subjugate the people. We the Garifuna people, because of our isolation from the other ethnic groups in these countries, were able to speak and maintain our language. As time went by, these countries decided to set up an educational system where everybody must go to school and learn only their languages. In schools located in Honduras, Nicaragua, and Guatemala, all the various ethnic groups were learning how to read, write and speak Spanish, and in Belize and parts of Nicaragua, English.

They introduced new languages to the Garifuna people in these territories for their economic, political, and social survival. As a result of this, Garifuna people focused on learning how to speak, write, and read these languages while some of them were neglecting their own Garifuna language. Most Garifuna people cannot write or read the words in their native language, because there were no native schools in most of their communities that taught them how to read and write Garifuna. Under international law, it is the responsibility of all governments to facilitate, accommodate, and assist the indigenous people like the Garifuna to preserve their language and culture. UNESCO and other international organizations have been providing funds to most countries for this purpose. Most countries have signed on to these international agreements, including St. Vincent and the Grenadines, Honduras, Nicaragua, Guatemala, Belize, and the United States. Yet, they have no program in place for the Garifuna language and culture to be taught in their schools. This is the same for the other ethnic groups in Belize.



analyze our Garifuna language in the countries where we live, we must do the following things:

- Continue to speak and teach our language to our children at home
- Open schools in all of our communities to teach our people how to speak, write, read and analyze our Garifuna language
- Bring a case against the governments in all the countries where we live who signed Treaties, Conventions, ILO-169, and other international agreements to teach our language in schools
- Interact with Garifuna people who live in other communities and countries to conduct language workshops and symposiums
- Establish an International Garifuna Language Institute (IGLI) with representatives from all the countries where we live to be responsible for the preservation, promotion, and protection of our language and culture.

This organization should be under the jurisdiction of the Garifuna Nation and it is a necessary body to preserve our language and culture, introduce new words, deal with all aspects of the language, and gain worldwide recognition. Once we establish the IGLI, the members of this organization will be able to do a thorough evaluation of the current state of our language and culture, make recommendations on how to improve, preserve, and protect it. In my research, the late Vilma Roches-Joseph, a Garifuna scholar who did extensive research on our language, said that most of our people do not want to speak our language because of shame and low selfesteem.

I also think that we should include the following among the reasons our native language was not spoken to us in our homes: acculturation with other ethnic groups; peer pressure in the communities where some of us live; absence of persons to speak the language with regularly; resentment from other Garifuna people like ourselves who know how to speak the language; while some of us do not understand the value and benefits of our rich history, language and culture. We know the obstacles we face with our history, culture, and language; now is the time for us to come together and correct the injustice.

## No plans for seismic testing YET, says PM

Reef. Then we can take that and leverage it and go to the other countries or to these international NGOs and say 'okay, we will leave it there but pay us for it so that

we can use that money," PM Briceno said. Oceana's Vice President has suggested, however, that seismic and sonar testing are a clear indication of the intention on the part of GoB to engage in offshore oil exploitation, and as one Oceana article that was published earlier this year points out, "Where they drill, they spill."

PM Briceño said that if Oceana Belize successfully gathers the number of signatures to trigger a referendum, his administration would be able to "take a look", but he said that it is the Cabinet that would make that decision.

## Teen charged for friend's death in RTA

BELIZE CITY, Wed. Nov. 30, 2022

William Faux, 19, a resident of Ladyville, Belize District, was charged in the Magistrate Court in Belize City on Tuesday with multiple offenses in connection with the death of his best friend, Daniel Thompson, 19, who was riding on a

motorcycle when he was hit by Faux's car between Miles 12 and 13 on the Philip Goldson Highway on October 14.

The incident occurred at around 1:00 in the morning, after what was reportedly a night of socializing/partying by the two young men, who had seemingly arranged to head to another destination, with Thompson, a Ladyville resident, driving

there on his motorcycle while Faux followed closely behind in his car. They were reportedly en route north on the Philip Goldson Highway, toward the Burrell Boom when junction, Thompson's motorbike, which reportedly was missing its tail lights, was hit by Faux's Dodge Challenger, which caused Thompson to be flung several feet away from the

highway. He died not long after of the injuries he sustained.

Faux was charged on Tuesday, November 29, with manslaughter by negligence, causing death by careless conduct, and driving a motor vehicle without due care and attention. He was granted bail in the sum of \$10,000 and is scheduled to reappear in court on January 30 of next year.





## Number of burglaries is up!

BELMOPAN, Thurs. Dec. 1, 2022

At a recent press conference, the Commissioner of Police, Chester Williams, acknowledged that, despite what is appearing to be a decrease in the number of murders in 2022 compared to last year, there has been a considerable uptick in the number of burglaries.

Williams made reference to data from the Belize Crime Observatory, which indicates that the number of murders at the end of October this year was 7% lower than the tally of murders at the same time last year, but that the number of burglaries has so far increased by 12% compared to last year's numbers—with the number of burglaries in 2022 already exceeding the total number of burglaries last year.

"Burglaries are killing us. Unfortunately, it has my stats looking bad, but at the end of the day, to prevent burglaries requires more than the police. Many of these burglaries are a result of carelessness on the part of homeowners, and so homeowners need to do more in terms of securing their property, and their homes when they leave. Neighbors need to do more in terms of looking out for each other. You find that sometimes a neighbor leaves, and the other neighbors don't know, and so when you see light on and things happening at the house, they think the neighbor is there ..," said Williams.

Williams said that, with the Christmas holidays approaching, there will be an increased police presence as part of what he referred to as a burglary campaign.

"What we will do for the Christmas season is to do a burglary campaign. We'll create some fliers and we'll have our community policing officers, and even when we do our weekly meet and greet, go out and issue these fliers and talk to people and see how best they can help to secure their properties. And I have also directed the commanders to go on the talk shows in their respective areas and give tips about how people can do to prevent burglaries and to secure their homes, so we'll see how that goes. That is a contributing factor and that's the reason why people should try and do more to protect their properties and avert these burglaries from occurring," he said.

In September, the Guatemalans disrespected Belizeans when their soldiers uprooted Belizean flags from the Sarstoon River island and took the flags to Guatemala City.

A few days ago, the Guatemalans again disrespected Belizeans when they described Belize's recent approach to the International Court of Justice (ICJ) to turn back Honduras' claim to the Sapodilla Cayes as "deplorable." "Deplorable," because Guatemala says the Sapodilla Cayes are theirs, even though the cayes have never been recognized as such by the regional or international community.

A few years ago, then Guatemalan president, Jimmy Morales, massed troops on Guatemala's border with Belize because he claimed to believe that a Guatemalan youth trespassing in Belize had been murdered by Belizean soldiers. These were a frightening few days for Belizeans.

What we are about today is establishing a pattern, a pattern where the militarily superior Guatemalans speak and behave disrespectfully to Belizeans about our 8,867 square miles of Jewel.

Now Russia's invasion of and war with Ukraine has proved that the technology of modern military equipment can enable a smaller, weaker nation to neutralize the size advantage of a larger one.

But in order for such modern military

technology to have an effect, the smaller nation must have fighting morale, which Ukraine has demonstrated that it does. This is not the case with Belize, where most citizens, it seems to me, still have a mental dependency on the British where any Guatemalan emergency is concerned.

There is an old cliche which says that you cannot have your cake and eat it too. Belizeans who have migrated to the United States believe they still have a vital stake in Belize, the nation-state. I agree, but successive Belizean governments have indicated that they do not hold the Belizean diaspora in high regard where the ICJ and the Belizean constitution are concerned.

The new Belize government elected two years ago has done a lot of talking about changing "competencies" and other technical matters in education, but there has been almost nothing said by their spokesmen about African and Mayan history.

Well, the truth of the matter is that the Maya are the best jungle fighters in Belize's little army, and the fearless Garifuna (of African origin) comprise probably the largest percentage of that army.

The truth about Maya history in this region is important if one wishes to expose the injustice and cruelty of the military/corporate oligarchy in Guatemala. There was a very bloody

civil war fought in Guatemala between 1960 and 1996, and while there were ideological issues involved, the ethnic issue was large. Guatemala is a racist nation, and the large, probably majority, Maya population is considered and treated as inferior.

We come now, in this brief essay, to the so-called Creole population of Belize, a population which features many spokesmen who refuse to consider themselves African, as such. What is the reality? British pirates and business investors brought our African ancestors here in chains for a specific purpose from the seventeenth to the nineteenth centuries: our ancestors worked the forests here, the British made a lot of money, and our women and children had to dump our waste into open sewers in Belize Town.

There were rebellions by our ancestors in 1894, 1919, 1934, and 1950, and after we achieved selfgovernment in 1964, we believed that we were about to inherit these 8,867 from the British enslavers and colonizers. In 1964, we Belizeans knew almost nothing about something called "corporations." And we knew next to nothing about the international Cold War, a fight for ideological control of the post-colonial world.

The Creoles, by 1964, had developed a superiority complex with respect to the Maya and the Garinagu. This was a complex which was created and nurtured by the British. That is why I have said that you must read Peter Ashdown's essay on "Creole Historiography" in order to understand what has gone on here since 1964.

I hope that Audrey Matura's new organization will encourage discourse and debate about some of these issues which the academics controlled by the Roman and Anglican churches pretend do not exist. In a way, I don't blame the present academics for being scared: the Roman and Anglican Churches are used to maintain European supremacy by the neoliberal corporations.

'Nuff said.

En septiembre, los guatemaltecos faltaron el respeto a los beliceños cuando sus soldados arrancaron banderas beliceñas de la isla del río Sarstún y las llevaron a la Ciudad de Guatemala.

Hace unos días, los guatemaltecos volvieron a faltarle el respeto a los beliceños cuando describieron el reciente acercamiento de Belize a la Corte Internacional de Justicia (CIJ) para revertir el reclamo de Honduras sobre los Cayos Sapotillos como "deplorable". Estos fueron unos días aterradores para los beliceños. De lo que tratamos hoy es establecer un patrón, un patrón en el que los guatemaltecos militarmente superiores hablan y se comportan de manera irrespetuosa con los beliceños sobre nuestras 8,867 millas cuadradas de la Joya. Ahora, la invasión de Rusia y la guerra con Ucrania han demostrado que la tecnología del equipo militar moderno puede permitir que una nación más pequeña y más débil neutralice la ventaja de tamaño de una más grande. Pero para que esa tecnología militar moderna tenga efecto, la nación más pequeña debe tener una moral de lucha, y Ucrania ha demostrado que la tiene. Este no es el caso de Belize, donde la mayoría de los ciudadanos, me parece, todavía tienen una dependencia mental de los británicos en lo que respecta a cualquier emergencia guatemalteca.

Hay un viejo cliché que dice que no puedes tener tu pastel y comértelo también. Los beliceños que han emigrado a los Estados Unidos creen que todavía tienen un interés vital en Belize, el estadonación. Estoy de acuerdo, pero los sucesivos gobiernos beliceños han indicado que no tienen en alta estima a la diáspora de Belize en lo que respecta a la CIJ y la constitución de Belize.

El nuevo Gobierno de Belize elegido hace dos años ha hablado mucho sobre el cambio de "competencias" y otros asuntos técnicos en la educación, pero sus voceros no han dicho casi nada sobre la historia africana y maya.



## CCJ "disappointed" with GoB's handling of FPIC

communal land rights, ordered that a reconciliation process be put in place as soon as possible.

The spokesperson for those groups further noted to 7News, "The document is, as far as our views go-that document is still being negotiated. As you heard, even the court expresses its disappointment in saying that how can party finalize an FPIC Protocolsomething so important to the implementation of their order. How can one party implement this FPIC Protocol without the other party even seeing the last or the final version? We should learn-all of us, Belizeans, Maya people in Toledo. The only reason we still enjoy the use and enjoyment of our lands is that we have struggled for the recognition and respect of our rights. And so, we rely on the wisdom of the Caribbean Court of Justice. I heard the President resoundingly say yesterday that we must be reminded that this desire to - this

implementation of the consent order did not arise out of a pure desire of the Government to do good for its people. In fact, it arose out of litigation. We had to fight for it. We had to struggle for it. And so, it reminded the Government that there are litigants on the other side, that you cannot be doing this unilaterally, that we, as Maya people, have a stake in how this consent order is implemented, and that the court itself has an interest in how its order is implemented."

Upon his return from Venezuela earlier this week, Prime Minister Briceño briefly mentioned the FPIC Protocol in relation to potential oil exploration in Toledo during a media briefing. PM Briceño said that the Commissioner of Indigenous Peoples' Affairs, Gregory Ch'oc, has been consulting the residents in the area to get their views on potential seismic testing in the area:

"I had a meeting two Fridays ago in the Toledo District where I met 60 acaldes and chairpersons. None of them were talking that they were against oil

exploration – not a single one of them. Now, the Commissioner is going his job. The Commissioner - since they're going to have under the FPIC they're going from village to village to meet with the villagers to inform them on what's going on and try to see whether they will get the support or not. He's just there as the witness, he's not there to encourage them one way or the other. I can tell you that several villages have informed me that they have signed a petition. They have signed that they want the seismic test to commence because they believe that by doing that, they can again create jobs for them," he said.

Christina Coc, however, has challenged that assertion by the PM.

"... As far as I'm concerned, the meeting that happened in Toledo - while I was not there in person, members of my team and the Toledo Alcaldes Association were present. At no point was US Capital's development discussed at this meeting. Yes, there was a meeting, and there was an audience

with leaders of many villages, but at no point. So, how would the communities have yes, I am for US Capital, or no, I'm not for US Capital? How would they have said that? And to simplify it to that point, the Maya people have never been against development. We have always been protecting the communities against exploitation. So, you can't just ask, do you want oil exploration or not, right? We want to be able to explore, through a free prior informed consent process, what will result. If we end up with at a consent agreement that upholds the conditions that the communities set, that upholds the standards that the communities set, and upholds the benefit-sharing and compensation, that the communities desire, then the communities are at liberty to give their free prior informed consent, right? But, you can't just go and tell the community, [whether] you want US Capital or not. That is not the consent process. That is not due process," she told a 7News reporter.



## New activist group, MAT, formed by Audrey Matura

The new group, the brainchild of activist attorney Audrey Matura, brings together influential members of the community focused on "removing the shackles of the PUDP"

#### BELIZE CITY, Wed. Nov. 30, 2022

A group of about one hundred Belizean citizens living both within the country and overseas have formed a pressure group named "Moving Ahead Together", which was officially launched in Belize City on Saturday, November 26, at the first meeting held by the group. It is an initiative that was organized by firebrand attorney activist Audrey Matura. Matura stated during an interview before the opening ceremony of the group's launch that she got the idea to form the group while personally reflecting on this year's Emancipation Day, and when she put out a call for members in a Facebook post, over 100 persons reached out to express interest.

"It's not people I've met, I've known; we are meeting here for the first time," she said. The band of Belizeans from various sections of the community and diaspora have together outlined one objective of their organization: improving the quality of life of Belizean citizens, which, in their view, will require "removing the shackles" of the so-called PUDP.

"It's about unity. I know there are enough Belizeans who are of like minds, and the other message would be to remove the shackles of the PUDP that you are used to, remove the shackles where your leaders control you. You actually have the power and you don't know it," Matura said.

The keynote speaker at the event was the president of the Belize National Teachers Union, Senator Elena Smith, who chronicled how her life of

activism has resulted in victimization from the highest levels. She urged members to prepare themselves for the persecution that will come.

"If you're not prepared for the pushback, then you are going to fall aside, and when we have these movements, we don't want people who are going to be starting and stopping halfway because they get frightened, they get scared, you know. Somebody threatens them, somebody begins to bully them. You have to have that courage to understand that, listen, this is a part of this journey, and if I will take this journey seriously, I must understand that it comes with those things," Senator Smith noted.

Four guest speakers delivered remarks during the meeting: Nigel Petillo, a wellknown land activist; Cristina Coc of the Maya Leaders Alliance; Louis Wade, Jr.; and attorney Richard "Dickie" Bradley.

Matura indicated that the MAT will serve as a support group for other movements with which they are aligned, and their next endeavor will be to recruit members from home and abroad. She said that every member is required to recruit two other persons and is also asked to fundraise on behalf of the movement.

She also said that members of the organization contributed \$100 each, and additionally a small businessman made a contribution of \$250 and the United States section of the group donated \$800, which covered the remainder of the group's initial expenses.

This project is to be extended countrywide including the Cayes and the PSWT is in the process of negotiating with and signing MOUs with supermarkets in the other district locations.

Finally, the PSWT wishes to remind its beneficiaries countrywide the Health Project remains ongoing and a total of **18** MOUs have been signed with health service providers in all six districts. Beneficiaries who have not yet accessed the health project can do so by contacting the offices of the PSWT to start the process.

Besides fundraising and recruiting, Matura expects to engage in a country tour with the help of the executive members located in the various districts. The goal is to visit all villages in the country by next year, to hear from the people in their communities.

"I know how to network and to align myself with groups that are already in existence so that I channel through them. I'm not inventing the wheel. I'm just taking the message, and I'm taking the message in English and in Spanish," Matura said. Matura added that eventually, she will travel abroad to meet with the diaspora. "This is full movement," she said, and when asked if the MAT may possibly evolve into a political party, she simply said, "if it is to be, it will be."



## Blue Economy Ministry hosts Climate Resilience Forum

BELIZE CITY, Thurs. Dec. 1, 2022 The Ministry of Blue Economy and Civil Aviation has partnered with the UN's Food and Agriculture Organization and the Green Climate Fund to organize the 2022 Blue Economy Climate Resilience Forum, which is being held on December 1st and 2<sup>nd</sup> at the Civic Center. The event is taking place on the heels of COP 27, which was held in Egypt early last month and will focus on topics such as Marine Spatial Plan & The Blue Economy, The Role of Vulnerable Groups in the Blue Economy, and Blue Economy & Climate Resilience Nexus.

Day one featured a series of informational sessions which included panel discussions, presentations and conversations between experts and the audience in attendance. Day two will take on a more informal atmosphere and will feature an information booth, entertainment, and the sale of seafood and other local goods made from marine products.

The Chief Executive Officer of the Ministry of the Blue Economy, Kennedy Carrillo, met with the media on the first day of the event to discuss how impactful the event and the blue economy overall can be for all Belizeans:

"We have a large expanse of blue from the Corozal Bay all the way down to the Sapodilla Cayes. We have our territorial waters, and we even have our EEZ Zones, where we know that there is so much capacity for economic growth and investments. And so, we want to make sure that every single Belizean has an opportunity. And that is our role as a ministry. Because it's easy to get the large lobster producers and exporters involved. It's easy to get people who want to get involved in seacucumber and in exporting crab claws and so on. But what about the young people? What about the women? The children in the small communities? The coastal communities that have such an intimate relationship with the sea? How can they take advantage, but also have the necessary support? So when we speak right now about the MSME's, that's a big thing right now. Blue Economy is an integral part of this, because we want to make sure that these incentives will also be able to reach the small fisherman in Seine Bight. It will be able to reach the young people in Hopkins that want to get into jewelry making. It will reach the women in Monkey River that want to do something about their situation as well," Carrillo said. CEO Carrillo also discussed the importance of building Belize's resilience to climate change and noted that the country is ranked at number eight out of over one hundred countries that are most vulnerable to the effects of climate change.



## **Belize's Pok-ta-Pok/Ulama team** wins gold in Mexico

Over the weekend, а national Pok-ta-Pok/Ulama team consisting of seven players from Yo Creek, Orange Walk District; Ladyville, Belize

District; and San Pedro Town, Ambergris Caye, competed in the 7th Ball Mesoamerican Game Championships in Playa del Carmen, Mexico and won gold medals.

The team, which was sent to the tournament by the Belize Hipball Association, competed in the game, Ulama, which is a ball game played in Mexico, and is derived from the Aztec version of the Mayan ballgame, Pok-ta-Pok, which is considered one of the oldest played sports in the world and the oldest known game using a rubber ball. According to an article about the sport on hobbylark, com, "The objective of the game was to get a ball through a narrow stone hoop placed on the court wall, often as high up as 20 feet from the ground. Players were not allowed to use their hands or feet-only their head, shoulders, elbows, wrists, and hips."

The Belize team was defeated in their first match, which was played against Mexico, but redeemed themselves in a

## End of the road for Waterloo cruise project?

Holdings Limited have the option of taking the National Environmental Appraisal Committee (NEAC) or any department of the government to court if they so choose.

While Minister of Sustainable Development, Climate Change and Disaster Risk Management, Hon. Orlando Habet, confirmed to KREM News the NEAC's decision to deny approval of Waterloo's project, there has as yet been no official announcement by the NEAC or the Department of the Environment of the decision. Neither has there been a government press release or any other comment by a member of Cabinet on the matter. Hon. Habet himself has, since the KREM News interview, been evasive about the issue when questioned by other media outlets.

Much controversy surrounded Waterloo's second project proposal submission, after the public became aware of a strongly worded letter from Ashcroft to Prime Minister Briceño (sent in January of this year) in which he warned the government of a possible arbitration proceeding due to what he (Ashcroft) alleged was a violation of the 1982 UK Belize **Investment Promotion and Protection** Agreement treaty signed between the UK and Belize. In the letter, Ashcroft stated that he and the UK shareholders of Waterloo had already invested more than 5 million dollars in the project and were thus entitled to compensation under the 1982 agreement. The letter then advised GoB to "amicably settle the above dispute" within three months from the date of the letter or "the investors will be entitled to submit this dispute to international arbitration." Following the surfacing of the letter in August, the AMANDALA had stated that it appeared "to be a more aggressive tactic aimed at wresting approval of Waterloo's proposed cruise terminal from GoB" and that it "entered the public domain just days before the scheduled public consultation on the new ESIA for the project" took place.

Waterloo has invoked this treaty several times, as far back as 2009. A December 2009 AMANDALA article reported that, in 2009, "By way of formal notice to Prime Minister Dean Barrow and Attorney General Wilfred Elrington, Dunkeld International Investment Limited (a Turks and Caicos company affiliated with British tycoon Michael Ashcroft) ... indicated that it [was] invoking foreign arbitration for damages and losses of at least BZ\$200 million and up to \$400 million, following the nationalization of Belize Telemedia Limited (BTL) in August. The notice of arbitration makes reference to a treaty Belize signed with the UK back in 1982, with a 1985 amendment signed by Barrow, as Minister of Foreign Affairs, extending the treaty to the British territory of the Turks and Caicos." Most recently, in connection with the rejection of the Waterloo cruise terminal proposal late last year, Ashcroft stated in his January letter to the Briceño administration that investors in the Waterloo Cruise Port

and Cargo Expansion project would be forced to invoke the treaty if, essentially, Waterloo's appeal for reconsideration of its proposal did not lead to project approval by the NEAC.

Instead of the appeal, however, a new ESIA (Environmental and Social ImpactAssessment) for the project was submitted, and after two public consultations, and various purported amendments to the proposal, the NEAC ultimately rejected the project a second time.

But according to PM Briceño, while his administration might not be able to grant approval of Waterloo's proposed construction of a cruise terminal, his government is still very much in support of an expansion of the cargo capacity at the Port of Belize Ltd., which would be an enhancement of the primary function of that facility, and the importance of such an improvement at what is currently the major port in the economic hub of Belize cannot be overstated. For his part, the PM expressed his belief that the much-needed repairs and development of the cargo capacity at the Port of Belize are long overdue.

He then commented on the port's 20-year status as an operation under receivership, and pointed out that this arrangement should not continue to be in place much longer.

"The port is under receivership, and that is something now that has to be addressed shortly. The receivership, or the bank, or whosoever has the receivership, has to decide what they're going to do. The Port of Belize cannot stay in perpetuity on the receivership, and it is more than- the time has way passed for them to start the development or to repair or modernize the port. That is a must for this country, and the receivership or the people that are responsible for the port under the receivership will have to make up their mind if they either want to develop the port or get people who are prepared to develop the container port," he said.

When asked in a 2021 interview if his company would upgrade the bulk storage facility and container port if his cruise terminal proposal was not approved, however, Ashcroft had said a clear "No".

"That will not happen, because for the bulk handling you need dredging too, so you would have the same issue, so Waterloo has made it abundantly clear that there is not one without the other. So, it's not the end of the world for me," Ashcroft had said. He made these comments following the first rejection of Waterloo's project proposal by the NEAC late last year. He had stated at the time that they would go through the process and "if it happens it happens." "Putting something of this size together takes a lot of work and sadly, I'm 75, so for me to really make sure – because I won't enter into any project that can't be completed, so whether it happens, time will tell," he had said. Whether this second denial by the NEAC is the end of the road for the Waterloo project, or Ashcroft will subject the country to a new round of costly litigation, is yet to be seen.

## Retired public officers seek payout from 27-year-old trust

GOB \$7 million in expenses. Esquivel later compensated those hundreds of workers by allotting them 450,000 shares of BTL. The dividends generated by those shares, however, were placed in the control of the Public Sector Workers Trust-a source of frustration for those workers, many of whom are now retired, who claim they have still not received a payout. More than twenty years later in 2017, hundreds of the public workers who were affected, banded together to sue the leadership of the Public Sector Workers Trust (PSWT), who they said had failed to provide them their compensation.

As litigation took its course, the judiciary ordered that a new trust deed be created and that there he consultation between the GOB and the retired public workers to ensure that only those who were working for the government during the period of the pay freeze were compensated. The dividends which had matured to a sum of \$8 million were to be used to finance projects that would benefit the designated public workers. (The workers had failed, however, to get the Court to order a direct payout of the funds.)

The Public Sector Workers Trust is claiming that since then it has headed initiatives aimed at bettering the lives of the assigned beneficiaries, such as their recent Food Assistance Project which seeks to provide groceries and food supplies at a maximum value of \$150 to all beneficiaries of the fund. However, the 5,887 retired public officers who are entitled to these benefits are not satisfied.

On Monday, a relatively new advocacy group called the Association of **Beneficiaries and Retired Public Officers** (ABRPO) called upon the government via press release to take decisive action against the failure to issue a payout of the funds to the public workers. In their release, ABRPO, which was reportedly established in 2019, stated that the Supreme Court ruling of 2017 which indicated that the dividends were to be used to alleviate the hardships caused by the 1995-97 salary/increment freeze has yet to be honored. ABRPO asserts that instead, a "protracted state of litigation, failed mediation, and managerial inertia ensued."

The association also claims that the trust is being used for other purposes that do not serve the beneficiaries. A statement from the association asserts that "At this time, twenty-seven years later, some \$8 million has accrued by way of BTL dividend payments, deposited into the

account of an agreed Public Sector Workers' Trust Fund established in 2014 for which the Unions were the responsible Settlor. Beneficiaries of the Trust became concerned about decisions taken by the Board of Trustees of the PSWT, directed by the Unions, which engaged in spending that did not benefit those public sector workers who were entitled to do so."

Further, the ABRPO stated that due to a failed attempt to have the 2017 ruling varied to allow a payout of funds to beneficiaries (and) the funding of projects, and the replacement of the Board of Trustees of the PSWT to obtain better representation for beneficiaries, the situation has worsened. An appeal was submitted; however the Association feels it has been "confounded because the written judgment may not have been signed off on by the presiding judge who has since demitted office, and because of the unavailability of a transcript."

The impasse has apparently resulted in a number of retired workers who were to have benefited from the fund passing away before receiving the benefits to which they were entitled, which makes the matter time-sensitive. The association's press release stated, "ABRPO has written the Prime Minister and the Attorney General requesting the government's intervention. A growing number of beneficiaries are passing away without the benefit of their entitlement. It has drawn attention to the abject incompetence and failure of the PSWT Board of Trustees to ensure that beneficiaries' needs are satisfactorily attended to."

In closing, the ABRPO, which is headed by president Hubert Enriquez, also expressed their support of the call by public sector workers for the early restoration of their increments and compensation for monetary loss caused by the GOB's 2020 salary increment freeze.

*7News* stated in its newscast last night that Dr. Philip Castillo, one of the trustees of the Public Sector Workers Trust, has refuted some of the claims made by the ABRPO and stated that "the Trust was sued - not once - but twice and that the second lawsuit is still awaiting a full hearing before the Court of Appeal. He asserted that the Association is attempting to challenge the outcomes of one of the court cases and that if they wanted to do that, they needed to file an appeal against the iudgment"

According to *7News*, Castillo also claimed that "the Trust has been engaging in a health project to look after the medical needs of those retired beneficiaries."

## **Guats bex after submission of** Honduras' claim to the ICJ



They are claiming that the application was deliberately submitted just days before the December 8, 2022 deadline for the submission of their final Reply in the Guatemalan claim brought against Belize. Notably, Belize's countermemorial was submitted to the ICJ in early June of this year, within the timeline set out by the court for the review of Guatemala's claim. Guatemala, as just mentioned, was scheduled to submit its reply on December 8, 2022, and Belize's rejoinder would then have been submitted on June 8, 2023.

On June 24 of this year, time limits were fixed by the ICJ for the submission of Guatemala's Reply and Belize's Rejoinder, the last written submission expected to be handed to the justices of the ICJ before oral hearings.

The Guatemalan Foreign Affairs Ministry claims that their reply to the Counter-Memorial submitted by Belize in a few days would constitute the last procedural act in the written phase of the process on their part, suggesting that Belize's late inclusion of Honduras' claim in the adjudication process somehow blindsided them.

"Belize agreed with Guatemala to take to the International Court of Justice the case of the Territorial, Insular and Maritime Claim of Guatemala (Guatemala/Belize), which began on June 7, 2019. Said case includes the question of the sovereignty of the Zapotillos Cays," the release states.

It adds, "Belize's action is particularly deplorable because it was carried out a few days from December 8, 2022, the date set by the Court for Guatemala [to] present its Reply in this case," It could be said, however, that Honduras' claim and its relevance to the ICJ adjudication of the Guatemalan claim, was an unresolved matter that was hidden in plain sight. Since 1982, Honduras has maintained a claim to the Sapodilla Caye Range (a cluster of islands located about 40 miles offshore of Punta Gorda in the Toledo District that is said to be "home to the most concentrated area of beaches in all of Belize") in Article 10 of its Constitution. And according to what Foreign Affairs Minister Eamon Courtenay stated in the Senate in late October, it became a matter of urgency to address that claim, since its exclusion from the adjudication process could derail the country's entire quest to settle once and for all the questions surrounding its sovereignty over the 8,867 square miles that are known to be Belizean territory.

international lawyers that the position of the current case brought by Guatemala against Belize may not result in a final settlement as required and requested by the Belizean people because the Honduran constitution claims sovereignty over the Sapodilla Cayes," he had explained to the Senate.

He went on to state during the October

2022 Senate hearing, "Once the ICJ becomes aware of a claim by Honduras to the Sapodillas, there is a significant risk that the court would not delimit the Maritime Areas that appertain to the Sapodillas, thereby leaving unresolved a large part of our maritime entitlement. Indeed the ICJ may decide not to pronounce sovereignty over the Sapodillas as well, even as Belize and Guatemala. This would mean that sovereignty over a very important part of our sovereign domain, the Sapodillas and the Maritime Areas pertaining to it would remain unresolved. In light of all the circumstances, and based on legal advice from our international lawyers, Madam President, Belize seeks to accede to the Pact of Bogota, a Treaty to which Honduras is a party."

Belize had thus fast-tracked its signing of the Pact of Bogotá in October of this year to bring the proceeding properly before the ICJ. The treaty, also known as the American Treaty on Pacific Settlement, compels nations of Latin America to resolve disputes peacefully, first exhausting dispute resolution options regionally before going to the United Nations and seeking to have the case heard at the ICJ.

"We were advised that if we join the Pact of Bogota and commence a claim against Honduras and bring that to the ICJ, then we can say, the Guatemala v Belize and Belize v Honduras cases are related because of this overlap of the claim of sovereignty, resolve it once and for all,"

Courtenay had explained.

He had also noted, "If we don't bring Honduras into the court, our advice is that it is likely that we will have to commence yet another case, suing Guatemala and Honduras to resolve sovereignty over the Sapodillas." It is a move, however, to which the Guatemalan government has strongly objected. The press release issued by the Guatemalan Ministry of Foreign Affairs this week states, "The Government of Guatemala reaffirms that the aforementioned keys belong to Guatemala and that the action of the Government of Belize in no way affects Guatemalan sovereignty over them." Belize's application, however, asserts that the Sapodillas, which are part of a range that consists of 14 islands, including Hunting Cave, Tom Owens Caye, and Lime Caye, as well as a 39,000-acre section of the barrier reef, have always been a part of its territory, and it was not until independence in 1981 that the claim of Honduras first

## **Royal Caribbean makes deal** with Port of Magical Belize

Port of Magical Belize, rather than the two other companies that have had plans to develop cruise terminals in the Belize District—Stake Bank Enterprises Ltd. and Waterloo Holdings Ltd.

That major cruise line has reportedly stated that the Port of Magical Belize project "encompasses the adequate environmental and operational criteria" required by the company and that a subsequent Memorandum of Understanding that will lay out the terms of partnership between the two entities is soon to be signed by the companies.

At this juncture, as three companies (Portico, Waterloo and Stake Bank) jostle for a spot in the cruise terminal sector within a limited geographical space in the Belize District (with indications from the Government of Belize that it might not be feasible to have three cruise terminals in the area), the selection of Port of Magical Belize by the Royal Caribbean Group, could be crucial, perhaps even decisive, in determining which cruise terminal projects can succeed. Recently, reports surfaced of the National Environmental Appraisal Committee's denial of Waterloo's proposal for the development of a cruise port at the Port of Belize Limited compound for a second time. While there is no indication at this time whether the company will continue to pursue approval of its project, the Royal Caribbean Group has stated in their letter that their ships would not be docking at any Waterloo cruise terminal, nor at Stake Bank's Port Coral development, the construction of which is already at an advanced stage.

"RCG commits that Magical Belize will be the exclusive development

project and port of entry for RCG amongst Waterloo and Port Coral," the letter states.

That company, whose passengers are currently tendered to the Fort Street Tourism Village (49% of which is owned by RCG), states that it will continue to honor its fiduciary responsibility to the FSTV until the concession is no longer valid or the tourism village is no longer a port of entry. At that point, its ships would start berthing at the Port of Magical Belize, which is to be located near Northern Lagoon in the southern part of the Belize District and is to be built at a cost of USD 355 million.

Royal Caribbean and the other major cruise lines have indicated the need for cruise destinations to provide shoreside berthing capabilities for its large Oasisclass vessels, in line with an upgrade within the cruise industry. Those massive ships cannot berth at the Fort Street Tourism Village. The process of tendering passengers from sea to the mainland is to be phased out totally by 2025, which is the year in which the construction of Port of Magical Belize is reportedly scheduled to reach completion.

RCG has stated that they will now manage the project development along with the principals of Portico. The project will, according to its developers, create around 5,000 jobs.

7News is claiming that the Port of Magical Belize's "lead developer David Gegg has navigated between two governments, first getting an MOU from the UDP in 2017, and then an EIA approved under the PUP in 2021... the project also got a 'Definitive Agreement' under the UDP, signed one month before the election in October of 2020."

mentioned that his department in the past has been unable to effectively address reports of cybercrimes on social media and other platforms – a task that should now be easier following the symposium:

"if you were to see someone bullying you on social media, and you go to the police, for the most part the police will tell you, 'we can't do anything', when in fact the legislation is there and they can do something. So even within the department itself, we're doing a lot of sensitizations in bringing our officers up to speed in letting them understand the law itself and what their powers are under the law so that we will be able to address the issues of people where

cybercrime is concerned. Once the complaint is made, then the police station - the officer who would be dealing with the complaint — would make a request to the Cybercrime Unit here in Belmopan, and the Cybercrime Unit here is going to ensure that they notify Facebook to preserve the information as well as to - and it will be preserved so that when we get a court order they will have it - and once that is done then we also download what we can download from the site itself that will serve as evidence, but we also ask people when they come to bring along a copy of the post that they find to be offensive to them," Williams said. Officers from all districts in the country participated in the symposium.
