Caves Branch tour guide dies during flash flood

Rainy weather over the weekend resulted in flash floods that caused the tragic death of one tour guide and trauma for hundreds of tourists who were being taken on cave tube tours along Belize's rivers. While forecasts did indicate that heavy rainfall was expected during the long weekend, bookings had been made for various river and cave tours in certain portions of the country such as the Cayo District.

Waterloo appeals DOE's decision ... again!



Dec. 29, 2022 An appeal process is underway that could lead to the overturning of the decision of the Department of Environment to reject Waterloo Investments Holdings Limited's (WIHL) proposal to construct a cruise terminal at the Port of Belize Ltd. The proposal was initially denied approval last year by the National Environmental Appraisal Committee (NEAC) based on what was described as the developers' failure to answer key questions (related to environmental concerns) that had been posed by the NEAC. In late November of this year, a second ESIA (Environmental and Social Impact Assessment) submitted by the company,

BATSUB soldier remanded for harming ex-fiancé

This week, a transnational love affair ended, not only in heartache, but in an outburst of violence by a British soldier who has been charged for assaulting and kidnapping his Belizean fiancé. The incident reportedly occurred at about 3:00 a.m. on Saturday, Christmas Eve. Stratford, who is serving in the British Army Training and Support Belize Unit of (BATSUB), reportedly found text messages on the phone of his fiancée, 28-year-old Gabriela Vanutterbeeck, and after he questioned her about it and she admitted that she had cheated on him, he became enragedreportedly throwing many of her belongings through the window of

their home, which is located beside the river. Vanutterbeeck has claimed that he also attempted to throw her dog out the window and that he kicked her and dragged her by the hair. She said that he then forced her into her vehicle, a Toyota RAV 4, with the purported intention of taking her to Belmopan, but that he stopped and put her out the vehicle near the Burdon Canal Bridge. She then hitchhiked and went to the police station. Her injuries were classified as harm, and police detained Stratford shortly after.

When he appeared in the Magistrate Court on Tuesday before Chief Magistrate Sharon Fraser, he was charged with harm, damage to property, theft and kidnapping, and Fraser informed him that, because of the serious nature of the kidnapping charge, she could not offer him bail, and he would be remanded to the Belize Central Prison. It is at that point, when Stratford learned that he would be taken to the Belize Central Prison, that he began to weep. If he had been offered bail, it would have been possible for him to spend his time on remand at the BATSUB facility at Price Barracks in Ladyville, and it is possible that Stratford had been hoping that would be the case. Fraser told him that he would have to return to court on February 17, 2023.

Immediately after the hearing, however, Stratford's attorney, Orson "OJ" Elrington, launched an emergency bail application process—one not previously

carried out in Belize, to secure bail so that his Stratford could be transferred to the.BATSUB facility. The application was submitted on the grounds that, according to international standards, law enforcement officers are not to be placed in the general population of any prison.

By the following afternoon, on Wednesday, Supreme Court Justice Ricardo Sandcroft had granted bail, and he was released into the custody of military personnel from BATSUB, where he will remain until next February. He is not to leave Price Barracks, and must report daily to military police. Justice Sandcroft also stipulated that he is to receive six months of anger management counseling.

Elrington told reporters after the hearing, "The learned justice was particularly perturbed about the fact that military and law enforcement officers at all costs, so long as they have not been convicted, should have alternative places for them to reside until their bail can be heard at least."

Stratford must also refrain from contacting his ex-fiancé.

Caves Branch tour guide dies during flash flood

had been employed at the Ian Anderson Caves Branch Jungle Lodge for almost twenty years, was conducting one of those tours on Christmas Eve (Saturday) near Mile 41 on the Hummingbird Highway when a flash flood occurred, and he was flung from his tube. Some reports have suggested that it was a fallen tree trunk that set in motion the sequence of events that led to his being dislodged from the tube and swept away by the river's current, which led to his drowning. That, however, has not been confirmed.

What the communications director of the Belize Police Department, ASP Fitzroy Yearwood, has indicated, however, is that Escobar had been attempting to lead the tourists to a more shallow section of the river, but while crossing the river he was overpowered by the river's currents. In a press briefing on Tuesday, Yearwood explained, "About 11:30 a.m., Julio Escobar and two other

tour guides and some guests were in that area somewhere upstream in the river that began to rise rapidly. The tour guides attempted to move towards a more shallow area that they believed they could have crossed the river, but Escobar disappeared, and he was flung from his tube where he disappeared in the water."

According to Yearwood, when attempts to locate Escobar failed, Astrum helicopter services was contracted to hover over the water and try to pinpoint the spot in the river where Escobar could be found. Yearwood said that at about 8:00 that night, "the pilot of that helicopter and the search party believe they saw a body in the river not too far from the area where Mr. Escobar disappeared. They managed to retrieve him from the river and he was transported to the Western Regional Hospital, where he was pronounced dead by a medical officer around 9:30 p.m."

Similar incidents reportedly occurred during other tours in the district, although

no other lives were lost. Two hundred tourists and tour guides had been taking a tour through the Actun Tunichil Muknal (ATM) Caves in the Roaring Creek River, but when they emerged from the river, they found that the level of the water had risen a few feet. The tour guides responded by joining their efforts and using some emergency routes. They had also deployed ropes to keep the tourists and themselves secure as they crossed the river, and had also received canoes from the Chaa Creek resort to transport some scared tourists across the river.

One tour guide, Oscar Carbajal, told 7News, "It started normal. Water was low, nice and clear, and everybody went and did their tour. Coming out is when we, because you have to cross this river three times before you get to the cave. As we came out, flash flood. Luckily for us, we have a, what you call emergency trail, so it goes around the hillside and it boycotts two crossings. This last one here, you can't dodge. Luckily too we

have a brotherhood of guides, and we all pool our resources together when it comes to things like that, and so we started to get our canoes and life vests, and some were strong swimmers and some struggled, but luckily we all got out safe."

Another tour guide, Francisco Raymundo, further explained, "I had a good knowledge what to do. I was calm, keep guests calm, and help the guys to bring people across the stream. It was easy for me. We had to cut through a big part of the trail since Hurricane Lisa. The trail was not visible, so we had to cut down a nice part of the trail until we met the trail we normally cross, and we got here and the other guides were all waiting for us on the other side waiting for assistance. People were already crossing, the rope that was attached, it was easy. Just some challenges with guests that were uncomfortable. We made sure they had jackets and everything was normal, calm."

Waterloo appeals DOE's decision ... again!

which purportedly addressed the grave environmental concerns, was again rejected by the NEAC—a decision that was followed by the Department of Environment's (DOE) confirmation in the first week of December of the validity of the NEAC's reasons for denying Waterloo's much-sought project green light.

That decision by the DOE to accept the NEAC's recommendation came at the end of a consultation and review process which was preceded by questions among members of the public about how many times an entity such as Waterloo could attempt again to get approval for a project deemed to be an environmental risk. The second decision by the DOE thus seemed to be final. But it was not. Waterloo has triggered an appeal of its decision and the formation of a tribunal to preside over that appeal. (After the DOE had made its decision, it was announced that Waterloo could submit an appeal within 21 days.) Three persons who are selected by

officials at the highest levels of the public and private sector (the judiciary, the government and the business community) will now make a decision that could subvert a years-long process of public consultation and scientific review. And it is a process that, unlike the process which ended in a denial of Waterloo's project, will take place largely outside of the public eye by a trio that will include only one person with technical/scientific understanding of the risks the project could pose, and that will require only two of those three to agree in order for a final ruling to be made. In other words, just two persons can say yes, and thus overrule the decision of countless others who said no. If that is indeed the case, all public consultations and science-based assessments by various committees could be disregarded—overruled by the decision of a tribunal of three.

Notably, this is the second time that the company has started an appeal process—with the first being last year when the Cruise Port Terminal and Cargo Expansion project proposed by the

Waterloo was first denied. At that time, the appeal process (allowed for by section 27 of the Environmental Protection Act, Chapter 328) was aborted after the company was allowed to submit a new ESIA on the project.

Significant pushback from the environmental community, which highlighted the extensive damage that could be caused to the Belize Barrier Reef and the country's marine areas by the dumping of millions of cubic meters of dredged material nearshore; the signing of 20,000 signatures by Belizeans who opposed the project; and references to the inadequacies of the developers' proposed method of containing dredge spoils, as well as unanswered questions about how the mechanisms to be used would hold up if a hurricane hit the country, were just some of the factors that led to the ultimate rejection of Waterloo's proposal by the National Environmental Appraisal Committee(NEAC), which made its decision on the basis of a scientific review of the technical information submitted by

the company. The DOE ultimately accepted this decision by the NEAC and rejected the project.

But now, Waterloo has invoked section 27 of the Environmental Protection Act, which empowers a threeperson tribunal to reverse the DOE's decision, and either accept or reject the

Under that section which governs the appeals process, the developers are able to submit an appeal directly to the Minister of Sustainable Development, Climate Change and Disaster Risk Management, Hon. Orlando Habet. Hon. Habet confirmed to KREM NEWS that an appeal was submitted by the company and that a tribunal will be established and will "hear and determine the appeal" and report their findings to him.

According to the March 2007 amendment, a Magistrate appointed by the Chief Magistrate or Judge nominated by the Chief Justice will be appointed as Chair of the tribunal. The other two

PM aims to settle 27-year debt to public officers

In the first week of December, the AMANDALA had reported that "retired public workers who had endured a wage and increment freeze between 1995 and 1997 and who were compensated by the government with shares in what was then the Belize Telecommunications Ltd.," had publicly decried the fact that they still hadn't received the dividends from those shares, which were placed in a trust, and they were intent on receiving a payout from that fund, which reportedly now totals \$8 million.

The article further explained that, "The Manuel Esquivel administration, during the 1995-1997 period, had implemented the freeze on the salaries of all teachers and public officers—a move which reportedly saved the then GOB \$7 million in expenses. Esquivel later compensated those hundreds of workers by allotting them 450,000 shares of BTL. The dividends generated by those shares, however, were placed in the control of the Public Sector Workers Trust—a source of frustration for those workers, many of whom are now retired, who claim they have still not received a payout."

After the public workers banded together to take litigative action in 2017 against the Public Sector Workers Trust (PSWT), who they said had failed to provide them their compensation, the Supreme Court had ruled that the GoB and the retired public workers were to engage in consultations and that the funds were to be used to benefit the designated public workers.

But the Association of Beneficiaries and Retired Public Officers (ABRPO), an advocacy group formed a few years ago (in 2019) is claiming that that is not what has taken place. The group, in a press release issued at the end of November, urged GoB to take decisive action to address the failure to issue a payout of the funds to the public workers, and asserted that the 2017 Supreme Court ruling has yet to be honored.

"... Beneficiaries of the Trust became concerned about decisions taken by the Board of Trustees of the PSWT, directed by the Unions, which engaged in spending that did not benefit those public sector workers who were entitled to do so," the association claimed in its release. And it pointed to the particular urgency of the situation by noting that a growing number of retired workers have passed away before receiving the benefits that were due to them. "ABRPO has written the Prime Minister and the Attorney General requesting the government's intervention. A growing number of beneficiaries are passing away without the benefit of their entitlement. It has drawn attention to the abject incompetence and failure of the PSWT

Board of Trustees to ensure that beneficiaries' needs are satisfactorily attended to," the release from the association had

Now, nearly a month later, there are indications that the Prime Minister may indeed provide a payout to those retired workers who were affected by that 1995-1997 increment freeze. Hon. Briceño has made public statements which suggest that he is contemplating the sale of the shares that had been set aside for

the workers and the direct distribution of the monies collected. In reference to the trust that had been established, PM Briceño said that "it may be time to wrap it up and give people – the ones that are part of that – what is due to

The ABPRO, following those remarks by the PM, has issued a press release in which it stated that it welcomes this move that the Prime Minister is planning to make.

"The Association of Beneficiaries and Retired Public Officers (ABRPO) congratulates Prime Minister John Briceño on his announcement that it is the intention of his government to move early in the New Year to dissolve the Public Sector Workers Trust, and to distribute its assets among beneficiaries

of the Trust. This has been the overwhelming call made by the vast majority of beneficiaries who had to endure the hardships caused by the double salary increment freeze as well as other austerity measures imposed upon them at the time," the ABPRO's release states.

The association also acknowledged how challenging this task of dissolving the Public Sector Workers Trust will be for the GOB and said that close engagement with the ABRPO Executive Committee and advisers as well as participation from the beneficiaries will be needed. It expressed its hopes that, through these efforts, "all beneficiaries, including the families of those who are deceased, will be fully compensated for the losses which were incurred".

Missing man's family fears for his life

The family of 27-year-old Akeem Augustine, also known as "Cummings," is trying to locate him after receiving news that he may have been murdered and dumped near Mile 8 on the Western Highway. Augustine went missing on Christmas Day after reportedly going into the Jane Usher Boulevard area of Belize City to socialize with some

He has not been seen since, and a string of calls have been made to his family, and several rumors have arisen, since his disappearance. His family has filed an official missing person report at the Police Department, and a police search is ongoing for the young man.

According to his girlfriend's sister, Nirice Mejia, he had told the family that he would be joining his friends at a party in the Jane Usher area and had assured them that he would be returning home as usual.

"... He said he was going to a friend, and I'm like 'okay which area?' And then he was like, 'Well, sis, it's just boring here. I just want to go out so'. And so I said to be safe and thing, because he was going to an area where he doesn't usually go. So, I was like 'what are you going to do there?' and then he was like it's just a party for all of his friends and that he would come home", Mejia told reporters.

She further explained, "... My sister came home around 9:00 and asked me if her boyfriend had already come home, and I was like no. So, we got news that he was killed, but we are not

sure, so we don't want to falsify anything, but she is calling, texting, calling, texting and nothing, so his sister contacted my sister and told her that is what she heard. So, we told her don't think like that, and they are still calling and texting, calling and texting, and anonymously someone called in and said that he is at 8 Miles, and we aren't sure if anyone has gone to look for him as yet, but that is what we are hearing."

He is said to be around 5'6" in height and of a dark complexion. He has a bald head and mustache and was last seen wearing a red T-shirt, black kneelength pants, and a pair of red and black Jordan slippers. Augustine, who was recently shot in the mouth while in Hopkins, is reportedly employed with the Leadership Intervention Unit in Belize City. He has one young son.

Pitter Street man shot by gunman who shouted "police"

Early on Tuesday morning, December 27, a Pitter Street resident, Lindon Mark Hinds, 30, was killed by a gunman who lured him out of his house by shouting "police" at his door.

It is being reported that around 1:45 that morning, Hinds was at home sleeping with his common-law wife at his home on Pitter Street when they heard knocks at his front door, and someone yelled "police". Hinds, who had been charged previously for violent crimes, probably found the claims that police officers were at his door so early in the morning to be credible, so he got up and opened the door. When he did, a gunman shot him several times.

Hinds' motionless body was transported to the Karl Heusner Memorial Hospital (KHMH), where he was pronounced dead at 3:55 a.m. His body lies at the KHMH morgue, where it will undergo a post-mortem examination.

Hinds, also known as "Monsta", was, known in his neighborhood as a gunman, and was believed to be responsible for previous shooting incidents, including the death of a 5year-old girl who was killed in 2020 on the same street on which Hinds resided and on which his own murder occurred. The child—Kia Herbert, an infant one student at the Unity Presbyterian Primary School—had been fatally wounded at about 2:00 in the morning in March of that year while sleeping with



her mother, Frances Herbert. The shots that penetrated the walls of the bedroom and wounded little Kia had been fired by a gunman who was standing outside the house on Pitter Street.

The child's grandmother had told reporters, "All ah we mi di lay down on the floor last night, and we gone sleep and like after 2:00 we just wake up to gunshot. We mi feel like dehn just shot up the house. We neva know anybody get shot. Dah when my daughter jump up and ih see the blood and say 'Mommy, mi baby get shot'. Then she lift up and scream and say 'Mommy, Mommy' two times, and from there in just gone. Ih close ih eye, and my daughter say, 'Mommy, call the ambulance for mi. Mi baby get shot and ih look like ih di dead'." (News5 transcripts)

Baby Kia had been wounded in the abdomen, back, and leg and was declared dead after being taken to the



10 Haitian tourists wrongfully detained

The group of tourists from our CARICOM sister nation included students.



LADYVILLE, Belize District, Tues. Dec. 27, 2022

What is appearing to be a breakdown in procedure at the Philip Goldson International Airport on Monday, December 26, led to the overnight detention of 10 tourists, all Haitian nationals, at the Ladyville Police Station, even though they met all the requirements for legal entry.

They arrived in the country at about 6:30 a.m. that day, according to attorney Arthur Saldivar, who was retained by a family member of one of the detainees. But, Saldivar said, they were not interviewed, as is typically done. It was a deviation from the usual process, and it is being reported that it was three junior officers who decided to not adhere to the procedure that is to be followed when dealing with visitors/tourists at the PGIA.

"... They were not interviewed upon landing by Immigration...", Saldivar explained. He went on to state, "... They were simply brought over arbitrarily and locked down. We have six women and four men. Four of the women are university students; one speaks 5 languages. There are professionals among them, but they were never asked any questions. Their documents were taken from them, and those documents would have revealed that they have return tickets to their country; they have reservations at hotels in Belize – in Belize City, in particular; they have monies to spend, as is the requirement."

He further decried the treatment of the visitors by stating, "They are students, a number of them. Others are professionals, and they have not even been allowed to eat. One of my clients is going through her cycle as a female and has not been allowed to change. This is inhumane, the treatment that has been meted out to them. On what basis are they being considered suspicious travelers by three junior officers?"

Saldivar further noted that all the detainees are CARICOM nationals and went on to suggest that the way they have been treated is possibly a breach of the protections and rights afforded to such persons under the Treaty of Chaguaramas. He said that the entire Immigration Department is not to blame, however, and went on to speculate on the chain of command at the Immigration Ministry, and at what level in that chain the decision was made to take such a course of action suggesting that possibly directives from the Director of Immigration may have overridden authority of the on-theground supervisors.

"I want to say that, this is something that I do not believe the entire Immigration Department is complicit with, nor do I believe that this has anything to do with the Minister of Immigration, whom I know, knows very well what the rule of law requires, and certainly has a very intimate relationship with the Treaty of Chaguaramas and the whole CARICOM, CSME, relationship. So, I do not think that he would be one to be sanctioning this kind of action on behalf of three junior officers at Immigration who have actually taken it upon themselves along with the Director to do this to these people," Saldivar said.

He said that the community of Haitians living in Belize and the 250-member Haitian association in the country have been notified of the incident. And he pointed to the possibility of litigative action which could result from the violation of the rights of the visitors.

"My understanding of things is that only these junior officers dealt with these people and brought them here arbitrarily, and in that regard, their human rights and their constitutional rights have been violated. We have women, young women, who have committed no crime at all, locked up and being made to suffer indignity here in our country as CARICOM nationals... We have never been given this kind of treatment when we land at our sister country's port of entry. For us now, as Belizeans, who require the support of CARICOM in our plight, to do this on our own," he pointed out.

While Saldivar was talking to reporters, representatives from the Immigration Department arrived at the

Our economy on the eve of 2023

Our economy is not where we need it to be, but on the eve of 2023 we are in a better place than we were on the eve of 2022. On the eve of 2022, the BSCFA and ASR-BSI were locked in an industrial dispute that had forced a delay of the start of the harvest. On the eve of 2023, there is every sign that the industry will be firing on all cylinders, at least until the eve of 2024, and that's because the BSCFA and ASR-BSI agreed last week to kick the "difference between them" down the road for another year. It's a win for the millers, ASR-BSI, though not of the duration they aimed for. It's a victory for the country, and the thanks go to the farmers of the BSCFA, who decided to "suck it up" while continuing to negotiate for a better price for their cane.

On the eve of 2023, citrus and farmed shrimp are still being plagued by the diseases that hit them more than a decade ago; the banana and marine products industries remain relatively stable, just as they were on the eve of 2022; and oil production remains a trickle.

Our biggest engine, tourism, is doing well on the eve of 2023. Because of the pandemic, cruise tourist arrivals in 2021 were the lowest in over a decade, and the number of overnight tourist arrivals was a little more than 40% of what it was in our best year, 2019. On the eve of 2022, it appeared that the pandemic would soon be behind us. On the eve of 2023, we still have to be on guard, but the ships and planes are coming again, though not yet as many as were arriving before the WHO declared Covid-19 a global pandemic.

Where would Belize be without Business Process Outsourcing (BPOs), the call centers? The eve of 2023 is as bright as the eve of

2022 in the call center industry, which started back in 2005. In May this year Hon. Christopher Coye, the Minister of State in the Ministry of Finance, Economic Development and Investment, stated that the call centers continued to bring in the foreign exchange for our country and to provide critical employment for our people. In 2019, about 3,500 Belizeans worked in the industry; in 2022, that number has grown to almost 8,000.

Beltraide says the industry is a specialized "niche" area for Belize, that it is "on a strong growth trajectory owing to the advantages of a young population, natural flair of a service-based economy, a competitive business environment, world class telecom infrastructure, specialized incentives and strong active government support." We are also "a great value destination due to [our] high workforce availability [and] salaries that are 60-80% lower than US locations."

On the eve of 2022, our public debt had fallen from around 130% of GDP (on the eve of 2021) to around 110%. On the eve of 2023, the GOB says that our debt-to-GDP ratio has been further

reduced, to less than 70%. While in office during the first frightening months of the pandemic, former prime minister, Dean Barrow expressed the hope that the International Financial Institutions (IFIs) would give some debt relief to Belize and the other struggling, heavily indebted countries in the world, and said that debt restructuring would be a necessity for our survival. Indeed, on the matter of our international debts, even prior to the pandemic we had been faltering on our payments to the holders of the so-called Super Bond.

We are still waiting on the IFIs to reduce our pain, but through major debt restructuring we have received much ease on the macroeconomic front. Firstly, the Super Bond became the Blue Bond in November 2021. The Nature Conservancy (TNC) said it is "the world's largest debt refinancing for ocean conservation to date", that it "enabled Belize to repurchase USD 553 million, a quarter of the country's total public debt, from bondholders at a 45% discount through a 'Blue Loan' arranged by TNC."

Just this month the Prime Minister, Hon. John Briceño, announced that Venezuela had agreed to a restructuring of the massive debt we owed under the Petro Caribe program, and the result was the wiping off of another quarter billion dollars of debt.

After the Blue Bond agreement, the Financial Secretary, Mr. Joe Waight, had warned that the deal wouldn't lead to "any additional cash flow for the government and the country in the short term", and that we remained on "the cliff of financial peril." On the eve of 2023, the debt-to-GDP ratio is greatly improved, but our country is still in the grip of poverty.

On the eve of 2023, we are hours away from a promised increase of the minimum wage, to \$5 per hour. Inflation has eroded the purchasing power of the Belize dollar, in some areas by as much as 30%, so the little extra on the paycheck of the lowest paid Belizeans is timely.

On the eve of 2023, the cost of fuel is higher than it was on the eve of 2022, and Belizeans are straining their pockets to pay the bills at the fuel pumps. Belizeans scream for relief, and there has been a drop in the cost of fuel in the latter part of December, but the GOB has indicated that fuel prices won't go back to pre-pandemic levels until a new Petro Caribe arrangement with Venezuela is rolling our way again.

Belizeans see the price of fuel in the US in news stories on American television, but we really can't compare ourselves to them. The U.S. Energy Information Administration (EIA) says "federal taxes include excise taxes of 18.3 cents per gallon on gasoline and 24.3 cents per gallon on diesel fuel, and a Leaking Underground Storage Tank fee of 0.1 cents per gallon on both fuels." While US states apply additional taxes on fuel, at the end of the day the taxes on fuel in the US don't come close to what we Belizeans have to pay. The truth is that our GOB is heavily dependent on the taxes from fuel to run the country.

In July this year the GOB Press Office said the acquisition cost of fuel had gone up 300% since November 2020. In that same release, the GOB said that "at November 2020 and continuously for years before that, excise tax on diesel and regular gasoline was \$2.97 and \$3.29 per gallon, respectively" and that to ease the fuel pain the taxes on diesel and regular gasoline had "been reduced by virtually 100% and 77% respectively down to less than one cent, and 75 cents per gallon."

On the eve of 2023, we are still very much a "third world" country, from slavery to colonialism to neocolonialism. There is so much need in our land. But, on the balance sheet, our country is better off than it was on the eve of 2022. We are grateful for the improvement. Happy New Year to all Belizeans, from the Hondo to the Sarstoon, from Benque Viejo del Carmen to Halfmoon, and those living in countries abroad!



Nuestra economía en vísperas de 2023

Nuestra economía no está donde necesitamos que esté, pero en vísperas de 2023 estamos en un mejor lugar que en vísperas de 2022. En vísperas de 2022, BSCFA y ASR-BSI estaban enfrascados en una disputa industrial que había obligado a retrasar el inicio de la zafra. En vísperas de 2023, todo indica que la industria estará trabajando a toda máquina, al menos hasta la víspera de 2024, y eso se debe a que BSCFA y ASR-BSI acordaron la semana pasada retrasar la "diferencia entre ellos" un año más. Es una victoria para los molineros, ASR-BSI, aunque no de la duración que esperaban. Es una victoria para el país, y el agradecimiento es para los agricultores de la BSCFA, quienes decidieron "aguantarse" mientras continuan negociando por un mejor precio para su caña.

En vísperas de 2023, los cítricos y los camarones de cultivo siguen estando plagados de enfermedades que los afectaron hace más de una década; las industrias bananera y de productos marinos se mantienen relativamente estables, tal como estaban en vísperas de 2022; y la producción de petróleo sigue siendo un goteo.

Nuestro mayor motor, el turismo, está funcionando bien en vísperas de 2023. Debido a la pandemia, las llegadas de turistas de cruceros en 2021 fueron las más bajas en más de una década, y el número de llegadas de turistas de una noche fue un poco más del 40% de lo que fue nuestro mejor año, 2019. En vísperas de 2022, parecía que la pandemia pronto quedaría atrás. En vísperas de 2023, todavía tenemos que estar en guardia, pero los barcos y aviones están llegando de nuevo, aunque todavía no tantos como antes de que la OMS declarara el Covid-19 como una pandemia mundial.

¿Dónde estaría Belize sin las empresas de outsourcing de procesos de negocios (BPO por sus siglas en inglés), los centros de llamadas? La víspera de 2023 es tan brillante como la víspera de 2022 en la industria de los centros de llamadas, que comenzó en 2005. En mayo de este año, el Honorable Christopher Coye, Ministro de Estado en el Ministerio de Finanzas, Desarrollo Económico e Inversión, afirmó que los centros de llamadas continuaron trayendo divisas para nuestro país y brindando empleo crítico para nuestra gente. En 2019, alrededor de 3500 beliceños trabajaban en la industria; en 2022, ese número aumentó a casi 8000.

Beltraide dice que la industria es un área de "nicho" especializado para Belize, que está "en una fuerte trayectoria de crecimiento debido a las ventajas de una población joven, el estilo natural de una economía basada en servicios, un entorno comercial competitivo, infraestructura de telecomunicaciones de clase mundial, incentivos especializados y fuerte apoyo activo del gobierno". También somos "un destino de gran valor debido a [nuestra] alta disponibilidad de mano de obra [y] salarios que son entre un 60 % y un 80 % más bajos que en las ubicaciones de EE. UU."

En vísperas de 2022, nuestra deuda pública había caído de alrededor del 130% del PIB (en vísperas de 2021) a alrededor del 110%. En vísperas de 2023, el Gobierno de Belize dice que nuestra relación deuda-PIB se ha reducido aún más, a menos del 70%. Mientras estuvo en el cargo durante los primeros meses aterradores de la pandemia, el ex primer ministro, Dean Barrow, expresó la esperanza de que las Instituciones Financieras Internacionales (IFI) brindarían algún alivio de la deuda a Belize y a los demás países del mundo en dificultades y muy endeudados, y dijo que la reestructuración de la deuda sería una necesidad para nuestra supervivencia. Efectivamente, en el tema de nuestras deudas internacionales, incluso antes de la pandemia veníamos flaqueando en nuestros pagos a los tenedores del llamado Súper Bono.

Todavía estamos esperando que las IFI reduzcan nuestro dolor, pero a través de una importante reestructuración de la deuda hemos recibido mucha tranquilidad en el frente macroeconómico. En primer lugar, el Súper Bono se convirtió en el Bono Azul en noviembre de 2021. The Nature Conservancy (TNC) dijo que es "el refinanciamiento de deuda más grande del mundo para la conservación de los océanos hasta la fecha", que "permitió a Belize recomprar USD 553 millones, una cuarta parte de la deuda total del país, de los tenedores de bonos con un descuento del 45% a través de un 'Préstamo azul' organizado por TNC".

Justo este mes, el Primer Ministro, el Honorable John Briceño, anunció que Venezuela había accedido a una reestructuración de la enorme deuda que teníamos bajo el programa Petro Caribe, y el resultado fue la liquidación de otro cuarto de billón de dólares Vea página 27 de deuda.

In Dean Barrow's first run as leader of the United Democratic Party (UDP) in March of 2003 (he had replaced the late Manuel Esquivel following the UDP's 1998 general election defeat), the UDP was badly beaten by Said Musa's ruling People's United Party (PUP).

By late 2003/early2004, the UDP was still on its hands and knees, figuratively speaking. When Her Majesty's Loyal Opposition is in shambles, the English parliamentary system, which we inherited from our former colonial masters, does not work well. The government is given free rein (so to speak) when the

Opposition is quarreling within itself, and institutions like the media come in for special criticism and attacks by the incumbent administration.

As publisher of the nation's leading newspaper, I made it my business to offer some advice to Mr. Barrow's UDP. For such daring, I was publicly censured by Mr. Barrow's right-hand man, Hon. Michael Finnegan, then the area representative for the Mesopotamia division, and told, in no uncertain terms, that the UDP didn't need any advice from me, and could take care of its business very well.

En la primera carrera de Dean Barrow como líder del Partido Demócrata Unido (UDP por sus siglas en inglés) en marzo de 2003 (él había reemplazado al finado Manuel Esquivel luego de la derrota del UDP en las elecciones generales de 1998), el UDP fue seriamente derrotado por el gobernante Partido Unido del Pueblo (PUP) de Said Musa.

A finales de 2003/principios de 2004, el UDP todavía estaba de rodillas, en sentido figurado. Cuando la Leal Oposición de Su Majestad está en ruinas, el sistema parlamentario inglés, que heredamos de nuestros antiguos amos coloniales, no funciona bien. Al gobierno se le da rienda suelta (por así decirlo) cuando la oposición está peleando consigo misma, e instituciones como los medios de comunicación reciben críticas y ataques especiales por parte de la administración en funciones.

Como editor responsable del principal periódico de la nación, me propuse ofrecer algunos consejos al UDP del Sr. Barrow. Por tal osadía, fui censurado públicamente por la mano derecha del Sr. Barrow, el Honorable Michael Finnegan, entonces el representante de área de la división de Mesopotamia, y dijo, en términos muy claros, que el UDP no necesitaba ningún consejo de mi parte y que podía ocuparse muy bien de sus asuntos.

Creo que a principios de 2004, febrero si no recuerdo mal, el UDP trató de manifestarse en contra de los excesos financieros de la administración del PUP, donde personas como Ralph Fonseca y Glenn Godfrey se estaban desbocando en instituciones financieras como la Corporación Financiera de Desarrollo (DFC por sus siglas en inglés) y la Junta de Seguridad Social (SSB por sus siglas en inglés). Esa manifestación UDP, me pareció, fue un fiasco.

Así fue como las cosas marcharon a trompicones hasta finales de julio de 2004 cuando estalló un gran escándalo en la SSB. Un grupo de ministros del Gabinete PUP se encargó a principios de agosto de confrontar al primer ministro Musa. En efecto, ese llamado G-7 tenía que hacer el trabajo de la Oposición. Para esto,

hubo ministros como Mark Espat y Cordel Hyde que terminaron como chivos expiatorios, y los leales a Fonseca/ Godfrey los tildaron de desleales al azul.

El resultado de la posición adoptada por el G-7 a principios de agosto fue que el público en general, encabezado por los diversos sindicatos organizados por el Congreso Nacional de Sindicatos de Belize (NTUCB por sus siglas en inglés), comenzó a agitar en nombre de los trabajadores de Belize. El UDP de Barrow se aprovechó de esa agitación popular y, a fines de enero o principios de febrero de 2005, el gobierno de Musa estaba en peligro de colapsar cuando los sindicatos organizaron una manifestación/marcha en la Ciudad de Belize, el centro poblacional de la nación.

La pandemia del coronavirus creó un escenario en Belize donde el gobierno del PUP electo en noviembre de 2020 se benefició de que durante mucho tiempo no hubo actividad pública en las calles con referencia a la política. Mientras tanto, el UDP se estaba organizando para elegir un nuevo líder, porque la carrera del Muy Honorable Dean Barrow había llegado a su fin, se diría que con éxito, porque había ganado tres elecciones generales consecutivas para el UDP, en 2008, 2012 y 2015.

Se suponía que Patrick Faber, como líder adjunto del UDP, sucedería al Sr. Barrow como líder del UDP, pero, por diferentes razones, el Sr. Barrow no facilitó esa sucesión tan enérgicamente como podría haberlo hecho. Una de esas razones fue que al muy poderoso y rico Gaspar Vega, quien se vio obligado a retirarse del Gabinete UDP a fines de 2016 pero retuvo su escaño en Orange Walk, tenía una aversión apasionada por Faber.

Bueno, no sé cómo funciona la constitución del UDP y todo eso, pero lo que vimos fue que el UDP celebró una

I think in early 2004, February if I remember correctly, the UDP tried to demonstrate against the financial excesses of the PUP administration, where people like Ralph Fonseca and Glenn Godfrey were running wild in financial institutions like the Development Finance Corporation (DFC) and the Social Security Board (SSB). That UDP demonstration, it appeared to me, was a bust.

So it was that things stumbled along until late July of 2004 when a major scandal broke in the SSB. It was for a group of PUP Cabinet ministers to take it upon themselves in early August to confront Prime Minister Musa. In effect, that so-called G-7 had to do the work of the Opposition. For this, there were Ministers like Mark Espat and Cordel Hyde who ended up as scapegoats, and Fonseca/Godfrey loyalists branded them disloyal to the blue.

Younger Belizeans who have heard talk about a so-called "Superbond" should be informed that the Superbond was the product of wild borrowing at commercial rates by Ralph Fonseca, and loose spending.

The upshot of the stand taken by the G-7 in early August was that the general public, led by the various trade unions as organized by the National Trade Union Congress of Belize (NTUCB), began to agitate on behalf of the working people of Belize. Barrow's UDP piggybacked on that popular agitation, and by late January/early February of 2005, the Musa government was in danger of collapsing when the unions organized a demonstration/march in Belize City, the nation's population center.

The coronavirus pandemic created a scenario in Belize where the PUP government elected in November of 2020 benefited from the fact that for a long time there was no public activity in the streets with reference to politics. Meanwhile, the UDP was organizing to choose a new leader, because Rt. Hon. Dean Barrow's career had reached its end, successfully one would say, because he had won three straight general elections for the UDP, in 2008, 2012, and 2015.

Hon. Patrick Faber, as UDP deputy leader, was supposed to succeed Mr. Barrow as UDP leader, but, for different reasons, Mr. Barrow had not facilitated that succession as energetically as he could have. One of those reasons was that the very powerful and wealthy Gaspar Vega, who had been forced to withdraw from the UDP Cabinet in late 2015 but retained his Orange Walk seat, disliked Faber with a passion.

Well, I don't know how the UDP's constitution works and all that, but what we saw was that the UDP held a leadership convention, and John Saldivar of Belmopan, supported by Vega no doubt, defeated Patrick to become UDP leader. Days later, Saldivar was forced to resign because of the Lev Dermen scandal. Since then, there has been a disunity in the UDP which is practically shocking.

I'm not sure how Hon. Moses Shyne Barrow, Dean Barrow's older son and Michael Finnegan's nephew, first became UDP leader. I'm not sure if he defeated Faber in a convention, or Faber simply had to step down because of repeated domestic disputes. I know for sure that Shyne defeated Hon. Tracy Taegar Panton, the area representative for Albert, in a UDP leadership convention a few months ago.

Faber was sniping in television ads from the side all the while, however, and eventually he was disqualified from offering himself as the UDP's candidate in the Collet constituency, where he had won five straight general elections for the party.

Then the superpower United States of America "designated" John Saldivar and branded him as a corrupt politician, which forced the Shyne leadership to disqualify Saldivar from offering himself as the UDP's candidate for the Belmopan constituency, where Saldivar had won general elections in 2008, 2012, and 2015. (But, Saldivar had won the Belmopan seat before that, in 2003 or 2004, I'm not sure, in a bye-election following the death of the PUP incumbent, Agripino Cawich.)

Saldivar challenged the disqualification from Belmopan candidacy at the UDP's National Party Council (NPC) level, and recently he won the support of the NPC. This is another major complication for the Shyne Barrow leadership, following on Patrick Faber's announcement that he will run as an independent in the next general election.

Now, my opinion is that if the ruling PUP suddenly called a general election, all these feuding UDP politicians would quickly find a way to come together. We saw it happen in November of 1969 with the NIPDM coalition, and we saw it happen in June of 1993 with the UDP/NABR alliance.

In the meantime, however, Belize is without a strong opposition to the ruling PUP, and so more and more pressure will come on the trade unions, the media, and other interested parties, to challenge the ruling PUP executive on specific issues. The classic case recently involved the mobilization of the evangelical churches to derail the PUP Cabinet's legalization of marijuana initiative. This situation was confused by the fact that the UDP Leader supported legalization.

And, to repeat, UDP Leader Shyne followed the U.S. State Department's line in disqualifying Saldivar from the Belmopan candidate convention.

To top it all off, so to speak, UDP Leader Shyne is increasingly appearing to be a

Lord Michael Ashcroft crony. In 2003, it was his father's decision not to criticize Ashcroft's cruel telephone fees at BTL which led to the UDP's massive defeat.

These are personal opinions, you know. I am not a UDP hater, even though Dean Barrow victimized Kremandala from 2013 to 2020 because of our stance on the Elvin Penner/Citizen Kim matter. But the nature of the parliamentary system is such that every now and then, people like us in the media need a strong opposition to protect us from a Cabinet gone wild. This was the case in 2003/2004. The history is there for Belize's younger generations to examine.

It was after a lawyer and his wife were viciously murdered, and a law partner of a prime minister was shot, that we started getting murder trials by judge, instead of by jury. One victory from trial by judge is that local lawyers can no longer boast that

Dear Mr. Ely Fabro,

I like the fact that you said something about football in Orange Walk Town, but you failed to mention some key facts. When I was transferred from Belize City to Orange Walk Town to be stationed as a police officer in 1974, there was no football taking place at the senior level in the town. I formed a team by the name of Caribbean Eleven that was supported by Mr. Pedro Cuello. Most of our players were police officers, along with some Garifuna football players from Guatemala and Honduras who were cutting cane in Orange Walk. We were practicing on the field by the Town Hall every evening from 5:00 p.m. to 9:00

One day I went out there, and I saw another group of players, led by a

famous football legend, namely (Orvin) "Stud" Hendricks, practicing. He asked me if we would be willing to play against his team on a Sunday, and I told him yes, but we were working on raising funds for a set of uniforms, because we had no money. I went to Mr. John Loskot, who had a clothing store, and asked him to donate some cloth to our team, and he donated a roll of black and yellow cloth to the team. We became friends after he made that donation, because without him, we would not have had a team. Two of our players were tailors, and one was an artist. The tailors sewed our uniforms, and the artist painted the numbers behind

We then arranged with Stud that we were ready to play against his team by the name of Santos. When that game was played on the field, it was packed with people from Orange Walk Town

and Orange Walk District. That was the game that resurrected football in Orange Walk Town and District. Prior to this, football was dead in Orange Walk Town that year.

The late Joe Briceño, the Orange Walk North area representative, and his friend Ramon Cervantes, the school teacher, came to me and asked if we would be interested to form a football league, and I said yes. That meeting was held at the Town Hall through the efforts of his brother, the then mayor, Leopold "Polo" Briceño, who loved and was passionate about football. Enrique Carballo had just returned from his studies in Honduras, and I asked him to play with us, but he did not. Later on he ended up playing for Riverside, the team that was sponsored by Amado Vasquez, which I later joined. At the time that football was resurrecting in Orange Walk Town, the field by the Town Hall was being abandoned and permission was being sought from BSI to have the football competition on their grounds next to Trial Farm up the hill.

Teams from all over Orange Walk Town and District were enrolled in this tournament, and the team that won the first championship was "Spurs", sponsored by Mr. Nicholson from Douglas. Matthew Williams left our team to play for that team. We changed our name before the tournament started from Caribbean Eleven to Astros, because we received sponsorship from Mr. Coyock from Trial Farm, a football In 1975, the second championship was won by Santos, sponsored by Stud Hendricks himself. Stud Hendricks should be given a lot of credit for his contributions to football in Orange Walk Town, not only as an exceptional player but also as a football legend. I have a lot of respect for him, even though we only played for the Orange Walk Selection together.

I won three championships with Gregsie Jones, Matthew Williams and Enrique Carballo.

Orange Walk was developing talented football players all over the district. When the Inter-District Competition started in 1975, we formed a committee to select the Orange Walk Inter-District Selection players. Most of these players were from Orange Walk Town and came from the following teams: Spurs, Santos, Riverside, Astros, Belize Road, Trial Farm and San Jose Palmar.

Even though I must admit that there were some exceptional players from the other villages who were not selected to play, this was the first out-of-district team to convincingly defeat the All Belize Selection at MCC Grounds in Belize City. From there they continued to excel and ended up playing in the Inter-District Finals in 1975 and 1976, back to back. We lost to the Stann Creek Selection at MCC Grounds on both occasions.

I am writing this because for me history is very important for our children, grandchildren and generations to come. I want this article to be shared among the Orange Walk citizens who are still around so that they can give their versions of their stories.

He was five years from retirement and knew that no bank would lend him that kind of money with no security and a short remaining work life.

When he bought the medical policy, the agent had assured him that he was covered for this very kind of eventuality. The word he used was "catastrophe," and this was catastrophic by any measure. If the insurance had indeed declined to pay, he was ruined.

Jim dropped the letter on the seat, leaned forward on the steering wheel, and sobbed loudly.

The insurance company confirmed that there was no cover. Their explanation used technical language he had not heard before; words like "lines," "excess of loss," "ceding company," "retentions," and on and on. 



No estoy seguro de cómo el Honorable Moses Shyne Barrow, el hijo mayor de Dean Barrow y sobrino de Michael Finnegan, se convirtió por primera vez en líder del UDP. No estoy seguro si derrotó a Faber en una convención, o Faber simplemente tuvo que renunciar debido a las repetidas disputas domésticas. Sé con certeza que Shyne derrotó a la Honorable Tracy Taegar Panton, representante de área de Albert, en una convención de liderazgo

UDP hace unos meses.

Sin embargo, Faber estuvo criticando todo el tiempo en anuncios de televisión y, finalmente, fue descalificado para presentarse como candidato del UDP en el distrito electoral de Collet, donde había ganado cinco elecciones generales consecutivas para el partido.

Luego, la superpotencia Estados Unidos de América "designó" a John Saldivar y lo tildó de político corrupto, lo que obligó a la dirigencia de Shyne a descalificar a Saldivar para que no se ofreciera como candidato del UDP a la circunscripción de Belmopan, donde Saldivar había ganado las elecciones generales en 2008, 2012, y 2015. (Pero, Saldivar había ganado el escaño de Belmopán antes de eso, en 2003 o 2004, no estoy seguro, en una elección parcial tras la muerte del titular del PUP, Agripino Cawich).

Saldivar impugnó la descalificación de la candidatura de Belmopán a nivel del Consejo Nacional del Partido (NPC por sus siglas en inglés) del UDP, y recientemente ganó el apoyo del NPC. Esta es otra complicación importante para el liderazgo de Shyne Barrow, luego del anuncio de Patrick Faber de que se postulará como independiente en las próximas elecciones generales.

Ahora, mi opinión es que si el gobernante PUP de repente convocara elecciones generales, todos estos enemistados políticos UDP encontrarían rápidamente una manera de unirse. Lo vimos suceder en noviembre de 1969 con la coalición NIPDM, y lo vimos suceder en junio de 1993 con la alianza UDP/NABR.

Mientras tanto, sin embargo, Belize no tiene una fuerte oposición al gobernante PUP, por lo que habrá más y más presión sobre los sindicatos, los medios de comunicación y otras partes interesadas para desafiar al ejecutivo gobernante del PUP en temas específicos. El caso clásico involucró recientemente la movilización de las iglesias evangélicas para descarrilar la iniciativa de legalización de la marihuana del Gabinete del PUP. Esta situación se confundió por el hecho de que el líder UDP apoyó la legalización.

Y, para repetir, el líder del UDP, Shyne, siguió la línea del Departamento de Estado de EE. UU. al descalificar a Saldívar de la convención de candidatos de Belmopán.

Para colmo, por así decirlo, el líder UDP Shyne parece cada vez más ser un compinche de Lord Michael Ashcroft. En 2003, fue la decisión de su padre de no criticar las crueles tarifas telefónicas de Ashcroft en BTL lo que condujo a la derrota masiva del UDP.

Estas son opiniones personales, ya saben. No soy un enemigo del UDP, a pesar de que Dean Barrow victimizó a Kremandala de 2013 a 2020 debido a nuestra postura sobre el asunto de Elvin Penner/Ciudadano Kim. Pero la naturaleza del sistema parlamentario es tal que, de vez en cuando, la gente como nosotros en los medios de comunicación necesita una fuerte oposición para protegernos de un Gabinete que se ha vuelto alocado. Este fue el caso en 2003/2004. La historia está ahí para que la examinen las generaciones más jóvenes de Belize.

4 women charged for shopping with stolen debit card

BELIZE CITY, Tues. Dec. 27, 2022 Four women who went on a pre-Christmas shopping spree at a number of stores using a stolen debit card appeared on Friday, December 23, in the Magistrate's Court in Belize City, where they were charged for the offense. The women, who together spent a total of approximately \$7,000 on items that reportedly included groceries and alcohol, are Candice Parham, 37; Kecha Miller, 35; Catherina Cadle, 32; and Deandra Parham, 21.

The debit card used by the women belonged to Symone Ogbujil, 29, who reportedly last had her purse in her possession on December 16, but did not notice that it was missing until three days later, on December 19. On that same day (December 19), she filed a report that her purse, which contained her Atlantic Bank debit card and her ID, was missing. Police then began an investigation, during which they found out that, since the reported disappearance of the purse, a number of purchases had been made at several stores with a debit card belonging to Ogbujil. They later identified the four women as the persons who had made those purchases.

Police first apprehended Candice Parham and Catherina Cadle, then on Thursday, December 22, Deandra Parham surrendered herself into police custody.

Last Friday, the four women appeared in court unrepresented and were charged with a single count of card theft. Only one of the four,

Deandra Parham pleaded guilty to that charge. According to Parham, who confessed to using the card to purchase a total of \$5,165.00 of goods, she had found the debit card. The other three women, however who reportedly used the card to make purchases totaling \$1,642.00, pleaded

Deandra Parham, who apologized for what she had done, was not given a prison sentence, but was instead fined \$2,500 plus a \$5 court cost, which she will have to fully pay by March 31, 2023. Otherwise, she will have to serve four months in prison. She was spared a more severe sentence because, according to the magistrate presiding over the case, she was a first offender who seemed sorry for what she had done, and she promptly pleaded guilty, which saved the court time. The three other women were each granted bail of \$1,500 and one surety of the same amount. They are scheduled to return to court on February 20, 2023.

Reflections on the World Cup 2022

The World Cup 2022 epic final had all the elements one could desire in the battle for football's most prestigious prize: to crowned world champion. The matchup between soccer giants France and Argentina began to take shape after 4-time winner Germany and 5-time winner and favorite Brazil shockingly made early exits in the first round and group stage, respectively. The competition was saturated with incredible, brilliant athleticism, and magical moments such as the tournament's sensational one-of-two goal-scoring acrobatic scissor kick by Brazil striker Richarlsion, which was

blasted against a stunned Serbian team.

Then came tournament's unscripted seismic earthquake when Saudi Arabia humiliated Lionel Messi's Argentine team by defeating them 2 goals to 1 in their opening game. The win by Saudi Arabia was so earthshaking, it reverberated across the Arab world, with the Saudis declaring a national holiday in celebration of their triumphant accomplishment and their King awarding a Rolls-Royce to each player on the squad. However, this was only the beginning of the toppling of some of the tournament's traditionally dominant teams. The challenge by smaller

nations to the hegemony of a handful of European countries is expected to increase as FIFA expands the roster from 32 to include 48 nations in the World Cup 2026.

Costa Rica couldn't replicate its 2014 magnificent performance and was demolished by Spain 7 – 0 in a game that was the tournament's most lopsided and painful to watch. Yet, Costa Rica rebounded and put up a gallant fight against a 4-time World Cup champion, Germany. The match ended with Germany winning 4-2, but the Germans were still eliminated based on points, and as a result of Japan's defeat of Spain in the group stage. In essence, the Costa Ricans assisted in sending Germany home in the first round of the World Cup. Costa Rica was the only country from the Central American mainland that qualified for the 2022 competition when they defeated New Zealand 1-0 in the intercontinental playoff. Costa Rica can hold its head high for its accomplishments.

Yet there was plenty of drama, controversy, and allegations to come as the games turned on their head and the tournament took shape. Black Africa was represented by the legendary Senegalese, Cameroonian, and Ghanaians. Despite their brilliance and athleticism, they continue to suffer from a kind of psychological disposition that affects performance even before they hit the field. The Arab North African team Morocco did not have superior players on the field against Spain as Senegal had against England. In their crucial game against England, Senegal, who had advanced to the group of 16, came out strong, played with high-quality tenacity, and attacked in the first 20 minutes, almost scoring a goal, then went to sleep for the remainder of the game. England's 1st goal came from a spectacular pass by the brilliant 19-year-old Jude Bellingham to an unguarded striker right in front of Senegal's goalie, exposing weak defense and tactical mistakes. Senegal never recovered.

Cameroon defeated 5-time World Cup winners Brazil 1-0 and Switzerland won 3-2 over Serbia. If Serbia had beaten the Swiss, Cameroon would have advanced to the final group of 16, as they did in their magical run in the 1994

games, led by the unforgettable 42-year-old super striker Roger Milla. Cameroon was Black Africa's star at the '94 World Cup, and many had hope that they would rise again in Qatar. Both African countries had the potential and talents to have gone beyond the qualifiers. In Ghana's game against Portugal, they played passively in the first half with a little counterattack, but this tempo changed as Ghana equalized by tying the score 1-1. As Ghana became more confident, they

struck again with a second goal. However, all of Ghana's midfielders and defense just sprinted alongside Portugal's incoming strikers with no attempts to disrupt the play and allowed 2 uncontested goals. At the end of a game they should have won, Ghana fell to Portugal 3-2. One of the major impediments for Black Africa is that many of their top players are recruited by Europe with promises of a big payday, fame, and glory. This saga was on spectacular display when Switzerland's 1st goal against Cameroon was scored by a native player from Cameroon. Striker Breel Embolo refused to celebrate with the Swiss team, as he was clearly torn and conflicted playing against his countrymen and colleagues. Despite these challenges, Africa is poised for preeminence in world soccer, as their quality continues to soar.

Some of the most controversial moments occurred when Brazil went from glory to agony against the former enclave of the now-defunct Yugoslavia, Croatia. Brazil, a favorite to win the World Cup title, failed to put the upstart Croatians to sleep in regulation and tied 1-1, which forced them to play the football penalty lotto. It was a shocking and fatal gamble; they lost 4-2, leaving

fans stunned around the world. Also, highly controversial and questionable was why in heaven's name would Brazil bench its elite striker Richarlison De Andrade in such a crucial game. It remains a mystery.

Argentina vs the Netherlands was equally controversial. Antonio Mateu Lahoz, the referee from Spain, allowed several fake dives and gave free kicks and penalties to the Argentines. The Dutch came from behind and tied the game 2-2, forcing it into overtime. The game was determined by the infamous penalty lotto shootout that Argentina won 4-3. Most lovers of the game prefer to see winners determined in regulation by beating their opponents fair and square on the field. Yet, no other mechanism has evolved in the sport to replace penalty shootouts when no team can win in regulation.

Japan had a great run at the games by defeating two World Cup champions, Germany and Spain. They played Croatia to a tie 1-1, and forced them into overtime and an eventual penalty shootout. It appeared that the highly disciplined Japanese players were demotivated by not winning outright on the field and approached the penalty lotto completely nonchalantly. To this

end, Japan had no convictions in their penalty kicks and was thus eliminated by Croatia. Unfortunately for Korea, they had to contend with facing Brazil in the group stage, and the Brazilian did not disappoint by scoring 4 goals in 30 minutes against the dominated Koreans. The game ended with the Koreans managing a single goal, which resulted in a 4-1 win for Brazil.

Morocco vs. Spain. Nobody expected Morocco to topple Spain in their match. However, the Moroccan's strategy was to erect two walls of defense, combining mid-fielders with a defensive posture against the Spanish squad. It worked, and Spain, despite having several opportunities, could not execute and finish in regulation. The game went into penalties, and Morocco eliminated the 2010 World Cup champion. But Morocco's Cinderella ascendancy at the World Cup was indeed magical. They defeated both Spain and Portugal to claim a spot in the semifinal.

The other game of historical consequence was between France and England. England has some great individual players, such as their 19-yearold striker, Jude Bellingham, but despite being awarded 2 penalties, with one of them highly questionable, their aging forward Harry Kane scored one and completely missed the goal on the other. With this performance, they didn't deserve to be in the finals. There was no outcry and criticism from the British press and fans about Kane's abysmal penalty performance, like the racist attacks the Black players received who had missed penalty kicks in the Euro championship earlier.

Some have argued that the Argentine ascendancy to the final with France was orchestrated by FIFA in an epic farewell to the aging star Lionel Messi who had never won a World Cup title. There are many (real) reasons I am not a fan of Argentina, and to be explicitly clear the only legend I admire from that white supremacy culture is the remade and enlightened revolutionary Ernesto Che Guevara. The French are no different; however, their national team was

represented by the African diaspora, of which I am a member and supporter. In addition, they have one of the most explosive young forward strikers in the world, Kylian Mbappe.

The match between France and Argentina was the most epic I have witnessed in my lifetime. But it was not without controversy. Argentina appeared to dominate in the 1st half, then late in the second half, all hell broke loose in spectacular fashion. Kylian Mbappe

exploded with a sensational goal and assisted in tying the game in a convulsing conclusion at 3-3. With momentum on their side, France ran out of time and could not finish the game in regulation, thus forcing a penalty shootout. It was not how most wanted to see this epic game conclude, but it wasn't to be, and Argentina won by penalty 4-2. Messi won his World Cup, and the future belongs to Kylian Mbappe, who scored the most goals, 12, to be precise, in the World Cup 2022 and was awarded the Golden Boot trophy.

There were many players who dazzled us on the field, but for me, the three who left the most memorable performance are England's Jude Bellingham, Brazil's Richarlison De Andrade, and France's Kylian Mbappe.

In closing, I cannot complete this writing without paying respect to the thousands of slave workers who suffered and died building the infrastructure and elegant stadiums whose names we shall never know. The only reason Qatar was in the World Cup is that they are the host country. They were destroyed by Ecuador, one of the weaker teams in the tournament. Qatar played lazy and kept passing the ball around with zero strategies, as though they were winning the game. They took 4 years to prepare a national team, but stumbled out like the amateurs they are. One of the tragic human stories to hang over the World Cup 2022, is the amount of slave labor deaths in Qatar in preparation for the games. Racing to meet deadlines and building the infrastructure and giant soccer stadiums proved deadly. Most of the workers are imported from Africa and Asia, with passports confiscated, and are forced to work 12 to 14 hours a day under horrific conditions. According to FIFA and human rights organizations, upward of 500 to 6500 workers have perished in building beautiful Qatari stadiums and infrastructure. The sad reality is that these facilities will never be used again in this capacity. Hopefully, their families will be adequately compensated financially. May their souls rest in peace.

Weekend rains impede cane deliveries

Association (BSCFA) on Friday. BSI reps have indicated that the scale of machinery used for milling requires a threshold amount of cane to maintain a steady flow of production, and that the amount of cane that had thus far been delivered was not enough to meet that threshold. Olivia Avilez, Manager of Cane Farmer Relations at BSI, at a press briefing called by the company specified the minimal amount of cane that would have been needed to start the milling operations: 600 tons of cane. She also noted that an assurance of a consistent supply from the farmers is also needed prior to to starting what is a large-scale, intensive milling process. Until the quantities of cane being delivered are sufficient and there is a steady, rather than halting, flow of such deliveries, the BSI has thus opted to delay grinding the sugar cane that has so far been delivered but has begun offloading the cane.

Deliveries, which had been scheduled to start at about 10:00 on Tuesday, December 27, reportedly started at about noon that day.

"We haven't started grinding. We have started to receive the cane and offloading. We haven't started grinding because, what is important is that when we start, we don't stop. This is a big machine; of course, it's an entire system. So, once we start grinding, we want a steady flow. So, we are awaiting information from the SCPC manager, who is confirming the numbers from the cane farmers.... We estimate later today, maybe in the late afternoon, that we're able to start grinding," said Avilez.

During an interview with CTV3, Avilez said, "We understand that farmers are just taking a little bit longer on the field to load, and there is some already on the way." She said that, although only one boiler has been active, due to modifications that were made to ensure that the air emissions from the factory are less harmful, the company aims to have the second boiler in operation before the January 2023 deadline.

"We will start with half the usual amount, because of the issue with cane supply, and so we are starting with that, and as we progress and we are sure about cane supply, then we can move forward, and move up the milling rate," Avilez further explained.

Chairman of the Sugar Industry Control Board (SICB), Marco Osorio, said that they expected to have been notified earlier of the decision to delay milling due to insufficient cane.

"I just forwarded a message to Mr. Chavarria [BSI Director of Finance] asking him why the gates were not open if the time was 10 o'clock, and his response, was 'there is not enough cane supply and we don't want to start and stop'. It is understood, but that communication should have come earlier, you know, officially from their end," Osorio said.

He agreed that given the weather conditions and the farmers' limited ability to extract cane from their fields at that time, starting the mill at a 50% production rate was a practical decision, but as the harvest season progresses, full production levels will be needed.

"Well, at the end of the day, every day that we are not able to deliver at full capacity, it simply means that it is cane that is being delayed in the field, but also, being honest, we will have a pretty much of a difficult start, little challenging because of weather condition, we say, over the weekend, and field conditions are not optimum as yet — we still have water in the fields," Osorio said.

According to him, the Sugar Cane Production Committee (SCPC) estimates that 1.34 million tons of cane can be milled this year. BSI has indicated that they expect to mill one million one hundred and fifty thousand tons of cane to produce one hundred and twenty-three thousand tons of sugar.


"The crop is expected to run from today to the end of July," Osorio said. He said that with the water damage, pest damage, and quantity of stand-over cane, they are concerned about the cane quality.

"The mill issued a first price estimate indicating that starting with a TCTS of 9.39, and I recall at last crop which started with better conditions than we have today, and the TCTS back then was at 10, so we had questioned why 9.39 because of the condition we have today, which are far different from last year, and we definitely foresee that there will be a big challenge in terms of TCTS cane quality," Osorio said.

Undelivered sugar cane that had remained in the fields since last year (or standover cane) will be a significant part of deliveries for this year. In an interview earlier this month, Minister of Agriculture, Jose Mai noted that around 125 tons of cane were left in the field last year.

Avilez said that ensuring that the maximum amount of sugar is extracted from the sugar cane is important. This will require that the milling target be met every day.

"The SCPC has made an estimate of around 1.3 million tonnes and a little bit more. Our perspective on that is, again, every year, we have an inflated production estimate. And again, this year, we think that there has been a lot of impacts from flooding and stand-over cane which will not yield production estimate. And we've also had some impacts from frog hoppers, which are one of the key pests in the industry. So, with all of that, our estimate is around 1.15 million tonnes of cane. When we lose, it's not just days. We lose the amount of cane... What is worse, when you don't have your crop in the cycle is that you're losing sugar, and you're also impacting the following crop. For example, right now, the cane is already impacted. You have the stand-over cane that we didn't mill last year because we had a really late start again.... So, you have that cane that's already impacted, that's going to start to come into the factory. You have less sugar from the year before, and you're also having those fields being able to ratoon... So, you don't have that production. You don't have the sugar content that should have come in, and you also don't have the optimal time of that cane, because the maturity of that is long gone. So, when you're calculating, or when you're looking at the impact of not starting a crop season in time, you have to look at all of those factors," she said.

Will new CFB president Alicia Thompson ride in Krem Classic 2023?

BELIZE CITY, Wed. Dec. 28, 2022

With the days winding down to the Krem New Year's Day Cycling Classic 2023, speculation among cycling fans and enthusiasts surrounds the question whether the newly elected first-time female president of the Cycling Federation of Belize (CFB) and 6-time Krem Classic Female Champion, Alicia Thompson will be riding this time. Alicia is the woman with the most Krem Classic championships to date, followed by Shalini Zabaneh with 5 wins. Shalini retired a few years ago, and is now goalkeeper for NAWL football champions Sagitun Girlz. Alicia confirmed this morning with Amandala Sports desk that she will NOT be riding in the upcoming Krem Classic.

One does not have to play a particular sport to become a good administrator in it, but it does add some flavour and insight to the leadership when they can also boast of experience at the highest levels of competition, and the current CFB executive can certainly boast of such. In fact, Ms. Alicia Thompson, the new CFB president, won six Krem Classic championships, including four consecutive, over a period from 2006 to 2020 (2006, 2015, 2016, 2017, 2018, 2020), including the current record of 2:43:30 in 2018, a feat not likely to be surpassed any time soon, and she is also the first female president of any major sports federation in Belize. She is also a two-time Women Cross Country champion in 2015 and 2017.

Alicia will not be on the bike to start the new year, but as CFB president she will surely be "riding" with all the cyclists, young women and men, vying for the Krem Classic championship on New Year's Day 2023.

Pedal by Pedal of Chief's Single Cien BAXING DAY Classic of 2022

BELIZE CITY, Wed. Dec. 28, 2022

Despite cold and rain some, 30 Elites and 5 Juniors registered for their version of this race now in its 2nd year. Meanwhile, that number was doubled to 70 riders in the WW/GONS Category. There were 20 station prizes of \$50 and \$100 in this 62-mile race, which works out to about one every 5 miles.

The Elites took off at 8:15 while the WW/GONS Riders took off 10 minutes later.

In the Elite Category a break was quickly formed of 8 riders including 3 of the VALVOLINE/501 Squad in Oscar Quiroz, Joshua Fuller and Brandon Cattouse, while WESTRAC was represented by Wasani Castro and Eric Trapp. FAL had Derick Chavarria and newcomer Dylan Levy. Meanwhile, Henry Lee was the sole representative of the G-Flow team but rode a monster race. At the tape it was Joshua Fuller taking the big W, followed by Wasani Castro, Henry Lee, Oscar Quiroz and Eric Trapp who rounded out the top 5.

Meanwhile in the Weekend Warrior/Gons Category, 6 riders made good their escape in the first 5 miles. However, by the midway point 8 more riders connected to this front group making it a strong 14man breakaway. Team Santino's had 3 riders in this front group including Mexican Gabriel Cardozo, who had recently won the GONS Hills Race on November 20th. He was accompanied by teammates Mexican

David Balam and Belizean Daniel Cano. Team SPD had Smoke Gladden and Philip Leslie; Running Rebels had Athlee Lozano and Claude Young; while the remaining riders were single representatives of other teams including George Abraham Jr. of Imani's, Heno Moreira of VALVOLINE/501, Joey McKoy of Shattaz, and Ryne Bradley of Wateva Boyz, among others. Right after they sprinted for the \$100 at Prison on the return, the attacks commenced with a little more than 20 miles still remaining in the race. As they exited the Boom Road unto the Northern Highway, the attacks by the Mexicans were relentless, with Cardozo sweeping up most of the station prizes. As they jumped the Haulover Bridge fatigue started to show on many riders, and as they approached the station prize at Design Depot, Heno Moreira attacked and only the Mexican Gabriel Cardozo caught the move. Cardozo swept the final 3 station prizes. As the remaining riders caught these 2

front runners there was less than a mile left to the finish line at San Cas Plaza. Right after the Buca Shell Gas Station, the Mexican David Balam, who was doing the yeoman's share of the pacing, got a flat and that was it for him. As they went around the last roundabout with some 700 meters to the line, the other Mexican Gabriel Cardozo, 45 years of age, caught everyone by surprise with a massive attack, which he was able to hold to the line, giving him his 2nd victory in a row here in Belize.



Like Pele, France striker Kylian Mbappe shot to stardom after winning the World Cup at a young age.

Mbappe helped France lift the World Cup in 2018 and also scored a hat-trick in Les Bleus' dramatic penalty shoot-out defeat against Argentina in the tournament's 2022 final earlier this month.

"The king of football has left us but his legacy will never be forgotten. RIP KING," PSG forward Mbappe tweeted.

Former England World Cup winner Geoff Hurst hailed Pele as the "greatest of all time".

Hurst played against Pele in the 1970 World Cup, with Brazil winning a group stage match between the two countries 1-0, and rated the forward as the best he ever faced.

"I have so many memories of Pele, without doubt the best footballer I ever played against (with Bobby Moore being the best footballer I ever played alongside)," Hurst tweeted.

"For me Pele remains the greatest of all time and I was proud to be on the pitch with him. RIP Pele and thank you."

Hurst's record as the only man to score a World Cup final hat-trick — in England's 4-2 victory against West Germany in 1966 — was equalled by Mbappe in Qatar.

Gunshot kills man, 61; 77-yearold wounded

year-old Emert Flowers, in whose yard the men had been sitting, sustained more severe wounds that caused his death, and many believe Flowers, who was a tour guide who had previously lived in the United States, was killed to send a message to his son.

According to initial reports, at around 10:00 p.m. on Tuesday, Flowers and Waight were sitting together in the gated yard when an unknown gunman forced his way onto Flowers' property and unleashed several shots in their direction. Flowers died on the spot, while Waight, although wounded, fled.

The two men were later transported to the Karl Heusner Memorial Hospital, where Waight was admitted in stable condition. Flowers, however, was pronounced dead on arrival.

It is being reported that Flowers, who owned a van that he used to take cruise ship visitors on tours, was killed by persons who wanted to send a message to his son, who is said to be a gang affiliate.

That son, Kyle Latchman, has, according to some sources, been missing for a few days. Flowers' sister, Ana Flowers, who is currently on a visit to Belize from the US, told reporters, "My nephew is missing for the last three to four days, and I understand that he's supposed to have gotten kidnapped, and whoever got him hold, I would ask for them to let him go, or... I don't know. But they got him hostage and they turned around and killed my brother that don't have anything to do with what my nephew do in Belize."

Flowers, who was a father of 5, resided alone at his residence.

persons to sit on the tribunal will be a person appointed by the Minister with academic training in an environmental field, and the Senator representing the Private Sector, in this case, Senator Kevin Herrera. (Notably, the Belize Chamber of Commerce and Industry, had stated, following the NEAC decision, that its representative, despite not being present to receive a full briefing on the technical aspects of the project and the environmental risks of the project, would nonetheless have voted to support the Waterloo project).

The tribunal is empowered under the related legislation to make rules and regulations to govern the procedure for hearing the appeals. Section 27B (3) states that the "decision of the tribunal shall be by a majority."

As previously noted, two of the three persons voting in favor of the project at the tribunal level can override the decision of the 16-member NEAC. It must be noted that the Sustainable Development Minister will not be a member of the tribunal, and any final decision will not rest with him, as was the case in a previous version of this legislation.

At this point, in a process that has veered so abruptly away from the previous procedures that involved public consultation and scientific review, the tribunal alone has the power to confirm, vary, amend or alter the decision made by the DOE. According to subsection 5 of the legislation, they have the power to reverse the previous decision by the DOE for "any decision which is just and equitable and which is in the interest of the protection and management of the environment." It is not known how extensive the evidence/data (if any) presented by the tribunal to justify any claims that a "just and equitable" decision was made in the "interest of the protection... of the environment" will be

Karl Heusner Memorial Hospital. Hinds and another man had been charged for that heinous shooting which took the 5year-old girl's life and wounded her mother, whose injuries were classified as grievous harm.

While many believe that the murder of Hinds on Tuesday was an act of retaliation for his suspected role in the murder of the child, the communications director for the Belize Police Department, ASP Fitzroy Yearwood, told local reporters that the police must carry out an investigation before concluding that the two incidents are linked.

"One, we haven't established the true motive as yet. So, we wouldn't want to say at this early in the investigation what we believe. What we will do and we have done already is put measures into place to stop any retaliation from his group. As I said at this point, at this time we do not know the true identity of the assailant but we have everything in place to prevent any form of retaliation," he said.

ASP Yearwood said that several persons have been detained for questioning in connection with Hinds' murder.

and how that reasoning will align with all data and scientific arguments presented by the DOE to explain why it could not approve the project of Waterloo.

After outlining its decision in writing, the tribunal may refer the matter back to the DOE for the preparation of an environmental compliance plan or to fulfill any other requirement.

An online advocacy group named Belize Marine Life made a poignant observation in a post which stated, "To Clarify: 2 of the 3 members are all that are needed to change the outcome of a national decision to reject this project. This seems like an easy obstacle for Ashcroft to purchase a win. Who will be the three appointed tribunal members?"

They also question whether the tribunal deliberation will be held publicly or en camera, and suggested that a unanimous decision by the tribunal, rather than a majority decision, be required to overrule any previous decision that was made.

"At the very least, this SI needs to be changed to require all 3 members to agree, a unanimous decision of 3 people to overturn the NEAC ruling of the 16member panel (based on 2020 revision of EIA Regulations.)," the post on Facebook noted. They also pointed out that the appeal process is not very welldefined, with no timeline to ensure the completion of deliberations by the tribunal. It could be argued that those specifics are handled by the appointed tribunal's chairperson and members.

"The DOE appears to legally be able to shelve this tribunal for decades if they chose to end this litigation-based strategy by Ashcroft to try and force Belize to swallow his dredge spoils and his project," the group's post suggested meaning that the current administration could possibly put a pause on this derailment of the NEAC and DOE's decision, if it so chooses.

All members of the tribunal must be present at the hearings of the appeal in order to establish a quorum.

Nuestra economía en vísperas de 2023

Después del acuerdo del Bono Azul, el Secretario de Finanzas, el Sr. Joe Waight, había advertido que el acuerdo no conduciría a "ningún flujo de efectivo adicional para el gobierno y el país en el corto plazo", y que permanecíamos en "el precipicio de peligro financiero." En vísperas de 2023, la relación deuda/PIB ha mejorado considerablemente, pero nuestro país todavía está en las garras de la pobreza.

En vísperas de 2023, estamos a horas de un aumento prometido del salario mínimo a \$5 por hora. La inflación ha erosionado el poder adquisitivo del dólar beliceño, en algunas áreas hasta en un 30%, por lo que el pequeño extra en el cheque de pago de los beliceños peor pagados es oportuno.

En vísperas de 2023, el costo del combustible es más alto que en vísperas de 2022, y los beliceños están forzando sus bolsillos para pagar las facturas en las bombas de combustible. Los beliceños piden a gritos alivio, y ha habido una caída en el costo del combustible a fines de diciembre, pero el Gobierno de Belize ha indicado que los precios del combustible no volverán a los niveles previos a la pandemia hasta que un nuevo acuerdo de Petro Caribe con Venezuela este rodando hacia nosotros de nuevo.

Los beliceños ven el precio del combustible en los EE. UU. en las noticias de la televisión estadounidense, pero realmente no podemos compararnos con ellos. La Administración de Información de Energía de EE. UU. (EIA, por sus siglas en inglés) dice que "los impuestos federales incluyen impuestos especiales de 18,3 centavos por galón de gasolina y 24,3 centavos por galón de combustible diésel, y una tarifa por fugas en el tanque de almacenamiento subterráneo de 0,1 centavos por galón en ambos combustibles". Si bien los estados de EE. UU. aplican impuestos adicionales sobre el combustible, al final del día, los impuestos sobre el combustible en los EE. UU. no se acercan a lo que los beliceños tenemos que pagar. La verdad es que nuestro Gobierno depende mucho de los impuestos a los combustibles para el funcionamiento del país.

En julio de este año, la Oficina de Prensa del Gobierno de Belize dijo que el costo de adquisición del combustible había subido un 300% desde noviembre de 2020. En ese mismo comunicado, el Gobierno dijo que "en noviembre de 2020 y de manera continua durante los años anteriores, el impuesto especial sobre el diésel y la gasolina regular era \$2.97 y \$3.29 por galón, respectivamente" y que para aliviar el dolor del combustible, los impuestos sobre el diésel y la gasolina regular "se habían reducido prácticamente en un 100 % y un 77 %, respectivamente, hasta menos de un centavo y 75 centavos por galón".

En vísperas de 2023, seguimos siendo en gran medida un país del "tercer mundo", desde la esclavitud hasta el colonialismo y al neocolonialismo. Hay tanta necesidad en nuestra tierra. Pero, en el balance, nuestro país está mejor que en vísperas de 2022. police station, and the 10 detained tourists were eventually taken back to the PGIA, where the proper process of interviewing them and reviewing their documents was carried out, after which they were allowed to enter the country, without any charges.

It is to be noted that because a significant number of Haitian nationals have been traveling to Latin America as visitors in an attempt to enter the United States from these countries in the region (particularly Mexico), the Ministry of Immigration has put into place stringent policies regarding the entry of persons who arrive on flights coming out of Haiti. As part of that more hardline approach being taken by the country, chartered flights have not been allowed to land in the country for some weeks.

Saldivar has emphasized the fact that if persons come into the country legally, they should be protected under our Constitution, as is mandated.

"As far as I am aware, there is no law that prohibits any CARICOM national from visiting Belize, Haiti is a member of CARICOM, and certainly the Haitians ought to be afforded every right as any other CARICOM citizen to land in Belize once they show that they fulfill the requirements," Saldivar said.
