Belizean Demetrie Meyers wins two gold medals at **CARIFTA Games**

NASSAU, Bahamas, Wed. Apr. 12,

A 14-year-old boy has cemented his name in the history books of Belize's sports after winning two gold medals in the U-17 Track and Field event over the weekend at the 50th CARIFTA Games held in Nassau, Bahamas, April 8 to April

Demetrie Meyers, a 14-year-old Belizean and a freshman at Haverford High School in Haverford, Pennsylvania, participated in the CARIFTA Games in the Bahamas and won a gold medal in the 1500-meter competition on Saturday, and then another in the 3000-meter competition the following day.

Meyers dominated the competition, as he ran away from his competitors in both events. On Saturday in the 1500m, he finished with a time of 4:11.19 ahead of Guyana's Javon Roberts, who

Belizean Oscar Quiroz wins 2023 Holy Saturday Cross Country Classic

BELIZE CITY, Wed. Apr. 12, 2023

Belizean Oscar Quiroz (Team 501 Valvoline) was the first rider across the finish line and won the 93rd running of the annual Holy Saturday Cross Country Cycling Classic on Saturday, April 8, in a time of 5 hours, 43 minutes and 19 seconds.

He out-distanced his nearest competitors Cory Williams 2nd (Team L39ION — 5:44:41), a Belizean American; and Johnathan Brown, 3rd (Team Miami Blazers —5:44:42), an American.

Quiroz won \$11,000, 5 trophies, a cup, a championship jersey, \$1,100 as the first Belizean across the finish line, and the traditional garland for his winning ride, but was also instantaneously lauded throughout the Belizean nation as "The King of the Country" as Belizean hearts swelled with pride.



Veggie vendor killed in **Gungulung**

BELIZE CITY, Thurs. Apr. 13, 2023

In the late hours of Wednesday, April 12, a vegetable vendor from the Valley of Peace community, Cayo District, identified as Jose Antonio Lopez, 35, was fatally wounded on Barbara Harris Street in the Gungulung area of Belize City.

Initial police reports

indicate that at around 11:00 p.m. that Wednesday, Lopez was socializing on the street when three unknown individuals approached him, and a struggle ensued between the men. During the altercation, one of the men fired gunshots and fatally injured Lopez.

The three men then fled down Barbara

Harris Street, after stealing Lopez's wallet which contained cash and his licensed firearm that he kept on his person. Lopez was transported to the Karl Heusner Memorial Hospital, where he was pronounced dead at around 1:07 a.m.

Lopez sold vegetables in Belize City and Belmopan but resided in the Valley of Peace area.

According to the family of Lopez, he wasn't

affiliated with any gangs, and worked hard to provide for his children. They also vowed to get justice for their loved one and are hoping the footage of the cameras in the area will lead to the identification of the men responsible for his death.

He leaves behind 4 children – the youngest a year old.

Prime Minister Hon. John Briceño has been served with a Notice of Arbitration under the rules of the United Nations Commission on International Trade Law 2021. Two companies owned by Lord Michael Ashcroft – the British Caribbean Bank and Prize Holdings International Limited—are taking the Government of

Belize before the Permanent Court of Arbitration in The Hague seeking 5 areas of relief. A letter which was sent to the Prime Minister to signal notice of the dispute, indicated that government has three months to reach an "amicable settlement" on the matter of the environmental clearance of the Port of Belize Cruise and Cargo

Terminal Project after a second denial by the Department of the Environment (DOE) following a recommendation that was issued by a 16-member National Environmental Appraisal Committee

That local body has outlined significant shortfalls and major unaddressed risks that it observed in the developer's methodology which was outlined in the second iteration of the Waterloo EIA (Environmental Impact Assessment). The principals of The Port of Belize Ltd., all of who fall under the umbrella of the multi-tentacled Waterloo Investment Holdings Limited, have now doubled down. This is the second legal proceeding launched by the attorneys of the Waterloo chairman, Lord Michael Ashcroft, in response to the recent rejection of his proposed cruise port development.

This claim is being brought under Article 8 of the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Belize for the Promotion and Protection of Investments – referred to as the UK Bit Treaty 1982. The purpose of this instrument, which was signed into law less than a year after Belize's independence, was to protect the investment of UK nationals. The two companies, BCB and Prize Holdings, both located in the British Overseas Territory of Turks and Caicos, fall within the scope of this protection. A previous letter that had been sent by Ashcroft to the Prime Minister on January 19 of last

year, had first suggested impending Notice of Dispute under the UK Bit Treaty. The most recent letter which notifies the GoB of the initiation of such arbitration proceedings was sent despite GoB's confirmation to Waterloo that the process of setting up a statutory appeals tribunal to review the denial of approval for the Waterloo project was ongoing.

In a letter responding to the Ashcroft correspondence, the PM remarked that the threat of arbitration at the time was "premature." The notice on April 3 states that this response has only "compounded and exacerbated the dispute." Since the requested "amicable settlement" was not reached, a team of UK lawyers have been retained by Ashcroft to argue his case against Belize in front of a three-person arbitration body in the Hague.

They claim that the approximately US\$300 million investment was actively encouraged, and that after the first rejection of Waterloo's proposal on December 15, 2021, representations were made to them by the Department of the Environment (DOE) that, "if a developer applied for environmental approval for a project by submitting an Environmental Impact Assessment (the "EIA") that met the applicable Terms of Reference, then the developer would be duly granted environmental clearance for the project."

This first appeal never took place. Representatives from Waterloo and the



Two men charged for fatal home invasion out west

Two men are facing an extensive list of charges this week after a fatal home invasion on Easter Sunday in Tres Puntas Area, San Ignacio.

Twenty-six-year old Isiah Azueta of Kontiki Extension, San Ignacio; and fifty-nine-year old Ernest Thompson of Santa Cruz Area, Santa Elena; have been arrested by San Ignacio police after they invaded the home of Maxwell Samuel Smith, 72, in the

Tres Puntas Area, and left him dead and two others injured.

According to reports, Smith, a retired Belizean-American, was at home on Sunday morning along with his sister, Dorothy Lois August, when two men broke into his home and held them at gunpoint. A neighbor and friend of Smith, who became aware of what was happening, called the police, who went to the area and immediately surrounded the two-story home, and called out the burglars who were inside.

Police would go on to hear two gunshots inside the home before Azueta stepped outside with his face covered with a T-shirt, and threw his weapon on the veranda before surrendering. He also indicated that he had been shot in the leg. While the police were distracted by Azueta his accomplice attempted to escape through the back door, and this led to a shootout between the thief and the police.

While some police officers held Azueta on the ground, others chased his accomplice, Thompson, who escaped the home fully armed.

In the shootout with the officers Thompson wounded P.C. Ronaldo Oh to his head, stomach, and left hand, before making his escape.

On entering the home police discovered the lifeless and bloody body of Smith, who was lying on his back with a gunshot wound in his armpit area. His sister, August, also suffered injuries in the hold up, one of them a facial wound around her right eye.

A manhunt for Thompson was immediately initiated by police, who have since detained him.

It is alleged that Azueta was shot by Smith, while Thompson was shot by police during the shootout.

Reports are that the thieves attempted to rob Smith of his two firearms. Police recovered both of Smith's weapons, and they also recovered the weapon the two men used to carry out the crime. Police say the investigations are ongoing, and at this time the motive for the attack is still unclear.

Azueta was hospitalized under police supervision while receiving treatment, prior to him and his accomplice being arrested for their crimes.

Reports reveal that both burglars, Azueta from Kontiki Extension, San Ignacio, and Thompson from Santa Cruz Area, Santa Elena, are jointly arrested for one count of murder, one count of aggravated burglary, and one count of dangerous harm. They are each also facing one count of robbery, one count of kept firearm without a gun license, and one count of kept ammunition without a gun license.

Thompson was separately charged with one count of attempted murder and one count of handling stolen goods.

Police say they suspect that there was

a third person involved, a person who they believe is the mastermind of the home invasion, and they are carrying out an investigation with the aim of arresting that third individual.

Smith's oldest son, Elridge McDougal, said that he was alerted by neighbors about the shooting before visiting the police station, where he received the tragic news of his father's death

"From talking to the police, it seems as if though there were some guys that went up there to orchestrate some kind of

robbery, and that's the home invasion that we all heard of what had happened, you know. So, that's what the police told me, that two guys were in the house and they had held my dad and my aunt and other persons, they had held them hostage," said McDougal.

Smith lived in Belize for many years and was a well-known and respected "icon" of his community, according to McDougal.

"He held a high position at the United Nations, working for Belize for many years, and he is a retired person from the UN. He used to live in New York, you know, and now he decided that he wanted to come back to Belize to build a resort and, you know, to come and retire here in Belize," said McDougal.

Local authorities and friends of Smith have expressed shock on learning of his passing, and his family has been receiving many messages of condolence.

NATS Farmer of the Year winners 2023

The annual Belizean National Agriculture and Trade Show (NATS) is back in full swing and quickly approaching, under the theme, "Innovations in Technology: Driving a Climate Resilient and Competitive Agriculture and Food Sector."

As is done every year, top farmers countrywide are once again being recognized as part of the annual Farmer of the Year Competition, during which three judges visited the different farms throughout the country and decided on the top three winners.

And on Tuesday of this week, the NATS committee, along with the Ministry of Agriculture, Food Security, and Enterprise, announced via a press release the winners for the Farmer of the Year 2023.


The winner of the Senior Farmer of the Year award was Adrian Bartley, 38, of the Belize District. Bartley's farm, known as "Kingdom Orchard" and located in Rockstone Pond, was established during the pandemic when he was encouraged to plant to be able to provide for a feeding program in Belize City. His 14 acres are covered with land bear cabbages, sweet peppers, tomatoes, habaneros, and a ton of chickens. Bartley has faced

numerous challenges in the cultivation of his farm, including constructing a well after a long drought; nevertheless, he said that he has been able to overcome each through prayer and dedication.

The Female Farmer of the Year award was given to Esmeralda Stanley, 48, of the Toledo District. Stanley's farm, located in Trio Village and bearing the name "Emmanuel Farm", was started from scratch by her and her two daughters on land that was initially a savannah. Her goal was originally to grow and sell soursop at a lower price than was on the market, but she fell in love with agriculture as a whole, which led her to plant plantain, tomatoes, habanero, cilantro, pakchoi,

okras, bananas, and coconuts to sell. Stanley's creativity in formulating her own organic pesticide demonstrates how dedicated she is to optimizing conditions on her 6-acre farm.

With a farm located in Cristo Rey village, Corozal District, this year's Junior Farmer of the Year winner, Axel Perez, has worked tirelessly with a dream to complete his education. His farm has been a tool to not only support himself, but a way to learn to manage a business. On his 12 acres, he has planted carrots, cabbages, sweet peppers, tomatoes, and onions, sold to customers from the comfort of his home. He has even innovatively built a drip irrigation system powered by butane gas to sustain his produce.

Perez hopes through his efforts, to one day major in agronomy or in business management.

The press release closed by stating the committee's recognition of each farmer for their contribution to Belize's economy.

"The committee congratulates all winners for their hard work and dedication in ensuring the sector remains vibrant and valuable to Belize's resilience to climate change and economic shocks," said the release.

ADO and FDN back in Belize

On Thursday of last week, the Minister of Transport, Hon. Rodwell Ferguson, announced that two Central American bus lines — Fuente del Norte (FDN) from Guatemala, and Autobuses de Oriente (ADO) from Mexico - will be allowed to enter Belize

to transport tourists both into the country and across the border.

Ferguson told reporters that discussions with these bus lines have been taking place since last August when they approached Ferguson with the request to resume their runs within our borders; however, Minister Ferguson said that his requirement has

always been that Belize operators have similar access to runs within the borders of the countries in which those bus lines are based: Mexico and Guatemala.

Ferguson reportedly made numerous trips to Guatemala and Mexico to attend meetings and engage in discussions about how this agreement could work amongst the three parties.

And finally, 8 months later, and with the approval of the Cabinet, FDN and ADO are set to once again carry out certain runs within the country and to transport tourists from within Belize with Fuente del Norte carrying out one run per day, while ADO's schedule in Belize, according to Ferguson, "eventually will be three runs per day from Mexico side."

Ferguson told local reporters that in no way are these new runs a threat to our local bus operators, as those buses will cater specifically to those who want to travel out of the country.

"They will stop at specific locations but not to pick up any Belizeans; unless you are a Belizean and you want to go to Merida, you can catch a bus from a particular location to go across Corozal, not to stop in Corozal, so it will not affect our local operators, "he said.

Belizean operators will also be allowed to transport passengers into Guatemala and Mexico. However,

when they enter Guatemala they can only travel up to Flores, Peten; while in Mexico, they can only travel a maximum distance of 20 kilometers into the country.

"That's what the Mexican government said. We can't go beyond 20 kilometers. They have a big economy; we are a very small economy. They dictate the pace; they're a very big economy; we are trying to figure out how we can increase our tourism numbers in this country," explained Ferguson.

The official announcement was made on Wednesday, April 12, via a press release from the Department of Transport which informed the public that, "ADO will be providing services from Belize City to Merida and Cancun starting on the proposed date of May 1st, 2023. Fuente Del Norte will be providing services from Belize City to Flores and Guatemala City starting on the proposed date of April 21st, 2023."

And, as part of the effort to fulfill the government's promise to safeguard the business of local operators, Minister Ferguson has put in place strict regulations for both foreign companies.

Firstly, they must obtain a road service permit which will be issued for every run per day. The fee for these permits must be paid in full before operations begin; failure to do so would result in immediate cancellation of the permit, or failure to present the permit at a checkpoint would result in operators being fined \$500.

Secondly, these bus lines must have a manifest of only ticketed passengers before crossing the border; no pickups of local commuters are allowed.

Both lines will commence their journey from the Belize City terminal; however, FDN will be granted additional designated stops in Belize City, as well as in San Ignacio, apart from the terminal spaces.





DPM Hyde: Every child should play sports

Belize is thrilled about the performances of our athletes over the Easter weekend, particularly cyclist Oscar Quiroz, who won the Holy Saturday Cross Country Race, and 14-year-old Demetrie Meyers, who won two gold medals at the 50th CARIFTA games in the under-17 category. The week before was pretty bad, our national football team losing twice during the period, but it is a young team we put out there to defend our honor, and the fact is that it has been some time since our footballers have had success regionally.

The Deputy Prime Minister (DPM), Hon. Cordel Hyde, wasn't looking at performance excellence during the recent debate on the budget; he was thinking about the fabric of our nation when he noted that the 2023/24 budget for sports is \$2 million more than what the last UDP government budgeted, but said that is not nearly enough for youth and sports. The DPM said every child should play sports—whether they are good at it or not. He said the benefits from playing sports are incalculable, that sports teach discipline, build character, teach our children how to resolve conflicts and to be magnanimous in victory and humble in defeat, teach our children and youth teamwork and to work really hard to achieve success. He said the benefits from playing sports cannot be duplicated.

No country can afford to squander the opportunity to train its children and youth during their school years. We need to become a lot more serious about sports. All our children and youth must participate in athletic activities. At the child/youth-level athletics—football, softball, basketball, cricket, and volleyball programs—aren't costly to run. For some sports only a ball is needed, and a goal/basket/net.

The right supervision is critical. A ready resource for the country is the ranks of public officers, and retirees. Public officers who display the right character should be given time off, to train, and then they should be assigned to work with the children and youth.

With proper organization, and with a little investment in facilities, funds can be generated to cover the cost of advanced programs. Venues would have to be improved, with fences, bleachers, and bathroom facilities. Transportation issues can be easily addressed. Old buses can be refurbished, "governored" to not exceed 45 mph, and they can be used to transport students and teachers/coaches to the various tournaments.

We want our children and youth to win all the games and races when we lock horns with our neighbors, but far more important for our children and youth is the development of their character. As the DPM said, every child should play, even if they aren't good at it. The lessons they learn, and the health benefits too, will serve them well throughout their lifetimes. And the ultimate glory will be for Belize.

US "anti-communist hysteria" destroyed modern Haiti

Our Foreign Minister, Hon. Eamon Courtenay, says the Immigration Department suspects that many Haitian citizens are using Belize to get into the USA, hence the recent decision that Haitians will have to get a visitors' visa to enter our country. Our island neighbor, Haiti, has been the poorest country in our region for decades, and presently it is in turmoil. Belizeans who questioned the veracity of reports that chunks of the country had fallen under the control of gangs got a front-row lesson when our national football team, in Haiti for a World Cup qualifier in March 2021, was held up by an armed gang.

Haiti's story is similar to many in our region that have tried to follow a true nationalist path. The US shockingly and sadly saw "communists" during the first Jean-Bertrand Aristide government in Haiti (1991), and "allowed" the power-crazed elite from the Duvalier days to oust him. Francois Duvalier, aka Papa Doc, seized power in Haiti in 1957, and his regime served the rabid anti-communists in our region well. When he died, in 1971, his son, Jean Claude "Baby Doc" Duvalier, took over

the reins of Haiti and remained in power until 1986, when he was forced into exile. During the Duvalier regimes the Haitian elite participated in the plunder of the island, while the masses suffered.

In the article "Criticism of Aristide is Misplaced", SocialistWorker.org says Aristide (who was president of Haiti in 1991, 1994 to 1996, and 2001 to 2004) built more schools than all other governments combined, created Haiti's first ministry of women's affairs, doubled the minimum wage, reformed agriculture, resisted pressure "to privatize the state telephone, electricity companies and the Port-au-Prince docks", and went to the World Court "in 2003 to recover the \$21 billion (current dollars) in funds that were extorted from Haiti by France from 1825 to 1947."

The Irish Times said that during the 1991 Aristide government, the president met with the Fidel Castro government and discussed "the feasibility of adopting Cuba's successful literacy campaign", and that during that period hope was so high in the country that "the exodus of Haitian boat people to Miami, Florida, dropped to zero…"

But the first Aristide government (1991) was too "friendly" with Cuba, and forces outside of Haiti helped take his government down. Aristide fled to Venezuela, and then went into exile in the US, and while there he was made to "get the sense." *The Irish Times* said he was ushered back into power in 1994 by 20,000 US marines. The *Times* said "the reformed statesman agreed to implement IMF-inspired economic reforms, including a privatization package and cutbacks in social spending."

Haiti would return to a full free-enterprise path thereafter. Unequal wealth distribution, the horrific drugs trade, and a series of natural disasters have kept the country unstable and deprived. The assassination of Haitian president, *Jovenel Moïse*, in 2021, exacerbated a very bad situation.

Foreigners have contributed massively to the deprivation and instability in Haiti, and some nationalists are calling for them to stay out, to leave the country to resolve its issues without their "help." Unfortunately, civil wars in countries like ours seldom deliver the cures the masses need. The fact is that the greedy class will get foreign support, and foreign powers are just too powerful, as Aristide found out, so maybe the best that can be hoped for is peace coupled with the resolve for justice. The present problem in Haiti has implications for the region. Foreign powers have their agenda. Belize and the rest of the Caribbean must insist on having a say in any foreign peace force.

Our region needs the US to accept some responsibility for the chaos in Haiti. The US has its interests, and it does keep things relatively stable in our part of the world. The masses in countries south of the Rio Grande are starving to death, but a form of democracy reigns in most of our countries, and in that there is hope that things could become better.

Our region needs the US to ease up on its disastrous "anticommunist" hysteria. Embracing Cuban literacy programs, maintaining control of key public assets, and making hospital care affordable for all, don't make anyone in our region Russian or Chinese satellites.

Retired public officers say: Dissolve the Trust and give us our money!!

VS.

The Public Service Workers Trust The (PSWT)

In 1995 the economy of the country was not doing well. The then government took a decision to freeze the increments of civil servants for 2 years. Ironically, whenever the country is in trouble economically, the burden of the problem is placed on the shoulders of the Public Service. There is not an extra 3% tax on the business or private community to share the burden; it is always the civil servants, i.e. government office workers, teachers, nurses, doctors, police, BDF, Coast Guard, etc., all the people who run the country, who bear the burden of the entire state. Thus the increment freeze in 1995 to 1997. However, the government had provided shares in the profitable BTL company to compensate them; and, after some 28 years, the shares have yielded some 9 million dollars. But this was placed in a trust for them to manage the funds for the benefit of the workers affected. This trust has been spending the monies on their idea of projects, and the real beneficiaries have not received anything for 27 years. Hence, they formed the ABRPO, which is now advocating for the trust to be disbanded and for the beneficiaries to receive what is rightfully theirs.

The ABPRO is adamant in its drive to have the PSWT dissolved, and rightly so, because the money gained from the shares belongs to those who had been forced to make the sacrifice of having their increments frozen for the 2 years between 1995 and 1997. The PSWT was supposed to have been managing the money for the benefit of the beneficiaries who after 27 years have received nothing. Instead, and in the meanwhile, the PSWT has been spending the money the way they please, touting that the money is solely for projects to benefit the beneficiaries. These projects are solely

THEIR idea, without consulting anyone, and solely THEIR decision. They have even expressed that when a beneficiary passes on, that individual's share is dead along with him/her. Completely ludicrous! For example, some nine teachers from the former Belize Technical College have passed, and "nada" for their next of kin. Of late, they offered to give \$150.00 to beneficiaries for groceries to be purchased at Publics Supermarket and \$200.00 for medical expenses.

The thing is, many of the authentic beneficiaries are not even on the list to even get those little benefits. Their solution is that such people should seek to get their name on the list. What ridiculously gross inefficiency. BEFORE any such handout, the PSWT, who has been paying themselves, should first have the list of everyone. So, what is it they have been doing over the years, when all they had to do was obtain the government staff list from the Establishment Department through the Public Service Commission, who employ public officers; and if anyone is still missing, then since government is divided into ministries, check with the appropriate ministry to get the names? How can retired individuals be getting their pension and Social Security pension and not be on the list? Instead, the PSWT has been paying themselves some \$240,000.00 annually in salaries etc. to manage the monies they have been borrowing, and lending out hundreds of thousands of dollars as they see fit. When a court case is brought against them, they pay their attorney from the funds, pay themselves to travel around, and pay themselves stipends, even though they are employed elsewhere.

Take the situation of teachers from the past Belize Technical College (BTC); they along with other departments such as the Fisheries Department are not on the list. Over the life of BTC, being the first and only science and engineering institution when they started in 1952, the British principal instituted the first night-class programme to accommodate other high schools and the public that wanted a science training background to pursue careers in medicine, agriculture,

Sanctuary Bay point man charged with embezzlement

BELIZE CITY, Wed. Apr. 12, 2023

Exactly one week ago, the Federal Bureau of Investigation (FBI) charged Andris Pukke with wire fraud and embezzlement in connection with what has been dubbed the largest land scam uncovered by the US Federal Trade Commission (FTC) to date. The Sanctuary Bay scheme is said to have banked US\$124 million through its marketing of housing in a luxury retirement community on a 14,000-acre tract of land in southern Belize. The package being marketed to retirees overseas turned out to be a phantasm, created by Pukke and his colleagues, including an offshore bank in Belize, and a local businessman who engaged in aggressive marketing tactics to fill the scammers' coffers.

Pukke was booked last week for wire fraud and unlawful monetary transactions for the embezzlement of US\$13 million through the Sanctuary Bay development scam. The charges brought against Pukke after the unsealing of the indictment in Manhattan Federal Court could result in a total prison sentence of up to 30 years for Pukke if he is convicted.

According to the US Department of Justice, "Pukke used the embezzled funds for his personal benefit, including the renovation of his home in Newport Beach, California; investments in various entities unrelated to Sanctuary

Belize; investments in unrelated real estate developments; repayment of personal debt; and payments to PUKKE's family members."

Meanwhile, the road, utilities, deep water marina, canals, hospital with American staff, golf course, and local airport that were touted as some of the amenities in Sanctuary Bay were never constructed. Over 1,000 persons who bought properties from the scammers reportedly lost sizable amounts of money. By 2018 the FTC obtained a Federal Court Order to halt the real estate scam after more than US\$100 million was already siphoned, mostly from American buyers. Atlantic International Bank Limited was

accused of illegally assisting and facilitating the Sanctuary Bay Belize scam

According to FTC documents, "AIBL representatives visited SBE's California offices and coached SBE's telemarketers about the services the bank could provide U.S. consumers interested in Sanctuary Belize lots, including lower interest rates and relaxed underwriting for buyers wishing to finance Sanctuary Belize home construction. AIBL urged the telemarketers to sell its banking services to American consumers as part of the



Sanctuary Belize sales pitch."

AIBL in September 2019 settled with the FTC for US\$23 million dollars under a consent order in connection with charges that it assisted the Sanctuary Bay promoters and various related entities in deceiving US consumers as a part of the real estate scheme.

FTC noted in their release, "Notably, AIBL filed multiple unsuccessful motions to dismiss the FTC's case based on alleged lack of personal jurisdiction because, like many offshore

banks that assist and facilitate domestic deceptive practices, AIBL had no offices, employees, or operations within the United States."

One Belizean businessman, John Usher, who was the principal of the Sanctuary Bay development locally, was found liable by the US Courts for his involvement in the scam and was ordered to pay US\$120,200,000 – representing the amount of money lost through the Sanctuary Belize real estate development scheme. This is according to most recent court records signed in 2021, since previous court documents state that he was ordered to pay US \$138,700,000. Usher's assets and bank accounts were frozen shortly after.

In these filings, Andris Pukke; his partner, Peter Baker; and Luke Chadwick were similarly ordered to pay US\$120.2 million to the FTC. The court's final order against the men,

Belize está emocionado por las actuaciones de nuestros atletas durante el fin de semana de Pascua, en particular el ciclista Oscar Quiroz, quien ganó la carrera a campo traviesa del Sábado Santo, y Demetrie Meyers, de 14 años, quien ganó dos medallas de oro en los 50 juegos de CARIFTA en la categoría sub-17. Queremos que nuestros niños y jóvenes ganen todos los juegos y carreras cuando enfrentamos a nuestros vecinos, pero mucho más importante para nuestros niños y jóvenes es el desarrollo de su carácter. Como dijo el VPM, todos los niños deberían jugar, incluso si no son buenos en eso. Las lecciones que aprendan, y también los beneficios para la salud, les servirán durante toda su vida. Y la gloria final será para Belize.

La "histeria anticomunista" de Estados Unidos destruyó el Haití moderno

Nuestro Ministro de Relaciones Exteriores, el Honorable Eamon Courtenay, dice que el Departamento de Inmigración sospecha que muchos ciudadanos haitianos están usando a Belize para ingresar a los EE. UU., de ahí la reciente decisión de que los haitianos deberán obtener una visa de visitante para ingresar a nuestro país. Nuestro vecino insular, Haití, ha sido el país más pobre de nuestra región durante décadas y actualmente está en crisis. Los beliceños que cuestionaron la veracidad de los informes de que partes del país habían caído bajo el control de pandillas recibieron una lección de primera fila cuando nuestro equipo nacional de fútbol, en Haití para un partido de clasificación para la Copa Mundial en marzo de 2021, fue asaltado por una pandilla armada.

La historia de Haití es similar a muchas en nuestra región que han tratado de seguir un verdadero camino nacionalista. Impactante y tristemente, EE. UU. vio a los "comunistas" durante el primer gobierno de Jean-Bertrand Aristide en Haití (1991), y "permitió" que la élite enloquecida por el poder de los días de Duvalier lo derrocara. François Duvalier, también conocido como Papa Doc, tomó el poder en Haití en 1957, y su régimen sirvió bien a los rabiosos anticomunistas de nuestra región. Cuando murió, en 1971, su hijo, Jean Claude

"Baby Doc" Duvalier, tomó las riendas de Haití y permaneció en el poder hasta 1986, cuando se vio obligado a exiliarse. Durante los regímenes de Duvalier, la élite haitiana participó en el saqueo de la isla, mientras las masas sufrían.

En el artículo "Criticism of Aristide is Misplaced" ["La crítica a Aristide está fuera de lugar"], Socialist Worker.org dice que Aristide (quien fue presidente de Haití en 1991, 1994 a 1996 y 2001 a 2004) construyó más escuelas que todos los demás gobiernos combinados, creó el primer ministerio de asuntos de la mujer de Haití, duplicó el salario mínimo, reformó la agricultura, resistió la presión "para privatizar las empresas estatales de telefonía, electricidad y los muelles de Port-au-Prince", y acudió a la Corte Mundial "en 2003 para recuperar los \$21 mil millones (dólares corrientes) en fondos que fueron extorsionados de Haití por Francia desde 1825 hasta 1947".

The Irish Times dijo que durante el gobierno de Aristide de 1991, el presidente se reunió con el gobierno de Fidel Castro y discutieron "la factibilidad de adoptar la exitosa campaña de alfabetización de Cuba", y que durante ese período había tanta esperanza en el país que "el éxodo de personas haitianas en barcos a Miami, Florida, se redujo a cero..."

Pero el primer gobierno de Aristide (1991) fue demasiado "amigable" con Cuba, y fuerzas fuera de Haití ayudaron a derribar su gobierno. Aristide huyó a Venezuela, y luego se exilió en los EE. UU., y mientras estuvo allí se le hizo "entrar en razón". El Irish Times dijo que fue devuelto al poder en 1994 por 20.000 infantes de marina estadounidenses. El Times dijo que "el estadista reformado acordó implementar reformas económicas inspiradas en el FMI. incluido un paquete de privatización y recortes en el gasto social".

Haití volvería a un camino de libre empresa total a partir de entonces. La distribución desigual de la riqueza, el horrendo tráfico de drogas y una serie de desastres naturales han mantenido al país inestable y privado. El asesinato del presidente haitiano, Jovenel Moïse, en 2021, exacerbó una situación muy mala.

Los extranjeros han contribuido enormemente a las privaciones y la inestabilidad en Haití, y algunos nacionalistas les piden que se mantengan al margen, que dejen que el país resuelva sus problemas sin su "ayuda". Desafortunadamente, las guerras civiles en países como el nuestro rara vez brindan las curas que necesitan las masas. El hecho es que la clase codiciosa obtendrá apoyo extranjero, y las potencias extranjeras son demasiado poderosas, como descubrió Aristide, por lo que tal vez lo mejor que se puede esperar es la paz junto con la determinación de conseguir justicia. El problema actual en Haití tiene implicaciones para la región. Las potencias extranjeras tienen su agenda. Belize y el resto del Caribe deben insistir en tener voz en cualquier fuerza de paz extranjera.

Nuestra región necesita que EE.UU. acepte alguna responsabilidad por el caos en Haití. Estados Unidos tiene sus intereses y mantiene las cosas relativamente estables en nuestra parte del mundo. Las masas en los países al sur del Río Bravo se están muriendo de hambre, pero en la mayoría de nuestros países reina una forma de democracia, y en eso hay esperanza de que las cosas puedan mejorar.

Nuestra región necesita que EE.UU. le baje a su desastrosa histeria "anticomunista". Adoptar programas cubanos de alfabetización, mantener el control de los activos públicos clave y hacer que la atención hospitalaria sea asequible para todos, no convierte a nadie en nuestra región en satélites rusos o chinos.

From the Publisher From The Publisher

I think the photograph you see inside this column is one of the greatest photographs ever taken by a Belizean. It was published in 1975 on page 57 of FEELINGS, which was my last serious attempt at creative writing.

The photo was taken by the one Philip Lewis, who used to work at the Lands and Surveys Department and was a member of my uncle's cycling team in the middle/late 1960s. Philip may have finished as high as fourth in a Cross Country.

Sometime in the 1970s Philip organized and led a serious, quality creative group known as SOUL TO ART. Philip also wrote an outstanding poem, which I believe was entitled: "I see a new Belize." But, I would say his greatest talent lay in photography. By the way, we used cameras in those days, not telephones.

There were several Philip Lewis photos which were included in FEELINGS. I feel ashamed to say that I can't find where he was named



The photo by Philip Lewis which appears on page 57 of FEELINGS, published in 1975.

FROM THE PUBLISHER, en Espanol

Creo que la fotografía que ven dentro de esta columna es una de las mejores fotografías jamás tomadas por un beliceño. Fue publicada en 1975 en la página 57 de FEELINGS [SENTIMIENTOS], que fue mi último intento serio de escritura creativa.

La foto fue tomada por Philip Lewis, quien solía trabajar en el Departamento de Tierras y Agrimensura y era miembro del equipo de ciclismo de mi tío a mediados o fines de la década de 1960. Philip pudo haber terminado hasta el cuarto lugar en una carrera de campo a través.

En algún momento de la década de 1970, Philip organizó y dirigió un serio grupo creativo y de calidad conocido como SOULTO ART. Philip también escribió un poema sobresaliente, que creo que se tituló: "Veo un nuevo Belize". Pero diría que su mayor talento estaba en la fotografía. Por cierto, en esos días usábamos cámaras, no teléfonos.

Hubo varias fotos de Philip Lewis que se incluyeron en FEELINGS. Me avergüenza decir que no puedo encontrar dónde lo nombraron fotógrafo y le dieron el crédito adecuado. Por cierto, en el momento en que se publicó el folleto, Sandra Coye y yo estábamos en buenos términos, y ella escribió el prefacio de FEELINGS. Respeto.

La foto es de un anciano, de unos setenta, tal vez incluso ochenta, y está en la popa de su bote, con la cabeza hacia abajo, cavando profundamente en el río con su remo y obviamente concentrado en llevar la carga del bote a su destino. En la parte delantera del bote hay un niño que presumiría que es el nieto del anciano, cuyo parecido con mi difunto y amado primo hermano, Mark Hyde, siempre me pareció asombroso, y el niño tiene su

remo levantado en acción, pero está claro que está totalmente distraído por algo: un pájaro, un pez, un mono, ¿quizás incluso un caimán? La foto, sin palabras, cuenta la historia de diferentes generaciones, en el mismo barco

En ese momento, esta foto me inspiró a escribir un poema para acompañarla, pero no estoy seguro de que el poema esté en la categoría de calidad de la foto, así que no lo reproduciré aquí.

He perdido el contacto con Philip durante décadas. Lo último que supe fue que estaba en Ginebra, Suiza, y es posible que nos hayamos enviado un par de correos electrónicos, pero no estoy seguro. Sé que él no ha respondido a los mensajes enviados a esa dirección de correo durante muchos años, y todo lo que sé es que alguien dijo que podría estar en Trinidad.

Cuando pienso en la partida/exilio de Philip de Belize, pienso en la lamentable partida/exilio de Belize del finado y gran Bob Reneau, quien todavía estaba en su mejor momento creativo cuando voló a Chicago y nunca regresó a casa. Respeto a su hijo, Norman, quien se mantuvo firme con UBAD a principios de la década de 1970 antes de irse a la Ciudad de los Ángeles.

La foto de Philip Lewis tocó una fibra sensible en mí, porque mi abuelo materno, Wilfred "Papa Bill" Belisle, y yo habíamos estado muy unidos hasta que mis padres se mudaron de la Calle Church a la Calle West Canal en 1954. Cuando yo era niño mi mi abuelo me llevó en al menos tres viajes de pesca, solo él y yo, tal como este viejo y el niño de la foto, y recuerdo lo especial que me hacía

as the photographer and given his proper credit. Incidentally, at the time the booklet was published, Sandra Coye and I were on good terms, and she wrote the Preface to FEELINGS. Respect.

The photo is of an old man, in his seventies, maybe even his eighties, and he is in the stern of his dory, head down, digging deep in the river with his paddle and obviously focused on taking the dory's cargo to its destination. In the front part of the dory is a child who I would presume is the old man's grandson, whose resemblance to my late and beloved first cousin, Mark Hyde, always struck me as uncanny, and the child has his paddle raised in action, but it is clear that he is totally distracted by something — a bird, a fish, a monkey, perhaps even an alligator? The photo, without words, tells the story of different generations — in the same boat.

At the time, this photo inspired me to write a poem to accompany it, but I'm not sure the poem is in the quality category of the photo, so I won't reproduce it here.

I've lost contact with Philip for decades. The last I heard he was in Geneva, Switzerland, and we may have e-mailed a couple times, but I'm not sure. I know that he has not been responding to messages sent to that mail address for many years, and all I know is someone said he may be in Trinidad.

When I think of Philip's departure/exile from Belize, I am minded of the lamentable departure/exile from Belize of the late, great Bob Reneau, who was still in his creative prime when he flew to Chicago and never returned home. Respect to his son, Norman, who stood strong with UBAD in the early 1970s before he went to the City of Angels.

Philip Lewis' photo struck a personal chord with me, because my maternal grandfather, Wilfred "Papa Bill" Belisle, and I had been very close until my parents moved from Church Street to West Canal Street in 1954. My grandfather took me as a child on at least three fishing trips, just he and I, just like this old man and the boy in the photo, and I remember how special my grandfather made me feel.

In the 1950s, the weather patterns in Belize were such that if the wind blew from the land in the night and early morning, from the west, then it would fall totally calm between maybe 10:30 a.m. and 1:30 in the afternoon. After that, the southeaster would come in fresh and strong, and the fish would be hungry and looking to feed. On one such afternoon, my grandfather took me trolling, and the catch was stunning. I would have been maybe 6 or 7.

In October of 1957, when I was 10, my grandfather borrowed my father's sailboat, CHRISTINE, and went to Spanish Caye, nine miles south of Belize City, to spend time on his lonesome. Belize was a very safe place in those colonial days, and nobody in the family worried about his personal excursion. Relatives fishing in the area saw CHRISTINE half sunk in front of the caye, and realized something must be very wrong. My grandfather had been dead for days, and his body was badly decomposed. He was only 62.

This is one of the reasons Philip Lewis' photo does things to me. The old man in his photo is my grandfather, and the child is me. If this column serves to assist in any way to link me with Philip, it will have done its job. I understand how native Belizeans can give up on Belize. I've felt that way myself many times. Many times.





Hopkins man stabbed to death on Holy Thursday

HOPKINS, Stann Creek District, Tues. Apr. 11, 2023

A 38-year-old Hopkins resident, Francis Augustine, also known as "Chingu," was brutally attacked in the early hours of Holy Thursday in his bedroom by an assailant who was likely accompanied by another person and who allegedly inflicted numerous wounds on him with a knife-like weapon.

Police learned, after conducting an initial investigation, that at about 3:45 a.m. on Thursday, April 6, Augustine was in his bedroom inside his elevated wooden home when his attackers, who either entered his bedroom or had been socializing with him inside that room, began to stab him multiple times in his neck and chest area.

Augustine jumped out of his bedroom window, situated on the top floor of his residence, and reportedly began desperately knocking at the door of his cousin's house, but she later told reporters that she was terrified, and feared for the safety of her family, so she did not open the door.

Augustine thus died outside her home.

There are reports that shortly before Augustine's death, he was involved in an argument with one of his assailants, with whom he had a disagreement over

a pair of torn sneakers that was sold to him for a hundred dollars.

Police have discovered the murder weapon, which was located inside Augustine's bedroom.

On Tuesday, April 11, Commissioner of Police, Chester Williams provided an update to local reporters on what information the police have so far gathered about Augustine's murder. ComPol Williams noted that the police have apprehended two suspects in connection with the murder and believe one of them is responsible for the crime.

"We have collected a number of evidential materials that we will be [sending] for DNA testing. We're almost sure that one of the two suspects we had detained is responsible for that particular murder, but we'll have to await the results of the DNA testing that we're going to send," he said.

Tyrone Young charged for Gracie Rock murder

BELIZE CITY, Tues. Apr. 11, 2023

Tyrone Young, 35, a taxi driver, has been detained and charged with the crime of murder in connection with the fatal shooting of Denver Montero, 26, who was among a group of persons who were targeted by a group of robbers last Sunday evening, April 2, while they were swimming in the river in Gracie Rock Village.

According to reports, Montero, along with a number of other persons, including a man named Ryan Kerr, had been swimming in the water near the hammock bridge in the village when 12 individuals, including 5 minors, arrived in a van and proceeded to assault some of the individuals in the water and rob them of their belongings.

During the robbery, Montero was shot and chopped, and Kerr was also injured. Kerr later received medical attention and survived the attack, but Montero succumbed to his injuries.

Shortly after the incident, police intercepted the van in which Young and the 11 other persons in his group were traveling between Miles 14 and 15 in Hattieville. The stolen items were



recovered and they were all detained.

Police say they found a number of expended shells at the scene of the robbery and recovered a 9-millimeter pistol that is believed to be the weapon that was used during the incident.

Young appeared in court on April 5, to face the charge of murder, as well as one count of attempted murder, and one count of deadly means of harm.

Police are also expecting to make two more arrests — of Young's son as well as Aaron Smith, for the robbery and murder at Gracie Rock.

It has been reported, however, that the victims of the robbery and attack are not willing to cooperate with police, which has hindered the Police Department's efforts to formally charge those two men.

including Usher, also imposes bans that prohibit them from engaging in activities pertaining to marketing and telemarketing sales, and selling or assisting others in selling most real estate, as well as from any involvement with Sanctuary Belize.

In addition to this, all the assets of Sanctuary Bay were turned over to a receiver, Robb and Evans & Associates LLC. They were ordered to take control of the receivership assets — all the unsold land and areas of development that do not belong to specific persons. A letter from the Government of Belize to the FTC penned by Prime Minister, Hon. John Briceño in December 2020 signals support for a Joint Redress Plan proposed by the FTC and court receiver to adopt.

Sanctuary Bay has been rebranded "New Sanctuary," according to the Joint Plan designed by FTC and the Receiver and seeks to "stabilize the development, restore confidence, and help ensure infrastructure is complete," according to the PM's letter.

As closely as our Belize government and people are allied, being in the backyard of America and with a sizable percentage of our diaspora population residing in different cities of the USA, it comes as strange to most of us with some African ancestry to hear our kinfolks from the African continent expressing anything but good vibes and warm cordiality towards a visiting U.S. government official, the U.S. Vice President at that. But it was eye opening to hear what one high ranking African government official, the Zambian Opposition Leader had to say on the visit of American Vice President, Kamala Harris. Zambian Opposition Leader: US 'Killed Our Leaders,' Now They're 'Coming to Teach Us About Democracy'

As many Zambians react with indifference to Kamala Harris' trip to Africa, one of the country's leaders had a scathing rebuke of American politicians' enduring colonial attitudes toward the continent – which has since gone viral on social media.

An African politician's fierce condemnation of the American government "killers" who ordered many of the continent's governments overthrown and their leaders killed has gone viral as US Vice President Kamala visits the region in an effort to reign in African nations who've chartered an independent foreign policy path and declined to join Western economic sanctions on Russia.

"The killers of Patrice Lumumba, those who toppled Kwame Nkrumah, those who killed Nasser, those who killed Muammar Gaddafi, today are coming to teach us about democracy," explained Fred M'membe, president of the Socialist Party of Zambia, in a speech given March 23 at the International Forum on Democracy in Beijing.

America has no moral authority when it comes to lecturing Africa about democracy. That's the stinging assessment of Zambia's opposition leader, Fred M'membe. He delivered it during the visit of US Vice President Kamala Harris. And pointed to her country's ruthless pursuit of coups and enslavement in the past.

On Friday, videos showing excerpts of the speech were posted on US social media, where they quickly racked up hundreds of thousands of views.

Zambian opposition leader slams Kamala Harris visit:

"A country that has killed so many of our leaders in Africa... the killers of Patrice Lumumba, those who toppled Kwame Nkrumah, those who killed Nasser, those who killed Gaddafi... today are coming to teach us about democracy."

"A country that has toppled so many governments in Africa, that has led so many coups in Africa and other parts of the world, a country that has killed so many of our leaders in Africa and other parts of the world," M'membe continued, in a blistering critique of US double standards.

As the Zambian politician pointed out with incredulity, "a country that has been built on brutal force, on enslavement of other human beings, on the humiliation of Africans, the exploitation of Africans, the plunder of Africa, today is coming to teach us about democracy."

"If you have no respect for the dignity of others, if you have no respect for the sovereignty of other countries, you cannot claim to be a champion of democracy," he explained.

Last week, M'membe also condemned the US government's ongoing "anti-China crusade" in comments given to American state-affiliated media.

"It's not democracy and human rights they are pursuing in Africa. They are pursuing their geopolitical interests. They are pursuing their own economic interests. It is not for us—it is for them."

OW man killed in Holy Thursday RTA

road traffic Α accident that occurred in the afternoon on Holy Thursday, April 6, in the vicinity of Mile 28 on the George Price Highway claimed the life of a sales consultant of Orange Walk Town, 39-

year-old Roel Edel Moguel.

An initial police report on the incident states that around 1:04 p.m. on Thursday, April 6, 32-year-old Ronald Hiron, a Belizean truck driver of Belmopan, was driving a white Freightliner tractor truck on the highway toward Belmopan when, near Mile 28, Hiron reportedly saw a Ford Ranger pickup truck, driven at the time by Moguel, coming in the opposite

direction. According to Hiron, who was accompanied by his coworker Emir Moreno, 27, Moguel's pickup truck swerved suddenly into the lane of Hiron, thus causing him to swerve to the extreme right to avoid a head-on collision.

However, the impact of the encounter on the left front side of Hiron's

truck caused him to lose control of the truck, which ran off the highway.

When police arrived at the scene, they found Moguel seated motionless inside the vehicle behind the steering wheel, and he was pronounced dead at the scene by medical personnel.

A Notice of Intended Prosecution was served to Hiron, pending a police investigation.

The Forgotten Story of the Tragedy of the "E.M.L."

Preface

In the dead of night exactly one hundred years ago, in April 1923, a mailboat named the *E.M.L.* sank off the coast of Sarteneja, British Honduras, taking with it the lives of 18 people. It is a story that has been lost to the passage of time. One might be tempted to think that it was not a noteworthy event. That would be wrong.

A few years ago, during a break while writing a scientific paper for a conference on Natural Language Processing (a field in Artificial Intelligence now making headlines about ChatGPT), I conducted a Google search of my much-



loved maternal grandmother, Alice Marchand.

Born in British Honduras in 1888, she was a key figure in our Jamaican household. Like many middle-class women of her generation, her role was primarily that of housewife and mother. She was not associated with any of the public deeds or misdeeds that would normally warrant an internet presence. I had no expectation of finding anything.

Searches using several permutations of her name received no hits until I entered in the words "Mrs Lucio Marchand" – remembering that letters sent to her when I was a child were always addressed in this way. Success! Up popped the link to an article from the archives of a Jamaican newspaper, *The Gleaner*, dated the 25th of April 1923, apparently a reprint of a recent article from a British Honduran newspaper, *The Clarion*. This article reported a shipwreck that had occurred on the 10th of April in British Honduras. Yipes!

Granny would occasionally mention in passing, usually along with a story of Charles Lindbergh having landed his seaplane in front of her house, that she had been on a ship that sank off the Yucatan a long time ago, that one of her five children had drowned and that she had saved someone else's little girl. But little otherwise. This article announced that very shipwreck. Not only was Granny mentioned by name, but she was referred to in glowing terms, recalling her bravery, especially compared to the male passengers and crew. It was also reported that a well-known Catholic bishop had drowned when the *E.M.L.* sank.

With more time on my hands during the COVID lockdown, I would occasionally run a Google search on the *E.M.L.*, hoping that someone, somewhere would have uploaded some material on the event. I found a lot online about the Bishop, the Reverend Frederick Hopkins, S.J., on various sites belonging to the Catholic Church.

Then up popped my second big discovery, this time on the official Facebook site of the Belize Archives and Records Service. It was a detailed first-person testimony of the sinking of the ship, in the form of an extract from a Coroner's Inquest into the event. The person providing the testimony was none other than Granny herself! Her story was heartbreaking. I emailed copies to several members of my family, with the subject title "Granny was a hero!".

A distant cousin in Belize, Florencia Castillo, whom I had met briefly a few years earlier when my sisters and I took our mother to Belize as a birthday treat, very kindly directed me to a newly-formed Facebook group named "Belize National Historic Society". Through this group, I learned a lot about the history and traditions of the country and members would answer my no-doubt naïve occasional questions ("What is a kraal?", "A patakee?"). I soon realised that even amongst those with a deep interest in the history of that country, very little is known today about the shipwreck of the *E.M.L.* other than that it led to the drowning of a famous Bishop and three nuns. But among the many photographs of riverboats that were published on the site, were two of the *E.M.L.* Remarkably, I was also able to track down a daughter of the seven-year-old girl that Granny had saved, to whom she referred in her testimony as "a Sabido girl". Eliza Jefferson and I had an emotional conversation over Facebook Messenger. Her mother, she said, was Sybil Sabido, and she was one of the survivors of the *E.M.L.*

I corresponded with Mary Alpuche, Archive Officer of the Belize Archives and Records Service, who generously devoted some of her time to finding copies of the weekly newspaper,

The Clarion, for the period following the tragedy. She unearthed about 10 articles about the disaster. One contained extracts of a few other first-person testimonials given at the Coroner's Inquest that followed.

Later, I was able to put many pieces of the puzzle together through visits to the National Archives at Kew in London, which houses in their staggeringly large collection of Colonial Records an almost complete set of the original correspondence and dispatches between the then Secretary of State for the Colonies, Lord Devonshire, and the Governor of British Honduras, Sir Eyre Hutson. It contained about 50 reports on the sinking of the E.M.L. and included the official report from the Coroner's Inquest held in Corozal a few days after the sinking. Among the 27 depositions at the Inquest, there were 14 from surviving passengers and crew on board, each recounting their experience of the pandemonium that ensued during the 10 to 15 minutes that the ship went down. It was heart-racing stuff.

Armed with all this information, and supplemented with many forays with Google, I have been able to collect an almost complete account of the events surrounding the shipwreck, and of the lives of those who drowned. Missing, regrettably, is any verifiable information surrounding the two drowned children of Edwin Llewellyn Fuller of Orange Walk – Gladys (aged 10) and her unnamed sibling – other than that Gladys's body was later identified by a relative on board, Henry Gustavus Longsworth, but the body of her sibling was never recovered.

This account is dedicated to those whose lives were tragically cut short off the coast near Sarteneja on the 10th of April 1923.

Ashcroft doubles down: UK BIT arbitration...

DOE agreed that a new EIA would be submitted and processed on an expedited basis. This was done, and by August 2022 that new Waterloo EIA was received by the DOE. After two rounds of consultation and a request for additional information from the developers, the NEAC ultimately decided that this development-which would involve the dredging and dumping of millions of cubic meters of material near Belize's marine areas—would pose too great of a risk to the environment, including the country's barrier reef, and handed down its decision to not grant environmental clearance to the DOE. The DOE accepted this recommendation and informed Waterloo of the second rejection of their proposal on December 5.

In the notice, the Ashcroft companies claimed that the DOE, which had released an extensive explanation of the specific risks posed by the project and the unanswered questions surrounding its proposed containment methods, was biased in its decision-making. They claimed

that the DOE, "Applied different and more stringent standards to the applications made by PBL than those which had been applied to other, comparable, applications for environmental approval, including especially the applications made by two greenfield developments: Port of Magical Belize and Stake Bank."

And they insisted that they engaged in a, "lengthier and more onerous process for considering the applications made by PBL than those which were applied to other, comparable applications for environmental approval." They then suggested that this gave "rise to the inference that the DOE was acting for ulterior or corrupt purposes in granting environmental approval to projects proposed by PBL's competitors."

In regard to the ongoing Waterloo Appeal Tribunal—on which Paul Hunt, Sr., was appointed to serve as private sector representative after Lucy Fleming chose not to take the position — the companies say the government, "wrongfully interfered with the constitution of the Environment Tribunal as an independent and impartial

arbiter of the appeal." (They did not indicate whether they would have expressed the same level of concern about impartiality if Kevin Herrera, the business senator who would have otherwise sat on the tribunal, and whose brother is a consultant for the Waterloo project, had retained his tribunal seat.)

In the notice, Lucy Fleming, who had been proposed as a possible tribunal member, and Professor Terrence Hughes. who sits on the tribunal as one of its three members, are referred to as individuals with "recorded and evidenced bias."

"The Claimants reserve their right to bring additional claims of violation of the BIT in respect of the Respondent's continued failure to address the appeal," the notice further states.

We note that a proceeding in the domestic High Court was initiated by local Ashcroft lawyers in an attempt to have the court strike down SI 23 of 2023 which legislated the recomposition of the appeals tribunal. They claimed that the tribunal which was selected following this amendment, which included Fleming, was

"tainted with bias and will likely breach the claimant's rights."

BCB and Prize have retained attorneys from Essex Court Chambers and Clifford Chance LLP in the UK to seek five areas of relief: a declaration that Belize has violated the UK BIT Treaty, a monetary award to compensate for the harm caused by the aforesaid breaches, to be quantified in subsequent pleadings; an award of costs in the arbitration, an award of interest on the monetary compensation (including awarded costs) up to the date of payment; and such other relief as the Tribunal determines is appropriate.

This Notice of Arbitration was served on PM Briceño 10 days ago on April 3. Paul Hunt, Sr. was appointed to the Tribunal on April 5. As mentioned, the government of Belize must now signal whether or not it consents to having the Permanent Court of Arbitration in the Hague serve as the arbitral body for this case. Three arbitrators will sit to hear this latest proceeding initiated by Lord Michael Ashcroft against the Government of Belize.

Belize participates in Latin American Anti-**Inflation Summit**

BELIZE CITY, Thurs. Apr. 13, 2023

Economies in the Latin American region are under a lot of pressure, with the never-ending increase in prices and shortages of basic food and necessities. In Belize, our economy has suffered drastically, and has not fully recovered to what it pre-Covid. was Presidents of neighboring countries in Latin America and South America have met with the hopes of mitigating inflation the best way they can, through trade.

On Wednesday, April 5, Mexican President Andres Manuel Lopez Obrador called a meeting via Zoom with key leaders from the region, including Argentina, Bolivia, Brazil, Chile, Colombia, Cuba, Honduras, Venezuela, Saint Vincent and the Grenadines, and Belize. The aim was to discuss a plan for economic cooperation through the importation and exportation of food and other goods.

Leaders highlighted what started the inflation in each country and what should be traded. It was proposed that

taxes and tariffs be reduced throughout, if not removed in order to lower the high prices of food items.

Belizean Ambassador to Mexico, Oscar Arnold described it as an honor and privilege to be invited to this antiinflation summit, explaining to a local media house what it means for Belize.

"For us, it was a privilege and an honor because now Belize sits at the table with these other countries, Argentina, Colombia, Mexico, a couple of the other big countries in South America, and a few in Central America to discuss trade ... a big part of that discussion has to deal with, 'okay, what can countries provide to the region that you are already producing at a reasonable cost' ... It's an opportunity again for Belize to form trading partners with countries that we may have limited or no trading with at this point in time."

Arnold said that although Belize is small it is well respected regionally for how we have exited the pandemic with almost half of our debts reduced, and over the last year having a 12%-14% growth of our economy. Belize is able to bring different elements to the

table, including cattle, soybeans, other types of beans, sugar, and other agricultural products.

Another discussion was the partnership with Venezuela to restart the Petro-Caribe project, which would greatly aid Belize and other countries at the Summit in coping with the rising fuel

Following this virtual meeting, a faceto-face meeting is scheduled to take place on May 6-7 in Cancun, Mexico, which will cover inflation as well as other issues.

Trio charged for Sirenian Bay home invasion

STANN CREEK DISTRICT, Tues. Apr. 11, 2023

After carrying out an extensive investigation into a terrifying invasion of a Sirenian Bay Resort and Villas beach house in which some American tourists from Arizona had been staying, police have arrested three men.

It was reported last month that a group of 4 men arrived at the resort – two armed with firearms and the others with sharp weapons – at approximately 12:50 a.m. on Thursday, March 9. The group then entered the beach house where the tourists were staying and began interrogating them about the owners of the establishment and the whereabouts of money while they held them hostage.

Among the tourist group was an 18year-old who was tied up.

But during the course of the home

invasion, police arrived on the scene and began approaching the resort, where they encountered two of the four robbers guarding the entrance. The men proceeded to fire shots in the officers' direction, resulting in a shootout between both groups.

The four men managed to escape on a skiff, only taking a cell phone.

On Friday, April 7, police arrested and jointly charged three men from the Belize District in connection with the

Belizean Oscar Quiroz wins 2023 Holy Saturday Cross Country Classic

for the start of the hemisphere's longest, oldest one-day race, but none were Guatemalans, only one was Mexican, and eleven were Americans. Last year's winner, Hasani Hennis from Anguilla, who currently rides for the Miami Blazers, also failed to register and defend his championship.

It has been 10 years since a resident Belizean cyclist won the Ride for the Roses—Darnell Barrow winning in 2013—and a parade of Guatemalans (3), Belizean Americans (2), a Mexican (1) and an Anguillan (1) have since claimed the coveted prize. (The race was postponed for 2 years during the Covid-19 pandemic).

Quiroz broke away from the leading trio 4 miles outside of Belize City and at no point after that did he lose the leading position. Jonathan Brown, Oscar Quiroz, Corey Williams, and his brother two-time champion Justin Williams along with Ian Macdonald had seized the lead just after Mile 39 on the way to San Ignacio. A few miles later, Justin for still unexplained reasons pulled up, while Macdonald began experiencing mechanical problems shortly after the men were returning from San Ignacio.

This year's race may have been the most lucrative in its long history, with over \$15,000 cash divided among the first 20 finishers and as much as \$20,000 in cash and other prizes from almost 100 station prizes along the 142.5 miles route.

The top three finishers in the U23, Masters 35+, Masters 4/5, Elite Category 3, and 18-year-olds also divided up \$3,000 in cash prizes.

Quiroz told his now expanded fan base in a Facebook post: "Emotions drew from my eyes and words will never explain what I am feeling. It is quite an unreal experience when your dreams become the reality you seek. This passion will never die and as I embrace this HUGE win I'll continue to remain humble and most important continue to work hard. Not for ONLY me but for my family, my country and all the youths that I give hope to. Some day you can be better than me and do as much as I did but one thing to remember is to work hard and never give up!"

Quiroz, 28, has been one of Belize's best and most successful cyclists over the last decade or so, having won the National Junior Road Championship of Belize twice, the Belmopan Classic (Junior) twice, the Krem New Year's Day Classic (Junior), and the 2012 Belize Junior Cross Country, and he was also a silver medallist at the Junior Caribbean Road Championship ITT.

He has also won the 2017 Belmopan Classic and the 2018 Digicel Belize General Classic, and placed 41st at the 2018 Commonwealth Games.

He repeated as the Digicel Tour of Belize General Classification winner in 2019 and won the 2019 National ITT Champion of Belize before winning a silver medal at the 2019 Caribbean Elite Road Championships Road Race.

He became the only cyclist to win the Krem New Year's Day Cycling Classic as a Junior and as a Senior when he won in 2020, and was also the National ITT Champion of Belize in 2021.

He competed in the 2021 Chicago Intelligensia Cup, finishing 9th in the first stage and 2nd in the Omnium, before placing third and winning a bronze medal in the 2021 Caribbean Elite Road Championship ITT & Road Race.

Oscar Quiroz left Belize on Tuesday for California, where he is competing in the Redlands Tour, a multistage race.

The 53rd Annual Belize National Teachers Union (BNTU) Convention continues today, after a full day of activity at the Muffles College Auditorium in Orange Walk yesterday. A new BNTU president will be chosen over these two days. Three candidates are vying for the position of leader of what has become one of the most formidable unions in Belize under the leadership of Senator Elena Smith. Smith will now be transitioning to other roles and activities after 27 years of unionism, and will hand over leadership to either Ifasina Efunyemi, Ruth Shoman, or Ray Martinez—the three BNTU presidential candidates.

Under the theme, "One Union, One

work on the part of the police in conducting that investigation. We know it was not an easy one, as the incident occurred during the dark of night and police were not able to identify the suspects. But again, through good police investigation, we're able to identify who the suspects are and gathered the evidence needed to have been able to arrest those persons."

In our *Amandala* archives, we found Garnett's name mentioned numerous times throughout the years where he was recognized as a reputable gang figure.

In late 2012, he was charged for the murder of Excelsior High School 4th form student, Raheem Requena, 19, but was never convicted, being acquitted of the crime in 2018. However, he served time behind bars for other crimes – 6 months for possession of controlled drugs and 1 year for wounding.

Lately, he was employed as a member of the LIU (Leadership Intervention Unit), but according to Hon. Kareem Musa, Minister of Home Affairs, Garnett will be removed from the program due to his recent involvement with the crime.

Mission, One Voice," the Annual BNTU Convention runs from 8:00 a.m. to 3:30 p.m. for two days, and has included the presentation of the union's Annual Report, sports competitions, the BNTU election, a mini-expo, food stalls and even a social night at Hi5 club in Orange Walk. The event is akin to a retreat for the teachers – notwithstanding the serious work of presentation of the Annual Report, and the union elections which will also take place during this time.

The first day featured speakers from the union ranks, and a presentation from the outgoing national president, Senator Elena Smith. Her intention to retire from the union's presidency was signaled late last year when she indicated she had come to the "end of that journey."

"It has been a challenge, but I think when you have a passion for what you do and you have supportive family members, it helps. Even at times when they don't support you, when they say enough is enough. My family has said to me, 'you've been in it for twenty-seven years; it is time for you to leave that and attend to your family.' But it's something that I love – just as much as I love my teaching, I love my union work. And so, the balance has been difficult at times, but thank God I have managed to overcome that, and I am now at the end of that journey. So, I think I've done well," Smith commented in a November 2022

She did express at the time that her work in unionism was not over, and this new era simply involves stepping away from the union leadership. This makes way for a leadership role for one of the three candidates, all of whom are career teachers and unionists.

Ifasina Efunyemi told local media that what she brings to the table is a "formidable force."

She said that she brings a wealth of negotiation experience, gaining practice at the international level with the United Nations. She emphasizes the importance of maintaining a balance in the social contract between the government and the people. She is a member of the BNTU Stann Creek Branch.

Ruth Shoman is well-known for her work on the ground with the union. She currently sits as the representative for the BNTU on the People's Constitutional Commission. She has held various ranks within the leadership of the BNTU and sister organizations like the NTUCB as well. She has worked in concert with Senator Smith as BNTU National Secretary to spearhead some major demonstrations countrywide over recent years. Her advocacy for teachers has included unrelenting calls for fair wages and proper equipment inside the classroom. In her leadership positions, she took serious jabs at past governments, calling for greater protection of children and education reform at the 50th Annual BNTU Convention held in 2020.

"We need to ensure that our children are in school. Where are our truancy officers? We need to ensure that age-appropriate sex education classes are incorporated as well as conflict resolution in all our schools. We need to ensure that

ASP Fitzroy Yearwood passes at 47

the weekly police press briefing, has passed away after suffering a massive stroke during the Easter holidays.

ASP Yearwood began his career as a law enforcement officer in mid-1996, and worked his way up the ranks to his final position as the Police Department's Communications Director. He served during the tenure of former Commissioner of Police (ComPol), Allen Whylie, as well as under the headship of the current Police Commissioner, Chester Williams.

On the morning of Easter Sunday, information spread like wildfire on social media that ASP Yearwood had been admitted into the Intensive Care Unit at the Karl Heusner Memorial Hospital after suffering a stroke, which caused severe damage to his brain. After being admitted, reports suggested that he was unresponsive to treatment and remained in that state until he passed away on Tuesday, April 11, at around 3:00 p.m.

A few hours before Yearwood's death, ComPol Williams met with members of the national media to give an update on ASP Yearwood's condition.

"Mr. Yearwood has been the face of the Police Department for the past three years, interacting with the media and doing the weekly press briefs, as well as doing other public relations matters as may be directed by myself or OCED for him to do ... I know that he loves what he does as a press officer. He normally does it with a high degree of pride and passion, and so for him to be out at this time, saddens us and we just want to hope for the best going forward," said ComPol Williams.

After hearing the news of his passing, Minister of Home Affairs, Hon. Kareem Musa shared his sentiments on social media

"You were a valiant, charismatic, and humble officer who always managed to bring a smile to your colleagues' faces. From north to south, you will be forever missed," he said.

The following day, ComPol Williams met with the national media once more and spoke regarding the passing of his dear friend and colleague.

"When I became the Commissioner of Police, I saw the need to have someone who can be a good intermediary between the police and the media, and I could not have thought of anyone better than Fitzroy. He had that charisma and that touch that the media loved about him ... He truly took his job as the PR officer seriously, he did it with a passion," ComPol Williams said.

And filling the void that ASP Yearwood left may be an almost impossible task, as ComPol Williams told the media. He said, however, that ACP Hilberto Romero will be serving as an interim public relations officer for the department until the vacant position is filled.

Before suffering from the stroke, ASP Yearwood was seen with his family at the end of the Holy Saturday Cross Country Cycle Classic and was reported to be in a jovial spirit.

He suffered from chronic diseases, including diabetes and hypertension, which had caused him to be on the brink of death over a decade ago.

ASP Fitzroy Yearwood served over 25 years in the Belize Police Department. He was 47.

laws are amended; we currently have laws that prohibit proper and efficient collection of data in rape cases, which result in the lack of prosecution of these perpetrators. We need to create a system that will ensure that there is equity in the BOOST and Food Pantry program. We have seen where sometimes gang leaders are giving out vouchers to people who they select," Shoman said.

The final candidate is from the Toledo District, where he serves as the president of the Toledo Rural Branch of the BNTU. Ray Anthony Martinez has said that a vote for him is a vote for the teachers. He said that his work will focus on voicing the concerns of the teachers - many of whom are one salary away from poverty where he serves, in the rural communities. He noted that his morning starts at 4:30 a.m. -like many other teachers in that district, and that the hardships faced by rural teachers result in an unequal playing field - despite rural teachers being held to the same standard of performance. His presidency will include advocacy for those teachers facing such hardships.

Along with the three presidential candidates, Jorge Mejia is vying to be elected First Vice President; Edison Ogaldez is also vying for the position. Armin Cardenas and Bay Rivas are in the race for the post of National Secretary.

The Annual BNTU Convention ends today – and the result of these elections are expected to be released shortly after. Senator Elena Smith will not officially hand over the post until June this year when the work of the union will be taken up by a new executive.

Prime Minister Hon. John Briceno in an interview today said that they have always viewed the BNTU as a partner, and maintained that even in difficult times the parties have not lost respect for each other.

"We went through a difficult period when we were trying to see how we can cut salaries, and they argued strongly against it and even demonstrated in some instances, but despite all of that we never lose respect for one another," PM Briceno said.

He commended Senator Smith for her lifelong commitment to the cause of the union.

"Today, they are going to elect a new president, so I wanted to take the opportunity to thank Elena for the outstanding work that she did. She is a firebrand. But when we meet person to person, she is calm and determined and has her position, but we work together, and that is why I have great respect and admiration for her to be able to do that," Briceno commented.

He wished the BNTU well on the election of their new president, and reiterated his government's support to work with the union as partners.

Late this evening we received word that Ruth Shoman was successful in her bid for National President of the BNTU. Candidate Efunyemi managed to garner 226 votes, while Martinez received a total of 76 votes. President-elect Shoman finished the day with 356 votes. For the positions of First Vice President and National Secretary, Jorge Mejia and Bay Rivas, respectively, secured those posts.



2 weeks left in reg. season race to Top-4 PLB playoffs

The competition is fierce going down the stretch in these last two weeks of regular season, as 6 teams are still in the race for a spot in the Top-4 playoffs of the Premier League of Belize (PLB) 2022-2023 Closing Season. (See the standings below.)

Defending champs Altitude FC are struggling to make the playoffs; but they are still in the Concacaf berth discussion by virtue of their Opening Season championship. The cumulative regular season points of the champions from both the Opening and Closing seasons will be compared, and the one with the most points gets the berth in Concacaf play. Verdes FC has represented the Jewel in the past three years, and they have a back-match game in hand besides currently leading the standings, so their playoff berth is almost certain. But they must win the championship if they want a return trip to Concacaf. Altitude is almost guaranteed a win in their next outing against the hapless Bandits/International (which would keep them in the mathematical race), but the same cannot be said for any other team in contention for a playoff spot. Neither Bandits/ International nor Wagiya SC are in the race, as they finish the season against each other for the cellar dweller distinction. (There is yet no relegation program in place for the PLB.)

For a recent two-game stretch, it seemed like the party was over for Belize City fans, as playoff hopeful Port Layola FC went 180 minutes without scoring a goal, and lost back to back matches in front of their home fans at the Marion Jones Sports Complex, a 1-0 loss to Police/Benque United FC on Sunday, April 2, and a 2-0 loss to Verdes FC in a Week #10 back match on Wednesday night, April 5.

But Week #12 this past weekend brought a change of fortune for the city boys who travelled to Mango Creek, Independence, and came away with a surprising 2-0 win. With all opposing defenses targeting rookie sensation Michael Palacio (who still leads the

league in scoring despite having a spectacular goal against Verdes struck off the record because of a protested game), was Port it Layola's senior striker Gilroy "Bredda" Thurton who found his after groove lackluster performances at home, and served the Mango Creek fans a goal in each half, to lead visiting Port

Layola to the 2-nil victory over Altitude FC

That was on Holy Saturday night, April 8, and in another Holy Saturday encounter, it was a late injury-time goal that gave home standing Police/Benque United a 2-1 win over Bandits/International who had taken a first half 1-nil lead and were looking for their first victory of the tournament. Jalen Myers (34') put Bandits/Int'l ahead, but the veteran Danny Jimenez (68') equalized in second half for Police/Benque, and their captain Anderson Cordova (90+5') got the late game winner from a scramble in front of goal after a corner.

Some confusion with referees for the other Holy Saturday night match at Ambergris Stadium resulted in the San Pedro Pirates FC vs Verdes FC match being called off when the Verdes team was already on the island and fans anticipating some exciting action. No decision on the match has been announced yet, as the PLB and FFB, as well as the Pirates management all sent out press releases apologizing to fans for the disappointment.

In the only Sunday game, Wagiya SC apparently collapsed in front of their home fans at the Carl Ramos Stadium, where the young Progresso FC squad from Orange Walk, featuring a couple former Dangriga players, unleashed an 8-0 beating on the once formidable Wagiya. Leading Progresso in the scoring was 'Griga native and former PLB Best Young Player, Jonard Castillo with 4 goals (27', 48', 64' & 87'). Other Progresso goals were by Marlon Gutierrez (2'), Kyle Budna (45' & 70') and Abner Howard 75').

The numbers game is really tight in this race to the Top-4 playoffs, and it may come down to goal difference.

Chess Grandmaster, Nigel Short, visits Belize

BELMOPAN, Thurs. Apr. 13, 2023

57-year-old Chess Grandmaster and former World Championship Finalist, Nigel Short of England, visited Belize and hosted 20 of the top chess players in the country in a simultaneous match at the home of the British High Commissioner on Wednesday, April 12, and won all of the matches.

Short earned the title of Chess Grandmaster at the tender age of 19 and was ranked third in the world by FIDE (International Chess Federation). Before earning the title of Grandmaster, Short was seen as a child chess prodigy and garnered media attention when he defeated Viktor Korchnoi, then ranked second best in the world, in a simultaneous exhibition in London over 31 boards at only 10 years old.

In 1977, three days before his 12th

birthday, he participated in the British Chess Championship, being the youngest in the tournament, and defeated ten-time British champion Jonathan Penrose.

Later that year, he earned the title of Master, then two years later he earned his first International Master and was the youngest (at the time) to earn the title in chess history. In 1984, at age 19, he was awarded the

title of Grandmaster, also becoming the youngest, at the time, in the world to hold the title.

Short spoke to the local media and expressed that Belize has the potential in expanding the sport, however the structure of the federation is lacking.

"I think if they manage to get



organized, there is great hope for chess in this country ... Belize was one of the very few countries that did not go to the Chess Olympiad in Chennai last year. You had 185 countries going there, and Belize didn't send a team, and that just means there's poor organization; so I think there is recognition amongst the

people here that they just need to be a little more disciplined," he said.

Short also added, "These people, and there are some good players here, will not improve if they're playing in a small pond. They have to play regionally where the stands are higher and where they meet players with different styles, and they have to get accustomed to that."

President of the Belize Chess Federation, Steve Flores told

national reporters about his experience playing the game with a Grandmaster.


"For me, it's not that foreign. We've had before in Belize ... Grandmaster Maurice Ashley came to the George Price Center in 2013 ... On my game, I could attest that he just squeezed my throat for the entire game, but it was nice," he said.

The 2023 Belize Elite Basketball League (BEBL) Tournament resumes this weekend with 2 of the co-leaders clashing at the Belize Civic Centre on Friday night, and the 2 cellar dwellers, the San Pedro Tiger Sharks hosting the Punta Gorda Panthers at the San Pedro High School auditorium on

Saturday.

The Tiger Sharks won their first encounter 98-77 and know that they need a win and to keep winning to keep their opportunity of making the tournament's 4-team playoffs alive.

They have 7 games remaining, 6 of which would be home games because 2 of their home games were cancelled and possibly postponed due to the non-availability of the auditorium, and they had swapped with the Orange Walk Running Rebels.

The Panthers are all but mathematically eliminated as they are now the victims of a 6-game losing streak, and would have to improbably win all their remaining 5 games and also see the 3 teams above them in the standings somehow lose all 5 or more of theirs.

The Orange Walk Running Rebels are currently the owners of a remarkable 6-game winning streak after losing their first 3 games. The Benny's Belize Hurricanes were and remain the pre-season favourite though they have stumbled against Griga and their Belize City rivals the Defenders. They also have a cancelled game to play against San Pedro, but reports are that they are at full strength and finally have a complete and healthy roster available.

Although the teams are tied in the win column and the 'Canes have a game to play, under the BEBL's point system (2 for a win, 1 for a loss), the Rebels are the tournament's leader. Both teams are very aware that the result of their head-to-head matchup is the first tiebreaker and that the 'Canes won the first encounter 85-77 on the Rebels' home court.

The Griga Dream Ballers will have more than revenge on their minds when they host the Belmopan Red Taigaz Saturday night at the friendly confines of the Russell Chiste Garcia Auditorium. While their 91-79 loss to the young Belmopan team in Belmopan still stings, the fact is that their remaining schedule dictates that 3 of their remaining 5 games will be on the road where they have only won once.

The young Taigaz are perhaps the "smartest" team in the league with a high percentage of college graduates, but they have been inconsistently consistent, dropping one then winning one before losing another, then winning 2 before losing 2. They know the only formula for success is winning.

Friday night the Western Ballaz will host the Belize City Defenders on their home court at the Sacred Heart Auditorium in San Ignacio, and it may be the most important game of the weekend schedule. A home team victory would leave both teams tied with 5-5 records. The Defenders have yet to win away from the Civic Centre, losing to the BEBL's cellar dwellers and Griga and are trying to continue recovering from a 3-game losing streak. They beat the Western Ballaz 84-69 in the fourth game of the tournament.

These two teams have been most affected by serious injury to two of their star players. If the Ballaz are going to make a stretch run it must start with this game, because a loss and a 4-6 record is a deeper hole to climb out than may be at first surmised because the Taigaz and Tiger Sharks are hot on their heels in the fight for the last playoff spot.

discussions between parties are ongoing based on good faith, and not tension.

- Cabinet was advised that the process to resume the payment of performance-based increments to public officers, effective 1st April 2023, has commenced. There was unanimous agreement that moving forward, increments must be based on actual performance, and every discussion with the Joint Unions must include the implementation of a comprehensive and objective appraisal system.
- Cabinet gave its support for the adaptation of the recommendations by the Ministry of Tourism & Diaspora Relations, in conjunction with the Belize Tourism Board, to amend the agreement between Government and Belize Island Holdings Limited, in relation to the Harvest Caye Cruise Port in Southern Belize, to improve and define future growth and development of the Harvest Caye Port.
- Cabinet gave its recommendation for amendments to the Law Revision Act to better reflect the current state of law with respect to Money Laundering and the Terrorism Prevention Act. These amendments will be

introduced at the next sitting of the House of Representatives.

- Cabinet gave its approval for the ratification of the World Trade Organization Agreement on Fisheries Subsidies, which will establish new global rules for eliminating harmful subsidies and protecting global fish stocks.
- Cabinet endorsed the updated National Climate Change Policy, Strategy and Master Plan, the Low Emission Development Strategy, and the National Climate Finance Strategy as national documents. Additionally, Cabinet gave its approval to provide support for the coordination, mainstreaming, and implementation of appropriate climate change mitigation and adaptation measures to pursue lowcarbon and climate-resilient development pathways.
- Cabinet requested that a subcommittee comprising Sustainable Development, Energy, Natural Resources, Rural Development and Agriculture meet to follow up on the strategies for water resources management, including aquifers (ground) and surface water.
- Finally, Cabinet reminds all motorists to drive safely, and with care and attention.

rights in Belize

In 2002, the PUP Prime Minister of Belize, Said Musa, and his administration gave the Commerce Bight Port to a friend of his, Luke Espat, without consulting and getting the approval of the Garifuna citizens of Dangriga, free of cost. After he took possession of the port, he constructed a fence and a gate, employed a watchman, and deprived the Garifuna citizens of entry into and use of the facility. Since then, the Garifuna people are still being prohibited from using the port or any area in the vicinity.

This is a picture of the fence and gate that were erected by Luke Espat and his company, Belize Ports Limited, in 2002.

The UDP came to power in 2008 and promised the G a r i f u n a citizens of Dangriga that they would take back the port from Luke



Espat and hand it over to the people of Dangriga. In 2013, the UDP government took Luke Espat to court to repossess the port. Luke Espat and his company had taken out a loan from Belize Bank and defaulted on his payments.

Michael Ashcroft, who owns Belize Bank, took Luke Espat to court and won his case. He asked the Belize government for all the ports under Luke Espat's control to be granted to him; but the Barrow administration worked out an agreement with him, whereby all the ports except Commerce Bight Port were to be contracted to him. All this time, the Commerce Bight Port remained dormant.

The PUP won the General Elections in 2020, and a company by the name of Recological Services Limited (RSL) presented a contract to them that was signed by the UDP government with a twenty-five (25)-year lease. This is without consulting the Garifuna people and their organizations, who own this indigenous land located

in the Garifuna Reserve-2 in Dangriga Town where the Commerce Bight Port is located.

The PUP decided not to honor the contract because they said it was not legitimate. The company threatened to sue the PUP administration. The PUP government responded by bringing the issue to the National Assembly to have the contract voided. They were acting as if the land and the port belong to them.

To the Garifuna Nation's and their citizens' surprise, about two weeks ago the PUP Prime Minister of Belize, Hon. John Briceño, announced that his government is planning to reopen the Commerce Bight Port.

He continued by saying that he has assembled a group of his Ministers to work on a plan. The elected area representative of Dangriga, Hon. Dr. Louis Zabaneh, the representative for Stann Creek West, Hon. Rodwell Ferguson, and no Garifuna individual or organizations were contacted or included as a part of this planning team.

Again, the Garifuna Nation and their citizens in Dangriga and Stann Creek District were never consulted by the Prime Minister and his government to seek our Free, Prior and



Informed Consent (FPIC), as is required under international Law, to use our indigenous lands. This is a repeat of what the PUP Prime Minister, Said Musa, did in 2002 when he granted our port to Luke Espat, and the UDP Prime Minister, Dean Barrow did when he granted a contract to RSL in 2018. It is clear that these two political parties have no regard for indigenous peoples' land and human rights as is listed below in the UNDRIP document.

The collective rights of indigenous peoples to lands, territories and resources are firmly embedded in the <u>United Nations Declaration on the Rights of Indigenous Peoples</u> (Articles 3 and 26) as well as in the International Labour Organization's Indigenous and Tribal Peoples Convention No. 169 and its

predecessor Convention No. 107.

Balliceaux, an island off the coast of St. Vincent, where many Garifuna people were unlawfully imprisoned, tortured, killed and



buried

In 1796, after the British captured our nation, they imprisoned about 5,000 of our people: men, women and children, on the desolate island of Balliceaux off the coast of the St. Vincent mainland. On that island they continued their torturing and killing of our people, which resulted in about half of the total amount dying and being buried on the island where their remains are left up to this day. It is said that only about 2,500 of our people survived that genocidal act.

The British king at the time, George III (1760-1801), then gave orders for our people who survived to be removed from Balliceaux to their distant colonized Bay Island, Roatan, Honduras, on eleven ships. Upon our people's arrival on the island, their names were changed from their original names to Spanish names to conceal their identities and also to make it difficult for us to reconnect with our families in our motherland, St. Vincent and the Grenadines. Our ancestors did not like the living conditions on the island of Roatan in Honduras, and appealed to the British to allow them to leave to a better place.

The British granted their request and allowed about 165 of them to sail to British Honduras, now known as Belize,

"What our investigation is showing so far is that he may have been killed over the

on the Mexican side and thrown into the river and the body [floated] over to the Belize side of the river," said Commissioner of Police, Chester Williams to the national media on April 5.

Williams also declared that an investigation will be done with Mexican authorities as he believes the incident occurred on the Mexican side of the Free Zone and that the culprit is from there.

Rosas' body was identified by his mother and transported to the National Forensic Science Services in Ladyville Village, Belize District where it awaits a post-mortem examination.

In an interview with Oscar Arnold, Belizean Ambassador to Mexico on Wednesday, April 12, he did not disclose any additional information as a police investigation is still being conducted.

"The details are still coming out of what may have transpired there, and I believe it would be better served if we wait for the official report from the investigating officers, said Arnold.

The motorcycle which Rosas was traveling on has yet to be discovered.

Police are seeking one person in connection with Rosas's death—Mexican national, Jose Julio Martinez.

Mexican national found dead in Free Zone

Police are investigating the death of a Hispanic Mexican national who was found dead with head injuries on the bank of a shallow lagoon inside the Corozal Free Zone in the Corozal District late Tuesday evening, April 4. The deceased Mexican was identified as Carlos Alberto Yepes Rosas, 33, of Santa Elena, Quintana Roo, Mexico.

Preliminary information from the police has indicated that on Saturday, April 1, Rosas and a friend, whom he was assisting, left his home on a motorcycle to purchase several items from the Corozal Free Zone after midday. However, Rosas never made it back to his home, which resulted in his family being concerned and contacting authorities at the Free Zone to search for their loved one.

Rosas' body, which was discovered after 5:00 p.m. on Tuesday, April 4, in an advanced state of decomposition, was found lying in a facedown position, partially submerged in muddy water with three pallets on top of him, and visible injuries on the center of his forehead and the back of his head. His attire was described to be a black polo shirt, a white tee shirt, red fabric short pants,

and black socks.

Julian Brown, Public Relations officer for the Corozal Free Zone, confirmed with the local media via Zoom that Rosas would frequently travel to the Free Zone area to purchase goods and resell them in Mexico. Brown also told reporters that Rosas' body was found in the 'cargo area', which is a far distance away from the commercial area of the Free Zone and is described as a savannah area with no surveillance cameras in sight.

No information has been released on how Rosas' body was dumped in that area

Opposition; GoB violating CARICOM treaty; Minister says they are uninformed

visa requirement for Haitians wishing to visit Belize and to require Jamaican nationals to provide evidence of fully paid non-refundable hotel reservations prior to boarding flights to Belize."

The cited section of the treaty speaks to general exceptions and states "1. Nothing in this Chapter shall be construed as preventing the adoption or enforcement by any Member State of measures: (a) to protect public morals or to maintain public order and safety." The Opposition, however, describes the added stipulations as a violation of the free movement rights of Jamaicans and Haitians. The UDP further affirms that imposing a visa requirement for Haitians is "discriminatory and violates their right to hassle-free movement ..." which should be enjoyed by all CARICOM nationals in the region.

The Opposition implores the Briceño Administration not to "... lead Belize down a path of whimsical decision making that will undermine the institution of CARICOM, the objective of regional integration and our ultimate aspirations for a single market economy." It calls on the administration to collectively find solutions with other CARICOM Heads of State on the matter.

Prime Minister Hon. John Briceño responded to the UDP release by, in usual fashion, throwing barbs at the Leader of the Opposition, Hon. Moses "Shyne" Barrow. Briceño in an interview today casually stated that Barrow is "suffering from Attention Deficit Disorder (ADHD) that just wants attention because he knows what is happening." Briceño affirmed it was Barrow's father, former Prime Minister Rt. Hon. Dean Barrow, who first instituted a visa requirement for Haitians. Indeed, we have come across news articles of Haitians being taken to court due to having fake visas or going through the process of getting visas to come to Belize. The Briceño administration subsequently lifted the visa requirement in July 2021 via S.I. 81 of 2021.

PM Briceño today explained that the trend they have been observing of late is that Haitians are being smuggled to Belize on their way to the U.S. He added, "the United States government has already been looking at us and calling our attention and saying, 'listen, we are seeing now evidence of human trafficking through your country. So

what is it that you are going to do?' So it is damned if you do, damned if you don't. We had no other option but to implement a visa requirement for Haitians." We confirmed with the Minister of Immigration, Senator Eamon Courtenay today that the visa requirement for Haitians is already in effect but the hotel reservation policy for Jamaicans has not yet been implemented. Courtenay says they are consulting with Belize's Minister of Tourism and also with the Jamaican government on that issue.

As to the Opposition likening the new policies to the restrictions that were challenged in the landmark CCJ case of Shanique Myrie, a Jamaican who was body-searched and ridiculed about her nationality while trying to enter Barbados in 2011, Courtenay responded, "It is clear that the Opposition has not read the Myrie case, or if they have read it they do not understand it. Myrie confirms that Belize is entitled to adopt the measure we have already taken, so does the Revised Treaty of Chaguaramas."

On another immigration matter, the UDP has said the Briceño Administration is out of touch with the financial reality of the average Belizean citizen regarding the new passport fees. In the case of a regular passport for adults, the cost has gone from \$50 to \$200 – an increase of 400%. The UDP states in a release, "After butchering the rollout of the new passport system and causing months-long delay for appointments and document processing, they have now disenfranchised poor Belizeans by pricing the processing fees for passports beyond their reach."

The Opposition then takes aim at the comparison made by Immigration CEO, Dr. Gilroy Middleton, who said that the passport cost in Belize is still less than in other Caribbean countries and Mexico. The UDP's release declares, "None of the mentioned countries have ever quadrupled the cost of passport processing overnight, especially not in the most difficult financial times since the Great Depression. Furthermore, the mentioned countries have income per capita 50 percent, 67 percent, 125 percent, 175 percent and 525 percent higher than Belize, respectively." The Opposition concludes by demanding that the prices for passports be reverted to the previous figures.

In his interview today, the Prime Minister shared that the passport is now

where they landed on November the 19th 1802. They landed on the south side of Belize City, in an area now known as 'Yabra'. The British at the

time had some people from the continent of Africa as slaves, known today as 'Creoles'. The British did not want the Garifuna people to intermingle

with the Creoles, for fear that they were going to encourage them to revolt against the British for their freedom. Also, the British knew that the Garifuna people had a history of taking away slaves from the European slave masters to make them free people.

This was what the British experienced when they had controlled their nation, St. Vincent, and they (the British) did not want them (the Garifuna people) to do the same thing in Belize. The Spanish in Honduras also began to allow more of our Garifuna people to move to the mainland along the coast because they wanted us to fight with them against the British for disputed

territories. Later on, the Nationalistas, who were demanding their independence from Spain, forged an alliance with the Garifuna people.

Roatan, Honduras, part of the Bay Islands where the Garifuna people



were dumped by the British on April 12, 1797.

British and Spanish rivalry over the Americas was constant, and they were both competing to control the entire region. When the British and the Spanish granted us permission to stay in the areas where we lived, there were some restrictions not to move away from the south of Belize, but to stay confined in that region. They did not want the Creole people, who they had as slaves, to know that there were free black people living in Belize. It seems as if the Creoles found out afterwards, and questioned them about our free status.

Two men and minors arraigned for burglary of home in Los Lagos

stealing a large amount of money along with jewelry and firearms.

The incident occurred sometime between the morning of Holy Saturday and the night of Easter Sunday, when robbers entered Teichrob's home by cutting the wires of the chain-link fence and prying open the burglar bars and wooden doors. They then proceeded to steal a safe which contained an assortment of electronic devices, jewelry and liquor, as well as firearms – a semi-automatic rifle, a pump action shotgun and live rounds.

Along with the initial items stolen from the safe, they also stole the DVR which contained footage captured by surveillance cameras. The estimated value of the items is \$38,000.

The culprits were identified as 20-year-old Lyndon Chun and 46-year-old Kirk Dougal, and the two minors are aged 16 and 12 years.

When police arrived at the scene, they saw Chun and two minor boys running away from the scene and discovered a knapsack inside a plastic drum on the verandah. Inside the bag, the officers discovered 532 grams of cannabis.

valid for 10 years instead of 5 and therefore is equivalent to a cost of \$20 per year. Additionally, according to the PM, the new passport is now accepted worldwide. He noted that the European Union will review Belize's passport system upgrade and consider visa waivers for Belizeans.

Dougal was charged with burglary, meanwhile Chun and the two minors were given the initial charge along with possession of a controlled drug with intent to supply.

When they appeared in the Magistrate Court in Belize City, they all pleaded not guilty and were given bail the men in the sum of \$5,000 each plus two sureties of \$2,500, and the minors were handed over to the care of their mothers with a bail of \$2,000 each with the condition that they must live with their parents, mandatorily report to the Community Rehabilitation Department, and not associate with any gang affiliates, as well as comply with a curfew of 8:00 p.m. to 6:00 a.m. Chun and Dougal, in addition to being prohibited from going within a hundred yards of any of the prosecution's witnesses, must report to the police station every Monday, Wednesday and Friday; and they should not associate themselves with any criminals or known gang members.

They are to return to court on June 15. Another home burglary also occurred during the Easter weekend, this one in the Belizean American site of Hattieville Village. Reports suggest that the incident occurred sometime around 2:40 a.m. on Easter Sunday, and that a safe as well as \$30,000 worth of gold and diamond jewelry were stolen.

A reward of 2,000 Belize dollars is being offered for information leading to the recovery of jewelry and conviction of the culprits.

Lev Dermen gets 40 years in US tax fraud case

The US Department of Justice announced the sentencing of Lev Dermen and his four other co-conspirators in what is being called "one of the longest-ever" tax fraud schemes in the US. The U.S. Attorney's Office Tax Division will now seek forfeiture of assets connected to the fraud scheme to recoup losses it caused to the US. In Belize, those fraudulent proceeds were used to pay former UDP Minister of National Security, John Saldivar tranches of funds for political purposes, and \$700,000 to purchase land for the construction of a casino.

Saldivar as the Belizean Cabinet minister who received cash payments of US\$25,000 routinely from Dermen and his associate Jacob Kingston. Saldivar's fall from grace—just three days after assuming the role of leader of the United Democratic Party in February 2020—occurred after the release of those messages and reopened the conversation of campaign finance reform in Belize. Last Friday, the 56-year-old Dermen was convicted of fraud and money laundering at the close of the sevenweek trial in a Salt Lake City courthouse and was sentenced to 40 years in prison.

Additionally, Dermen was ordered to pay \$442,615,520 in restitution to the IRS, in addition to a monetary judgment of more than \$181 million. Jacob Kingston, the CEO and coowner of the company, Washakie Renewable Energy, which was the vehicle through which the fraud was carried out, was sentenced to 18 years and ordered to pay \$511 million in restitution to the IRS likewise. He pled guilty to the charges related to the scheme in 2019 and testified against Dermen.

Kingston's entire family are members of a polygamous sect from Utah. He was born and raised within the Davis County Cooperative Society. His entire family was involved in the business affairs of Washakie. Isaiah Kingston, 42, was sentenced to 12 years in prison and ordered to pay

The US \$1 billion bio-fuel tax scheme was an operation aimed at illegally profiting from a program that was meant to provide incentives to companies in an effort to curb greenhouse gas emissions. The company, Washakie Renewable Energy, promoted itself as an enterprise which converted used cooking fuel, cornstalks, and other biological materials into biofuel at its plant. Evidence shows that very little fuel was actually made by the company. From 2010 to 2018 that company was involved in multiple fraudulent schemes, creating false paperwork to claim it created biofuel from feedstock, when in fact that biofuel was produced by others who had already claimed fuel tax credit from the US government. They claimed IRS biofuel tax exemptions using the forged documents.

They frequently obtained US\$65 million in EPA renewable IDs, purchased millions of gallons of fuel, and created the impression that the fuel was being produced and sold by Washakie. They applied for and were paid over \$300 million for claims in 2013 and \$164 million in 2014. The fraud proceeds were laundered through more than \$3 billion in transactions across multiple bank accounts.

"Money from the fraudulent claims were distributed to Dermen and the Kingstons and used to make lavish purchases in the United States,

finished with a time of 4:13.63. Capturing the bronze was Jamaica's Joel Morgan.

Then he clocked 9:08.56 on Sunday in the 3000m, ahead of silver medal winner Ejay George of Grenada who finished with a time of 9:36.82, and the bronze medal winner Love Joseph of the Turks and Caicos Islands.

"Coming into the race, I thought that I was going to be chased a little bit more. I didn't expect to be able to go and nobody [tried] and follow, but I just kept going at the pace I needed to go, and I was really surprised and honored to win two gold medals," Meyers said.

In an interview with Meyers' father/coach, Greg Meyers, he told *Amandala* about the emotions he felt in reaction to his son's performance.

"To be honest with you, with Demetrie running, nothing surprises me. I was slightly concerned at the beginning because the pace he chose was extremely aggressive. It wasn't out of his range to do, and as he was running, it became more and more evident that he was well in control. Inside I had cold seed. My eyes were swelling up. But externally, I was very subtle. I threw my hands in the air as he crossed the finish line," Greg Meyers said.

He also spoke to us about being a

dad-coach to his son:

"That is one of the most difficult things to do, is to be coach and dad, because when he's not in school, he's with me, and I'm pushing him hard, and he's with me when doing his homework. So that balance is incredibly difficult," he said.

"... I have several assistant coaches, and we all manage different sections of it, so while I am his coach and make all the workouts, I have other assistant coaches that help so that it's not always dad yelling at him or dad always giving him instructions, so we balance it out that way," he added.

Demetrie told us that his short-term goal is to do the best he can in his last year of the U17 category and then transition to the U20 for the CARIFTA games. Then, in the long term, he aims to try to represent Belize at the Olympic level and secure the Jewel's first Olympic Gold medal.

Also in the CARIFTA Games, Mallory Meyers, sister of Demetrie, finished 6th in the 1500 metres girls U17 competition. Andre Armstrong of Belize City finished 14th, 9th, and 12th in the U20 800m, 1500m, and 5000m, respectively. Joas Mejia of Punta Gorda finished 5th in the triple jump and 9th in the long jump. Daniel Meyers, brother of Demetrie, did not finish his race due to injuries.

Turkey, and **Belize**," a release from the US Department of Justice notes.

According to the release, "Dermen also caused Jacob Kingston to send more than \$700,000 on behalf of Dermen to purchase land in Belize for a planned casino."

It goes on to state that the US government is "seeking forfeiture" of those illegally attained proceeds.

This brings into question the proceeds received by Saldivar as alleged campaign financing. While there is no indication of exactly how many "tranches" were paid to Saldivar, we can confirm that payment started as early as June 2014 – six years before the scandal actually broke.

Since then, a chain of events – including a US State Department declaration of Saldivar as a corrupted politician, the removal and subsequent reinstatement of Saldivar from the UDP, and Saldivar's unwelcome win in the UDP Belmopan consistency – has battered a far from battle-weary Saldivar. For his dealings with Dermen, the alleged Armenian mafia boss, Saldivar was removed from the Ministry of National Security and the Dean Barrow-led Cabinet, and stripped of the position as leader of the UDP.

In November 2022, the US Department of State designated the former minister as having "Involvement in Significant Corruption," claiming that Saldivar, "accepted bribes for the improper acquisition of Belizean immigration documents and interfered in the public processes for his personal benefit during his tenure as a government official."

At one point, Lev Dermen submitted an application to the government of Belize to be named as the country's honorary consul to Las Vegas, Nevada. The application was vetted by the Special Branch and no infractions against Dermen were found; but when the Ministry asked the US if there were any objections to the appointment of Dermen as Honorary Consul, the reply was a firm rejection of such an appointment. Reports are that Dermen, prior to this conviction, had bested the US government in fraud and assault cases before.

Saldivar, in a press conference following the designation, doubled down on his position of innocence on the matter and challenged the US to provide the evidence to buttress their claims against him. No such evidence has been provided.

"Let me state, therefore, for the record, as I have stated many times before: I am innocent of any allegation that has been made against me. At no time have I participated in any corruption at the Immigration Department while I was the minister, even before or after, and there can never be any proof brought out against me in that respect," Saldivar affirmed. He went on to challenge the US:

"I challenge the United States government to provide that proof. I have no difficulty in facing a trial (whether) here in Belize or abroad in the US," Saldivar said.

"However, the work, in this case, is not over. Going forward, our office and the Tax Division will continue to work together to seek forfeiture of assets connected to this massive fraud scheme to recoup the losses it caused to the United States," the release from the US Department of Justice states.

With the Department of Justice now focused on recovering the funds siphoned from the US taxpayers' pockets, Saldivar and any other persons in Belize involved in money dealings with Dermen may very well have their day in court.
