





Woman Coast Guard on trial for attempted murder

Tonight, 32-year-old Woman Coast Guard, Keyren Lavaun Tzib, accused of trying to kill her former Coast Guard colleague, 37-year-old Kurt Hyde, a resident of Ontario Village, Cayo District, on April 6, 2015, almost 9 years ago, is preparing to present her defense tomorrow morning for firing an M-4 Carbine rifle, the bullet from which allegedly hit Hyde in the head.

After so many years of waiting, Tzib's trial for attempted murder kicked off last week Wednesday, January 17, before Justice Candace Nanton in the High Court, and is soon coming to an end.

The Crown closed its case around 10:39 this morning.

The Crown's case is that at around 9:30 a.m., the team of Coast Guard officers, including Hyde, the Boat Captain among as many as 15 others on board the vessel, had left the San Pedro Coast Guard office heading to Belize City when, according to 3 of the Crown witnesses, Tzib, from the back of the vessel, behind Hyde, with the M-4 Carbine in her hand, fired a single shot which caught Hyde.

Noel Lanza, a BDF; Delon Castro, a boat captain for Belize Port Authority; and Tyrone Young, a Coast Guard who is now deceased.

From their testimony in court, Lanza said that in a state of readiness he saw Tzib stand up, take aim, and fire a shot.

According to Lanza, he grabbed the gun from Tzib, disarmed it, dislodged the magazine, then cleared the gun and kept Tzib there in custody.

Castro, in his testimony, said when he saw that happen he intervened by pushing down the gun after Tzib had fired the shot.

According to Castro, when he hit the gun, it was in a raising position, and that's when Lanza grabbed hold of the gun.

Young's statement, which was read out in court as evidence, corroborated what Castro and Lanza said. In Young's statement, he outlined the seating of the vessel.

A total of 16 persons were on board, said Young's statement, and it gave the court an idea of where individuals were sitting prior to the shooting.

Young also said in his statement that Tzib pointed the gun towards the front of the boat, then he heard a loud bang.

Tzib's attorney, Darrell Bradley made a no case submission, but the judge, Madam Candace Nanton, rejected the defense's no case submission and adjourned for tomorrow morning at 9:00, for the defense to present their case.

In attorney Bradley's no case submission, he submitted to the court that the crown had not proved the charge of attempted murder against Tzib, and that the gun had been discharged or fired by accident.

With that said, Bradley asked Justice Nanton to stop the trial at this junction because of the tenuous nature of the evidence. He cited the Galbraith test, which says if the evidence of the prosecution taken at its highest could not reasonably persuade a jury so that they are sure that the defendant is guilty of the crime she is charged with, then the judge or court should stop the case.

But Justice Nanton did not agree with attorney Bradley, and so called Tzib to answer to the charge.

Tzib is expected to give a dock

BSI Commission of Inquiry set to begin as sugar shortage ends

BELIZE CITY, Thurs. Jan. 25, 2024

The Belizean Cabinet, influenced by the demands of the Belize Sugar Cane Farmers Association (BSCFA), decided in March 2023 to initiate a Commission of Inquiry into the sugar industry with the aim to scrutinize and improve processes across the sugar production chain.

This decision was never brought to fruition. Consequently, it became an addendum to the commercial agreement between Belize Sugar Industries (BSI) and BSCFA, signed on January 8, 2024, which called for such an investigation. The commission, however, is yet to be established, with work scheduled to commence the week of February 5th.

Minister of Agriculture, Hon. Jose Abelardo Mai disclosed on January 19 that, while no official appointments had been made, the formation of the commission was in progress. The proposed team includes international experts from Mauritius, and at the request of BSI, two additional members are to be nominated.

"We have names for people from Mauritius, but I think ASR, through our Attorney General's office, has said that they want to add two more people to that cocktail of experts," Mai stated.

In an update on January 24, Minister Mai stated that BSI had nominated two individuals for the commission and the terms of reference were being finalized.

"Yesterday we sat down again, my team, and we just finalized the terms of reference. We have not removed anything from the terms of reference. BSI had some addendums that they wanted to do, which we saw it would strengthen the terms of reference, so we have included those, but nothing has been removed So, the terms of reference is now stronger and it's more holistic, and I believe that it will serve all parties involved well," Mai affirmed.

This inquiry comes at the tail end of a significant sugar shortage in Belize, which has been ongoing since the latter half of 2023. The shortage was caused by an





unauthorized cross-border trade into neighboring countries of Mexico and Guatemala after their sugar prices spiked to BZ \$2.50 a pound. The shortage prompted BSI to begin importing sugar from the U.S., which led to a price hike in locally retailed sugar.

William Neal, BSI's Communications & Government Affairs Officer, confirmed a week ago that over half of the 250 metric tonnes imported in December 2023 had already been distributed. As of January 10, a 50pound bag of white sugar was priced at \$59.26, wholesale price, and around \$1.50 to \$1.60 per pound, retail price, significantly higher than the controlled price of \$0.75 per pound.

In response to the crisis, the Santander Sugar Group from the Cayo District had offered to supply brown and white sugar, appealing to the government for a quota to supply the local market, although at a price above the controlled rate. However, under its Designated Processing Zone license, the Group was restricted to exporting its sugar production.

Meanwhile, on January 18, BSI confirmed that the 2023/2024 sugar crop season was underway. Following this, the Cabinet announced "that as of 25th January 2024, local plantation white sugar will start to be sold," indicating an end to the local sugar shortage and a return to the regular controlled price nationwide.



Burglar to serve 10 years in prison

ORANGE WALK, Thurs. Jan. 25, 2024 A man who attempted to burglarize a home on Tuesday, January 23, in the Orange Walk District was yesterday sentenced to ten years in prison.

According to police, around 5:00 a.m. on the day of the incident, Jared Kendrick Heisey, 21, of Carmelita Village, Orange Walk District, was awakened by the sound of his dogs barking, and when he looked outside, he saw Mark Conorquie, also known as "Kitos" – whom the victim has known for over a year – inside his fenced yard, standing about fifteen yards away from him.

Heisey reportedly yelled at Conorquie to go away, and Conorquie then jumped over the fence and fled. About 40 minutes later, however, Heisey exited his home through the front door and saw Conorquie once more inside his yard, but approximately six feet away with an object that resembled a firearm in his hand, which he pointed at Heisey before shouting, "I have a gun." Heisey then ran inside in fear for his life.

However, Conorquie followed him

and began to push open the door, then entered the home, whereupon a struggle developed between him and Heisey. Conorquie was disarmed, but he quickly grabbed a knife, which Heisey was also able to wrest away. During the struggle, however, Conorquie had bitten Heisey on both thumbs.

The struggle ended when several persons who heard the commotion came to assist Heisey and subdued Conorquie

until police arrived at the scene. They later discovered that the firearm that he had brandished was simply a plastic toy gun.

Conorquie was arrested and charged with the crime of aggravated burglary and one count of wounding. Yesterday, he was arraigned in the Orange Walk Magistrate Court and pleaded guilty to the charges, after which he was sentenced to 10 years in prison.

New evidence delays rape case against attorney—DPP Vidal

It has been two weeks since allegations surfaced of the rape of two women by a prominent attorney affiliated with the United Democratic Party (UDP), yet charges have so far not been brought against the accused individual.

The case was forwarded to the Director of Public Prosecution (DPP), Cheryl-Lyn Vidal, but the apparent delay in the issuance of a directive from her office for charges to be brought against the attorney has sparked speculations about the reason for the seeming hesitation-with some members of the public suggesting that the attorney's connections to the judiciary or even his status as a lawyer were influencing the process.

On Tuesday of this week, however, the Commissioner of Police, Chester Williams, commented on the ongoing investigation. "The file is still with the Director of Public Prosecution. She had requested the police to do some further work. That work is being done, and once those are completed, they will be sent back to her; and hopefully, we get a final determination from the DPP in respect to that matter," he stated.

"I know that the police had reported that they had sent the statement to the DPP. I think at the time what they did not say was that when those statements were sent, it was made very clear that other evidence was forthcoming. We have been receiving additional evidence. Just today, I received additional evidence. So, I cannot make a decision until I have everything before me. It is not the ordinary case, where it would have been possible just on the statements that were provided on the onset to make a determination," DPP Vidal subsequently explained in an interview.

The attorney was accused by two women of raping them while they were unconscious on January 11, and a formal police complaint was filed two days after the alleged incident.

The attorney had voluntarily gone to the police station to be interviewed after the accusations were made, and shortly after that, the UDP issued a statement in which it acknowledged the accused individual's position in the party and condemned any form of violence against women, while pleading for a fair investigation.

One of the alleged victims, a Belize Coast Guard member, recounted that the incident took place at the attorney's home

in Belize City. She claimed that, after meeting him at the Thirsty Thursday nightclub and accepting a ride home, she lost consciousness after having a drink at the home and subsequently found herself naked in bed with the attorney. The second woman similarly alleged being raped while unconscious.

Meanwhile, a video which was posted on the Hot Off The Press (HOTP) news blog and which exposed the women's faces (purportedly the two who said they were raped) while they were in the nightclub that night, along with an article on the web page that spoke in a disparaging way about the women, have added to the controversy - particularly due to the fact that the news blog is linked to attorney Orson Elrington and known for its pro-UDP stance.

Although the appearance of these media pieces might not directly impact the case, it has forged a negative perception of the accused. The video appears to be an attempt to salvage the accused attorney's name while victimshaming the women.

Hon. Moses "Shyne" Barrow, the Leader of the Opposition, expressed his views on the matter, particularly the content published by HOTP.

"I don't believe in re-victimizing anyone. We have to have a balance as to the freedom of the press, the freedom of this media entity, and whether it is a certified media entity. If you feel it is victim-shaming, I could see how you arrived at that position. I would not have wanted that to be a story they did. I don't think it is helpful to the accused. I think, there are many people that share your opinion that it is victim shaming. So, I believe it is regrettable," he told reporters.

900+ illegal guns destroyed

On Monday, January 22, the Police Department began to destroy a large number of illegal firearms that it had been storing after confiscating those weapons from civilians or removing them from public spaces where they were stashed. It is an undertaking that is being carried out with the collaboration of CARICOM IMPACS and Mines Advisory Group (MAG) with funding from the British High Commission.

"The reason for that is because we are trying to avoid these weapons being diverted or moved from secure state stores towards criminal networks and gangs. In other words, we are contributing towards reducing armed violence by ensuring that these weapons, that are no longer serviceable and that are obsolete, are destroyed," said Nikita Mohammed, Regional Program Manager for MAG.

Callixtus Joseph, Strategy Coordinator for CARICOM IMPACS, explained to reporters that the program is being carried out throughout the Caribbean, and while some might believe that all that is required is to disassemble the weapon and store it in another location, that is not the case. Joseph noted that each weapon has a unique serial number, which can be used to identify that weapon and could cause major issues in the justice system.

"As you saw today, the destruction of some 923 very deadly weapons that we certainly would not want to get out into the hands of the wrong people, and so this is a [crucial] exercise," said


Minister of Home Affairs, Hon. Kareem Musa. He further mentioned, "There are thousands that enter our country illegally, whether it is through our ports, whether it's through our very porous and illegal border crossings; it's [effortless] to come across the border. Most of the time the origin is the United States, and they make their way down through Mexico, through Guatemala, and like I said, across our illegal crossings into the country; so, there are thousands, and each year hundreds of them are recovered off the streets by our Police Department."

Bart Jones, Deputy Commissioner of Police, who was present at the weapons destruction, spoke to local reporters and noted that a number of years have passed since the last gun destruction exercise was carried out by the department.

"It has been, I think, a couple of years that [it was] last done, but nothing to this size. Many of the firearms now are some that by international conventions are deemed unsafe for civilian use; so, certainly, we cannot have police officers with these rifles on the streets, so we just decided to destroy them. No use in having firearms there. We're not using them; and then in a lot of cases, it lessens the instances or potential for firearms ending up in the hands of criminals, or having unintended explosions," he said.

All weapons are scheduled to be disposed of by Wednesday of this week. The exercise is being carried out by 23 members of the Belize Police Department, the Belize Defence Force, and the Coast Guard, along with the Customs Department.

Stevedore found guilty of murder

BELIZE CITY, Thurs. Jan. 25, 2024 Rodman Welch, 37, a stevedore who was charged with the murder of Shakeem Philip Dennison, was found guilty of the charge in a judgement that was handed down today by Justice Nigel Pilgrim.

The case was adjourned until March 26 for Welch, a father of four, to submit a plea for mitigation.

Dennison was shot and killed at about 5:00 p.m. on October 12, 2020, while he was on Yabra Basketball Court, located next to Yabra Football Field. His assailant rode up behind him on a motorcycle and shot him twice in the back of his head. The Crown, represented by Crown Counsel Riis Cattouse, used 15 witnesses, 10 of them agreed witnesses, to prove the case for the Crown. One of the agreed witnesses, Rupert Lopez, said in his statement, which was read in court, that the person who was at the Chinese shop near to the basketball court was Welch. But he couldn't tell if the shooter on the motorcycle was Welch because the shooter wore a mask.

Welch gave a caution statement to the police in which he said that he was shot twice, first in 2012 and second in 2019, and he did the same thing to the person who shot him, and that it was a case of self defence. He said that he was shot in his hand in 2012, and in 2019 he was

shot in his face while he was working as a security guard at Excelsior High School. A voire dire was held to determine the admissibility of the statement, and during it Welch testified that the police threatened him to give the statement. He said that the police told him that his children would go missing if he did not give the statement. However, at end of the voire dire, Justice Pilgrim ruled that the statement was admissible because he believed that Welch gave the statement voluntarily.

After the Crown closed its case, Welch's attorneys Orson "OJ" Elrington and his father, Senior Counsel Hubert



Guatemala's Attorney General refuses to resign

Tensions are escalating within the Guatemalan government headed by newly inaugurated President Bernardo Arévalo, due to the refusal of the Guatemalan attorney general, Consuelo Porras, who has opposed Arevalo's presidency, to resign.

Barely a week after Arévalo's inauguration on January 15, amid multiple challenges to his presidency, the conflict has intensified.

Porras, alongside Senior Prosecutor Rafael Curruchiche and Judge Fredy Orellana, had previously attempted to undermine Arévalo by discrediting his party, Movimiento Semilla (the Seed Movement).

Porras' office aggressively pursued investigations against Arévalo, his vice president, and their party, including officials involved in the elections—going as far as issuing numerous arrest warrants, raiding party offices, and seizing electoral records and ballots.

The anti-corruption stance of Arévalo, a former lawmaker, diplomat, and sociologist who emerged victorious in the August 2023 elections, put him at odds with prosecutors accused of corruption and aligned with the nation's elite.

Efforts to revoke Arévalo's immunity, despite strong international support, were unsuccessful. It is believed that Porras' last effort to disrupt the inauguration ceremony involved a ninehour delay due to congressional disputes.

It was therefore no surprise that Arévalo, three days after his inauguration, sent Porras a letter requesting a meeting to seek her resignation.

Porras, however, publicly refused both the meeting and resignation in a video message published by her office, and has insisted on completing her four-year constitutional mandate.

"I am not going to resign," she said in the video. "You (President Arévalo) as the maximum authority of the nation must

respect what the (Constitution) and the country's laws establish."

She threatened legal action to block any attempts to oust her, citing the autonomy of her office.

Appointed in 2018 by then-President Jimmy Morales and reappointed in 2022 by Alejandro Giammattei, Porras has faced U.S. sanctions for impeding corruption inquiries and engaging in actions that have been deemed a threat to democracy.

In response to her defiance, Arévalo summoned her to a mandatory Cabinet meeting on January 22. He stated at a press conference that her absence would constitute a "breach of duty."

Arévalo intends to query Porras on several matters, including COVID-19 vaccine purchases and alleged bribery in the previous administration.

BAPDA calls for termination of cops who mocked mentally ill man

The Belize Assembly of Persons with Diverse Abilities (BAPDA) is outraged by a video which shows several police officers poking fun at a mentally challenged man inside a police station, and is calling for the termination of those police officers.

In the amateur video, which has been circulated widely via social media, the victim, a mentally challenged man, can be seen inside a police station, wearing several layers of clothing and being instructed by the spectating police officers to remove that clothing—which he does, layer by layer. In the video, those officers are heard laughing and hurling homosexual slurs at the man.

"I wonder what goes through the minds of some police officers, honestly. I reach a point at times where I just try to answer for the stupidity that they do, and it is rather frustrating," said Commissioner of Police, Chester Williams. "As police officers, we must ensure that we uphold the rights and dignity of every person, regardless of who they are; and when we have police officers take advantage of a person with diverse disabilities, it does not look good," he continued.

BAPDA president, K. Raymark Theus also described to *Amandala* his reaction on seeing the video.

"I got pissed! That is something that should have never come out of the police station. They are to protect and serve. They don't go out there and gather stuff on their phones and put it out there for public consumption; which means now, there is no confidentially in anything, because that should've been confidentially at the station," he said.

Theus noted that he did not know why that individual had been at the police

station and whether he committed a crime, but that the officers' actions can in no case be justified. He also commented that the level of confidence in the police has been reduced, as it has become a practice for officers to share videos of civilians within a group. Those videos are often leaked into the public domain.

"By putting it out there in the group, you're inviting trouble [because] you don't know who shared it and with whom. Certain things must be kept confidential at all times, and this is a matter that should have been kept confidential," he said.

BAPDA is calling for those officers involved to be terminated.


"They need to be dealt with, not with a reprimand, because reprimands don't

Barber freed second time of murder charge

BELIZE CITY, Tues. Jan. 23, 2024 For the second time in less than 3 years, Anthony Reyes, 25, has been freed of a charge of murder of the same victim-Emerson Anderson. After being out on bail of \$25,000, Reyes appeared today before Justice Candace Nanton in court, where Senior Crown Counsel Sheneiza Smith, who represented the Crown, entered a nolle prosequi, indicating that the Crown would not proceed to trial. As a result, Justice Nanton told Reyes that he was free to go, and he walked out of the courtroom. Anderson, 44, was shot and killed on March 28, 2018. He was with a group of friends on Ebony Street when a lone gunman appeared and opened fire. Only Anderson was hit. On April 2, 2018, Reyes, a barber of Ebony Street, was arraigned on a charge of murder in connection with the shooting. Then on January 30, 2020, a nolle prosequi was entered, freeing Reyes of the murder charge. In 2021, however, he was rearrested and charged with murder.

BAHA ramps up fight

against Zoonotic diseases

The Belize Agricultural Health Authority (BAHA) has announced an escalation in its monitoring efforts for animal diseases that

could affect humans and the economy.

This increased vigilance comes amidst growing concerns about zoonotic diseases – illnesses transmitted from animals or insects to humans – within the Central American and Caribbean regions.

Zoonotic diseases, also known as zoonoses, vary in severity, ranging from minor illnesses to potentially fatal conditions. These diseases can be caused by various pathogens including viruses, bacteria, fungi, and parasites.

Some of the most severe zoonotic diseases, such as dengue fever, Lyme

disease, and malaria, are transmitted by mosquitos and ticks. Transmission of zoonotic diseases can occur through airborne pathogens, and also through consumption of contaminated meat or produce, direct contact with infected animals, or contact with contaminated surfaces. Some other feared zoonotic diseases include bird flu, rabies, Ebola, and Hepatitis E.

While zoonotic diseases are a global concern, developed countries, including the United States, have implemented

Government's million \$ question – pump money in, or step away

During the recent standoff between the largest cane farmer association, BSCFA, and BSI, which is majority-owned by the giant American company, American Sugar Refining, Inc. (ASR), BSI's Director of Finance, Shawn Chavarria reminded the government that sugar is the only big agroindustry in the country that is in full sail at this time. Belizeans know the importance of the sugar industry, and every ear was tuned in to the meetings until there was a truce and the milling season got underway in full.

The agreement is only for two years. If the parties can't find consensus on some critical differences during that time, they might lock horns again. While all were happy to see everyone at work, moving in the same direction in the industry, some questioned how the difference was resolved, particularly the usage of public funds to get farmers to sign the agreement. But, if any sin was there, it is venial. Governments all over the world use public funds and special legislation to support private businesses when they are in distress because, while the profits from private businesses go into the pockets of the shareholders, when they fail countries suffer economic collapse.

Last week, Agriculture Minister, Hon. Jose Mai shared with the nation the state of the other two backbone agro-industries, bananas and citrus. The report on the former wasn't the best, and the latter, citrus, things are going so poorly in that industry that the Minister suggested that abandoned orchards might best be planted out with oil palms, a tree that has never been grown commercially in Belize. Farmed shrimp isn't even being mentioned these days, the heyday of that industry, which was brief, ending over a decade and a half ago.

All governments wrestle to find solutions when industries are struggling.



When the problem is extremely difficult to surmount, governments have to decide if they should pump in more money, or step away. No private entity takes off without major support from government, and when private businesses encounter difficult times, government has to decide on the extent of the support it will give.

In the last century, our first banana industry, our first coconut industry, a farmed shrimp industry, a cacao industry that was heavily dependent on pesticides and chemical fertilizers, were major industries that experienced collapse; and minor industries such as cohune oil extraction, pine resin extraction, trawling for marine shrimp, and papaya production had to close shop. Our present banana industry started in South Stann Creek in the 1970s with the introduction of Grand Nain (a variety of banana from the subgroup called *Cavendish*) which was tolerant to the Panama Disease that forced farmers to give up their Gros Michel plantations in the 1930s. Minister Mai pointed to climate change factors and the high price of imported chemical fertilizer as causes for the severely reduced

production. *Grand Nain* is a very productive but fragile banana. Unfavorable weather and reduced fertilization of the fields (because of the price) led to an increase in leaf spot disease (Sigatoka), which led to the decrease in the production of marketable fruits. Fortunately, the price of imported chemical fertilizers is decreasing, but it will still take some effort, major financing over some months, to get the banana fields producing at old levels.

Banana growers could do with some luck. A deadly new strain of Panama Disease, Tropical Race 4 (Panama Disease TR4), was detected in Columbia in 2019, and this fungus could wipe out plantations in Belize if it reaches our soils. In 2023, QUT—Queensland University of Technology in Australia—announced that it had produced a genetically modified (GM) Cavendish banana that "had proven to be highly resistant to Panama Disease TR4". But not everyone will be excited about eating a GM banana.

We don't only depend on bananas for critical foreign exchange. Bananas are particularly nutritious, affordable on the local market, and the industry played a critical role in helping us through the Covid-19 pandemic.

Worldwide, the citrus industry has been in decline going on two decades because of the disease called Citrus Greening. Data from the Statistical Institute of Belize show that in 2013 Belize earned \$114 million from citrus exports, and in 2022 that had fallen to \$39 million. The number of bearing citrus trees in Florida is 50% of what it was in 2004, largely because farmers have cut down trees because of the disease. Some large farmers in Belize and a group from Jamaica have expressed interest in planting bamboo in the Stann Creek District, some of it on lands that once produced the best oranges and grapefruits in the world. And now Minister Mai is talking about oil palm.

Across the globe, some citrus farmers are holding on, and what is emerging is that hardy citrus is becoming a crop only for the biggest farmers, those ones who can afford the chemical inputs and practices that are now necessary to get sustainable production. Successive governments have pumped money into citrus, and maybe we need to pump in more. Bailout funds could help both small and big farmers stay in the industry. Citrus has been vital to our economy for over six decades. We are dependent on the foreign exchange the industry brings in, and citrus fruits are essential for our health.

Industries rise and fall, come and go, and the task is for the government to know when to hold on, and when to let go. History suggests that our governments have been too eager to give up on such industries. According to a 2008 7*News* report, Williamson Industries, the clothes-making factory which shuttered that year, had 700 employees at its peak. According to the *Amandala*, the company's demise in Belize came about not because our workers weren't producing quality clothing, but because the company had found workers in other countries who were willing to work for less pay. Textbook economists might argue that the story there is simple market reality. But could our government have found creative ways to keep the workers happy and so keep those jobs here?

In the early part of this century the farmed shrimp industry, led by

Nova Shrimp Farm in Ladyville, had risen to the status of number one as a foreign exchange earner. The dream of one of the industry's earliest investors, Keith Jackson, an American, that shrimp become as common as chicken on tables on Sunday, seemed to be on the verge of being realized. But in the midst of Nova's expansion, a virus was introduced to the ponds and, simultaneous with plummeting production, the industry was faced with depressed prices.

The government of the day didn't support Nova in its distress, even though the company hired up to a thousand workers at peak time and had shown such great promise. Some experts in the industry insist the farm, with its semi-intensive production system, could have survived.

And where are the children of the workers who lost their jobs when the government decided to let Williamson Industries and Nova Shrimp collapse? It is our great fortune that another boom industry, the call centers — Business Process Outsourcing (BPO)—was about to explode in Belize. But there are not enough call center jobs to absorb the blows if the government left the citrus and banana industries to fail.

La pregunta del millón del gobierno: inyectar dinero o alejarse

Durante el reciente enfrentamiento entre la mayor asociación de productores de caña, BSCFA, y BSI, cuya propiedad mayoritaria es la gigante estadounidense American Sugar Refining, Inc. (ASR), el Director de Finanzas de BSI, Shawn Chavarría, recordó al gobierno que el azúcar es la única gran agroindustria del país que se encuentra en pleno apogeo en estos momentos. Los beliceños conocen la importancia de la industria azucarera y todos los oídos estuvieron atentos a las reuniones hasta que hubo una tregua y la temporada de molienda comenzó en pleno.

El acuerdo es sólo por dos años. Si las partes no pueden encontrar consenso sobre algunas diferencias críticas durante ese tiempo, podrían volver a enfrentarse. Si bien todos estaban felices de ver a todos trabajando, avanzando en la misma dirección en la industria, algunos cuestionaron cómo se resolvió la diferencia, particularmente el uso de fondos públicos para lograr que los agricultores firmaran el acuerdo. Pero si hubo algún pecado, es venial. Los gobiernos de todo el mundo utilizan fondos públicos y legislación especial para apoyar a las empresas privadas cuando están en dificultades porque, mientras las ganancias de las empresas privadas van a los bolsillos de los accionistas, cuando fracasan los países sufren un colapso económico.

La semana pasada, el Ministro de Agricultura, el Hon. José Mai compartió con la nación el estado de las otras dos agroindustrias principales, el banano y los cítricos. El informe sobre el primero no fue el mejor, y sobre el segundo, los cítricos, las cosas van tan mal en esa industria que el Ministro sugirió que sería mejor plantar palmas aceiteras en los huertos abandonados, un árbol que nunca se ha cultivado comercialmente en Belize. El camarón cultivado ni siquiera se menciona en estos días, el apogeo de esa industria, que fue breve, habiendo terminado hace más de una década y media.

Todos los gobiernos luchan por encontrar soluciones cuando las industrias tienen dificultades. Cuando el problema es extremadamente dificil de superar, los gobiernos tienen que decidir si deben inyectar más dinero o retirarse. Ninguna entidad privada despega sin un importante apoyo del gobierno, y cuando las empresas privadas enfrentan tiempos difíciles, el gobierno tiene que decidir el alcance del apoyo que brindará.

Circos más grande que este vienen y se quiebran en Belize. En el siglo pasado, nuestra primera industria bananera, nuestra primera industria del coco, una industria de cultivo de camarones, una industria del cacao que dependía en gran medida de pesticidas y fertilizantes químicos, fueron industrias importantes que experimentaron un colapso; e industrias menores como la extracción de aceite de corozo, la extracción de resina de pino, la pesca de camarón marino y la producción de papaya tuvieron que cerrar.

Nuestra industria bananera actual comenzó en el sur de Stann Creek en la década de 1970 con la introducción del Grand Nain (una variedad de banano del subgrupo llamado Cavendish) que era tolerante al Mal de Panamá que obligó a los agricultores a abandonar sus plantaciones de Gros Michel en la década de 1930. El Ministro Mai señaló los factores del cambio climático y el alto precio de los fertilizantes químicos importados como causas de la grave reducción de la producción. Grand Nain es un plátano muy productivo pero frágil. El clima desfavorable y la reducción de la fertilización de los campos (debido al precio) provocaron un aumento de la enfermedad de la mancha foliar (Sigatoka), lo que provocó una disminución en la producción de frutas comercializables. A fortunadamente, el precio de los fertilizantes químicos importados está bajando, pero aún será necesario un esfuerzo, una importante financiación durante algunos meses, para que los campos de bananos produzcan a los niveles anteriores. A los productores de bananos les vendría bien algo de suerte. En 2019 se detectó en Colombia una nueva cepa mortal del Mal de Panamá. la Raza Tropical 4 (Enfermedad de Panamá TR4), y este hongo podría acabar con las plantaciones en Belize si llega a nuestros suelos. En 2023, la Universidad Tecnológica de Queensland en Australia (QUT en inglés) anunció que había producido un plátano Cavendish genéticamente modificado (GM) que "había demostrado ser altamente resistente al Mal de Panamá TR4". Pero no a todo el mundo le entusiasmará comer un banano transgénico. No dependemos sólo de los bananos para obtener divisas críticas. Los bananos son particularmente nutritivos y asequibles en el mercado local, y la industria jugó un papel fundamental para ayudarnos a superar la pandemia de Covid-19.

Instituto de Estadística de Belize muestran que en 2013 Belize ganó 114 millones de dólares por las exportaciones de cítricos, y en 2022 esa cifra había caído a 39 millones de dólares. La cantidad de árboles de cítricos en producción en Florida es el 50% de lo que era en 2004, en gran parte porque los agricultores han talado árboles debido a la enfermedad. Algunos grandes agricultores de Belize y un grupo de Jamaica han expresado interés en plantar bambú en el distrito de Stann Creek, parte de ello en tierras que alguna vez produjeron las mejores naranjas y toronjas del mundo. Y ahora el Ministro Mai habla de la palma aceitera.

En todo el mundo, algunos agricultores de cítricos están resistiendo, y lo que está surgiendo es que los cítricos resistentes se están convirtiendo en un cultivo sólo para los agricultores más grandes, aquellos que pueden permitirse los insumos químicos y las prácticas que ahora son necesarias para lograr una producción sostenible. Sucesivos gobiernos han invertido dinero en los cítricos, y tal vez necesitemos invertir más. Los fondos de rescate podrían ayudar tanto a los pequeños como a los grandes agricultores a permanecer en la industria. Los cítricos han sido vitales para nuestra economía durante más de seis décadas. Dependemos de las divisas que aporta la industria y los cítricos son esenciales para nuestra salud.

Las industrias suben y bajan, van y vienen, y la tarea del gobierno es saber cuándo resistir y cuándo dejar ir. La historia sugiere que nuestros gobiernos han sido demasiado ansiosos por renunciar a tales industrias. Según un informe de *7News* de 2008, Williamson Industries, la fábrica de ropa que cerró ese año, tenía 700 empleados en su punto máximo. Según *Amandala*, la desaparición de la empresa en Belize no se debió a que nuestros trabajadores no estuvieran produciendo ropa de calidad, sino a que la empresa había encontrado trabajadores en otros países que estaban dispuestos a trabajar por menos salario. Los economistas textuales podrían argumentar que la historia allí es una simple realidad del mercado. Pero, ¿podría nuestro gobierno haber encontrado formas creativas de mantener contentos a los trabajadores y así mantener esos empleos aquí?

A principios de este siglo, la industria del cultivo de camarón, liderada por Nova Shrimp Farm en Ladyville, había alcanzado el estatus de número uno como fuente de divisas. El sueño de uno de los primeros inversores de la industria, el estadounidense Keith Jackson, de que los camarones se volvieran tan comunes como el pollo en las mesas los domingos, parecía estar a punto de hacerse realidad. Pero en medio de la expansión de Nova, se introdujo un virus en los estanques y, simultáneamente con la caída de la producción, la industria enfrentó precios bajos.


El gobierno de turno no apoyó a Nova en sus dificultades, a pesar de que la empresa contrató hasta mil trabajadores en el momento pico y había demostrado ser muy prometedora. Algunos expertos del sector insisten en que la granja, con su sistema de producción semiintensivo, podría haber sobrevivido.

Nelson Reed opines that there were four definable areas in the Yucatan of 1847 - with distinct economic, political and social problems. These were Merida and the northwest; Campeche; the frontier; and Valladolid.

Merida was the center of the Yucatecan Ladino world. Campeche was the second city of the peninsula and the only Yucatan port until Merida developed Sisal in 1811.

Neither Campeche nor Sisal (both on the western coast of the Yucatan) was a natural port; tenders were necessary for oceangoing vessels, and "there was no protection from the dreaded <u>norte</u>, which brought fierce storms from the north."

When Mexico became independent in 1821, Yucatan chose the federalist as opposed to the centralist philosophy of government, "a choice that drew on its experience as a separate entity under the Spanish Crown. Federalism became synonymous with liberalism rather than centralist-conservatism."

Antonio Lopez de Santa Anna, a liberal hero and at first a federalist in favor of states' rights, changed sides after a term as president taught him that Mexico was a collection of weakly joined anarchic states and would need firm handling to become a nation. Beginning in 1835, his congress began to pressure Yucatan. "National troops were sent to garrison Yucatan and paid with state money, while Yucatecans were sent overseas to fight rebellion in distant Texas—a serious matter for the soldiers involved, for there was no provision for their return upon discharge. And those Texans were fellow liberals."

In May of 1838, Santiago Iman, a captain in the Yucatan state militia, began a federalist revolt at Tizimin against centralist Mexico City. Defeated in the first skirmish, he received reinforcements when men of his former battalion seized the ship that was taking them to Texas and forced the captain to put them ashore. Iman was defeated in a second battle, however, and forced into hiding, whereupon a desperate idea occurred to him. The Indios had long been forbidden to bear arms, but had recently been forced to serve in the militia. Many of the Indios had shotguns; all of them carried machetes, and they were many in number. Iman recruited thousands of Indios with various promises and took

Valladolid, whereupon the whole of Yucatan came to his assistance and drove the national Mexican troops from their last stronghold of Campeche in June of 1840. Yucatan declared independence.

Mexico City declared Yucatan ships outside the law and closed mainland Mexican ports, such as Vera Cruz, to them. The Yucatecans retaliated by hiring three ships from the Texas navy to guard the sea lanes between Vera Cruz and Yucatan.

Santa Anna returned to power in 1843 after being defeated and captured by the Texans. Santa Anna sent an ultimatum and an army to Yucatan, where Yucatecans were flocking to arms to defend the peninsula. Yucatan raised an army of 6,000 men, mostly among the Indios, who were promised land and, for the second time, a reduction of their church taxes. Among those Indios was a Maya named Cecilio Chi, chief of the village of Tepich, and a sergeant named Manuel Antonio Ay, both without arms except machetes.

Then the central government of Mexico City sent reinforcements by sea. "The Mexicans had overwhelming naval

superiority—three steamers and four brigantines. Two of the Mexican steamers were the *Montezuma* and the *Guadalupe*, ironclad paddle wheelers equipped with the latest pivot guns bought from England. These ironclads were manned by British sailors and commanded by British officers on leave from the Royal Navy."

In response, the Yucatecans turned to Texas to rehire the Texan navy. This is a whole story in itself, involving a Texan Commodore named Edwin Moore, who disobeyed orders from Texas president Sam Houston to return to Texas, and instead sailed south to Merida and Campeche.

In my Tuesday column this week, I told you that the pre-Caste War story and the situation in Mexico before the 1847 war were complex. If you really want to understand the pre-Caste War situation in Yucatan and Mexico, not to mention Texas, then you have to read Nelson Reed's book, although, since Reed's first edition in 1963, many, many papers and books have been written about the Caste War. I must point out

"Voting" for Wagner a third time

Before these municipal elections get too heated, let me declare my vote and get back into my corner. Ordinarily, no village council chairman, city/town council mayor, or prime minister would get my vote three times. We would have to be shaat-a talent fu troo for me to throw my vote that way. My 2-votesand-out system doesn't apply for councilors and area reps, because they are but aspirants fighting for the crown.

No, ordinarily I'm not with third terms for leaders. If Barrow wasn't so consumed with a third term, he wouldn't have gone and locked up in a room in Miami and rushed a bad deal for BTL. But these past few years have not been usual. Anyone who says otherwise is living off accumulated fat, has one of the few businesses that did better because of the pandemic, or they are, sorry, not in love with honesty.

I can't comment further on those matters, because I don't know the innards of these parties.

Whoa, I can see why party animals on both sides of the PUDP would closely watch Bernard. I told you already that there is room for only one saint in the PUP, and the name is Price. And the UDP has become a Barrow show.

Okay, before I dip my finger in the ink, yes, I'm an in-law of Bernard too. The right thing trumps the popular thing every day of the week.

A representative isn't elected for a day or a week or a month. In our system they get up to 5 years. Politicians who experienced 20% popularity midterm have won elections with 60% of the votes at the end of their term. At the end of the term, the people vote. Look, I don't need to belabor this.





A citizen's plea to police

Belize City resident seeks peace after decade-long harassment by neighbors

BELIZE CITY, Tues. Jan. 23, 2024

Christopher Lamb, 75, of the Lake Independence area, visited *Amandala's* office today, January 23, in a desperate attempt to seek public awareness of, and police intervention in, what he describes as an ongoing nightmare of harassment at his residence.

According to Lamb, for years he has been experiencing harassment by his neighbor, a female, and her 5 children, in addition to other acquaintances of hers. He said that they not only verbally abuse him, but also throw human feces into his yard to the point that it becomes unbearable. "I have a neighbor, and every time she cusses me out—'old, crazy, and stupid,"" he lamented.

Lamb, who lives alone, told us, as he struggled to hold back his tears, "Every day, it's a quarrel. If they don't throw s#!t, they try and burn my name. I'm in my bed and my head is hurting me. I can't live good. If I go eat, there is s#!t; if I wake up, there is s#!t. Everything they do is spiteful, to make me fight them so I could go to jail."

Various attempts to report the matter to the police have failed, and Lamb is claiming that it is because a number of the officers are either friends or relatives of his neighbor.

"I go to report to the police station; when I look, it's the brother of the family; when

I look, it's a sister of the family; and when I look, it's the uncle of the family; and every day I have to deal with these people," he said.

Lamb is claiming that his life has also been threatened.

According to Lamb, the family which is harassing him not only sells drugs, but is affiliated with a well-known gang in the area, which he wishes not to engage with. Instead, he said, he wants to live in peace. "I want betterment, and I want peace. I can't live with stress. I work hard—I clean yards, paint houses, I do everything. I am self-employed," he said.

He said that today he made his 5th attempt to report his situation at the police station on Racoon Street.


When we visited his home today, we observed that his yard was barricaded with tarps and littered with feces and broken bottles. We also visited the police station, where we confirmed that his case was legitimate, and that a follow-up report was in the process.

In 2014, Lamb reported similar incidents to *Amandala*, involving gang-related harassment and criminal activity in his area.

Lamb, then 63, had indicated that feces was frequently thrown into his yard, and he also described a life-threatening encounter with an armed assailant wielding machetes.

A pioneer of the area (Christopher Lamb Street is named after him), Lamb says he has made repeated appeals to the police for increased patrols and visibility to help secure a peaceful living environment, but with the ongoing abuse he feels a growing sense of defeat.

(AMANDALA Ed. Note: Our reporter's visit to the scene has confirmed that Mr. Lamb is not deranged or lying. No less than the Commissioner of Police has lamented the existence of a few "rogue cops" within his department. Unfortunately, if this oft-repeated plea for help continues to be unresolved by the Police Department, the public will be inclined to believe that some police officers are in cahoots with the drug-dealing gangs, and the whole department could be smeared by any unfortunate "incident" involving Mr. Lamb. that where you see quotation marks in this column, this means these are Nelson Reed's words. Let me continue.

In skirmishes between Mexican soldiers and Yucatecan troops near Merida, more than one hundred men were killed or wounded on each side. The Yucatecans, under the command, of Colonel Sebastian Lopez de llergo, a Meridano, were considered the victors, and llergo was promoted to general.

In April of 1843, the Texan sloops, *Austin* and *Wharton*, appeared with thirty-three medium-range cannons between them, to strengthen Yucatan. But the *Guadalupe*, featuring welltrained English gunners, was the world's first ironclad steam-driven warship. "It had only four guns, but they were two times and four times heavier and had a much longer range than the weapons of their adversaries." The *Montezuma* was of wooden construction, but had eight modern cannons. "There were four other Mexican sailing ships with a total of thirty-six guns, but the steamers were the heart of the matter and could be expected to reduce the Texan ships to burning, sinking hulks before they got within range to reply."

But the battle went in the Texans'/ Yucatecans' favor. On the *Guadalupe*, forty-seven were killed and sixty-four were wounded. On the *Montezuma*, forty were killed and wounded. Among the Texans/Yucatecans, five were killed, twenty-two wounded. The invasion of Yucatan was over.

"Following the Mexican-American War, and with a stronger sense of nationality, a remembrance of Yucatecans hiring Texans to fight Mexicans might not have been politically correct. For the Yucatecans of that time, revolting Federalists in alliance with another revolting federalist state was proper and the money well invested."

But the Yucatecan leaders had to realize that independence was not practical. Plus, there was the problem of what to do about the land promised to the Indio volunteers. So many had enlisted that it was considered impossible to reward them all.

"His Serene Highness Lopez de Santa Anna had signed the treaty of reincorporation in December 1843. But the treaty terms and the defeat of his army and navy galled him, and two months later he reneged, banning the entry of all products of Yucatan to Mexican ports." Then he appointed a governor.

Well, what happened then? There was protest in Yucatan, then a declaration of independence by the Merida garrison, and the election of Miguel Barbachano as provisional governor.

The Mexican-American War began in 1846. Santa Anna, overthrown and exiled that year, ended up promising Yucatan its full rights as listed in the 1843 treaty. Barbechano chose to believe Santa Anna.

But, intimidated by the Texas navy, Campeche revolted against Mexico. The Campechanos marched towards Merida.

In January of 1847, troops which featured the Indios defeated the Barbachanista militia, a second victory of Maya Indians against whites.

Around the same time, a Barbachano unit murdered the leaders of the Maya of Tabi. Maya troops under Colonel Antonio Trujeque, hearing of the murders, stormed Valladolid three days after the executions, and a slaughter of the inhabitants resulted. It was very, very bad. Bonifacio Novelo led a lynch mob to the suburb of Sisal. "A paralyzed curate was macheted in his hammock; upper-class girls were stripped and raped before their helpless relatives, then tied spread-eagled to the grillwork of windows and mutilated."

"Violent emotions cloud the facts. Even cannibalism was included in the charges. The sack continued for six days, during which at least eighty-five civilians were murdered."

This would be described as the beginning of the Caste War.



Do you ever wonder what the Old Capital must look like to visitors? What do they think about when they see Belize City for the first time? In his book, The Caste War of Yucatan (first published in 1963), author Nelson Reed warns readers that the shooting does not begin until the third chapter, because he has to set the stage for the action with a description of the worlds which clashed in the war - the Ladino world and the Mazehual world.

Today, scholars insist that the Caste War, which began in 1847, was not a race war, as it had been depicted in years bygone. I don't know about that, because the matter of the Caste War, the matter of mid-nineteenth century Mexico itself, these matters are so complex. In trying to give you a sense of the situation, I read Reed's first chapter, on the Ladino world, several times. I didn't want merely to quote his thoughts, but it was very difficult work; trust me.

Before I quote Reed on Yucatan's sociology, I want to discuss Mexico's

geography. Mexico is at its widest where its northern border meets the border of the United States, at the Rio Grande. This border runs all the way west from California to Texas, America's largest state. Many, many of us Belizeans have entered the U.S. through Mexico's Tijuana border, where the American city equivalent in California is San Isidro. We had travelled by bus from Chetumal to Vera Cruz to Mexico City to Tijuana.

In the old days in the 1950s and before, however, when we left Chetumal, we Belizeans had to go all the way up to Merida, in the northwest of Yucatan, before coming back down to the southeast of Yucatan in order to travel to Vera Cruz through Villahermosa and cities like that. Sometime in the 1960s, however, the Mexican government built a highway from Chetumal through Escarcega which spared us Belizeans the great problem of having to

go all the way up to Merida, when it was really to America that we wanted to go.

Another thing. In the old days, before the war between the United States and Mexico began in 1846, Texas belonged to Mexico. (It had previously belonged to Spain, Mexico's colonial master.) Roads were primitive in the nineteenth century, and you can see on a map that Texas would be much closer to Yucatan by sea, than Yucatan would be to the capital of Mexico City by road. Yucatan, like Texas, had an independent streak from way back.

Here is what Reed says of the social makeup of the Yucatan: "Under the Spanish Crown, Yucatecan society had been dominated by men of Spanish birth. The royal captain general, his lieutenant, and the bishop all came from the mother country-along with most of the higher judges, officials, and many officers. After them in status came the Creoles, people

of supposedly pure white birth but born in the New World. Next stood the mestizos, far down the ladder, of mixed white and Indian blood, and a few mulattos of white and Negro blood. The Pardos, of Negro and Indian blood, came from several hundred ex-slaves in neighboring Tabasco, as well as a group who survived a shipwreck and formed a village in north central Yucatan, but they were never important in number. At the bottom of the ladder were the Indios." Mexico became an even more complex

place after independence in 1821. A number of white Americans had drifted south into Texas by the time the short-term Mexican president, Vicente Guerrero, declared slavery illegal in 1829 in Mexico, but pressure from the Texans forced him to exempt Texas from the anti-slavery decree. The key thing to note here, historically speaking, is that Guerrero, Mexico's only president of African descent, who was deposed and shot by firing squad in 1831, had been supported by the General Santa Anna, whose history in Mexican politics and wars is simply

In the American propaganda movies about Texas and the Alamo which we watched as children growing up in British Honduras, the hero was, of course, Davy Crockett. Santa Anna, leading the Mexican side, was depicted as a buffoon, a weirdo, a coward, and anything else negative you would like to describe him as.

But you can't understand the background to the Caste War without having an idea of how incredible Santa Anna was. According to Enrique Krauze, Lucas Alaman wrote as follows: "The history of Mexico since 1822, might accurately be called the history of Santa Anna's revolutions ... His name plays the major role in all the political events of the country and its destiny has become intertwined with him."


Krauze himself wrote of Santa Anna as follows on pg. 135 of Mexico: Biography of Power: "If Iturbide's empire had been the dramatic enactment of a tragedy, Santa Anna's eleven presidencies might be compared to the less distinguished genre of operetta, in which he played several roles. One of them was 'the conspirator.' Sometimes, a strident 'pronouncement' was enough to topple a government. On other occasions, he would incite the rebels in secret, and when he realized that the government had more soldiers than he did, he would change sides and boldly join the peacemakers. But afterwards he would always retire with his profits in monies, power and prestige to Manga de Claro, his luxurious hacienda in the state of Veracruz. Smothered in the admiration of his public and feigning the most bucolic of lives, 'concerned only with his crops and his livestock,' Santa Anna would wait for the next call of destiny, which never failed to come and nearly always worked out to his advantage." In this column, then, you should have gotten an idea of the furors and uproars in Mexico City, the capital; the independence and ambitions of Yucatan, led by Merida and Campeche; and, finally, the role of Texas in between Mexico City and Yucatan. At the bottom of all this ferment in 1847 were the oppressed Indios. The Caste War was their fight for human rights.

gunshot at him while Brown was inside his vehicle.

"If you do something to my son, he'll come back and do something to you right away," Brown's mother said.

She also claimed that the person who fired the fatal shot had, after the shooting, gone to his home in the St. Martin De Porres area to change his clothes and then went to the Queen Street Police Station. She believes that the person who took her son's life is connected to a prominent local family, and that this influenced the DPP's ruling. "We don't want street justice; we want justice from the system. If the lawyer has to go get the video from inside Thirsty [Thursday] from what transpired inside until that very moment, then so be it. We have to get some kind of justice some way or the other," said Cheryl Brown. "... You know long me and my family members are trying to get to Chester [Williams], and he doesn't answer his phone for anything ... All I want is answers ... If it was the other way around, my son would've already been arrested and go to prison. Look at it as if it was the other way around—a poor man killed a person in high society child," she stated.



The commercial media arena in little Belize is relatively large, with newspapers, television stations, and recently a host of social news media, all competing for the attention of the public and the advertising dollar. Understandably, with our small population, the competition is fierce, especially since Covid-19 and the explosion of various social media news outlets which entered the commercial advertisement field, when businesses were struggling to survive and cutting costs in their advertisement budget. Time marches on, and the suggestion is that we all just have to move with the times: newspapers used to be the only means of quick mass communication, then radio, then television, and now "social media" of various sorts have been added to the mix.

In Belize, newspapers are operating with a much-reduced budget, at a time when the advertisement dollar is shrinking and hard copy readership has also been reduced, as more and more people are satisfied with getting their news from the major television and radio stations or the many "instant" news outlets on social media. Fair enough, but in this world of competition, situations arise that point to the possibility of the playing field being not quite level, and to the detriment of the listening and viewing public. The recent *7News* revelations associating the ownership/influence of a particular social media news outlet with a prominent person who has been questioned by police in regard to a matter whose principals were blatantly exposed on that said social media outlet, comes to mind. Was the particular news media in this case being used for a personal vendetta?

The idea of an unbiased media is one which is very debatable in Belize; in fact, certain newspapers are publicly acknowledged to be the mouthpieces of particular political parties – the party organ, they are called. And that is accepted as no big thing. Everyone knows that *The Belize Times* is the newspaper of the PUP; and *The Guardian* is for the UDP. *The Reporter* is generally considered independent, but with a known bias, from its founding, towards the business class.

And the *Amandala*, an independent voice, has from time to time thrown its support behind one or the other party, or even a single political candidate at times; but no political party or group can claim that they "own" *Amandala*, which means "Power to the People". The newspapers have their owners, and so do the radio and television stations, which have to gain a license to



We know for a fact, from our experience here at Amandala, that by law a copy of the newspaper, signed by the publisher, must be submitted to the authorities every week. The owners/publishers of the newspapers, radio and television stations are liable, under the libel laws of Belize, for any matter released to the public that violates those laws. This newspaper, and others also in Belize, has been sued many thousands of dollars under these laws that are very restrictive on the media in regard to what is considered defamatory to any individual. In competition for the advertisement dollar, the commercial news media - newspapers, radio and television – thus have to walk a thin line. The public often laments the scarcity of good investigative reporting in Belizean news media, but everything comes at a cost, and as we repeat, the advertisement dollar, upon which these media depend to pay operating costs, including employees, is limited and shrinking.

What 7News owner Jules Vasquez revealed in an editorial comment on his television station last Friday, is something that should be of concern to all Belizeans, and particularly, the Broadcasting Authority of Belize, whose oversight authority may not be as robust as it could be over this relatively new phenomenon called "social media". When we talk about the instant social media news outlets, that anyone can access by cell phone, the major ones that come to mind are "Breaking Belize News", "Hot Off The Press", "Belize News Network" and "Belize Live News". There may be others. In every issue of every newspaper published in Belize, the reader can find in a prominent place the names of the publisher, editor, etc. as well as the names of reporters who write articles in the paper. Because of the problem of anonymity of callers to the radio/ television talk shows, who might put the station at risk by defamatory

Nelson Reed opina que había cuatro áreas definibles en el Yucatán de 1847, con distintos problemas económicos, políticos y sociales. Éstas eran Mérida y el noroeste; Campeche; la frontera; y Valladolid.

Mérida era el centro del mundo ladino yucateco. Campeche era la segunda ciudad de la península y el único puerto de Yucatán hasta que Mérida desarrolló Sisal en 1811.

Ni Campeche ni Sisal (ambas en la costa occidental de Yucatán) eran un puerto natural; Se necesitaban gabarras para los buques transoceánicos y "no había protección contra el temido norte, que traía feroces tormentas desde el norte".

Cuando México se independizó en 1821, Yucatán eligió la filosofía de gobierno federalista en lugar de la centralista, "una elección que se basó en su experiencia como entidad separada bajo la Corona española. El federalismo se convirtió en sinónimo de liberalismo más que de conservadurismo centralista".

Antonio López de Santa Anna, un héroe liberal y al principio un federalista a favor de los derechos de los estados, cambió de bando después de que un mandato como presidente le enseñó que México era un conjunto de estados anárquicos débilmente unidos y que necesitaría un manejo firme para convertirse en una nación. A partir de 1835, su congreso comenzó a presionar a Yucatán. "Se enviaron tropas nacionales a guarnición en Yucatán y se les pagó con dinero del estado, mientras que los yucatecos fueron enviados al extranjero para luchar contra la rebelión en el lejano Texas, un asunto serio para los soldados involucrados, porque no había ninguna provisión para su regreso después de su licenciamiento. Y esos tejanos eran compañeros liberales."

En mayo de 1838, Santiago Imán, capitán de la milicia del estado de Yucatán, inició una revuelta federalista en Tizimín contra la centralista Ciudad de México. Derrotado en la primera escaramuza, recibió refuerzos cuando hombres de su antiguo batallón se apoderaron del barco que los llevaba a Texas y obligaron al capitán a desembarcarlos. Sin embargo, Imán fue derrotado en una segunda batalla y fue obligado a esconderse, momento en el que se le ocurrió una idea desesperada. A los indios se les había prohibido durante mucho tiempo portar armas, pero recientemente se les había obligado a servir en la milicia. Muchos de los indios tenian escopetas; todos llevaban machetes, y eran muchos. Imán reclutó a miles de indios con diversas promesas y tomó Valladolid, tras lo cual todo Yucatán acudió en su ayuda y expulsó a las tropas nacionales mexicanas de su último bastión de Campeche en junio de 1840. Yucatán declaró su independencia. La Ciudad de México declaró a los barcos de Yucatán fuera de la ley y les cerró los puertos de México continental, como Vera Cruz. Los yucatecos tomaron represalias contratando tres barcos de la marina de Texas para proteger las rutas marítimas entre Vera Cruz y Yucatán. Santa Anna regresó al poder en 1843 después de ser derrotado y capturado por los tejanos. Santa Anna envió un ultimátum y un ejército a Yucatán, donde los yucatecos acudían en masa a las armas para defender la península. Yucatán reunió un ejército de 6.000 hombres, en su mayoría indios, a quienes se les prometieron tierras y, por segunda vez, una reducción de los impuestos eclesiásticos. Entre esos indios se encontraba un maya llamado Cecilio Chi, jefe del pueblo de Tepich, y un sargento llamado Manuel Antonio Ay, ambos sin armas excepto machetes.

Luego el gobierno central de la Ciudad de México envió refuerzos por mar. "Los mexicanos tenían una superioridad naval abrumadora: tres barcos de vapor y cuatro bergantines. Dos de los barcos de vapor mexicanos eran el Montezuma y el Guadalupe, acorazados de ruedas equipados conlos últimos cañones de pivote comprados en Inglaterra. Estos acorazados estaban tripulados por marineros británicos y comandados por oficiales británicos con licenciación de la Marina Real."

En respuesta, los yucatecos recurrieron a Texas para volver a contratar a la marina texana. Esta es toda una historia en sí misma, que involucra a un comodoro texano llamado Edwin Moore, quien desobedeció las órdenes del presidente de Texas, Sam Houston, de regresar a Texas y, en cambio, navegó hacia el sur, hacia Mérida y Campeche.

En mi columna del martes de esta semana, les dije que la historia anterior a la Guerra de Castas y la situación en México antes de la guerra de 1847 eran complejas. Si realmente se quiere entender la situación anterior a la Guerra de Castas en Yucatán y México, por no hablar de Texas, entonces hay que leer el libro de Nelson Reed, aunque, desde la primera edición de Reed en 1963, se han escrito muchísimos artículos y libros con respecto a la Guerra de Castas. Debo señalar que cuando vean comillas en esta columna, significa que son palabras de Nelson Reed. Déjenme continuar.

En las escaramuzas entre soldados mexicanos y tropas yucatecas cerca de Mérida, más de cien hombres murieron o resultaron heridos en cada bando. Los yucatecos, al mando del coronel Sebastián López de Llergo, meridano, fueron considerados vencedores y Llergo fue ascendido a general.


En abril de 1843, aparecieron las balandras texanas, Austin y Wharton, con treinta y tres cañones de mediano alcance entre ellas, para fortalecer Yucatán. Pero el Guadalupe, con artilleros ingleses bien entrenados, fue el primer buque de guerra acorazado impulsado por vapor del mundo. "Tenía sólo cuatro cañones, pero eran dos y cuatro veces más pesados ??y tenían un alcance mucho mayor que las armas de sus adversarios". El Montezuma era de madera, pero tenía ocho cañones modernos. "Había otros cuatro veleros mexicanos con un total de treinta y seis cañones, pero los barcos de vapor eran el meollo del asunto y se podía esperar que redujeran a los barcos texanos a cascos hundiendo en llamas antes de que estuvieran dentro del alcance para responder". Pero la batalla fue a favor de los texanos/yucatecos. En el Guadalupe murieron cuarenta y siete personas y sesenta y cuatro resultaron heridos. En el Montezuma hubo cuarenta muertos y

statements, program hosts are quick to advise callers not to call the names of individuals about whom they may be making controversial statements. But, who knows the names of the owners/editors of these various social media news outlets? Jules has his sources, and he stated categorically on Friday that a prominent attorney, whose name has been associated with a rape allegation by two women, is a prominent person in the Hot Off The Press news outlet, which released some very derogatory material about the said two women.

Aside from whatever self-serving motive was behind the Hot Off The Press release concerning the two women, another concern for us in the news business is that the public has a right to know who are the owners of every news media outlet that accepts advertisement dollars from the business community, who are liable to pay taxes to the national treasury. Who owns "Hot Off The Press", "Belize Live News", "Breaking Belize News" and "Belize News Network"? In this small country, where sometimes it seems like everything is politics, the public has a right to know who is giving them the news, so that people can have an opportunity to consider the possibility of any bias that may be involved. Moreover, if some news media are paying taxes and others are not, then we are not all competing on a level playing field.

Everybody seems to be jumping onto social media; and that is fine. To each his own. Even the Ministry of Sports is pursuing cost savings by designing a special app to share all their sporting competition news with the public on social media. Newspaper space costs money — for paper, ink, film, media workers, etc., so space is limited for what we can cover in our sports section. Even the multi-million-dollar FFB has chosen Facebook, rather than invest a penny for advertisement in the newspaper sports pages. And that is fine too. With Jah's blessing, we will survive. You know where we stand, and where we have always stood, since 1969. Amandala means, Power to the People!



Moises Perez's body from morgue by Kristen Ku

Family desperate for release of

BELMOPAN, Tues. Jan. 23, 2024

Over ten days have passed since a tragic traffic accident on the Hummingbird Highway that claimed the life of 38-yearold Moises Perez, and his family is desperately pleading for the release of his body from the morgue.

Moises Perez, a father of three and a respected church member, was involved in a collision near Mile 53 in the early hours of Sunday, January 14. According to reports, he was on his way back from Bella Vista Village with a pastor when the tragedy took place.

But his family's grief is heightened by the fact that they have not been able to retrieve his body.

"The reason why we are here is because we are fighting to take out my brother from the morgue," Miley Pérez, Moises's sister, stated. "We already went through so much pain. We got 10 days today that we are fighting to take out my brother from the morgue. We have been up and down since day one. The day the accident happened, I was there, and until now, I'm still there. We want to know why it is that they don't want to give us our brother," she went on to say.

The incident occurred when a Nissan pickup, driven by Elifara Vasquez, 31, with Moises Perez as a passenger, collided with a Ford F-150 driven by Omar Cawich, 44, who had driven onto the road near a junction.

According to ACP Romero, Cawich has been arrested and charged with manslaughter by negligence, causing death by careless conduct, and driving without due care and attention.

Delia Perez, Moises's wife, also shared her frustration, stating, "Today will mark

10 days. I don't think it's fair, because it's not an animal that is there; he's a human being just like us. We have been there constantly waiting to get his body, so I don't know why they're making it difficult."

The family has been in a state of limbo, with authorities reportedly passing responsibility between the police and the hospital. "We know his death was an accident. It is a situation for the police; that's why we go to the police; and they are saying that they're waiting on a call from the doctor," Delia added.

Miley Pérez will remember her brother as a kind and devoted family man, "He's a nice guy. A churchman [who] dedicated himself to his family. He left three children and a wife."

(AMANDALA Ed. Note: On Wednesday, January 24, we reached out to the Western Regional Hospital morgue, where the body was held, and were informed that the body had been released to the family early that morning. Morgue assistant, Dwayne Anderson said he had explained to the Perez family that due to multiple death cases, Perez's body had been placed in a list to be delivered by turn.)

Para los yucatecos de esa época, los federalistas rebeldes en alianza con otro estado federalista rebelde era apropiado y el dinero

La guerra entre México y Estados Unidos comenzó en 1846. Santa Anna, derrocada y exiliado ese año, terminó prometiendo a Yucatán todos sus derechos enumerados en el tratado de 1843. Barbechano optó por creerle a Santa Anna.

Pero, intimidados por la marina de Texas, Campeche se rebeló contra México. Los campechanos marcharon hacia Mérida.

En enero de 1847, las tropas integradas por los indios derrotaron a la milicia barbachanista, una segunda victoria de los indios mayas contra los blancos. Por la misma época, una unidad de Barbachano asesinó a los líderes de los mayas de Tabi. Las tropas mayas al mando del coronel Antonio Trujeque, al enterarse de los asesinatos, asaltaron Valladolid tres días después de las ejecuciones y se produjo una masacre de los habitantes. Fue muy, muy malo. Bonifacio Novelo encabezó un linchamiento al suburbio de Sisal. "Un cura paralítico fue macheteado en su hamaca; chicas de clase alta fueron desnudadas y violadas ante sus familiares indefensos, luego atadas con los brazos abiertos a las rejas de las ventanas y mutiladas". 

How Israel has repeatedly rejected Hamas truce offers

This narrative has become ever more apparent since October 7, when Hamas launched an attack just outside the besieged Gaza Strip on Israeli territory, killing some 1,140 people, Israeli officials said.

Israel launched a brutal military campaign on the Gaza Strip as Prime Minister Benjamin Netanyahu, who has equated Hamas with ISIL (ISIS) and Nazis, pledged to "eradicate" the Palestinian group in the wake of the October 7 attacks.

More than 25,000 Palestinians have been killed and 90 percent of Gaza's 2.3 million population has been displaced in one of the most violent military assaults in modern history, which many have labelled as "genocide". South Africa has taken Israel to the International Court of Justice (ICJ) on charges of genocide.

Since October 7, Israel has described Hamas as an existential threat. It has argued that it needs to destroy the group.

Yet, in 2017, Hamas revised its original 1988 charter to recognise, in effect, a two-state solution—and therefore the existence of Israel as a legitimate entity. This, even as Israel insists it can no longer allow Hamas to exist, and as Israeli politicians, led by Netanyahu, have ruled out a two-state solution.

On Sunday, Netanyahu rejected a Hamas proposal to end the war and release more than 100 captives held by the group, in exchange for a withdrawal of Israeli forces, the release of Palestinian prisoners in Israeli jails and recognition of Hamas governance over Gaza. A look into the history of Hamasamong Palestine's most popular resistance fronts-suggests that its political leadership has, over the years, proposed numerous long-term truces or ceasefires to Israel in exchange for the realisation of a sovereign independent Palestinian state. Israel has rejected those offers, arguing that Hamas could not be trusted to adhere to any long-term ceasefire, and insisting that the proposals for short-term pauses in fighting were insincere and strategically aimed only at helping the armed movement regroup from losses. Sunday was only the latest instance of Israel rebuffing those offers. A timeline of Hamas truce proposals: 1988: Just one year after the group was founded, Hamas leader Mahmoud

The People's Constitutional Commission (PCC) should consider electing Attorney Generals of Belize, rather than to keep appointing them.

Under the Constitution of Belize, the Prime Minister can appoint an elected representative or an unelected person to be the Attorney General of our country. Most of the unelected representatives that were appointed, were made senators so that they could be a part of the Prime Minister's Cabinet because of the importance of this powerful and significant portfolio.

Under this arrangement, the Attorney General is mostly loyal to the Prime Minister or President and their political parties who employed him or her. Yet, his or her duties in the Constitution makes him or her the Chief Law Enforcement Officer for the country to grant justice to all citizens. Also, to uphold the Constitution and to prosecute any citizen, including the Prime Minister, the President and members of the Cabinet, if they violate the Constitution and laws of the country.

He or she also serves at the pleasure of the Prime Minister or President, and can be asked to resign his or her office at any time. If the Prime Minister, President or members of their Cabinet break the law, it is highly unlikely that the Attorney General will bring any charges against them for fear of losing his or her employment.

This [allows] the Prime Minister, the President or members of his or her Cabinet to break the laws, commit crimes and violate the Constitution at will. No Attorney General in Belize or most countries has ever brought criminal charges against the Prime Minister or President who employed them.

Instead, they choose to resign from office when they suspect that the Prime Minister, the President or members of the Cabinet are breaking the laws or violating the Constitution. It is for this reason I ask that we the people of Belize ask our People's Constitutional Commission (PCC) to consider electing our Attorney Generals for a four-year term.

system the way it is. Also, to have the National Assembly approve an annual budget for the office and have them be responsible for the management of our entire Judiciary System. This could be the gamechanger to end corruption in government, abuse of power and violation of our Constitution. If not, our Judiciary System will never be independent of the Prime Minister and his Executive Branch of our Government.

It is important to note that both methods have their own advantages and disadvantages, and the decision to elect or appoint the Attorney General should be made based on the specific needs and circumstances of each country. Below are the advantages and disadvantages of both proposed models

al-Zahar met the late top Israeli officials Yitzhak Rabin and Shimon Peres, and proposed that Israel withdraw from the 1967-occupied territories in exchange for a truce. This was before Hamas had built its armed wing, the Qassam Brigades. Also, in 1988, Hamas founder Sheikh Ahmad Yasin himself indicated a willingness to negotiate with Israel under the condition that it "first acknowledge the Palestinian people's right to selfdetermination and right of return to their land".

1994: Hamas offered a truce to Israel after the abduction and killing of Israeli soldier Nachshon Wachsman. A year earlier, the Palestinian Authority (PA) had accepted the proposal of a Palestinian state comprised of the West Bank, Gaza Strip and East Jerusalem. Hamas agreed to that proposal.

1995: Hamas again proposed a 10year truce based on the same condition of Israeli withdrawal from occupied territories.

1996: In March, after Israel assassinated Hamas military leader Yahya Ayyash in January, the movement offered a ceasefire.

1997: September: Days before Israel attempted to assassinate Hamas political leader Khaled Meshaal in the Jordanian capital, Amman, the movement offered Israel a 10-year truce. October: After his release from Israeli prison, Hamas founder Yasin renewed the call for а ceasefire. November: Hamas again proposed a truce. The Qassam Brigades said attacks against Israeli civilians would stop if Israel stopped targeting Palestinian civilians.

1999: Yasin made another ceasefire offer provided Israel withdrew from the 1967 territories. In a letter to European diplomats, Hamas offered to cease all hostilities in exchange for Israeli withdrawal, evacuation of settlements, and release of Palestinian prisoners.

2003: In December, Yasin offered a ceasefire on the condition that Israel withdraw from the Palestinian territories. He was killed four months later in an Israeli attack.

2004: Yasin's successor and Hamas co-founder Abdel Aziz al-Rantisi again proposed a 10-year truce. Israel killed him



Hamas revises its 1988 charter

The Hamas movement was founded in 1987, two decades after Israel's 1967 military occupation of the remaining Palestinian territories it failed to capture in 1948. Its leaders were shaped by the since 1948, and the formation of a sovereign independent Palestinian state in return for Arab recognition of Israel.

But Hamas's offers were repeatedly dismissed by Israel and ignored by its Western allies, including the United States, despite Washington's claims of playing the role of an "honest broker" in at the time.

"Hamas, ever since its inception, realises the nature of the struggle against the Israeli occupier, that it is not a struggle because they are Jews, but because they are occupiers."

Israeli officials dismissed the new policy paper as "lies". In a video, Netanyahu symbolically threw the document into a bin, saying it was an attempt to deceive the world.

2006: Hamas again offered a 10-year truce that would be "automatically renewed if [Israel] commits to restoring the full and legitimate rights of the Palestinian people to them within a final solution that matches what is accepted by the PLO".

2007: Senior Hamas leader Ismail Haniyeh repeated the group's call for a Palestinian state within the 1967 borders.

2008: Hamas leader Meshaal again offered a 10-year truce, which he repeated a year later.

2014: Hamas and Palestinian Islamic Jihad offered a 10-year truce in exchange for the lifting of the Israeli blockade and release of Palestinian prisoners.

2015: Hamas proposed a long-term ceasefire in exchange for the lifting of the blockade.

2017: Hamas presented its revised

hard realities of occupation, which was marked by mass arrests of Palestinians, expropriation of Palestinian lands and control of resources.

More than half a million Palestinians were arrested and tried in Israel's militaryrun courts between 1967 and 1987, some 1,500 Palestinian homes were demolished, and thousands of other people were forcibly deported.

After Hamas won the 2006 elections in Gaza, its leader Haniyeh said the group accepted a state on the 1967 borders and all the decisions taken by the PA and the Palestine Liberation Organization (PLO), but there were no takers.

Hamas leaders have also backed the 2002 Arab Peace Initiative that called for the withdrawal of Israeli forces from territories occupied in 1967, the right of Palestinian refugees to return to the homes they have been displaced from

the conflict.

"Hamas has always said that they are ready to offer a truce and to stop targeting civilians if the [Israeli] occupation removes its settlers," Tareq Baconi, author of Hamas Contained: The Rise and Pacification of Palestinian Resistance, told Al Jazeera.

At least 750,000 Israelis live in hundreds of fortified illegal settlements and outposts across the occupied Palestinian territories of the West Bank and East Jerusalem, the vast majority of which have been built either entirely or partially on private Palestinian land.

In 2017, Hamas formally amended its 1988 charter, announcing once again that it would accept a Palestinian state on the 1967 borders.

"The Hamas thinking from the very start was clear: 'We are not facing a religious war'," Meshaal told Al Jazeera 'Not about Gaza'

However, some analysts say that Israel has not shown interest in a political settlement, whether with Hamas or other Palestinian political parties such as Fatah, which governs the occupied West Bank.

"The issue is not about Gaza," Sari Orabi, a Ramallah-based analyst, told Al Jazeera. "It's also not about whether Israel or Hamas started the war. There are daily killings and assaults in the occupied West Bank, there are attacks on Al-Aqsa Mosque, there are prisoners and checkpoints."

"The people in Gaza are refugees. They were isolated and separated from the rest of the Palestinian people," he said.



Lucky to be alive after RTA

Vehicle crashed and overturned; but two women suffer only minor injuries

This afternoon, Thursday, January 25, a woman and her mother escaped major injury as they were involved in a serious road traffic accident on the Philip Goldson Highway.

Advantages and Disadvantages of Appointing the Attorney General.

Advantages of Appointing the Attorney General

1. Appointing the Attorney General can help ensure that the person appointed is qualified and experienced in the field of law.

2. Appointing the Attorney General can help prevent the politicization of the office, as the person appointed is not beholden to any political party or interest group.

3. Appointing the Attorney General can help ensure that the office is independent and free from political influence.

Disadvantages:

1. Appointing the Attorney General can lead to a lack of accountability, as the person appointed is not directly accountable to the people.

2. Appointing the Attorney General can lead to a lack of transparency, as the appointment process is often conducted the person elected may be beholden to a particular political party or interest group.

2. Electing the Attorney General can lead to a lack of qualifications, as the person elected may not have the necessary experience or expertise in the field of law.

I was reading about the lack of Belizean judges on the Supreme Court by the National Trade Union Congress of Belize (NTUCB) and our former Attorney General of Belize, Michael Peyrefitte. None of them mentioned the impact our Constitution has that has led to this situation. Maybe, both political parties believe that if they employ foreign judges, they will receive favorable rulings from the Supreme Court. That is a political fantasy because most judges rule based on the law and the facts that are presented to them in court. I have noticed many rulings that the PUP have lost since they came to power in 2020 because they violated the Constitution on many of the decisions they made. If the judges rule against the government, they still will have their contracts. If the government terminates their contracts, they still will be paid, and it is to their benefit. Otherwise, the judges will sue the government.

The vast majority of Gaza's population are refugees, expelled from their cities and villages in what is now the state of Israel by Zionist militias in 1948.

Analysts also blame Israel for the failure of the Oslo Accords, signed in 1993 and 1995, between Israel and the PLO – which was representative of the Palestinian people at the time.

The agreements led to the formation of the PA, an interim, five-year governing body meant to lead to an independent Palestinian state comprising the occupied territory of East Jerusalem, the West Bank and the Gaza Strip.

However, 30 years into its existence, the PA has failed to create a state in the face of Israeli occupation, illegal land grabs and settlements. Hamas took control of Gaza from the PA in 2007. While there was initial support for the Oslo Accords among Palestinians, the failure to reach a final peace agreement by 1999 and the growing settlement projects particularly under Netanyahu, left many disappointed. In a leaked video in 2010, Netanyahu boasted how he made sure the Oslo Accords did not succeed.

The hopes of the Oslo Accords have turned into despair as Israeli policies under successive governments continued to undermine the PA and its aspirations.

Today, the PA has limited administrative rule over pockets of the occupied West Bank, while Israeli settlements, which are considered illegal under international law, have grown rapidly. The settler population in the occupied West Bank and East Jerusalem has grown from 250,000 Israelis in 1993 to more than 700,000 this year.

"The Israelis wanted Oslo [Accords] because that's how they maintain their colonisation; by maintaining the facade

behind closed doors.

declares, "This policy is worthless since it says one kilometre around our village. It is like affording us just the pig pen where you are placing us. You are not treating us with dignity and that is why this is of no use." The Toledo Alcaldes Association (TAA), an appellant in the Maya Land Rights case, has recorded several other videos in which leaders of multiple Maya villages likewise express their rejection of the policy. Adandino Ack, Youth representative from Otoxha similarly destroys a copy of the draft policy labeling it as "... a threat that is going to harm us, or kill us and destroy our livelihoods."

Since it received the draft policy from the Government on January 5, the TAA has been going into the Maya communities to seek their feedback. Having polled 34 of 41 Maya villages and obtained a resounding rejection from all, the TAA wrote Senior Counsel Andrew Marshalleck, the Government's lead attorney in the case, on January 24 to share the majority decision. Village leaders have also come together and jointly communicated their rejection to Marshalleck. A letter from the leaders of Santa Elena, Santa Cruz, San Jose, Crique Jute and Na'Lum Ca dated January 23 notifies Marshalleck that the leaders are not in agreement with new insertions in the policy, and in particular, that which makes reference to a land recognition and titling scheme based on a circular area of 1 to 3 kilometers from the center of the village depending on the population size. The letter states, "This is a scheme that is unilaterally proposed by the government and does not reflect how we live on our lands, making this an impractical proposal if in fact the intention is to protect our land tenure system." The leaders then point out to Marshalleck that they have invested a considerable amount of their time and resources from partners to auto-delimit the lands they use, enjoy and occupy, and their expectation now is for the Government to move to conduct its verification exercise as the next step in the demarcation process. In the letter from the TAA, Marshalleck is informed that "the communities emphatically declare that the circular scheme does not reflect how we live on our lands and that it fails to protect the lands that face the greatest threat, our farmlands - the lands on which we depend for our food, traditional medicines, and self-sufficiency." The government had invited the village leaders to consultation meetings on January 27 and 28 in Punta Gorda, but the TAA says their feedback is that the leaders feel the Government representatives should speak directly to the villagers because "it is unfair to ask them [the leaders] to explain the government's draft policy to the village members." As a result, the village leaders are proposing that the Government officials make their presentation in Santa Elena, Toledo, where villagers will be gathered beginning at 9:00 a.m. on Saturday, January 27.

Mabil Ha elder,

Jose Tush affirmed, "We do not accept! We do not accept! What we want is all the lands we have been speaking of." Directing himself to the Toledo West Area Representative, Hon. Oscar Requena, he says, "We are not asking for money from you. Instead, we are saying, give us the lands we work on and which we occupy. I ask you here to help us the same way you asked for our support." The villagers are asking for Requena to also attend their meeting on Saturday. Nela Pan, Deputy Alcalde of San Lucas, questioned, "Why are they doing this to us? Don't they see we are farmers who depend on the land to eat? Where else would we work? Where else would we eat along with our children?" Pan makes the appeal, "... don't take away our livelihoods. We are Q'eqchi; from the land we feed. There is where we earn our income, our food, everything. So why are you killing us?" Mr. Sub, an elder of Dolores, reminded the Government that they were not elected to harm the people. He questioned, "Why is it then that our government does not see our value? To the government, we are nothing."

The Alcalde of Santa Elena, Brigilio Ack said, "We want ALL our land. The land is for us. We are the owner of the land ... I want you to get it clear. We will continue to fight, and we will not give up! We will stay fighting!"

In response to the latest developments, today, Thursday, January 25, Minister of Indigenous Peoples' Affairs, Hon. Dolores Balderamos Garcia said, "Well, first of all, what they tore up was a draft, so we're not going to cry over that." She then shared the belief that the village leaders are being influenced to be hasty without having participated in another round of consultation. She told the media that the circular scheme is "only one of the suggestions and the proposals that we have made." She said the Government can increase how far the communal land extends out if the villages can provide proof of further use and occupation. Pointing to the challenges of implementing the Caribbean Court of Justice's April 2015 Consent Order acknowledging the rights of the Mayas to their land, the Minister pointed to an example of third-party rights conflicting with communal land. She shared that in Golden Stream, there is a spice farm owned by Doctor Thomas Matthew and his wife who have been in Belize for 32 years. She stated, "I would wish to see that we can have a meshing or at least a melding, a coming together of interests

so that we don't have to be fighting one another. Because if the spice farm employs over 30 employees from the Maya communities, why would we want to send him home? This is his home now." According to the Minister, the owners plan to construct 12 rustic cabanas which will provide even more jobs. She then questioned, "So, why would we want to deprive our country of that kind of resort and facility, when we can probably find a way to live together without having to take away people's land; and in any event, we have to respect private ownership."

Minister Balderamos Garcia is calling on the Appellants to be responsible. "Don't be riling up the people to tear up a piece of paper when we have not even had a chance to have the consultations as yet," she said. The Minister also acknowledged that they may need to meet with the villagers "because sometimes, an alcalde or a chairman or a leader might go to a meeting, but we don't know that the message is being taken back to all the membership of the community."

Worth noting is that the Minister today said that the Government officials who were planning on conducting consultations with the village leaders this weekend in Punta Gorda, will, in fact, attend the meeting that the TAA has called them to attend in Santa Elena.

Crown Close In Selgado's Trial

Although both the Crown and the defense, represented by former High Court judge Adolph Lucas, Sr., had agreed to have the evidence from a *voire dire* that had been held earlier, incorporated into the main trial, Williams and Ferrufino were called to give additional evidence.

Williams testified that in March 2023 he received the contents of several audio recordings from Giovanni Ramirez via WhatsApp. He said he listened to the tapes 2 or 3 times, and he recognized the voice of Selgado and the voice of Ramirez as the two persons in the recording. He said that he heard Selgado telling Ramirez that the "b@#ch" (referring to Marilyn Barnes), had to die. (Barnes was a former client of Selgado who had submitted a complaint against him to the General Legal Council, which could have led to his being disbarred.) Williams also said that he heard Selgado telling Ramirez where Barnes resides. He said that Selgado's voice was very recognizable to him because he had heard it almost every night in the past in television interviews that he granted to the media about trials in which Selgado was serving as a defense attorney.

to make an assessment, and he recognized the voices of Selgado and Ramirez as the two persons on the tape. He further corroborated Williams' testimony by saying that he heard Selgado telling Ramirez that he wanted Marilyn Barnes dead before the next meeting of the General Legal Council. Ferrufino also testified that he handed over the information from the tapes to police corporal Cunningham along with a chain of custody form for him to extract certain information. He said that the voice of Selgado telling Ramirez what to do in the tapes was clear, and it confirmed what Ramirez stated in his statement on July 4, 2019. Ferrufino also testified that he was the arresting officer, and that the video and audio tapes were clear, but those recordings had gone

missing.

Senior Magistrate Anderson testified that she was the person who presided over the preliminary inquiry, and that the defense agreed to accept the witness statements without challenging them. She also said that Selgado was given disclosure, and he was indicted to stand trial in the High Court for the charge of abetment to murder.

The trial was adjourned until today for the defense to start its case, but it was further adjourned until tomorrow, January 26, due to unforeseen circumstances.

Mysterious murder in Willows Bank

of Willows Bank, Belize District, was found sometime before 7:00 p.m. on Tuesday after her common-law husband, Emeterio Reyes, 52, found that she was missing from their home, where there were pools of blood, and sought help from neighbors.

Those neighbors told reporters that Reyes, who they said had come off a bus around 6:25 p.m., had gone to their home crying and explaining that there was blood in the home, and that Cleland was missing. The neighbors said that they went to the home, and that they saw blood on the door and a bloody path that led to an outdoor bathing area, near which the 18-month-old toddler had been found by Reyes — stuck in a puddle of water and calling out for his dad.

They commenced a search, and shortly after, they found Cleland's motionless body in a face-down position in bushes near the side of the road, and there were injuries to the back of her head.

She was dressed in a green blouse and tights. When police arrived at the scene, they saw the blood stains on the house and in the yard.

It is being reported that three days before her death, on Saturday, January 20, Cleland left several cryptic messages on her social media page, stating, "He kill them and put his nephew in [jail] because of the big man please take care of my kid", and "I know what happens my people know too they will kill me soon too." This has led to speculation that she was a witness to a murder.

However, Commissioner of Police, Chester Williams told reporters, "I can confirm that the victim is neither a witness and she had not provided any information to police regarding any criminal activity." He further mentioned that, "The content of those comments

food safety regulations to mitigate the risks associated with animal-sourced food products. BAHA emphasizes the critical threat posed by illegal importation of animals and animal products into Belize. Such practices can introduce devastating diseases like New World Screwworm, Highly Pathogenic Avian Influenza, and Classical Swine Fever, all present in nearby regions. These diseases not only pose a health risk but also threaten food security and livelihoods in Belize. In response, BAHA has heightened its national surveillance programs and is actively participating in international and regional initiatives to prevent the spread of these hazardous diseases. However, they reassure that there have been no reported cases of such diseases in Belize at this time. The organization stresses the collective responsibility of Belizeans in preventing illegal animal importations.

was only brought to our attention this morning, and we cannot at this time confirm if they were indeed made by her. If they were made by her [before] her death."

When it comes to the safety of the 18-month-old toddler, Minister of Human Development, Hon. Dolores Balderamos Garcia spoke to members of the media in the wake of the horrific murder, and explained that the child has been taken into the care of the ministry.

"So that child [needs] care; the mother has just been killed. And so that the reference, I think, came from the village chairlady, if I'm not mistaken, and immediately we already have the child in care. He was given a bath; he was given clothes, food, and everything. I believe that we have him in foster care with a set of foster parents who have proven that they are good at caring for children," she said.

While people would believe that the child would be given to a relative for care, Minister Balderamos Garcia noted that that's not the case, as the ministry determines if the child is safe if given to any relative.

"The main, number one mantra of the entire child-care system is that we do what is in the best interest of the child. Even though the biological father would have first right to that child, we would have to look at whether the child would be safe. I mean, even if the [father] is not guilty of whatever accusation may come, and we don't even know if that will happen yet, but even if that is the case, what we would do is make sure that the best interests of the child are taken care of. So, it's not an automatic thing that goes to the mother, the father, the auntie, or the granny. It's what [is] in the best interest of the child," she expressed.



Third Senate hearing postponed





the Portico Definitive Agreement and the subsequent tabling of that agreement for the Cabinet, was postponed today after a quorum was not reached. The committee's chairperson, Senator Janelle Chanona expressed her disappointment during an interview following the cancellation of the session, which was already being streamed live on YouTube.

A prompt statement released by the Government Press Office following the forced cancellation of the meeting mentioned that "some members of the committee are sick, traveling and going through family emergencies, which have resulted in a lack of quorum for the Public Hearing to be held."

Chairperson Chanona in her remarks reiterated the same.

"We have several members that are dealing with different emergencies, crises, and required international travel," she said. The number of missing members and their names were not revealed.

But the question being asked by many in the public and notably by the chairperson of the United Democratic Party, Senator Michael Peyrefitte, is how the committee could have not known that its members would be out and had to cancel at the eleventh hour, after already starting the broadcast of the session. The session was streamed for at least an hour and fifteen minutes before the notice of its cancellation was displayed.

"I don't know how you did not know those people were not available before this morning," Peyrefitte said.

Two former UDP Ministers, Erwin Contreras and Hugo Patt, were scheduled to testify before the committee during this session, and according to Chairman Peyrefitte, they were present at the National Assembly building.

"They were so gung-ho about it, and they seemed so aggressive in summoning Erwin Contreras and Hugo Patt; and they seem very nonchalant in wanting to hear from the Prime Minister himself, who was the one who took the document, the Definitive Agreement, as well as proposed legislative drafting to the Cabinet to be passed. So, they were excited to have these people there; these people showed up today, and they balked. What prevented them from proceeding with the hearing today and putting it to, I think, February 14 is anybody's guess. That is a matter for them. I'm not privy to that information, but I think it would have been good for the public to have heard what these two gentlemen have to say, or at least their responses to the questions that they were going to ask them," Peyrefitte said.

The public will have to wait until February 14 to hear Contreras' and Patt's responses to the committee's questions about the events that led to the signing of the so-called Portico "Definitive Agreement."

"We ask for the patience and understanding of everyone who has been following this process very closely, and I can tell you that the membership is very keen on moving the process expeditiously along; and it is indeed disappointing that today's session was forced to be postponed, and we will be moving to make sure that that does not happen again in the future if at all it could be avoided," Chanona said.

He ended by mentioning that if the department doesn't take any actions within a certain timeframe, BAPDA will become more forceful in its effort to get its message across.


