July 11, 2024 In April of this year, the Millennium Challenge Corporation (MCC) of the United States of America concluded a formal negotiation with the Government of Belize for the establishment of the terms of a funding agreement. Today, the House of Representatives passed the legislation to formalize this agreement and begin the rollout of a grant of \$250 million BZD that will be used to carry



Appeals of Mason et al dismissed by Court of Appeal

A revised and expanded edition of Belizean author and activist, Beverly Lemoine Gutierrez's book, While Passing Through, was released today, Thursday, July 11, at the Leo Bradley Library in Belize City.

The narrative recounts the first 23 years of Gutierrez's life while growing up in Belize through a raw first-person point of view as she endured sexual trauma by relatives, poverty, pregnancy, drugs, and multiple suicide attempts along with other topics.

PM Briceño speaks on various topics

BELMOPAN, Thurs. July 11, 2024

After yesterday's session at the House of Representatives in Belmopan, the local media got to speak with the Prime Minister of Belize, Hon. John Briceño, for a brief moment on various topics.

Speaking on the MCC (Millennium Challenge Corporation) Grant where the US government approved a five-year US\$125 million to Belize in April, PM Briceño mentioned that there are no strings attached. "If you want to look at what the MCC is all about, as I pointed out, fighting poverty and it has to do also with assisting a country to grow its economy. So that's what they do all over the world; there's nothing new. There have been no strings attached; it's simply that they have come in to align themselves with what we want ... we're attempting to do in Plan Belize."

Reporters asked him about the upcoming by-elections scheduled for next Wednesday, July 17, for the vacant seat in Toledo East. He said it wasn't the same as in 2021, when Hon. Elvia Vega-Samos won in a by-election in 2021.

"At that time, it was in the pandemic; her brother had died; the PUP had just won 26 seats; and we knew it would be a walk in the park. We were so busy trying to put this country back in place," he said

He was questioned about People's United Party (PUP) standard bearer for the upcoming by-election, Dr. Osmond Martinez, about allegations that he holds dual nationality, which would disqualify him for office.

"If you have dual nationality, all you need to do is to give up one of them. So, you could only have ... you could be born elsewhere, or you can be a Belizean born elsewhere and you're here; you can give up, you could only have Belizean nationality. So, this isn't a problem. But I think Mr. Martinez was born, and explained it very well. He was, as he said, he was conceived in Belize. His mother had a delicate pregnancy, but then there were no good medical facilities in PG. So, her mother was originally from Honduras, so she went to their family in Honduras where they believed they could have gotten better medical attention. The baby was born and they came back to Belize," he said.

Lastly, he was asked about relief for the Caribbean countries that were affected last week by Hurricane Beryl, a Category 4 storm. PM Briceño mentioned that Belize can only afford to assist Grenada and St. Vincent and the Grenadines with 50,000 USD.

Man faces 5 years for sharing ex's nude video; changes plea

BELIZE CITY, Tues. July 9, 2024

Brian Lee Perriott, 20, a call center agent, is out on bail after changing his initial guilty plea to not guilty, after he became aware in the wake of being charged that he could face up to 5 years behind bars at the Belize Central Prison for sharing a video in which his 26-

year-old ex-girlfriend was nude, without her consent.

The incident allegedly took place during the month of June after the woman had ended her relationship with Perriott. He became vengeful, and a few days later, he opened a Facebook account under the name "D-Juan Petterson" and sent her a private message with a video which was recorded without her knowledge of the former pair in bed, where she was naked. The woman then reported the incident to authorities.

The harassment reportedly continued, as Perriott threatened her that he would send the video to her parents and post it on social media. Additionally, a few days later, Perriott created another fake profile in the woman's name. The video was eventually distributed, which was confirmed when the woman received a screenshot of Perriott sharing it with several persons. When the woman

when the woman asked him to stop, he then threatened her that he would shoot at her house while her family was at home. Everything was reported to the police, and it was confirmed that Perriott was the mastermind behind the fake

accounts.

When he appeared in the Magistrate's Court on Friday, July 5, Perriott pleaded guilty to the offenses, and was remanded to prison. However, when he appeared in court for sentencing on Tuesday, July 9, he changed his plea to not guilty and appeared with attorney OJ Elrington, who claimed that his client had been unrepresented in court when he was initially charged, hence his initial plea.

After changing his plea, Perriott was granted bail for \$8,000 plus one surety, with conditions being that he should not speak to anyone involved in the case while the matter is in court, and should stay off social media while the matter is in court, and stay 100 yards from the complainant.

He is to return to court on September 9.







According to neighbors, the mother of the home left earlier that morning to go to work along with her two small children, whom she dropped off at a babysitter. Not too long afterwards the smoke was seen coming out of the structure.

"That information reached me, and the police officer who allegedly transported him out of Placencia has been transferred from there," said Commissioner Williams. ComPol Williams has told the local media that they have already provided information to US authorities concerning Meighan being wanted in Belize. Due to his claims of asylum, it will make the deportation process a lengthy one, but the ComPol remains optimistic.

BCC and Peak Outsourcing sign MOU

BELIZE CITY, Wed. July 10, 2024 The Belize City Council and Peak Outsourcing-Belize International Ltd., a business process outsourcing (BPO) company, signed a Memorandum of Understanding (MOU) on Wednesday, July 10, at City Hall in downtown Belize City.

First established in Dumaguete and Makati in the Philippines in 2011, under the name Pinoy Partners Incorporated Limited, Peak Outsourcing expanded its operations to Belize in 2022 and set up its offices on Coney Drive in Belize City, with initially around 120 agents.

The purpose of the MOU is to create a bridge for employment opportunities and career development for the residents of Belize City. Peak Outsourcing will partner with the Belize City Council to not only provide jobs through the MOU, but also provide internship and training programs. According to Orson Picart, Senior Talent Acquisition Specialist for Peak Outsourcing Belize, the collaboration has been in the pipeline for some time, but faced obstacles along the way; and last week's looming landfall of Hurricane Beryl near the country forced them to delay the signing.

"We had an initial meeting before penning the MOU, making sure that we had visibility across the entire MOU, and the different mechanisms in place to make sure that we can offer gainful employment training and different aspects that 'newbies' and possibly people who are in the BPO sector would need in terms of competences," he said. "It also has to do with the other community-based initiatives that we're partnering on to make sure that, once again, we could build the competences of qualified individuals to make sure that they have placement. Cotton Tree man charged with 2 counts of abetment to murder

Jamal James Hyde, 22, a construction worker from Cotton Tree Village, Cayo District, has been charged in connection with the shooting death of 39-year-old Clint Castillo, a Cotton Tree resident, and the attempted murder of 32-year-old Andrew Muns, which occurred over the weekend.

According to reports, Castillo had been socializing with some men around 10:30 p.m. on Saturday, July 6, when an argument between two of his associates



865 dengue cases in Belize, says Health Ministry

BELIZE CITY, Tues. July 9, 2024 Amandala has confirmed with the Ministry of Health that there are over 800 active cases of dengue fever in Belize, particularly in the Toledo District.

"As a country, we have reported 865 dengue cases, 383 lab-confirmed cases, and 482 [clinically] confirmed cases," said Kim Bautista, the Chief of Operations at Vector Control for the Ministry of Health. "75 percent of those cases come from the Orange Walk, Cayo, and Toledo districts. In the Toledo District, the majority of their cases are from Punta Gorda Town and Bella Vista, which geographically is right on the boundary between the Stann Creek and Toledo districts," Bautista additionally mentioned.

According to Bautista, 224 cases, which is 26 percent of all the cases in the country, are in the Toledo District. The Orange Walk District has 197, which is 23 percent of all cases; and there are 225 in Cayo. Earlier this year, the country experienced an extreme heat wave during April and May, but during that time, dengue was still prevalent in the south.

"Now, as we all experienced earlier this year, there was an extensive drought, and there were parts of the country that still had dengue transmission; and that is in Toledo; that is when the outbreak in Toledo started. There was a situation where the municipality was stockpiling tires as part of beach reclamation efforts, and so when we look at the data that our field officers captured, the containers that are most positive for the mosquito that transmits dengue tend to be tires and uncovered drums and buckets and things like that. So, though you have a drought, if you still have the containers out there to breed these mosquitoes, there is the potential for transmission," said Bautista.

He further noted that in 2019, the Americas region saw the highest number of dengue cases: a total of 3.18 million; however, in 2023, that number rose even more—to 4.5 million. Meanwhile, in Belize, an increase of 5 percent has been recorded this year compared to last year.

"There's only a 5 percent increase. So, at week 27 last year, we're looking at 823; and this year, we're looking at 865. So, there's a 5 % increase. However, EpiWeek 18, which is at the end of April ... since the end of April we have been below that threshold, and we have been below the trend last year. So, following the projections that we're

seeing, we were on trend to end the year with a lower number of cases than we had last year," Bautista said.

"... Last year, as a country, we reported 3,054 cases; 1,370 laboratoryconfirmed cases and 1,370 clinical. This year, we're at 865. So, if we maintain the current trend, we should be under significantly reduced numbers at the end of this year," he added.

To combat the country's mosquito crisis, 14 trucks are passing through various communities across the country, including San Pedro and Caye Caulker, to spray chemicals that prevent the breeding of mosquitoes. They are targeting over 200 areas with a history of dengue, including the rural and urban areas.

"It is a maximum of four to four and a half hours, because you cannot apply chemicals in using that methodology during the day because it will evaporate. You cannot apply when it is raining; it will not work. And if you apply after it has rained, it would have to be a minimum of one hour after the rain has passed. So, you have maybe from about 5:00 a.m. to about 6:00 to 6:30 in the morning, and then from about 6:00 to about 9:00 in the evening. So, it's a short window that you have to go, and you're driving roughly seven to eight miles per hour to do a proper spray. So, you can imagine that it's a slow process, and the amount of communities you need to cover," he said.

Dengue is also driven by socioeconomic conditions, said Bautista, since there are persons who are living in areas more highly at risk for mosquitoborne transmitted diseases, such as lowlying areas or areas with poor drainage which are affected by climate change.

Bautista shared data from the Ministry's Epidemiological Week, which starts on Sunday and ends on Saturday.

escalated into a fight and he tried to be the peacemaker between the two men.

It is alleged that the same triggerman then turned the weapon toward Muns, with whom he had been arguing, and fired gunshots at him.

On Tuesday, police reported that one person was detained and another was being sought, and today it was revealed that Hyde has been captured and charged with two counts of abetment to murder.

When reporters questioned Commissioner of Police, Chester Williams on the matter, he mentioned that the person who shot Castillo and Muns was still being sought by the

department, and they had gotten information about his whereabouts, but

had yet to find him.

"I have personally gone to the mother and asked her to see if she would be able to assist the police in locating her son, and even to the extent of asking her if she would be able to locate him and surrender him to the police. She pledged that she would do her best, so we'll wait to see what happens. In the meantime, we continue our efforts to try and locate him. He's now on our Five Most Wanted list, so you know that he's of great priority to us," he said.

According to ComPol Williams, the murder isn't gang-related, but the men involved in the incident are all friends. However, with the State of Emergency (SOE) in effect in that community, some may believe that the SOE is failing, but ComPol Williams thinks otherwise.

"SOEs are not designed to stop every crime occurring. Just like if you have an SOE, and a wife and husband have an issue at home and one kills the other, how do you expect this? So, it's not going to stop that ... The objective of the SOE is to go after the persons known to have continuous problems in the area. It's not just to look at somebody and say, 'Oh, he looks like he has a gun'; or 'Oh, he looks so', and we pick them and lock them. They were in a yard, hanging out, enjoying themselves, and arguments started ... Certain things are going to happen that are going to be outside the preventable reach out of the police," he pointed out.

ComPol sees possible justifiable behavior in viral video

Commissioner of Police, Chester Williams defends his godson, Devon Makin, for his actions committed in the viral video in San Pedro.

SAN PEDRO TOWN, Ambergris Caye, Thurs. July 11, 2024

The Commissioner of Police, Chester Williams, broke his silence on a viral video that made its rounds on social media over the weekend in which his godson, Devon Makin, a police officer stationed in San Pedro Town, is seen aggressively detaining a civilian along with using profanity.

As mentioned in *Amandala* Tuesday's digital edition, Makin was reportedly in pursuit of two men who were believed to be equipped with firearms and allegedly on their way to commit a crime. A snippet

of the incident was captured via cell phone displaying Makin aggressively kicking the San Pedro man once, forcing him to kneel while hurling profanities.


Then Makin pulled out his service-issued pistol and proceeded to pistol-whip the detainee. After doing so once, Makin took two glances at the camera, placed his weapon in its holster, approached the camera, and aggressively ordered the person not to video him, while turning his back to the detainee.

According to ComPol Williams, Makin was off duty and was making his way home when two minors asked for his assistance, because they were being threatened by two men,

one of them being the alleged detainee.

After the viral video made its rounds on social media, critics commented that Makin used excessive force. However, in the eyes of ComPol Williams, Makin's behavior might not be completely unjustifiable.

"He met the one who was seen with him in the video, and the information is that he may be armed. The police would have to take out his weapon to secure his safety as well as the safety of others; and in doing so, what we normally do if we have a suspect who is believed to be armed, is you would put him to kneel down or on the ground on his belly until you are certain that he is safe. The sergeant attempted to do that, but while trying to put the person in either position, the young man was resisting [and he] only had two hands. So, he was holding him with one hand and he had the other, the gun in the other hand, and so he tried to hit him with the other hand, but that's the hand that had the gun," he said. ComPol Williams further mentioned, "We have to look at the situation in its totality. It's not like the sergeant just went and picked on someone for no reason and just beat him up. There was a complaint made by two minors and even though he

was off duty, he responded to the calls of these two minors to try and apprehend the individual. Those persons who did the video recording, know exactly what happened; but, as usual, they spliced the video and just released what needed to be released ... If it is that you know that you are so innocent, you have done nothing wrong, and you believe that the police have abused you, then why can't you come forward and make a complaint?"

because he dared to question why he was being searched. The Ambergris Caye resident was accompanying 18 tourists waiting to board a Maya Island Air flight.

The claim form for the case was filed on March 22, 2023. The Police Department, via its legal counsel Bart Jones, declined to pay damages of BZ\$30,000 sought by Foster on May 6, 2022. They argued that the version of events of the police officers in question differed from Foster's narrative.

Foster reported that while waiting on the Maya Island Air compound, a police mobile arrived and two officers approached him to conduct a search. They were later identified as Albert Martinez and Linda Chan. In the cell phone video that Foster managed to capture of the distressing ordeal, the officers are heard using demeaning language and stating that he did not appear to be a tour guide because of how he was dressed. In an attempt to get Foster to stop his recording, Martinez hit him on the arm; and while putting his hand on his gun he threatened, 'You want this to get f**g nasty?" Foster was then hit a second time, and that caused his cell phone to fall to the ground and the screen to shatter. The officer even threatened to accuse him (Foster) of assaulting a police officer. Despite it all, Foster did not respond with expletives. Nothing incriminatory was found on him, and Foster alleges that the officers did not apologize for the arbitrary search.

The incident was followed up in June 2022 by Foster, who filed a complaint against the officers at the Professional Standards Branch. However, up to almost nine months after the filing of the claim, Foster had not received any formal response or update on his complaint.

The claim zeroes in on the police's "wide interpretation of their power to stop and search," wrote Foster's attorney, Leslie Mendez, in a statement when the claim was filed. She added that "officers misuse this power to operationalize their prejudices, and adopt all manner of repressive tactics against ordinary citizens ..."

Sought in the claim are damages for constitutional relief, including vindicatory damages. Also being sought are 5 declarations, including that the search conducted on Foster was unlawful; that the action of the police to stop him from recording the search was a breach of his fundamental right to protection of the law and freedom of expression; that the manner in which the search was conducted violated his right to dignity and respect as guaranteed under Section 3 of the Belize Constitution; and that he was deprived of an effective remedy because he was not notified about any disciplinary proceedings.

Finally, the Court is also being asked to declare that "... the disciplinary proceedings conducted by the Professional Standard Branch under the Belize Police Department fails to meet the requirements to provide an effective remedy to the claimant in that the process lacks transparency, independence and impartiality..."

Today, High Court Justice Martha Alexander heard closing arguments in the case. After the session, attorney Mendez spoke with Amandala about aspects of the case that would be precedent-setting. In the case of the right to record a police officer in the conduct of his or her duties, Mendez says they are arguing that this right is protected in the Constitution of Belize under the right to freedom of expression. She explained, "We are inviting the Court to find that that right encompasses your right to record police officers, because essentially what you're doing is you're receiving information, you're collecting information that is relevant to public officials' duties and how he carries out those duties."

Mendez said she has not come across a case in the Commonwealth Caribbean that directly addresses the right to record police officers while on duty. She shared that the cases they relied on to help make their arguments were from courts in Canada and the U.S. They also relied on comments by international bodies regarding the inclusion of the recording of protests and public assemblies within the scope of freedom of expression.

Speaking about Foster's disposition throughout the case, Mendez said she admires his perseverance given the lengthy process, and that while he had an interest in his matter individually, "he definitely wanted to explore to see how to deal with the systemic issue."

In the past, when officers would demonstrate similar behavior they would be nailed to the cross by the ComPol; however, because Makin is his godson, thus the soft tap on the wrist, the public is saying.

"What does that have to do with the price of milk? It has nothing to do with it. If you want to talk about the issue of relatives ... Inspector Martinez, he's my first cousin, correct? And what happened? My first cousin is more to me than a godson. And if I was able to move quickly on Inspector Martinez, who is my first cousin, then why would I not be able to do so with Mr. Makin? If it were that we were not looking at the thing holistically? Professional Standard Branch is in the picture. They are investigating. Once the investigation is done, we see how it goes from there," Commissioner Williams said.

Speaking to the matter of the sergeant addressing bystanders with a camera, the Commissioner said: "When you have a situation like that, Mr. Vasquez [Channel 7 proprietor/journalist], those persons who were recording were part and parcel of the same enterprise of that young man. So not just because he, if a matter of fact, the police could not even have ascertained at that point, if he was armed or not; but the information is that he was armed. The a fine of \$150. While the claim does not seek penalties for the officers individually, Mendez says they do not consider the fine to be appropriate.

police must act as if he was. Those other persons who were in the immediate area, too posed a threat to the police, because one of them could have well had the gun that the young man had. ComPol Williams expressed that if the men are innocent, they should make a complaint to the police station; but the duo have not done so.




Sizable deportation could provoke Bukele-type response

It's not our call to influence who fills the leadership positions in other countries, but it is incumbent on our leaders to consider the implications of foreign elections, particularly those in countries that directly impact us. Especially because we are small, our leaders are usually silent about whom they support, though very often it's clear at home whom they prefer. In a tack away from our usual posture, Belize's present leaders were overtly supportive of President AMLO's successor, Claudia Sheinbaum, maybe because AMLO, a left-leaning leader, has been more supportive of Belize's economic well-being than any leader who has been president in Mexico.

Leaders in big countries aren't coy about where they stand regarding the leadership in other nations. New UK Prime Minister, Keir Starmer, of the left-wing Labour Party, has a cordial relationship with former US president, Barack Obama. In March this year, when Obama visited the previous UK prime minister, Rishi Sunak, of the Conservative Party, for informal talks, Nile Gardiner, in the right wing newspaper, *The Telegraph*, said in a story titled "Obama is no friend of Britain – Sunak should invite Trump," that it was "a reckless move by Downing Street ahead of an impending US presidential election this November, as well as a bad strategic decision to host a left-wing anti-British former president."

It is a worrying promise made to the American people, by Donald Trump of the Republican Party, that if he wins the presidency in November his administration will embark on deporting 15 to 20 million people living in the US illegally. There is no guarantee that Mr. Trump will become the next president, because there is a formidable rival competing for the crown, the present president, Joe Biden, of the Democratic Party. There is also no guarantee that a Trump administration would follow through with the largest mass deportation of people in history. Some experts say it would be impossible

to execute such a program.

There are no guarantees in politics. For decades, the Democratic Party has been seen as less hostile to undocumented immigrants, all non-white, and when the US got its first non-white president, Barack Obama, it was anticipated that the pressure on undocumented persons would ease. There are various aspects of the immigration story, but it is not an empty charge by some that Obama turned out to be "deporterin-chief." It is claimed that his administration sent home more immigrants than any other in US history.

Our system, a capitalist one, has never been able to provide

broad and generalized. Also, there has always been considerable underemployment in Belize, and a massive hike in the price of imported goods has caused more Belizeans to slip into this category. Belizeans are overly dependent on foreign products, especially since our post-independence governments abandoned the "mixed economy" system, and access to foreign television increased our appetite for luxury goods. The majority of our people have fallen into the ranks of the underemployed – with insufficient or barely enough money from our paychecks to buy what we need or perceive as needs.

The present government could point to the fact that our country was in recession for more than 4 consecutive quarters when they took office, that they took office during the Covid-19 pandemic, that a war in Europe and a genocide in Palestine have further disrupted the world economy, that they took over a country in massive debt, and that a couple of our backbone agro-industries aren't doing well. What caused our present economic state and what the present government has done to make things better are important, but only to help us chart a way forward. As it stands at this moment, our economy is unable to withstand any shocks of some severity, such as what mass deportation from the US would cause.

People are a country's greatest resource, if they have a place in the economy. When people can't find a place in the economy, they become a burden. Neither a Trump nor Biden government would send home doctors, engineers, computer technicians/programmers, or other highly skilled Belizeans. They walk on the proverbial red carpet, and many, if not all, have gained citizenship status in the US. The Americans are about increasing the fruits of their economy, so they will hold on to those who help make their economy grow. They won't send back Belizeans who do the jobs that Americans don't want either. Though their work is not nearly as prized, their services are essential.

Primarily, they would be sending back our people whose services are expendable, and those who are involved in illegal activities. Our biggest concern is the return of Belizeans who have been sucked into the world of violent crime. Deportees who had turned criminal so overwhelmed El Salvador that the people there embraced the suspension of basic rights and the incarceration of thousands, under their president, Nayib Bukele. Next door, in Honduras, President Xiomara Castro's government, faced with a similar problem, recently announced plans to construct a large prison with a capacity for 20,000 inmates.

Even if absorbing hundreds of deportees wasn't looming, we should be moving with urgency toward boosting our economy. We have to become more productive. Raising more cattle and selling them on the hoof, and more primary agricultural production, are positive, but the increased stress on our environment has to be considered. More than two decades after cruise tourism became "a thing," we have yet to produce a plan to guide its future.

Paramount for the growth of our economy is that we produce more of the goods that are sold in the grocery stores, and that we make a conscious effort to spend a greater portion of our dollar on products that are made in Belize. For the good of the nation, we must reduce our dependency on foreign luxuries. Our dollars must be spent on tacos and meat pies, products from our cottage industries, local art, locally processed foods and beverages, and the fresh fruit/vegetables/meat/fish produced by our farmers and fisher folk. We must return to planting 10,000 trees each year, to increase our forest cover and so we don't have to import lumber. We must revisit the cooperative system, combining our capital, talent, and labor so we become more competitive. Our government must continue promoting MSMEs, and it must redeploy the technical talents in its employ in the service of small entrepreneurs. Our economy would be shocked by any sizable deportation. Deportees with no criminal inclinations would be tempted to turn to crime when they can't find economic opportunities in the land of their birth. Already we have to rely on SOEs from time to time to restore order when there is an escalation of violent crimes. If we were "hit" with some plane loads of deportees, it's likely only a Bukele-like response would keep our country from being paralyzed. We can prevent that happening by producing more, spending more of our money on Belizean products, and foregoing foreign luxury goods.

opportunities, or incentivize Belizeans to create opportunities sufficiently, so that our people are content to remain at home. Our economy is fragile, and struggling, and that's why Belizeans have left our shores, sometimes in droves, to seek a better economic life in the US.

Recent data from the Statistical Institute of Belize (SIB) is that our unemployment situation has never been as good as it is now. But the statistics don't tell the full story of what's on the ground. Many consider the SIB's definition of "employed person" to be overly



Our national symbols tell the world who we are, but it is our culture that reminds *us* of who we always will be.

Culture is not just a driving force of tradition; it is also a compass for navigating the way we take our traditions into the future. As one industry that directly benefits from the preservation of Belizeanism. the Ministry of Tourism and Diaspora Relations (MTDR) actively works to safeguard all aspects of local culture, even as that culture changes to adapt to modern times. For example, last week the MTDR hosted member states of the Mundo Maya Organization at a four-day event in San Ignacio. The Maya, the ancient temples, and their agricultural practices are tied to some of Belize's most ancient cultural inheritances. Una deportación considerable podría provocar una respuesta tipo Bukele

No es decisión nuestra influir sobre quién ocupa los puestos de liderazgo en otros países, pero corresponde a nuestros líderes considerar las implicaciones de las elecciones extranjeras, particularmente aquellas en países que nos impactan directamente. Especialmente porque somos pequeños, nuestros líderes generalmente guardan silencio sobre a quién apoyan, aunque muy a menudo en casa está claro a quién prefieren. Alejándonos de nuestra postura habitual, los actuales líderes de Belize apoyaron abiertamente a la sucesora del presidente AMLO, Claudia Sheinbaum, tal vez porque AMLO, un líder de tendencia izquierdista, ha apoyado más el bienestar económico de Belize que cualquier líder que haya sido presidente en Mexico.

Los líderes de los países grandes no dudan en decir cuál es su posición con respecto al liderazgo de otras naciones. El nuevo primer ministro del Reino Unido, Keir Starmer, del izquierdista Partido Laborista, mantiene una relación cordial con el ex presidente estadounidense, Barack Obama. En marzo de este año, cuando Obama visitó al anterior primer ministro del Reino Unido, Rishi Sunak, del Partido Conservador, para mantener conversaciones informales, Nile Gardiner, en el periódico de derecha *The Telegraph*, dijo en un artículo titulado "Obama no es amigo de Gran Bretaña – Sunak debería invitar a Trump", que fue "una medida imprudente de la Calle Downing antes de las inminentes elecciones presidenciales estadounidenses en noviembre, así como una mala decisión estratégica recibir a un expresidente antibritánico de izquierda".

Es preocupante la promesa hecha al pueblo estadounidense por Donald Trump, del Partido Republicano, de que si gana la presidencia en noviembre, su administración se embarcará en deportar a entre 15 y 20 millones de personas que viven ilegalmente en Estados Unidos. No hay garantía de que Trump se convierta en el próximo presidente, porque hay un rival formidable que compite por la corona, el actual presidente, Joe Biden, del Partido Demócrata. Tampoco hay garantía de que una administración Trump lleve a cabo la mayor deportación masiva de personas de la historia. Algunos expertos dicen que sería imposible ejecutar un programa de este tipo.

En la política no hay garantías. Durante décadas, el Partido Demócrata ha sido visto como menos hostil hacia los inmigrantes indocumentados, todos ellos no blancos, y cuando Estados Unidos tuvo su primer presidente no blanco, Barack Obama, se anticipó que la presión sobre los indocumentados disminuiría. Hay varios aspectos de la historia de la inmigración, pero no es una acusación vacía de que Obama resultó ser el "deportador en jefe". Se afirma que su administración envió a casa a más inmigrantes que cualquier otra en la historia de Estados Unidos.

Nuestro sistema, uno capitalista, nunca ha sido capaz de brindar oportunidades o incentivar a los beliceños a crear oportunidades lo suficiente como para que nuestro pueblo se contente con quedarse en casa. Nuestra economía es frágil y está en dificultades, y es por eso que los beliceños han abandonado nuestras costas, a veces en masa, para buscar una vida económica mejor en Estados Unidos.

Datos recientes del Instituto de Estadística de Belize (SIB en inglés) indican que nuestra situación de desempleo nunca ha sido tan buena como ahora. Pero las estadísticas no cuentan la historia completa de lo que ocurre en el terreno. Muchos consideran que la definición de "persona empleada" del SIB es demasiado amplia y generalizada. Además, siempre ha habido un subempleo considerable en Belize, y un aumento masivo en el precio de los bienes importados ha provocado que más beliceños caigan en esta categoría. Los beliceños dependen excesivamente de los productos extranjeros, especialmente desde que nuestros gobiernos posteriores a la independencia abandonaron el sistema de "economía mixta" y el acceso a la televisión extranjera aumentó nuestro apetito por artículos de lujo. La mayoría de nuestro pueblo ha caído en las filas de los subempleados, con dinero insuficiente o apenas suficiente de nuestros sueldos para comprar lo que necesitamos o percibimos como necesidades. que asumió el cargo durante la pandemia de Covid-19, que una guerra en Europa y un genocidio en Palestina han perturbado aún más la economía del mundo, que se apoderaron de un país enormemente endeudado y que a un par de nuestras agroindustrias centrales no les está yendo bien. Lo que causó nuestro estado económico actual y lo que el gobierno actual ha hecho para mejorar las cosas son importantes, pero sólo para ayudarnos a trazar un camino a seguir. Tal como está en este momento, nuestra economía es incapaz de soportar cualquier shock de cierta gravedad, como el que causaría una deportación masiva de Estados Unidos.

Las personas son el mayor recurso de un país, si tienen un lugar en la economía. Cuando las personas no pueden encontrar un lugar en la economía, se convierten en una carga. Ni un gobierno de Trump ni de Biden enviaría a casa a médicos, ingenieros, técnicos/programadores informáticos u otros beliceños altamente calificados. Ellos caminan por la proverbial alfombra roja y muchos, si no todos, han obtenido la ciudadanía estadounidense. Los estadounidenses buscan aumentar los frutos de su economía, por lo que se aferrarán a aquellos que ayudan a que su economía crezca. Tampoco devolverán a beliceños que hacen los trabajos que los estadounidenses no quieren. Aunque su trabajo no es tan apreciado, sus servicios son esenciales.

Principalmente, enviarían de regreso a nuestra gente cuyos servicios son prescindibles y a aquellos que están involucrados en actividades ilegales. Nuestra mayor preocupación es el regreso de los beliceños que han sido absorbidos por el mundo de los delitos violentos. Los deportados que se habían convertido en criminales abrumaron tanto a El Salvador que la gente aceptó la suspensión de derechos básicos y el encarcelamiento de miles de personas, bajo su presidente, Nayib Bukele. Al lado, en Honduras, el gobierno de la presidenta Xiomara Castro, enfrentado a un problema similar, anunció recientemente planes para construir una gran prisión con capacidad para 20.000 reclusos.

Incluso si no fuera inminente absorber a cientos de deportados, deberíamos estar actuando con urgencia para impulsar nuestra economía. Tenemos que volvernos más productivos. Criar más ganado y venderlo en pie, así como más producción agrícola primaria, son positivos, pero hay que tener en cuenta el aumento de la presión sobre nuestro medio ambiente. Más de dos décadas después de que el turismo de cruceros se convirtiera en "una cosa", todavía nos falta producir un plan para guiar su futuro.

Lo más importante para el crecimiento de nuestra economía es que produzcamos más bienes que se venden en las tiendas de comestibles y que hagamos un esfuerzo consciente para gastar una mayor porción de nuestro dólar en productos fabricados en Belize. Por el bien de la nación, debemos reducir nuestra dependencia de los lujos extranjeros. Nuestros dólares deben gastarse en tacos y *meat pies*, productos de nuestras industrias artesanales, arte local, alimentos y bebidas procesados localmente y las frutas, verduras, carne y pescado frescos producidos por nuestros agricultores y pescadores. Debemos volver a plantar 10.000 árboles cada año, para aumentar nuestra cobertura forestal y así no tener que importar

El gobierno actual podría señalar el hecho de que nuestro país estuvo en recesión durante más de 4 trimestres consecutivos cuando asumió el cargo,

madera. Debemos revisar el sistema cooperativo, combinando nuestro capital, talento y mano de obra para ser más competitivos. Nuestro gobierno debe seguir promoviendo las MIPYMES y debe redistribuir los talentos técnicos a su disposición al servicio de los pequeños empresarios.

Nuestra economía se vería afectada por cualquier deportación importante. Los deportados sin inclinaciones criminales se verían tentados a recurrir al crimen cuando no puedan encontrar oportunidades económicas en su tierra de nacimiento. Incluso ahora tenemos que depender de vez en cuando de las empresas estatales para restablecer el orden cuando hay una escalada de crímenes violentos. Si fuéramos "golpeados" por algunos aviones llenos de deportados, es probable que sólo una respuesta como la de Bukele evitaría que nuestro país quede paralizado. Podemos evitar que eso suceda produciendo más, gastando más de nuestro dinero en productos beliceños y renunciando a los bienes de lujo extranjeros.

In North Amerikkkan Blues, written in 1971, I tried to explain what had happened to me in America to change my perspective on life in the winter of 1967.

Blessed with a university scholarship from the United States Consulate here in 1965, I did my best to stay out of the American socio-political ferment of the time. To me, African Americans have a different perspective on life from Caribbean people, and black people, generally speaking, from other parts of the world. I think African Americans, for various reasons, are American before they are African (or black). I was the only student of color in a Dartmouth College fraternity named Zeta Psi. There was one white "brother" in the fraternity who, I could see, disliked black people, but overall things were pretty cool in Zeta Psi.

One night, however, I woke up, having fallen asleep drunk on the Zete floor/carpet, and I heard my white "brothers" criticizing some African American students who had demonstrated that night against the visit to Dartmouth of George Wallace, the segregationist governor of Alabama who was campaigning for the 1968 presidential nomination of the Democratic Party.

I realized that I had to support my African American brothers who had demonstrated against Wallace, and from there one thing began to lead to another. So that, I ended up basically roots in my life instead of becoming a member of the black bourgeoisie.

From the age of 7, I grew up on West Canal across the street from the family home of the respectable Barrow family, whose patriarch was Ebenezer Oliver Bunting (E. O. B.) Barrow, a highranking civil servant who was grandfather to Dean, Denys, and Denise Barrow, who have become multimillionaire members of Belize's black oligarchy.

But the Southside of Belize City was a strange place up until the 1970s and 1980s, in that roots people lived right next to the black bourgeoisie. So, next to the Barrow family home lived a brother named Godwin Gordon, whom we called "Dino." His common-law was June Stanford, whom I had taught at Belize Technical College in 1968/69, and I believe it was June's family who owned or rented the house where Dino and June lived upstairs.

Anyway, in the 1970s, Dino used to lead me and a couple of my younger brothers to the open space at the Newtown Barracks to play "pick side" football. We walked from Bolton Bridge to Newtown, which had been, historically speaking, a place of recreation for roots black people.

The Belizeans who opposed Right Hon. George Price and the PUP, claimed that he was "Latinizing" the country, and that they, led by the NIP, stood for black Belizeans' interests. But when Mr. Price was finally voted out in 1984, it was not the NIP which replaced the PUP, but a new entity called the UDP, which had been formed in 1973 as an amalgamation of the PDM, the NIP, and a so-called Liberal Party.

And one of the first things the newly empowered UDP did, under the leadership of Hon. Manuel Esquivel, was sell the Newtown Barracks space to the Ramada Hotel group. After that, the PUP, when they returned to power in 1989, grabbed the rest of the Barracks, which had been iconic recreational space for Southside people for many, many decades. The symbolism involved here is stunning. But it is only a few people, like yours truly, who talk about this.

Whatever the case, for maybe five years I've been working on land at a site called Lake Garden just north of Ladyville. It's been a lonely ride, and it is clear that the elitist neighborhood is suspicious of my intentions. I have enough enemies to last a lifetime, so all I have done is try to keep the 7 acres as clean as I can. This week I ran into a brother in Ladyville who used to participate in our "pick side" games on the Barracks. I hadn't seen this roots brother for several decades. We were happy to see each other, and the first person's name he brought up was that of Dino, who had been shot and killed in Los Angeles in the early 1980s. Roots brother and I reminisced about "The Mongolians." The sacred Newtown Barracks Club had stood across the street (Princess Margaret Drive) from the Barracks space, which had featured cricket,



Six hours away from big trouble

The government should pass a law giving it license to commandeer "ALL sturdy hotels and private buildings not used as homes" in coastal areas when there is a threat of a big hurricane. In the fully public domain, by itself the City Center in Belize City could handle 10,000 in a crisis. Mass evacuation is unnecessary when so many safe spaces are about. The private structures should be released from their obligation IMMEDIATELY after the ALL CLEAR is given.

I don't know how far inland the storm surge would be a problem, but people who experienced Hattie could say. Backwater is another issue, a concern, but storm surge is where the terror is. There are hundreds of structures near the coast in Belize that are as much a "fortress" as the Mayan temples. My, my, there's so much irony in life. If some uncaring so-and-so built one of these ugly cement structures in front of your home, you curse them for blocking out your glorious sea breeze, but bless them during hurricanes. Your house could be biscuit, nothing will happen to it if it is buffered by some of these beasts. Well, I might be exaggerating a little.

It's the season for roofers. Noh put no fat guys up there; that job is for wiry people. GoB should make available a little subsidy for people living in coastal areas so everyone sleeping under zinc roofs can get someone up there to secure all zinc sheets that aren't properly stapled down.

Getting to the title of my piece, the meteorologists seem to get better with their predictions every year. They are having some difficulty figuring out why some of these strong winds blow up and become fierce beasts so quickly, but they are on the button with the general course of storms. These individuals are brilliant, but humble, a tremendous combination. Bully, they never play God and tell us exactly where the hurricane will hit. They predicted, rightly, a WNW course for Beryl; but for days before she reached shore in Central America, the cone included, at times, from down south Belize to the north tip of Yucatan.

Please don't ever play like any kind of god with these storms. Just a little wobble can set us up for catastrophe. At 9:00 p.m. on July 4, the Weather Underground hurricane track chart had Beryl at 19.5 N, 84.3 W. At 3:00 in the morning, six hours later, the coordinates were 19.6 N and 85.5 W. Over 6 hours it moved 0.1 degree north (about 7 miles), and 1.2 degrees west (about 83 miles). During that 6-hour period, Beryl was traveling due west, not west by northwest. If she had wobbled to the south during that 6-hour period, by 1 degree, she would have smack dab lined up with Corozal Town.

I congratulate the young lady who was so kind to share her mangoes with everyone, for free. I hope that all who got mangoes from her didn't have money in their pockets to buy from the vendors with their little stalls on the street side. Now, before I go on, yes, I like free mangoes. There, I've established that I'm a sinner too. Whoa there, it is important to know when we are sinning, and when we're not; and when we are, to not brag, feel proud about it. Oh, of course the young lady is a saint in all this. Hopefully, all of us who received tasty fruits are in the saint category too.

Understandably, very few people were happy about tomatoes and hot peppers being sold for some crazy high prices. It happens sometimes in the capitalist system. I guess the people who complained don't know what caused the price of those products to be so high, have no idea how many farmers lost their shirts to make the prices shoot up that way. See, we came through some severe dry, and heat extremes rarely experienced in Belize. Many of those vegetables we love aren't native to Belize. I guess only the farmers who are rich enough to create artificial environments got a crop. Most of our farmers lost big time.

Does anyone say to farmers when the wholesale price of tomatoes goes down to 5 and 10 dollars per bucket, as it does very often around the middle of the year, here Bro, hold this little extra so you can pay for gas to go home? Sometimes we need to check ourselves. Bah, there's a lot of information out there that isn't sinking in. Please, you can't like capitalism when the vegetable is \$5 a bucket, and hate it when it is \$6 a pound. There's a word or term for that.



Griga man dies after motorbike hits dead cow


DANGRIGA, Stann Creek District, Wed. July 10, 2024

After fighting for his life for a little over three days, a Dangriga resident who on Friday, July 5 was thrown to the ground when his motorbike hit a dead cow near Mile 4 on the Southern Highway, passed away due to his injuries.

It is being reported that the cow was killed at around 11:00 p.m. that Friday, when a pickup heading to Dangriga Town hit it while it was

wandering in the middle of the street. The dead cow was reportedly hit again by another pickup truck after it was placed on the opposite side of the road, and it was shortly after that second hit that 26-year-old Lokenver Montero, who was riding a motorcycle, approached and collided with the dead cow. This caused him to lose control of the motorbike, and he was flung onto the pavement.

He suffered head and body injuries and was taken to the Southern Regional

Hospital, where he remained hospitalized until his passing on Tuesday, July 9.

Reports are also indicating that residents of the area had seen the cow wandering alongside the highway some hours before it was hit. Stray animals on the highway, some of which escape from their owners, are a serious hazard, especially at night, as they are at risk of being killed by oncoming vehicles which may also result in the loss of life of the driver and passengers.





The Sleepwalking Defense

If I say, "sleepwalker," does your mind conjure an image from the movies or cartoons of a person walking robotically, arms outstretched, eyes closed, unaware of their surroundings or actions?

Before the rise of the data-based science called sleep medicine, sleepwalking was considered a mysterious phenomenon. Movies, theatre productions, novels, and other fantasy-rich arts played on people's lack of knowledge. The dramatic arts imprinted dramatic images on the general public's minds, leading people to misunderstand and, in criminal cases, attempt to misuse the facts about this rare sleep disorder.

What is called the "sleepwalking defense," is actually a legal argument that a criminal defendant isn't at fault because they acted while in a sleeplike state, without consciousness or intent to

commit a crime. It has proved successful occasionally in the U.S.-one time each in 1846, 1879, 1920—and once in the 20th century in 1987. But as science about sleep and sleep disorders has evolved, the sleepwalking defense has been tossed out of courts around the world.

Godfrey Smith, the attorney for triplemurderer Jared Ranguy, has suggested sleepwalking as the reason Ranguy murdered his stepfather, Robert Vellos; his mother, Karen Skeen Vellos; and his sister, Teena Skeen at the family's home in Ladyville. In March 2024, Ranguy pleaded guilty to the November 2012 murders. To raise a sleepwalking defense is to conjure doubt about Ranguy's intent: Did he intend to kill his family members in cold blood?

What is not being discussed is that the introduction of a sleepwalking defense might impact the judicial system of Belize. If it persists, sleepwalking might be used for any crime in Belize without the proof required in countries where the sleepwalking defense has already been rejected. To fully understand the issues at hand, we must examine the nature of sleep.

When we sleep, our bodies move through three stages. The first, which lasts about ten minutes, occurs right after we fall asleep, and in this stage we can be awakened easily. Next, our muscles relax, and our brains move into slow wave activity. The final stage is deep sleep. It takes us 20-40 minutes to fully enter the third stage of sleep, and although there may be body movement, it's very difficult to wake someone. The body cycles through these stages four to five times each night.

Sleepwalking occurs in stage three. Since the somnambulist (the medical term for a sleepwalker) is in a deep state of sleep, they usually don't respond when spoken to. If they do speak, it's incoherent. In a handful of criminal cases, the sleepwalking defense has been used to argue that a defendant cannot be culpable for his crime.

However, for the defendant to have a valid sleepwalking excuse, the defendant must: 1. Provide evidence, through existing, pre-crime medical records of a history of sleepwalking that involves violent or dangerous acts that are inconsistent with the individual's daytime behavior; 2. Undergo a sleep study in a sleep lab, which is a designated medical space where sleep testing takes place, and this test would have to be conducted during normal sleeping hours; 3. Not have a history of violence or abuse toward the individuals that the defendant has harmed or murdered; and 4. Not have engaged in behaviors during the crime that require conscious intellectual activity such as thinking, reasoning, or remembering.

According to the American Psychological Association's handbook on sleepwalking and criminal behavior, "The current scientific study of the sleepwalker's brain and cognitive

Belize has a culture which seemingly delights in promoting rivalries. You remember when we were in primary school in the 1950s, if two boys had any kind of disagreement, the rest of us would gather around and begin chanting, "Knock out di bomb and touch di man." One of the encircling boys would hold a stone (the "bomb") or some other object, and the rest would urge the "beefing" boys to get it on, so to speak.


When it comes to something like sports, people have different opinions, and this sparks gambling, wherein people will bet on who will win in a boxing bout, football, basketball, and so on.

When we were growing up here in the 1950s and 1960s, the undoubted leader in business was Santiago Castillo, Ltd. Bob Turton had died in 1955; Isaiah Morter had passed in 1923. For sure, Belize Estate and Produce Co. (BEC) was a giant, but it had a foreign flavor to it. San Cas was the Belizean boss.

My late mother told us that her maternal grandfather, George Lindo, had told her that Santiago Castillo, a native of the outskirts of Orange Walk Town, had begun with a small plantain shop in the capital city, at a time when George Lindo himself was pretty wealthy. He owned rum shops, but died broke because of a serious gambling habit.

In the year 2000, the Santiago Castillo group of companies published a magazine history of their businesses, and this is what they said: "Santiago Castillo Limited started as a sole proprietorship import commission business under the ownership of Mr. Santiago Castillo, at the tender age of 19. It grew rapidly until the hurricane of September 10, 1931, which destroyed Belize. Not being insured, Mr. Castillo picked up the pieces and started all over again. His business progressed steadily until the start of World War II in 1939. During the war years, importation became risky business. Merchant ships ran the risk of being torpedoed. Importation halted and the country of Belize quickly suffered a shortage of basic food items. "Mr. Castillo, with

filled with basic food items, destined for Belize. Unable to buy marine insurance because of the war, his risk was compounded. Luckily, his plan worked and was repeated one more time. This catapulted his business to a position of strength and gained him the respect of the business community. In 1959 his business was incorporated under chapter 206 of the laws of Belize as a limited liability company."

One of the reasons for Mr. Castillo's success in Belize City, to most people's minds, was that he, a Mestizo, had a Creole partner by the name of Clive Tucker close to him, and he had prominent Creole employees like Cyril Gibson, Bertie Ellis, Johnny Chessman, Roy Dixon, and so on. So the San Cas company had a lot of credibility amongst the then majority Creole population in the city.

The Bowen group of companies was limited to a lemonade bottling factory named Crystal until they became a franchise of the transnational behemoth, Coca Cola, sometime in the early 1960s. Barry Bowen then spearheaded the creation of the Belize Brewing Company (Belikin), which acquired a development concession from the Government of Belize in 1969.

Challenged by Charger for beer production/distribution in the middle 1970s, Bowen smashed that group, and then began growing rapidly in the 1980s. So that, by the early 1990s, the introduction of television in Belize having destroyed San Cas' profitable Palace and Majestic Theater movie houses, it seemed to outsiders that the Bowen group was challenging the San Cas group for business hegemony in Belize. (Benny's was not yet a player in the game.) The subject of this column came up when my youngest daughter and I were discussing the early stages of World War II, when German submarines (also called U-boats) were wreaking havoc on British merchant shipping in the Atlantic. The United States did not enter the war on Britain's side until 1941, but in 1939 and 1940, the British vitally needed goods shipped from the United States and Canada.

The case of the brazen burglar

BELIZE CITY, Tues. July 9, 2024

Between 8:00 p.m. and 9:00 p.m. on Sunday, July 7, an Apple laptop was stolen under seemingly unbelievable circumstances.

The victim was Roy Davis, 70, a freelance reporter who resides at #9 Corner Seagull Street and Iguana Street.

Davis told *Amandala* that he was sitting on a grey plastic chair in his yard with his back to the door of his concrete bungalow house and facing Iguana Street, when the burglar, whom he believes to be someone from his neighborhood, sneaked up behind him and entered his house without him knowing.

He said he had his laptop, valued at about \$2,000, charging on a small, wooden table, located about 3 feet from the doorway.

The laptop was the only item the burglar was apparently interested in, and he disconnected the charger from it and took it, leaving the charger behind.

Davis said he believes that the burglar left the same way he came—sliding along the side of the house through a path from his yard, using the bushes and some small trees as cover.

Davis was not aware that his laptop was missing until he went to the door of his house and saw, to his surprise, that the laptop was not on the table. He said he was in shock and disbelief, and he wondered who could have been so brazen to have stolen his laptop from "right under my nose". Then it dawned on him that the culprit must be someone who knows him very well and was monitoring his movements that night, hoping for an opportunity to take the laptop.

Davis said he then told a friend of his what had happened, and the friend, who knows a lot about Apple computers, locked it.

Davis then went to the police station and reported the burglary. The police are investigating.

Kidnapping trial for "Danny" Mason and Ryan Rhaburn adjourned

BELIZE CITY, Wed. July 10,2024 The trial of William "Danny" Mason and Ryan Rhaburn, charged with 2 counts of

kidnapping, was to

start yesterday before Justice Francis Cumberbatch at the High Court in Belmopan, but it was adjourned because Mason made an application for a change of venue.

The trial was adjourned until July 18, for the court to hear submissions from the Director of Public Prosecutions, Cheryl Lynn Vidal, who is representing the Crown, and from Senior Counsel Hubert Elrington and attorney Norman Rodriguez, who are representing Mason, and attorneys Ian Gray and Simeon Sampson, who are

representing Rhaburn.

The charges against Mason and Rhaburn are for the kidnapping of Mennonite businessman Lloyd Thiessen and his wife, Rosie, which occurred in May, 2016, at Mason's ranch, located in the vicinity of Mile 31 on the George Price Highway.

According to the allegation against him, Mason and his ranch manager, Rhaburn, kidnapped the couple after a business deal between Mason and Thiessen went sour.

It is alleged that Thiessen gave Mason \$300,000 to import a large quantity of corn into Belize, but the corn was not delivered.

When Thiessen went to Mason to get back his money, he was kidnapped and released later.

Mason, Rhaburn and three others were charged with 2 counts of kidnapping, but charges against the others were withdrawn.

Mason and three of his workers were convicted of the murder of Dangriga pastor Llewellyn Lucas, who was beheaded and his body burnt. They are currently serving life sentences with eligibility for parole after serving 35 years.

"Belize white" families were caught selling fuel to German submarines outside the Barrier Reef. In other words, they were traitors. My stats are that they were treated leniently by the British authorities, in that all that was done to them was that they were quarantined in Jamaica for the rest of the war.

Since San Cas "blew up" in size during and after the war, it always seemed to me that Mr. Castillo himself must have had a special deal with the British. The official San Cas story, as quoted earlier in this column, is that he took risks which worked out well for him. Whatever the case, the British, in the person of Lord Michael Ashcroft, are very, very powerful in Belizean business again. Bowen and Bowen are still very huge, while Benny's has grown rapidly in the last three decades. Then, there are the Chinese and the Indians, about whom I know nothing. Oh, I forgot to mention the Atlantic Bank group of companies, and the oligarchs from down south. Mr. Castillo suffered a series of strokes, beginning in 1976, and died in 1983. His third wife has been running the businesses for some time, but the business landscape in Belize has definitely and dramatically changed. The San Cas group still has a special place in the affections of older Belizeans, but this is no longer a San Cas town.



AMANDALABelize



En *North Amerikkkan Blues*, escrito en 1971, traté de explicar lo que me había sucedido en Estados Unidos para cambiar mi perspectiva de la vida en el invierno de 1967.

Bendecido con una beca universitaria del Consulado de los Estados Unidos aquí en 1965, hice todo lo posible para mantenerme al margen del fermento sociopolítico estadounidense de la época. Para mí, los afroamericanos tienen una perspectiva diferente de la vida a la de los caribeños y a la de los negros, en general, de otras partes del mundo. Creo que los afroamericanos, por diversas razones, son estadounidenses antes que africanos (o negros).

Yo era el único estudiante de color en una fraternidad del Colegio Dartmouth llamada Zeta Psi. Había un "hermano" blanco en la fraternidad a quien, como pude ver, no le gustaban los negros, pero en general las cosas estaban bastante bien en Zeta Psi.

Una noche, sin embargo, me desperté, después de haberme quedado dormido borracho en el suelo/la alfombra de Zete, y oí a mis "hermanos" blancos criticar a unos estudiantes afroamericanos que se habían manifestado esa noche contra la visita a Dartmouth de George Wallace, el gobernador segregacionista de Alabama que estaba haciendo campaña para la nominación presidencial del Partido Demócrata en 1968.

Me di cuenta de que tenía que apoyar a mis hermanos afroamericanos que se habían manifestado contra Wallace, y de ahí una cosa empezó a llevar a la otra. Así que terminé básicamente con perspectiva de la base en mi vida en lugar de convertirme en miembro de la burguesía negra.

Desde los 7 años, crecí en West Canal, frente a la casa familiar de la respetable familia Barrow, cuyo patriarca era Ebenezer Oliver Bunting (E. O. B.) Barrow, un funcionario de alto rango que fue abuelo de Dean, Denys, y Denise Barrow, quienes se han convertido en miembros multimillonarios de la oligarquía negra de Belize.

Pero la Zona Sur de la Ciudad de Belize era un lugar extraño hasta las décadas de 1970 y 1980, en el sentido de que la gente de la base vivía justo al lado de la burguesía negra. Entonces,





Belize awarded BZD\$250 million by MCC

The US-funded private corporation provides time-limited grants to address poverty and promote growth in countries considered financially challenged. The persistent high poverty rates and economic and climate vulnerabilities in Belize put the country in a position to benefit from this funding, called "free money" by PM Briceño.

The two program areas, as mentioned, will address education and energy shortfalls in Belize. According to PM Briceño, 80 percent of the funds will be allocated to education, while the remaining 20% will be allocated to the energy sector.

Prime Minister Briceño shared that the compact program funding will be disbursed over a 5-year period.

Education

In the education sector, the government seeks to increase the number of postprimary graduates. The project will include the establishment of an education quality assurance system to assess and improve the quality of management and teaching within the classroom.

Besides this, other project goals include capacity building for education leadership and teachers; provision of teaching and learning resources, and increased support for primary school graduates to enroll in and complete secondary education programs.

To enhance and build the capacity of the Technical and Vocational Education and Training institutions across the country, a national agency will be established.

Energy

The objective of the energy program under this MCC compact is to lower the cost of energy and reduce reliance on power from Mexico's Comision Federal de Electricidad (CFE).

Recent power outages across the country have raised concerns and questions about Belize's energy security. The government will support BEL and PUC to modernize the grid.

Establishment of implementing agency

As part of the grant, the government

established the Millennium Challenge Account Belize Authority to serve as the implementing agency on behalf of the Government of Belize.

They are expected to sign the compact agreement in early September 2024. All of the funds associated with this grant will be directed through that authority.

PM Briceño said that, besides GoB, representatives relevant to the projects will also be included on the board of directors. This will include a representative from the Belize National Teachers Union, the Belize Chamber of Commerce and Industry, civil society organizations, and a non-voting member representative from academia. There is no seat on the board for a member of the Opposition.

Opposition on MCC grant

For his part, the Leader of the Opposition, Hon. Moses "Shyne" Barrow said that what was to be a moment in bipartisan agreement was used as an opportunity for political grandstanding by the Prime Minister.

He outlined that while the Opposition is in support of the MCC grant program and thanked the United States for the donation, he is concerned that they have no seat on the board laid out by PM Briceño in his speech.

He described the Opposition as a primary stakeholder and explained the importance of including them in the decision-making body.

Minister of Education, Hon. Francis Fonseca pointed out instead, that he believes that it is not necessary to have an Opposition member on the board.

Hon. Patrick Faber, area representative for the Collet Division, said during his comments that the United States has a clearly stated agenda to maintain its position as the world superpower, and this contribution, like other forms of aid, is a part of a larger plan to maintain that superpower status.

The Millennium Challenge Belize Account Authority Bill was passed by the Lower House and now goes to the Senate. Also, read for a third time was the National Security Council Bill.

On June 19, 2017, they were charged with Pastor Lucas' murder which occurred on July 15, 2016, at Mason's farm, located between Miles 30 and 31 on the George Price Highway.

Lucas' decapitated head was found by police in a bucket in the pan of Mason's pickup truck that was parked at Sancho's Bar in Belmopan. The police were investigating a robbery when they stumbled upon Lucas' decapitated head.

All of the appellants were seen coming out of the vehicle.

Further investigation by the police led to the discovery of pieces of burnt bones in a pit at Mason's farm. The police also retrieved telephone records and digital video recordings.

The Crown, represented by the Director of Public Prosecutions, Cheryl

its case. The case for the Crown was based substantially on circumstantial evidence. The category of evidence included direct evidence leading up to the death of Pastor Lucas, electronic evidence, telephone records, video recordings from a surveillance camera, photographs and forensic evidence.

The telephone records showed that the phone calls and text messages were mainly between Lucas and Mason, and that on the day of the murder Mason invited Lucas to come to his house at Intelco Hill in Belmopan for some money.

Lucas' went with two other men in a vehicle to Mason's house and upon their arrival they were blindfolded, bound and gagged and they were taken to Mason's farm. The two men who were with Lucas were released, and only Lucas was kept a prisoner by Mason. wants to drive and contribute to reducing unemployment in our city. Dr. Mario Estradabran, the pathologist, testified that he could not tell the cause of death because he did not have Lucas' body to examine. Mason and Keiron Fernandez gave unsworn statements denying that they had anything to do with the murder. Mason called one witness to testify on his behalf. Keiron Fernandez did not call any witness. The other appellants chose to remain silent.

The Court of Appeal dismissed all of their grounds of appeal.

Castillo and the Fernandez brothers were represented by attorney Aaron Tillett. Vanegas was represented by attorney Norman Rodriguez, while Mason was represented by Senior Counsel Hubert Elrington.

The appeals were heard on March 21. All four, except for Mason, appealed their convictions and sentences. Mason only appealed his conviction.



function has determined that frontal and parietal lobes are profoundly deactivated during sleepwalking episodes while motor areas remain active. (As a result)... sophisticated, cognitive functions such as planning, memory, or social skills should be very limited or absent. Thus, by closely examining the sleepwalker's actions and behaviors, the expert can determine whether witnessed or inferred behavior should or could be possible during an alleged sleepwalking episode, or more likely occurred during wakefulness, alcohol intoxication, or another state of consciousness. If the alleged sleepwalker demonstrates cognitive behaviors possible only during wakefulness, then sleepwalking can be ruled out ...'

Some psychiatrists and psychologists in the U.S., the U.K. and Canada have expressed great concern that the sleepwalking defense could become a get-out-of-jail-free-card no matter the crime. This might be particularly an issue for countries like Belize that lack professional sleep labs and that are without psychiatrists who are board certified in sleep disorders. It's not difficult to find a paid expert to assert that sleepwalking is a "possibility" in a criminal case, thus supporting the "reasonable doubt" that defense attorneys rely on. The American Psychological Association (APA) has repeatedly registered great concerns about the sleepwalking defense: "How is the court to distinguish between the bona fide sleepwalker who involuntarily committed an act that is otherwise criminal, and the individual who voluntarily committed a criminal act and is now using the sleepwalking defense to avoid the legal consequences of his actions? How is a judge to determine who is a sleep expert and what is reliable sleep science?"

is a reliable expert on sleepwalking? As the APA has noted, some who call themselves sleepwalking experts may pull from circumstantial or indirect evidence of sleepwalking and consider stress levels before the incident, prior sleep deprivation, even caffeine use. Other sleep experts might focus on descriptions of the defendant's behavior during a sleepwalking episode as being inconsistent with the current scientific knowledge of sleepwalking. Keep in mind that sleepwalking is a rare disorder, and yet one that some accused individuals attempt to mimic to elude responsibility for their crimes.

Jared Ranguy, the triple murderer, is my cousin by marriage. He murdered my kind-hearted Uncle Robert, who is my mother's brother; Robert's wife, my beloved Aunt Karen; and my beautiful cousin, Teena. Robert, Karen and I, along with Karen's wonderful sister, Marilyn, worked together for more than a decade in a nonprofit that provided free training for Belizean teachers, and free academic summer school programs for Belizean children. Jared helped out a few times, too. And yet, in the many years that our family worked together in these education programs, and during other visits and holidays, no one mentioned a sleepwalking disorder ever occurring in the family. Rising from a bed, walking through a home, and speaking gibberish if spoken to—all of the behavior is so strange, it's hard to imagine that it would never have been mentioned. In addition, Jared has no established medical history of such a disorder. I commend Jared for pleading guilty to the crimes he committed. Now, I can only hope that the Jewel will not suffer from future claims of the sleepwalking defense. Perhaps with a good night's sleep, we will all see the potential harm it could cause.


