



MOHW launches revised Breastfeeding Policy

BELIZE CITY, Mon. Nov. 11, 2024 The Ministry of Health and Wellness (MOHW) officially launched a revised version of its National Breastfeeding Policy 2024-2034 on Monday, November 11.

The official launch replaces the ministry's previous policy which was instituted nearly 30 years ago -28 years to be exact, and promotes breastfeeding on demand by increasing the rate of exclusive breastfeeding for the first six months of a child's life.

"The last time the breastfeeding policy was launched in 1996, it's 28 years too long," said the Minister of Health and Wellness, Hon. Kevin Bernard. "In any developing country, in any country, when you set policies, especially health policies, it should be within 10 years, because it has to be reviewed. As time changes, you need to adapt to certain things; you need to adapt to certain conditions," he added.

"When we look at breastfeeding, we see who is involved in the breastfeeding process. We see nurses; we see nutritionists; we see health educators; we see our directors in terms of advocacy legislation; and we also have our stakeholders and partners. So, it's the entire team here today to do this launch," said Robyn Daly-Faber, Technical Advisor for the Nutrition Unit at the MOHW.

Members of the Ministry of Health and Wellness along with the Pan American Health Organization (PAHO) and United Nations Children's Fund (UNICEF) formulated the policy over three years.

"We were able to develop this new policy. One that is progressive, one that is looking at ensuring that we are reaching our targets," said Minister Bernard.

He additionally highlighted that Belize stands at 33% when it comes to the percentage of children under the age of 6 months old being breastfed with the implementation of the national policy, which is lower than the 50% target the World Health Organization (WHO) set for countries.



Leeroy Bardalez freed of murder charge

Leeroy Bardalez, 26, who was charged with the murder of Nelson "Ricky" Miguel, walked out of the court of Justice Nigel Pilgrim a free man this morning after the Crown, represented by Senior Crown Counsel Sheneiza Smith, entered a *nolle prosequi*, indicating that the Crown would not



education. It will include the human development aspect of our ministry, the Ministry of Health. It will also be our mothers and our children, our fathers, because we need to ensure that from an educational side, people understand that breastfeeding is very critical. It's important for a child's growth," Minister Bernard noted.

According to Daly-Faber, work has been in the pipeline to formalize breastfeeding in the workplace with over 50 different workplaces throughout the country.

"A woman who is breastfeeding goes through a lot, and we advocate and influence employers to support women who are breastfeeding. So, the support can come in different ways. They can have a space; some places have established an entire room for breastfeeding, and other places have allowed a space where, a private space for a woman [where she] can pump her breast; or the child can be brought to the facility; and then we also have other support that, for example having the woman have time off, flexible work schedule. These are all parts of the support that we ask employers to consider when looking at workplace support for breastfeeding women," she said.

Murder in Mango Creek

A man was brutally murdered in southern Belize on Thursday n i ght, November 7.

The victim,

who was stabbed to death, was identified as 28-year-old Selvin Humes, a construction worker from Independence Village.

According to police reports, Humes's lifeless body was found with multiple stab wounds in the village around 9:00 p.m. near Southern Corner restaurant, adjacent to the village's cemetery.

Humes' body was taken to the Independence Poly Clinic where he was pronounced dead, and then transferred to the Southern Regional Hospital, where a post-mortem examination will be conducted. It was reported that the alleged killer, 22-year-old Randell Montero of Independence Village, became enraged when Humes threw some beer on him, and this led to the stabbing.

Police have detained Montero, who was charged with murder on Saturday, November 9.

Some persons in the community have said that Humes was a calm person and a loner; and that he had decided to move out of his aunt's home approximately three weeks ago.

Humes is originally from Belize City, but had relocated to Mango Creek to obtain employment with his uncle.

Man shot and killed in San Pedro

Police currently have in custody a man who is the main suspect in a fatal



proceed to trial.

Justice Pilgrim then told Bardalez that he was free to leave the courtroom. Bardalez walked as far as the corner of Treasury Lane and Regent Street, then he sprinted across Regent Street to freedom.

Miguel, a resident of Dangriga, was shot and killed on the night of September 7, 2020, while he and a woman, Thalia Westby, were in a car parked on Fabers Road in Belize City.

The gunman reportedly fired a barrage of bullets into the car from the driver's side where Miguel was located. Miguel sustained several gunshot wounds



and he died several hours later while receiving treatment at the Karl Heusner Memorial Hospital. Westby was shot in her leg. She was treated and released.

Bardalez had also been charged with attempted murder, but that charge was withdrawn.

Bardalez was represented by attorney Arthur Saldivar. shooting that occurred in San Pedro Town on Friday, November 8.

The shooting took place at Mile 8.6 in the Secret Beach subdivision of the island after 1:00 p.m. When police later went to the scene, they found the lifeless body of Matthew Jonathan Moses, 46, a maintenance worker from the island, and when they observed his body they saw several gunshot wounds. Also present at the crime scene was Samuel Bolanos, 27, a caretaker.

According to police reports, before the fatal shooting occurred, there had been an argument between Moses and Bolanos, which led to Bolanos pulling out a licensed 9mm pistol and firing multiple gunshots which fatally wounded Moses.

Unconfirmed reports are suggesting that the argument between the two men

arose due to an issue with a former employer, and Moses had allegedly threatened to kill Bolanos and his family. Bolanos was detained by police when they arrived at the scene, and his firearm was confiscated along with two magazines. Charges have yet to be levied against Bolanos.

Moses' body will undergo a postmortem examination.





Hon. Habet continued, "Remember that you carry with you the hopes of a nation ... together we are planting the seeds of our progress."

One of those recipients is Doharty Cus from the Belmopan Comprehensive High School, who now wants to study at Galen University in Central Farm.

"I feel relieved because there will be less financial stress," he said.

Adrianni Yanes is another recipient who now wants to go to the University of Belize. "I feel thankful for the opportunity," she said.

Since its founding, PACT has been at the forefront of conservation in Belize. PACT is a statutory organization established as a Trust Fund under the Protected Areas Conservation Trust Act, Chapter 218 of the Laws of Belize, Revised Edition 2020.

Body found near to San

At around 4:00 p.m., Carrillo's lifeless body, which displayed stab wound injuries, was found on the outskirts of his home village.

Authorities from the Orange Walk

District who are investigating what may have happened to cause Carrillo to die suspect that he was placed at the scene and the heinous act was committed elsewhere.

Additional information is that Carrillo was last seen three days ago by his family, but they lost contact with him. However, he was reportedly sighted by several villagers who claimed to have seen him alive as recently as Sunday, November 10.

Two persons who it is believed played a role in the Carrillo's execution are being sought.




The age of misinformation — Fake News

With the explosion of social media in recent years following the internet revolution, the major mass media outlets (radio and television stations) worldwide no longer have a monopoly on the information reaching the ears and minds of citizens worldwide. With Facebook, Instagram, TikTok, and individual podcasts on YouTube, etc., one person can have hundreds, thousands, and even millions of "followers". The genie is out of the box, so to speak, and things will never be the same again, where information to the public is concerned. And whereas previously we all felt that reports from CNN, NBC, BBC, CBS, etc. were gospel, many people are now tuning in to Al Jazeera and following podcasts on YouTube from Democracy Now! as well as reading articles and blogs by a number of independent writers and scholars for information on international issues. And as a nation, it is good for us to become more keenly aware of how information on the global scene could be manipulated for or against us as a people, especially in the light of our approaching destiny with the ICJ. Just like the food we consume could be unhealthy for us, some news sources can be pushing special agendas-thus the need to carefully navigate through them and stay alert to "pick sense from nonsense."

Interestingly, the winner in the recent U.S. presidential election, whom his opponents had labeled a felon and liar, was among the first to draw national attention to the pervasiveness of "fake news", as his defense against the plethora of accusations he faced. While the major mass media touted the election as one of the most hotly contested ones in modern times, the result was decisive. The Republican Trump received in 2024 just over a million more votes (75,581,082) than he did in 2020 (74,223,975) according to Wikipedia; meanwhile his Democrat opponent in 2024, Kamala Harris, whose campaign was heavily financed, received almost ten million fewer votes (71,708,435), than Joe Biden did in 2020 when he won with 81,284,666 votes.

There have been all kinds of explanations from the experts at the major American media houses; but in our old Belizean tradition, it appears that Trump



was not necessarily voted in by American voters, but Harris (Biden) was voted out. The question is why.

After being relieved of the burden of the aging Biden and his unpopular "iron clad" stance on the genocide in Gaza, and following his disastrous debate with Trump, there was some relief and new energy inside the Democrats' campaign behind new presidential candidate Kamala Harris; but the wind was soon knocked out of their sails, when she committed to maintain Biden's "iron clad" stance, and frustration disintegrated into despair at their national convention when, despite protests, not a single pro-Palestinian speaker was allowed on stage, and the angry backlash was unleashed on November 5. If the Democrats were

listening to the major mass media in the U.S., it is understandable how they could have been fooled. Social media was on fire with the pain and anger of the American voters (many of whom were struggling to make ends meet) against the repeated announcements of billions being sent to Israel to bomb the helpless Palestinians, billions that represented their tax dollars, to kill thousands of innocent children and women and elderly in Gaza, even while the rest of the world and the United Nations condemned the genocide. Talk about the economy, and abortion, and

climate change all they want; the student demonstrations on university campuses across the U.S. were real, and their repression by the police was reminiscent of the 1960's anti-war fever against the U.S. involvement in Vietnam. The election result therefore seems to indicate a protest vote from those Democrat voters who could not bring themselves to vote for Harris (Biden), but would not vote for Trump.

The reality is that, as activist/educator Sandra Coye said on Krem WUB this morning, people all over the world are fed up with political leadership. And that might be a factor to consider at home, where, in the absence of a credible Opposition at this time, our current PUP government might be tempted toward complacency, and to ride roughshod over all dissident voices. Despite a supermajority in the House, and a string of landslide election victories in village council and town board elections, they may recall that elections in Belize have often been characterized by a focus on the office holders, and voters decide to put them back in, or vote them out, whatever be the credentials or competencies of the replacements. In that light, it is heartening to note that our government seems to be giving pause to acknowledge and value the input and opinions of voices from the community: case in point, responding to the protest from the hospital workers union to have their representative replaced on the board of the KHMH. Every voice counts, and it may be a sign of political maturity and good stewardship that they seem not inclined to make the mistake of taking silence from the electorate to mean enthusiastic support.

For those still not convinced of this very real phenomenon called "fake news" or twisted information, a very good case just occurred a couple days ago in Amsterdam, where some major news sources chose to wrap the facts completely with an Israeli bias, while others looked at the whole picture with greater balance, and fairness to the Palestinians.

It is relevant to us in Belize, because our story might one day be in the news.

The problem of fan hooliganism at football matches has long been a concern in Europe, but the media treatment of the recent Amsterdam incident is a revelation. Notably, nobody was killed.

Belizeans, read for yourself, and pick sense from nonsense. And remember the backdrop of this incident: daily bombings and killings in Gaza, while hundreds of Israeli fans traveled by airplane to Amsterdam to support their football team in a town with many resident and grieving Arab Palestinians.

La era de la desinformación **Noticias falsas**

Con la explosión de las redes sociales en los últimos años tras la revolución de Internet, los principales medios de comunicación masivos (estaciones de radio y televisión) de todo el mundo ya no tienen el monopolio de la información que llega a los oídos y las mentes de los ciudadanos de todo el mundo. Con Facebook, Instagram, TikTok y podcasts individuales en YouTube, etc., una persona puede tener cientos, miles e incluso millones de "seguidores". El genio ha salido de la caja, por así decirlo, y las cosas nunca volverán a ser lo mismo en lo que respecta a la información al público. Y mientras que antes todos creíamos que los informes de CNN, NBC, BBC, CBS, etc. eran la palabra de Dios, muchas personas ahora sintonizan Al Jazeera y siguen podcasts en YouTube de Democracy Now!, además de leer artículos y blogs de varios escritores y académicos independientes para obtener información sobre cuestiones internacionales. Y como nación, es bueno que nos volvamos más conscientes de cómo la información en la escena global podría ser manipulada a favor o en contra de nosotros como pueblo, especialmente a la luz de nuestro destino que se avecina con la CIJ. Al igual que la comida que consumimos puede ser insalubre para nosotros, algunas fuentes de noticias pueden estar impulsando agendas especiales, de ahí la necesidad de navegar con cuidado a través de ellas y estar alertos para "separar el sentido del disparate".

Curiosamente, el ganador de las recientes elecciones presidenciales de Estados Unidos, a quien sus oponentes habían tachado de delincuente y mentiroso, fue uno de los primeros en atraer la atención nacional hacia la omnipresencia de las "noticias falsas", como su defensa contra la plétora de acusaciones que enfrentó. Si bien los principales medios de comunicación promocionaron la elección como una de las más reñidas de los tiempos modernos, el resultado fue decisivo. El republicano Trump recibió en 2024 poco más de un millón de votos más (75.581.082) de los que recibió en 2020 (74.223.975) según Wikipedia; Mientras tanto, su oponente demócrata en 2024, Kamala Harris, cuya campaña fue fuertemente financiada, recibió casi diez millones de votos menos (71.708.435) que Joe Biden en 2020, cuando ganó con 81.284.666 votos.

Ha habido todo tipo de explicaciones por parte de los expertos de los principales medios de comunicación estadounidenses; pero en nuestra vieja tradición beliceña, parece que Trump no fue necesariamente elegido por los votantes estadounidenses, sino que Harris (Biden) fue expulsada. La pregunta es por qué.

In March of 1961, the colony of British Honduras held its first national election under a new Ministerial constitution. (British Honduras became self-governing in 1964.) The People's United Party (PUP) won all 18 seats in the new House of Representatives.

Ever since then, this country has practiced a form of parliamentary democracy which is bastardized, so to speak. For parliamentary democracy to be perfected, again so to speak, the persons in the Cabinet, or executive section of the democracy, must be fewer in number than the non-Cabinet members of the House of Representatives, who constitute what we call the legislature.

Even when the margin of the ruling party's majority is very narrow, such as the PUP's 16-14 majority in 1989 and the United Democratic Party's (UDP) 16-13 majority in 1993, the Prime Ministers of Belize have always made sure that no alliance of the non-Cabinet area representatives can take place with the Opposition area representatives to outnumber the Cabinet, in order to reject any piece of legislation and send it back to Cabinet. In other words, there has never been a functional group of so-called backbenchers in the Belize House of Representatives.

At the beginning of the 1998 PUP government, there was a reform movement amongst influential and informed Belizeans which was pushing for an elected Senate. Strictly speaking, such an elected Senate was to have the power to reject a bill and send it back to the House.

Such an elected Senate was never introduced into Belize, but at some point a Senate system was established wherein the ruling party appointed the majority of a Senate, but the Opposition party's appointments could cast a majority vote with the support of the Senators appointed by the churches, the unions, the Chamber of Commerce, and the Non-Government Organizations (NGO's).

Personally, I have never paid a great deal of attention to the shenanigans involving the discussions about the Senate initiative. I feel that I have been negligent on this score, and my excuse was that the important thing was always to embrace the righteous backbencher aspect of the parliamentary democracy system.

So that, I had to do some consultation before writing this column, because I thought I had heard somewhere that the present Senate, comprised of 13 Belizeans, has in fact sent back a bill to the present House, <u>not</u> to the Cabinet. (The present Senate includes 6 PUP-appointed Senators, 3 UDP-appointed Senators, and Senators from the churches, the unions, the Chamber, and the NGO's.)

The key thing is that our present Senate cannot send a financial bill back to the House. Now then, it <u>is</u> the case that government (political power) is all about money, or the power of taxation over the citizenry. If you can't question the money, then you are more cosmetic than powerful. That is why the backbencher system would be more of a check upon the Cabinet. Or, at least, that is what I believe.

The parliamentary system we have in Belize came from the British, who developed it in the first half of the seventeenth century. In Great Britain, the parliament became so powerful that they beheaded a king in 1649. Kings and queens had ruled Britain for centuries, but today the king is only a figurehead. The power in Britain rests in the House of Commons and its Prime Minister, but the backbencher system is in place so that the Prime Minister and his Cabinet can be checked.

In Belize today, not only has there never been a backbencher system in place, but presently there is absolute chaos amongst the five elected Opposition area representatives. One UDP area rep has never attended a House meeting since being elected four years ago, and there are two UDP area reps who are quarrelling for leadership on a public stage. At this point, not only does Belize not possess the important backbencher system, but we also do not have a really functional Opposition.


The upshot of this situation is that Belize cannot be considered a parliamentary democracy. You may even say that it never was, a parliamentary democracy, that is, because there have never been backbenchers. But today, November 11, 2024, we do not have an organized, cohesive Opposition, so all we have is a lot of noise in the broadcast and social media.

This is not good. Somewhere, it is said, there are people who are supposed to be preparing a new constitution for Belize. Interesting, beloved, interesting.



"Fonto King" found dead in Griga

DANGRIGA, Stann Creek District, Mon. Nov. 11, 2024

The lifeless body of a man was found floating in a body of water in the Riverside area of Dangriga Town on Friday, November 8. The deceased has been identified as 35-year-old Guillermo Martinez of Dangriga Town, who was known as "Fonto King," because he made a living selling tobacco leaf.

According to reports, authorities found Martinez's decomposing body floating in the sea after 7:30 a.m. in a face-down position between two fishing boats along the river bank.

Unconfirmed reports suggest that Martinez's body had its left hand detached from the elbow down, and his right foot had three bullet holes. ACP Hilberto Romero, Regional Commander for the Belize Police Department's Eastern Division, did not confirm those reports when asked by reporters.

Members of the community mentioned that Martinez didn't socialize much, and have no idea who wanted him dead. However, he had a rap sheet to his name. On November 1st he was released from the Belize Central Prison after spending a year



in jail for a theft charge.

Apart from his latest conviction, Martinez had been charged for the murder of a Honduran national living in Dangriga Town in 2009, but was acquitted of the charge in 2014.

ACP Romero mentioned that Martinez's body is awaiting a postmortem examination to determine the exact cause of death.

Martinez was reportedly last seen in the community five days before his death.

at the location around 11:30 p.m., destroying the two-story wooden structure that stood there for over two decades.

"The older the building the faster it burns. Remember, fire doesn't wait on anyone; it consumes very fast," said Gladstone Bucknor, Station Supervisor of the National Fire Service.

Bucknor told reporters that the structure was without electricity, thus the theory of electrical failure was excluded. Nonetheless, no concrete evidence has yet been established by those investigating the blaze.

"At this moment, we have a slight idea, but it's still under investigation to determine the [cause of the] fire ... It seems to me [the fire] may have started in the center of the building," Bucknor said.

Residents in the area applauded the

fire service's quick response, and fortunately they were on the scene quickly because there were two butane gas [tanks] inside the charred structure, which if they had blown up would have caused an even more dire situation.

"We always inform the public: Please do not have your butane tank inside the building; it belongs outside. Having it inside poses a threat when it has a leak and causes worse damages than what you can think about," Bucknor mentioned.

Bucknor noted that the lower flat of the structure was occupied by two persons, but neither was present when the fire occurred. Information to *Amandala* indicates that said persons were tasked to protect the home from being vandalized.

The building was not insured, and the estimated cost of damages is yet to be established, explained Bucknor.

has transformed Japan Day into a beloved cultural bridge between Belize and Japan.

races on the ground here. Second, it's about people trying to win money to support their programs; and first, it's about selling how much more advanced their hocus pocus is than witchcraft. Governor General honoring fallen veterans on Rememberance Day

The poppy became a symbol of Remembrance Day due to its prominence on the battlefields of World War I. After the devastation of war, the once beautiful fields of Flanders were scarred by artillery and bloodshed. But in the spring of 1915, the bright red poppies began to bloom amidst the destruction. This sight deeply moved Lieutenant Colonel John McCrae, a Canadian physician, who penned the famous poem, "In Flanders Fields", as a tribute to fallen soldiers. The imagery of the resilient poppy flower growing amid the horrors of war resonated with many, and soon the poppy became a symbol of sacrifice and remembrance.

In 1921, the Royal British Legion in the UK began selling poppies to raise funds for veterans and their families. This initiative quickly spread across the

Nunca se introdujo en Belize un Senado electo de ese tipo, pero en algún momento se estableció un sistema de Senado en el que el partido gobernante designaba a la mayoría del Senado, pero los nombramientos del partido de la oposición podían emitir un voto mayoritario con el apoyo de los senadores designados por las iglesias, los sindicatos, la Cámara de Comercio y las Organizaciones No Gubernamentales (ONG).

Personalmente, nunca he prestado mucha atención a las artimañas que implicaron las discusiones sobre la iniciativa del Senado. Siento que he sido negligente en este aspecto, y mi excusa fue que lo importante siempre fue abrazar el aspecto justo de diputado ordinario del sistema de democracia parlamentaria.

Así que, tuve que hacer algunas consultas antes de escribir esta columna, porque pensé que había escuchado en alguna parte que el Senado actual, compuesto por 13 beliceños, de hecho ha enviado un proyecto de ley a la Cámara actual, no al Gabinete. (El Senado actual incluye 6 senadores designados por el PUP, 3 senadores designados por el UDP y senadores de las iglesias, los sindicatos, la Cámara y las ONG). La clave es que nuestro Senado actual no puede enviar un proyecto de ley financiera de vuelta a la Cámara. Ahora bien, es el caso de que el gobierno (el poder político) se trata todo acerca del dinero, o el poder de los impuestos sobre la ciudadanía. Si no se puede cuestionar el dinero, entonces es más cosmético que poderoso. Es por eso que el sistema de diputados de segunda línea sería más un control sobre el Gabinete. O, al menos, eso es lo que creo.

El sistema parlamentario que tenemos en Belize proviene de los británicos, quienes lo desarrollaron en la primera mitad del siglo XVII. En Gran Bretaña, el parlamento se volvió tan poderoso que decapitaron a un rey en 1649. Reyes y reinas habían gobernado Gran Bretaña durante siglos, pero hoy el rey es solo una figura decorativa. El poder en Gran Bretaña reside en la Cámara de los Comunes y su Primer Ministro, pero el sistema de diputados de segunda línea está en su lugar para que el Primer Ministro y su Gabinete puedan ser controlados.

En Belize hoy, no solo nunca ha habido un sistema de parlamentarios ordinarios, sino que actualmente hay un caos absoluto entre los cinco representantes de área electos de la oposición. Una representante de área del UDP nunca ha asistido a una reunión de la Cámara desde que fue elegida hace cuatro años, y hay dos representantes de área del UDP que se pelean por el liderazgo en un escenario público. En este punto, Belize no solo no posee el importante sistema de parlamentarios ordinarios, sino que tampoco tenemos una oposición realmente funcional. El resultado de esta situación es que Belize no puede considerarse una democracia parlamentaria. Incluso se puede decir que nunca lo fue, es decir, una democracia parlamentaria, porque nunca ha habido parlamentarios ordinarios. Pero hoy, 11 de noviembre de 2024, no tenemos una oposición organizada y cohesionada, por lo que todo lo que tenemos es mucho ruido en los medios de comunicación y las redes sociales. Esto no es bueno. En algún lugar, se dice, hay gente que se supone que está preparando una nueva constitución para Belize. Interesante, queridos, interesante.

Commonwealth, becoming an annual tradition on Remembrance Day. The red poppy, with its striking color, became synonymous with the act of remembering the fallen soldiers.

Although Belize is far from the European battlefields, the tradition of wearing a poppy on Remembrance Day has taken root in the country, as it has in many parts of the Commonwealth. Belize, a former British colony, shares a deep connection with the United Kingdom's military history, and many Belizeans served in both World Wars, including the British West Indies Regiment.

The Remembrance Day Ceremony in Belize was held on Sunday, November 10, 2024, at Memorial Park in Belize City, where citizens gathered to honor the fallen soldiers who served the nation. The official

wreath-laying ceremony took place Monday, on November 11, 2024, at Price Barracks, the Belize Defense Force compound in Ladyville, Belize. Both events marked a solemn tribute to the sacrifices made by military personnel in defense of the country.

The Belize Ex-Services League is a

non-profit, non-political, and nongovernmental organization, founded by World War II veterans. Established in 1961, the League is governed by a legally binding Act, and operates with the mission of supporting veterans and preserving their legacy.

Approximately 1,500 men from across Belize served during World War II, including members of the British Honduras Forestry Unit and the North Caribbean Force. A small group of women from the British Honduras Red Cross Society also served during the war, contributing to the collective effort.

According to Valerie Richardson, J.P., of the Belize Ex-Services League, a few widows remain alive today, with one World War II veteran having celebrated his 100th birthday this past February. The widows receiving assistance from the League are typically around 94 years old. The funds raised through the sale of poppies play a critical role in supporting the League's work, particularly in covering the burial expenses of veterans and widows in urgent need, as the League does not receive funding for such services.

In addition to World War II veterans, the League also includes members from other branches of service, such as the British Honduras Volunteer Guard, the Belize Police Force, and the Belize Defence Force (BDF). Despite the passing of many veterans, the League remains steadfast in its commitment to honoring their memory.

Richardson also highlighted the support the League receives from key benefactors, such as the Royal Canadian Legion, which provides poppies, wristbands, and poppy trays, and the Royal Commonwealth Ex-

Services League, which offers assistance to benefit both veterans and widows. The League also engages in fundraising efforts to cover monthly administrative expenses.

It is important to note that the correct name of the organization is the "Belize Ex-Services League," as it encompasses both male and female veterans. The League is not an extension of the Belize Defence Force (BDF), but an independent organization dedicated to supporting all veterans who have served in various military and auxiliary roles.

As a small, tightly-knit community, the impact of these commemorations is profound in Belize. They serve as a reminder of the global interconnectedness of wartime sacrifice and the shared duty of remembrance. The poppy remains an enduring symbol that transcends borders, reminding us all of the price of peace and the courage of those who gave their lives for it.

Parliament members attend conference in Australia



This year's conference was one of the largest gatherings of Commonwealth parliamentarians, with over 700 decisionmakers and parliamentary staff from across the world. It was hosted by the Parliament of New South Wales and the CPA New South Wales Branch, and provided an opportunity for the delegates to engage in discussions that will help shape more inclusive and sustainable legislative practices in Belize.

The CPC gave attendees an opportunity to collaborate among themselves on serious issues such as gender equality, disability inclusion, and stronger democratic institutions.

The conference actually consisted of a number of meetings and subconferences, which included the 40th CPA Small Branches Conference, during which Hon. Woods was elected as its chairperson and will serve a three-year term; the 8th CPA Commonwealth Women's Parliament (CWP) Conference; Meetings of the Commonwealth Parliamentarians with Disabilities (CPWD), the CPA Executive Committee, and the CPA Interim Executive Board; the 67th CPA General Assembly; and the 58th Society of Clerks at the Table (SOCATT) meeting.

The Belize delegation's participation in the CPC aligns with the country's commitment to strengthening democracy and parliamentary engagement on both a national and global scale.

They are scheduled to return to Belize on Saturday, November 9.

Senate passes 6 Bills at Special Sitting


The Movable Property Security Rights Bill is intended to allow small, micro and medium enterprises easier access to finances to grow their business by enabling them to use their movable assets and equipment as collateral for loans to invest, according to the Prime Minister when he introduced the Bill in September. However, Senator Hon. Denfield Dennison was skeptical of the true intent of the Bill, arguing that it may create loopholes in the law for unscrupulous individuals to register movable items of questionable provenance as assets.

The Senate passed amendments to the Customs and Excise Act, the Misuse of Drugs Act, and the Criminal Records Rehabilitation Act to repeal the expungement of convictions for first time criminal offenders, to close a loophole in the law which was being exploited by repeat offenders.

The Senate also approved a Finance Belize Recognition Bill, and the Global Fund Privileges and Immunities Bill, which drew derision from the Opposition Senator, Hon. Michael Peyrefitte. He challenged that the Privileges and Immunities Bill would create a group of people who would be above the law. He also suggested, concerning the bill to create a non-profit private organization to promote investment in Belize, that in effect it would be duplicating the function of BELTRAIDE and other departments of the Ministries of Foreign Trade and Finance, and thus was not really needed.

Peyrefitte dissected the Supplementary Appropriations Bill for the fiscal year ending March 31, 2025, which he said seemed to betray a lack of proper budgetary planning by the government when it first presented its budget for this fiscal year in March. Senator Peyrefitte noted that the Supplementary budget was almost 10 percent of what was approved in March,

that the Ministry of Finance budgeted \$4.5 million in March for the entire year, and has now come back to request an additional \$6.1 million to finance operations for the next four months left in the fiscal year. The Office of the Prime Minister had budgeted for \$1.9 million in March for the entire year, but is now requesting \$.2 million more. The Ministry of Immigration had budgeted for \$750,000 for the year, but is now requesting \$1.9 million more. The Constitutional Review Project began the year with a \$500,000 budget, but is now requesting \$500,000 more. The Ministry of Agriculture and Food Security had budgeted \$220,000 for the entire year, but is now requesting \$3.2 million for the remaining four months. Land Acquisitions had been budgeted at \$21 million, but now the government is requesting an additional \$9 million to pay for acquisitions. The Ministry of Sustainable Development and Climate Change had begun the fiscal year with



a budget of \$534,000, but is now requesting \$961,000 more for the remaining four months.

The Ministry of Infrastructure Development and Housing had budgeted \$5.1 million under Cap. II for this year, but now is requesting \$13.7 million more. In March, MIDH had only budgeted \$127,000 to pave the San Estevan road, when it is well recognized that it costs \$1 million per mile to build a good road. Now MIDH is asking for \$3



million more for the project.

Similarly, the Ministry of Rural Transformation and Community Development began the year with a budget of \$200,000, but is now requesting \$8.4 million more! Some \$3.0 million was budgeted for Groceries and Food Assistance to the needy, but now an additional \$2.5 million has been requested. One million dollars was budgeted for capital subscriptions to international financial institutions, but now the government is asking for \$2.02 million more for these payments. Peyrefitte suggested that all these adjustments betray a lack of proper planning and would seem to indicate that the Prime Minister, who is also the Minister of Finance, does not know how to manage finances.

Senator Hon. Mark O'Brien also questioned the lack of planning evidenced by the request for a supplementary \$106 million to the government's budget for this year, that \$43 million was budgeted for Cap. II projects but now needs another \$55 million. He asked the government senators to explain the reason for the unexpected spending spree, and said it demonstrates poor, poor planning.

Managing the country's debt has always been a top priority for the New PUP government since it took office, Minister of State for Finance, Senator Hon. Chris Coye argued, and the government's prudent fiscal



management has brought down the ratio of debt to Gross Domestic Product, and these policies have achieved a fiscal surplus. Some \$20 million of the supplementary budget is money from grants, from Taiwan and other international funding agencies. He explained that the appropriations bill was, in effect, the government asking the people's permission to spend this money, but this is only an estimate and not what will actually be spent. Often as not, the ministries do not spend the full amount approved in the budget.

By comparison with previous supplementary budgets, in 2020-21 the supplementary was 13 percent of the budget. In 2021-22 it was 16.5 percent of the budget, in 2022-23 it was 17.8 percent, in 2023-24 the supplementary was only 10 percent of the March budget, and this year is the smallest supplementary, only 6.6 percent of the original March budget.

The investments in infrastructure and roads have become necessary as a result of recent but unexpected weather events, Coye explained, something no one could have foreseen. The increase in agricultural spending is for fertilizer to support the citrus and sugar cane industries, and a \$1 million is needed to fight the new threat of New World Screwworm, which poses a serious danger to the cattle industry. This pest is already detected in Guatemala, and the threat alone is endangering Belize's export market for cattle to Mexico.



Belize buys catastrophe insurance against natural disasters, but with the increase in violent storms, the increased risk has driven up the insurance premiums. So, the government has to pay more to the financial institutions that offer this risk insurance. Payments for land acquisitions are also to settle court judgments of past land acquisitions of past administrations, even before the past UDP administration.

RE: US authorities probe text messages invoking enslavement of Black people

US authorities probe text messages invoking enslavement of Black people

Texts telling recipients to go to 'nearest plantation' prompt alarm across US states.

Authorities in the United States are investigating reports of Black people across the country receiving text messages invoking slavery following Donald Trump's victory in the presidential election.

The racist text messages have been reported by people in more than a dozen US states, including California, Pennsylvania, New Jersey, Michigan, North Carolina, Virginia and Alabama.


The wording of the messages varies, but follows the same basic script of telling the recipient they have been "selected to pick cotton at the nearest plantation", according to local news reports and social media posts. contact with the Justice Department and other federal authorities.

"As always, we encourage members of the public to report threats of physical violence to local law enforcement authorities," the agency said in a statement.

The Federal Communications Commission said it was investigating the texts in conjunction with federal and state law enforcement.

Attorneys general in a number of states also confirmed that they were looking into the matter.

"These messages are horrific, unacceptable, and will not be tolerated," Maryland Attorney General Anthony Brown said.

Some of the texts were labelled as coming from a "Trump supporter" or included the hashtag, #MAGA.

Frances Carmona, a Native American woman in Grand Rapids, Michigan, told local media that her 15-year-old niece had received one of the messages, which said she should be ready to be "searched and patted down once inside of the plantation".

"Upset is an understatement," Carmona was quoted as saying by NBC affiliate WOOD-TV.

"I don't know what's happening. I knew things were going to happen after the election, but not the day after. You know, it is kind of scary. It's frightening."

The FBI said on Thursday it was aware of the messages and was in

"If you have been sent one of these texts, I am asking for you to please come forward and report it. I am committed to protecting the rights of all Marylanders. There is no home for hate in Maryland."

The NAACP, one of the largest Black civil rights organizations in the US, condemned the messages.

"The threat – and the mention of slavery in 2024 – is not only deeply disturbing, but perpetuates a legacy of evil that dates back to before the Jim Crow era, and now seeks to prevent Black Americans from enjoying the same freedom to pursue life, liberty, and happiness," NAACP president and CEO Derrick Johnson said.

"These actions are not normal. And we refuse to let them be normalized."

The Southern Poverty Law Center (SPLC), another civil rights organization, also expressed condemnation, describing the messages as a "public spectacle of hatred and racism that makes a mockery of our civil rights history".

"Leaders at all levels must condemn anti-Black racism, in any form, whenever we see it – and we must follow our words with actions that advance racial justice and build an inclusive democracy where every person feels safe and welcome in their community," Margaret Huang, SPLC president and CEO, said in a statement.

About one-fifth of the hate crimes reported in major US cities in 2022 were targeted against Black people, according to police data analyzed by the Center for the Study of Hate and Extremism at California State University San Bernardino.
