

Belize ends child marriage

Marriage Act amended – legal age raised from 16 to 18 years - at special sitting of House of Representatives

Belize has raised the legal age for marriage from 16 years to 18 years, by an amendment to the Marriage Act which the House of Representatives passed with bipartisan support at a special sitting at the George Price Center in Belmopan on Tuesday morning, November 12.

The Youth Parliament had voted unanimously to raise the legal age for marriage to 18 in November 2023, and the National Committee for Families and Children, the National Women's Commission and the churches continued to advocate for the law to be changed at a public forum at the Princess Hotel in August of this year. They argued that raising the legal age would help to break the cycle of poverty,







Nah evidence still not received

On Wednesday, November 13, former police officer, 40-year-old Elmer Nah, returned to the High Court in Belize City, where he is being tried for the infamous triple murder of Jon and David Ramnarace and Jon's wife, Vivian, that occurred in Belmopan on New Year's Eve (December 31) in 2022.

The victims had been reportedly socializing at Jon's and Vivian's home in the Maya Mopan area in Belmopan when a gunman believed to be Nah entered the couple's yard and fatally shot the siblings – Jon and David Ramnarace – and injured Jon's wife, Vivian, who died 15 days later due to a pulmonary embolism resulting from a blood clot, which led as well to heart failure.

Since the incident occurred, Nah has been charged with three counts of murder, one count of attempted murder, and one count of use of deadly means of harm.

Nah last appeared in court on Thursday, October 18, when his attorney, Senior Counsel Godfrey Smith, said he had received assistance from a forensic firm in Los Angeles, California, to review the crucial video footage of the shooting to prove that his client wasn't the shooter.

Nah made another court appearance on Wednesday, November 13, but virtually, before Justice Nigel Pilgrim, who noted that all parties were to file their applications by November 1.

However, the prosecution didn't meet the deadline, causing Smith to list several items that were requested for evidence, which included Nah's cellphone, a

flashlight, a headlight, an SD card, body cam footage, and video recordings from the night of the murder, which allegedly were to be provided by the US Embassy, after being sent for enhancement.

When questioned by Justice Pilgrim, the prosecutor indicated that the requested items are still being reviewed, which is causing delays.

"We have been trying to get a list of crucial matters, access to them, from the Crown, the state, and have not been successful in doing so," Smith told reporters. "He [Justice Pilgrim] was not impressed with the Crown's responses and explanations as to why the defense has not been so provided, and he set a further date," he added.

November 29 is the new deadline for the Crown to submit the requested items.

Nah is expected to return to court on December 16.

Man walks free after robbery charge

BELIZE CITY, Thurs. Nov. 14, 2024 Tonight, one of three men believed to have carried out an armed robbery six years ago - at Premium Wines & Spirits located on Newtown Barracks, escaping with almost \$60,000 value in cash and personal items belonging to employees and the company - is a free man.

The case of the Crown for the DPP did not go down without a fight; however, the prosecutor's application for his fearful witness to not have to come to court to testify, was not allowed by the judge; and so, the DPP's office was forced to enter a nolle prosequi in the case of Everald Sambula, 24.

On September 7, 2018, Sambula and others were accused of committing the big heist; however, only Sambula was arrested and charged criminally.

This week, the case was called up for trial before a jury of nine - 5 men and 4 women, but before the case could be put to the jury of 9, the DPP made his application because of a fearful witness who did not wish to come to court.

When the judge, Justice Candace Nanton heard the application, which was done in camera and not before the jurors, she ruled against the Crown's application and ordered that the witness must appear in court.

In light of having a fearful witness who already expressed fear of testifying in court, the Crown, at 9:30 this morning, discontinued the case against Sambula,



and he was free to go.

Sambula had been charged and indicted on five counts of robbery:

Count 1 was for robbing Noel Hyde of \$34,000 Belize currency and \$6,300.00 US currency, property of Premium Wines & Spirits; Count 2 was for the sum of \$6,400.00 robbed from Celeny Romero, property of Premium Wines & Spirits; Count 3 was for a black Motorola cellular phone value \$450 and \$120 in cash robbed from Noel Hyde; Count 4 for robbery was for robbing from Maria Price, a gold Samsung Galaxy S7 cellphone value \$1,900.00 and


Paul Smith, Jr., freed of murder charge after nolle prosequi submission

BELIZE CITY, Wed. Nov. 13, 2024 Paul Smith, Jr., 20, who was charged with the murder of Tyreak Dwight August, 19, was freed of the charge when a nolle prosequi submission was entered, indicating that the Crown did not wish to proceed to trial.

The nolle prosequi was entered by Crown Counsel Shanell Fernandez due to insufficient evidence.

A nolle prosequi submission is not an acquittal. Smith could be rearrested and charged for August's murder if the Crown obtains more evidence that could

ones responsible for the death of 48year-old Julio Carrillo, a resident of San Lazaro Village, Orange Walk District.

In Tuesday's edition of *Amandala*, it was reported that on Monday, November 11, Carrillo's lifeless body was found by two minors who had gone swimming on the outskirts of the village.

Carrillo's body displayed stab wound injuries and was already decomposing.

It was reported that the deceased was last seen by his family three days before the gruesome discovery, at which time he had mentioned to relatives that he was going to Orange Walk Town and said that he would return home that day, but he never did.

It was believed that Carrillo's killers were known to him, men he would hang out with and consume alcohol.

In previous reports, two persons were being sought by authorities, and tonight two men were captured and they have been charged jointly with the crime of murder, 47-year-old Iran Moguel, a farm worker, and 24-yearold Emanuel Carrillo, a cane farmer.

be the basis for a conviction.

However, although Smith no longer has the murder charge hanging over his head, he is still an inmate of the Belize Central Prison because he is still facing firearm and ammunition charges for which trial is pending.

His attorney, Ronell Gonzalez, will be seeking bail for him from the High Court on Friday, November 15. Smith was on bail for the firearm and ammunition offences, but his bail was revoked when he was charged for other offences.

Before Smith left the courtroom, Justice Derick Sylvester gave him some advice. He told Smith that he, Smith, had been freed of the murder charge, and what he does with his life is solely dependent on himself, and that he has the power to make changes to his life at this point. He referred to the case of Leroy Smith, (no relation to Paul), who



was recently before him and who was shot and killed in a robbery attempt not long afterwards.

Gonzalez approved of Justice Sylvester's words of advice, and he noted that other jurists often give guidance to accused persons, notably Justice Antoinette Moore, especially to young ones who come before her.

Smith said he plans to enroll in the Belize Defence Force and become a role model for his younger sister.

August was shot and killed on the night of April 7, 2022, in the village of La Democracia, located at Mile 31 on the George Price Highway. The single bullet entered his right ear and exited through his left ear.

Smith was only 17 at the time.

The new name of the parking lot – which is located at the corner of Regent and Bishop Streets in downtown Belize City-honors the late Fonseca, who first served as mayor of Belize City under the People's United Party (PUP) in 1992. David, as he was known to most people, served for two consecutive terms as the old capital's first elected mayor. He passed away at his home in Belize City in 2015, one day before his



61st birthday.

christening this area as the William David Fonseca Parking Facility. I want to thank you that his name will be joined with yours in memory of this situation here as we christen this place," said Yolanda Fonseca, widow of Fonseca.

He would have been one to say, 'No, no, no, don't name it after me; name it after somebody else.' That was the type of individual that he was. But we have to acknowledge the work that he did, and

we have to acknowledge the work that other members of the Fonseca family did," said Hon. Henry Charles Usher, area representative of Fort George.

The modern parking facility can hold a maximum of 34 cars and there are security cameras installed at every turn, giving drivers a sense of security when they leave their cars there.

"This new facility developed by your Belize City Council [symbolizes] where we are headed as a city and country. It forms part of the broader

BEL predicts decline in power supply in 2025

BELIZE CITY, Thurs. Nov. 14, 2024 In a 12-month notice letter, dated November 8, that was sent to the Public Utilities Commission (PUC), the Belize Electricity Limited (BEL) projected a considerable decline in power generation in 2025.

The letter stressed that the expected peak electricity demand within the next twelve months will exceed available generation capacity, which will make it necessary to procure additional generation services beyond what will be available within the next year.

BEL thus requested that the PUC secure the approval of the Government of Belize as soon as possible, but otherwise no later than 15 November 2024, which is tomorrow, to declare an emergency concerning generation services in Belize, and thus authorize BEL to initiate the process for emergency generation procurement.

Amandala attempted to seek comment from the PUC but our requests were declined. However, the Prime Minister of Belize, Hon. John Briceño, has said that there have been discussions about securing additional energy when it is needed.

"On declaring the energy [emergency], I have not spoken to the CEO, but we have had many discussions on this, and he has pointed out under the Act that we can declare an emergency to quickly get investors to sign up for energy [procurement]. He believes that if he does that, by the end of next year he could have 60 or 80 megawatts," he said.

We have discussed access to a ship

Integrating the teaching of the Garifuna language in schools

Efforts to integrate the teaching of the Garifuna language in Belizean schools continue. A Garifuna Settlement Day panel discussion was held at the University of Belize (UB) on November 12. Interspersed in the discussion was drumming done by Joshua Arana from Uarau Drumming.

The Garifuna language is part of the Arawakan group of languages and is well-developed, featuring unique nasalization. It is also capable of transmitting complex and analytical thought.

The panel discussion began with a statement by Dr. Vincent Palacio, president of the University of Belize, who remarked that "this language issue is one that is very profound to me."

Some groundwork has already been laid to integrate the teaching of the Garifuna language in schools in southern Belize.

"So, we had an initial discussion with

the Minister of Education in May of 2023. We finalized the curriculum and the professional development plan, which we submitted to the Ministry [of Education] in August of 2023; from there the Ministry did their reviews and gave approval in February of 2024," said Darius Avila, president of Battle of the Drums, whose cooperation with the National Garifuna Council has brought remarkable results.

Since then, nine schools in both the Stann Creek and Toledo districts have participated in the teaching of Garifuna language. But some challenges remain.

Avila stated, "It is very expensive to run such a program; so, as we speak, we are fundraising. The Battle of the Drums competition and show is part and parcel of our fundraising initiative; and some of the funds that we generate from that event we infuse into the Garifuna Language in Schools program."

Sheena Zuniga, president of the National Garifuna Council (NGC), has stated that they are now cooperating with the Battle of the Drums to form the Garifuna Language Commission.

"We have our Garifuna language commissioners who are responsible to assist with the curriculum development to help us in training the teachers to get this onboard. This year we are doing our pilot project, so we are trying to see what the challenges are [and] how we can get suggestions how we can fix it," she said.

Zuniga is encouraging the Garifuna community to participate in an effort "to preserve our Garifuna language [that] we are currently losing." Dr. Dylan Vernon, who is the Executive Director of the Belize Policy Research Institute at UB, believes that the incorporation of languages should be a national effort.

"I think that the basic message is that, if we are going to get the minority languages to be taught and preserved in Belize, we need to do it as part of state policy, national language policy; and that would set the stage for there to be

A call to Garifuna Nation on Garifuna Settlement Day

The celebrating of our Garifuna Settlement Day in Belize alone has not brought economic and other political benefits to our Garifuna people, especially as it relates to our people's living conditions, and human and land rights.

Every year in the country of Belize, the Garifuna people, and their brothers and sisters from other countries who make up their nation from their motherland "Yurumein" (now known as Saint Vincent & The Grenadines) such as Honduras, Nicaragua, Guatemala, the United States of America and elsewhere, look forward to celebrating the 19th of November celebrations which has been today, where they settled. In our Garifuna oral history, we are being told that some of our people made a decision to settle in Gales Point Manatee and Mullins River.

Thomas Vincent Ramos was born in Puerto Cortes, Honduras, on September 17 of 1887 and died in Dangriga, Belize on November 13, 1955. He came to Dangriga as a teenager to live when he was about eighteen years old.

Guatemala and Belize for the same reason.

Below is an extract discovered on the Prabook website, about what was taking place in Honduras during this time:

"When Policarpo Bonilla (no relation to Manuel) became president in 1895, it was understood that his minister of war, General Terencio Sierra, would be the Liberal Party candidate in 1899, and

Manuel Bonilla, the vice president, 1903. in However, Policarpo and Manuel Bonilla quarreled, and Manuel Bonilla withdrew from the vice presidency. He subsequently became President Sierra's minister of war. However, Sierra announced his support for Juan Angel Arias in the 1903 elections. Bonilla then resigned and founded a new coalition, the Nationalists, composed of his following among the Liberals and practically all remaining Conservatives. Bonilla received 28,850 votes. Arias 25,118, and a third nominee 4.857. "When president Sierra blocked Congress' attempt to select a president from between the top two candidates, Bonilla and a group of supporters left the capital for Amapala, where the mayor administered the presidential oath to Manuel Bonilla. After several battles,

Sierra fled to El Salvador, and Bonilla was declared president-elect by Congress on May 5, 1903. When Bonilla balanced his cabinet with Liberals and Conservatives, however, he irritated members of both parties. He suspended the constitution and declared martial law in the first week of 1904. A constitutional convention in 1905 lengthened the presidential term from four to six years and installed him as president for the period 1907-1912."

According to some Garifuna people from Honduras, Manuel Bonilla was liked by the Garifuna people because he was the president that gave them titles for their lands in Honduras in 1911. The Martial Law that was declared by Manuel Bonilla in 1904 was only one year before T. Vincent Ramos left. The stories that were given to me by the elders in Dangriga town about their martial law experiences in Honduras were frightening. They said that the Honduran soldiers would be on the streets with their guns loaded and people

a national holiday in Belize since 1976.

This day was founded by Thomas Vincent Ramos, a Garifuna nationalist and activist in the 1950's, to commemorate the arrival of the Garifuna people to Belize in 1802. This year will make it 222 years since the Garifuna people first landed in Belize in the "Yabra" area of Belize City. After they landed there, they were given instructions by the then British Superintendent, Richard Bassett, that they could not settle there due to the treaty the British had signed with Spain in 1763.

In this treaty, the British were only granted permission to cut logwood and mahogany up to the Sibun River, and the establishment of settlements was prohibited. As a result, they then started to move southwards to the settlements of Gales Point Manatee, Mullins River and in the place we know as "Dangriga" DEVELOPMENT SOCIETY (CDS) THE GARIFUNA SETTLEMENT DAY IN BELIZE AND THE GARIFUNA FLAG IN 1924



It was never mentioned what were the reason or reasons that Thomas Vincent Ramos may have decided to leave Honduras for Belize. However, a look at Honduras' political history during the time that he left his country of birth, shows that there was political unrest taking place. This may have been the main reason why he left. Before his departure to Belize, some of his relatives and other Garifuna people had already left Honduras and gone to Nicaragua, could not move freely in their villages, towns and cities.

I have a relative from Honduras who is lucky to be alive today because they shot at his mother during a period of martial law in Honduras while she was carrying him in her arms. T. Vincent Ramos arrived in Dangriga and became active in the Marcus Garvey Universal Negro Improvement Association (UNIA) and African Communities League (ACL) which was formed on July 15, 1914. Marcus Garvey's philosophy was the unification of all people of African descent with their mother continent, Africa.

During the time of Garvey's movement, most countries in Africa were colonies of some European countries, mainly Portugal, France and






Garinagu, celebrating their roots; sharing their culture

On May 18, 2001, UNICEF declared the Garifuna language, music and dance a Masterpiece of the Oral and Intangible Heritage of Humanity, recognition that was fully deserved and that made the nation proud, across the length and breadth of the country. According to *Belize Glessima Research*, the celebration of Garifuna Settlement Day began in 1941 after Thomas V. Ramos, Catarino Benguche and Matias Avaloy "wrote to the Governor requesting a day to recognize the contribution of the Black Caribs", and in 1943 "the holiday spread to Toledo and became a Public and Bank Holiday in the Southern Districts." First as a trickle, Belizeans from the other districts traveled south to join the celebrations, and since 1977 when the day, November 19, was made a Public and Bank Holiday for the entire nation, there's been an explosion of Garifuna culture countrywide in the month of November, up to Settlement Day.

The history of the Garinagu began with a shipwreck in the 1600s near the island of St. Vincent, with the survivors, Africans from the continent who were destined for the slave plantations in the Americas, escaping the chains and beginning a new life among the native Caribs on the island. The marriage of the Caribs and the Africans created the Black Caribs. *Belize Glessima Research* says that between 1974 and 1975 leaders of the group "advocated for Stann Creek Town to be renamed [Dangriga] and Black Caribs to be called Garifuna/Garinagu."

The Garinagu ran afoul of the British in St. Vincent when they refused to give up their lands to European farmers who wanted to expand their sugarcane plantations. The militarily superior British eventually overcame the Garinagu, and after the Garinagu leader, Joseph Chatoyer fell in battle, his people were rounded up and taken to Balliceaux, an island off the coast of St. Vincent.

The story, "219 years after genocide attempt, Garinagu celebrate survival,"

published in the Amandala of April 16, 2016, notes: "another historic date which is commemorated among members of the wider Garifuna community-that of 12th April 1797... marks the exile by the British of over 2,000 Garinagu to Roatán, Honduras." That report says, "Unlike the Garinagu's arrival to Belizean shores, their arrival to what is now known as Honduras, was not as joyous, since those who had made it to that destination had seen almost half of their brothers and sisters perish from starvation and disease on the desolate island of Balliceaux"

Continuing with that 2016 story in the Amandala, E. Roy Cayetano, a Garifuna educator, historian, and former Deputy Chief Education Officer of Belize, said the British "were too civilized to just take a gun and kill the survivors, the Balliceaux survivors; so they exiled them." Cayetano said, "between July 1796 and March 1797, 4,338 (some say, 5,000 and odd) Garinagu were imprisoned on Balliceaux, an island unfit for human habitation, and on March 11, 1797, 2,248 were boarded on 11 ships. The flagship was HMS Experiment, and the Garinagu were taken away ... and dumped on the island of Roatán to fend for themselves." Science teaches us that diamonds are produced under extreme temperature and pressure, not in soft beds. Mainly because the Garinagu are black, they weren't embraced on mainland Honduras, and when they started migrating northward to Belize, which would become the home of Garinagu on the west shore of the Caribbean, they landed in a country where they weren't immediately accepted. History records that while the men were given jobs in Belize's forest industry, the colonial rulers insisted that they be kept apart from the enslaved/recently freed African woodcutters.

The pain of losing their land in Yurumein (the Garifuna name for St. Vincent), the exile on barren Balliceaux, the banishment and starvation on Roatán and rejection in mainland Honduras, and separation from others in Belize, helped forge a remarkable people. Not by choice, by force the Garinagu recognized that if they would survive, their stance would have to be, "we against the world." They won, and the world, especially Belize, did too. Like *the stone the builders refused*, our Garinagu brothers and sisters have become a pillar.

On November 19, we celebrate the numerous outstanding contributions of the Garinagu to our nation. In education, music, sports, dance, the arts, they have excelled. There are too many Garinagu heroes and heroines to name here, but Alejo Beni, who led many Garinagu to Belize to escape violence and other hardship in Honduras, and Thomas Vincent Ramos, who led the lobby that won national recognition for Garinagu contributions to the nation on November 19, stand tallest during the annual celebration.

<u>Krem Radio, since 1989</u>

The United Black Association for Development (UBAD), a cultural group which later became a political party, since its birth in 1969 had included free radio in its platform, and when the party dissolved in 1974 the party's newspaper, *Amandala*, continued championing the call for voices other than those of the ruling PUP to be heard on the airwaves. In the 1970s, only the government-controlled Radio Belize and the private radio station of the British Forces in Belize were licensed to operate in our country.

The ruling PUP maintained that Radio Belize was neutral, despite all its employees having to pass a PUP smell test before getting before a microphone, and the unceasing broadcasting by the station of the glorious achievements of the government ministers. The only time the opposition parties in the country — NIP, PDM, UBAD, Liberal Party, and the amalgamated UDP— were allowed to air the issues that concerned them was just prior to general elections, and only for a few minutes.

Disappointingly, the UDP, which had experienced the disadvantage of challenging a government that controlled the only local radio station, instead of magnanimously freeing the airwaves when it took the reins of government in 1984, in a decision that reeked of pettiness and ingratitude, effectively said it was "our turn" to take advantage of their good fortune at the polls. Throughout their term in office, 1984-1989, the UDP maintained the status

quo of a single radio station for Belizeans, this time under their control.

The *Amandala*, in the editorial, "*Krem at 21*", said "KREM Radio was the result of an act of political desperation on the part of the then Opposition People's United Party (PUP) ... Having contributed substantially to the UDP general election victory in 1984, at *Amandala* we felt we were being given a bureaucratic runaround [over a radio license] ... In early 1989 we began making noise, and the PUP suddenly jumped on our bandwagon. They publicly promised to give 'Radio Amandala' a license if they were elected in the 1989 general elections. And so they were ..."

On this 35th anniversary of KREM Radio on November 17, the *Amandala* salutes all the contributors to free radio, and the station's survival. SAN PEDRO, Ambergris Caye, Wed. Nov. 13, 2024

The tragedy of motorcycle deaths continues, with the lives of two more men being lost within three days in separate motorcycle accidents


The first fatal accident took place early Sunday morning, November 10, in San Pedro Town where the deceased, 30year-old Eric Williams, a carpenter from the DFC area, tragically lost his life.

According to police, Williams was riding his motorcycle on Crocodile Street at the entrance to the San Pedrito area around 1:00 a.m. on Sunday when he reportedly lost control of the bike, which hit a lamppost. He suffered major head injuries as a result of the collision and died shortly after.

According to Hilberto Romero, Regional Commander of the Belize Police Department Eastern Division, when police went to the scene they saw Williams lying on the ground next to his extensively damaged motorcycle. There was reportedly an open wound to his right elbow and blood oozing out of his left ear.

An unconscious Williams was then taken to the San Pedro Polyclinic, where he passed away less than an hour later.

The second motorcycle accident took place on Tuesday, November 12, in Orange Walk Town, and claimed the life

indicate that before 9:00 p.m., Castellanos was ridinghis motorcycle on Tate Street when he collided with the front right bumper of a Freightliner truck driven by 50-yearold Orlando Tzul. It is alleged that when Tzul attempted to

make a left turn onto Muñoz Lane, Castellanos hit the ride side of the truck.

The collision caused Castellanos to lose control of the bike and fall onto the pavement, and as a result he sustained head and body injuries.

Castellanos was taken to the Northern Regional Hospital, where he was pronounced dead. Tzul was detained and remains in custody, pending charges, as a police investigation continues.

Los garífuna, celebrando sus raíces; compartiendo su cultura

El 18 de mayo de 2001, UNICEF declaró la lengua, la música y la danza garífuna como Obra Maestra del Patrimonio Oral e Inmaterial de la Humanidad, un reconocimiento que era totalmente merecido y que enorgullecía a la nación, a lo largo y ancho del país. Según *Belize Glessima* Research, la celebración del Día del Asentamiento Garífuna comenzó en 1941 después de que Thomas V. Ramos, Catarino Benguche y Matias Avaloy "escribieron al Gobernador solicitando un día para reconocer la contribución de los caribes negros", y en 1943 "la festividad se extendió a Toledo y se convirtió en un día festivo público y bancario en los Distritos del Sur". Al principio, los beliceños de otros distritos viajaban al sur para sumarse a las celebraciones y, desde 1977, cuando el 19 de noviembre se declaró feriado público y bancario para todo el país, se ha producido una explosión de la cultura garífuna en todo el país durante el mes de noviembre, hasta el Día del Asentamiento.

La historia de los garífunas comenzó con un naufragio en el siglo XVII cerca de la isla de San Vicente, y los supervivientes, africanos del continente que estaban destinados a las plantaciones de esclavos en las Américas, escaparon de las cadenas y comenzaron una nueva vida entre los caribes nativos de la isla. El matrimonio de los caribes y los africanos creó a los caribes negros. Belize Glessima Research afirma que entre 1974 y 1975, los líderes del grupo "abogaron por que el Municipio de Stann Creek se llamara [Dangriga] y que los caribes negros se llamaran garífuna/garinagu".

Los garífunas se enemistaron con los británicos en San Vicente cuando se negaron a ceder sus tierras a los agricultores europeos que querían ampliar sus plantaciones de caña de azúcar. Los británicos, que eran militarmente superiores, acabaron venciendo a los garífunas y, tras la muerte en combate de su líder, Joseph Chatoyer, su pueblo fue acorralado y llevado a Balliceaux, una isla frente a la costa de San Vicente.

El artículo "219 años después del intento de genocidio, los garífunas celebran su supervivencia", publicado en *Amandala* el 16 de abril de 2016, señala: "Otra fecha histórica que se conmemora entre los miembros de la comunidad garífuna en general, la del 12 de abril de 1797... marca el exilio por parte de los británicos de más de 2.000 garífunas a Roatán, Honduras". Ese informe dice: "A diferencia de la llegada de los garífunas a las costas de Belize, su llegada a lo que ahora se conoce como Honduras no fue tan alegre, ya que los que habían llegado a ese destino habían visto a casi la mitad de sus hermanos y hermanas perecer de hambre y enfermedad en la desolada isla de Balliceaux..."

Continuando con esa nota de 2016 en Amandala, E. Roy Cayetano, un educador garífuna, historiador y exdirector adjunto de educación de Belize, dijo que los británicos "eran demasiado civilizados para simplemente tomar un arma y matar a los sobrevivientes, los sobrevivientes de Balliceaux; así que los exiliaron". Cayetano dijo: "entre julio de 1796 y marzo de 1797, 4.338 (algunos dicen, 5.000 y algo) garífunas fueron encarcelados en Balliceaux, una isla no apta para la habitación humana, y el 11 de marzo de 1797, 2.248 fueron abordados en 11 barcos. El buque insignia era el HMS Experiment, y los garífunas fueron llevados... y arrojados a la isla de Roatán para que se las arreglaran por sí mismos".

La ciencia nos enseña que los diamantes se producen bajo temperaturas y presiones extremas, no en lechos blandos. Principalmente porque los garífunas son negros, no fueron bien recibidos en el continente hondureño, y cuando

comenzaron a migrar hacia el norte, a Belize, que se convertiría en el hogar de los garífunas en la costa oeste del Caribe, desembarcaron en un país donde no fueron aceptados de inmediato. La historia registra que, si bien a los hombres se les dio trabajo en la industria forestal de Belize, los gobernantes coloniales insistieron en que se les mantuviera separados de los leñadores africanos esclavizados o recientemente liberados.

El dolor de perder su tierra en Yurumein (el nombre garífuna para San Vicente), el exilio en la estéril Balliceaux, el destierro y la hambruna en Roatán y el rechazo en la Honduras continental, y la separación de otros en Belize, ayudaron a forjar un pueblo extraordinario. No por elección, sino por la fuerza, los garífunas reconocieron que si querían sobrevivir, su postura tendría que ser "nosotros contra el mundo". Ganaron, y el mundo, especialmente Belize, también. Al igual que la piedra que los constructores rechazaron, nuestros hermanos y hermanas garífunas se han convertido en un pilar.

El 19 de noviembre celebramos las numerosas contribuciones sobresalientes de los garífunas a nuestra nación. En la educación, la música, los deportes, la danza y las artes, han sobresalido. Hay demasiados héroes y heroínas garífunas para nombrarlos aquí, pero Alejo Beni, quien llevó a muchos garífunas a Belize a escapar de la violencia y otras dificultades en Honduras, y Thomas Vincent Ramos, quien encabezó el lobby que ganó reconocimiento nacional por las contribuciones garífunas a la nación el 19 de noviembre, se destacan durante la celebración anual.

¡Feliz Día del Asentamiento Garífuna, Belize! "Afeduhawaméiwagücha, afareinhawaméiwanichigu! - Celebrando nuestras raíces; compartiendo nuestra cultura".

<u>Radio Krem, desde 1989</u>

La Asociación Negra Unida para el Desarrollo (UBAD en inglés), un grupo cultural que luego se convirtió en un partido político, desde su nacimiento en 1969 había incluido la radio libre en su plataforma, y cuando el partido se disolvió en 1974, el periódico del partido, Amandala, continuó defendiendo el llamado para que se escuchen voces distintas a las del gobernante PUP en las ondas. En la década de 1970, sólo Radio Belize, controlada por el gobierno, y la estación de radio privada de las Fuerzas Británicas en Belize tenían licencia para operar en nuestro país.

El partido gobernante PUP sostuvo que Radio Belize era neutral, a pesar de que todos sus empleados tenían que pasar una prueba de olfato PUP antes de ponerse delante de un micrófono, y la estación transmitía incesantemente los gloriosos logros de los ministros de gobierno. La única vez que se permitió a los partidos de la oposición en el país - NIP, PDM, UBAD, Partido Liberal y el UDP fusionado - emitir los temas que les preocupaban fue justo antes de las elecciones generales, y sólo durante unos minutos.

Lamentablemente, el UDP, que había experimentado la desventaja de desafiar a un gobierno que controlaba la única estación de radio local, en lugar de liberar magnánimamente las ondas cuando tomó las riendas del gobierno en 1984, en una decisión que olía a mezquindad e ingratitud, dijo en realidad que era "nuestro turno" de aprovechar su buena suerte en las urnas. Durante su mandato, de 1984 a 1989, el UDP mantuvo el status quo de una única estación de radio para los beliceños, esta vez bajo su control. Amandala, en el editorial "Krem at 21", dijo que "Radio KREM fue el resultado de un acto de desesperación política por parte del entonces opositor Partido Unido del Pueblo (PUP)... Habiendo contribuido sustancialmente a la victoria del UDP en las elecciones generales de 1984, en Amandala sentimos que nos estaban dando evasivas burocráticas [sobre una licencia de radio]... A principios de 1989 comenzamos a hacer ruido, y el PUP de repente se subió al carro. Prometieron públicamente darle una licencia a 'Radio Amandala' si eran elegidos en las elecciones generales de 1989. Y así fue..." En este 35° aniversario de Radio KREM el 17 de noviembre, el Amandala saluda a todos los contribuyentes a la radio libre y a la supervivencia de la estación. Debido a que nunca se ha doblegado ante el establishment, debido a su insistencia en decir la verdad al poder cada vez que cree que el "poder" es abusivo o va por el camino equivocado, KREM no ha sido el favorito de las corporaciones. KREM podría fácilmente haber cedido, haber cantado para ganarse la vida, haber "hecho amigos" con el dinero. Pero, al igual que su empresa matriz, Amandala, KREM puso la educación y el bien del pueblo en primer lugar. ¡Feliz cumpleaños, KREM!

Telemedia or Digi (or whatever its name is) ended up costing Belizean taxpayers hundreds of millions of dollars about ten years ago. In the House of Representatives on Tuesday afternoon this week, the Collet area representative, Hon. Patrick Faber (UDP), who is so highly educated that I believe he is a candidate for a Ph.D., sought to do a historical sketch of the Belizean telecommunications saga, beginning in 1989 when the then UDP Prime Minister, Rt. Hon. Manuel Esquivel, privatized the company then known as BTA (Belize Telecommunications Authority), which became BTL (Belize Telecommunications Limited.)

I think Hon. Faber made a mistake

when he said that Lord Michael Ashcroft had gotten control of telecommunications in Belize in 2003; and I feel that, while he did mention the Jeffrey Prosser debacle, Hon. Faber did not say a word about the Intelco adventure, which ended up with PUP Prime Minister, Rt. Hon. Said Musa, and his Finance Minister, Hon. Ralph Fonseca, leaving the Intelco entrepreneur, Glenn Godfrey, high and dry around 2004 or so. Lord Ashcroft reigned supreme.

You know, when I was a youth/young man growing up in British Honduras/ Belize in the 1960s, it was often that my friends and I would lament situations in Belize which we would compare, unfavorably, with the superior operations that addressed similar situations in the United States of America. There was no television in Belize then, but we were able to listen to American radio stations in the night, because the AM broadcast technology of that time had radio waves travelling all the way to Belize from huge American cities like St. Louis, Houston, and Little Rock (Arkansas). If you had a shortwave radio, you could listen to the U.S. Armed Forces radio station both night and day.

Our critical perspectives on Belizean situations were not fair to our leaders and authorities, because the U.S. was so much larger, richer, and more experienced than our little country. The U.S. declared independence in 1776; we Belizeans managed to become a selfgoverning British colony in 1964.

In America, there are some very wealthy institutions, called foundations, such as the Rockefeller Foundation and the Ford Foundation, which make substantial financing available to researchers and writers after they submit appropriate requests to study important topics and publish their findings.

So that, if we were in America, there would have been appropriate literature available for Belizeans to read concerning the very, very important history of telephones and telecommunications in Belize.

The most important point I want to make in this essay is that Lord Ashcroft, according to my sources, gained control of our telecommunications on the final day of the PUP administration which lost power on June 30, 1993. P.M. Esquivel, and his chief adviser, Net Vasquez, had constructed BTL in 1989 with a guard rail against foreign predators which was called "the golden share." The golden share, a control mechanism, was supposed to remain in the hands of Belizeans forever and ever.

I believe Hon. Faber should dig deeper and find out more about how and when the deadly deal was done, how the betrayal was planned and executed.

There have been a few cases where important research and publication have been done by Godfrey Smith, such as when he wrote the authorized biography of the national hero, Rt. Hon. George Price, and by Mr. Lawrence Vernon, formerly Belize's chief librarian, whose work is extensive and invaluable. In the matter of election history in post-1950 Belize, Lady Myrtle Palacio's work is also worthy of praise.

But, the story of Belizean telecommunications has to be told from the time when telephones were a small and almost insignificant department under the jurisdiction of the Post Office. This was during the 1960s. I believe the independent BTA was established in the middle or late 1970s.

Since telecommunications ended up with Belizean taxpayers being battered and gouged, even though the transformation from Cable & Wireless to BTA was a tremendous achievement which featured the praiseworthy work of Belizean workers and executives, it is very sad, to my mind, that the story has not been told in bold and confirmed detail from beginning to now.

In America, there is collusion in critical areas of knowledge between universities and the industrial private sector. What happened in the case of telecommunications in Belize was that the Belizean masses were basically ignorant about the industry, and the elected politicians of Belize, both PUP and UDP, got away with murder. On both sides of the political spectrum, our politicians and their cronies have become multimillionaires because we, the people, were ignorant about the real. We should have been informed by our scholars along the way. And our scholars should have been focused and financed.

We "wuz" robbed, Belizeans.



There has to be a serious debate about terminating a pregnancy in the later stages. But in those first three months, really, it should be entirely a matter for the woman's heart. We pray she has a good one.

In March of 1961, the colony of British Honduras held its first national election under a new Ministerial constitution. (British Honduras became self-governing in 1964.) The People's United Party (PUP) won all 18 seats in the new House of Representatives.


Ever since then, this country has practiced a form of parliamentary democracy which is bastardized, so to speak. For parliamentary democracy to be perfected, again so to speak, the persons in the Cabinet, or executive section of the democracy, must be fewer in number than the non-Cabinet members of the House of Representatives, who constitute what we call the legislature.

Even when the margin of the ruling party's majority is very narrow, such as the PUP's 16-14 majority in 1989 and the United Democratic Party's (UDP) 16-13 majority in 1993, the Prime Ministers of Belize have always made sure that no alliance of the non-Cabinet area representatives can take place with the Opposition area representatives to outnumber the Cabinet, in order to reject any piece of legislation and send it back to Cabinet. In other words, there has never been a functional group of so-called backbenchers in the Belize House of Representatives.

At the beginning of the 1998 PUP government, there was a reform movement amongst influential and informed Belizeans which was pushing for an elected Senate. Strictly speaking, such an elected Senate was to have the power to reject a bill and send it back to the House.

Such an elected Senate was never introduced into Belize, but at some point a Senate system was established wherein the ruling party appointed the majority of a Senate, but the Opposition party's appointments could cast a majority vote with the support of the Senators appointed by the churches, the unions, the Chamber of Commerce, the Non-Government and Organizations (NGO's).

Personally, I have never paid a great

deal of attention to the shenanigans involving the discussions about the Senate initiative. I feel that I have been negligent on this score, and my excuse was that the important thing was always to embrace the righteous backbencher aspect of the parliamentary democracy system.

So that, I had to do some consultation before writing this column, because I thought I had heard somewhere that the present Senate, comprised of 13 Belizeans, has in fact sent back a bill to the present House, not to the Cabinet. (The present Senate includes 6 PUP-appointed Senators, 3 UDP-appointed Senators, and Senators from the churches, the unions, the Chamber, and the NGO's.)

The key thing is that our present Senate cannot send a financial bill back to the House. Now then, it is the case that government (political power) is all about money, or the power of taxation over the citizenry. If you can't question the money, then you are more cosmetic than powerful. That is why the backbencher system would be more of a check upon the Cabinet. Or, at least, that is what I believe.

The parliamentary system we have in Belize came from the British, who developed it in the first half of the seventeenth century. In Great Britain, the parliament became so powerful that they beheaded a king in 1649. Kings and queens had ruled Britain for centuries, but today the king is only a figurehead. The power in Britain rests in the House of Commons and its Prime Minister, but the backbencher system is in place so that the Prime Minister and his Cabinet can be checked.

In Belize today, not only has there never been a backbencher system in place, but presently there is absolute chaos amongst the five elected Opposition area representatives. One UDP area rep has never attended a House meeting since being elected four years ago, and there are two UDP area reps who are quarrelling for leadership on a public stage. At this point, not only does Belize not possess the important backbencher system, but we also do not have a really functional Opposition. The upshot of this situation is that Belize cannot be considered a parliamentary democracy. You may even say that it never was, a parliamentary democracy, that is, because there have never been backbenchers. But today, November 11, 2024, we do not have an organized, cohesive Opposition, so all we have is a lot of noise in the broadcast and social media. This is not good. Somewhere, it is said, there are people who are supposed to be preparing a new constitution for Belize. Interesting, beloved, interesting.



History has it that in the early 1990s, after the breakup of the Soviet Union,

at the time when war between NATO and North Korea was looking like a real possibility, North Korean supreme leader Kim Il-Sung called his top generals together for a meeting to discuss strategy for a war against the USA.

After hours discussing the nuts and bolts of prosecuting this war, Kim asked everyone in the room a question that they did not know how to answer. He asked, "What if we lose? What will we do if we lose?"

The generals didn't want to answer this question, because to do so, which would be to acknowledge the possibility of losing, might be interpreted as disloyalty or even treason. At the same time, "We cannot possibly lose" was not a useful answer, and Kim certainly wasn't looking for delusional optimism in his military commanders.

Kim's son, Kim Jong-Il, who was present at the meeting, was the only person who spoke up. His answer was simple: "If we lose, I will make sure to destroy the world. What good is a world without North Korea?" And this was the answer that satisfied Kim Snr. and became part of the foundational ethos of the Kim dynasty and North Korea to this day.

Regardless of whatever moral issue one might have with North Korea planning to basically destroy the world in a giant tantrum if a hypothetical war does not go its way, I have always found something deeply compelling and somewhat admirable about North Korea seeing itself as the centre of the world.

If the inhabitants of that patch of cold, rocky land that is poor in natural resources and seemingly condemned by geography to eternal poverty and

Estados Unidos de América. No había televisión en Belize en ese entonces, pero podíamos escuchar estaciones de radio estadounidenses por la noche, porque la tecnología de transmisión AM de esa época tenía ondas de radio que viajaban hasta Belize desde grandes ciudades estadounidenses como St. Louis, Houston y Little Rock (Arkansas). Si uno tenía una radio de onda corta, podía escuchar la estación de radio de las Fuerzas Armadas de los EE. UU. tanto de día como de noche.

Nuestras perspectivas críticas sobre las situaciones beliceñas no eran justas para nuestros líderes y autoridades, porque Estados Unidos era mucho más grande, más rico y más experimentado que nuestro pequeño país. Estados Unidos declaró su independencia en 1776; nosotros, los beliceños, logramos convertirnos en una colonia británica autónoma en 1964.

En Estados Unidos, hay algunas instituciones muy ricas, llamadas fundaciones, como la Fundación Rockefeller y la Fundación Ford, que ponen a disposición de investigadores y escritores una financiación sustancial después de que presentan las solicitudes correspondientes para estudiar temas importantes y publicar sus hallazgos. De modo que, si estuviéramos en Estados Unidos, habría habido literatura apropiada disponible para que los beliceños leyeran sobre la importantísima historia de los teléfonos y las telecomunicaciones en Belize. El punto más importante que quiero destacar en este ensayo es que, según mis fuentes, Lord Ashcroft obtuvo el control de nuestras telecomunicaciones el último día de la administración del PUP, que perdió el poder el 30 de junio de 1993. El primer ministro Esquivel y su asesor principal, Net Vasquez, habían construido BTL en 1989 con una barandilla de protección contra los depredadores extranjeros, llamada "la acción de oro". En Estados Unidos, hay colusión en áreas críticas del conocimiento entre las universidades y el sector privado industrial. Lo que sucedió en el caso de las telecomunicaciones en Belize fue que las masas beliceñas eran básicamente ignorantes sobre la industria, y los políticos electos de Belize, tanto PUP como UDP, se salieron con la suya. En ambos lados del espectro político, nuestros políticos y sus compinches se han convertido en multimillonarios porque nosotros, el pueblo, éramos ignorantes sobre la realidad. Deberíamos haber sido informados por nuestros académicos a lo largo del camino. Y nuestros académicos deberían haber sido enfocados y financiados. Nos robaron, beliceños.



of babies having babies, prevent children from becoming parents before they had the knowledge, abilities and resources to properly raise a family.

As Minister of Human Development, Families and Indigenous Peoples Affairs, Hon. Dolores Balderamos Garcia put it, early marriage for teenagers "prematurely exposes them to health risks of early childbirth or unwanted pregnancies and related complications, and it increases their risk of contracting sexually transmitted infections including human immunodeficiency virus (HIV). It also increases a child's vulnerability to domestic violence, ... perpetuating the cycle of poverty.

"Moving to the adulthood age for marriage is a good thing to do, because marriage is a contract ... No disrespect to any church leader whatsoever, but I have said that you're married, not because you went to church, but because you signed a binding contract which I believe only adults should be able to do. So, I put it to this House this afternoon, that ending child marriages and early unions will have a positive multiplier effect on promoting all our strategies for gender equity and equality in Belize. I believe that the strong consensus in favour of raising the legal marriage age to 18 years is a good thing, ... and I urge others to do the same."

Prime Minister Hon. John Briceño, in his capacity as the Minister of Finance, Economic Development, Investment, Aviation, Civil and Immigration, presented nine other Bills for their second readings on | Tuesday. These included:

provide for related issues.

A Bill to amend the Securities Industry Act, Act No. 46 of 2021 was presented a second time; to provide for appeals of decisions of the Commission to be made to the Appeal Panel under the Financial Services Commission Act, and to consider all other related issues.

The Bill to amend the Income and Business Tax Act, Chapter 55 of the Laws of Belize 2020 was also read, to exempt certain employed individuals from being taxed on their income. This change also removes income tax deduction anomalies, as it removes the tax on interest income on time deposits. It also applies double tax treaty relief provisions to all treaty nations, not just for Commonwealth nations, to encourage pensioners from the United Kingdom to come live in Belize. It also regularizes the withholding of tax on gross contract payments, and offers incentives for the private sector to support sports and educational development in Belize by changing the wording of the law to make it easier to understand.

A Bill was also presented to amend the Tax Administration and Procedure Act, Chapter 51 of the Laws of Belize 2020, to improve tax administration and enhance tax compliance; to enable electronic tax invoicing; to make clarifying amendments, and to take into account any related issues.

A Bill to amend the General Sales Tax Act, Chapter 63 of the Laws of Belize, to enable electronic tax invoicing and to change the wording of the law to make it more understandable.

A Bill to amend the Business Names Act, Chapter 247 of the Laws of Belize 2020 was introduced to make a Certificate of Registration valid for one year, and other issues related to this change.

The Designated Processing Areas Act was amended to accommodate the continued development of the Global Digital Services Sector, so as to offer

incentives and additional support to the Aquaculture industry, to establish a Special Border Entertainment Zone, and to consider other related issues.

Minister of Foreign Affairs, Foreign Trade, Education, Culture, Science, and Technology, Hon. Francis Fonseca introduced a Bill to amend the National Institute of Culture and History (NICH) Act to strengthen NICH's power to protect and preserve resources in nature cultural and reserves. It also standardizes the definition of "Minister" throughout the Act; penalizes offences more strictly, and considers other related issues.




Valerie Woods, Speaker of the House

Speaker of the House, Hon. Valerie Woods had some sobering personal news, that she had been diagnosed with breast cancer. She informed the House that as time goes on her illness might impact the performance of her duties as she seeks treatment.

Prime Minister Briceño introduced the first reading of the Social Security (Amendment) Bill 2024 to amend the Act to allow for the retroactive appointment of a General Manager of the Authority and a Chair of the National Health Insurance Committee, and other related matters.

He also proposed the National Health Insurance (Validation) Bill for an Act to validate the acts, decisions or omissions



related to how the National Health Insurance scheme is implemented and associated issues.

Minister Fonseca introduced a Bill to amend the Senior Courts Act, to provide for notices and documents required to be served in relation to appeals from inferior courts to be served by public advertisement, and other related issues,

Minister of Public Service, Constitutional and Political Reform, and Religious Affairs, Hon. Henry Charles Usher introduced a Bill to amend the People's Constitution Commission Act, to retroactively extend the Commissioners' terms of appointment and that of the Commission, and other related issues.

Minister of Blue Economy and Disaster Risk Management, Hon. Andre Perez proposed an amendment to the Disaster Preparedness and Response Act, to expand the definition of disaster emergency to include Orders made under the Belize Agricultural Health Authority Act in relation to quarantine pests and notifiable pests of potential or substantial national economic and other related matters. A Bill to amend the Stamp Duties Act, was also introduced to exempt certain instruments from stamp duty; to make clarifying amendments; and to provide for related issues.

a gold chain with a Topaz pendant value \$400; while Count 5 was for robbing from Guillermo Fuentes, a black and white Samsung cellphone value \$500.00.

The heist was carefully executed, because Premium Wines & Spirits in Belize City was designed where their customers usually have to be buzzed in to enter, and that's when the men waited until a customer was entering and then rushed in after her.

One of them, who was armed with a gun, pointed it in her face, she said, and stole from her a Samsung Galaxy S7 worth \$1,900 and a gold chain worth \$400.

At the same time, one of the other robbers was robbing two customers. He also stole another cellphone worth \$500 from the business's deliveryman.

One of the three robbers then went to the counter and demanded money from the cashier. When the cashier refused, the robber slammed her iPhone 6S, valued at \$700, on the counter. Frightened, she then handed over \$7,219 in different denominations. The men also stole a backpack that contained daily deposits and personnel payroll amounting to \$34,000 in different denominations, \$1,166.25 in checks, and \$6,300US.

The thieves then locked everyone who was in the business in an office in the store, and escaped with their loot, which had a total value of \$57,785.25.

This morning, Justice Nanton, before releasing the jurors of their duty, explained to them that the Crown discontinued the case against Sambula after some issues had been addressed in their absence.

On January 8, 2020, Sambula was indicted on five counts of robbery.

He was initially arraigned on Wednesday, September 12, 2018, on robbery charges, and was denied bail and later granted bail through the High Court.

In the matter at the High Court, Sambula was represented by attorney Leeroy Banner.

The two other men who police believe had been a part of the robbery were never captured or charged in connection with the robbery.

Great Britain. They were fighting for their independence from these countries.

Meanwhile, there were also territorial disputes taking place among the Europeans on their own continent. World War I began 13 days after Marcus Garvey launched his association on July 28, 1914, and ended in November of 1918.

Thomas Vincent Ramos then decided to use the knowledge he gained from UNIA to advocate for Garifuna nationalism. This was at a time when most of our people were afraid to challenge the British Crown for dismantling our nation-state by the name of "Yurumein," now known as Saint Vincent and The Grenadines, in 1796.

Then, they unlawfully removed our people as prisoners of war to the island of Balliceaux, where we were imprisoned, tortured, killed, and some of our people were buried there. Our people who survived that genocide were then removed from this island and were forcefully taken to the island of Roatan, where they landed on April 12, 1797. Garifuna people subsequently migrated to Nicaragua, Guatemala, Belize and the United States as a fragmented nation of people. Thomas Vincent Ramos requested that we be granted a day to come together as one, so that we could realize that we are a nation of people who must be proud of ourselves for fighting for our nation, "Yurumein," against European colonialism and human rights violations,

and reassert our nationhood no matter where we live.

The 19th of November celebration is not only about dancing, drinking and having fun. Just look at the number of times that we have been dancing, drinking and having fun. Yet, our social, political and economic situation has remained the same, and, in the view of some of our people like myself, has gotten worse. It is now the time for us to re-examine the state of our living as a people and our Garifuna Nation that is fragmented in the diaspora countries.

"We were living in our independent nation, 'Yurumein,' where we were selfsufficient and then brought to colonies that were controlled by the same Europeans whom we fought against and were defeated in wars in our homeland, Saint Vincent & The Grenadines. This is not progress, but an unfortunate regression that we must overcome to become free people once again." All of our Garifuna people see themselves as a part of one nation of people, no matter which country they currently reside in.



irrelevance can see themselves not only as a key part of the world, but as *centrally important* to it, then why do the inhabitants of the planet's most fought-over continent, bursting from Cairo to Cape with every sort of desirable resource known to man, struggle to see themselves as main characters in the world?

Between themselves, Kim Il-Sung, Kim Jong-Il, and Kim Jong-Un turned a barely-hospitable corner of East Asian into an impregnable, nuclear-armed fortress that absolutely nobody dares to take levities with. Unlike Africa, they have no huge amounts of gold, bauxite, oil, coltan, diamonds, copper, arable land, or sunlight.

In a world where independence and sovereignty are only guaranteed by nuclear bombs and ballistic missiles, they built those things out of Kimchi, rough potatoes, and sheer willpower. Nobody particularly *wants* North Korean territory — its most valuable geographical asset is its border with China — yet it sees itself as not just a key player on the global stage, but the world's *main character.* Meanwhile in Africa-the continent that supplies *everything* to the world and also controls the 2 most important shipping lanes in global trade (Gulf of Aden & Suez Canal) — nobody here seems to believe that they are part of the world, let alone among its main characters. The president of its most populous country is a CIA asset, and that country's citizens are not especially bothered by this. It does not fund its own continental union (only 16% of the AU's

annual budget comes from Africa).

It has no continental defence strategy. It plans to integrate its 54 economies by 2063, when most people reading this will be long dead. It can't even implement its own open-skies agreement, so it is cheaper to fly to Europe and Asia than to fly within Africa. It has no real priorities, and it is never in a hurry to get anything done.

If Kim Il-Sung had African generals at that meeting in 1991 and he asked them the same question Kim Jong-Il answered, their answer would probably have been something like, "We'll propose terms of surrender with a soft landing for ourselves and our families."

Africans deep down haven't recovered from the psychological effects of multicentury slavery and colonization, and as such, appear truly incapable of perceiving themselves as the main characters even in their own stories ...

I now call on every Garifuna person, to become active in the Garifuna Nation so that you can be like your ancestors who were willing to put their lives on the line for their land rights, autonomy, independence and economic sustenance to rid ourselves of neocolonial perpetual dependency.

TS Sara will bring lots of rain

bring lots of rain when it makes landfall on the coast of Belize a few days from now.

As of 9:00 a.m. on Thursday, TS Sara was moving west at 14 miles per hour with maximum sustained winds of 35 miles per hour, and it was located 391 miles east by south of Belize City, which would theoretically allow for potential landfall within 27 hours.

"However, the forecast is for the system to slow down, so that 14 miles

per hour speed is not expected to be maintained. The forecast is for it to stall north of Honduras for at least 24 to 36 hours, and begin moving to the northwest into our area," said Ronald Gordon, Chief Meteorologist at the National Meteorological Service of Belize.

The system has the potential to make landfall in Belize, and even possibly to strengthen into a hurricane before landfall. Nonetheless, Gordon said that the system is likely to weaken as it moves closer to the coast of Honduras within 24 hours.

He cautioned, however, that the forecast may not be completely accurate.

"No forecast can be exact, and hence, again, that's why, of course, you have this uncertainty cone indicating that the depression is moving towards us, but there is a possibility it can go in either direction. However, the most likely scenario from this probability distribution is that it will move to the center, where the highest probability is. As it moves farther away from the center, the probability decreases. So, there is a good chance that Belize will be impacted by a tropical storm sometime on Sunday, late Sunday, and possibly Monday morning. Timing is also variable, because no one can predict exactly when ... these models, again, are not perfect," Gordon said.

Gordon acknowledged that the storm could strengthen into a hurricane if it moves away from land, but that such a scenario is unlikely.

"If it remains offshore, then it should be a bit stronger. So, there is still some variance within that intensity forecast. The forecast is for it to come ashore as a 50-mile helper or storm. And that's down from yesterday when they had it at 70. So, it's trending downward because that means that more of the models show it is beginning overland in Honduras." he highlighted.

"The extreme worst-case scenario, outside the forecast, is perhaps a category one hurricane. We are not seeing that, but that's the extreme worst. Currently, it's at 50 miles per hour. So that's what we're expecting. In the best case, we can [see it go] further over Honduras, and come across as a [tropical] depression and be a rainfall producer," Gordon said.

It is predicted that TS Sara will bring 10 inches of rainfall or more.

it in April, we need to be able to sign a contract with them. To do it you need to sign an emergency. All things equal, there may be or may not be a shortage in April, or May. We are doing everything in place possible to avoid that," he said.

In previous years, 2019, 2023, and early 2024, the country experienced significant load shedding due to the failure to install new generation capacity on the grid, which was amplified by the impacts of extended droughts and heatwaves in Belize and southern Mexico (which drove up demand for electricity, while simultaneously curtailing supply from both local hydroelectric power plants and CFE, Mexico).

The load shedding was more prevalent from April to June when various parts of the country

experienced daily outages of 5 hours on average. BEL additionally noted that around 28 MW of new generation capacity will be added to the grid in 2024. However, it will run on diesel, with fuel costs between \$0.50 and \$0.60 per kWh. Moreover, the generation services available to meet demand may be further constrained if energy imports from Mexico become more limited or more expensive with the introduction of Tren Maya in the Yucatan Peninsula and the delays with Mexican generation projects.

At the moment, BEL's supplier of energy is Comisión Federal de Electricidad (CFE), and it is predicted that challenges will continue throughout the warmer months of 2025 as CFE supply to Belize will decline from the 55MW contracted amount, instead averaging 22MW, 7MW, 8MW, and 34MW during May through August 2025, respectively.

accountability.

During Dr. Taylor's visit, one of the main focuses was a shared commitment of both Belize and Barbados to establish a National Human Rights Institute (NHRI), that aligns with the international Paris Principles, which will reflect both countries' dedication to fulfilling their international obligations.

"So, the visit is to look at what successes, what strategies we are implementing to establish our National Human Rights Institute, and to see how best they can utilize what best practices we have learned so far, so that they do not necessarily have to reinvent the wheel," shared Hon. Major (Ret'd) H. Gilbert Swaso, Ombudsman of Belize.

"Moving forward [with] this together, we can better strategize and say what you think of this idea. Share ideas, so that then, when we establish our National Human Rights Institute ... because it will also have to be in consultation with the general public, we'll also have to have a continued consultation with all the relevant stakeholders who are at this moment dealing with any human rights issues, so that then, when the legal framework, when the organization is framed, that it's buy-in from everyone; and this is

exactly what is it that we want to achieve," he added.

Dr. Taylor and Hon. Major Swaso exchanged best practices, innovative strategies and solutions to address common challenges in their mandates. Dr. Taylor observed developments within Belize and the steps made by the Office of the Ombudsman of Belize.

Also, a special presentation was done by Hon. Major Swazo indicating the roadmap to establishing Belize's NHRI, offering insights into the strategic steps that Belize is taking to enhance human rights protections at the national level.

"You guys have a working formula," said Dr. Taylor. "The other thing too is, we are hoping to engender the support of other Caribbean countries to understand that ... because technically, if persons are going to complain for human rights and the violation of civil liberties, you have to have systems in place to deal with it," he continued.

The United Nations Development Programme (UNDP) and Belize's Ministry of Foreign Affairs and Foreign Trade brought both parties together, recognizing the importance of regional cooperation and the Ombudsman's vital role in safeguarding the human rights and welfare of the citizens.

Dr. Taylor and Dr. Sabazan were welcomed on Monday, November 11.


