34-year-old man convicted of sexual assault and rape of minor

BELIZE CITY, Mon. Nov. 25, 2024

Tonight, Robert Usher, 34, the man who took advantage of a child from the age of 8 until she was 17, taking every opportunity he could to sexually abuse her over a ten-year period, is spending his first night on remand, pending sentencing set for January 6, 2025.

In the meantime, Justice Candace Nanton will be contemplating from now until after the Christmas holidays an appropriate sentence to hand down to Usher for sexually assaulting the minor, repeatedly, despite the child telling her mother.

The child testified that when she cried for help, her cry went unheard by her own mother, who she said didn't believe her; and so, she kept quiet until she had been raped not once, not twice, but three times by Usher. And



that's when she told her aunt, and the police got involved and investigated the

Two dead in separate weekend RTAs, one involving a motorbike

BELIZE CITY, Mon. Nov. 25, 2024 Two separate traffic accidents that occurred over the weekend claimed the lives of two persons.

The first accident happened in northern Belize, where a man from Carmelita Village, Orange Walk District was struck from behind by a car and was left for dead on Saturday, November 23.

After 6:00 p.m. that evening, 67-year-old Fabio Chan was riding a bicycle between Miles 57 and 58 on the Philip Goldson Highway, heading to Orange Walk Town, when he was hit from behind.

When authorities arrived at the scene, they witnessed a motionless Chan on the shoulder of the highway in a facedown position in a puddle of water with his damaged bicycle nearby. Initial inspection of Chan

determined that he received a large cut wound to the head, a broken right foot, and abrasions to the back.

He was taken to the Northern Regional Hospital, where he was pronounced dead. The driver who hit Chan did not stop to assist and immediately fled the scene. Police are searching for a vehicle that matches the description of the car.

The other fatal accident involved a motorcycle and took place out west shortly before 10:00 p.m. on the same day at Mile 45 on the George Price Highway. 20-year-old Roy De Jesus Martinez and 26-year-old Kenny Garcia were traveling on a motorcycle but lost control of the bike, which fell on the pavement.

They were transported to the Western Regional Hospital, where Martinez died from his injuries and Garcia is in stable condition.


Belize celebrates Children's Day

San Pedro woman charged for arson

SAN PEDRO, Ambergris Caye, Fri. Nov. 22, 2024

A woman from San Pedro Town who police believe set a fire that eventually consumed a number of buildings on Tuesday, November 19, has been charged with arson.

The flames erupted around 2:30 p.m. that day in the San Pablo area of the island near the Ambergris Caye Stadium. Among the buildings destroyed were a two-story home, a four-bedroom house, and a small shop with a bedroom—with total damages estimated at \$200,000.

When firefighters arrived at the scene, the flames had already spread and the homes were unsalvageable. The National Fire Service confirmed that the fire started in a structure belonging to 47-year-old Sandra Catzim, and that someone intentionally started the blaze, which then spread to the other buildings.

Following an investigation, police

arrested 28-year-old Isela Catzim, the daughter of Sandra Catzim. She was charged with five counts of arson. According to information received by *Amandala*, the accused started the fire after having an argument with her mother, Sandra Catzim.


Man charged for killing teen

Police have captured a man accused of fatally shooting 18-year-old Johnathan Leonardo, a driver of Duck Run 2, Cayo District, after he had exited Divinas Restaurant and Bar at Mile 47 in Roaring Creek Village on Wednesday night, November 20.

According to reports, around 10:30 p.m. that Wednesday, Leonardo was with two friends at the night-time establishment when he was approached by the accused, 33-year-old Abraham

Shal, a storekeeper of Belmopan, and an argument began.

Leonardo attempted to leave the establishment in a car with his companions to diffuse the situation, but before they left the premises, Shal followed them with a firearm, and fired a single gunshot at Leonardo at point-blank range, killing him instantly.

A 9mm shell was found at the scene, which was linked to Shal's weapon, and he was later detained by police. He was charged with murder on Saturday, November 23.

Dead frog found in Crystal 5-gal water bottle

BELIZE CITY, Mon. Nov. 25, 2024 A resident of Esperanza Village, Cayo District, took to social media on Friday, November 25, after discovering a lifeless frog inside a 5gallon container of Crystal water that he had purchased.

The social media post indicated that the individual went to purchase the water from a nearby store to ensure sufficient supply for the week, and later discovered the dead frog floating around inside the sealed plastic container.

"Definitely for us, it was not expected. That's something highly unusual for us. A strange occurrence to say the least," said Rosanna Villanueva, Corporate Relations Manager at Bowen & Bowen Ltd., which sells the bottled water.

"... It is highly unusual. For us we found it strange. Crystal is a brand that has been around for decades, and is a brand that Belizeans trust. We want to assure our customers and consumers that they can continue feeling confident drinking Crystal

water, and that is why we are putting our efforts into trying to identify what could have possibly happened," she further stated.

Villanueva explained that Bowen & Bowen produces bottled water in four locations in the country, and that the water undergoes an extensive and rigorous purification process, and the specific bottle was distributed from the company's plant in Esperanza.

"All our plants are subjected to the same protocols and procedures. The water is processed the same way as in our other locations. So, for us, we did find it highly unusual. Our Crystal water goes through an 11-step process to be purified, and it's a closed process; so, from the water enters the system to when it goes into a bottle, that's a closed process, so there's no opportunity along



the way to get in there," she mentioned.

While this discovery is unusual for the company, Villanueva noted that Bowen's quality control team is carrying out an investigation to determine what may have happened.

"At this point, we don't know as yet. As I said, we're looking into it. We have an entire quality control team that ensures all our facilities are producing and operating to the same standards, so they're currently looking into it. As soon as we know anything, we will share it; but for right now, we are still in the process of looking as to what may have happened ... It's been something that we've been going through, and we're doing all our processes and going through the steps one by one. No definite timeline for when we will have a response," she explained.

Belize starts 16 Days of Activism

The National Women's Commission (NWC) held an opening ceremony on Friday, November 22, to mark the start of "16 Days of Activism Against Gender-Based Violence", which is a yearly global activity aimed at disrupting the cycle of violence that affects women and girls.

The theme of this year's "16 Days of Activism Against Gender-Based Violence" is "No Excuse for Violence Against Women and Girls", and although the official start of the set of events is November 25, Belize launched the morethan-two weeks of activities a few days early in order to ensure the participation of students of the various high schools in the city.

"Technically, it starts on Monday; but



we wanted to include the schools and nearby schools downtown that have participated with us. I think this is the second year they've done so, and it's a lot easier on a Friday to get them out; and then we have the municipalities doing their launches on Monday. So, we do an overall national launch today, and then we follow up with the municipalities on Monday," said Thea Garcia-Ramirez, Chairperson of the NWC.

At Friday's event, Garcia-Ramirez drew attention to the fact that violence is embedded within the homes of many Belizeans, with young girls being taught by their mothers and elderly women to view physical violence as a natural part of relationships between men and women

"I think all of us have heard these seemingly innocuous comments growing up like, you know, 'if ih nuh beat me, ih nuh love me', or 'ih beat me but no left me', and we kind of say it in jest and so; but it's things that we've heard, and it's sort of normalized when we're growing up. I remember people [around] my grandma's age group [would] say to us as little girls—and I'm talking about ages 10 and, or so—and saying if we don't know how to cook or if we don't learn to cook – some women have no interest in cooking; and that's just a fact that we don't have to have an interest in cooking - but if you don't know how to knead, and if that tortilla did not come out round, or if that fry jack no puff, and they beat you, da cah yo look for it, because you need to know these things," she said.

"... So, it's ingrained; and then when it happens to you when you are an adult in a union or a marriage, well, my grandma tells me this may happen anyway, so it sort-of gets normalized. Or when you have a boyfriend and they say, 'Well, you know, you pick your man.' And if something wrong just, you

know, that you have to go and tek yo lick, because that's the way you ask for that; the way you look for ... as if that it's okay, and you just have to suffer and close your mouth, shut your eye and suffer through domestic violence; and it's just a fact of life," Garcia-Ramirez went on to say.

Garcia-Ramirez further explained that due to traditional gender roles, many women bear the brunt of the load at home after working a regular job, and she classified this phenomenon as economic violence.

"For instance, women who work a regular eight-to-five job, and have to come home and do unpaid work at home for at least five or six hours every day; and the man – if she has a husband or a partner – comes home, does a regular eight to five, but comes home tired and can watch TV and does nothing to help around the house; and that is normalized, and that is violence that is economic violence. We normalize that. So, you can see where tradition, upbringing, and the way we are socialized tie into our gender roles, and how these same gender roles play an important part in us accepting gender-based violence as a norm; and it has to stop," she noted.

After the opening ceremonies, several high schools within Belize City marched downtown from the House of Culture on Regent Street onto Albert Street, then returned to the start point.

assault/rape, which led to Usher being arrested and charged criminally.


The presiding judge told the court that allegations of such nature being relived in a trial over a decade later had its challenges, where in this case the victim's memory was a bit faded about precise dates and times. But in the end, the court believed the victim, who testified at age 22 about her ugly childhood trauma, and her evidence and testimony could not be shaken or disbelieved, hence Usher being found

guilty of all 5 counts.

The charges were of aggravated assault of an indecent nature - count 1; indecent assault - count 2; and counts 3, 4 and 5 were for rape of a child which occurred in the period between September 2010 in Belize City until the age of 17 when she moved from the neighborhood where she was being sexually abused and raped continuously.

It was not until October 2024 that the decade-old case came to trial where the victim, now 22, testified "In camera"

Manhattan nightclub shooting has drawn sharp rebuke from his former mentor, Sean "Diddy" Combs.

Now behind bars on charges of sex trafficking, racketeering transportation to engage in prostitution in New York City, for which he was indicted in September, rap mogul Combs of Bad Boy Entertainment has reportedly written to Shyne to caution him to "cease and desist" from the accusation that he was made the patsy for the 1999 shooting during an outing that included Jennifer Lopez. Combs said that Barrow's suggestion that he arranged for him to "take the fall" or that he sacrificed Shyne are "unequivocally false".

In a recent interview on *News5*, Grammy award winner Shyne said he has moved on and has forgiven Combs, although he alleged that Combs, "pretty much sent me to prison ... everyone was partying and having a great time with Diddy while I was left to rot in prison." Combs escaped the consequences of the shooting incident that left three persons injured. Shyne said he takes no pleasure in Combs' present woes.

Shyne spent months in the United States prior to the film's release promoting the film. He invited viewers to hear from his father himself, and from his mother, that he did not grow up with even a bronze spoon in his mouth. "Coming from a single parent household and everything that I have, I had to endure great suffering and sacrifice to get there", he recalled.

Shyne was only 21 when he was sentenced to 10 years in a state penitentiary after he was found guilty of five charges, including assault, reckless endangerment and criminal possession of a pistol. Shyne served eight, almost nine years of his sentence before he was paroled and deported to Belize in October 2009. The film also examines Shyne's path after he was released from prison, his soul-searching pilgrimage to Israel after he had converted to Orthodox Judaism behind bars, and his entry into Belizean politics upon his return to Belize in 2013, under the mentorship of his uncle, Hon. Michael Finnegan, whose parliament seat he sort of inherited when Finnegan retired from politics.

where, embarrassed by what happened to her and still in fear of her abuser, a screen was placed between her and Usher.

The victim told the court that at age 8, on September 28, 2011, until 2019 Usher touched her inappropriately on more than three occasions when other children were not around, and she told him not to do it, but he continued.

The child testified that when she would not allow him to do what he wanted, he would cover her mouth, or threaten to hurt her.

She said at the age of 13 he raped

her for the first time, and then two more times after that.

The child told the court that whenever Usher touched her inappropriately, she told her mother but she didn't believe her.

Usher, who was represented in the trial by attorney Lynden Jones of Corozal, gave an unsworn testimony from the dock, where he denied the allegations, saying he was working at the time the child claimed, so he could not do what the victim said occurred over a ten-year period. However, on a number of occasions during that period, the child would have been left in his care with other children, noted Justice Candace.

The story of Chinweuba Onumba — a great Dibia of the Igbo

You may not have heard about Chinweuba Onumba—the famous divination Dibia who was given a Certificate Merit in the Science

of Divination by the British colonial administration.

Ozoemena Nsugbe sang about his feat in one of his songs. However, aside from Ozoemena Nsugbe, the Rt. Hon. Dr. Akwaeke Nwafor Orizu, the second Senate president of Nigeria and a onetime acting president, in his autobiography, Liberty or Chains, Africa Must Be Free, wrote about how Chinweuba accurately prophesied his birth through Afa divination.

This great divination Dibia from Nando in Aguleri, Anambra State, was called by Ezeugboyamba to make inquiries about his pregnant wife. It was a common practice in the olden days to make inquiries about the future of a newly born child, or a child still in the womb.

Chinweuba, via divination, stated:

- 1. The child will be born on an Afo day. (Afo is one of the four market days of the Igbo).
- 2. An attempt will be made to kill him immediately.
- 3. He will grow up to be an illustrious son of his people.

All these prophesies came to pass as the great Dibia had predicted. Dr. Akwaeke Nwafor Orizu was born on Afo day. On the day he was born, a pot of poison, Udu Nsi, was found where he was born. He later became one of the finest Igbo statesmen of his generation.

Now, the real feat that made Chinweuba popular was when he was arrested and brought to court by some clients for whom he had done a divination. Some members of a family had come to him to ascertain whether the sick patriarch of their family would survive. But he told them to go home, because he whom they had come to enquire about was dead.

On arriving home, they found that it was true. The mind being deceitful, they believed Chinweuba may have used sorcery to kill the patriarch of their family. So they had him arrested.

In court, the white colonial judge brought out a pod and suggested to Chinweuba that, since he claimed it was through Afa he knew that the man had

for those years and raped her.

Justice Nanton told the court prior to handing down her guilty verdict on all

died, he should use the same Afa to tell the court how many seeds would be found in the pod once it was broken.

Chinweuba Onumba — Afa divination Dibia of the Igbo

A tense Chinweuba brought out his Afa. He began to call on all his ancestors who did Afa before him. He called on his Ezumezu. He reminded them that they were the ones on trial, not him. He then threw his Afa down, and asked them to open the pod, and that they would bring out six seeds.

Lo and behold! When the pod was opened in the court, they saw only six seeds. The English judge then commanded that a Certificate of Merit be immediately issued to Chinweuba Onumba. The judge stated that this was not magic, but a finely-honed tradition of the Igbo. And, that was how Chinweuba Onumba became the first Dibia to receive a licence to practice the art of divination during Nigeria's colonial era. (Report @Dshaikhism)

* This is the kind of story I tell my grandchildren, born and growing up in Britain, about their Igbo grandfather's people and culture.


I grew up in colonial Belize knowing the Grimm and Hans Andersen tales; those of the former slave - -Aesop; of the Norsemen; those of the ancient Greeks; as well as the Egyptians; and the exploits of King Arthur and his knights of the Round Table in Camelot, of ancient Britain.


I also knew the stories about the cunning feats of Brer Anancy -- the wily spider of Ghanaian folklore, known in Ghana as Kweku Ananse — who had stowed away on the ships with the slaves coming from West Africa to the British Caribbean and Belize. Anancy and his exploits are now enshrined in the memories of these descendants. I knew of Tata Duhendy, another towering figure of Belizean folklore. Much, much later, I began immersing myself in the legends of Sundiata of the great Malian empire.

Our African and Belizean stories are truly fascinating, stimulating and valid, exactly like those of other great cultures, and we owe our children the gift of telling

counts, that the court is satisfied that the medical report is consistent with what the victim said had happened to her; and while there were inconsistencies found in her testimony, she found her account plausible.

The "myths" of September 10th and October 7th

Just as in Belize there has been for years a debate over the facts and the significance of the events on September 10, 1798; so, in the past year there has been a raging debate about the facts and also the significance of the events that occurred on October 7, 2023, in Israel, where Hamas terrorists from Gaza reportedly committed atrocities against Israeli soldiers as well as civilians, including women and children—with 1,200 of those victims dying and 250 being taken as hostages. Since that terrible event, the initial bombastic claims of wanton rape of women in the streets, and babies being beheaded and burned in ovens, have been debunked. Indeed, among our own Belizean people at home and in the U.S., this dilemma has also manifested itself, where the religious right stood solidly behind their candidate, not just for his professed pro-life stand, but just as much for his pro-Israel commitment, despite the much publicized genocide in Gaza; meanwhile, many would-be Democrat voters who were pro-choice, found themselves conflicted and emotionally turned off by their party's "iron-clad" continued support and financing of Israel's genocidal campaign in Gaza. The problem for the Democrats, was that the incumbent, Joe Biden, was apparently sincerely and completely "sold" and galvanized by the reported October 7th unprovoked atrocities against innocent Israeli civilians, women and children, by Hamas terrorists; but his and Israel's prime minister's reaction to October 7th, and their continued year-long vengeful onslaught in Gaza, had turned the stomachs of many of Biden's own Democrat voters, starting with university students across the nation, and that revulsion has been shared by people across the globe, including many in Belize.

those settlers in the Bay to continue to feel that the day's events played a major role in earning them and subsequent generations the right to this Jewel called Belize? And what happened on October 7, 2023, that would make the Zionist leaders of Israel, with the support of the US president, feel justified and righteous, despite almost the whole world feeling otherwise, about their continuing murderous onslaught and destruction that has persisted for the past thirteen months and counting in Gaza?

September 10, 1798, was real; it is documented in both English and Spanish history books; but indeed, it was often overblown in regard to the extent of supposed action, the enthusiasm of the slaves, and alleged casualties in patriotic songs sponsored by the colonial British rulers. And it did not of itself give the people of the Bay ownership of this territory either, which was still claimed by the Spanish crown, having been given it by a declaration from the Pope of Rome whose word was law in those times among Europeans of the Catholic faith. But, nevertheless, it provided the evidence of history that these people were here, occupying this land, and persisted in such occupation and administration for over a century, and were never again, since September 10, 1798, displaced from this territory,

eventually becoming a British colony in 1862, and a Crown Colony in 1871. Plus, there was a treaty signed in 1859.

October 7th was a glaring and momentous attack against the Israelis by a Palestinian military group called Hamas; but October 7th was not unprovoked, and it did not happen in a vacuum. And therein lies the myth.

While September 10th marked an attack by the forces of Spain to uproot the settlers in the Bay from this area, that attack failed completely in its objective. And that is a fact.

The circumstances in Israel were completely different on October 7th. For many decades before October 7, 2023, the Palestinians were an occupied people being subjugated by Israeli forces, since 1967. Nowadays, slave rebellions in history are not condemned, because slavery was such an abhorrent and brutal institution that every slave is now considered justified to try and break free "by any means necessary". Discussing and considering the fantastical and terrible atrocities allegedly committed by Hamas on October 7th, which have permanently motivated the actions and stance of many, including US president Biden, is fruitless if one does not understand what were the conditions of the Palestinian people in the days and years before and up to October 7, 2023. And if one wishes to debate whether the efforts of Hamas were successful in achieving their objective, it must be admitted that, though it has turned out to be a humongous price levied upon the Palestinian people by Israel; nevertheless, today, November 24, 2024, the vast majority of nations of the world, including now even many European allies of the US, are stating their support for Palestine, and their agreement with the verdict of the International Criminal Court, that Israel's prime minister and defense minister are to be arrested for crimes against humanity committed against the Palestinian people. If not for October 7th, this development would not have occurred.

So, what was life like for the Palestinians including Hamas in Gaza before October 7th?

We refer to a Jewish expert on the Holocaust and the Israeli occupation of Palestine, professor Norman Finkelstein, who gave a 36-minute lecture at the GPU (Global Peace Unity) Festival, October 2024 in London. Here are just a few transcribed quotes (to the best of our ability) from a recording of Finkelstein's speech, which will hopefully spark your curiosity to listen to the whole speech:

Time doesn't allow to describe in detail what life looked like in Gaza on October 6th. But one image keeps springing to mind, with when anyone visits Gaza. So, the main U.N. official working in Gaza – this was when Gaza was under Egyptian administrative detention in 1955 – the main U.N. official there is a fellow named E.L.N. Burns. And he's asked to describe Gaza. How does he describe it? He said Gaza resembles a concentration camp. Right after the June 1967 war, the father of our wellknown senator, Al Gore, who ran for president at some point, his father visited Gaza. And in a speech, how did he describe? He said Gaza is a concentration camp. In 2004, the head of Israel's National Security Council, his name is Giora Eiland, he had to describe Gaza. And Mr. Eiland is not a peacenik; he's not the liberal. Mr. Eiland is the individual who in more recent months has been advocating the spreading of epidemics in Gaza to achieve Israel's aims. So, he's not exactly what you would call a nice guy. How did he describe Gaza? In March, 2004, he described Gaza as, quote, 'a huge concentration camp'. One of Israel's senior sociologists at the Hebrew university, he wrote a little book, and he had to describe Gaza. He described Gaza as 'the biggest concentration camp ever to exist'. Israel's most authoritative journalist on Gaza is a woman named Amira Haas; and once, she had to confront the question, and it was a personal question for her, because her parents passed through the Nazi Holocaust. And she had to describe, or she was asked the question, 'How would you describe Gaza?' She said, 'A concentration camp.'

"So, on October 7th, a large portion of that population, a large portion had been born into a concentration camp. From the first day of their birth to the last breath of their life, they were confined in a concentration camp. But it wasn't just a concentration camp, because periodically, Israel went into Gaza to, what it called, 'mow the lawn in Gaza'."

Our Belizean patriots have made great efforts to tell the story of our peaceful, constructive Belizean revolution to the world, and gain their support for our right to self-determination and independence; and, thankfully, we got the ear of the great U.S. president Jimmy Carter in 1979, and the rest is history. Los "mitos" del 10 de septiembre y el 7 de octubre

Si bien el 10 de septiembre marcó un ataque de las fuerzas de España para desarraigar a los colonos de la Bahía de esta área, ese ataque fracasó completamente en su objetivo. Y eso es un hecho.

Las circunstancias en Israel eran completamente diferentes el 7 de octubre. Durante muchas décadas antes del 7 de octubre de 2023, los palestinos fueron un pueblo ocupado subyugado por las fuerzas israelíes, desde 1967. Hoy en día, las rebeliones de esclavos en la historia no se condenan, porque la esclavitud era una institución tan aborrecible y brutal que ahora se considera

justificado que cada esclavo intente liberarse "por cualquier medio necesario". Debatir y considerar las atrocidades fantásticas y terribles que supuestamente cometió Hamás el 7 de octubre, que han motivado permanentemente las acciones y la postura de muchos, incluido el presidente estadounidense Biden, es inútil si no se entiende cuáles eran las condiciones del pueblo palestino en los días y años anteriores y hasta el 7 de octubre de 2023. Y si se desea debatir si los esfuerzos de Hamás tuvieron éxito en la consecución de su objetivo, hay que admitir que, aunque ha resultado ser un precio enorme impuesto al pueblo palestino por Israel, sin embargo, hoy, 24 de noviembre de 2024, la gran mayoría de las naciones del mundo, incluidos ahora muchos aliados europeos de los EE.UU., están declarando su apoyo a Palestina y su acuerdo con el veredicto de la Corte Penal Internacional, de que el primer ministro y el ministro de defensa de Israel deben ser arrestados por crímenes contra la humanidad cometidos contra el pueblo palestino. Si no fuera por el 7 de octubre, este acontecimiento no habría ocurrido.

El Sr. Eiland es el individuo que en los meses más recientes ha estado abogando por la propagación de epidemias en Gaza para lograr los objetivos de Israel. Así que no es exactamente lo que llamarías un buen tipo. ¿Cómo describió Gaza? En marzo de 2004, describió Gaza como, cito, "un enorme campo de concentración". Uno de los sociólogos de alto rango de Israel en la universidad hebrea, escribió un pequeño libro, y tuvo que describir Gaza. Describió Gaza como "el mayor campo de concentración que jamás haya existido". La periodista israelí más autorizada sobre Gaza es una mujer llamada Amira Haas. En una ocasión, tuvo que enfrentarse a esta pregunta, que era una pregunta personal para ella, porque sus padres pasaron por el Holocausto nazi. Y tuvo que describirla, o le hicieron la pregunta: "¿Cómo describirías Gaza?". Ella dijo: "Un campo de concentración

"Así, el 7 de octubre, una gran parte de esa población, una gran parte había nacido en un campo de concentración. Desde el primer día de su nacimiento hasta el último aliento de su vida, estuvieron confinados en un campo de concentración. Pero no era sólo un campo de concentración, porque periódicamente, Israel entraba en Gaza para, lo que llamaban, 'cortar el césped en Gaza'".

Nuestros patriotas beliceños han hecho grandes esfuerzos para contar la historia de nuestra pacífica y constructiva revolución beliceña al mundo, y ganar su apoyo para nuestro derecho a la autodeterminación y la independencia; y, afortunadamente, conseguimos la atención del gran presidente estadounidense Jimmy Carter en 1979, y el resto es historia. Desafortunadamente para el pueblo palestino, su historia completa puede haber escapado a los oídos de quienes tienen el poder de veto en la ONU. Sin embargo, con la marea cambiante de apoyo de algunas naciones occidentales a Palestina, los horrendos eventos del 7 de octubre aún pueden resultar cruciales en la búsqueda de la soberanía nacional palestina.



But the documentary put a spotlight



This is a Belizean story that began in Belize and ended in Belize. In years to come, there will be a rewrite, because nothing remains the same. I just hope that this young man never gives up. He has been through a lot in his young years, much more than most of us will experience in many lifetimes.

After seeing this documentary, the ups and downs of a man who could've simply disappeared into obscurity, I find myself reluctantly admiring the man called Shyne!





West splits on Israel: US threatens ICC & allies over Netanyahu arrest warrant

The Western alliance is divided on Israel, after the International Criminal Court issued an arrest warrant for PM Netanyahu over crimes against humanity in Gaza. US officials threaten sanctions.

The International Criminal Court (ICC) has issued an arrest warrant for Israel's Prime Minister Benjamin Netanyahu and former Defense Minister Yoav Gallant, charging them with war crimes and crimes against humanity in Gaza.

This historic decision has led to a political split in the West. The European Union, United Kingdom, Canada, and Australia have expressed support for the ICC.

On the other hand, the United States is openly attacking the ICC and threatening to impose sanctions.

US President Joe Biden blasted the ICC's charges as "outrageous". The White House said it "fundamentally rejects" the Court's order.

Washington is working with Israel to make a list of ICC officials whom they plan to sanction.

This is deeply ironic, given that the Biden administration, and particularly Secretary of State Antony Blinken, have constantly claimed to uphold a so-called "rules-based international order", while accusing US adversaries like China of supposedly violating it.

But it is not just the Democrats; the assault on the Hague is bipartisan in Washington.

Top officials nominated by Presidentelect Donald Trump, who will return to the White House in January 2025, have also threatened the ICC.

Trump's pick to be national security advisor, the neoconservative war hawk Mike Waltz, vowed to impose sanctions on ICC Prosecutor Karim Khan, while smearing the Court as "anti-semitic".

The first Trump administration hit ICC personnel with sanctions in 2020, after the Court opened an investigation into accusations of war crimes committed by US-NATO forces in Afghanistan.

The Biden administration boasted of lifting these ICC sanctions in 2021, but is now considering returning to Trump's extreme policy.

Some far-right members of Congress have gone even further. In response to the ICC's arrest warrant for Netanyahu this November, Republican Senator Tom Cotton threatened a military assault on the Hague.

Cotton referenced a law approved by the US government in 2002, known as the Hague Invasion Act (officially called the American Servicemembers Protection Act of 2002). This legislation "permits" the White House to unilaterally send troops to the Hague, in the Netherlands, to physically remove any officials from the United States or its allies who face justice at the ICC.

Countries in the Global South have long criticized the ICC, accusing it of bias in the interest of Western governments. The vast majority of officials tried at the court have been from African countries.

The decision to issue arrest warrants for Israeli officials appears to be an



British Museum to conduct internal review of Olmec mask and Santa Cruz idol replica in the Thomas Gann collection

The British Museum will conduct an internal review of information it holds about two pieces in the 8,000,000-object collection kept by the museum. Both items are in the Thomas Gann Collection of the museum and have attracted controversy over their origins. The internal review has been forced on the museum by Freedom of Information Act requirements and will be conducted by a senior museum official.

The internal review, expected to be completed in December, will look at an Olmec mask and the Santa Cruz idol replica. The museum's catalog entry says it purchased the mask from collector Thomas Gann in 1938, the year of his death. However, the museum says it cannot say how much was paid for the serpentine mask. The Santa Cruz replica only turned up in a museum storeroom in 1991, bears the facial image of Gann, and is alleged to have been found at Tulum, Mexico. The museum cites as proof the replica is a genuine ancient artifact, a photograph of Gann and the idol. However, the book Ancient Cities, which contains the photograph, also has a picture of the real Santa Cruz idol still in its hidden jungle shrine. The museum refuses to admit it holds a 1927 replica and not the genuine relic.

The internal review request explains why the museum should examine its records more carefully.

"While you have provided a scan of the Register and a brief 1938 article about the Olmec mask, you have not provided any financial information indicating how much the Museum paid Gann or his estate for the mask. Further, the mask has been extensively exhibited internationally over the years and it is difficult to believe that there are no 'records, letters, emails, memoranda, summaries' or other information that discusses the origin of the mask with the other museums."

"You have not provided any receipts or financial information on any of the objects purchased from Thomas Gann or his estate. It is difficult to believe the Museum has such lax financial records for its acquisitions. If the Museum does not know how much it paid for an object, it raises the question how does the Museum really know it purchased the object."

'While you have acknowledged that no scientific testing of the stucco figure has been conducted and provided a photograph of Gann and the figure, you have not provided 'any and all records, letters, emails, memoranda, summaries' or other information that discusses the figure. Further, the figure was exhibited as a genuine ancient artifact at Cambridge University in 1992, the year after the figure was found unregistered in a Museum storeroom. It is difficult to believe that there were no communications with Cambridge University regarding the figure's discovery and lack of provenance information.'

The British Museum is currently undertaking another internal review of interest in Belize. The museum has refused to provide copies of its expedition reports to British Honduras for 1926-1930. Even though the museum already has the reports in digital form and could provide them to the public via the internet with a keystroke, the museum insists the public obtain the reports from a private subscription service which charges \$40 BZD for each year's report of approximately a dozen pages. Reports for the five-year period would cost a total of \$200 BZD. The issue in that internal review is whether the pay-to-read requirement is in keeping with the museum's free admission policy. A decision in that internal review is expected sometime near the end of November.

attempt to save the international reputation of the Court.

Nevertheless, the ICC also faced criticism for delaying the arrest orders. Prosecutor Karim Khan initially announced the charges against Netanyahu and Gallant, as well as against a commander of the Palestinian armed group Hamas, back in May 2024. It took six months for the arrest warrants to finally be issued.

Throughout this time, the US government was putting significant pressure on the ICC, threatening personnel.

Senator Lindsey Graham warned in May that, "if they'll do this to Israel, we're next!"

In June, the US House of Representatives approved legislation that would impose sanctions on the ICC. The bill passed with support from more than 200 Republicans, along with 42 Democrats.

United Nations accuses Israel of genocide and ethnic cleansing in Gaza

The United Nations convened a special committee to investigate Israel's warfare methods in Gaza, and it concluded in a November report that they are "consistent with the characteristics of genocide, with mass civilian casualties and lifethreatening conditions intentionally imposed on Palestinians there".

Israel's leading human rights organization B'Tselem has warned that the Netanyahu regime is carrying out a concerted campaign of ethnic cleansing in northern Gaza, expelling indigenous Palestinians from the home with plans to annex and colonize their land, so they can never return.

UN Secretary General António Guterres has called on the world to prevent Israel's ethnic cleansing in Gaza.

EU, UK, Canada, Australia support ICC, breaking with US

While the leaders of both major political parties in the United States are threatening the International Criminal Court in defense of Israel, some major Western allies have broken ranks.

Australia, Canada, and the United Kingdom said they would abide by the ICC's order and arrest Netanyahu if he entered their territory.

The European Union's foreign policy chief Josep Borrell likewise stated that Brussels would honor the arrest warrant, stressing, "The states that signed the Rome convention are obliged to implement the decision of the court. It's not optional".

The top EU diplomat pushed back against the Israeli regime's baseless accusations of "anti-semitism". Borrell asserted, "I have the right to criticize the decisions of the Israeli government, be it Mr. Netanyahu or someone else, without being accused of antisemitism. This is not acceptable. That's enough".

Among EU members, the governments of Belgium, France, Italy, Ireland, and the Netherlands have publicly clarified that they would respect the ICC decision and arrest Netanyahu.

Republican Senator Lindsey Graham responded to the countries that support the ICC by threatening to impose sanctions on them and "crush" their economies.

"To any ally — Canada, Britain, Germany, France — if you try to help the ICC, we're going to sanction you", Graham vowed on Fox News.

"We should crush your economy", Graham said to the US allies. "Because we're next", he added in fear.

Far-right regimes in Hungary and Argentina back US attacks on ICC

Unlike the EU leadership and many European states, Germany has said it will not abide by the ICC's order.

One EU member that has openly attacked the ICC is Hungary, which is governed by far-right leader Viktor Orbán, a close ally of Israel and an anti-Muslim demagogue. In defiance of the Hague, Orbán invited Netanyahu to visit Hungary.

Joining the US and Hungary in condemning the ICC was Argentina's far-right President Javier Milei, a self-declared "anarcho-capitalist". Although Milei is a close Trump ally, he and Biden are in alliance on Israel.

In the UN General Assembly in September, Hungary and Argentina also sided with the United States in voting against a resolution that demanded an end to Israel's illegal occupation of Palestinian territories within 12 months.

Much of Europe abstained in this vote, however several key EU states endorsed the resolution, including Belgium, France, Ireland, Portugal, and Spain.

The lack of provenience records for objects in the Gann collection at the British Museum, and Gann's reputation as a looter of burial mounds have triggered recent social media calls for the return of Maya relics to Belize where Gann did most of his digging. A new Maya exhibit at the Belize Museum highlights growing interest in the country's prehistory. Thus far the British Museum has made no

public overtures toward repatriation of Gann's loot to Belize.
