

Belize's economy has bounced back!

Central Bank reports full economic recovery from pandemic and reducing inflation

BELIZE CITY, Wed. Nov. 27, 2024

The Central Bank of Belize (CBB) is reporting a full recovery of Belize's economy from the pandemic as well as falling inflation which had surged to 6.3% at its peak in 2022. At the CBB's latest press conference to present updates on Belize's economic landscape, Central Bank Governor, Kareem Michael remarked, "The Belizean economy has proved itself to be resilient." He listed the COVID pandemic, the oil price shock due to the Russia-Ukraine war, and adverse shocks from climate-related events including Hurricane Lisa in 2022, as negative occurrences that Belize has weathered. "Today, we can confidently

Ever-closer NW screwworm has Belize authorities concerned

As of mid-November, there were 13 officially confirmed cases in Guatemala

BELMOPAN, Tues. Nov. 26, 2024

The discovery of the potentially devastating NW screwworm in municipalities very near to Belize has local agricultural authorities concerned. Servulo Baeza, CEO in the Ministry of Agriculture and Food Security, told *Amandala* today that an infected head of cattle was intercepted on November 22 in southern Mexico at one of their checkpoints established in Catazajá, Chiapas as part of their screwworm prevention measures.

Mexico had eradicated the NWS screwworm over 30 years ago in 1991 along with Central American countries. Their Ministry of Agriculture, in a release on the discovery, reported that the


"Sweet Bwai Caine" off to jail

BELIZE CITY, Thurs. Nov. 28, 2024

On Tuesday of this week, a traffic officer was assaulted by as many as three persons while carrying out his duties, and tonight one of the culprits, who was identified in an amateur phone video of the attack that went viral, is behind bars.

That assailant is 31-year-old Evan Nicholas Caine, aka "Sweet Bwai Caine", a part-time bus conductor/caregiver who resides in Biscayne Village at Mile 23 1/4 on the Philip Goldson Highway.

According to police, 46-year-old Kenrick DeShield visited the police station and reported that whilst conducting duties between Miles 2 and 3 around 7:30 on Tuesday morning, he stopped a Bluebird bus heading from Benny's towards the Smart headquarters because the door was wide open, and he noticed the presence

 Last week, it was reported that most of Crooked Tree Village in the Belize District was submerged under water that flooded the area following the downpour of Tropical Storm Sara, thus making it difficult for village residents to commute without the assistance of boats. Several days later, Burrell Boom Village and surrounding villages were also inundated by the high-rising water from the Belize River which spilled over into homes and covered the village’s main entrance, making it impossible for lower vehicles to enter.
Amandala visited the Burrell Boom Village on Wednesday afternoon, November 27, and while it was impossible for us to go as far as we had planned into the interior of the village due to the high water level, we saw several homes underwater and residents using canoes to leave their

of this; but so far, [it] don’t look like it’s going down; it looks like it’s rising more than anything else,” he said.
 “... We have a [two-story] house, but the upstairs isn’t an area that you can take beds there; it doesn’t have any roof or anything on it as well. In that case, we have to find a way to move out of the area and see if we could work,” he added.
Amandala visited Black Orchid Resort where its owner, Douglas Thompson, told us that since opening his business in 2005, this has been the third flooding he has experienced.
 “This is our third time dealing with flooding from the river. 2008 was the worst so far. 2020 was worse than this. So, it seems to be receding, and it has done enough damage as is, but we are fortunate it doesn’t get any higher. Whatever we are experiencing is already on the ground and not raining. We’re keeping our fingers crossed that this is it, and maybe [in] a week or week

homes.
 A village resident told *Amandala* that although the water level is not as high in his yard as it is in some other yards, he is concerned about the level of the water, which could potentially cover the adjoining roads in the next few days.
 Hubert Carcamo, a longtime resident of Burrell Boom, described his own experience to *Amandala*.
 “We have to use our means of transit which are canoes. So far, how has it affected us? The inside of the house has about 2 feet of water, so the good thing about it was we got a head start to elevate everything. Other than that, we have to see what will be the result

and a half the water should be gone,” he said.
 According to Thompson, despite the flooding, most guests did not cancel their stay or leave early. However, work has to be done to restore the structures of the establishment, and several planned events will have to be canceled or postponed.
 Thompson noted that he has been receiving less guidance and advisories from government departments than he had received in previous years.
 “What we don’t have this time ... then, what we had in the past is

Immigration and Customs forms to be electronic

BELIZE CITY, Thurs. Nov. 28, 2024
 The Cabinet has announced via press release that Immigration and Customs departure and arrival forms at the Philip Goldson International Airport (PGIA) will be electronic starting December 1, 2024.



The change is a collaborative effort involving the Department of Border Management and Immigration Services, the Customs and Excise Department, and the Ministry of Public Utilities, Energy, Logistics, and E-Governance.
 On the date above travelers will use the platform to complete and submit the required immigration and customs information in advance through a user-friendly web link, enhancing data accuracy and streamlining the travel experience.
 It will only be available to persons entering and departing through the

PGIA. It is a three-month trial phase until transitioning to a fully online process. During the trial phase both versions of the forms – physical and digital – will be accepted, but travelers will be encouraged to participate in the digital option.
 This new strategy is a part of the Government of Belize’s plan to eliminate paper forms by March 31, 2025, the aim being to provide a modern travel procedure that will enhance the overall traveler experience for a faster and more convenient process. In the second phase, starting the end of January 2025, the other ports of entry in Belize will implement the change.

Central Bank to revise limits on foreign currency for travel

BELIZE CITY, Wed. Nov. 27, 2024

At its press conference on Wednesday, the Central Bank of Belize (CBB) reported on four of over 50 special projects it says it is currently spearheading. Among them is exchange control modernization, and in particular, revising the limits for foreign currency travel facilities to ease travel. Governor Kareem Michael shared that currently, authorized dealers of foreign currency (domestic banks) can issue US \$250 per day for business travel, whereas those travelling for medical and vacation purposes can get US \$3,000 each. Deeming the limits to be outdated, the Central Bank intends to introduce an increase across the board to US \$10,000. This will take effect in January 2025. As expected, supporting documentation must be provided to bank tellers.
 The Central Bank is also embarking on an update of the exchange control regulatory framework with the assistance of an IMF technical assistance mission. The work will also feature strengthening the exchange control administrative processes, and digitizing the data recording and monitoring system. An effect of this will be increased efficiency, as an applicant for a foreign currency permit will soon be able to use an online portal rather than filling out a form, and emailing it to the Bank or printing it to take to an authorized dealer. They will then be directed to the dealer of their choice to pick up the foreign currency.

the mandate to oversee the credit union sector since 2005. Today, Governor Kareem Michael informed the public that they have been working to increase the sector’s resilience and competitiveness. The assets held by credit unions in Belize have expanded to over 1 billion dollars since 2006, and they have also increased their range of products and services. The CBB is working on new credit union legislation to replace the original act that was enacted in 1944 and revised partially in 2022. Additionally, the bank intends to liquidate 19 inactive and defunct credit unions to eliminate “potential financial liabilities and risks to the overall financial stability ...”

Implementation of credit reporting system planned for 2026

The Central Bank has been working for some time on implementing a Credit Reporting System (CRS). Governor Michael has pointed to the lack of such a data-driven system as one factor contributing to stubbornly high interest rates because the banks and financial institutions lack information on a customer’s creditworthiness to properly assess risk. At today’s conference, it was announced that the CRS should finally be operational in 2026 after the establishment of a Credit Bureau. Once the CRS comes on stream, customers will have a credit score based on their reputational collateral through their credit history. This will prove their capacity to repay their debt. The credit history will come from standardized non-traditional data like utility

Joshua Ashburn's wife charged and remanded

BELIZE CITY, Thurs. Nov. 28, 2024

Tonight, the wife of businessman Joshua Moses Ashburn of Western Avenue joins him behind bars on four criminal offenses, including kept prohibited firearm and ammunitions and 2 counts of possession of a controlled drug with intent to supply.

She is 37-year-old businesswoman Xochil Natalie Lopez, a resident of #1 Halfmoon Street, Belmopan.

Late this evening Lopez, who was represented in court by attorney Dale Cayetano (former Family Court Director), appeared before a Senior Magistrate in Court #6.

Inside the courtroom, Lopez was read four criminal offenses, one count of kept prohibited firearm without a gun license for a black Glock Gen 5 USA 40 calibre pistol, one count of kept prohibited ammunitions for 24 .40 S&B, S&W brand live rounds of ammunitions; and two counts of possession of a controlled drug for 7,311.91 grams of cannabis and 1,696.44 grams of cannabis.

Lopez pleaded not guilty to all charges; but, due to the nature of the offenses she was remanded into custody at the Belize Central Prison until January 20, 2025. The sitting Senior Magistrate of Court #6 told her that under Section 16 of the Crimes Control Criminal & Justice Act, the Magistrate's hands are tied from offering her bail.

Lopez was advised that she has the right to apply for bail at the High Court with the assistance of her attorney.

Lopez now joins her husband, Joshua Moses Ashburn, 47, a businessman and a resident of #6917 Western Avenue, Belize City. Ashburn, along with 2 others, Mario Fernandez and 20-year-old Keenan O'Connor, had been charged earlier.

On Monday, November 25, 2024, while the trio all pleaded not guilty to the kept prohibited firearm and

ammunitions, Ashburn wanted to plead guilty to the two counts of possession of a controlled drug. He told the court he was guilty to possession "simplicita" but not with intent to supply anyone. He said that, however, he never got an opportunity to speak to his attorney.

Meanwhile, O'Connor and Fernandez pleaded not guilty to all four counts.

However, the sitting Senior Magistrate of Court #6 told Ashburn that the charge before the court is for possession of a controlled drug with intent to supply, and so she could not accept a plea for a lesser charge; thus, his guilty plea for possession simplicita was rejected, and a plea of not guilty entered on his behalf.

Fernandez told the court that he only went there for work, that he never knew drugs was at the yard. Fernandez was represented in court on Monday by attorney Sharon Pitts-Robateau.

The four persons now facing the charges will appear together for the first time on January 20, 2025.

Man accused of assaulting a police officer remanded to prison

A policeman claims he was assaulted by the Saldano brothers who were armed with a gun, and this week police have levied charges of aggravated assault upon the brothers, the older brother also being slapped with a charge of escape.

They were picked up separately. First to be detained was the older brother, Edward Saldano, followed by his younger brother, Damion.

On Monday, November 25, 2024, Edward Saldano was arraigned before a Magistrate in Court #7 where he was read two counts of aggravated assault with a firearm upon police constable, Briceno Shal.

Edward Saldano was also read a charge of escape from lawful custody. He pleaded not guilty to both charges, but due to the nature of the offenses bail was denied and he was remanded into custody at the Belize Central Prison until January 8, 2025.

At 2:00 p.m. this afternoon, Damion Saldano, 23, a resident of M & M Street, Belize City, appeared unrepresented before a Magistrate in Court #7. He wanted to plead guilty; but on hearing that he would go to jail for 3 years, he entered a not guilty plea. Damion cried when he learned that despite his not guilty plea, he was going to jail on

remand.

He told the court that he cannot go back to jail for something he never did.

According to Damion Saldano, everything bad that happens, the police link him with his brother.

Initially, after being read the charge of aggravated assault, Damion Saldano told the court that the police officer fabricated the story. He said he spoke with the officer who told him that he didn't understand why the police charged him because he (the officer) never told them that he was assaulted with any gun. He told the court that the officer wanted to withdraw the charge.

But that's Damion Saldano's version. The matter was stood down for a while and checks were made, and the virtual complainant's name, Briceno Shal, was called outside the court room, but he was a no-show. Saldano's arraignment continued at around 3:00 p.m.

Due to the nature of the offense, Damion Saldano was denied bail and remanded into custody at the Belize Central Prison until January 8, 2025, where he will now join his older brother, Edward Saldano.

The incident which has landed both brothers behind bars is said to have occurred on Thursday, November 21, 2024, in Belize City.

Motorcycle collision kills man, injuries woman

A motorcycle accident claimed the life of a well-known electrician from the Toledo District on Wednesday night, November 27, and left a woman injured.

The deceased has been identified as

45-year-old Jose Hoppington of Independence Village and the injured woman is 34-year-old Xiomara Molina, a high school teacher.

Hoppington was riding a motorcycle after 9:00 p.m. in Bella Visita Village, Toledo District when he collided with Molina who was also riding a motorcycle in front of the Toledo Teacher's Credit Union.

Reports suggest that the motorists collided head-on. Hoppington was transported to the Independence Polyclinic where he was pronounced dead. Molina sustained injuries to her forehead, left leg, and left forearm and remains hospitalized at the Independence Polyclinic.

Police are investigating the circumstances of the fatal accident.

Big changes coming to PG

PUNTA GORDA TOWN, Toledo District, Thurs. Nov. 28, 2024

The Government of Belize has announced two huge changes that will be coming to southern Belize that will make an economic impact on the Toledo District.

First, Cabinet approved the extension of the operational hours of the Punta Gorda Port of Entry. Previously, the facility only operated on weekdays. It was nonfunctional on the weekends, and that had a negative impact on economic activity in the town. However, all that has changed with the Cabinet decision this week.

Hon. Dr. Osmond Martinez, Area Representative of Toledo East told *Amandala* that the new operational hours for the Punta Gorda Port will be from 6:00 a.m. to 6:00 p.m. on weekends. Weekdays operation will remain from 8:00 a.m. to 5:00 p.m.

Martinez added that he and the Prime Minister of Belize, Hon. John Briceño, after analyzing the Port's new operational hours, believe it will create



employment and enhance economic activity in Punta Gorda Town.

Cabinet's other approval is for tourism enhancement in Punta Gorda Town through modern infrastructure and marina development.

Martinez said that the marina will attract nearby boat owners from Guatemala to moor their vessels at the marina and allow them to spend time in Belize. He said that this will have a domino effect, as the growing number of tourists flocking to Punta Gorda Town will lead to more investors in the municipality.

The marina, whose estimated cost was not disclosed, as adjustments are still being made, will be funded by the Belize Tourism Board (BTB).

government. I don't [know] what department it was; they used to call every day and talk to us about the height of the water, and give us an idea of what to expect. In this instance, we don't have any knowledge of how much water to expect. It could have been much higher than this, but we could have known from the experience instead of by information provided by some department that should be able to [advise] us on the ground. We got nothing. I'm not trying to criticize the government, but they could have done a better job of monitoring and informing people. This flood is going to be in Belize City; there is no question about it. How much water and when? They should be telling Belize City residents who are in the zones that get flooded," he said.

Carcamo also said that there has not been a sufficient NEMO presence in the village during the flooding. However, today, Thursday, *Amandala* reached out to the chairman of Burrell Boom Village, Anselm Gillett, who informed us that members of NEMO had arrived at the village and were helping some residents.

"We try our best fu move who wahn move, but Belizean people stubborn. So, you can't force anybody but thank God, [it] looks like the water is going down now, so I'll give it another week before the water goes back to normal. If, there isn't any other rain," he said.

As previously mentioned, Crooked Tree Village was the first rural community to experience major flooding as a result of Tropical Storm Sara, forcing commuters to use boats. It was

reported last week that the operators of the commuters' regular bus had refused to return to the village because water levels had reached the second step of the bus.

According to George Tillett, chairman of Crooked Tree, over 100 persons, consisting of workers and students at various levels, normally commute daily via the buses from Crooked Tree across the causeway to the main road and on to the Philip Goldson Highway and their destinations which are mostly in Belize City; but with the floods, they need to be ferried by boats from Crooked Tree island through the length of the causeway to the main road, so they must exit the village by boat as early as 4:00 a.m. to ensure a seat on the bus that waits at the main road junction with the causeway.

As of the publishing of this article, Crooked Tree is still inundated, but an estimated 5 inches of water have receded since yesterday. Nonetheless, Tillett mentioned that "the island" has been split into five smaller ~~other~~ islands due to some parts being submerged while other areas of higher ground remain above water level; and he expects that vehicles will not be able to enter the village for the next 4 to 5 weeks. Tillett highlighted that as a result of the flooding, an estimated 7 individuals have been placed into shelters, with the possibility of them residing there for the next month or more.

In addition to the inundated portions of Crooked Tree and Burrell Boom, some low-lying areas of the Lords Bank community have also become flooded, forcing some residents to evacuate.

Inauguration of Coast Guard base in Big Creek

BIG CREEK, Toledo District, Thurs. Nov. 28, 2024

In celebration of the Belize Coast Guard's 19th anniversary, an inauguration ceremony was held on Thursday, November 28, for the opening of its Big Creek base in the Stann Creek District.

"19 years ago, the Government of Belize decided to form the Coast Guard. What is the purpose of the Coast Guard? When I was going to school, history taught me about pirates and buccaneers roaming the sea and confiscating any boat out at sea. So, countries around the world decided it was best to create a team to manage the coast, sea, and ocean to mitigate the amount of discrepancy on the high seas. And 19 years ago, Belize decided to do likewise, and I must say they are doing an excellent job," said Hon. Rodwell Ferguson, Area Representative for Stann Creek West.

"Before the Coast Guard, we used to call on the police or the BDF, but the Coast Guard understands the movements of the sea [better] than the BDF and the police. So, many times they are called upon, and they are there to the rescue. Most times they do a successful rescue and save lives ... As we celebrate the 19th anniversary of our Coast Guard, it is a major milestone [and] I know, as the country grows, we are going to have more demands for additional Coast Guard for the country of Belize," he added.

During the ceremony, Rear Admiral Elton Bennett, Commandant of the Belize Coast Guard, remarked on the success of the Coast Guard and achievements since its inception in 2005.

In August of this year, the Belize Coast Guard went airborne by introducing its drone squadron. Rear Admiral Bennett highlighted that since implementing this new capability, four

of its pilots have been qualified as trainers, and three of the Coast Guard pilots have gone to Mexico City to participate in training in drone operations.

"This new operational dimension bridges a gap in our capability, now enabling your Belize Coast Guard to conduct aerial surveillance in support of marine conservation efforts, while simultaneously supporting every one of our 22 other Coast Guard missions that have been given to us through legislation for us to execute," said Rear Admiral Bennett.

He mentioned that the Coast Guard can access the Cooperative Situational Information (CSII) and is a part of the All Partners Access Network.

"With these technologies and networks, your Coast Guard is well poised to better deter drug trafficking from our shores," he added.

One of the traditional threats monitored by the Coast Guard is drug trafficking, and in a notable successful mission officers seized two high-powered military-grade firearms and ammunition from a remote island.

During the past year, criminals collared by the Belize Coast Guard have paid more than \$53,000 in fines, and officers of the Coast Guard have confiscated more than 750 feet of gillnets from our waters to prevent illegal fishing in Belize's waters. 126 lives were saved out at sea including pulling people from the water, rescuing vessels that were in distress, and providing medical care.

"Even at 19 years of service, the Coast Guard must continue to seek new capabilities, and years of development to meet the new challenges that we face in an ever-increasingly complex security environment," Rear Admiral Bennett said.

The Big Creek base joins 5 other locations in Belize where the military conducts its operations.

It was built for 1 million dollars.

Capitalists who condemn welfare are myopic and unfeeling

Most Belizeans living in the mighty USA (Belizeans/BelAms) are accomplished, having taken advantage of the myriad opportunities that exist in a country that has been the dominant economic and military force on the planet since the end of World War II. Their observations are valuable because they provide a firsthand view to add to what we read in newspapers and see on the television about the country which, when it sneezes, we *kech* cold.

Most Belizeans in the US, definitely the vocal ones, are sympathetic to the right of center Democratic Party. But there are Belizeans in the US who champion the values of the far-right Republican Party, and they aren't shy about making known where they stand on the issues over there. Brother Neri Briceno, an "oil man" who is listed in his *LinkedIn* profile as the Associate Director of Operations at Central Park Conservancy, is a frequent contributor to *The Reporter*, and host of Plus Television's morning show when he is vacationing in Belize. He is from the latter group.

In a commentary about the recently concluded presidential election in the US published in *The Reporter*, titled, "The New Trump Era", Mr. Briceno said: "The push for a welfare state also played a part in the Democrats' loss. While the U.S. has long had safety nets, the idea of a government-dominated welfare system rubbed many people the wrong way. The Democrats' focus on expanding the welfare state and making more people dependent on government handouts, did not sit well with the typical American voter, who still believes in the idea of the American Dream—working hard and getting ahead."

The US economy is the largest on the planet, and the vast majority of its 300 million plus citizens enjoy a standard of living that is among the highest. The US is wealthy, with enough to take care of the needs of all, but because of extreme wealth disparity, and an insufficient safety net, there are pockets

of severe poverty. It is estimated that over half a million unemployed or underemployed Americans live in makeshift abodes or on the sides of streets, and the high cost of healthcare bankrupts thousands each year. Describing a country that could turn its back on so many of its own as a welfare state seems imaginative.

The new US government promised to put the clamps on this "government-dominated welfare system", and cut fat in government. Subsidies for healthcare, education, and food are to be reduced, and the two million plus individuals employed by the federal government are going to see their ranks severely diminished. Outlining what's in store for the latter, a story by Jazmin Tolliver in *Huff Post* that discusses a new Cabinet appointee is titled, "Vivek Ramaswamy Pledges To 'Delete' Entire Government Agencies Alongside Elon Musk", and the title of a story in *Business Insider* by Ayelet Sheffey and Madison Hoff is, "Musk's DOGE [Dept. of Govt. Efficiency] wants to 'delete' entire government agencies."

In the name of efficiency, the Americans are going to guillotine workers, when their country has more than enough to feed, clothe,

house, and provide the best available healthcare for ALL its citizens. The Americans have the money to take very good care of all the country's citizens, but doesn't do so, because "people [being] dependent on government handouts [does] not sit well with the typical American voter ..."

There are Belizeans on the far right who would call our country a welfare state because of the expanding NHI, the large number of public servants, school subsidies for children and youth from not-so-well-off families, and various pantries. They would throw a party if the government announced that it would gut the ranks of the public service in the name of efficiency, if, of course, it doesn't directly impact them.

Indeed, it is accepted by many economists that government could run as well as it does now with several hundred fewer employees. And at this period in our existence, it does seem that there are jobs aplenty in the booming BPO industry for those who would be displaced. We must pray that growth in the call center industry doesn't stagnate, because it provides a reasonable income for our young people until they can find or create the kinds of jobs that remunerate them better.

We live in a time of dramatic change, with negative things occurring in the natural world—extreme weather phenomena and species on land and in the sea facing extinction; and in the man-made world there are major technological advances, which, depending on how they are managed, could lead to great good or grave injury.

In respect to the man-made world, in years past there were more jobs that involved taming the forest for agricultural purposes than machete/axe gangs in the country could handle. That work is now being done by bulldozers and other heavy equipment. More and more sugarcane plantations are using mechanical harvesters. Quite likely, there will be mechanical harvesters in the citrus orchards when the industry recovers. Major sections of modern shrimp farms are almost completely automated. In the world of education there are made-for-television modules that can replace flesh-and-blood teachers in a number of areas.

People who heap scorn on the "welfare state", scorn on people at the bottom of the ladder, will quickly change their tune when automation, artificial intelligence, replaces them in the workplace. Many a smug capitalist will be driven to their knees, begging for crumbs when the robots are unleashed, if "placement" isn't found for them so they aren't left out in the cold. Some of the most aggressive capitalists change their tune when LIFE happens to them—an illness that only the super expensive specialists can heal, a lawsuit against them that only the highest-priced lawyers can resolve, a decision by government or a new development that leaves their business high and dry, bankrupt and indebted to the gills.

These technological advances should make it easier for people to survive, not displace them. With the massive amount of wealth that the Americans have piled up through technological advances, much of it in the hands of a few individuals, they can afford to extract less from "vassal" states around the world. But that is wishful thinking. The American dream of greatness is to have more, and more, and more material wealth. There are Americans who have a heart for the less well-off. They are not the majority.

We have to take care of ourselves. If we call a bloated public work force, NHI, school subsidies, and various pantries, welfare, then we embrace the welfare state. Our economic system must be geared toward ensuring that the needs of everyone—the hardworking, the brilliant, those less gifted to function in the present system, even those who are called lazy—get taken care of. This is not a call for slacking off. People need jobs. The human being must have purpose; human beings must feel that they are making a contribution. The axe man found a job handling the chainsaw. Soon a robot will apply for his job. Government must help him find a new one.

The tools of production must be in the hands of those who are capable and ambitious. The resources of government must facilitate businesses, production. But the heroes and heroines in the marketplace can't hoard all the wealth. Big machines, robots, and computers are doing the heavy lifting. If we secure these tools and our leaders appreciate that "welfare" is essential in a capitalist system, all of us will win.

Los capitalistas que condenan la asistencia social son miopes e insensibles

La mayoría de los beliceños que viven en el poderoso Estados Unidos (beliceños/*Belams*) son personas exitosas, que han aprovechado las innumerables oportunidades que existen en un país que ha sido la fuerza económica y militar dominante en el planeta desde el final de la Segunda Guerra Mundial. Sus observaciones son valiosas porque proporcionan una visión de primera mano que se suma a lo que leemos en los periódicos y vemos en la televisión sobre el país que, cuando estornuda, nos resfriamos.

La mayoría de los beliceños en los Estados Unidos, definitivamente los más expresivos, simpatizan con el Partido Demócrata de centro-derecha. Pero hay beliceños en los Estados Unidos que defienden los valores del Partido Republicano de extrema derecha, y no son tímidos a la hora de dar a conocer su postura sobre los problemas que se viven allí. El hermano Neri Briceno, un "petrolero" que figura en su perfil de *LinkedIn* como Director Asociado de Operaciones en Central Park Conservancy, es un colaborador frecuente de *The Reporter* y presentador del programa matutino de Plus Television cuando está de vacaciones en Belize. Él pertenece a este último grupo.

En un comentario sobre las elecciones presidenciales que acaban de concluir en Estados Unidos y que se publicó en *The Reporter* y que lleva por título "La nueva era de Trump", Briceno dijo: "La presión a favor de un estado de bienestar también influyó en la derrota de los demócratas. Si bien Estados Unidos ha tenido redes de seguridad durante mucho tiempo, la idea de un sistema de bienestar dominado por el gobierno no le sentó bien a mucha gente. El enfoque de los demócratas en expandir el estado de bienestar y hacer que más personas dependan de las dádivas del gobierno no le sentó bien al típico votante estadounidense, que todavía cree en la idea del sueño americano: trabajar duro y salir adelante".

La economía estadounidense es la más grande del planeta y la gran mayoría de sus más de 300 millones de ciudadanos disfrutan de un nivel de vida que se encuentra entre los más altos. Estados Unidos es rico, tiene lo suficiente para atender las necesidades de todos, pero debido a la extrema disparidad de riqueza y a una red de seguridad insuficiente, hay bolsones de severa pobreza. Se estima que más de medio millón de estadounidenses desempleados o subempleados viven en viviendas improvisadas o en las cunetas de las calles, y el alto costo de la atención médica lleva a la quiebra a miles de personas cada año. Como un estado de bienestar, describir a un país que podría darle la espalda a tantos de los suyos parece imaginativo.

El nuevo gobierno de los EE.UU. prometió ponerle freno a este "sistema de bienestar dominado por el gobierno" y recortar los gastos del gobierno. Se reducirán los subsidios para la atención médica, la educación y la alimentación, y los más de dos millones de personas empleadas por el gobierno federal verán sus filas severamente reducidas. Para resumir lo que les espera a estos últimos, una historia de Jazmin Tolliver en el *HuffPost* que habla de un nuevo nombramiento al gabinete se titula "Vivek Ramaswamy se compromete a 'eliminar' enteras agencias gubernamentales junto con Elon Musk", y el título de una historia en *Business Insider* de Ayelet Sheffey y Madison Hoff es "El Departamento de Eficiencia Gubernamental (DOGE en inglés) de Musk quiere 'eliminar' enteras agencias gubernamentales".

En nombre de la eficiencia, los estadounidenses van a guillotinar a trabajadores, cuando su país tiene más que suficiente para alimentar, vestir, albergar y brindar la mejor atención médica disponible para TODOS sus ciudadanos. Los estadounidenses tienen dinero para cuidar muy bien de

todos los ciudadanos del país, pero no lo hacen porque "la gente [siendo] dependiente de las dádivas del gobierno no le sienta bien al típico votante estadounidense."

Hay beliceños de extrema derecha que llamarían a nuestro país un estado de bienestar debido a la expansión del NHI, la gran cantidad de funcionarios públicos, los subsidios escolares para niños y jóvenes de familias no tan adineradas y las diversas despensas. Harían una fiesta si el gobierno anunciara que limpiaría las filas del servicio público en nombre de la eficiencia, si, por supuesto, no los afecta directamente.

De hecho, muchos economistas aceptan que el gobierno podría funcionar tan bien como lo hace ahora con varios cientos de empleados menos. Y en este período de nuestra existencia, parece que hay muchos puestos de trabajo en la floreciente industria de SPE para aquellos que se verían desplazados. Debemos rezar para que el crecimiento en la industria de los centros de llamadas no se estanque, porque proporciona un ingreso razonable para nuestros jóvenes hasta que puedan encontrar o crear el tipo de trabajos que los remuneran mejor.

Vivimos en una época de cambios dramáticos, en la que ocurren cosas negativas en el mundo natural: fenómenos climáticos extremos y especies terrestres y marinas en peligro de extinción; y en el mundo creado por el hombre hay grandes avances tecnológicos que, dependiendo de cómo se gestionen, podrían producir grandes beneficios o graves daños.

En lo que respecta al mundo creado por el hombre, en años pasados había más trabajos que implicaban domesticar el bosque para fines agrícolas de los que podían realizar las cuadrillas de machetes y hachas del país. Ese trabajo ahora lo realizan excavadoras y otros equipos pesados. Cada vez más plantaciones de caña de azúcar utilizan cosechadoras mecánicas. Es muy probable que haya cosechadoras mecánicas en los huertos de cítricos cuando la industria se recupere. Grandes secciones de las granjas camaroneras modernas están casi completamente automatizadas. En el mundo de la educación hay módulos hechos para la televisión que pueden reemplazar a los maestros de carne y hueso en varias áreas.

Las personas que menosprecian el "estado de bienestar", menosprecian a las personas que están en la parte inferior de la escala, cambiarán rápidamente de tono cuando la automatización, la inteligencia artificial, los reemplace en el lugar de trabajo. Muchos capitalistas presumidos se verán obligados a arrodillarse, mendigando migajas cuando se desaten los robots, si no se les encuentra "colocación" para que no queden desamparados. Algunos de los capitalistas más agresivos cambian de tono cuando les sucede la VIDA: una enfermedad que sólo los especialistas súper caros pueden curar, una demanda en su contra que sólo los abogados más caros pueden resolver, una decisión del gobierno o un nuevo desarrollo que deja su negocio abandonado a su suerte, en quiebra y endeudado hasta las cejas.

Estos avances tecnológicos deberían facilitar la supervivencia de las personas, no desplazarlas. Con la enorme cantidad de riqueza que los estadounidenses han acumulado mediante avances tecnológicos, gran parte de ella en manos de unos pocos individuos, pueden permitirse extraer menos de los estados "vasallos" de todo el mundo. Pero eso es una ilusión. El sueño americano de grandeza es tener más, y más, y más riqueza material. Hay estadounidenses que tienen un corazón para los menos favorecidos. No son la mayoría.

Tenemos que cuidar de nosotros mismos. Si llamamos bienestar a una inflada fuerza laboral pública, NHI, subsidios escolares y diversas despensas, entonces abrazamos el estado de bienestar. Nuestro sistema económico debe estar orientado a garantizar que se atiendan las necesidades de todos: los trabajadores, los brillantes, los menos dotados para funcionar en el sistema actual, incluso aquellos a los que se llama perezosos. Esto no es un llamado a la holgazanería. La gente necesita empleos. El ser humano debe tener un propósito; los seres humanos deben sentir que están haciendo una contribución. El hombre del hacha encontró un trabajo manejando la motosierra. Pronto un robot solicitará su puesto. El gobierno debe ayudarlo a encontrar uno nuevo.

Las herramientas de producción deben estar en manos de quienes son capaces y ambiciosos. Los recursos del gobierno deben facilitar los negocios y la producción. Pero los héroes y heroínas del mercado no pueden acaparar toda la riqueza. Las grandes máquinas, los robots y las computadoras están haciendo el trabajo pesado. Si aseguramos estas herramientas y nuestros líderes comprenden que el "bienestar" es esencial en un sistema capitalista, todos ganaremos.

The United States is presently in a state of transition from the Democratic Party's Joe Biden presidency to that of the Republican presidency of the re-elected Donald Trump. Mr. Trump was elected three weeks ago and will be inaugurated on January 20, 2025. He has been nominating the members of his Cabinet, who, according to the U.S. constitution, have to be accepted by the Senate, which is controlled by the Republicans.

This week it was announced that the United States under President Biden has brokered a ceasefire between the Hezbollah of Lebanon and Israel. War continues, however, between Israel and

Hamas of Gaza. The Gaza war has been horrific beyond description, while the Lebanon war is relatively recent, but has resulted in massive damage to Beirut, the Lebanon capital, and other areas.

There is social and political tension within the United States itself, because Mr. Trump has promised mass deportation of immigrants from the day he is inaugurated. President Trump is supported by a movement referred to as the MAGA (Make America Great Again) group, which appears to have a white supremacist attitude.

From my personal viewpoint, there would have been a level of violence in

the United States had Mr. Trump and the MAGA movement been defeated in the election earlier this month. The rhetoric in the MAGA movement gave one that impression, especially when one considered the violent behavior of militant Trump supporters on January 6, 2020 at the U.S. Capitol in Washington.

I recently read a work by one Erik Larson about the period leading up to the American Civil War of 1861 to 1865. This war began in early April of 1861 with the shelling of the federal fortress at Fort Sumter, South Carolina, by Confederate elements which wanted to maintain chattel slavery as an American institution. Confederate

elements in America's southern, slaveholding states had been heavily agitated by the election to the presidency of Abraham Lincoln in November of 1860.

But the incident which had earlier alarmed the South was the raid by a white American named John Brown on October 16, 1859, on the federal arsenal at Harpers Ferry in northern Virginia. John Brown was a militant abolitionist whose intention was to arm the region's enslaved Blacks and spark widespread uprising.

In that same year, the United States had brokered the signing of a treaty between Great Britain and Guatemala on April 30, 1859, which delineated the borderline between Guatemala and British Honduras. This 1859 treaty will be a centerpiece of the negotiations/arbitration at the International Court of Justice (ICJ) which will rule on Belize's borderline with Guatemala, the republic which claims it inherited ownership of Belize from Spain.

In Belize's education system, we are taught nothing about the period from 1834, say, to 1859, a period during which slaves were freed in Belize (1838), Texas fought Mexico in 1835 to preserve slavery in Texas after Mexico outlawed slavery in the late 1820s, and the United States itself went to war with Mexico from 1846 to 1848, defeated Mexico and took possession of territory from Texas all the way to California.

The United States, which had declared the Monroe Doctrine in 1823, then confronted Great Britain in the 1850s, signing two treaties which stripped Britain of territory in Nicaragua and Honduras, and followed that up with the brokering, to repeat, of the 1859 treaty between Britain and Guatemala.

The period between 1834 and 1859 has never existed in the educational curriculum of British Honduras/Belize. Today, we Belizeans can see that we are in a tricky spot where Guatemala is concerned, and we have no idea what the mighty Trump's thinking is where the Guatemala/Belize situation is concerned.

It struck me that John Brown's raid on Harpers Ferry was just months after the Britain/Guatemala treaty in 1859. I thought some readers may be interested in Larson's description of the raid and the context in which it occurred in the United States. The United States, incidentally, lost 750,000 lives in its Civil War.

Following are five paragraphs from pages 66 and 67 of Larson's THE DEMON OF UNREST, published this year by Crown:

On October 16, 1859, John Brown, a fierce abolitionist, led a company of twenty-one men in an assault on the federal arsenal at Harpers Ferry



The UDP in turmoil

Dear Editor,

Please allow me space in your widely circulated newspaper to give my observation and opinion as it relates to the United Democratic Party (UDP) turmoil. I'm not a political scientist, just an outsider looking in:

For a leader who has for a long time projected strength and stability within his party, the growing public awareness of his controversial political tactics makes the Opposition even more dysfunctional and divided. His growing isolation reflects not only his tenuous grasp for power, but also the unravelling of traditional stalwarts and structures that have historically supported the UDP.

There's too much overreach; the unilateral expulsion of elected party

members exposes leadership micromanagement and prioritization of personal and political image over substantive leadership and unity. Now there's the appointment/installation of new candidates which will now further divide the dwindling number of voters supporting the UDP. Will they vote for the United Democrat Party or for the Alliance for Democracy? This will certainly throw the General Elections into the hands of the People's United Party (PUP).

Additionally, they risk losing seats already held. My advice for them is to bury the hatchet and extend an olive leaf. There will still inherently remain division in the hearts of many, but at least they will go united into the next elections. Hon. The question remains: Can the UDP navigate this unprecedented storm, or will it fracture under its division?


Multi-lingual book launched at Lake-I Library



speaking country [in Central America]; if we want to connect with persons in this other part of the area, this is a step in that direction," she explained.

Dawson, who had no writing experience before the publication of her book, highlighted that she was inspired by a dream two years ago.

"It was a dream that inspired the book. I wrote it immediately after the dream, but I never took it beyond that point until about two years later, when I said, 'You know what? Let me at least go there and try it.' So, I dreamt about it two to three years ago; I wrote it immediately, but I never put it in a book form until about last year; and then I officially made a publication in January of this year," she said.

"We're expecting suspense. We're expecting excitement. The reality is that it's encouraging you to dream; it's letting you know it's okay to dream. I'm trying to think of the right words to say without revealing what's going to happen in the book, because it is a short book; you can sit and read it in one sit-down," Dawson explained.

After writing the first draft of the book, Dawson anonymously handed it to her daughter to read without receiving any biased reviews, and was praised at the end.

"This book was written by my mom, and I oversaw it. I thought it would be beneficial for her to turn it into a book. I think it's nice, and I think that even if you're above the age range, which is six or ten years old, I [believe] that children before the age of six could also read it, because, you know, they have some children who are advanced, and also children who may not be able to read it themselves, but their parents or guardians may be able to read it to them; and I feel like they would find it very amusing," said Zyrah Noralez, daughter of Dawson.

The printed copies of *Dream Powers: Where Dreams Become Adventures* were distributed at the launch and are available for purchase for \$25 BZD each. Meanwhile, *Less is More: Faith-Driven Progress for Service Providers* will be available via pre-order for the same price. Purchase of that publication will give buyers access to an upcoming webinar hosted by Dawson.

Two suspected drownings occur on Monday

BELIZE CITY, Wed. Nov. 27, 2024

Police are awaiting the results of post-mortem examinations on the bodies of two men who reportedly perished in what are suspected to have been drowning incidents that took place on Monday, November 25.

55-year-old Rafael Vasquez of the Paslow Falls area of Bullet Tree Village, Cayo District, is the first victim who perished. It is believed that he died while attempting to cross the Mopan River.

His motionless body was reportedly found by two fishermen who were passing the area around 3:00 p.m., and saw Vasquez

lying in a face-down position at the river bank in some nearby bushes. When police carried out an initial inspection of the body, they did not observe any signs of foul play, so they labeled his death a drowning incident.


Relatives of Vasquez said that he routinely crossed the river between Paslow Falls and Bullet Tree to get home, and was a habitual drinker. They believe that he may have dived into the river while under the influence of alcohol, and due to the high water level, he was overpowered and perished.

Vasquez's body awaits a post-mortem examination.

The other incident occurred that same day in San Pedro Town, Ambergris Caye, where the lifeless body of Manuel Choc was discovered.

According to police reports, between 4:25 p.m. and 4:30 p.m., Choc went for a swim in the sea while under the influence of alcohol, and minutes later his body was seen floating in the water.

He was retrieved by a bystander who performed CPR; however, he was unresponsive. No physical injuries were found on his body. Choc's body was taken to the San Pedro Polyclinic, where he was pronounced dead. The body awaits a post-mortem examination.





Before getting into the beef of the letter, for a couple months now I've been wanting to say thank you to Brother Romel Cuello for lending me James Michener's historical novel, *Caribbean*. I enjoyed the book, and it's quite informative, as historical novels go. I have, as Romel requested, handed it over to the UEF Library. Thanks very much.

The US was properly and deservedly scolded for its raw treatment of Haitian refugees, and for persistently undermining Haiti, and for their ingratitude to Haiti after the island nation's giant stand against imperialism led to their gaining the vast Louisiana Territory. US policies, the letter says, have "stunted Haiti's development, fostered violence, forced displacement, and deepened economic despair." The letter noted the flooding of Haitian markets with US agricultural products, which devastated Haitian industries and displaced farmers.

Speaking to the present crisis, the group chastises the US for "the flow of arms ... into the hands of paramilitary death squads." Presently, Haiti is in the grip of gangs; the nation is in chaos. I differ with the group when it says, "deploying Kenyan police forces to Haiti - a nation [Kenya] with only recent diplomatic ties to Haiti—signal an alarming disregard for the Haitian people's agency and self-determination. The U.S.-led decision to impose foreign forces, supposedly to manage Haiti's internal affairs, not only undermines Haiti's sovereignty but dismisses the Haitian people's right to self-governance and independent problem-solving." I have to believe that the majority of Haitians want law and order in the country, through any means necessary. It is the nature of most people to put peace, order, before everything else.

"Urging the U.S. to forge a new path—one that truly supports the right of the Haitian people to democratic government and nurtures an equitable and mutually respectful relationship with Haiti" is a humanitarian call, and if the US were to do so, the fruits could only be realized if the present chaos is arrested.

More Haiti: I see where France's Macron has called the interim Haitian government an insulting name for replacing their interim PM, Garry Conille. Macron said, "it's the Haitians who have destroyed Haiti by allowing drug trafficking. And then what they did: the prime minister was superb, I defended him, [but] they sacked him!" It is reported that France will provide US\$4.2 million for the security mission.

Estados Unidos se encuentra actualmente en un estado de transición de la presidencia Joe Biden del Partido Demócrata a la presidencia republicana del reelegido Donald Trump. Trump fue elegido hace tres semanas y tomará posesión del cargo el 20 de enero de 2025. Ha estado nominando a los miembros de su gabinete, quienes, según la constitución estadounidense, deben ser aceptados por el Senado, que está controlado por los republicanos.

Esta semana se anunció que Estados Unidos bajo el presidente Biden ha negociado un alto el fuego entre Hezbolá del Líbano e Israel. Sin embargo, la guerra continúa entre Israel y Hamás de Gaza. La guerra de Gaza ha sido horrible más allá de toda descripción, mientras que la guerra del Líbano es relativamente reciente, pero ha provocado daños masivos en Beirut, la capital del Líbano, y otras áreas.

Existe tensión social y política dentro del propio Estados Unidos, porque Trump ha prometido la deportación masiva de inmigrantes desde el día de su investidura. El presidente Trump cuenta con el apoyo de un movimiento llamado MAGA (Make America Great Again) [Hacer grande a Estados Unidos otra vez], que parece tener una actitud supremacista blanca.

Desde mi punto de vista personal, habría habido un nivel de violencia en los Estados Unidos si el Sr. Trump y el movimiento MAGA hubieran sido derrotados en las elecciones a principios de este mes. La retórica en el movimiento MAGA dio esa impresión, especialmente cuando se considera el comportamiento violento de los partidarios militantes de Trump el 6 de enero de 2020 en el Capitolio de los EE.UU. en Washington.

Recientemente leí una obra de Erik Larson sobre el período previo a la Guerra Civil estadounidense de 1861 a 1865. Esta guerra comenzó a principios de abril de 1861 con el bombardeo de la fortaleza federal en Fort Sumter, Carolina del Sur, por elementos confederados que querían mantener la esclavitud como una institución estadounidense. Los elementos confederados en los estados esclavistas del sur de Estados Unidos habían estado muy agitados por la elección a la presidencia de Abraham Lincoln en noviembre de 1860.

Pero el incidente que antes había alarmado al Sur fue el asalto que un estadounidense blanco llamado John Brown llevó a cabo el 16 de octubre de 1859 contra el arsenal federal de Harpers Ferry, en el norte de Virginia. John Brown era un abolicionista militante cuya intención era armar a los negros esclavizados de la región y provocar un levantamiento generalizado.

Ese mismo año, Estados Unidos había negociado la firma de un tratado entre Gran Bretaña y Guatemala el 30 de abril de 1859, que delineaba la frontera entre Guatemala y Honduras Británica. Este tratado de 1859 será una pieza central de las negociaciones/arbitraje en la Corte Internacional de Justicia (CIJ) que dictará sentencia sobre la frontera de Belize con Guatemala, la república que

afirma haber heredado la propiedad de Belize de España.

En el sistema educativo de Belize, no se nos enseña nada sobre el período comprendido entre, digamos, 1834 y 1859, un período durante el cual los esclavos fueron liberados en Belize (1838), Texas luchó contra México en 1835 para preservar la esclavitud en Texas después de que México prohibiera la esclavitud a fines de la década de 1820, y el propio Estados Unidos fue a la guerra con México desde 1846 a 1848, derrotando a México y tomando posesión de territorio desde Texas hasta California.

Estados Unidos, que había declarado la Doctrina Monroe en 1823, luego se enfrentó a Gran Bretaña en la década de 1850, firmando dos tratados que despojaron a Gran Bretaña de territorio en Nicaragua y Honduras, y luego siguieron con la intermediación, para repetir, del tratado de 1859 entre Gran Bretaña y Guatemala.

El período entre 1834 y 1859 nunca ha existido en el currículo educativo de Honduras Británica/Belize. Hoy, los beliceños podemos ver que estamos en una situación complicada en lo que respecta a Guatemala, y no tenemos idea de cuál es el pensamiento del poderoso Trump en lo que respecta a la situación de Guatemala/Belize.

Me llamó la atención que la incursión de John Brown en Harpers Ferry se produjo solo unos meses después del tratado entre Gran Bretaña y Guatemala en 1859. Pensé que a algunos lectores les podría interesar la descripción de Larson de la incursión y el contexto en el que ocurrió en los Estados Unidos. Estados Unidos, por cierto, perdió 750.000 vidas en su Guerra Civil.

A continuación, se presentan cinco párrafos de las páginas 66 y 67 de THE DEMON OF UNREST de Larson, publicado este año por Crown:

El 16 de octubre de 1859, John Brown, un feroz abolicionista, lideró una compañía de veintidós hombres en un asalto al arsenal federal en Harpers Ferry en el norte de Virginia con la intención de armar a los negros esclavizados de la región y provocar un levantamiento generalizado. Los ciudadanos locales y la milicia lucharon contra Brown hasta un punto muerto hasta que llegó una fuerza federal, liderada por el coronel Robert E. Lee, por el momento un oficial del ejército de los EE.UU. Lee aplastó rápidamente la insurgencia de Brown, matando a diez de los hombres de Brown, incluidos dos de sus hijos. El efecto en todo el Sur fue galvánico. La incursión y su líder fueron la encarnación de las imaginaciones más oscuras de la caballería sobre los levantamientos de esclavos. Como diría más tarde un historiador: "Ni siquiera el más acérrimo de los radicales habría podido hacer que la amenaza de un holocausto interno pareciera tan real e inminente a los sureños como lo había hecho el severo y dedicado Brown."

in northern Virginia with the intent of arming the region's enslaved Blacks and sparking a widespread uprising. Local citizens and militia battled Brown to a standoff until a federal force arrived, led by Col. Robert E. Lee, for the moment an officer in the U.S. Army. Lee quickly crushed Brown's insurgency, killing ten of Brown's men, including two of his sons. The effect throughout the South was galvanic. The raid and its leader were the embodiment of the chivalry's darkest imaginings of slave uprisings. As one historian would later put it, "Not even the fieriest radical could ever have made the threat of an internal holocaust appear so real and imminent to Southerners as had the grim, dedicated Brown."

Ruffin understood at once that this changed everything. He was elated. Although the news at first seemed hard to believe, he wrote in his diary, "It really seems now most probable that the outbreak was planned and instigated by Northern abolitionists, and with the expectation of this starting a general slave insurrection. I earnestly hope that such may be the truth of the case. Such a practical exercise of abolition principles is

needed to stir the sluggish blood of the South."

In the North, the reaction was laden with a surprising degree of nuance. Widespread condemnation of the raid was tempered by warm praise for Brown's character and his moral stand. Even William Lloyd Garrison's the LIBERATOR made a distinction between the act and the underlying principle. Garrison described Brown as "conscientious, truthful, brave," but called the raid "a misguided, wild and apparently insane escapade". The New York INDEPENDENT echoed this, declaring, "The insanity of the act does not impeach the rectitude of the motive."

In the South, there was only rage and fear. Existing state militias saw a surge in new recruits; new companies formed as well and began actively drilling their volunteers. Stockpiles of weapons expanded. Communities formed vigilance committees to identify and eject citizens who might be harboring abolitionist views. An Atlanta newspaper warned, "We regard every man in our midst an enemy to the institutions of the South who does not boldly declare that he or she believes African slavery to be a social, moral, and political blessing."





Paradise lost? How cruise companies are 'eating up' the Bahamas

Another vast tourist resort project promising jobs and prosperity. But critics say such developments imperil the pristine environments they advertise

Joseph Darville has fond memories of swimming with his young son off the south coast of Grand Bahama island, and watching together as scores of dolphins frolicked offshore. A lifelong environmentalist now aged 82, Darville has always valued the rich marine habitat and turquoise blue seas of the Bahamas, which have lured locals and tourists alike for generations.

The dolphins are now mostly gone, he says, as human encroachment proliferated and the environment deteriorated. "You don't see them now; the jetskis go by and frighten them off.

"There's a lot going on. It's a tragedy – and continues to be a tragedy," says Darville.

Now, he fears further acceleration of the decline, with the scheduled opening next year of Carnival Cruise Line's vast Celebration Key resort, now under construction on the island's south coast.

The sprawling entertainment complex across a mile-long beach, already stripped of its protective mangroves, will ultimately bring up to an additional 4 million people a year to the island, Carnival says, with four of its ships able to dock simultaneously.

Concerns about giant cruise ships bringing multitudes of tourists, and pollution, to the ecologically fragile Bahamas are nothing new. Neither is the concept of foreign-owned cruise companies buying land to build private retreats exclusively for their passengers: Disney's Castaway Cay, a private island near Great Abaco, last year celebrated its 25th birthday.

But if only for their scale alone, Celebration Key and two other expansive developments just like it, either recently opened or being built elsewhere in the 700-island archipelago, represent a worrisome new threat, campaigners say.

Cruise companies have spent at least \$1.5bn (£1.1bn) since 2019 buying or leasing land in the Caribbean, according to a Bloomberg analysis in May, and Darville wonders what that means for the future of his beloved islands.

As executive chair of the environmental group Save the Bays, he was part of an alliance that fought against the Grand Bahama development, as well as Disney's Lookout Cay at Lighthouse Point, which opened on Eleuthera island in June, and Royal Caribbean's Royal

Beach Club at Paradise Island, which broke ground in April.

"It has to stop somewhere; we have to preserve something for our future generations, for our own native Bahamians," Darville says. "We cannot always be seduced by these cruise lines and other developers who come in and eat what's left of our country."

The "seductions" he sees are the cruise lines touting the supposed economic advantages to the Bahamas of being allowed to buy and develop land, promoting what he claims are questionable environmental credentials, and pledging community investments for locals in terms of jobs and grants for small businesses and education.

Such messaging has been well received in a country still struggling to recover from Hurricane Dorian in 2019, the worst natural disaster in its history, which prompted the near-collapse of the tourism industry.

An unemployment rate that reached almost 20% after the storm and subsequent Covid-19 pandemic has finally dropped back into single figures, but a stroll around once-bustling Freeport, the largest town, cruise port and commercial hub of Grand Bahama, provides plenty of

evidence of the island's decline.

The waterfront 542-room Grand Lucayan resort, formerly the grande dame of Grand Bahamian tourism, sits mostly empty, abandoned and awaiting a buyer, with only a small portion of the development still open.

The adjacent straw market, once a thriving hub of souvenir stalls, entertainment and refreshment, is largely bereft of customers, even when a cruise ship is in town. And taxi drivers can spend a day or more waiting at the airport or cruise terminal without earning a fare.

It is hardly surprising, then, that the cruise companies, amplified by the Bahamian government, honed their pitches for land deals to receptive ears, focused on the jobs they would create and the dollars they would bring in.

Carnival, for example, says all but two of the 31 construction companies working on Celebration Key are owned by Bahamians. Job fairs over the summer, offering employment with perks including medical insurance and paid time-off, were

swamped.

Disney says it created more than 200 "high-quality" jobs for locals at Lookout Cay, has invested more than \$1m into the local economy since it opened, and has promised almost as much again for playgrounds, sports fields and infrastructure for the island's students.

On Paradise Island, Royal Caribbean's deal for the 7-hectare (17-acre) site included a promise that Bahamians "will be invited" to own up to 49% of the venture.

The websites of all three projects are also heavy with words and phrases such as "environmental commitment", "sustainability" and "responsibility".

Meanwhile, Isaac Chester Cooper, the Bahamas' tourism minister, continues to cite a Tourism Economics study, prepared for Carnival in 2019, stating that the "development, construction and ongoing operation of Celebration Key" would create thousands of Bahamian jobs and generate a \$1.5bn boost for the Bahama's GDP.

By contrast, Carnival Corporation recorded an all-time high \$21.6bn annual revenue in 2023; Royal Caribbean's revenue increased 57% year-on-year to \$13.9bn; and that of Disney's Magical Cruise Company, while smaller at \$2.2bn, still represented a rise of almost 91%.

Cooper did not return a request for comment from the Guardian.

Darville concedes it is harder to push an environmental message in such circumstances. "Whenever there's word there's going to be cruise ship development coming to the Bahamas, the first thing the government looks at, and the people generally, is how many people will be employed, what economic benefits we're going to derive," he says.

He says that ignores the environmental impact

and damage caused by developments on previously pristine Bahamas beaches. Mangrove destruction is a particular concern, given the protection the trees provide against storm surge from hurricanes.

But campaigners say the projects are also significantly detrimental to wildlife, in water and on land, as well as precious coral reefs already imperiled by rising sea temperatures.

At Lookout Cay, Disney built a half-mile-long pier to allow cruise liners to dock, driving countless support posts deep into the seabed. The company insisted that "viable individual corals within the pier's footprint were expertly relocated to improve the health of struggling coral reefs in the area".

Darville is skeptical and worries about the

effect on coral reefs and fish populations of thousands of people in the water slathered in chemical-based sunscreens. "When Disney was putting out its proposal, no matter what they said or how they did it, there was going to be a catastrophic impact," he says.

Gail Woon, executive director of the educational non-profit group Earthcare, and partner of the Global Cruise Activist Network, an alliance of industry critics, says previous developments in the islands that were touted as environmentally friendly turned out to be anything but.

She cites a private golf resort where residences can cost tens of millions of dollars, but construction and operations destroyed coral just offshore.

"We had coral reef biologists testify that if you put a golf course on the beach and fertilize the grass, the run-off will go into the ocean and kill the coral because they can't take large amounts of nitrogen and phosphorus," she says.

"They went ahead and did it anyway, then where there should have been pristine sand and clear water they have these big clumps of green and brown macro-algae that smothers the corals. They were destroying the product they were trying to promote."

Through projects such as Earthcare's EcoKids, Woon and others around the Bahamas are working to educate the next generation about environmental challenges facing the country and the world.

It's a message reinforced at Conservation Cove, a small but thriving living laboratory east of Freeport where cruise ship tourists and pupils on school field trips learn the importance of coral reefs and mangrove restoration.

Javan Hunt, mangrove nursery coordinator at Conservation Cove, says: "If you make decisions based on ignorance, you allow people to run over you, or sell you something that's not in your best interest.

"So, for me the most important thing is to educate those coming up, so that in five years, 10 years and beyond, they can make informed decisions – and won't just smile when someone is presenting shit to them and telling them it's treasure."

Ruffin comprendió de inmediato que esto lo cambiaba todo. Estaba eufórico. Aunque al principio la noticia parecía difícil de creer, escribió en su diario: "Ahora parece realmente muy probable que el estallido fuera planeado e instigado por abolicionistas del Norte, y con la expectativa de que esto iniciara una insurrección general de esclavos. Espero fervientemente que esa sea la verdad del caso. Se necesita tal ejercicio práctico de los principios abolicionistas para agitar la sangre inerte del Sur."

En el Norte, la reacción estuvo cargada de un sorprendente grado de matices. La condena generalizada de la incursión se vio atenuada por cálidos elogios al carácter de Brown y su postura moral. Incluso el LIBERATOR de William Lloyd Garrison hizo una distinción entre el acto y el principio subyacente. Garrison describió a Brown como "consciente, veraz, valiente", pero calificó la redada como "una escapada equivocada, salvaje y aparentemente demente". El New York INDEPENDENT se hizo eco de esto, declarando: "La locura del acto no impugna la rectitud del motivo".

En el Sur, solo había rabia y miedo. Las milicias estatales existentes vieron un aumento en nuevos reclutas; también se formaron nuevas compañías y comenzaron a entrenar activamente a sus voluntarios. Las reservas de armas se expandieron. Las comunidades formaron comités de vigilancia para identificar y expulsar a los ciudadanos que pudieran albergar opiniones abolicionistas. Un periódico de Atlanta advirtió: "Consideramos a cada hombre en nuestro medio un enemigo de las instituciones del Sur que no declare audazmente que él o ella cree que la esclavitud africana es una bendición social, moral y política".



companies showing how customers have been repaying their bills. Other institutions to be included in the credit reporting system as data providers will be banks, credit unions, money lenders, insurance companies, the Development Finance Corporation (DFC), public registry and a Central Bank-designated person. Importantly, as part of data protection, the customer will have to consent to their data being released, and will have a right to know what has been shared. Additionally, they must be given access once every year to a free copy of their credit report. The data will be managed and stored by the Credit Bureau. Selected as the international Credit Bureau Reporting and Business Information (CRIF).

Among the expected effects of the CRS are increased access to financing (loans, mortgages and other financial services) and financial inclusion for the unbanked, which currently stands at 30%. It is also expected to prevent over-indebtedness, given that lenders will

be able to better assess credit profiles. As well, it is expected to contribute to lower credit costs for healthy borrowers.

New currency to be unveiled in January 2025

The promised new currency with the images of our two national heroes, George Price and Philip Goldson, is coming soon. Central Bank Governor Kareem Michael announced today that the unveiling of the new bank notes will take place in January 2025. "While the new bank notes will look different, the value remains the same," emphasized Michael. He added, "Design does not equal value. A dollar is still a dollar. Our rate of exchange remains the same, which is two Belize dollars to one US dollar."

The new bank notes will enter into circulation sometime in the third quarter of 2025, and are expected to have enhanced security features. Michael also noted that existing bank notes will remain in circulation until the Central Bank has retrieved a large share of what is in circulation - and that may take years.

lauded that country's prevention measures which led to the detection of the infected animal in this instance, and its prevention of the spread of the disease in their country. However, CEO Baeza explained that the greater concern is the illegal cattle trade. He shed some light on the movement of cattle in the region stating, "A lot of the cattle from Nicaragua comes through Honduras, goes through Guatemala, and then ends up in Mexico." According to Baeza, even the majority of Belize's cattle exports to Guatemala are believed to eventually end up in Mexico. He added that, while countries seem to have a handle on the controlled trade, it is the informal trade that is worrisome.

As a result of the discovery of the infected animal in Mexico, the United States temporarily closed its border with Mexico for cattle trade. Mexico has done the same with Guatemala. Baeza stated that if even one case of the NW screwworm were to be detected in Belize, Mexico would suspend cattle trade with us. Another great concern for our authorities is a possible decline in Guatemala's demand for our cattle as a result of oversupply of beef due to the measures taken by the U.S. and Mexico.

CEO Baeza estimates that 85% of our cattle is exported to Guatemala informally, while the remaining 15% is exported to Mexico via legal, regulated trade through the northern border. The cattle on the hoof goes to one buyer, SuKarne. In total, Belize exports between 35,000 and 45,000 heads of cattle annually. The value of our cattle industry is estimated to be around \$90 million annually.

While Belize remains free of the NW screwworm, the pest, which deposits its larva into open wounds

or mucous of mammals, is getting closer. Baeza revealed that since mid-November, there were 13 official reported cases of the screwworm in Guatemala, and there is an unconfirmed report that there is one in Peten. More worrying, however, is that there may be more unreported and undetected cases. Baeza said that Guatemala is under-resourced, and has admitted to being overwhelmed when it comes to ensuring active surveillance and monitoring to avert an infestation. On Monday, officials from Belize and Guatemala met and discussed better collaboration to prevent the spread of the myiasis disease caused by the screwworm.

Belize's agriculture authorities continue to work closely with OIRSA, the Belize Agricultural Health Authority (BAHA) and the Belize Livestock Producers Association (BLPA). As part of our prevention measures, all trucks returning from Guatemala are required to be sanitized. There are points of control in Bullet Tree, Cayo and in Jalacte, Toledo, as no animal is being allowed to enter Belize from Guatemala. In our case, Baeza admits too that "resources is always a challenge." He added that, as it currently stands, he believes BAHA is stretched thin. The Government recently approved a supplementary appropriation for prevention work. He said it is not enough, but "we are doing everything we can with the resources that have been provided." The USDA is also providing some funding through OIRSA, and Belize is receiving some of those resources. However, it is not significant, because Belize was far removed from the area where the initial infestation started in February this year in Panama and Costa Rica.

Cattle farmers are being asked to remain vigilant and treat all wounds on their cattle.

year-old David Ramnarace—has expressed frustration over the paucity of information they have been receiving on the progress of the case, which has been proceeding at a snail's pace, with multiple adjournments and delays.


The Belisle family declined an interview; nonetheless, they mentioned in their statement that they are receiving updates on the case through media reports like everyone else. In the family's statement, they deny a claim made by attorney Richard "Dickie" Bradley that the enhancement of the video footage of the shooting of the victims is something "they don't want to do". "Our family is not opposed to this," they assert in the statement.

The shooting took place at Vivian's and Jon's residence on Belen Street in the Maya Mopan area of Belmopan while the couple had been socializing with David and his common-law wife, 28-year-old Yemi Alberto, who had also been wounded by the shooter, but unlike the other three victims, did not lose her life.

Jon and David Ramnarace had been outside of the residence when the gunman entered the yard, and proceeded to shoot them, killing them instantly. The shooter then went inside the home and fired shots at the two women before leaving the scene. The chilling incident was captured by security cameras.

After the shooting, police identified one of their own – former police constable Elmer Nah—as the suspected killer. He was initially charged with the double murder of the Ramnarace siblings, but when shooting victim Vivian Belisle Ramnarace passed away 16 days later, his charges were upgraded to three counts of murder (of Jon, David and Vivian Ramnarace), as well as attempted murder, use of deadly means of harm, and wounding charges in connection with the shooting of Yemi Alberto, David's girlfriend.

At every appearance at the Magistrate's Court in Belmopan, Nah has professed his innocence, and after almost two years, the case proper has still not gotten underway, because at the end of every session involving

preliminaries, the case has been adjourned until a later date, only to be then pushed back again until another date.

Earlier this year, the case was moved to the High Court following the presentation of arguments by Nah's defense attorney that enhancements to the video footage of the shooting would reveal that Nah was not the gunman seen in the video. Nah's attorney, Senior Counsel Godfrey Smith, has secured the services of an audio forensics firm in Los Angeles, California.

Smith told reporters that he had requested the original footage of the incident along with his client's cell phone and other items that are currently in the possession of the police. However, at the most recent court appearance, he mentioned that the items that he requested hadn't been submitted by the Crown. These items are now scheduled to be submitted on November 29.

The family is appealing for the office of the Department of Public Prosecution (DPP) to comply with the requirements of the court so that the case can proceed at a brisker pace and hopefully reach a just conclusion.

The date of the next court appearance is December 16.

of excessive passengers.

DeShield said he signaled to the driver to stop, and he entered the bus to make checks; and that's when he saw many standees. He said that he then noticed a male who weighed about 200 pounds sitting in front of the driver's seat, but the driver refused to park the bus, and sped forward.

But, according to DeShield, after the bus had passed Mile 1 and as the bus approached the Belize Flour Mill Ltd., a male person dressed in a yellow shirt, whom he identified as Evan Caine, looked at him and said, "You need to get off the bus."

Caine then grabbed his hand and pushed him off the bus along with the help of another male he recognized to

be Ocean Blease.

This morning shortly before 10:00, Caine was transported to the court in a prison van and, at around 10:15 a.m., he was escorted into a courtroom where he appeared unrepresented, and was read a single charge of aggravated assault upon a traffic officer, 46-year-old Kenrick DeShield, in the course of his duties.

After the charge was read to him, Caine told the sitting Magistrate of Court #7, "I wahn plea guilty, Maam."

Immediately, out of an abundance of caution, given that Caine was unrepresented, the sitting Magistrate asked Caine if he understood what is an assault.

Caine replied by indicating that he did understand.

That's when the facts of the case

were read out to him; and after hearing the facts, Caine maintained his guilty plea.

During a subsequent mitigation process, the sitting Magistrate asked Caine what he wanted the court to take into consideration before a sentence was passed upon him, and he said, "I just want to get over this and get back home to care for my mom."

The Magistrate then asked him if that's all he wanted her to take into consideration, and then asked him if he was not apologetic for his actions, as she could observe no remorse in his statements or his behavior.

That's when Caine said, "Well, if I have the opportunity to apologize to the officer I would, but he is not

present".

The Magistrate then explained to Caine the serious nature of the offense, since DeShield is a public officer and was doing his duties; and before sentencing him, she told him that she would remand him pending sentencing, so that she could decide on an appropriate sentence to impose.

She also indicated that in the ensuing time before sentencing, she would have the court summon the traffic officer so he could be present in court and so Caine could apologize to him in person.

Caine was then remanded into custody at the Belize Central Prison until next Wednesday, December 4, 2024.






Bank Fees and Charges




Domestic and Regional Inflation

economy has fully recovered,” said Michael. In fact, he reported that the real Gross Domestic Product (GDP) per person in 2023 was at \$15,500, well over the projected \$13,500 if growth had continued on the path prior to the pandemic. Michael attributed the rebound in 2022 and 2023 primarily to the recovery of our tourism sector.

The Central Bank’s projection for Belize’s 2024 economic growth is a rate of 7%. This would be well above the IMF’s projected growth rate for Latin American and Caribbean countries, with the exception of Guyana, which is deemed an outlier due to its spectacular growth of over 40% linked to its recent oil discovery. For 2025, the projected growth rate for Belize is 4.1%, whereas the global average is expected to be around 3.2%.

When it comes to inflation, Michael shared that upward pressures on prices have weakened, and inflation is “trending downward.” He did admit, though, that despite real GDP growth and the increased minimum wage “which helped to raise income, rising costs have partially offset these income gains.” As a result, said Michael, Belizean households have had to trade-off to stretch their dollar in meeting their expenses. In 2023, the inflation rate had dropped to 3.6%, which Michael attributes in part to the “unwinding of supply chain disruptions” seen earlier in the COVID-19 pandemic, as well as ease in the “energy and commodity price pressures” from the Russia-Ukraine war. According to the available figures, the Central Bank notes that, whereas inflation was externally driven in 2021 and 2022, in 2023 it was an increase in the prices of domestically produced food items that accounted for the lion’s share (44%) of inflation.

The projection for 2025 is a further reduction of inflation to 3%. Michael did concede that perhaps the Statistical Institute of Belize (SIB), from whom they draw the inflation figures, ought to expand

the basket of goods and services used to determine its consumer price index, and perhaps include home prices and mortgage interest rates, which bite off a huge chunk of the disposable income of families. The Governor also cautioned that the impacts of climate-related events can also further drive up inflation.

Domestic banks retaliated against the CBB’s attempt to drive down fees

Today, Central Bank Governor Kareem Michael explained that the bank tried to do its part in assisting consumers through lowered transactional costs in the banking sector. “I’m sure the media is well familiar with this battle,” said Michael in reference to the negotiations that ensued when the Central Bank attempted to introduce Practice Direction 7 in 2023. In the subsequent negotiations that followed after a legal challenge was initiated by the commercial banks, it was agreed that all ATM fees would be capped at 25 cents, and there would be reduced fees for early pay-out of residential mortgages, among others. Michael agreed with the interpretation that the banks collectively retaliated by hiking fees for over-the-counter withdrawals and check clearings. When *Amandala* asked if the CBB has done an assessment to determine if the new fee changes imposed by the banks outweigh the benefits that resulted from its efforts to drive down banking fees, Michael responded, “The increases on this side should be less than the overall activity within the financial system, so, the way how online transactions have been growing -- and growing exponentially -- versus how many people still actually want to go into a bank and wait in line to do over the counter. And also, I think it is slowly sinking in within those people who are still using cheques that it is not the way to go. There are better ways to conduct financial transactions.”

Room for improvement regarding

interest spreads

During his remarks at today’s Central Bank press conference, Governor Michael also noted that there is room for improvement when it comes to the interest spreads for money lending, as well as the rate that commercial banks pay for deposits. He pointed out that there has been little change in this regard for more than 10 years. Imposing changes, however, would be challenging, according to Michael, who says that it is a reality faced by the banking sector in many small countries “that have similar market structures and macro environments that induce wider interest rate spreads.” He added, “In our case, I think the situation is compounded by the fact that our system is so small, having just four domestic commercial banks accounting for the lion’s share of the financial sector.”

CBB reports robust foreign exchange reserves

Another piece of good news shared by the Central Bank today was that its foreign exchange reserves remain robust, with 4 months of import cover or 1 billion dollars held by the Central Bank and another \$0.9 million held collectively by the domestic banks. Michael remarked that this is the highest our foreign exchange pool has ever been. Tourism, again, leads the charge with revenue from that sector up 11.6% or \$1.2 billion from January to September this year.

In the case of Foreign Direct Investment (FDI), Michael informed that it is “very strong” for the first three quarters of the year at 44% or \$195.4 million. Remittances are at \$222.3 million, while our export revenue is listed at \$783.3 million and business process outsourcing at \$169.1 million. Loan disbursements account for \$149.4 million.

Debt to GDP ratio still listed as 64% despite new loans

Belize’s finance experts in Government, like Minister of State Chris

Coye and Financial Secretary Joseph Waight, reported previously that from as far back as 2022, our debt-to-GDP ratio had gone down to 64%. Debt-to-GDP ratio, as per a definition by *Investopedia*, is a metric which compares a country’s public debt to its GDP, and reliably indicates a country’s ability to repay its debts by comparing what it owes with what it produces.

With the signing of the Blue Bond in November 2021, our debt-to-GDP ratio was reduced by 12% from a sky-high 133% to about 121%. When the Statistical Institute of Belize implemented rebasing (updating the methodology used to estimate GDP) in the first half of 2022, Belize’s rate was reduced to a percentage in the 80’s range. Thereafter, we were told that, with the agreement of the Venezuelan government to shave off between BZ\$257 million and \$327 million from our PetroCaribe debt, our public debt had gone down to 64.1% in 2022. The international standard for sustainability is 60%. But almost two years later, our authorities are still citing the same figure for our debt-to-GDP ratio, despite new loans having been approved by the National Assembly.

Our question to Central Bank Governor Kareem Michael today, when he reported the 64% figure at the Central Bank press conference, was why the debt-to-GDP ratio has remained the same despite the new external debt. Among them has been the BZ\$90 million Saudi loan for the University Hospital (June 2023) and BZ\$14 million from the Inter-American Development Bank for fisheries (October 2023), among many others. Michael explained that, with the rebasing exercise, the denominator (GDP) was increased by 27%, plus about 4 years of good growth. That resulted in the denominator becoming bigger in comparison with the numerator (the debt). In that regard, Michael also pointed out that due to fiscal discipline there has been amortization (repayment of loans) that has reduced the debt.
